Dr Qureshi, however, confirmed that a Kashmir-based female pilgrim, who was already unwell, passed | More on P10


## J&K Gets Biggest Ever Rural Road Package Under PMGSY-IV

The approved 1781 kilometers of road length are expected to deliver a substantial boost to rural road connectivity, ushering in a new era of prosperity, particularly in J&K's far-flung and remote areas.

#### **CSC Submits Reservation Report,** Para Wants It Made Public

The Jammu and Kashmir cabinet subcommittee examining the region's reservation policy has submitted its repor within the mandated sixmonth period, Education Minister Sakina Itoo announced on Tuesday. "The report will be placed before the Cabinet when it meets," she posted on X.

Formed in December 2024, the Sub Committee was tasked with reviewing the reservation framework following the Centre's



move to grant Scheduled Tribe (ST) status to the Pahari community. The decision sparked widespread protests and legal challenges, with students and aspirants expressing concern that over 60% of seats were now reserved. leaving limited opportunities-estimated 30–40%—for open merit candidates.

Responding

Itoo's announcement, PDP MLA Waheed Parra said, "Students are demanding answers, not delays. Why hold back the Cabinet Committee report on merit? After your government's adverse stand on merit in court, intentions, not actions are under question." He called for transparency, noting that

Kashmiris have endured six years under an unelected administration.

Tensions have building among aspirants. On June 5, representatives of the Open Merit Students' Association (OMSA) met MP Aga Ruhullah Mehdi, reiterating that June 10 was the deadline for the committee's report. #### **Man Held For Posing As SSP CIK**

Srinagar: In a startling case of impersonation and digital fraud, Iammu and Kashmir Police have arrested a man for posing as the Senior Superintendent of Police (SSP) of Counter Intelligence (CI) Kashmir in a bid to pressure gambling platforms into refunding money he had lost online.

According to officials, the accused-identified as Barkat Ali Parray alias BK, son of Ghulam Mohammad Parray and a resident of Gundhassi Bhat, Sheltang, Srinagar-was found using the photograph of the SSP CI Kashmir as his WhatsApp profile picture. Parray allegedly used this fake identity to threaten individuals, including organisers of online gambling platforms.

CI Kashmir acted on credible intelligence and tracked the suspect through his digital footprint. He was apprehended on June 9 at Jahangir Chowk, Srinagar. During a routine check of his mobile phone, police found that his WhatsApp account, linked to his personal number, featured the SSP's image as the | More on P10

Jammu Hits 44.4°C, Srinagar 33.5°C

Srinagar: Jammu and Kashmir is in the grip of a severe heatwave, with the Meteorological Department forecasting no respite for at least the next four days. Tuesday saw temperatures soar well above normal across both Jammu and Kashmir divisions, disrupting daily life and prompting health advisories.

Jammu recorded its hottest day of the season at a blistering 44.4°C, which is 5.6°C above normal. Other parts of the Jammu region also reported extreme temperatures-Katra at 40.6°C. Banihal at 33.6°C, Batote at 33.3°C, and Bhaderwah at 33.4°C, all several degrees above seasonal averages.

#### **Motorists Suffer As Rambagh Road Turns Into A Death Trap**

**SRINAGAR:** The road stretch near Rambagh Bridge in Srinagar has turned into a virtual death trap, riddled with deep potholes and broken surfaces that have made daily commuting a dangerous gamble for motorists, especially bikers. Despite being one of the busiest road links in the city, the stretch has been left in a state of utter neglect, raising serious concerns about the priorities of the administration.

According to KNT, for the past two years, commuters say the road has been crumbling under their wheels, with no meaningful intervention from the authorities. "It's not just an inconvenience anymore, it's a hazard," said a visibly angry commuter at the site. The potholes are so deep and widespread that even cars struggle to navigate without risking damage to their suspensions, while bikers remain at constant risk of injury or worse.

Muhammad Iqbal, a Natipora resident and daily commuter, shared a harrowing experience with the news agency Kashmir News Trust: "I was riding my bike at full speed during the early morning hours when traffic was light. Suddenly, the front wheel hit a pothole and the bike slipped. I broke my knee and arm. I was lucky to survive." Iqbal is not alone, several similar accidents have been reported in recent months, particularly among two-wheeler riders, some of whom were left with serious fractures and long-

Locals question how a road so central to city traffic. which leads to Srinagar Airport, has been allowed to deteriorate to such an extent. They say that repeated complaints to authorities have gone unanswered, and routine patchwork, when done, barely lasts a few weeks before the stretch reverts to its

hazardous state. The situation not only threatens human lives but also highlights the sheer apathy of those responsible for road maintenance in Srinagar. With the stretch being used by thousands daily, including school vans, ambulances, and office-goers, the consequences of inaction could be disastrous.

Dwarika Nath, who belonged to Anantnag district, said. "I have been going to Kashmir for the last three years as a tourist. I do not stay in hotels or houseboats. I feel comfortable in the houses of my Muslim friends and neighbours."

Mohan Lal, who has been living in Jammu and Delhi for the last 17 years, said that "though we crave for returning to Kashmir for many among us the situation has changed to the extent that we may not be able to resettle ourselves permanently." He explained that children of a major section of Kashmiri Pandit community has, after coming out of various professional colleges are suitably settled and hence it will not be 'feasible for them to return to Kashmir." Others who have returned from the valley in recent days said besides these domestic issues, the security scenario in Kashmir is still not conducive for their return and rehabilitation.

#### Indian Students At Harvard Navigate Uncertainties

New York: Indian students at Harvard say they are navigating a "rollercoaster" of uncertainty and anxiety amid the Trump administration's relentless battle against the university while also dealing with a dearth of job opportunities.

"It's just been a time of not quite knowing what to do, whether we should make our moves back home, or whether we should try and figure something out here," an Indian student, who graduated last month from the Harvard Kennedy School, said, not wishing to be identified.

Indian students at Harvard, speaking to PTI on condition of anonymity, shared their concerns and experiences of the last few months during which the prestigious university has seen relentless attacks by the Trump administration.

The administration's actions include a freeze of USD 2.2 billion in grants, revocation of the university's eligibility to enrol international students and suspension of entry of foreign nationals seeking to study or participate in exchange programmes at Harvard.

The Department of Homeland Security (DHS) has said

that Harvard's leadership has created an "unsafe campus environment by permitting anti-American, pro-terrorist agitators to harass and physically assault individuals, including many Jewish students, and otherwise obstruct its once-venerable learning environment."

US President Donald Trump, in a proclamation last week, said Harvard had refused recent requests of the DHS for information about foreign students' "known illegal activity," "known dangerous and violent activity," "known threats to other students or university personnel," and other related data.

Another Indian student who graduated from the Harvard Graduate School of Design after completing a two-year course, said students come to American institutions with plans of finishing their studies and then finding jobs to work for a few years in the US. But she described the situation of the past few months as being a "rollercoaster." "With all the uncertainty, I can say that a lot of people who are hiring were generally hesitant of international students, and maybe the Harvard tag helped earlier, but that's not the same right now at this particular mo-

#### Thunberg Accuses Israel Of Kidnap After Gaza Aid Boat Intercepted

PARIS: Swedish activist Greta Thunberg on Tuesday accused Israel of "kidnapping us in international waters and taking us against our will to Israel" after security forces intercepted a boat carrying humanitarian aid bound for Gaza.

"This is yet another intentional violation of rights that is added to the list of countless other violations that Israel is committing," Thunberg, 22, told reporters on arrival at Charles de Gaulle airport in Paris after being deported from Israel.

She stressed that her own experience was "nothing compared to what the Palestinians are going through."

Of the 12 people on board the Madleen carrying food and supplies for Gaza, five French activists were taken into custody after they refused to leave Israel voluntarily. But Thunberg, who rose to fame as a schoolgirl activist against climate change and seeks to avoid flying because of its environmental impact, was deported by Israel on a commercial flight of national airline El Al bound for Paris.

"This is not the real story. The real story is there is a genocide going on in Gaza and systematic starvation," said Thunberg.

Several rights groups including Amnesty International have accused Israel of genocide of the Palestinians in Gaza but Israel vehemently rejects the term.

The vessel carrying French, German, Brazilian, Turkish, Swedish, Spanish and Dutch activists had the stated aim of delivering humanitarian aid and breaking the Israeli blockade on the Palestinian territory.

Israel intercepted the Madleen about 185 kilometers (115 miles) west of the coast of Gaza.



## India's Population Hits 1.46 Billion, Fertility Below Replacement: UN

New Delhi- India's population is estimated to reach 1.46 billion in 2025, continuing to be the highest in the world, according to a new UN demographic report, which also revealed the country's total fertility rate has fallen below the replacement rate.

UNFPA's 2025 State of World Population (SOWP) Report, The Real Fertility Crisis, calls for a shift from panic over falling fertility to addressing unmet reproductive goals.

Millions of people are not able to realise their real fertility goals, it asserts.

This is the real crisis, not under-population or overpopulation, and the answer lies in greater reproductive agency – a person's ability to make free and informed 150 per cent choices about sex, contraception and starting a family, it says.

The report also reveals key shifts in population composition, fertility, and life expectancy, signalling a major demographic transition. This means that, on average, In-

dian women are having fewer children than needed to maintain the population size from one generation to the next, without migration.

Despite the slowing birth rate, India's youth population remains significant, with 24 per cent in the age bracket of 0-14, 17 per cent in 10-19, and 26 per cent



#### "Operation Sindoor Biggest Action Against Terror In Indian History": Rajnath

Dehradun: Defence Minister Rajnath Singh on Tuesday said the Pahalgam terror strike was not just an attack on our people but also an assault on the social unity of India, as he asserted that Operation Sindoor carried out in retaliation was the "biggest action" taken against terrorism in India's history.

In his address at an event in Dehradun, he also said that terrorists killed people in Pahalgam asking their religion but "we didn't ask their 'dharm' (religion) but hit back seeing their 'karm' (deeds)".

Mr Singh said in the last 11

years, the government under Prime Minister Narendra Modi's leadership has bolstered the circle of national security.

"On every matter related to national security, we have changed both attitude and way of action of the government. The world saw this change during the recent Operation Sindoor," he said.



On April 22, terrorists killed 26 people, mostly tourists, in Pahalgam in south Kashmir.

India launched Operation Sindoor early on May 7 to destroy nine terror infrastructures in Pakistan and Pakistan-occupied-Kashmir in retaliation for the Pahalgam terror attack.

All subsequent retaliations to Pakistani offensives were carried out under this operation. Singh termed it as "big and tough action" by India in response.

"This (Operation Sindoor) was the biggest action taken against terrorism in Indian history, I can say firmly say this," he said.

#### Delhi Sizzles At 43.8° c, Records Season's Hottest Day



The humidity levels fluctuated between 39 per cent and 24 per cent, the weather department said.

New Delhi: In the grip of extreme heat, Delhi on Tuesday recorded its highest maximum temperature of the season at 43.8 degrees Celsius, 3.6 notches above the season's average, the India Meteorological Department (IMD) said.

The real-feel temperature - or heat index - was 47.1 degrees Celsius on Tuesday, while the minimum temperature settled at 27.8 degrees Celsius. The humidity levels fluctuated between 39 per cent and 24 per cent, the weather department said.

The IMD on Monday issued an orange alert for the capital city till Wednesday, warning people to stay cautious and take steps to protect themselves from the ongoing heatwaye.

According to the IMD, very hot weather will persist in Delhi until at least June 12.

The daytime temperature on Wednesday is expected to hover around the 45-degree Celsius mark, while the nights will also be warm at around 29 degrees Celsius, the IMD said.

Safdarjung, the base observatory of Delhi, on Tuesday recorded a maximum temperature of 43.8 degrees Celsius, while the other monitoring stations, including Lodhi Road, Ridge, and

Ayanagar, recorded heatwave conditions, with the latter recording a high of 45.5 degrees Celsius.

According to the IMD, a heatwave is declared when the temperature exceeds 40 degrees Celsius with a departure of at least 4.5 degrees Celsius from normal, or the maximum crosses the 45-degree mark - as Ayanagar did for the second straight day on Tuesday.

Delhi is also experiencing warm nights with the temperature remaining high even after sunset. This can make it harder for people to cool down, besides increasing the risk of heat-related illness, especially for the elderly, children, and those with health issues.

There may be some relief starting June 12, with the IMD forecasting light rainfall and thunderstorms in parts of Delhi, along with gusty winds between 30 and 40 kmph.

The air quality in the capital was recorded in the 'poor' category on Tuesday with an Air Quality Index (AQI) reading of 215 at 4 pm, Central Pollution Control Board (CPCB) data showed.

According to the CPCB, an AQI between zero and 50 is considered 'good', 51 and 100 'satisfactory', 101 and 200 'moderate', 201 and 300 'poor', 301 and 400 'very poor', and 401 and 500 'severe'.

## Two Indian Women Detained For Theft At Singapore's Changi Airport

ingapore, (PTI): Two Indian women transiting through Singapore's Changi Airport were detained for allegedly committing a series of shop thefts at different stores, police said on Monday.

The thefts were committed on June 2 by the women, aged 29 and 30, The Straits Times newspaper reported, quoting a police statement.

Both women were detained before they could leave the country.

Police were alerted to the suspected theft case in the departure transit area of Terminal 3. Through the use of CCTV camera footage, airport authorities identified and found the two women

within an hour.

A stolen purse, a backpack and a bottle of perfume -- all allegedly stolen -- were found in their possession. The three items had a total value of SGD 635, according to the report.



The women are expected to be charged in court on June 10, and if convicted, can be jailed for up to seven years, fined, or both.

"The police will continue to work closely with stakeholders and the community to prevent and deter cases of shop theft," the statement said.

#### Gurugram Bar Body 'Bans' Non Lawyers From Wearing White Shirt, Black Trousers

he Gurugram District Bar Association has passed a resolution "banning" non-lawyers from wearing white shirts and black trousers in the court premises.

The professional attire is now re-

served solely for registered lawyers and authorised law trainees, said a senior members of the bar association while referring to the resolution.

According to the resolution, it was

often observed non-advocates or unrecognised law trainees wore white shirts and black trousers in the district court premises.

The scenario, the resolution said, led to "misidentification" and in some cases

even disrupted the dignity and discipline of the court proceedings.

The bar association, as a result, "appealed to all concerned" to strictly adhered to the resolution in the interest of

maintaining the dignity of the court.

"No other person, including clerks, brokers, litigants or the general public, will be allowed to wear advocate's dress i.e. white shirt and black pants in any part of the court premises. The Bar Association will coordinate with the court administration and security staff to ensure the dress code. Violation of this can also attract a fine of Rs 5,000", it read.

Advocate Rahul Dhankar, secretary of the Gurugram District Bar Association, said the resolution aims to check the activities of tout-like persons pretending to advocates in the court premises.

"These types of people wear clothes like lawyers and fool clients by assuring them of legal services and documentation. Security staff at entry gates have been given special instructions to verify the identity of registered lawyers and trainee advocates through Bar Councilissued identity cards or other valid certificates," he said.

Local lawyers welcomed the initiative and said the rule would curb fraud and ensure clients receive secure, reliable legal services.

"The Bar Association has passed this resolution with the objective of maintaining the sanctity, identity and professional distinction of the legal fraternity within the court premises. Dress code decorum for advocates is for a reason and anyone trying to misuse this must be punished", said advocate Kulbhushan Bhardwaj, former president of district bar association, Gurugram.

#### **Vande Bharat Will Bring Hearts Closer, Boost Tourism: Dr Farooq**

#### **Operation Sindoor A Defining** Blow To Terrorism: Rajnath Singh

**DEHRADUN:** Calling terrorism a "curse on humanity" and "an epidemic destined to perish", Defence Minister Rajnath Singh on Tuesday said Operation Sindoor marked the biggest counter-terror offensive in Indian history.

Speaking at a national dialogue on security and terrorism, Singh highlighted the operation as a turning point in India's security posture. The massive cross-border response came in retaliation to the April 22 Pahalgam terror attack that killed 26 civilians. Indian forces targeted nine terror camps in Pakistan and PoK in early May, forcing Pakistan to seek a ceasefire by May 10.

Singh said the Pahalgam attack was aimed at disrupting India's social unity. "India struck back by dismantling terrorist bases. We will not allow such incidents to be repeated," he said.

He asserted that terrorism has no justification-religious, political or ideological—and called Pakistan the "father of global terrorism" for shelter-



ing extremists like Hafiz Saeed and Masood Azhar.

Criticising the UN Security Council's decision to appoint Pakistan as Vice-Chair of its Counter-Terrorism Committee, Singh expressed disbelief. "This country gave refuge to the 9/11 mastermind. It cannot lead a global fight against terror." he said.

The Defence Minister advised Pakistan to seek India's help in fighting terrorism. "If Pakistan can't control terrorism, it should ask for help. Our armed forces have shown their capability during Operation Sindoor," he said.

He also described terrorism as a threat to democracy and peaceful coexistence, calling for global unity in eliminating its infrastructure and funding. "Foreign aid to Pakistan indirectly supports terrorism," he warned.

On domestic preparedness, Singh said the defence sector has become a key pillar of Aatmanirbhar Bharat. "Weapons used in Operation Sindoor were Made-in-India," he said, listing achievements like a jump in defence production from ₹40,000 crore in 2014 to ₹1.3 lakh crore now, and exports from ₹686 crore to over ₹23,000 crore.

Singh also urged citizens to become "social soldiers" by misinformation. combating "Even after military operations stop, information warfare continues. The public must verify facts before sharing content,' he said, adding that cyber security is as critical as border

He concluded by calling on the media to prioritise truth over speed. "Journalism is not just a profession; it is a national duty," he remarked.

To maintain quality and efficiency, he instructed the senior officers of JPDCL and KP-DCL to undertake field visits to inspect the ongoing installations. He stressed the importance of institutional leadership while encouraging the DISCOM employees to set an example by adopting rooftop solar systems themselves.

The Chief Secretary also directed that Common Service Centre (CSC) operators be empanelled to facilitate the consumer registrations at the grassroots level, ensuring ease of access for the rural and remote households.

Reviewing the solarization of government buildings, another critical component of the PMSMBY, the Chief Secretary described it as a prestigious initiative that must be executed with utmost seriousness. He directed the Deputy Commissioners to verify the functionality of each installed rooftop system and submit building-wise status reports by June 30, after coordinating with the JAKEDA for the requisite data.

#### **Statehood In Limbo**

rmer Jammu and Kashmir Chief Minister Dr Farooq Abdullah on Monday reiterated the call for restoration of J&K's statehood, terming it a fundamental demand and an essential step for ensuring governance and development in the region. Speaking to reporters in Ganderbal, Abdullah said that promises made by the Centre in Parliament and before the Supreme Court must be honoured in full.

The demand was also voiced by the NC's additional General Secretary and Former Minister, Ajay Kumar Sadhotra, who said the continued delay in the restoration of statehood to Jammu and Kashmir is severely obstructing its overall development and undermining the aspirations of its people.

Now, the question is whether the centre has any immediate or near-term plan to reinstate statehood? There is no easy answer to this. If the recent statements by the senior union government leadership are anything to go by, there are no signs to this effect. This is a promise whose reiteration by them has been conspicuously absent from any remarks on Kashmir in recent weeks. Prime Minister Narendra Modi too skipped any mention of the J&K statehood in his recent visit to the region to inaugurate Chenab bridge. This, despite the fact that the Chief Minister specifically made this demand in his speech.

However, the PM didn't respond to the demand in his speech unlike in January when he visited to inaugurate Z-Morh tunnel in Sonamarg connecting Kashmir Valley in Ladakh. Also, the central government has never given a timeline for the return of statehood. So, there is a section of people in J&K who believe that statehood might take longer than expected. More so, after the Pahalgam attack and the now paused Operation Sindoor, which has fundamentally altered the geopolitical situation in the region. It remains to be seen whether the transformed context has also altered the centre's priorities in Kashmir. For example, this may have made it more chary of the civilian control of the governance in J&K, especially that of the security situation. But there can also be a counter-argument to this: J&K has been run by a civilian government during its toughest times over the past three decades. And with cooperation from the centre, it could do so again. Ultimately, the question of statehood for J&K may remain unresolved for some time, with both its advocates and detractors watching closely. But eventually, the centre may even pleasantly surprise the people of the union territory.

#### **Let Your Money Do the Work**

In a region where most families rely on a single income, learning how to build passive income could change everything.

'n Kashmir, most households still depend on one person to earn for all. Usually, it's the father or eldest male. His ability to earn often shapes his role in the family. But when ■that income stops, even briefly, families face real trouble.

That's because most people only know one kind of earning: active income. It's the money you make by working. At a job, in a shop, or on a farm. If you can't work, the income stops. And with rising costs and growing needs, that risk is

There's another way: passive income. It's what you earn without showing up every day. Rent, dividends, interestmoney that your money makes. It needs planning, yes, but it offers something active income never can: peace of mind.

Here's a simple example. If you invest 1 crore wisely with a 12% return, you could earn 1 lakh a month, without working. That's steady income for your family, even if life takes an unexpected turn.

It starts with saving, then investing. Build assets, not just bank balances. Don't fall into social traps like lavish weddings or luxury spending. Those don't build wealth. Strategic planning does.

In Kashmir, this shift in mindset could reshape futures. The goal isn't to get rich fast. It's to stay secure, even when life gets hard. Passive income gives you that safety net.

If more people start thinking this way, the financial stress on families could ease. Children wouldn't fear sudden loss. Parents could rest a little easier. And slowly, Kashmir could move from survival mode to financial strength.

## This Eid, Kashmiris **Celebrated Wisely**

Some called it a muted celebration. But in the bakeries, butcher shops and alleyways of Kashmir, people marked Eid with care, restraint and dignity, not absence.

very year, like clockwork, someone says it: Kashmir didn't spend much this Eid.

It's said in newsrooms, shop counters, WhatsApp forwards, and expert panels. The logic is simple: fewer fireworks, fewer shopping bags, fewer sales receipts must mean less celebration, less life.

But what if that reading says more about the expectations of the observer than the choices of the people?

I spent this Eid in Pulwama, and what I saw didn't match the headlines. There was no loud extravaganza, no flood of shoppers choking the roads. But there was movement, warmth, and intention. People bought what they could, and what they needed. A little meat. A pair of sandals for the youngest daughter. Biscuits from the baker, who sold out before noon. There were greetings exchanged, prayers said, homes cleaned, and food shared.

It didn't look like a spectacle. But it looked like life.

In Kashmir, where trauma has bent the shape of daily routine for decades, ordinary days are never entirely ordinary. And special days like Eid carry even more weight. The idea that Kashmiris didn't spend enough this time isn't just wrong — it's lazy. It reduces the complex moral choices of a people to a ledger

What exactly does "not spending" mean? Are we talking about retail figures? Card transactions? Or is it a vague sense, picked up from a few malls and media bytes, that things weren't "bustling enough"? Most of the time, it's that last one — a kind of soft disappointment that Kashmir didn't put on a show.

But why should it? What rulebook says joy must be loud to be real? That dignity must wear designer labels?

There's a quieter kind of celebration that's easy to miss if you're not looking closely. In Pulwama's markets, I saw men weighing mutton in back lanes, teenagers laughing over plastic bangles, and women bargaining for embroidered scarves. These weren't big-ticket purchases. But they weren't nothing. They were what people could afford, what they chose with care.

And in those choices was something deeply human — an economy not of noise, but of

This isn't about glorifying scarcity. Kashmiris, like anyone else, want to live well. They want to provide for their families, enjoy their holidays, feel secure. But when money is tight — and dignity is even tighter — people make trade-offs. They celebrate within limits. They make space for others to do the same. That's not failure. That's wisdom.

There's a popular idea in economics that well-being is best measured by how much people consume. It's a convenient yardstick — neat, countable, visible. But it's not the only one. And it misses something essential, especially in places like Kashmir.

Kashmir's economy, especially during festivals, often follows a different script. It's shaped by things that are harder to quantify — responsibility, memory, restraint. One father told me he bought only one pair of new clothes this year — not for himself, but for his daughter. "That's enough," he said. "She'll remember the day, not the price."

gesture. I think it's a powerful one. In academic terms, this might be called a "moral econ-— one where spending choices are tied to values, not just prices. But you don't need jargon to understand what that means. It's the decision to skip a new outfit so a neighbour can afford meat. It's the refusal to show off when someone else is barely

Some might call that a small

getting by. That kind of thinking runs deep in Kashmir. It comes from generations of living under curfews, shocks, and shutdowns. It comes from remembering what it feels like to have nothing. And from knowing that the measure of a good Eid isn't how much you spent, but whether everyone had

This year, that spirit was alive. You just had to know where to look.

The idea that Kashmir's celebration was "muted" isn't just wrong — it's also telling. It reveals how quickly we confuse visibility with vitality. If it's not on Instagram, did it really happen? If the shops weren't overflowing, was there even joy?

But many Kashmiri households marked Eid without posting a single photo. That doesn't mean they weren't celebrating. It means they were too busy living.

And maybe that's the point we keep missing. In a world that pushes us to consume more, show more, and feel more, all at once, choosing less is sometimes the most radical act.

This year, Kashmiris chose less. But they also chose wisely. They chose deliberately. They chose each other. And in doing so, they reminded us of something we've forgotten: that the economy of dignity doesn't always come with receipts.

So the next time someone says Kashmir didn't spend much this Eid. ask them this: what kind of spending are you looking for? And what kind of economy do you think really matters?

Because from where I stood, among the dust and the chai and the lively exchanges, it didn't look like absence. It looked like endurance. It looked like care. It looked like home

#### 20 Years On, Rural Kashmir's Digital Workers Still Wait

t's been over twenty years. We are the Community Information Centre (CIC) Operators who have served across rural Kashmir under the Rural Development Department. We were hired to help bring digital services to the farthest corners of the region - to connect people with their government. We did our job. We stayed through floods, shutdowns, power cuts, and policy shifts. Yet our jobs remain temporary, our futures uncertain.

When we started, many of us were young graduates. We believed in the project. We believed in our roles. Most of us were posted in remote blocks where we became the first point of contact for people trying to access public services. We helped villagers apply for ration cards, pensions, birth certificates, and other essential records. Our work was recognized by local officials and welcomed by citizens. But year after year, our job status stayed the same — contractual, unstable, underpaid.

Successive governments gave assurances. Regularization was promised, most clearly during the previous tenure of Chief Minister Omar Abdullah. His party's election manifesto in 2014 placed our issue high on the list. It meant something to us at the time. We believed change was coming.

But the promise was never fulfilled. We have met every requirement. Our documentation is complete. Many of us have crossed the age limit for other government jobs. We have no safety net, no pension, and in many cases, not enough income to support our families with dignity. We live from one month to the next, unsure if our next paycheck will even arrive.

This isn't just about employment. It's about recognition. It's about honouring the commitment

made to a workforce that played a quiet but essential role in Kashmir's digital transformation.

We write now with a simple. sincere appeal. Let the government and especially the Chief Minister Omar Abdullah — remember what was promised. We don't ask for favours. We ask for fairness. We ask

## A Helping Hand in the Valley

Without titles or a clinic, a Kashmiri Samaritan helps people name their pain, reach for help, and believe in healing. In a place where silence often hides suffering, his work is changing lives.

ahid Ashraf lives in a modest neighbourhood tucked between the dusty short drive from Srinagar. His home doesn't have a signboard, and he doesn't call himself a therapist. Still, people come.

They come with heavy hearts, scattered thoughts, and stories they haven't told anyone else. Zahid listens. That's where it starts.

"I'm not a doctor," he says, "but I can sit with someone and say: what you're feeling, it's okay. It has a name. And it can get bet-

Zahid, 29, studied psychology in college but never pursued a clinical license. Instead, he made mental health his way of serving people. He talks to those who are hurting, gives them books, tells them they're not alone. And sometimes, when they're ready, he connects them to a therapist.

One of them was Ubaid Manzoor, a 22-year-old who used to sit in silence for hours, lost in his own head. "I didn't know what was happening to me," Ubaid says. "I would get angry without reason. I stopped talking to friends. I thought I was broken."

Zahid noticed him during a neighbour-hood gathering. They talked. Then they talked again. "He gave me a book on depression," Ubaid recalls. "And he said, read just a few pages. I did. That's when it clicked. This is what I've been going through.'

For weeks, Zahid met Ubaid over tea. Sometimes they walked. Sometimes they cooked. Eventually, Zahid helped him book an appointment with a professional. "I was scared," Ubaid says. "But Zahid bhai went with me the first time. He didn't have to, but he did. Now, I smile more. I talk. I feel lighter."

This isn't a formal program. There's no funding, no office, no team. Zahid works alone, often out of his own pocket. He keeps a growing collection of books on anxiety, grief, trauma, and healing. He lends them out, always making sure the person knows

they can return it anytime, or keep it.
In his own words, "A book can be the first



friend that tells you: you're not crazy.'

Sometimes, he hands people a sketchbook. Or tells them to write a poem. Other times, he teaches them to cook. "Cooking helps you focus," he says. "You cut vegetables, you smell the spices, you stay in the moment." In Kashmir, where food is tied to memory and emotion, he finds it an easy doorway to peace.

His house smells of cardamom most evenings. The living room has more books than furniture. On the wall, there's a framed piece of calligraphy that reads: Sabak phir padh sadaqat ka, adalat ka, shujaat ka lines from a famous poem about truth, justice, and courage.

Zahid doesn't speak in big statements. He speaks slowly, gently, often pausing midsentence to search for the right word. But his actions are clear. He volunteers at the local mosque, calls the azan, helps sweep the floors when no one's watching. Last winter, when heavy snow blocked access to a family's house nearby, Zahid and a few boys cleared the path with shovels.

"Kids in the area respect him," says Imtiyaz, a neighbour. "He never preaches. He

In recent years, Zahid started travelling to villages outside Srinagar with NGOs. He

doesn't take a salary. He teaches children and parents about emotional wellbeing. He talks about what sadness feels like, what stress can do to the body, and why it's okay

In one session at a rural school in Pulwama, he asked students to draw what fear looked like. One girl drew a locked door. Another drew a shadow. When they talked about the drawings, some of the children started to open up. "One boy said his uncle died in front of him," Zahid recalls. "He'd never spoken about it. Not once."

Mental health services in Kashmir remain scarce. According to a 2015 survey by Médecins Sans Frontières, nearly 45 percent of the population shows signs of psychological distress. Self-harm cases have lately surged. Therapists are too few, and stigma keeps many away.

"People here don't use the word depression," Zahid says. "They say, 'mera dil ghabraata hai'. They say, 'mujhe neend nahi aati'. We have to meet them where they are." He doesn't claim to fix anyone. "I'm not

the solution," he says. "I just help them see that there is one." What sets Zahid apart isn't just what he

does, it's how he does it. There's no urgency, no saviour complex. He waits. He listens. He treats people like they matter, not like they're a case to be solved.

"I think of it like watering a dry plant," he says. "You don't pull the leaves and say, grow. You give it sunlight. You wait."

Back in his neighbourhood, more young people are following his example. A cousin of his recently started reading about trauma and wants to study counseling. A group of local boys have begun volunteering at oldage homes. Zahid doesn't call this a move-

ment. But it's moving.

When asked why he keeps doing this, even with no money or formal backing, he shrugs. "It's just what makes sense to me," he says. "I know how it feels to be lost in your head. If I can sit with someone for an hour and help them feel seen, that's

## **'Obesity Injections May Have Fewer Weight Loss Effects In Real World'**

New Delhi: Anti-obesity injections may have smaller effects on weight loss in a real-world context compared to clinical trials, as patients tend to discontinue treatment or use a lower maintenance dose, a study in US patients has found.

Semaglutide, sold under the brand names Wegovy and Ozempic, and tirzepatide (Zepbound and Mounjaro) are prescribed for weight management and treating type 2 diabetes by helping patients regulate blood sugar.

The study, published in the Obesity Journal, examined the effects of anti-obesity injectables on weight reduction and blood sugar regulation (glycaemic control) in a real-world setting.

"Our study shows that patients treated for obesity with semaglutide or tirzepatide lost less weight on average in a regular clinical setting compared to what is observed in randomised clinical trials," lead author Dr Hamlet Gasoyan, a researcher with the Cleveland Clinic, US, said.

"According to our data, this could be explained by higher rates of discontinuation and lower maintenance dosages used in clinical practice, compared to randomised clini-



cal trial settings," Dr Gasoyan said.

The researchers examined 7,881 adult patients with an average body mass index (BMI) of over 39 -- classified as 'severe obesity'. Of these, 1,320 had pre-diabetes at the start of the study, which meant they were at a higher risk of developing type 2 diabetes.

The participants were started on obesity treatments between 2021 and 2023 with semaglutide or tirzepatide injectables.

Following up on the participants a year after starting with the treatment, the average weight loss among those who discontinued injections within three months was

3.6 per cent, compared to 6.8 per cent in those who discontinued within 3-12 months.

"Mean percentage weight reduction at one year was 8.7 per cent, and it was 3.6 per cent with early discontinuation (three months), 6.8 per cent with late discontinuation (3-12 months) and 11.9 per cent with no discontinuation," the authors wrote.

Furthermore, those on a high-maintenance dosage -- the amount required to sustain the effects of the medication -- lost 13.7 per cent of their body weight with semaglutide and 18 per cent with tirzepatide, the researchers said.

Among the participants having pre-diabetes, 33 per cent of those who stopped taking injections within three months experienced normal blood sugar levels, compared to 41 per cent who discontinued within 3-12 months, and 67.9 per cent of those who did not discontinue treatment.

#### **Disruption Of Rare Earth Magnet Supplies Beyond 30 Days Can Impact Vehicle Production: Report**

disruption in rare earth magnet supplies lastmagnet supplies and ing beyond a month can impact production of passenger vehicles, including electric models, weighing on the do-mestic automobile industry's growth momentum, a report on Tuesday said.

Rare earth magnets, low in cost but critical in function, could emerge as a key supplyside risk for India's automotive sector if China's export restrictions and delays in shipment clearances persist, Crisil Ratings said in a statement.

The supply squeeze comes just as the auto sector is preparing for aggressive EV rollouts. Over a dozen new electric models are planned for launch, most built on PMSM platforms," Crisil Ratings Senior Director Anuj Sethi said.

While most automakers currently have 4-6 weeks of inventory, prolonged delays could start affecting vehicle produc-tion, with EV models facing deferrals or rescheduling from July 2025, he added.

A broader impact on twowheelers and ICE PVs may follow if the supply bottlenecks persist for an extended period, Sethi said.

"The shortage of rare earth magnets is forcing automakers to reassess supply-chain strategies. Despite contributing less than 5 per cent of a vehicle's cost, these magnets are indispensable for EV motors and electric steering systems," said Crisil Ratings Director Poonam Upadhyay.

Automakers are actively engaging with alternative suppliers in countries such as Vietnam, Indonesia, Japan, Australia, and the US, while also optimising existing inventories,

"With applications across EVs and ICE vehicles, a prolonged supply squeeze could disrupt production of PVs and 2Ws, making this low-cost component a potential highimpact bottleneck for the sector," she said.

Rare earth magnets are integral to Permanent Magnet Synchronous Motors (PMSMs) used in EVs for their high torque, energy efficiency and compact

Hybrids also depend on them for efficient propulsion. In internal combustion engine (ICE) vehicles, the use of rare earth magnets is largely limited to electric power steering and other motorised systems.

The shortage of rare earth magnets is forcing automakers to reassess supply-chain strategies. Despite contributing less than 5 per cent of a vehicle's cost, these magnets are indispensable for EV motors and electric steering systems,"

In April this year, China, the world's dominant exporter of rare earth magnets, imposed export restrictions on seven rare earth elements and finished magnets, mandating export licences.

The revised framework demands detailed end-use disclosures and client declarations, including confirmation that the products will not be used in defence or re-exported to the US.

With the clearance process taking at least 45 days, this added scrutiny has significantly delayed approvals.

And the growing backlog has further slowed clearances, tightening global supply chains.

India, which sourced over 80 per cent of its 540 tonnes magnet imports from China last fiscal, has started to feel the impact.

By end-May 2025, nearly 30 import requests from Indian companies were endorsed by the Indian government, but none have yet been approved by the Chinese authorities, and

no shipments have arrived. During the pandemic earth magnet supplies remained stable, unlike semiconductors, reinforcing reliance on just-in-time inventory without

building strategic buffers. However, while semiconductors have a globally diversified supply base, over 90 per cent of rare earth magnet processing is concentrated in China, with limited short-term alternatives.

Recognising the risk, the government and automakers are taking action on two fronts, Crisil said

In the short term, the focus is on building strategic inventories, tapping alternative suppliers and accelerating domestic assembly under Production Linked Incentive schemes.

### 'Hmm...Something Seems To **Have Gone Wrong': ChatGPT Experiences Global Outage**

penAI's AI chatbot ChatGPT experienced a major global outage on Tuesday, leaving thou-sands of users unable to access the service across multiple continents, with India and the United States reporting the highest number of disruptions.

According to the real-time monitoring platform Downdetector, user reports of Chat-GPT outages surged rapidly around 3:00 PM, with about 800 complaints logged in India alone.

About 88 per cent of complaints from India cited the chatbot not responding to queries, 8 per cent reported issues with the mobile app, and 3 per cent faced API-related problems.

Users attempting to access ChatGPT encountered repeated error messages such as "Hmm...something seems to

have gone wrong" and "A network error occurred. Please check your connection and try again." The outage led to a flurry of activity on social media, with users sharing memes, voicing frustration, and highlighting the growing reliance on AI tools for daily

OpenAI acknowledged the outage on its system status page, confirming that both ChatGPT and its text-to-video platform Sora were affected.

'Some users are experiencing elevated error rates and latency across the listed services. We are continuing to investigate this issue," OpenAI

However, it did not provide a specific timeline for resolution.

#### **US And China Are Holding Trade Talks In** London After Trump's Phone Call With Xi

**LONDON:** High-level delegations from the United States and China met in London on Monday to try and shore up a fragile truce in a trade dispute that has roiled the global

A Chinese delegation led by Vice Premier He Lifeng held talks with US Commerce Secretary Howard Lutnick, Treasury Secretary Scott Bessent and Trade Representative Jamieson Greer at Lancaster House, an ornate 200-year-old mansion near Buckingham

Wang Wentao, China's commerce minister, also was part of Beijing's delegation.

The talks, which may continue on Tuesday, follow negotiations in Geneva last month that brought a temporary respite in the trade war.

The two countries announced on May 12 they had agreed to a 90-day suspension of most of the 100 per centplus tariffs they had imposed on each other in an escalating trade war that had sparked fears of recession.

The US and China are the world's biggest and secondbiggest economies. Chinese trade data shows that exports to the United States fell 35 per cent in May from a year earlier.

Since the Geneva talks, the US and China have exchanged angry words over advanced semiconductors that power artificial intelligence, visas for Chinese students at American



universities and "rare earth" minerals that are vital to car makers and other industries.

President Donald Trump spoke at length with Chinese leader Xi Jinping by phone last Thursday in an attempt to put relations back on track. Trump announced on social media the following day that the trade talks would resume



in London.

Rare earths were expected to be a focus of the talks. The Chinese government started requiring producers to obtain a licence to export seven

rare earth elements in April. Resulting shortages sent automakers worldwide into a tizzy. As stockpiles ran down, some worried they would have to halt production. Beijing indicated Saturday

that it is addressing the concerns, which have come from European companies as well Kevin Hassett, a US econom-

ic adviser, told CNBC on Monday that he expected a short meeting with "a big, strong handshake" on rare earths.

The UK government says it is providing the venue and logistics but is not involved in the talks, though British Treasury chief Rachel Reeves met with both Bessent and He on Sunday, and UK Business Secretary Jonathan Reynolds was due to meet Wang.

'We are a nation that champions free trade and have always been clear that a trade war is in nobody's interests, so we welcome these talks," the British government said in a

#### **Uber To Launch Driverless Taxis In London Next Year**

LONDON: Ride-hailing firm Uber will launch self-driving taxis in London next year when England trials new driverless services, the firm and the UK government said on Tuesday.

Under the Uber pilot scheme, services will initially have a human in the driver's seat who can take control of the vehicle in an emergency, but the trials will eventually transition to being fully driverless.

The government announcement will see companies, including Uber, being allowed to trial commercial driverless services without a human presence for the first time in the UK. They will include taxis and "bus-like" services.

Uber CEO Andrew Macdonald described London's roads as "one of the world's busiest and most complex urban environments".

"Our vision is to make autonomy a safe and reliable option for riders everywhere, and this trial in London brings that future closer to reality," he said.

Members of the public will be able to book the transport via an app from spring 2026, ahead of a potential wider roll-out when new legislation -- the Automated Vehicles Act -- becomes law from the second half of 2027, the Department for Transport added.

The technology could create 38,000 jobs, add £42 billion (\$57 billion) to the UK economy by 2025, and make roads safer,

"The future of transport is arriving. Self-driving cars



and the opportunity for the UK to be among the world-leaders in new technology," Transport Secretary Heidi Alexander said.

'We can't afford to take a back seat on AI.... That's why we're bringing timelines for-ward today," added Technology Secretary Peter Kyle.
The wider rollout will also

allow the sale and use of selfdriving, private cars.

Driverless vehicle have been underway in the UK since January 2015, with British companies Wayve and Oxa "spearheading significant breakthroughs in the technol-

ogy", the ministry said.
"These early pilots will help build public trust and unlock new jobs, services, and markets," said Wayve CEO Alex Kendall.

According to the government the forthcoming legislation will require self-driving vehicles to "achieve a level of safety at least as high as competent and careful human drivers".

"By having faster reaction times than humans, and by being trained on large numbers of driving scenarios, including learning from real-world incidents, self-driving vehicles can help reduce deaths and inju-

#### **CS For Giving Solar Power Push To Energy Sector**

**SRINAGAR:** Chief Secretary, Atal Dulloo, today chaired a high level meeting to review the progress achieved under the PM Surya Ghar: Muft Bi-jli Yojana (PMSMBY), a flagship initiative aimed at promoting solar energy through rooftop installations for the households and solarization of government buildings across the country.

The meeting was attended by Principal Secretary, Power Development Department (PDD); Principal Secretary, Finance; Managing Directors of JPDCL and KPDCL; Deputy Commissioners; CEO JAKEDA; Chief Engineers of KPDCL/JP-DCL and other senior officials. Taking stock of the rooftop

solar installations across the districts, the Chief Secretary emphasised the need for timebound implementation. He directed the DISCOMs, JPDCL and KPDCL, to ensure that the vendors complete installations in the shortest possible time. Dulloo impressed upon the

Deputy Commissioners to personally monitor the progress on rooftop solar projects in their respective districts and ensure timely completion, enabling the consumers to experience minimal delays. He also reviewed the status of applications and installations district-wise and sought a strategy from each DC to fasttrack execution. To maintain quality and effi-

ciency, he instructed the senior

officers of JPDCL and KPDCL to undertake field visits to inspect the ongoing installations. He stressed the importance of institutional leadership while encouraging the DISCOM employees to set an example by adopting rooftop solar systems themselves.

The Chief Secretary also directed that Common Service Centre (CSC) operators be empanelled to facilitate the consumer registrations at the grassroots level, ensuring ease of access for the rural and remote households.

Reviewing the solarization of government buildings, another critical component of the PMSMBY, the Chief Secretary described it as a prestigious initiative that must be executed with utmost seriousness. He directed the Deputy Commissioners to verify the functionality of each installed rooftop system and submit buildingwise status reports by June 30, after coordinating with the JAKEDA for the requisite data.

Speaking on the occasion, Principal Secretary, Finance, Santosh D. Vaidya, stressed the need to involve the local contractors in solarisation drive by registering them as vendors and incentivising their participation. He underlined that the scheme's momentum hinges on the proactive involvement of local players, both from a developmental and entrepreneurial standpoint besides ensuring its completion on time.

## Iran Looks for Planes and Partners in Post-Sanctions Order

ran's national airline is preparing for the day when it's finally released from the US sanctions that have worn down its fleet and crimped access to other nations.

With nuclear talks under way between Iran and the US, executives from Iran Air used the annual gathering of the International Air Transport Association in New Delhi last week to sound out potential airline partners and suppliers who were in attendance, according to people familiar with the matter.

Iran Air executives made contact with representatives from Japan Airlines Co., Vietnam Airlines and Royal Air Maroc as it seeks to line up codeshare agreements, the people said, asking not to be named discussing private matters. The encounters were mostly ad-hoc, they said, given the conference-hall setup and the sensitivities of doing

business with Iran. Executives from the stateowned carrier also dropped into an evening reception sponsored by Boeing Co. as they consider which aircraft Iran Air might acquire should US-made jets become accessible again, the people added. Tehran-based Iran Air is eager

to expand its operations to meet rising travel demand and is actively seeking new aircraft, spare parts and partnerships with carriers that fly to destinations it's currently barred from serving, the people said.

The carrier aims to increase its fleet from fewer than 50 mostly grounded aircraft to at least 100 through direct purchases, if permitted, or by acquiring secondhand jets from foreign markets, the people said.

US President Donald Trump's freewheeling approach to trade and foreign policy suggests the current diplomatic push could potentially lead to an opening for Iran Air after decades of restrictions. Boeing purchases took center stage in Trump's recent Middle East trip, and were featured



in a trade deal with the UK.

As yet, there's no sign of a breakthrough. Supreme Leader Avatollah Ali Khamenei last week pushed back against US pressure to cease Iran's uranium enrichment programs, calling US demands "arrogant" and vowing not to give in.

Last week's concentration of hundreds of aviation executives at the IATA event presented a prime opportunity for Iran Air to establish contacts, even where agreements aren't currently pos-

sible. Several executives from carriers in countries that have normalized ties with Tehran say they are unlikely to sign pacts that could impair relationships with other airline partners. For years, the sale of US-origin

aircraft or related goods, technology or services to Iran has been barred without prior authorization, with violations subject to civil and criminal enforcement action by the Treasury's Office of Foreign Assets Control. The European Union has also imposed

Under the US-led sanctions, Boeing and Airbus SE can't discuss plane or parts sales with Iran without a license. While there was brief contact between Boeing and Iran Air officials at the IATA reception, there were no commercial discussions, people familiar with the interaction said.

A Boeing representative declined to comment. Iran Air and Vietnam Airlines didn't immediately respond to requests for comment, while a spokesman for Royal Air Maroc said "no contact whatsoever took place between officials from the two companies in New Delhi."

A Japan Airlines spokesman said an Iran Air representative came by, but there was no substantial exchange of information. Iran has faced suspicion for years over its nuclear ambitions and whether it's developing the ca-

pability to fire an atomic weapon. Since returning to the White House, Trump has said he wants a new agreement with Tehran, and the two sides kicked off fresh nuclear talks in mid-April. He is pouring on "maximum pressure" to speed the slow-moving talks, even drawing in Russian President Vladimir Putin for as-

Iran Air has a lot to gain from a breakthrough. Since its founding more than a half-century ago, the carrier has struggled to establish itself in a competitive interna-

tional market. US sanctions dating back to the 1979 Islamic Revolution have forced the airline to operate aging aircraft, sometimes cannibalizing grounded planes for spare parts, while remaining largely

isolated from global markets. The average in-service aircraft at Iran Air is over 20 years old, according to data from aviation

consultancy Cirium. In 2024, the EU also barred Iran Air from flying into the bloc because of Iran's support for Russia. Among the airlines that still fly into Tehran are Emirates, Qatar Airways, Turkish Airlines and

Deutsche Lufthansa AG. Unlike most carriers, Iran Air handles nearly all of its own maintenance and relies on a network of brokers to source second-

Iran Air is interested in acquiring jets from Boeing and Airbus, and has little appetite for Russian or Chinese alternatives, according to the people. In one recent deal, it obtained two used Airbus A330-200s from China, they said. With expansion in Europe curtailed, the company is looking to add services in Asia, including China, Thailand, Japan, India and Ma-

laysia, the people said. Iran Air's longstanding maintenance workarounds, use of brokered parts and domestic repair shops present obstacles to a full reintegration with global networks. These practices have kept the fleet flying through the sanctions, though adding operational risks but their hodgepodge maintenance make Iran Air planes difficult to certify.

## India's Population Touches 1.46 Billion, Fertility Drops Below Replacement Rate: UN Report

New Delhi, June 10: India's population is estimated to reach 1.46 billion in 2025, continuing to be the highest in the world, according to a new UN demographic report, which also revealed the country's total fertility rate has fallen below the replacement

UNFPA's 2025 State of World Population (SOWP) Report, The Real Fertility Crisis, calls for a shift from panic over falling fertility to addressing unmet reproductive goals.

Millions of people are not able to realise their real fertility goals, it asserts.

This is the real crisis, not underpopulation or overpopulation, and the answer lies in greater reproductive agency – a person's ability to make free and informed 150 per cent choices about sex, contraception and starting a family, it says.

The report also reveals key shifts in population composition, fertility, and life expectancy, signalling a major demographic transition.

The report found that India's total fertility rate has declined to 1.9 births per woman, falling below the replacement level of 2.1.

This means that, on average, Indian women are having fewer children than needed to maintain the population size from one generation to the next, without migration.

Despite the slowing birth rate, India's youth population remains significant, with 24 per cent in the age bracket of 0-14, 17 per cent in 10-19, and 26 per cent in 10-24.

The country's 68 per cent of the population is of working age (15-64), providing a potential demographic dividend, if matched by adequate employment and policy support.

The elderly population (65 and older) currently stands at seven per cent, a figure that is expected to rise in the coming decades as life expectancy improves. As of 2025, life expectancy at birth is projected to be 71 years for men and 74 years for women.



According to the UN estimates, India's population at present stands at 1,463.9

India is now the world's most

populous nation, with nearly 1.5 billion people – a number expected to grow to about 1.7 billion before it begins to fall, around 40 years from now, the

eport said.

Behind these numbers are the stories of millions of couples who decided to start or expand their families, as well as the stories of women who had few choices about whether, when or how often they became pregnant, the report said.

In 1960, when India's population was about 436 million, the average woman had nearly six children.

Back then, women had less control over their bodies and lives than they do today. Fewer than 1 in 4 used some form of contraception, and fewer than 1 in 2 attended primary school (World Bank Data, 2020), the report said.

But in the coming decades, educational attainment increased, access to reproductive healthcare improved, and more women gained a voice in the decisions that affected their lives. The average woman in India now has about two children.

While women in India, and every other country, have more rights and choices today than their mothers or grandmothers did, they still have a long way to go before they are empowered to have the number of children they want, if any, when they

want them.

The UN report placed India in a group of middle-income countries undergoing rapid demographic change, with population doubling time now estimated at 79 years.

"India has made significant progress in lowering fertility rates – from nearly five children per woman in 1970 to about two today, thanks to improved education and access to reproductive healthcare," said Andrea M Wojnar, UNFPA India Representative.

"This has led to major reductions in maternal mortality, meaning million more mothers are alive today, raising children and building communities. Yet, deep inequalities persist across states, castes, and income groups.

"The real demographic dividend comes when everyone has the freedom and means to make informed reproductive choices. India has a unique opportunity to show how reproductive rights and economic prosperity can advance together," she said. (Agencies)

Earlier on Tuesday, Minister Sakina Itoo, who chaired the sub-committee, provided an update on the progress. "The Cabinet Sub-Committee constituted to examine the issue of reservations has drafted its report within the stipulated time frame of six months. The report will be placed before the Cabinet when it meets," Itoo said in a post on X.

The committee was constituted in response to widespread concerns following a March 2024 amendment to the Jammu and Kashmir Reservation Act, 2004, under the administration of Lieutenant Governor Manoj Sinha. The amendment increased reservations in government jobs from 43% to 70%, largely due to the inclusion of the Pahari community under the Scheduled Tribe (ST) category.

The policy sparked protests and opposition from several quarters, prompting then-Chief Minister Omar Abdullah to establish the Cabinet Sub-Committee to reassess the implications of the move. The panel was given six months to complete its review.

"Preliminary investigation revealed that the accused had downloaded the SSP's photo from the internet with the intent to impersonate a police officer," a police official said.

Further inquiry uncovered that Parray had been involved in online gambling for the past year, actively using platforms like 'Aviator' and '777'. Investigators said he had made advance payments on the '777' platform and later used the impersonated identity to pressure the organisers into refunding the money he had lost.

Authorities are now conducting a deeper analysis of his digital devices to determine if Parray has links to any other criminal or antinational activities.

Police have urged the public—especially youth—to stay away from online gambling apps, warning that such platforms are often fronts for exploitation and can lead to involvement in illegal or anti-social activities.

**LONDON:** Marnus Labuschagne has moved one place up the batting order to open with Usman Khawaja for Australia in the World Test Championship final against South Africa at Lord's from Wednesday.

Labuschagne's place in the team was in doubt after a lean 2023-25 WTC cycle — average 28.33 runs – but he was given another shot on Tuesday by Australia's failure to find a permanent replacement at opener for David Warner, who retired from tests in January 2024. Labuschagne will open in a test for only the second time in nine years.

"It's one spot up really. It's not too different to batting three," captain Pat Cum-mins said. "Marnus has done well here at Lord's (average 45.33) and in England in general (average 39.36).

"Opening the batting can be tough, but it can also be sometimes the best time to bat, before the Dukes ball actu-

ally starts swinging. There's an opportunity to score there, so just keeping

that ball in tow I think is going to mean

The 19-year-old specialist opener Sam Konstas was left out and Travis Head, preferred in Sri Lanka in February, will drop back to No. 5 in the order. Konstas was disappointed, Cummins said.

"Realistically, he's really young, he's got a long career ahead of him," he added. Fit-again Josh Hazlewood was picked ahead of the unlucky Scott Boland in the pace attack. Boland replaced an injured Hazlewood for the 2023 final and starred as Australia beat India by 209 runs at the
