Middle East On Brink As Israel Strikes Iran

Iran's Nuclear Sites & Military Leadership Hit, Middle East Braces For Retaliation

Srinagar: Israel launched a massive attack on Iran early Friday targeting the country's nuclear program and killing half a dozen top military commanders and at least six nuclear scientists. This is the most significant attack on Iran since the 1980s Iraqi invasion, raising the potential for an allout war between the two bitter Middle East adversaries.

Top military leadership and several veteran nuclear scientists including Dr Fereydoon Abbasi and Prof Mohammad-Mehdi Tehranchi were assassinated in the initial Israeli strike.

Iran Loses Top Commanders, Names Successors

Chief of Staff of the Iranian Armed Forces Major General Mohammad Hossein Bageri, IRGC Commander Maior General Hossein Salami, Commander of Iran's Khatam al-Anbia Central Headquarters Major General Gholam Ali Rashid, Brigadier General Amir Ali Hajizadeh, Commander of Aerospace Force of the IRGC were confirmed to have been assassinated by series of air strikes and Mossad operations on ground in Tehran in the early hours of Friday.

Unconfirmed reports said Quds Force chief Brigadier General Esmail Ghaani too was among those targeted.

The IRGC announced in a statement on Friday that "Brigadier General Hajizadeh was martyred in a terrorist strike by the Zionist regime on an IRGC center in the wee hours of Friday".

srael's unprecedented attack on Iran has triggered widespread condemnation from political and religious leaders across Jammu and Kashmir, who have labelled the move as unjustified, provocative, and a serious threat to global peace. Leading the chorus, Mirwaiz Umar Farooq, the chief cleric of Kashmir, denounced Israel's actions during his Friday sermon at Srinagar's historic Jamia Masjid. Describing Israel as a "rogue state and a huge threat to world peace," the Mirwaiz expressed outrage over the killing of Iranian civilians, including women and children, in the strike.

"Besides perpetuating genocide on hapless Palestinians and getting away with it, Israel is now putting the whole Middle East in peril," he said, calling upon the international community, especially the United Nations, to intervene and restrain Israel from launching attacks on sovereign nations. | More on P10

Air India Plane Crash: Black Box Recovered

Ahmedabad: The black box of the Air India AI171 has been found on the rooftop of the building where the flight had crashed, reports said on Friday.

Police sources told Reuters that one of the two black boxes has already been located, though it remains unclear whether it is the flight data recorder (FDR) or the cockpit voice recorder (CVR). NDTV reported that the black box was found on the rooftop of the building.

There is no clarity if the second unit has been found.

The search for the aircraft's black box had taken centre stage as investigators continued to piece together what caused Air India flight AI171 to crash just minutes after takeoff.

The flight data and cockpit voice recorders — collectively known as the black box - are considered critical in unravelling the factors that led to the tragedy.

Emergency teams with specialised equipment, including metal cutters, have been deployed at the wreckage site in Ahmedabad's Meghaninagar area to recover the device. The Telegraph reported that

the DVR of CCTV cameras of BJ Medical College hostel, where the plane crashed, has been taken into custody by police. A DVR is an electronic device

designed to record and store video footage from CCTV cameras.

Srinagar: As Jammu and Kashmir continues to reel under an intense heatwave, the Meteorological Department has issued 'orange' and 'yellow' alerts for the next six days, warning of isolated heatwave conditions and gusty winds till

According to the MeT, hot and dry weather will persist over the next 24 with temperahours, remaining above normal across the Union Territory. Light showers in Srinagar and some other areas on Thursday evening,

however, offered slight respite from the soaring temperatures.

An orange alert has been issued for Saturday (June 15), indicating severe weather conditions, while yellow alerts have been sounded for June 15, 16, 18, and 19.

"There is a possibility of brief spells of light rain and thundershowers at isolated to scattered places from June 16 onwards. accompanied by gusty winds," said Dr Mukhtar Ahmad, Director of the Meteorological "Between Department. June 17 and 20, the weather will remain mainly hot

DLSA Conducts Inspection Of Central Jail

Israeli Attack Followed Trump's 60-Day Deadline to Iran

Srinagar- President Donald Trump issued a warning to Iran following a major Israeli attack, cautioning Tehran against retaliation. The strikes, which took place on the 61st day after a U.S.backed ultimatum to Iran, were reportedly coordinated with the Trump administration, according to Israeli sources.

Though the air assault was carried out solely by the Israeli Air Force, senior officials in Jerusalem emphasized that the operation was not unilateral. Contrary to Secretary of State Marco Rubio's earlier comments, Israeli officials stated that President Trump had been in close contact with Prime Minister Benjamin Netanyahu and had agreed to the timing of the strikes, marking a significant escalation in the standoff with Tehran.

"Israel acted after the deadline," said one Israeli security source, referring to the two-month window the Trump administration had reportedly given Iran to return to the negotiating table. "The 60-day warning passed. On day 61, Israel struck.

Speaking to Fox News shortly after the operation began, President Trump confirmed the U.S. had prior knowledge of the airstrikes but did not participate militarily. Still, he signaled strong backing for the operation and indicated readiness to defend U.S. and Israeli interests in

"We will defend ourselves, and we will defend Israel,' Trump said. "Several people in leadership [in Iran] will not be coming back," he added, hinting at the reported deaths of senior Iranian officials.

Despite the military escalation, Trump left the door open for diplomacy. "We still want to talk," he said. "But Iran needs to understand—they cannot have a nuclear bomb. That is non-negotiable.

Iran insists it maintains a civilian nuclear programme as weapons of mass destruction are forbidden in Islam

Meanwhile Iranian military spokesperson accused the U.S. of facilitating the Israeli attack, claiming residential areas were targeted and threatening retaliation. "Israel acted with U.S. help... It will pay a heavy price," he said.

Meanwhile, American officials confirmed that the U.S. had recently restocked Israel's Iron Dome interceptor supply and maintained close coordination with allies in the region, though they stressed that Washington had no direct role in the strikes.

According to Israeli security sources, the current phase of hostilities could last at least two weeks, with the potential for U.S. involvement if Iran retaliates. The U.S. Central Command remains on high alert, and President Trump is expected to attend a National Security Council meeting to assess the

Middle East Airspace Shut After Israel Strikes Iran, **Airlines Cancel Flights**

SEOUL/LONDON, June 13 (Reuters) - Airlines steered clear of much of the Middle East on Friday after Israeli attacks on Iranian sites forced carriers to cancel or divert thousands of flights in the latest upheaval to travel in the region.

Israel on Friday said it targeted Iran's nuclear facilities, ballistic missile factories and military commanders at the start of what it warned would be a prolonged operation to prevent Tehran from building an atomic weapon.

Tel Aviv's Ben Gurion Airport was closed and Israel's air defence units stood on high alert for possible retaliatory strikes from Iran.

Israel's El Al Airlines (ELAL. TA), opens new tab said it had suspended flights to and from Israel as did Air France KLM (AIRF.PA).

With Russian and Ukrainian airspace closed due to war, the Middle East region has become an even more important route for international flights between Europe and Asia.

DGCA orders enhanced inspection of Air India's Boeing 787 Dreamliner fleet

New Delhi: Aviation watchdog DGCA on Friday ordered enhanced safety inspection of Air India's Boeing 787 Dreamliner fleet powered by GEnx engines, a day after 241 people on board died in the plane crash in Ahmedabad.

The enhanced DGCA inspection will include checks of various systems and a review of takeoff parameters of the Boeing 787 Dreamliner aircraft of Air India owned by Tata Group.

There are 26 Boeing 787-8s and 7 Boeing 787-9s in the Air India fleet.

The Directorate General of Civil Aviation (DGCA) has directed Air India to carry out additional maintenance actions on its Boeing 787-8 and 787-9 planes equipped with Genx engines with immediate effect.

These actions will be carried out in coordination with the DGCA regional offices concerned.

Air India's Boeing 787-8 Dreamliner aircraft, operating a flight from Ahmedabad to London Gatwick, crashed soon after the take-off on Thursday afternoon. Out of the 242 people on board the plane, only one person survived. With effect from January 15, the regulator has ordered various

planes, including inspection of fuel parameter monitoring and associated system checks. Inspection of cabin air compressor and associated systems, electronic engine control system test, engine fuel driven actuator-

"Iran's leadership is likely reeling, but that paralysis is unlikely to last," Sina Toossi, senior fellow at the Center for International Policy, said in a statement, CNN reported.

"A large-scale retaliation, likely involving drone and missile strikes into Israeli territory, appears imminent," Toossi said, adding that "rather than crippling Iran's military and nuclear capabilities, Israel's escalation risks fueling nationalist sentiment, solidifying internal cohesion and triggering a dangerous cycle of retaliation, all while increasing the likelihood of American entanglement."

Trita Parsi, executive vice president of the Quincy Institute in Washington, DC, told CNN that it would be difficult for Iran not to retaliate. adding that Iran's response is likely to be bigger than its attack in October, which saw

Iranian missiles attack Israeli military sites.

Having Seat Near Emergency Exit Door Saved Lone Survivor's Life?

The Boeing 787-8 aircraft, better known as the Dreamliner, operating the Ahmedabad-London AI171 flight, had 242 people on board, including 12 crew members.

While it might be too early to conclude on the factors that helped Ramesh exit the aircraft that went up in flames, being seated near the emergency exit door could be one of the reasons for his miraculous escape.

Currently, there are 27 B787-8 planes in the Air India fleet and each of them has 238 economy and 18 business class seats.

All these aircraft are set to go for retrofit in the coming months.

Air India has confirmed that 241 people on board the AI171 flight have died.

SDA Issues Advisory On Cleanliness, Safety Measures

SRINAGAR: With the rising temperatures and increasing influx of both local and non-local tourists at the popular destination of Sonamarg, the Sonamarg Development Authority (SDA) has issued an advisory to ensure the safety of visitors and the protection of the environment.

According to an advisory, a copy of which lies Kashmir Observer, the SDA said that it has been observed that many visitors, including children are entering the River Sindh-especially in areas from Gagangir to Fish Point-to seek relief from the ongoing heatwave.

These water bodies are extremely unsafe for bathing due to their unpredictable currents and hidden dangers, which can lead to fatal drowning incidents, reads the advisory.

The Sonamarg Development Authority strongly advised people not to enter or bath in the River Sindh, or any river, stream or waterfall in Sonamarg.

"To maintain cleanliness and environmental safety, visitors and campers are advised, Do not erect tents in close proximity to the River Sindh, Avoid disposing of garbage in open surroundings, Collect all waste and dispose of it responsibly in designated dustbins placed across Sonamarg," it reads.

The SDA urged all visitors to act responsibly and cooperate in preserving the sanctity and safety of this breathtaking tourist destination. "Let us all work together to keep Sonamarg clean, safe, and welcoming for everyone," reads the advisory.

Marhama Bijbehara Residents **Demand Basic Amenities**

SRINAGAR: Scores of residents from Marhama village in Bijbehara area of South Kashmir's Anantnag district staged a pro-test on Friday, demanding immediate attention towards the basic infrastructural needs of the area, including proper electricity, drinking water, irrigation facilities and healthcare services.

Chanting slogans, the protesting villagers assembled in main Marhama locality and urged authorities to wake up from what they termed as a

"deep slumber" and fulfill their long-pending demands. Talking to KNO, a local resi-dent said, "Just few mohallas of our village have been receiving proper power supply while the rest are being neglected and no attention is being given towards them.'

He said that if the whole village pays the same fee then why some areas are witnessing step motherly treatment.

Residents also complained about the lack of potable water. "We are forced to fetch unclean water from a nearby stream. This poses serious health threats, especially for children and elderly."

Locals said that a water supply scheme was constructed in the area years before, but it was unable to cater to the whole village that consists of over 18000

Being a predominantly agrarian village, Marhama residents also voiced concern over poor irrigation facilities. "We depend on agriculture for livelihood, but without a proper irrigation system, our fields remain dry during crucial months. Canals are choked or broken and lift irrigation pumps don't work," said Ghulam Mohammad, a farmer.

He said that Awantipora canal passes through the village that is providing water to over 20 villages but not to this village.

The villagers also lamented the absence of a proper healthcare facility in the area, adding that the staff has been drawing salary from PHC Marhama but have been posted at other places.

In absence of technicians various machines are lying defunct at the centre even as a gynaecologist was posted in PHC Marhama, who has been attached to SDH Bijbehara, thus leaving locals to lurch at large.

According to KNO, the protestors appealed to Lieutenant Governor Manoj Sinha, Chief Minister Omar Abdullah, Deputy Commissioner Anantnag and concerned departments to intervene into the matter and take necessary steps to improve infrastructure and provide relief to the neglected population of Marhama.

Two Killed As Car Overturns On Jammu-Udhampur Highway

UDHAMPUR: At least two persons lost their lives while another sustained injuries in a tragic road accident that oc-curred near Prince Dhaba on the Jammu-Udhampur National Highway in Udhampur district on Friday.

According to officials, the mishap took place when a Swift car bearing registration number JK21K-9427, traveling from Jammu towards Udhampur, lost control and overturned near the popular roadside eatery.

The impact of the crash proved fatal for two occupants of the vehicle. The deceased were identified as 40-yearold Sunil Verma, son of Faquir Chand, and Ashik Kumar – both residents of RS Pura. Another

occupant, Sham Singh Rajput, aged 35 and also a resident of RS Pura, sustained injuries and was rushed to a nearby hospital where he is currently undergoing treatment.

According to KNT, Prelimi-

nary reports suggest that overspending may have been the cause of the accident, though authorities have yet to confirm the exact reason pending further investigation. The sudden demise of the two

men has sent shockwaves through their native locality of RS Pura, with grieving families calling for stricter enforcement of traffic regulations on the highway.

Police have taken cognizance of the incident and launched an inquiry to ascertain the exact circumstances that led to the

HC Rejects Anticipatory Bail in Rape-by-Deceit Case

SRINAGAR: In a key ruling under India's new criminal code, the High Court of Jammu and Kashmir and Ladakh rejected the anticipatory bail plea of a man accused of rape under false promise of marriage, citing prima facie evidence of prolonged deception and sexual exploitation initiated through social media.

The case, registered under Sections 69 and 351(3) of the Bharatiya Nyaya Sanhita, involves allegations by a woman who claimed that Shakir-ul-Hassan began an intimate relationship with her in 2021, promised marriage, lived with her in Anantnag and Delhi, introduced her as his wife, borrowed Rs 10 lakhs, and ultimately sexually assaulted her in March 2025. She further alleged threats and assault by his family when she raised her voice.

Justice Sanjay Dhar, while rejecting bail for the main ac-

cused, quashed the FIR against his family, ruling their involvement was not substantiated. He emphasised that granting bail at this stage could jeopardise vital digital evidence and discourage other victims from coming forward.

The accused claimed the relationship was consensual and the case was retaliatory, citing the woman's alleged criminal background. The Court, however, found the timing of the countercomplaint suspect, and upheld the FIR as valid.

Justice Dhar underlined that rape through deceit, especially via social media, is a serious charge under Section 69 of BNS, and said anticipatory bail cannot be presumed in such cases. The judgment underscores the growing importance of electronic evidence and sets a precedent in handling sexual abuse cases involving manipulation and betrayal of trust. (CNS)

A Dangerous New Front

srael's reckless airstrikes on Iran's nuclear and military infrastructure, and Tehran's vow of "bitter revenge," threaten to pull the entire region into an unpredictable spiral of escalation. And this would be too much to take for a region already exhausted by the Israel-Palestinian conflict.

Although, Israel has earlier also attacked Iran, the direct, large-scale strikes deep inside Iranian territory, killing top military commanders and nuclear scientists seems to have crossed a dangerous threshold. This has left Iran no option to back down, putting the entire region on the edge of a precipice.

The conflict has already led to a rise in oil prices, shutdown of regional airspace, and dipping of global stock markets on fears of a broader conflict. Iraq, Jordan and Israel have all sealed their skies in anticipation of missile and drone attacks. Iran sees America's unwavering military support for Israel as an endorsement of the strikes. This perception almost guarantees that US military bases in Iraq, Syria or the Gulf could become targets if Tehran decides to retaliate beyond Israel's borders, as Iran has itself made it clear.

The Middle East is already in the middle of several conflicts, most visible of them being the Israel's 20 month long assault and siege of Gaza, which has killed close to sixty thousand Palestinians so far and by and large levelled the place. Israel has also put restrictions on the supply of aid to this tiny strip of land, housing over two million people. The United Nations has now called Gaza, the hungriest place on earth. Then there are conflicts in Yemen, Syria, Lebanon, with Israel involved in each of them. The new front with Iran opened by Israel threatens to reignite and worsen these conflicts. This can draw Israel and the US deeper into a regional war that no one can truly win.

Amid this, the nuclear question looms large. Iran, which denies pursuing a bomb, is now more likely than ever to double down on its enrichment programme, arguing that only nuclear deterrence can protect it from existential threats. The collapse of trust and the death of diplomacy will push the region further from dialogue and closer to disaster.

The world must recognise that this is not just an Israel-Iran feud; it is a spark that could engulf an entire region. Regional leaders, major powers, and international organisations must act urgently to halt the slide towards all-out war. Failure to do so will deepen instability, inflame sectarian divides, disrupt global energy markets, and condemn millions more to the misery of endless conflict. The Middle East cannot afford another war. Neither can the world.

Kashmir's Timeless Culture of Ageing Well

As science pushes the boundaries of ageing, a Kashmiri judo coach wonders if the secret to longer, happier lives lies not in labs, but in orchards, poetry, and the slow rhythm of home.

n the hills above Shopian, there was a man known only as "Mujah Baba." No one knew his real name or age. He kept bees. He drank a glass of raw milk every morning. His skin was leather, but his grip was strong enough to break open walnuts.

Some said he was 100. Others said older. He never said anything. Just smiled and went on collecting honey like time owed him nothing.

I think of him often these days, especially when I read about scientists promising to extend life with stem cells, gene editing, precision pills. They say we could soon live to 120, maybe more. But I wonder: what for?

In Kashmir, we've already seen people stretch the limits of age. They did it without doctors. Without diagnostics. They did it quietly, by living the kind of life that's disappearing fast.

It wasn't built on supplements or gym memberships. It was built on hard work, silence, and a kind of patience you don't learn from books.

There was rhythm to their days. They rose before the sun, worked in fields, walked to springs for water, and returned home with stories carried on their shoulders like firewood.

Meals were simple but complete. Roti and rice, curd, homegrown vegetables, fruits like bananas, apples, mulberries; eggs fresh from backyard hens; chicken or meat when available. All of it was cooked with what came from their own land. Nothing was artificial, nothing came with a barcode.

They didn't snack. They didn't scroll. They chewed slowly and rarely ate alone.

Longevity wasn't something they spoke of. It just happened. Because they didn't fight time. They moved with it. Now, things are changing.

As a coach, I see it firsthand. Young athletes, full of potential, struggling with the basics. Some can't sleep without pills. Others complain of constant body aches, slow recovery, or fatigue that doesn't match their age. They train hard, but something's missing.

It reminds me of when I first left Kashmir to join the national judo camps. I was still young, unsure, but naturally strong. The coaches and other athletes noticed. "This girl is built different," they'd say. And it wasn't just about my

Yes, I had never touched a supplement. I didn't even know what creatine or protein powders were. I ate whatever was cooked at home: bananas, eggs, chicken, vegetables, rice, whatever our land gave us.

But it wasn't just my diet. What truly made me strong was the mental strength to not give up. I didn't even know how to use a gym, but I could lift another person on my shoulders and keep going. That came from willpower, not whey powder.

Today, I see a rise in giving up. Small pains lead to big doubts. Minor setbacks feel like defeat. The body doesn't break first, the mindset A miracle drug won't fix broken families. what do we really want? The truth is, longer life doesn't come from the future. It comes from memory.

Because this is what science promises—but

I remember my friend's great-grandmother oiling her hair with walnut oil, sitting under a pear tree, humming half-remembered lullabies. She was nearly blind, but she knew the steps of her courtyard better than my friend knew the city bus routes.

She lived to 96. No check-ups. No panic. Just grace, and a steady grip on this world.

She had everything we're trying to buy back now: gut health, mindfulness, sleep hygiene, community

But these aren't trends. They were once nor-

So what happens when medicine starts giving us longer lives, but our bodies are wired for burnout, and our minds are already ageing from overstimulation?

What good is a second century if your soul feels worn out at 40?

And so, while the world rushes to hack death, I think Kashmir must remember how it

Eat what your soil grows. Kaand. Nadru. Turnips in winter, mulberries in summer. Let food be memory, not industry.

Move with purpose. Don't exercise to punish yourself. Walk to the spring. Hoe a row of earth. Carry a bucket, lift your child, knead

dough. Sweat should mean something.
Speak. Especially to those older than you. Let their stories remind you how long life can be, and still how full.

Stay outside. Watch how the light shifts on a snow-covered branch. Notice how the body slows in winter and speeds up in spring. There's a language in nature that recalibrates the body better than any app.

And most of all, make peace a daily practice. We can't control war, but we can be soft with each other. We can learn to sleep without anger. We can sit with the ones we love and just be still.

Because maybe the real question isn't how long we can live, but how much life we can fit into the years we already have.

Mujah Baba didn't worry about the future. He lived by the sun, trusted the bees, and died peacefully, one winter, in his sleep. They say the honey he left behind never spoiled.

I believe them. And I also believe we still have time to sweeten our own lives, too-if we remember how.

In today's distracted Kashmir, a parent's attention is the most powerful form of education.

earning in Kashmir starts long before the first school bell rings. It begins with a mother's lullaby. A father's silence. The way a child is held, spoken to, corrected, comforted.

Parents teach without lesson plans. They shape lives without a syllabus. Walk through a narrow alley in Anantnag, or past the bustling bazaars of Sopore, and you'll find it everywhere: education without certificates. A grandmother reciting a verse. A father teaching his daughter how to measure rice. These are classrooms too.

Science backs what Kashmiris already live: 90% of brain development happens before age five. That's before formal schooling. Before report cards. Before anyone outside the home takes over.

Parents are not just caregivers. They are builders. What they build ear-

But parenting today is harder than ever. Screens tug at attention. Competition crushes joy. Even in the serene parts of valley, the noise has arrived. And somewhere between ambition and anxiety, many parents have begun outsourcing what once belonged at home.

We expect schools to do everything. But schools aren't magic. They work best when homes do too. A child who's been listened to, encouraged, and corrected with love at home walks into class ready. Not just to learn, but to grow.

You don't need degrees to do this right. You need presence. A question

asked after school. A story at bedtime. A calm voice during chaos. These aren't extras. They're essentials.

In Srinagar, Rehana Ahanger watched her son struggle through math and science. She pushed. He withdrew. One day, she noticed his sketches. "I stopped forcing him to fit into my idea of success," she told me. "He started shining in his own way.

Too many kids never get that chance. According to NCRB data, over 13,000 students in India died by suicide in 2022. Many of them buckling under academic pressure. That's not failure. That's collapse.

And often, it starts at home, with unrealistic expectations and withheld affection.

We must flip the script. Praise effort, not just outcomes. Allow mistakes. Honour passions, even when they don't fit the mold. Children aren't projects. They're work in progress.

And yes, not all parents have equal

tools. In Kashmir's rural belts, poverty, illiteracy, and ignorance still steal time and attention. But small interventions can do wonders. NGOs in Baramulla and Pulwama

now hold parenting circles, where even non-literate parents learn how to nurture growth. It's not complicated. A warm home.

A safe space. A conversation instead of a command. These shift a child's direction more than any tuition centre ever could.

Technology adds new layers. It widens access, but it also eats away at connection. Parents must guide digital use, not with lectures, but example. Put the phone down. Look up. Be there. Kids copy what we live, not what we say.

Schools must open up too. Not every parent knows the system. Invite them in. Treat them as partners, not intruders. When teachers and parents talk, children win.

In Kashmir, education has long been seen as a ladder out of hardship. But a ladder is only useful if you're steady on the first rung. That steadiness comes from home.

We talk often about revolutionising education. Maybe the real revolution is this: recognising that the most powerful educators don't stand in front of a class. They sit beside their child on a cold morning, cup of tea in hand, listening.

That's where it begins. That's where it always begins.

What does it mean to care for someone without words? In a place like Kashmir, where grief has visited far too many homes and trauma is something everyone knows by name but never spells out, empathy becomes a language of life.

It's in the tea your neighbour brings without asking. It's in the way children hold hands when sirens scream. It's in the hush of a classroom when a teacher notices the slumped shoulders of a boy who hasn't spoken all week.

Empathy is not about grand gestures here. It doesn't shout. It doesn't perform. It shows up in silences, in small offerings, in sitting beside someone when you don't have answers.

Across the world, scientists call it emotional or cognitive empathy. They map it with theories - mirror neurons, simulation responses, mental models.

But in Kashmir, people practice it before they learn its name. They grow into it like language. By watching. By feeling. By living through shared winters, power cuts, curbs, funerals.

Research tells us children show signs of empathy as early as one year old. In Kashmir, many show it sooner.

A five-year-old girl in Pulwama once gave her school lunch to a neighbour's son after his father went missing. No one taught her that. She just understood. Because in Kashmir, understanding pain is not an academic skill. It is something passed down like heirloom copper.

Studies say empathetic people have stronger mental health, better relationships, deeper friendships. That may be true.

But in the valley, empathy has always been about more than well-being. It is about belonging. About not letting someone drown in their silence. About holding space for another's sorrow even when your own is too much to carry.

Can it be taught? Maybe. But here, it's lived. In homes where mothers notice the change in a child's eyes even when he says he's fine. In schools where a teacher senses that a student hasn't done her homework because she didn't sleep last night. In hospitals where a nurse speaks softly to a grieving family because she's been there too.

What makes this all the more remarkable is how private it is. No news. No noise. Just human beings making room for each other. Every day. Without asking for applause.

It's easy to think of empathy as softness. But in Kashmir, it's a kind of strength.

It survives when systems fail. It bridges where people divide. It comforts when words collapse. It doesn't fix what's broken. But it keeps people from breaking.

As the world moves faster and colder, the Valley holds on to something warm. And if you've ever been cradled in that care by a friend, a stranger, a smile across a broken street — you know it's not ordinary. It's what makes Kashmir, despite everything, still feel human.

Let the world debate empathy in theories and journals. Here, it's folded into every day. And maybe, that's the real lesson.

When the Tourists Stopped Coming
In the shadow of a tragedy far from its hills, Naranag stands still. Its silence is a
testimony to lives paused, plans broken, and a future in waiting.

Taranag is a village of stones and sky and silence. It sits tucked into the hills of Kangan, in Ganderbal district, a place where the ancient breath of temple ruins lingers among pine forests and the river Sindh curls like a song.

In summer, it hums with life. There are ponies clipping over trails. Tea stalls open early and sleep late. Young boys run alongside trekkers, offering directions or dreams. Women sweep porches of guesthouses. The whole village moves with the season, like a heartbeat in step with the footsteps of strangers.

But this summer is different. This summer, there is no sound.

It started far away, on April 22, 2025, in Pahalgam. A sudden attack. Violence, once again, breaking into the ordinary. And in its wake, a swift decision from the administration: shut down 48 tourist sites. Among them was Naranag.

The reasoning made sense. Safety. Prevention. A necessary pause.

But what does a pause mean when your entire life depends on motion?

Naranag, in the absence of tourists, becomes a ghost with memory. Guesthouses sit fully furnished, but empty. The roads that once echoed with horns and hooves now lie deserted, shaded by still trees. There are no footprints on the trail to Gangabal. No schoolchild is told to avoid the roadside traffic.

I went to Naranag to ask how people were doing. A man told me, "Some of us bought horses for this season. Others got loans, renovated our rooms, expanded kitchens. We were ready. But now, there's nothing. We're just watching time pass.'

It's not just Naranag that's hurting. But Naranag feels it most deeply, because this village doesn't just host tourists—it breathes through them.

In these short months of warmth, the village earns enough to carry its weight through winter. The math is simple: no tourists, no income. No income, no repairs, no school fees, no weddings, no medicine, no dignity.

Children who once helped their families with ponies or packed food for trekkers now



sit home, unused to this stillness. Elders who used to lean on fences and count the arriving taxis now count days instead. In the rhythm of the village, a beat has gone missing.

In Srinagar, people used to drive up to Naranag for a breath of cooler air, a view of the peaks, a walk among ruins older than memory. Even that tradition is on hold.

I worry most about the young people. Their pride in seasonal work has been replaced by restlessness. Some of them wander the village with nothing to do, anxious and bored. When a routine breaks, something else can take its place, something darker.

Drug addiction is already creeping into the Valley. And when there's no work, no hope, and too much time, the risk grows sharper.

Kashmir has always known how to survive. But survival, like tourism, is also about timing. When a season is lost, a year is lost.

Tourism accounts for about seven percent of Kashmir's GDP. It feeds over two hundred thousand people, directly or indirectly. Naranag is part of this great network. One guesthouse here means work for a baker in Ganderbal, a carpenter in Kangan, a weaver in Baramulla. The closure doesn't just shut doors in one village. It shakes a web that stretches across the region.

Last year, Kashmir saw nearly three million visitors. There was hope again. Hope that the post-COVID world would bring back the economy, inch by inch. Then April came, and it slipped away. News reports spoke of lakhs of cancellations. But in Naranag, the cancellations weren't on paper. They were in kitchens with no rice, in stables with idle ponies, in bank accounts with minus signs.

Still, the villagers aren't asking for magic. They aren't even asking for full reopening. They're asking for balance.

There are ways. Let tourists come in small numbers. Give passes. Station guards. Let villagers help patrol trails. Offer them work in keeping the paths safe. Provide a little money, just enough to last the season. ₹10,000 or ₹15,000 can mean a lot here. More than money, it gives a feeling of being seen.

Even former Chief Minister Mehbooba Mufti called it "collective punishment." Many on the ground don't seem to disagree with

Amid anguish, the ruins still stand. The river still flows. And the people still wait.

One pony handler told me, "We just want to work again. That's all." He said it gently, like someone asking not for a favour, but for the chance to earn one.

Naranag is small, but its silence is loud. It tells us what's at stake when safety forgets to make space for the living.

It tells us that a village can survive war and winter, but not neglect. It asks us: when will the footsteps return?

in the Goni Khan market. Around me, old beggars sit by the road, but one elderly man stands out.

He isn't asking for alms. Instead, he's trying to earn a living, selling cheap carry bags for Rs 10 or 20. He wears them on his arms like bangles, walking silently among the crowd. Muzamilah is with me. We take a narrow lane that loops us back to the main road.

We see another elderly man in a pheran. His right hand is held out like a beggar's, palm facing upward. But his left arm stays tucked inside his cloak.

Then I notice his left hand emerging from the collar of his pheran, holding a smartphone to his ear as he speaks to someone. The scene feels both familiar and surreal: an image of poverty and technology layered together.

Near Dal Lake, a bold sign reads: Wine Shop. However you look at it-through a religious lens, a moral one, or even a scientific one-alcohol does more harm than good.

I was dressed in a beautiful ethnic outfit that day. Makeup isn't really my thing, but I was groomed and carried a small basket in hand. Muzamilah and I were rushing to catch a cab when we passed a cherry vendor. "Cherries! Cherries!" he called out.

Then, swept by the moment, he added with a grin, "The way she is groomed!" It made me laugh.

Later, at a well-known department store, I was asked to leave my handbag at the entrance with the security guard. That hadn't happened before. I complied but decided to speak to the manager.

"We've had some distur-



bances lately—shoplifting," he explained. "So we're not allowing handbags inside."

It saddened me. But theft is a global issue. The fact that every language on earth has words for feelings like love and greed shows how much we humans share, our struggles and our flaws.

In another cab, a young woman approached my window. She was nicely dressed, with some makeup on. "Is this going to Budgam?" she asked. It wasn't.

She walked back to the bus stand. A car slowed nearby. She leaned toward the window, spoke briefly, and stepped away. No smiles passed between them, no gestures of familiarity, just a cold exchange. She hesitated, then returned, opened the front door, and drove off with him. The moment lingered.

A year or two ago, on a

couple of late evenings, my father and I were heading home when the streets had mostly emptied. I remember seeing young women standing by the roadside, alone. I didn't understand it then. But now, the memory settles differently.

In a final lane we passed, a man probably in his mid-thirties was arguing with a woman old enough to be his mother. She seemed timid. I caught her saying, "Fear God...."

Her husband stood beside her. He looked like a decent man, said nothing rude, just helpless. The younger man snapped, "Show this attitude to villagers and Gujjars, not

I turned back and asked a nearby shopkeeper what the issue was. "There wasn't enough space for his car to pass, so I asked him to back

up," he said. I don't know whether he truly couldn't move forward, but nothing justifies how he spoke to those elders. He was another overgrown child who had no real argument, just a need to insult and diminish others. His words showed neither education nor dignity.

If we want to understand where we're headed, what kind of society we are building, we must look to the developed world, not just to admire but to learn.

The West has set the benchmarks. Whether it's education, jobs, or lifestyle, we aspire to match them. But what we often miss is that their progress didn't come from wearing designer clothes or driving luxury cars. It came from education, discipline, and respect

ome books arrive without noise. They just sit silently on the shelf, until you open the first page. Jalta Gulab is one of those books. You don't read it all at once. You read a story, pause, look up, and feel like you've met someone real. Someone who's still sitting with you, long after the story ends.

Dr. Abdul Majeed Bhaderwahi knows people. He's spent his life with them. Not only as a writer, but as a doctor. He understands silence, hesitation, the words people leave unsaid.

And in these 65 stories, he gives them space. They don't shout. They don't ask for pity. They just live, and somehow, that's enough to move you.

He writes in Urdu, but there's nothing ornate or overly literary about his language. It's clean, honest, and unafraid of feeling. His characters speak like they would in real life. No lines that sound like they were written to impress. Just speech, thought, pain, memory: unfiltered and true.

The title story, Jalta Gulab, "The Burning Rose", says everything. Beautiful things hurt too. The stories hold joy and grief in the same breath. Many of them revolve around women: wives who refuse to become, daughters who notice too much, lovers who vanish slowly.

Stories like "Biwi Hum Nahin Banain Gi" and "Be Reham Mazhab" cut deep, not with volume, but with precision. The way women are written here—alert, layered, tired, strong-feels unusually honest. There's no savior. Just weight.

There are other stories that look at social justice without slogans. "Amanat Ka Haqdaar" and "Qasoor Sunnat Hai" explore betraval, belief, and the ugly gap between who we are and who we pretend to be. Some end with a twist. Not a trick-but a quiet shift that leaves you

The writer's hometown, Bhaderwah, appears in glimpses: the landscape, the air, the dialects. But it never overwhelms

the story. It breathes quietly through it. In his hands, the setting doesn't become scenery. It becomes mood. And mood, in these stories, is everything.

There's something else here that's rare: restraint. Dr. Bhaderwahi never drags a scene. He never over-explains. He trusts you to feel the weight of what's missing. In "Zahreeli Aankhen", a glance carries more violence than words. In "Khwab Aur Aansoo", dreams fall apart without making noise.

Some titles run long and verge on the theatrical. You wonder if a tighter name would serve the story better. But once you're in, the storytelling clears away that clutter. You don't remember the titles—you remember the emotions.

Writers like Mohammad Yousuf Teng and Noor Shah have written warmly about this book. Teng calls it a portrait of human truths. Shah says it carries social responsibility without sermon. Both observations land. These stories aren't escape, they're encounter.

"Jalta Gulab" was released on May 31 by the Jammu and Kashmir Academy of Art, Culture, and Languages. The room was packed with writers, critics, and scholars. Rukhsana Jabeen was there. So was Ayaz Rasool Nazki, Khalid Hussain, Shamshad Kralwari. This wasn't just a book launch, it was a homecoming. Dr. Bhaderwahi's earlier work, Chub-

han, was noted in literary circles. But Jalta Gulab feels fuller, deeper. Not because the stories are bigger, but because they're braver. He doesn't create drama. He uncovers what's already there-de-

spair, love, and courage.

By the end, you're left with an ache. The kind that doesn't fade quickly. These stories aren't wrapped up neatly. They stay unfinished, like real lives do. You don't finish this book and move on. You carry it with you.

And maybe that's the point. To stop. To notice. To see.

How to Make Office Time Actually Worth It

go to the office just to sit on Zoom." This isn't a complaint it's a clue. A clue that today's return-to-office plans are missing something vital. It's (usually) not the commute that's draining people—it's the lack of something you can't access alone at home.

In my work helping organizations build culture through connection, one complaint echoes loudly: "When I go into the office, I end up doing work I could have done at home. So why go in at all?"


It's a fair question—if the only goal is to get the work done. But what if coming into the office isn't about doing work? What if it's about harnessing something invisible that accelerates the work?

That something is called collective effervescence.

A 2022 meta-analysis by José J. Pizarro and colleagues, which reviewed over 50 studies and 182,000 participants, found that collective effervescence—a state of intense shared emotional activation strongly correlates with increased group identity, motivation, and long-term cohesion. Collective effervescence describes the shared emotional energy that emerges when people come together with a common purpose. It's that electric feeling you get:

- Singing with strangers at a
- Cheering in sync at a playoff game.
- Marching for a shared cause.
- Celebrating a hard-won team victory.

In the workplace, it's the pulse you feel when your team is firing on all cylinders. When meetings spark ideas instead of draining energy. When progress feels like it's being pushed forward by more than just individual effort.

Why Collective Effervescence Matters Collective effervescence isn't just feel-good chemistry—it has real business value: It strengthens bonds between colleagues, reinforces be-

longing and psychological safety, sparks motivation and shared momentum, and creates a lift that often outlasts the moment itself.

Collective effervescence creates organizational lift. But here's the catch: It doesn't happen by accident.

Effervescence is a reaction a spark created when people and purpose collide in the same space. For leaders and teams looking to maximize their in-person time, there's a simple formula.

The Onsite Advantage Formula Presence + Purpose + Participation = Collective Effervescence

Let's break it down:

- Presence = Are you physically and mentally here? Not just in the building, but with each other. Sharing time, space, and attention.
- Purpose = Do you know why you're here? Purpose channels our energy toward something bigger than ourselves.
- Participation = Are you actively engaging? This ensures energy is shared, not siloed. Participation is the

difference between observing and owning.

Whether it's a team meeting or a full day in the office, this formula transforms routine gatherings into energizing connection points.

Real-World Applications

Here are two examples of the formula in action onsite:

The Morning Kickoff: Start the day with a 15-minute team huddle.

- Presence: Everyone gathers for a morning stand-up meeting.
- Purpose: Clear updates on the team's mission and obiectives.
- Participation: End with a quick challenge or call to action ("Who can find one way to support a teammate today?")

The Work-Together Block: Instead of working in silos, schedule 90 minutes of shared work time in a conference room.

- Presence: Phones down, laptops up.
- Purpose: Everyone focuses on one team objective.
- Participation: Light music, shared updates, and real-time collaboration encouraged.

Connection is too valuable to waste. If you're showing up to the office just to check boxes or sit in solitude, you're missing the point—and the power—of shared space.

Stop focusing only on the tasks. Focus on the teamwork. Because done alone is progress—but done as one is momentum.

Tata Group To Give Rs 1 Crore Compensation To Families Of Persons Killed In Plane Crash: AI CEO

MUMBAI: Mumbai, Air India's parent Tata Group will pay Rs one crore to the families of persons killed in the Ahmedabad plane crash, besides covering the medical expenses of those injured, the carrier's MD and CEO Campbell Wilson said on

In a message shared on the official handle of Air India on X, Campbell said that while everyone at Air India is devastated by this loss and grieves for those affected, the airline has moved 100 caregivers and 40 engineering staff to Ahmedabad.

"...We have confirmed that 241 of the 242 passengers and crew perished in the incident. All of us at Air India are devastated by this loss and grieve for those affected near families and their loved ones," he said.

The technical team is now helping at the site and caregivers are providing support to families, he said, adding that many more caregivers are travelling to Ahmedabad to provide further support.

Kashmir's Small Businesses Get a Digital Lifeline for Dispute Resolution

A new government-backed portal promises faster justice for small firms in Kashmir struggling with delayed payments and legal bottlenecks.

SRINAGAR: In a modest conference hall at Sanat Ghar, Bemina, small business owners got a crash course in something they rarely expect: quick justice.

The Directorate of Industries and Commerce, in collaboration with India's Ministry of MSMEs, hosted a one-day workshop to train Micro and Small Enterprises (MSEs) on how to resolve payment disputes using a newly launched Online Dispute Resolution (ODR) portal.

"Delayed payments can break a business," said Khalid Majeed, Director of Industries and Commerce, Kashmir. "We need fast, affordable solutions-and this is one of

The ODR portal, part of the World Bank-supported RAMP program, is linked with the government's Samadhaan platform. It allows businesses to report disputes, upload documents, and seek resolution online.

Officials described it as a game-changer for small firms locked in endless payment cy-



cles. "It saves time, cuts costs, and builds trust," said a senior MSME trainer. "And it's built for those who can't afford to wait."

In Kashmir, where thousands of small units operate with thin margins and little legal backup, the problem is common and often paralyzing. "Clients delay payments for months," said Rafiq Ahmad, who runs a packaging unit in Srinagar. "We don't chase them because going to court is a waste of time and money."

At the workshop, participants learned how to register, upload contracts, and manage disputes directly through the

Government data shows that late payments are one of the biggest roadblocks for India's 63 million MSMEs. In Kashmir's fragile economy, the effects are more severe: missed salaries, halted supplies, and shuttered shops.

Khalid Majeed urged businesses to embrace digital tools, saying the portal is more than just a complaint box. "It's about creating a culture of accountability," he said. "This will make it harder for buyers to stall payments and easier for sellers to fight back."

The training ended with practical demos and user logins. For many in the room, it wasn't just a workshop. It felt like a rare win.

"I've never seen a dispute resolved in weeks," said one participant. "Maybe now I

Gold Rallies Rs 2,200 To Rs 1.01 Lakh/10G As Tensions In Middle East Escalate

New Delhi: Rising for the third consecutive day, gold prices on Friday surged Rs 2,200 to trade near a record high of Rs 1,01,540 per 10 grams in the national capital amid heightened tensions following Israel's military strike on Iran, which drove investors to the safe-hav-

en asset. According to the All India Sarafa Association, the precious metal of 99.5 per cent purity rallied by Rs 1,900 to Rs 1,00,700 per 10 grams (inclu-

sive of all taxes). On April 22, the yellow metal had climbed Rs 1,800 to hit a lifetime high of Rs 1,01,600 per 10 grams.

In addition, silver prices jumped by Rs 1,100 to revisit the all-time high of Rs 1,08,100 per kg (inclusive of all taxes) on Friday.

The metal rose by Rs 1,000 to hit a lifetime high of Rs 1,08,100 per kg on Monday.

On the Multi Commodity Exchange (MCX), the most-traded August delivery contracts of the precious metal zoomed Rs 2,011 to hit a record high of Rs 1,00,403 per 10 grams in the morning trade.

"Gold prices touched a new high and scaled past the Rs 1 lakh-mark per 10 gram while in the international markets, the bullion soared past USD 3,440 per ounce as investors flocked to safe-haven assets amid mounting global instability," Rahul Kalantri, Vice President of Commodities at Mehta

newed uncertainty over US trade policy, including threats of unilateral tariffs by President Trump-fuelled risk-off sentiment, Kalantri said.

US Treasury Secretary Scott Bessent's remarks about possibly extend-

ing the 90-day tariff pause failed to ease concerns. Additionally, weaker-than-expected US inflation data strengthened expectations for further interest rate cuts by the Federal Reserve, enhancing gold's appeal, he added.

According to Kaynat Chainwala, AVP-Commodity Re-search at Kotak Securities, investors are now focused on the upcoming University of Michigan Consumer Sentiment report, particularly the inflation expectations component, for further guidance on the bullion prices and monetary policy outlook.

Kashmir Traders Push Back Crypto Income On I-T Radar; Dept **Against Distant Tax Hearings Sends Emails To Individuals**

At Srinagar meet, business leaders urge Income Tax Department to move appeal hearings to the Valley and simplify compliance.

SRINAGAR: Traders in Kashmir want their tax appeals heard closer to home. At a meeting in Srinagar,

business leaders asked senior Income Tax officials to shift exemption and appeal cases from Chandigarh and Jammu to the Valley. "It makes no sense for local assessees to travel hundreds of kilometers," said Javid Ahmad Tenga, president of the Kashmir Chamber of Commerce and Industry. "It delays justice and adds unnecessary costs."

The meeting, held at the Chamber's Residency Road office, was led by Joint Commissioner of Income Tax Dr. Ruveda Salam and attended chartered accountants, industrialists and KCCI members. It opened a rare window for Kashmir's business community to speak directly to tax authorities.

Several members said they felt left out of key processes and weighed down by overlapping demands from the Income Tax and GST departments. They called for regular coordination meetings to address confusion and stream-

Two Days Of Market Slump Wipes Out Rs 8.35 Lakh Cr Investors' Wealth

NEW DELHI: Equity investors become poorer by Rs 8.35 lakh crore in two days of market fall, where the benchmark Sensex dropped nearly 2 per cent amid heightened Middle East tensions, which drove Brent crude oil prices to skyhigh levels.

Falling for the second day in a row on Friday, the 30-share BSE Sensex dived 573.38 points or 0.70 per cent to settle at 81,118.60. During the morning trade, it tanked 1,337.39 points or 1.63 per cent to 80,354.59.

In two days, the benchmark has lost 1 396 54 points or 1 69 per cent.

The market capitalisation of BSE-listed firms eroded by Rs 8,35,799.85 crore to Rs 4,47,21,343.34 crore (USD 5.19 trillion) in two days.

"Indian equities fell sharply, reacting to weak global cues and a surge in crude oil prices after Israel launched military strikes on Iran earlier today. The sharp rise in crude prices weighed on the Indian rupee and led to selling pressure in OMCs, paints, tyres and lubricant stocks," Siddhartha Khemka, Head – Research, Wealth Management at Motilal Oswal Financial Services Ltd, said.

Global oil benchmark Brent

crude jumped 7.61 per cent to USD 74.64 a barrel.

"Indian equity markets en-dured a sharp sell-off on Friday, with the Nifty-50 and Sensex both off their intraday lows but still closing with significant losses. The market faced pressure from geopolitical tensions in the Middle East, surging crude oil prices, and broad-based sectoral weak-ness," Satish Chandra Aluri, Analyst at Lemonn Markets Desk, said.

Among the Sensex firms, Adani Ports, ITC, State Bank of India, IndusInd Bank, HDFC Bank, Titan, Kotak Mahindra Bank and UltraTech Cement were the major laggards.

On the other hand, Tech Mahindra, Tata Consultancy Services, Maruti and Sun Pharma

were the gainers. The BSE midcap gauge declined 0.32 per cent and small-

cap index dipped 0.30 per cent. Among BSE sectoral indi-

Rupee Dives 55 Paise To Close At 86.07 Against US Dollar

MUMBAI:The rupee plummeted 55 paise to 86.07 (provisional) against the U.S. dollar on Friday (June 13, 2025) due to a spike in global oil prices and a firm dollar amid rising tensions in the Middle East following Israel's attack on Iran's nuclear sites.

Brent crude, the global oil benchmark, rose sharply by 7.27% to \$74.40 per barrel in futures trade.

At the interbank foreign exchange, the rupee opened at 86.25 against the greenback and traded in the range of 85.92-86.25 before closing at 86.07 (provisional), up 55 paise from its previous close. The local unit had settled at 85.52 on Thursday (June 12,

UN conference on Palestinian state postponed because of Middle East tensions

Paris, Jun 13: A top-level UN conference on a two-state solution for Israel and the Palestinians scheduled next week has been postponed amid surging tensions in the Middle East, French President Emmanuel Macron said Friday.

France and Saudi Arabia were due to co-chair the conference hosted by the UN General Assembly in New York on June 17-20, and Macron had been among leaders scheduled to attend. The Palestinian Authority hoped the conference would revive the long-defunct peace process.

Macron expressed his "determination to recognise the state of Palestine" at some point, despite the postponement. France has pushed for a broader movement toward recognising a Palestinian state in parallel with recognition of Israel and its right to defend itself.

After Israel's strikes on Iran on Friday, Macron said that France's military forces around the Middle East are ready to help protect partners in the region, including Israel, but wouldn't take part in any attacks on Iran.

Macron told reporters that the two-state conference was postponed for logistical and security reasons, and because some Palestinian representatives couldn't come to the event.



He insisted that it would be held "as soon as possible" and that he was in discussion with Saudi Crown Prince Mohammed bin Salman about a new date.

'The aim is a demilitarised Palestinian state recognizing the existence and the security of Israel," Macron said. Any such state would exclude any Hamas leaders, he said.

Macron said that the Israel-Iran conflict, the war in Gaza and the situation for Palestinians around the region are all "interlinked".

Macron spoke on Friday with 10 world leaders, including US President Donald Trump

and Israeli Prime Minister Benyamin Netanyahu, about the Israeli strikes on Iran and consequences.

One of the aims at the UN conference was to increase the number of countries recognising Palestinian territories as an independent state. So far, more than 145 of the 193 UN member nations have done so. The Palestinians view their state as encompassing Gaza and the West Bank with east Jerusalem as the capital.

Netanyahu has rejected the creation of a Palestinian state, and Israel refused to participate

2 Chinese scientists will stay in jail while accused of bringing biological material to US

Detroit, Jun 13 Two Chinese scientists accused of smuggling or shipping biological material into the United States for use at the University of Michigan will remain in custody after waiving their right to a hearing Friday in federal court.

Yunqing Jian and Chengxuan Han said in separate court appearances in Detroit that they would not challenge the government's request to keep them locked up while their cases move forward.

"This is a constantly evolving situation involving a large number of factors," Han's attorney, Sara Garber, told a judge. She didn't elaborate and later declined to comment.

Han was arrested Sunday at Detroit Metropolitan Airport after arriving on a flight from China, where she is pursuing an advanced degree at Huazhong University of Science and Technology in Wuhan.

She planned to spend a year completing a project at the University of Michigan lab, and is accused of shipping biological material months ago to laboratory staff.

It was intercepted by authorities. The FBI, in a court filing, said the material is related to worms and lacked a



government permit. Experts told The Associated Press it didn't appear to be dangerous.

Jian's case is different. She is charged with conspiring with her boyfriend, another scientist from China, to bring a toxic fungus into the US Fusarium graminearum can attack wheat, barley, maize and rice.

The boyfriend, Zunyong Liu,

was turned away at the Detroit airport last July and sent back

to China after authorities

found red plant material in his

backpack. Jian, who worked at the university lab, was arrested June 2. Messages between Jian and Liu in 2024 suggest that Jian was already tending to Fusarium graminearum at the lab before Liu was caught at the airport, the FBI said.

Jian's attorneys declined to comment Friday.

Federal authorities so far have not alleged that the scientists had a plan to unleash the fungus somewhere. Fusarium graminearum is already prevalent in the US — particularly in the east and Upper Midwest and scientists have been studying it for decades.

Nicknamed "vomitoxin" because it's most known for causing livestock to throw up, it can also cause diarrhea, abdominal pain, headache and fever in animals and people.

Researchers often bring foreign plants, animals and even strains of fungi to the US to study them, but they must file certain permits before moving anything across state or national borders.

The university has not been accused of misconduct. It said it has received no money from the Chinese government related to the work of the three scientists.

In a statement, it said it strongly condemns any actions that "seek to cause harm, threaten national security or undermine the university's critical public mission".

President Pezeshkian: 'Our response to make Israel regret'

President Iranian Pezeshkian has vowed a "legitimate and powerful" response to the enemy that will make it regret it's preposterous action.

"The people of Iran and the country's officials will not remain silent in the face of this crime, and the legitimate and powerful response of the Islamic Republic of Iran will make the enemy regret their foolish actions," Pezeshkian said in a message to the Iranian people on Friday following the Israeli regime's assassination of senior military commanders, scientists and civilians, Press TV reported.

Pezeshkian called on the Iranian people not to heed the enemy's psychological warfare and boost their unity with officials instead.

"Today, the people of Iran need to be more united, trusting, harmonious, convergent and reconciliatory more than ever, and with the help of the Almighty God, ... they will give a crushing, wise and powerful response to the crime of the occupying regime," the president emphasized.

Pezeshkian said Iran has made its utmost efforts to promote peace and tranquility in the region and the world and demonstrated its full readiness to hold long and confidence-building negotiations.

At the same time, he emphasized, Iran will take a decisive measure in response to the aggression and in legitimate defense of the country's integrity.

US Warns Iran Against Retaliation In Washington, the Trump administration said that Israel took "unilateral action against Iran" and that it had informed the US ahead of the attack but warned Iran against retaliations.

U.S. Secretary of State Marco Rubio said Israel took "unilateral action against Iran" and that Israel advised the U.S. that it believed the strikes were necessary for its self-defense.

"We are not involved in strikes against Iran, and our top priority is protecting American forces in the region," Rubio said in a statement released by the White House that warned Iran against targeting U.S. interests or personnel.

Israel launched the attack a day after the US Embassy in Israel issued a security alert restricting the movement of its employees and their family members in the country, amid escalating tensions in the region.

Earlier President Trump said on Wednesday U.S. personnel were being moved out of the Middle East because "it could be a dangerous place," as tensions with Iran rise.

Israel's Strike

Echoing similar sentiments, National Conference MP Agha Syed Ruhullah, representative Srinagar in the parliament, slammed Israel's repeated attacks on countries in the Middle East, labelling it a "colonial thug" on the global stage.

"Israel has now bombed Yemen, Syria, Lebanon, and Iran, and still plays the victim. This rogue Zionist regime isn't defending itselfit's behaving like a colonial thug," Ruhullah said in a series of strongly worded posts on X.

He also rebuked India's abstention from a recent UN General Assembly resolution demanding an immediate and permanent ceasefire in Gaza, calling it a betrayal of India's post-colonial legacy.

'This reflects a shrinking of moral imagination and an abandonment of global solidarity. Nehru and Indira Gandhi upheld justice in Palestine what changed?" he asked.

Jammu and Kashmir Chief Minister Omar Abdullah also joined in, calling Israel's strike on Iran "totally unjustified" and warned of serious global repercussions.

"Israel launched the attack calling it 'pre-emptive,' but this is nothing short of waging war. If Russia's aggression on Ukraine is condemned, why the silence on Israel?" he told reporters in Srinagar.

Omar Abdullah also raised concerns about the potential impact on global fuel prices, aviation routes, and economic stability. He urged the Ministry of External Affairs to ensure the safety of Kashmiri students in Iran.

Former chief minister and PDP president Mehbooba Mufti described the attack as a "brazen act" and pointed to the West's silence as a form of complicity.

"Israel has gone rogue, and the silence of the global community-especially Western powers led by the United States—is both alarming and telling," Mufti said on X.

She was equally critical of the lack of response from Muslim-majority nations, describing their inaction as a "betrayal" of the values they profess to uphold.

"These glaring double standards endanger global peace and stability. The inaction of so-called Muslim countries is not just disappointing-it's shameful," she added. The Israeli airstrikes on Iran mark

The Jammu and Kashmir Students Association (JKSA) has formally requested intervention from the Ministry of External Affairs, highlighting the precarious security conditions and communication challenges faced by students. With around 1,500 students from Kashmir currently studying in Iran - most of them pursuing MBBS - JKSA has urged External Affairs Minister Dr. S. Jaishankar to ensure their safe return amid the escalating Iran-Israel conflict.

"We, the Jammu and Kashmir Students Association (JKSA), write to you with deep urgency and grave concern regarding the dire situation faced by hundreds and thousands of Kashmiri students currently studying in Iran, following the unprecedented escalation in hostilities between Iran and Israel," the letter reads.

JKSA said that the recent Israeli preemptive airstrikes on Iran's nuclear infrastructure, followed by a barrage of retaliatory drone and missile attacks by Iran, have brought the region to the brink of a full-scale conflict. "This volatile security environment has left thousands of Indian students, the majority of them from Kashmir valley, extremely vulnerable and exposed to immediate danger. These students had traveled to Iran to pursue professional education, particularly MBBS, due to the country's economically viable academic infrastructure. Now, they find themselves in the middle of an active military zone, fearful for their lives."

JKSA said students have been reporting "continuous sounds of airstrikes, air defence sirens, and increased military activity" around their campuses. Many institutions are situated dangerously close to military installations, raising fears of being directly affected in case of further escalation.

"The students are terrified and feel completely helpless," the letter continued. "Numerous students have contacted the Indian Embassy seeking support, relocation, or evacuation. However, they have not received any reassuring response or concrete information about the next steps.'

The association also said it is receiving distress calls from families in Kashmir, with parents in tears pleading for the safe return of their children. IKSA offered to assist with verified student lists and coordination efforts. urging the government to act swiftly before the situation worsens.

Chief Minister Omar Abdullah on Friday urged the Ministry of External Affairs to ensure the safety of Kashmiri students in Iran.

In a post on X, Abdullah, said that the families of Kashmiri students are deeply worried.

"Requesting @MEAIndia to urgently ensure the safety and well-being of Kashmiri students currently stuck in Iran. Their families are deeply worried, and we stand with them in this difficult time," Omar said.

He urged the External Affairs Minister S Jaishankar that "every step must be taken to safeguard our students.'

This marks the first-ever fatal crash of a Boeing 787 Dreamliner since its commercial debut in 2011.

Flight AI171, a Boeing 787-8 Dreamliner bound for London Gatwick, went down in flames shortly after taking off from Sardar Vallabhbhai Patel International Airport at 1:39 p.m. on Thursday. The aircraft, carrying 230 passengers and 12 crew members, lost altitude rapidly and slammed into the newly built BJ Medical College hostel, erupting into a massive fireball.

Rescue operations were carried out through the night, with emergency crews battling smoldering debris and thick black smoke. According to authorities, 241 people onboard died, with only one British national surviving. An additional 24 people on the ground are believed to have perished, although exact figures are yet to be

confirmed. First responders reported finding many of the victims still strapped into their seats. "Almost 70 per cent of the passengers were found in their seats, most with their seatbelts still on," said one official.

Residents living in the vicinity said that construction of the hostel for resident doctors was completed only a year ago and the buildings were not fully occupied.

"We were at home and heard a massive sound, it appeared like a big blast. We then saw very dark smoke which engulfed the entire area," said 63-yearold Nitin Joshi, who has been living in the area for more than 50 years.

Fake Lists, Bogus

depositing unspent flood relief funds into the Additional Treasury Tankipora under inconsistent figures ranging from ₹31.54 crore to ₹42 crore.

Fake Lists, Fictitious Associations As per the CBI findings, two nonexistent organizations — Al-Falah Shopkeepers Association and Flood Affected Coordination Committee Srinagar — submitted fabricated lists in 2018 to the Tehsil Office Central Shalteng. The lists, bearing names of 1,503 purported flood-affected shopkeepers, were submitted without the required affidavits or verification, blatantly violating official guidelines.

"The majority of names in the list were found to be from a single household," an official source said, confirming that both the associations were fictitious.

Legal Route Used to Push Fake Claims

In an attempt to legitimize the fraud, 401 shopkeepers from North Srinagar filed a writ petition in the J&K High Court in 2021. The court, citing an earlier order, directed authorities to consider their claims. Citing this order, 24 individuals from the 1,503 fictitious beneficiaries also approached the court in 2022, followed by 1,479 more in 2024, filing separate petitions.

The court directed the government to consider their claims "provided they are eligible." These orders were then used by the accused officials to secure revalidation and release of ₹13.79 crore from the Finance Department, along with an additional ₹12 lakh for the 24 petitioners.

Shopkeepers, Brokers & Officials Collude

Although the 1,503 individuals hysically exist and maintain active bank accounts, they were found to have knowingly shared their credentials with brokers and officials to falsely claim flood relief benefits.

"The shopkeepers were not entitled to any such relief, yet became part of the conspiracy by providing their details for financial gain," the CBI noted.

The investigation further revealed that the accused officers submitted fake verification reports to various top-level government offices to ensure the release of funds.

Advocate Implicated The scam also involved Advocate

Zahoor Ahmad Bhat, who represented the 24 petitioners. Verification revealed that eight of his close family members were among the alleged beneficiaries.

Charges & Sections Invoked

The CBI has booked the accused under multiple sections of the Ranbir Penal Code, J&K Prevention of Corruption Act, and the Prevention of Corruption Act, 1988 as amended under the J&K Reorganisation Act 2019. These include Section 420 (cheating), 120-B (criminal conspiracy), and other provisions related to criminal miscon-

duct by public servants. The fraudulent scheme resulted in a misappropriation of ₹7.51 crore, with funds credited directly into the bank accounts of ineligible beneficiaries.

The CBI has launched a full-sca probe to identify the entire modus operandi and network of conspirators, including the officials, brokers, and pseudo-beneficiaries involved in this elaborate scam.

South Africa Need 69 More Runs To Win WTC Final **Against Australia**

LONDON: Hobbling captain Temba Bavuma and hundredhitter Aiden Markram pushed South Africa to the brink of a sensational victory over Australia in a gripping World Test Championship final at Lord's on

Bavuma, elevating the drama with a strained left hamstring, and opener Markram partnered for an unbroken 143 runs against one of Australia's greatest bowling attacks to have South Africa 69 runs from an historic triumph.

Chasing 282 to win, the Proteas were 213-2 at stumps on day three in a stirring bid to win a first ICC trophy in 27 years.

Bavuma was 65 not out, his running restricted but not his batting technique, and Markram was 102 not out, easily the highest individual score of the final.

Defending champion Australia bombarded them with four of its top-10 all-time test wickettakers – more than 1,500 wickets in total — but they couldn't part the Proteas pair, and hardly

In South Africa's huge favor, the day three pitch flattened, offered the bowlers little and was far easier paced than the first two days, when 14 wickets fell on each. Only four wickets were taken on Friday, and none after tea.

The odds were in Australia's favor when South Africa's chase began straight after lunch.

One of cricket's best test bowling batteries faced a workin-progress batting lineup needing to equal England's most successful ever run chase at Lord's from 2004 to win. The only bigger triumphant run chase at the home of cricket was 344-1 in 1984 by the West Indies.

By the time pacer Mitchell Starc removed Ryan Rickelton and Wiaan Mulder, South Africa was 70-2 but flying.

The positive intent missing from the first innings was shown from the first ball of the chase, and the strike was rotated constantly. Australia managed only three maidens than Lyon.

Starc could have had a third wicket and reduced South Africa to 76-3 when Bayuma, on 2. thick-edged to first slip.

But a helmeted Steve Smith, standing closer than usual to the wickets because the ball hasn't been carrying to the cordon all game, couldn't hold Starc's 138 kph delivery and broke his right pinkie finger. He immediately left for a hospital, was out of the final and probably the following threetest tour of the West Indies.

Earlier, tailenders Starc and Josh Hazlewood resisted for almost two deflating hours.

Both exceeded their test batting averages. Hazlewood uppercut Marco Jansen over the cordon, and Starc achieved his 11th test fifty, and first in six

Their third 50-plus partnership for the 10th wicket tied the all-time test record. The stand ended on 59, Hazlewood out for 17 to part-timer Markram. Starc was not out on 58 from

Liverpool To Pay Record \$157 Million For Florian Wirtz: Reports

LONDON: Liverpool has agreed to pay a transfer fee of 116 million pounds (\$157 million) for attacking midfielder Florian Wirtz from Bayer Leverkusen, British media reported Friday.

The deal for the 22-year-old Germany international includes a guaranteed 100 million pounds plus 16 million pounds in add-ons, which if achieved would make it a British record.

The Premier League record for an initial fee was set when Chelsea signed Enzo Fernandez from Benfica for 106.7 million pounds (\$131.4 million at the time) in 2023.

Later that summer, Chelsea then agreed to pay up to 115 million pounds (\$146 million at the time) – with 100 million pounds up front – for midfielder Moises Caicedo from Brighton.

British media including the BBC reported the Wirtz fee – which would be a Liverpool record without citing a source. Sky Sports

reported the fee to be 116.5 million

Wirtz's move has been expected for several weeks and the player has seemed to confirm it himself on his Instagram account, dismissing reports he asked for the No. 10 shirt held by Liverpool midfielder Alexis Mac Allister.

Wirtz is expected to undergo a medical in the coming days ahead of the signing.

Liverpool is aiming to build a dynasty after winning the Premier eague title this season.

Wirtz would reunite with former Leverkusen teammate Jeremie Frimpong after the Dutch right back signed for Liverpool for a reported 35 to 40 million euros (\$39.7 million to \$45.4 million) last

Wirtz only turned 22 last month but has been a key first-team player for Leverkusen since he was 17. He was the star attacking player in the team that won the Bundesliga and German Cup in 2023-24 without losing a game.


