Heart Attacks In Their 30s: A Generation At Risk In Kashmir

What once shocked doctors is now common. An investigation into the valley's shifting health profile reveals a looming epidemic.

Srinagar: The discomfort started as a dull pressure under his ribs. Shakeel Ahmad, a 38-year-old schoolteacher from Baramulla, thought it was just indigestion. He kept teaching. The pain got worse.

By the time his family reached the hospital in Srinagar, doctors said they were already two hours late.

"He kept saying it wasn't his heart," said Shakeel's widow. "But in the end, his heart was what failed him, and us."

Heart disease is fast emerging as one of the deadliest public health threats in Kashmir. Despite its growing toll, the silent killer remains largely overlooked in a region already burdened by unpredictable weather and prolonged uncertainty.



Doctors in Srinagar and public health officials across

the Valley say they're seeing a troubling rise in cardiovascular

disease, especially among people in their 30s and 40s.

A study published in the Indian Heart Journal found that 7.5 percent of Kashmiris over the age of 40 already suffer from coronary artery disease. The burden is even greater in urban areas.

Recent hospital records show that 1 in 5 heart attack patients in Kashmir is under 45. In 2025 alone, dozens of deaths among young patients, some in their early 30s, have been linked to undiagnosed diabetes, obesity, and heart conditions. In winter, the risk doubles. Hospitals report nearly 30 cardiac emergencies a day, compared to 15–18 in summer.

Modi Rejects Trump's Ceasefire Narrative Says Op Sindoor Paused After Pak Appeal

New Delhi: Prime Minister Narendra Modi has told President Donald Trump that India and Pakistan halted their military actions last month following direct talks between their militaries without any mediation by the US, calling out the American leader's narrative that he brokered the ceasefire.

In a nearly 35-minute phone call with Trump on Tuesday, Modi firmly stated that India does not and will "never accept" mediation and that the discussions between Indian and Pakistani militaries on cessation of military actions were initiated at Islamabad's request, Foreign Secretary Vikram Misri said.

PM Modi also said that India no longer views "terrorism as a proxy war, but as a war itself", and that India's Operation Sindoor is still



ongoing, the foreign secretary

Hours after the phone conversation with Modi, Trump on Wednesday repeated his persistent claim that he stopped a war between India and Pakistan.

"Well, I stopped the war..I love Pakistan. I think Modi is a fantastic man. I spoke to him last night. We're going to make a trade deal with Modi of India. But I stopped the war between Pakistan and India," Trump said.

The cessation of hostilities between India and Pakistan was first announced by President Trump on May 10. Since then, the US president has been claiming that he brokered the ceasefire deal by threatening to stop trade with

both countries if they do not agree to stop the conflict.

The prime minister declined a request by the US president to stop over in the US on his way back from Canada, citing "prior commitments".

The May 7-10 military clashes between India and Pakistan figured prominently during the phone conversation that took place as the two leaders could not meet on the sidelines of the G7 summit following the American president's early departure.

"Prime Minister Modi clearly conveyed to President Trump that at no point during this entire sequence of events was there any discussion, at any level, on an India-US trade deal, or any proposal for a mediation by the US between India and Pakistan," Misri said.

Forecaster Warns **Srinagar May Cross 35°C**

Srinagar: The Kashmir Valley is witnessing an early surge in temperatures as a dry spell continues to grip the region. With a 26 percent rainfall deficit recorded so far in June, weather experts have warned of an intense heatwave likely to prevail over the next three days. According to independent weather forecaster Faizan Arif Keng, Srinagar may see the mercury soar above 35 degrees Celsius, much higher than the usual seasonal average. On Wednesday, the summer capital recorded a maximum temperature of 32.5 degrees Celsius.

Other parts of the Valley too recorded unusually high temperatures. Qazigund registered 31.4 degrees Celsius, Pahalgam 27.0, Kokernag 30.8, Kupwara 30.5, and the ski resort of Gulmarg recorded 22.8 degrees Celsius. Interestingly, Jammu city recorded below-normal temperatures, with the day's maximum settling at 37.6 degrees Celsius. Banihal, Batote, Katra, and Bhaderwah also reported temperatures hovering around or slightly below 35 degrees.

Data compiled by the local Meteorological Department shows a significant drop in rainfall across Jammu and Kashmir this month. Samba recorded the highest deficit at 72 percent, followed by Kathua at 62 percent. Most other districts, including Srinagar, Budgam, Baramulla, Bandipora, Ganderbal, Kishtwar, Kulgam, Poonch, Reasi, Shopian, and Udhampur, have all recorded below-normal precipitation. Rajouri, however, remained the only station to record large excess rainfall, while Anantnag, Doda, Jammu, Kupwara, and

No Stone Will Be Left Unturned: CM On Muharram Arrangements

Says Govt Must Stay Responsive Beyond Ashura

Srinagar: Chief Minister Omar Abdullah on Tuesday chaired a high-level meeting at the Civil Secretariat to review and finalize the arrangements for the upcoming holy month of Muharram, which this year coincides with the annual Amarnath Yatra.

Top officials including Deputy Chief Minister Surinder Kumar Choudhary, senior ministers, legislators, administrative secretaries, and prominent Shia leaders were present. Officers from outside stations joined via video conference.

In his address, the Chief Minister reaffirmed the government's commitment to ensuring comprehensive and seamless preparations for Muharram. "We will leave



no stone unturned in our efforts, and there should be no shortcoming from our side," he asserted.

He emphasized that the administration must remain responsive throughout the full period of Muharram, which spans two months and eight days—not just the initial ten days. "The very size and composition of this meeting reflects the importance we attach to the sacred month of

Muharram," Omar said. Acknowledging the added

complexity of this year's calendar, where Muharram overlaps with the Amarnath Yatra, the Chief Minister announced the appointment of a Secretary-level Nodal Officer—independent of the Divisional Commissioner—to oversee and coordinate interdepartmental efforts across the Union Territory.

Reservation Report Sent For Legal Vetting: J&K Cabinet

Srinagar: The Jammu and Kashmir Cabinet on Wednesday evening convened a meeting at the Civil Secretariat in Srinagar to deliberate on the much-debated reservation policy report submitted by the Cabinet Sub-Committee (CSC). After a detailed discussion, the report was referred to the Department of Law for legal examination, delaying any immediate decision on the matter.

A senior Cabinet Minister confirmed that the CSC report, which has recently stirred both political and public uproar, has not been finalized. "The cabinet held detailed deliberations on the CSC report regarding the reservation policy, and after discussion, the report was referred to the Law Department for its opinion," the minister said.

He added that no timeline has been set for the report's return from the Law Department. "Only after legal vetting, the report will return to the cabinet for a final decision," he stated, suggesting that the process may take some time.

Apart from the reservation policy, sources said the cabinet also reviewed the situation following the recent terror attack in Pahalgam, which has led to a dip in tourist arrivals. Discussions were held on measures to revive tourism in the valley and restore confidence among visitors.

Preparations for the upcoming Amarnath Yatra, scheduled to commence on July 3, also featured prominently during the meeting. The cabinet focused on improving logistics and strengthening health arrangements for the smooth conduct of the annual pilgrimage.

The meeting, chaired by Chief Minister Omar Abdullah, lasted for more than an hour and was attended by key ministers and top bureaucrats, sources added. (inputs from KNS)

This biased system has crippled the local industrial ecosystem, marginalised local entrepreneurship, and drained economic opportunity from the region.

Given this hostile environment, how can one reasonably expect Kashmir's industry to survive, let alone thrive? **KEEMA demands:**

Restoration of industry-friendly safeguards and revival of local participation mechanisms

Over 12,000 Dog, Cat Bite Cases **Reported At ARC SMHS**

SRINAGAR: A whopping 12,833 bite victims, mostly from dog and cat bites, sought treatment at the Anti-Rabies Clinic at Srinagar's Shri Maharaja Hari Singh (SMHS) Hospital in the past year, officials said.

They said the prevalence of dogs across the valley has contributed to human-dog conflicts, leading to a rise in cases of dog bites in the region. They added that rearing cats at home has also led to bite cases.

Officials informed KNO that in the last one year, from June 2024 to May 2025, ARC SMHS Hospital received 12,833 cases, including 6,258 dog bites, 6,095 cat exposures, and 480 other bite cases. They said the cat exposure is increasing exponentially over the last few years, as many people are keeping them as pets, while almost all dog bites are reported from stray dogs.

"We receive over one thousand animal bite scratch exposures every month in Anti-Rabies, and in the last one year, around 13,000 cases have been reported," they added. This figure of 12,833 cases marks the highest recorded in the past decade, underscoring the urgent need to address the issue immediately, officials

Providing a breakdown, an official said that 530 dog bites were reported in June 2024, 598 in July, 521 in August, 515 in September, 540 in Oc-

tober, 423 in November, 439 in December, 480 in January 2025, 463 in February, 524 in March, 625 in April, and 601 in May.

Details reveal that 440 cat bite cases were reported at the clinic in June 2024, followed by 440 in July, 432 in August, 414 in September, 486 in October, 399 in November, 514 in December, 692 in January 2025, 658 in February, 542 in March, 491 in April, and 537 in May till date, bringing the total number of cat bite cases from June 2024 to date to 6,095.

Speaking to KNO, an official at ARC SMHS said that cats do transmit rabies, similar to dogs, and that cat bite cases are on the rise. People need to take precautions in this regard. 'The trend of keeping cats as pets has gone up, especially post-COVID times, but in many instances, owners are not following norms like vaccination, deworming, timely treatment, and hygiene practices," he said. "We have seen many fold increases in the number of cases visiting the Anti-Rabies Clinic at SMHS over the last three years. Almost half of the cases are victims of cat exposures."

Reviewing the yearly data on bite cases, the official said that from April 2015 to March 2016, 7,061 bite cases were reported to ARC SMHS, followed by 5,832 from April 2016 to March 2017, 6,802 from April 2017 to March 2018, 6,397 from April 2018 to March 2019, 6,139 from April 2019 to March 2020, 4,808 from April 2020 to March 2021, 5,469 from April 2021 to March 2022, 6,875 from April 2022 to March 2023, and around 8,800 from April 2023 to March 2024, making the total cases since April 2015 around 70,000.

According to officials, Kashmir witnessed a surge in pet ownership over the last decade. In contrast to farm animals, which provide milk, meat, and eggs, pets are kept purely for companionship. They stressed that adherence to personal hygiene while handling pets is crucial for preventing zoonosis.

"A person who intends to keep a pet must be mentally prepared to take proper care of their pet, respecting its behavioural requirements, providing adequate feeding, shelter, and healthcare facilities. There is no fun in bringing home an animal without taking proper care of it," they said.

They added that regular hygiene practices, such as routine grooming and dental care, help prevent skin infections and dental diseases in pets.

In Kashmir, dog bites pose a serious public health concern, with thousands of people becoming victims of animal bites, particularly from stray dogs, and some developing rabies. 'Shocked' Tourist Joins Efforts To Clean Dal

SRINAGAR- A German tourist, who was "shocked" by the levels of 'pollution" in the worlds, famous Dal Lake here, on Sunday joined NGOs cleaning up the water body.

"I am shocked to see the pollution in the lake ... Last time when I visited Srinagar and stayed in a house boat, the condition of the lake was not so bad," said Marc Stollreiter,30, who

hired 60 labourers to clean the Nehru Park part of the lake. This part was once a favourite place for youngsters to swim. Once, even former Chief Minister Faroog Abdullah had jumped into the lake here during his regime in I 996-2002.

Stollreiter said the plan to clean the lake was chalked out by him and his friend Birgit Lenger in collaboration with House Boat Owners Association, Valley Citizen's Council and Dal Zamindar Union.

By noon, volunteers took out tonnes of garbage, including polythene carry bags and plastic bottles, from the lake into

boats for proper disposal. A concerned Stollreiter said, "This lake is dying--- It needs proper maintenance and urgent measures to ensure that coming generations are not deprived of the beautiful water body." A visitor to the city since his childhood, the tourist said that

on every trip he observed an "'increase" in the level of pollution in the lake. His efforts were lauded by the General Secretary of the Val-

ley Citizen's Council, Imdad Sagi. We are very concerned over the detoriating health of the lake and failure of authorities to save it," he said and alleged the Lakes and Waterways Development Authority set up to maintain the lake was doing nothing.

DNA tests to establish the identity of the victims as many bodies were charred beyond recognition or damaged. Wednesday morning, 190 DNA samples have been matched, and 159 bodies have already been handed over to the respective families. The process of matching (DNA samples of) other bodies is still on," Ahmedabad Civil Hospital's medical superintendent Dr Rakesh Joshi told reporters.

The road transport and highways minister said the annual pass will enable seamless and cost-effective travel across National Highways throughout the country.



Khamenei Unleashes 'Zulfiqar', **Declares 'Battle has Begun'**

Srinagar: Tensions between Iran and Israel have reached a boiling point, as Iran's Supreme Leader issued a stern warning, signaling the possibility of a full-scale war.

The warning came just hours after direct threats from U.S. President Donald Trump to Savyed Khamenei, along with his call for Iran's "unconditional surrender.'

Ayatollah Khamenei posted a cryptic but strongly worded message on the social media platform X, stating:

"In the name of the renowned Hyder, the battle begins. Ali, with his Zulfiqar, returns to Khaybar."

The statement invoked powerful Islamic symbolism — "Hyder" and "Zulfiqar" refer to the first Shia Imam, Ali, and his legendary sword.

A subsequent post read:

"We must give a strong response to the terrorist Zionist regime. We will show the Zionists no mercy.'

The post appeared to frame the battle as part of a broader ideological struggle, accompanied by an image of a man with a sword entering a castle gate — a clear allusion to the historic Battle of Khavbar.

'Irreparable consequences' Meanwhile in his first remarks outside of social media posts since Friday, when he delivered a speech broadcast on state media after Israel began bombarding Iran, Ayatollah

Earlier, Trump claimed that the United States and Israel had full control of Iranian airspace and warned that the country's top leader

was within reach. He called for Iran's "unconditional surrender," and said Washington knows the exact whereabouts of Khamenei but was holding off on assassinating him "for now," adding, "Our patience is wearing thin."

Khamenei said peace or war could not be imposed on the Islamic Republic.

"Wise individuals who know Iran, its people, and its history never speak to this nation with the language of threats, because the Iranian nation is not one to surrender. Ayatollah Khamenei said in the video message aired on state TV.

U.S. officials insisted as of Tuesday that the American military has not taken any offensive actions against Iran, only defensive strikes to take out incoming Iranian missiles to protect Israel.

Additional U.S. fighter jets and refueling tankers have been deployed to the region, but officials have declined to provide specific numbers. Fighter jets have joined in launching strikes to defend Israel, but officials said Tuesday that no American aircraft were over Iran.

EC System to Now Deliver Voter ID Cards in 15 Days

New Delhi: The Election Commission (EC) on Wednesday said voter identity cards will now be delivered to electors within 15 days, virtually halving the time taken.

Till now, it took a little over a month for the Elector Photo Identity Card (EPIC) to be delivered to the voters, officials pointed out.

The EC said a new standard operating procedure (SOP) has been introduced to ensure that voter cards are delivered within 15 days of new enrolment of an elector or change in particulars of an existing voter. The new system will en-

sure real-time tracking of each stage right from the EPIC generation by the Electoral Registration Officer (ERO) till the delivery of the card to the elector through the Department of Posts (DoP), the poll authority said.

The electors will also re-ceive notifications via SMS at each stage, keeping them informed about the status of their EPIC, it noted.

For this purpose, the EC has introduced a dedicated IT module on its recently launched ECINet platform.

The new IT platform will replace the existing process by re-engineering the current system and streamlining the workflow.

The DoP's Application Programme Interface (API) will be integrated with the ECINet for seamless delivery, the EC said.

Regional Conflict Derails Pakistan-Russia Train

Dubai: The launch of a muchanticipated direct railway link between Pakistan and definitely, Gulf News reported on Wednesday. The delay comes as tensions rise in the region, forcing the closure of the Iran-Pakistan border — a crucial transit point for the rail corridor.

The freight train service, originally set to begin on June 22, was to run from Lahore to Astrakhan in southern Russia, passing through Iran, Turkmenistan, and Kazakhstan. The route was part of a broader initiative signed in June 2024 during the 27th St. Petersburg International Economic Forum (SPIEF). A Memorandum of Understanding (MoU) was inked by Pakistan's Ambassador Muhammad Khalid

Jamali and Russia's Deputy Minister of Transport Dmitry S. Zverev to strengthen bilateral cooperation in rail transport and trade.

The cargo line was expected to begin operations with 16 freight wagons, with plans for future expansion. Officials saw the project as a strategic move to deepen trade ties with Russia and improve regional connectivity with Central Asia.

Despite the setback, Pakistan has made progress on another regional initiative a new railway route to Uzbekistan via Afghanistan. This first-of-its-kind corridor aims to provide landlocked Uzbekistan and Afghanistan direct access to the Arabian Sea. Uniquely, the route will also support passenger services, opening up greater travel and trade opportunities across the region.

Indian tourist stranded at Azerbaijan border while fleeing Iran; ordeal continues

fter a perilous 500-km journey out of conflict-torn Tehran, stranded Indian tourist Falguni Dey reached Iran's Astara border with Azerbaijan on Tuesday evening, but his ordeal is far

Dey is now caught in a web of complex paperwork needed to cross into Azerbaijan and reach Baku, from

where he plans to fly home. "I may have managed to escape the bombs in Tehran by undertaking this journey, but now I am stuck in Iran's Astara land border because the Azerbaijan authorities would not accept me into their country without a special migration code issued by that government, and my e-visa won't work," Dey told PTI

through a voice message "Despite my best persuasions, I have been told that it would require at least another fortnight for that code to arrive, and I have no idea how I will survive that long in Iran," the college professor from Kolkata added.

Translated into reality, this means the additional 300-odd kilometre journey from Astara — near the Caspian Sea in northeastern Iran — to the safety of a hotel room in Baku now remains a distant dream for Dev.

PTI had on Tuesday reported the plight of Dey, also an amateur mountaineer, who reached Tehran on June 5 for a bid to conquer the volcanic summit of Mount Damavand and remained stranded in Tehran because of Israeli missiles till June 17 before making a desperate attempt to escape the city by road and reach the Azerbaijan

"I am physically and emotionally drained. On top of that, I am facing a severe funds crunch, and the uncertainty of reaching home is killing me. All my efforts and the money spent by my family and friends to get me to safety seem to have come to naught," Dey said, nearly breaking down.

The hotel booking in Baku made by his family from Kolkata, where Dey was supposed to reach on Wednesday morning, had to be cancelled because of the complexities at the border check post preventing his cross-over, Dey said.

"Even the Mumbai-bound flight from Baku, where I had booked a ticket, has now been cancelled because of the prevailing uncertainties all around," he added

Man Returns 70 Tolas Gold, **Cash from Ahmedabad Crash Site**

ajesh Patel, who was among the first responders following the Ahmedabad plane crash on June 12, returned to the cene soon after carrying bodies and many injured to ambulances. He began rummaging through the smouldering wreckage.

Patel, 57, said he collected nearly 70 tolas of gold ornaments, which would be priceless for the victims' kin, Rs 50,000 and a few US dollars from the scene of the deadly aviation tragedy and handed them over to the police.

As he heard a deafening sound and saw a giant ball of fire rising into the sky, Patel, who lives just 300 metres from the scene of the accident, hopped into an ambulance of a private hospital run by his relative in the city's Shahibaug area.

"Upon learning that an aircraft had crashed into a hostel complex of BJ Medical College, I rushed to the area with the hope of saving as many people as I could. However, we could not get close to the spot for the first 15 to 20 minutes. We started the rescue work after the fire was brought under control," said Patel, who is in the construc-

Since Patel and the other volunteers did not have any stretchers, they used old sarees, bedsheets, and gunny sacks to carry bodies as well as injured persons to the ambulances, he said.

After finishing the rescue work, Patel turned to salvaging luggage and other belongings of those on board the ill-fated Air India plane.

"From 10 to 15 handbags, which were burnt and lying scattered, we recovered 70 tolas of gold jewellery, 8 to 10 silver articles, a few passports, a copy of Bhagavad Gita, Rs 50,000 cash and 20 dollars. We handed them over to a police official supervising the rescue operation," said Patel.

Patel, who earlier worked as a photographer, had volunteered at Ahmedabad Civil Hospital after the 2008 Ahmedabad serial blasts. He lost two of his close friends in one of the explosions that took place inside the trauma centre of the hospital.

According to Inspector DB Basiya from the Meghaninagar police station, one of their teams has been tasked with preparing a detailed list of every valuable article as well as luggage recovered from the crash site.

RTI Group Flags Mining, **Land Issues In Budgam**

BUDGAM: The smell of dust still hangs over Sukhnag River, long after the machines stopped digging.

On Wednesday, a small delegation walked into the office of Budgam's newly posted Deputy Commissioner, Dr. Bilal Mohi-Ud-Din Bhat. They didn't come with slogans or protest banners. Just facts, names, and a growing list of what they say is being lost-rivers, pastures, livelihoods.

There are laws. But they're only on paper," said Dr. Raja Muzaffar Bhat, who led the group from the Jammu and Kashmir RTI Movement. "What we're seeing is destruction in broad daylight."

The activists handed over documents and verbal complaints. They spoke of illegal clay mining in remote blocks, of fruit trees axed without fair compensation in Surasyar, and of Gujjar and Chopan herders being denied access to traditional grazing routes.

"Pastoralists are being pushed off their own land," said Basharat Chopan, who has lived off the highland pastures of Tosamaidan since childhood. "Now they have to beg for permission.'

For years, local herders say, a confusing maze of permits and official delays has kept them from reaching meadows they've used for generations. Some have

given up. Others still try.

The group also called for opening trekking routes across Pir Panjal, including Yusmarg and Doodhpathri, where local youth have invested in guiding and homestay services. "People prepared for tourists. The tourists are ready. But the gates are closed," said Mushtaq Ahmad Lone, RTI Movement's district coordinator.

Mining, though, was the sharpest concern. The National Green Tribunal recently flagged violations in Sukhnag. Residents claim extraction continues under the radar.

"They take the sand, leave craters, and disappear," said Shabir Ahmad Bhat, another member of the group. "The damage stays behind."

Dr. Raja Muzaffar acknowledged recent action by police in Charar Sharief and Chadoora. "But it shouldn't take a court to get results," he said. "The administration should be one step ahead."

The meeting ended without promises but with what the activists described as a "patient hearing."

"We're not asking for favours," Dr. Muzaffar concluded. "We're asking them to follow

J&K Porters Among Victims As Landslide Hits Kedarnath Yatra Route

RUDRAPRAYAG: A tragic landslide struck the Kedarnath trek route on Wednesday, claiming the lives of two palanquin-bearers from Jammu and Kashmir and injuring three others, including a pilgrim from Gujarat.

The incident occurred around 11:20 am near Junglechatti Ghat, a key point along the pilgrimage path to the revered Kedarnath shrine. According to police officials, boulders suddenly rolled down the hillside, striking pilgrims, p lanquins, and porter operators en route. The deceased have been identified as Nitin

Kumar and Chandrashekhar, both residents of Doda district in Jammu and Kashmir. The injured include two more palanquin-bearers from Doda—Sandeep Kumar and Nitin Manhas—as well as a pilgrim from Gujarat, Akash Chitriya of Bhavnagar, police said.

"All five individuals were thrown into a gorge after being hit by falling debris," said Rudraprayag Superintendent of Police Akshay Prahlad Konde. Swift response teams from the State Disaster Response Force (SDRF), along with local police and volunteers, launched a rescue operation, navigating treacherous terrain and using ropes to retrieve the victims.

While two individuals were declared dead at the scene, the injured were rushed to a local health centre. Two of them, reportedly in serious condition, were referred to a medical facility in Gaurikund for further treatment.

Despite the incident, the yatra has not been halted. "Pilgrim movement continues under strict police supervision," SP Konde confirmed.

This tragedy highlights the persistent risks associated with high-altitude pilgrimage routes, especially during the monsoon season when landslides are common.

Modi-Trump call

rime Minister Narendra Modi's firm rejection of US President Donald Trump's repeated offers to mediate between India and Pakistan is not just a reiteration of India's longstanding policy, it is a clear signal to the world that New Delhi will brook no ambiguity about its sovereignty and its red lines.

Ever since the signing of the 1972 Simla Agreement, India has maintained that the question of Jammu and Kashmir is a bilateral matter between India and Pakistan, to be resolved only through direct dialogue, if and when conditions permit. This principle is rooted not just in diplomatic consistency but also in bitter experience. Each time India has attempted talks with Islamabad, the overture has been followed, sooner or later, by a terror attack. This has made New Delhi wary of talking to Pakistan. In the past, when the two countries were closer to a breakthrough in their negotiations - for example during the 2003-07 dialogue between the then prime minister Manmohan Singh and the then Pakistani counterpart Parvez Musharraf - it is immediately followed by a major incident that disrupts the engagement and turns the discourse hostile.

The current situation is no different. Despite the latest flare-up, the pattern remains: Mediation by an external power, no matter how well-intentioned, may not change this fundamental reality.

President Trump's dramatic statements, claiming that he leveraged trade threats to stop the recent India-Pakistan conflict, or that he can broker a "solution" to Kashmir after a thousand years, do little for peace in South Asia. They undermine the carefully cultivated understanding between India and its Western partners that equating India and Pakistan is a reality that India doesn't see as reflecting the new geopolitical reality in the region.

That said, India has demonstrated the ability, capacity and maturity to handle its challenges on its own. And should there be a time for talks with Pakistan, it will come not through third-party pressure but through India's considered determination. Until then, any offer of mediation, however lofty in rhetoric, is both redundant and unhelpful.

As things stand, there is an irreconcilable divergence in the stances of the two countries. While Pakistan seeks focus on the Kashmir issue, India wants the stoppage of crossborder terrorism for any talks to start. As for the Kashmir issue, New Delhi has removed it from any future talks with Pakistan, except the discussions on the status of the part of the region under Islamabad's control. India, thus, has a bilateral approach to engagement with Pakistan. The message is clear: peace talks will be possible only when Pakistan addresses India's concerns on terror, not when outsiders knock on the door with unsolicited solutions.

The Land Trap

Buying property in Kashmir can cost more than money, thanks to fraud, confusion, and a broken system.

ehind the valley's 'shining' property market lies a darker reality, where buyers are misled, brokers exploit gaps, and the law lags behind.

Most property deals here happen through brokers. Few are licensed. Many operate on trust, not paperwork. And that's the problem.

Buyers, unfamiliar with legal terms like khasra numbers, mutation records, or registered sale deeds, often sign without fully understanding what they're getting into.

Some brokers deliberately show incomplete or forged documents. Others sell the same plot to more than one person. Many use family inheritance disputes or forged gift deeds to sell land under litigation. By the time buyers realise, they're either stuck in court or forced to settle for a fraction of what they paid.

Take the case of a Srinagar businessman who bought land for 50 lakh, only to find it had already been sold twice before. His case is now dragging through court. He's paying legal fees, fighting for land he thought he owned.

Why does this happen? Kashmir lacks a digital land registry. Records are mostly on paper, often outdated. Property laws are complex and rarely explained. Legal help is expensive. And revenue officials are too overwhelmed to verify every deal.

There's little deterrent. Scammers walk away while victims stay trapped.

Fixing this won't be easy, but it must start with digitis-

ing land records, licensing brokers, and requiring document verification before any sale.

Until then, Kashmir's land will stay fertile ground. Not just for homes, but for fraud. And every new buyer walks in blind, hoping they won't be next.

The Coaching Culture Is a Crisis

Behind every NEET rank is a child under siege. It's time we chose schools over stress.

ot long ago, in Anantnag, a young girl preparing for NEET died by suicide. She was just 18. She had left the familiarity of home for the promise of Kota, India's coaching capital, where thousands of students chase dreams shaped by the alphabet soup of JEE, NEET, and UPSC.

Her life ended in silence, just another number in a long, grim list of suicides that has turned Kota into something darker: a city of sorrow.

This wasn't the first tragedy, and, heart-breakingly, it won't be the last.

So far this year, at least 15 students have taken their lives in Kota. The Supreme Court recently asked the Rajasthan government what, if anything, had been done. But the real question runs deeper: how did we let things get this far?

We now live in an academic culture where "going to school" has become an afterthought, even an inconvenience.

Children as young as 14 are pulled from classrooms and placed into coaching centers with military precision. They wake before dawn, study until night, and see the world not in experiences, but in multiple-choice questions.

In Jammu and Kashmir, as in many parts of India, senior secondary students skip school altogether, enrolling instead in private coaching centers while maintaining what are, in essence, ghost admissions in their schools.

This arrangement is mutually beneficial. Private schools pocket monthly tuition fees and celebrate the students' exam results as their own. Students, meanwhile, get attendance certificates without ever stepping into a classroom.

But what is lost in this transaction — what disappears in the blur of test series and cram sheets — is something far more essential: the

soul of education.

A school is not just a building. It's a space where students learn to speak up, to fall down and rise again, to think critically and feel deeply. In its best form, a school is a laboratory of life. It teaches collaboration in morning assemblies, leadership in classroom debates, expression through arts and writing, and resilience through routine. Coaching centers, by contrast, offer content. Pure, relentless, mechanical content.

We need to ask ourselves, what are we preparing our children for? A high-stakes exam? Or a full life?

The rise of the coaching industry, now a multi-billion-dollar behemoth, reflects our collective fear. We worry that schools can't keep up, that they don't prepare our kids for the cutthroat competition of elite colleges. That fear is not entirely unfounded.

But in trying to compensate, we've allowed coaching centers to become not a support system but a replacement. And with that shift, something fundamental has been lost.

It's not just about stress. It's about identity. Children in this system are not seen as individuals, with talents and flaws, dreams and doubts, but as output machines. A child's worth is measured in percentile ranks and ranks alone. The pressure to perform is constant, the emotional scaffolding non-existent. When students break down, as they increasingly do, we treat it as a private failure rather than a public warning.

Consider this: in Anantnag, a girl named Deeba Bilal recently scored 97% in Class 11 without any coaching. Her success came from consistent school attendance and an encouraging learning atmosphere at HSS Salia. She credited her school, not a private tutor, for her achievement. There's also Syed Sania Misbah, a student and activist nominated for the Rashtriya Bal Puraskar for her advocacy for tribal

girls' education.

These students are reminders that schools still matter. That schools, when empowered, can nurture excellence. Not just in marks, but in meaning.

We often speak of 21st-century skills: critical thinking, creativity, communication, collaboration. But coaching centers are still stuck in the 20th century, or perhaps even earlier, where rote learning is king and human emotion is irrelevant.

Schools, at their best, are still trying to teach empathy, purpose, and belonging. They are still trying to raise not just toppers, but citizens.

But to do that, schools must reclaim their space. We need policy reform, yes, but more than that, we need cultural reform. Parents must stop viewing school as a checkbox and coaching as a cure-all. Teachers must be trained not only to deliver lessons but to support emotional well-being. Education departments must ensure that dummy admissions are not just discouraged but made impossible. And we must create avenues for academic success that do not require children to sacrifice their childhoods.

The Ministry of Education's recent move to bar coaching enrollment for students under 16 and to clamp down on misleading promises is a start

But regulation won't fix what culture has normalized. We need to ask ourselves: what kind of learning do we value? What kind of child do we want to raise?

At the end of the day, a child who cracks an exam but loses his sense of self in the process is not a success story. It's a cautionary tale.

And we already have too many of those.

In every town and village of Kashmir, there's a line. It begins in coaching centres, winds through government offices, and ends somewhere between postponed exams and age limits. This line is filled with young, educated people—graduates, postgraduates, engineers—who spend the best years of their lives chasing one goal: a government job.

They're not lazy. They're not aimless. They're doing exactly what they were told to do.

Since childhood, many Kashmiri youth grow up hearing that a "sarkari naukri" is the only path worth taking. Whether it's as a schoolteacher, a constable, or an officer, government jobs are held up as the gold standard of success. Families pin their hopes, and often their savings, on that one dream. Entire lives are built around preparing for an exam that may never happen.

But how many actually make it?
In recent recruitment drives, the numbers tell a harsh story. For a hundred posts, ten thousand apply. In some cases, the ratio is even worse. Imagine working for years, attending classes, burning the midnight oil, and still not making it—not because you weren't good enough, but because the odds were never fair to begin with.

What happens to the rest? Do they try again? Shift to private

The Great Queue Trap

Every year, thousands of young Kashmiris wait endlessly for government jobs that may never come. It's not just a crisis of employment, it's a collapse of dreams, dignity and direction.

jobs? Or just wait?

The truth is, many of them wait. And wait. Coaching becomes routine. Family pressure builds. Mental health starts to suffer. And years slip by.

There's a saying: "Intizaar sab kuch khatam karta hai"—waiting kills everything. For too many of our young people, this waiting has become their life.

The coddest port is how this

The saddest part is how this queue—this obsession with one kind of job—shrinks ambition. We now have engineers applying for Class IV posts. Not because they lack skill, but because they've been taught that it's better to mop a government floor than build something of their own.

It's not just desperation. It's a lack of imagination in our system. We've built a culture that puts

We've built a culture that puts government labels above personal growth. That sees stability as more important than creativity. That rewards waiting more than working. And the cost? Thousands of capable minds never explore other possibilities. They don't start businesses. They don't learn trades. They don't try digital work, freelance gigs, or creative paths. They just wait

Yes, job security matters. And yes, government jobs do offer that. But they are not the only source of rizq. Islam reminds us that sustenance comes from Allah, not from a government file. The Qur'an says: "Indeed, it is Allah who is the Provider, the firm possessor of strength." That verse isn't just religious comfort. It's a call to shift our mindset.

So why are we still knocking on the same closed door?

Look around. The world has changed. People earn from coding, designing, teaching online,

farming, baking, and building apps. Young people are creating podcasts, running media pages, and exporting crafts. These aren't backup plans. These are futures. But only if we allow them to be seen as such.

The cost of not doing this

The cost of not doing this is already too visible. Burnout. Frustration. Thirty-year-olds still asking parents for pocket money. Depression that goes undiagnosed. And at the end, even those who do get the jobs often feel underused, unhappy, or stuck. They didn't chase a passion—they chased a guarantee.

We need to ask: what is success, really?

Is it a salary slip, or the joy of building something that matters? Is it an office chair, or a life you control? Kashmir's youth are among the brightest in the country. They deserve more than a waiting room.

Families need to widen the definition of dignity. Schools must teach skills beyond textbooks. Governments should back ideas, not just announce vacancies.

And we as a society must stop seeing anything outside "government service" as failure.

Kashmir's Aspirants Deserve Better Than a Glitchy Website

'm writing to express deep concern — not just mine, but that of many job aspirants across Jammu and Kashmir — about how the Jammu and Kashmir Public Service Commission (JKPSC) is functioning. Most people already know about the delays in exams, slow results, and irregular recruitment calendars. But there's another problem that doesn't get talked about enough: the complete failure of its online system.

Recently, three of my friends — all law graduates — tried to apply for a JKPSC exam. The process should've been simple. Fill out the form online, upload documents, pay the fee. But when they got to the payment stage, the website froze. No error message, no confirmation. Just nothing. They waited. Tried again. Switched browsers. Still

All three live in different districts — Ganderbal, Anantnag, and Kupwara. That same day, they all faced the exact same issue.

They emailed JKPSC for help. No one responded. With the deadline getting close, they had no choice but to travel to Srinagar and sort it out in person. One spent nearly a thousand rupees just on travel. Another skipped work. And when they reached the office, no one seemed surprised. Their complaint was treated like routine.

It shouldn't be like this.

JKPSC is not a college website. It's a state-level commission that handles the future of thousands of young people. Yet, it continues to operate with an outdated portal that often doesn't work, doesn't reply to emails, and doesn't seem to care.

One of those friends, after fixing the payment in person, came home to upload the rest of his documents. The portal failed again. He couldn't upload anything. Another round of anxiety. Another day wasted. Another trip possibly needed.

This isn't a rare story. Many candidates go through this, especially those from remote areas.

They don't just deal with broken links. They deal with broken hopes. Because behind every form is a young person who's studied for years and is just asking for a fair shot.

What makes this worse is that JKPSC charges a hefty application fee. For that money, we don't get a smooth experience. We get errors, delays, and silence.

This isn't just about tech. It's about trust. It's about the message being sent to thousands of young minds: that we must fight the system even before we fight for the job.

I urge those in power to take this seriously. Fix the portal. Respond to queries. And treat candidates with the respect they deserve. It's the least we ask.

A Builder of Roads, and Lives, in South Kashmir

With mud on his boots and no PR team, a young Kashmiri engineer is doing what decades of policy couldn't

n Kralmad, a village tucked under the Pir Panjal in South Kashmir, people speak of a man who doesn't sit in offices. He builds

Gowhar Ahmad Mir is 36. A computer engineer by training. A contractor by profession. A local hero by default. He walks to work in dusty shoes, rolls up his sleeves, and calls his workers by name.

In a place long defined by absence-of jobs, of leaders, of plans that last-his presence is starting to change things.

"He didn't leave," said Abdul Rahim, an elderly farmer leaning against a stone wall. "That's all it took to matter here."

After earning his engineering degree, Gowhar could have gone the usual route-Srinagar, Delhi, Dubai. He stayed.

In 2010, he registered a small construction group under a government-backed self-help scheme. No capital. No machines. Just borrowed tools and a handful of local youth who believed him when he said, "We can build this ourselves.

Today, his firm handles public infrastructure projects across the Doru tehsil-roads, classrooms, irrigation canals, community centers. He employs over 50 men, most from nearby villages. Many had no income before.

"He gave me my first job," said Waseem Ahmad, 28, who now manages field operations. "And he told me, learn everything. One day you'll lead.'

Gowhar shows up to work sites with his own helmet, sometimes before the labourers. He doesn't outsource supervision. He doesn't sit in air-conditioned cabins. "If I'm not in the field, I'm not leading," he says.

But it's not just the concrete that matters. In Doru, his influence runs deeper.

When a widow's roof collapses in the winter, his men fix it. When a student needs tuition, the bill gets paid, quietly. There are no press releases, no social media posts. Just small interventions that, over time, stitch to-

"He never asks for anything," said Mehnaz Jan, a school teacher. "But if you need help, somehow, he already knows.

Locals call him muhafiz, protector. During floods, he organizes relief. During curbs, he sends medicine. During snow, he clears the roads himself. He's never contested an election, but village heads ask him to mediate disputes. Young men ask him how to register a business. Women ask if their

sons can apprentice under him. In a region where many grow up watching their dreams float outward-to cities, to other states, to other countries-Gowhar built a life by staying.

"I tell boys, you don't need to escape to succeed," he says. "You need to start from where you are."

His vision now includes a skill training center. He's drafted a plan for a local construction academy to teach plumbing, masonry, digital design. He wants to create a cooperative for small-time contractors so they don't drown in debt during lean seasons. The plan is modest. The ambition is not.

He doesn't speak the language of development conferences. He speaks Kashmiri and Urdu and a little Hindi, in a tone more fatherly than fiery. That makes him more trusted than most district officials, more accessible than the local MLA.

"Gowhar is not just building houses," said Bashir Lone, a retired school headmaster. "He's rebuilding belief."

The younger generation, often disengaged and disillusioned, sees in him something rare. A figure who doesn't preach success, but models it, without ego.

Sameer Bhat, 24, used to consider leaving for Punjab or Delhi. He now runs a small plumbing business, inspired by Gowhar's example. "He told me: make mistakes here, not in a strange city. That stuck."

In the larger politics of Kashmir, names like Gowhar don't usually surface. But on the ground, in the spaces between government schemes and lived reality, he has become in-

"He's the only person we know who builds and stays," said Irfan, a young electrician. "Everyone else comes to cut the ribbon."

The locals call him the people's engineer. Not for his degree, but for the dignity he brings to work.

If you walk down the road from Doru to Kralmad in the evening, you'll likely spot him. Not in a motorcade. Not in a boardroom. But standing in the mud, phone in one hand, pointing with the other, making sure the pavement holds.

"It's not about contracts," he says. "It's about making this place livable."

He pauses. The call comes again. He turns, walks back toward the worksite.

Behind him, a group of boys watch closely. Some of them will build roads next year. Some will start their own crews. All of them have seen what it means to lead without leaving.

Theij-Kad: When Rice Fields Sang in Kashmir

Once, summer in Kashmir arrived with song, sweat, and soil. Now, amid cranes and concrete, the old music is fading fast.

easons in Kashmir once moved like chapters from an old book. You could tell when one ended, when another began. Not by calendars, but by colour, scent, and sound.

Summer didn't simply arrive. It entered with a rustle, a murmur, a rhythm. And at its heart was Theij-Kad — the paddy season that turned the Valley into something lyrical.

Ask the old women in Qazigund or Shopian, and they'll remember. They'll speak of the May sun melting into the fields, of ankles sunk in cool mud, of voices rising like incense in the morning air.

Theij-Kad wasn't a task. It was a celebration. A calling. A festival disguised as farming.

The land, back then, was a theatre. Women from neighbouring homes arrived at first light, their fists full of rice saplings. They didn't speak much Mehjoor's verses. Rasool Mir's laments. Lalla Ded's prayers.

The songs weren't performed. They were lived. Bent over the flooded fields, these women stitched melodies into mud.

Children were sent as little couriers, carrying pink noon-chai in copper samavors, careful not to spill. The fields smelled of milk-tea, damp earth, and cow dung. There were no machines, only muscle.

The men, meanwhile, moved in silence, clearing water channels, pulling seedlings from nurseries,

dragging heavy baskets. When weeds came, they returned, hands calloused, knees stiff, to bend again.

It was hard work, yes. But it had a rhythm. A meaning. It connected people to land, families to each other. It marked time not with alarms but with the soft ripples of water shifting around ankles.

But that world is fading. The fields have grown silent. The women no longer gather. The songs are no longer sung.

Walk through Pulwama or Baramulla now, and you'll see what took their place. Factories, malls, housing blocks. The fields weren't abandoned, they were bought, sold, repurposed.

Agriculture gave way to horticulture. Apples yield more profit than rice. A box of walnuts earns more than a bag of grain. Land, once sacred, is now real estate.

Despite laws meant to protect farmland, the shrinkage is visible. Between 2011 and 2021, paddy cultivaley. Satellite images confirm it. What the eye misses, the numbers catch.

And with this vanishing land, something else has disappeared. The spirit of Theij-Kad.

Where once women sang, now hired men from outside Kashmir work in silence. They transplant saplings swiftly, mechanically, with no knowledge of the old songs, no connection to the soil beneath their feet. Their work is efficient. Their presence is quiet. But it lacks the beauty of belonging.

In the past, Theij-Kad was also a

time of gathering. Evenings were for feasts. Beef cooked in three ways. Potatoes from the backyard. Chutneys ground by hand. The entire village, it seemed, sat at one long table. Married daughters returned home with children in tow, adding to the laughter. Some engagements were even delayed until after Theij-Kad, as if the land needed time to breathe first, be-

fore celebrations could begin. Now, such evenings are rare. Kitchens are smaller. Songs are fewer. Fields are fewer still.

Yet, the memory holds. Sometimes, in early June, if you find yourself near an old village, you might hear it. A low hum. A lone woman's voice. A whisper of a song from a time when farming was not a chore but a chorus. A time when Kashmir's rice fields didn't just grow grain, they grew joy.

We are told this change is progress. That development must come. That the economy must growth silences memory? When profit tears apart the page before the chapter ends?

Theij-Kad still arrives each year. The sun still warms the soil. Water still glistens in the fields. But fewer people listen. Fewer hands reach into the mud.

What remains is a shadow of the old season, a flicker of its music. And if we're not careful, even that may vanish.

Why Jammu and Kashmir Needs Sociology More Than Ever

In a region shaped by conflict and complexity, sociology offers more than theory. It offers a way to see clearly, ask harder questions, and shape a better future.

e live in a world where everything moves fast. Opinions arrive before facts, and headlines often crowd out history.

In Jammu and Kashmir, where life is layered with struggle, hope, and constant change, that speed can blur what really matters. That's where sociology comes in.

Sociology isn't just an academic subject tucked away in university departments. It's a way of seeing. A way of asking questions that many

Why do some communities remain poor while others progress? Why do youth turn to drugs? Why do

schools fail some and uplift others? These aren't just personal tragedies-they're social patterns. And to understand them, we need to look

Jammu and Kashmir has always demanded that kind of deeper thinking. The region has been shaped by long years of political conflict, social tension, economic uncertainty, and cultural shifts. Every few years, the landscape seems to change: new laws, new leadership, new headlines.

But the underlying questions remain. Who benefits? Who gets left behind? Who decides what progress

Sociology helps us trace the invisible lines that connect people's private lives to public issues. It looks at how institutions like education, religion, media, family, and government shape our choices and limit them. It helps us move from asking, "What's wrong with that person?" to "What happened to their world?"

Take, for example, the growing issue of drug addiction in Kashmir. It's easy to blame individuals. But sociology shows how addiction links to unemployment, lack of purpose, mental trauma, peer pressure, and social breakdown.

Gender-based violence isn't just about one man and one woman. It ties to patriarchy, silence, lack of support, and deeply rooted norms.

School dropout rates are not just about bad students or teachers. They often reflect income inequality, caste bias, inaccessible education, and shifting family expectations.

Anthony Giddens, a well-known sociologist, said society is more than the sum of its parts. What he meant was: to truly understand people's lives, you have to understand the systems around them. You can't separate a girl's dreams from the village she lives in, the expectations her family places on her, or the stories her society tells about success and shame.

In Jammu and Kashmir, sociology gives us the tools to name these connections. It helps explain why the same problems-violence, inequality, unemployment-keep returning despite programs, policies, and promises.

It helps us see how caste, class, gender, religion, and power intersect in real life, not just in textbooks. And it urges us to listen, to those who are often ignored.

Sociology doesn't stop at pointing out what's wrong. It helps us imagine what could be better. It supports dialogue across difference, builds empathy, and encourages change that begins with understanding. In a place like Kashmir, where trust is fragile and stories often go unheard, that matters.

When young people study sociology, they don't just memorize facts. They learn how to think. They learn to ask: Why is this happening? Who gains? Who suffers? What might be done differently? That mindset—critical, curious, compassionate-is what the region needs more of.

Sociology also teaches us to recognize what's working. The strength of extended families. The resilience of displaced communities. The cultural values that hold people together. The everyday kindness that still exists, even in difficult times.

Jammu and Kashmir stands at a crossroads. The choices made today will shape its future for decades. To make the right choices, we need more than numbers and plans. We need insight. We need understand the history behind the headlines and the people behind the

Sociology is not a luxury. It's not only for professors or policymakers. It's for anyone who wants to understand their place in a changing world. And it's especially for those who

want to turn understanding into ac-

A Hormonal Epidemic in Kashmir's Classrooms and Colleges

Polycystic Ovarian Disease is silently growing in Kashmir's teenage girls and women. Doctors say the solution isn't in pills but in everyday choices.

Tou hear it in whispers during bus rides, in clinic waiting rooms, in college corridors. Girls skipping periods for months. Women in their 20s growing facial hair. Teenagers breaking down over sudden weight gain and cystic acne.

A silent crisis is gripping women in Kashmir, and it has a name: PCOD.

"I hadn't seen my period in five months," says 19-year-old Iqra from Anantnag. "I was scared, but the doctor just wrote it off as stress."

When she finally got an ultrasound, the image showed what doctors call a "string of pearls": rows of tiny, undeveloped follicles lining her ovaries. It confirmed what she had feared: Polycystic Ovarian Disease, or PCOD. And she's not alone.

A recent estimate suggests that more than 37% of women and girls in Kashmir may be affected by PCOD. That's more than one in three. Many doctors say it's not an issue that

medicine alone can fix. "We're seeing it in girls as young as 13," says Dr. Iffat Wani, a gynecologist based in Srinagar. "And we can't just hand them pills and send them off. The root problem is deeperlifestyle, food, stress, and too much sitting."

PCOD isn't just about irregular periods. It can mean hair growing where it shouldn't, acne that refuses to heal, sudden weight gain, and infertility.

Most of this is linked to hormonal confusion inside the body, especially when insulin and male hormones (called androgens) take over. "People think PCOD is about cysts. But it's

really a hormonal imbalance," says Dr. Wani. "The ovaries don't release eggs regularly. That throws everything off."

Inside the body, things get complicated fast. Hormones that are supposed to work in harmony begin to clash. The brain tells the ovaries to prepare for ovulation, but the signal gets scrambled. Instead of one egg maturing, multiple follicles start to grow and then stall halfway. These immature follicles appear on an ultrasound as cysts, though they're not the dangerous kind, they still mess with the cycle.

What triggers this chaos? Doctors say one word: insulin.

Insulin is the hormone that manages sugar in the blood. But when the body stops responding to it properly—a condition called insulin resistance—the pancreas pumps out more.

This extra insulin pushes the ovaries to produce more androgens. That, in turn, causes acne, unwanted facial hair, and irregular cycles. Even more worryingly, this isn't just happening in women who are overweight. "We've seen PCOD in thin girls too," says

Dr. Nusrat, a clinical nutritionist in Pulwama. 'Weight isn't always the cause. It's about how the body handles sugar.' Still, excess belly fat adds fuel to the fire. Fat releases chemicals that mess with insulin and

increase inflammation, making things worse. Combine that with hours of sitting, a diet filled with processed foods and sugary drinks, and little to no exercise, and you have

a perfect recipe for hormonal meltdown. Igra blames her habits too. "During the pandemic, I stopped going out. I gained 12 kilos, and my sleep was all over the place. I used to eat instant noodles every day. That's when my periods stopped."

Doctors across Kashmir echo the same concern: too much junk food, sugary beverages, late-night screens, and not enough movement.

"Our girls are drinking soda, skipping meals, eating cheese-loaded snacks, and then not moving an inch," says Dr. Nusrat. "It's a ticking time bomb."

There's also another problem: social silence. Many girls feel too embarrassed to talk about irregular periods or facial hair. Mothers often dismiss it. Teachers don't talk about it in schools. "We need more awareness," savs Dr. Iffat. "Girls must know what's happening in their bodies."

Medical treatment does exist. Pills containing Myo-Inositol or insulin-sensitizers like metformin are commonly prescribed. But most doctors now push for a different kind of medicine: lifestyle change.

"Even losing 5% of body weight can make periods return," says Dr. Nusrat. "That's two to four kilos for many girls. And you don't need a gym. Just walking briskly, avoiding processed sugar, eating home-cooked food, drinking enough water-it all helps."

Stress is another silent culprit. The body responds to mental tension by releasing cortisol, another hormone that can trigger insulin resistance.

Add erratic sleep patterns, social media doomscrolling, exam pressure, and it's a storm. Sleep matters too. "Girls are staying up till 2am, eating chips at midnight," says Dr. Iffat. "The body's natural rhythm is disrupted. Hormones go out of sync."

So what works? Not pills. Not surgery. Just a return to the basics: move more, eat real food, sleep on time, and unplug.

Some girls are turning their lives around. Iqra started walking every morning. She stopped drinking fizzy drinks, switched to homemade meals, and began journaling to manage stress.

"My periods came back after three months," she says, smiling. "I didn't even take medicines." The problem is real. The numbers are

scary. But the solution isn't out of reach. The real challenge is not just medical, it's cultural. Can families talk openly about menstruation? Can schools educate girls early? Can society stop treating hormonal health as a private shame?

As PCOD creeps silently into the lives of young Kashmiri women, it's not just their bodies that are hurting, it's their confidence, their fertility, and their future.

Study Indicates Incidence Of Rheumatoid Arthritis Increased 13% Since 1990

heumatoid arthritis affected nearly 18 million people worldwide in 2021—an over 13 per cent rise in cases since 1990, a study has found.

According to the study more

According to the study, more young people are being diagnosed with this disease, which became geographically widespread with time.

Rheumatoid arthritis, a chronic autoimmune condition, occurs when the body's immune system mistakenly attacks its healthy tissues, especially those in joints, leading to inflammation, pain and stiffness.

The study, published in the journal Annals of the Rheumatic Diseases, found that population growth impacted the disease's burden in most countries, including India, Pakistan and Spain, while ageing impacted the most in Thailand, China and Poland.

The regions high on the sociodemographic index were hit the hardest, while those low witnessed an increase, it said.

"While previous Global Burden of Disease (GBD) studies have provided important insights, they have largely focused on high-level descriptions and visualisations at global and national scales, failing to capture local disparities or the dynamic interactions between socioeconomic development and disease trends," said principal investigator Queran Lin from Imperial College London.



Coordinated by the Institute for Health Metrics and Evaluation, University of Washington, GBD studies analyse data from over 200 countries and territories to map trends in disease prevalence, severity and deaths attributable to 371 diseases between 1990 and 2021.

"In 2021, RA (rheumatoid arthritis) affected 17.9 million people globally, with a 13.2 per cent increase in incidence rate from 1990-2021, trending younger and broader," the authors wrote.

They were "able to generate the most granular disease burden estimates to date, offering a new framework for guiding precision public health across diverse populations", Lin said. The study also projected that the regions with a low-middle sociodemographic index could see an increase in burden by 2040 due to ageing and population growth, while the burden in regions high on

the index could decrease.

Controlling smoking could

curb deaths due to the chronic disease in high-smoking regions (such as China) by 16.8 per cent and the burden on the population by over 20 per cent, the authors said.

Japan showed a decline in burden of rheumatoid arthritis (by over 22 per cent) despite having a high sociodemographic index, which the authors said might re ect nationwide early diagnosis programs, widespread use of biologic therapies and a diet rich in anti-inflammatory components.

The authors called for localised policies and resource allocation, particularly in the regions having low-middle sociodemographic index. "Demographic changes and uneven health infrastructure exacerbated RA burdens and disparities worldwide, with high SDI areas hardest hit while low SDI regions saw increases. Trend analysis empowered targeted policies such as localised smoking control to address these inequities." the authors wrote.

Govt To Shortly Notify Rules For Mandatory Use Of Indian Standard Time: Joshi

NEW DELHI- The government has decided to make mandatory the use of Indian Standard Time for all legal, commercial, digital and administrative activities, Food and Consumer Affairs Minister Pralhad Joshi said on Wednesday.

This initiative will translate into more secure digital transactions, accurate billing in utilities, reduced cybercrime risks and synchronized timekeeping in transportation and communication. Presently, several systems

rely on foreign sources of time. To make Indian Standard Time (IST) mandatory, the government will shortly notify Legal Metrology (Indian Standard Time) Rules, 2025. The draft rules were issued in January

2025 for stakeholders' feedback. On Wednesday, the Department of Consumer Affairs organized a round table conference on Time Dissemination here.

Joshi emphasized on the strategic significance of the Time Dissemination Project being implemented by the department in collaboration with CSIR-NPL and ISRO.

He said the upcoming rules will mandate synchronization of all legal, commercial, digital and administrative activities with IST, "prohibiting the use of alternative time references unless explicitly authorised".

"We are notifying the rules. that, we are now One Nation One Time... These rules will be mandated very shortly. Exact date will be decided at a later stage," Joshi told reporters here.

today's data-driven the un-synchronised world, clocks lead to digital mismatches, investigation challenges and network inefficiencies. Several systems currently rely on foreign timing sources like GPS, posing the risk of cyber attacks, inconsistency and non-traceable time stamps," he said.

This project addresses a longstanding gap of institutionalising the IST as the official legal time of India, the minister said.

"Since we have decided to implement and notify these rules... and that is going to be mandatory, we had a round table conference of all stakeholders...," the minister said adding that "very shortly, IST will be a reality. We will have our own time".

Sitharaman Ask Fintechs To **Find Solutions To Prevent Digital Arrests, Cyberfrauds**

NEW DELHI- Finance Minister Nirmala Sitharaman on Wednesday asked fintech startups to come out with solutions to deal with the rising incidence of digital arrests, cheating by fly-by-night operators, and other kinds of cyberfrauds.

Lauding the success of fintechs, the Finance Minister said they have helped in speeding up financial inclusion, and taking the payment system to even the far-flung areas of the country.

Speaking at the Digital

Payments Awards 2025 Ceremony here, Sitharaman said it is important to ensure that startup companies come up with solutions so that people are not arrested at home digitally, or fly by night operators don't take away their money.

Another major threat, she pointed out, is 'deep fake', which is causing a lot of damage to the public in large.

'Today, we should take care of addressing them so we need a set of fintech companies which are constantly working to give solutions for the newer challenges which are arising, Sitharaman said.

She also called upon the fintech sector to further expand the digital lending facilities to the key MSME sector. Sitharaman further said In-

dian fintech innovations have the potential to become global public goods that can benefit other emerging and developed economies. This will open new markets for our firms.

International merchant



payments through UPI are now accepted at select merchant outlets in seven countries, including Bhutan, France, Mauritius, Nepal, Singapore, Sri Lanka and the UAE.

"Our players must aim to export our successful models abroad and capture global markets. We have the talent, we have the market scale, and we have the proven solutions,' she said. This, she said, will open up new markets for domestic firms.

Indian fintech market is projected to grow to over USD 400 billion by 2028-29.

"That's not too far away. Just three years. Reflecting on an anticipated annual growth of 30 per cent. The scale of opportunity is immense. I firmly believe its best chapters are yet to be written.

"Together, let us 'Innovate. Include, and Inspire'. Innovate new solutions fearlessly, include every citizen in your vision, and inspire the world with what India can achieve,' she said.

Noting that India now actually accounts for almost half of all real-time digital transactions in the world, she said direct benefit transfer (DBT) has saved a lot money by plugging

About Rs 44 lakh crore have been transferred through DBT since 2014 and Rs 3.48 lakh crore have been saved.

The Minister said the speed at which innovation is happening in India is just a dream for many other countries.

"Several advanced countries are nowhere close to the kind of momentum our fintech companies have achieved, not just in terms of progress in their respective areas, but also in creating entirely new paradigms. This is something which is very unique of the Indian fintech sector," she said.

A World Bank study noted that through Digital Public Infrastructure (DPI), India achieved an 80 per cent financial inclusion rate in just six

Sebi To Introduce Special Measures To **Facilitate Voluntary Delisting Of certain PSUs**

MUMBAI- Markets regulator Sebi on Wednesday decided to introduce special measures to facilitate voluntary delisting of public sector undertaking where the government owns 90 per cent or more of shares.

Among the measures include relaxations from requirement of two-third threshold for approving delisting by public shareholders and in the mode of computation of floor price.

Under current rules, delisting is successful if promoter shareholding reaches 90 per cent. Moreover, the floor price for delisting is calculated using several pricing metrics such as 60-day average price and highest price in the last 26 weeks.

These rules can make delisting costly for PSUs due to high market prices despite low book values or weak financials.

"In certain Public Sector Undertakings (PSUs) with minimal public float, the shares are traded frequently at prices which are not com-



mensurate with operations, net worth, profitability and other financial parameters of the company. If such PSUs are to undertake delisting, the current norm of 60 days' volume weighted average market price makes it financially burdensome to delist such companies," Sebi said after the conclusion of its board meeting.

In view of these drawbacks and to facilitate delisting of such PSUs, the board approved amendment to Sebi (Delisting of Equity Shares) norms for introduction of a special measures for PSUs (other than banks, non-banking financial companies (NBFCs) and insurance companies). Those under the ambit of any financial sector regulator are to undertake voluntary delisting through fixed price delisting process when the shareholding of the Covernment of India as moter equals or exceeds 90 per cent.

Further, these PSUs can delist without meeting minimum public shareholding norms. Moreover, delisting can happen at a fixed price -- at least 15 per cent premium over the floor price -- regardless of trading frequency.

The regulator decided to abolish the requirement for two-thirds public shareholder approval in cases where the promoter plus PSU holding is already 90 per cent.

Regarding handling unclaimed money, Sebi said that such money should be transferred to the stock exchange for 7 years and then moved to the Investor Education and Protection Fund (IEPF) or the regulator's IPEF. Further, investors can claim the amount during this period.

scheduled to make their first joint public intervention since the FTA negotiations concluded last month at the India Global Forum (IGF) UK-India Week in a session - Agreement to Action in the UK-India FTA.

Reynolds has earlier said that "this trade agreement is a huge economic win for the UK – the biggest trade deal since Brexit and the best deal that India has ever offered".

Surrendering its early gains, the 30-share BSE Sensex declined by 138.64 points or 0.17 per cent to close at 81,444.66. After a weak opening, the index hit a high of 81,858.97 in morning deals but failed to hold onto gains later. The barometer dipped 346.29 points or 0.42 per cent to hit a low of 81,237.01. The 50-share NSE Nifty edged lower by 41.35 points or 0.17 per cent to settle at 24,812.05, marking its second day of losses.

Among Sensex firms, Tata Consultancy Services was the biggest loser dropping by 1.79 per cent. Adani Ports fell by 1.55 per cent, Hindustan Unilever by 1.35 per cent, Bajaj Finserv by 1.16 per cent, and Nestle by 0.95 per cent. Losses in ICICI Bank, Larsen & Toubro, Infosys, NTPC and HCL Tech also dragged the index down.

On the other hand, IndusInd Bank surged by 5.12 per cent after a report expressed optimism over its performance in the coming 12 months.

Titan rose by 1.99 per cent, Mahindra & Mahindra by 1.24 per cent and Maruti by 1.12 per cent.

"The domestic market failed to maintain the opening gains as the continuing tensions in the Middle East & volatility in oil prices dragged the overall sentiment. However, auto and consumer discretionary gained in expectations of a demand revival," Vinod Nair, Head of Research, Geojit Investments Limited, said.

Solutions To Problems Can't Come From Battlefields: PM In Croatia

Zagreb: Prime Minister Narendra Modi on Wednesday said India and Croatia have agreed that whether it is Europe or Asia, solutions to problems cannot come from battlefields, asserting that dialogue and diplomacy is the only way ahead.

In his media statement following talks with his Croatian counterpart Andrej Plenkovi , Modi said both leaders agree that "terrorism is an enemy of humanity" and it is inimical to forces that believe in democracy.

"We agree, whether in Europe or Asia, solutions to problems can't be found from battlefields, and dialogue and diplomacy is the only way," he said.

His comments come amid an escalating situation in West Asia as the military confrontation between Israel and Iran

Modi said that for any country, respect for territorial integrity and sovereignty is essential.

During the meeting, Modi also said it was a "happy coincidence" that both he and Plenkovi were given the opportunity to serve a third term by the people of their respective countries last year.

"With this mandate, in our third terms, we have decided to give three-time pace to our bilateral ties," he asserted.

"Held productive talks with my friend, Prime Minister

Andrej Plenkovi in Zagreb. Our talks covered many sectors, aimed at making the India-Croatia bond even stronger. We will be working closely in the fields of defence and security, pharmaceuticals, agriculture, IT, renewable energy, technology and more. Synergies in areas like semiconductors, shipbuilding, connectivity and more will also be greatly beneficial,"

Modi said in an X post. The two leaders reviewed the full spectrum of India-Croatia bilateral relations and explored avenues to deepen collaboration in various sectors, Ministry of External Affairs Spokesperson Randhir Jaiswal said on X.

Prime Minister Modi thanked Croatia for its steadfast support to India in fighting cross-border terrorism. The leaders also called for further deepening India-EU strategic ties, he added

Modi was accorded a ceremonial welcome on his arrival for the talks.

He is the first Indian Prime

Minister to visit the Balkan nation. In his remarks, Plenkovi said his meeting with Modi reflects the importance and strength of relations between the two countries.

"We also said that global situation in terms of security is very volatile. So, it is important to have the most influential actors worldwide to give their contribution to peace, de-esca-lation of conflict, and to respect

the rule of international laws." the Croatian prime minister

He added that the Russia-Ukraine conflict and the Israel-Iran situation also figured in the discussions.

He further said that Croatia expressed sorrow over the recent terror attack in India.

"We have understood very well, Indian Prime Minister's message on fighting against terrorism, because that is the biggest threat to global stability," he underlined.

Police Directed To Set Up Additional Checkpoints In Jammu Range

Ahead of the Jammu: Amarnath Yatra, police have been asked to identify locations to set up more checkpoints in the border districts of Jammu, Samba, and Kathua for the security of pilgrims.

The 38-day-long yatra is scheduled to start on July 3 from the twin routes — the traditional 48-km Pahalgam route in Anantnag district and the 14-km shorter but steeper Baltal route in Ganderbal district - to the 3,880-metre-high shrine of Amarnath.

The first batch of pilgrims will leave for Kashmir from Bhagwati Nagar a day before the start of the yatra.

"All the officers were directed to strengthen all the nakas (checking points), especially during night hours. They were also directed to identify places where more nakas can be established for the security of the yatris," a police spokesperson said.

This was conveyed to the police officers by Deputy Inspector General (DIG), Iammu-Samba-Kathua

range, Shiv Kumar Sharma, during a security audit of various police and paramilitary deployments in and around the base camp, lodgements, yatra route, CCTV installations, and parking areas.

Sharma conducted a security review of Ram Mandir Purani Mandi, Geeta Bhawan Parade, the base camp at Bhagwati Nagar, various routes, and the highway, the spokesperson said.

He also interacted with officers and security personnel of the CISF deployed at Ram Mandir Purani Mandi, in Jammu and directed them to remain extra alert at their posts, the spokesperson said.

All Station House Officers (SHOs) were also directed to remain alert and intensify security measures and patrolling during night hours.

The Bhagwati Nagar Yatri Niwas in Jammu serves as the main base camp for Amarnath pilgrims before they proceed to the Kashmir Valley to pay obeisance at the 3,880-metre-high shrine of Amarnath.

Air India Cancels 3 Int'l Flights Over Maintenance, Technical Issues

Mumbai: Air India has cancelled three of its international flights on Wednesday owing to various reasons, including maintenance and technical issues.

Two of these flights were cancelled after the passengers had already boarded the aircraft, the airline said.

The airline said it had to cancel its Toronto-Delhi flight AI188 of June 18 due to extended maintenance and consequently operating crew coming under regulatory flight duty time limitation norms.

Passengers, who had already boarded the aircraft, were disembarked following cancellation of the flight, it said.

Also, flight Al996 from Dubai to Delhi on June 18, 2025 was cancelled due to technical reasons and passengers were disembarked after boarding, as per Air India.

However, the airline's flight AI2145 from Delhi to Bali was cancelled after it was advised to return to Delhi mid-way due to reports of volcanic eruption near the destination airport Bali, in the interest of safety. Air India stated.

The flight safely landed back in Delhi and all passengers were disembarked.

Air India said its teams on the ground are making alternative arrangements for the passengers to fly to their respective destinations at the earliest.

Full refunds on cancellation or complimentary rescheduling have also been offered to passengers. Air India said it is anticipating some disruptions (in its flight operations) due to the continuing enhanced checks on the airline's Boeing 787 fleet coupled with airspace restrictions and inclement weather.

On June 13, a day after the B787-8 crash that killed 241 people on board, the Directorate General of Civil Aviation ordered enhanced surveillance of Air India's Boeing 787 fleet, comprising 26 787-8 and seven 787-9 planes.

Since the Ahmedabad crash, Air India cancelled 66 flights to be operated with Boeing 787 between June 12th and June 17th. Multiple flights have been cancelled or delayed citing technical issues.

At a review meeting with top executives of Air India and Air India Express, aviation safety regulator DGCA flagged concerns regarding recent maintenance-related issues reported at Air India and "advised the airline to strengthen internal coordination across engineering, operations, ground handling units and ensure availability of adequate spares to mitigate passenger delays.

under the age of 70. Public health experts call it a "generational crisis in slow motion."

This is not just a problem of the old anymore," said a senior cardiologist at SKIMS, the region's top referral hospital. "Every week, we see new cases of heart attacks in patients under 40. Some don't even make it to the

So why is this happening?

A combination of lifestyle changes, chronic stress, substance abuse, and gaps in the healthcare system is fuelling the surge.

Kashmir has one of the highest tobacco use rates in India. Around 38 to 56 percent of adults in the Valley smoke or use tobacco products. In rural heart patients, smoking rates touch 76 percent. Hookah, locally known as jajeer, is deeply woven into social life.

But addiction doesn't stop at tobacco. In 2022, an official study found that nearly 8 percent of youth in Kashmir were addicted to opioids or other hard drugs Doctors warn this is placing a direct strain on young hearts and blood vessels.

But the triggers aren't only physical. A 2015 survey by Médecins Sans Frontières found that nearly 45 percent of adults in Kashmir showed symptoms of psychological distress. Doctors now believe that prolonged exposure to stress-curbs, violence, unemployment-is accelerating cardiac wear and tear in young men.

"When you're in a state of stress for years, the body never gets to rest," continued the cardiologist quoted above. "Cortisol stays high. Blood pressure rises. The heart suffers.'

Then there is the diet.

Kashmiri cuisine, rich in oil, salt, and red meat, has evolved in unhealthy ways. Traditional staples like greens and lentils are giving way to fast food and packaged snacks.

A 2024 study found alarming rates of obesity, poor diets, and low awareness of heart-health markers like cholesterol or blood pressure among Kashmiri youth.

"There's very little education around prevention," said Dr. Sajad Bhat, a physician in Kupwara. "People come in only after the damage is done.

Kashmir's cold months pose their own threat. With temperatures below freezing, people stay indoors, activity declines, and blood vessels constrict. Doctors say hypoxia, lower oxygen levels at high altitude, makes things worse for those with existing

But perhaps the biggest challenge is healthcare access.

In Srinagar, tertiary hospitals like SKIMS and SMHS can manage cardiac emergencies. But in Kupwara, Pulwama, and Shopian, most public hospitals lack specialists, cath labs, or defibrillators. If a heart attack strikes at night, patients may have to travel four hours for emergency care.

Cost is another barrier. An angioplasty in a private hospital can cost over 1.2 lakh, far beyond what most families can afford. Public hospitals are overcrowded, with long waitlists for surgery and limited post-operative

Perhaps the most worrying sign, experts say, is how little we know. No region-wide data tracks how many

people monitor their blood pressure or cholesterol each year. Without that baseline, planning prevention becomes guesswork.

Asifa, a 31-year-old mother from Anantnag, was diagnosed with hypertension during pregnancy but didn't return for follow-ups. One evening, she collapsed while feeding her child. Doctors said she had suffered acute heart failure.

"No one told me it could come back like this," she said. "I thought I was fine after the delivery."

Despite the bleak outlook, cardiologists insist the crisis is still reversible, if action is taken now.

They are calling for mandatory screening programs in schools and colleges, mass awareness drives in rural districts, and focused efforts to reduce tobacco use and promote traditional diets with less oil and salt.

"Parents need to understand the risks. Young people need to get their blood pressure checked. It's not expensive," said Dr. Bhat. "We can't wait for the next funeral to raise alarm."

Mental health also needs attention Services are scarce, and stigma keeps people silent. Until that changes, the body will keep paying for what the

"It's not just a medical issue," said Dr. Hilal Sofi, a Srinagar-based cardiologist. "It's a social issue. It's about poverty, education, trauma, and infrastructure. We have to treat all of it."

Back in Baramulla, Shakeel's wife still finds herself waiting for the school bell that used to bring him home.

"He was too young to die," she said. In Kashmir, more people are thinking the same. Until, suddenly, they

Iran and Israel launched new missile strikes at each other on Wednesday as the air war between the two longtime enemies entered a sixth day.

Iranian armed forces launched the new phase of Operation True Promise III by unleashing a barrage of missiles, including those being used for the first time, at ITel Aviv and port city of Haifa.

Images shared on social media showed missiles fired from different parts of Iran moving in an unusual manner in the night sky and evading the multi-tier Israeli air defense

costly conflicts. Steve Bannon, who served as a senior adviser to Trump during his first administration, on Wednesday said the administration should tread carefully.

Trump pushed back at the notion that deepening U.S. involvement could impact his standing with bis base.

"My supporters are more in love with me today, and I'm in love with them more than they were even at election time when we had a total landslide," Trump said.

India Begins Evacuation

Ministry is in touch with the Indian mission in Tehran, the Indian government has yet to issue an official state-

ment on the matter. In a press release, the Ministry of External Affairs (MEA) said that the afety of Indian nationals abroad remains a top priority. It confirmed that over 110 Indian students from northern Iran were evacuated and assisted in safely crossing into Armenia on Tuesday.

"These students departed from Yerevan on a special flight at 14:55 hours on June 18 and are expected to arrive in New Delhi in the early hours of June 19," the MEA said. The evacuation was coordinated by Indian missions in both Iran and Armenia. More than 4,000 Indian nationals

currently reside in Iran, nearly half of whom are students. The government expressed gratitude to the governments of Iran and Armenia for their cooperation in facilitating the first leg of the operation. The MEA noted that it has been pro-

actively working over the past several days to safeguard Indian citizens in Iran as the conflict with Israel intensifies. Measures include relocating Indian nationals from areas witnessing hostilities to safer zones within Iran, with evacuation plans unfolding in phases depending on available routes and conditions.

The ministry has also urged Indian nationals in Iran to remain in close contact with the Indian Embassy in Tehran and to use the emergency helpline or reach out to the 24x7 MEA control room in New Delhi for assistance.

Merely the investigating officer has remained lackadaisical in investigation of the case, cannot be a sole ground for release of the accused on bail, the court added.

Liverpool will be bidding for a third league championship in six years, likely with Florian Wirtz in its squad, and will play the first match of the season in a Friday night start at Anfield against a Bournemouth team

that finished in ninth place. It's quite a tough beginning for Arne Slot's champions, with a trip to Newcastle in the second round followed by a home match against Arsenal — another team in the Champions League — a

week later. Arsenal, which finished second for a third straight year last season, heads to Old Trafford for its first game and will play Liverpool, Manchester City and Newcastle in its opening six matches. Everton bade farewell to its

long-time home at Goodison Park at the end of last season and the first game in its stateof-the-art, 53,000-capacity stadium at Bramley-Moore Dock will be against Brighton on Aug. 23.
