Study Suggests Ultrasound Of Thigh Shoulder Muscles Could Help Detect Stage Preceding Prediabetes

An ultrasound of one's thigh or shoulder muscle could help detect insulin resistance, a stage that often precedes prediabetes, a study suggests.

Ultrasounds of muscles of 25 patients -- who were also checked for insulin resistance -- showed that their muscles appear "unusually bright", lead author Steven Soliman, director of musculoskeletal radiology fellowship at the University of Michigan, US, said.

"We found it interesting that most of these patients (with bright ultrasound images) have type 2 diabetes. Seeing this pattern, we often thought, 'This patient must have diabetes'," Soliman said. "More importantly, many were unaware of their condition until we verified with their electronic records and confirmed with their bloodwork that they indeed had type 2 diabetes or pre-

diabetes," the lead author added. For this study, published in the Journal of Ultrasound in Medicine, the team analysed 300 images of the participants' ultrasound and found an increased brightness or 'muscle echo intensity', which suggests that the quality of muscle has changed due to increased fat. Eight participants had insulin resistance, and seven had "impaired insulin sensitivity".

Initial findings from a muscle biopsy also suggested that the bright ultrasound images may indicate an excess accumulation of fat and possibly fibrosis, potentially affecting muscle health and function, the researchers said.

The study, therefore, highlights the potential of an ultrasound of muscles -- a non-invasive procedure -- in predicting the development of prediabetes or diabetes earlier than current diagnostic methods, they added.

The team had previously demonstrated that a higher muscle echo intensity could help accurately detect prediabetes and type 2 diabetes, regardless of age and duration of disease.

An elevated muscle echo intensity was seen in patients not diagnosed with prediabetes or diabetes. Some of them showed an increased muscle echo intensity before their blood test revealed a higher HbA1c -- a measure of average blood sugar levels over the last two to three months, the re-

searchers said. The team added that while the ultrasounds could detect insulin resistance and impaired insulin sensitivity, muscle echo intensity (or brightness of ultrasound images) was not linked with M values -- insulin sensitivity measured using a clamp test, which assesses how well the body uses glucose and is sensitive to insulin.

Kashmir Is Slowing Down. And The Thyroid May Be To BlameThis overlooked health crisis is swelling necks, clouding thoughts, and draining energy across Kashmir.

Srinagar: The lump wasn't supposed to be there. A teacher found it while straightening Amina's collar in a Kupwara classroom. The nine-year-old didn't react. Her family hadn't noticed. But that small swelling was a sign of something much



That swelling was a goiter, a telltale sign that something deep inside her body had gone off balance. And she's not alone.

A 2022 district health survey in Kupwara examined 2,700 schoolchildren. More than 270 had goiters. One in ten. Among ten-year-old girls, the number

jumped to one in seven. Goiters, once thought to be a condition of the past, are visible again in Kashmir classrooms.

Zoom out, and the picture gets worse. Across four districts — Kupwara, Shopian, Bandipora, and Ganderbal - recent government data puts the average goiter rate at 12.6 percent.

That's more than double the World Health Organization's threshold of concern.

According to WHO, anything above 5 percent in schoolchildren means a population is fac-

ing iodine deficiency. Behind these numbers lies a chain of daily decisions, and daily neglect. Salt, the main source of dietary iodine in India, is often stored in open bags or near heat. In many Kashmiri homes, it's added too early while cooking, destroying what little iodine it carries.

Household salt samples tested in Kupwara revealed an average of just 6.3 parts per million, less than half the legal minimum.

It doesn't end there. In urine tests from the same district, 10 percent of children had too little iodine in their bodies. But more than 30 percent | More on P10



Is Aga Ruhullah Forming **A New Political Party?**

Bird-Hit, Safety Checks Ground 9 Air India Flights

Srinagar: A bird-hit on an Air India flight from Delhi to Pune on Friday forced the cancellation of its return leg — one of several disruptions as the airline grapples with a growing operational crisis.

According to multiple media reports, the bird strike happened during the landing at Pune Airport. The aircraft landed safely, and all passengers were unharmed.

After the bird hit was detected, the aircraft was taken out of service for a thorough inspection. As a safety measure, the return flight from Pune to Delhi was cancelled.

At least eight other flights, including four international services, were cancelled the

Air India said four domestic flights — AI874 from Pune to Delhi, AI456 from Ahmedabad to Delhi, AI-2872 from Hyderabad to Mumbai, and AI571 from Chennai to Mumbai — have been cancelled.

The Directorate General of Civil Aviation (DGCA) has stepped up inspections of Air India's Boeing 787 fleet, leading to cascading delays and groundings. On Tuesday alone, 13 Dreamliner-operated flights were cancelled, and aircraft like AI-159 — the revised number for the ill-fated Ahmedabad-London route remain grounded amid continued unavailability.

Passengers across domestic and international sectors have faced delays, refunds, and



same day due to intensified maintenance and safety checks following the June 12 Dreamliner crash on the Ahmedabad-London Gatwick route that killed 271 people, including over 30 on the ground.

The international flights to be cancelled were AI906 from Dubai to Chennai, AI308 from Delhi to Melbourne, AI309 from Melbourne to Delhi, and AI2204 from Dubai to rebookings as Air India struggles to stabilize operations under heightened scrutiny.

Air India said its teams on the ground are making alternative arrangements for the passengers to fly to their respective destinations at the earliest.

It has also offered full refunds on cancellation or complimentary rescheduling to passengers, the airline said.

India To Organise Yoga Day **Events In 191 Countries**

NEW DELHI: India will organise thematic events and programmes in 1.300 cities across the globe to mark the International Day of Yoga on Saturday, showcasing the nation's ancient tradition and soft power.

The Indian High Commission in Pakistan is also organising a yoga event in Islamabad on the occasion, according to a statement issued on Friday by the Indian Council for Cultural Relations (ICCR), the cultural arm of the Ministry of External Affairs.

"On the 10th anniversary of International Day of Yoga, we will practically cover every country in the world where yoga events are being organised. In some countries like the US, we are hosting multiple events across various cities," ICCR's Director General, K Nandini Singla, was quoted as saying in a statement.

The ICCR will organise various yoga events and programmes in 191 countries on June 21 to mark the IDY, with more than 2,000 events to be hosted at 1,300 locations, cov-

ering multiple cities in various nations, it said.

Additionally, the ICCR is also hosting 'Yoga Bandhan', a signature event of IDY 2025, where 17 yoga gurus and practitioners from 15 countries, including Brazil, Argentina, Russia, China, South Africa, Malaysia, Sri Lanka, Indonesia, Singapore and South Korea, will lead the Yoga Day events across India, Singla said.

In Delhi, yoga events will be led by these foreign yoga gurus at Jantar Mantar, Qutub Minar, Purana Quila and Humayun's Tomb, while similar 'Yoga Bandhan' programmes will be organised at iconic locations in Lucknow, Avodhva, Varanasi, Jaipur, Jodhpur, Bhopal, Gwalior and other cities, she added.

Just as yoga is a 'union' between ' Atma' and 'Paramatma', 'Yoga Bandhan' seeks to "unite India and the world', the ICCR's DG said.

"It is a matter of great satisfaction that yoga has come full circle. Yoga went from India to these countries. People abroad learnt yoga, and today they have come back to India to lead yoga demonstrations by Indian people in India," Singla added.



Trump To Decide In 2 Weeks Whether Us Will Directly Attack Iran

Washington: President Donald Trump said on Thursday he will decide within two weeks whether the US military will get directly involved in the conflict between Israel and Iran given the "substantial chance" for renewed negotiations over Tehran's nuclear programme, as the two sides attacked each other for the seventh day.

Trump has been weighing whether to attack Iran by striking its well-defended Fordo uranium enrichment facility, which is buried under a mountain and widely considered to be out of reach of all but America's "bunkerbuster" bombs. His statement was read out by White House press secretary Karoline Leavitt.

Earlier in the day, Israel's defence minister threatened Iranian Supreme Leader Ayatollah Ali Khamenei after Iranian missiles crashed into a major hospital in southern Israel and hit residential buildings near Tel Aviv, wounding at least 240 people.

Israel's military "has been instructed and knows that in order to achieve all of its goals, this man absolutely should not continue to exist", Defence Minister Israel Katz said.

As rescuers wheeled patients out of the smoldering hospital, Israeli warplanes launched their latest attack on Iran's nuclear programme.

Prime Minister Benjamin Netanyahu said he trusted that Trump would "do what's best for America"

Speaking from the rubble and shattered glass around the Soroka Medical Centre in Beersheba. he added: "I can tell you that they're already helping a lot."

A new diplomatic initiative appeared to be underway as Iran's Foreign Minister Abbas Araghchi prepared to travel on Friday to Geneva for meetings with the European Union's top diplomat and counterparts from the United Kingdom, France and Germany.

Britain's foreign secre-

tary said he met at the White House with US Secretary of State Marco Rubio and envoy Steve Witkoff to discuss the potential for a deal that could cool the conflict.

"A window now exists within the next two weeks to achieve a diplomatic solution," Britain's David Lammy said in a social media post after Thursday's meeting.

The open conflict between Israel and Iran erupted last Friday with a surprise wave of Israeli airstrikes targeting nuclear and military sites top generals and nuclear scientists. At least 657 people, including 263 civilians, have been killed in Iran and more than 2,000 wounded, according to a Washington-based Iranian human rights group.

Iran has retaliated by firing 450 missiles and 1,000 drones at Israel, according to Israeli army estimates. Most have been shot down by Israel's multi-tiered air defences but at least 24 people in Israel have been killed and hundreds wounded.

Woman Doesn't Need **Husband's Nod For** Passport: HC

Chennai- The Madras High Court has held that it is not necessary for a woman to get the permission of her husband and take his signature before applying for a passport before the authority.

Justice N Anand Venkatesh gave the ruling in a recent order while disposing of a petition filed by Revathy. She sought a direction to the authorities to issue a fresh passport without insisting signature from her husband in a time bound manner.

The case of the petitioner was that she got married in the year 2023 and that there was a matrimonial dispute between the parties which resulted in her husband filing a petition before a local court, seeking for the dissolution of the marriage. This petition was pending.

The petitioner, applied for a passport in April this year before the Regional Passport Office (RPO) in the city. It was not processed and when enquired, the petitioner was informed that she must obtain the signature of her husband in Form-J and only thereafter, the application will be processed by RPO.

The RPO also took into consideration the pending dispute between the petitioner and her husband before the Court. It was under these circumstances, she filed the present petition.

In his order, the judge said that in the considered view of this court, the application submitted by the petitioner seeking a passport has to be processed independently.

"It is not necessary for a wife to get the permission of her husband and take his signature before applying for a passport before the authority", the judge added.

He said this insistence made by the RPO shows the mindset of the society in treating women who were married as if they were chattel belonging to the husband. It was quite shocking that the passport office was insisting for the permission of the husband and his signature in a particular form in order to process the application submitted by the petitioner for the passport.

Already the relationship between the petitioner and her husband was in doldrums and the RPO was expecting the petitioner to get the signature of the husband. Virtually, the RPO was insisting the petitioner to fulfill an impossibility, the judge added.

The judge said the petitioner after marriage does not lose her individuality and a wife can always apply for a passport without the permission or signature of the husband in any form. "The practice of insisting for permission from the husband to apply for a passport, does not augur well for a society which is moving towards woman emancipation. This practice is nothing short of male supremacism", the judge added..

The judge directed the RPO to process the application submitted by the petitioner and issue a passport in her name on her satisfying the other requirements.

This process shall be completed within four weeks, the

Delhi Cops Bust Fake Degree Racket, 5 Arrested, Forged Documents Seized

New Delhi: Delhi Police has busted a large-scale fake degree racket and arrested five people for their alleged involvement in fabricating and distributing forged academic certificates, an official on Friday said.

The operation has led to the recovery of hundreds of counterfeit documents from multiple universities across India, police said.

"The accused were running a highly organised syndicate that operated through coaching centres and educational consultancies, primarily in Delhi and the National Capital Region (NCR), offering fake and backdated degrees, mark sheets and migration certificates in exchange for hefty payments from students," said Special Commissioner of Police (CP), Crime Branch, Devesh Chandra Srivastva.

The officer said that 228 forged mark sheets, 27 fake degree certificates and 20 counterfeit migration certificates purportedly issued by

various universities across the country were recovered during the operation.

"In addition, 20 mobile phones and six laptops were seized, which upon forensic inspection, revealed more than 5,000 to 5,500 soft copies of similar fake academic documents, including degrees in BA, B.Sc, B.Com, B.Tech, BAMS, B.Ed, MBA and MA," he added.

The operation was initiated after a team received credible information regarding certain institutions in Delhi and surrounding areas offering fake degrees in exchange for money, police said.

"Acting on this tip, a team first apprehended Vicky Harjani, the alleged kingpin of the racket and owner of Paramhans Vidyapeeth in Netaji Subhash Place (NSP). A search of his vehicle and office premises led to the recovery of 75 forged academic certificates linked to universities in Uttar Pradesh, Uttarakhand. Himachal Pradesh, Rajasthan, Gujarat, Sikkim, Meghalaya and Tamil Nadu," said the Special CP.

Fearful Of Iranian Missiles, Many Sleep In Israel's Underground Train Stations

RAMAT GAN. Israel: Aziza Melech felt her body relax for the first time in days when she settled onto her inflatable mattress in an underground station of Israel's light rail system on a recent evening. For the next few hours, at least, the 34-year-old event planner wouldn't need to run every time a siren warning of Iranian missiles sounded.

Since the war began a week ago with Israel's airstrikes on Iran, families with young kids, foreign workers, and young professionals have brought mattresses and sleeping bags, snacks and pets into the stations each evening.

Repeatedly running for shelter

On Wednesday night, in a station that straddles Tel Aviv and neighboring Ramat Gan, parents settled in their kids with stuffed animals, while young people fired up

tablets loaded with movies. Many walked in carrying boxes of pizza. Workers set out snacks and coffee.

It was Melech's first night sleeping in the brightly lit train station, and she was joined by her friend Sonia Shraibmen.

"We're not sleeping because of the anxiety and because of the sirens that are happening during the nights," said Shraibmen. "It's very scary to run every time to the shelter."

That morning, Shraibmen fell on the street while rushing to a nearby shelter, and decided to move somewhere where she wouldn't have to get up and run each time her phone blared.

Melech said the scene, with hundreds of people in their pajamas in the train station, reminded her of her grandfather's stories from World War II. "Now, we'll be able to tell our grandkids about this," she said. The war between Israel and Iran began on June 13,

when Israel launched airstrikes targeting Iranian nuclear and military sites as well as top generals and nuclear scientists. More than 600 including over 200 civilians, have been killed in

Iran and more than 2,000 wounded, according to a Washington-based Iranian human rights group. People in Tehran have also packed into metro stations as strikes boomed overhead.

Iran has retaliated by firing 450 missiles and more than 1,000 drones at Israel, according to Israeli army estimates. Those strikes have killed have killed 24 people and injured hundreds in Israel. Missiles have struck 40 different sites, including apartment buildings, offices and a hospital, according to authorities.

Tyndale Biscoe School Refutes Harassment Allegations

Rise In Heart Attacks

quiet crisis is unfolding in Kashmir: Heart attacks, once whispered about as an old man's disease, are now claiming people in their 30s and 40s. According to a study published in the Indian Heart Journal, 7.5% of Kashmiris over 40 already suffer from coronary artery disease, a figure alarmingly high by national standards. Hospital records paint an even grimmer reality: one in every five heart attack patients in the Valley is under 45. In winter, cardiac emergencies double, straining an already fragile health system.

How did we get here? Doctors and studies are attributing this to stress, poor diet, tobacco, drugs, and fragile healthcare, especially in rural areas. This, as a report published in this paper shows, has put many people at risk far earlier than they should be. Smoking, fried food, and the other bad lifestyle choices are the usual suspects, but experts also point out that years of conflict are also one of the critical factors. Unemployment and uncertainty have stoked anxiety. This has created a mental health crisis, a contributor to heart ailments.

Add to this a growing drug menace: an official study in 2022 found nearly 8% of Kashmiri youth hooked on opioids and hard drugs. Or, for that matter, a 2016 study by the Doctors Without Borders revealed that nearly 1.8 million people in the region suffered from mental health disorders. But it is clear that the number may have substantially risen since then. We need to have a proper study to get an estimate of how many are afflicted by the disease now. Inadequacy of the mental health services has only created a significant treatment gap.

The crisis is reversible, but only if we act. Health authorities must roll out mandatory heart screenings in schools and colleges, revive traditional healthy eating habits and run relentless awareness campaigns. Tobacco use too must be targeted. Mental health must be prioritized. This is a multipronged fight and the UT's health department needs to take a lead in this. And this fight has to be on two fronts: one, urging people, especially our youth, to adopt a better lifestyle. Two, upgrade the health infrastructure to ensure swift medical attention to the people when they suffer from heart attacks. This would require a deliberate, long-term effort by the government. The issue demands sustained policy focus, stronger healthcare infrastructure and interest the support of the su

The Ink in Your Samosa

Hot pakoras wrapped in yesterday's headlines might feel nostalgic, but the ink could be harming your gut, hormones, and heart. It's time to unwrap the truth.

n a Srinagar afternoon, a street vendor hands a customer a piping hot potato snacks, folded neatly in a piece of yesterday's newspaper. It's a scene repeated every day across Kashmir.

From Baramulla to Anantnag, from Pulwama's halwai shops to evening snack stalls in Lal Chowk, food wrapped in newsprint feels familiar, even comforting.

But that warm, oily snack comes with something more than spice.

Hidden in the ink are chemicals that, once transferred to hot food, may be affecting your body in serious ways.

Modern printing ink isn't just ink. It's a mix of chemicals, some of them toxic. While these chemicals help words and images stick to paper, they're not meant for your plate.

Mineral oils, for instance, are found in almost all printing inks. They may contain polycyclic aromatic hydrocarbons (PAHs). These compounds are linked to cancers of the skin, lungs, and bladder.

According to the European Food Safety Authority, exposure to PAHs through food remains one of the most concerning public health risks.

And it worsens when the food is oily, hot, or wet, exactly how most Kashmiri snacks are served.

Lead, once common in printing inks, has been reduced in newer publications. But older or regional newspapers, still widely used by vendors, may still carry it.

Lead, even in small amounts, has a devastating impact on brain development. A child regularly eating food from such sources could be unknowingly exposed to developmental delays, attention problems, or learning difficulties.

In Kashmir, where educational pressures are already high, such risks deepen the crisis.

Another chemical to worry about is BPA (Bisphenol A), which mimics hormones in the human body. It's been linked to early puberty in girls, PCOS (polycystic ovarian syndrome), and infertility in men.

Kashmiri doctors have reported a steady rise in teenage girls being diagnosed with PCOS. Could the ink in our food be part of the reason?

It doesn't stop there. Phthalates, another ink component, are known hormone disruptors. Volatile Organic Compounds (VOCs), released from ink solvents, can worsen asthma or respiratory allergies, especially in children and the elderly.

In 2016, the Food Safety and Standards Authority of India (FS-SAI) issued an advisory warning against using newspapers for wrapping, serving, or storing food. Their concern was based on several studies that showed harmful chemicals migrating from ink to food.

But on the streets of Kashmir, that advisory went largely unnoticed.

In fact, in a 2021 pilot study by the Department of Environmental Sciences at a northern Indian university, food samples wrapped in newspaper were found to have cheap, easy, and available. And because no one's really told them not to.

Food-grade wrapping, like butter paper, foil, or banana leaves, comes at a cost. Vendors often run on tight margins. But with growing evidence of health risks, this tradeoff is becoming harder to ignore.

For consumers, the change starts with a simple ask: "Can you use something else instead of newspaper?"

It's a small question, but repeated enough times, it shifts practice. Carrying your own wrapping for street food may sound like a stretch, but so did cloth bags once.

Vendors, too, can be part of the solution. Some have already started using recycled brown paper or

significantly higher levels of PAHs and Lead than those stored in food-grade material.

Another alarming connection is the rising cases of early heart disease in young Kashmiris.

A 2023 study at SKIMS (Sher-i-Kashmir Institute of Medical Sciences) found increasing oxidative stress among youth, which can be linked to long-term exposure to environmental toxins, including those found in food packaging.

The problem with ink-laced food is that it doesn't taste different. There's no smell or visible warning. But its impact shows up silently.

It starts with stomach troubles, like acidity or cramps. Then mood disorders, from irritability to anxiety, linked to hormone imbalances caused by BPA and phthalates.

And then allergic skin reactions, especially in children who eat with their hands. Also, long-term fertility issues, particularly among men exposed to hormone disruptors during adolescence.

The damage builds over time, with every newspaper-wrapped snacks, every paratha rolled in yesterday's headlines.

But why do vendors still use newspapers?

The simple answer is: it's

foil. A handful of Srinagar shops now offer snacks in paper bowls or biodegradable wrappers. These examples show change is possible, especially if supported by policy.

The Jammu and Kashmir Food Safety Department has issued notices in the past, but enforcement remains spotty. Awareness campaigns, subsidies for packaging, and vendor training programs are missing.

Meanwhile, harmful habits continue unchecked on our streets, silently impacting an entire generation's health.

We've read enough. It's time to stop eating ink.

A samosa shouldn't come with a side of toxins. Nor should tradition come at the cost of thyroid issues in young girls or high blood pressure in teenage boys.

If the pandemic taught us anything, it's that public health begins with the everyday choices we make, and the ones we ignore.

Newspaper tells stories. But

when it wraps our food, it becomes part of a story we never asked for. Let's not eat it.

From rehab centers to remote villages, Kashmir's drug crisis is turning into a full-blown generational catastrophe.

here was a time when the biggest fear in Kashmir was getting caught in crossfire. That fear hasn't vanished, but something else has crept in, something less visible, yet just as dangerous.

The Valley is now facing a different kind of war, one that's unfolding inside its neighbourhoods, classrooms, and hospital wards. It doesn't involve slogans or standoffs. It involves syringes, pills nowders and silence

pills, powders, and silence.

Drug addiction is tightening its grip across Kashmir. The shift didn't happen overnight, but its presence is undeniable now.

Walk into a de-addiction centre in Srinagar and you won't just see statistics. You'll see teenagers with sunken eyes, young women battling withdrawal, and parents who never imagined their child would end up here.

Hospitals are seeing more cases than they can manage, and the numbers are rising with every passing month.

According to the J&K police, drugrelated arrests have gone up dramatically in the last few years. More than 10,000 cases were registered under the

NDPS Act in 2023 alone. Healthcare professionals say heroin is now the most common substance among patients, and the majority of users are under 30. Many of them started using before they were even old enough to vote.

This isn't just about personal

choices gone wrong. The crisis is deep-

ly rooted in the circumstances young people are growing up in.

Kashmir has lived through decades of political uncertainty, frequent shutdowns, and emotional exhaustion. Those who came of age in the last two

than stability.

For many, drugs offer a way to feel numb. For others, they offer a break from boredom, anxiety, or the constant weight of expectations in a place that

decades have seen more disruption

promises little and delivers less.

Unemployment makes things worse. Youth joblessness in Jammu and Kashmir is among the highest in India, hovering around 18.3%.

But that number hides the larger picture: thousands of educated young people waiting for job calls that never come.

In this void, frustration builds. Dreams shrink. Time becomes a burden. Drugs slip in, not as rebellion, but as relief. The supply chain has grown more

Families are struggling to keep up. Addiction isn't just hurting users; it's tearing apart the people around them. Many parents feel ashamed. Others are in denial. Some hide the problem until it's too late.

In conservative communities, especially, the stigma is heavier. Women who fall into addiction are often silenced entirely. Their pain doesn't make it to clinics or case files. It stays behind closed doors: untreated, unspoken, and dangerously invisible.

Kashmir's healthcare system, already fragile from years of neglect and crisis, isn't equipped to handle this wave. There are only a handful of functional rehabilitation centers, and most are overburdened.

Mental health services are limited, and trained addiction counselors are rare. Without follow-up care, many patients relapse within weeks. Some never return at all. There have been efforts. The gov-

ernment has launched awareness campaigns. Police have carried out major drug busts. NGOs and religious organizations are running outreach programs.

But most of these are isolated, underfunded, and lacking coordination. For a crisis this complex, the response has been far too scattered.

What's needed now is not just action, but clarity and commitment. That begins with admitting the scale of the problem.

Addiction in Kashmir is not a fringe issue. It's no longer something

that happens to "other families." It's happening in cities and villages alike, in upper-class homes and working-class lanes.

It's not someone else's crisis, it's everyone's.

The solutions have to be multilayered. There's a need for more de-addiction centers and trained professionals. But equally important is the work that happens before a young person picks up drugs for the first time — inside classrooms, at home, in the streets where they spend most of their time.

Schools should include drug education in a way that's honest, not moralistic. Teachers and parents need tools to spot the early signs. Community-based mental health programs must be part of everyday life, not just emergency responses.

And there has to be hope. Real, tangible opportunities — jobs that aren't just announcements, programs that don't stop at training but lead to actual employment.

When young people feel like they matter, they are less likely to give up. When they believe their future has shape, they don't reach for ways to escape the present.

When Parenting Misses the Heart

Parenting in Kashmir is often inherited, not learned. And the cost is silently carried by our children.

was seven when I first learned that silence can sting more than

I'd accidently dropped a glass of water, and the room stiffened. My mother looked away. My father didn't speak. I still shudder to recall that cold moment making my small body fold in shame.

I spent years thinking I was careless. I grew up watching every step, careful not to take up too much space. That carefulness stayed.

Now, when I watch five-year-old Zaid, I see that same confusion flicker across his face.

He's the kind of child who runs before he thinks, climbs everything he's told not to, and laughs from his stomach. He's joy in motion. But also, according to most grown-ups around him, Kherifeh-mischievous.

The label sticks, like dust on his scraped knees.

A few days ago, he chased a sheep outside his home, slipped, and fell. His father rushed out. For a second,

he looked worried. Then he snapped. "Are you out of your mind?" the man shouted, grabbing Zaid by the arm. A hard slap landed on his back. Zaid didn't cry from pain. He looked stunned, like he'd expected something else, maybe arms, not anger.

This happens every day in homes across Kashmir. Children fall, and instead of comfort, they get correction. They get told off for being children. They get taught that love can come with shouting, and protection can

Zaid's parents love him. They send him to school, keep him warm, feed him well. But they don't see the damage in their response. They think they're teaching him how to be good. What they're really doing is teaching him how to be scared.

And I understand why. They're repeating what they were shown. So did my parents.

They didn't hit. But they withdrew affection when we failed to follow rules. They withheld praise when we tried our best but fell short. I thought they were right. I still fight that belief some days.

It took me years to realise that obedience isn't the same as respect, and soft-spoken kids aren't always understood children.

Now that I've come of age, I find myself facing the same questions: How do I raise my children differently when my own instincts were shaped by fear? How do I learn what I was never taught?

We prepare for careers, degrees driving tests. But we have no cultural manual for parenting. We just wing it by inheriting habits, old hurts, and good intentions. And that shows, especially here, in Kashmir.

We don't talk about emotional parenting. We avoid breaking cycles. We overlook the difference between discipline and damage

Psychologist Waseem Kakroo sees this every day. "Parents in Kashmir still equate authority with harshness," he told me. "They think correction means control. But it often comes from unresolved emotional issues they've carried from their own childhoods."

He says many of us are stuck in that loop. Repeating what hurt us, because it feels familiar. "Parenting," Kakroo continued, "is not instinct alone. It's a skill. And skills require

But where do we learn? Unlike in Western countries, where parenting classes and support circles are part of public life, in Kashmir, we're left to figure it out behind closed doors. There's no space to talk about emotional connection, no

room to ask how to be softer, how to listen better, how to raise a child without fear.

Instead, children grow up hearing that crying is weakness, that feelings must be swallowed, that respect must be earned with silence.

And then we wonder why so many young people carry invisible scars into adulthood.

We're told not to question our elders. But what if they were hurting

What if we stopped seeing parenting as something you just do, and started treating it as something you can get better at? Children aren't miniature adults.

They're still learning what the world means. And every time they're met with a slap instead of support, that learning gets shaped by fear. They don't stop loving us, they stop trusting themselves.

I look at Zaid and wonder what he'll remember: the sheep, the fall, or the slap?

I hope, someday, someone explains to him that it wasn't his fault. That he wasn't too much. That he didn't deserve to be scolded for being curious.

I hope we start doing it differently. For our children. And for the children we once were.

After all, parenting, at its heart, is not about control. It's about presence, listening, sitting beside a crying child and saying, "I'm here. You're safe." Even when we're tired, even when we weren't shown how.

It's hard to change what's inherited. But it's possible. And it's necessary. Before another child falls and gets punished for trying to fly.

A Mother's Bold Goodbye

Gaslighted, dismissed, and told to be patient, Hania's story exposes the invisible violence that hides behind "happy marriages in the valley.

Gowher Bhat

was a blistering summer day in Pulwama. The sky was open and clear, and schoolchildren were filing into classrooms under tall walnut trees. Hania stood at the blackboard, white chalk in hand. Her voice was soft but steady, her smile practiced. She looked like someone in control.

But inside, she was quietly rebuilding a life undone by love.

For three years, she had lived with a man who never hit her, never screamed at her in public,

never left a mark anyone else could see. Yet every day, he chipped away at her, word by

word, silence by silence. "He would send long messages when we were

dating," she said. "Did you eat? I love you. No one can love you like I do.' I thought that was love. I was 24. It felt real." They married within a year. From the outside,

it looked right. A thoughtful husband, a quiet teacher, a peaceful home. But after the wedding, she noticed the small controls.

"He didn't like my friends. Said they were too modern," she said. "Then he asked me to quit teaching. Said it was to protect me. And I thought, that must be love, right?'

It wasn't.

What followed wasn't loud. It was slow. He criticized how she cooked, how she spoke, how quickly she picked up the phone. He didn't yell. He withdrew. He gave her the cold shoulder for days. Then he'd come back crying.

"He'd kiss my forehead and say sorry. I forgave him. Every time," she said. "I kept thinking, maybe I was being difficult. Maybe if I tried harder."

But she began forgetting who she was. She couldn't trust her own memory. "He'd say something cruel and then swear he

never said it. I thought I was going crazy. I started writing things down, just to stay sane." This was gaslighting. She didn't know the term back then. All she knew was that she had

stopped dreaming, stopped speaking, stopped being herself. Kashmir is a place where silence is mistaken for strength. Where daughters are told to adjust.

Hania heard it from everyone. "My mother told me to be patient. My in-laws said I was imagining things. Friends told me not to talk about my marriage," she said. "So I

On Instagram, she smiled in pictures. At fam-

ily functions, she laughed. But inside, she was

Then one January night, she curled up on the cold bathroom floor while her toddler slept in the next room. "I looked in the mirror," she said, "and I didn't see a person. Just a shadow."

She didn't cry loudly. She didn't wake anyone.

But in that moment, she made a decision. "I couldn't let my daughter grow up thinking

this was what marriage looked like." She left soon after, with the help of her cousin

and therapist. She packed her bags and walked out just with her daughter.
"I had nothing," she said. "But I had my will."

She found a small flat with two rooms, leaking tap, and weak heating. But it was hers. It was safe. She started teaching again. She cooked for herself. Watched old Bollywood films with her daughter. Wrote in a journal. And above all, laughed again.

'I remembered what joy felt like," she said.

In Kashmir, where emotional abuse is rarely named and often buried under talk of honour and family, Hania's story is rare. Many women stay. Cultural silence, economic dependence,

fear of gossip keeps them from leaving. And because abuse doesn't always look like

bruises, people don't see it. Hania broke the silence. She didn't just leave.

She spoke.

"I don't want sympathy," she said. "I want peo-ple to understand. Real love doesn't confuse you. She tells women to trust their gut. To speak.

To leave if they need to. She doesn't pretend it's easy.
"You're not weak for staying," she said. "But if you choose to leave, that takes a different kind

Now, she walks the same streets she once

crossed with her head down. Her daughter holds her hand. Her chalk-stained fingers carry stories, not shame. Her classroom is full of life again.

She teaches maths and language. But she also teaches something else. That it's okay to start over. That it's okay to say no. That silence isn't

And maybe that's the legacy. She didn't just survive. She showed what survival looks like, in a society that often expects women to suffer silently.

The Farewell That Silenced a College

In Kashmir countryside, a dedicated educator's transfer stirs tears, stories, and the lingering weight of goodbye.

n the far south of Kashmir, where roads wind between oplar trees and school bells echo faintly across paddy fields, a college gathered for a farewell.

The man at the center of it, Dr. Ishtiyaq Ahmad Shah, was leaving after years of service. He wasn't retiring, just moving, as government officers often do.

But the moment didn't feel routine. It felt like the end of something fragile and meaningful.

Government Degree College Frisal isn't a place you're likely to read about. It sits silently in the Kulgam district, far from the capitals of power. Its buildings are modest, its needs many.

But for the students who walk there every day, some from villages miles away, it is an anchor. And Dr. Shah, during his tenure, had become its most stable part.

His transfer came through official channels, a simple order directing him to take charge at another college, this one in Qazigund, a small highway town known mostly as a stopover on the way to Srinagar. It wasn't a surprise.

Transfers in the public education system are expected, sometimes even necessary. They balance staff shortages, shift leadership, and try to stir progress.

But Frisal wasn't ready.

When the farewell was announced, the faculty began planning something respectful, maybe even formal. It quickly became something else.

Students began writing notes. Former graduates called in, asking if they could attend. Teachers who'd once worked with Dr. Shah returned just to say goodbye. Despite ongoing exams, the assembly hall filled slowly, then

Dr. Muzaffar Yousuf, a longtime faculty member, opened the event with a gentle speech. He didn't need notes. He talked about Dr. Shah as a principal who listened, who stayed late, who asked not just how classes were going but whether



the drinking water was cold, whether the students had

Others followed. Department heads. Young lecturers. Non-teaching staff. Each one told a small story. They spoke of decisions made quietly, of problems solved without fanfare, of a man who seemed always present, even when silent.

Miss Mehnaza Jan, an assistant professor of economics, walked to the podium with a sheet of paper in her hand. She didn't read a word. She looked at the room, tried to speak, and then returned to her seat in tears.

Dr. Riyaz Ahmad, who teaches sociology and anchored the program, described Dr. Shah as "a leader who never raised his voice but always got things

The words felt accurate. Dr. Shah's tenure had been marked not by declarations but by follow-through, on timetables, infrastructure, faculty appointments, and the confidence that

someone was paying attention. When Dr. Shah finally stood to respond, he kept it brief. He thanked the staff and the students. He reminded them that colleges are not buildings but people. "You have given me more than I ever expected," he said. "If I have given anything back, I am grateful."

It is difficult to explain the significance of a principal's transfer to someone outside Kashmir, or outside any place where institutions must double as communities. In a region often caught be-

fer continuity where little else

does. And when a figure like Dr. Shah leaves, the loss feels per-At Frisal, the mood was som-

ber. In the corridors, teachers spoke in low tones. In the staff room, someone had placed a framed photograph from the farewell on the table. The students lingered after the event, standing in clusters, sharing stories.

One student, a final-year undergraduate, summed it up quietly to no one in particular. "It's not that he solved everything," she said. "It's that he made us feel that someone was trying."

In a world of metrics and performance charts, this might not seem like much. But in this part of Kashmir, it means every-

Gund's Green Gold

On the banks of the Nallah Sindh, a Kashmiri village stands at a crossroads. Will policymakers act before Gund's rich fields are lost to concrete and careless development?

Tast the switchbacks of Sonamarg, where the Nallah Sindh cuts through pine and pasture, lies Gund. This captive countryside looks peaceful with orchards, farms, and the hush of alpine life.

But behind the meditative landscape is a slow unraveling no one can ignore

Gund, part of Ganderbal district, sits in a stunning pocket of Kashmir. Glacial streams water its edges, and the air stays crisp long into spring. This place could feed families, grow rare herbs, and bring visitors closer to the earth. It has all the right ingredients for sustainable farming.

But each year, more land lies unused. More young men leave. And slowly, concrete begins to win.

You may wonder: why does this matter?

Because in places like Gund, farming is not just tradition. It's survival. It's the main source of food and income for many. Tourism comes and goes. Factories don't exist here. But the soil still remembers how to grow.

Walk through its meadows in early summer, and you'll find patches of garlic, onions, peas, and cabbage. These aren't big crops. They're daily staples, and they grow well in Gund's cool climate.

In fact, with proper care, these could supply markets across the valley, and

The same goes for fruit. Gund's hills can grow apples, walnuts, even plums. With cold storage, good packaging, and better roads, these orchards could feed a new economy.

But help rarely comes. Farmers sell what they can, how they can, often at a

Then there are the hidden treasures: lavender, thyme, valerian. These herbs don't need much water and are used in oils, teas, and medicines. They're already valuable. But here, they barely get no-

Add to that the possibility of agritourism. Imagine visitors spending a few days on a farm, picking fruit, sipping noon chai under walnut trees, and watching the sun fall behind snowtipped mountains. That experience is priceless. Yet, it's not being built.

buried under concrete,

As land loses its farming value, families start to sell. A hotel here, a guesthouse there. It may seem harmless. But over time, this unchecked construction eats into the green. It breaks up the land, threatens local water sources, and chips away at the mountain ecosystem. The Nallah Sindh doesn't just add beauty to the landscape, it feeds it. And it's at risk.

So what can be done? First, people need support in the form of real tools, irrigation channels, crop insurance, and loans that don't require middlemen.

A cold storage unit could save half the year's harvest from waste. A packaging unit could double a farmer's income. Training sessions on organic farming or plant-based products could keep the youth rooted instead of restless.

Most importantly, Gund needs protection as a living model, a zone for ecofarming, a place where growth doesn't come at the cost of nature. Where development is smart, not scattered.

It's not too late. Gund still has its green gold. But if we keep ignoring it, that gold will be buried under concrete, and lost

The question now is simple. Will we let this happen? Or will we act before Gund becomes just another name in a report?

'CBDT Taking Action For Non-Responsive Taxpayers Having Foreign Income'

NEW DELHI- Finance Ministry on Friday said CBDT is taking action against people having foreign income and as many as 5,483 taxpayers have filed belated returns reporting foreign assets worth Rs 29,208 crore and additional income of Rs 1,089.88 crore.

Suitable action under the extant provision of law is under consideration for non-responsive taxpayers, the finance ministry said in a statement.

The finance ministry's statement comes amid reports that money deposited in bank accounts of Indian entities in Switzerland has increased in 2024.

Indian money parked in Swiss banks more than tripled in 2024 to 3.5 billion Swiss francs (nearly Rs 37,600 crore) on the back of a huge jump in funds held through local branches and other financial institutions, annual data released by Switzerland's central bank showed on Thursday.

The ministry statement said that a total of 24,678 taxpayers reviewed their ITRs and 5,483 taxpayers filed their belated return for the assessment year (AY) 2024-25, reporting foreign assets of Rs 29,208 crore and additional foreign income of Rs 1,089.88 crore.

The initiative has resulted in

substantial growth of taxpayers reporting foreign assets and income in ITR for AY 2024-25, it said, adding that a total of 2.31 lakh taxpayers have reported their foreign assets and income in AY 2024-25, witnessing a growth of 45.17 per cent over 1.59 lakh taxpayers in AY

On account of various awareness initiatives and a systemdriven approach, taxpayers are voluntarily declaring their foreign assets and income and are also revisiting their ITRs to offer correct income, it said.

In cases of continued noncompliance, the statement said, enforcement and statutory actions are being taken as per the law.

For AY 2024-25, it said, the Central Board of Direct Taxes compared the data under Automatic Exchange of Information (AEOI) with the information about foreign assets and income filed in the ITRs by the taxpayers, for the purpose of verification.

The analysis covered all jurisdictions, including Switzer-land, it said, adding that additionally, SMS and emails were sent to various taxpayers with a request to review their ITRs, where foreign assets and income were not reported in the appropriate Schedules of ITR. In order to combat offshore

tax evasion, tax jurisdictions cooperate among themselves and share relevant information about financial assets held by the citizens of other countries in their tax jurisdiction. India regularly receives information about foreign accounts and assets from more than 100 tax jurisdictions.

Make GST Registration Easier Using Technology Risk-Based Parameters: FM To CBIC

NEW DELHI: Finance Minister Nirmala Sitharaman on Friday asked CBIC to make the GST registration easier, seamless, and more transparent for taxpayers, using technology and risk-based parameters.

Sitharaman, who chaired the Central Board of Indirect Taxes and Customs (CBIC) Conclave with the Principal Chief Commissioners, Chief Commissioners and Director Generals of the field formations, reviewed the performance of Customs and CGST zones on key indicators.

During the conclave, she directed the zones to prepare an action plan to improve various parameters, such as GST registration, processing of refunds, and handling taxpayers' grievances.

The finance minister also directed the CGST formations to launch targeted awareness campaigns among taxpayers, trade associations, and industry bodies regarding the documentation mandatory required for GST registration, particularly those related to the principal place of business, the finance ministry said in a statement.

This would help reduce rejections and delays in registration and enable faster processing of applications, she said.

She also directed CGST Zonal Heads to have a dedicated helpdesk for GST registrations to facilitate the taxpayers in the application process.

The finance minister also highlighted the need to ensure that GST Seva Kendras and Customs Turant Suvidha Kendras are well-staffed, accessible,



and properly maintained so that taxpayers receive timely and quality assistance.

Emphasising taxpayer trust, she called for a targeted and sustained focus on grievance redressal, ensuring the timely resolution of queries and complaints through improved systems and accountability.

Sitharaman also underlined the need for the speedy closure of investigations for Customs and CGST cases, and exhorted for an analysis on detection and recovery and to seek solutions to reduce the gap between detection and recovery.

At the same time, she emphasised the need to prevent tax evasion and wrongful input tax credit (ITC) claims.

The CBIC was asked to expedite the processing of GST and Customs refunds to ensure timely redressal and ease of doing business, especially for MSMEs and exporters.

Hailing that CBIC ranks in the top five out of 90 Central Ministries/Departments in CP-GRAMS performance since February 2024, she underscored the importance of promptly addressing public grievances received through CPGRAMS.

The finance minister suggested that the CGST and Customs zones may dedicate teams to further expedite the resolution of grievances.

Govt Meets Stakeholders To Assess Impact Of Iran-Israel Conflict On Trade; Monitoring Situation

NEW DELHI- The commerce ministry on Friday held consultations with key stakeholdexporters, container firms, and other departments, to assess the impact of the Iran-Israel conflict on India's overseas trade, an official said. The meeting was chaired by Commerce Secretary Sunil Barthwal.

The participants informed that the situation in the Strait of Hormuz is currently stable and a ship reporting system is in place to monitor any incidents.

The freight and insurance rates are also being closely monitored, the official said.

The commerce secretary emphasised the need to assess the evolving situation and its impact on Indian trade, the official said. He highlighted the importance of exploring all possible alternatives in response to the situation.

Exporters have stated that the war, if escalated further, would impact world trade and push both air and sea freight

They have expressed apprehensions that the conflict may impact the movement of merchant ships from the Strait of Hormuz and the Red Sea.

Nearly two-thirds of India's crude oil and half of its LNG imports pass through the Strait of Hormuz, which Iran has now threatened to close.

This narrow waterway, only 21 miles wide at its narrowest point, handles nearly a fifth of global oil trade and pensable to India, which depends on imports for over 80 per cent of its energy needs.

According to think tank GTRI, any closure or military disruption in the Strait of Hormuz would sharply increase oil prices, shipping costs, and insurance premiums, triggering inflation, pressuring the rupee, and complicating India's fiscal management.

The present conflict that began with an attack on Israel on October 7, 2023 had brought cargo movement through Red Sea routes to a halt due to attacks by Houthi rebels on commercial shipping.

Last year, the situation around the Bab-el-Mandeb Strait, a crucial shipping route connecting the Red Sea and the Mediterranean Sea to the Indian Ocean, escalated due to attacks by Yemenbased Houthi militants.

MPC Minutes: RBI Guv Expects Rate Cut Front-**Loading To Support Growth Amid Global Tension**

MUMBAI- RBI Governor Sanjay Malhotra said frontloading of monetary policy rate action would give a clear signal and some certainty to the economic agents that the growth amid global tensions, MPC meeting minutes released on Friday said.

On June 6, the RBI governor-headed six-member panel reduced the benchmark short-term lending rate by 50 basis points, taking the total reduction to 100 bps in quick succession, besides a change in the policy stance to neutral from accommodative and liquidity infusion measures.

While five members voted for a 50 bps reduction in the repo rate during the three-day meeting (June 4-6), an external member of the panel, Saugata Bhattacharya, suggested a 25 bps cut.

Given a sharp reduction in inflation of about 3 percentage points over the past few months (6.2 in October 2024 to 3.2 in April 2025) and the projected reduction in annual



average inflation by almost one percentage point from 4.6 to 3.7 per cent, Malhotra voted for a 50 bps rate cut, the minutes showed

"It is expected that the frontloaded rate action, along with certainty on the liquidity front, would send a clear signal to the economic agents, thereby supporting consumption and investment through lower cost of borrowing," he said.

On the change of monetary stance, he was of the opinion that a neutral stance would provide monetary policy with the necessary flexibility to cut, pause or hike policy rates in response to the evolving domestic and global economic conditions.

"This package of measures will provide some certainty in times of uncertainty and is

expected to support growth," Malhotra added.

The MPC consists of three RBI officials -- Governor Malhotra, Deputy Governor Poonam Gupta and Executive Director Rajiv Ranjan, and three government-appointed nomi-Bhattacharya and Ram Singh.

As per the minutes, Deputy Governor Gupta was also of the opinion that a 50 bps reduction in repo rate should help foster policy certainty and faster transmission than a staggered rate cut and more effectively counter the challenges emanating from the global economy.

She also supported a change in stance from accommodative to neutral.

'This means that any further actions should be contingent upon incoming data and the evolving global uncertainties," Gupta said.

Ranjan said from the perspective of inflation, growth, transmission, global and most importantly signalling and imparting certainty perspective, a 50 bps cut is apt at this juncture.

Air India Cancels 8 Flights; **Bookings Decline By Up To 20%**

MUMBAI- Air India on Friday cancelled eight flights, including four on international routes, due to operational reasons even as the impact of the Ahmedabad plane crash last week is becoming manifest on its overall bookings dropping

A London-bound Air India flight, AI-171 carrying 242 passengers and crew members crashed in Ahmedabad on June 12. All but one passenger onboard the plane died along with nearly 29 on the ground when the aircraft crashed on a medical college complex shortly after the take-off

In a statement on Friday, Air India announced cancellation of several flights -- Dubai-Chennai (Al906), Delhi-Melbourne (AI308), Melbourne-"Delhi (AI309) and Dubai-Hyderabad (AI2204).

According to the tour operators body, Indian Association of Tour Operators (IATO), bookings for Air India flights have declined by around 20 per cent on domestic as well as international routes while the average fares have dropped by 8-15 per cent in the aftermath of the Boeing 787-8 Dreamliner crash last week.

Federation of Associations in Indian Tourism & Hospitality (FAITH) General Secretary Rajiv Mehra also said that an up to 20 per cent decline in bookings has been observed for Air India flights while the fares have turned cheaper by about 10 per cent on certain sectors where there is high competition with other carriers.

An Air India spokesperson did not respond to a query seeking comments from the airline on decline in bookings.

A Pinch Of Pink Salt In India-Pak Trade

KARACHI- The trade ban imposed by New Delhi after the Pahalgam terror attack put brakes on the export of Himalayan Pink Salt from Pakistan to India, but has also provided local traders an opportunity to explore new markets.

Pakistan is one of the world's largest producers and exporters of Himalayan Pink Salt. The Khewra pink salt mines in Punjab province is the largest mine in the country and has 30 processing units.

In 2024, Pakistan's total pink salt exports stood at 3,50,000 tonnes estimated to be worth

USD 120 million. After the April 22 Pahalgam terror attack that claimed 26 lives, India took a series of measures, including immediate shutting down of the Attari land-transit post, used for movement of certain kinds of goods.


In retaliation, Pakistan too announced that "all trade with India, including to and from any third country through Pakistan, is suspended forthwith."

The trade ban hit the exporters of Himalayan Pink Salt, which is in high demand on the other side of the border. "India has been one of the biggest importers of Himalayan pink salt from Pakistan. The ban has meant zero exports to that country," Mansoor Ahmed, a senior director in Ghani International, one of the top exporters of pink salt and related products, said.

"For years, Indian importers imported raw Himalayan pink salt from Pakistan and then it was refined, packaged and marketed/exported to other countries as a finished Indian product at higher prices," Mansoor claimed.

That is why India was ranked among the top three exporters of salt with Pakistan and China, he said, adding, "It is only Pakistan, not India or China that produces Himalayan Pink Salt."


However, Pakistan's top exporters of pink salt are not alarmed by the ban as it also offers a silver lining for them.

Cold Storage Units Vacant As Growers Cash In Early

SRINAGAR: In a significant turnaround from last year's sluggish market, Controlled Atmosphere (CA) cold storage units in Kashmir are now almost empty, with over 99% of stored apples already soldwell on time. Thanks to strong early-season demand and timely dispatches, the growers have managed to reap decent profits despite a modest dip in prices.

Speaking to KNO, the growers and industry stakeholders say the early clearance of cold storage stock reflects not just better market conditions but also a maturing understanding among growers of when and how to sell.

"Last year, cold storage units weren't cleared for nearly 10 months. This time, everything has moved at a good speed," said Mehraj Ahmad, a manager at a CA unit in Lassipora. "We now have only about 1% of the stock left, which too will be cleared in the next few days."

In 2024, about 20% of the apples stored in these facilities remained unsold for over 10 months due to competition from cheaper imported apples and market saturation.

"Demand picked up from January itself much before the scheduled time," said Javed Ahmad, an apple grower from Shopian. "Even though rates dipped by around Rs 200 per box compared to peak prices at one

stage but at the end stage rates went very high and growers reaped good returns this year.

The ability to sell at will rather than in distress has been a game-changer, Mehraj emphasized. "Cold storage has empowered growers. They're no ket's worst days. This flexibility

Kashmir has around 50 CA storage units, primarily in the SIDCO Lassipora industrial estate, with a combined capacity of storing nearly 3 lakh metric tonnes of apples. Given the Valley's annual apple production of over 20 lakh metric tonnes, these facilities play a crucial role in post-harvest management, price stabilization, and farmer income.

Growers also credit better market coordination and buyer confidence for this year's positive outcomes.

"We managed to sell our produce earlier, and that made a big difference," said Abdul Rashid, another grower. "Last year, some of us had to wait months with no buyers. This year, most sold their stock before April."

However, stakeholders stress that more work remains. "We need to improve our grading and packaging," Mehraj said

"Imported apples still dominate some markets due to their polished presentation, even though our produce is superior in taste. We can't ignore their appearance in this competitive

Aspirants Seek CM's Intervention In 'Long-**Delayed AP Recruitment Process'**

SRINAGAR: Aspirants shortlisted for the post of Assistant Professor in Hospitality and Catering in Jammu and Hon'ble Chief Minister, Shri Omar Abdullah, to urgently intervene in the recruitment process that has remained stalled for over a year.

The recruitment was advertised by the Jammu and Kashmir Public Service Commission (JKPSC) under Advertisement No. 17-PSC (DR-P) of 2023, dated May 15, 2023. While the written examination was held on June 9, 2024, and the results were declared on July 30, 2024-shortlisting 29 candidates for 11 posts—the interview process has yet to be scheduled, even after nearly eleven months.

In a collective representation addressed to the Chief Minister, the candidates have expressed growing anxiety and frustration over what they describe as an "unexplained and prolonged delay" in the selection process. They state that

the recruitment cycle has already stretched over two years and that the delay is pushing some aspirants close to the upper age limit for eligibility.

"All shortlisted candidates are highly qualified, holding PhDs, UGC-NET certifications, and substantial teaching and research experience," the letter reads. "We have cleared every stage and are only awaiting interviews. This unexplained stagnation has put our professional lives on indefinite hold and is causing emotional and psychological distress."

The candidates suspect that the delay may be linked to questions over the nomenclature of academic degrees held by applicants. In their letter, they clarify that no university within the Union Territory offers a postgraduate degree specifically named "Hospitality and Catering." Instead, aspirants have pursued closely allied degrees such as Tourism and Hospitality Management or Travel and Tourism Management, which are widely recognized as equivalent by academic and regulatory bodies, including the UGC and AICTE. "Denying us interviews over nomenclature would be unjust. These are the only viable postgraduate degrees avail-

able regionally. Penalizing us

be deeply unfair," the aspirants asserted. The representation also notes that regional Institutes of Hotel Management (IHMs) do not offer postgraduate degrees, making tourism and hospitality degrees from local universities the only practical path for those aspiring to teach

in the field. Calling the situation disheartening in a region where public sector employment is already limited, the aspirants warn that such delays undermine trust in the recruitment system and damage the morale of educated youth.

They have requested the Chief Minister to direct the concerned authorities to expedite the interview process and adopt a pragmatic, inclusive view of relevant academic

The gap between these two extremes signals a bigger problem: unpredictability.

People don't know what they're getting. Some get none. Others too much. It's blind guessing, with real health consequences

And it's not just children.

A 2021 study of 763 tribal adults in Kashmir's Gujjar-Bakarwal communities found that one in three had a malfunctioning thyroid. About 7 percent had overt hypothyroidism. Nearly a third had iodine deficiency.

"They don't call it an illness," says Dr. Manzoor Mir, a physician in Ganderbal, a region with a large tribal population. "They just say they feel cold all the time. Or that their minds feel foggy. Or they're too tired to walk. But the numbers don't lie."

Thyroid hormones power nearly every organ system - heart rate, temperature, mood, memory, metabolism. When those levels drop, so does everything else.

And in Kashmir, something else is dragging them down: pesticides.

In Shopian, where apple orchards spread like green waves across the landscape, growers spray chemical cocktails to protect fruit. These sprays contain organophosphates and organochlorines — both linked in global research to thyroid disruption.

A large 2020 meta-analysis found people exposed to these chemicals had a 49 percent higher risk of developing thyroid disease.

A parallel study from Government Medical College Srinagar showed that 35 percent of farmers exposed to pesticides in Shopian and Baramulla had neurological damage, a figure four times higher than non-exposed

Another study linked 70 percent of brain tumour patients in Kashmir to long-term pesticide exposure.

In this context, the thyroid seems almost forgotten. But doctors are beginning to connect the dots.

They come in complain loss, fatigue, brain fog," said Dr. Ahsan Zahoor, who sees the pattern daily at his city clinic. "Routine labs show everything's 'normal.' But when we dig deeper – T3, T4, antibodies – the real picture emerges.'

Then there's the diet.

Once full of fresh fish, pastured eggs, walnuts, milk, and greens, the Kashmiri plate is changing.

Processed foods, sugary drinks, and deep-fried snacks are filling the gap. Essential nutrients, especially selenium, iron, and iodine, are vanishing from everyday meals.

For families like Nazir's, an orchard farmer in his forties, the changes are personal.

He felt himself fading: waking tired, moving slow, thinking slower. His bloodwork showed nothing wrong, until a full thyroid panel exposed the imbalance. His salt, tested on-site, showed almost no iodine.

"It wasn't laziness," he said. "It was something missing.'

Some schools are starting to act. In Bandipora, teachers are showing parents how to store salt in airtight jars and add it after cooking. In Kupwara, health workers are testing both salt and urine during routine checkups. And in some clinics, thyroid panels, once rare, are becoming common.

But experts say that's not enough.

hectare than any other region in India. More than 2.3 kg per hectare, often sprayed without protective gear or oversight. Food storage systems remain outdated. And iodine deficiency is rarely discussed, let alone prioritized in public discourse.

"Kashmir's thyroid crisis is quiet and creepy," Dr. Ahsan continued. "It slows thought. It weakens bones. It clouds the mind. It makes children forget lessons and adults forget themselves."

The daily signs are simply stark. In classrooms, necks are swelling. In fields, workers slow down. In homes, mothers struggle with fatigue they can't explain.

And still, it's barely mentioned.

Trump's Iran

Speaking via White House Press Secretary Karoline Leavitt, Trump said he is "closely watching developments" and weighing U.S. involvement in what is now an all-out war between Iran and Israel — a war that has entered its seventh day with escalating casualties on both sides.

The centerpiece of Trump's military dilemma is Iran's Fordow enrichment facility, buried under over 100 meters of mountain rock near Qom. It is considered impervious to all but America's GBU-57 Massive Ordnance Penetrator — the largest conventional bomb in the U.S. arsenal. Israel lacks the aircraft needed to deliver such munitions, and Trump is aware that even U.S. involvement would require major escalation.

Meanwhile, Israel's latest retaliatory strike came hours after Iranian missiles struck Soroka Medical Center in Beersheba and nearby buildings, wounding at least 240 people. In response, Israeli Defence Minister Israel Katz issued a chilling threat toward Iran's Supreme Leader: "This man absolutely should not continue to exist."

Prime Minister Benjamin Netanyahu said he trusted Trump to "do what's best for America" but emphasized ongoing U.S. support: "I can tell you that they're already helping a lot."

The broader strategic picture remains grim. The Bloomberg analysis, based on satellite images taken up to June 17, shows Natanz and Isfahan facilities — key to Iran's nuclear fuel cycle – remain largely functional. While Israel's strikes damaged some external electrical components, experts say repairs could be completed in months.

"They did damage but left a lot intact," said Robert Kelley, former IAEA inspector and U.S. satellite analysis lab director. Kelley emphasized the sophistication of Iran's nuclear defenses: "Any competent designer will have backup power. The problem is that Iran prepared for this decades ago.'

At Isfahan, reportedly struck on June 15, imagery showed only minor impacts. More alarmingly, the 409-kilogram stockpile of near weapons-grade uranium stored there is now unaccounted for. UN inspectors confirm they have not had access to the site since the strikes began on June 13.

"In a time of war, all nuclear sites are closed. No inspections, no normal activity can take place," IAEA Director General Rafael Grossi told Bloomberg. Iran has since moved its enriched uranium under "special measures," potentially storing it in as few as 16 small canisters - making detection and tracking exceedingly difficult.

According to Iranian estimates, 657 people – mostly civilians – have died in Iran, and over 2,000 have been wounded. Israel reports 24 dead and hundreds injured with widespread material damage. Iran, according to one estimate, has so far pounded Israel with 450 missiles and 1,000 drones. Military censorship bars any reports about damage to 'sensitive' sites in

Meanwhile as military tensions crest, a diplomatic path may be forming. Iranian Foreign Minister Abbas Araghchi landed in Geneva for emergency talks with the EU and foreign ministers from the UK, France, and Germany. British Foreign Secretary David Lammy, after meeting U.S. Secretary of State Marco Rubio and Middle East envoy Steve Witkoff at the White House, said: "A window now exists within the next two weeks to achieve a diplomatic solution."

That timeline aligns with Trump's stated decision window - a window now shaped not only by geopolitics, but also by the hard reality revealed in satellite images: Iran's nuclear infrastructure was built to survive, and

His comments come as tensions surge in the ongoing war between Israel and Iran, now in its second week, and amid signs that the U.S. under President Donald Trump may deepen its involvement. Russia and Iran signed a strategic partnership agreement in January 2025, and Tehran has supplied drones and missiles to Moscow for its war in Ukraine. While Israel has remained officially neutral on Ukraine, it has criticized Iran for aiding Russian aggression.

Peskov reiterated that any direct attack on Ayatollah Khamenei would be met with a "very negative" response from Russia, though he stopped short of outlining military retaliation. He stressed that Iran itself would likely take the lead in any response. "It will only lead to another round of confron-

tation and escalation," he warned. Since Israel began targeting Iranian nuclear sites and senior officials on June 13, over 224 Iranian civilians have reportedly been killed, though independent confirmation is pending. Iran responded with large-scale missile and drone attacks on Israeli cities, escalating a war that is now drawing in wider global attention — and warnings from Moscow that it may not remain on the sidelines.

The matter was taken up with I&K Chief Minister Omar Abdullah's advisor, Nasir Sogami, who confirmed that all concerned officers have been informed. Students will be directly facilitated from Delhi Airport to TRC Srinagar."

Advisor to Chief Minister Nasir Aslam Wani also informed the Association that transport facilities are in place at Delhi Airport and all relevant departments have been duly informed.

Ton-Up Gill, Jaiswal Lead India To 359/3 At Stumps

LEEDS: Y Yashasvi Jaiswal and captain Shubman Gill announced their readiness to carry India's batting into the post Virat Kohli-Rohit Sharma era, striking marvellous hundreds to guide the visitors to a dominant 359 for three against a faltering England on the first day of the opening Test here on Friday.

Gill (127 batting) and Jaiswal (101, 159b) shared a 129-run partnership for a determined third wicket alliance that carried India to 221 from a slightly wobbly 92 for two after KL Rahul (42) and debutant B Sai Sudharsan (0) were dismissed in quick succession.

Rishabh Pant (65 batting) was keeping vigil with Gill at close.

But there was an underlying significance to the centuries of Jaiswal and Gill other than giving India a head-start on the first day of the newlyminted five-match Anderson-Tendulkar Trophy.

This Indian batting line-up is a tad thin on experience after the recent retirements of former skippers Kohli and Ro-

hit, who played at the pivotal No. 4 and opening slots in their illustrious careers.

Both Jaiswal and Gill are not newcomers to the unforgiving Test arena, but there has been this widespread anxiety over how the 'New Gen' India stars would step into the big shoes of their predecessors.

But the portends are quite bright, if the day's innings by Jaiswal and Gill are anything

Jaiswal was the first to reach the three-figure mark, the fifth in his flourishing career, off 144 balls and Gill reached his own landmark off 140 balls in the final passage of the day, heralding the start of a new era in Indian cricket.

But the way they reached that point was entirely different. Jaiswal eschewed his natural flair as the first session offered its own share of assistance to the English bowlers in the shape of movement and carry.

However, it was an altogether different matter that the home bowlers were not prudent enough to exploit that offering, and later the pitch eased up considerably.

But a flaccid track and a fangless England attack without James Anderson or Stuart Broad could not take the sheen out of the knocks of Jaiswal and Gill.

It was not a typical Jaiswal innings where he simply flayed the bowlers around, but he showed admirable self-restraint, particularly outside the off-stump.

The left-hander was dismissed in that channel a couple of times while playing for India A against the England Lions in the recent tour matches, but here the 23-year-old did not repeat his mistakes.

He celebrated with gusto too — a roar and leap into the Headingley sky. England could not be blamed for imagining the Indian batter repeating his 712-run effort he managed last year during a home series.

If Jaiswal's innings was more about adaptation, Gill's knock was all about following his natural batting doctrine, which has its fundamentals in timing and elegance.

The right-hander played shots with minimum follow-through through on-side and with a flourish on the off-side.

India Tops WADA List Of Doping Offenders

ndia's doping woes came to the fore once again with the country topping the World Anti-Doping Agency's 2023 testing figures among countries which analysed 5,000 or more samples even as the sports ministry promised an "aggressive clean-up" and an amended Anti-Doping Act after addressing objections from the WADA.

India's positivity rate for banned substances stood at 3.8 percent -- 214 Adverse Analytical Findings (AAF) from 5606 samples. The sample size was significantly higher from 2022 when 3865 tests returned an AAF rate of 3.2 percent.

Of the 5606 tests, 2,748 were conducted incompetition. India's positivity rate for banned substances was significantly higher than China (28,197 samples, 0.2 percent AAF rate), USA (6798 samples, 1.0 percent AAF rate), France (11,368 samples, 0.9 percent AAF rate), Germany (15,153 samples, 0.4 per ent AAF rate) and Russia (10,395 samples, 1.0 percent AAF rate).

As compared to India's 214, France, Russia, USA, China and Germany recorded 105, 99, 66, 60 and 57 AAFs respectively.

Athletics leads the number of India's positive cases with 61 AAFs from 1223 samples.

But even with the reinforcements PSG failed to break through a determined Botafogo defence. The decisive moment came in the 36th minute when Igor Jesus beat Gianluigi Donnarumma.

Luis Enrique did not look for excuses and praised the Copa Libertadores champions for their approach.

"Botafogo were the best defensive side we've come up against all season — both in our league and in the Champions League. They were excellent," the Spaniard said.

"They were simply highly effi-

cient, very compact, and always had the threat of hitting us in transition. They scored a great goal through Jesus, and that gave them a real injection of belief. "We didn't create the number

"We didn't create the number of chances we're used to. We're very accustomed to working against teams defending deep — but it's always difficult to break one down. In this case, Botafogo did it very well, and I congratulate them for it."

Despite enjoying long spells of possession, PSG lacked their usual sharpness and Doue said the defeat should serve as a wake-up call.
