

HIV Stigma In Kashmir Leaves Many Undiagnosed, Untreated

Despite rising cases and new mobile testing efforts, HIV/AIDS remains shrouded in stigma and silence in Jammu and Kashmir, leaving many undiagnosed and untreated.

Srinagar: When Sakina Itoo, the Health Minister of Jammu and Kashmir, flagged off two mobile HIV testing vans from Srinagar on June 24, it was more than just a symbolic gesture. It was a silent admission that the Union

Territory's fight against HIV/AIDS is far from over. And perhaps, not as visible as it should be.

For years, the conversation around HIV in Kashmir has been stuck in hesitation. Many still treat it like a distant, unspeakable threat, something that happens to "other people."

Yet official numbers now point to a growing, if largely ignored, concern.

According to the Jammu and Kashmir AIDS Control Society, the region currently has around 4,000 identified HIV-positive cases. But health experts warn that these are only the tip of the iceberg.

"There is no reliable estimate of how many people are actually living with HIV here because a huge section of the population has never been tested," said Dr. Bashir Ahmad, a senior physician involved in HIV counseling in Kashmir. "The social fear is so deep that people | **More on P10**

Srinagar Sizzles At 20-Year June High Met Office Predicts Rain From Today

Srinagar: A day ahead of a predicted three-day wet spell, Srinagar recorded its hottest June day in nearly two decades as temperatures soared to 35.5°C — the highest for the month since 2005.

According to data accessed this is the highest temperature of the season so far in Srinagar, with a similar reading also recorded on June 20, matching a two-decade-old record.

Several other parts of the Valley also witnessed soaring temperatures. Qazigund recorded 33.6°C, Pahalgam 30.6°C, and Kupwara touched 34.7°C. Kokernag

reported 33.2°C, while Gulmarg — the famous ski destination — was relatively cooler at 26.0°C.

In contrast, Jammu division remained relatively normal, with the winter capital Jammu registering a maximum of 34.1°C. Other areas recorded the following: Banihal 30.6°C, Batote 28.2°C, Katra 30.7°C, and Bhaderwah 33.2°C.

Meanwhile, the Meteorological Department has forecast a three-day wet spell from June 25 to 27.

According to MeT Director Dr Mukhtar Ahmad, intermittent light to moderate rain and thundershowers are expected across many places, with | **More on P10**



Shaky Cease-Fire Takes Hold In Gulf

Trump ordered Netanyahu to turn IDF jets around in call to salvage ceasefire

Srinagar: The ceasefire between Israel and Iran began on a shaky start with US President Donald Trump, the key broker, showing his frustration by using televised expletives against ally Israel for undermining the deal just hours after its announcement.

Despite the formal agreement, tensions flared immediately after nine people were killed in Israeli strikes on the northern Iranian province of Gilan, Iranian state media reported, while five people were killed in Iranian strikes on the southern Israeli city of Beersheba.

President Trump, speaking to reporters before departing for a NATO summit, said both sides had likely violated the fledgling agreement, but he aimed his strongest criticism at Israel, a long-time U.S. ally. "They're making it harder," he said, reportedly using strong language behind the scenes. Later, in an attempt to

stabilize the narrative, Trump claimed the ceasefire had been restored:

"ISRAEL is not going to attack Iran. All planes will turn around and head home, while doing a friendly 'Plane Wave' to Iran. Nobody will be hurt, the Ceasefire is in effect!" he posted on Truth Social.

In Tehran, Iran's top security body, the Supreme National

Security Council (SNSC), declared that Israel had been forced to halt hostilities following a "powerful and determined response" by Iranian forces. In a statement issued Tuesday, the SNSC credited the Iranian armed forces' "exemplary courage" and said their coordinated missile operations — including strikes on U.S.-run Al-Udeid Air Base in Qatar

— brought Israel's campaign to a unilateral end.

"In response to the Zionist enemy's aggression, your brave and self-sacrificing children... heeded the command of the Leader and Commander-in-Chief (Ayatollah Khamenei) and responded with exemplary courage," the SNSC said.

Iran's Foreign Minister Abbas Araghchi offered cautious optimism saying Iran would pause retaliation "provided that the Israeli regime stops its illegal aggression against the Iranian people."

Surprise ceasefire announcement came hours after Iran launched a missile attack on Al-Udeid Air Base — the headquarters of the U.S. Air Force Central Command and a critical American military hub in West Asia. The campaign codenamed Tidings of Victory by Iranian armed forces was in response to US attack on three nuclear sites inside Iran.

PM Modi: 'No Terror Hideout Is Safe Anymore'

New Delhi: Asserting that Operation Sindoor has made clear to the world India's stringent policy against terrorism, Prime Minister Narendra Modi said on Tuesday that his government takes whatever steps are appropriate in national interest.

Weapons manufactured in India showed their impact during the conflict with Pakistan, he said, without naming the country, at an event to mark the centenary celebration of the conversation between spiritual figure and social reformer Sree Narayana Guru and Mahatma Gandhi.

"We have shown that no hideout is safe for terrorists who spill the blood of Indians," he said, adding that his government has worked on the ideals of the revered spiritual figure who wanted a strong India that was free of any discrimination.

Modi said his government has, in the past 11 years, worked to make India strong in social, economic and defence sectors.

He said India's reliance on foreign countries to meet its defence needs is declining and it is becoming "autmanirbhar" in the defence sector.



Indian military brought the enemy to its knees with made-in-India weapons in 22 minutes, he said of the precision attacks on terror sites in Pakistan and Pakistan-occupied-Kashmir following the horrific killing of 26 civilians by terrorists in Pahalgam on April 22.

The prime minister said he was confident that made-in-India weapons will be feted across the world in future.

Modi cited his government's welfare schemes in housing, drinking water and health insurance among other fields to assert that these have empowered the deprived and backward sections of society.

'Human Rights Are Sacrosanct'

J&K HC Orders Return Of Woman Deported To Pak

Srinagar: Emphasising that human rights are the most sacrosanct component of human life, the Jammu and Kashmir High Court has directed the Union Ministry of Home Affairs to facilitate the return of a woman deported to Pakistan in the aftermath of the April 22 Pahalgam terror attack.

Justice Rahul Bharti issued the directive while hearing a petition filed by the daughter of Rakshanda Rashid, a Pakistani national married to a resident of Jammu and living in India for nearly four decades on a Long-Term Visa (LTV).

The court observed that Rashid's deportation lacked



due legal process and may have been unwarranted, especially considering her age, medical condition, and long-standing family life in Jammu.

In an order dated June 6, the court instructed the Secretary of the Ministry of Home Affairs to ensure that Rashid is brought back within 10 days and reunited with her husband, Sheikh

Zahoor Ahmed. The court also directed the Centre to file a compliance report by July 1.

"Human rights are the most sacrosanct component of a human life, and therefore there are occasions when a constitutional court is supposed to come up with SOS-like indulgence, notwithstanding the merits and demerits of a case," the court said in its order.

The petitioner, Rashid's daughter, informed the court that her mother is now stranded in Pakistan without support and is suffering from multiple health ailments. She said the deportation has placed her mother's life at serious risk.

Study Of Gut Genomes Finds How Antibiotic Resistance Can Differ Between Genders

A recent study analysing gut genomes found that trends of antibiotic resistance differ between genders. For instance, in high-income countries, women may have more antibiotic-resistant genes, while in low- and middle-income countries, men may have more. Led by researchers at the University of Turku, Finland, the study analysed over 14,600 gut genomes from across 32 countries, taken from a publicly available dataset.

Antibiotic resistance, in which infection-causing germs become immune to the drugs designed to kill them, is a significant public health challenge and is estimated to claim over 39 million lives in the next 25 years, a study published in The Lancet journal in September 2024 said.

Furthermore, differences in antibiotic resistance related to gender were found to emerge in adulthood.

"This suggests that lifestyle, biological differences or healthcare-related factors may influence these differences more in adulthood than in childhood," author Katariina Parnanen, a postdoctoral researcher at the University of Turku said.

"We observed that the association between ARG (antibiotic resistant gene) load and gender was inverted between HICs (high-income countries) and LMICs (low- and middle-income countries): women had higher ARG load in HICs and lower ARG load in LMICs than men," the authors wrote in the study published in the journal



npj biofilms and microbiomes.

The findings also reveal that in high-income countries, women had an average of nine per cent higher amount of genes related to antibiotic resistance compared to men.

Women may be more frequently exposed to antibiotics, bacteria resistant to antibiotics, or are more often carriers of resistant bacteria, the researchers suggested.

Additionally, women in these countries were found to have a slightly higher diversity of antibiotic resistance genes compared to men, suggesting a broader variation in resistance in the gut microbiomes, the team said.

"Understanding gender differences in antibiotic resistance is key to designing equitable and effective healthcare interventions. Our study will lay the groundwork for further research to reduce health inequalities related to

antibiotic resistance," Parnanen said.

The researchers also found a strong association between age and country of residence and the number and diversity of genes involved in antibiotic resistance. These were particularly high in infants and the oldest age group, they said.

High antibiotic use was associated with higher resistance gene loads and greater diversity. High levels of resistance were also found in low-income countries, which may be explained by factors such as poor hygiene and sanitation, the team said.

"Our data-driven analyses shed light on global, gendered antibiotic resistance patterns, which may help guide further research and targeted interventions," the authors wrote.

The study used data publicly available from datasets 'Sequence Read Archive' (SRA) and European Nucleotide Archive (ENA).

Suspend operation of Air India Boeing fleet pending safety audit: Plea in SC

NEW DELHI: A plea in the Supreme Court has sought suspending Air India Boeing aircraft operations pending a safety audit within two weeks in wake of the recent Ahmedabad air tragedy that claimed lives of 241 passengers and crew on board.

The London-bound Air India flight, Boeing Dreamliner 787-8, with 242 passengers and crew on board, crashed moments after taking off from the Sardar Vallabhbhai Patel International Airport in Ahmedabad on the afternoon of June 12.

The plea sought directions to the authorities, particularly the DGCA, to conduct unannounced audits of entire fleet of Air India and other air carriers operating in India, with public disclosure of findings and imposition of immediate corrective measures or penalties for non-compliance.

The plea filed by petitioner and advocate Ajay Bansal has made the Centre, Directorate General of Civil Aviation (DGCA), Air India Limited and Bureau of Civil Aviation Security (BCAS) as parties.

It also sought directions for stringent security and scientific checks of all planes operating in India and immediate grounding of all aircraft found not fully functional or without prescribed facilities for international passenger service until all defects were rectified and airworthiness re-certified.

In the interim, the plea sought to "suspend operation of Boeing aircraft of Air India, pending a safety audit within two weeks, in view of the recent crash and reported main-

tenance backlogs".

Air India Express Jaipur-Dubai flight cancelled after cockpit fault detected moments before take-off

The petitioner further sought within four weeks the formulation and notification of fresh mandatory guidelines prescribing stringent and periodic functional checks of all cabin equipment, engines, air-frames and ancillary systems, consistent with best international standards.

"The present petition challenges systemic failures in maintenance, functionality and passenger services on Air India flights, as evidenced by the recent tragic Ahmedabad-London crash, and the petitioner's own business class journey on AI 127 (DEL ORD) on May 20, 2025, where seats, in-flight entertainment and air-conditioning were non-functional," Bansal said, referring to his journey from Delhi to Chicago.

The plea claimed the seats failed to recline properly, the seat-back entertainment systems were entirely non-functional and air-conditioning did not work until cruising altitude.

The recent crash of an Air India Boeing aircraft on the Ahmedabad-London route has further compounded concerns of general public, the plea added.

Calling it a violation of Article 21 of the Constitution, Bansal said the safety and security of all air passengers was subsumed within "life" under the constitutional provision.

Air India, AI Express resume flights to Middle East as airspaces reopen

New Delhi: Air India and Air India Express on Tuesday progressively resumed their services to the Middle East, with flights to Dubai and Muscat, respectively, as countries in the region reopened their airspaces.

With escalating tensions in the Middle East, especially after Iran launching missiles against US airbase in Qatar, some countries in the region shut their airspaces resulting in numerous flight diversions and cancellations, including by Indian carriers.

Tata Group-owned carriers — Air India and Air India Express — have restarted flights to cities in the Middle East. Officials said Air India is operating Delhi-Dubai flight and Air India Express is operating Delhi-Muscat service.

On Tuesday, Air India said it will progressively re-

sume flights to the Middle East as airspaces are gradually reopening in the region and most of the operations will resume from June 25.

"Flights to and from Europe, previously cancelled, are also being progressively reinstated from today, while services to and from the East Coast of the US and Canada will resume at the earliest opportunity," the airline said in a statement.

Some flights may experience delays or cancellations due to consequential impacts and extended re-routings/flight times, but we are committed to minimising disruptions and restoring our schedule integrity, it added.

Air India Express, which is one of the largest operators to the Middle East, also said it is progressively resuming services to the Middle East from Tuesday with flights to Muscat, Riyadh and Jeddah.



India On Iran-Israel Truce

'No Alternative To Dialogue, Diplomacy'

New Delhi: Hours after US President Donald Trump's claims of an Iran-Israel ceasefire, India on Tuesday said it stands ready to play its part to resolve the situation and insisted on "dialogue and diplomacy" as the way forward.

New Delhi said it remained "deeply concerned" about the overall situation, but welcomed reports of a ceasefire between Iran and Israel.

Though Trump announced the ceasefire between Israel and Iran, later he accused both sides of violating it.

"We have been following developments overnight relating to the conflict between Iran and Israel, including the US action against Iran's nuclear facilities and Iranian retaliation against US military bases in Qatar," the

Ministry of External Affairs (MEA) said.

"While we remain deeply concerned about the prospects for overall and sustained regional security and stability, we welcome reports of a ceasefire between Iran and Israel and the role played by the US and Qatar in bringing it about," it said.

New Delhi again called for resolution of the conflict through dialogue and diplomacy.

"We wish to reiterate that there is no alternative to dialogue and diplomacy in order to address and resolve the multiple conflicts in the region," the MEA said in a statement.

"India stands ready to play its part in these efforts and hopes that all parties concerned will work towards sustained peace and stability," it said.

New Delhi's latest statement came two days after Prime Minister Narendra Modi conveyed to Iranian

President Masoud Pezeshkian India's "deep concern" over Iran's conflict with Israel.

Modi had also called for immediate de-escalation of the situation through "dialogue and diplomacy".

The phone conversation initiated by Pezeshkian on Sunday came after the US bombed three major nuclear sites — Fordow, Natanz and Isfahan — in Iran, bringing itself into the Israel-Iran conflict.

"We discussed in detail about the current situation. Expressed deep concern at the recent escalations," Modi had said in a social media post.

"Reiterated our call for immediate de-escalation, dialogue and diplomacy as the way forward and for early restoration of regional peace, security and stability," the prime minister added.

The US attack on the Iranian nuclear facilities had triggered fears of a wider regional conflict.

Iran Says Taking Measures To Continue Nuclear Programme

TEHRAN: Iran's government said Tuesday it had "taken the necessary measures" to ensure the continuation of its nuclear programme after US and Israeli strikes targeted its facilities.

"We have taken the necessary measures and are taking stock of the damage" caused by the strikes, said the head of the Atomic Energy Orga-

nization of Iran, Mohammad Eslami, in a statement aired on state television.

"Plans for restarting (the facilities) have been prepared in advance, and our strategy is to ensure that production and services are not disrupted," he added.

The United States struck the Fordo, Isfahan and Natanz uranium enrichment facilities on Sunday.

US President Donald

Trump called the strikes a "spectacular military success". The extent of the damage is unknown.

An adviser to Iran's supreme leader, Ayatollah Ali Khamenei, said his country still had stocks of enriched uranium and that "the game is not over". Israel announced on Monday that it had again bombed the Fordo site, buried under a mountain south of Tehran, to "obstruct access routes".

Defence Minister Heads to China Summit

New Delhi: Indian Defence Minister Rajnath Singh will travel to China this week for talks with his regional counterparts, New Delhi said Tuesday.

Ties between the world's two most populous nations have improved in recent months, after hitting a low in 2020 over a deadly clash between their troops on the Himalayan border.

Singh will join fellow defence ministers in the eastern city of Qingdao for the Shanghai Cooperation Organisation (SCO) summit starting Wednesday.

He will "outline India's vision towards achieving greater international peace & security, call for joint & consistent efforts to eliminate terrorism & extremism in the region", a defence ministry statement said.

Singh will also hold bilateral meetings with his counterparts from China and Russia, which are alliance members alongside Pakistan, Iran, Kazakhstan, Kyrgyzstan, Tajikistan, Uzbekistan and Belarus.

Ahead of the two-day SCO

meeting, India's National Security Adviser Ajit Doval held talks in Beijing with Chinese foreign minister Wang Yi.

Doval "underscored the need to promote the overall development of the India-China bilateral relations", New Delhi



said Monday.

Wang said relations have "seen some positive developments" since the two countries' leaders met last year, China's foreign ministry said.

Beijing has granted permission to Indian pilgrims wishing to trek to Mount Kailash in Tibet, a site holy to Hindus and Buddhists, for the first time since the deadly 2020 clash.

The rival countries have also agreed to expedite resuming direct flights.

Shun Double Standards on Terrorism: NSA Doval at SCO Meet

New Delhi: National Security Adviser Ajit Doval on Tuesday called for shunning double standards in combating terrorism and urged

"crime against humanity", Doval said.

The NSA specifically called on SCO member states to hold accountable the perpetrators, organisers, financiers and sponsors of acts of cross-border terror and to help bring



members of the Shanghai Cooperation Organisation (SCO) to hold accountable the perpetrators, organisers and financiers of cross-border terrorism, seen as a reference to Pakistan.

Doval made the remarks in an address at a meeting of the security council secretaries of the SCO in Beijing.

The NSA conveyed India's deep concern over continued threat from UN-proscribed terror groups such as Lashkar-e-Taiba (LeT), Jaish-e-Mohammed (JeM), Al Qaeda, ISIS and its affiliates. More importantly, Doval highlighted the need to shun "double standards" in the fight against terror.

"Travesty Of Justice": Top Court Summons UP Jailer For Not Releasing Man Despite Bail

New Delhi: The Supreme Court on Tuesday said it was a "travesty of justice" that a man it granted bail to in April in a case under UP's anti-conversion law had not yet been released from jail.

A bench of Justices K V Viswanathan and N Kotiswar Singh took strong exception after the man claimed that he was not released on bail on the ground that a sub-section of a provision of Uttar Pradesh Prohibition of Unlawful Conversion of Religion Act, 2021 was not mentioned in the bail order.

The bench, therefore, directed the superintendent jailor of the district jail Ghaziabad to appear



physically present before it on June 25.

Observing that this case presented a "very unfortunate scenario", the bench further directed the Director General of Prisons of Uttar Pradesh to appear through video-confer-

encing.

The bench noted after the top court granted bail to the man on April 29, a trial court in Ghaziabad on May 27 issued a release order to the superintendent jailor to release the accused from custody upon execution of the

personal bond, unless liable to be detained in some other matter.

"After this order was made, it is stated by the petitioner that he has been unable to secure his liberty because in the order of the (Allahabad) High Court and this court, clause (1) of section 5 of the Uttar Pradesh Prohibition of Unlawful Conversion of Religion Act, 2021 was omitted and because of that, the petitioner could not be released," the bench noted.

The top court called it April 29 order "categorical" and said the appellant should be released on bail during the pendency of trial in the FIR of January 3, 2024 registered with a police station at Ghaziabad, on conditions set by the trial court.

French Tourist Raped In India's Udaipur After Cafe Party; Accused On The Run

Jaipur: In a shocking case, a French woman was raped after attending a party in Rajasthan's Udaipur. The Rajasthan Police have registered a case, confirmed officials on Tuesday.

According to police, the incident took place on Monday evening after the victim attended a party at a local cafe, where she met the accused.

The accused, identified as Siddharth, allegedly lured the woman to his rented apartment in Sukher under the pretext of showing her scenic spots in the area. There, he is accused of raping her.

The victim later admitted herself to a private hospital, where she is now out of danger and receiving medical care, the official said.

SHO Purna Singh Rajpurohit of Badgaon Police Station confirmed the incident and said an FIR has been registered based on the woman's complaint. The accused is currently absconding, and police teams are actively searching for him, he said.

According to the FIR, the tourist arrived in Udaipur from Delhi on June 22 and was staying at a hotel in the Ambamata police station area. On Monday evening, she attended a party at The Greek Farm Cafe and Restro Cafe at Tiger Hill, where she met the accused. In her state-

ment, the woman said the man approached her during the party and invited her to step outside for a smoke, promising to show her some scenic views.

Despite her repeated requests to return to her hotel, he allegedly insisted otherwise, eventually taking her to his apartment. Once there, he allegedly made advances and, when she refused, forcibly raped her.

She said her phone battery had drained, leaving her unable to call for help.

After the assault, her health deteriorated, and she admitted herself to a private hospital.

Authorities have assured that the accused will be apprehended soon.

KEEMA Strongly Condemns Budgam Transformer Blast — Demands Criminal Action and Government Accountability

The Kashmir Electrical Equipment Manufacturers Association (KEEMA) expresses profound grief and outrage over the tragic transformer explosion in Budgam, which has resulted in the loss of a precious life and left several others grievously injured. We extend our deepest condolences to the family of the deceased and stand in solidarity with the injured. Their dedicated service to the public must be honoured not with mere tributes, but with action, justice, and accountability. This is not an accident it is a man-made disaster born out of systemic neglect. Despite KEEMA's repeated warnings to the government and the Power Development Department (PDD), substandard, uncertified electrical materials continue to be used, putting lives at constant risk. This preventable tragedy is a direct consequence of ignoring quality standards, and the cost has been paid in blood. Preliminary reports confirm that the failed transformer lacked valid ISI certification and was never cleared through standard quality protocols. This is criminal negligence. KEEMA demands that a formal FIR be lodged immediately against both the agency that installed the equipment and the supplier who provided it. Those responsible must be booked under applicable sections of the Indian law without delay. The silence of authorities in the face of such gross dereliction is unacceptable. For over five decades, Kashmir's electrical manufacturers have maintained a flawless safety record

not a single incident has occurred involving KEEMA-certified equipment. Our industry has remained committed to supplying the highest-grade products, fully compliant with ISI standards. This tragedy has once again demonstrated the grave danger of bypassing certified local manufacturers in favour of dubious, uncertified supplies.

We therefore urge Hon'ble Chief Minister Omar Abdullah to take urgent cognizance of this matter and order a comprehensive, independent, and time-bound judicial inquiry into the transformer blast. This probe must establish individual and institutional accountability, fix criminal liability, and ensure that only certified and standardised equipment is used across the power sector going forward. KEEMA reaffirms its willingness to extend full technical assistance and cooperation to the government to help prevent such tragedies. But the time for appeals is over—this is the time for action.

Let this be a moment of reckoning, not another entry in a forgotten file. The lives lost were not collateral damage—they were preventable victims of a broken system. Justice delayed is not only justice denied it is death repeated.

Iran Holds Ground

The fragile but holding ceasefire between Iran, Israel, and the United States brings a rare and much-needed moment of relief. After nearly two weeks of relentless strikes that killed hundreds in Iran and scores in Israel, and triggered a barrage of missiles even at a major US base, a lull in violence feels almost unreal. Yet, the cost of this calm must not be lost on us, nor how Iran turned the tables on the joint brute force of Israel and the US and fought them to a standstill. It is now clear that Israel's surprise preemptive strikes on Iran's nuclear and military sites were calculated to cripple Iran's capacity. Instead, they triggered an unprecedented direct exchange that laid bare not only Iran's resilience but also its ability to absorb punishment and respond proportionately, despite crippling sanctions and decades of covert warfare. Iran's decision to calibrate its missile attacks, even when targeting American forces, demonstrated not reckless adventurism but a hard-headed realism to avoid a wider regional inferno.

For far too long, military establishments in Washington and Tel Aviv have relied on the perceived vulnerability of Iran to unilateral strikes, confident that regime change, chaos, or at least containment would follow. Iraq, Libya, Syria, and Afghanistan stand as graveyards of such arrogant miscalculations, albeit these nations were destroyed in the process. This time, the confrontation with Iran proved different.

Iran has neither nuclear weapons nor the same level of conventional power as its adversaries, but it has once again shown that military muscle alone cannot subdue a nation forged by revolution and sustained by a deep well of popular and ideological resolve. From the early hours of the conflict to the final moments before the truce, images of ordinary Iranians waving flags in bombed streets showed their resilience unlike those in Israel who took shelter in underground bunkers following every siren warning of Iranian missile barrage.

President Trump's dramatic warnings on his social media and hurried push for a ceasefire reveal what Tehran's steady posture achieved: a forced recalibration of Washington's appetite for a drawn-out conflict it could not win quickly. Israel, too, cannot ignore that it faced real deterrence, a notion that should inform its future security calculations and its relationship with neighbors it has long tried to weaken by covert operations and assassinations.

The region must seize this fragile window to pivot from endless war to dialogue. This ceasefire is not the end of old hostilities nor a guarantee of a peaceful future, but it is a moment to step back from the abyss. It should remind policymakers in the west that the Middle East deserves a security architecture built on mutual respect and non-aggression, not cycles of siege and retaliation.

Above all, Iran, long demonized and squeezed between sanctions and threats, has emerged not as victim but as a country whose endurance and unity turned an imposed war into a stalemate. That must be acknowledged, even by those who once imagined otherwise. May this truce, fragile as it is, be a foundation for the region's leaders to choose dignity, sovereignty, and peace over the fear of the west.

Teaching these things early matters. Schools and colleges should talk more about how rules shape the systems we use every day. It's not just about staying legal. It's about building a society where fairness and safety come first.

Legal awareness isn't optional anymore. It's a tool young people need to carry with them as they step into a world full of opportunities and risks.

Degrees Without Direction

Thousands of Kashmiri students graduate each year, but with no jobs, no guidance, and little mental health support, they are left searching for a future that seems to be missing.

Each year, thousands of students across Kashmir graduate, hoping for a fresh start.

After years of lectures, exams, and assignments, the degree finally comes. But instead of feeling joy, many of us feel stuck.

The question isn't just about getting a job, it's about not knowing where to go next.

Students in Kashmir often finish their degrees without any real-world experience. There are no internships, no campus placements, no professional mentors. We are called “freshers,” but no one wants to hire freshers.

And when we ask, “How do we gain experience?” the answer is usually a shrug. There was never a door open in the first place.

One day, after class, someone in my group asked, “What's next for you?” The room fell silent. Then someone whispered, “I feel like a burden at home.” Another said, “I don't know where to even start.” Heads dropped. Eyes filled. That day, I realized this is bigger than just career confusion. It's a silent mental health crisis.

In just one year, the Tele-MANAS mental health helpline handled over 55,000 calls, most of them from young people struggling with anxiety, depression, and fear.

On the second day of Eid this year, a day meant for joy, the helpline received 119 distress calls, most of them late into the

night and early morning. Even our happiest days are now clouded with worry.

Behind these calls are real stories. One was from a 26-year-old labourer who was close to harming himself. Aareba, a counselor with Tele-MANAS, answered his call that day. “We made him pause and think,” she said. “We helped him see the light at the end of a dark tunnel.” He was lucky. Not everyone is.

The pressure isn't just emotional, it's economic.

Rising suicides in the valley are reportedly linked to poor education quality, joblessness, and growing health issues. Many students now look outside Jammu & Kashmir, or even abroad, for better education.

But this comes at a price. Not every family can afford it. Some who leave don't return because life outside offers more stability, better pay, and safer futures. Those who come back often find no jobs waiting for them.

After years of study, they return to a place where they are made to feel useless. Some give up. Some sink into depression. Some, tragically, do not survive the weight of it all.

This is the story of Kashmir's youth in 2025. We are not afraid of working hard, we are afraid of having nowhere to work at all. We are not afraid of growing, we are afraid there is no room left for

us to grow here.

But there are solutions.

Experts have suggested ways to help young Kashmiris find their way. They say the government and private sector should support local startups, offer business-friendly loans, and build co-working spaces where young people can develop their ideas and meet mentors.

We need vocational training that actually connects to today's markets. We need our classrooms to offer skills that match real jobs. We need internships, apprenticeships, and career counseling within Kashmir.

And we need mental health support to be available on campuses, not just in emergencies.

Schools and local communities should talk openly about emotional well-being and offer regular, easy-to-access help.

We don't lack ambition. We don't lack talent. What we lack is a system that understands and supports us. We need fair chances to build our lives, right here in Kashmir.

We have waited long enough. Let this not be another forgotten story.

As more young people get involved in sports, small businesses are also growing, like shops that sell equipment, coaches who train new athletes, local events that bring people together.

Sport is creating work and energy in places where, for a long time, there wasn't much.

Kashmir's landscape is also part of this change. The mountains, lakes, and open meadows are not just places to visit anymore. They are places to play, train, and compete.

When people come from other parts of India or from around the world to join skiing or kayaking events, they are not just tourists. They become part of the place. They get to know the land in a different

In many places, sports are still seen as something extra, not as something important. But for many young people in Kashmir, sports can be the thing that keeps them going.

Following the Crowd, Kashmir Forgets Its Masters

Over the past few decades, Kashmir's vibrant culture, once built on individual creativity and artisanal excellence, has increasingly succumbed to a pernicious “domino effect”: the unthinking adoption of popular trends at the cost of originality and craftsmanship.

What began as a subtle bandwagon effect has escalated into herd mentality, where conformism and social pressure stifle critical reasoning and dilute the region's artistic heritage.

Psychological research describes this phenomenon as a combination of informational social influence, where people follow others because they believe others are better informed, and normative pressure, where the desire for social accep-

tance drives people to conform.

Kashmir is not immune. Across disciplines—culture, career paths, art—young Kashmiris are herded by communal norms rather than guided by unique talents and passion.

A 2025 quantitative study of 340 Kashmiri artisans found a sharp decline in craft innovation, citing limited market access, intermediaries' exploitation, and socio-economic pressures as fatal blows to creativity.

Similarly, academic work on human capital in Kashmir's handicraft sector warns that lack of competitive talent erosion has “killed” the industry, condemning it to reproduce relic designs rather than nurture new forms.

Local examples abound. In Srinagar, young artisans often abandon

centuries-old papier-maché techniques in favour of mass-produced souvenirs, believing these sell better.

Graduates flock to engineering and medical fields, not due to aptitude, but to satisfy a herd-driven social narrative of success.

In literary circles, budding poets echo dominant themes—conflict, identity—as if originality is taboo; deviation invites social ostracism.

This growing conformity defames the memory of Kashmiri forebears - masters who once wrote and wove from their own souls. The Mughal-era miniature painters, the papier-maché virtuosos, the Pashmina weavers thrived on uniqueness.

Today, their heirs chase the latest fad, reducing art to hollow imitation. But this trend is not immutable.

Combating it requires fostering critical thinking in schools, encouraging arts beyond clichés, and promoting market structures that value novelty, not just volume.

Kashmir still harbours extraordinary individual talents. Let us cease treating our youth as reluctant echo-chambers. Instead, empower them to break the chain of herd-driven mediocrity and restore Kashmir's rightful stature as a cradle of authentic art.

This Kashmiri Techpreneur Turned a Lost Notebook into a Cultural Revolution

What began with Wartaav became Dawat Book, a platform where Kashmir's forgotten rituals find new life through care and code.

Kashmiri celebrations are more than events. They are memory, care, and beauty woven into food, gifts, and gathering. But somewhere along the way, many of our traditions began to slip, lost between modern noise and forgotten notebooks. That's where Dawat Book began.

Iqra Nazir didn't set out to build a business. She set out to protect something tender.

She comes from a tech background, but her eyes were always on the small things, like Wartaav, the handwritten record of who gifted what at weddings and Nikkahs. It's a tradition passed from hand to hand, often by women, and often unnoticed.

Iqra saw it written on scraps of paper, the last page of a school notebook. She saw how it held more than just names. It held gratitude, memory, relationships. And she saw how easily it could vanish.

So she built Dawat Book. Not just an app, but a home for that fading tradition. And it grew, into a platform that now celebrates local bakers, women growers, forest foragers. And into a space that replaces plastic bottles with Shahi Sheera, that brings wild greens back to our tables, that invites technology to serve culture, not erase it.

Today, Iqra runs this journey mostly alone. But in her words, every Kashmiri is a part of the team. Every woman baking at home. Every guest who still remembers who came, who cared.

In this conversation, Iqra walks us through her journey, from a fleeting idea to a growing movement, one that hopes to keep the heartbeat of Kashmir alive, celebration after celebration.

What first pulled you toward this work? Why Dawat Book?

I come from a tech background. But I've never looked at technology as just shiny tools. I've always felt that tech should make life more meaningful, not just more performative.

The real beginning was something very simple, Wartaav. I grew up watching my father, my uncles, carefully writing down



who gave what at weddings and family gatherings. It wasn't just bookkeeping. It was a way of remembering people, of honouring connections.

Over time, I could see this tradition slipping away: misplaced papers, forgotten ledgers. It was becoming one of those things we'd lose without even noticing. That bothered me. I wanted to protect it. That's how Dawat Book started, as a digital home for Wartaav.

Was there a particular moment that made this personal for you?

Yes. It was a family function. My mentor and I were watching someone write Wartaav in a small diary, and we joked: what if this diary gets lost?

I suddenly realised how fragile the whole system was. I thought about all the weddings I had helped manage, how much cultural work happened quietly, usually in women's minds, never really seen.

That's when I knew. We needed to build

something that would not only hold this work but also value it.

You've spoken about women's work being invisible in these settings.

Yes, always. Women have kept traditions alive—recording, cooking, organising—but no one called it innovation. No one called it important.

With Dawat Book, I wanted to make that work visible. It's not about glorifying the past. It's about giving our traditions dignity, design, and a proper space.

Did people immediately understand what you were trying to do?

No, not at all. In fact, most people didn't get it. They thought I was making celebrations too formal, too technical. Some laughed, some ignored it.

But those who tried it, they came back and said, "This is exactly what we needed." That's been the most rewarding part. Not

everyone understands it right away, but those who do, they really care about it.

How did the idea of using local ingredients and old recipes become part of Dawat Book?

For me, a dawat is a story. And stories should start from where we come from.

At our events, we began serving wild greens like Obuj and local mushrooms like Kabul Dhingri—ingredients that have always grown here but rarely show up in weddings now. Instead of fizzy drinks, we served Shahi Sheera, an old, rich recipe. And we made herbal teas for diabetic guests, blends prepared by local women growers.

It wasn't about being fancy. It was about care. About remembering that our own land is full of flavour, that we don't need to import culture to impress anyone.

How do you find these ingredients and the people behind them?

We work with women who grow herbs in their backyards. We source from old bakers in downtown Srinagar. Many don't have shops or Instagram pages, but they carry legacy in their hands.

One of the sheermals we served recently came from a young boy trying to revive his family's baking tradition. For me, these people are the real heart of Dawat Book.

Was there a particular event that felt like a turning point?

Yes, a Kashmiri-Mexican wedding we curated recently. We blended cultures in the smallest ways: Kehwa with walnut fudge for the Mexican guests, herbal teas brewed by local women, Shahi Sheera instead of soft drinks, and handmade photo props that mixed sombrero patterns with Kashmiri embroidery.

One guest whispered, "I've never felt so embraced in a place I've never been to before." That's when I knew this was working. You don't need grandeur. You need meaning.

How are people responding now to this shift away from big, showy celebrations?

In the beginning, people hesitated. They thought we were cutting costs. But when they experienced the events, they saw the beauty in the details, intention, and care.

I think people are beginning to want something real now. They're slowly moving toward the Dawat Book way: a celebration that feels like their own, not a borrowed version.

What's your dream for Dawat Book?

I want Dawat Book to grow into a full cultural ecosystem. Not just weddings, but professional events, community gatherings, exhibitions, even ticketing, all with the same rooted care.

I want local vendors to earn more. I want women to be recognised as creators. I want young Kashmiris to see that technology can preserve culture. It doesn't always have to be disruptive.

Maybe one day a Sufi concert or a women-led startup event in Kashmir can be hosted through Dawat Book. That's where I see this going.

What do you hope this blend of tradition and technology inspires?

I hope it tells people, especially young girls, that your roots are not a burden. They're your superpower.

You can write software that honours your grandmother's recipes. You can build businesses around your own stories, not borrowed ones.

Innovation doesn't always look like rockets. Sometimes it looks like digitising Wartaav. Sometimes it looks like offering walnut fudge with kehwa because the bride is Mexican and the soul is Kashmiri.

If even one person sees Dawat Book and feels their story is worth building something around, that's enough for me.

The Sacred Threads of Kashmir

Amidst change and conflict, the ancient arts of Kashmir still carry a spiritual pulse that binds its people to their land, their history, and something far beyond themselves.

In the soft morning light of Baharabad, my hometown in Sumbal Bandipora, the sound of looms used to echo through the narrow lanes. There was a time when almost every house hummed with the rhythm of weaving.

Today, that sound has mostly faded. Only a few hands now carry the memory of the pashmina, the art that once kept our community alive, that once felt like a form of prayer.

Kashmir's art has always had a sacred weight. The valley has long been a meeting place of faiths, ideas, and stories, and all of them have found corners inside its crafts.

The famous pashmina shawls, soft as whispers, are not just cloth. They are months of devotion, woven by hands that know the value of patience. Each thread seems to carry a piece of the sky, a memory of the goat grazing high in the cold, lonely mountains. There's a tenderness in this work that feels more spiritual than material.

But in the village today, only a few still sit at the loom. The rest have folded away the wooden frames, pushed aside by the weight of politics, the rush of modern life, and the slow erosion of tradition.

There are people trying to bring the art back, to teach it again, to keep it breathing. Yet, sometimes it feels like holding water in your hands.

Kashmiri carpets still glow with rich colours and intricate patterns. The old paper maché boxes, with their careful flowers and golden vines, continue

to hold their charm. They tell stories without speaking. But it is not just the objects that matter. It is the feeling behind them. In these crafts, time slows down. There is a patience here that the modern world often forgets.

Even in food, you can taste the spirit of the place. The wazwan is more than a feast, it is a celebration of life, of community, of togetherness. The slow-cooked meats, the deep spices, the way people gather around a single large plate, all feel like pieces of the same art that we see in the shawls and carpets—a kind of carefulness, a kind of love.

The music carries it too. The Sufiana Kalam, with its calm, winding melodies, sounds like it comes from somewhere far beyond this world. The Rouf, the women's dance, simple yet full of grace, is like a living poem. The soft clapping, the gentle swaying feels like a conversation with the past, a promise not to forget.

What holds it all together is not just skill. It is the soul. The people of Jammu and Kashmir carry their art like they carry their prayers, with care, silence, and struggle.

Even as the world changes around them, these crafts survive, stubborn and beautiful.

Maybe that's the real story here. In the folds of a pashmina, in the beat of a folk song, in the slow simmer of a wazwan, Kashmir's spirit lives on as a gentle, breathing presence.

Home Is the First Frontline

Behind the rising drug abuse in Kashmiri youth are weak systems, unchecked industries, and parenting that struggles to keep pace. Real change starts at home, but must not end there.

Drug addiction often slips into young lives unnoticed, until the damage is hard to undo. We tell our children to stay away from drugs. But the places that make drugs, and the routes that sell them, remain wide open.

Some of the danger comes from where we least expect it. Drug-producing industries, especially pharmaceutical and chemical companies, continue to release substances that can easily be misused. These are not just the pills you get on prescription. Some end up being misused on the streets, or inside homes where no one is watching.

There are laws, there are rules, but often these systems are not properly checked. Companies keep producing, people keep buying, and somewhere along the way, the line between medicine and misuse gets crossed.

Then there is the illegal side. Drugs flow through street networks and black markets that somehow keep escaping the law. Despite police crackdowns, these chains stay alive, feeding

on weak enforcement and public silence.

Everyone knows where to find the dealers. The problem is, no one really stops them. It's not just a failure of enforcement, it's a failure of communities that look the other way.

But this fight does not start with governments and courts. It starts at home. Parents hold a power that no law can replace. It is not about strict control. It is about building trust, being there when children fall, and showing them they can speak without fear.

Too often, families raise children under the weight of what other people will think, rather than what their child truly needs to grow. Anger when they slip up, silence when they need support push children further into harm.

When bad influences from the past resurface, a good parent does not panic. They listen. They guide. They remind their child of the values that matter. Parenting shines in the middle of mistakes, not just in moments of success.



If we want to protect young people from drugs, we cannot just patch the surface. We must block the supply, fix the gaps in our systems, and create homes where children feel safe to talk. Parenting and policy need to work together. One without the other will never be enough.

At the heart of this crisis is a simple truth: children need love, patience, and protection from the forces that wait to pull them under. If we get that right at home, and fight for it in our streets, we may finally stand a chance to turn the tide.

Why Does My Phone Sometimes Not Ring When People Call? A Communications Expert Explains

The Conversation

There's a certain feeling I get in the pit of my stomach when I'm waiting for an important call to come through. You know the type – maybe a call from your boss, a potential new employer or news of a loved one who's due to give birth.

In these situations, I usually stare at my phone, willing it to ring. I make sure – over and again – it's not on silent or “do not disturb” mode. When the screen is out of my sight, I imagine I can hear the familiar ringtone.

Then it pops up – the missed call notification. But the phone never rang. What happened?

How do mobile calls work?

When making a mobile call using 4G or 5G networks, the caller dials a number and their network operator (Telstra or OneNZ, for example) routes the request to the recipient's device.

For this to work, both phones must be registered with an IP Multimedia Subsystem – or IMS – which automatically happens when you turn on your phone. IMS is the system that allows the combination of voice calls, messages and video communications.

Both phones must also be connected to a 4G or 5G cell phone tower. The caller's network sends an invite to the recipient's device, which will then start to ring.

This process is usually very fast. But as generations of cellular networks have evolved (remember 3G?), becoming faster and with greater capacity, they have also become more complex, with new potential points of failure.

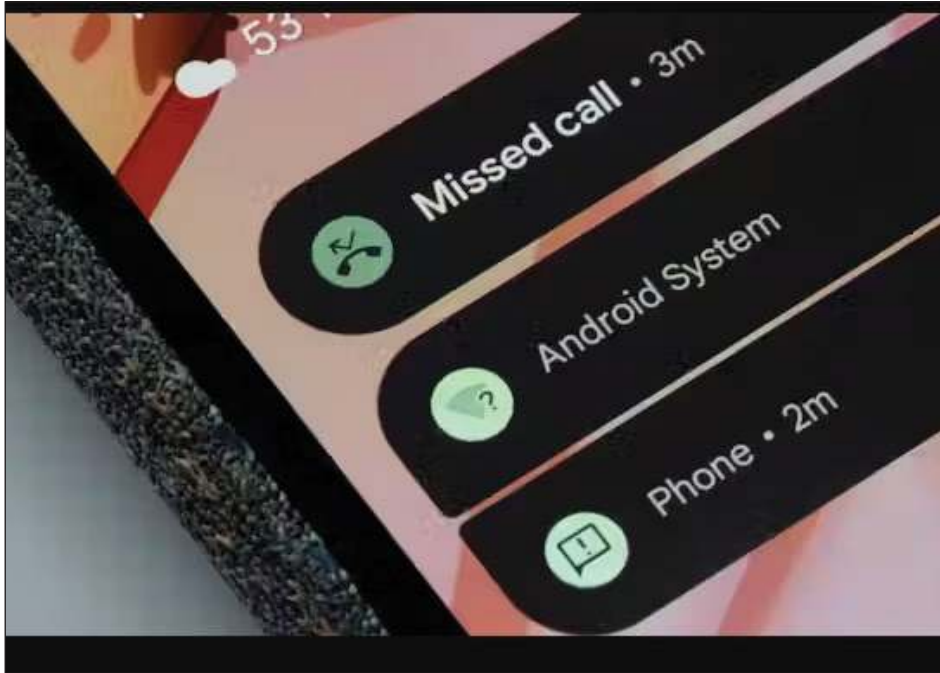
From phone failures to 'dead zones'

Mobile phones use Voice over LTE (VoLTE) for 4G networks or Voice over New Radio (VoNR) for 5G. These are technologies that enable voice calls over those two types of networks and they use the above mentioned IMS.

In some countries such as New Zealand, if either of these aren't enabled or supported on your device (some phones have VoLTE disabled by default), it may attempt to fall back to the 3G network, which was switched off in Australia in 2024 and is currently being phased out in New Zealand.

If this fallback fails or is delayed, the recipient's phone may not ring or may go straight to voicemail.

Another possibility is that your phone may have failed to register with the IMS network. If this happens – due to something like a software glitch, SIM issue, or network problem – a phone won't receive the call signal and won't ring.



In some countries such as New Zealand, if either of these aren't enabled or supported on your device (some phones have VoLTE disabled by default), it may attempt to fall back to the 3G network, which was switched off in Australia in 2024 and is currently being phased out in New Zealand.

Then there are handover issues. Each cell phone tower covers a particular area, and if you are moving, your call will be handed over to the tower that provides the best coverage. Sometimes your phone uses 5G for data but 4G for voice; if the handover between 5G and 4G is slow or fails, the call might not ring. If 5G is used for both data and voice, VoNR is used, which is still not widely supported and may fail.

Mobile apps introduce other potential

problems. For example, on Android, aggressive battery-saving features can restrict background processes, including the phone app, preventing it from responding to incoming calls. Third-party apps such as call blockers, antivirus tools, or even messaging apps can also interfere with call notifications.

Finally, if your phone is in an area with poor reception, it may not receive the call signal in time to ring. These so-called “dead zones” are more common than telcos would like to admit. I live at the end of a long driveway in a well-covered suburb of Auckland in New Zealand. But, depending on where I am in the house, I still experience dead zones and often the WiFi-enabled phone apps will more reliably cause the phone to ring.

What can I do to fix it?

If your phone frequently doesn't ring on 4G or 5G there are a few things you can do:

- Make sure VoLTE/VoNR is enabled in your network settings.
- Restart your phone and toggle airplane mode to refresh network registration.
- Check battery optimisation settings and exclude the phone app you are using contact your carrier to confirm VoLTE/VoNR support and provisioning.

But ultimately, sometimes a call will just fail – and there's very little an everyday person can do about it. Which yes, is annoying. But it also means you have a fail-safe, expert-approved excuse for missing a call from your boss.

Trade Agreements With US, EU To Be Concluded Soon: Sitharaman

NEW DELHI- Finance Minister Nirmala Sitharaman on Tuesday said negotiations for the proposed free trade agreements with the US and European Union (EU) are progressing at a fast pace and would be concluded soon.

All efforts are being made to boost exports to achieve the ambitious target of USD 2 trillion by 2030.

India has already signed free trade agreements with the UAE, Australia, and 4-nation EFTA (European Free Trade Association) bloc and negotiations have been completed with the UK, she said adding "with the US and the European Union, negotiations are really intensely going on and should come to conclusion sooner."

The emphasis now is on concluding more free trade agreements, she said while inaugurating Trade Conclave by India Exim Bank here.

She also mentioned Budget announcements of Export Promotion Mission and Bharat Trade Net, a digital public infrastructure which provides a unified platform for trade documentation and financing solutions.

The Budget also proposed a National Framework for Global Capability Centres (GCC) to further support services-led growth in emerging tier 2 cities and Trade Facilitation Measures.

Referring to the country's exports, the finance minister said total exports of goods and services reached a record high of USD 825 billion in FY25, achieving 6 per cent



growth over previous year. This is a significant leap from USD 466 billion in 2013-14.

While global exports grew by only 4 per cent, India's exporters managed to fast-track and cross growth of 6.3 per cent despite global uncertainties on trade front, she said.

Observing that exporters are "swimming against tides", she assured all support to them and urged them to focus on innovation and finding newer markets for their products.

Quoting United Nations Conference on Trade and Development (UNCTAD) World Investment Report 2025, she said, India's position has improved though the global FDI flows dropped 11 per cent.

FDI inflows of nearly USD 668 billion from 2014-24 account for nearly 67 per cent of the total FDI reported in the last 24 years which was USD 991 billion, she said.

India has deepened its participation in global value chains, she said, adding, Apple India's iPhone contract manufacturers have crossed the 20 per cent

domestic value addition (DVA) threshold across variants.

Speaking at the event, Financial Services Secretary M Nagaraju said India's growth prospects remain bright even as the world economy is troubled by geopolitical uncertainties and significant headwinds emanating from it.

"Even amidst all the global headwinds, India continues to be a beacon of hope," he said.

Nagaraju said that India's exports, which the commerce ministry is "trying very hard" to integrate into the global value chain, are doing well irrespective of the challenges.

Exports from the pharmaceuticals and gems and jewellery sectors are showing resilience, he said adding in this endeavour, the finance ministry is committed to extending support through policy, schemes and financial aid.

"Our financial systems are strong with adequate capital and low non-performing assets," he said, adding, this gives strong support to India's financial needs.

‘India, UK Likely To Sign Trade Pact By July End; Commerce Secy In London’

NEW DELHI- The process of legal scrubbing of the India-UK free trade agreement (FTA) text is progressing at a faster pace, and the pact is expected to be signed by the end of July, an official said on Tuesday.

To give an impetus to the process, Commerce Secretary Sunil Barthwal is in London with his official team.

Barthwal will meet UK Secretary of State for Business and Trade Jonathan Reynolds and other British senior officials during his two-day visit.

The two countries announced the conclusion of the negotiations on May 6. It will remove taxes on the export of labour-intensive products such as leather, footwear and clothing, while making imports of whisky and cars from Britain cheaper, in a bid to double trade between the two economies to USD 120 billion by 2030.

The world's fifth and sixth-



largest economies concluded the deal after three years of on-off negotiations.

Once the FTA is signed, it will require approval from the British Parliament and India's Cabinet before it can take effect. The implementation is likely to take about a year after the signing.

"The agreement is likely to be signed by July end. India's legal team is also there in London for the legal scrubbing of the text. The pact's text would be put in public domain after

signing," the official said, adding the commerce secretary's visit is important, as issues such as the implementation process of the pact would be discussed.

Commerce and Industry Minister Piyush Goyal was also in London earlier this month. He held discussions with Reynolds on issues related to the implementation of the FTA.

Prime Minister Narendra Modi has invited UK Prime Minister Keir Starmer to India.

Gold Declines Rs 900 To Rs 98,900/10 G On Iran-Israel Ceasefire Hopes

NEW DELHI- Gold prices plummeted Rs 900 to Rs 98,900 per 10 grams in the national capital on Tuesday as the expectations of a ceasefire between Iran and Israel reduced the precious metal's safe-haven appeal in the global market.

According to the All India Sarafa Association, the precious metal of 99.9 per cent purity had closed at Rs 99,800 per 10 grams in the previous market session.

Gold of 99.5 per cent purity depreciated by Rs 800 to Rs 98,300 per 10 grams (inclusive of all taxes). It had finished at Rs 99,100 per 10 grams on Monday.

"Gold is under pressure as safe-haven demand eases after the US confirmed a full ceasefire between Iran and Israel. The announcement came shortly after Iran attacked a US military base in Qatar, briefly heightening tensions before quickly calming them.

"With fears of further escalation fading, investors are booking profits and pulling back from gold," Abans Financial Services' Chief Executive Offi-



cer Chintan Mehta said.

Silver prices also diminished by Rs 1,000 to Rs 1,04,200 per kilogram (inclusive of all taxes) on Tuesday. The metal had ended at Rs 1,05,200 per kg in the previous market close.

Meanwhile, spot gold fell by USD 46.05 or 1.37 per cent to USD 3,323.05 per ounce in the overseas markets.

"Investors are closely watching Federal Reserve Chair Jerome Powell, who is set to testify before US Congress on Tuesday and Wednesday, which can provide any signals on the future policy path of interest rate cuts," Saumil Gandhi, Senior Analyst - Commodities at HDFC Securities, said

Pak Aiming At Loans Worth USD 3.3 Billion From Chinese Banks

ISLAMABAD- Pakistan is aiming to secure USD 3.3 billion in the form of two foreign loans — one a syndicated loan and the other a refinancing of commercial loans — from Chinese banks within the next few days, according to a media report Tuesday.

It is expected that the foreign exchange reserves held by the State Bank of Pakistan (SBP) will surpass the USD 14 billion mark if this deal materialises within the outgoing financial year, which ends on June 30.

"Yes, we are still working closely with the Chinese high-ups to finalise modalities of this expected deal. We are expecting the striking of two different foreign loans from Chinese banks till the end of June 2025.

"A syndicated financing of USD 2 billion will be made available to Pakistan by a consortium of Chinese banks for three years," top officials

of the government confirmed while talking to The News here on Monday.

The second loan of USD 1.3 billion will be a refinancing of a commercial loan from the Industrial and Commercial Bank of China (ICBC), which was paid back by Islamabad a few months ago.

In rupee terms, the government will be able to generate approximately Rs 924 billion (USD 3.3 billion), so the maturity of the short-term domestic debt would be cleared till the deadline of the first 10 days of July 2025.

Pakistan's foreign exchange reserves held by the State Bank of Pakistan (SBP) stood at USD 11.7 billion by June 13, 2025 and the expected injection of USD 3.3 billion would help the SBP to jack up the foreign reserves to touch USD 15 billion mark.

However, keeping in view outflow requirements, there are strong expectations that the foreign reserves held by the SBP might be standing at over USD 14.5 billion by the end of June 2025.

Markets Trim Gains On Renewed Geopolitical Tensions In Middle East

MUMBAI- Equity benchmarks Sensex and Nifty on Tuesday gave up most of their sharp intra-day gains due to the emergence of profit-taking as investors turned cautious amid reports of a ceasefire violation between Iran and Israel.

In the morning trade, markets bounced back sharply, mirroring a rally in global peers and a steep decline in crude oil prices amid hopes of a potential de-escalation in the Middle East conflict.

After surging 1,121.37 points or 1.36 per cent to 83,018.16 in intra-day trade, the 30-share Sensex later trimmed most of its gains as reports surfaced of the ceasefire plan faltering. But, the benchmark still managed to settle in the green, climbing 158.32 points or 0.19 per cent to 82,055.11.

As many as 2,662 stocks advanced

and 1,339 declined while 143 remained unchanged on the BSE.

On similar lines, the 50-share Nifty rose 72.45 points or 0.29 per cent to end at 25,044.35. The index fell from an intra-day high of 25,317.70.

"Initial gains in the domestic market, driven by the ceasefire announcement and sharp drop in crude prices, were short-lived as renewed geopolitical tensions in the Middle East unsettled investor sentiment.

"Adding to the uncertainty was heightened volatility due to expiry day dynamics. Although the market attempted to break out of its recent consolidation range, persistent global risks continue to impede momentum," Vinod Nair, Head of Research, Geojit Investments Limited, said.

From the Sensex constituents, Adani Ports, Tata Steel, Kotak Mahindra Bank, UltraTech Cement, Bajaj Finserv and Titan were among the biggest gainers.



DGCA Flags Multiple Violations in Airlines, Airports, Aircraft Maintenance Works

NEW DELHI- Aviation watchdog DGCA has detected multiple violations related to airlines, airports, aircraft maintenance works, and repeated defects in multiple cases during its surveillance at major airports, an exercise carried out in less than two weeks after the Air India plane crash.

Without disclosing names of the airlines, airports and other entities in relation to the defects, the regulator on Tuesday said surveillance covered multiple critical areas such as flight operations, airworthiness, ramp safety, Air Traffic Control (ATC), Communication, Navigation and Surveillance (CNS) systems, and pre-flight medical evaluations.

The surveillance was done last week and DGCA is stepping up efforts to strength the overall safety oversight of the aviation ecosystem.

From a faded centre line marking of a runway at an airport to non-updation of obstruction limitation data for three years to a scheduled carrier's domestic flight being held up due to worn tyres, the watchdog came across multiple defects in the aviation ecosystem.

Noting that the comprehensive surveillance will continue in future to detect hazards in the aviation ecosystem, the Di-

rectorate General of Civil Aviation (DGCA) said the findings have been communicated to the entities concerned for taking corrective actions within seven days.

Two teams led by the Joint Director General carried out the surveillance during night and early morning hours at major airports, including Delhi and Mumbai airports.

In a detailed statement about the surveillance findings, DGCA listed multiple cases wherein the reported defects reappeared many times on the aircraft indicating ineffective monitoring and inadequate rectification.

"Ground handling equipment such as baggage trollies... were found unserviceable; Line maintenance stores, tool control procedures were not followed," it said.

During maintenance of aircraft, the work order was not followed, DGCA said and added that the unserviceable thrust reverser system and flap slat lever were not locked.

"During maintenance, safety precautions found not (to have been) taken by AME (Aircraft Maintenance Engineer) as per AMM (Aircraft Maintenance Manual); at places, AME was not attending to the snag rectification; defect reports generated by the aircraft system, were not found recorded in the technical logbook," the statement said.

EPFO Member May Soon Be Able To Withdraw EPF Money Through ATMs, UPI Directly

NEW DELHI- Retirement fund body EPFO subscribers may soon be able to withdraw their employees' provident fund (EPF) directly from their accounts through ATMs or other modes like UPI after linking their bank accounts with EPF.

A highly placed source said the labour ministry is working on a project where a certain proportion of the EPF will be frozen and a large chunk will be available for withdrawal through their bank account using various modes like UPI or ATM debit cards.

The source also said there are some software challenges to implementing this system, which are being resolved.

Presently, the members of the Employees' Provident Fund Organisation (EPFO) have to apply for withdrawal claims to access their EPF money, which is time-consuming.

Under the auto-settlement mode, the withdrawal claims are settled electronically without manual intervention within three days of filing the application form.

The limit of this auto-settle-



ment mode has been raised to ₹5 lakh on Tuesday from existing ₹1 lakh.

This will facilitate a large number of EPFO members to access their EPF money within three days for illness, education, marriage, and housing purposes.

The EPFO, which has more than 7 crore members, had first introduced online auto-settlement of advance claims during the COVID-19 pandemic to provide quick assistance to those facing financial crunch.

However, all members have to file claims to access their own EPF.

The new system is being evolved to avoid this time-consuming process and reduce the burden of the EPFO, as over 5 crore claims mostly for withdrawal EPF are settled every year.

'Iran-Israel Ceasefire To Stabilise Global Trade Aid India's Exports To Middle East'

NEW DELHI- The ceasefire between Iran and Israel has offered major relief to India, which has over USD 100 billion worth of trade with the Middle East countries and is heavily dependent on energy imports from the Gulf region, experts said.

They said that reduced geopolitical tension lowers the risk premium, stabilises freight costs, and enhances predictability in shipping routes for Indian goods via the Strait of Hormuz, a narrow but key passage between Iran and Oman.

Economic think tank Global Trade Research Initiative (GTRI) said that for India, with over USD 100 billion in the Middle East trade and heavy reliance on Gulf energy imports, the de-escalation offers relief.

"A sustained ceasefire would stabilise energy prices and safeguard vital shipping routes. But any flare-

up would again threaten India's trade flows, energy security, and diaspora interests," GTRI Founder Ajay Srivastava said.

He added that oil prices fell more than 3 per cent, and volatility in the strait, through which a fifth of global oil passes, briefly eased.

However, he said, this ceasefire may prove temporary, as the underlying issues between the US, Israel, and Iran remain unresolved.

Federation of Indian Export Organisations (FIEO) Director General Ajay Sahai said the ceasefire brings welcome relief to global trade and supply chains, particularly across the Middle East, a key conduit for energy and cargo movement.

"This development is particularly beneficial for Indian exporters of engineering goods, food products, textiles, and chemicals to West Asia, and for importers reliant on crude oil and petrochemicals," Sahai said.

However, it was not immediately clear whether efforts had been made to bring her back or the ministry was going to challenge it in a division bench.

Duckett Flays India Bowlers To Win 1st Test For England

LEEDS: Opener Ben Duckett hit the most defining century of his career, exposing an out-of-depth Indian attack as England comfortably chased down a tricky target of 371 to win the opening Test by five wickets after an intriguing five days of play here on Tuesday.

Duckett's 149 off 170 balls with 21 fours and an audacious reverse-swept six off Ravindra Jadeja, along with Zak Crawley's 65 in an opening stand of 188, followed by Joe Root's composed 53 and Jamie Smith's cheeky 44 made the chase look much easier than it actually was.

Having chased down 378 at Birmingham courtesy Jonny Bairstow in 2022, England once again did the same with elan on Tuesday, leaving India head coach Gautam Gambhir with an even bigger frown on his face.

England lead the five-match series 1-0.

It will be difficult to recall when was the last time that India had five centuries in a single Test and yet lost a game so comprehensively.

Shoddy fielding effort and no support for the peerless Jasprit Bumrah made matters worse for India. Indian bowlers in second innings alone conceded 44



boundaries and three sixes. Add to that the 54 boundaries and five sixes in the first innings.

There will certainly be bowling changes in the next Test but whether that will result in

20 wickets is a million dollar question.

In the final session, Ravindra Jadeja, who enjoys a favourable match-up against Ben Stokes, got the important breakthrough

with the England skipper trying to reverse-sweep from the rough and his opposite number Shubman Gill taking an easy catch.

With 69 runs to get, Root

brought his 150-plus Test experience to play, guiding a young Smith through and through during the unbroken sixth wicket stand that sealed the deal for England.

While this was one of India's worst fielding efforts with Yashasvi Jaiswal alone dropping four catches, skipper Gill's relative inexperience in strategizing and taking on-your-feet decisions also became visitor's undoing.

At one point, it seemed the team's most experienced batter KL Rahul was captaining the side, and Gambhir's record as a coach in traditional format got a tad worse.

In Gambhir's coaching, India have now lost seven Tests out of the 11 that he has been in charge so far. The number of defeats could well go into double digits, considering the only potent match winning bowler Bumrah won't play two of the remaining four games.

With nearly 50 overs bowled in the match, others need to step up if they don't want the world's best fast bowler to have another on-field breakdown.

Not playing a spinner of Kuldeep Yadav's calibre came back to haunt India and they would certainly make corrective measures in Birmingham Test that starts on July 2.

CM Omar Wants To Develop Gulmarg As World-Class Golf Destination

But we are determined to bring it back," he said.

The Chief Minister revealed that the government is actively considering the establishment of a Jammu and Kashmir Golf Development Authority to manage and maintain all major golf courses, including Srinagar, Pahalgam, Gulmarg and venues like Sidhra in Jammu.

Omar also commended his father and former CM, Dr. Farooq Abdullah, a passionate golfer and someone who has built the golf infrastructure in J&K.

Earlier in the day, CM Omar Abdullah inspected the newly constructed Gulmarg Convention Center. On the occasion, the Chief Minister flagged off the Cyclothon, encouraging youth participation in sports and promoting eco-friendly tourism across the Valley.

Later, the Chief Minister laid the foundation stone for a 726-meter ski drag lift at Kongdoori, to be constructed at an estimated cost of ₹6.84 crore.

Pant Charged By ICC For His Dissent At Umpire's Decision

LEEDS: India wicket-keeper batter Rishabh Pant has been reprimanded by the ICC for showing dissent at an umpire's decision during the third day's play of the ongoing opening Test against England here.

Pant, who had an exceptional outing with the bat during the Headingley Test with hundreds in both the innings, was reprimanded for his on-field conduct during England's first innings.

The 27-year-old was found to have breached Level 1 of the ICC Code of Conduct.

"Pant was found to have breached Article 2.8 of the ICC Code of Conduct for Players and Player Support Personnel, which relates to showing dissent at an Umpire's decision during an International Match," the ICC said in a statement.

In addition to this, one demerit point has been added to Pant's disciplinary record, for whom it was the first offence

in 24 months.

The incident happened in the 61st over of England's innings, when Harry Brook and Ben Stokes were batting. Pant was seen having a discussion with the umpires regarding the condition of the ball.

When the umpires refused to change the ball after checking it with the ball gauge, the wicket-keeper showed his dissent by throwing the ball on the ground in front of the umpires.

There was no disciplinary hearing as Pant admitted to the offence and accepted the sanction proposed by ICC match referee Richie Richardson.

The charges were brought in by the on-field umpires, Chris Gaffaney and Paul Reiffel, along with the third umpire Sharfuddoula Ibne Shahid and the fourth umpire, Mike Burns.

Level 1 breaches carry a minimum penalty of an official reprimand, a maximum penalty of 50 per cent of a player's match fee, and one or two demerit points.

Expected Stubbornness But Jay Shah Is Honest: Ganguly

NEW DELHI: Reflecting on his eventful tenure as BCCI President, Sourav Ganguly has revealed that he expected a "certain kind of toughness and stubbornness" from the then Board secretary and current ICC chairman Jay Shah but was left impressed with his "honesty" and resolve to do things "properly".

Ganguly and Shah were colleagues at the world's richest cricket board from October 2019 to September 2022, navigating a tumultuous phase caused by the COVID-19 pandemic, which



brought sporting activity to a grinding halt for few months.

"He (Jay) had his own way of doing things but the best thing about him was he wanted to do things properly for Indian cricket," Ganguly told PTI in an exclusive interview at his residence in Kolkata.

"See, he had the power, the support, so you expected certain kind

of toughness, stubbornness from him but he would do things for Indian cricket," the iconic former captain explained, referring to Shah's status of being the son of Home Minister Amit Shah.

It was the first time that both Ganguly and Shah held BCCI positions. Before that, Ganguly had headed the Cricket Association of Bengal, while Shah was an office-bearer in the Gujarat Cricket Association.

While Ganguly was replaced by another former Test player Roger Binny in 2022, Shah continued as BCCI secretary till November 2024 before taking over as the young-

est ever ICC chairman at 36 years of age.

Asked about how the power dynamics and relationship was between the scion of a political family and a celebrated cricket star, Ganguly said they shared a cordial equation which has continued to this date.

"Relationship was very good. It's still very good. When he came in September 2019...he was a young boy, straight from Gujarat CA, very cooperative, approachable," he recalled.

"Obviously, he had opinions and rightfully so, he wanted to do things and still does, he is the ICC

chairman and it is a bigger post."

Ganguly believes that with time, Shah became better at his job.

"He is very supportive of players. He got better as he learnt. The good thing about him was he wanted to do good for the game," the soon-to-be-53 superstar said.

The Kolkata-based legend said Shah was acutely aware of his status and always wanted to carry out his work in a principled manner.

"He is very honest, he always had the thought (about) who he was at the back of his mind, what baggage he carried. So, he wanted to do things rightfully and properly all the time.

1. Incorporating sports, aerobics, stretching, dancing, or any fitness activity into daily routines.
2. Maintaining proper hydration by drinking adequate water throughout the day.
3. Consuming a balanced diet rich in nutrients.
4. Eating seasonal fruits and preserving seeds for monsoon sowing.
5. Maintaining a personal diary or notebook to record daily activities.

The Directorate of Youth Services and Sports has urged Physical Education Lecturers, Masters, and Teachers to actively support students in adopting a healthy lifestyle. Joint Directors of both the divisions and District Youth Services and Sports Officers have been directed to oversee the implementation of these guidelines. (Observer News Service)



India, England Honour Dilip Doshi Before Start Of Day 5

Players from India and England wore black armbands and observed a minute's silence in the memory of former spinner Dilip Doshi before start of day five of the first Test here on Tuesday.

Doshi, a former India spinner who took 113 wickets in 33 Tests, died of a cardiac arrest in London on Monday. He was 77.

"Both teams are wearing black armbands today in memory of former Indian cricketer Dilip Doshi, who passed away on Monday."

"The teams also observed a minute's silence before the start of Day 5," read a social media post from BCCI.

Doshi carved out a niche for himself despite being in the shadows of Bishan Singh Bedi for the majority of his international career.

He was also a stalwart in English county circuit having plied his trade for more than a decade there. He represented Nottinghamshire and Warwickshire. (PTI)



Wimbledon Champ Murray To Help Design Statue Of Himself

Two-time Wimbledon champion Andy Murray is to help design a statue of himself to mark the grass-court tournament's 150th anniversary in 2027.

Wimbledon organizers said Tuesday they aim to unveil the statue of the British tennis great during the 2027 edition.

"He's got to rightly be very involved in that and him and his team will be," the All England Club chairwoman Debbie Jevans said.

Murray ended Britain's 77-year wait for a home champion in men's singles in 2013 when he beat Novak Djokovic in the final.

The Scotsman won a second title — and his third Grand Slam singles title overall — in the 2016 final against Milos Raonic.

An inspiration for the statue project is the way Rafael Nadal was honored, with Murray in attendance, this month at Roland Garros where he won 14 French Open titles.

A bronze statue of Fred Perry, the previous British men's champion before Murray in 1936, was put up at Wimbledon in 1984 marking 50 years after his first singles title at the tournament.

The 2025 tournament at Wimbledon starts Monday. (AP)

Porto, Al Ahly Eliminated From CWC After a 4-4 Draw

Pepe's goal in the 89th minute gave Porto a 4-4 tie against Al Ahly in a back-and-forth match Monday night, before both teams were eliminated from the Club World Cup on goal differential.

Rodrigo Mora, William Gomes and Samu Aghehowa also scored for the Portuguese team. Wessam Abou Ali had a hat trick for the Egyptian team in front of a crowd of 39,893 at MetLife Stadium, where a sea of red jerseys dominated the stands.

Both teams pushed for a late goal before the final whistle but neither could score again to finish above Inter Miami after its 2-2 draw with Palmeiras.

Porto held an advantage in possession with 56.5% but Al Ahly created more opportunities with a 22-14 advantage on shots.

A penalty just minutes into extra time kept Al Ahly in the lead going into halftime. Porto gained momentum after Gomes sent a right-footed shot from outside the box to the top right corner.

Wessam consolidated his hat trick with a header that sent the ball into the center of the box. (AP)

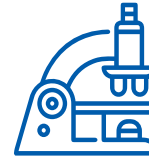
