Big Financial Changes Roll Out From July 1

Srinagar: Get ready for a series of significant financial and travel regulation changes rolling out across India starting July 1. These updates will impact everything from how you file your income tax returns to how you use your credit cards and book train tickets, directly affecting individual taxpayers and customers of major banks like HDFC, SBI, and ICICI.

Aadhaar Now Mandatory for PAN Applications

One of the most impactful changes comes from the Central Board of Direct Taxes (CBDT). From Tuesday, Aadhaar verification will be mandatory for all new PAN card applications. This means the days of using just a driving license or birth certificate for a new PAN are over. Existing PAN holders aren't exempt either; they must link their Aadhaar numbers by December 31 to avoid their PAN being deactivated.

Key Changes for Train Travel

The Railways are also tightening their rules, particularly last-minute bookings. Aadhaar verification will become mandatory for booking Tatkal tickets. Furthermore, starting July 15, all train ticketing, whether online or inperson, will require two-factor authentication, involving a onetime password sent to your registered mobile phone. Travelers should also brace for a minor increase in ticket prices, potentially ranging from 1 paisa per km for non-AC coaches to two paise for AC coaches.

ITR Filing Deadline Extended

In a piece of good news for salaried individuals, the CBDT has extended the Income Tax Returns (ITR) filing deadline from July 31 to September 15. This provides an additional 46 days to complete your filings. However, those whose documentation is already prepared might consider sticking to the original schedule to avoid potential website glitches and errors that often occur as the extended More on P10

MeT Sees No Big Relief Before July 8

Srinagar: The ongoing heatwave in Kashmir showed no signs of letting up on Monday, with most areas recording temperatures well above 30°C. The Meteorological Department has predicted scattered rain and thundershowers over the next five days, but no major weather activity is expected to break the prolonged spell of heat.

In Srinagar, the maximum temperature climbed to 34.5°C. Other parts of the Valley also sweltered under intense heat, with Qazigund recording 33.6°C, Pahalgam 30.2°C, Kupwara 34.2°C, and Kokernag 33.6°C. Gulmarg, the only exception, offered slight respite with a relatively cooler maximum of 25.0°C.

In contrast, parts of the Jammu division witnessed below-normal temperatures. Jammu city recorded a high of 32.3°C — 4.7 degrees below normal for this time of year. Banihal reported 29.8°C, Batote 28.3°C, Katra 30.2°C, and Bhaderwah 32.1°C.

omen exposed to household air pollution from cooking fuels may be at a higher risk of cognitive impairment than men, a study by the Indian Institute of Science (IISc) in Bengaluru has found. The study, published in The Lancet Regional Health Southeast Asia journal, analysed MRI brain scans of ageing adults in the rural town of Srinivaspura in Karnataka, revealing that women might be at a higher risk of experiencing adverse effects in the brain.

A team, which also included researchers from the University of Chicago, US, explained that burning solid fuels for cooking, especially in poorly ventilated spaces, can release air pollutants, such as oxides

The pollutants have been shown to affect the brain through varied mechanisms. primary ones being inflammation and oxidative stress, they said.

The researchers analysed more than 4,100 adults aged 45 and above, who are participants of the ongoing Centre for Brain Research-Srinivaspura Aging, Neuro Senescence, and COGnition (CBR-SANSCOG) study at IISc. MRI brain scans were taken for around a thousand of these participants.

Cognitive impairment, they explained, affects memory, reasoning, and speech. It may precede conditions like dementia and Alzheimer's disease -- in which the affected person faces trouble performing daily routine activities.

The study's authors wrote, "Polluting cooking technology users may be at a higher risk for cognitive impairment. Rural females, who tend to be more exposed than males, could have greater vulnerability to (household air pollution's) adverse effects on the brain.'

Given the increasing burden of dementia -- an ageing-related disorder -- in India, the findings have significant implications for public health, providing insights on how household air pollution can influence dementia risk, the team said. "Policies promoting clean cooking fuel (or)

technology adoption are imperative," they They added that the findings support

those from previous studies which showed a lowered cognition and ability to process visual information in space among people using polluting cooking technology.

Further, upon analysing the MRI brain scans of women, the team found lower volumes of hippocampus -- a brain region critical for memory and known to be significantly impacted in Alzheimer's disease. Overall, the study broadens the understanding of how pollution-causing cooking fuel is related with poor cognition, the authors said.

"Community-centred interventions to improve health literacy and clean cooking fuel adoption among rural Indians, could help reduce the substantial morbidities associated with polluting cooking fuel use, and reduce dementia risk," they said. The study is the only one to employ brain scanning techniques in a rural population to examine how household air pollution can adversely impact the brain structurally, the authors said.



Israeli Raids Kill 60 in Gaza as Crisis Deepen

Jerusalem: At least 60 people were killed across Gaza by Israeli strikes, health workers said on Saturday, as Palestinians face a growing humanitarian crisis in Gaza and ceasefire prospects inch closer.

The strikes began late on Friday and continued into Saturday morning, among others killing 12 people near the Palestine Stadium in Gaza City, which was sheltering displaced people, and eight more living in apartments, according to staff at Shifa Hospital, where the bodies were brought.

More than 20 bodies were taken to Nasser Hospital, according to health officials. A strike midday on Saturday killed 11 people on a street in eastern Gaza City, and their bodies were taken to Al-Ahli Hospital.

The strikes come as US President Donald Trump says there could be a ceasefire agreement within the next week.

U.S. Spends Over \$1 Billion Defending Israel in 12-Day War

Srinagar:The United States has spent an estimated \$1 to \$1.2 billion defending Israel during a 12-day missile war with Iran earlier this month — a staggering figure that has reignited debate in Washington over the long-term costs of America's military commitments in the Middle East.

At the heart of the expenditure was the deployment of the U.S.'s elite THAAD (Terminal High Altitude Area Defense) system, which fired between 60 and 80 interceptors to shield Israeli cities from Iranian ballistic missile attacks. According to Military Watch Magazine each interceptor costs between \$12 million and \$15 million, making this one of the most expensive defensive operations in recent U.S. history

While the U.S. government has long supported Israeli defense through military aid and joint systems like Iron Dome and Arrow. this episode marked a rare instance where Americanoperated missile defenses were directly used in live combat to protect Israeli territory — at significant cost to U.S. taxpayers.

Military Watch noted that Iran fired its missiles at a "modest" rate, well below its full capabilities,

"The numbers are shocking," said a senior congressional aide familiar with defense appropriations. "We burned through over a billion dollars' worth of interceptors in less than two weeks. That kind of burn rate raises serious questions about sustainability and priorities.'

Iran's response to the attacks on its nuclear and military sites came fast and heavy. Ghadr. Emad. Kheibar Shekan. Then the Fattah. Hypersonic, deadly and hard to stop. These were not random rockets. These were long-range and high-precision messages aimed at Israel's core.

While Israel's Arrow and Barak-8 systems played some roles in interception, the bulk of high-altitude defense fell to the U.S.-operated THAAD batteries, which had been quietly stationed in Israel since early 2024.

Military analysts warn that the asymmetric cost dynamic - where cheap offensive missiles force expensive defensive responses — poses a growing challenge for U.S. strategy. Iran's missile assault was described as "modest" in scale compared to its full arsenal, yet it still forced the U.S. to use up 15-20% of its global THAAD stockpile.

With only 50-60 THAAD interceptors produced annually, the 12-day conflict effectively erased more than a year's worth of missile defense capacity — raising alarms about readiness elsewhere, particularly in the Indo-Pacific, where tensions with China and North Korea are rising.

"There's no world where we can afford to spend a billion dollars every two weeks defending allies," said one former Pentagon official. "We need to seriously rethink how we structure and fund mis sile defense — or risk being caught unprepared in a far bigger conflict."

Despite the ceasefire announced by President Donald Trump on June 24, the finan cial and strategic aftershocks of the Israel-Iran war continue to ripple through Washington. With an eighth THAAD battery due online by late 2025, military planners face a critical question: Can America afford to keep using billion-dollar solutions against million-dollar threats?

Pakistan, China, Bangladesh Eye New Bloc to Counter India

New Delhi: Islamabad, Beijing, and Dhaka are reportedly in talks to form a new regional alliance aimed at countering India's influence and replacing the largely defunct South Asian Association for Regional Cooperation (SAARC).

The proposed bloc, still in early stages, would focus on economic integration, infrastructure, and strategic cooperation — areas where SAARC has stagnated due to India-Pakistan tensions.

Media reports from Islamabad stated that discussions between Islamabad and Beijing on forming this new bloc are already at an advanced stage. The report also noted that Bangladesh participated in a recent meeting held in Kunming, China, on June 19 to explore the creation of the proposed group.

According to The Express Tribune, the primary goal of the Kunming meeting was to extend invitations to other South Asian nations, many of them former SAARC members, to join this emerging regional platform. The development follows a China-Pakistan-Afghanistan trilateral dialogue held in May, which focused on expanding the China-Pakistan Economic Corridor (CPEC) and deepening cooperation with Afghanistan's Taliban-led regime.

SAARC, established on December 8, 1985, in Dhaka, had originally included seven countries, with Afghanistan joining in 2007. The bloc has been largely inactive since 2016. While there hasn't been an official SAARC summit since 2014 in Kathmandu, Indian Prime Minister Narendra Modi did host a virtual SAARC leaders' conference in 2020 to propose a COVID-19 $\,$ Emergency Fund, pledging \$10 million from India.

The 19th SAARC summit was scheduled for Islamabad in November 2016, but India withdrew following the Pakistan-sponsored attack in Uri that killed 17 Indian soldiers. Afghanistan, Bangladesh, and Bhutan also pulled out, citing terrorism and regional instability, leading to the summit's cancellation and an indefinite pause in SAARC activity.

The Express Tribune report claimed that both China and Pakistan believe a new regional framework is essential for enhancing integration and connectivity in South Asia. Countries such as Sri Lanka, the Maldives, and Afghanistan are also expected to be included in the proposed bloc.

According to diplomatic sources cited in the report, India may be extended an invitation to join the new group. However, given New Delhi's strategic differences, its participation is consid-

Iranian Clergy's New Fatwa: Threats to Supreme Leader Constitute 'Moharebeh'

Tehran: Iran's top Shia clergy have issued strong religious decrees, warning that any attack or threat against the country's Supreme Leader, Ayatollah Seyyed Ali Khamenei, constitutes a red line for the Islamic world. Citing escalating threats from Israel and incendiary remarks by U.S. President Donald Trump, the clerics emphasized the religious, political, and symbolic centrality of the Supreme Leader's position.

In a fatwa issued Sunday, Grand Ayatollah Nasser Makarem Shirazi declared that any regime or individual threatening the leadership of the Islamic Republic is guilty of moharebeh-a grave Isfatwa comes amid recent Israeli strikes on Iran, including targeted assassinations of Iranian commanders and scientists, and growing rhetoric from Western officials.

"The Supreme Leader of the Revolution stands as the guardian of Shi'ite identityand indeed the entire Islamic Ummah," Ayatollah Shirazi stated. "His leadership is a central pillar of our belief. No righteous and free Muslim can remain silent in the face of threats against this sacred position."

Clerical Consensus on Defense of Leadership

'Will Wait for Najeeb Till My Last Breath,' Says Missing JNU Student's Mother

wait for Najeeb will continue till last breath,' Fatima Nafees, mother of first-year JNU student Najeeb Ahmed who went missing in 2016.

She said she would speak to her lawyers to explore a future course of action.

A Delhi court on Monday allowed the CBI to close Ahmed's case saying the agency "exhausted all options".

Ahmed went missing from the Mahi-Mandvi hostel of JNU, following a scuffle with some students allegedly affiliated with

the Akhil Bharatiya Vidyarthi Parishad the previous night.

Talking to PTI over the phone, Nafees said, "I will talk to my lawyers. But my wait for Najeeb will continue till my last breath. I pray for him every day and I hope I will get justice one day.'

She was involved in multiple protests demanding a fair probe into her son's case. She said she has not been keeping well.

The CBI in October 2018 closed its investigation into the case as the agency's efforts to trace Ahmed yielded no result.

The agency filed its closure report before the court in the case after getting permission from the Delhi High Court.

Nafees' counsel had previ-



ously said it was a "political case" in which the "CBI has succumbed to the pressure of its masters".

The case was initially probed by Delhi Police but was later transferred to the CBI.

Additional chief judicial magistrate Jyoti Maheshwari also "earnestly hoped" Najeeb was traced soon.

"This court expresses its regret that while the proceedings in the present case end with this closure report, a closure for Najeeb's mother and other loved ones, still eludes us," the order said.

Man Poses as IAS Officer, Travels in Car with 'GOI' Plate

olice have arrested a 32-yearold man who allegedly posed as an IAS officer, stayed at a Customs' guest house in Mumbai and travelled in a car with the 'Government of India' name plate, an official said on Monday.

The accused, identified as Chandramohan Singh, hailing from Bihar, stayed at the Customs' facility by claiming to be an employee of the Ministry of Home Affairs, he said.

He used to move around in a car bearing the 'Government of India' name plate, the official said.

The man had been stopped by a traffic constable in Dadar for a road rule violation, but he managed to escape by claiming he was an Indian Administra-



tive Service (IAS) officer, the police said. Acting on a tip, the police tracked Singh down outside a hotel in Malad area in a car with a driver on Saturday.

He initially posed as an IAS officer and showed a fake identity card, but during the probe, he confessed the documents were forged, the official said.

The police also found another document in his possession which claimed the man was working with the Ministry of Defence, he said.



Jhelum Water Levels Dip Amid Kashmir Dry Spell

SRINAGAR: As the prolonged dry spell continues to grip the Kashmir Valley, the Jhelum river and its tributaries have seen a noteworthy drop in water levels, raising concerns over irrigation and drinking water availability across the region.

According to data from the Irrigation and Flood Control Department on Monday morning, accessed by KNO, the water level at Sangam stood at just 0.57 ft, far below the flood alert mark of 21 ft. Other gauges also reported low readings: Munshi Bagh (2.47 ft), Asham (2.57 ft), and Pampore (-1.29 m).

Wular Lake was recorded at 1574.97 metres, significantly below its average level of 1578.00 metres, according to the data.

It says tributaries are also showing signs of stress, with Rambiyara Nallah at Wachi dipping to -0.43 m, Lidder Nallah at Batkoot at 0.30 m, and Sindh Nallah at Doderhama measuring 1.05 m.

SRINAGAR: As the Amarnath Yatra draws near, Pahalgam witnessed an even larger tourist influx this weekend, with thousands thronging the scenic valley. The rush, mainly comprising local tourists, led to massive traffic jams that lasted for hours on the Pahalgam routes on Sunday.

The growing buzz is seen as a promising sign for the valley's tourism sector, still recovering from the shadow of a 22 April Pahalgam terror attack that had initially sparked fear and cancellations.

Traffic snarls were reported from multiple stretches between Anantnag and Pahalgam, with vehicles crawling for miles. Despite the inconvenience, the atmosphere remained festive, as families, trekkers, and nature lovers took advantage of the weekend to visit the lush green meadows, riversides, and famous parks like Betaab Valley.

"This is the second consecutive weekend where we've seen a huge footfall," said Fayaz Ahmad, a hotelier in Pahalgam, told KNO. "Occupancy touched 80 per cent by Sunday evening. It feels like the season is picking up pace again, and we're hopeful the upcoming Yatra will boost things even more."

Local businesses, which had been reeling under uncertainty after the attack, are slowly regaining confidence. "The fear was there, but people have started coming back. The market was lively again, and we've had good sales after a long gap," said Asma Jan, a handicrafts vendor near Lidder Park.

Tourism department officials said the steady rise in visitor numbers is a positive indicator. "We've been working to ensure safety and coordination across all departments. The weekend rush shows that people are regaining trust in Pahalgam as a safe tourist destination," an official said.

Security has been tightened in view of the upcoming Yatra, with additional personnel deployed along key routes. The traffic department and Pahalgam Development Authority were on the ground, managing the crowd and ensuring that the rush didn't spiral into chaos.

"The traffic was heavy but manageable. With proper planning and more deployment during the Yatra, we hope to streamline the flow better," said a traffic official.

Photos and videos of the bustling Pahalgam along with jams went viral across social media, drawing praise and raising further hopes for a revival of tourism.

Stakeholders believe that if the current momentum continues, the season may still turn around. "With school vacations going on and Yatra, we hope the flow to further increase. If peace prevails, we're looking at a near-normal season," said Mohammad Yousuf, who operates a pony service.

Stakeholders said that there are still three months of peak season, and if they will go good, they will be able to earn their livelihood despite the dent caused by the attack.

Break HIV Stigma

hen Health Minister Sakina Itoo flagged off two mobile HIV testing vans in Srinagar, it signaled an important step forward. But beneath this measure lies an unsavoury truth: HIV/AIDS in Kashmir is still wrapped in silence, fear, and deep-rooted stigma. And unless we confront that stigma head-on, no number of mobile vans will be enough.

The numbers tell one story: just over 4,000 confirmed HIV-positive cases in the region, but health experts caution that the reality is likely far worse. This is because, many don't visit health institutions for getting tested for fear of judgment, social exclusion, and even discrimination by medical staff. This silence is dangerous. People are being diagnosed late, when their immune systems have already deteriorated and are beyond treatment. What's more. They are also threat to the society as they can infect their partners, and may be others also.

So, the mobile testing vans are a good initiative. Equipped with kits and counselors, they bring services to people who would never walk into a clinic out of fear of being seen. But it is not so simple also: In conservative, close-knit society like ours, even being spotted near a testing vehicle can trigger gossip and social isolation. The real fight, therefore, must be against the stigma itself.

Kashmir is not alone in this. Globally, HIV-related stigma is among the leading barriers to prevention and care. But here, it's intensified by silence from families, from community leaders, and often from healthcare institutions. While we talk freely about diabetes and cancer, we strictly avoid discussing HIV. And this silence only feeds the fear.

One of the major routes of transmission is the drug addiction, the rise in injectable drug use, especially among the youth. So addiction support should be an essential part of HIV care services. But this is hardly the case right. We are staring at a dual crisis: untreated addiction and undiagnosed HIV.

The problem is much bigger and the provision of the testing vans is a small step in this direction. Our focus should be on a targeted public awareness campaigns that reach rural areas, schools, and religious platforms. Also important is training the healthcare workers to treat HIVpositive patients with dignity. That said, it is not easy to break the break the stigma. Much more so, in a deeply conservative society like ours. This is why, addressing is not just the job of the government, the community leaders also need to play an important role.

Kashmir's Risky Rush

The valley's early stock market dreams crashed before they steadied.

ashmir arrived late to the stock market, but when it did in the early 2000s, it arrived in a rush. Online trading pulled in a wave of first-time investors who jumped in fast and heavy. Many bet big without understanding what they were buying.

People threw in ten lakh rupees to control stocks worth a crore, chasing tiny profits. They played close to the edge, where even small market dips could burn them. And often, they did.

The valley's first brush with the market was driven more by instinct than by skill. Greed and fear traded places every day. Investors watched global events—wars, oil prices, elections move their fortunes in ways they couldn't predict. Some panicked and sold at losses. Some held on and lost more.

Those who lasted began to see what the market really was: a cycle, not a straight line. Stocks rise and fall, but they don't stay down forever. Still, they learned this the hard way.

The smartest ones stopped betting everything on stocks. They turned to gold, international funds, government bonds anything that could steady the ride. They built safer, slower portfolios. It wasn't just strategy; it was survival

But the hardest fight was never with the market. It was with themselves. Holding steady when prices crash, walking away from greed, waiting through the slow days are skills the valley's investors had to learn on their own.

Kashmir's market story is not about overnight success. It's about the cost of impatience and the slow making of discipline. The early rush has settled, but the lessons linger

Wealth, the valley is starting to see, is not found in the sprint.

It's built in the long, steady walk.

The New Apple Game

High-density apple farming is transforming lives in Kashmir, but without proper checks, the dream risks turning sour.

omething remarkable is unfolding in Kashmir's orchards. In a land where patience was once the price of survival, apple farmers are finally witnessing a shift that promises faster returns, better produce, and a real escape from decades of low profits.

This change is called high-density apple farming, and it is reshaping the economic future of the valley.

But like every new promise in Kashmir, this one comes with its own set of risks. And if we are not careful, the very thing lifting our farmers today could harm them tomorrow

I have spent over a decade in apple farming, moving from the old world of traditional orchards to the faster, sharper world of high-density planting. I have lived both stories. I know what it feels like to wait more than ten years for a tree to bear fruit, only to find the apples small, pale, and difficult to sell.

Traditional apple trees in Kashmir are giants, stretching high into the sky, but they take far too long to produce anything meaningful. Many of us poured money into pesticides and sprays, only to walk away with shrinking profits.

The numbers were against us. Each kanal of land under the old system could only support 20 to 25 trees. Add to that the problem of alternate bearing, one good year, one bad year, and the weight of uncertainty became too much to carry. Farming families who had stuck with apples for generations found themselves trapped in a losing game.

High-density farming broke that cycle.

These new apple plants, grown on imported dwarf rootstocks like M9, remain short, easy to manage, and start bearing fruit in the first or second year.

One kanal can now hold 150 trees. The turnaround is rapid, and the rewards are clear. Most of the apples grown in these orchards are now grade-one, the best you can get in the market.

The size, the colour, the taste has improved. I have seen this shift with my own eyes.

Today, a single kanal of high-density apples can earn a farmer 1.5 lakh a year, even after paying for labour and chemicals. For people like us, that is not just profit, it is survival.

The change has been dramatic. More young people are stepping into apple farming, seeing it as a modern profession with real earning potential. In a region like ours, where unemployment casts a long shadow, this is no small thing. For the first time in years, apple farming is drawing people back to the land instead of pushing them away.

The government has played an important role. Through schemes that support high-density planting and by encouraging partnerships with private suppliers, they have helped spread this movement across the valley.

European apple varieties like Gala, Schinico, Red Velox, and Jeromine have settled well into Kashmir's climate. Farmers who once feared the long wait are now planting with confidence.

But this success story has a dangerous blind spot. The rapid import of apple plants has flooded our markets with unchecked material. Many of these plants have arrived without proper inspection and have brought new diseases with them, like crown rot, collar rot, and other infections that were once rare in Kashmir.

If we ignore these warning signs, we could face an outbreak that would tear through our orchards and destroy the very gains we are now celebrating

Seven lakh families in Kashmir depend on the apple economy. It is not a side story. It is the backbone of life here. And yet, the rules meant to protect this industry seem alarmingly loose.

Imported plants are slipping through the cracks without serious quarantine, while healthy, disease-free plants grown in local nurseries are often overlooked. This is not just bad policy. It is a direct threat to the future of our apple industry.

We should not have to choose between faster profits and long-term safety. We need stricter checks at the entry points. Every imported plant should be properly quarantined and cleared before it reaches farmers.

Local nurseries, like the ones I run, have the capacity to produce high-quality, diseasefree plants. Yet they remain underused, even though they offer safer, sustainable options.

The truth is that high-density apple farming has already proven it can bring faster growth, better jobs, and real income to Kashmir's farmers

It is building stronger families, stronger markets, and a stronger connection to the land. But if this progress is to last, we need to be smarter about what we allow into our soil.

Our apple revolution deserves more than fast solutions. It deserves protection. It deserves policies that put farmers first. It deserves to grow safely, for the long haul.

ashmiris like to believe they're beyond caste, that their society is free of such divisions.

But the truth is that caste and class discrimination are alive in Kashmir, shaping marriages, friendships, and social networks. We just don't admit it.

This prejudice is not loud. It does not always come with slurs or public humiliation. It is soft, folded into polite rejections and measured silences.

It happens in family meetings where a potential match is dismissed because the person is from a rural village. It happens when a girl's proposal is turned down because her father doesn't hold a government job. It happens when a boy is seen as "unsuitable" because his family does not carry the right surname, even if his character shines.

The tragedy is not just that this happens. It's that it happens, and people pretend it doesn't.

Many Kashmiris wear the mask of progress. We praise education. We quote verses about equality. We claim that our society has outgrown the shadows of caste. But these are words. Behind closed doors, decisions are still made based on caste and class, even when they are dressed in new language.

In modern Kashmir, caste often hides behind class. It is easier now to judge people not by what caste they belong to, but by where they work, where they live, or where they studied.

Families take pride in their connections, their addresses in the city, and their relatives abroad. People with government jobs or foreign degrees are considered superior, as though wealth or urban life alone proves refinement.

But this is not refinement. It is just caste wearing a different coat. One of the more insidious ideas is khaslat — the belief that some

people are born with inherently 'good qualities," that virtue runs in families like blood.

It is a dangerous idea that turns away decent, kind, capable people simply because they do not come from the "right" family. It gives caste and class an invisible power. It says to people: No matter what you achieve, no matter who you are, you can never really belong.

This belief plays out most sharply in marriage decisions.

In Kashmiri homes, marriage is often less about love, compatibility, or faith, and more about family background. A girl from a village no matter how educated or virtuous, is often rejected. A boy without a prestigious job is quickly deemed inadequate. Parents talk of social status, family "standard," and community image. They say they want the best for their children, but what they really want is to preserve their standing.

Marriage becomes a kind of business negotiation, a transaction where human worth is weighed against material and social measures. The result is painful. People are reduced to checklists. Relationships are shaped not by the goodness of hearts, but by the size of houses and the reach of surnames.

And yet, if you ask around, many people will tell you that caste discrimination is not a problem here. They will say that Islam has no caste. They will say that Kashmiris have moved beyond this. But the gap between what people say and what people do is wide.

It is easier to deny casteism when it happens in subtle ways. There are no protests in the street when a marriage proposal is turned down because someone comes from the "wrong" village. There are no social penalties when families quietly reinforce these lines. And because there is no open fight, many pretend there is no problem.

But the silence itself is the problem. When people deny caste and class discrimination while practicing it in their daily lives, the prejudice is able to thrive unchecked.

This is not just a social issue. It is a moral one. Islam came to Kashmir with a message that could not be clearer: human beings are equal in the eyes of God. The Quran tells us that we were made into nations and tribes so we may know one another, not so we may judge each other.

The Prophet Muhammad (peace be upon him) broke every wall of social superiority. He married across tribes. He raised the status of the poor and the marginalized. He chose his companions from all backgrounds

The Prophet did not ask, "What is your caste?" He asked, "Who has tagwa?" — who has sincerity, goodness, and inner faith. And yet many Kashmiris hold

on tightly to their caste and class pride, as if it is a badge of honour. They claim to follow the Prophet while defending the very divisions he spent his life trying to erase. This is not just a contradiction. It is a betrayal.

We cannot continue to talk about unity while building invisible walls. We cannot speak of brotherhood while preserving social ladders. If we truly want to live the values we preach, we must make real choices. We must reject caste and class as measures of human worth. We must see people as people, not as labels, not as family names, not as income brackets.

Change will not come from slogans. It will come from the decisions families make at their din ing tables, from the choices young people make when they challenge their elders, from the courage to value kindness over khandaan, and character over class.

Our community leaders, scholars and teachers must speak about this, directly and without hesitation. Our young people must refuse the social inheritance that says who they can and cannot marry, who they can and cannot befriend, who they can and cannot become.

Kashmir stands at a turning point. We can choose to stay trapped in a social script written long before us, or we can write something new. If we do not, we will carry these old chains into a future that deserves better.

It is time to set them down.

In Kashmir's Rush to Succeed, a Pause Is Missing

pressure on Kashmiri kids rarely speaks its name. It shows up in the drooping shoulders, the restless eyes, the growing silence inside our classrooms.

I see it every day as a schoolteacher. Our students sit still for long hours, carrying more than just books. They carry invisible weight. The fear of falling behind, the stress of constant comparison, and the ache of not knowing how to slow down.

The pace of school life in Kashmir has quickened. Between academic pressure, social expectations, and the creeping pull of digital screens, our students are left with little room to move, to pause, or to simply breathe.

They spend their days running toward the next exam, the next mark. the next competition, and somewhere along the way, they begin to drift from their own well-being.

I believe yoga can offer them something they have lost: a space to return to themselves.

Yoga, in its simplest form, fits into the slow, thoughtful rhythm of Kashmir. It is not a race. It does not demand that some children win while others lose. It welcomes every child, whether they are athletic or not, whether they are confident or still finding their place.

Yoga helps students move gently, stretch with purpose, and begin to notice their own breath again.

But its greatest offering is not just physical strength. It is emotional steadiness Kashmiri children grow up

learning to hold many things inside - fear, anger, frustration. Yoga gives them a soft, steady way to meet these feelings without being overwhelmed.

I have seen students become more patient, not only with others but with themselves. I have seen them sit through their worries with a little more courage, and return to their studies with a calmer mind.

This matters in a place like ours, where life can shift suddenly, and where uncertainty often lingers in the background.

There is also growing evidence to

support what teachers in Kashmir are witnessing: students who practice yoga regularly tend to focus better, attend school more consistently, and show genuine curiosity in their learning.

Yoga is not a complete answer to all the pressures our children face. But it can be a simple, steady tool a soulful space they can carry with them, wherever life takes them.

If we want our classrooms to build not just bright minds but balanced hearts, perhaps it is time we make room for this.

In Muharram's Heat, Kashmir Offers Water and Remembrance

Across Kashmir, the centuries-old tradition of Sabeel-e-Hussain continues to unite communities, offering water and compassion in memory of sacrifice.

s Muharram begins, the streets of Kashmir come alive with a familiar sight: wooden stalls, steel tubs, plastic glasses stacked in rows, and young volunteers calling out to passersby to stop for a drink.

These are Sabeel-e-Hussain, the water stalls that appear each year as symbols of service and remembrance.

The tradition runs deep. It honours Imam Hussain (A.S.) and his companions, who faced unbearable thirst under the blazing sun of Karbala.

In Kashmir, where Muharram often arrives with days of relentless heat, sometimes crossing 35°C, the Sabeels offer more than water. They offer belonging.

In downtown Srinagar, near the old Imambaras, teenage boys in black kurtas scoop sherbet into glasses and offer them to strangers passing by. Women bring out cold water and juice from their homes. Little children carry buckets to refill the stalls. The rhythm is steady. No one is turned away.

The sound of Noha Khwani, the sorrowful chants of Karbala, rises from processions that move through the city, sometimes lasting 12 hours a day.

Amid the slow steps of mourners, the Sabeels stand firm. People stop, drink, rest, and

What makes this tradition stir the heart is its open door. There are no divisions here. In the lanes of Zadibal, in the alleys of Budgam, people from all walks of life step forward to



Sunni Muslims donate supplies, help with

logistics, and serve at Langars, where free meals of rice and lentils are shared without

question. The walls that often divide the community seem to dissolve at these stalls.

In a place where differences sometimes run deep, Muharram brings a different kind of pulse to the valley. It is a time when serving water becomes an act of devotion, when offering food becomes a way to heal.

The Sabeel is not just a Kashmiri custom. It is tied to the earliest lessons of Islam.

The Prophet Muhammad (PBUH) called the offering of water a sacred duty. For centuries, people built wells for travellers and handed glasses to the thirsty. Over time, the Sabeel-e-Hussain became a

way to remember not just the pain of Karbala, but the responsibility to care for one another.

In today's Kashmir, where modern life often races ahead and old ties can feel strained, these water stalls still draw people back to something essential.

In the simple act of passing a glass, something larger is preserved: a history, a faith, a shared humanity.

Each year, as the crescent moon marks the arrival of Muharram, the valley prepares itself. The black flags go up. The mourners gather. And the Sabeels rise, one after another, across towns and villages, holding steady

In the end, the story of these stalls is not just about loss. It is about what survives. It is about the spirit that moves a teenager to pour water for a stranger, that brings neighbours together over a pot of rice, that holds communities firm in their grief and their giving.

The Right to Switch Jobs Shouldn't Be Up for Debate

A recent ruling challenges a growing global trend: companies using contracts to trap workers.

cross the world, employers are tight-Aening their grip on workers. In the United States, non-compete agreements have come under fire for limiting job mobility and suppressing wages. In Europe, courts are questioning whether companies can enforce long-term restrictions on where employees can work after they leave. And now, in India, a landmark judgment has added its voice to this growing pushback against employment contracts that

The Delhi High Court has ruled decisively: workers cannot be forced to choose between returning to their old jobs or staying unemployed.

The case involved Varun Tyagi, a software engineer who had worked on India's critical POSHAN Tracker—a government project aimed at improving child nutrition.

After finishing his notice period with Daffodil Software, Tyagi joined the government agency that owned the project. But his former employer quickly took him to court, citing a contract clause that barred him from working with any of their business partners for three years.

A lower court initially blocked Tyagi from continuing his new job. But the Delhi High Court stepped in and struck down that decision.

Justice Tejas Karia made it clear: contracts that lock employees out of future jobs, especially when no trade secrets or proprietary assets are involved, cannot stand. "An employee cannot be confronted with the situation where he has to either work for the previous employer or remain idle." the court said.

The ruling is a significant step not just for

India, but for the global fight against overreaching employment contracts. Around the world, workers are being squeezed by clauses that limit their future choices.

In the U.S., non-compete agreements are so widespread that even low-wage workers in fast food and retail have been restricted from moving to competing businesses. The Federal Trade Commission recently proposed a ban on such agreements, recognizing the damage they do to economic

The Delhi case taps into the same concern. It reinforces the idea that a company's desire to protect its business cannot come at the cost of a worker's right to earn a living.

Tyagi wasn't taking any sensitive information with him. The government already owned the project he had worked on. Daffodil Software's attempt to block him wasn't about protecting trade secrets. It was about controlling where he could go next.

Employment contracts that try to chain workers to their former employers aren't just a legal issue. They are a question of fairness and dignity. They decide whether people are free to grow in their careers, or whether they can be boxed in by fine print.

This judgment sends an important message: restrictive job contracts that limit where people can work after they leave are not acceptable.

In an era of fast-changing industries, where skills and opportunities move quickly, employees must have the freedom

The right to switch jobs should not be a privilege. It is, and must remain, a right.

How Do People Get Started In The Gym, Here's What The Research Says

o you've never been to a gym and are keen to start, but something's holding you back. Perhaps you don't know what to actually do in there or feel like you'll just look stupid in front of everyone. Maybe you're worried about injuring yourself.

It's OK. Everyone starts somewhere. I did. too.

Resistance exercise (such as weight lifting) is really good for your health. Benefits include a reduced risk of osteoporosis-related fractures, reduced risk factors for chronic diseases such as diabetes, better sleep, improved mental health and, of course, stronger and bigger muscles.

So, how do people get started in the gym? Here's what you need to know, and what the research says.

Worried about injury?

Don't be. It's probably less risky than lots of other forms of exercise you might already do or did in the past.

Team sports such as rugby and soccer, and strength-based sports such as powerlifting, weightlifting, and cross fit all have similar injury rates. They're all in the vicinity of three to four injuries per 1,000 hours of participation.

Going to the gym has almost half this rate of injuries, at about 1.8 per 1,000 hours.

Let's put that into context.

If you go to the gym three times per week for a one-hour session – and you do that every week of the year – you achieve approximately 156 hours of resistance training exercise a year.

So if the injury rate is about 1.8 injuries per 1,000 hours, that means that you could exercise for years in the gym without even a little niggle! Some groups, such as young men under 40, may be at a greater risk of injury in the gym. So if that's you, you may want to be a little more conscious about how fast you progress, and the types of exercises you do in the gym.

Compare these injury risk stats to the known risks of sedentary lifestyles, and the worry should go out the door.

In short, it's a lot more dangerous to be sedentary than it is to go to the gym.



OK, how do I get started?

It's fine to begin with what you feel most comfortable with. You don't have to go straight to a ridiculously complex or challenging program.

However, that doesn't mean you don't need to put in the effort!

Most gyms can start you off by designing a workout program for you (you might have to pay for a personal training session). If you have a medical condition, find an accredited exercise physiologist. They're trained to help you exercise safely.

It's OK to start with gym machines, which are designed to make it easier to keep your movements consistent.

But keep your mind open about trying the free weights section (where the dumbbells, barbells and mirrors are). Benefits from this type of training may vary from what you get via machines.

That's because a lot of the moves you do with free weights are what's called compound exercises, meaning they work a lot of muscles and joints together at the same time. They're really good for you. Examples of compound exercises include: squats, lunges, deadlifts, bench presses, hip thrusts, kettle bell swings.

How much should I do in the gym?

Standard government physical activity recommendations state you should do muscle strengthening twice

If you are new to the gym, you can make progress with a minimalist approach. For example, you may choose to only lift once or twice per week, compared with many seasoned gymgoers who might lift four or five times per week.

Recent research shows even those people already consistently lifting in a gym can maintain or slowly improve by doing just two sessions per week, in which each exercise is only performed for one set and the whole session lasts just 30 minutes or so.

so if you can stick to one hour per week (made up of two challenging halfhour sessions) then you will still be making progress.

How do I make my habit stick?

Sticking to the habit after the novelty has worn off is where many come unstuck.

Some research suggests it takes six weeks to form a gym habit, and that the more frequent the attendance in those first six weeks, the more likely the habit will stick.

At the one-year mark, the biggest predictor of regular attendance (de-

fined as twice per week) was enjoyment. This was followed closely by the concept of self-efficacy (believing in yourself and your ability to stick to it), and social support.

This is really important.

Find what you like about the gym. Train the way that you enjoy. Find a friend to join the gym with. That will help you create the habit.

From there, you can progress the types and intensity of gym exercises

I feel like a duck out of water Every gym-goer felt this at first. I

did too.

The confusion about which bit of the machine to sit on, pull, or push, is a tad overwhelming. The sense of secu-

rity in sticking to the familiar, shying away from the free weight area.

Remember: everyone is there to improve themselves and is on their

own journey.

Most people won't even notice that you are there, and most experienced gym-goers will be delighted to help if

you're unsure.

If that's not your experience at your local gym, perhaps look for a new and more welcoming environment.

Not all gyms and gym cultures are created equal.

China's Humanoid Robots Generate More Soccer Excitement Than Human Counterparts

While China's men's soccer team hasn't generated much excitement in recent years, humanoid robot teams have won over fans in Beijing based more on the AI technology involved than any athletic prowess shown.

Four teams of humanoid robots faced off in fully autonomous 3-on-3 soccer matches powered entirely by artificial intelligence on Saturday night in China's capital in what was touted as a first in China and a preview for the upcoming World Humanoid Robot Games, set to take place in Beijing.

According to the organisers, a key aspect of the match was that all the participating robots operated fully autonomously using AI-driven strategies without any human intervention or supervision.

Equipped with advanced visual sensors, the robots were able to identify the ball and navigate the field with agility

They were also designed to stand up on their own after falling. However, during the match several still had to be carried off the field on stretchers by staff, adding to the realism of the experience.

China is stepping up efforts to develop AI-powered humanoid robots, using sports competitions like marathons, boxing, and football as a real-world proving ground.

Cheng Hao, founder and CEO of Booster Robotics, the company that supplied the robot players, said sports competitions offer the ideal testing ground for humanoid robots, helping to accelerate

the development of both algorithms and integrated hardware-software systems.

He also emphasised safety as a core concern in the application of humanoid robots.

"In the future, we may arrange for robots to play football with humans. That means we must ensure the robots are completely safe," Cheng said. "For example, a robot and a human could play a match where winning doesn't matter, but real offensive and defensive interactions take place. That would help audiences build trust and understand that robots are safe."

Booster Robotics provided the hardware for all four university teams, while each school's research team developed and embedded their own algorithms for perception, decision-making, player formations, and passing strategies—including variables such as speed, force, and direction, according to Cheng.

In the final match, Tsinghua University's THU Robotics defeated the China Agricultural University's Mountain Sea team with a score of 5–3 to win the championship.

Mr. Wu, a supporter of Tsinghua, celebrated their victory while also praising the competition. "They (THU) did really well," he said. "But the Mountain Sea team (of Agricultural University) was also impressive. They brought a lot of surprises."

China's men have made only one World Cup appearance and have already been knocked out of next years' competition in Canada, Mexico and the United States.

Govt Keeps Interest Rates On Small Savings Schemes Unchanged For Q2

NEW DELHI- The government on Monday left interest rates unchanged for various small savings schemes, including PPF and NSC, for the sixth straight quarter beginning July 1, 2025.

The rates of interest on various Small Savings Schemes for the second quarter of FY 2025-26 starting from 1st July, 2025 and ending on 30th September, 2025 shall remain unchanged from those notified for the first quarter (1st April, 2025 to 30th June, 2025) of FY 2025-26," the finance ministry said in a notification.

As per the notification, deposits under the Sukanya Samriddhi scheme will attract an interest rate of 8.2 per cent, while the rate on a three-year term deposit remains at 7.1 per cent prevailing in the current quarter.

The interest rates for popular Public Provident Fund (PPF) and post office savings deposit schemes, too, have been retained at 7.1 per cent

and 4 per cent, respectively.

The interest rate on the Kisan Vikas Patra will be 7.5 per cent, and the investments will mature in 115 months.

The interest rate on the National Savings Certificate

(NSC) will remain at 7.7 per cent for the July-September 2025 period.

Like the current quarter, the monthly income scheme will earn 7.4 per cent for investors during the second quarter of the current fiscal year.

With this, the interest rates on small savings schemes, majorly operated by post offices and banks, have been left unchanged for the sixth consecutive quarter. The government had last made changes in some schemes for the fourth quarter of 2023-24.

Bank GNPAs Decline To Multi-Decadal Low Of 2.3% In March, May Inch Up By March 2027: RBI Report

MUMBAI- The gross non-performing assets (NPAs) of the banking system declined to a multi-decadal low of 2.3 per cent in March 2025, the

Reserve Bank said on Monday. The GNPA level for all the scheduled commercial banks had stood at 2.8 per cent in the year-ago period and 2.6 per cent in September 2024.

In the half-yearly The Re serve Financial Stability Report, the Reserve Bank of India (RBI) said the GNPAs for 46 banks accounting for 98 per cent of the total assets of scheduled commercial banks (SCBs), may rise to 2.6 per cent by March 2027.

It can be noted that dud assets have been one of the most challenging part for the banking system for a large part of the latter part of last decade especially due to stress among corporate segment, but the system has been improving on

the key ratios ever since. Given the prevalent tendencies among banks to evergreen loans or not recognise NPAs at all, the Reserve Bank had to step in and force lenders to recognise certain loans as non-performing through the asset quality review.

As the state-run lenders had



money as a result of the same.

The level of the GNPAs at shadow banks, or NBFCs, was at 3 per cent across types in March 2025, the FSR said, adding that for a sample set of lenders commanding a major share of assets under management, the same will go up to 3.3 per cent in March 2026 from 2.9 per cent in March

The FSR said loan write-offs, including the technical writeoffs which can be recovered in the future, were one of the prime reasons for the reduction in GNPAs at banks over the last five years.

As per the FSR, write-offs to GNPA ratio for SCBs moved up to 31.8 per cent in FY25 from

year, led by private sector lenders and foreign banks, and added that write-offs by PSBs exhibited a marginal decline.

The half-yearly slippage ratio, measuring new accretions to NPAs as a share of standard advances at the beginning of the half-year, remained stable at 0.7 per cent.

From a sectoral perspective, the agricultural sector had the highest contribution to GNPAs at 6.1 per cent, while it was broadly stable on the personal loans side at 1.2 per cent.

However, public sector banks' GNPAs from the credit card segment moved up to 14.3 per cent as against 2.1 per cent in the case of the private sector rivals.



CS Sets The Tone For Transforming Rural Women Into Successful Entrepreneurs

SRINAGAR- In a move to empower rural women and foster self-reliance, Chief Secretary Atal Dulloo Monday chaired a meeting to review the performance of the Jammu & Kashmir National Rural Livelihoods Mission (NRLM) here with the prime objective of transforming women registered with NRLM across the UT's rural areas into successful entrepreneurs.

On this occasion Dulloo emphasized the immense potential of this tremendous human resource of around 7 lakh women calling for their intensified social mobilization and capacity building efforts to ignite a powerful movement of self-reliance among them.

The Chief Secretary further issued a slew of directives aimed at bolstering the economic independence of women Self-Help Group (SHG) members. He directed the registration of Cluster Level Federations (CLFs) with the Cooperative Department under the Cooperative Societies Act, strengthening their organizational framework.

Dulloo also enjoined upon the NRLM to aggressively enhance credit linkage for 55 HGs. aiming to reach at least 75,000 linkages by the end of October this year. The Chief Secretary stressed the need to bridge the existing gap of 16,000 linkages through focused efforts and active support from financial in-

Recognizing the substantial number of literate SHG members (around 3 lakh), Chief

Secretary Dulloo directed the MD, NRLM, to ensure they are skilled and trained. This will be achieved by linking them with the online Daksh Kisan Courses offered by the Agriculture Production Department, thereby increasing their chances of sustainable livelihoods.

In order to create successful entrepreneurs, he directed the organisation to link the members with the HADP of the Agriculture Production Department or with Mission YUVA of the Skill Development Department to achieve the set objective successfully.

On this occasion the Chief Secretary highlighted that mere formation of Farmer Producer Organizations (FPOs) is not enough; their credit linkage and production must be the primary focus to ensure they become successful enterprises.

He emphasized optimal utilization and establishment of Community Managed Training Centres (CMTCs) across all 20 districts of the UT. Assistance from J&K Bank, NABARD, and other institutions, along with agreements with OMPLIS, shall be sought for comprehensive training of registered SHG members, he emphasized.

Dulloo also advised the Finance Department to prioritize the enrolment of all SHG members under social security schemes like PMSBY and PM-JJBY. Furthermore, this 7 lakh strong human resource should be leveraged by the Finance Department to raise awareness about these schemes during an upcoming 3-month long campaign across the UT,

Indian Economy Remains Key Driver Of Global Growth: RBI Report

MUMBAI- Indian economy remains a key driver of global growth on the back of sound macroeconomic fundamentals and prudent policies, the Reserve Bank said on Monday.

In its bi-annual Financial Stability Report (FSR), the central bank also said elevated economic and trade policy uncertainties are testing the resilience of the global economy and the financial system.

"Financial markets remain volatile, especially core government bond markets, driven by shifting policy and geopolitical environment. Alongside, existing vulnerabilities such as soaring public debt levels and elevated asset valuations have the potential to amplify fresh shocks," the Reserve Bank of India (RBI) said.

Despite an uncertain and challenging global economic backdrop, it said the Indian economy remains a key driver of global growth, "underpinned

by sound macroeconomic fundamentals and prudent macroeconomic policies".

"The domestic financial sysem is exhibiting resilience fortified by healthy balance sheets of banks and non-banks. Financial conditions have eased supported by accommodative monetary policy and low volatility in financial markets. The strength of the corporate balance sheets also lends support to overall macroeconomic stability," the RBI said.

According to the report, the soundness and resilience of scheduled commercial banks (SCBs) are bolstered by robust capital buffers, multi-decadal low non-performing loans ratio and strong earnings.

Results of macro stress tests affirm that most SCBs have adequate capital buffers relative to the regulatory minimum even under adverse stress scenarios. Stress tests also validate the resilience of mutual funds and clearing corporations, it

Fiscal Deficit Slips To 0.8% Of **Full-Year Target At May-End** 2025: CGA Data

NEW DELHI- The central government's fiscal deficit fell to 0.8 per cent of the full-year target at the end of May, mainly due to a whopping Rs 2.69 lakh crore dividend received from the Reserve Bank of India.

The fiscal deficit, or gap between the government's expenditure and revenue, had touched 11.9 per cent of the Budget Estimates (BE) for 2025-26 or Rs 1.86 lakh

Following the RBI's dividend payout, the Centre's fiscal deficit was reduced to 0.8 per cent of BE of 2025-26 or Rs 13,163 crore, the data released by the Controller General of Accounts (CGA) showed.

The Centre estimates the fiscal deficit during 2025-26 at 4.4 per cent of the GDP or Rs 15.69 lakh crore. It stood at 3.1 per cent of BE of 2024-25 in the first two

months of the previous financial year.

According to the CGA, the amount the government received under the head 'dividends and profits' was Rs 2.78 lakh crore or 86 per cent of the BE.

The data on monthly accounts showed that the Government of India received Rs 7.32 lakh crore, 21 per cent of corresponding BE 2025-26 of total receipts, up to May 2025.

Industrial Output Growth Slows To 9-Month Low Of 1.2% In May

NEW DELHI- India's industrial production growth slowed to a nine-month low of 1.2 per cent in May 2025 due to poor performance of manufacturing, mining and power sectors caused by the early onset of Monsoon, according to official data released on Monday.

The factory output, measured in terms of the Index of Industrial Production (IIP), had expanded by 6.3 per cent in May 2024.

The National Statistics Office also revised downward the industrial production growth for April to 2.6 per cent from the earlier estimate of 2.7 per cent released

The previous low was observed in August 2024 when IIP remained unchanged.

The NSO data showed that the manufacturing sector's output growth decelerated to 2.6 per cent in May 2025 from 5.1 per cent in the year-ago month.

Mining production contracted by 0.1 per cent against a growth of 6.6 per cent a year ago. Power production declined by 5.8 per cent in May 2025 against 13.7 per cent growth in the year-ago period.

During the April-May period of FY26, industrial production grew by 1.8 per cent compared to 5.7 per cent

Over 2.3 Million Users Shielded From Online Fraud In J&K In Just 47 Days: Airtel

Drones Can Safely Deliver Blood In Tough Terrains: ICMR Study

New Delhi: An Indian Council of Medical Research (ICMR) study has confirmed that drones can safely transport blood without compromising its quality, offering a promising solution for remote and hard-to-reach areas.

In the trial, a drone covered 36 km in just 8 minutes—significantly faster than a van, which took 55 minutes for the same distance. The study found that key blood parameters and temperature remained stable during drone transport, proving it comparable to traditional delivery methods.

Titled "Adopting drone technology for blood delivery", the study emphasized the critical need for cold-chain integrity in blood transportation. Blood, if exposed to unsuitable

temperatures, can undergo hemolysis or bacterial contamination, both of which can be fatal.

Conducted between May and July 2023—when ambient temperatures ranged between 30–40°C—the study documented the operational and logistical challenges encountered while ensuring biochemical stability in real-world conditions.

The research aligns with global findings from Rwanda,

Italy, and parts of Southeast Asia, where drones have helped overcome logistical hurdles in healthcare delivery, especially during emergencies.

With proper planning, drones could soon be used to deliver emergency drugs, vaccines, and other time-sensitive medical supplies, the study noted. However, it also called for further studies to address operational challenges and regulatory aspects before widespread adoption.

Credit Card Transaction Revisions Several major banks are revising their credit card terms and charges:

SBI is discontinuing its air accident insurance on selected premium cards, including SBI Elite, Miles Elite, and Miles Prime, when used for air ticket purchases. The bank is also expected to introduce a new Minimum Amount Due (MAD) calculation for monthly bills.

HDFC Bank will implement new transaction fees. A one percent transaction fee, capped at ₹4,999 per transaction, will apply if you use your card to pay rent or spend over ₹10,000 on online skill-based games. The same fee will also be levied on utility payments exceeding ₹50,000 monthly, with insurance transactions being an exception. Additionally, loading over ₹10,000 into a digital wallet in a single transaction will incur a one percent fee, also capped at ₹4,999.

ICICI Bank is revising various service charges, including those for ATM transactions. The first five transactions at ICICI Bank ATMs remain free, after which cash withdrawals will cost ₹23 per transaction. For non-bank ATMs, the free transaction limit is three for Metro cities and five for smaller cities; beyond this, charges of ₹23 and ₹8.5 per transaction, respectively, apply. International ATM cash withdrawals will be charged at ₹125, non-financial transactions at ₹25, plus a 3.5% currency conversion fee. Charges for online transfers via IMPS have also been revised sharply, ranging from ₹2.5 to ₹15 depending on the amount transferred. Furthermore, customers will get three free cash transactions per month at Cash Recycler Machines (CRMs), after which a ₹150 fee per transaction will apply. Cash deposits exceeding ₹1 lakh a month will incur a fee of ₹150, or ₹3.50 per ₹1,000 (whichever is higher), with the third-party cash deposit limit remaining ₹25,000 per transaction.

Train Tickets

The fares of suburban trains and monthly season tickets have been left unchanged in the interest of daily commuters.

The ordinary second-class fare has not been increased for up to 500 km and for distances beyond that, there is an increase in the ticket prices by half a paisa per km.

The passengers of ordinary sleeper

The passengers of ordinary sleeper class and first class will also have to pay half a paisa more per km more from July 1.

"The fare revision also applies to premier and special train services, such as Rajdhani, Shatabdi, Duronto, Vande Bharat, Tejas, Humsafar, Amrit Bharat, Mahamana, Gatimaan, Antyodaya, Jan Shatabdi, Yuva Express, AC Vistadome coaches, Anubhuti coaches and ordinary non-suburban services, in accordance with the revised class-wise fare structure," the ministry said in a press

"Revised fares will apply to tickets booked on or after 01.07.2025. Tickets issued before this date will remain valid at the existing fare without any fare adjustment. PRS, UTS and manual ticketing systems are being updated accordingly," it added.

According to the ministry, there is no change in ancillary charges. For instance, the reservation fees, superfast surcharges and other charges have remained unchanged.

Similarly, the Goods and Services Tax (GST) will continue to be charged in accordance with the applicable rules and the fare-rounding principles will remain as per the existing norms.

He emphasized that the event is not a one-off showcase.

"Under the scheme, we are committed to organizing six regular Buyer-Seller Meets and six reverse meets. These will ensure sustained engagement and provide deeper market access for our artisans and entrepreneurs," he said.

Underscoring the importance of inclusivity, the Chief Minister urged the Industries Department to prioritise artisans and entrepreneurs who have not yet had the opportunity to participate in such platforms, particularly those with limited financial means. "They have the skill and the product, but lack exposure. If we bring them into the fold, we can address many challenges related to marketing and reach," he said.

He further stressed that the real benefits of such initiatives must directly reach the artisans themselves.

"We must ensure that no one else takes credit or benefit for the work done by our craftspeople. The recognition and rewards must go to the actual creators," CM Omar said.

Calling for innovation and adaptation, the Chief Minister said that artisans need to modernise—not just in design and product development, but in processes and infrastructure as well. "Consumer tastes are constantly evolving, and if we remain rigid, we risk falling behind. of casting a shadow, the tragedy appears to have ignited a deeper resolve among pilgrims.

At the Jammu registration centre near the railway station, chants of "Bam Bam Bole" and "Jai Baba Barfani" echoed as long queues formed. Many pilgrims insisted on taking the traditional 48-km Pahalgam route, despite it being longer and more arduous than the Baltal track, to honour those killed in the attack.

"This time, the yatra is more than just a pilgrimage—it's a message to terrorists that we are not afraid," said Mumta Deshmukh, who had traveled overnight to be part of the first batch.

The 38-day Yatra to the 3,880-metre-high Amarnath cave shrine will officially begin on July 3 via the twin tracks—Nunwan-Pahalgam in Anantnag and Baltal in Ganderbal. The first batch will depart from the Jammu-based Bhagwati Nagar base camp on July 2.

Authorities have made elaborate security arrangements along both routes. Yet for many yatris, especially those arriving from states like Maharashtra, West Bengal, Assam, Gujarat, and Uttar Pradesh, the emotional weight of choosing Pahalgam is overriding any concern about safety.

"This will be our tribute to the martyrs of April 22," said Sarita Ghosh from Kolkata, part of a 95-member group. "By walking through Pahalgam, we are reclaiming the space from fear."

Nirohotum Kumar from Assam said, "What happened in Pahalgam was tragic, but we are here with full faith. No one can instill fear of death in us."

Some pilgrims, however, expressed frustration over the limited daily quota of 2,000 tokens for on-the-spot registration. Many had queued for hours, only to be turned away.

"The government should consider issuing tokens for the next day too, so people don't have to go through this daily struggle," said Joginder Singh from Uttar Pradesh, who waited over four hours with his group of eight but couldn't get a token.

Scuffles broke out between disappointed pilgrims and police as tempers flared. Authorities have now announced that three more offline registration centres—Vaishnavi Dham, Panchayat Bhawan, and Mahajan Hall—will begin functioning from Tuesday. (inputs from PTI)

Call On Bumrah Soon But Two Spinners Will Play

BIRMINGHAM: A call on premier pacer Jasprit Bumrah playing the second Test will be taken in the next 24 hours but India assistant coach Ryan ten Doeschate is pretty sure that his team will take the field with two spinners at Edgbaston.

There is a growing clamour to include wrist spinner Kuldeep Yadav in the playing eleven but to maintain the batting depth, Washington Sundar is also in the mix to start alongside Ravindra ladeia.

All three spinners bowled in the nets on Monday.

Bumrah, who would be playing three out of five Tests in the series as part of workload management, held a two coloured ball (red and white) at the start of the training session before picking up the Dukes ball to bowl only towards the end of the session.

He bowled roughly three overs, unlike teammates Mohammed Siraj, Akash Deep and Prasidh Krishna, who bowled a lot upfront.

With 0-1 down, India find themselves in a conundrum over picking Bumrah's three Tests.

"He's available for the game obviously. We know from the start he's only going to play three out of the five. He's had eight days to recover from the



last test," said Doeschate

"But given conditions and workload and how we think we can best manage for the next four games, we haven't made a call on that. We're going to see what the other guys are with their workload as well.

"If we feel like there's value in playing him in this Test, we'll make that call at the very last minute. But I'm talking about weather, how the pitch is going to play. Are we better off holding

him back for Lord's and maybe Manchester or the Oval? So it's all those factors."

Is it tempting to include Bumrah given India are trailing in the series?

"It is, but we also feel we can go 1-1 or keep the score at 1-0 without Jasprit. Again, that's putting the eggs in the back end of the series. We're going to need him at some stage as well. You've got to decide when you're going to play your strongest suit. "We came pretty close without Jasprit in the second half (at Leeds). He didn't get any wickets. But you can't win the Test series with just one bowler in any case. Sorry, I can't give you a more firm answer. But we'll work out in the next 24 hours how."

Pretty Sure Two Spinners Will Play Here

The Leeds wicket was full of runs and considering the hot weather, expectations are that the pitch will again be good for batting, bringing the spinners into play.

India missed the service of a second spinner in the seriesopener and Doeschate said the team is likely to change its strategy for the game beginning on Wednesday.

Doeschate did not reveal much on that but came -close to confirming that two spinners will be part of the playing eleven.

Indian Pacers Use 2-Coloured Ball To Shed IPL Habits

BIRMINGHAM: The Indian pace attack, practising with two-coloured balls to shed the "filthy" habits of white-ball cricket, drew plenty of attention at the penultimate net session ahead of the second Test against England at Edgbaston.

Jasprit Bumrah was seen holding a red and white ball at the start of the session and so were the other members of the Indian pace battery.

It is common practice to use multi coloured balls and to be specific, the Indian pacers have been using them since the start of the English summer.

One reason for it is that the fast bowlers arrived in England after a lengthy white-ball stint, including the Champions Trophy and the subsequent Indian Premier League.

India assistant coach Ryan ten Doeschate said training with the two-coloured balls helps in eliminating white ball tendencies from the red ball game.

"It's not a new thing. All the ball manufacturers make those balls. We talk about detoxing the bowlers, just getting the very basics right. And that's the easiest way to give you an indication. Guys have come out of a long IPL season and the filthy habits of that cricket.

"We don't want that creeping into Test cricket. So Morne (Morkel) and the bowlers just use that tool just to make sure the basic fundamentals are in place. We've been using it for the last two weeks," said Doeschate.

MOEEN ALI CHECKS IN AT ENGLAND TRAINING

Former England all-rounder Moeen Ali made a surprise visit to the host's net session at his home ground here on Monday.

England are banking on Ali's knowledge of Edgbaston where the pitch is expected to be full of runs and aid spinners day three onwards. Head coach Brendon McCullum and spin bowling coach Jeetan Patel were seen having a long conversation with Ali.



England Name Unchanged Playing XI; Archer Misses Training

BIRMINGHAM: England have named an unchanged playing XI for the second Test against India even as fast bowler Jofra Archer missed Monday's training session at Edgbaston due to a family emergency.

While Archer is expected to rejoin the squad on Tuesday on the eve of the second Test beginning Wednesday, England have stuck with the side that secured a five-wicket win in the series opener at Headingley.

Archer, who had missed the opening Test, was added to the England squad for the five-match series last week but will have to wait for his chance.

"Men's fast bowler Jofra Archer will not be joining the England Test squad for today's training session at Edgbaston, Monday 30 June, due to a family emergency. He is expected to rejoin the squad tomorrow, Tuesday," the England and Wales Cricket Board's (ECB) said on Monday.

Archer, who has struggled with elbow-related injury to his bowling arm over the last several years, last played in a Test more than four years ago against India in Ahmedabad.

The second Test is scheduled to begin here from Wednesday. England lead the series 1-0.

Protesters Urge Wimbledon To Cut Ties With Barclays Over Israel

LONDON: Pro-Palestinian protesters urged Wimbledon to drop Barclays as a sponsor Monday because of the British bank's business dealings with Israel.

About two dozen protesters from Palestine Solidarity Campaign demonstrated by the main entrance of the All England Club as thousands of fans arrived for Day 1 of the tournament.

"They're the bank for the arms companies that are obviously supplying weapons to Israel," protester Khalid Zalmay told The Associated Press. "We should not be arming Israel, we should not be allowing anybody to facilitate arming them, and I think ties should be cut with Israel, the same way that ties were cut with Russia." One protester held a sign that said Barclays is a "spon-

sor of Wimbledon and genocide." Hamas-led militants killed



some 1,200 people, mostly civilians, and abducted 251 people in the Oct. 7, 2023 attack that sparked the Israel-Hamas war.

Israel's military response has led to the death of 56,000 Palestinians, according to the Health Ministry, which does not distinguish between civilians and combatants. It says more than half of the dead were women and children. Wimbledon did not immediately respond to a request for comment.

Barclays said it is "proud of our partnership with Wimbledon" and defended its business practices. "We provide a range of financial services and products to companies supplying defense products to the UK, NATO and its allies," the company statement said. "As NATO, the EU and UK seek to increase their defense capabilities in response to increasing geopolitical threats, the provision of financial products and services to the defense sector is becoming increasingly important."

WIMBLEDON HIT BY RECORD-BREAKING DAY 1 TEMPERATURES

Wimbledon players and spectators were hit by record-breaking Day 1 heat as the temperature rose to 91 degrees Fahrenheit — 33 Celsius — at the oldest Grand Slam tournament on Monday.

"For sure, you feel like the sun is getting closer and closer every minute that passes by," said Adrian Mannarino, a 37-year-old Frenchman who frequently sprayed his shaved head with sunscreen at changeovers

during his first-round victory. "I was struggling a little more than usual."

The 2001 fortnight had the previous hottest opening day at the All England Club, reaching 85 degrees F (29.3 degrees C).

"I feel like everyone is kind of

struggling with the heat right now," Germany's Eva Lys said after winning her match Monday.

Some sweat-soaked athletes sought help from ice-filled towels wrapped around their necks while they sat on sideline chairs.

Others said it actually wasn't all that unbearable, especially given that the weather was not extraordinary compared to what often occurs during the local summers when the Australian Open is held in Melbourne in January or the U.S. Open is in New York in August and September. At those events, temperatures regularly get to 90 degrees F (32 degrees C) and can top 100 degrees F (38 degrees C).

Dhoni Seeks Trademark For Sobriquet 'Captain Cool'

ormer Indian cricket team captain Mahendra Singh Dhoni has filed a trademark application for the phrase 'CAP-TAIN COOL', a sobriquet widely associated with his calm on-field demeanour.

According to the Trade Marks Registry portal, the application's status is 'accepted

and advertised'. It was published in the official trademark journal on June 16. The application was filed on June 5.

The proposed trademark is registered under the category for sports training, providing sports training facilities, sports coaching and services.

No comments could immediately be obtained from Dhoni. Interestingly, another company, Prabha Skill Sports (OPC) Pvt Ltd, had earlier filed a

similar application for the phrase. However, that application's status is showing as 'rectification filed'.

Earlier this month, Dhoni was inducted into the ICC's Hall of Fame for the year 2025 along with

seven cricketers, including Australian great Matthew Hayden and South Africa's Hashim Amla. The ICC hailed Dhoni as a player who excelled not just in numbers but also in "extraordinary

Yashasvi Jaiswal To Continue Playing For Mumbai

ndian Test opener Yashasvi Jaiswal will continue to play for domestic giants Mumbai after the state cricket body on Monday approved the withdrawal of his earlier request for a No Objection Certificate (NOC).

The 23-year-old Jaiswal had surprised one and all in April by writing to the MCA, seeking NOC to represent a different state.

Mumbai Cricket Association (MCA) had initially accepted his request for the NOC. Jaiswal was headed to Goa and was even set to become their captain in domestic competitions.

"His deep knowledge of the game, combined with hands-on international exposure and proven success in the English county circuit, make him exceptionally well-suited for this position," the PCB added.

South Africa Set Zimbabwe 537 To Win

outh Africa set Zimbabwe 537 runs to win the first test after Wiaan Mulder's career-best 147 on Monday.

Zimbabwe was 32-1 at stumps on day three, trailing by 505 runs with two days to go and without concussed opener Brian Bennett. His replacement, Prince Masvaure, was 5 not out.

A solid start by Zimbabwe was spoiled by opener Takudzwanashe Kaitano edging Corbin Bosch to second slip on what turned out to be the last ball of the day.

Zimbabwe has six 500-plus scores in test cricket, most recently last December against Afghanistan at the same Queens Sports Club. But its highest fourth-innings total was 331 in a 2001

loss to New Zealand, also in Bulawayo. Considering Zimbabwe was out for 251 in the first innings, South Africa already began the day in charge from leading by 216 at 49-1 in the second innings with Mulder 25 not out.

South Africa was reduced to 155-5 in the morning session but Mulder stood firm and his partnership with Kyle Verreynne, worth 104 in 131 balls into the afternoon, diminished Zimbabwe hopes.
