Kashmir Under Heat Siege

Srinagar Records Hottest July In Over 70 Yrs

Srinagar: A relentless heatwave continues to grip the Kashmir Valley, setting new temperature benchmarks and disrupting daily life across the region. On Saturday, Srinagar recorded a scorching 37.4°C, marking the third highest temperature ever recorded in July. This reading comes close to the second highest of 37.7°C logged on July 5, 1953, and just below the all-time high of 38.3°C recorded on July

10, 1946. The extreme heat wasn't limited to the capital. Pahalgam, which serves as a key base camp for the ongoing Amarnath Yatra, witnessed its hottest July day ever with the mercury touching 31.6°C, surpassing its previous record of 31.5°C set on July 21 last year. Kokernag also sizzled at 34.0°C, the second-highest

Research Suggests Mental Health Support For Burn Survivors In Health Facilities To Deal With Stigma

esearchers at the George Institute for Global Health have identified key areas where India's health system can improve support for patients seeking care for burn injuries, officials said.

Mental health support for patients, more training and counselling for healthcare providers and anti-discrimination policies in health institutions were among several recommendations that was made in the study conducted by the

medical research institute. The study conducted in Uttar Pradesh explored how burn survivors experience stigma and discrimination within healthcare settings and proposed a set of policy and practice recommenda-

tions to address these gaps. Claimed to be first-of-its-kind study globally that specifically aimed to assess stigma faced by burn patients in hospitals and healthcare settings, the research was carried out as part of the Royal Society of Tropical Medicine and Hygiene (RSTMH) early career grants programme, supported by the National Institute for Health and Care Research (NIHR), UK.

Even as survival rates have increased with better medical care, the study suggested that institutional neglect, under-resourced facilities, overburdened staff, and systemic failures are some reasons for burn patients receiving discriminatory and low-quality care.

According to officials, burns can result in emotional, physical and psychological damage, particularly for patients with visible disfigurements or disabilities and those from underprivileged backgrounds.

Worldwide, there are about 180,000 deaths each year due to burns, with the greatest burden in low- and middle-income countries. India contributes to the largest burden of approximately 2.1 million burn injuries, 25,000 deaths, and more than 1.4 million disability-adjusted

life years (DALYs) annually. "Burn survivors, particularly women and poor people, receive blame and isolation and face neglect in hospitals. At the same time, overworked and under-supported healthcare staff struggle with burnout, which can lead to unintentional but harmful behaviour towards pa-

"Addressing both patient experiences and system challenges is key to building compassionate and fair burn care," said Pratishtha Singh from the George Institute for Global Health. Jagnoor Jagnoor, also from the George Institute for Global Health, said, "Burn survivors show extraordinary resilience in the face of life-alter-

ing injuries. Yet, stigma within the very systems

meant to support them continues to be a bar-

rier to recovery and reintegration. Our research



highlights the urgent need to create inclusive, dignified spaces that empower survivors to heal, thrive, and reclaim their place in society." Findings from the study suggest that practical steps such as improved provider training, dedicated counselling services, and clear operational guidelines can help create a more supportive environment for burn patients in healthcare

While India has made commendable strides in emergency burn care in recent years, long-term issues such as persistent stigma, inadequate mental health support, and limited social reintegration of recovered patients remain largely

The study was conducted in Uttar Pradesh, India's most populous state, with more than 200 million people, 77.7 per cent of whom reside in rural areas. With its limited medical infrastructure and health indicators, the region was a critical location for such a study, emphasising the pressing need for systemic upgrades in patient care throughout India.

The research involved interviews with burn patients, healthcare providers, and legal professionals and highlights the need to address both structural limitations and interpersonal

interactions in hospitals. Participants reported challenges such as limited empathetic communication, social isolation during hospitalisation, and perceived differences in care based on socioeconomic background. Introducing structured training and counselling for healthcare providers on burns-related stigma, patient-centred care, and mental health support were recommended by the research-

They also recommended updating medical and nursing curricula to include modules on empathetic communication and psychosocial aspects of burn recovery; strengthening hospital-based support systems, including mental health services and rehabilitation pathways, especially in public facilities.

Developing and implementing anti-discrimination policies in health institutions, tailored to the needs of visibly injured or disabled patients, are also among the recommendations made in the study.



Over 100 BBC Staff Accuse Broadcaster of Pro-Israel Bias

Srinagar: More than 100 current BBC employees have signed a scathing open letter accusing the broadcaster of failing its editorial standards and acting as "a mouthpiece" for Israel amid its coverage of the war in Gaza.

The letter, also endorsed by over 300 media figures including actors Miriam Margolyes and Charles Dance, filmmaker Mike Leigh, and historian William Dalrymple — criticizes the BBC for sanitizing the humanitarian crisis in Gaza and for internal censorship.

"All too often it has felt that the BBC has been performing PR for the Israeli regime and military," the letter reads, calling this "a cause of great shame and concern."

Signatories allege editorial interference and pressure to avoid content critical of Israel, under the guise of neutrality. Staff also condemned

the BBC's decision to pull its own commissioned documentary Gaza: Doctors Under Attack, which Channel 4 has since picked up, calling the move politically motivated.

The letter further demands the resignation of BBC board member Robbie Gibb over what it calls a conflict of interest, citing his ties to The Jewish Chronicle, which it accuses of publishing anti-Palestinian material.

Critics say the BBC has failed to report adequately on UK government arms sales to Israel or the broader legal implications of Britain's involvement in the war.

According to Gaza health officials, over 57,000 Palestinians - mostly women and children - have died since Israel launched its military campaign in October 2023. Is rael now faces genocide proceedings at the International Court of Justice and war crimes charges from the International Criminal Court

Setback for Saif Ali Khan: ₹15,000 Cr **Property Case Revived**

New Delhi: In a setback to actor Saif Ali Khan and his family, who inherited Rs 15,000 crore properties owned by Bhopal's erstwhile rulers, the Madhya Pradesh High Court has set aside the trial court's verdict given over two decades ago, and ordered a retrial in the case.

In its order passed on June 30, the single Bench of Justice Sanjay Dwivedi set aside the judgment and decree of the trial court which upheld Pataudis — Saif Ali Khan, his mother Sharmila Tagore and his two sisters Soha and Saba — to be the owners of the properties.

It also directed the trial court to make all possible efforts to conclude and decide the matter within one year.

Nawab Hamidullah was the last ruling Nawab of the princely state of Bhopal. He and his wife Maimoona Sultan had three daughters — Abida. Sajida and Rabia. Sajida married Iftikhar Ali Khan Pataudi and became the Nawab Begum of Bhopal. Their son, Mansoor Ali Khan Pataudi, former Indian cricket team skipper, married Sharmila Tagore.

After Nawab Hamidullah's eldest daughter Abida migrated to Pakistan, Sajida became the owner of the properties. Later, her son Mansoor Ali Khan Pataudi became the successor of these properties estimated to be valued at nearly Rs 15.000 crore — which were inherited by Saif Ali and his siblings.

The two appeals, one filed by Begum Suraiya Rashid and others, and another by Nawab Mehr Taj Sajida Sultan and others, all heirs of late Naw-



ab Mohammad Hamidullah Khan, said the trial court had dismissed their suits against what they called as 'unfair partition of royal property'.

In their pleas, they stated that the Bhopal district court's judgement and decree dated February 14, 2000, dismissed their suits unfairly.

Their lawyers pleaded that the partition of the Nawab's personal property should have been done between them and defendants Saif Ali, Sharmila and 16 other heirs as per the Muslim Personal Law.

The appellants opposed the defendants (Pataudis) for citing the certificate issued by the Government of India on January 10, 1962, in fayour of Sajida Begum as the sole successor of all the private properties.

Justice Dwivedi said "The matters are remanded back to the trial court for deciding it afresh.'

"And if so required, the trial court can allow the parties to lead further evidence in view of the subsequent development and changed legal position," the court ordered.

"I am of the opinion that the trial court, without considering other aspects of the matter, had dismissed the suits, that too relying upon the judgment which has already been overruled by the Supreme Court. Thus, in my opinion, the impugned judgment and decree deserve to be and are hereby set aside," the iudge said



Bilawal Says Pak Open To Extraditing 'Individuals Of Concern' To India

Islamabad: Pakistan's former foreign minister Bilawal Bhutto Zardari has said that his country had no objection to extraditing "individuals of concern" to India as a confidencebuilding measure, as long as New Delhi showed willingness to cooperate in the process.

Bilawal, the chairman of the Pakistan People's Party, made the comments in an interview with Al Jazeera on Friday while responding to a question about extraditing Lashkar-e-Taiba (LeT) chief Hafiz Saeed and Jaish-e-Muhammad (JeM) chief Masood Azhar as possible concessions and good-faith gestures to India, Dawn newspaper reported.

"As part of a comprehensive dialogue with Pakistan, where terrorism is one of the issues that we discuss, I am sure Pakistan would not be opposed to any of these things,' Bilawal said

Both LeT and JeM have been banned by Pakistan, according to the National Counter Terrorism Authority (Nacta), while Saeed, the 26/11 Mumbai terror attack mastermind, is currently serving a 33-year sentence for terror financing, and Azhar, a UNdesignated global terrorist, has been proscribed by Nacta.

Bilawal said that cases prosecuted against these "individuals" were those related to Pakistan, such as terrorist financing. However, he noted that prosecuting them for cross-border terrorism was difficult due to what he claimed was "noncompliance" from Delhi.

"India is refusing to comply with certain basic elements that require that conviction to take place," he said. "It's important ... to present evidence within these courts, for people to come over from India to testify, to put up with whatever the counter-accusations will be." "If India is willing to be cooperative in that process, I am sure there will be no hurdle in extraditing any individual of concern," he added.

Bilawal also expressed concern about India's vow to pursue terrorists, calling it a 'new abnormal"

"This does not serve the interests of Pakistan, and it does not serve the interests of India," he added.

Pressed on the whereabouts of Saeed and Azhar, Bilawal stated that the former was incarcerated, while Islamabad believes the latter is in Afghanistan.

"It is factually not correct that Hafiz Saeed is a free man; he is in the custody of the Pakistani state," he maintained, stating that Islamabad has been unable to arrest Azhar.

"It is our belief that he is in Afghanistan," Bilawal stated. "If and when the Indian government shares information that he is on Pakistani soil, we will be more than happy to arrest him.

PM Modi Arrives In **Argentina On Two-Day Visit**

Buenos Aires: Prime Minister Narendra Modi has arrived here on a two-day visit during which he will hold talks with the country's top leadership to review ongoing bilateral cooperation and discuss ways to enhance India-Argentina partnership in key areas.

Modi, who reached here on Friday evening (local time), was accorded a ceremonial welcome upon his arrival at the Ezeiza International Airport.

"Landed in Buenos Aires for a bilateral visit which will focus on augmenting relations with Argentina. I'm eager to be meeting President Javier Milei and holding detailed talks with him," he said in a post on X.

This is the first Indian bilateral visit at the prime ministerial level to Argentina in 57 years. It is Modi's second visit to the country as prime minister; he had visited in 2018 for the G20 Summit.

It also marks the third stop on the prime minister's five-nation visit.

"Celebrating the enduring friendship between our nations. PM @narendramodi has landed in the vibrant city of Buenos Aires, Argentina on an Official Visit. He was accorded a ceremonial welcome on arrival at the airport. This is the first bilateral visit by an Indian PM to Argentina in 57 years, marking a new chapter in India-Argentina ties," Ministry of External Affairs (MEA) spokesperson Randhir

Modi will hold wideranging talks with President Milei to further boost India-Argentina partnership in key areas including defence, agriculture, mining, oil and gas, renewable energy, trade and investment, according to

"The bilateral visit of the prime minister will further deepen the multifaceted strategic partnership between India and Argentina," it said in a statement.

In his departure statement, the prime minister said that Argentina is a key economic partner in Latin America and a close collaborator in the G20 and that he looked forward to discussions with President Milei, whom he had met last year.

"We will focus on advancing our mutually beneficial cooperation, including in the areas of agriculture, critical minerals, energy, trade, tourism, technology, and investment," Modi had said.

India Becomes Fourth "Most Equal" Country **Globally: World Bank Report**

New Delhi: Inequality in India has come down significantly between 2011-12 and 2022-23, making it the fourth-most equal country globally, according to a World Bank report.

This is in addition to a sharp decrease in extreme poverty, which has dropped from 16.2 per cent in 2011-12 to 2.3 per cent in 2022-23, an official release said quoting World Bank data.

The government attribited the reduction in inequality to various initiatives and schemes pursued during the last decade.

The only three countries which have a better Gini Index score, a measure of equality, are the Slovak Republic. Slovenia and Belarus, India is much better placed than countries like China, the USA and the United Kingdom.

'...India's Gini Index stands at 25.5, making it the fourth most equal country in the world, after the Slovak Republic, Slovenia and Belarus," the statement said.

The Gini Index helps in understanding how equally income, wealth or consumption is distributed across households

or individuals in a country. It ranges in value from 0 to 100.

A score of 0 means perfect equality, while a score of 100 means one person has all the income, wealth or consumption and others have none, hence absolute inequality. The higher the Gini Index, the more unequal a country is.

India's score is much lower than China's 35.7 and far lower than the United States, which stands at 41.8.

As per the World Bank's report, which has released the data for 167 countries, Inlow" inequality category, which includes Gini scores between 25 and 30.

India is only a fraction away from joining the "low inequality" group.

The government attributed this achievement to a sharp reduction in the poverty level in the last decade.

According to the World Bank report, 171 million Indians have been lifted out of extreme poverty over the past decade. The share of people living on less than USD 2.15 a day, which was the global threshold for extreme poverty till June 2025, fell sharply from 16.2 per cent in 2011-12 to just 2.3 per cent in 2022-23.

Russia Is Paying Schoolgirls To Have Babies

Countries Are Pushing Women to Have More Babies

Moscow: In some parts of Russia, schoolgirls who become pregnant are being paid more £900) for giving birth and raising their babies

This new measure, introduced in the past few months across 10 regions, is part of Russia's new demographic strategy, widening the policy adopted in March 2025 which only applied to adult women. It is designed to address the dramatic decline in the country's birthrate.

In 2023, the number of births in Russia per woman was 1.41 - substantially below 2.05, which is the level required to maintain a population at its current size.

Paying teenage girls to have babies while they are still in school is controversial in Russia. According to a recent

survey by the Russian Public Opinion Research Centre, 43% of Russians approve of the policy, while 40% are opposed to it.

But it indicates the high priority that the state places on increasing the number of children being born. Russia's president, Vladi-

mir Putin, regards a large population as one of the markers of a flourishing great power, along with control over a vast (and growing) territory and a powerful military

Paradoxically, though, his efforts to increase the physical size of Russia by attacking Ukraine and illegally annexing its territory have also been disastrous in terms of shrinking Russia's population.

The number of Russian soldiers killed in the war has reached 2,50,000 by some estimates, while the war sparked an exodus of hundreds of thousands of some of the most highly

educated Russians. Many of them are young

men fleeing military service who could have been fathers to the next generation of Russian citizens.

But while Russia's demo graphic situation is extreme. declining birth rates are now a global trend. It is estimated that by 2050

It's not only Russia

Putin is not the only world leader to introduce policies designed to encourage women to have more babies. Viktor Orban's government in Hungary is offering a range of incentives, such as generous tax breaks and subsidised mortgages, to those who have three or more children.

he Dalai Lama said on Saturday he hopes to live until he is more than 130 years old, two decades longer than his previous prediction, following his assurance to followers that he would reincarnate as the spiritual head of the faith upon his death.

The Nobel Peace Prize winner was speaking during a ceremony organised by his followers to offer prayers for his long life, ahead of his 90th birthday on Sunday, and as China insists it will choose his successor. The Dalai Lama told Reuters in December he might live to 110.

"I have been able to serve the Buddhadharma (the teachings of Buddhism) and the beings of Tibet so far quite well," he said between prayers, clearing his throat now

and then. "And still, I hope to live over 130 years," he said, sparking applause and cheers among his followers.

The 14th Dalai Lama, already longestlived head of Tibetan Buddhism, spent about 90 minutes at the prayers in his temple. The ceremony was attended by thousands of followers from around the world who gathered in the northern Indian hill town of Dharamshala, where he has lived since fleeing Tibet in 1959 in the wake of a failed uprising against Chinese rule. "We have lost our country and we live

in exile in India, but I have been able to benefit beings quite a lot. So, living here in Dharamshala, I intend to serve beings and the dharma as much as I can," he said in Tibetan, which was translated simultaneously in English and other languages.

China, keen to consolidate its control over Tibet, views the Dalai Lama as a separatist. Beijing insists its leaders would have to approve his successor, in a legacy from imperial times.

The Dalai Lama has previously said that he would reincarnate in the "free world" outside China and this week told his followers that the sole authority to recognise his reincarnation rests with his non-profit insti-



tution, the Gaden Phodrang Trust. Devotees stream in

prize for what the Nobel committee said was keeping alive the Tibetan cause and seeking genuine autonomy to protect and preserve the region's unique culture, religion and national identity without pressing for independence.

At the prayers on Saturday, he sat on a throne before a large statue of the Buddha,

with dozens of monks seated in front of him. Marigold garlands hung from pillars as his followers and journalists crowded around the main temple area. Oracles and other figures, shaking

in trance, arrived to pay their obeisance to their guru. Monks struck cymbals and played ornate long trumpets in honour of the Dalai Lama and others

The Dalai Lama said he prays daily to benefit all sentient beings and feels he has the blessings of Tibet's patron deity, Avalokitesvara.

"Looking at the many prophecies, I feel I have the blessings of Avalokitesvara," he said. "I have done my best so far. At the least, I hope to still live for 30 or 40 years more.'

His birthday celebrations on Sunday will be attended by senior Indian ministers as well as diplomats from the United States, along with thousands of his devotees.

HC Slams KU's 'Hire & Fire' Policy

Orders Continuation Of Contractual Law Faculty Until Core Staff Appointed

SRINAGAR:The High Court of J&K and Ladakh has directed University of Kashmir to allow contractual as well as faculty members engaged in academic arrangement to continue till such time when core faculty is put in place in the Department of Law.

"So far as the legal position as regards the permissibility of replacing the teaching faculty of an educational institution engaged on contractual basis or academic arrangement basis by a similar arrangement is concerned, the same,, is beyond any cavil, inasmuch it is not permissible for an institute to resort to hire and fire policy and to replace contractual/temporary arrangement by a similar arrangement," a bench of Justice Sanjay Dhar said while allowing a bunch of petitions filed by those engaged on academic arrangement basis and whose engagement was extended from time to time either by virtue of interim orders passed by the Court or otherwise.

"The replacement can only be resorted through regularly appointed staff/teaching faculty," the court said.

The petitioners had challenged various advertisement notices whereby the University invited applications for engagement of contractual Lecturers on academic arrangement basis for the Session 2023 and 2024.

"The action of the respondents (KU authorities) in disengaging the services of the petitioners and replacing them by ad hoc arrangements like visiting lecturers and guest lecturers is nothing but a malafide exercise of power," the court said, adding, "By doing so, the respondent University intends to do away with the service contracts of the petitioners but in the process, they are also doing a great disservice to the students' community who are being left to the mercy of guest/visiting lecturers without there being any continuity."

Instead of creating a core faclty, as envisaged under Rule 17 of the Rules of Legal Education 2008, the court said, the University, it seems, is resorting to hire and fire policy which is detrimental to the interests of not only the petitioners but also to the larger interests of the student community.

J&K NARCO-TERROR CASE

Hizb Chief Salahuddin, 10 **Others Chargesheeted**

JAMMU: The Jammu and Kashmir State Investigation Agency (SIA) has filed a chargesheet against 11 accused, including Pakistan-based Hizbul Mujahideen supremo Syed Mohammad Yusuf Shah alias Syed Salahuddin, in connection with a narcoterror case here, an official said.

The case was initially lodged by SIA, Jammu in 2022 and a probe uncovered a well-organised network of terrorist associates and couriers aiding the proscribed outfit by facilitating smuggling of narcotics and raising funds for terror activities, a

spokesperson of the agency said. "Besides Sallahuddin, a resident of Sibugh village in central Kashmir's Budgam who is presently operating from across the border, another Hizbul terrorist, Basharat Ahmad Bhat of Khan Sahib area of Budgam, was named in the chargesheet. He operates from Rawalpindi in Pakistan", he said.

"The others were identified as Khalid Hussain of Rajouri, Mohd Shokit of Poonch, Javid Ahmed Rather of Budgam, Manzoor Ahmad and Asif Rehman Reshi of Srinagar and Harpreet Singh, Chain Singh, Sahil Kumar, and Sandeepak Singh of

Jammu", the official said. "This network as per the investigations has emerged as a major channel for terror financing in the region," the spokes-

person said, adding several of these individuals involved have amassed significant wealth through drug proceeds, despite having negligible legitimate sources of income. The SIA said the investigation revealed a systematic modus operandi wherein narcotics were smuggled from Pakistan into the Union Territory of Jammu and Kashmir.

The proceeds from the sale of these drugs were deposited in the account of one of the accused, on the instructions of Pakistan-based terrorist Bhat, the spokesperson said.

He said the accused individuals were allegedly key drug dealers responsible for distributing narcotics among local youth. Some reportedly employed the other accused for selling narcotics to their clientele, the spokesperson said.

He said the investigation points to a larger conspiracy spearheaded by Pakistan-sponsored Hizbul Mujahideen to destabilise the peaceful atmosphere of Jammu and Kashmir by facilitating terrorist activities.

Rise In Tourist Footfall Puts Mughal Road To Test

SRINAGAR: The historic Mughal road, which connects Shopian in South Kashmir to Poonch-Rajouri in Jammu division, is witnessing a surge in tourist and commuter traffic this summer.

With every passing year, the volume of vehicles on the scenic 84-kilometer stretch continues to rise-but so do complaints about poor infrastructure and lack of essential facilities.

Despite being granted National Highway status three years ago, the Mughal Road remains devoid of basic amenities, leaving both tourists and local drivers in distress.

Speaking to KNO, officials said that footfall has significantly increased in recent months. Tourists from both the Poonch-Rajouri and Shopian sides are thronging destinations like Peer Ki Gali, Dubjan and Aliabad Sarai, drawn by the region's breathtaking natural beauty.

However, visitors say the scenic drive comes at the cost of safety and comfort.

"The views are stunning, but you're completely cut off from the world once you enter the stretch. There is no mobile network, no roadside help and not even basic washrooms," said Shabina Jan, a visitor from Srinagar, who visited Peer Ki



Gali with her family. Locals and regular travellers echoed similar concerns, urging the government to address the lack of infrastructure.

'The road feels like paradise, especially from Hirpora to Peer Ki Gali-but if your vehicle breaks down, there is no mechanic or help available. You're on your own," said Abdul Ma-jid, a driver who frequently commutes on the route.

There are stretches of over 20 kilometers without a single shop or eatery. It's a nightmare for tourists and commuters alike," said Fayaz Ahmed, a local transporter from Rajouri.

"In case of accidents or emergencies, it's impossible to call for help due to zero network connectivity. This makes the road risky, especially for those travelling with children or elderly people," added Tariq

Lone, a regular commuter. For women, the absence of public washrooms poses an even more serious issue.

"It's a shame that such a beautiful and important road lacks basic sanitation. It becomes a traumatic experience for women, especially during long journeys," said Nusrat Bano, a tourist from Pulwama

Stakeholders have urged the government to act swiftly and improve facilities along the Mughal Road—not just to ease travel, but also to boost tourism and local livelihoods.

"If roadside facilities, eateries, and communication setups are improved, the tourist footfall will increase tenfold. This will generate employment for locals and additional revenue for the government," said Aijaz Khan, a hotelier in Poonch.

People from both sides have called for mobile towers, emergency helpline booths, public toilets, rest areas, and regular maintenance of the road.

Hariparigam Orchardists Crave For Water Agencies

SRINAGAR: Farmers of Hariparigam village, Awantipora in south Kashmir's Pulwama district are reeling under a severe irrigation crisis as their orchards, dependent on the Dadi Canal, are drying up due to non-availability of water.

Locals said that despite being allocated water supply during the first four days of July as part of the irrigation department's Warbandi (irrigation schedule), the residents say that they were unable to irrigate their orchards due to unavailability of water.

The villagers allege that residents of upstream areas have been using water pumps illegally on the Dadi Canal to irrigate their fields, leaving tail-end villages like Hariparigam high and dry.

"We were scheduled to redays of July according to the department's schedule, but nothing reached us. Powerful motors used by people in upstream villages have left us with parched fields," said Ghulam Nabi Wani, a local orchardist.

He added that the orchardists in Hariparigam are largely dependent on the Dadi Canal for irrigation, and with the current heatwave and prolonged dry spell, the absence of water has pushed their orchards to the brink of disaster.

"Over 70% of orchards in our area are rain-fed or canal-dependent. With this level of water theft, our trees are drying, leaves are falling prematurely, and fruit size is shrinking. We fear heavy losses this season," said Farooq Ahmad Dar, another orchardist from the village.

Locals accused the authorities of inaction despite repeated complaints.

"We have approached the irrigation officials multiple times, but no action has been taken against the violators. There should be a strict ban on illegal motor use and proper monitoring to ensure fair distribution of water," said Bilal

Ahmad, a resident. The residents have urged the higher authorities, particularly the Executive Engineer Irrigation Department Ananthag and the District Administration, to take strict action against violators and ensure that scheduled water reaches tail-end villages without hindrance.

"If immediate steps are not taken, our entire fruit crop will be lost. This is our only source of livelihood," said another resident.

Locals have demanded fieldlevel monitoring teams and a ban on unauthorized motor pumps to ensure water reaches the end users—(KNO)

NC Not Afraid Of Polls: CM's Advisor

SRINAGAR: Senior National Conference (NC) leader and Chief Minister Omar Abdullah's Advisor, Nasir Aslam Wani, on Saturday asserted that holding assembly elections in Jammu and Kashmir are not a prerequisite for the restoration of statehood.

Talking to reporters, Wani, according to KNO said, "The NC is fully prepared for elections whenever they are announced but the restoration of I&K statehood should not be linked to electoral timelines." "We come to know about such reports only through media leaks or planted stories," Wani said while referring to recent news reports suggesting that assembly elections must pre-

cede the return of statehood. "No official proposal regarding the holding of fresh elections has been communicated to us so far. For Jammu and Kashmir to regain statehood from Union Territory status, the Reorganisation Act needs to be amended and the Legislative Council (upper house) must be restored. Nowhere is it mentioned that elections are a precondition."

He added, "Let me be very clear National Conference has never been scared of facing the people. We are the only true grassroots party in Jammu and Kashmir. Our demand remains clear: full statehood for Iammu and Kashmir."

Wani also reiterated NC's longstanding call for the formation of a Truth and Reconciliation Commission, a proposal repeatedly advocated by Omar Abdullah to bridge the trust gap between Kashmiri Muslims and Kashmiri Pandits. There has been a serious trust deficit since the 1990s, and only credible Truth and Reconciliation mechanism can help heal the wounds and foster understanding between communities." Wani said.

Referring to the turbulent 1990s, Wani highlighted the sacrifices made by NC workers. "Our workers stood by the nation at a time when standing with India cost them their lives. Hundreds of our party men were killed just because they chose the path of democracy and unity. Despite that, we are still asked to prove our nationalism," he said.

He lamented the recurring political experiments in Jammu and Kashmir, saying, "Since I joined politics, I have seen various experiments being conducted in J&K. But whenever the people are given the opportunity to choose freely, they repose their faith in the National Conference. That's because NC wasn't created by Delhi or any agency. It was born out of the aspirations of the people of this land."

he summer heat in Kashmir this year has been Temperatures have hit levels that locals say haven't been seen in over a century. As the valley swelters, a fresh debate has erupted: should schools extend the summer break?

It's not just a quiet conversation among parents anymore. Social media has exploded with opinions, arguments, and even angry accusations. Some influencers, chasing likes and shares, have turned the issue into a public spectacle. They offer advice as if they understand the real situation inside our schools. But many of them are far from the ground reality.

Let's be clear: the people making these decisions are not sitting in a bubble. School authorities and officials know what they're doing. They don't need YouTube personalities or self-proclaimed experts preaching from air-conditioned rooms. What they need, and what we all need, is to look closely at the actual conditions our children face in schools across the valley.

Parents are right to worry. Most government schools in Kashmir are simply not built to handle extreme weather. Many classrooms have broken windows, cracked walls, and tin roofs that trap heat like ovens. Some schools don't even have proper ceilings or fans. Students sit on uncomfortable benches in rooms with no cooling at all. In these conditions, asking young children to sit through classes in the peak of summer is more than unfair. It's unsafe.

Some critics, especially online, have mocked teachers during this debate, painting them

as people looking for an easy way out. That's a terrible misjudgment. Teachers in Kashmir have worked in some of the harshest conditions imaginable.

In the far-flung areas of the valley where temperatures can drop to minus 40 degrees, teachers still show up. They work in schools high up in the mountains and in towns where basic facilities are missing. To suggest they are lazy is both unfair and uninformed.

It's important to understand that summer vacations are for students, not for teachers. Teachers lose out on service days and other work benefits during these breaks. No one is asking for extra holidays. What we're asking is: how can we send children to classrooms that feel like furnaces?

Look at our hospitals. They work round the clock because they have at least the basic facilities to help people through extreme weather. Imagine if those hospitals lacked fans or cooling systems, how would the doctors and staff cope?

Yet that's exactly the situation in many schools. Even at home, we can't switch off our fans in this weather. Some families can afford air conditioners, but many can't. And when you think about those uncomfortable classrooms, how can we expect small children to focus, let alone stay healthy?

We don't need swanky schools with air conditioning. But we do need the basics: working fans, proper windows, and decent roofs. If those things were in place, the demand for extended summer vacations would shrink. Right now, there is no other option.

years, schools in Kashmir have made good progress in reducing the number of days lost to strikes, shutdowns, and curfews. That's a big step forward.

But winter vacations still eat up a huge chunk of the academic calendar. This can change if we modernize our schools. Other places have shown it's possible.

Delhi, for example, has improved the condition of its government schools by investing in better facilities.

Before the COVID-19 pandemic, Kashmir had winter tutorial programs that helped students continue their studies even during long breaks. These sessions were flexible and widely appreciated. We should bring them back.

I'm not asking to cancel winter vacations altogether, students need time to rest and recharge, but perhaps we can reduce the break to just January, the coldest month.

Kashmir's education system cannot keep relying on old patterns. The world is moving ahead, fast. We need new ideas and bold steps. Ending long vacations without fixing school buildings won't help.

But if we invest in infrastructure, basic things like heating in winter and fans in summer, our schools can stay open longer and our students can finally catch up.

Teachers are ready to do their part. What we need now is a serious plan to make our schools places where learning is possible, no matter the season.

The Valley Bets Big

In tea shops and on bus rides, the buzz of stock alerts is replacing old conversations about land, gold, and orchards.

But now, in the lanes where families once huddled around copper samovars, there is a new ritual unfolding: His investments stretched from Mumstocks, funds and charts. A language bai to New York, from India's largest not native to these streets is slowly takcompanies to the global giants whose

offices he would likely never see. But the markets, like the valley, can

Faisal's small gains did not last. Prices slipped. His carefully stacked portfolio began to tremble. Some days, the red numbers on his screen felt like the seasons had turned against him. Friends who had started with him silently sold their shares and stepped away.

Perhaps, they said, this game was not made for people like them, people from Kashmir.

But Faisal did not step away.

The gamble was never just about making money. It was about the chance to belong to something that stretched beyond the valley's tight borders. To know that from his small town, he could hold a fraction of a company that shaped the world.

And he was not the only one.

Across the region, the change was catching on. By early 2025, the number of Demat accounts in Jammu and Kashmir had crossed 250,000, a figure that would have once seemed almost impossible. Investment apps, stripped of old barriers, began appearing on the phones of university students, shopkeepers, even housewives.

Mutual funds became a stepping stone for many. They offered a gentler

path, managed by professionals and watched by regulators like SEBI. In 2024, the Association of Mutual

Funds in India recorded one of the sharpest increases in investor participation from Jammu and Kashmir. These were often first-time investors, cautiously placing their money in funds that balanced risk and reward.

The doors to global markets opened through Exchange-Traded Funds. Some investors in Baramulla now tracked the movement of gold through ETFs. Others followed the fate of American tech stocks from the narrow courtyards of Pulwama.

But there were twists still to come. Faisal thought he was alone until the morning he overheard two young men arguing about stock ratios at a roadside stall near Dal Lake. He didn't know their names. He didn't need to. The conversation told him enough. The markets had crept into the cracks of everyday life.

It was no longer just about the saffron crop or the price of timber. It was about Meta's quarterly earnings. It was about whether to hold or sell. The game

The valley's old wealth remains wrapped in gold, rooted in land, tucked inside family homes. But something else is growing now. Something slower, more patient, more uncertain.

Each morning, Faisal checks his stocks. Some days they rise. Some days they fall. The gamble is not whether he wins or loses today. The gamble is whether he can wait long enough to see how far this story will go.

And somewhere inside him, he knows the real reward is not the money. It's the proof that even from here, you can still play the long game. And maybe, just maybe, you can win.

The Race for Ranks

The push for academic success in Kashmir is draining families and shaping young lives in ways we can no longer afford to ignore.

ducation in Kashmir has always carried the weight of expectation. For decades, families have looked to books and degrees as their path to dignity and security. But when learning turns into a product sold in shiny packages, the dream begins to cost more

than most can afford. Today, Kashmir's coaching centres are estimated to be worth several hundred crores. They cover everything from medical and engineering entrances to civil services and even school-level tutoring.

Every step of a child's academic journey has been turned into a business opportunity. Students move through long hours of memorization, expensive study guides, and endless tests.

The question is no longer what they are learning, but how much they are paying.

At the heart of this growing system is fear.

Parents are often told, directly or indirectly, that missing out on a particular coaching centre could ruin their child's future. Fees as high as 1.5 to 2 lakh are treated as necessary, not optional.

Many families willingly sell gold, take loans, or cut daily expenses to pay these fees. For a daily wage worker earning 600 or 700 a day, spending 70,000 on coaching feels like an investment in survival. But this isn't always an investment that pays off.

Classes stretch from early morning to late evening, and instead of sparking curiosity, they leave students exhausted. Many no longer find joy in learning. They are buried under expectations they cannot escape, and soon their mental health begins to suffer.

In homes across Kashmir, parents watch their children lose their spark, but feel trapped by the fear of doing otherwise.

In this industry, there is little room for those who stumble.

Coaching centres focus their advertising on the few who top exams. The students who do not make it are simply left out of the story. Their photos are never on the walls, their efforts never mentioned.

For these centres, students who fail are not people. They are forgotten numbers.

The way these coaching centres operate is troubling. They often charge similar fees, use the same teaching methods, and compete over celebrity teachers who carry more brand value than teaching skill.

Sometimes, a single successful student is claimed by several centres, their story retold in glossy pamphlets.

The message is always the same: success is for sale. The problem does not stop there. In some schools, coaching centres have started shaping classroom learning to fit their own targets. Some government school teachers also work at coaching centres, raising serious concerns about divided loyalties. Oversight is weak, and few seem interested in changing that. For many, this is a system too profitable to challenge.

There is also no safety net for students caught in this race. Few centres offer mental health support. Few even consider it their responsibility. Students struggling with stress are often told to work harder. No one asks if the system itself is the problem.

The price is not just stress. It is a loss of confidence, imagination, and sometimes, self-worth.

These coaching centres set their own rules. Fees are fixed without checks. Claims about success are rarely verified. There are no public reports to show how many students truly benefit.

In the absence of clear rules, profit, not education, becomes the driving goal, and even students start to believe that only high ranks can prove their value.

What Kashmir urgently needs is a system to monitor and regulate these coaching centres. These are not just small tuition shops. They are

large, powerful businesses that shape the hopes of an

Regulation should bring fair fees, honest advertising, and basic welfare standards. Mental health support should not be optional. It must be part of the system.

If coaching centres help shape young lives, they must also help protect them.

But new rules alone will not be enough. There needs to be a deeper change in how people think about success

The mindset that links worth to rank, and education to suffering, must be questioned. Parents must stop believing that more money always means better chances. Teachers, especially those in public schools, must be held to higher ethical standards. The media must also take a step back from celebrating only the toppers and begin asking about those left behind.

Kashmir's conversation about education must go beyond numbers and cut-offs. We must ask: what are we building, if the price is the happiness and health of our children?

The goal should not be to simply make this system less harmful. It should be to build something better something kinder, more honest, and more just.

Such a vision cannot come from those who profit from the present system. It must be led by parents who ask for more, by teachers who choose care over cash, and by young people who believe learning can still be a joyful journey.

Until then, coaching centres will keep selling

And beneath every success story on a billboard, there will remain untold stories of loss, stories we can no longer afford to ignore.

Karbala's Haunting Hours

From the first arrow to the final prayer, the battlefield of Karbala became a memory that time could not bury.

The morning sky over Karbala was dark but still. The first call to prayer pierced the silence at 5:47 AM. In the camp of Imam Husayn, men stirred from uneasy sleep, their hearts tethered to the weight of the day ahead. They knew this dawn might be their last.

After the prayers, Husayn gathered his companions. His voice, steady but shadowed with sorrow, called them to patience, to courage, to the kind of steadfastness that legends remember. Across the plain, the soldiers of Kufa prayed behind their commander, Umar ibn Sa'ad, then busied themselves tying armor, readying bows, tightening their ranks.

The earth itself seemed to hold its breath. As the first light broke at 7:06 AM, Husayn mounted his camel, rising above his men so the enemy could see him. He rode alone towards the Kufan army, his words ringing out like an urgent drum. He reminded them who he was—the grandson of the Prophet, the son of Ali, the brother of Hasan. He called out their betrayal, their false invitations sealed in the very letters he now flung back at them.

His sermon hung in the desert air for half an hour, but the hearts he addressed had already turned to stone.

By 8 AM, his companions stepped forward

to speak. Burayr, the master Qur'an reciter of Kufa, stood tall, his voice a blade. After him came Zuhayr. Their words tried to reach the wavering hearts on the other side. Husayn's cry came next—a question that would echo through history: Is there anyone to help me? Some soldiers hesitated. Hurr, a commander, faltered on the edges of his loyalty. Others slipped away from the Kufan side, drawn by the magnetic pull of Husayn's cause.

Then the hour struck.

At 9 AM, Shimr's voice cut through the morning, urging Umar ibn Sa'ad to begin. Umar raised his bow, loosed the first arrow, and declared: Let it be known—I shot first. A hailstorm of arrows followed, falling like rain upon Husayn's camp. Husayn turned to his companions and told them to prepare for death. Scores fell in that opening barrage, their bodies folding into the sand before they could lift a sword.

The ground trembled as individual duels broke out at 10 AM. Abdullah bin Umayr stepped forward, his resolve like iron. He struck down two of Kufa's warriors but lost his fingers in the clash. The battles grew fierce. On the right flank, Habib's men clung to the line. On the left, Zuhayr's fighters met Shimr's assault. Shimr, the merciless commander, was wounded but not stopped. Then Umar unleashed five hundred archers. More of Husayn's men fell. Abu al-Sha'tha, a skilled bowman, fired his last arrows before the enemy consumed him.

The Kufan army tried to outflank Husayn from behind, but they were met with fire. A trench burned like a wall of flame, keeping the enemy at bay, barely.

By 11 AM, Husayn's companions were dying faster than they could be mourned. They made a pact: no one from Husayn's family would go to battle while they still lived. Burayr, old yet fierce, was among the first to fall, followed by Muslim bin 'Awsajah. In his final breath, Muslim pointed to Husayn. That is my will-protect him. Seven of Husayn's men were surrounded; Abbas broke through to save them.

Then the call to Zuhr prayer rose at 12:50 PM. Even as swords clashed, Husayn ordered the prayer to be held. Some fought while others prayed. Saeed bin Abdullah shielded Husayn, his body catching thirteen arrows before he collapsed. Habib ibn Mazahir was struck down after defending the sanctity of Husayn's prayer. Husayn wept, the first time his tears broke through that day.

By the end of the prayer, only thirty companions remained. Hurr, once an enemy, now bled among the martyrs. Now, the Bani Hashim stepped onto the battlefield. Ali Akbar, Husayn's son, fought with the fire of his father. His brothers, nephews, cousins followed. One by one, they were cut down.

By 2 PM, the sons of Hasan, the sons of Husayn, the brothers of Husayn, and their kin had fallen. Only Abbas and Husayn remained. Abbas, the loyal brother, asked to fight. Husayn sent him instead to fetch water for the thirsty children. Abbas reached the river but was ambushed. His arms were severed. His head was smashed with a pole. When Husayn found him, his knees buckled. Now my back is broken, he cried.

By 3 PM, Husayn stood alone.

He returned to the tents to bid farewell. In a heart-wrenching gesture, he tore pieces from his shirt to wear, so the looters would find it unworthy of theft. In one final plea for mercy, Husayn carried his six-month-old son, Ali Asghar, to the battlefield. He lifted the baby towards the enemy, asking for a drop of water. In answer, an arrow pierced the infant's throat.

Husayn kissed his son and turned to face

They came for him from a distance, fearful to face him up close. Spears and arrows tore into him until his body was marked by dozens of wounds. Near 4:06 PM, as the Adhan for Asr called out, Husayn fell. Some say it was Sinan bin Anas who struck the fatal blow. Others say it was Shimr.

The looting began almost immediately. They stripped the dead, even Husayn. It is said those who robbed him were later cursed with incurable diseases. Umar ibn Sa'ad ordered a brief halt to the looting. Suwayd bin Mata', a Shia from Basra who had arrived too late, fought to protect the surviving women and children but was killed.

As the sun slipped low near 5 PM, Husayn's severed head was handed to Khuli to be sent to Ibn Ziyad. The soldiers then trampled Husayn's body beneath the hooves of their horses.

At 6:49 PM, the call for Maghrib prayer rose over the blood-soaked field. Umar ibn Sa'ad led the evening prayer as though nothing had happened. Sinan recited poetry, boasting that gold awaited him for killing the finest man who had walked the earth.

The day ended, but in places far from Karbala, in cities like Srinagar, its story never would. The sorrow travels through centuries, carried in processions, in the laments of Muharram, in the chests of those who still beat their hands to the rhythm of that long, mournful day.

Why Ashura Still Matters

Ashura remains a call to conscience, echoing across time for those who face injustice.

ore than fourteen centuries ago, in a time of slavery, injustice, and chaos, a man set out on a mission that would forever change the world.

Prophet Muhammad (peace be upon him) faced ridicule, rejection, and threats as he tried to teach a new way of life, one that valued truth, justice, and compassion.

His mission wasn't just about prayers or rituals. It was about creating a fair and ethical society.

From those difficult bed Islam slowly grew, touching hearts and building communities. It offered a system of life where people could find order, dignity, and purpose.

But even after the Prophet's passing, his message faced fresh dangers. Corrupt rulers, injustice, and moral decay began to creep in.

It was in this setting that Imam Hussain, the beloved grandson of the Prophet, made a choice that would shape history.

Imam Hussain refused to accept Yazid, a leader who had brought oppression, dishonesty, and cruelty to power. He knew that staying silent would mean surrendering the values his grandfather had fought for.

So, he left Medina with his family and a few loyal companions, beginning a journey that would lead them across deserts and into the

The story of Karbala is one of the most powerful moments in Islamic history. Imam Hussain was not driven by power or fame. As he told his brother, "I have not risen to spread evil or to show off. I have left for the betterment of my grandfather's community. I wish to do good and stop evil."

What happened next is remembered every year on Ashura, the 10th

On that day, in the year 680 CE, Imam Hussain and his small group of supporters faced an army that outnumbered them. They were surrounded, denied water, and brutally

Imam Hussain, along with his family and companions, embraced martyrdom. But in losing their lives, they won something much greater: a timeless victory of courage over fear, of truth over tyranny.

The sacrifices of Karbala did not

end on the battlefield. Lady Zainab, the Prophet's granddaughter, rose in the aftermath, delivering bold speeches in the streets of Kufa and even in Yazid's court. In chains, she carried the message forward, making sure the world would

never forget what happened. Across centuries, stories about Karbala have crossed continents and languages. Even today, visitors at a museum in Istanbul pause before a simple display: a glass case holding what is marked as "The Soil of

According to tradition, the Prophet once collected this soil and gave it to his wife Umm Salma, telling her that it would turn red on the day his grandson would fall. And it did.

In 2018, in Srinagar, a scholar spoke of this moment during a public gathering, reminding listeners that the soil still holds its sacred meaning.

Surviving the tragedy was Imam Zain-ul-Abideen, the Prophet's greatgrandson, who was just 23 years old and seriously ill at the time. He would carry forward the teachings, ensuring that the spirit of Karbala

Today, the story of Ashura is not simply a ritual of mourning. It remains a call to stand for what is right, even when standing alone.

Imam Hussain's story speaks to anyone who faces injustice, who refuses to bow to fear, who believes that values matter more than victory.

As the philosopher Thomas Carlyle once wrote, "In the history of Islam, the life of Imam Hussain stands unique... Without his martyrdom, Islam would have long per-

The battle of Karbala ended in blood, but it gave the world a message that still survives: truth does not die.

Muharram in Poonch's **Many Tongues**

From Punjabi elegies to Pahari chants, Poonch carries Muharram in the sound of many voices.

The hills of Poonch come alive each Muharram, not with the sound of a single language, but with the layered voices of

Here, remembrance speaks in Kashmiri, mourns in Punjabi, chants in Pahari.

It is a grief stitched into the land, shaped by the borders that cut through these mountains, vet softened by the ways people hold on to each other.

In this border district, Muharram is not just a religious observance. It is a memory kept alive in every dialect, a procession that carries history not only through footsteps but through words.

The streets fill with the cries of Ya Hussain, carried in Pahari songs, echoing in Urdu verses, folded into Kashmiri laments. Jaffer, a lifelong resident of

Poonch, finds comfort in this. "For generations, our majalis

gasidas in Urdu," he said. "It's not just ritual. It's how we remember. how our grandparents mourned." Across Jammu and Kashmir,

The people here move with a certain rhythm. When they say the juloos will begin at two in the afternoon and end by five, it happens that way.

a familiar sequence: the recitation of the Our'an the singing of praises, the telling of elegies, and the collective beat of mourning. There's a discipline to the sor-

row, a structure that seems to hold the weight of the grief. "This is our way," said one of the local organizers. "It keeps the

sanctity alive. It keeps us togeth-

The mornings during Ashura have their own tenderness.

After the pre-dawn meals, the Imambargahs open their doors early. Volunteers, many of them young, serve sehri to anyone who walks in. Rich or poor, local or traveler, it doesn't matter. They sit side by side, sharing the same food, preparing for the long day of remembrance.

"You don't have to call people twice here," Jaffer said. "They re-

turn on their own. It's part of their respect."

There is a kind of unsaid discipline in Poonch's Muharram that doesn't come from announcements or loud instructions. It seems to rise naturally from the people, from their deep sense of responsibility toward what they are remembering.

In many places, Muharram rituals are shown in ways that make them all look the same.

But Poonch does not follow expected patterns. The people here remember Karbala in ways that feel local, that feel close to their skin. They sing in their mother tongues, they recite in the language their grandmothers spoke.

This is not a loss of tradition. It is its survival.

When the processions pass through the narrow lanes, they carry more than flags and slogans. They carry the weight of belonging. They carry the promise that even in the smallest dialect, grief will find its voice.

And as the chants of Labbayk Ya Hussain rise from the streets of Poonch, they do not rise as many, hut as one

Iqbal's Pursuit of the Sacred in Karbala's ShadowIn Allama Iqbal's poetry, the love for Hazrat Ali and Hazrat Hussain is more than reverence. It is a bold reminder of courage, conviction, and the kind of faith the modern world often forgets.

n a world where faith is often measured by ritual, not courage, Allama ■ Igbal takes us back to the heart of Islam, a place where love is defiance

and resilience is worship. Iqbal's poetry is not content with praising from a distance. His devotion to Hazrat Ali [A.S.] is raw, urgent, and deeply personal. In his verses, Ali is not just the cousin of the Prophet Muhammad (peace be upon him) or the fourth caliph of Islam. Ali is the first Muslim, the king of the brave, and,

most of all, the gate to the city of love. But Igbal's admiration is not for titles. It is for Ali's life, his fierce courage, his unmatched simplicity, his stubborn refusal to be dazzled by the world's empty crowns.

Ali ate barley bread, slept on the bare earth, and yet carried the weight of armies on his shoulders. Iqbal does not idolize Ali because he was powerful. He loves him because Ali walked away from power when it meant losing his integrity.

In a time where people chase status and influence, Iqbal's obsession with Ali cuts sharply against the grain. For Iqbal, the power worth chasing is not the power of empires. It is the power of self-mastery. "For me, the strength of Ali is enough," he writes. "Let others chase the sharpness of Plato's mind."

It is this strength, Iqbal believes, that moves history forward, not grand speeches or clever philosophies. In a line that burns with pride, he writes that the wealth of faith is to love Ali. It is not a metaphor. It is his faith.

Iqbal never hides his own faults. He admits he is far from pure. But his heart, stained as it may be, holds one thing tightly—the love of the Prophet's family, the Ahle Bait.

He believes this alone might be enough to save him. He writes that he carries the mark of this love on his heart and imagines Ali searching for him, ready to offer shelter.

In Kashmir, where the love of Ahle Bait still shapes the rhythm of mourning processions and shapes stories passed from grandmothers to grandchildren, Iqbal's poetry is more than literature. It is a heartbeat.

His verses remind Kashmiris, and perhaps all Muslims, that faith is not just in rituals. It is in standing firm when the world leans the other way. Iqbal's devotion is not bound to Hazrat Ali alone. It flows through to Hazrat Hussain, Ali's son, the man who stood alone on the plains of Karbala and refused to bow to tyranny.

Hussain's death is often seen as tragedy. But for Iqbal, it is something else. It is Islam's proudest moment of resistance. Hussain's refusal to submit made him the beating heart of truth.

Igbal's words capture this sharp and sacred link: "Allah, Allah! The father belongs to Bismillah, the son to the meaning of sacrifice."

Ali stands for the opening of love; Hussain becomes the full expression of it, a sacrifice that does not break, but builds. Even in one of his most precise

reached its fullness with Hussain." It is an unbroken chain of courage and submission to truth, passing from the knife held over Ismail to the sword

and colorful. It began with Ismail and

age, in every heart. The choice between surrendering to falsehood or standing firm with dignity is not ancient history. It is a present-day decision. His anger at those who speak ill of Ali

is not rhetorical. It is personal. He wonders how those who claimed to love the Prophet still found room to hate Ali.

And if Ali was not spared by his own people, why would Iqbal, a mere servant of Ali, expect anything better?

In today's world, where political calculations often matter more than principles, where many choose comfort over standing firm, Iqbal's love for Ali and Hussain is a provocation.

It pushes us to ask: Who are we really standing with? What are we really defending?

For Iqbal, the answer was never complicated. The love of Ali and Hussain is not a soft love. It is not ornamental. It is a fire that burns down falsehood, a courage that stands alone if needed, and a wealth that no empire

It is a love that still has the power to reshape hearts. Even now. Even here.

Study Finds Human Brain Cells Continue To Form Into Late Adulthood

study has shown that neurons or nerve cells continue to form well into late adulthood in the brain's hippocampus, which manages memory -- a finding that presents compelling new evidence about the human brain's adaptability.

Neurogenesis -- a process whereby new neurons are created -- is said to continue throughout one's life, even as the rate is considered to slow down with age.

However, researchers from Karonlinska Institutet in Sweden said the extent and significance of neurogenesis is still debated with no clear evidence of cells that precede new neurons -- or 'neural progenitor cells' -- actually existing and dividing in adults.

"We have now been able to identify these cells of origin, which confirms that there is an ongoing formation of neurons in the hippocampus of the adult brain," Jonas Frisen, professor of stem cell research, Karolinska Institutet, who led the research published in the journal Science.

The team used carbon dating methods to analyse DNA from brain tissue, which made it possible to determine when the cells were formed. Tissue samples of people aged 0 to 78 were obtained from international biobanks, they said.

The results showed that cells that precede the forming of new neurons in adults are similar to those mice, pigs and monkeys, with differences in genes which are active.

The researchers also found large differences between individuals -some adult humans had many neural progenitor cells, others hardly

Frisen added that the study is an "important piece of the puzzle in understanding how the human brain works and changes during life", with implications for developing regenerative treatments in neurodegenerative and psychiatric disorders.

A steady loss of neurons resulting in an impaired functioning and

eventually cell death is said to drive neurodegenerative disorders, which affects the hippocampus, among other brain regions. Risks of the disorders are known to heighten with age.

For the study, the researchers used a method called 'single-nucleus RNA sequencing', which looks at activity of a gene in a cell's nucleus.

This was combined with machine learning (a type of AI) to discern varied stages of how neurons develop, from stem cells to immature neurons, many of which were in the division phase, the team said.

"We analysed the human hippocampus from birth through adulthood by single-nucleus RNA sequencing. We identified all neural progenitor cell stages in early childhood," they wrote.

"In adults, using antibodies against the proliferation marker Ki67 and machine learning algorithms, we found proliferating neural progenitor cells," the authors wrote.

"The results support the idea that adult neurogenesis occurs in the human hippocampus and add valuable insights of scientific and medical interest," the study said.

'Stimulating Brain With Weak Electric Currents May Help Improve Learning Maths'

new study in young adults has found that stimulating the brain with safe electric currents may help them solve mathematical problems more efficiently.

Researchers, led by those at the University of Surrey, UK, found that applying safe, painless electric currents to the brain's dorsolateral prefrontal cortex—which helps with learning, memory and focus—improved mathematical problem-solving abilities in people aged 18 to 30.

The dorsolateral prefrontal cortex is located on the outer surface of the frontal lobe, which is at the front of the head behind the forehead.

"A growing body of research has shown that biological factors often explain educational outcomes in mathematics more powerfully than environmental ones," said Roi Cohen Kadosh, head of the University of Surrey's school of psychology and lead author of the study published in the journal PLOS Biology, said.

The author pointed out that efforts to improve education have primarily focused on environmental factors, such as training teachers and redesigning curricula, while largely ignoring the neurobiology of the learner.

'Transcranial random noise stimulation' -- a non-invasive technique that involves delivering weak electrical currents to the brain via electrodes placed on the scalp -- is being studied for how it can impact brain activity, such as improving cognition, depressive symptoms and reducing pain.

Seventy two adults took part in a five-day maths training programme -- 24 received transcranial random noise stimulation to the dorsolateral prefrontal cortex, 24 to the posterior parietal cortex, and 24 received a sham version of the treatment (placebo).

The posterior parietal cortex, which helps process information received via



one's senses, is located in the parietal lobe at the top rear of the head.

Brain scans revealed that people with a stronger connection between the dorsolateral prefrontal cortex (which helps focus and learn) and the posterior parietal cortex performed better in mathematical tasks.

However, for those having a weak connection between these brain regions, providing safe electric currents to the dorsolateral prefrontal cortex significantly improved learning, the researchers said.

Improvements were also related to lower levels of GABA in the dorsolateral prefrontal cortex. GABA is a brain chemical that works to stabilise newly acquired information and is, therefore, crucial to learning and memory.

"By integrating insights from psychology, neuroscience and education to develop innovative techniques that address neurobiological constraints, we can help more people reach their potential, broaden access to diverse career pathways and reduce long-term inequalities in income, health and wellbeing," Kadosh said.

The team emphasised that while previous studies have highlighted the role of brain regions -- dorsolateral prefrontal cortex and posterior parietal cortex -- in mathematical learning, their study sheds light on how these regions play a causal role in a critical academic skill.

"Our multimodal approach elucidates the causal role of the (dorsolateral prefrontal cortex) and frontoparietal network in a critical academic learning skill," the authors wrote.

Microsoft Shuts Its Pakistan Office After 25 Years, Sparks Economic Concerns

KARACHI: Tech giant Microsoft has announced to shut down its limited operations in Pakistan as part of its global strategy to reduce workforce, which various stakeholders termed on Friday as a "troubling sign" for the

country's economy.

Microsoft, while closing its office in Pakistan on Thursday after 25 years, cited global restructuring and a shift to a cloud-based, partner-led model.

The move came as the tech giant cut roughly 9,100 jobs worldwide (or about 4 per cent of its workforce) in its largest layoff round since 2023.

Jawwad Rehman, former founding Country Manager of Microsoft Pakistan, urged the government and IT minister to engage with the tech giants with a bold KPI (Key Performance Indicators) driven plan.

He said the exit reflected the

current business climate. "Even global giants like Microsoft find it unsustainable to stay," he posted on LinkedIn.

Former Pakistan president Arif Alvi, in a post on X, also expressed concern over Microsoft shutting down operations.

"It is a troubling sign for our economic future," he wrote. He claimed Microsoft once considered Pakistan for expansion, but that instability led the company to choose Vietnam instead by late 2022.

"The opportunity was lost,"

he wrote.

Jawwad explained that Microsoft didn't operate a full commercial base in Pakistan, relying instead on liaison offices focused on enterprise, education, and government clients.

Over recent years, much of that work had already shifted to local partners, while licensing and contracts were managed from its European hub in Ireland.

Number Of Poor Rising, Wealth Getting Concentrated In Hands Of Some Rich: Gadkari

MUMBAI- Union minister Nitin Gadkari on Saturday expressed concern over the "rising" number of poor, and said wealth was getting concentrated in the hands of some affluent people.

There is a need for decentralisation of wealth, Gadkari said during an event in Nagpur, where he touched upon a range of issues, including agriculture, manufacturing, taxation and public-private partnerships in infrastructure development.

"Slowly the number of poor people is increasing and wealth is getting centralised in the hands of some wealthy people. It should not happen," the Road Transport and Highways Minister said.

The economy must grow in a manner that creates jobs and uplifts rural areas, he said.

"We are looking at an economic option that will create jobs and (give a boost to the) growth of the economy. There is a need for decentralisation of wealth, and many changes have happened in

that direction," he said.

The senior BJP leader also credited former prime ministers P V Narasimha Rao and Manmohan Singh for adopting liberal economic policies but cautioned against unchecked centralisation. "We have to be worried about it," he added.

Referring to India's economic structure, he pointed out the imbalance in sectoral contributions to GDP.

"Manufacturing contributes 22-24 per cent, services 52-54 per cent, while agriculture, despite engaging 65-70 per cent of the rural population, contributes only around 12 per cent," he said. Invoking Swami Vivekananda, Gadkari said, "Philosophy can-



not be taught to someone whose stomach is empty."

He highlighted the evolving role of chartered accountants, Gadkari said, "CAs can be the growth engines of the economy. Our economy is changing rapidly. It is not only about filing income tax returns and GST submissions." Talking about the infrastructure development, Gadkari highlighted his own initiatives in the transport sector.

"I was the one who started the Build-Operate-Transfer system for road construction," he claimed. There is no shortage of funds for road development, he added. "Sometimes I say I do not have a fund crunch but I have a shortage of work," Gadkari said.

"Now, we earn nearly Rs 55,000 crore through toll booths and in the next two years, our income will go up to Rs 1.40 lakh crore. If we monetise it for the next 15 years, we will have Rs 12 lakh crore. New toll will add more money to our coffers," he said. The minister also spoke about projects aimed at enhancing regional connectivity and investment.

"We are constructing a rope of Rs 5,000 crore in Kedarnath. The contractor is ready to spend the amount and give Rs 800 crore royalty to the Union government. When the Uttarakhand government asked us to share the royalty, I asked whether they would also share the loss-making units," he said.

'India's Rights In WTO To Retaliate On US Auto Tariffs Wont Affect Trade Deal Talks'

NEW DELHI- India's decision to reserve its rights to impose retaliatory duties on the US over imposition of tariffs on auto parts is a procedural move under the WTO agreement on safeguards and it will not affect ongoing negotiations on the proposed trade pact between the two countries, an official said.

India on Friday proposed imposing retaliatory duties under the WTO (World Trade Organisation) norms against the US over American tariffs on imports of the country's auto parts in the name of safeguard measures.

The proposed suspension of concessions or other obligations would take the form of an increase in tariffs on selected products originating in the US, according to a notification of the WTO being circulated at the request of India.

"The notification in WTO is an essential step to reserve India's right, in accordance with the provisions of the agreement on safeguard and does not prejudice ongoing discussions, deliberations, negotiations for finalizing tranche one or subsequent tranches of India-US bilateral trade agreement (BTA) in any way," the official told PTI.



The two countries have aimed to conclude the first phase of the BTA by fall (September-October) this year. The agreement is aimed at more than doubling bilateral trade to USD 500 billion by 2030 from the current USD 191 billion.

Both India and the US are

Both India and the US are signatories to the Agreement on Safeguard at the WTO which empowers a WTO Member to suspend its tariff concessions to another member who introduces safeguard measures on its imports.

On 26 March 2025, the US announced a 25 per cent ad valorem tariff on the import of automobiles and on certain automobile parts, including, from India under Section 232 of the Trade Expansion Act, 1974.

"India treated it as a safeguard measure and gave a notice for consultation under the WTO agreement earlier. Now, as per the provisions of that agreement, after completion of 30 days period for consultation, as a next step, India has notified that it is reserving its right to suspend concession on equivalent US exports to India as a response to enhanced tariff of 25 per cent imposed by the US on Indian exports of auto components," the official said.

Before the first phase, India and the US are negotiating to finalise an interim trade agreement before July 9, which marks the end of the 90-day suspension period of the Trump tariffs imposed on dozens of countries including India.



India's First National Cooperative University Will End Nepotism In Sector, Training Vacuum: Shah

ANAND (GUJARAT)- Union Home and Cooperation Minister Amit Shah on Saturday said India's first national university for cooperatives coming up in Gujarat will work to end nepotism as only persons trained by it will get jobs in this sector in the future.

Shah was addressing a gathering at the campus of Anand Agriculture University after laying the foundation stone of Tribhuvan Sahkari University (TSU) that will be built on a 125-acre plot at a cost of Rs 500 crore.

The university has been named after the late Tribhuvandas Keshubhai Patel, one of the pioneers of the cooperative movement in India who was instrumental in laying the foundation of Amul. Born on October 22, 1903, in Kheda in Anand, Patel died on June 3,

"The upcoming university will work to address the allegations of nepotism in this sector. Unlike the past, when people were first hired and then trained, only trained people will get jobs in this sector in the future," Shah said.

The Union minister said the university will also address the existing "weaknesses" in this sector and fill the training gaps in the domain that engages ev-

ery fourth person of the country, or about 30 crore people.

He said the cooperatives sector in India has no dearth of talent and what the country requires now is trained man-

TSU will fill this "mega vacuum" which has stopped the progress of this sector, he said.

Shah also sought to address criticism from some quarters about the upcoming university not being named after Dr Verghese Kurien, the father of the White Revolution, saying his role in the cooperatives sector can never be denied.

"Patel sahab (Tribhuvan Patel) enlightened and nurtured the cooperative movement... it was his vision that the sector is standing strong today," he said.

Standing strong today, he said.

Shah said it was Patel who sent Kurien to study in the Netherlands, adding those "who say that Kurien's contribution to this sector was not being acknowledged were the ones who did nothing to celebrate his birth centenary".

It is Amul that is celebrating his legacy, he said.

Congress leaders who raised such questions do not know that Patel was from their party. The BJP did not even exist then, the minister said.

Shah said the TSU will not only produce a talented work-force but also leaders like Patel for the cooperatives sector.

Nearly Half Of MSMEs Polled Prefer UPI For Business Transactions, Says Report

MUMBAI- Nearly half of MSMEs surveyed prefer UPI as a mode of transaction to grow their business, followed by Aadhaar-enabled banking, says a report.

According to the MSME Digital Index Report by PayNearby, digital payments continue to gain strong acceptance among MSMEs, with UPI emerging as the most preferred mode of transaction at 48 per cent, followed by Aadhaar-enabled banking at 39 per cent.

Among women entrepreneurs, Aadhaar banking saw even higher preference at 42 per cent, reflecting increasing trust in secure, tech-enabled services such as fingerprint and face authentication, the report said.

The report is based a nationwide survey conducted among 10,000 individuals and MSMEs in retail-focused segments such as kirana stores, mobile recharge outlets, medical shops, customer service points (CSPs), and travel agencies.

It found that smartphones have emerged as primary business device at 71 per cent while among women, it is even higher at 84 per cent.



On benefits from digital adoption, a third of respondents cited improved operational efficiency, while over 73 per cent of small businesses across semi-urban and rural India have seen increased income or improved operational efficiency as a result of adopting digital tools.

"A small but notable 7 per cent of respondents have begun exploring automated or Al-powered tools, including inventory apps, automated billing systems, and customer engagement platforms, mostly through third-party solutions," the report said.

Anand Kumar Bajaj, Founder, MD & CEO, PayNearby, said, "The MSME sector is the backbone of Bharat's economy, and the rapid adoption of digital tools such as smartphones, UPI, Aadhaar-enabled banking, and emerging AI workflows is proof that this segment is embracing modernisation."

India, Maldives Hold Talks To Deepen Trade And Investment Ties

Market Manipulation Is Not Going To Be Tolerated: Sebi Chairman Pandey

MUMBAI- Capital markets regulator Sebi chairman Tuhin Kanta Pandey on Saturday made it clear that market manipulation is not going to be tolerated.

Speaking with reporters a day after an interim order against New York-based hedge fund manager Jane Street, Pandey said surveillance has been increased both by the regulator and also at the exchange level.

When asked if similar patterns have been seen with other foreign portfolio investors as well, Pandey said, "All what I can say that market manipulation is not going to be tolerated". Sebi on Friday barred US-based Jane Street Group from the securities markets and directed the group to disgorge unlawful gains of Rs 4,843 crore for allegedly manipulating stock indices through positions taken in the derivatives segment.

This could be the highest disgorgement amount ever directed by the Securities and Exchange Board of India (Sebi). In its interim order, the regulator has debarred JSI Investments, JSI2 Investments Pvt Ltd, Jane Street Singapore Pte Ltd, and Jane Street Asia Trading -- entities collectively referred to as the Jane Street Group -- from trading until further notice, while continuing its investigation.

Pak, US Conclude Critical Round Of Trade Negotiations

SLAMABAD- Pakistan and the US have concluded a critical round of trade negotiations, reaching an understanding on a deal that could shape the future of the country's key export sectors, a media report said on Saturday.

While both sides have reached an understanding, a formal announcement is expected only after the US concludes similar ongoing negotiations with other trade partners, Dawn News reported.

The understanding was reached with less than a week before the July 9 deadline to conclude the talks in Washington, where Commerce Secretary Jawad Paal led the Pakistan delegation to finalise a long-term reciprocal tariff agreement that would prevent the re-imposition of a 29 per cent tariff on Pakistani exports, primarily textiles and agricultural products.

The tariff relief, temporarily paused earlier this year, was at risk of expiring if no progress had been made by July 9. Officials familiar with the negotiations said the four-day talks were successful, with both sides agreeing to a broad framework.

The agreement, when signed, could lead to increased Pakistani imports of US goods — notably crude oil — and potential American investment in Pakistan's mining, energy, and infrastructure sectors.

Govt Slashes Toll Rates by Up to 50% on Highways with Bridges, Tunnels

New Delhi: The government has reduced the toll rates up to 50 per cent for the sections of National Highways that have structures like tunnels, bridges, flyovers or elevated stretches, a move which will lower travelling

cost for motorists

User charges at fee plazas on National Highways are collected as per NH Fee Rules, 2008. The Ministry of Road Transport and Highways has made amendment to 2008 rules and notified a new method or formula for calculating toll charges.

"The rate of fee for use of a section of national highway comprising of structure or structures shall be calculated by adding ten times the length of structure or structures to the length of the section of national highway excluding the length of structure or structures, or five

times the total length of section of national highway, whichever is lesser," said the notification dated July 2, 2025.

'Structure' means an independent bridge, tunnel or flyover or elevated highway.

To explain the new toll charges, the ministry has cited examples.

In one of the examples, it said that if a section of a national highway has a total length of 40 kilometers, comprising of structure alone, the minimum length shall be computed: '10 x 40 (ten times length of structure) = 400 kilometers or five times the total length of section of a national highway =

 $5 \times 40 = 200 \text{ kilometers'}.$

"User fee shall be calculated on the lesser length i.e. for 200 kilometers" and not 400 kilometers. In this case the user charge is only on half (50 per cent) of the road length.

According the extant rules, users pay ten times the regular

toll for every kilometre of structure on national highways.

A senior official of National Highway Authority of India (NHAI) said the existing toll calculation method was meant to offset higher construction cost associated with such infrastructure.

"We have received a lot of phone calls from worried parents and students urging us to consider an extension in summer vacations due to the persistent heatwave," she told reporters.

The Minister, according to Kashmir News Trust, said the government is closely monitoring the situation and a final decision would be taken today (Sunday) after reviewing weather conditions. "If the heatwave continues, we will announce an appropriate decision in the interest of children's health and well-being," she said

Expressing concern over the extreme weather, Itoo said she hoped for rainfall and divine intervention. "We pray for rain and hope Allah shows mercy upon us. The well-being of our students remains our top priority," she added.

The summer break for government and recognized private schools is scheduled to end today, but with record temperatures reported from several areas, pressure on the administration to extend the holidays has intensified.

DM Lays Down Conditions

The District Magistrate Srinagar has issued a formal order granting permission for the 10th Muharram procession, scheduled for July 6, 2025. The permission was sought by the J&K Shia Association, which had proposed an alternate route for this year's procession. However, the district administration has denied the request for the alternate route and allowed the procession to take place only on the traditional path through Gasiyar Zadibal.

According to the official order, the Shia Association had submitted an application requesting permission to carry out the Muharram procession from Bota Kadal to Zadibal via Mill Stop and Firdous Cinema. The application was examined by the district authorities and forwarded to the Senior Superintendent of Police (SSP), Srinagar, for comments. In response, the SSP Srinagar, in a communication dated July 4, 2025, advised against allowing the procession on the proposed alternate route due to unspecified security concerns.

In line with the SSP's recommendation, the District Magistrate denied permission for the procession to pass through the proposed route. However, the administration granted approval for the procession to be held along the old route from Bota Kadal to Imambara Zadibal. The route includes Alipora Chowk, Syed Afzal Lane, Sharibhat, Alamgari Bazar, Gassiyar Chowk, and finally reaches the Imambara at

"The permission is conditional and subject to several guidelines laid out by the district administration. These include strict adherence to the approved route and a complete prohibition on any deviation. The organizers and participants have been directed not to indulge in any anti-national, anti-administration, or sectarian sloganeering or speeches. Any activity that disturbs communal, religious, or ethnic harmony will not be tolerated", order, a copy of which lies with Kashmir Observer, reads.

Furthermore, the order bars any actions that could harm the sovereignty or security of the state. Participants are also prohibited from disrespecting national symbols or emblems. "Flags carrying provocative slogans, images of terrorists, or logos of banned organizations — whether national or international — will not be allowed. The procession must also avoid causing any damage or defacement to public or government property", it further said.

The administration has asked the organizers to fully cooperate with the police and security

forces and ensure that the procession does not obstruct regular traffic or emergency services. Organizers are also required to provide in advance the details and numbers of participating dyaras (mourning circles) and volunteers to the SP City Hazratbal.

Use of drones during the procession has been strictly banned. Additionally, installation of any public address systems, loudspeakers, or stages that may cause inconvenience or disturb the general public has also been prohibited.

The District Magistrate warned that any violation of these conditions will result in strict legal action. "The decision reflects the administration's approach of allowing religious processions within a framework of law and order, ensuring both religious freedom and public safety. While the denial of the alternate route may disappoint some, the granting of permission for the traditional procession route is being viewed as a continued step towards cautious normalization of religious activities in the region", the order further said.

In central Kashmir's Budgam District, According to Anjuman Sharie Shiayan two major processions will be taken out from Imambargah Mirgund to Imambargah Budgam and Dargah Bab-ul-Hawaij to Imambargah Hajipora

"The biggest procession in Budgam will be taken out from Jamia Babul Ilm Mirgund at 9 am in the morning to Imambargah Budgam," Anjuman said.

Small scale processions are expected in other Kashmir districts of Ganderbal, Baramulla, Anantnag, Pulwama, Kulgam and Sopore. A mourning procession is planned in Jammu city as well besides other districts of Jammu province.

BIRMINGHAM: Shubman Gill's insatiable appetite for runs resulted in a second hundred of the game as India set an impossible 608-run target, throwing down the gauntlet to England's Bazballers who were staring down the barrel going into day five of the second Test here.

Gill (161 off 162 balls) turned himself into a virtual 'Run Ma-chine', smashing his third hundred in four innings following his epic 269 in the first essay.

The other contributions in the second innings came from Ravindra Jadeja (69 not out), Rishabh Pant (65) and KL Rahul (55) as India declared their second innings

The Indian pacers once again got the new ball to talk with Akash Deep accounting for the dangerous Ben Duckett and the dependable Joe Root while and Mohammed Siraj had Zak Crawley caught at backward point with a full outswinger, reducing the hosts to 72 for three in 16 overs at

The timing of India's declaration, that came one hour after tea, was questioned by the experts and fans alike with the likes of Cheteshwar Pujara saying on air that India should have declared at least half hour earlier.

The England fans in the fabled Hollies stand chanted 'boring boring' when declaration was not announced despite Gill's dismissal. The booing followed soon after. Gill, who got to three figures

at the stroke of tea, stepped up his offensive against the spin duo of Shoaib Bashir and part timer Joe Root, employing the sweep to deep square and mid-wicket fence regularly.

His innings included 13 fours and eight sixes and took his match tally of runs to 430, surpassing the great Sunil Gavaskar's record (344 against West Indies at Port of Spain in 1971) for most runs by an

He also became the second Indian after Gavaskar to get a 200 and 100 in the same Test.

The wickets have been flat and

Gill brought up his second consecutive century and third of the ongoing tour of England while crossing the 500-run aggregate in only fourth innings of the five-match series on Saturday.

The 25-year-old captain struck 13 fours and eight sixes to make 161 off 162 balls, following up his first-innings' 269 to become only the second Indian after legendary Sunil Gavaskar to have scored a double century and a ton in a Test.

"Well played star boy. Rewriting history. On-wards and upwards from here. You deserve all of this," wrote Kohli, who retired from Test cricket a month before the England tour and is now settled in London.

Gill amassed 430 runs in the two innings of the second Test, which is also the second highest aggregate ever from a batter in a match following Graham Gooch's 456 runs (333 and 123) against India at Lord's in 1990. (PTI)

ndian javelin superstar Neeraj Chopra on Saturday clinched the inaugural NC Classic as he realised his dream of hosting and competing in a world class event in front of the home crowd and family members.

The 27-year-old double Olympic medallist emerged winner with his third round throw of 86.18m at the Sree Kanteerava Stadium watched by his parents. This was his third straight title, having won in Paris Diamond League (June 20) and Golden Spike in Ostrava, Poland (June 24).

Kenya's 2025 world champion Julius Yego was second with 84.51m while Rumesh Pathirage (84.34m) of Sri Lanka was third.

BCCI, BCB Agree To Defer White Ball Series In Bangladesh

NEW DELHI: The Bangladesh Cricket Board (BCB) and the Board of Control mutually agreed to defer the white-ball series between Bangladesh and India, which was scheduled to be held in August 2025 to September 2026.

The away series was to feature three ODIs and three Twenty20 Internationals to be played from August 17 to 31 in Chittagong and Dhaka.

'This decision has been reached following discussions between the two Boards, taking into account the international cricketing commitments and scheduling convenience of both teams," the BCCI said in a release

The BCB said the fresh schedule of the series will be announced in "due

"The BCB looks forward to welcoming India in September 2026 for this eagerly

anticipated series. Revised dates and fixtures for the tour will be announced

in due course," the release said. While the two boards pinned the reason for deferring the series to scheduling inconveniences, the PTI had reported on July 4 that the BCCI wanted the series to be rescheduled since it was wary of the security situation in Bangladesh which is in turmoil since last year's civil unrest that resulted in the overthrow of the Sheikh Hasina-led government.

It is understood that the BCCI wanted the tour to go ahead only after the general elections are held in Bangladesh and "a stable government is in place taking care of the law and order situation."

Chelsea Completes Signing Of Winger Gittens From Dortmund

helsea completed the signing of English winger Jamie Gittens from Borussia Dort-mund on Saturday for a reported initial fee of 48.5 million pounds (\$66 million).

Known as Jamie Bynoe-Gittens when he made his Dortmund debut in 2022, the winger announced last year he wanted to be known simply as Jamie Gittens. He said he was following the example of his father, who also uses part of his full surname.

Liverpool Players Join Family Of Diogo Jota For Funeral In Portugal

GONDOMAR (PORTUGAL): Liverpool players joined family and friends for the funeral of their teammate Diogo Jota and his brother on Saturday, two days after the siblings died in a car crash in Spain.

The service will be held at Igreja Matriz church in the Portuguese town of Gondomar, where Jota had a home.

Portugal's national team coach Roberto Martínez and several top Portuguese players also attended, including Manchester City duo Bernardo Silva and Rúben Dias and Man-

chester United's Bruno Fernándes. Jota, 28, and his brother, André Silva, 25, were found dead near Zamora in northwestern Spain early Thursday after the Lamborghini they were driving crashed on an isolated stretch of highway just after midnight on Thursday and burst into flames.

The brothers were reportedly heading to catch a boat from northern Spain to go to England where Jota was to rejoin with Liv-

erpool after a summer break. Spanish police are investigat-



ing the cause of the crash, which did not involve another vehicle, they said. They said they believe it could have been caused by a

blown tire. Their bodies were repatriated to Portugal after being identified by the family. A wake was held for

them on Friday. Jota's death occurred two weeks after he married longtime partner Rute Cardoso while on vacation from a long season where he helped Liverpool win the Premier League. The couple had three children, the youngest born last year.

Jota was born in Porto but started his playing career as a child on nearby Gondomar.


