J&K Hajj Pilgrims Protest Short **Stay, Demand Compensation**

Srinagar: Several Hajj pilgrims from Jammu and Kashmir have expressed deep disappointment over the unexpected curtailment of their stay in Saudi Arabia, calling it a disruption to their spiritual journey and a cause of financial loss.

In a formal representation submitted to the Executive Officer of the J&K Haj Committee, the affected pilgrims stated that they were initially scheduled for a 40-day stay in the Kingdom of Saudi Arabia. However, their return was advanced by several days without prior notice.

"Only the batch that departed on May 30 was affected," the representation said, adding that all other pilgrims were allowed to complete their full scheduled stay. "This sudden change resulted in irreparable spiritual loss, as the final days in the holy city are considered highly sig-nificant for prayers, especially at Masjid Al-Haram."

The pilgrims also pointed out that despite paying higher charges compared to pilgrims from other Indian states or countries, they were offered fewer facilities and a shortened Hajj experience.

"For many of us, this was a once-in-a-lifetime opportunity," said Iftikhar Qadri, one of the pilgrims. "The final few days in Makkah hold immense religious value, and we were deprived of that spiritual fulfilment."

In addition to seeking a formal inquiry into the decision, the pilgrims have demanded financial compensation and accountability from those responsible. They also urged authorities to compensate pilgrims who were housed in accommodations outside the central Markazia area, which is considered | More On P6

<u>'Illegal Drug Trade In J&K'</u>

License Of 4 Pharma **Firms Cancelled**

Srinagar: Authorities in Jammu and Kashmir have cancelled the licenses of four pharmaceutical firms allegedly involved in the illegal purchase and sale of habitforming drugs, officials said on Saturday.

The action was initiated by State Drugs Controllercum-Licensing Authority Lotika Khajuria, following inspections of multiple wholesale establishments across the Union Territory.

According to an official spokesperson, enforcement action was taken against Healthways Pharma (Rajouri), Nuegene Pharmaceutical Distributors and N T Traders (Baramulla), and Essence Pharmaceutical Distributors (Srinagar) after they were found to be indulging in "clandestine purchase and sale" of narcotic pharmaceutical preparations, particularly Tapentadol and Pregabalin.

The firms were allegedly sourcing these drugs from neighbouring states without maintaining the mandatory purchase or sale records, violating regulatory protocols designed to prevent the misuse of such substances.

"These drugs are highly addictive and fall under strict regulatory control," the spokesperson said. "The absence of proper documentation and | More On P6

Fuel Cutoff, Pilot Confusion Led To Deadly Air India Crash: Report

New Delhi: Seconds before Air India flight 171 crashed while ascending from Ahmedabad, the fuel control switches of both its engines were cut off, a preliminary investigation report said on Saturday, suggesting a catastrophic pilot error in the cockpit of the Boeing 787 Dreamliner.

Airlines Pilots The Association of India disagreed with the report, saying the investigation is "shrouded in secrecy," appears to be biased against the pilot and has come to a



AIR INDIA DID NOT CARRY OUT INSPECTIONS recommended in the 2018 FAA advisory on fuel control switch safety conclusion hastily.

A 15-page preliminary investigation report into the disaster revealed fuel-control switches of the two engines moved from the 'run" to the "cutoff" position, within the space of one second, leading to im-mediate loss of altitude. In the cockpit voice re-

cording, one pilot is heard asking the other why he cut off the fuel. The other denied having done so.

The report by Aircraft Accident Investigation Bureau (AIIB), released early on Saturday, neither concluded any reason for

the switches moving nor apportioned explicit blame for the crash.

It also did not identify the pilots in the voice recording. But it also said no fault was found in the aircraft, leaving only the possibility of pilot error as the cause.

At the controls was First Officer Clive Kunder, 32, while Sumeet Sabharwal, a veteran with 30 years of experience at Air India, was the senior cockpit occupant in command monitoring the flight.

¬o the world, he may be seen as extraordinarily lucky. But to 40-year-old Vishwas Kumar Ramesh, the lone survivor of the Air India crash on June 12, survival has come at an unbearable cost.

an Indian-origin Vishwas, British national, was the only person to walk away alive after Flight AI171, a London-bound Boeing 787 Dreamliner, crashed seconds after taking off from

Ahmedabad's Sardar Vallabhbhai Patel International Airport. The crash claimed the lives of 241 passengers and crew members on board and 19 people on the ground. Among the dead was his younger brother, Ajay.

Vishwas was seated on 11A, near the emergency door on the left side of the aircraft. That detail, seemingly insignificant at the time of boarding, likely saved his life.

Fire Guts Cable Network Shop In Hassanabad

or many young Kashmiris, the future feels uncertain. Unemployment remains high, even among the most educated. School curriculums often lag behind the demands of a rapidly changing world. And opportunities to learn practical, modern skills, particularly in technology, are few and far between.

That's what makes the launch of a 24-hour student hackathon in Srinagar so important. Open to schoolchildren and first-year college students, the event offers hands-on training in coding, artificial intelligence, and collaborative software development. It is a window into a world most young Kashmiris rarely see.

The program is simple in form, yet ambitious in purpose. Beginners start with Scratch, a visual language that teaches the logic behind programming. Others move on to more advanced concepts, including large language models and version control systems.

But what matters most is not the syllabus. It is the invitation, to think differently, work in teams, and build something new.

In many parts of India, such programs have become common. But in Kashmir, they remain rare. And yet they are exactly what the region needs.

The jinx of joblessness in Kashmir is staggering. Young people, even those with degrees, struggle to find work. Government jobs are scarce and private industry is limited. In such a setting, the ability to code, even at a basic level, can open new paths, whether through remote work, freelancing, or further study.

There is no reason events like this one should be isolated. Schools, nonprofits, and local governments could organize similar programs in classrooms, community halls, or public libraries. Mentorship need not come from elite institutions. It can come from within the community, from young professionals willing to share what they know.

Technology alone will not solve Kashmir's problems. But teaching young people how to use it, to solve problems, express ideas, and build things that matter, is a step in the right direction. It gives them tools not just for employment, but for agency.

n Jammu and Kashmir, a revolution is being scripted, on paper, at least.

The government has launched WALHARUS, an ambitious project to digitize all land records in the Union Territory.

In theory, this is a leap forward: a system where landowners can finally access their records with a few clicks, corruption can be curbed, and disputes resolved with clarity and speed.

But here's the catch: in vast stretches of rural Kashmir, the very people tasked with bringing this digital vision to life, patwaris, are working without electricity.

Yes, you read that right. The people asked to scan, verify, and upload generations of land records into a sleek new online system often don't even have a plug point to charge a laptop.

This isn't a minor logistical hiccup. It's a fundamental contradiction. You cannot digitize in the dark.

Across districts like Kupwara, Doda, Poonch, Anantnag, and Kulgam, many Patwar Khanas, the modest offices that house land records, are barely functioning. Some are tucked away in rented private homes. Others are squatting in borrowed rooms of panchayat buildings.

Many don't have working bathrooms. Some don't have doors that lock. And most damningly, dozens still don't have steady electricity or internet access

And yet, these are the same spaces expected to anchor a digital revolution

This isn't just about inconvenience. It's about the integrity of governance

A system meant to bring transparency and efficiency is being built on foundations so fragile they can barely hold a file cabinet, let alone a server.

It gets worse.

The patwari of today is not the record-keeper of the past. He

is expected to be a digitization officer, data entry clerk, public service agent, and village-level IT technician.

That's abandonment.

What happens when you demand digital compliance without providing digital conditions?

A Valley Reimagined

In a place shaped by conflict and contradictions, peace demands more than silence. It needs empathy, education, and the will to see each other as human beings first.

he idea of peace is both intimate and elusive in Kashmir. You hear it in prayers at dusk, feel it in the hush of snowfall, and see it vanish in the blink of a news headline.

We talk about peace often, but rarely do we ask: what does it take to build a peaceful society in a region like ours-torn between memory, politics, and survival?

There are no shortcuts. The foundations of peace aren't laid with grand speeches or security deployments.

They begin, instead, with how we think, what we teach, and how we treat one another.

Let's start with mindset. Too often, we wear labels before names: Shia, Sunni, Pandit, Gujjar, Bakarwal, rich, poor, English-medium, government-school. These categories don't just define us, they divide us.

In a place where trauma runs deep, such divisions feed mistrust and distance

But imagine if we drop those filters. If we see each other first as people trying to live, love, and provide. Perhaps the walls between us wouldn't feel so high

In Srinagar's SMHS hospital not long ago, two patients were brought into the emergency ward. One was a man from Baramulla, the other a woman from Anantnag. Both needed urgent care. The woman's son, seeing the older man struggle to breathe, told the nurse to treat him first. "He's worse," he said simply.

In that moment, there was no region, no religion, just instinctive compassion. That's where peace begins, in the small human gestures that go unnoticed and uncelebrated.

But compassion needs cultivation, and that brings us to education.

Kashmir has a literacy rate of nearly 68%, according to government figures, but how much of that education nurtures values like empathy, cooperation, or mutual respect?

In schools across the valley, children are taught about resolution through history, but rarely about prevention through kindness.

The syllabus may include Newton's laws and Mughal dynasties, but rarely addresses how to comfort a grieving friend or help a neighbour in distress.

What if schools taught these things too? What if moral education wasn't reduced to a period before lunch, but woven into every subject, story, and playground quarrel?

It's not about westernising or moralising. It's about humanising.

Children in Pulwama and Kupwara, in Sopore and Kulgam, deserve an education that teaches them how to live with dignity in a fractured world.

That won't just produce bet-ter students, it will shape better citizens.

And then comes respect that doesn't depend on someone's age, position, or power.

It's a human act shown when a shopkeeper listens patiently to a distressed customer, when a child offers his seat to an elder in public bus, when we speak gently to those who disagree with us.

Respect is not a grand ideal. It's a daily habit.

We must also learn gratitude that teaches us to value what we have, without waiting to lose it.

In Kashmir, where so many have lost so much, this isn't just a virtue. It's a necessity.

There's no denying that peace in Kashmir is tangled with history and politics. But politics alone cannot rebuild the social fabric. That work begins in our homes, schools, hospitals, and mohallas.

It begins when we speak to our children not just about career choices, but about conscience. When we tell them: it's good to succeed, but it's better to be kind.

hey say love is blind, but that's hard to believe in a place where a boy's heart is weighed by his job grade and a girl's worth is measured in kanals.

Today, in Kashmir, love walks into living rooms not with flowers or poetry, but with a sealed envelope from the SSRB or a certificate from JKAS.

In a Budgam borough, where the breeze still smells of damp earth and sun-dried apples, I recently asked a mother about her son's marriage plans. She smiled, almost apologetically, and said, "Woh abhi PSC ka intezaar kar raha hai. Pehle naukri lag jaye, tab baat aage badhegi." He's waiting for the Public Service Commission list. Only after that, she said, would they begin thinking about love.

This is no longer a personal worry. It's the collective rhythm now.

Today, that sorrow has been replaced by a fear far more pervasive: financial instability.

When Kashmir's Roads Were Built to Last

A forgotten blueprint from 2019–2020 shows how science and discipline, not just funds, can make roads in Jammu and Kashmir endure. It's time we return to it.

Roads in Kashmir have a reputation for giving up long before their time.

Asphalt peels, potholes bloom, and once-smooth stretches crack into webs of frustration. It's a familiar cycle that repeats with every season.

While many point to budget constraints, weather, or hurried contractors, the real story lies somewhere deeper, in what happens before the first truck even arrives with hot mix.

I've seen firsthand what makes a road last. And more importantly, what makes it fail.

Back in 2019, we launched a focused quality control and assurance (QA/QC) drive in Srinagar under the technical leadership of Er. Aijaz Masood Bhat, a former research officer at the Road Research and Material Testing Lab.

This wasn't just another campaign. It was a three-season-long attempt to prove something long considered unachievable: that Jammu and Kashmir could build roads that actually stay built.

It was a difficult time. Article 370 had just been revoked. Then came the COVID-19 pandemic. But even with all that, we carried out one of the most rigorous road-building exercises this region had seen in years.

Together with Executive Engineers Er. Javaid Iqbal and Er. Ishtiaq Malik, and field engineers like myself and Er. Nufail Gowhar Indrabi, we set out to beat the odds. Our focus was to perfect the mix.

For roads, that means getting the right gradation of bituminous mix



as per MoRTH (Ministry of Road Transport & Highways) standards. Sounds easy on paper, but in practice, most believed it couldn't

be done. Crushed aggregates are inconsistent. Plant feeding systems aren't always precise. Many engineers had simply accepted these limitations.

But Er. Aijaz refused to settle. Starting at the source, we tested aggregate samples from Hot Mix

aggregate samples from Hot Mix Plants, did sieve analysis on-site, and designed our own mixes using an Excel-based tool built around MoRTH gradation bands.

When we found that most plants were uncalibrated and feed rates were being adjusted manually (read: guessed), we introduced tachometers to measure and fix realtime flow rates.

This wasn't theoretical. It was dirty, hands-on work. But it paid off. Today, if you walk or drive down the Northern Foreshore Road, Ra-

jbagh Bund Road, or Maulana Azad Road in Srinagar, you'll see surfaces laid in 2019–2020 that still hold strong. There aren't any major potholes, no early erosion. That's not magic, that's method.

Unfortunately, that momentum didn't last.

Excel tools are collecting dust. Plant calibration is skipped. QA/QC enforcement is sporadic. Bitumenrich, dust-deficient mixes are being laid again. And roads are crumbling all over again. But bitumen is only one part of the story.

Overloading is crushing our roads. Trucks with excessive axle weights press down on roads not designed for such punishment, breaking down the subgrade and causing rutting.

This isn't just about enforcement. We need smarter, mechanistic subgrade designs that anticipate these loads.

Water is another enemy. Seepage from underground utilities, irrigation channels, or just high water tables weakens the base. It turns solid structure into mush. Without proper drainage, both surface and subsurface, no road can survive Kashmir's climate.

Drainage infrastructure is often missing or ignored. Blocked stormwater channels, misaligned slopes, and missing edge drains let water pool where it shouldn't. That water then chips away at the road from below.

And then there's the overlooked issue of overlays.

Many times, when a damaged road is overlaid without milling the surface first, the camber (or road slope) is ruined. Drainage suffers. Water gets trapped. The road lifts too high and the side drains get buried. Milling before overlaying is mandatory.

Another blind spot is how we monitor construction.

Often, the same person is expected to supervise both the Hot Mix Plant and the field execution site. It's impossible to do both effectively. We need a dedicated QA/ QC team for each site. That's how consistency is maintained. We also need to shift to weigh batching Hot Mix Plants. These machines measure materials with precision, reducing guesswork. They make feed control and quality enforcement easier and more transparent.

The solution doesn't need reinvention, it only needs implementation.

Every Hot Mix Plant must be calibrated using load-cell checks, with dry gradation analysis made mandatory before work begins.

Real-time feed rates should be tracked using tachometers and Excel-based tools to ensure mix accuracy.

Engineers in the field need both technical equipment and administrative support to enforce standards.

These practices must be institutionalized across all R&B divisions, with drainage planning and surface milling treated as essential steps in every project.

Finally, weigh batching plants should be prioritized, and staff trained to operate them effectively.

The roads we laid five years ago still stand. Not because we had extra money, but because we refused to compromise. We measured, analyzed, corrected, and treated engineering as a science, not a gamble.

If we return to that standard, we won't just save roads. We'll save public money, improve safety, and give the people of J&K the infrastructure they deserve.

It's not rocket science. It's just good engineering.

No More Backbenchers

When schools stop ranking kids by where they sit, real learning begins. Kerala shows how.



Sindh Waits for the Switch

Two mountain towns in Ganderbal are asking for policy attention. Their rivers have long powered homes, and could now drive Jammu & Kashmir's green future, if the Hydropower Policy 2025 keeps pace with the terrain.

The Nallah Sindh doesn't roar as it runs. It winds down from the glaciers of Sonamarg, cutting through steep ridges, feeding forests, villages, and hopes along its way. Every bend of this icy river has a story. And in Gund and Kangan, two towns tucked in District Ganderbal, many of those stories begin with power.

In a classroom somewhere in Kerala, children now sit in a Ushape. There are no front or back rows, just a circle of students looking at each other, and at the teacher, as equals.

It's a small change, born from a Malayalam film, Shanthaari Sreekutty. But the impact is turning heads in India's education circles.

Kashmir should be watching, too.

In most schools here, the backbench is a place of hiding. Whether in a government school in Kupwara or a private school in Srinagar, it's the same pattern: the bold students occupy the front rows, the hesitant ones recede to the back.

Over time, this seating becomes a symbol of status, confidence, and, un-fortunately, invisibility.

Teachers, often unknowingly, focus on those in front. The rest become spectators.

Kerala's idea is simple: rearrange the desks in a U or circle. Suddenly, everyone is part of the conversation. Everyone is seen.

This new approach is being adopted across the southern state. The aim is to break the rigid classroom hierarchy and move toward a model where discussion matters as much as instruction.

Experts say it helps dissolve the idea of "backbenchers" entirely. More importantly, it invites every student

into the learning process. The need for such a change is urgent in Kashmir.

While schools here have made strides in enrollment and infrastructure, the classrooms often remain stuck in the past: rows of wooden benches, a blackboard, a teacher who talks, and students who memorize. Interaction is limited, curiosity rarely rewarded.

This is not a criticism of teachers. Many of them are trying their best in difficult conditions. But the structure of the classroom itself discourages engagement.

Teachers have to work twice as hard to include students at the back. Many give up. The result is predictable: students tune out.

A U-shaped layout can do what no amount of scolding or seat reshuffling can: make learning feel equal.

It allows eye contact, creates a space where students are responding and thinking.

It also fits well with the New Education Policy 2020, which calls for more student-centered classrooms. According to the policy, learning should be active, not passive. But this vision can't be achieved if our class-

rooms still resemble 19th-century lecture halls. Of course, this seating model works

best in classrooms with around 20 to 30 students and enough room to move desks. That may not be possible everywhere in Kashmir right away. Decades ago, the Upper Sindh Hydel Projects I and II changed life here.

USHP-I, built in the late 1960s in Tehsil Gund, became a source of steady jobs and economic growth. Shops sprung up. Roads got better. Families who once relied only on farming found themselves working at power stations, selling produce to a growing workforce, or simply benefiting from more predictable electricity. Then came USHP-II in the early

1980s, built further downstream. Together, the two hydropower sta-

tions stood as rare examples of how local natural resources could be used without destroying the land or displacing people.

They're still operational, still part of the valley's electric grid, and still remembered in local conversations not just as projects, but as turning points.

But the flow of investment has slowed. A few micro-hydel units have come up, but their contribution remains small.

Researchers and energy analysts believe the untapped potential of the area's river systems could exceed 150 to 200 megawatts.

That's enough to power several towns – cleanly, efficiently, and locally. The Hydropower Policy 2025, announced by the J&K government, offers a roadmap to revive such efforts. It favours small and medium projects, public-private partnerships, and promises streamlined clearances. It also talks about creating local jobs and using natural resources sustainably.

On paper, it reads like a plan designed with Gund and Kangan in mind. But on the ground, little has moved.

Every year, thousands of liters of glacier-fed water rush through this region. The streams don't dry up in summer. The slopes are perfect for run-ofriver and gravity-based systems.

Unlike large dams, these setups don't need massive submergence anderbal rarely makes it to the top of development priority lists, even though it sits at the crossroads of energy, tourism, and agriculture.

or human displacement. Grid infrastructure is nearby. And the local workforce, shaped by past experience, is more than ready to work again.

What's missing is urgency, and recognition.

Ganderbal rarely makes it to the top of development priority lists, even though it sits at the crossroads of energy, tourism, and agriculture.

Using this region's potential isn't just about meeting Jammu & Kashmir's power needs. It ties directly to India's Sustainable Development Goals and its Net Zero 2070 commitment.

Clean energy is a necessity for climate reasons, energy independence, and regional growth.

Gund and Kangan offer something rare in infrastructure planning: natural feasibility.

Water flows year-round. There's minimal ecological cost. And there's an emotional, social legacy that still connects people to these projects.

When residents talk about USHP-I, they speak of it the way people elsewhere speak of old schools or ancestral lands, with memory and pride.

If the policy catches up with this reality, these twin towns could become Kashmir's model energy corridor.

If it doesn't, the region will continue exporting electricity without truly empowering itself.

The water is still flowing. The blueprints have been drawn. The history is on our side. The question is, will action follow?

Or will we, once again, let the river run on, and do nothing?

After 3 Decades

The return of lotus vegetation is being viewed by residents and officials as a major ecological and cultural comeback.

'This is nothing short of a miracle," Abdul Hameed, a local resident told PTI. "We used to disperse seeds ourselves, but it

never worked because of the silt. The lake had lost its capacity to support lotus growth."

The 1992 floods had choked Wular Lake with silt, severely degrading its ecosystem. Over time, the thick sediment buried the root structures of lotus plants, affecting the lake's ecology and the seasonal 'nadru' (lotus stem) economy that once supported hundreds of families.

Thanks to conservation efforts by the Wular Conservation and Management Authority (WUCMA) – including a large-scale desilting project using Cutter Suction Dredgers – the lake has begun to show signs of revival. Last year, preliminary signs of lotus regrowth were observed. This year, a targeted seed dispersal programme by WUCMA led to successful blooming across nearly three square kilometres of the lake.

"This revival was possible due to the removal of nearly 80 lakh cubic metres of silt from the lake," said Mudasir Ahmad, Zonal Officer at WUCMA. "We've managed to restore approximately five square kilometres of lake area and significantly increased its water-holding capacity."

According to Irfan Rasool, Chief Conservator of Forests, Kashmir Division, the return of lotus beds is a strong indicator of ecological recovery. "It's not just about the visual appeal — it signifies a functional shift in the lake's health. Sunlight now reaches the lakebed, allowing dormant root structures to grow again.

The comeback of the lotus also rekindles the hope of a return to nadru harvesting – a key seasonal livelihood in the region. The edible stems, considered a delicacy in Kashmiri cuisine, require workers to wade deep into the water to extract them.

"Nadru was non-existent in the lake for all these years," Ahmad added. "With the lotus back, people can now think of harvesting again. This will give a much-needed boost to the local economy.

According to PTI, beyond lotus restoration, WUCMA's work has also improved the overall aquatic environment. Better water depth and flow have contributed to greater biodiversity. According to Rasool, rare migratory birds have begun to return to the lake over the last two years. Sightings now include species such as the Great Bittern, Falcated Duck, Pacific Golden Plover, Horned Grebe, and Marbled Teal, among others.

yatris descending from Burimarg to Railpathri around 12:30 AM when he suddenly began to show signs of high-altitude sickness, including confusion and erratic behaviour."He reportedly began running aimlessly, took multiple coldwater showers, and ultimately jumped over a railing near Z-Morh," said a senior police officer, adding that the pilgrim is suspected to have fallen into a glacier-fed stream (nallah) in the area.

Upon receiving the alert, a joint rescue operation was launched involving Mountain Rescue Teams (MRTs) of JKAP, SDRF, ITBP, CRPF, NDRF, Village Guards, and the local police. Drone surveillance has also been deployed to assist in the search amid the challenging terrain and icy conditions.

As of Saturday evening, the search was still underway, with authorities hopeful of retrieving the body or finding any trace of the missing yatri."We suspect he may have been disoriented due to altitude sickness," said an officer involved in the operation. "The rescue teams are doing everything possible to locate him."

bulletin by the US Federal Aviation Administration that said fuel switches had been installed on Boeing 737s, a smaller model, "with the locking feature disengaged". The locking mechanism was similar on various Boeing aeroplane models, including certain 787s, it said.

Air India did not carry out inspections recommended in the 2018 FAA advisory on fuel control switch safety, as the bulletin was classified as "non-mandatory", the report said.

It wasn't immediately clear if this had any link to the accident. The report provided the first detailed account of the fateful 32 seconds between takeoff in Ahmedabad and the crash into a medical college hostel just outside the airport perimeter, killing all but one of the 242 onboard and another 19 on the ground in the deadliest aviation accident in a decade.

The report did not provide any clues to why and by whom the two fuel switches were moved to a cut-off position as the plane nosed into the air, starving the two engines of the thrust needed for the lift. It ruled out any bird hit or fuel contamination.

According to a chronology laid out in the report, both fuel cutoff switches moved from RUN to CUTOFF, one second apart, almost immediately after takeoff. Ram Air Turbine (RAT) pump was deployed to supply hydraulic power as both engines fell below the minimum idle rate.

About 10 seconds later, Engine 1 fuel cutoff switch moved to its so-called RUN position, followed by Engine 2 four seconds later.

The pilots managed to relight both engines, but only Engine 1 recovered while Engine 2 failed to build up enough power again to reverse deceleration. One of the pilots issued a "Mayday, Mayday, Mayday" distress call, but before air traffic controllers could get a response about what had gone wrong, the plane crashed just outside the Ahmedabad airport boundary having grazed some trees before plunging into a hostel packed with students.

The time between the takeoff and the crash was only 32 seconds. The preliminary report recommended no action for now for the operators of Boeing 787-8 planes. In a statement, Air India said that it "stands in solidarity with the families and those affected" and "[continues] to mourn the loss" of those killed in the accident. Air India said it was "working closely with stakeholders, including regulators" and "continue to fully cooperate with the AAIB and other authorities as their investigation progresses." On its part, Boeing said: "Our thoughts remain with the loved ones of the passengers and crew on board Air India Flight 171, as well as everyone affected on the ground in Ahmedabad. We continue to support the investigation and our customers.' The US National Transportation Safety Board noted that there were no recommended actions in the report aimed at operators of Boeing 787 jets or the GE engines. The ill-fated flight was commanded by Sumeet Sabharwal, 56, a veteran with 30 years of experience at Air India. He had logged 15,638 flying hours, including 8,596 on the Boeing 787. He was also an Air India instructor. His co-pilot was Clive Kunder, 32, who had 3,403 hours of total experience, with 1,128 hours on the Dreamliner.

As per the report, the engine N1 and N2 began to decrease from their take-off values as the fuel supply to the engines was cut off.

"In the cockpit voice recording, one of the pilots is heard asking the other why did he cutoff. The other pilot responded that he did not do so," it said.

Almost immediately after the plane lifted off the ground, CCTV footage shows a backup energy source called a ram air turbine had deployed, indicating a loss of power from the engines.

The report provided only a limited picture of the interaction between the two pilots in the flight deck.

The report said both fuel switches were found in the run position at the crash site and that there had been indications of both engines relighting before the low-altitude crash.

It said the aircraft took off at 08:08:39 UTC 13:38:39 IST) and at about 08:09:05 UTC 13:39:05 IST) one of the pilots transmitted 'MAYDAY MAYDAY MAYDAY'.

"The ATCO (Air Traffic Controller) enquired about the call sign. ATCO did not get any response but observed the aircraft crashing outside the airport boundary and activated the emergency response," the report said.

AAIB also said fuel samples taken from bowsers and tanks used to refuel the aircraft were tested at the DGCA (Directorate General of Civil Aviation) Lab and were found satisfactory.

The preliminary report was widely anticipated to throw more light on what could have led to the crash, which was one of the worst in India in decades, and also it was the first accident involving a Boeing 787 aircraft that resulted in hull loss.

The AAIB said the wreckage site activities, including drone photography/ videography have been completed and the wreckage has been moved to a secure area near the airport.

"Both engines were retrieved from the wreckage site and quarantined at a hangar in the airport. Components of interest for further examinations have been identified and quarantined," it said.

The AAIB is gathering additional details based on initial leads and data downloaded from the forward Enhanced Airborne Flight Recorder (EAFR) is being analysed.

"At this stage of investigation, there are no recommended actions to B787-8 and/or GE GEnx-1B engine operators and manufacturers," the report said.

Aviation experts have said it is difficult for pilots to inadvertently move the fuel switches, as there is a little mechanical gate built into the switch. Switches need to be lifted up over this little gate to shut off supply. They also asked why the report made no reference to cockpit camera footage.

Fuel switches are devices that regulate the flow of fuel into the engine of an aeroplane. Pilots use them to start or shut down engines on the ground or during a flight in case of an engine failure. They are spring-loaded to remain in position. To change fuel supply, a pilot has to first pull the switch up and then move it from RUN to CUTOFF or vice versa.

"The aircraft achieved the maximum recorded airspeed of 180 Knots IAS at about 08:08:42 UTC (13.38 IST) and immediately thereafter, the Engine 1 and Engine 2 fuel cutoff switches transitioned from RUN to CUTOFF position one after another with a time gap of 01 sec," the report said.

the medical college hostel premises after the crash-landing," he recalled in an interview to Doordarshan. "When I saw that the door was broken, I told myself that I can try and get out. Eventually. I came out."

Moments later, a video captured by a bystander showed a dazed Vishwas walking barefoot and bloodied toward an ambulance, away from the burning wreckage. But escaping the debris was only the beginning.

Back in Diu, where the brothers had travelled to visit family before returning to London, grief settled like a permanent guest. On June 7, Vishwas was discharged from Ahmedabad Civil Hospital. That same day, his brother's remains, identified through DNA matching, were handed over to the family. The next morning, a viral video showed Vishwas carrying Ajay's body on his shoulders to the cremation ground. Since then, life has stood still.

"He does not speak to anyone. He doesn't even take calls from our relatives abroad," said Sunny, his cousin. "He wakes up in the middle of the night and can't go back to sleep. He's still haunted by the crash and Ajay's death.

With no immediate plans to return to the UK, Vishwas remains in India and has begun psychiatric treatment. "We took him to a psychiatrist two days ago. His therapy has just started," Sunny said.

The trauma is all-consuming. For a man who emerged from mangled metal and flames, the invisible wounds have proven much harder to escape.

Prime Minister Narendra Modi had visited Vishwas in the hospital a day after the crash and enquired about his condition. But while the nation's attention may soon shift elsewhere, Vishwas's life remains suspended between memory and mourning.

He survived what few ever do. But healing – if it comes – will take far longer than the fall from the sky.

The structures, made of tin and mud, lacked proper containment systems and posed a serious health risk, officials said.

The demolition was carried out by the Rural Development Department under the district's rural waste management program.

These toilets were contaminating the stream locals depend on," said a field officer. "Removing them was necessary. Though Jammu and Kash-

mir was declared open defecation free under the Swachh Bharat Mission, dry latrines and unsafe toilet practices

persist in many villages. Their proximity to streams has led to rising concerns over waterborne diseases and pollution. The Jammu & Kashmir

RTI Movement, which has highlighted the issue in the ongoing Doodhganga river case before the National Green Tribunal, welcomed the step.

"This is a long-overdue intervention," said RTI Movement chairman Dr Raja Muzaffar Bhat. "Human waste was entering the water supply. Raithan must be the beginning, not the exception."

Villagers also voiced support. "The stream is our only water source," said Abdul Rashid, a resident. "We've been asking for this for years."

Officials said similar drives are being prepared in other parts of Budgam, where toilets continue to pose environmental threats.

Activists stress the need for more than demolition, calling for safe toilet design, soak pits, and waste treatment systems.

Cop Among Three Booked For Securing Jobs On Fake Documents

Jammu: Three people have been booked, including a subinspector and a teacher, for al legedly securing government jobs by using forged documents, said a senior crime branch officer on Saturday.

The three accused have been identified as Sub-Inspector Mohinder Paul, teacher Govind Kumar and Anganwadi Worker (AWW) Shakeela Bano, all from different areas of Jammu region.

Three separate FIRs have been registered at the crime branch (Economic Offences Wing) police station, said Senior Superintendent of Police Benam Tosh of Jammu crime branch. Paul, presently posted in

LONDON: KL Rahul racked up his second hundred at the iconic Lord's before India matched England's first innings total of 387 on an attritional day three of the third Test to leave the game on even keel on a deteriorating pitch.

Besides Rahul's high quality effort (100 off 177), Ravindra Jadeja (72 off 131) and Rishabh Pant (74 off 112) propped up India's first innings total.

It would be a challenge for India to bat last on a surface where the odd ball is taking off after pitching besides offering some turn.

When England batted, Zak Crawley wasted precious time to ensure that he faced only solitary hostile over from Jasprit Bumrah as hosts went into fourth day with a slender two-run lead.

But in the final five minutes on third day, there was enough dra-



ma with Shubman Gill and Crawley engaged in a confrontation which could have turned uglier after Indian skipper in some choic-

est language urged the English opener to show some guts while facing Bumrah. It was a spectacle once again to

see Jofra Archer go about his business and consistently breaching 90 mph mark. Ben Stokes too got the ball to rise sharply from back of length and one of them crashed into Nitish Reddy's helmet grille.

Like the case in England innings, India chose to play waiting game on a two-paced track, scoring at less than 3.5 runs per over.

Indian lower-order consumed a lot of balls but was not able to push the scoring rate. After scoring his third fifty in a row, Jadeja got a faint edge down the leg side off Chris Woakes.

Akash Deep got two on field lbw decision was overturned via DRS but perished after hitting a six. Realising he was running out

of partners, Washington Sundar went for a wild swing off Archer but caught by Harry Brook at a straightish fine leg to bring an end to India's innings. In the afternoon, Rahul got out to a loose drive after completing his 10th Test hundred.

Rahul reached his hundred shortly after the lunch break with a single off Archer. He became second Indian batter after Dilip Vengsarkar (3 hundreds) to score multiple ton at the Lord's.

However, he had a lapse in concentration in the very next over when he went for a drive off a flighted delivery from Shoaib Bashir but ended up edging it to Harry Brook at first slip.

Runs were hard to come by in the session with India accumulating only 68 runs.

Bashir was forced off the field soon after getting into the wickets column as he took a blow on his left finger while fielding off his own bowling. The poor running between the wickets between Reddy and Jadeja also stood out in the session. Either of them could have been run out thrice.
