No School, No Support: The Rule That's Hurting Kashmir's Poorest Girls

Thousands of poor girls in Kashmir are ineligible for state marriage aid due to one education clause. Now, a court wants answers.

Srinagar: When Rubeena's name was struck off the list for marriage assistance last year, her mother folded the rejection letter and tucked it under a stack of prayer beads, as if hiding it would also hide the humiliation.

Rubeena, 23, had never gone to school. Her remote village



in Baramulla didn't have one when she was a child, and her father's sudden death during her childhood left the family too fragile to think about anything beyond survival.

Still, her mother had hoped. state-run Marriage The Assistance Scheme promised 50,000 and five grams of gold to help poor girls begin their married lives with dignity.

But there was a catch: the girl had to be at least 8th class pass. Rubeena had never seen the inside of a classroom.

"We never thought they would use education to decide if we are poor enough," her mother said. "My daughter isn't less because she didn't go to school."

Now, a court ruling is giving hope to Rubeena and

FAKE J&K BANK APPS

Cyber Police Issues Alert

Srinagar: The Cyber Police in Jammu and Kashmir has sounded a public alarm over the circulation of fake JK Bank mobile application files being shared through WhatsApp groups and other social media platforms.

In a formal advisory, the cyber cell warned that these fraudulent APK files closely resemble the official JK Bank app but are in fact designed to steal users' personal, financial, and banking information.

The police emphasized that unsuspecting users who download these malicious files risk exposing their sensitive data to cybercriminals. Once installed, the fake apps can capture confidential details such as OTPs, MPINs, passwords, and account credentials, leading to potential financial fraud and identity theft.

Authorities have strongly urged the public not to download or install any mobile application shared via messaging apps or social media, particularly those claiming to be related to banking. Citizens have been advised to install only the official JK Bank application from verified sources such as the Google Play Store or Apple App Store.

The advisory further cautioned users never to enter their bank details in any unofficial applications and never to share sensitive banking information with anyone. People are encouraged to remain vigilant and report any suspicious files, links, or messages to the cybercrime helpline or lodge a complaint on the national cybercrime portal.

Rain Halts Amarnath Yatra; 500 Rescued

9,000 Pilgrims Manage Darshan, Army Steps In

Srinagar: The Amarnath Yatra was suspended on Thursday from Jammu as well as the twin routes of Baltal and Pahalgam due to continuous rainfall and adverse weather conditions. However, over 9,000 pilgrims managed to offer darshan at the holy cave, officials said.

"No fresh batch was allowed to move from Jammu towards the base camps," an official said, adding that the Border Roads Organisation (BRO) deployed additional personnel and machinery to carry out urgent repairs on the rain-damaged tracks. Divisional Commissioner

Kashmir, Vijay Kumar Bidhuri, said critical restoration work was underway and the Yatra is expected to resume on Friday, subject to weather conditions. "Only pilgrims already stationed at Panjtarni were allowed to descend towards Baltal today under the supervision of BRO and Mountain Rescue Teams," he said. This is the first time this year that the pilgrimage has been halted simultaneously from Jammu and both the base camps. Despite the suspension, 9,020 pilgrims performed darshan today. These included 6,345 men, 2,232 women, 132 children, 112 sadhus, 12 sadhvis, and two transgender devotees. Additionally, 185 security personnel also paid obeisance. Since the Yatra began on July 3, over 2.56 lakh pilgrims have visited the shrine.

Sale Deeds Manipulated, Khasra Numbers Changed

Srinagar: The Economic Offences Wing (EOW) on Thursday carried out searchat multiple locations es Jammu and Kashmir's in Srinagar and Budgam districts in connection with a case against seven individuals, including two officials from the revenue department, for

alleged corruption and cheating. "Search warrants have been obtained from a court and searches are underway at seven locations in Srinagar and Budgam districts," said a spokesperson of the EOW, which was earlier

known as the Crime Branch of the Jammu and Kashmir Police. According to the spokes-

person, the case involves seven people, including the then Tehsildar of Balahama, Nusrat Aziz Lone, and Patwari Ashiq Ali, who were booked earlier

this year for "fraudulently" making insertions in revenue records to benefit a private individual

The case was registered following a written complaint in which the complainant alleged that they had purchased a piece of land at Balhama from one Mohammad Shafi Lone alias Shafi



Cheeni and had prepared three sale deeds. The complainant paid an amount of Rs 88.4 lakh to Shafi Cheeni and also gave two kanals of land situated at Goripora Rawalpora to the accused in exchange for the Balhama land. This two-kanal land was later sold off by the accused. It was further alleged that

the sale deeds were taken back by the accused under the pretext of updating records. 'However. after their return. it was found that insertions have been made in the sale deeds by changing Khasra numbers," the EOW spokesperson said.

The complainant also alleged that one Rayaz Ahmad Bhat has forcibly occupied 2.5 kanals of the land at Balhama. Following the com-

plaint, a verification process was initiated at the EOW police station in Srinagar. During the probe, it was prima facie substantiated that the accused had deceived the complainant and inserted wrong survey numbers in the

Why Drones And AI Can't Quickly Find Missing Flood Victims, Yet

or search and rescue, AI is not more • accurate than humans, but it is far faster.

Recent successes in applying computer vision and machine learning to drone imagery for rapidly determining building and road damage after hurricanes or shifting wildfire lines suggest that artificial intelligence could be valuable in searching for missing persons after a flood.

Machine learning systems typically take less than one second to scan a high-resolution image from a drone versus one to three minutes for a person. Plus, drones often produce more imagery to view than is humanly possible in the critical first hours of a search when survivors may still be alive.

Unfortunately, today's AI systems are not up to the task.

We are robotics reseachers who study the use of drones in disasters. Our experiences searching for victims of flooding and numerous other events show that current implementations of AI fall short.

However, the technology can play a role in searching for flood victims. The key is AIhuman collaboration.

Al's potential

Searching for flood victims is a type of wilderness search and rescue that presents unique challenges. The goal for machine learning scientists is to rank which images have signs of victims and indicate where in those images search-and-rescue personnel should focus. If the responder sees signs of a victim, they pass the GPS location in the image to search teams in the field to check. The ranking is done by a classifier, which is an algorithm that learns to identify similar instances of objects - cats, cars, trees - from training data in order to recognize those objects in new images.

For example, in a search-and-rescue con-



text, a classifier would spot instances of human activity such as garbage or backpacks to pass to wilderness search-and-rescue teams, or even identify the missing person themselves.

A classifier is needed because of the sheer volume of imagery that drones can produce. For example, a single 20-minute flight can produce over 800 high-resolution images. If there are 10 flights – a small number – there would be over 8,000 images.

If a responder spends only 10 seconds looking at each image, it would take over 22 hours of effort. Even if the task is divided among a group of "squinters," humans tend to miss areas of images and show cognitive fatigue.

The ideal solution is an AI system that scans the entire image, prioritises images that have the strongest signs of victims, and highlights the area of the image for a responder to inspect. It could also decide whether the location should be flagged for special atten-

tion by search-and-rescue crews.

Where AI falls short

While this seems to be a perfect opportunity for computer vision and machine learning, modern systems have a high error rate. If the system is programmed to overestimate the number of candidate locations in hopes of not missing any victims, it will likely produce too many false candidates.

That would mean overloading squinters or, worse, the search-and-rescue teams, which would have to navigate through debris and muck to check the candidate locations. Developing computer vision and machine

learning systems for finding flood victims is difficult for three reasons.

One is that while existing computer vision systems are certainly capable of identifying people visible in aerial imagery, the visual indicators of a flood victim are often very different compared with those for a lost

hiker or fugitive. Flood victims are often obscured, camouflaged, entangled in debris or submerged in water. These visual challenges increase the possibility that existing classifiers will miss victims.

Second, machine learning requires training data, but there are no datasets of aerial imagery where humans are tangled in debris, covered in mud and not in normal postures. This lack also increases the possibility of errors in classification.

Third, many of the drone images often captured by searchers are oblique views, rather than looking straight down. This means the GPS location of a candidate area is not the same as the GPS location of the drone. It is possible to compute the GPS location if the drone's altitude and camera angle are known, but unfortunately those attributes rarely are. The imprecise GPS location means teams have to spend extra time searching.

How AI can help Fortunately, with humans and AI working together, search-and-rescue teams can successfully use existing systems to help narrow down and prioritise imagery for further inspection.

In the case of flooding, human remains may be tangled among vegetation and debris. Therefore, a system could identify clumps of debris big enough to contain remains. A common search strategy is to identify the GPS locations of where flotsam has gathered, because victims may be part of these same deposits.

An AI classifier could find debris commonly associated with remains, such as artificial colours and construction debris with straight lines or 90-degree corners.

Responders find these signs as they systematically walk the riverbanks and flood plains, but a classifier could help prioritise areas in the first few hours and days, when there may be survivors, and later could confirm that teams didn't miss any areas of interest as they navigated the difficult landscape on foot.

'70% Of City's Roadside Vendors Are Reportedly Millionaires'

SRINAGAR: The common perception that roadside vendors in Kashmir are poor and struggling to make ends meet is now under serious question. An investigation conducted by KNT has revealed a startling economic reality: nearly 70 percent of roadside vendors in Srinagar and surrounding areas are, in fact, millionaires, living far removed from the poverty they project daily on the streets.

Field surveys and data collected from areas such as Mehjoor Nagar, Qamarwari, HMT, Shalteng, Bemina, and other localities show that a large number of these vendors own plush properties, drive expensive vehicles, and maintain comfortable lifestyles while continuing to operate makeshift stalls in the busiest public spaces of the city.

Far from being marginalized, these vendors have successfully built a parallel economy, thriving amidst lax regulations and weak enforcement. According to sources, many of them have not only occupied prime public spaces-such as footpaths near hospitals and markets, but have also monetized these spots, leasing them out or handing them over to relatives and acquaintances under government-sanctioned relocation schemes

In one glaring example, dozens of vendors who were relocated by the administration from congested commercial areas quietly returned under different names or had their kin reoccupy the same spaces. This

manipulation of policy has allowed them to maintain their stranglehold on some of the city's most high-value real estate, rent-free and taxfree.

The entire stretch behind LD Hospital in Srinagar has become a chaotic, uncontrolled sprawl of street vending, causing severe disruptions to vehicular and pedestrian movement. "They are like locusts," remarked one official anonymously, "spreading unchecked from one part of the city to another, exploiting every loophole

in the system." Ironically, public sympathy often shields these affluent vendors. Every time the authorities initiate an antiencroachment drive, social media buzzes with criticism, portraying such actions as oppressive. "What people don't see is the scale of money involved," said a source in the Srinagar Municipal Corporation. "Many of these individuals own multiple

shops and still run street carts. They play the poverty card brilliantly." The lack of strong municipal legislation and poor coordination among departments has emboldened these vendors to assert ownership over public property, leading to worsening traffic jams, shrinking pedestrian space,

and serious safety hazards. T findings challenge the simplistic narrative of urban poverty often associated with street vending. It is now clear that street vending in Kashmir, in many cases, is not a means of survival but a route to untaxed, unregulated affluence.

Mental Health Camp Held For Inmates At Central Jail

SRINAGAR: In a dedicated effort to support the mental well-being of incarcerated individuals, District Legal Services Authority (DLSA), Srinagar, in collaboration with trained counselors from the Institute of Mental Health and Neurosciences (IMHANS), conducted a mental health counseling session for jail inmates at Central Jail Srinagar.

The programme was held under the chairmanship and guidance of Tasleem Arief, Chairman DLSA (Principal District and Sessions Judge), Srinagar, and under the supervision of Sajad Ur Rehman, Sub-Judge/ Secretary, DLSA Srinagar.

The session aimed to address the psychological issues faced by inmates and provide therapeutic interventions through structured counselling.

A team of trained mental health professionals namely Dr.Aijaz Ahmad Suhaff, Assistant Professor (Psychiatry), and Dr. Zahoor Ahmad Wagay from IMHANS, along with Para Legal volunteers and DLSA's LSUM unit members and Legal Aid



Defence Counsels interacted with the inmates and provided one-onone and group counseling sessions. During the session, inmates were encouraged to express their thoughts, emotions, and challenges. The counselors also educated them on coping mechanisms, stress management techniques, and the importance of mental health in rehabilitation and reintegration into society. Speaking on the occasion, an official of DLSA Srinagar emphasized the

importance of such initiatives in ensuring the holistic development and human rights of prisoners. "Mental health support is a crucial part of the reformation process. This collaboration with IMHANS is a step forward in making rehabilitation more meaningful for the inmates," she said.

Australia Frees Kashmiri Detainee After 7 Years

SYDNEY - A Kashmiri youth, freed yesterday after spending a record of almost seven years in an Australian immigration detention, thanked the Prime Minister, John Howard, and the Immigration Minister, Amanda Van stone, for "showing me compassion".

Peter Qasim; was 24 when he arrived on Thursday Island via Papua New Guinea, in September 1998.

He is still in the Adelaide psychiatric hospital to which he was admitted five weeks

ago, but will leave early this week after being granted a visa to live in the community, with full health benefits and employment rights. A Christian couple from Adelaide's southern suburbs, Faye and David, who have visited him in Baxter detention centre near Port Augusta many times, were at his side yesterday, excited to be taking him home.

He calls them Mum and Dad, and thanked them andthe Liberal backbenchers who made his plight public, and other "loving, caring supporters" including the Sydney entrepreneur Dick Smith.

"I have been living for almost seven years in a very hard situation," said Qasim, looking relaxed as he read slowly from a prepared statement. "I don't know what my future is now, but I am happy to have the chance to live a normal life. I never wanted to be a burden on Australia." Although his application for asylum was rejected, Qasim can live as an Australian citizen pending deportation. In reality, he has tried unsuccessfully to be deported for the past two years, and it is unlikely this will happen. Although he asserts he is a Kashmiri national, an orphan who fled the country after becoming involved with the separatist Jammu and Kashmir Liberation Front, no government will accept him and he is effectively stateless.

He has also applied for a permanent visa under a section of the Immigration Act that allows the minister to grant visas on humanitarian grounds.

61 People Killed As **Fire Engulfs New Mall** In Iraq's Wasit

Baghdad: At least 61 people have been confirmed dead after a massive fire engulfed a newly opened shopping mall in the eastern Iraqi city of Kut, according to the Iraqi Interior Ministry on Thursday.

In detail, most of the fatalities died in bathrooms from suffocation. Rescue teams found 14 charred bodies yet to be identified.

"The tragic fire claimed the lives of 61 innocent citizens, most of whom suffocated in bathrooms, and among them 14 charred bodies yet to be identified," the ministry said in a statement. Authorities had previously put the toll at 50 dead.

The fire broke out late Wednesday night at the Hyper Mall, a major commercial center that had been operating for just five days. The cause of the fire remains unknown. though early reports suggest the blaze may have started on the mall's first floor.

Emergency crews worked through the night as ambulances continued to transport the injured well into Thursday morning. By 4:00 am, local hospitals in Kut, located roughly 160 kilometers (100 miles) southeast of Baghdad, were overwhelmed by the influx of casualties.

Trump Hosts Gulf Leaders Amid Renewed Mideast Violence

Trump Hosts Gulf Leaders Amid Renewed Mideast Violence

Washington- President Donald Trump hosted a pair of Arab Gulf leaders at the White House on Wednesday as violence between Israel and Syria renewed doubts about his pledge to impose peace on the

Middle East. Trump held a meeting in the Oval Office with Bahrain's crown prince and dined privately with Qatar's prime minister.

The Republican president has lavished attention on the Persian Gulf, a wealthy region where members of his family have extensive business relationships. He has already visited Saudi Arabia, Qatar and the United Arab Emirates on the first foreign policy trip of his second term.

With little progress to share on the region's most intractable problems, including the war in Gaza, Trump was more focused Wednesday on promoting diplomatic ties as a vehicle for economic growth.

"Anything they needed, we helped them," Trump said in the Oval Office while meeting with Bahrain Crown Prince Salman bin Hamad Al Khalifa. "And anything we needed, they helped us."

Bahrain is a longtime ally that hosts the US Fifth Fleet, which operates in the Middle East

Like other Arab leaders, Al Khalifa was eager to highlight

the lucrative potential of diplomatic ties with the US, including \$17 billion of investments.

"And this is real," he said. "It's real money. These aren't fake deals.

According to the White House, the agreements include purchasing American airplanes, jet engines and computer servers. More investments could be made in aluminum production and artificial intelligence

Bahrain's king, the crown prince's father, is expected to visit Washington before the end of the year. An important part of the relationship will be an agreement, signed on Wednesday, to advance cooperation on civilian nuclear energy.

Dinner with Qatari prime minister

Sheikh Mohammed bin Abdulrahman Al Thani, the prime minister of Qatar and a member of the country's ruling family, was at the White House for a private dinner with Trump on Wednesday evening.

Trump visited Qatar during his trip to the region, marveling at its palaces and stopping at the Al Udeid Air Base, a key US military facility.

The base was targeted by Iran after the US bombed the country's nuclear facilities. One ballistic missile made impact, while others were intercepted.

Trump wants to use a luxurious Boeing 747 donated by Qatar as his Air Force One because he's tired of waiting for Boeing to finish new planes. However, the arrangement has stirred concerns about security and the ethics of accepting a gift from a foreign government.

Aaron David Miller, who served as an adviser on Middle East issues to Democratic and Republican administrations, said "the Gulf represents everything that Trump believes is right about the Middle East"

"It's rich, it's stable, it's populated by authoritarians with whom the president feels very comfortable," he said.

Fighting in Syria

The fighting in Syria be gan with clashes between Sunni Bedouin tribes and Druze factions in the country's south Government forces inter vened, raising alarms in Israel where the Druze are a politi cally influential religious minority. On Wednesday, Israel launched strikes in the Syrian capital of Damascus. A ceasefire was later announced, but it was unclear if it would hold.

Secretary of State Marco Rubio, who was in the Oval Office for Trump's meeting with the crown prince of Bahrain, said the fighting was the result of "an unfortunate situation and a misunderstanding"

Shubhanshu Adjusting To Life On Earth, Says His Father; Lucknow Awaits Hero's Return

roup Captain Shubhanshu Shukla, the Indian astronaut who along with three others returned recently from a successful space mission, is in Houston in the US, as he readjusts to life on Earth, his father said on Thursday.

Shukla, or "Shux", his call sign among colleagues and nickname for friends, splashed down on Earth on Tuesday after 18 days aboard the International Space Station (ISS). He is the first Indian on the ISS and the second after legendary Rakesh Sharma to venture into space.

Right now, he is in Houston. His wife Kamna, and their six-year-old son, Kiash, are already there.

According to an official statement quoting Union Minister Jitendra Singh, Shukla and the three other astronauts of the mission will remain in quarantine until July 23 to complete medical and re-adaptation procedures

"From the 24th, they will begin discussions with ISRO. Debriefings with Axiom and NASA will follow," he added.

"He (Shubhanshu) said he is under excellent care; (it) is required for him to readjust to life on Earth. His wife and son are there too," Shambhu Dayal, Shukla's father, told

"During our telephonic Shubhanshu conversation.

appeared excited at the accomplishment that means so much for the country."

The 39-year-old Indian Air Force officer, who became a national icon after his mission to ISS aboard the SpaceX's Dragon 'Grace' spacecraft, is currently with his family in Houston.

Speaking to PTI from the US, Shukla's wife, Kamna Shukla, said, "We are in Houston and we have already met him. He is with us. 'Homecoming has happened.'

Shukla's father said the family in Lucknow was overwhelmed by the public response to Shubhanshu's achievement and they are eager to welcome him.

'Hands Up In The Air' **Delhi Court Punishes 4 Accused For Contempt**

New Delhi- A Delhi court directed four accused persons to stand in the court with their hands raised in the air for the entire day after finding them guilty of contempt of court.

Judicial Magistrate Saurabh Goyal was hearing a 2018 complaint case, which was at the stage of pre-charge evidence.

In an order dated July 15, he said, "Despite waiting and calling the matter twice from 10 AM till 11:40 AM, the bail bonds were not furnished by the accused persons. For wasting the time of the court, which is in contempt of the order duly promulgated on the last date of hearing, the accused persons are hereby held guilty for contempt of court proceedings and are convicted for the offence under Section 228 (intentional insult or inter-



ruption to public servant sitting in judicial proceeding) of the IPC.'

'They are directed to stand in the court till the rising of this court with their hands straight in the air," the magistrate added.

The court posted the matter for further proceedings on August 11.

SRINAGAR: Minister for Health and Medical Education, Social Welfare and Education, Sakeena Itoo directed the J&K Medical Supplies Corporation Limited (JKMSCL) to ensure zero stock-outs of life-saving drugs and injections, particularly in emergency and trauma care units of all district hospitals across Jammu and Kashmir.

The Minister passed on these directions while conducting a comprehensive review of functioning and performance of the J&K Medical Supplies Corporation Limited (JKMSCL) in a meeting held at the Civil Secretariat here.

The meeting was attended by Secretary Health and Medical Education, Dr. Syed Abid Rasheed Shah; CEO State Health Agency, Ananth Dwivedi; MD JKMSCL, Kapil Mishra; Director Health Services Kashmir/Jammu, Director Family Welfare and Immunization, Director Finance, Health and Medical Education department, Principals of various GMCs and other senior officers, either in person or through video conferencing.

Addressing the officers, the Minister underlined the pivotal role of JKMSCL in ensuring seamless procurement and distribution of essential medicines, surgical equipment and other necessary medical supplies to the government health institutions across Jammu and Kashmir.

While having detailed appraisal of the corporation's procurement processes, inventory management systems, logistics networks and district-wise supply status, the Minister stressed on the urgent need to plug any gaps in real-time supply of critical and life saving medicines.

She directed the JKMSCL to ensure zero stock-outs of life-saving drugs and injections, particularly for cancer patients as well as cardiac patients in all district hospi-tals of J&K. "Health and well-being of the people is non-negotiable. We must ensure that no hospital, regardless of its location, faces a shortage of essential or emergency medicines", asserted the Minister.

Highlighting that a robust, transparent and responsive supply chain is the backbone of any public healthcare system, she instructed the JKMSCL management to adopt tech-enabled inventory tracking systems, ensure real-time coordination with GMC Principals, Chief Medical Officers (CMOs) and conduct monthly audits to monitor availability of essential healthcare supplies and utilization of stock.

She directed both the Directors of the health department to give advance requisition for healthcare equipment and accessories to the JKMSCL in order to avoid any delay in healthcare service delivery to people. "The effectiveness of our health system is closely tied to the efficiency of medical supply chains, any delay or lapse directly affects patient care", the Minister stated.

Calling for maintaining quality standards, especially in procurement of antibiotics, cardiovascular and other critical drugs, Sakeena Itoo emphasized upon the management of JKMSCL to maintain stringent quality control benchmarks for procurement process for enhanced transparency and competitiveness. She also asked them to avoid any kind of delay in the procurement process as these equipment and medical supplies are very critical for improving the healthcare facilities across Jammu and Kashmir.

Mobile Passport Van To Offer Five-**Day Doorstep Service In Kargil**

REASI: Deputy Commissioner Nidhi Malik on Thursday chaired a meeting to finalise the arrangements for the smooth and safe conduct of the Kounsar Nag Yatra, scheduled t o commence from July 27, 2025.

The meeting was attended by Senior Superintendent of Police Paramvir Singh; Commandant 126 CRP Manoj Verma; ADC Rakesh Kumar; ASP Iftkhar; ACD Vijay Kumar; DFO Mahore and

other officers. The President and Members of Kousar Nag Yatra Management Committee were also present.

The meeting discussed security arrangements, track clearance, drinking water facilities, toilet infrastructure, medical support and transportation logistics.

The DC directed the CMO to establish medical check-up camps at Sungari and Sari and deploy dedicated medical teams along the entire yatra route. She emphasized the availability of essential medicines, first aid kits, oxygen cylinders and ambulances to handle any medical emergencies. She stressed on thorough screening and said only those pilgrims found medically fit will be authorized to undertake the yatra.

The Deputy Commissioner emphasized on following the designated yatra route. She instructed the Forest and Rural Development Departments to ensure thorough clearance of the path and renovation of existing and installation of new toilets and sheds

at night halt points.

The Executive Engineer Jal Shakti Department was asked to make adequate arrangements for drinking water at langar sites and halting points. The Transport Department was tasked with co-

ordinating transportation for the pilgrims, while SDM Mahore was directed to monitor the overall progress on a daily basis.

To enhance safety, State Disaster Response Force and mountain rescue teams will be deployed all along the yatra

track. The Tehsildar Chassana informed that the registration process will begin one week before the yatra, and pony-walla rates will be notified shortly.

The Deputy Commissioner also instructed the BRO and PMGSY departments to deploy machinery for road clearance in case of any natural disaster. She further directed the Executive Engineer, PDD Mahore, to ensure uninterrupted power supply and make arrangements for backup generators at critical points.

Statehood Debate

n a fresh development in the politics surrounding the restoration of statehood to Jammu and Kashmir, Congress leaders Rahul Gandhi and Mallikarjun Khargehave written a letter to Prime Minister Narendra Modi urging the, restoration of statehood to Jammu and Kashmir. The move has been wekcomed by the National Conference (NC) and People's Democratic Party (PDP)

It has now been six years since August 5, 2019, since the revocation of Article 370 and the simultaneous downgrading of the J&K state into a union territory. However, the home minister Amit Shah, at the time, assured the nation that statehood would be restored, albeit at an "appropriate time." That time, clearly, is long overdue.

The Congress has now called for statehood legislation in the upcoming Monsoon session of Parliament. According to the ruling NC, there is simply no reason for further delay. J&K has held peaceful elections, seen a relative calm in recent years, and demonstrated resilience in the face of adversity.

There is also the Ladakh question. Congress has sought Ladakh's inclusion under the 6th Schedule, which offers special protections for tribal areas. This is in response to concerns voiced by people of Ladakh about losing their identity, land rights, and representation.

The BJP, on the other hand, has maintained that the abrogation of Article 370 was meant to integrate J&K fully into the Indian Union. Both the PM Modi and the home minister Shah have promised return of statehood. People in J&K now want the words to be matched with action. If the Monsoon session comes and goes without any concrete legislation, it will certainly disappoint people in J&K.

In recent past, however, centre has largely gone silent on the issue. More so, following the brutal Pahalgam attack and the attendant four-day war between India and Pakistan. The question is whether the centre has any immediate or near-term plan to reinstate J&K's statehood? There is no easy answer to this. If the recent statements by the senior union government leadership are anything to go by, there are no signs to this effect. This is a promise whose reiteration has been conspicuously absent from any remarks on Kashmir. The PM too skipped any mention of J&K statehood in his recent visit to the region to inaugurate Chenab bridge. This, despite the fact that the Chief Minister specifically mentioned this in his speech at the event. That said, the PM Modi has in the past pleasantly surprised the people of J&K. For example, last year, Assembly elections were announced when no one in the union territory expected them to be held.

A Generation Adrift

Delays, scams, and endless waiting: How Kashmir's job crisis is crushing a generation's spirit.

'm 25 years old, a graduate from a wellknown university. Like many others in Jammu and Kashmir, I didn't step into the workforce right after finishing college. Instead, I enrolled in a Master's program through IGNOU. because it felt like the only way to stay busy while preparing for government exams that always seem just out of reach.

We, the youth of this region, held onto a fragile hope, especially after 2019, when Article 370 was abrogated and our state transitioned into a Union Territory under Governor's rule.

We were told of a new dawn of development, opportunities, and most importantly, transparent and timely recruitments. We envisioned a future where merit would prevail, our hard work would be rewarded, and the chronic unemployment that plagued our parents' generation would finally be a thing of the past.

But look at us now. The promised dawn has yet to break. Instead, we find ourselves trapped in a relentless cycle of disappointment, our aspirations crumbling under the weight of broken promises.

Whenever a recruitment notification appears, a rare event in itself, often after years of anticipation, it's either marred by allegations of scams, forcing us to witness the brazen theft of our futures, or indefinitely delayed, caught in a bureaucratic labyrinth or legal quagmire.

The Jammu and Kashmir Public Service Commission (JKPSC) has managed to notify the Combined Competitive Exams only four times since 2019. It's a positive step, but the glacial pace and unpredictable timing cost us invaluable opportunities, years of our prime youth that can never be reclaimed.

Each postponement, cancelled exam feels like a punch to the gut. It drains our savings spent on coaching and forms, as well as our will to persevere.

Adding insult to injury, the very system designed to offer a fair chance has turned its back on a significant section of us.

With a staggering 67% of seats now reserved for various categories, candidates from the Unreserved category, like myself, find ourselves in an agonizing limbo: na ghar ke na ghat ke, neither

here nor there.

We are not against affirmative action, but when such a vast majority of opportunities are reserved, it leaves us, who have also toiled and sacrificed, feeling utterly marginalized. We bear the disproportionate burden, watching as our age limits tick down, our chances dwindle, and our future becomes increasingly uncertain.

It's a cruel irony: we are told to compete, to excel, only to find the goalposts constantly shifting, leaving us with a sense of profound injustice.

We had a flicker of renewed hope when, after a decade, we finally elected a new government in this new era of Jammu and Kashmir as a UT. We believed they would listen, that they would understand our plight, and that they would usher in an era of transparency and timely recruitments. We thought our voices, finally, would matter.

Yet, the malice persists. The recent notification for Naib Tehsildar posts in the Revenue Department, a beacon of hope for many, was met with protests over a qualifying Urdu language requirement. The case went to the Central Administrative Tribunal (CAT), and once again, the entire recruitment process has been put on hold.

Nothing, it seems, is going right. Every single step forward is met with two steps back, and it's the youth who pay the price.

The emotional toll is immense. Students are sinking into depression, their eyes hollowed by sleepless nights and endless anxiety. Unemployment figures continue their relentless climb, and a pervasive sense of helplessness grips our generation.

When we question the elected government, they claim a lack of powers, citing the UT status as a shield. When we turn to the Lieutenant Governor's administration, we are met with indifference, told they are "not concerned."

Who, then, is concerned about our future? Who is accountable for the years we are losing?

This bureaucratic ping-pong leaves us feeling like pawns in a game we never signed up for. Our futures are sacrificed at the altar of political and administrative inertia.

I don't want this trauma anymore. I am exhausted by the constant uncertainty, the dashed hopes, and the feeling of being utterly abandoned.

The government's efforts to empower

youth with skills have been negligible, offering little more than tokenistic programs that fail to address the core issue of job creation and fair access

Corruption, it seems, remains at its peak. It's a cancerous growth on the very system meant to uplift us.

I find myself confined to my home, unable to study, unable to focus, consumed by a gnawing anxiety. The vibrant dreams I once held have faded into a dull ache. Being an unreserved category candidate, the ticking clock of age limits on competitive exams is a constant, suffocating reminder of my diminishing prospects.

My health is deteriorating, plagued by stress and despair, and I feel like a leech, unwillingly sucking the blood of my parents. I'm unable to contribute, and thrive. The guilt is immense. The feeling of being a burden, a failure, despite my best efforts, is fierce.

This is not just my story. It is the collective agony of a generation in Jammu and Kashmir. We are not asking for handouts, but for a fair chance, a transparent system, and a future that doesn't feel like a mirage.

We are losing our youth, mental peace, and faith in the system. The silence from those in power is deafening, and the cost of their inaction is the slow, heartbreaking erosion of our dreams, replaced by a chilling sense of hopelessness

It is time for the authorities to stop passing the buck. It is time for concrete action, for a clear roadmap to address the unemployment crisis, for a review of policies that disproportionately burden sections of the youth, and for accountability in every recruitment process.

Our future, and the stability of this region, depends on it. We implore those in power to look beyond the statistics and see the faces of a generation on the brink.

A generation that simply wants the opportunity to build a life, contribute, and live with dignity in their own land.

fierce financial crisis is tightening its grip in the valley. Loans, once rare and strategic, are now routine. Weddings, homes, businesses, even daily expenses are increasingly financed by borrowed money. On the surface, it looks like progress. Beneath, it's a financial time bomb.

In a region like Kashmir, where uncertainty is already baked into everyday life, the added burden of poorly managed debt is devastating. Entrepreneurs who take loans without plans find themselves sinking. Families borrow to impress, not invest. And soon, peace of mind vanishes under rising dues.

One morning, he got a message from a company in Rangreth. He didn't have money for the fare, so he borrowed it from his brother. The interview stretched across seven rounds in one day. He didn't flinch. One woman handed him an envelope. Before he could open it, someone whispered, "You're in."

That project never took off. But something else did.

Zaid updated his resume. He kept learning. He managed a pharmacy. Through a referral, he entered another company. This time, he didn't just work, he led. Departments that once ignored him now waited for his decisions. His signature started to carry weight.

nothing. Each rejection, or worse, Zaid's story isn't a rare excep-

tion. It's a pattern. It's what happens to thousands of young Kashmiris every year, the ones with degrees, drive, and determination, but no system that knows what to do with them.

The government speaks of schemes. Institutions boast of programs. Yet in the real world, young men and women are stuck in endless loops of rejection, unpaid internships, and half-chances.

Employers ask for experience but offer none. They expect confidence but give nothing to build it. They run interviews like interrogations and pay as if the youth should be grateful for scraps.

The private sector in Kashmir barely functions. What little exists often mimics the worst of corporate habits: demanding reference checks in a place where most youth don't have networks, asking for five years of experience for entry-level jobs, and

Kashmir's Job Market Is Stuck in Promise Mode

"t's been almost six years since the government of India revoked Article 370, stripping Jammu and Kashmir of its special status, and promising a new era of growth. We were promised development, investment, and jobs. But today, on the ground, that promise feels like a mirage

The roads are smoother. The streetlights stay on longer. And yet, behind the facade of progress, unemployment looms large, especially among the youth.

Jammu and Kashmir currently has one of the highest unemployment rates in India. According to data from the Centre for Monitoring Indian Economy (CMIE), it hovers between 17% and 19%, almost twice the national average

In places like Srinagar and Anantnag, it's worse. The story that

numbers tell is sobering. Thousands of young men and women, many of them well-educated, are struggling to find work. They go from exam centers to coaching institutes, clinging to the hope of a government job that may

Programs like Mission Youth were launched to build skills and prepare candidates for modern careers. They reached wide. But the results fell short. Over 60% of the people trained under such initiatives are still without work. The training didn't match the job market, and the market itself hasn't grown fast enough.

The private sector was supposed to bloom in this new phase. Investors were expected to arrive, factories to rise, and startups to thrive. That momentum never fully took off.

Local businesses are struggling

to compete with bigger companies from outside the region. Procurement changes meant to improve transparency ended up pushing smaller regional manufacturers to the sidelines.

Even the public sector, the traditional employer of choice in Kashmir, has slowed down. Between 2022 and 2025, only about 12,500 government jobs were filled. That doesn't come close to covering the annual retirement rate, let alone addressing the growing backlog.

This crisis isn't just economic. It's social. Young people with degrees but no jobs are slipping into despair. Anxiety, depression, and a deepening sense of alienation are taking root.

In a region that has spent decades dealing with discord, this sort of despair is ominous.

What Kashmir needs now is a

clear-headed, inclusive employment strategy. Bring back trust in public hiring. Focus on reviving core local sectors: horticulture, tourism, handicrafts. Align skills with real jobs. Support rural and tribal youth, including women and those with disabilities, through funding and mentorship.

Above all, build transparency into the process. Track progress, audit outcomes, and listen to those affected.

A job is more than a paycheck. For many in Kashmir, it's proof that their future matters. And until the promise of opportunity reaches them, true progress will remain out of reach.

Gulmarg Goes Smart, Sustainable With high-tech tools and local wisdom, Gulmarg is setting the stage for a new kind of Himalayan tourism.

The rules are finally catching up with the rush in Kashmir's postcard-perfect tour-

ist town. Over the past few weeks, teams under the Gulmarg Development Authority (GDA) have launched a sweeping crackdown, sealing and seizing illegally built hotels, shops, and other encroachments that have crept into the fragile alpine zone.

Leading this action is Tariq Hussain Naik, the JKAS officer at the helm of the GDA. For him, this isn't just an anti-encroachment drive.

"It's a turning point," he says. "Encroachment is an environmental theft. Every inch of land taken without approval erodes the future of Gulmarg.'

With over 1.5 million visitors each year and 15,000 on peak days, the pressure on Gulmarg's ecosystem is enormous.

For years, lax regulation and unchecked expansion chipped away at its balance. Now, Naik is reimagining how high-altitude tourism should work in Kashmir.

Under his watch, the focus has shifted from footfall to foresight: geotagging tourists, zoning the recreation core, regulating guides, enforcing construction norms, and rolling out AI-backed permit systems.

The goal is bold, make Gulmarg South Asia's smartest and safest alpine destination, where safety protocols mirror air travel, and every season is managed, not just marketed.

A 2008-batch officer with a historian's eye and a reformer's drive, Naik sees Gulmarg not as a trophy town, but a living system.

In this conversation, he lays out how enforcement is just the first step, and why Gulmarg's real transformation will be led by locals, backed by tech, and rooted in sustainability.

Let's start with Pahalgam. It wasn't just tragic. It really rattled people. From your end, what changed after that?

A lot changed. It was a targeted terror attack. And it exposed something we'd never dealt with head-on: how fragile our tourism setup really is. The loss shook everyone. But what came after that forced a rethink.

Would you call it a turning point?

Absolutely. We realised this can't be a numbers game anymore. It's not just about how many people visit. It's about how safely we host them. That's where the real shift happened. Now, safety and sustainability are at the heart of every tourism plan.

What were the key lessons?

Three. First, preparedness. We can't wait for things to go wrong. So we're building in predictive weather alerts, evacuation plans, satellite-linked communications, especially

for high-altitude spots.

And regulation?

Big one. We had to clean up the mess: unlicensed pony rides, illegal camps, informal guides. Now, we're rolling out a Universal Licensing Framework. QR-coded IDs for every service provider. It's a total transparency. And third?

Communication. It has to be fast, clear, and multilingual. Our alert system now syncs with the Indian Meteorological Department. Tourists get briefed at hotel check-ins, kiosks, and even on Instagram. Emergencies shouldn't be guesswork

Sounds like this is part of something bigger.

Yes, the Tourism Risk Management Framework, built with the State Disaster Management Authority. Think biometric check-ins, AI-driven alerts, and geotagged tourists in sensitive zones. Pahalgam and Gulmarg are pilot sites. We're using drones to monitor crowds. We want safety here to feel as structured as air travel.

delicate ecosystem. How do you balance that? lion visitors a year. On peak days, 15,000. It's our crown jewel, and our biggest test.

So what's the plan?

Zoning. We've mapped the core recreational zone digitally. Buffer zones are off-limits to commercial activity. Construction follows the Master Plan 2032. Gondola rides are capped. And we run annual ecological impact audits: snow, waste, traffic, everything.

Are you planning to cap visitors?

Yes. We're working with TERI on a Carrying Capacity Index. It looks at stay duration, transport mode, and activities, not just headcount. Based on that, we'll roll out an AI-based permit system during peak seasons. Controlled entry without hurting local livelihoods.

What about fragile zones?

Places like Alpather Lake and Khilanmarg will have seasonal windows. They need to breathe too.

Alright. Let's talk waste and sustainability. What's new there?

Two big projects are underway, sewage and solid waste treatment plants. Hotels with more than 20 rooms must use bio-digesters and efficient heating. For trekkers, it's "Backpack Out, Waste Out": you carry your waste back. And with WWF India, we've launched biodiversity trails, complete with eco-guides and audio tools for students and nature groups.

"Sustainable tourism" gets thrown around a lot. What does it really mean here?

For us, it means three things: protect nature, respect culture, and empower locals.

In Gulmarg, that looks like hydro-powered ski lifts, zero-plastic zones, and farm-to-resort supply chains. Over 70% of resort produce

That's a big shift.

And we're investing in cultural preservation too. We're working with Dastkar Kashmir to bring back local wool and pashmina crafts, and make them part of the tourism economy.

Are locals involved in planning?

More than ever. We now hold regular townhalls with hoteliers, artisans, service providers. Three regional tourism task forces are in place, with 50% local representation. They help decide where to build, what to host, and how funds get used. We've even introduced participatory budgeting.

What about homestays, local guides, and artisans? Are they getting help?

They are. Over 140 homestays registered, with zero-interest loans and solar subsidies. Our Trail Guide Programme trained 180+ vouth in first aid, storytelling, and ecology. Local food festivals and artisan workshops are now part of our official calendar.

But can tourism really curb youth unemployment and outmigration?

It already is. The J&K Economic Survey 2023 shows thousands of tourismlinked jobs. In Baramulla alone, youthrun tourism startups are up 28% since 2021. One homestay, one bike rental, that's what keeps people rooted.

OK, let's talk tech. What's next for Gulmarg?

The Smart Gulmarg Initiative launches in 2026. Al-powered surveillance for crowd control, alerts, and planning. Online bookings already work for gondolas, huts, gear. We're adding VR ski simulators and AR overlays for heritage spots, perfect for off-season tourism and schools.

So the goal is a smart mountain destination?

Exactly. By 2030, we want to be the first net-zero Himalavan tourism zone. Real-time monitoring, sensor-managed utilities, digitally guided visitors. A place that's smart, inclusive, and gentle on the land.

And changing how the world sees Kashmir, any digital storytelling efforts?

Yes. We're working with Meta and Google India on immersive content: short films, virtual tours, essays. Campaigns like #RealKashmirStories and #BeyondThePostcard are gaining traction. Influencer residencies are on. The world needs to hear Kashmir's story, from



Kashmiris.

With slow travel and wellness on the rise, how does Kashmir fit in?

Perfectly. With walnut groves, shrines and old trails, we're built for it. We're reviving pilgrimage routes, creating healing trails, working with Ayurveda and Unani experts to design retreats. Gulmarg will host our first regenerative tourism workshop this year.

Could we see yoga residencies or artist fellowships here?

Already in motion. Wellness retreat centers are coming up near Baba Reshi. We're planning an Eco-Residency Fellowship for artists, yoga teachers, sustainability thinkers. And yes, an annual Himalayan Sustainability Bootcamp is in the works.

Skiing made Gulmarg famous. What about the rest of the year?

We've got a full-year blueprint. Summer brings golf, fishing, heritage walks. Autumn's about foliage and festivals. Spring brings flower trails. We've launched a Summer Adventure Series: paragliding, biking, long-distance runs. Gulmarg isn't just a winter postcard anymore.

Any new treks or birding zones?

Yes. New GPS-mapped trekking routes, eco-trails with audio guides, signage, and shelters. And we're developing a birding hub at Ferozepur Nallah to offer deeper experiences, without harming the environment.

Big picture. What's Gulmarg's role in Kashmir's adventure tourism map?

It's the flagship. The terrain, snow quality, and safety upgrades are setting it up as South Asia's top alpine destination. But it won't stand alone. We're linking Gulmarg with Gurez, Sonamarg, Pahalgam to form a fullfledged high-altitude circuit.

Fast forward to 2030, what should Gulmarg feel like?

For visitors: seamless, safe, and soulful. For locals: something they own with pride. And for nature: a place that breathes and heals.

And personally, what legacy do you hope to leave?

That we didn't just run tourism. We reimagined it. Gulmarg became a space where progress and preservation walked together. A living, year-round sanctuary.

This Artist's War on Waste Is Kashmir's Wake-Up Call Armed with nothing but discarded trash and a fierce sense of duty, a young Kashmiri artist is turning waste into urgent public art, and a message too loud to ignore.

n a recent summer morning, as crows circled a trash-strewn canal near the government school playground in Kulgam's Kulpora, Mudasir Rehman Dar unpacked his kit: crushed bottle caps, torn paper, a spool of jute string, and a stack of flattened cardboard.

He was preparing an art installation with a dozen schoolchildren, part of a self-organized eco-campaign he's been running for over two years.

The children watched closely as Dar pressed a yellowed polythene wrapper into shape and whispered, more to himself than to anyone else, "Nothing is waste. It's just waiting to be seen."

Dar's eco-campaign is trending at a time when his homeland Kashmir's beauty is increasingly buried under plastic.

According to a 2023 report by the Jammu & Kashmir Pollution Control Board, over 3,100 metric tons of solid waste are generated across the region every day, with nearly half dumped into open fields and waterways without treatment.

In places like Kulgam, where infrastructure is thin and environmental awareness even thinner, the problem is multiplying.

"There are mounds of garbage where or-chards used to be," said Dar. "We talk of paradise, but we're living in a dump.'

And so, he chose art as his form of resistance

Dar, 28, is a self-taught artist who has never attended an art school, held a salaried job, or received government funding. He works from a makeshift studio in the back room of his



family's modest home, tucked between apple trees and grazing fields.

The walls of his workshop are covered with hanging scraps - painted leaf portraits, a globe made of shredded polythene, a child's face drawn in ink on torn cardboard.

His tools are all improvised. He paints with old makeup brushes, builds frames from bent wires or used matchsticks, and colors his work using ink from dried markers or leftovers from house renovations.

But the message comes through.

In one of his most powerful works, Shades of Chinar, Dar uses scrap paper and plastic to recreate the famed red-gold chinar trees of Kashmir.

Upon closer inspection, the leaves are

made of worn-out food wrappers. A rusty syringe lies embedded at the tree's base. "This is where we're headed," he said. "Beauty on the surface, rot underneath."

Kashmir's environmental degradation is not just a local concern. The Himalayan region, already vulnerable to climate change, is seeing accelerated glacier melt, erratic weather patterns, and disappearing wetlands.

But municipal responses remain slow and fragmented. Many towns lack proper waste segregation. In rural areas, open burning of plastic is common.

For Dar, the lack of infrastructure is matched only by the absence of urgency. "There are policies," he said. "But there is no people's movement. And what is art, if not a cry?"

His work has already taken him across India, from exhibitions in Delhi, Chandigarh, and Amritsar to workshops in Kerala and Kolkata. In 2021, he entered the Asia Book of Records and India Book of Records for creating the world's smallest painting of the Holy Kaaba and Masjid-e-Nabawi, etched on a stone smaller than a grain of rice.

International admirers have followed. His leaf portraits of Gandhi, Tagore, Mother Teresa, and poet Iqbal have circulated widely on social media, gaining traction in countries like Sri Lanka, Russia, and the UAE.

And yet, Dar says, "I've never sold a painting, because people still don't believe art should cost anything unless it's on canvas in a frame.

Despite his growing recognition, Dar receives no government grants or gallery representation. He runs his campaigns from his own savings, money scraped together by selling handmade greeting cards or accepting small private commissions.

He spends most of his time visiting schools, parks, or shrines, holding pop-up installations or hands-on sessions where students learn to make portraits from biscuit wrappers or craft animals from used toothbrushes.

In a recent awareness event held at a school in South Kashmir, Dar spelled out the word "SORRY" using 400 crushed soft drink bottles. He then painted the face of the Earth crying over it.

"That's the apology our land never got," he told the students.

Dar's work draws deeply from Islamic spiritualism and the emotional textures of daily life in Kashmir. Some pieces depict the Prophet's Mosque in miniature form on a ring

stone. Others address addiction, domestic abuse, and child labour.

These issues, he says, are linked to the same cycle of neglect and waste.

"I was never taught to separate the spiritual from the ecological," he said. "If the Earth is sacred, how can we desecrate it like this?"

His motivation majorly comes from a place of pain, watching his homeland decay beneath the surface.

"This place gave me everything: language, faith, childhood. It hurts to see it buried under plastic."

In recent months, Dar unveiled a viral portrait of IPL cricketer Rasikh Salam Dar, another son of Kulgam.

The painting, made from reused art paper and old charcoal pencils, drew widespread praise on Instagram and was shared by sports fans across India.

And yet, on most days, he walks the short dirt path to his studio alone, past ditches lined with trash, past burnt plastic heaps smoldering in silence.

He says he'll keep going as long as his hands work.

"Art is not about galleries," he said. "It's about making people pause, look, and care."

Back at the school, the children finish assembling the installation: a large butterfly, its wings cut from biscuit packs and discarded examination forms. It doesn't fly, but it holds its own.

'It's not perfect," one boy says.

"It doesn't have to be," Dar replies. "It just has to be honest."

Brain Scans Reveal Changes Due To Exposure To Extreme Conditions Affect Physiology Cognition

study analysing brain scans of crew members who spent a year at an Antarctic research station has revealed changes due to exposure to isolated and extreme environments with potential impacts on physiology and cognition.

The findings, published in the journal 'npj Microgravity', have implications as extended space missions are planned from around the world, researchers said.

The team from the US, Europe, Australia and New Zealand found an overall reduction in white matter and a reduced grey matter in brain regions known to help with memory, language and spatial awareness

Astronauts experience consider able stress in space, and understanding its effects on the brain can aid in assessing risks and building resilience, the researchers explained. They pointed out that analogue environments - locations on Earth with features similar to those found on the Moon or Mars- such as the Antarctic Concordia Station, simulate "isolated, confined, and extreme" (ICE) conditions.

The findings are also relevant for individuals in the general population where a perception of isolation -- or loneliness -has been on the increase, and many have experienced chronic stress over the past years, the team said.

The researchers, including those from the University of Pennsylvania and the New Zealand Brain Research Institute, analysed MRI scans of 25 crew members who



spent 12 months at Concordia (a French-Italian research facility). The scans, taken before the mission, immediately after, and five months post-mission, were compared with those of another 25 individuals not subjected to isolated, extreme conditions.

The team found an overall reduction in white matter, along with decreased grey matter in the brain's temporal and parietal lobes, hippocampus, and thalamus. These regions are critical for processing sensory information, memory, language, and spatial awareness.

While it is known that white and grey matter naturally decrease with age-leading to age-related cognitive decline- other factors like diseases and lifestyle choices can also contribute to these reductions.

The study revealed that improved sleep and physical activity, such as gymming, during periods of isolation and confinement were linked to a lesser loss of grey matter, suggesting that lifestyle choices may have protective effects. Moreover, the levels of white and grey matter were observed to return to pre-exposure

levels five months after the participants returned from Antarctica.

"Life in space and on Earth entails exposure to and requires resilience to stress. Elucidating the effects of prolonged stress in extreme conditions highlights significant, but transient brain changes relevant for optimal physiological and cognitive functioning," the authors wrote.

'The current data and future studies in (isolated, confined and extreme) environments, including space travel, reemphasise the need to identify specific countermeasures that may mitigate changes in brain anatomy when individuals are isolated," the team wrote.

"The relevance of the current findings has broadened with the increase in isolation in the general population," they further noted.

IIT Madras Develops India's 'Lightest' Active Wheelchair 'YD One'

ew Delhi- Indian Institute of Technology (IIT) Madras on Wednesday launched 'YD One - India's lightest active wheelchair' built indigenously, according to officials.

YD One is the country's first indigenously developed precisionbuilt mono-tube rigid-frame wheelchair, designed to match the world's best, they added.

Built to international standards, YD One is fully customised for each user's body, posture and daily mobility needs. Weighing just nine kilograms, its ultra-lightweight and precision-engineered design delivers maximum strength and energy efficiency while making it effortless to lift, handle and stow in cars, autos or public transport.

According to IIT Madras Director V Kamakoti, the wheelchair is too often seen across the world as a universal symbol of disability — something that confines or re-



stricts its user. This narrative must change. A wheelchair, when built right, is not a burden but an enabler of independence, mobility and full participation in society, he said.

"Yet for millions, the reality remains grim: most still rely on heavy, poorly fitted hospital-style wheelchairs designed for short-term indoor use. These chairs make it hard to move freely and force people to be pushed around by others, limiting comfort, freedom and dignity.

"YD One transforms this reality. Built with precision-engineered geometry and aerospace-grade materials, it delivers the kind of high-performance, ultra-light mobility once only possible through expensive imports — but at a fraction of the cost. Minimalistic, stylish and fully customised, YD One is not something users are bound to — it's something they are proud to own, a device that

expands their world rather than shrinking it," he said.

To bring YD One to market, the research team partnered with Thryv Mobility, an IIT Madras-incubated startup that will manufacture the wheelchairs locally to global benchmarks, ensuring each chair is truly bespoke and affordable to users in India and emerging markets.

"Today, true independence means inclusion, dignity and selfreliance for each and every citizen of this country, regardless of their background, ability and circum-stances. WHO has given a figure where they say that almost 15 pc of the global population suffers from some form of disability.

"In absolute numbers, this amounts to almost 1.3 to 1.9 billion and this number is going up. It is estimated that by 2058, this will be 2.5 billion, which is a huge number," said Surgeon Vice Admiral Anupam Kapur, Nau Sena Medal, **Director General Hospital Services** (Armed Forces)

India Plays Down Threat Of Sanctions On Russian Oil Supplies

Says Can Source From Alternate Places

NEW DELHI- India on Thursday played down the threat of the US imposing sanctions on countries buying Russian oil, saying it is confident of meeting its needs from alternative sources.

Oil Minister Hardeep Singh Puri said the world's thirdlargest oil importer should be able to deal with any prob-lems with Russian imports by seeking supplies from other countries.

India imports more than 85 per cent of its requirement of crude oil, which is turned into fuels like petrol and diesel in refineries

Traditionally, the Middle East was the main source, but Russia has been the mainstay supplier for nearly three years now. After much of the West shunned Russian crude following Moscow's invasion of Ukraine in February 2022, Russia began offering steep discounts to attract alternative buyers.

Indian refiners seized the op-portunity, turning Russia, once a marginal supplier, into India's largest source of crude oil, overtaking traditional suppliers from West Asia. Russia now accounts for as much as 40 per cent of India's oil imports.

Speaking at the Urja Varta annual conference of the Directorate General of Hydrocarbons (DGH), Puri said there are many new suppliers coming onto the market, such as Guyana and

supplies can also be ramped up from existing producers such as

Brazil and Canada. "I don't feel any pressure in my mind. India has diversified the sources of supply," he said in reply to a question on the impact of the US threatening Russia with sanctions.

Earlier this week, US President Donald Trump had threatened that countries purchasing Russian exports could face sanctions or steep tariffs if Moscow fails to reach a peace agreement with Ukraine within 50 days.

Puri said India is also increasing the hunt for finding new deposits of oil within the country and quickly bringing them to production.

"I'm not worried at all. If something happens, we'll deal with it," he said. "India has diversified the sources of supply and we have gone, I think, from about 27 countries that

we used to buy from to about 40 countries now."

In the event of Russian supplies being hit, Indian Oil Corp chairman A S Sahney said the country could "go back to the same template (of supplies) as was used pre-Ukraine crisis when Russian supplies to India were below 2 per cent."

The Oil Minister said prior to February 2022, India was buying 0.2 per cent of overall crude oil from Russia. "Today... It has gone up considerably," he said.

Addressing a press confer-ence, Puri said at present the market does not react to geopolitical turmoil, especially in terms of prices as much as there is good availability of oil.

Addressing a press confer-ence, he said at present, the price of crude oil is around USD 68.5 per barrel and it is expected to remain around the same levels in the months to come. "I think it will be somewhere around USD 65/barrel," he said.

We're Very Close To A Deal With India: President Trump

NEW YORK/WASHINGTON-US President Donald Trump on Wednesday said that Washington is "very close" to a trade deal with India.

"We're very close to a deal with India, where they open it up," Trump said in the Oval Office while talking to reporters during a bilateral meeting with Crown Prince and Prime Minister of Bahrain Salman bin Hamad Al Khalifa.

"We've made deals with a lot of great places... We have another one coming up maybe with India. I don't know, we're in negotiation. When I send out a letter, that's a deal," Trump said. A day earlier, Trump had said that America will have access to the Indian market as a trade

deal with the country is being

worked on. "We will have full access into Indonesia, and we have a couple of those deals that are going to be announced. India basically is working along that same line. We're going to have access into India," he said.

"And you have to understand, we had no access into any of these countries. Our people couldn't go in. And now we're getting access because of what we're doing with the tariffs," Trump added, while talking to reporters as he departed the White House en route to Pittsburgh.

India and the US have been holding negotiations for the trade pact primarily to keep the tariffs below 20 per cent. India hopes it will be able



to strike a deal with the US to avoid the reciprocal tariffs. At the same time, India has

indicated that it will not enter into the trade deal in a hurry. India does not enter into any trade agreement based on deadlines and will accept the proposed trade deal with the US only when it is fully finalised, properly concluded and in the national interest, Commerce Minister Piyush Goyal said earlier this month.

An Indian commerce ministry team is in Washington for another round of talks on the proposed trade agreement.

India's Goods Exports Likely To Face Headwinds In Fiscal 2026: CRISIL

KOLKATA- Ratings firm CRISIL said that India's goods exports are likely to face some headwinds in fiscal 2026, as reciprocal tariffs imposed by the US are seen to aggravate this.

With the tariff hikes expected to come into effect from August, India and the US are negotiating on a bilateral trade agreement and a key monitorable, the report said.

The World Trade Organisation forecasts a 0.2 per cent decline in the volume of merchandise trade in 2025 compared to 2.9 per cent in 2024.

The report said global growth is expected to slow down to 2.9 per cent in 2025 from 3.3 per cent.

Growth in the US, India's largest export destination, is projected to slow to 1.7 per cent from 2.8 per cent.

Accordingly, India's merchandise trade is expected to come under pressure this fiscal.

However, the current account deficit (CAD) is expected to stay in the safe zone at 1.3 per cent of the GDP in the current financial year. The surplus in services trade, a robust flow of remittances is expected to cushion the CAD, the report added.

New Ladakh LG Will Have To Be Sensitive To **People's Sentiments: CM**

Next Indian Astronaut Will Travel In **Indigenously Built Spacecraft: Jitendra Singh**

New Delhi, Jul 17: Shubhanshu Shukla's successful space odyssey has provided expertise for India's future voyages and the next Indian astronaut will travel in an indigenously built spacecraft, Union Minister Jitendra Singh has said

In an exclusive video interview to PTI, Singh said Shukla's three-week stay at the International Space Station as part of the Axiom-4 mission has given India valuable insights and experience in handling space missions as it prepares for its own Gaganyaan project.

The Indian Space Research Organisation (ISRO) is preparing to launch its human spaceflight mission -Gaganyaan - that will take two astronauts to a low earth orbit sometime in 2027.

'The next mission is going to be totally, totally indig-enous, developed in India, right from the scratch. Indian astronauts going in for the



first time in an Indian spaceship," the Union Minister for

Science and Technology said. "It would also place us in that elite league of nations in the world which have actually been able to do so. And it would also pave the way for our future endeavours which includes setting up our own space station," Singh said.

The International Space Station is operated in collaboration by five space agencies - NASA, Roscosmos, European Space Agency, Japan Aerospace Exploration Agency and Canadian Space Agency. China has its own

space station Tiangong.

Singh said India was also working towards building its own space station and was open to hosting foreign experiments and astronauts when it becomes operational

"We are looking forward to having a space station of our own. Most likely it should be possible by the year 2035 and we have also decided to name it as Bharat Space Station," he said.

Singh rejected criticism that Shukla's travel to the ISS was a commercial mission and offered little scientific

value. "Absolutely not. I think there is some kind of a lack of understanding. In fact, he (Shukla) was the most important player of the four (astronauts who were part of the Axiom-4 mission),' Singh said.

ISRO has paid Rs 550 crore to Axiom Space for sending Shukla to the ISS and the costs included several months of training for him and backup crew Prashanth Balakrishnan Nair.

"Peggy Whitson, the commander, is of course a veteran. Whereas, Shubhanshu was the pilot who performed the bulk of the experiments on board the ISS," the minister said, adding the outcome of the studies carried out by Shukla will benefit the entire mankind.

Singh said Shukla's space travel gave a tremendous amount of experience, expertise for India's future vovages and also put the country in a better position for large international collaborations.

The Division Bench, led by Chief Justice Arun Palli and Justice Rajnesh Oswal, heard the petition and directed the government to take a decision on the rule within two months.

While the court did not strike the clause down, it asked the administration to view the matter "in its true perspective", a phrase that legal experts say suggests a deeper discomfort with how welfare is being withheld.

The SMAS was launched in 2015 by the Social Welfare Department to provide financial assistance to women from families living Below the Poverty Line (BPL).

Over 17,000 girls have received benefits under the scheme since its inception, according to government records.

But in Kashmir's remote and underserved districts, the number of rejections on educational grounds has piled up.

A 2023 report from the Directorate of School Education noted that nearly 28 percent of Kashmiri girls between ages 12 and 16 drop out of school. Some leave because their schools are too far. Others leave to care for siblings. Many stop attending after their villages got caught in conflict or closures for months.

In villages like Chadoora and Khansahib, advocate Hamid Rather says he personally documented dozens of applications turned away due to the education clause.

"In some of these cases, the girls were orphans. Others had never seen a school in their lives," he said. "They were poor in every way, and this scheme was supposed to protect their

dignity, not become another checkpoint." Legal scholars say the clause might not y stand a broader constitutional challenge.

They are also demanding that the LJHP authorities station boats along the canal for emergency rescue operations and deploy personnel to monitor visitor activity, particularly as the area has become a popular picnic destination.

"People come here with families, children play near the canal, and one slip is all it takes. If boats and rescue men are deployed, lives can be saved," said Tanveer Ahmad, a local of main town Uri

In addition to fencing, residents have urged the administration to install visible signboards at regular intervals along the canal, warning visitors about the risks of swimming or venturing near the fast-flowing water.

This is not just a demand, it's a plea. We don't want to mourn another young life just because someone didn't see the danger," said Mohsin Bhat, another local.

Despite repeated appeals, residents claim there has been little to no response from the concerned departments.

"We now urge the LG-led government and district administration to intervene and direct the LJHP authorities to take immediate action before more lives are lost," they added.

"Any condition attached to a welfare scheme must have a rational link to the purpose of the scheme," said Srinagar-based lawyer Zubair Ahmad. "If the goal is to assist the poor, educational attainment cannot be used to exclude those who never had access to school in the first place.'

In practice, the clause has created a cruel irony: girls who were denied education are now also being denied empathy.

At the heart of the petition, many argue, is the question of intent: Was the scheme meant to reward schooling, or to uplift the impoverished?

For activists working on ground, the answer is clear.

"Encouraging education is important," said community worker Naseema Bano, who helps families apply for government schemes in Pulwama. "But punishing those who never had that chance is the opposite of social justice."

The government has yet to respond publicly to the court's directive, but officials familiar with the scheme say internal discussions are underway.

Whether this leads to a policy shift remains uncertain, especially in a bureaucracy known for slow-moving reforms.

Yet the court's intervention has opened the door for reassessment.

In homes like Rubeena's, the ruling has rekindled a small hope. Her wedding is still pending. Her mother still carries the rejection letter in a tin box.

"Maybe now," she said, "someone will remember that our daughters are more than their school certificates."

Across Kashmir, where entire communities live at the margins of visibility, the case has struck a deeper nerve.

"It's not just about one girl's right to marry with dignity," advocate Hamid said. "It's about whether a welfare system meant to serve the poor truly understands the poverty it claims to address.'

Government Medical College (GMC) Jammu, his attendants allegedly assaulted a female doctor on Wednesday, triggering protests and a strike by junior doctors. The Doctors Association Jammu (DAJ) on Thursday sought security cover at medical facilities for doctors, alleging a rise in such assaults and manhandling.

"Strict action has been directed in the recent case. I have asked for a case to be filed and justice to be delivered. Our doctors must work free from fear and intimidation," Omar said while addressing a function at AIIMS in the Samba district.

The chief minister said that doctors must never bear the brunt of violence. "They dedicate themselves selflessly, often beyond duty hours. Their intentions and efforts are unwayering and they must never be blamed for outcomes beyond their control," he said.

Omar said that doctors cannot save everyone. "Life and death are not in the hands of doctors but in the hands of the Almighty. It is not acceptable to assault a doctor for having no fault. It cannot be tolerated. You have to file a case against the person who assaulted the doctor," he said.

He asked how a doctor can perform their duty if they are afraid of the outcome of treatment. "So long as I am here, we will do everything possible to ensure that medical practitioners are in a safe environment while performing their duties," he said

He further said that one of the female doctors sustained an injury and has been admitted for treatment. He revealed the CCTV footage of the incident at a press conference, clearly showing the doctors being physically attacked.

"I was on emergency duty yesterday. I got a call that a patient was unstable and not able to breathe. I immediately rushed and removed the tube, but still the patient was not able to breathe. During these medical procedures, the patient's attendants were getting aggressive. I tried to make them understand the procedures, but they became aggressive. We do not deserve this treatment because we give our hundred percent," said the doctor who was assaulted.

The Doctors Association Jammu on Thursday reiterated its demand for security cover at medical facilities for doctors and said that the healthcare system will collapse if such incidents continue. (PTI)

Russell, who was part of the title-winning squads in 2012 and 2016, announced his decision just seven months ahead of the 2026 T20 World Cup in India and Sri Lanka. The swashbuckling all-rounder has snapped 61 wickets and scored 1078 runs in 84 T20I outings. (PTI)

Why The US Might Finally Start Calling Soccer 'Football'

t is the world's most popular sport and yet there is still debate over what it should actually be called.

Is it football or soccer?

U.S. President Donald Trump waded into the topic while at the Club World Cup final in New Jersey last Sunday. He joked that he could pass an executive order to bring the United States in line with much of the rest of the world and ensure that from now on Americans refer to it as football.

'I think I could do that," he said with a smile during an interview with host broadcaster DAZN.

It was a light-hearted comment, but at a time when the U.S. is playing an increasingly significant role in soccer the question of why Americans continue to call it by a different name to the one by which it is most commonly known has been raised again.

"They call it football, we call it soccer. I'm not sure that change could be made very easily," Trump said.

Soccer keeps growing in the U.S. and so does its influence on the sport. It is co-hosting the men's World Cup with Canada and



Mexico next year — the third year in a row that it stages a major tournament after the 2024 Copa America and this summer's Club World Cup.

Other factors are keeping soccer more often in the U.S. consciousness -- and perhaps they will make saying "football" more commonplace in a tough sporting landscape.

One of the greatest players of all time, Lionel Messi, plays for MLS team Inter Miami; the popularity of the Premier League and Champions League is booming; and the documentary series "Welcome to Wrexham" about a low-level Welsh club coowned by Hollywood actors Ryan Reynolds and Rob McElhenney, has attracted new eyeballs.

DON'T BLAME AMERICANS FOR CALLING **SOCCER**

Despite "soccer" being widely associated with the U.S., it is commonly accepted that the word was actually coined in Britain, perhaps as far back as the 1880s.

The exact date when it was first used is not known, but it is believed "soccer" was derived from "association football," which was the first official name of the sport.

The charity English Heritage says the nickname may have first been used by pupils at the iconic Harrow School to "distinguish the new association game from their older pursuit, known as 'footer."

Numerous versions of football began to flourish, often involving handling a ball more than kicking it. One example dating back to the 1600s and still played today in England is Royal Shrovetide. Rugby is another example.

Massive Prize Money Boost For Durand Cup This Year

The upcoming Durand Cup may see participation from only six Indian Super League teams this year, down from 12 last season, but Asia's oldest football tournament has received a significant prize money boost, the organisers announced on Thursday.

The reduced ISL presence could largely be due to the ongoing deadlock between Football Sports Development Limited and the All India Football Federation (AIFF) over the renewal of the Master Rights Agreement. The uncertainty has forced the ISL to put its

2025–26 season "on hold", creating confusion for franchises about their team building, schedules and commitments, and resulting in fewer ISL clubs confirming participation in the Durand Cup, starting July 23. Chairman of the Durand Cup Organising Com-

mittee, Lt Gen Mohit Malhotra announced that the prize money this year has been increased from less than Rs 1.2 crore to Rs 3 crore, and three SUVs will be awarded to individual winners.

Individual awardees -- like the Best Goalkeeper, Golden Boot, and Golden Ball winners -- will receive SUVs.

Only six ISL teams have confirmed their participation this year. (PTI)
