Srinagar: The Meteorological Department (MET) Wednesday issued a weather advisory predicting light to moderate rain and thunderstorms across Jammu & Kashmir, with heavy to very heavy rainfall at isolated to scattered places, particularly in the Jammu Division, over the next 48 hours.

Director MET, Dr. Mukhtar Ahmad said that from July

J&K'S **DRUG** CRISIS

Over 1.12 Lakh Kg Drugs Seized, 10,000 Arrested Since 2018: Govt

Srinagar: Jammu and Kashmir has witnessed a massive surge in drug seizures, arrests, and rehabilitation cases over the last seven years, according to a detailed response tabled in the Lok Sabha on Tuesday.

In a written reply to a question in the Lok Sabha, Minister of State for Home Affairs Nityanand Rai said the Union Territory has witnessed a persistent rise in narcotics trafficking, illegal cultivation, and substance abuse cases over the past five years.

Citing data from the National Crime Records Bureau (NCRB), the minister said drug seizures saw a sharp rise from 2018 to 2020, followed by a gradual decline in subsequent years. In 2018, authorities seized 19,353 kilograms of narcotics, 87,713



units, and nearly 8,000 litres of psychotropic substances.

Seizures surged in 2019 and peaked in 2020, when over 27,000 kilograms of drugs and more than 40,000 litres of liquid narcotics were confiscated. From 2021 onwards, the volume of seized substances declined, though officials believe trafficking has continued through more concealed methods.

A total of 10,828 pilgrims had darshan at the 3800-metre high holy cave shrine on Wednesday, they said.

The officials said the yatris included 8,461 men, 1,802 women, three transgenders, 89 children, 56 sadhus, two sadhvis, and 415 security forces personnel.

Assault On SMHS Doctor Sparks Protest, Patient Care Paralyzed

Srinagar: Tensions ran high at Srinagar's Shri Maharaja Hari Singh (SMHS) Hospital on Wednesday after a violent assault on a resident doctor triggered a dramatic protest by medical staff, who shut the hospital's main gates and brought patient services to a grinding halt. The action led to scenes of chaos and despair, with ambulances stranded and hundreds of patients left unattended.

The flashpoint came after Dr. Shahnawaz, a resident doctor, was allegedly attacked by a patient's attendant.

'Tĥe incident took place at around 12:15 am on Tuesday. I was at the medical reception



when the patient was brought in. After assessing the patient, his vitals were not recorded, and he was sent to the triage room for further investigation. Unfortunately, the patient later died," Dr. Shahnawaz said.

CAT Allows 7 Candidates To Participate In J&K CC Mains

Srinagar, July 22: Central Administrative Tribunal has directed Jammu & Kashmir Public Service Commission to provisionally allow at least seven candidates to appear in J&K Combined Competitive (Mains) Examination.

A Bench of M. S. Latif (Member–J) and Prasant Kumar(Member—A) passed the orders after hearing counsel for the parties, perusal of the material and an order passed by Jammu bench of CAT, giving similar relief to a batch of candidates.

"We, accordingly, order that the respondents (JKPSC) will provisionally permit the petitioners to participate in the J&K Combined Competitive



Mains Examination, 2024 and the respondents, shall, accordingly accept their application forms.

In its objections, JKPSC submitted that in terms of rule 10-C of the J&K Public Service Commission Conduct of Examination Rules, 2022, the provisional Answer Keys for General Studies Paper – I and Paper – II were uploaded on

the official website of JKPSC on 23 February 2025 and immediately after the conduct of examination, objection were invited from the candidates within three days.

It said that the experts recommended changes in certain answers and JKPSC, as per rules and established procedure, accepted the recommendations and accordingly notified the Final Answer Key.

The JKPSC contended that change in merit position of the candidates about the final answer key cannot be termed as arbitrary and mala fide and the initial answer keys were clearly notified as 'Provisional' and subject to objections/review.

No J&K Voice In VP Poll As RS Seats Vacant

Srinagar: Jammu and Kashmir will have no voice in the election of India's 15th Vice President, as all four of its Rajya Sabha seats continue to lie vacant, a status unchanged for the past four years.

Vice President Jagdeep Dhankhar resigned on July 21 citing health reasons, creating a vacancy during the ongoing monsoon session of Parliament. Just two days later, the Election Commission of India initiated the process for electing his successor.

The Vice President is elected by an electoral college comprising 788 members of both Houses of Parliament, 543 from the Lok Sabha and 245 from the Rajya Sabha, as per Articles 63 to 71 of the Constitution and the Vice-President (Election) Rules, 1974. However, due to existing vacancies, only 782 members will participate in this election. With one Lok Sabha and five Rajya Sabha seats vacant, the winning candidate will require 392 votes. | More on P6

Study Analyses Intake Of Ultra-Processed Foods Among South Asian Countries

study that analysed intake of ultra-processed foods among South Asians found that three-fourths of those living in Bangladesh, Sri Lanka, and north India reported consuming these foods in the 24 hours prior to the

Researchers from the University of Cambridge in the UK, the Madras Diabetes Research Foundation in Chennai, and institutes in Pakistan, Bangladesh and Sri Lanka looked at the relation between consuming ultra-processed foods and sociodemographic factors of participants.

The findings, published in The Lancet Regional Health Southeast Asia journal, also show that 41 per cent of participants from south India and Pakistan reported having consumed ultra-processed foods in the 24 hours prior to being surveyed.

These foods involve extensive industrial processing and additives such as added sugars, and are known to heighten risk of obesity, metabolic and cardiovascular con-

Data of over 60,700 adults living in Bangladesh, Pakistan, Sri Lanka and India were



analysed

The participants were recruited for the South Asia Biobank, a UK-based longterm study designed to understand reasons contributing to the high risk of life threatening conditions such as heart disease, type 2 diabetes and obesity among South Asians.

Across the four regions studied, ultraprocessed foods were found to account for 13-17 per cent of one's total energy intake,

with biscuits being a common source. Other commonly consumed foods included sweetened beverages in Pakistan, packaged salty snacks in south India, and breakfast cereals in Bangladesh, the study found.

Further, younger age was a factor linked with consuming ultra-processed foods in Pakistan and Sri Lanka, and older age in Bangladesh and north India -- and women across most regions were more likely to Consumption also was found to be lower among married people or those living together across the regions studied, compared to those who were single.

The researchers said a 2023 study that examined the link between consuming ultraprocessed foods and sociodemographic factors analysed data from 32 countries, but "revealed a significant evidence gap with no studies conducted in South Asian countries".

"This is the first study to assess the sociodemographic correlates of (ultra-processed foods) consumption in South Asia, using individual-level dietary recall data in a large population-based study of South Asian adults," according to the study.

"In Bangladesh, Sri Lanka, and North India, (nearly) 75 per cent of participants reported consuming (ultra-processed foods) during the previous day, versus 41 per cent in south India and Pakistan. it said.

They added that the study's results provide valuable insights for developing targeted interventions

The South Asia Biobank is based at Imperial College London and funded by the UK's National Institute for Health Research.

Starving Gaza

n Gaza, 21 children have died of malnutrition and starvation in just three days. The number, announced by the head of Gaza's largest hospital, is not just a statistic, but an indictment of the world's collective failure. When children are dving from enforced hunger, it is time that the world reckons with its silence.

It is baffling to see the world watching a livestreamed genocide on a day to day basis and appearing not to care. Or just confining its concern to intermittent condemnations and calls for ceasefire, which Israel dismisses contemptuously.

The United Nations calls the situation a "horror show", and yet, the horror deepens daily. More than 59,000 Palestinians, mostly civilians, have been killed since Israel's military campaign began in October 2023. Now, starvation is being used as a weapon against Palestinians.

The Israeli government claims it has facilitated aid. Videos are posted of trucks lined up. But the reality on the ground tells another story: people shot while trying to reach food, children dying in hospitals from starvation, and aid trickling through a system stripped of its UN backbone and handed to the controversial Gaza Humanitarian Foundation. That over a thousand Palestinians have reportedly been killed while simply trying to access food aid is unconscionable.

This isn't just about logistics or blockades. This is about intent. When far-right Israeli leaders meet in Jerusalem to discuss transforming Gaza into a "tourist-friendly Riviera" for 1.2 million Jewish settlers, even as bombs fall and bodies pile up, it's not difficult to understand what the people of Gaza fear: permanent displacement and erasure.

That's why the recent joint statement from 28 nations, including long-time Israeli allies such as the UK, Japan, and several EU states, matters. It marks the strongest unified call vet for an end to the war. Their message is unequivocal: the starvation, the mass civilian casualties, the obstruction of aid, and the demographic engineering must stop. They have also called for immediate ceasefire and humanitarian access besides accountability under international law.

That said, statements will not save Gaza. The territory needs food, medicine and a permanent ceasefire. Unfolding currently in Gaza is not just an unmitigated, everyday catastrophe where people, including children are killed like flies but a global moral crisis. Although, the parts of the world have started speaking in recent past, there is little that is being done in terms of action. It is good that Europe is waking up to the Gaza reality - albeit not forcefully enough - now it is time for the Global South to make its voice heard.

uying an insurance policy is common practice in Kashmir. But what follows too often is silence. Documents don't arrive. Agents stop answering. And the buyer is left chasing a refund they're legally

entitled to during the policy's "free look period." Many turn to consumer courts, hoping for justice. One Srinagar resident spent 50,000 on legal fees without getting a

single penny back. His case isn't rare. It's a warning. The real problem isn't just rogue agents. It's a system that

doesn't tell consumers about simpler, faster solutions. India's financial regulators offer direct complaint platforms. The Insurance Regulatory and Development Authority of India (IRDAI) allows policyholders to lodge grievances online for free. So do SEBI and AMFI for investment-related fraud. These tools are quicker and often more effective than

But most Kashmiris don't know these channels exist. That's the gap.

Consumer empowerment doesn't require lawyers. It requires access to the right information. Schools, local bodies, and media in Kashmir must do more to spread awareness about financial rights and remedies.

When Kashmiris are informed, they don't waste time or

money. They take action, and get results.

Kashmir's Café Craze

A wave of cafés is reshaping Kashmir's urban scene, but without data, planning, or innovation, is the bubble about to burst?

he café scene in Kashmir is booming. With aesthetic interiors and Instagramworthy corners, these hangouts have shaped urban culture and stir up economic dreams

But behind the aroma of fresh brews and polished tabletops, a deeper question brews: is this growth sustainable, or are we chasing

In the past few years, the valley has seen an explosion of new cafés. Srinagar alone has over 200 cafés operating as of May 2025, a dramatic leap from fewer than 30 a decade ago.

The pace of this growth has been startling. Many of these ventures are started by young aspirants, professionals returning home, or those keen to cash in on what looks like the trend of the moment.

The logic seems straightforward: "If others are doing it, I can too." But this thinking

Even then, the trend feels particularly am-

plified in the valley. The rush to open cafés is often driven more by Instagram aesthetics than sound business sense. Business plans are missing or shallow, focused more on likes than ledgers.

Few café owners seem to consider critical questions: Is there enough demand to justify this many cafés? Is the market already saturated? What happens when the tourist season ends?

Most of these ventures overlook essential factors, like inflation, interest rates, raw material costs, and consumer spending dips at the national or global level.

In a climate where optimism isn't backed by capital reserves, contingency planning, or supply chain strategy, even a promising boom can quickly spiral into a bust.

That exactly makes this café culture more than just a lifestyle shift. It actually becomes an

economic experiment. And like any experiment without a solid

base, it's at risk of collapsing. Instead of slowing down, the café wave has oddly gained momentum, spreading over the last three to four years beyond Srinagar into towns like Baramulla, Sopore, and Pulwama.

But experts now believe the market may be peaking.

Informal reports from local hospitality circles suggest that several cafés launched in the last 12–18 months have either shut down or scaled back significantly.

Many blame a critical difference between demand visibility and demand durability. Many cafés rely heavily on tourists, especially during spring and summer.

In early 2024, Kashmir received around 1.56

Kashmir's café economy sits on a knife-edge, caught between promising growth and unplanned sprawl. The future depends on the discipline of the entrepreneurs. If they begin to monitor market trends, consult financial experts, and innovate beyond the surface, cafés can anchor the region's services economy.

million tourists, yet over the full year, the valley accounted for only 13% of the 23.59 million visitors to the Union Territory. This shows how seasonal the demand is.

When tourism dipped in April 2025 following the Baisaran bloodbath, bookings dropped by over a million, and 48 resorts temporarily shut down.

This sudden disruption reduced footfall in the hospitality sector across the board. Many café owners, who project their revenue based on peak seasons, struggled to meet fixed monthly expenses like rent, often above 60,000, during tne lean montns.

Seasonal slumps are common in hospitality, but few Kashmiri cafés have the financial strategy to ride them out. Often, there's no expert consultation or market study at all.

Then there's the issue of rising costs.

Most of these cafés don't operate on bulk procurement models or central supply chains. Ingredients are bought in small lots, equipment is imported at high prices, and utility bills soar due to harsh winters

As a result, even popular cafés suffer from high per-unit costs and low operational efficiency.

Training gaps and labour inefficiencies add to the challenge. Without a structured supply ecosystem, cafés operate below optimal scale.

This erodes profits and increases risk, even when customer footfall is decent.

What's more, there's a striking sameness to the café experience.

From Edison bulbs to chalkboard menus and continental plates, the formula feels copy-pasted. The lack of innovation in concept or service dilutes customer loyalty and kills uniqueness.

For tourists, the novelty fades fast. For locals, it becomes forgettable.

This points to another serious concern: inefficient capital allocation.

When similar ventures pop up within a limited market, they undercut one another. The overall demand doesn't grow, only competition does. This squeezes margins and raises the risk of failure.

Easy access to informal loans only worsens the problem, allowing people to jump in without proper cost-benefit analysis.

Since 2022, dozens of cafés across the valley have either waned or vanished within a year of launch. In most cases, the issue was a lack of preparation than passion. There were no clear break-even plans, no data on customer acquisition costs, and no forecasted returns.

What we're seeing isn't just entrepreneurship. It's speculative risk-taking dressed as innovation.

If the café surge continues without checks, research, or innovation, the sector may implode. Economically, this resembles a consumption-led bubble.

These bubbles don't always start with financial speculation. Sometimes, they're born out of trend-chasing and social validation without a data-driven base.

Right now. Kashmir's café economy sits on a knife-edge, caught between promising growth and unplanned sprawl.

The future depends on the discipline of the entrepreneurs. If they begin to monitor market trends, consult financial experts, and innovate beyond the surface, cafés can anchor the region's services economy.

But if the current wave of copycat cafés continues, the so-called boom will fade. And with it the hopes of many young business owners.

As any economist would say, trends driven by sentiment rarely last.

Whether Kashmir's cafés can endure will depend on whether their owners treat them as weekend hobbies, or serious, sustainable businesses.

From job interviews to ad targeting, Kashmiris are discovering how deeply the web already knows them.

arah had told no one. And yet, as she scrolled through her Instagram one morning in Baramulla, her feed seemed to know the secret she hadn't shared: she was expecting a

Every few posts, there it was: ads for baby bottles, prenatal vitamins, sleep tips for new mothers. "It felt eerie," said Sarah, a 32-year-old schoolteacher. "I hadn't typed the word pregnant

What gave her away wasn't a single search or status update. It was a series of small, seemingly harmless actions: a couple of late-night queries on morning sickness, a few seconds spent hovering over parenting forums, a click on a blog about first-trimester diets.

gestures. Those thoughts, were captured, stored, analyzed, and interpreted. They painted a picture, told a story, and did it more quickly than she ever imagined.

Across Kashmir, that sense of eerie recognition is becoming common. Students, teachers, professionals, and homemakers are discovering how their online behaviour is silently being turned into data.

That data, in turn, becomes a reflection of who they are, what they believe, what they want, and sometimes, what they fear.

What's surprising people isn't that the internet tracks them. It's how accurate, invasive, and predictive that tracking has become.

Everything we do online swipe on a screen, pause over a reel, like or comment - leaves behind what technologists call a digital footprint.

This footprint is constantly being mapped, measured, and molded into a version of us that exists on the servers of companies we've never heard of.

And this version of us is being used to target us, with ads, content, or decisions that affect real life. In Kashmir's classrooms and coffee shops, that version often starts with cookies. These are not the type that come with chai. Cookies are tiny data files placed on your device by websites and Some serve basic functions,

like remembering what's in your shopping cart. Others, known as third-party cookies, follow your trail across the internet, linking your searches on travel websites to your video recommendations on social media and your ad suggestions on news apps. They stitch together a digital diary



without your knowledge. Those diaries don't just sit still. They're fed into algorithms: mathematical models that sort and serve content, ads, and infor-

mation based on what they think

will keep you hooked. If you linger on a political post, expect more of the same. If you search for fitness routines, expect a flood of health products, diet tips, and protein shakes.

These systems don't just reflect preferences, they shape them. And slowly, your digital world becomes narrower, more predictable, and eerily self-reinforcing.

For instance, several young job seekers in Kashmir's private sec tor have reported interviewers bringing up old tweets or Insabout jokes they'd shared years ago. A few lost offers without being told why.

In a job market as tight as Kashmir's, digital impressions are often all a recruiter needs.

And it doesn't stop at jobs. Financial technology firms are piloting ways to assess loan risk using online behaviour. Your browsing habits, shopping patterns, and even the apps you download might soon help decide if you qualify for credit.

The phone you use, the websites you trust, and the time you spend online could affect your There are darker edges, too.

As data piles up, so do threats. In Kashmir, where surveillance anxiety already runs deep, the idea that personal data might be misused hits a nerve. Digital rights activists warn

that in politically sensitive regions, the consequences of a misinterpreted post or leaked location data can go far beyond embarrassment. They can mean questioning, intimidation, or

Data, once exposed, is impossible to pull back. It lingers on invisible ledgers long after you've moved on.

Some Kashmiris are starting to push back. Aamir, a student from Shopian, began auditing his phone apps after noticing tar-geted ads for products he'd only mentioned in passing.

"I realized I'd given camera and microphone access to a note-taking app," he said, "It felt invasive. I deleted half my apps the same

Others are adjusting browser settings to block trackers, turning off location access, or shifting to encrypted messaging services.

Still, the tide is hard to resist. Social media rewards openness. E-commerce thrives on personalization. Streaming platforms compete to know you best. And every convenience asks for a small trade-off: your preferences, habits, and attention.

Piece by piece, the picture fills

For many in Kashmir, where digital access has only recently stabilized after years of blackouts and slow speeds, the shift has been especially stark. People who once struggled to load a webpage now find themselves inside highlv curated digital bubbles. Their feeds are faster, smarter, and more manipulative than anything they've experienced before.

Sarah, the teacher from Baramulla, says she's more cautious now. Her son is four months old, and her feed has evolved with him: diaper discounts, parenting hacks, first-toy suggestions.

She rarely clicks, clears her browser history, and thinks twice before searching anything too personal.

But the sense that something is always watching hasn't gone

"I never said I was pregnant," she repeated. "But somehow, the internet knew. And that still unsettles me."

Bhalessa's Blooming Heart

Far from the crowds and camera flashes, Bhal Padri in Jammu and Kashmir offers travellers a vivid, sacred escape into alpine meadows, tribal life, and a rare kind of silence.

he road to Bhal Padri doesn't reveal its secret all at once. It unravels slowly, like a whispered story, beginning in the bustling center of Gandoh and snaking through pine forests, sleepy hamlets, and hills painted in green.

There comes a time when the asphalt turns patchy, the air grows colder, and somewhere between the sound of cowbells and wind slipping through trees, the world begins to feel softer.

Then the meadow appears. Wide and wild, Bhal Padri stretches out like a dream: rolled in flowers, framed by forests, and crowned by distant snowy peaks.

For a moment, it feels as though time has folded in on itself. There are no hotels or tour buses, no phone signals or souvenir stalls. Only colours — lavenders, whites, golds — scattered across the grass like offerings to the sky.

Tucked into the Changa region of Bhalessa in Jammu and Kashmir's Doda district, Bhal Padri sits silently at 2,500 meters above sea level, untouched by the noise of modern travel.

Known to those who live around it as Wadi-e-Gulposh, or the Valley of Blooming Flowers, the name isn't a poetic flourish.

It's a lived reality. From late spring through summer, the valley turns into a natural mosaic of buttercups, bluebells, daisies, and wild herbs. Even the breeze seems scented.

Unlike the polished postcard Kashmir of Instagram fame, this valley demands nothing and gives everything. There are no curated views or constructed experiences. You arrive as you are, and the place meets you with raw beauty.

Travellers usually start from Gandoh, the nearest administrative outpost. The journey from there is as much part of the experience as the destination.

Pine-scented bends, dirt paths interrupted by grazing flocks, and children waving from wooden porches, carry the feeling of moving deeper into something ancient and undisturbed.

The meadow finally opens with a long breath of land, wide enough to feel like sky, soft enough to feel like memory. The eye struggles to settle, pulled from blossom to blossom, stream to stream. There are shepherd huts scattered like punctuation marks, and at times, the canvas tents of Gujjar and Bakarwal families, the region's traditional nomads, rise with the mist.

These seasonal dwellers bring life and history to the valley. They arrive each summer with their livestock, settling into a rhythm older than borders or roads. Their homes are light and temporary, their knowledge of the land deep

Their days follow the sun,

Plastic bags and blaring speakers don't belong here. Neiup before the afternoon clouds ther do careless hands or wanderroll in. Evenings are best spent by ing tires. This is a place that asks streams, sipping salted tea or listening to village stories.

A three-day trip allows space for immersion: arrival and orientation on day one, exploration of Bhal Padri on day two, and a gentle return through nearby villages on day three, perhaps stopping at a shrine, a forest trail, or a local craft center before moving on to

Bhaderwah or Doda. Travellers are encouraged to follow a simple ethic: take nothing but memories, leave nothing but footprints. There are no dustbins here, and no one to clean up after you. Waste must be carried back. Modest clothing is appreciated. Photographs should be taken with consent, especially when nomadic families are involved. This is not a place to drink or party. It is a place to listen, watch, and

Bhal Padri may not always stay this way. The signs of change are already faintly visible: more footprints, a few wrappers, a growing presence on travel blogs. There is still time to steer it in the right direction. With local involvement and ecological care, the valley can serve as a model for responsible Himalayan tourism, one that puts nature, people, and cultural heritage first.

For now, Bhal Padri remains what many travellers seek but rarely find: a landscape that feels untouched, a place that invites awe, a journey that lingers.

And as you step back into the forest on your way home, the scent of wildflowers still clinging to your sleeve, it becomes clear that Bhal Padri is not the type of place you visit. It's the type you carry with you.

War Between India, Pak Was Probably Going To End Up Nuclear: Trump

New York:US President Donald Trump on Tuesday claimed yet again that he stopped the recent "war" between India and Pakistan and that five planes were shot down in the conflict.

He also claimed that the conflict between India and Pakistan "was probably going to end up in a nuclear war".

"We stopped wars between India and Pakistan, the Democratic Republic of the Congo and Rwanda," he said at a reception in the White House with the Congress members.

"They shot down five planes and it was back and forth, back and forth. I called them and said, 'Listen, no more trade. If you do this, you're not going to be good...They're both powerful nuclear nations and that would have happened, and who knows where that would

have ended up. And I stopped it'," he added.

Trump claimed the US took out Iran's entire nuclear capability and also stopped the conflict between Kosovo and Serbia.

"And a couple of others that we didn't stop a war, but we stopped what probably could have ended up in a war. We do that on the House as compliments of America. Okay, do you think (former US President Joe) Biden would do that? I don't think so. Do you think he ever heard of any of those countries? I don't think so," Trump said.

Trump, who has repeatedly said that he stopped the conflict between India and Pakistan through trade, last Friday said for the first time that "five jets were shot down" during the fighting.

"You had India, Pakistan, that was going... in fact, planes were being shot out of the air, five, five, four or five. But I think five

that was getting worse and worse, wasn't it? That was looking like it was going to go, these are two serious nuclear countries and they were hitting each other" he had said at the White

tries and they were hitting each other," he had said at the White House in his remarks made during a dinner that he hosted for the Republican senators.

Meanwhile, Acting US Representative Ambassador

Representative Ambassador
Dorothy Shea said at an open debate in the UN Security Council on
Tuesday on 'Multilateralism and
Peaceful Settlement of Disputes'
held under Pakistan's presidency
of the Council that across the
globe, the United States continues to work with parties to disputes, wherever possible, to find
peaceful solutions.

With Pakistan Deputy Prime Minister and Foreign Minister Ishaq Dar presiding over the Council meeting, Shea said that in the past three months alone, "we have seen the US leadership deliver de-escalations between Israel and Iran, between the Democratic Republic of Congo and Rwanda, and between India and Pakistan."

"The United States, under President Trump's leadership, played an important role in encouraging the parties to reach these resolutions, which we applaud and support," Shea said.

Ambassador Parvathaneni
Harish, India's Permanent
Representative to the UN, in his
statement in the UNSC chamber
spoke about the Pahalgam terror
attack for which The Resistance
Front, a front for Pakistan-based
terror organization Lashkar-eTayyiba had claimed responsibility.

Harish emphasized that there should be a "serious cost" to states who "violate the spirit of good neighbourliness and international relations by fomenting cross-border terrorism."

He said that India launched

Operation Sindoor targeting terrorist camps in Pakistan and Pakistan-occupied Jammu and Kashmir consequent to the gruesome terrorist attack in Pahalgam on April 22 that led to the killing of 26 innocent tourists and based on the April 25 UNSC statement.

In the UNSC statement.
In the UNSC statement, the Council members had underlined the need to hold perpetrators, organizers, financiers and sponsors of this reprehensible act of terrorism accountable and bring them to justice.

Harish emphasised that India's response was focused, measured and non-escalatory in nature.

"On achieving its primary objectives, a cessation of military activities was directly concluded at the request of Pakistan," he said.

Since May 10, when Trump announced on social media that India and Pakistan had agreed to a "full and immediate" ceasefire after a "long night" of talks mediated by Washington, he has repeated his claim several times on various occasions that he "helped settle" the tensions and that he told the nuclear-armed South Asian neighbours that America will do a "lot of trade" with them if they stopped the conflict.

Prime Minister Narendra Modi and Trump were scheduled to meet on the sidelines of the G7 Leaders' Summit in Kananaskis, Canada, in June, but the US president returned to Washington early.

Before departing Kananaskis and wrapping up his first visit to Canada in a decade, Modi had a 35-minute telephonic conversation with Trump in Washington.

Foreign Secretary Vikram Misri had said in a video message from Kananaskis that Modi clearly conveyed to Trump that at "no point" during the days following Operation Sindoor was there any discussion, at any level, on an India-US trade deal or any

proposal for mediation by the US between India and Pakistan.

Asserting Prime Minister Modi firmly stated that India does not and will never accept mediation, Misri had said the discussion to cease military action took place directly between India and Pakistan through the existing channels of communication between the two armed forces and it was initiated at Pakistan's request.

The US has designated The Resistance Front as a Foreign Terrorist Organization (FTO) and Specially Designated Global Terrorist (SDGT).

The State Department said these actions taken by it against The Resistance Front "demonstrates the Trump administration's commitment to protecting our national security interests, countering terrorism, and enforcing President Trump's call for justice for the Pahalgam attack."

Meanwhile, J&K received intermittent rainfall for the third straight day on Wednesday. Srinagar recorded a rainfall of 19.3 mm during the last 24 hours. The highest precipitation during the period was recorded in Qazigund at 23.9 mm followed by 22.1 mm at Katra.

With weather showing signs of improvement, traffic officials late Wednesday evening confirmed that the highway has been partially restored. "Stranded vehicles between Nashri and the NAVYUG Tunnel are being cleared," a senior traffic officer said. Restoration efforts are still ongoing to ensure full movement of traffic in the region.

Heavy rain has lashed the Jammu region for the third consecutive day, swelling rivers and streams. However, there is no immediate threat of flooding, officials said, though the India Meteorological Department (IMD) has issued a flash flood alert for Jammu division valid until July 24.

The Kishtwar-Sinthan road, which had also been blocked by flash floods at Sinthan Nallah, has now been reopened to traffic. Officials are simultaneously working to clear debris from several other link roads affected by landslides across Rajouri, Poonch, Reasi, Udhampur, Doda, and Ramban districts.

Authorities said there have also been reports of damage to kutcha houses and cattle sheds, but a detailed assessment is still underway.

In response to the IMD alert, District Disaster Management Authorities (DDMAs) have activated 24x7 control rooms and are monitoring the situation closely.

According to the MeT department, Udhampur received the highest overnight rainfall at 51.8 mm, followed by Ramban with 20.5 mm, Reasi with 17.9 mm, and Jammu with 8.5 mm.

Doctors Shut Hospital Gates,

Services Disrupted

In response, resident doctors suspended medical services and locked the hospital gates. Dressed in white coats and holding placards, they staged a sit-in outside the emergency wing, highlighting what they termed a growing crisis of violence against healthcare workers.

"The physical assault on any medical professional is unacceptable and inexcusable. We demand strict action against the accused and immediate steps to ensure our safety while we discharge our duties," said a protesting doctor.

But the protest had immediate consequences. Ambulances carrying critically ill patients were left waiting at the gates. One of the most harrowing moments came when a man from south Kashmir's Pulwama arrived carrying his electrocuted son in his arms, only to find the entrance shut. "My son has received an electric shock and needs urgent medical attention. I beg of them, don't let him die like this," he pleaded.

Patients' Families Stage Counter-Protest

The standoff triggered a spontaneous counter-protest by attendants and families of patients who were unable to access care. "We don't support violence, but why should the patients pay the price for someone else's mistake?" asked an elderly woman waiting with her sick husband. "This is a hospital, not a battlefield."

Tensions escalated further as both sides—doctors demanding safety and attendants demanding access—stood their ground. Police were deployed to maintain order and prevent further escalation.

Hospital officials confirmed that a First Information Report (FIR) had been filed against the accused. "We condemn the assault on our doctor. Violence in any form cannot be tolerated in medical institutions," said a senior SMHS official. He added that the administration was in active discussions with police and the protesting doctors to find a resolution. "Our priority remains the well-being of the patients while also ensuring the safety and dignity of our staff," he said.

Family Alleges Negligence
Meanwhile, allegations of medical negligence emerged in connection with the death of Javid Ahmad, an employee of Srinagar Municipal Corporation. His family claimed that Javid was suffering from chest discomfort and was allegedly denied oxygen support by doctors, despite repeated pleas. They alleged that the attending doctor, later assaulted, paid little heed and instead asked them to procure medicines from outside. Tragically, Javid died before the medicines arrived.

The family, while admitting that slapping the doctor was wrong, insisted that the perceived negligence caused the death. They have demanded access to CCTV footage and called for an impartial probe into the incident.

The protest drew hundreds of resident doctors, interns, and staff from GMC Srinagar and affiliated institutions. Demonstrators chanted slogans, condemned the assault, and called for lasting security arrangements in all healthcare facilities.

"We are not here to be attacked; we are here to heal," said one protesting doctor. "These incidents are no longer rare—they are becoming distressingly recurrent," said another.

Doctors also voiced concern about institutional silence. "How long are we expected to keep quiet while our own

lives are in danger?" asked a junior resident.

GMC Srinagar administration issued a statement denouncing the assault and urged the public to remain calm during medical emergencies. It confirmed that FIR No. 11/2025 had been lodged and that an investigation was underway.

A senior police official said the case is being pursued rigorously and assured that the perpetrator would be held accountable under the law.

The medical fraternity warned that if their safety concerns are not addressed, they may escalate their protest. "If it was Dr. Shahnawaz today, tomorrow it could be anyone among us," a senior doctor said. "We need assurance that we can work without fear."

Doctors urged the government to treat hospitals as secure spaces for both caregivers and patients and to implement strong deterrents against future assaults.

Parliament To Debate

April 22 Pahalgam attack.

The government, the sources said, has made no commitment on the opposition's demand for the prime minister's response but has cited its proposal for a parliamentary discussion next week on the ground that Modi will be back by then from his fourday foreign visit, for which he left on Wednesday.

A senior BJP leader said the debate on the conflict with Pakistan, which ensued after India retaliated under Operation Sindoor following the killing of 26 civilians in the Pahalgam terror attack, will not only have a strong national traction but will also be paid attention to by the global community.

"The prime minister may choose the occasion to convey his government's robust response to the terror attack and stand on a host of issues," the BJP leader said, adding that a final call has not been taken yet on whether Modi will speak or not.

Congress' deputy leader in the Rajya Sabha Pramod Tiwari, who attended the BAC meeting, claimed, "We have demanded that Prime Minister Narendra Modi should be present during the discussion, and we have been assured of that by the government."

This was the first BAC meeting after Jagdeep Dhankhar stepped down as vice president on Monday, when he chaired two back-to-back committee meetings to finalise the House's agenda. The vice president is ex officio chairman of the Rajya Sabha.

Dhankhar called off the second meeting and rescheduled it for Tuesday as Leader of the House in Rajya Sabha J P Nadda and Parliamentary Affairs Minister Kiren Rijiju did not attend due to what they later said was their engagement in other official business. Dhankhar resigned a few hours later to "prioritise health care".

The BAC includes representatives of various parties and is chaired by the respective presiding officers of the two Houses.

In 2020 alone, 893 acres of poppy crops were destroyed. The figure fell in the following two years but rose again in 2023 and 2024. Cannabis destruction also increased, with over 900 acres cleared in 2023 and nearly 1,000 acres in 2024.

Under the Ministry of Social Justice

and Empowerment, the number of individuals receiving de-addiction services rose from just over 1,500 in 2020–21 to more than 35,000 in 2024–25. In total, 83,208 people have been treated and discharged from various de-addiction centres in Jammu and Kashmir since 2020. Currently, ten de-addiction centres are operational in the region.

At the Institute of Mental Health and Neurosciences (IMHANS) Kashmir, the Drug Treatment Clinic registered 3,207 new cases in 2021–22, followed by 3,334 in 2022–23. The number dropped to 1,457 in 2023–24, and 1,389 patients were registered up to January 2025. In total, IMHANS has treated 9,387 patients for drug addiction.

In a concerning revelation, the government informed the Lok Sabha that since 2018, at least 17 suicides in Jammu and Kashmir have been linked to drug and alcohol addiction. The data highlights the seriousness of the crisis and the urgent need for stronger, community-driven responses.

The Ministry of Home Affairs reiterated its commitment to tackling the drug threat through stricter enforcement, awareness campaigns, and expanding treatment and rehabilitation facilities across the Union Territory. (inputs from KNO)

Of the five vacant Rajya Sabha seats, four belong to Jammu and Kashmir and one to Punjab, vacated after Sanjiv Arora moved to the legislative assembly.

Despite having held its first assembly elections in more than six years in 2023, Jammu and Kashmir's four Rajya Sabha seats remain unfilled. The 90-member J&K Legislative Assembly is responsible for electing these members, yet the Election Commission has not initiated the process to fill the vacancies. While by-elections were announced for Gujarat, Kerala, Punjab, and West Bengal in May, no dates have been set for the J&K Rajya Sabha seats or for the assembly constituencies of Budgam and Nagrota.

On February 15, 2021, Ghulam Nabi Azad and Nazir Ahmad Laway completed their Rajya Sabha terms. Before this on February 10, the terms of Fayaz Ahmad Mir and Shamshir Singh Manhas came to end.

National Conference spokesperson Tanvir Sadiq called the situation "unfortunate" and said the region continues to be denied its rightful place in the country's highest legislative bodies. "We have been consistently demanding that these seats be filled. The silence is unjustified," he said.

One of the BJP leaders, however, said the onus lies with the Election Commission. "Political parties are trying to politicize the issue during the VP election. Our party stands for democracy and supports filling the vacant seats," he said.

Currently, J&K has five Lok Sabha MPs, three from Kashmir and two from Jammu,but its voice is missing in the 245-member Rajya Sabha, where its representation has been absent since the terms of the previous four MPs expired in 2021.

EC Begins VP

Both elected and nominated members are eligible to vote in the vice presidential election.

It is also finalising the returning officer and assistant returning officers.

"On completion of the preparatory activities, the announcement of the election schedule to the office of the Vice President of India will follow as soon as possible," the EC said.

Dhankhar stepped down as vice president on Monday, citing health reasons. His term was to end on August 10, 2027.

The Union home ministry on Tuesday formally notified the resignation of Dhankhar from the office of the vice president.

According to Clause 2 of Article 68 of the Constitution, an election to fill a vacancy in the office of the vice president occurring due to his death, resignation or removal, or otherwise, will be held "as soon as possible" after it goes vacant.

The person elected to fill the vacancy will be entitled to hold office "for the full term of five years from the date on which he enters upon his office".

From the day the notification is issued, "calling the electoral college to vote", and till the day of the poll, a period of 30 days is stipulated.

A person cannot be elected as the

vice president unless he is a citizen of

India, has completed 35 years of age and is qualified for election as a member of the Rajya Sabha.

A person is also not eligible if he holds any office of profit under the government of India or a state gov-

ernment or any subordinate local

authority.

The ruling NDA has a comfortable edge in the vice presidential elections.

The vice president is elected by the members of Lok Sabha and Rajya Sabha, where nominated members of the Upper House are also eligible to

cast their vote.

The 543-member Lok Sabha has one vacant seat — Basirhat in West Bengal — while there are five vacancies in the 245-member Rajya Sabha.

Of the five vacancies in the Rajya Sabha, four are from Jammu and Kashmir, and one from Punjab. The seat from Punjab was vacated after AAP leader Sanjeev Arora quit following his election to the state assembly in a bypoll last month.

The effective strength of both the Houses together is 786 and the winning candidate will require 394 votes, considering that all eligible voters exercise their franchise.

In the Lok Sabha, the BJP-led NDA

In the Lok Sabha, the BJP-led NDA enjoys the support of 293 of the 542 members. The ruling alliance has the support of 129 members in the Rajya Sabha, assuming that the nominated members vote in support of the NDA nominee, which has an effective strength of 240.

The ruling alliance has the support of 422 members.

Article 66 (1) of the Constitution provides that the vice presidential election shall be held in accordance

with the system of Proportional Representation by means of the single transferable vote and the voting at such election shall be by secret ballot.

In this system, the elector has to mark preferences against the names of

the candidates.

The vice president is the second highest constitutional office in the country. He serves for a five-year term, but can continue to be in office, irrespective of the expiry of the term, until the successor assumes office. PTI

Tral WLS Vital Corridor For Hangul Conservation: Report

SRINAGAR: Tral Wildlife Sanctuary (WLS) has emerged as a crucial link in survival of Hangul-the critically endangered Kashmir stag, acting as a natural corridor between Dachigam National Park and historical habitats in Shikargah and

Overa. This connectivity aligns with the findings of the latest Management Effectiveness Evaluation (MEE) 2020–2025 report, a copy of which also lies with Kashmir Observer which rated Dachigam's manage-

ment as 'Very Good' but stressed the urgent need for expanding conservation efforts into a 'Greater Dachigam Landscape', a proposal that specifically highlights strengthening wildlife corridors such as Tral WLS to ensure longterm Hangul survival.

"This sanctuary serves as a critical corridor for the movement of Hangul between Dachigam NP and its historical range areas of Shikargah and Overa. There are no villages within the PA, and it benefits from good coordination with the Forest Protection Force, territorial divisions, and security forces," reads the MEE report.

The report further states that the PA, which includes the erstwhile game reserve and consists of Shikargarh and Khangund forests, extends over 154.15 km² and was notified in 2019. Additionally, the PA encompasses 113 km² of various forests from the territorial division of Awantipora, which have not yet been formally handed over to PA management.

As per the report, the area also maintains active anti-poaching camps and regular livestock vaccination programmes.

"There is an effective presence of anti-poaching camps at Tral and Khangund, along with support from WII, local universities such as SKUAST-K and Kashmir University, and various local NGOs," reads the report.

However, experts caution that the absence of a formal management plan, delay in eco-sensitive

zone notification, encroaching summer pastoralists and their dogs, and significant armed forces presence within the sanctuary lenges.

"The PA currently lacks a management plan, and an ESZ proposal has been submitted but not yet approved. The area faces challenges from traditional summer pastoralists and their dogs, rapid land use changes in the vicinity, a widespread presence of armed forces within the PA, and shortages of protection staff, communication equipment, mobility,

and high-altitude camping gear." Wildlife specialists stress that, in line with MEE recommendations, improving protection infrastructure and surveillance systems and adopting an ecosystem-scale landscape approach will be essential to safeguarding Hangul and other species such as musk deer.

The report has also called for conducting studies on the effects of climate change, ensuring career progression opportunities for officers from assistant wildlife wardens, and enhancing intersectoral coordination and outreach functions of the PA.

hear what we've said here today, everything is controlled?"

He also referred to the Emergency period under Indira Gandhi, drawing a parallel to the current situation:"They talk of Indira Gandhi's Emergency-it lasted only 18 months. I just hope the message we are trying to send reaches Parliament, and that our elected leaders will fight for Indian democracy."

Ending on a powerful note, he said: "We are not here to beg. We are here to demand our right-peacefully. Kashmir was made a testing ground, but other states may face the same future if we don't stand together. That's why we are here-to wake the nation up."(KINS)

Shopian Shuts Down Over Shifting Of Dy CEO Office

SRINAGAR: South Kashmir's Shopian town observed a complete shutdown on Wednesday in protest against the govern-ment's decision to shift the Deputy Chief Education Officer (Dy CEO) office to Chitragam tehsil of the district, triggering widespread anger among locals, political leaders, and civil society.

According to KNO, the protest, organised under the banner of the All Party District Development Forum Shopian, witnessed participation from a broad coalition of political parties, traders, transporters, students, fruit growers, and other sections of society. Shops and businesses remained closed for half a day, with leaders terming the move "politically motivated" and "administratively illogical".

Prominent political figures, including MLA Shopian Advocate Shabir Ahmad Kullay, former MLA Aijaz Mir, Apni Party's Advocate Gowhar, and BJP leader Raja Wasim, and DDC Raja Waheed, led the demonstration. Protesters assembled in the town centre and marched towards the office of the Deputy Commissioner, where they submitted a joint memorandum.

Speaking to reporters, MLA Kullay questioned the rationale behind displacing a vital office from the district headquarters and urged the government to focus on creating new zonal education posts in areas such as Zainapora, Turkwagam, Harmain, Kanjiullar, and Kapran.

Former MLA Aijaz Mir also opposed the move, saying, "If the aim was to enhance academic oversight in Chitragam, a separate post could have been created without disman-

tling the existing structure in Shopian."

The protesters further demanded the establishment of a separate mechanical division for Shopian and the upgradation of infrastructure at the dis-

trict hospital. 'The complete shutdown of trade and transport in Shopian reflects the widespread disapproval and anguish over this covert and malafide act of brazen illegality against the vital interests of the Shopian citizenry and its students," reads the memorandum they submitted to DC Shopian.

According to the memorandum, the Dy CEO office had historically served as a crucial administrative unit, offering accessible public service, especially for residents in remote and hilly areas. "Its sudden and unjustified relocation has caused grave concern, particularly among students who rely on this centrally located office." it read.

The forum asserted that no public consultation took place before the decision was made and called for an impartial inquiry into the matter. It also warned of long-term adverse impacts on the education sector in the district.

The memorandum concluded with three key demands that include immediate revocation of the order shifting the Dy CEO office to Chitragam, an impartial inquiry to evaluate the legality and necessity of the move and public assurance that future administrative decisions affecting public interest will involve stakeholder consultation.

The protest was called off peacefully after the submission of the memorandum, but the leaders warned of intensified agitation if their concerns were not addressed on time.

MANCHESTER: Sai Sudharsan made the opportunity count in his comeback game with a fifty while Rishabh Pant suffered another injury as India played the old-fashioned way to reach 264 for four at stumps on day one of the fourth Test here on Wednesday.

At stumps, Ravindra Jadeja (19 batting off 37) and Shardul Thakur (19 batting off 36) were holding fort in

Put in to bat in overcast conditions, Indian openers KL Rahul (46 off 98 balls) and Yashasvi Jaiswal (58 off 107) put on 94 runs for their highest stand of the series before Sudharsan (61 off 151) produced a dogged knock under pressure to justify his selection over Karun Nair. Batting alongside Sudharjust started flexing his muscles before missing a reverse hit off a full ball from Chris Woakes.

The sun stayed away for the majority of the day but the slow nature of the pitch gave the batters enough time to tackle the extra pace of Jofra Archer.

In the afternoon session, England removed a well set Rahul and Jaiswal before sending back Shubman Gill to leave India at 149 for three at tea.

Having failed to land a wicket in the morning session, England broke through shortly after lunch with Woakes finally rewarded for relentlessly bowling in the off-stump channel. He had Rahul caught at third slip with a ball that seamed away from length.

The second wicket of the session came via left-arm spinner Dawson,

who took just seven balls to strike in

his first Test in eight years. Jaiswal played for the spin but the ball did not turn that match, taking a thick outside edge on way to the first slip.

India captain Gill (12) did not last long as he misjudged an incoming ball from Stokes to not offer a shot, trapping him in front.

No team opting to bowl first has ever won at Old Trafford but Stokes ignored that piece of statistics on an overcast morning.

Despite backing Nair on the eve of the game, Gill dropped the number three batter for Sudharsan.

The other two were forced changes with uncapped Anshul Kamboj and Shardul Thakur making way for the injured Akash Deep and Nitish Reddy respectively.

Engineer, Lloyd Honoured With Stands At Old Trafford

ormer India wicketkeeper Farokh Engineer and legendary West Indies captain Clive Lloyd were on Wednesday honoured by the Lancashire County Cricket Club with stands named after them at the Old Trafford Stadium here, on the opening day of the fourth Test between India and England.

Engineer, who represented Lancashire from 1968 to 1976, played 175 matches, amassing 5,942 runs, 429 catches, and 35 stumpings.

His arrival marked a turning point for the club, helping them win the Gillette Cup four times between 1970 and 1975 after a 15-year title drought.

Lloyd, a two-time World Cup-winning captain, joined Lancashire in the early 1970s as an overseas player. Lloyd's two-decade-long association with the club was transformational as he played a crucial role in reshaping Lancashire's cricketing fortunes.

Engineer, now 87, has made Manchester his home post-retirement and continues to reside here.

Barcelona Signs Rashford On Season-Long Loan

arcus Rashford has been given the chance to revive his career at Barcelona with a season-long loan move from Manchester United announced Wednesday.

The England forward, who was once considered among Europe's top talents, has seen his career stall in recent years after falling out of favor at United and ending last season on loan at Aston Villa. The 27-year-old Rashford will join a Barcelona attack that includes young star Lamine Yamal, Brazil international Raphinha and veteran striker Robert Lewandowski. Rashford had arrived in Barcelona on Sunday to sign his contract. He had already met his teammates and reportedly trained with the group on Tuesday.

Financial details were not immediately disclosed. Spanish media said the agreement with United would give Barcelona an option to buy Rashford for about 30 million euros (\$35 million).
