New Delhi: India's aviation sector is grappling with an escalating safety crisis following a deadly crash involving an Air India 787-Dreamliner and a rising wave of technical snags across multiple airlines, prompting urgent questions over operational oversight and crew welfare.

The crisis deepened after over 100 Air India pilots went on medical leave just days after the catastrophic Ahmedabad crash, which claimed 274 lives. The aircraft, en route to Delhi, lost thrust mid-air and slammed into a hostel building two kilometres from the airport boundary.

Anti-Encroachment Drive Held In Karan Nagar, Kak Sarai

SRINAGAR: The Srinagar Municipal Corporation (SMC) on Thursday carried out a major anti-encroachment drive in the Karan Nagar and Kak Sarai areas of the Srinagar city, targeting unauthorized constructions and illegal occupation of public spaces by commercial establishments.

Led by Chief Anti-Encroachment Officer Muhammad Sayed, the operation focused on dismantling extended portions of shops and businesses that had encroached upon footpaths and public areas. Notably, parts of several well-known business establishments, including Shakti Sweets, were removed during the action.

The SMC team, accompanied by enforcement personnel, instructed shopkeepers

to strictly refrain from occupying illegal portions outside their approved premises to. They were also directed to stop the practice of displaying merchandise on footpaths, which hampers pedestrian movement and contributes to urban congestion.

During the drive, a quantity of illegally displayed merchandise was seized by the authorities as a warning against future violations.

According to KNT, the Chief Anti-Encroachment Officer Muhammad Sayed said that the operation was aimed at reclaiming public space and ensuring smooth pedestrian access in the busy commercial zones.

He stated that such drives will continue across Srinagar in the coming weeks, urging business owners to cooperate and avoid encroaching upon public land.

SMHS Hospital Incident Raises Serious Concerns

SRINAGAR: The Government Medical College (GMC) Srinagar has issued a renewed appeal for public cooperation and stricter regulation inside hospital premises after a resident doctor was assaulted in the emergency ward of SMHS Hospital. The incident, which took place on the night of July 22, has once again brought to light the growing tension between medical professionals and attendants in Kashmir's overcrowded healthcare facilities.

Terming the incident "unfortunate but revealing," SMHS Hospital Administrator Muhammad Ashraf Hakak said the assault underscores the urgent need for better crowd control and public discipline within hospitals. "One patient is usually accompanied by three to four attendants. Most of them play no role in the treatment process but end up overcrowding emergency wards and interfering with procedures," Hakak told reporters during a press briefing.

According to officials, the assault occurred when a critically ill patient was brought to the hospital's emergency wing. While doctors were attending to the case, one of the attendants allegedly attacked a junior

doctor from behind. The moment, captured by CCTV cameras, quickly went viral on social media, sparking widespread condemnation. Though the accused was later seen apologizing in a separate video, an FIR has been formally registered against him.

Despite the disturbing nature of the assault, Hakak confirmed that all medical services continued without interruption. "Not a single section was shut. Emergency care remained operational throughout. Our doctors responded with professionalism and restraint," he emphasized.

Dispelling rumors of any press-related obstruction during the incident, the administrator said, "We fully respect and value the role of media as a public bridge. There was no official instruction to hinder media access." He also clarified that the brief closure of the hospital gates, which led to speculation, coincided with the end of routine OPD hours and was not linked to any administrative clampdown.

GMC Srinagar handles an over-

whelming patient load every year—over 27 lakh individuals across its associated hospitals, with thousands of surgeries conducted in a constrained infrastructure. "We are not short of manpower. But without proper entry regulations and a secure atmosphere, even the best teams struggle to function," Hakak pointed out.

He further noted that the hospital has a well-structured system in place, including full rosters, round-the-clock duty schedules, and department heads remaining present through the night.

Calling for a societal shift in how patients and attendants engage with the healthcare system, Hakak concluded, "This is not just about one incident. It's a growing pattern that threatens the safety of medical staff. Doctors must be allowed to work without fear, interference, or aggression."

The administration has pledged to intensify awareness efforts and seek community cooperation to prevent such incidents in the future.

Columbia to Pay \$220M to **Restore Federal Funding**

Washington: Columbia University announced on Wednesday that it had reached a deal with the Trump administration to pay more than \$220 million to the federal government to restore federal research money that was cancelled in the name of combating antisemitism on campus.

Under the agreement, the Ivy League school will pay a \$200 million settlement over three years, the university said. It will also pay \$21 million to resolve alleged civil rights violations against Jewish employees that occurred following the October 7, 2023, Hamas attack on Israel, the White House said.

"This agreement marks an important step forward after a period of sustained federal scrutiny and institutional uncertainty," acting University President Claire Shipman said.

The school had been threatened with the potential loss of billions of dollars in government support, including more than \$400 million in grants cancelled earlier this year. The administration pulled the funding because of what it described as the university's failure to squelch antisemitism on campus during the Israel-Hamas war.

Columbia has since agreed to a series of demands laid out by the Republican administration, including overhauling the university's student disciplinary process and applying a contentious, federally endorsed definition of antisemitism not only to teaching but to a disciplinary committee that has been investigating students critical of Israel

Wednesday's agreement which does not include an admission of wrongdoing codifies those reforms while preserving the university's autonomy, Shipman said.

Columbia's reforms are a roadmap,' Trump administration says

Education Secretary Linda McMahon called the deal "a seismic shift in our nation's fight to hold institutions that accept American taxpayer dollars accountable for antisemitic discrimination and harassment."

"Columbia's reforms are a roadmap for elite universities that wish to regain the confidence of the American public by renewing their commitment to truth-seeking, merit, and civil debate," McMahon said in a statement.

As part of the agreement, Columbia agreed to a series of changes previously announced in March, including reviewing its Middle East curriculum to make sure it was "comprehensive and balanced" and appointing new faculty to its Institute for Israel and Jewish Studies. It also promised to end programmes "that promote unlawful efforts to achieve race-based outcomes, quotes, diversity targets or similar ef-The university will also have to issue a report to a monitor assuring that its programs "do not promote unlawful DEI goals.

Need To Assess Impact Of New Technologies On **Society: RSS Chief**

New Delhi: RSS chief Mohan Bhagwat on Wednesday called for an assessment of the impact of emerging technologies on society and the labour market, saying it must be ensured that they do not impact work opportunities.

Addressing an event held here to mark 70 years of the Bharatiya Mazdoor Sangh's foundation, Bhagwat underscored the need to pay greater attention to the unorganised sector to ensure that workers do not face any exploitation by their employers.

Union Minister for Labour and Employment Mansukh Mandaviya was present at the event, attended by a large number of delegates, including representatives of various trade unions.

"Technology is coming ... When new technologies come, they bring many new questions as well. What will happen to unemployment? Will it reduce unemployment, or increase?" Bhagwat said in an apparent reference to Artificial Intelligence and concerns around its use

He said technology makes mankind's nature a "bit harsh" and "somewhat" reduces the respect for labour.

"Technology can't be rejected. New technology will come. But how to handle it and ensure that it doesn't affect the labour sector needs to be looked into," he said.

The Rashtriya Swayamsevak Sangh chief said the use of new technologies should bring happiness in society, instead of creating "new problems." "That's why there is a need to ponder over (this issue) and act. We will have to do this," he added.

Trump Admin Targets Harvard Exchange Program in New Probe

BOSTON: In the latest in series of Trump administration inquiries targeting Harvard University, the State Department said Wednesday it is investigating whether the Ivy League school will remain part of a government program that provides American visas for students and researchers from other countries.

Harvard has faced mountg sanctions and from Washington since rejecting demands from a federal antisemitism task force in April. Harvard has filed a lawsuit challenging \$2.6 billion in federal cuts and has accused the Republican administration of waging a retaliation campaign.

The statement from Secretary of State Marco Rubio did not say why his department examining Harvard's eligibility to take part in the Exchange Visitor Program, which allows foreign nationals to study or work in the United States through cultural and education exchange programs.

It said all sponsors, such as Harvard, "are required to fully comply with exchange visitor regulations, transparency in reporting, and a demonstrated commitment to fostering the principles of cultural exchange and mutual understanding upon which the program was founded."

"Harvard continues to enroll and sponsor international scholars, researchers, and students, and will protect its international community and support them as they apply for U.S. visas and travel to campus this fall," Newton said in a statement. He said the school is committed to complying with the program's rules.

Brett Bruen, a former director of global engagement under Democratic President Barack Obama, said there is no justification for the administration's action.

"It not only damages Harvard, but American higher education & industry that depend on the best & brightest wanting to come here," Bruen said in a post on X.

The State Department said the investigation will seek to ensure that its programs "do not run contrary to our nation's interests."

SC Moved to Cut Age of **Consent from 18 to 16**

New Delhi: The Supreme Court has been urged by amicus curiae and senior advocate Indira Jaising to read down the statutory age of consent

Jaising, who is assisting the top court in "Nipun Saxena v. Union of India" case, has filled her written submissions challenging the blanket criminalisation of sexual activity involving adolescents aged 16 to 18 under the Protection of Children from Sexual Offences Act (POCSO), 2012 and Section 375 of IPC

She has argued the current law criminalises consensual romantic relationships among adolescents and violates their constitutional rights.

Jaising said the legal framework wrongly equates consensual relationships between adolescents with abuse,

ignoring their autonomy, maturity, and capacity to con-

There is no rational reason or empirical data to justify the increase in the age of consent from 16 to 18 years, Jaising submitted, noting that the age had remained at 16 for over 70 years until it was raised by the Criminal Law (Amendment) Act, 2013.

She pointed out the increase came without debate and went against the Justice Verma Committee's recommendation to retain 16 as the age of consent.

The amicus curiae submitted adolescents today attain puberty earlier and are capable of forming romantic and sexual relationships of their choice.

Scientific and social data. including findings from the National Family Health Survey, indicate sexual activity among teenagers is not uncommon, she said.

The Justice Department declined to comment on the Journal's report. However, in a joint statement, Bondi and Deputy Attorney General Todd Blanche said the files were reviewed thoroughly and that "nothing in the files warranted further investigation or prosecution.

On July 15, when asked by ABC News whether Bondi had told him specifically that his name appeared in the files, Trump said, "No, no, she's she's given us just a very quick briefing," before suggesting, without evidence, that the records were fabricated by political adversaries.

Man Opens Fake Embassy, **Creates 4 Fictitious Nations**

"West Arcucknow: "Saborga", "Lodonia", "Poulvia" - these were among fictitious nations a Ghaziabad man claimed to have represented as a self-styled diplomat while operating their bogus embassies from his rented house less than 35 km from Delhi.

A cursory internet search reveals that "West Arctica" is a non-profit body for climate action and an unrecognised micronation in Antartica, Lodonia is a micronation (a self-declared entity but not officially recognised as nation) in southern Sweden. Similar searches for Saborga and



Poulvia yielded little result. "diplomat"

working out of the "consulate", which also hoisted "flags" of these "nations" and a fleet of luxury cars with special blue coloured number plates parked outside, the police said.

The conman's elaborate

deception, however, came to an end on Tuesday when the Uttar Pradesh Police's Special Task Force (STF) arrested Harsh Vardhan Jain and uncovered a stash that included Rs 44.7 lakh in cash, foreign currencies, multiple forged diplomatic passports and 18 fake diplomatic number plates.

How Delhi's Courtroom Restored Balance In Bandipora

After months of delay and official inaction, a cement brick unit near a school in Kashmir is finally shut, thanks to the National Green Tribunal's intervention.

SRINAGAR: It took more than two years, countless petitions, and the intervention of the country's top environmental court to shut down a cement brick unit in Naidkhai, Bandipora.

The unit stood just next to a government higher secondary school and private homes. Despite clear violations of environmental laws, local officials looked the other way.

Zahoor Ahmad Dar, a resident of Naidkhai, first raised concerns in 2022 when construction began next to the school. Dust from the site filled classrooms. Noise disrupted lectures. The school principal wrote to the local tehsildar. A report was ordered, but no action followed.

The matter bounced from the SDM's desk to the DC's office, and eventually landed in the Governor's Grievance Cell

In May 2024, the J&K Pollution Control Committee (JKPCC) finally stepped in. It found the unit in violation of both the Water (Prevention and Control of Pollution) Act of 1974 and the Air (Prevention and Control of Pollution) Act of 1981. A closure order was issued on May 27, 2024.

That should have ended the matter. It didn't.

The NGT cited Section 58 of the Water Act, which bars civil courts from interfering in cases handled under the Pollution Control framework. They advised the JKPCC to approach the CJM for modification of the order.

The CIM vacated the stay on Iulv 15, 2025. Days later, on July 22, the Tehsildar sealed the unit.

Hajj 2026: J&K Sees Low Response As Deadline Nears

Only 2,244 Forms Received Against Expected Quota Of 7,896: Officials

SRINAGAR: With only a week remaining before the July 31 deadline for Hajj 2026 applications, Jammu and Kashmir has recorded a significantly low response, with just 28.42% of the expected applications submitted so far, officials said on Thursday.

According to data from the Jammu and Kashmir Hajj Committee, the Union Territory has been allocated a provisional quota of 7,896 pilgrims. However, as of July 24, only 2,244 applications have been received.

Officials expressed concern over the sluggish response, especially since the final quota confirmation from the Saudi government is still pending.

District-wise data shows that Srinagar has submitted the highest number of applications - 527 against its expected 1,113, reflecting a 47.34% response rate. Pulwama follows closely with 194 applications out of 408 (47.60%). Samba district, however, leads in percentage terms, with 87.61% of



its expected applications submitted (19 out of 22).

In contrast, several districts have shown alarmingly low participation. Poonch has recorded just 10.08% of its expected applications, Doda 12.26%, and Kishtwar 17.46%.

"So far, only 28% of applications have come in. We expect a last-minute surge, but the final quota from Saudi Arabia is still awaited," an official said.

Last year, 3,606 pilgrims from J&K performed Hajj. Officials noted that around 10% of selected applicants typically withdraw before departure.

The data indicates a continuing downward trend in Hajj participation from J&K. A comparative analysis of applications submitted for Hajj 2024 and 2025 shows a marked decline across all districts.

Trade leaders and economic observers attribute the drop to rising travel costs and broader economic distress in the region. "People are grappling with financial hardships, and pilgrimage is becoming in-creasingly unaffordable," a local businessman said.

With the deadline fast approaching, officials remain hopeful for a late surge in applications, but concerns persist over whether J&K will meet its expected Hajj quota for 2026.

CS Discusses Key Highway Projects With NHAI Chief

Special attention was drawn to the NH-44 stretch between Banihal and Ramban, where the Chief Secretary stressed the need for timely completion of tunnels and viaducts to mitigate disruptions caused by adverse weather. Highlighting the strategic and economic relevance of the region, Dulloo noted that J&K's key sectors tourism, horticulture, and agriculture are closely tied to robust road infrastructure.

Inside Srinagar's Coaching Hubs: Anxiety, Isolation, & Invisible Pain

SRINAGAR: As thousands of young Kashmiris pour into Srinagar chasing dreams of IITs, NEETs, and civil services, a silent crisis is unfolding in cramped hostels and buzzing coaching centres. Behind the glow of topper posters and motivational slogans, many students are sinking into anxiety, isolation, and burnoutwhat mental health profes-sionals are now calling a "crisis in the making."

Dr Mohd Abrar Guroo, a leading psychiatrist in the city, sees these signs daily.

"They don't talk about academics when they visit. They talk about chest pain, sleepless nights, panic attacks, and overwhelming anxiety," he said. "Most of them live alone, away from home and emotional support. The rooms they stay in smell more of loneliness than freedom."

One of his recent patients, a 17-year-old from Shopian, was convinced he was having a heart attack. But the diagnosis was anxiety brought on by prolonged isolation. "He hadn't spoken to anyone for two days," the doctor said. "His roommate was a stranger."

In another case, a girl from Baramulla shared: "I don't manage anything. The institute manages me." She followed a strict 12-hour study regimen daily.

The city's high-pressure coaching culture is now drawing comparisons with Kotathe north Indian coaching hub infamous for student stress and mental health challenges.

"These are invisible dropouts," said Dr Abrar. "They haven't failed exams, but they've checked out mentally long before the tests. They hide their suffering behind silence, fearing that vulnerability is

With little to no emotional outlets, many adopt harmful coping mechanisms. "Some pick up smoking, turn to cannabis, misuse sedatives, or spend hours glued to screens. These are not bad kids. They're exhausted children without support," Dr Abrar said.

He called for urgent reforms.

Coaching institutes must reduce toxic schedules and bring in trained counsellors, he said. Hostels should create spaces that encourage healthy peer interaction. Parents, too, need to check in emotionally, not just academically. "Struggling or feeling low

isn't failure, it's part of the pro-cess," he said. "A child's worth can't be defined by a rank. The real cost of this obsession may be their emotional well-being. "We celebrate toppers," Dr Guroo concluded, "but it's time

we also see those silently fall-

ing apart, and reach them be-

fore it's too late." (KNO)

Growth Sans Jobs

ashmir's skyline is changing. From Srinagar's outskirts to the valleys of Baramulla and Anantnag, new buildings are rising at a stunning pace. Glossy advertisements promise "smart homes" and modern gated colonies. Developers from Delhi, Punjab, even Dubai are also looking to invest in what looks, from a distance, like a region on the rise.

But take a closer look, and the situation isn't as optimistic as far as the economy goes. These homes, many complete or nearing completion, are largely empty. Entire apartment blocks have one or two caretakers living alone, guarding homes that were never lived in.

What Kashmir is witnessing is a housing boom unanchored to economic realityThe truth is that the unemployment is rampant in the Valley, and it is a crisis that is aggravating by the day.

Engineers go to Bangalore. Nurses fly to the Gulf. Teachers, MBAs, and skilled workers follow opportunity across the country and abroad. They are not leaving for greener pastures but to escape the joblessness in the Valley, and the consequent bleak future.

Unemployment in Kashmir is not just a statistic. With a literacy rate of 67.16 percent, Kashmir offers its youth little beyond rare government job exams, underpaid private roles, and a long wait for something better. It's no surprise that migration is now a norm.

This leaves Kashmir with a stark contradiction: a region in the throes of an apparent construction boom but no substantive economic growth that could provide its educated youth employment. If this pattern continues, Kashmir risks becoming a ghost town in disguise, glittering on the outside, empty on the inside.

So, there's an urgent need for job creation. We need industries, and sustainable livelihoods. The proposal to set up Special Economic Zones (SEZs) in Kashmir is timely and necessary. SEZs focused on IT, handicrafts, horticulture, and food processing can be employment engines. Investment, whether government or private-led, should flow not just into Srinagar but into smaller towns to extend job opportunities to the youth also incountryside..

The government has a critical role: it must treat job creation as a priority. But this is something that doesn't seem even distantly on its agenda. Right now, youth in Kashmir have no option but to pack up and leave. While this is not entirely a bad thing, we must find reasons for them to stay. We must ensure that they don't leave because of the hopelessness at home.

Through it all, the doctor's white coat stood for something: a symbol of calm in a storm.

Now, that coat feels like a target. And let's be honest, it's not just the system that's collapsing. It's us, the people.

We're losing tience, trust, and the basic civility that holds a society together. The val-

ley that once lived by the wisdom of saints like Sheikh Noor-ud-din Noorani and Lal Ded now reacts with rage before it listens.

Empathy is fading, suspicion is rising, and we, the ones who show up to heal, are bearing the brunt of that change

Yes, the system is broken. The doctor-to-patient ratio is one of the worst in the country. In some areas of Kashmir, a single doctor may be responsible for more than 2.200 people. We work with outdated machines, late ambulances, short supplies, and chaotic environments.

But here's the truth: We keep going, because we've made a promise to help, even when it hurts.

Yet that promise feels harder to keep when violence becomes routine. We're shouted at, filmed without consent, blamed on social media.

or physically attacked, sometimes by those we're trying to save.

Just recently, a senior surgeon in Srinagar paused a scheduled operation after discovering abdominal adhesions. It was the right medical decision. But what followed was public outrage.

News outlets called it negligence. Social media called him a "butcher." No one waited for an inquiry, or asked for facts. A reputation built over decades was torn

down in hours. This isn't countability. mob justice,

guised as public concern. What's happening in our hos-

pitals is bigger than just broken infrastructure. It's a mirror. It reflects who we're becoming. Our hospitals have become the final line between order and collapse, and even they're starting to give way.

So what can be done?

First, we need to talk about respect, the basic understanding that doctors are human. We're not magicians or miracle workers. We make mistakes, but slapping, shouting, or threatening won't save lives.

Hospitals must have proper grievance cells. Complaints should be addressed quickly, transparently, and fairly. Accountability is necessary. But anger is not justice.

Doctors, too, must step up, with empathy. We must speak more clearly. Listen more fully. A rushed sentence or a cold tone can often do more damage than a wrong diagnosis.

I grew up hearing stories about how Dr. Ali Jan treated his patients, how he looked them in the eye and made them feel truly seen. In hard times, that kind of care is

often where healing begins. The government must finally recognize that this is not a minor issue. We need a national protection law for healthcare workers, with fast-track courts and strong deterrents.

We need de-escalation teams in hospitals, and public officials to speak out after every attack.

And the media must act responsibly. Cover medical stories with care. Don't rush to blame. A doctor's reputation shouldn't be destroyed by hashtags and headlines.

When we start attacking the people who save us, something fundamental is lost: hope.

Kashmir has already seen too much loss, mistrust and pain. Through all of it, the hospital remained one of the last safe spaces. That sanctuary is now cracking.

So we must ask: What kind of society attacks its own healers? And what kind of society stays silent while it happens?

We still have time to answer wisely. But not forever.

Strikes Can't Cure

At the heart of Srinagar's hospital crisis lies a moral dilemma: can a caregiver protest without betraying the patient?

unsafe systems is a form of care, because staying silent enables rot.

But there's a line.

Every strike risks a life. In Kashmir, where public hospitals are overloaded and private care out of reach, even a few hours of shutdown can mean tragedy.

Patients often arrive at tertiary hospitals as their last hope. A closed emer gency room doesn't just delay treatment. It closes the door on survival.

Strikes aren't equal in their im-COUNTER VIEW pact. The rich will find alternatives. poor won't.

Those who live in far-off villages or refugee camps don't have backup plans. That's where the ethical weight falls hardest.

Critics argue that protest should not come at the cost of care. The Hippocratic Oath isn't about conditions. It's about commitment.

And when doctors walk out, even briefly, that sacred trust frays. If the public begins to see doctors as negotiators first and caregivers second, trust crumbles

So where's the line between resistance and responsibility?

In the Srinagar case, the situation was handled delicately. Hospital management opened talks. Senior doctors were pulled in to cover gaps. Commitments were made. Still, many condemned the initial walkout. Some called it "unbecoming of the profession. Others blamed a larger system that leaves doctors exposed and unsupported.

Doctors, meanwhile, felt betrayed, mostly by those who were silent.

Where was the outrage when staff were assaulted, when protection was promised and

never delivered? Many feel society demands martyrdom from its doctors, but refuses to fight for their safety.

Social media erupted. Some stood with the doctor. Others with the patient's family. A few with the journalist who reported it.

Lost in the noise was the deeper crisis: a hospital built for hundreds. now treating thousands, run by staff

who haven't had a break in months. In these conditions, even the best falter from exhaustion.

What's needed is prevention. Kashmir's healthcare system must build early-warning systems, mechanisms for redress, formal grievance cells, and safety protocols that work in real-time. Above all, there must be a non-negotiable rule: emergency care never stops Doctors' bodies must also act, to

develop codes of ethical protest, guide members on how to dissent without damage, and stand firm when one of their own is harmed, without punishing patients in return. Media and civil society need to

stop treating every strike as betrayal. And leadership in healthcare must act before things collapse.

The strike at SMHS was not just a healthcare system held together by overworked staff and understaffed wards is bound to break.

Violence against doctors is a red line, so is leaving patients unattended. Neither can be justified. Both must be prevented.

Kashmir's public hospitals need protection, of patients and doctors alike. They need resources, respect, and reform. Without it, we'll keep circling the same crisis.

The question is not simply whether doctors should strike. It's why they feel they have to.

What We've Done to Marriage in Kashmir

Kashmiri wedding used to mean a prayer, a promise, and two families coming together. Today, it often

In a place where culture once valued simplicity and faith, marriage has become a public performance, with meat-heavy feasts, dowries dressed as gifts, and expectations that grow more punishing each year.

The numbers are stark. More than 65,000 women in Kashmir have crossed the traditional age of marriage. In Srinagar alone, over 45,000 women over 30 remain unmarried. This isn't due to a lack of education.

faith, or character. It's because their families can't afford what society now treats as minimum requirements: gold, lavish functions, designer wear, and long guest lists. Parents, especially fathers, carry

this burden. Many suffer in silence, knowing that even a simple, sincere marriage will invite judgment. A modest ceremony is seen as a social failure. The whispers follow, about status, respect, and whether the daughter was "worth celebrating." The girl, through no fault of her own, ends up believing she is a burden.

This isn't just about women. Expectations placed on men are equally suffocating. A young man with strong values and a decent job is often overlooked unless he's in government service, owns property, or comes from a well-known family. A

government badge now matters more than compassion or compatibility.

The tragedy is layered. These inflated standards don't just hurt families, they distort the meaning of marriage itself. Our faith teaches that a nikah should be simple, accessible, and rooted in mutual respect. The Prophet Muhammad (PBUH) said, "When marriage becomes expensive, adultery becomes easy." That's not a metaphor. It's a warning. And it's coming true

Many families take out loans just to keep up with expectations. Some never recover. Others are shamed for choosing restraint. Rituals once based on joy now feel like transactions. And the sacred bond of marriage is treated more like a luxury than a right.

We need to step back. The Qur'an

warns us against extravagance for a reason. Weddings shouldn't be about impressing guests. They should be about beginning a life.

This shift won't come from one family or one sermon. It has to come from the community. Imams must speak up. Teachers and elders must break the silence. Families must agree that a daughter's dignity is not measured in gold weight, and a son's worth is not based on a job title.

Marriage should be a door, not a wall. It should offer a future, not debt, shame, or delay.

In a crowded Kashmir hospital, a young woman's call for help leads to guilt, reflection, and a brush with invisible rules of fairness and favour.



The neurologist came late. My turn was going to get delayed by about two hours. The same fateful day, I got my period after over two months. My back was aching and my stamina was dropping.

I have been feeling quite terrible for the past month, feeling empty in my heart, crying a few times, holding back at other. When I finally got my period, it occurred to me that the disruptions in my mood could have been a consequence of some hormonal disturbances which led to the delay in my monthly cycle.

I am trying to do things independently as Baba has a lot to take care of already. I asked my younger sibling to accompany me to the hospital. It is a private hospital. I was on time but upon arrival, I came to know that the doctor had seen only a few patients. I was angry. To make things worse, the hospital was full and I did not have a place to sit. I took the support from the backrest of the hospital bench while standing and waiting.

"Should I go back?" My brain was in a low-key survival mode. But how could I? I had already invested money and energy into making it to the hospital. Dilemmas are scary. Same day early morning, I made several phone calls to the hospital for an hour to get my hands on an early appointment. But those people did not



answer any of the calls, until thev did and gave me one of the last serial

"Should I call Baba and ask him to come around?" No. This is not why I was trying to do things on my own.

My little sibling could see I was not doing well. I was feeling weak and a panic attack felt doing rounds up and down my throat.

"Should I call Doctor Uncle and ask him to help me with my turn?" After waiting for 40 lengthy minutes, I gave up and called him. He is a much respected senior doctor in the valley and my father's friend.

"I need help, only if possible. I am not feeling well," I insisted. "I will see if it is possible," he told me. After half an hour, Doctor Uncle called back saying that he spoke with the doctor.

I do not like such privileges. If I were a VVIP, I would respectfully want to wait for my turn like every other person. Those are my morals and principles. I was not feeling good about making this phone call. tried to recall how many rules I had broken in my life. I remembered breaking a red signal when the road was empty. But a gentleman rode by my side and in a fatherly manner told me that it was not a good thing. I took that advice to my heart and never ran a red light again. It feels like the Cosmos has its way to remind you of your values. Somehow, it felt that it would happen again if I

Doctor Uncle had already made the call when a young man standing in front of me complained to the receptionist that people were entering the doctor's office out of their turns. He was anguished and told the other patients that if he rose his voice

against this unfair treatment, he would be seen as the wrong person because the receptionist was a female. He was only adding to my guilt because as a woman I know it to be true. Matriarchy prevails over here. He kept complaining and my heart kept sinking because I knew they were about to call my name. I was unable to look the other patients in the eyes. I wished they never called my name. But it was too late already.

This young man went inside the clinic on his turn. Now there was one more patient and I standing at the door. After a few minutes, the doctor came out of his office and asked, "Who is Aisha here?" I entered with the other patient waiting at the door. I asked the doctor to kindly see the other patient first.

"Your reference came via Sir," the doctor told me.

"And I am not feeling good about it. I did not want to do it," I replied.

"It's okay," he said. The same day I was watching a horror movie, after a long time. I needed a shift in the kind of emotions I was feeling. I watched The Nun. I hoped that in the night when I turned the lights off, the scary nun does not feel real.

I was very tired that evening. I was drifting into sleep when the tall and paranormal nun came to my mind and oddly enough, all I could imagine was she sitting by my side and giving me a back massage, hoping she had strong hands. Now that is scary. My conscience was heavy with stress from pain and guilt.

come from the margins. My father labored to earn daily wages, and I stitched clothes in a small tailoring unit in Kashmir to support my family. We weren't rich, but we lived with dignity. I

liked the rhythm of my work, the feel of fabric under my fingers, the chatter of women hunched over sewing machines, the comfort of routine. One morning, everything changed.

There had been a theft at our workplace. Someone had taken something, I still don't know what it was, and the blame fell on me.

They said I brought the thief in. And that I was

My heart pounded as the accusations flew. I kept explaining, my voice hoarse from trying to convince them. I didn't steal. I didn't know who did. I begged them to believe me.

No one listened.

That single allegation shattered everything I had built. My employer dismissed me. People who once greeted me with warmth now looked through me. Some whispered behind my back. Others openly blamed me. I lost not just my job,

In a place like Kashmir, where social reputation is tightly woven into survival, that loss was devastating. The shame clung to me like smoke.

I remember walking back home in tears, my back aching from work, my body heavy with ex-

haustion and my mind heavier still. I became invisible in a community where word

travels fast and forgiveness travels slowly.

For days, I stayed home, afraid to step out. I stopped visiting friends. My family, already burdened by financial strain, didn't know how to help. I could feel them struggling to believe me, even as they comforted me. That doubt cut deeper than the accusation.

And yet, amid all the silence, something stirred inside me. Maybe it was rage. Or maybe it was the old resilience I inherited from women who survived curbs, and curdled dreams in this valley. I told myself: if they won't give me a chance, I'll

make one. I'll work again. I'll rebuild. I'll carry this wound and still walk forward.

That is what I did.

I took up small stitching assignments at home. A neighbour gave me fabric to hem. Someone else needed suit tailored. My hands got busy again. Slowly, I kept my earnings under my mattress. With each finished piece, I was sewing back not just fabric, but my sense of self.

What happened to me wasn't an isolated inci-

In our homeland, where unemployment among women remains among the highest in India and patriarchal norms still shape judgment, a woman's character is often treated like glass. One whisper, and it cracks.

Many women in informal workspaces lack contracts, complaint mechanisms, or legal safeguards. When something goes wrong, it's easier to blame the powerless. And too often, that means blaming a woman.

What struck me most was how quickly people believed the worst. I've seen dishonest people deflect blame onto others to protect themselves.

In our society, doing good doesn't always protect you from harm. In fact, being kind, being helpful, can sometimes make you more vulnerable.

So here's what I've learned: don't let someone else's lie define you. The truth may take time to surface, but it doesn't rot. It waits. It shines through your work, your actions, your persistence.

And when you've felt pain deeply, you learn never to be the cause of someone else's suffering. I still live with that false label. Some people continue to avoid me. But I carry my story now with strength, not shame. I've turned the sting of

accusation into the steel of survival. Life is rarely easy in the valley, especially for women at the margins. But I want others like me to know: one accusation isn't the end. You can stand again. You can rise.

A group of women wait by the mirror wall, water bottles in hand. Some are college students. Others are mothers. Most have never trained seriously before this.

By 7:05, the room is moving. Deadlifts, squats, push-ups. Form corrections. Breath counts. Sweat begins to bead across foreheads. So do stories, of breakups, weight gain, back pain, insomnia, fear.

And in the center of it all is a 29-year-old trainer who's doing more than coaching bodies. She's holding space.

Muskaan Bashir isn't a typical gym coach. She never planned to be one. Her early years were spent mastering martial arts, karate, spe-

Raised in Srinagar's Rawalpora neighborhood, she remembers childhood in motion: sunrise runs, bruised knees, disciplined limbs.

"Karate didn't just teach me how to punch. It taught me how to get up when everything in you says stay down," she said.

She became a certified national karate coach before she was 25, a state-level referee by 27. Her room holds medals few have seen. "Those medals are symbols," she said. "They mean I stayed.'

But sometime in 2019, after an injury forced her off the mat, Muskaan stepped into a gym and felt something shift.

There was structure, silence, and the possibility of strength without combat. She trained silently, learned weights, and realized that what mattered wasn't how fast she moved, but how steadily she could help oth-

ers stand. When she joined Go Fitness in 2020, Kashmir was still limping through the aftermath of political lockdowns and a pandemic. Gyms were shuttered. So were most women's aspirations.

But the two-storey air-conditioned gym in a busy Srinagar neighbourhood, had begun to carve space for female trainers. Muskaan became its anchor.


In a region where fewer than 30 certified female trainers exist across all districts, her presence mattered. Many women in Kashmir still avoid gyms due to conservative norms. lack of privacy, and internalized shame.

At Go Fitness, the female section has mirrors, mats, and machines. More importantly, it has Muskaan.

"She never once commented on my body," said Alia, a 32-year-old schoolteacher who joined Muskaan's sessions in 2022 after a miscarriage. "She asked how I slept. What I ate. Whether I was breathing okay. That's when I started to trust her."

Muskaan doesn't advertise results. She doesn't talk about six-pack abs. "Most of my girls don't care about the mirror," she said. "They want to sleep better. Carry groceries without pain. Feel safe in their skin."

Her daily batches include women from different social classes. Some take shared cabs from the outskirts.



Others come straight from university lectures.

In one group, a mother of four trains beside a teenager recovering from an eating disorder. The workouts are customized, but the message is the same: strength is personal.

"She never forces," said Farhat, a 26-year-old from Batamaloo. "She reminds us that progress isn't parade. It's when you breathe a little easier after a flight of stairs."

That philosophy shapes Muskaan's approach to mental health too.

She regularly holds Sunday sessions on menstrual fitness, stress release, and injury prevention. In 2023, she began collaborating with local counselors to offer referral support for women showing signs of anxiety and depression.

According to a 2022 study by the Government Medical College, Srinagar, over 40% of women in the valley suffer from some form of psychological distress.

"Therapy isn't accessible to many girls here," she said. "So I try to turn the gym into a safe zone. Sometimes, lifting weights is their therapy." Her Instagram feed avoids filters. Instead, it features progress clips,

food tips, and small wins. A recent video showed a firsttime lifter attempting 15kg deadlifts while wiping away tears. "This is where healing begins," the caption

Muskaan's impact now reaches beyond city limits. In Kupwara, a group of young girls began a self-organized fitness club after watching her videos. In Pulwama, a mother contacted her for home workouts after her daughter developed PCOS symptoms. NGOs working on adolescent health have approached her to conduct school-based awareness

Still, the journey isn't free from resistance. "Some men stare through the glass. Others say gyms make girls arrogant," she said. "Even some women say this isn't our role. That we're trying to be men."

She shrugs it off. "Let them talk. I don't train for applause."

In recent months, Muskaan has begun designing an all-women's training curriculum rooted in Kashmiri routines, incorporating local diets and body patterns often overlooked by urban models.

"Fitness advice copied from Delhi or Mumbai doesn't always work here," she said. "Our girls fast differently. Their energy dips differently. They need their own blueprint."

Inside Go Fitness, the 8 a.m. batch is winding down. Someone plays a song on Bluetooth. Two women high-five over a successful plank hold. Another pulls her dupatta tighter and wipes her face.

And in the back, Muskaan is adjusting weights for a girl who couldn't lift 5kg last month. Today, she's at 10.

This is the moment Muskaan waits for. "That moment when a girl realizes she's stronger than her past," she said. "That's when change begins.'

In a region long defined by limits - conflict, silence, shame - Muskaan Bashir is building something different: a room full of women who no longer wait for permission to feel

'4-Day Workweek **Boosts Well-Being in High-Income Nations'**

four-day workweek might help with an **L**employee's well-being, according to a study that trialled the intervention in organisations across the US, UK. Canada, Ireland, Australia and New Zealand.

Researchers from Boston College in the US and University College Dublin in Ireland found that workers reported an improved well-being with lower levels of burnAustralia, Canada, Ireland, New Zealand, the UK and the USA shows improvements in burnout, job satisfaction, mental health and physical health -- a pattern not observed in 12 control companies.'

The improved wellbeing was attributed to three factors -- an enhanced perception of one's own work ability, reduced sleep problems and lower levels of fatigue.

'The results indicate that income-preserving four-day workweeks are an effective organisa



out, a better job satisfaction and physical and mental health -- this was not seen among employees of 12 organisations where a reduced workweek was not trialled.

For the study, published in the journal Nature Human Behaviour, nearly 2,900 employees across 141 organisations in the six high-income countries worked four days a week for six months without a pay reduction.

To maintain productivity, workplaces were re-organised with efficiency and collaboration improvements prior to

start of the trial. The authors wrote. "Analysis of pre- and post-trial data from 2,896 employees across 141 organisations in

tional intervention for enhancing workers' wellbeing," the team said.

Countries around the world have been experimenting with interventions, such as a shorter workweek or reduced working hours in a week, to improve work-life balance and boost productivity.

However, a country's labour laws and economic conditions, along with how work and leisure is culturally perceived are other factors influencing a potential shift away from traditional work routines.

France legally mandated a 35-hour workweek in the early 2000s, while Bhutan is said to be amongst the countries with the most working hours per week -- over 50.

Indian Users Can Now Use UPI On Foreign Land, Sites Via PayPal World

NEW DELHI- In a major boost to cross-border digital payments, Indian users will now be able to use the Unified Payments Interface (UPI) to make payments

internationally through PayPal.
The global payments company 'PayPal' has announced the launch of "PayPal World", a new platform that aims to connect the world's largest payment systems and digital wallets.

The platform will start by of-fering interoperability between PayPal and Venmo, and include UPI as part of its initial launch. This means Indian consumers can now shop from international merchants and pay using the UPI option they are already familiar with.

For example, an Indian user browsing an online store in the United States to buy a pair of sneakers will now see a UPI button after clicking the PayPal option at checkout. This allows them to complete the transaction using their UPI account, just as they would for any domestic payment.

Shukla, Managing

Director and CEO of NPCI International Payments Limited, welcomed the development. He said, "The integration of UPI on PayPal World's platform will mark a significant step in expanding UPI's global foot-print. It aligns with our vision to make cross-border payments more seamless, secure, and inclusive. This collaboration will enhance convenience for Indian users making payments abroad and enable global businesses and merchants to tap into a growing base of UPI users."

The company stated that collaboration includes global partners representing nearly two billion users worldwide. These include Mercado Pago (MOU signed, further details being scoped), NPCI International Payments Limited (UPI), PayPal, Tenpay Global, and Venmo.

The platform also benefits users from other countries. For instance, a PayPal user travelling to China can make payments at a cafe that accepts Weixin Pay simply by scanning the code using their PayPal app.

Similarly, a Venmo user in the US can send money to a friend in Germany by typing in the phone number and selecting the PayPal wallet.

This step marks a new beginning for global digital payments, especially for Indian users who rely heavily on UPI for everyday transactions. With PayPal World, sending money or shopping across borders will

India's Mobile Phone Exports Rise 127 Times To Rs 2 lakh **Crore In 10 Years**

NEW DELHI- Export of mobile phones from India increased by 127 times to reach Rs 2 lakh crore in the last 10 financial years, Parliament was informed on Wednesday.

According to data shared by Minister of state for Electronics and IT Jitin Prasada in a written reply to Lok Sabha, the export of mobile phones "increased 127 times" from India from Rs 1,500 crore in 2014-15 to Rs 2 lakh crore in 2024-25.

The PLI Scheme for LSEM has already attracted a cumulative investment of INR 12,390 crore, of Rs 8,44,752 crore with exports of Rs 4,65,809 crore and generated additional employment of 1,30,330 (direct jobs) till Jun'25," the minister said.

The production linked incentive (PLI) scheme for Large Scale Electronics Manufacturing was mainly meant for mobile phone

manufacturing. The minister said that 75 per cent of the total mobile phone demand in the country was met through imports in 2014-15, which has now dropped to 0.02

per cent in 2024-25. "PLI Scheme for Large Scale Electronics Manufacturing has




significantly impacted the mobile manufacturing sector in India particularly in transforming India from a net importer to a net exporter of mobile phones. Bharat is now the second large mobile manufacturing country in the world," the minister said.

Mr Prasada said the PLI Scheme 2.0 for IT hardware has attracted a cumulative investment of Rs 717.13 crore, led to a cumulative production of Rs 12,195.84 crore and generated additional employment of 5,056 (direct jobs) till June.

"Total FDI in the field of electronics manufacturing in the last 5 years (i.e. since FY 2020-21) is USD 4,071 million, cumulative FDI of USD 2,802 million has been contributed by MeitY PLI beneficiaries," the minister said.

Historic Day For India-UK Relations: PM Modi **On Free Trade Deal**

NEW DELHI- India and the UK on Thursday inked a landmark free trade pact that will increase market access, cut tariffs on British whisky and cars among other items and double bilateral trade by 2030 as the two strategic partners vowed to chart a new growth path amid growing global concerns over Washington's trade policies.

Today is a historic day in India-UK relations, said Prime Minister Narendra Modi, who witnessed the signing of the trade pact along with his British counterpart Keir Starmer.

After many years of hard work, a comprehensive eco-nomic and trade agreement has been inked between India and the UK, he noted, with Starmer by his side at Chequers, the country residence of the British PM. The two leaders held a tete-a-tete before holding serious talks.

The deal is expected to benefit 99 per cent Îndian exports

In his remarks, Starmer said it is the biggest and economically most significant trade deal that the UK has signed since leaving the European

In his media statement, Modi thanked the UK for its strong condemnation of the Pahalgam terror attack and said both sides are united that "there is no place for double standards in the fight against terrorism."

"We agree that forces with extremist ideologies cannot be allowed to misuse democratic freedoms," he said.

Modi said security agencies of India and the UK will continue to enhance cooperation and coordination on matters such as the extradition of economic offenders.

On the free trade pact, Modi said it will create new opportunities in the British market for India's agricultural produce and processed food industry, and that it will be particularly beneficial for India's youth, farmers, fishermen,

and MSME sector. Indian textiles, footwear, gems and jewellery, seafood, and engineering goods will gain better market access in the UK, he added.

Modi said India and the UK are also firming up the "Vision 2035' roadmap to give new momentum and energy to the comprehensive strategic partnership between the two sides in the next decade.

The Prime Minister also touched upon the overall situation in the Indo-Pacific.

"We have continued to share views on peace and stability in the Indo-Pacific, ongoing conflict in Ukraine, and the situation in West Asia," he said.

The Prime Minister asserted that respect for the sovereignty and territorial integrity of all countries is essential.

The demand of today's era is not "expansionism, but developmentalism", he said.

Modi also condoled the deaths of several British citizens in the Air India plane crash

MUMBAI- The Enforcement Directorate on Thursday conducted raids at multiple locations as part of an alleged Rs 3,000 crore worth bank loan fraud-linked money laundering case against the companies of Reliance Group chairman Anil Ambani, official sources said.

Some more bank loans taken by these companies apart from certain alleged undisclosed foreign assets are under the scanner of the agency.

More than 35 premises in Mumbai belonging to 50 companies and 25 people were searched under the Prevention of Money Laundering Act (PMLA). Some documents and computer peripherals have been recovered, they said. The investigation is being carried out by a Delhi-based

investigation unit of the ED. ED sources said they are primarily probing allegations of illegal loan diversion of around Rs 3,000 crore, given by the Yes Bank to the group companies of Ambani between 2017-2019.

Two group companies, Reliance Power and Reliance Infrastructure, said in separate but identical regulatory filings that the ED action has had "absolutely no impact" on their business operations, financial performance, shareholders, employees, or any other stakeholders.

The media reports appear to pertain to allegations concerning transactions of Reliance Communications Limited (RCOM) or Reliance Home Finance Limited (RHFL) which are over 10 years old," the companies said.

The ED, the sources said, has found that just before the loan was granted, Yes Bank promoters "received" money in their concerns. The federal probe agency is investigating this nexus of "bribe" and the loan.

Sources said the ED is also probing allegations of "gross violations" in Yes Bank loan approvals to these companies including charges like back-dated credit approval memorandums, investments proposed without any due diligence/ credit analysis in violation of banks credit policy, the sources said. The loans are alleged to have been "diverted" to many group companies and "shell" (bo-

gus) companies by the entities involved. The agency is also looking at some instances of loans given to entities with weak financials, lack of proper documentation of loans and due diligence, borrowers having common addresses and common directors in

their companies etc., the sources said. The money laundering case stems from at least two CBI FIRs and reports shared by the National Housing Bank, SEBI, National Financial Reporting Authority (NFRA) and Bank of Baroda with the ED, they said. These reports indicate, the sources

said, that there was a "well-planned and thought after scheme" to divert or siphon off public money by cheating banks, shareholders, investors and other public institutions. The Union government had in-

formed the Parliament recently that the State Bank of India has classified RCOM along with Ambani as 'fraud' and was also in the process of lodging a complaint with the CBI. A bank loan "fraud" of more than

Rs 1,050 crore between RCOM and Canara Bank is also under the scanner of the ED apart from some "undisclosed" foreign bank accounts and assets, the sources said. Reliance Mutual fund is also stated

to have invested Rs 2,850 crore in AT-1 bonds and a "quid pro quo" is suspected here by the agency.

Additional Tier 1 (AT-1) are perpetual bonds issued by banks to increase their capital base and they are riskier than traditional bonds having higher interest rates. An alleged loan fund diversion of about Rs 10,000 crore involving Reliance Infrastructure too is under the scanner of the agency.

British products such as soft drinks, cosmetics, chocolates, biscuits, lamb, salmon and cars will also be easily accessible to Indians, as the average tariffs will drop from 15 per cent to 3 per cent after the free trade agreement comes into effect. Electric vehicles will see a tariff cut from 110 per cent to 10 per cent within a quota.

After the trade deal comes into operation, it will be easier for British firms to export whisky and other products to India per PTI. Import duty on whisky will fall from 150 per cent to 75 per cent immediately and to 40 per cent over 10 years.

Apart from products, the trade agreement also makes it easier for Indians to live in the UK as firms and freelancers will have access to 36 service sectors in the UK with no 'Economic Needs Test'.

Indian professionals will now be able to work in 35 sectors in the UK for 2 years even without an office in the country. The commerce ministry has stated that the move could benefit more than 60,000 IT professionals each year. Major beneficiaries include TCS, Infosys, Tech Mahindra, HCL Technologies, and Wipro.

Indian professionals will also be exempted from UK social security payments for 3 years under the agreement.

40 families received job appointments on July 13, within 15 days of LG Sinha's assurance in Anantnag last

Fayaz Ahmad Sheikh from Sheeri, Baramulla, who lost his father to terrorist violence, said repeated promises by past regimes amounted to nothing. "No one can imagine our pain," he said. "They made us run in circles with fake assurances and endless verifications. We urge LG Sinha to reserve jobs for survivors, we have suffered enough.'

A woman from north Kashmir, whose husband and only son were killed by terrorists, said she was never offered help. "I was left alone to raise two grandchildren in pain and poverty. No one came," she said.

Responding to the survivors' accounts, LG Sinha said families of terror victims had been ignored for decades while those connected to militants were given jobs and political cover. "That era is over," he said. 'The real victims are finally being heard and rehabilitated.'

In his address, LG Sinha said the government is committed to correcting past wrongs and dismantling the long-standing "terror ecosystem" that allowed perpetrators to thrive while victims were forgotten.

"For almost three decades, conflict entrepreneurs ruled the roost. They painted terrorists as victims and India as the aggressor. That false narrative has been demolished," the LG said. "We are now identifying those who supported terrorism and removing them from government jobs. Justice belongs to the real victims.

To institutionalize support, the J&K administration has launched a dedicated web portal to document and process claims from families affected by terrorism. Commerce and Industry Minister Piyush Goyal and his British counterpart Jonathan Reynolds signed the agreement at a ceremony in UK Prime Minister's country residence Chequers.

Prime Minister Narendra Modi, who flew in to mark the occasion. hailed the pact as "a blueprint for our shared prosperity".

"On the one hand, Indian textiles, footwear, gems and jewellery, seafood, and engineering goods will get better market access in the UK... On the other hand, people and industries in India will be able to access products made in the UK, such as medical devices and aerospace parts, at affordable and attractive prices," he

In his remarks to the media, Modi said the UK and India are "natural partners" and said the nations were 'writing a new chapter" in their

Prime Minister Keir Starmer termed it "the biggest and most economically significant" trade deal Britain has made since Brexit.

'The UK has been negotiating a deal like this for many years, but it is this government that got it done, and with it, we're sending a very powerful message that Britain is open for business, and that is already generating huge confidence," he said.

For India, the FTA represents its most significant strategic partnership with an advanced economy and could serve as a model for future agreements, including a potential deal with the European Union.

Under the pact, which has been termed Comprehensive Economic and Trade Agreement (CETA), tariffs on Scotch whisky will be reduced from 150 per cent to 75 per cent immediately, and further lowered to 40 per cent by 2035.

On automobiles, India will reduce import duties to 10 per cent over five years, down from the current rate of up to 110 per cent, under a gradually liberalised quota system.

In return, Indian manufacturers will gain access to the UK market for electric and hybrid vehicles, also within a quota framework.

India has provided duty concessions to the UK auto exporters only on large petrol and diesel vehicles and high-priced EVs, while protecting sensitive segments of the domestic automotive industry, especially mid and small cars and low-priced EVs, under the trade pact.

No concessions are given to electric, hybrid, and hydrogen-powered vehicles in the first five years of the agreement.

On the other hand, India will get duty-free access to several agri goods in the UK, such as fruits, vegetables, cereals, turmeric, pepper, cardamom, and processed goods like ready-to-eat food, mango pulp, pickles, and pulses.

Over 95 per cent of agricultural and processed food tariff lines will attract zero duty. Marine products such as shrimp, tuna, fishmeal, and feeds, currently taxed between 4.2 per cent and 8.5 per cent at present, will become completely duty-free once the pact comes into force. It may take about a year, as it requires approval from the British parliament.

In the textiles segment, India is facing a duty disadvantage vis-a-vis Bangladesh, Pakistan and Cambodia, which have duty-free access to the UK market. Now this FTA would eliminate the tariff on textile imports from India, thereby enhancing its price competitiveness in the UK market.

Products that are poised for exponential growth include RMG (readymade garments), home textiles, carpets, and handicrafts, where the removal of duties would create competitive advantages.

India is expected to gain at least 5 per cent additional market share in the UK within 1 to 2 years of the implementation of the deal.

The pact also announced tariff elimination (from 18 per cent at present) for Indian engineering exports to the UK. It could help double domestic exports in the next five years to over USD 7.5 billion by 2029-30.

India's exports of generic medicines and medical devices, such as X-ray systems and surgical instruments, will get a major boost with Britain agreeing on zero duty under a free trade agreement.

On the services front, the agreement will enable Indian financial services players to expand their footprint in Britain, enhance their competitiveness and serve the Indian diaspora and businesses.

For digitally delivered financial services, the UK has provided market access with respect to the various sub-sectors under both insurance and insurance-related, and banking and other financial services.

With regard to the insurance sector, the agreement is expected to enable non-life insurance services and insurance intermediation (maritime shipping and goods in international transit), reinsurance and retrocession, and services auxiliary to insurance to expand their operation in India.

India has also secured an agreement on the Double Contribution Convention, which will exempt Indian professionals and their employers from social security payments in the UK for up to three years, improving the cost competitiveness of Indian

Commerce and Industry Minister Piyush Goyal said that it will provide duty-free access to several domestic sectors such as leather, electrical machinery and chemicals in the British market, thus unlocking nearly USD 23 billion in opportunities.

"Duty-free access for about 99 per cent of Indian exports unlocks nearly USD 23 billion in opportunities for labour-intensive sectors, marking a new era for inclusive and gender-equitable growth," Goyal said in a post

Commenting on the deal, India Inc said that the pact marks a transformative moment in the global economic landscape, laying down the blueprint for a modern, values-led partnership.

Today is a historic day in India-UK relations, said Prime Minister Narendra Modi, who witnessed the signing of the trade pact along with his British counterpart Keir Starmer.

After many years of hard work, a comprehensive economic and trade agreement has been inked between India and the UK, he noted, with Starmer by his side at Chequers, the country residence of the British PM.

The two leaders held a tete-a-tete before holding serious talks.

The deal is expected to benefit 99 per cent Indian exports from tariff.

In his remarks, Starmer said it is the biggest and economically most significant trade deal that the UK has signed since leaving the European Union.

In his media statement, Modi thanked the UK for its strong condemnation of the Pahalgam terror attack and said both sides are united that "there is no place for double standards in the fight against terrorism."

We agree that forces with extremist ideologies cannot be allowed to misuse democratic freedoms, he said.

Modi said security agencies of India and the UK will continue to enhance cooperation and coordination on matters such as the extradition of economic offenders. On the free trade pact, Modi said it

will create new opportunities in the British market for India's agricultural produce and processed food industry, and that it will be particularly beneficial for India's youth, farmers, fishermen, and MSME sector.

Indian textiles, footwear, gems and jewellery, seafood, and engineering goods will gain better market access in the UK, he added.

BCCI To Host Asia Cup In UAE, India-Pak Match Likely

NEW DELHI/DHAKA: The high-intensity cricketing rivalry between India and Pakistan will resume briefly in September as decks have been cleared for the BCCI to host the upcoming Asia Cup T20 tournament in the UAE, sources in the Asian Cricket Council (ACC) said on Thursday.

The decision was taken at an ACC meeting attended by all 25 member nations. BCCI was represented by its vice-president Rajeev Shukla, who attended the meeting

to discuss the venue, virtually.
"The BCCI will host the Asia Cup in the UAE. India is likely to play

all its matches in Dubai. There are still deliberations on scheduling," an ACC source told PTI on conditions of anonymity.

The tournament is being held in UAE as India and Pakistan have mutually agreed to play all their matches across all multi-nation events till 2027 at neutral venues.

This edition of Asia Cup is being held in T20 format since the next ICC World Cup will be in the shortest format in India and Sri Lanka in February 2026.

The tournament will be held for a little over fortnight in

It has to end before the final week of the month as India's Test series against West Indies is also scheduled around the same time. Out of the three international grounds, one at Dubai and other at Abu Dhabi is expected to be used for the tournament.

Keeping the interests of broadcasters as well as sponsors in mind, there is every chance that India and Pakistan will be clubbed in the same group and there will be minimum two games -- group league and Super Six if not the final if both teams happen to qualify.

"Our vice-president Rajeev Shukla attended the ACC meeting. He will brief the members. I don't believe in speculations so you will get to know officially in a few days time," BCCI secretary Devajit Saikia told PTI.

In Dhaka, ACC chairman and Pakistan Cricket Board (PCB) head Mohsin Naqvi also kept cards close to his chest when asked about a possible Indo-Pak match at the continental event.

"We will announce it shortly. We have had discussions with the BCCI and there are a few issues that we will resolve shortly. All 25 members attended the meet either physically or virtually. We are all on same page," Naqvi told

reporters. It is also learnt that due to BCCI's pressure, only two out of 10 items on the agenda, were discussed. The only item in the agenda that was passed relates to grant for the developing nations under ACC's

"We have all decided to work for cricket. None of us wants politics in our organisation and we had very good meeting, hope we will continue working like this,"

Naqvi added. When asked about his reaction about BCCI representative not attending the meeting in person, Naqvi didn't want to make much

"If the league doesn't take place, it is not only footballers but the people who are associated with football will be affected. It's thousands of people who will be affected. So, we will put our best effort to ensure that the league happens," said Chaubey who is also a joint secretary of the IOA.

Pro Wrestling Icon Hulk Hogan Dies At Age 71

Tulk Hogan, the mustachioed, headscarfwearing icon in the world of professional wrestling, has died at the age of 71, Florida police and WWE said Thursday.

In Clearwater, Florida, authorities responded to a call Thursday morning about a cardiac arrest. Hogan was pronounced dead at a hospital, police said in a statement on Facebook.

Hogan, whose real name was Terry Bollea, was perhaps the biggest star in WWE's long history. He was the main draw for the first WrestleMania in 1985 and was a fixture for years, facing everyone from Andre The Giant and Randy Savage to The Rock and even company chairman Vince McMahon.

He won at least six WWE championships and was inducted into the WWE Hall of Fame

WWE posted a note on X saying it was saddened to learn about Hogan's death.

"One of pop culture's most recognizable figures, Hogan helped WWE achieve global recognition in the 1980s. WWE extends its condolences to Hogan's family, friends, and fans," it said. (AP)
