## **Modi Becomes 2nd Longest Serving** PM In A Row

#### KO Web Desk

New Delhi: Narendra Modi on Friday overtook Indira Gandhi to become the second longest serving prime minister of India in consecutive terms.

Modi, officials noted, completed 4,078 days in office on Friday. Gandhi was in the office in an unbroken stint for 4,077 days, from January 24, 1966, to March 24, 1977.

The record for the unbroken stint is held by Jawaharlal Nehru, the first prime minister. Both Modi and Nehru led their respective parties to victory in three consecutive Lok Sabha elections.

Nehru, who remained at the helm from August 15, 1947, till his death on May 27, 1964, had an uninterrupted tenure of 6,130 days.

## No US Role In Ceasefire With Pakistan: GOI Says Decision Taken After Direct Contact Between DGMOs

New Delhi: The Government of India has dismissed claims of U.S. interference in the recent ceasefire between India and Pakistan, asserting that the decision to halt military operations was based on India's own strategic objectives, particularly targeting terrorist infrastructure in Pakistan and Pakistan-Occupied Jammu & Kashmir (PoJK).

In a written response to the query in the Lok Sabha, Minister of State (MoS) for External Affairs Kirti Vardhan Singh said that India and Pakistan agreed on May 10

# **Study Estimates Lightning Kills 320 Million Trees In World Yearly**

bout 320 million trees could be getting killed by lightning strikes every year, accounting for about two to three per cent of the world's

plant biomass loss, according to a study. The tree loss is further estimated to emit between 0.77 and 1.09 billion tonnes of carbon dioxide yearly, which researchers from the Technical University of Munich, Germany, said was comparable to 1.26 billion tonnes of carbon dioxide released every year from the burning of plants in wildfires.

The estimates of trees lost to lightning strikes, published in the journal Global Change Biology, do not include those lost in wildfires triggered by lightning, the team said.

As the planet continues to warm, lightning strikes are expected to become more common, and "so, it's worth paying closer attention to this largely overlooked disturbance," lead author Andreas Krause, researcher at the chair of land surface-atmosphere interactions, Technical University of Munich, said. "Currently, lightning-induced tree mortal-

ity is highest in tropical regions. However, models suggest that lightning frequency will increase primarily in middle- and high-latitude regions, meaning that lightning mortality could also become more relevant in temperate and boreal forests." Krause said.

The findings support those from previous studies, indicating that lightning is an important cause of tree death in many forests, the authors said.

Damage to forests due to lightning strikes is hard to detect and has only been systematically studied in select locations of the world, they said.

The team added that the number of the world's trees directly damaged by lightning

The ecological impact of lightning is underestimated, the researchers said.

"We're now able not only to estimate how many trees die from lightning strikes annually, but also to identify the regions most affected and assess the implications for global carbon storage and forest structure,' said Krause.

The authors "find that lightning kills around 320 million trees each year, thereby causing (nearly) 0.25 (gigatonnes of carbon) of dead biomass.



SRINAGAR: Srinagar Development Authority (SDA) has announced the launch of Phase-II of the Shehjar Heights project at Bemina envisaging construction of 112 more residential apartments, including 56 each 2-BHK and 3-BHK flats.

Shehjar Apartments is a flagship Vertical Housing project of SDA in Srinagar involving construction of around 450 residential apartments comprising around 13 towers. The Phase-I of the project completed with the construction of 140 apart-

ments, is fully sold-out. Given the overwhelming demand for quality residential apartments in Srinagar, SDA has expedited the execution of the project and has started the process for construction of 112 more flats under Phase-II after the Phase-I was fully sold out, said Mohammad Rafi, Vice-Chairman SDA adding that the possession of flats in Phase-II is likely to be handed over to the prospective allottees within 2 years.

He said vertical housing has become a necessity to ensure economical use of land in the fast-expanding Srinagar city. "Given the scarce land resources and sky-rocketing land prices in Srinagar, time has come for SDA to promote the concept of flatted accommodation in the city in a big way," Mr Rafi said.

consultants for the Shehjar Heights, who have formulated the overall layout plan and design of towers and individual residential units.

Mr Rafi said that Shehjar Heights are spread over around 100 kanals of land with 40 ft wide main road and 36 ft wide internal roads transecting various apartment blocks located adjacent to Srinagar-Baramulla highway in Bemina near Hajj House.


The Vice-Chairman said that the project has been provided with adequate parking facility including surface parking for around 550 vehicles and covered parking for around 220 vehicles. Besides it will have parks, community hall, children's play area, tennis court, amphitheater, health club, community market, gym, food court and a dedicated STP. He said the best thing about Shehjar Project is that it is suitably located on National Highway in easily accessible and buzzing Bemina area of Srinagar, with remarkable proximity to urban amenities like hospitals,

schools and markets with hasslefree to SrinagarInternational Airport and Nowgam Railway Station. He said adequate and latest tech-

nological interventions have been ensured to make the structures earthquake resistant and HUDCO has got the structural design of the project approved by IIT Kanpur. "For the first time Liquefaction Resistance technology is being used in the construction of Phase-II to make the towers earth-quake resistant," he said and added that HUDCO is also providing consultancy for drainage, water supply and sewerage design, energy management, communication system, fire detection, fire protection and security systems for the Shehjar Apartments.

The Vice-Chairman said that each 3-BHK flat is spread over a net surface area of 1250 sft with 3 bedrooms, Drawing Room, Living Room, Kitchen, 3 washrooms, utility and veranda while 2-BHK flat has a surface area of 1012 sft comprising 2 bedrooms, drawing room, living room, 2 washrooms, kitchen, utility and veranda.

Rafi said the tendering process of Phase-II has been initiated and SDA is going to soon announce the booking for Phase-II with flexible payment mode.

New Delhi: Asserting that Operation Sindoor "still continues", Chief of Defence Staff General Anil Chauhan on Friday said the country's military preparedness must remain at a "very high" level, round-the-clock and throughout the year.



In his address at a defence seminar hosted at Subroto Park here, he also said the military in future will also need "information warriors, technology warriors and scholar warriors." And, in a merging landscape of warfare, a future soldier will need to be a mix of all three "info, tech and scholar warriors,' the CDS said.

The seminar on 'Aero-

#### space Power: Preserving India's Sovereignty and Furthering National Interests' was held under the aegis of the 'No.4 Warfare and Aerospace Strategy Programme'.

The CDS said there are no runners-up in a war, and any military must be constantly alert and maintain a high degree of operational preparedness.

"An example is Operation Sindoor, which still continues. Our preparedness level has to be very high, 24x7, 365 days (a year)," Gen Chauhan said.

India launched Operation Sindoor early on May 7 and decimated multiple terror infrastructure in Pakistan and Pakistan-Occupied-Kashmir (PoK). Pakistan also launched

offensives against India, and all subsequent counteroffensives by India were also carried out under Operation Sindoor.

The military conflict between the two nuclear-armed neighbours halted after they reached an understanding on the evening of May 10.



New Delhi: Airlines received 69 hoax bomb threats this year till July 20, the government said on Thursday.

As per data from the Bureau of Civil Aviation Security (BCAS), a total of 881 hoax bomb threats have been received by airlines from 2022 to July 20, 2025.

In a written reply to the Lok Sabha, Minister of State for Civil Aviation Murlidhar Mohol said BCAS has mandated robust protocols for handling such threats in coordination with law enforcement agencies, central security agencies, CISF and stakeholders, leading to minimal impact on flight operations. A total of 69 hoax bomb threats have been received by airlines this year till July 20, and the count was at 728 in 2024.

There were 71 and 13 hoax bomb threats in 2023 and 2022, respectively, according to the data shared as part of the written reply.

The minister said, "94 hoax bomb threats were received by airline operators in Karnataka from 2021 till 20th July, 2025. No arrests have been made for making hoax bomb threats to airlines in Karnataka." He was responding to a query from a Lok Sabha member asking about the number of bomb threats reported at airports in Karnataka during the last five years and the number of individuals arrested in connection with the same, along with the legal actions taken against them.

**Rs 295 Crore Spent On** PM Modi's Foreign Visits From 2021 To 2024: Centre

New Delhi: Over Rs 67 crore was incurred on Prime Minister Narendra Modi's visit to five countries, including the US and France, in 2025, while the total expenditure figures related to his foreign trips from 2021 till 2024 stood at nearly Rs 295 crore, according to data shared by the government.

As per the country-wise and year-wise data, the corresponding figures for PM Modi's visits to Mauritius, Cyprus, Canada and Croatia, and Ghana, Trinidad & Tobago, Argentina, Brazil and Namibia this year were not available.

### Sunjay Kapur's Mother Is Not A Shareholder, **Says Company Amid Family Feud**

New Delhi: The feud brewing within the Kapur family-owned Sona Group - an empire worth Rs 30,000 crore - took a sharp turn Friday evening after the flagship company, Sona BLW Precision Forgings Ltd, said Rani Kapur, the former Chairman Sunjay Kapur's mother, is not a shareholder, and has not been since 2019.

Hours earlier Ms Kapur wrote to the board, identifying herself as a majority shareholder and demanding an Annual General Meeting scheduled for this afternoon be postponed.

She said she had been coerced into signing documents and questioned the decision to appoint "certain people (i.e., Priya Sachdev Kapur, her daughterin-law)" who claimed to speak for the family



The company responded with a market filing that said in May 2019 a "declaration of significant beneficial ownership' was received that identified Sunjay Kapur as the "sole beneficial owner...

As a result, the company

And on Ms Kapur's claim about being "forced to sign documents behind locked doors". the board stressed that no documents had been signed or obtained from her since Mr Kapur's death.

The family row broke after an email from Rani Kapur late Thursday that requested the deferment of the AGM. The board said it took legal advice on how to proceed "out of respect" for Ms Kapur.

"Based on the legal counsel and the fact Rani Kapur is not a shareholder of the Company, the Company concluded that it could not defer the AGM," the exchange filing said.

## **Negligence In Patient Care** Won't Be Tolerated: Itoo

SRINAGAR: Jammu and Kashmir Health Minister Sakina Itoo on Friday condemned the strike by doctors at SMHS hospital, stating that such actions by which poor patients are made to suffer and move from pillar to post for no fault is "unacceptable" and "not tolerable" at all. Speaking to media per-

sons at SMHS hospital, Sakina Itoo described the incident as deeply unfortunate, emphasising that such situations should never arise, particularly within hospitals.

She said if any wrongdoing occurs, there are established rules and laws for investigation and action, and these must be strictly followed. "The closure of hospital services and denial of care to patients as a form of protest is both unjustified and unacceptable." "Patients who had ap-

pointments had to suffer and could not receive treatment because of the closure. In my opinion, this should not happen. There will certainly be an investigation and action will be taken, because what fault do the patients have?" she questioned.

She also said all such matters be resolved strictly within legal and procedural frameworks, involving departmental or police intervention if necessary. The minister criticised the

closure of the operation theatre, emergency services, and patient care wards, terming this as intolerable and contrary to the principles of public health. She also acknowledged the pressure and challenges faced

She also referenced an incident involving media personnel, emphasising that all complaints, whether from doctors, patients, or journalists, should be sub-

#### Apple Plant Scheme Turns Scam **Anantnag Man Cheats Farmers Of Crores, Goes Missing**

SRINAGAR: In a significant crackdown on white-collar crime, the Economic Offences Wing (Crime Branch Kashmir) has registered a case against a man from South Kashmir's Anantnag district for allegedly cheating scores of farmers and agri-entrepreneurs in a multi-crore High-Density

Apple Plant scam. The accused, Shahid Rehman Bhat, son of Abdul Rehman Bhat and resident of Tulbagh Shangus in Anantnag, is the proprietor of M/s AR Trading Agri Services Pvt. Ltd. According to officials, Bhat convinced farmers to pay him hefty sums with promises of delivering High-Density Apple Plants – a popular and high-yield variety increasingly adopted by orchardists in the region.

However, after collecting crores of rupees, Bhat allegedly failed to deliver the plants or refund the money. When he went

off the radar, the victims mostly small farmers and agribusiness men — approached the Crime Branch with formal complaints.

Preliminary investigation, including scrutiny of bank transactions, revealed that Bhat had received substantial deposits from multiple individuals across Kashmir. Despite repeated attempts, the victims were unable to contact him – with officials confirming that the accused had gone into hiding.

The evidence, officials said, points to a "clear case of cheat-ing and criminal breach of trust." A case has been registered under Section 318(4) of the Bharatiya Nyaya Sanhita (BNS) 2023 at the Economic Offences Wing Police Station in Srinagar.

Authorities have launched a manhunt to trace Bhat and have urged other possible victims to come forward and assist in the ongoing investigation.

#### **Gaming Chats New Tool For Terror Communication: Officials**

**SRINAGAR:** Online war games akin to PUBG requiring chats with partners anonymous or otherwise have emerged as a key communication channel for terror groups and Pakistan's ISI to convey messages to their

recruits in Jammu and Kashmir, officials here said. As terror groups operating across the border seek to bypass social media and conventional channels of communication and escape scrutiny by security agencies, it is a virtual battleground and in some cases a real one too. Four cases have been identified, the officials said.

In one case, an underage boy was being radicalised by his gaming partner sitting across the border. The boy was handed over to parents after proper counselling of the entire family. The gaming chat applications

allow players to communicate with each other in real time in the guise of playing online games, the officials explained without going into details of which game and how.

These applications, which facilitate voice, video, and text-based communication to enhance teamwork, strategy discussions and social interaction among players, are being used for different purposes, they said. The prospective recruits are identified during playing. The gaming applications have been increasingly incorporating encryption to protect user communications but the level of security varies widely. So, some games use basic encryption for in-game voice chat and others offer more robust end-to-end encryption for text and voice. There are also applications that allow for selfdestructing messages. Though several of these gaming applications are banned in India, they are downloaded using Virtual Private Network (VPN) illegally. A VPN creates a secure and encrypted connection over the internet by

masking Internet Protocol addresses and encrypts online traffic, making it more difficult to track online activity and access data.

In the past, messaging platforms like WhatsApp were delinked by terror groups and their handlers from Pakistan and they switched to other applications to communicate with each other. The included one developed by a Turkish company is being used by terror group handlers and their prospective recruits in the Valley, the officials said.

The new applications have the ability to work with the slowest internet connections where Enhanced Data for Global Evolution (EDGE), used in the

late 2000s, or 2G is in operation. The Central government had suspended the internet across Jammu and Kashmir after the abrogation of the special status of the erstwhile state on August 5, 2019.

All encryption and decryption happen directly on the devices, therefore reducing third party intervention at any point. These new apps use encryption algorithm RSA-2048 which was adopted as the most secure encrypted platform, officials said.

RSA is an American Network Security and Authentication founded in 1982 by company

nside a carpet showroom in Tangmarg, a tourist lately paid 2.55 lakh for what was promised as a handmade Kashmiri rug. It came with a GI tag, a certification mark, and a story of tradition. None of it was real. The rug was machine-made. The QR code was forged. And the deception was deliberate.

This isn't an isolated scam. It's a pattern of betrayal across Kashmir's handicraft market, and it's finally being called out.

The Department of Handicrafts and Handloom, Kashmir, has issued a firm notice to all registered dealers. They have seven days to remove every machinemade item from their showrooms or face blacklisting, deregistration, and legal action. The warning also applies to faked QR labels, misbranding, and tampered tags. Showrooms found violating the Jammu & Kashmir Tourist Trade Act will be dealt with under the law.

It should never have come to this.

Dealers had signed affidavits promising to sell only genuine, handmade crafts. Still, inspections revealed showrooms across Kashmir showcasing machine-loomed products, falsely marketed as local artisanal work. These aren't small infractions. They are calculated moves to cheat buyers and choke the region's oldest economy.

Kashmir crafts are not souvenirs, they're livelihoods. Over 400 training centres across the valley are producing fine pashmina, crewel, Sozni, chain stitch, and hand-knotted carpets. The government recently recorded over 1.07 crore in revenue from trainee sales alone. That figure represents more than earnings. It reflects potential. And that potential is at risk every time a fake product is sold in the name of Kashmir.

This business of counterfeits is turning tourists into skeptics and artisans into casualties. One rug with a fake QR code may look harmless on the shelf, but behind it is the slow erosion of trust that took centuries to build. Kashmir's GI tags are meant to guard this trust. They can't protect anything if they're forged.

Chief Minister Omar Abdullah has stepped in. After meeting with exporters, he assured strict enforcement and policy review. The industry wants an enforcement task force, mandatory signage, tighter import rules, and harsher penalties. These steps aren't ambitious. They are overdue. No machine can replicate the soul of a hand-knotted carpet. No shortcut can replace generations of skill. Dealers who want to profit from Kashmir's craft must honour it. That means pulling machine-made goods off the shelves, displaying real labels, and respecting the identity they claim to sell.

## **Kashmir's Crisis of Trust**

At the intersection of medicine, media, and power, a hospital strike in Srinagar reveals deeper fractures in Kashmir's public institutions.

t SMHS Hospital in Srinagar, clinical care gave way to institutional collapse. What should have remained an internal strike spiraled into a public confrontation, exposing the fragile scaffolding of Kashmir's public institutions.

Doctors, attendants, and journalists weren't allies. They stood opposed, caught in conflict.

Outside the emergency ward, a father carried his electrocuted son, pleading for attention. A doctor, without meeting his eyes, motioned them to leave. Inside, a journalist was physically restrained by an angry doctor.

In that moment, the hospital became a theatre of disorder. The professional codes that normally hold such institutions together seemed to vanish.

All that remained was a struggle, for space, control, meaning, and narrative.

Patients alleged the hospital gates had been shut. Eyewitnesses and video footage supported their claims. Journalists reported what they saw. In response, the institution issued an unequivocal denial during a press conference.

Doctors rejected the coverage as "misrepresentation" and an "attempt to discredit" the profession, instead of starting a discussion about systemic failure.

The reaction echoed what Bourdieu warned of: when credibility becomes the monopoly of the powerful, any challenge is dismissed as defamation.

That evening, a public debate unfolded in real time on Twitter-turned-X. Physicians spoke of exhaustion, assaults by attendants, and hostile media scrutiny. Attendants described being dehumanised, treated not as people but as obstacles.

Journalists defended their role, arguing that reporting from the margins is not bias. It is duty, especially in a place where the voiceless rarely find amplification.

The trolling journalists faced after the incident wasn't about media ethics. It was about discomfort.

For years, Kashmir's public discourse has been dominated by "high priests of public opinion", those who decided what could be said, and by whom.

When reporters began spotlighting the pain of patients and attendants, rather than officials, that or der was disrupted.



unethical reporting. It targets ethical reporting that centers the margins.

Equally important is to examine the imperial hangover in how we view professional hierarchies.

The belief that some jobs, especially those requiring Westerncertified education, are more 'noble' than others stems from colonial thinking.

The British empire's bureaucratic logic ranked and moralised professions: clerks above cultivators, doctors above carpenters, English above local knowledge.

This legacy still shapes perceptions in postcolonial societies like ours

When doctors demand unconditional respect, they unwittingly echo this colonial language. But in a civilised, postcolonial society, no profession holds moral supremacy.

A mason builds your home. A plumber gives you water. A journalist gives you voice. A doctor saves lives. Dignity belongs to labour, not to the uniform it wears.

Looking down on attendants many of whom are uneducated, working-class, and poorly paid - because they lack the symbolic capital of education is not only elitist, it is structurally violent.

Education is often about access, not merit. In societies shaped by historical and political marginalisation, the absence of formal education should never be mistaken for the absence of dignity or truth.

This, of course, does not absolve

But what followed the SMHS strike revealed something more dangerous than temporary chaos. The protest may be justified. But the refusal to even consider medical negligence points to deeper institutional decay.

An institution that won't examine itself isn't defending truth. It's simply shielding itself from accountability.

The notion that doctors are morally superior has been dismantled in many societies.

In Sweden, Canada, and New Zealand, medical professionals are respected but not revered. They are held to high standards and treated as doing a job, not fulfilling a sacred duty.

This shift creates space for both gratitude and critique, for praise and accountability.

What unfolded at SMHS was not about a single patient, video, or complaint. It was about a system at its operational and moral limits.

It was about a public that feels increasingly abandoned. It was equally about a professional elite afraid of losing its uncontested authority.

And above all, it was about institutions that prefer denial to reform.

Everyone came out wounded. Not all bore visible bruises. But all carried the scars of a trust broken in real time

As James Baldwin wrote, "Not everything that is faced can be changed. But nothing can be changed until it is faced. It's time Kashmir faces this.

more dangerous justified. But the

The clock is ticking. Kashmir crafts are on the line. It's time to choose truth over tricks.

This shift wasn't incidental. In recent years, Kashmir's public discourse has begun to fracture along deeper, more complex lines.

Beyond a single question, people now speak about caste, class, gender, and the rural-urban divide. This isn't mere evolution. It's rupture.

And rupture, by nature, unsettles those used to narrative control.

It is within this unease that journalism in Kashmir is being vilified,

since it decouples truth from power. A journalist's duty is not to bolster institutional confidence, but to interrogate it. Yes, bad journalists

exist. But the backlash rarely targets

attendants of criticism. There are real-life instances of doctors being attacked. A doctor being assaulted at SMHS is indefensible. In another 2023 incident in Anantnag, a surgical team was threatened following a patient's death.

Public introspection, legal action, and censure are essential responses. Any form of violence, civilian or institutional, undermines trust itself.

t Government Medical College (GMC) Jammu, the emergency ward is always loud. Monitors beep, stretchers roll in, and voices rise with panic or prayer. But on July 16, that signature shrill shifted.

After a critically-ill patient died, his attendants turned their grief into fury. A female postgraduate doctor was kicked in the abdomen. Her colleague was also attacked. It was all caught on CCTV. Within hours, the footage was on every phone in the region.

The next morning, doctors went on strike. Emergency services slowed, surgeries were cancelled, and exhausted consultants were left to hold up a crumbling system.

Then, just a week later, a similar scene unfolded at SMHS Hospital in Srinagar. A doctor was slapped to the ground while doing his job. He was trying to help.

These incidents are not anomalies. They are signals. They tell us something is deeply wrong, with how society is failing the people inside them

Doctors are seen as privileged. That's the assumption. The truth is different.

In Kashmir's government hospitals, young doctors routinely work 18 to 20 hours without proper food, rest, or even security. They manage hundreds of patients a day in poorly equipped wards. They face questions they can't always answer.

And when a life slips away, they are often the first ones blamed. And sometimes, they are assaulted. These assaults don't happen in a vacuum.

When families bring loved ones to a hospital, they bring fear, desperation, and in many cases, years of built-up frustration with a system that feels distant and confusing.

They wait for hours with no update. They don't know what's happening inside the ICU. No one explains the odds. And when the worst happens, something inside them snaps. Violence takes the place of grief.

This doesn't justify the attacks. Nothing does. But

## Fear In The Emergency Room

As trust breaks down between caregivers and the public, hospitals are turning into places of fear instead of healing.

it does show how thin the thread is that ties together caregivers and the people they serve. Once broken, it's hard to mend.

When doctors strike, they're asking for something basic: the right to work without fear. That demand is valid.

Yet every protest comes with collateral damage. For every doctor refusing service, there is a patient waiting in the corridor, unaware the hospital has shut down.

A woman in labour, turned away. A man clutching his chest, told to try elsewhere. These poor patients suffer in silence.


public health system is already Kashmir's stretched to its limits. Most government hospitals are understaffed and overcrowded. Security is either poorly trained or absent.

Critical areas like emergency rooms turn chaotic the moment multiple attendants push their way in. No real protocol exists for breaking bad news.

Doctors are left to play multiple roles, like physician, counsellor, mediator, while the clock ticks on another patient down the hallway.

What's worse is the failure to deliver consequences.

Laws exist to protect medical professionals from assault, but in reality, very few attackers are arrested. Even fewer are prosecuted.



The message is clear: you can hit a doctor and walk away. This breeds more rage, fear, and silence.

Yet this is not only a crisis of law or logistics. It's a crisis of compassion. A profession built on trust is now struggling to survive in an atmosphere of suspicion and anger

And in that struggle, both the doctor and the patient lose.

The young woman doctor who was lately assaulted at GMC Jammu didn't stay home. She returned the next day to treat patients. Her bruises invisible beneath her white coat.

The patients who came in during the doctor strike didn't go back either. They waited, hoping someone would eventually look their way.

In those parallel acts of endurance lies the tragedy, and the possibility.

Kashmir has seen enough loss. We cannot afford to turn our hospitals into battlegrounds.

Doctors need protection. Patients need care. The state must step in, not only with laws, but with trained security, better communication systems, and fast legal response when things go wrong.

We need hospitals where a patient's attendant can cry without being feared, and where a doctor can treat without looking over their shoulder.

The choice is no longer between protest and silence. It is between reform and collapse.

And if we let this moment pass, the next headline won't just be about a doctor who was assaulted. It may be about a patient who died waiting.

It's time to rebuild that fragile trust, before more lives fall through the cracks

## The Wait at the Station

The Srinagar-Katra train was meant to unite Kashmir with the rest of India. But for thousands like Danish, it remains a promise unfulfilled.

When Danish Habib lately stepped off the plane in Jammu, his heart beat with something more than homecoming.

After two long years working in Saudi Arabia, he had returned to Kashmir and was determined to take the new train to Srinagar.

It was all anyone talked about while he was away. Videos, speeches, and the way the Vande Bharat Express curved through tunnels and mountains looked like Kashmir was finally on the move.

But at the railway station, Danish was met with something else: a screen flashing sold out.

For the next day, the day after, and every day after that, there were no general seats. The train he had waited so long for had already pulled away without him.

That moment at the counter stayed with him. "I never thought I'd come home and still be stuck," he told me, bags in hand, shoulders slumped.

Danish isn't alone.

The Udhampur–Srinagar–Baramulla Rail Link, or USBRL, was built on decades of planning and hope. It cut through some of India's toughest terrain and cost thousands of crores. It's an engineering marvel.

And for a place as long isolated as Kashmir, it was meant to be more than just steel and stone. It was supposed to be belonging and ease.

For a few hours on a summer day in June, it felt like all of that had arrived. The Prime Minister flagged off the train, speeches were made, flowers were thrown, and for once, it felt like the valley had been placed on the same tracks as the rest of India.

But when the cameras left, Kashmiris began queuing, and waiting.

Only two trains run each way daily on this new route. Just two, and they are booked weeks in advance.

Among stranded, and searching for a seat, is a mother with a referral slip in hand trying to reach a hospital in Katra. There's a student with an admit card for an exam in Jammu, and a labourer heading to earn a day's wage.

The new rail line exists, but access to it does not.

This isn't a complaint about construction. The completion of USBRL is historic. It has bridged regions, tunneled through mountains, and brought Kashmir into a new conversation around mobility and inclusion.

But a railway is only as meaningful as the people it moves. A train becomes transformative not when it runs, but when it carries the weight of daily lives. Right now, that weight is falling

through the gaps. Across Baramulla and Budgam, in Kupwara and Anantnag, you hear the same story: We tried to book a ticket, nothing was available.

The handful of reserved seats are snapped up early. The fares for premium classes are unaffordable for many. And those who need to travel most

- patients, students, workers - are left scrambling for alternatives that cost more, take longer, and offer less safety.

We don't need a once-a-day headline. We need everyday trains. Trains that start early and run late. That connect villages to towns, towns to cities, and cities to futures.

We need local services, affordable tickets, and enough frequency to make this railway more than ceremonial.

There's a tendency to celebrate the first ride. But the real success of a railway is in the fifth ride, the fiftieth, the five-thousandth.

It lies in the child who makes it to school on time, the family that reaches a hospital safely, the migrant worker who returns home without sleeping on a bus floor.

None of that is possible if the train keeps passing by without stopping for them.

Danish eventually took a cab, split with four strangers, over winding roads that made him carsick by dusk. He reached Baramulla the next morning - exhausted, disappointed, and still holding the memory of the train he couldn't board.

"There was a time I'd have given anything to come home by train," he said, unpacking in his house. "Now that it's here, it feels like we're still waiting." The journey, it seems, isn't over yet.

## Soundtrack Over Story

As Kashmiri artists help shape Bollywood's biggest emotional hit, the stories they live remain untold.

It begins with a song. A haunting tune, wrapped in longing, plays as two lovers part ways at a misty train station.

That song, Saiyaara's title track, has become the heartbeat of a film that has swept the Indian imagination. Millions have heard it. Millions more have wept with it.

Its composer, Faheem Abdullah, is from Srinagar. Soft-spoken and sincere, he said in an interview, "I wanted people to feel something deeply. I put my soul into it."

And the country felt it, across timelines, reels, playlists, car radios.

But what they felt wasn't Faheem's Kashmir. His home doesn't make it to the screen, except

in the snow-covered postcard shots that Bollywood uses like wallpaper. The life behind the lens remains untouched.

Faheem wasn't the only Kashmiri behind Saiyaara. The film's striking aesthetic — golden dusk shots, flowing fabrics, soft interiors — came from the eye of cinematographer Rayees Ganaie and the imagination of costume designer Mahira Qadri.

All three, in their own way, brought emotion to life. Their fingerprints are on every frame. And yet, the story they helped tell was someone else's. It was a story that sold.

Saiyaara is now one of the biggest romantic hits of the year. Its plot — familiar, formulaic, tear-stained — is less important than its feeling. It delivered the one thing Indian cinema can always count on: escape.

In contrast, 12th Fail, the film that dared to show struggle without spectacle, sits in the shadow. Despite glowing reviews and a performance by Vikrant Massey that broke hearts with its honesty, the film made modest business. It told the story of a boy who failed, again and again, until he didn't. There were no dream sequences, no love songs in Europe, no dramatic reunions at airports. There was just effort. And the country looked

away.

In a place like Kashmir, where life often feels like a script no studio would dare touch, 12th Fail should have felt familiar. Many here know what it means to restart, rebuild, retake. They've stood in long queues for entrance exams, studied under candlelight, and waited for interview calls that never came. In 12th Fail, they could have seen themselves.

Instead, they sang along to Saiyaara.

And who can blame them, when real life offers little comfort, even the illusion of it can feel like medicine.

Maybe that's why Saiyaara worked. It didn't ask questions. It gave answers: beautiful, aching, artificial ones.

But in doing so, it revealed something deeper about the Indian film audience. We crave feeling more than truth. Films grounded in reality – Masaan, Chhapaak, Aligarh – get applause but rarely audience. Films wrapped in heartbreak and harmony rake in crores.

As director Hansal Mehta once said, "Real stories make people think. Unfortunately, people go to theatres to stop thinking."

The problem is sharper in a place like Kashmir. Our stories are either softened into tragic romance or hardened into terror tropes. There's rarely room for the everyday: the daughter waiting for her father to come home from court, the poet who teaches part-time to fund his manuscript, the fruit vendor's son who studies coding between harvests.

These are stories waiting to be told. But they don't "sell."

Streaming platforms once gave hope. Filmmakers dreamed of bypassing Bollywood's formulas. But even there, the tide is turning. Series set in real-life complexities now compete with glossy dramas built to be bingeable. One producer from Delhi told me, "We love Kashmir, but only when it bleeds or falls in love."

And so, Kashmir's talent continues to colour other people's stories. Faheem's music moves hearts across India. Rayees's camera captures longing. Mahira's costumes help define characters who look nothing like the women of Pulwama or Sopore.

What if these artists turned the lens on their own lives?

Would a film about a Kupwara dropout making it to a UPSC exam go viral? Would a script about a Kashmiri girl running a coding bootcamp get a theatrical release? Would a love story that ends in reality, without tragedy, without triumph, be enough?

Faheem once said his music was meant to make people "feel something deeply." It did. But maybe the question is what we choose to feel, and why.

Emotion isn't the enemy. It's the most powerful tool cinema has. But when it's used to avoid truth rather than explore it, we lose something vital.

Cinema could've been a window in Kashmir, where truth is already muffled by narrative fatigue. It could have let the world in, to understand and care.

Instead, we get the same story: A boy meets girl, a heartbreak blooms, and a song plays.

And yes, sometimes that song is perfect.

But Kashmir deserves more than a soundtrack. Its people deserve the screen, as humans: Struggling, stumbling, surviving. Someday, the reels will stop spinning, the ap-

Someday, the reels will stop spinning, the applause will fade, and the story that remains won't be the one that made us cry. It will be the one that told the truth.

And maybe, just maybe, that truth will sound a lot like Saiyaara, if only we let Kashmir write the lyrics.

## **Streams Without Mills**

Once vital to village life and powered by nothing but gravity and glacier-fed streams, Kashmir's traditional water mills are collapsing under the weight of climate change, apathy, and modern flour.

In the village of Rafiabad, near the lower slopes of north Kashmir, mornings once began with the sound of water meeting wood. It was not a roar or rush, but a reliable creak, the sound that told you the day had started, and bread was on its way.

Sara, now in her thirties, remembers those mornings clearly. Her grandfather would rise before the sun, sling a jute bag of maize or rice over his shoulder, and head to the village Aabe-Gratte, a traditional water-powered flour mill built on the stream that ran through the valley. He returned with freshly ground flour, warm from the friction of stone on stone, ready to be kneaded into kulchas and roti.

Today, the stream still flows, but the wheel doesn't turn. The millstone is split. The wooden sluice gate has caved in. Moss coats the fallen beams, and thorny shrubs fill the hollow where the flour was once collected.

The Aab-e-Gratte, meaning "water flour mill" in Kashmiri, was once a fixture in almost every village of the valley. Designed without motors, fuel, and fuss, it relied entirely on the natural gradient of mountain water.

Water was channeled from a stream to strike a wooden wheel, which turned a vertical shaft, rotating two stones, the top one (runner) spinning over the lower (bed), to grind grain into flour.

For centuries, these mills offered more than sustenance. They were the heartbeat of community life. People waited their turn while discussing crop yields, family marriages, and



village disputes. Some came just to listen to the hum of water, the scrape of stone, and the occasional bird perched on the dripping beams.

Today, only a few dozen remain. Most are in varying stages of collapse.

Technological change came first. With the rise of electricity and diesel-powered mills in the 1990s, villagers could get flour in minutes, not hours. Packaged flour from Punjab and Gujarat began appearing in Kashmir's local markets—pre-ground, neatly sealed, and chemically treated to increase shelf life. Then came climate shifts. Shrinking glaciers, erratic snowfall, and reduced spring flows have transformed the valley's water patterns. Many streams that once surged through villages during harvest season now trickle out before summer ends. The timing has changed too. Some streams arrive late, some dry up early, and some have disappeared altogether.

"The water doesn't wait anymore," said Noor Mohammad, a 65-year-old miller from Kulgam. He is among the last to run a functioning Aab-e-Gratte in his region. His mill operates just three months a year now, compared to nearly seven during his youth. "In spring, there's too little snowmelt. In summer, there's not enough rain. And when the water finally comes, it's already too late."

There's another issue: neglect.

These mills were often community-owned or passed down within families, with no formal protection or maintenance systems. When a beam broke or the channel cracked, repairs had to be done by hand, using local knowledge and materials.

Today, many young Kashmiris have moved to cities or taken up jobs that leave no time, or interest, for fixing ancestral mills.

Ghulam Rasool Dar, a retired schoolteacher in Tangmarg, pointed to the skeleton of a mill near his orchard. "My grandfather built this in 1943. It ran until 2001. Then the sluice rotted and the roof caved in. No one came to fix it. My sons say there's no use keeping it alive."

Data is scarce, but a 2023 informal survey by agricultural students at SKUAST-Kashmir identified fewer than 50 operational water mills in the entire valley, down from an estimated 400 in the early 1980s. Many of the remaining ones survive only in remote, uphill areas where modern infrastructure is slower to reach.

Some see value in reviving them. Environmental groups argue that Aab-e-Grattas are among the few surviving examples of zerocarbon food processing in the region. Their design aligns with local ecology and could, with minor adaptations, complement sustainable tourism or community farming projects.

"There's a climate-smart wisdom in them," said Dr. Tariq Hussain, who studies indigenous technologies in rural South Asia. "They require no fuel, produce no emissions, and work with seasonal cycles. If supported with even basic repairs and community awareness, they could play a role in local food security."

However, efforts to preserve them remain minimal. No government scheme currently exists to restore or protect these mills as heritage sites. Occasional cultural festivals might feature one for display, but the structural support is absent. NGOs working in rural sustainability say they lack funding or technical capacity to intervene.

Meanwhile, memory carries the burden.

When Sara visits her childhood village now, the wheel is no longer a sound she hears. It's something she has to imagine. She walks to the old spot by the stream and runs her hand along the mossy stones. The hollow where flour once collected is filled with leaves. The door is broken. A cow grazes nearby, uninterested.

"I tell my daughter about it," she said. "That once, a stream could feed a family. That water was enough."

Whether her daughter will ever see it turn again is uncertain.

The water still comes, some years more than others. But the will to build, repair, and wait fades faster than the streams.

### **'Compulsive Nature Possible Reason Why One Indulges In Self-Destructive Acts'**

person's compulsive nature could be the reason why such individuals indulge in self-destructive behaviours, making harmful choices despite knowing the obvious negative outcomes, according to a new study.

The study, published in the journal Nature Communications Psychology, also found that making compulsive decisions did not appear to be random mistakes or people having "bad days".

"They're stable traits — almost like personality types. This is not to say they're fixed, just that they may require (an) intervention to break," said lead researcher Philip Jean-Richard Dit Bressel, a behavioural neuroscientist and experimental psychologist at The University of New South Wales.

Researchers said self-sabotaging choices do not arise out of a lack of motivation or capacity —rather from a subtle, yet persistent failure to connect their actions with consequences.

The team observed three distinct behaviours among Australian participants whose choices in an online game resulted in either a reward or punishment — 'Sensitives', 'Unawares' and 'Compulsives'.

The 'Sensitives' were those who worked out which choices led to unfavourable outcomes and adapted their behaviour. The 'Unawares' were those who did not work out, yet were able to modify their strategies once their errors were brought to their attention.

The third group — 'Compulsives' — "persisted in harmful



decisions despite both punishment and informational intervention", the authors explained in the study.

"We basically told them, 'this action leads to that negative consequence, and this other one is safe'. Most people who had been making poor choices changed their behaviour immediately. But some didn't," said Jean-Richard Dit Bressel.

Playing the online game required the participants to click on either of two planets — one would lead to a spaceship that delivered points (reward), while the other to a spaceship that stole from the points accrued thus far (punishment).

After a few rounds of trial and error, the researchers found that the sensitive participants were able to work out which planet led to punishment, but the 'Unawares' and 'Compulsives' failed to make the connection and therefore, were "punished intermittently".

In another group of participants — a more diverse, international pool of 267 people from 24 different countries with different backgrounds and a wider age range — the researchers found similar results.

Further, when this diverse group played the same game six months later, most were seen to display the same behaviours.

"That was one of the more striking findings. It suggests these aren't just random mistakes or bad days. They're stable traits — almost like personality types. This is not to say they're fixed, just that they may require intervention to break," Jean-Richard Dit Bressel said.

The patterns seen in the study — "where people ignore both experience and information" — are similar to those noted in gambling and other compulsive behaviours, the lead researcher said.

The team also said the research has important implications for public health messaging, as campaigns largely rely on providing information about smoking, drinking, diet, or financial risks — assuming that people will act on it.

"We've shown that standard information campaigns work for most people — but not for everyone. For compulsive individuals, we may need a different kind of intervention," Jean-Richard Dit Bressel said.

#### FCIK Seeks Urgent MSME **Ministry Intervention For Revival Of J&K's Industrial Sector Observer News Service**

SRINAGAR- In a significant policy appeal to revive Jammu and Kashmir's ailing Micro, Small and Medium Enterprises (MSME) sector, the Federation of Chambers of Industries Kashmir (FCIK) has urged the Union Ministry of MSME to intervene decisively for the revival of sick industrial units, equitable dis-tribution of policy incentives, and overdue modernization of the region's industrial base.

During an interactive meeting held in Srinagar, FCIK Head Shahid Kamili submitted a detailed memorandum to Union MSME Secretary Subash Chandra Lal Das, outlining urgent measures needed to address the deepening crisis in the region's industrial ecosystem.

Kamili emphasized that more than 90 percent of the 40,000 industrial units in J&K are either sick or operating below capacity due to over three de-cades of sociopolitical unrest, natural disasters, and repeated lockdowns-amounting to an estimated 3,000 days of lost operations. Despite repeated representations, no structured revival mechanism has been put in place to address these long-standing issues.

In its memorandum, FCIK called for the immediate creation of a 2,000 crore revival fund to rejuvenate sick units, support technological upgrades, and facilitate modern-

ization and diversification. The initiative, it stated, could unlock over 1 lakh crore of stalled investments and generate large-scale employment across the region.

FCIK also urged a revised procurement policy favoring local units. It proposed reviving SICOP's procure-ment role, starting with 358 reserved items for MSEs and 25 percent allocation of public contracts to local MSMEs, and establishing a transparent mechanism for ensuring fair pricing and equitable distribution. The federation also called for a local vendor filter on the Government e-Marketplace (GeM) for contracts up to 2 crore, citing adverse impacts of post-2019 procurement reforms on local manufacturers.

Addressing regional dispari-ties in the New Central Sector Scheme (NCSS), FCIK demanded equitable access to incentives across all 20 districts, regardless of pre-registration status. It also advocated the inclusion of existing units seeking revival, which have been left out under current provisions favoring new investments.

## **J&K Govt Gives Craft Dealers 7 Days To Remove Machine-Made Items**

SRINAGAR- In an unprecedented move, the Department of Handicrafts & Handloom, Kashmir Friday issued a notice giving Kashmir handicraft dealers a sevenday ultimatum to remove all machine-made products, largely imports from Turkey & Iran, from their Showrooms, failing which, the department warned, they will be blacklisted & deregistered for unfair trade practice under the relevant sections of law.

Addressing the dealers, the notice, issued vide No. H&HD/ DDQC/TTA/95/2025, dated 25.07.2025, reads that, "you have been granted registration under the provisions of the Jammu & Kashmir Tour-ist Trade Act, 1978, for the sale of Kashmir handicraft products at your respective showrooms/outlets." As part of the registration process, the Notice reads that craft dealers have submitted a duly-sworn affidavit, wherein they undertook to exclusively display and sell genuine Kashmir handicraft products at your business establishment.

The Notice further states that under 'Violation of Rules' section that during recent inspections conducted by this office, it was found that sev-eral dealers have breached the extant rules by displaying and selling machine-made products, misrepresented as genuine Kashmir handicrafts. Such malpractices undermine the authenticity and reputation of Kashmir handicrafts, the Notice reads.

An official spokesman of the Handicrafts and Handloom Department, Kashmir, in a press release, stated that in response to these violations, this office has imposed penalties on defaulting dealers in accordance with the provisions of the J&K Registration



of Tourist Trade Act. 1978. "Direads.

Quoting from the notice, the spokesman said that the machine-made products are banned from being sold or displayed in Kashmir handicraft showrooms registered under handicraft or handloom categories, & any violation & misbranding including by way of pasting fake QR codes and pulling out the machine-made labels shall attract relevant clauses/provisions of the Quality Control Act, J&K Registration of Tourist Trade Act, GI Act as well as the Bhartiya Nyaya Sanhita.





## Two Days Of Market Fall Erodes Rs 8.67 Lakh Crore From Investors Wealth

NEW DELHI- Investors' wealth eroded by Rs 8.67 lakh crore in two days of sharp fall in the equity market, where the benchmark Sensex tanked 1.52 per cent.

Persistent foreign fund outflows and heavy selling in financial, IT stocks have dragged the markets lower.

In the past two trading days, the 30-share BSE Sensex has dropped 1,263.55 points or 1.52 per cent.

Following the sharp fall in equities, the market capitalisation of BSE-listed firms fell bv Rs 8,67,406.75 crore to Rs 4,51,67,858.16 crore (USD 5.22 trillion) in two days.

On Friday, the Sensex tanked 721.08 points or 0.88 per cent to settle at over a month's low of 81,463.09. The 50-share NSE Nifty dropped 225.10 points or 0.90 per cent to a month's low of 24,837.

"Nifty ended lower for the second consecutive day, declin-

ing 225 points to close below the 25K mark at 24,837 (-0.9 per cent). Financial stocks, particularly Bajaj Finance, led the sell-off due to concerns over asset quality. Global uncertainties, lack of progress in the India-US trade negotiations, and continuous selling by foreign investors further contributed to the market's negative performance," Siddhartha Khemka, Head of Research-Wealth Management at Motilal Oswal Financial Services Ltd, said.

Among Sensex firms, Bajaj Finance declined 4.73 per cent post its June quarter earnings announcement. Power Grid, Infosys, Tech Mahindra, Bajaj Finserv, Trent, Tata Motors, NTPC and Tata Steel were also among the laggards. However, Sun Pharma and Bharti Airtel emerged as the gainers.

Foreign Institutional Investors (FIIs) offloaded equities worth Rs 2,133.69 crore on Thursday, according to exchange data.

"Subdued corporate results and lacklustre global cues triggered a broad-based sell-off across domestic equities. Elevated valuations in large-cap stocks, coupled with significant net short positions held by FIIs, added to the downward pressure.

"Investor sentiment remained fragile amid ongoing uncertainty over US-India tariff negotiations and the ECB (European Central Bank) maintaining the status quo, with rate cuts deferred until clearer insights emerge on the inflationary impact of trade developments," Vinod Nair, Head of Research at Geojit Investments Limited, said.

The BSE smallcap gauge tanked 1.88 per cent and midcap index dropped 1.46 per cent.

## **Op Sindhu Of 3,597 Indians Evacuated From Iran, Over 1,500 Hailed From J&K: GOI**

New Delhi: Of 3,597 Indian nationals who were evacuated from Iran under Operation Sindhu, 1,521 citizens hailed from Jammu and Kashmir and 1,198 from Uttar Pradesh, according to data shared by the government on Thursday.

The data was shared in a written response by Minister of State for External Affairs Kirti Vardhan Singh to a query in the Rajya Sabha.

In a response to a separate query, he said, "Thirteen Indian nationals remain in the Russian armed forces, out of which 12 individuals have been reported missing by the Russian side."

Russian authorities "The concerned have been urged to provide an update on all the remaining/missing individuals, and also ensure their safety, well-being and early discharge," the MoS said.

Citing available information,

he said there were 127 Indian nationals in the Russian armed forces, out of which the services of 98 individuals were discontinued as a result of sustained engagement between the Indian Russian governments on

this matter, including at the highest levels. Singh was asked the number of Indians, including students, travellers and workers who are residing in Iran and Israel, as also if any Indian was killed during the recent Iran-Israel

conflict. "As per available information, no Indian casualties have been reported in Iran or Israel during the recent conflict," he said.

At present, approximately 40,100 Indians are residing in Israel, including students, caregivers, construction and agricultural workers, business persons/ experts, etc., Singh said.

In Iran, prior to the recent conflict, approximately 10,000 Indians were residing, including

students, workers, seafarers and fishermen, pilgrims and travellers.

The government of India had evacuated 4,415 Indian nationals from Iran and Israel under Operation Sindhu conducted recently. Under the operation, 3,597 Indian nationals were evacuated

from Iran, and 818 from Israel. In his response, the minister also shared state-wise figures of evacuated citizens, from both the countries amid the conflict. Of the 3,597 Indian nation-

als who were evacuated from Iran under Operation Sindhu, the state-wise data showed that 1,521 citizens were from Jammu and Kashmir; 1,198 from Uttar Pradesh; 223 from Ladakh; 89 from Maharashtra; 135 from Karnataka; and 50 from Bihar, among other states.

Of the 818 Indian nationals who were evacuated from Israel under the operation, the state-wise data showed that 151 citizens hailed from West Bengal

and 93 from Maharashtra, among other states.

In a separate query, Singh was asked about the measures the government is taking to address the "exploitation of millions of Indian workers in the Gulf", especially in construction and domestic work, where they face degrading conditions.

'As per the data available, a total of 7,001 and 3,723 death cases of Indian nationals (including Indian workers) from various causes in the Gulf countries were reported in 2024 and 2025 (till June), respectively," he said.

"The Missions/Posts utilise the Indian Community Welfare Fund (ICWF) from time to time to provide financial and legal assistance to Indian nationals in distress abroad including workers in Gulf countries on a means-tested basis. Under ICWF, the major assistance/facilitation includes boarding and lodging, air passage to India, and legal assistance," he added.

### Using Unfair Means During Govt Job Exam **UPSC Bars Woman Aspirant For 3 Yrs**

New Delhi: A woman candidate has been barred for three years for using unfair means during a government job recruitment examination conducted by the Union Public Service Commission (UPSC), officials said on Friday.

It has also cancelled her candidature for the current year's examination, they said, without citing further details.

The UPSC had last year initiated a series of actions against former probationary IAS of-ficer Puja Khedkar, including lodging of a criminal case, for availing attempts in the civil services exam by faking her identity. Khedkar has been accused of

cheating and wrongly availing Other Backward Class (OBC and disability quota benefits to ensure her selection in the Indian Administrative Service

(IAS). Giving details of the latest case, the UPSC said that recently, a candidate was found in possession of incriminating material in one of the recruitment examinations.

"As the candidate has violated the rules of the Examination and is found to be guilty under the rule of the examination -12(1)(h) 'being in possession of or using unfair means during

the examination'. "Accordingly, UPSC has taken stringent disciplinary action in line with standardisation of penalties by cancelling the candidature for the current year's examination and debarred the individual from appearing in all future examination(s)/selection(s) to be conducted by the Commission for a period of 3 years," the Commission said in

a post on LinkedIn. Speaking about the action, UPSC Chairman Ajay Kumar said, the Commission is firmly committed to upholding the highest standards of integrity, transparency, and fairness in its examination processes.

"Any candidate found guilty of indulging in unfair means or misconduct during examinations faces strict disciplinary action as per rules, including debarment from future examinations, as the strictest action," he said.

Such measures are essential to preserve the sanctity of the selection process and to ensure that merit remains the sole criterion for recruitment to the government services, Kumar said

"This is the sole reason why UPSC for the last 100 years, has been an epitome of merit and fair system, and candidates from any background can get selected, purely on merit basis, as per the selection process,' he added.

Investigation Agency (NIA) over the imposition of exorbitant travel expenses on the elected MP for attending the complete ongoing session of Parliament.

Engineer Rashid has challenged a trial court order asking him to bear travel expenses of Rs 1.44 lakh per day for attending Parliament in custody from July 24 to August 4.

A bench of Justices Vivek Chaudhary and Shalinder Kaur issued notice to the NIA on the plea and listed the matter for further hearing on July 29.

The court is also scheduled to hear on July 29 Rashid's regular bail plea in the case.

Reacting to the development, AIP Chief Spokesperson Inam Un Nabi said, "We welcome the Hon'ble Delhi High Court's decision to issue notice to the SSP NIA on this grave concern. Engineer Rashid is not just an accused-he is an elected Member of Parliament. Imposing such unaffordable expenses on him is discriminatory and deeply undemocratic."

He added, "Arguments in the matter will now be heard on July 29, which is also the date fixed for hearing Er Rashid Sb's regular bail application. The AIP remains committed to exhausting every democratic and legal avenue to ensure justice, dignity and full representation for the people of Baramulla."

Inamun Nabi further noted, "The question is simple–can a duly elected MP be financially handicapped from entering Parliament? The voice of the people of Baramulla must not be silenced. We hope the Hon'ble Court intervenes with fairness and constitutional clarity. The Baramulla MP has been lodged in Tihar jail since 2019 after he was arrested by the NIA under the Unlawful Activities (Prevention) Act in the case. During the brief hearing, Rashid's counsel submitted that the MP has already been saddled with Rs 17 lakh cost to represent the public at large in Parliament. He said Rashid was previously allowed to attend Parliament and that he was losing every day as he was unable to attend the session due to the huge costs. Rashid sought interim bail or custody parole with travel expenses to carry out his duty as a parliamentarian. Custody parole entails a prisoner being escorted by armed police personnel to the place of visit. On July 22, the trial court granted custody parole to Rashid to attend the Monsoon session from July 24 to August 4, subject to payment of travel expenses. Rashid, who defeated Omar Abdullah in the 2024 Lok Sabha polls, is facing allegations that he funded separatists and terror groups in Jammu and Kashmir.

Taking credit for the ceasefire again, Trump claimed he asked both warring nations to stop "throwing around nuclear weapons".

"But India and Pakistan were going at it, and they were back and forth, and it was getting bigger and bigger, and we got it solved through trade. We said, you guys want to make a trade deal. We're not making a trade deal if you're going to be throwing around weapons, and maybe nuclear weapons, both very powerful nuclear states," he claimed.

## England Take 186-Run Lead, End Day 3 At 544/7

MANCHESTER: Joe Root produced a batting masterclass on way to a milestone 38th hundred as England exploited a jaded Indian bowling attack to stamp their dominance on the fourth Test here on Friday.

At stumps on day four, England were 544 for seven, stretching their first innings lead to 186 runs.

Root made a sublime 150 off 248 balls while the other contributions came from Ben Stokes (77 batting off 134) and Ollie Pope (71 off 128), a day after the openers put a pedestrian looking Indian attack to sword.

It has been a long tour with another Test to go in a week's time but considering the body language of Indian pacers in the field on Friday, lasting the whole series would be a challenge.

The visitors have already been hit by a series of injuries with the latest one being X-factor cricketer Rishabh Pant's toe fracture. Both Jasprit Bumrah and Mo-



hammed Siraj seemed to be bowling with a niggle while debutant Anshul Kamboj hit underwhelming speeds in the range 125-130 kmph. Even Bumrah, who usually bowls in the range of 140 kmph, clocked speeds in the lower 130s.

Having bowled just one over in the afternoon session, Bumrah was seen holding his ankle and even had to leave the field briefly.

In his 24th over, he managed to procure the wicket of Jamie Smith (9)

Siraj too seemed to be in discomfort like Bumrah, but he bowled with more intensity in the final session and was rewarded the wicket of Chris Woakes.

The lone positive for India was the performance of Washington Sundar who struck twice in the afternoon session after being questionably brought in as late as the 69th over.

Shardul Thakur was used for 11 overs, raising questions on the presence of three all-rounders in

the team. It would take a special effort from the Indians to bounce back

and keep the series alive. In the afternoon session Root reached his 12th hundred against India as England extended their dominance over India, reaching 433 for four at tea.

Washington got the ball to drift and got rid of Pope (71 off 128) and Harry Brook (3 off 12) after lunch, providing a much needed relief for India following a wicketless morning session.

India employed spinners Sundar and Ravindra Jadeja from both ends despite taking the new ball. The move worked as Sundar had Pope caught at first slip before having Brook stumped as he could not connect on the charge.

Root chose to play on the backfoot when the spinners were in operation and used the reverse sweep effectively.

In the morning, the Indian bowlers did not pose enough threat for Root and Pope who steered England to 332 for two at lunch

#### **Root Surpasses Ponting,** Next In Sight Is Tendulkar

he prolific Joe Root on Friday surpassed Australian legend Ricky Ponting's tally to become the second highest run-getter in the history of Test cricket and next in sight of the England batter is Indian icon Sachin Tendulkar who continues to head the list. On the third day of the fourth Test against In-

dia here, Root first leapfrogged legendary Indian Rahul Dravid and South African great Jacques Kallis' aggregate of runs in a space of eight balls and then went past Ponting by steering the ball behind point for a single as the Old Trafford

crowd gave him a standing ovation. Ponting had scored 13378 runs in 168 matches at an average of 51.85, while Tendulkar continues to top the list with 15921 runs.

It was apt that Ponting was in the commentary box when Root went past him. Root is playing in his 157th Test.

Overall, the ton at Old Trafford was his 38th in red ball format as he joined former Sri Lanka star Kumar Sangakkara at fourth place in the list of centurions in the game's longest format. Tendulkar (51), Jacques Kallis (45) and Ponting (41) are ahead of him in the hundred's list. (PTI)

#### **RCB Pacer Yash Dayal Accused Of Rape, FIR** Registered

PL side Royal Challengers Bengaluru's under-fire pacer Yash Dayal has been accused of raping a minor in an FIR registered against him by Jaipur Police.

The 27-year-old cricketer from Uttar Pradesh is already facing charges of sexual exploitation from a woman in Ghaziabad who has alleged that Dayal abused her after promising to marry her during a five-year relationship.

SHO of Jaipur's Sanganer Sadar police station Anil Jaiman said that the latest FIR was registered on Wednesday.

According to Jaiman, the victim has alleged that the player raped her first in 2023 when she was 17 and a similar assault took place in April this year at a hotel in Sitapura area.

'She alleged that the cricketer had promised help and support in her career. He contacted her in April this year when he was in Jaipur for IPL and called her to the hotel where he al-legedly raped her again," the SHO said, adding that the matter was under investigation.

The player has not issued any statement on either of the two cases so far. (PTI)

### Xavi's Application Surprises AIFF, But An Indian Set To Become Coach

NEW DELHI: Spain's World Cup-winning mid-field superstar Xavi Hernandez was among those who applied for the position of India's head coach, leaving the All Indian Football Federation (AIFF) pleasantly surprised but also unable to process his application for reasons which had nothing to do with the game.

Xavi, it is learnt, "sent an email from his own account" to apply for the post.

However, the AIFF could not go ahead with the processing of his application as the costs involved in recruiting one of the world's finest mid-fielders was way beyond the federation's means.

"Yes, he (Xavi) applied for the job of the Indian senior men's team football head

coach. He has himself mailed his application to the people in the technical com-mittee, and it looks like he was very much interested in the job," a source in the AIFF told PTI on Friday.

"However, those tasked with the responsibility of recommending the short-list of coaches to the executive committee for final approval federation know that it's difficult.

"You understand that Xavi is one of the greatest mid-fielders of all time, people talk about Messi all the time but he along with (Andres) Iniesta are right up there as far as Barcelona is concerned. So, yes, it is what it is." he added.

The experienced Anglo-Cypriot Stephen Constantine, Stefan Tarkovic of Slovakia and home-bred Khalid Jamil were among three candidates shortlisted on Wednesday by the technical committee of the AIFF. Out of the three, Jamil appears to be the frontrunner to replace Manolo Marquez, who quit earlier this month after a string of poor performances by the national team. The side's FIFA ranking has plummeted to 133, which is its lowest in nine years.

The AIFF had invited applications for the top job on July 4 with July 13 as the deadline. It received 170 applications, which included big names like former Liverpool stars Robbie Fowler and Harry Kewell.

Before Xavi, Fowler and Kewell had thrown their hats into the ring for the position.

Besides the World Cup triumph with Spain in 2010 and Euro title victories in 2008 and 2012, the 45-year-old Xavi has won five La Liga titles, three Copa del

Rey trophies, and three UEFA Champions League trophies with FC Barcelona, including two continental trebles in 2008-09 and 2014-15.

A product of the famed La Masia like his longtime illustrious FCB teammate Messi, Xavi's last coaching job was at FC Barcelona, where he was in charge from 2021 to 2024.

Before that, the maestro was managing Qatari club Al Sadd from 2019-21.

After his glorious 24-year stint at Barcelona, Xavi had also played for Al Sadd before being appointed the team's manager.

He left Barcelona as a player in 2015 for Al Asadd, where he also won four trophies before retiring in 2019.

As Barcelona manager, he led them to the 2023 Supercopa de Espana and the 2022-23 La Liga tile.

The selectors have also retained top batsman Babar Azam for the three ODIs.

The T20s are scheduled from July 31 to August 3 in Florida followed by the ODIs in Trinidad.

The three young pacers -- Abbas Afridi, Ahmed Daniyal and Salman Mirza -- who played in the T20 series in Bangladesh which ended on Thursday, have not been picked for the West Indies tour.

## **US wrestling icon** Hulk Hogan dies at 71

ulk Hogan, the American sport and entertainment star who made professional wrestling a global phe-nomenon, has died at the age of 71, World Wrestling Entertainment said.

"WWE is saddened to learn WWE Hall of Famer Hulk Ho-gan has passed away," World Wrestling Entertainment wrote in a social media post on Thursday. "One of pop culture's most recognizable figures, Hogan helped WWE achieve global recognition in the 1980s. WWE extends its condolences to Hogan's family, friends, and fans."

Hogan, whose legal name was Terry Bollea, became a uni-versal symbol of WWE during the 1980s, with a beach-blonde handlebar moustache, bandanas, and towering physique that he paired with an over-the-top persona that endeared him to fans and captured the spectacle of wrestling entertainment. He referred to his bulging arms as "24-inch pythons" and often

waved a US flag in the ring. Hogan was twice inducted into the WWE Hall of Fame and

was never shy about his icon status, calling himself as the "Babe Ruth" of wrestling in a reference to the US baseball phenom who became synonymous with the sport.

Hogan's flair and bravado helped elevate US wrestling entertainment into a global phenomenon during the 1980s. He later became more involved in US politics, offering a fullthroated endorsement of Donald Trump in the 2024 election. "Let Trumpamania run wild, brother!" he said during a speech

at the 2024 Republican National Convention as he ripped off his shirt. "Let Trumpamania rule again!

"We lost a great friend today, the "Hulkster," Trump said in a social media post on Thursday. "Hulk Hogan was MAGA all the way – Strong, tough, smart, but with the biggest heart. He gave an absolutely electric speech at the Republican National Convention, that was one of the highlights of the entire week."

Hogan also attracted controversy when a recording emerged of him using an anti-Black racial slur, for which he was suspended by WWE in 2015. He was later reinstated in 2018.

# Major media say Gaza staff face starvation as US envoy prepares to host ceasefire talks


our leading news organizations said Thursday their journalists in Gaza are facing the threat of starvation as the Israeli assault on Gaza grinds on, while top US envoy Steve Witkoff was to meet with key negotiators from the Middle East for talks on the latest ceasefire proposal and the release of hostages. "We are desperately con-

cerned for our journalists in Gaza, who are increasingly unable to feed themselves and their families," said a joint statement by The Associated Press, Agence France-Presse, Reuters and the BBC. "For many months, these independent journalists have been the world's eyes and ears on the ground in Gaza. They are now facing the same dire circumstances as those they are covering."

The statement called on Israel to allow journalists in and out of Gaza and allow adequate food supplies into the territory. The statement came a day after more than 100 charity and

human rights groups said that Israel's blockade and ongoing military offensive are pushing Palestinians in the Gaza Strip toward starvation.

Also Thursday, Hamas confirmed it had sent its latest ceasefire proposal to Israel, with an Israeli official calling it "workable," although no details were provided. The official spoke on condition of



Israel's war in Gaza, launched in response to Hamas' Oct. 7, 2023, attack, has killed more than 59,000 Palestinians, according to Gaza's Health Ministry. Its count doesn't distinguish between militants and civilians, but the ministry says that more than half of the dead are women and children.

## Lionel Messi, Jordi Alba avoid sanctions over **MLS All-Star snub**

nter Miami's Lionel Messi and Jordi Alba have not been sanc-L tioned for skipping Wednesday's MLS All-Star Game in Austin, Texas, their coach confirms. Both players were voted into the showcase by fans and the media, but neither featured in the MLS squad's 3-1 win against Mexico's Liga MX All-Stars.

League rules stipulate that players who choose to opt out of the All-Star Game without an approved medical reason can face a one-match suspension. Inter Miami coach Javier

Mascherano pointed out on Friday that his team had "played the most games so far this semester by far" and Messi "showed normal fatigue from the number of games and minutes he's been playing", according to ESPN.

"Look, players always have discomfort, especially when they play every three days. But luckily, [Messi] is returning today," Mascherano said on Friday. "Let's hope he can train alongside the group so we can count on both of them for tomorrow's game. We



haven't received any [sanction]." Inter Miami host FC Cincinnati on Saturday night at Chase Sta-

dium in Fort Lauderdale, Florida. Mascherano said Messi, 38, and Alba, 36, will be available for the match depending on their fitness levels.

Messi shares the MLS top scorer honours with 18 goals and has 10 assists in 17 league matches this season. The Argentinian forward also made six starts in the CONCACAF Champions Cup and four in the FIFA Club World Cup.

Alba has one goal and eight assists in 18 MLS matches. The Spanish defender made seven starts in the Champions Cup and one in the Club World Cup.
