Aprons, Nameplates Must: J&K Govt To Medics

Srinagar- The Jammu and Kashmir government has directed all doctors and paramedical staff in government healthcare institutions to strictly adhere to the norms regarding the wearing of white aprons and nameplates during duty hours.

The directive comes after it was observed that a significant number of medical professionals-including engaged under the National Health Mission (NHM) and Ayush-do not wear aprons or display their

identity properly, leading to confusion among patients and attendants.

that the special module prepared by the National Council of Educational Research and Training (NCERT) will have 8 to 10 pages focussing on India's strategic military response to

President, PM Lead Homage on Kargil Divas

New Delhi: President Droupadi Murmu and Prime Minister Narendra Modi on Saturday led the nation in paying tributes to military personnel who fought valiantly in harsh conditions to hand Pakistan a crushing defeat in the 1999 Kargil conflict.

On July 26 that year, the Indian Army announced the successful culmination of "Operation Vijay", declaring victory after a nearly three-month-long battle on the icy heights of Kargil in Ladakh.

India observes the day as 'Kargil Vijay Diwas' every year. Over 500 soldiers made supreme sacrifice in the conflict.

In her message, President Murmu, who is also the Supreme Commander of the military, said: "This day symbolises the extraordinary valor, courage, and steadfast determination of our jawans."

Modi said Kargil Vijay Diwas reminds the country of unparalleled courage and valour of its soldiers who sacrificed their lives in defending the country's pride.

J&K To Get Law University, ₹50 Cr Allocated: CM

Srinagar: Jammu and Kashmir is set to get its first dedicated Law University, Chief Minister Omar Abdullah announced on Saturday, with an initial allocation of 50 crore sanctioned for the project.

Highlighting Government's vision, the Chief Minister said that the institution will focus on specialized legal education and research in fields such as tribal law, military justice, constitutional studies, and environmental law.

Omar was addressing a two-day north zone regional conference on reaffirming the constitutional vision of justice for defence personnel and tribals at SKICC.

Reaffirming his government's support to the legal



services in delivering justice to the "most marginalised", he said that "we must remain committed to provide every institutional, financial, and technological support" necessary to transform constitutional promises into everyday realities.

"The true test of our legal system lies in its treatment of all the weaker sections of

the society, including those who have defended us without question and those whose rights have too often gone un-recognised," Omar said.

This test must be met with humility, guarantee and resolve, he added.

The CM said the thematic focus of the conference on the rights and entitlements of defence personnel and tribal communities, touches upon two segments of the society -- the defence personnel who defend the Constitution with unflinching resolve, and the tribals who have long waited for its full embrace.

"It is our collective responsibility to ensure that the institutions of justice rise to meet their needs with speed, sensitivity, and strength," he said.

HC Updates Rules To Protect Soldiers

Srinagar:The High Court of J&K and Ladakh has amended Jammu and Kashmir General Rules (Civil) for the guidance of District and Subordinate Courts of twin UTs of Jammu & Kashmir and Ladakh to safe-

guard the legal rights of the military personnel. "In exercise of

Regarding the amenability to the civil courts of persons subject to military law, according the amendment, all

persons belonging to the Armed Forces are amenable to the jurisdiction of ordinary Civil Courts subject and are liable to certain procedural requirements as regards their personal appearance in Court and execution of decree against their persons, pay and allowances and military equipment. | More on P6

HC Overturns JKB Dismissal, **Grants Pension**

Srinagar: The High Court of Jammu and Kashmir and Ladakh has quashed the retrospective dismissal of retired J&K Bank officer Naseer Ahmad Sheikh, terming the disciplinary proceedings "arbitrary" and "procedurally flawed."

Justice Javed Iqbal Wani observed that Sheikh, who retired in June 2021 after 34 years of service, was dismissed nearly a year later, in April 2022, without being given a fair opportunity to de-fend himself. The court found that key witnesses were not examined, crucial evidence was ignored, and Sheikh was denied a chance to cross-examine those involved.

'Shorter Hajj, Same Price'

Special 20-Day Package Announced, Only 66 From J&K Apply

Srinagar: In a first, the Haj Committee of India (HCOI) has introduced a 20 day 'Short Hajj Package' for 2026. According to reports, the package covers minimum stay in Makkah and Madinah, and the core Hajj rituals in 20 days.

The package is aimed at individuals who cannot spare time for the usual 35-40-day stay due to work or personal commitments.

Officials from the J&K Hajj Committee said that while the package offers a shorter stay, primarily by reducing the number of days in Madina, it does not



significantly lower the overall cost of the pilgrimage.

"The package is meant for those who cannot stay for the full duration. However, the

Dengue Returns to J&K

23 Cases Reported, Authorities **Step Up Vigilance**

Srinagar: Jammu Kashmir has started witnessing the return of dengue, with 23 confirmed cases reported so far this year, prompting health officials to intensify their preventive efforts across the Union Territory.

According to officials, the majority of cases-20 in total-have been reported from Jammu division. Three additional cases have

been traced to individuals from other states, while the Kashmir division has not recorded any infections yet.

State Malariologist Dr. D. J. Raina said that while the current figures remain relatively low, public vigilance remains key. "Panic is unnecessary, but proactive pre-

ventive steps are crucial in the absence of a vaccine, Dr. Raina said, emphasising that timely action can keep the

mosquito-borne disease under control.

Despite a significant rise in testing this year, the infection rate has remained manageable so far. However, authorities have launched a wide-reaching anti-dengue campaign, involving fogging, spraying, and deploying bio-larvicide fish. The outreach strategy also includes mass awareness campaigns through newspapers, TV, radio, and social media, as well as public miking and com-

New Delhi: The Ministry of Education has issued a directive to all states and Union territories mandating them to conduct audits of safety mechanisms and facilities for children in schools, officials said

on Saturday. The Education Ministry has also called for schools to ensure the structural integrity of buildings. This comes a day after a portion of a govern-ment school in Rajasthan's Jhalawar district collapsed on Friday (July 25, 2025), killing seven children and leaving 28 injured.

"States and UTs must take urgent steps to ensure student's safety and their well-being. This includes mandatory safety audits of schools and child-related facilities as per national safety codes, training for staff and students in emergency preparedness, and the provision of psychosocial support through counselling and peer networks.

"Structural integrity, along with fire safety, emergency exits, and electrical wiring, must be thoroughly assessed. It must be ensured that staff and students are trained in emergency preparedness, including evacuation drills, | More on P6

GMC Principal Assures Action After Journalists Assaulted

Srinagar: In response to the recent incident involving the manhandling of journalists on the premises of SMHS Hospital, the Principal of Government Medical College (GMC) Srinagar, Professor Dr. Iffat Hassan Shah, on Saturday met with several members of the media to address their concerns and assure appropriate action.

The meeting followed Wednesday's confrontation, during which protesting postgraduate doctors allegedly assaulted at least three journalists attempting to cover the ongoing strike. A police officer who tried to intervene was also reportedly pushed aside. Journalists described the situation as hostile and urged the administration to take immediate disci-

plinary and legal steps.

Dr. Iffat Shah expressed regret over the incident and assured the media that the matter was under investigation by a government-appointed inquiry officer. "The conduct of doctors involved in the episode will be closely examined. The treatment meted out to media personnel is a serious matter and will be thoroughly addressed," she stated. She also stressed the need for restoring professional harmony between healthcare providers and the press.

The Deputy Superintendent of Police from Shaheed Gunj was also present at the meeting. Journalists urged legal proceedings against those responsible, including some Medical Representatives who were reportedly seen siding with the striking doctors.

Kashmir's Startup Problem

In recent years, Government of India has bet big on startups. It's a bet that's paid off in cities like Bengaluru, Hyderabad, and Pune, but not in Kashmir. Despite over a dozen incubation centres dotting the region, and generous government incentives, the valley's unemployment crisis is only growing sharper.

The gap isn't in infrastructure. It's cultural, structural, and human. Startup India is a national mission. But in Jammu and Kashmir, it's still largely a slogan.

Local entrepreneurs report that they can't find reliable, skilled workers. At the same time, thousands of qualified youth complain of a mismatch between their aspirations and what's

A young tech graduate may learn Python in theory, but he either finds no meaningful application for it in the local economy or is lured away by Gulf salaries. Even when startups try to build in Kashmir, they can't retain talent. And those with talent don't find reasons to stay.

This is not a simple jobs-versus-workers issue. It is about deep systemic misalignment.

Practical skills are in short supply because colleges still teach for exams, not enterprises. Incubators, often run by academics with little industry exposure, are disconnected from the market. They host PowerPoint-heavy "bootcamps" rather than build product-ready companies. Without strong industry partnerships, these centres become more ceremonial than catalytic.

Traditional sectors like handicrafts and tourism, meanwhile, still dominate Kashmir's economy. But these fields offer seasonal income, little tech infusion, and no room for modern ambition. Agriculture may feed the region, but it doesn't excite the engineers it produces.

Then there's the trust gap. Workers feel underpaid and undervalued. Businesses fear investing in people who might migrate the moment a government job opens up. And because private firms can't offer long-term security, they struggle to

To solve this, the government must move beyond laying stones for centres and start cultivating actual companies. Engage industry leaders, not merely academics who see startups as a career move. Bring commerce into classrooms. Encourage schools to teach entrepreneurship as a life skill, not a last re-

The valley lacks alignment not ideas. What Kashmir needs is a business culture that sees innovation as more than jargon and stability as more than a government posting

Startups can succeed in Kashmir. But only when we stop mistaking incubation for transformation.

Smoke Over Eden

As the world debates politics and progress, Kashmir battles a collapse of memory, values, and belonging.

here's the Kashmir we see in pictures: green valleys, snowy peaks, and calm lakes. Then there's the Kashmir people carry inside them today, one that feels tired, broken, and lost. The two no longer match.

The story of Kashmir is too often framed through security and geopolitics. News cycles swing between discord and diplomatic statements.

But that lens misses something more personal and unsettling.

What's happening in Kashmir today isn't just a power struggle or strife. It's a slow, deep moral and emotional collapse. Beyond jobs and jibes, we are losing each other.

The numbers tell part of the

story.

According to the Centre for Monitoring Indian Economy, Jammu and Kashmir continues to face one of the highest unemployment rates in the country. Young people, especially the educated, spend their

days waiting for purpose.

Around 12% of the population lives in multidimensional poverty. Half don't have access to basic sanitation. Over a quarter go without adequate nutrition.

For those who find work in the tourism sector, the situation is increasingly unstable. After the April 2025 attack on tourists in Pahalgam, the valley's economy suffered another blow.

Bookings dropped, hotels emptied, and families dependent on that income were left without options.

But even those economic hardships don't fully explain what's happening.

Something bigger is unraveling: Trust is thinning, suspicion is spreading, and a deep emotional fatigue is setting in.

In a place that often prides itself on cultural and religious unity, old social divisions have started to harden again.

Marginalized groups still struggle to gain space in religious, educational, and matrimonial institutions. Sectarian tensions are being fed by seclusion. Neighbourhoods that once shared rituals and resources now talk less, visit less, and fear more.

Even more troubling is the rise in superstition and stigma. Accusations of black magic, spiritual manipulation, and whispered fears have spiralled into real consequences.

a larger breakdown in rationality,



trust, and civic life.

Religion, once a source of guidance and grounding, is often being pulled in the opposite direction. Mosques are crowded, but that doesn't always reflect spiritual clarity. Sermons speak of truth, but society rewards cunning.

There is a growing disconnect between the ethics we preach and the behaviours we normalize. We are drifting toward performative piety and away from introspective faith.

Among the young, mental health is in crisis. A study by Médecins Sans Frontières found that 45% of Kashmiris show symptoms of mental distress. That was before the pandemic, before more lockdowns, before the latest round of instability.

For many in their teens and twenties, life is a blur of anxiety, situational stress and self-doubt. Social media is their outlet, but often it intensifies the loneliness it promises to fix.

Kashmir is also losing its language, memory, and sense of cultural place. Crafts like papier-mâché and Kani shawl weaving are declining. Fewer children grow up speaking Kashmiri with fluency. Traditional songs and stories are slipping out of households.

In schools and homes, a cultural silence has taken hold from disconnection.

Even the environment is now under strain. Dal Lake, once central to Kashmir's identity, is suffocating under untreated waste. The Jhelum's waters are polluted. Glaciers are shrinking. Forests are vanishing. The very symbols of Kashmiri resilience are under threat.

What we are experiencing is not just political gridlock or economic hardship. It's a slow erosion of moral life.

The virtues that once held communities together, like empathy, dignity, self-restraint, are fraying under pressure. Influence now holds more value than integrity. Fame matters more than service. Being feared has become more useful than being respected.

And yet, people still whisper their hopes. Many still believe there is something to protect, if only we can name it honestly.

Kashmir doesn't need anoth-

Kashmir doesn't need another development scheme without dignity, or another speech that doesn't mention grief. It needs moral repair.

And that kind of repair begins at the level of daily life, in the way we treat neighbours, raise children, speak across faiths, and listen when we disagree.

Healing won't come from the top down or outside. It will come from rebuilding the ethics of every-day relationships.

Until then, the phrase "Paradise on Earth" will remain more postcard than promise. And for those of us who call this place home, that hurts more than anything else.

n a summer morning in Vailoo, South Kashmir, the valley blazes awake in gold and green. Apricot trees drip with fruit, their shadows sharp on sun-cracked walls. From tin rooftops, mynahs rise like flung sparks. The air smells of dust, leaves, and something older: stories the wind won't stop telling.

At school, I walk into my classroom, where students sit with their backs straight, books open, eyes expectant. I read to them from Yeats. The words carry slowly across the room: "When you are old and grey and full of sleep..." They nod, half-understanding, waiting for explanation.

I wait with them, not rushing, letting the line breathe. Sometimes, the meaning of love arrives in the pauses.

I am a teacher. But I speak often of things outside the syllabus: longing, affection, and the soft ache that remains when everything else disappears. Love, I tell them, is not a subject, but a thread. It

Love, I tell them, is not a subject, but a thread. It winds through literature, yes, but also through life. It binds a girl to the memory of her grandmother's voice, or a man to the weathered hands of his father. It remains long after we think it's gone.

This is what Keats taught me with breath.

Gasping for air in the damp air of Rome, he wrote to Fanny Brawne with ink and yearning. He knew he was dying. Still, he asked her to take him away from the winter. His lungs could no longer hold the cold, but they could still hold her name.

I read that letter once on a rainy afternoon and wept out of recognition than sadness.

We are taught to love in hushed ways here in Kashmir. My mother never told me she loved me. She never had to. Her love came folded into leftover rotis, into the way she tugged my blanket tighter at night, long after I

had fallen asleep.

My father's love was quieter still, contained in the long walk to my school gate each morning, the silence he left behind as he turned back before I could wave.

These things are not written about in history books.

These things are not written about in history books.

They are not posted, liked, or shared. Yet they are the


only reasons history survives.

the real world. They want to be engineers, doctors, IAS officers. They want salaries, not sonnets. But I tell them this: the world will break you in ways no job can fix. When that happens, it is not your resume you'll turn to. It will be the poem you half-remember, or the voice of your mother on the phone, or the memory of someone who stayed when they could have left.

I think often of Dostoevsky, whispering to his wife on her deathbed, "Even in my thoughts, I haven't betrayed you."

There is a sacredness in that line. A type of fidelity that feels impossible now, in the era of swipes and scrolls. We live in a world that rewards detachment. We are trained to love with caution, feel with limits, and keep exits open.

But literature, and life in Kashmir, has taught me

otherwise.

Here, love survives in the smallest places. In the woman sewing by dim-light so her children can go to school. In the father who sold his land so his daughter could study medicine in Delhi. In the grandfather who walks five kilometers to bring his grandson a mango from the city.

These are the acts of love, done daily, without witness.

And yet, I worry. Something is fading. The language of affection is being replaced by the language of acquisition. We buy things to feel seen. We collect applause instead of connection. The more we chase material comfort, the more we lose the discomfort that makes love possible.

Leve by its nature is not convenient. It is discomfort.

Love, by its nature, is not convenient. It is disruptive, and asks you to stay when staying costs you something.

There is a grief in this forgetting. I see it in my students, too. They're sharp, ambitious, often tired. Some of them have never written a letter by hand. Some have never watched their parents hold each other's gaze for longer than a second. Love, to them, is something that happens elsewhere: mostly in films and fiction, and rarely at home.

Still, I teach and read Yeats and Keats aloud, hoping that somewhere, a phrase will lodge itself in their memory like a pebble in a shoe, small but unshakable.

Rumi said, "Love is the water of life." Elif Shafak reminds us that love has no definition. It just is. I believe that. And I believe it even more in a place like Kashmir, where winter eats into bones, where stories survive on lips rather than paper.

In the end, it is not degrees or declarations that endure. It is the hand on your shoulder when your voice shakes. It is the text that arrives before you ask. It is the stove lit early by a mother who knows your schedule better than you do.

Love is the thing that doesn't need to be said, but is always there.

And in that, I still believe.

Parizaads of Kashmir

The next poet, painter, or innovator may be sitting unnoticed in a Kashmir school. Will we see them before it's too late?

TV serial rarely changes how a society sees itself. But Parizaad did. Clety sees usen. But I arranged the Story of a boy who was dark-skinned, poor, and poetic.

He was mocked by neighbours, dismissed by teachers, ignored by peers. He had a kind heart and an honest mind. But that wasn't enough.

Only when he became rich did the world begin to value him. By then, it was too late.

What struck me most was how familiar his story felt, as Kashmir is full of

They sit in the backs of classrooms, drawing galaxies in the corners of their notebooks. They walk to school on muddy roads, shoes torn, and racing minds. They write poems in worn diaries, help parents in the fields, dream of labs, studios, and libraries.

But no one pays attention, until they

give up or disappear.
We talk endlessly of talent. We glorify Iqbal, celebrate Ghalib, invoke Rumi. But when a boy from Pulwama scribbles verses, we ask him to stop wasting time. When a girl in Gurez hums a tune in the corridor, we tell her to be realistic.

Dreams in Kashmir need a pedigree. Your family must be known. Your accent must be polished. Your schooling must be English-medium. Your references must be influential.

Merit is not enough. Hunger for learning is not enough. Grit, imagination, and

honesty are not enough. The result is predictable.


Children without access fall through the cracks. They cannot afford private coaching. They do not own laptops. They speak in broken English. They are mocked for being different.

So they shrink. Their voices go silent, and potential dries up in rooms where no one looks their way.

I have met these children. One could quote Faiz from memory. Another had figured out algebra before it was taught. A third painted her grief in astonishing colours.

None of them got a scholarship, or a mentor. Their fathers drove cabs or laid bricks, their mothers stitched clothes, and their excellence meant little in a system that rewards connections, not

Even our institutions betray them. Schools prize discipline over curiosity. Colleges prefer obedience over originality. Questioning is arrogance. Innovation is rebellion. Teachers toe the line. Students learn to memorize, not to think.



young Kashmiri A poet once told me, "I stopped writing because it made people uncomfortable." A teen techie said, "I wish I were born somewhere else."

Worse, those who refuse to flatter are punished. A gifted student who won't grovel for a recommendation is left behind. A brilliant teacher who dares to experiment is transferred. Competence is inconvenient, while compliance is celebrated.

And then there is the weight of conflict.

For decades, Kashmiri children have lived through sieges, shutdowns, and sudden death. They've grown up counting bandhs instead of birthdays. Many have missed entire academic years. Others have buried friends, fathers, or neighbours. Their lives are built around loss.

In such a climate, a child cannot simply "focus on studies." Trauma interrupts thought. Grief erases concentration. A creative spark needs calm to survive, but calm is rare here.

We wonder why substance abuse is rising. Why depression feels like an epidemic. Why children grow withdrawn or angry. The answer is not mystery. It

We failed them, systematically.

Parents mocked them, teachers scolded them, while officials allocated budgets without asking what children actually need. Community elders celebrated saints and poets, but never asked if the next one lives on their street.

Even when a Parizaad emerges - a boy who wins a poetry contest, a girl who builds a science model - there is no platform.

Where are the mentorship programs, youth fellowships, and the music rooms, writing workshops, coding labs? Where are the spaces where they can breathe, express, belong?

Instead, those who dare to shine must leave Kashmir. Or dim their light to sur-

A young Kashmiri poet once told me, "I stopped writing because it made people uncomfortable." A teen techie said, "I wish I were born somewhere else."

This is how we lose our best.

Yet all is not gone. Some Parizaads still walk among us. They teach in government schools for a fraction of what they deserve. They write at night after power cuts. They draw on old newspapers. They volunteer in hospitals, mentor younger kids, plant saplings in parks. Their names aren't trending. But they carry this valley forward.

They don't need pity. They need space. So the next time you see a shy child writing in a corner, don't ask her to be practical. Ask her what she sees when she closes her eyes. And then, listen.

In that answer may lie the future of Kashmir.

s a child, before I could answer what I wanted to become, I discovered something even more precious: the joy of true companionship. That discovery began in a school corridor in Kashmir, with a boy named Altaf.

Altaf was everything I wasn't. He had charm, confidence, and a way of talking to people that made them listen. I, on the other hand, preferred to observe from the corners.

He once led a group trip to his maternal home in Ganderbal. That place was like him: lush, alive, full of surprise. It's where I learned that friendship doesn't need similarity, just trust.

Then came Rahil, Yasir, and Mudassir. We were boys who dreamed big and studied hard. Yasir had a poetic walk, graceful like the couplets he often quoted. Mudassir had a nose we teasingly said gave him away as "Chinese," but his heart was Kashmiri through and through: gentle, funny, always present. Rahil was the brain of our

bunch, and once, in a twist only childhood can afford, his love letter ended up landing on my

name. That story still makes us laugh.
School wasn't just about grades. It was a stage where eagles would dive during lunch breaks, trying to snatch bread from our hands. It was where Shahnawaz ruled the fields with his charm and sporting flair, so popular that my own cousin warned me not to get "influenced." But how could one not?

Wasim joined us toward the end. He had this sparkle: tall, sharp, always full of clever comebacks. With him, even tough days were somehow light.

When I stepped into engineering, the faces changed, but the essence of friendship stayed. Nazish, Sajad, and Tahir came from different departments, but we clicked like cousins. Mechanical engineering had fewer students, but

that made our bond tighter, more personal. My M.Tech brought me to Ishtiyaq Ahmad Bhat. I was intense, he was steady. I overthought, he stayed practical. His discipline rubbed off on me, and we both grew better

through it.

Then came the Ph.D. years. Long, often isolating. But with Jibran and Ashiq, it never felt lonely. Jibran, with his sharp insights, and Ashiq, with his kindness, made even the hardest research feel human. Work life had its own cast

of companions. At Maruti Suzuki, Rashid Saleem became my anchor: focused, efficient, and always bringing energy to the team. In an industry built on deadlines and pressure, he made space for laughter.

At Toyota, two friends left a mark that still lingers. Sandy, with his lightning-fast typing and impeccable court-style documentation, turned routine meetings into performances. His energy was infectious. Then there was Karan, deliberate

and thoughtful. He taught me how to pause, breathe, and speak only when it matters.

Dagan Top's Wild Magic

With no hotels and fewer footprints, Dagan Top offers a lesson in humility and harmony.

There are no road signs for Dagan Top. No ticket counters, souvenir shops, or well-lit trails.

To reach it, you leave behind Doda town in Jammu and Kashmir and head toward Thathri, a small settlement perched in the Chenab Valley. From there, the road grows

narrower, less certain, more generous in its silences. It leads you toward a landscape that feels like a held breath: green, immense, and remarkably un-

Tucked in the Gandoh tehsil of Doda, high up in the Bhalessa hills, Dagan Top is a place that lives in the stories of shepherds and summer wanderers.

Known only to locals and nomadic families who climb these slopes each year with their herds, Dagan remains a mystery to most maps and all mainstream tourist itineraries. And perhaps that's its greatest gift.

The journey ends long before the experience begins.

After Bonencha village, the asphalt disappears. You either walk or hire a horse, threading through pine corridors that open like curtains onto meadows. Gingota is the last point of panchayat governance here, but it feels more like the beginning of something old and elemental.

What greets you at Dagan Top isn't a monument or resort. It's a vast, undulating canvas: the Rohari meadows spilling across ridgelines, snow-tipped mountains like sentinels standing far and high, and wind sweeping through canopies of deodar and kail as if rehearsing an old hymn.

The air feels thinner, sharper.

So does your awareness. This is cattle country, home in summer to the Gujjars, Bakkerwals, and ethnic Pahari communities who've followed the rhythm of transhumance, seasonal migration, for centuries. They arrive with livestock in May, set up tents on slopes, and disappear with the autumn chill.

Their stories are woven into the terrain: women milking

cows at dawn, children chasing goats across wild grass, men re-turning with bundles of dried herbs and moss.

And this is the heart of what makes Dagan Top different from other so-called "offbeat" travel spots. This place isn't being curated for tourists. It lives for itself.

Its villages, like Alni Gingota, Kota, Ghati, Kakoti, lie folded around the hills like wrinkles in an old map. From any vantage, you see Mandral, Jawali, and beyond that, the green shadows of Talaie and Gamgul, places

that sound mythical and remain mostly unseen.

The lack of formal infrastructure is both a challenge and a charm. There's no approach road to Dagan Top itself. Local guides and horsemen navigate the route, using ancestral knowledge of the terrain.

For now, the government schemes for tourism haven't reached here. It's bereft of reception centers, signage, and homestays. That absence forces you to engage with the place rather than consume it.

Even in winter, when the top

is white carpeted, snow trekking has started to gain interest. The landscape changes texture. What was lush in July turns stark and poetic by December. Snow muffles sound. The moun-

tains turn pale, monumental. For photographers, it's a canvas of contrasts. For trekkers, an invitation. Yet all of this rests on a fragile

ecological balance. The coniferous forests - home to rare flora, medicinal herbs, and native birds - face pressure from unregulated grazing and climate shifts. ment or trail maintenance, even a trickle of careless tourism could rupture this ecosystem.

That's why the future of Dagan Top depends not on development but on deliberation. Sustainable tourism here must mean walking slower, looking deeper, and leaving lighter.

The place needs simple, locally made trails, eco-cabins modeled after Gujjar shelters, and a visitor cap during grazing season.

Most importantly, a revenue model that pays local families to be custodians, not casualties, of tourism. The potential is real. Doda

district, according to government data, has over 20 identified tourism sites, most of them barely functional. Yet what Dagan offers is rar-

er: a chance to rethink the relationship between visitor and visited. You don't arrive here to be served. You come to witness, listen, and slow down. So when you stand atop Da-

gan, with nothing but wind in your ears and valleys in your gaze, you begin to understand the proposition. This is not leisure. This is a lesson. A lesson in how the land re-

members. How people endure without internet towers or tarmac. How beauty doesn't have to announce itself to matter. And how maybe, just maybe, the best places left are the ones that ask you to earn the view. To reach Dagan, start early

from Doda. Take the Kilhotran-Changa Road toward Thathri. Ask locals in Kota Bonencha for help with the final stretch. Bring your own food. Carry your waste out. Speak less, and walk more.

And once you arrive, try not to document everything. Some places are better left as stories told around fires, or dreams that smell faintly of pine and milk and moss.

ED Raids Against Anil Ambani Group Companies Continue On Day 3

New Delhi: Enforcement Directorate searches against the companies of Reliance Group chairman Anil Ambani in Mumbai continued for the third day on Saturday with the agency recovering a number of documents and computer peripherals from multiple locations, official sources said.

The raids were launched on July 24 by the federal probe agency as part of an alleged Rs 3,000 crore worth bank loan fraud-linked money laundering case apart from multiple other allegations of financial irregularities with crores of rupees by certain companies.

The searches, being conducted under the Prevention of Money Laundering Act (PMLA), are continuing at some locations out of the more than 35 premises that were covered in Mumbai since Thursday, the sources said.

These premises belong to 50 companies and 25 people

including a number of executives of the Anil Ambani Group companies.

ED sources had said the investigation primarily pertains to allegations of illegal loan diversion of around Rs 3,000 crore, given by the Yes Bank to the group companies of Ambani between 2017-2019.

Reliance Power and Reliance Infrastructure, two companies of the group, had on Thursday informed the stock exchanges saying while they acknowledge the action, the raids had "absolutely no impact" on their business operations, financial performance, shareholders, employees, or any other stakeholders.

"The media reports appear to pertain to allegations concerning transactions of Reliance Communications Limited (RCOM) or Reliance Home Finance Limited (RHFL) which are over 10 years old," the companies had said.

The ED, the sources had said, has found that just before the



loan was granted, Yes Bank promoters "received" money in their concerns.

The agency is investigating this nexus of "bribe" and the loan.

The sources said the ED is also probing allegations of "gross violations" in Yes Bank loan approvals to these companies including charges like backdated credit approval memorandums, investments proposed without any due diligence/credit analysis in violation of banks credit policy.

The loans are alleged to have been "diverted" to many group companies and "shell" (bogus) companies by the entities involved.

The agency is also looking at some instances of loans given to entities with weak financials, lack of proper documentation of loans and due diligence, borrowers having common addresses and common directors in their companies etc., the sources said.

companies etc., the sources said. The money laundering case stems from at least two CBI FIRs and reports shared by the National Housing Bank, SEBI, National Financial Reporting Authority (NFRA) and Bank of Baroda with the ED, they said.

These reports indicate, the sources said, that there was a "well-planned and thought after scheme" to divert or siphon off public money by cheating banks, shareholders, investors and other public institutions.

The Union government had informed the Parliament recently that the State Bank of India has classified RCOM along with Ambani as 'fraud' and was also in the process of lodging a complaint with the CBI.

A bank loan "fraud" of more than Rs 1,050 crore between RCOM and Canara Bank is also under the scanner of the ED apart from some "undisclosed" foreign bank accounts and assets, the sources said.

Reliance Mutual fund is also stated to have invested Rs 2,850

crore in AT-1 bonds and a "quid pro quo" is suspected here by the agency.

Additional Tier 1 (AT-1) are perpetual bonds issued by banks to increase their capital base and they are riskier than traditional bonds having higher interest rates. An alleged loan fund diversion of about Rs 10,000 crore involving Reliance Infrastructure too is under the scanner of the agency.

A Sebi report on RHFL is also part of the ED probe.

The companies also said in their filings before the stock exchanges that Anil Ambani was not on the Board of either Reliance Power or Reliance Infrastructure and that they had no "business or financial linkage" to RCOM or RHFL.

Any action taken against RCOM or RHFL, the companies said, has no bearing or impact on the governance, management, or operations of either Reliance Power or Reliance Infrastructure.

He said the Constitution guarantees justice—social, economic, and political—and it must reach the poorest of the poor who deserve it the most. Sinha added that, post-2019, several central laws that were previously not applicable to J&K are now being enforced, thereby extending full constitutional protections and guarantees to the tribal population, including access to justice through free and competent legal aid.

"We have taken major initiatives in J&K to ensure ease of justice to the members of Armed Forces and are committed to provide legal aid to the tribal community," Sinha said.

He emphasised the need for timely legal assistance to vulnerable groups. "State Legal Services Authorities must ensure that all possible legal aid reaches army personnel, tribal community, deprived and vulnerable sections of society so that their lives become easier and their rights granted by the Constitution are protected," he said."

The LG observed that before the abrogation of Article 370, several key central legislations were not applicable to Jammu and Kashmir. "Before 2019, various central laws including the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act and the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989 were not applicable to J&K," he said.

"Now, these laws have become applicable and the tribal community has been empowered. We are extending all constitutional guarantees and protections to the members of the tribal population including access to justice by providing free and competent legal aid to them," the LG added.

He also spoke about structural changes made to support soldiers legally. "Amendment has been made in J&K Legal Services Authority Rules, 2020 to include Secretary, Zila Sainik Board as a member of the District Legal Services Authority to provide legal aid to soldiers."

Further, the Lieutenant Governor highlighted the establishment of Sainik Sahayta Kendra, a dedicated mechanism for redressal of civilian grievances faced by soldiers belonging to J&K or posted in the Union Territory.

The event also marked the launch of NALSA Veer Parivar Sahayata Yojana 2025, aimed at providing legal services to defence personnel, ex-servicemen and their families, alongside other initiatives including the Defence Personnel Case Management System, Special Samvad Legal Units for tribal communities, and legal support centres at Rajya and Zila Sainik Boards.

The conference was attended by Supreme Court Judge and NALSA Executive Chairman Justice Surya Kant, Union Minister of State for Law and Justice Arjun Ram Meghwal, Chief Justice of J&K and Ladakh High Court Justice Arun Palli, Chief Minister Omar Abdullah, senior judges, officials, legal professionals, Veer Naris, and ex-servicemen.

Reports said that the programme has its genesis in the aftermath of Operation Sindoor. Sources told NDTV that Justice Surya Kant was deeply moved by the sacrifices made by the armed forces during the operation and began exploring ways in which the judiciary could contribute more directly to their well-being.

According to the sources, Justice Surya Kant remarked that the legal fraternity must do its part to ensure that soldiers defending the country are not left alone to handle personal legal crises.

The new scheme is tailored to address a longstanding issue: soldiers deployed in isolated areas often lack the ability to follow through on legal cases involving family property, domestic disputes, or land matters. For example, a soldier stationed in Jammu and Kashmir may have limited access or zero leave to appear in court proceedings back home in Kerala or Tamil Nadu.

Under the scheme, NALSA will intervene to ensure that such cases are properly represented in courts across the country.

The support will also extend to paramilitary personnel, including those from the Border Security Force (BSF), Central Reserve Police Force (CRPF), Indo-Tibetan Border Police (ITBP), and others who serve in similarly isolated and high-risk conditions.

were organised across the country, including at the Kargil War Memorial in Drass, to mark the occasion.

"Pakistan Army's ploy to extend the conflict beyond the Great Himalayan Range by sending regular troops disguised as Mujahideens, remains a stark reminder of their treachery," he said.

Chief of the Naval Staff Admiral Dinesh K Tripathi said the legacy of the Kargil "bravehearts" stands as a testament to the unwavering devotion to the service of the nation.

"Your sacrifice will remain a beacon of inspiration, not only for future citizens of our country but also for those who choose to serve in the defence forces with 'Duty-Honour-Courage!'," he added.

Chief of the Air Staff Air Chief Marshal A P Singh the Indian Air Force remains committed to defend the sovereignty of the nation and uphold the proud traditions of courage, honour and duty as exemplified by the bravehearts.

The order reads that the Enquiry Officer shall Assess the immediate precursors to the said incident, as well as the developments that ensued after the incident. It also reads that the enquiry officer shall investigate the reasons for the closure of Operating Theatres (OTs), assess whether such closure was avoidable, and fix responsibility upon the individual(s) found to have acted in dereliction of duty or in contra-

vention of established protocols.

The order also reads that the officer shall recommend concrete measures aimed at enhancing internal grievance redressal mechanisms, strengthening administrative coordination, and improving the overall functioning of the institution; and propose remedial and preventive measures to ensure that such incidents do not recur in the future.

"The Enquiry Officer shall submit a report to the Government within a period of fifteen (15) days from the date of issuance of this order", it reads

The order further adds that Mohammad Ashraf Hakak, Administrator Associated Hospitals, GMC Srinagar shall be the Presenting Officer in the case.

J&K To Get Law

Kargil Vijay Diwas, Omar remembered the fallen soldiers of the 1999 war and lauded their sacrifices

"Today, on the solemn occasion of Vijay Diwas, let me begin by acknowledging the service and sacrifices of our defence personnel, both past and present. These men and women, many of whom belonged to J-K, served in remote, inhospitable terrain, with a quiet dignity and an enduring sense of duty," he said.

The CM said when faced with legal challenges -- be it service-related disputes, pension matters, or civil grievances, the defence personnel often encounter systemic barriers owing to geographic remoteness, immobile nature of their postings, and their distinct constraints of military life.

"These challenges definitely constitute other disabilities under Article 39A and must be addressed with the urgency and the compassion that they weren't. It is indefensible that those who risk their lives to uphold the Constitution should struggle to access the protections in guarantees," he asserted.

Omar said there is a pressing need to establish a robust coordination among legal service authorities, military legal cells, zila sainik boards, and regimental welfare offices.

The establishment of dedicated legal aid clinics in cantonments and in districts with significant ex-servicemen populations should be prioritised. Equally important is the need to ensure that families of defence personnel, particularly widows, aged parents, and dependent children, receive empathetic, expert and timely legal support, he said.

The CM said awareness must accompany access, and no soldier, or the family of a soldier, should be left adrift, unsure of the procedural avenues available to them.

"To this end, paralegal volunteers trained especially in military legal issues should be deployed in areas with high defence populations. Simultaneously, technology must be harnessed to democratise access through mobile apps, virtual consultation platforms, and userfriendly legal information portals," he said.

"Justice in our times must not mainly be available, it must also be accessible," Omar added.

Referring to the tribal communities in J&K, the chief minister said they are the custodians of rich cultural and ecological heritage, and the Union territory is home to several scheduled tribes who have preserved ancient traditions while making their way through difficult terrain.

He said his government has augmented its development efforts for the community, but development alone cannot substitute justice.

He demanded that paralegal volunteers be trained from within the tribal communities themselves to ensure that legal support is rendered in familiar idioms, dialects and cultural frameworks.

Omar said that for justice to be meaningful, it must reach every remote hamlet from Poonch to Kishtwar and from Rajouri to Karnah.

Simultaneously, a sensitive balance must be maintained between national security and the rights of tribal citizens. Many tribal regions are located in border belts in areas of heightened security oversight. However, law enforcement must not translate into legal disenfranchisement, he said.

HC Updates Rules

"A Memorandum has been drawn by the Government of India ,..., showing the legal position concerning the persons belonging to Army Officers," it reads. "...When any officer or soldier actually serving Government in military capacity is a party to a suit and cannot obtain leave of absence for prosecuting or defending a suit, he can appoint some other person to act on his behalf by an authority in writing given in the manner prescribed in Order XXVIII of the Code of Civil Procedure."

Regarding immunity from Arrest for debt, the amendment refers to Sec. 29 of the Army/ Air Force Act which provides that no person subject to either of these Acts, so long as he belongs to the Armed Force, can be arrested for debt under any process issued by, or by the authority of a civil or revenue court or a revenue officer.

"Where, in spite of the above any-such arrest is made, the court of the revenue officer concerned on receipt of a complaint by such person or by his superior officer to that effect, may discharge him and award reasonable costs to the complainants," the amendment reads. The costs may be recovered in like manner as if they were awarded to him by a decree against the person obtaining the processes, it reads. "No court fees are payable for the recovery of such costs"

It also has provision for immunity of persons attending courts martial from arrest. "Under Section 30 of the Army/Air Force Act, no presiding officer or member of a court martial, no Judge advocate, no party to any proceedings before a court martial, or his legal practitioner or agent, and no witness acting in obedience to a summons to attend a court martial while proceeding to, attending or returning from, a court martial is liable to be arrested under civil or revenue process," it reads, adding, "If any such person is arrested under any such process, he may be discharged by order of the court martial."

The amendment also delineates priority in respect of Army Air Force personnel's litigation, underling that under Section 32 of the Army/ Air Force Act on the presentation to any court by or on behalf of any person subject to either of these Acts of a certificate, from the proper military/air force authority, of leave of absence having been granted to or applied for by him for the purpose of prosecuting or defending any suit or other proceeding in such court, court shall on the application of such person, arrange, so far as may be possible, for the hearing and final disposal of such suit or other proceedings within the period of the leave so granted or applied for.

Among others, the amendment provides clarification regarding succession certificate proceedings under the Indian Succession Act,

"A "party to any proceeding" is a person actually impleaded e.g., a plaintiff or defendant or an appellant or respondent—and the phrase does not include persons named under section 372, sub section (1), clause (c) of the Indian succession Act, 1925, in an application for the grant of a certificate until the Court has, by order under Section 373 (1) (a) of that Act, expressed the opinion that special notice of the application should be given to them."

Insecticides should also be used in outdoor storage units as a precautionary measure, he said.

Dr. Raina noted that the dengue-spreading

Aedes mosquito typically breeds in urban environments, favouring man-made containers like discarded tires, buckets, and flower pots. "This mosquito is most active during early morning and late afternoon. People should wear clothes that reduce skin exposure and use mosquito repellents," he advised.

To prepare for potential surges, dedicated

dengue wards with at least 20 beds have been established in each district hospital, and testing facilities are operational at the district level.

Patients who test positive are advised to take adequate rest, stay hydrated, and eat a diet rich in fruits and vegetables. The malariologist also warned against self-medication, especially with painkillers like aspirin and ibuprofen, which can aggravate bleeding in severe cases.

Typical symptoms of dengue include high fever, severe headache, pain behind the eyes, joint and muscle pain, skin rashes, nausea, and vomiting.

In recent years, dengue has posed an increasing public health challenge in the region. J&K reported nearly 7,000 cases in 2024, 6,403 in 2023, and a record 8,269 cases with 18 deaths in 2022. Earlier years had relatively fewer cases, with just two in 2009 and none in 2010.

Dr. Raina concluded with an appeal for public cooperation. "Community cleanliness is vital. Keep surroundings dry and mosquito-free, wear protective clothing, and use mosquito nets while sleeping," he said. (KNO)

He also reflected on the Apni Party's earlier warnings, claiming that the public is now beginning to recognize their validity. "People didn't believe us when we raised red flags earlier. But now they're saying we were right," Bukhari asserted.

Police detain 4 notorious peddlers in Budgam

All four individuals were identified as repeat offenders involved in the illegal trade of narcotics, particularly targeting and exploiting the local youth. Following the issuance of formal detention orders, the individuals were lodged in different jails as per legal procedures, he said.

Bilquis Mir Wins Legal Battle As JK High Court Slams ACB

SRINAGAR: Bilquis Mir, India's sole female judge for Kayaking and Canoeing at the 2024 Paris Olympics, has triumphed in her three-year legal battle for quashing an FIR filed by the Anti-Corruption Bureau, with the Jammu and Kashmir High Court delivering a scathing in-dictment of authorities saying it "seems that the people at the helm of affairs are leaving no stone unturned in harassing such talented people".

The court said the attitude of ACB "in criminalising nonacquisition of a technical qualification" by Mir when she has brought laurels to the country all over the world "speaks volumes about the manner in which we are treating our sporting heroes" and that the case appears to be "nothing but a witch-hunt launched against the petitioner

by vested interests". Mir still shudders recalling the moment, three years ago, when she learned from newspapers that the ACB had regis-

tered a case against her. "My dreams came crashing and I could not understand what was my fault," she recounted to PTI, tears welling up.

The FIR, which the High Court quashed on Friday, claimed a verification was conducted into allegations that Mir, appointed as a Physical Education Teacher, did not complete her Bachelor of Physical Education course during her probation.

The ACB had filed an FIR against Mir in 2023 under the Jammu and Kashmir Prevention of Corruption Act and the Indian Penal Code, charging her with taking gratification beyond legal remuneration for official work and involvement in a criminal conspiracy.

This marked the beginning of Mir's agony. "When I decided to opt for Kayaking, I did not have the money to buy a paddle for practising. I wore the India jersey at a time when terrorism was at its peak. Nothing deterred me, but this was a jolt was not ready to take, and I decided to challenge," she said.

Mir's illustrious 28-year career began at the age of eight, and her include representing India at the 2009 Canoeing and Kayaking World Cup in Hungary, where she finished 8th.

She was the first Indian woman appointed as a judge in the Asian Games (China) and served as national coach for the Women's team in Kayaking and Canoeing for the London Olympics 2012.

Mir also holds the distinction of being the first Indian woman to earn an International Coaching Diploma from Budapest's Semmelweis University Institute of Coaching and Sport. Her coaching roles extend to

the chief coach for the women's national team in the U23 Canoe Slalom World Championship (Italy 2018) and national coach for the 9th Asian Canoe Slalom Championship (Toyama, Japan 2016).

And what she terms as the peak of her career was the moment when she was selected as a judge for the Paris Olympics for which she had to fight and see a court order to catch a

"At times I wanted to call it quits, but the fire in me to do something for the country always pushed me beyond limits," she recalled.

In a 20-page order, Justice Sanjay Dhar referred to a February 16, 2024, letter from vice

president of Indian Olympic Association to the chief secretary highlighting the achievements of the petitioner by conveying that selection of Mir to officiate at the Olympics is a matter of pride not only for the country as a whole but Jammu and Kashmir in particular. The court also referred to

the communication that it is a celebration and triumph for all women of India that she has achieved what no one else has achieved in over a hundred years of the Olympics.

Coming down heavily on authorities, the court said this country has produced very few sports personalities and coaches of the level of Mir "and instead of honouring them and celebrating their achievements, it seems that the people at helm of affairs are leaving no stone unturned in harassing such talented people".

"No surprise that even after more than 75 years of independence, this country has failed to develop a sporting culture, as a consequence whereof, we have failed to produce sportsmen/women of international standards in proportion to our population," it said. The court said the attitude of

ACB in criminalising non-acquisition of a technical qualification" by Mir "speaks volumes about the manner in which we are treating our sporting heroes". In the strongly-worded order,

the court said it was "alarmed" to note that the ACB has even tried to go into the issue as to whether the answer scripts of Mir in her graduate examination have been properly evaluated by the examiners.

'This attitude" of ACB, the court said, "clearly smacks of wreaking vengeance upon the petitioner (Mir). The present case appears to be nothing but a witch-hunt launched against the petitioner by vested interests."

Invoking Section 528 of Bharatiya Nagarik Suraksha Sanhita (BNSS), which deals with the inherent powers of the High Court to prevent the abuse of the legal process and to secure the ends of justice, the court said the continuance of criminal proceedings against Mir in these circumstances would be nothing "but an abuse of process of law" and quashed

Asia Cup: India, Pakistan To Clash On September 14 & 21

KARACHI/NEW DELHI: The men's Asia Cup will be held in the United Arab Emirates (UAE) from September 9 to 28, Asian Cricket Council president Mohsin Naqvi announced on Saturday. As per the itinerary, the marquee group match between India and Pakistan will be held at the Dubai International Stadium on Sunday (September 14).

The arch-rivals are clubbed in the same group and are expected to square off again in a Super Four game on next Sunday (September 21).

India will start its campaign against UAE on September 10 and are likely to play all its matches in Dubai.

India, Pakistan, UAE and Oman are clubbed in group A, while Sri Lanka, Bangladesh, Afghanistan and Hong Kong are in group B.



The ACC will allow 17-member squads for the 19-match tournament and matches will be played in Dubai and Abu Dhabi.

ACC president Mohsin Naqvi stated, "Hosting the ACC Men's T20 Asia Cup 2025 in the UAE allows fans from across Asia to come together in a setting that mirrors our region's incredible diversity. When crowds

gather to witness the tournament's unforgettable clashes, it will be a great reminder of cricket's power to build bridges."

The venue of the event was decided at an ACC meeting on July 24, which was attended by all the 25 member nations.

BCCI is the host of the tournament but it is being held in the UAE as India and Pakistan have mutually agreed to compete only at neutral venues till 2027 due to the prevailing cross-border tension between them.

As per ACC's deal with the broadcasters, India and Pakistan will be clubbed in the same group and also get another shot at each other in the Super Four stage with a possibility of a third meeting if both teams reach the final.

This edition of the Asia Cup will be held in T20 format as is the convention with the next ICC global meet being T20 World Cup in India and Sri Lanka.
