How Kashmiris Are Building a Support System In Mumbai

From cancer treatment referrals to missing persons support, the Kashmiri circle in Mumbai fills the vacuum left by institutions.

Mumbai: Earlier this year, a Kashmiri family stepped onto a crowded platform at Mumbai's Dadar station. They had come with a toddler in their arms and a medical file in their bag. The city, vast and fast, offered no

Soon, they were stranded,

lost between streets, and unsure whom to call or where to go. Someone in their wider network forwarded them a number.

The number belonged to a member of the JK Mumbai Circle, a growing network of Kashmiri professionals across India's financial capital.

Within hours, help arrived.

That evening, the family was

offered a place to stay, connected with doctors, and brought a home-cooked meal.

The Circle began as a WhatsApp group in 2023. Today, it includes over a hundred members, including bankers, doctors, civil servants, restaurateurs, artists, who coordinate daily to respond to fellow Kashmiris in need.

Without office, funding, or



NGO status, the group fills the gap where official systems fall short. Every day, someone posts a

request: A patient needs a hospital referral, a student is looking for a hostel, and a graduate asks for help with a résumé.

The replies come quickly, usually with options, sometimes with offers to meet in person.

"What's being built isn't an

organization," said a founding member of the group. "It's a safety net, held together by trust."

EAM Again Rejects US Assertion Of Modi-Trump Call

DM Says Operation Paused After Achieved Goals

New Delhi: External Affairs Minister S Jaishankar on Monday asserted that at no stage in any conversation with the US was there any linkage of trade with halting of Operation Sindoor and said there was no call between Prime Minister Narendra Modi and US President Donald Trump between April 22 and June 17.

Jaishankar referred to the two phone calls between Trump and Modi, with the first one being on April 22, when the US President conveyed sympathies for the Pahalgam terror attack, and the second one on June 17, when he called the PM to explain that he could not meet him in Canada. Intervening in the special

discussion in the Lok Sabha on 'India's strong, successful and decisive Operation Sindoor in response to the terror attack



in Pahalgam', the senior BIP leader also said the result of India's diplomacy post-Pahalgam attack was that only three out of 190 nations which are part of the UN opposed Operation Sindoor. There was overwhelming support that the country which has been attacked has the right to defend itself, he said.

Jaishankar said India's military action against Pakistan following the Pahalgam terror attack marked a "new normal"

terrorism with a five-point approach that included firm response to terrorist acts, not yielding to nuclear blackmail and blood and water cannot flow together.

combative Though Jaishankar took on the previous Congress governments on a range of issues including on 26/11 Mumbai terror attacks, policy on China as well as Pakistan, the major highlight of his nearly 40-minute address was his articulation of the new normal in combating cross-border terrorism ema-

nating from Pakistan. "The challenge of crossborder terrorism continues but Operation Sindoor marks a new phase. There is now a new normal. The new normal has five points," Jaishankar said.

CM Eyes Statehood Restoration in Ongoing Session

Jammu: Chief Minister Omar Abdullah on Monday said he is hopeful of restoration of statehood to Jammu & Kashmir during the Monsoon session of Parliament, asserting that his government will raise the issue if there is no progress on it during this period.

However, the J&K Congress said they are intensifying the statehood restoration agitation from August 1 and announced a three-week programme including a chain hunger strike as part of its 'Hamari Riyasat Hamara Haq' campaign.

Talking to reporters on the sidelines of a function here, Chief Minister Abdullah said, "Let this Parliament session pass. We are hopeful that we will get something in this session. If we do not get anything, we will talk after that. I will not go for a strike as long as the Parliament is in session.'

He was responding to a question on the Congress' announcement that it will intensify its



agitation for the restoration of statehood.

The National Conference and the Congress fought the last year's assembly elections together with the national party only winning six seats against the regional party's 42 seats. The NC is also enjoying the sup-

port of five independent MLAs. The Congress has decided to stay away from the government till the restoration of statehood to J&K.

Lambardar Can't Hold Office Till Death: HC

Srinagar: The High Court of I&K and Ladakh has upheld an amendment, deleting a Sub-Rule that provided that Lambardar appointed otherwise than by election can hold the office till he dies or is dismissed, discharged or till the general election is held.

Dismissing a bunch of petitions, a bench of Justice Rajnesh Oswal termed it as a welcome step on the part of the Government in streamlining the appointment, election and nomination of Lamabardars.

The petitioners, claiming to have been appointed as Lambardars otherwise than by election under the provisions of the Jammu and Kashmir Lambardari Act, 1972 along with the Jammu and Kashmir Lambardari Rules, 1980 had assailed SRO No. 412 dated 29



September 2017 issued by the government to the extent of deletion of Sub-Rule 5 of Rule 16 of the Rules and for directing the authorities not to dislodge them from their respective offices of Lambardar.

"It is worthwhile to mention that no orders in respect of removal of petitioners were issued by the Government and also no elections for the office of Lumbardars were notified by the Government, but the petitioners, apprehending their removal, have filed these petitions in anticipation to stall the process of election which is

nothing but an abuse of process of law," the bench said and dismissed the petitions.

"The respondents (authorities) are left free to hold elections in accordance with Rules," the court said, adding, "It is hoped that the respondents would strictly follow the mandate of Rules while making temporary appointments of Lambardars.'

The court also ruled that the casual vacancy can be filled by nomination in terms of Rule 17 of the Rules for a period not exceeding six months. "This exceptional power can be resorted to only in cases where an unelected Lambardar is appointed in terms of Rule 11 of the Rules," the court said.

'BRUTAL CUSTODIAL TORTURE ON FELLOW CONSTABLE'

CBI Books DSP, 5 Other **J&K Police Officials**

New Delhi: The CBI has booked six officials of the Jammu and Kashmir Police following allegations of inflicting "brutal and inhuman custodial torture" on a fellow police constable two years ago.

In its FIR registered on the orders of the Supreme Court, the central agency has named Deputy Superintendent of Police Aijaz Ahmad Naiko and five others, who were then posted at the Joint Interrogation Centre, Kupwara, officials said.

Apart from DSP Naiko, Sub-Inspector Riyaz Ahmad and four other J&K Police officials--Ahmad, Imtiyaz Iahangir

Ahmad, Mohammed Younis and Shakir Ahmad-- have been named in the FIR for allegedly inflicting "brutal and inhuman custodial torture" over six days on Constable Khursheed Ahmad Chohan.

The victim, who was posted in Baramulla, was summoned through a signal communication on February 17, 2023, to report before SSP, Kupwara ostensibly for investigation in connection with a narcotics case.

On arrival, he was handed over to the Joint Interrogation Centre, where Naiko, Riyaz Ahmad and others tortured Khursheed for six days with iron rods and wooden sticks, besides | More on P10

'Unethical Referrals, Private **Practice': 6 Doctors Banned**

Srinagar: The Jammu and Government on Monday ordered a ban on six doctors for allegedly engaging in private practice during official duty hours and making unethical referrals to private Empanelled Health Providers Care (EHCPs).

According to a government order issued by the Health & Medical Education

Department, the action follows an evaluation conducted by the State Health Agency under the Ayushman Bharat – PMJAY/ SEHAT Scheme, which revealed that these doctors had been violating norms and undermining

the scheme's objectives. The doctors found involved in private practice during duty hours include Dr. Bilal Ahmad Bashir (Consultant Surgeon, Anantnag) with 312 cases, Dr. Ishaq (Medical Officer, DH Pulwama) with 170 cases, and Dr. Younis Kamal (Associate

Professor Orthopaedics, GMC Anantnag) with 185 cases. Additionally, three doctors were found


"I started learning this craft from my father, Noor Mohammad Najar, when I was young," Rafiq said.

Araghchi: Israel Plotted to Assassinate Me in June

Tehran: Iranian Foreign Minister Abbas Araghchi revealed Sunday that Israeli forces attempted to assassinate him during the peak of the Tel Aviv 12-day military assault on Iran in June.

"A bomb was planted in a house across from the one where I live," Araghchi stated via Telegram, adding that Iranian security forces managed to neutralize the threat. The plot, according to Araghchi, was timed to coincide with Israel's broader campaign of targeted killings and airstrikes, which began on June 13 under the pretext of halting Iran's peaceful nuclear program.

While Araghchi was attending the 51st session of the Organization of Islamic Cooperation (OIC) in Turkey, Israeli surveillance drones were reported to have hovered persistently over the Iranian delegation. "We responded by taking immediate precautions, such as turning off our phones," he said, highlighting the constant threat posed by Israeli espionage even in diplomatic settings, pan-Arab

news channel Al-Mayadeen reported on Monday.

The assassination attempt came amid a wider Israeli operation that killed several Iranian scientists and senior military officers in a series of aggressive and unprovoked strikes on Iranian soil. Tehran responded with measured but firm retaliation, launching drone and missile barrages targeting Israeli military installations. The United States escalated the conflict further by striking Iranian



nuclear facilities on June 22, an act widely condemned by Iranian officials as blatant aggression. In response, Iran targeted the US airbase at Al Udeid in Qatar.

The confrontation came to a temporary halt on June 23. when the US President announced a ceasefire

Iran Slams Media for Spreading Israel-Linked Fake News

New Delhi- Iran has issued a sharp rebuke to sections of the Indian media over "fake and fabricated" reports about Supreme Leader Avatollah Sayyed Ali Khamenei, accusing them of amplifying Israeli-linked propaganda and undermining journalistic credibility.

In a sharply worded statement issued Monday, the Embassy of the Islamic Republic of Iran in India criticised sections of the Indian media including prominent outlets for amplifying unverified social media content that it said insulted Iran's leader-

ship and misled the public. The Embassy was responding to recent stories in Indian news publications that claimed Iran's spiritual leader was "spending his days sleeping and using drugs." These reports appear to have drawn content from a social media account allegedly connected to Israel's intelligence agency Mossad — a source the Iranian government dismissed as pro-

paganda-driven and unreliable. 'Such irresponsible reporting not only undermines public confidence but also severely damages the professional reputation of these media

institutions among their audi ences," the statement said.

While affirming its respect for press freedom and the right to information, the Embassy urged Indian jour nalists to rely on credible and impartial sources. It warned that repeating sensationalist narratives from dubious foreign-linked social media accounts risked dragging Indian media into geopolitical information warfare.

The statement also reaffirmed the role of Iran's Supreme Leader not only as the spiritual and political head of the country but also as the Commander-in-Chief of the Armed Forces. Referring to a recent military confrontation — described by Iran as a "twelve-day imposed war" with the Zionist regime — the Embassy said Ayatollah Khamenei played an active leadership role in guiding military operations, ultimately leading to what it termed a "decisive act

of self-defence and victory." In its concluding remarks, the Embassy appealed to Indian journalists to resist being drawn into external propaganda and instead help "strengthen the historical ties of friendship and mutual respect between the peoples of two great civilizational-states.'



Hunger Must Never Be A 'Weapon Of War': UN Chief

ADDIS ABABA: United Nations chief Antonio Guterres urged the international community on Monday to reject hunger as a weapon of war.

UN agencies have been warning of life-threatening hunger in Gaza as aid supplies dried up, and international pressure has been building for a ceasefire to allow a massive relief operation.

Israel's government, under Prime Minister Benjamin Netanyahu, furiously denies that it is using hunger as a weapon of war, and instead accuses the aid agencies of failing to pick up and distribute aid delivered to Gaza's border crossing points.

"Climate change is dis-

humanitarand ian aid. Conflict continues to spread hunger from Gaza to Sudan and beyond," Guterres told a UN conference in Ethiopia by video.

"Hunger fuels instability and undermines peace. We must never accept hunger as a weapon of war," the UN chief added said.

In the Gaza Strip, the war-shattered Palestinian territory is gripped by dire humanitarian conditions created by 21 months of war and made worse by Israel's total blockade of aid from March to May.

Since the easing of the blockade, the levels of aid reaching Gaza have been far below what aid groups say is needed.

On Sunday, as Israel

the fighting to allow the UN and aid agencies to tackle a deepening hunger crisis, the World Health Organization warned that malnutrition was reaching "alarming levels."

Sudan is "the largest humanitarian catastrophe facing our world and also the least remembered", Othman Belbeisi, the regional director of UN's IOM migration agency, told reporters last week.

Corbyn and Sultana's New Party Surges Past 400,000 Sign-Ups

> London — Over 400,000 people have already signed up to join the new political party launched by Jeremy Corbyn and Zarah Sultana — a figure that surpasses the membership of any existing British party.

While the demand for a left-wing alternative to Labour has long been evident, even supporters of the new party did not anticipate such an overwneiming response.

The surge underscores a critical reality: Labour's rightward shift under Keir Starmer, since 2020, has alienated vast swathes of the left. Starmer, elected on a platform promising continuity with the Corbyn years, has instead presided over a crackdown on internal democracy through expulsions, suspensions, and bans on discussion — actions that have driven many members away.

Critics who accuse the new party of splitting the left must confront an inconvenient truth: this movement didn't set out to rival Labour it was born from exclusion.

Those behind the initiative only decided to run candidates against Labour after being pushed out of it. If Labour now faces a challenge from the left, the blame lies squarely with Starmer's leadership.

Importantly, the excitement around Corbyn's new project challenges the narrative that Labour's socialist phase was a political misstep. While party officials often cite two electoral defeats to dismiss Corbynism, they overlook the massive rise in Labour's vote between 2015 and 2017 - and that the 2019 election still saw Corbyn win more votes than Starmer ever has.

The Corbyn era mobilised hundreds of thousands of activists and brought millions to the Labour fold by channelling widespread disillusionment with decades of political consensus - marked by privatisation, deregulation, and deindustrialisation. That discontent remains potent today, as evidenced by the crumbling support for both Labour and the Conservatives.

While these frustrations are not always expressed in traditionally left-wing terms — as seen in the rise of Re-

form UK — they stem from rejection of the same neoliberal legacy. The systematic sidelining of socialism within Labour has not reflected a public shift, but rather a top-down suppression. Given a new platform, the left could regain national traction and even exert pressure on Labour from the outside.

That said, building a viable new party will be challenging. Polls suggest it could attract significant votes, but not yet shake Reform's dominance. Learning from Labour's success in 2017 and avoiding the pitfalls of 2019 including internal factionalism and insularity — will be crucial. Simply rerunning the Corbyn project from 2015–19 is unlikely to succeed.

Nonetheless, this is a powerful beginning. In a political climate marked by growing authoritarianism, and bipartisan complicity in foreign atrocities, a mass left movement could be vital in reviving the causes of public ownership, redistribution, and social justice. No genuine socialist can ignore this moment. -IPA

Saudi Forces Arrest Egyptian Pilgrim For Raising Palestinian Flag In Mecca

Riyadh: Saudi forces detained an Egyptian pilgrim in the holy city of Mecca for raising the Palestinian flag and protesting the Israeli-imposed siege and starvation in Gaza.

Video footage circulated online shows a man exclaiming "Wa Islamah!" – a phrase historically employed to convey distress when Islam or Muslims face peril, as he urgently appeals for assistance for the starving people of Gaza near the Ka'aba, a cubeshaped shrine that Muslims face when they pray.

The poignant scene, recorded and shared on social media, shows the pilgrim stating, "The children of Gaza are dying. O Muslims!'

A few seconds later, Saudi officers show up and detain him inside the mosque.

The incident has triggered widespread condemnation and reignited debate over Saudi Arabia's strict bans on political expression at Islam's holiest sites.

Authorities ban all slogans and symbols, including national flags, during Hajj and Umrah, asserting that these measures safeguard the sanctity of worship.

Nonetheless, critics argue that the kingdom employs these limitations to hinder support for Palestine and to silence expressions of Muslim solidarity.

In 2023, a British pilgrim was arrested for donning a white keffiyeh and a prayer bead in the colors of Palestine.

Apart from Mecca, Saudi officials have purportedly initiated a wider campaign against citizens who express criticism of Israel or show support for Gaza online.

Contraband Worth Rs 390 Crore Seized As Mumbai Cops Bust **Mephedrone Racket**

Mumbai :Mumbai police have seized more than 187 kilograms mephedrone worth Rs 382 crore following a raid in Mysuru in neighbouring Karnataka, leading to the arrest of four persons, a top official said on Monday. The probe into the case

began in April this year after a man was held with 52 grams of mephedrone in Sakinaka in western Mumbai, and his interrogation led police to three more persons, from whom 4.53 kg mephedrone worth Rs 8 crore was recovered, he said.

Further probe into this racket led to the arrest of Salim Imtiyaaz Sheikh alias Salim Langda (45) from Bandra Reclamation on July 25, Deputy Commissioner of Police (Zone 10) Datta Nalawade said.

"He led police to a struc-

ture along Ring Road in Mysuru, which looked like a hotel and garage from the front side. However, on entering it, we found a mephedrone manufacturing unit. The contraband from here was being supplied to Mumbai and adjoining districts. In all, we have arrested eight persons and seized 192 kilograms of mephedrone worth Rs 390 crore," the DCP said.

The operation in Mysuru took place on July 26, leading to the arrest of three more persons besides Sheikh, he said. "It is a big chain and more

arrests are likely. We are also verifying where they got the formula to manufacture mephedrone. The eight persons held so far, five of whom are from Mumbai, have been charged under the Narcotic Drugs and Psychotropic Substances Act," Nalawade said.

'Dog Babu' Gets Residence Certificate in Bihar as 77 Lakh Voters Vanish

rinagar: In a bizarre twist that has triggered outrage political circles, a residential certificate bearing the photo and name of a dog has reportedly been issued by government authorities in Bihar even as lakhs of genuine voters are allegedly being struck off the electoral rolls during the ongoing Special Intensive Revision (SIR).

The certificate, issued in the name "Dog Babu" from Kaulichak Ward 15. Masaurhi block of Patna district, includes further absurdities: the father's name is listed as "Kutta Babu," and the mother as "Kutiya Devi." The document appears to have been officially generated through the state's Right to Public Services (RTPS) portal and bears the signature of Rev-



enue Officer Murari Chauhan.

Congress leader Supriya Shrinate shared the image of the certificate on social media, questioning the credibility of governance and voter data integrity. The authenticity of the document has not been independently verified by The Telegraph Online.

The incident comes at a time when

the Election Commission is under fire for allegedly removing over 77 lakh legitimate voters — many of whom reportedly possess valid identity documents like Aadhaar, Voter ID (EPIC), ration cards, and PAN.

"All this while a dog named 'Dog Babu', son of 'Kutta Babu' & 'Kutiya Devi', has been granted residence. What are we witnessing — governance or grotesque theatre?" said Nilanjan Das, State General Secretary of the Trinamool Congress's IT & Social Media Wing.

Opposition parties are accusing the BJP-led NDA government of using bureaucratic manipulation to erase voters selectively and compromise the democratic process ahead of elections.

As calls grow for a thorough investigation, the Election Commission and Bihar government have yet to respond to the controversy.

Renovation Work Begins At Dilip Kumar, Raj Kapoor's Houses In Pakistan

Car Involved In Attempt To Murder Case Seized: Police

JAMMU: Jammu Police on Monday seized a Mahindra Thar, involved in an attempt to murder case in Gandhi Nagar area of Jammu, while a massive manhunt was launched to nab the accused driver.

As per officials, the incident, which has been classified as an attempt to murder, was caught on CCTV cameras, has raised serious concerns about road safety and reckless driving in the region.

Speaking to media, Superintendent of police SP Jammu South Ajay Sharma as per KNO said that the Mahindra Thar JK02DP-9594 allegedly struck an elderly pedestrian in Gandhi Nagar, Jammu has been seized while the driver, who was identified as Manan Aanad managed to flee the scene.

"As per the video, the driver deliberately hit the victim, seriously injuring him and fled the scene, shows the intent of crime," the officer said, adding, "The incident has been registered as a case of attempt to murder under relevant sections of the BNS at Police Station Gandhi Nagar. The vehicle has been seized and a manhunt launched to nab the culprit," he said.

Moreover, the elderly victim, who rushed to medical care, has been receiving treatment at Government Medical College and Hospital Jammu, though his condition remains critical due to head injury.

Preliminary investigations suggest the driver acted with malicious intent, prompting the police to treat the case with utmost seriousness.

Addressing the Gandhi Nagar Police Station, SP South Ajay Sharma emphasized the police's resolve to bring the culprit to justice: "This is a heinous act of violence against a defenseless elderly person. The driver of the Thar vehicle, bearing registration number JK02DP 9594, not only endangered a life but also fled the scene, showing complete disregard for the law. We have registered a case of attempt to murder and are employing all available resources, including CCTV analysis and witness statements, to apprehend the accused. The Jammu Police will leave no stone unturned to ensure justice is served.'

Local MLA Bahu Vikram Randhawa also visited GMC Jammu to enquire about the health of the victim.

Expressing concern over an attempted murder case reported in Jammu's Gandhi Nagar. Randhawa condemned the violent act and urged police to nab the culprit as soon as possible and punish as per law.

Four Arrested in Revenue Fraud Case

SRINAGAR: The Economic Offences Wing of the Crime Branch Kashmir on Monday announced the arrest of four individuals in connection with a major corruption case involving cheating, false mutations, and fraudulent insertions in official revenue records. The case, registered under FIR No. 14/2025, has implicated seven individuals, including two revenue officials, for their alleged involvement in a criminal conspiracy that defrauded landowners in both Srinagar and Budgam districts.

According to a statement issued by the Crime Branch Kashmir, a thorough investigation based on credible evidence led to the arrest of four of the seven accused. The case is being investigated under sections 167, 420, and 120-B of the Ranbir Penal Code, read with section 5(2) of the Jammu and Kashmir Prevention of Corruption Act, Syt. 2006.

The arrested individuals have been identified as Riyaz Ahmad Bhat, son of Ghulam Mohammad Bhat, a resident of Nowgam Srinagar; Mohammad Shafi Lone alias Shaff Cheeni, son of Abdul Ahad Lone, resident of Peerbagh Srinagar; Shahnawaz Ahmad Rather, son of Noor Mohammad Rather, resident of Padshahi Bagh Srinagar; and Shabir Ahmad Wani, son of Mohammad Ismail Wani, resident of Bagandar Lasjan.

The accused were reportedly part of an organised group

that tampered with official land records, facilitating false ownership claims and illegal property transfers. Officials say the fraudulent activities caused significant financial loss and distress to innocent individuals, many of whom were unaware their property rights were being manipulated.

Among the three absconding accused is a serving Tehsildar, Ms. Nusrat Aziz, daughter of Abdul Aziz Lone, a resident of Gurez currently residing at Mehjoor Nagar in Srinagar. Notably, her bail plea was rejected by the Hon'ble Court of the Anti-Corruption Judge in Srinagar. She remains on the run and is also implicated in four other FIRs, two registered with the Crime Branch, Kashmir, and two with the Anti-Corruption Bureau (ACB), Kashmir.

The other two accused who are evading arrest include Ashiq Ali, son of Ghulam Rasool Khan, a resident of Panner Jagir currently living in Hawal Srinagar, who served as the then Patwari of Balhama Srinagar; and Shamima Akhter, wife of Mohammad Shafi Lone, a resident of Gooripora Rawalpora.

Crime Branch officials confirmed that efforts are underway to apprehend the remaining accused as per the law. The investigation continues, with authorities determined to dismantle the network and ensure accountability in what is being viewed as one of the more serious recent cases of systemic corruption in the revenue department.

here, Mehbooba recalled the vision of her late father and party founder, Mufti Mohammad Sayeed, saying the PDP has always stood for peace through dialogue and political engagement.

She urged PM Modi to "shift away from the militarised policy" in J&K, saying, "If anyone has the power to resolve Jammu and Kashmir's issue, it is PM Modi. He has got the mandate of over 120 crore people."

Mufti stressed the PDP's core belief in political dialogue, saying, "We

never compromised on our belief that only political engagement can bring lasting peace."

Criticising the Centre's heavy reliance on security forces in Kashmir, she said, "They keep sending more CRPF companies to Kashmir. But how much security will you deploy?

Will that solve anything? You can't win hearts with guns and bunkers."

She raised concerns about India's growing military spending, pointing to inequality in basic services. "We are spending billions on weapons while schools

in many parts of the country don't even have clean drinking water or toilete." she said

toilets," she said.
On India's foreign policy approach, the PDP chief said, "What is India's foreign policy without addressing Jammu and Kashmir? What have we achieved from decades of hostility? Pakistan invested in weapons, and India turned Kashmir into a heavily militarised zone. Meanwhile, China surged ahead economically. Even our own External Affairs Minister has acknowledged this reality."

The Growing Drug Crisis

t a time when the law and order in Jammu and Kashmir has changed for the better, J&K is battling another crisis: drug abuse. The numbers speak for themselves. According to media reports, since 2018, over 1.12 lakh kilograms of narcotics have been seized. The number of people arrested under the Narcotic Drugs and Psychotropic Substances (NDPS) Act has crossed 10,000. And still, the crisis continues to grow, often hidden in plain sight, in homes, in schools, and increasingly, in graveyards. The 17 suicides linked to substance abuse since 2018 may be only the tip of the iceberg.

The data presented in Parliament this week by the Minister of State for Home Affairs, Nityanand Rai, confirms what many on the ground have long feared: drug trafficking, illegal cultivation of poppy and cannabis, and substance abuse have taken root in alarming ways. The year 2020, for instance, saw over 27,000 kg of drugs and 40,000 litres of liquid narcotics seized, according to the data from the National Crime Records Bureau (NCRB). This is a chilling peak that exposes the scale of the underworld economy feeding off Kashmir's vulnerabilities.

In recent years, the J&K Police and other agencies have stepped up their crackdown destroying illegal crops, with 1,000 acres cleared in 2024 alone. They have seized consignments, and arrested offenders, f 1,460 in 2018 and now 3,453 in 2022, reflecting the seriousness of the situation and the state's growing response.

Yet enforcement alone is not enough. Addiction is not just a law and order issue; it's a public health emergency. The fact that more than 83.000 people have undergone treatment at de-addiction centres since 2020, and nearly 9,400 at the IMHANS Kashmir clinic alone, is both a sign of progress and a stark reminder of the scale of the crisis.

The reasons for this surge are many, psychological trauma, unemployment, peer pressure, easy availability of drugs, and porous borders. But unless there is a wholeof-society approach with schools, religious leaders, local communities, parents, and youth themselves involved, the problem will continue to fester.

The government's efforts are visible, but a stronger response is needed. We must treat drug dependence as a disease, not a crime. We should aim for rehabilitation, not just punishment, and education, not just enforcement.

For Kashmir, long scarred by conflict, the drug menace poses a different kind of threat. In fighting this battle, we cannot afford to lose another generation.

Kashmir's Urban Health Crisis Has Arrived

The signs are everywhere: diabetes in the young, sleepless nights, rising temperatures, and stress.

here was a time when moving to the city meant you had made it.

City life in Kashmir once held the promise of modernity: better jobs, quicker access to services, and brighter futures for children.

For many families from remote districts, settling in towns like Srinagar, Anantnag, Baramulla, or Sopore was a symbol of upward mobility.

Today, that promise feels more like a pressure.

The charm is fading under layers of smog, concrete, and chronic stress. Our cities, though full of ambition, are now draining us.

Urban stress - the unseen weight of noise, pollution, overcrowding, and social disconnection - is no longer a theory. It's a growing health crisis.

In Srinagar, the city where I serve as a public health officer, the signs are clear.

PM2.5 levels, those fine inhalable particles that settle deep into our lungs, often exceed the safety limits defined by the World Health Organization.

In peak winter, when people burn wood and trash for heat, the air becomes dense and dangerous. According to the Jammu and Kashmir Pollution Control Committee's 2022 report, several localities in Srinagar recorded winter air pollution at nearly 200 micrograms per cubic meter, four times the safe threshold.

This bad air worsens respiratory issues.

In my clinic, I see a steady rise in cases of childhood asthma, chronic bronchitis, and sinusitis, especially during winter inversion days, when pollutants get trapped close to the ground.

high-density Patients from neighbourhoods like Batamaloo, Nowhatta, and Qamarwari often come in with recurring throat and chest infections.

Noise, too, is a daily invader. From early morning construction drills to late-night traffic snarls, our cities hum at a pitch that leaves no room for rest. In a 2023 health behaviour sur-

vey across Srinagar, Pulwama, and Ganderbal, nearly 6 in 10 respondents reported difficulty sleeping

Sleep, though underrated, is the foundation of health. When disturbed regularly, it leads to poor immunity, irritability, anxiety, and even metabolic disorders.

Urban heat is another silent hazard. Cities like Srinagar now record

higher summer temperatures than ever before. This July was one of the hottest months in two decades, with temperatures crossing 34°C. But heat isn't evenly felt.

In areas with fewer trees and more asphalt, like Hyderpora or Bemina, the "urban heat island" effect makes outdoor life unbearable.

In this month alone, SMHS and SKIMS hospitals received over 900 cases of heat-related fatigue and dehydration.

These environmental triggers intersect with lifestyle patterns that urban life encourages but rarely supports. Fast food chains and sugar-laden snacks fill the gaps left by long commutes and erratic work hours. Affordable fresh produce is hard to come by in many parts of the city.

A recent nutrition audit conducted by the Directorate of Health Services found that 34% of urban residents in Kashmir had poor dietary diversity, eating fewer than three food groups per day.

our bloodwork.

Hypertension, type 2 diabetes, fatty liver, and early-onset obesity are no longer "elderly diseases. Among people aged 25–45 in urban Kashmir, nearly one in four now shows early symptoms of a noncommunicable disease.

Sedentary routines, stress, and poor diets are a deadly mix. Many

people drive or take autos even for short distances due to poor pedestrian pathways and unsafe streets.

The average daily step count, based on a pilot study using fitness trackers in downtown Srinagar, was a meager 3,500, far below the recommended 10,000

Beyond the body, urban stress eats away at the mind.

In fast-growing cities, community structures thin out. Extended families are split across apartments. Children grow up with more screens and fewer conversations.

In a 2023 report by the Mental Health Services Cell of J&K, urban youth in Kashmir were found to be twice as likely as rural youth to report symptoms of anxiety, loneliness, and low mood. Working professionals, espe-

cially women juggling domestic responsibilities and office pressure, show rising levels of burnout. Therapy remains out of reach for most. Stigma adds to the isolation.

City planning doesn't help. Srinagar, despite being a capital city, has fewer than 50 officially maintained parks for a population of over 1.2 million.

That's less than 2 square meters of green space per person, well below the WHO's suggested minimum of 9.

In many colonies, even footpaths are missing. There are no designated cycling lanes, shaded

waiting zones, or noise barriers along main roads.

The city is expanding, but it isn't healing.

So how do we fix this?

We must start with urban design that puts people, not just property, at the center. Cities need breathable streets, lined with trees and flanked by wide pavements.

Planners must ensure every neighbourhood has access to a park within 10 minutes of walking. They must allot more space for non-motorized transport, build cycling tracks, pedestrian crossings, and car-free zones, especially near schools and hospitals.

Air quality monitors should be made public and real-time. The administration should ban open waste burning, incentivize solar panels and clean cooking fuel, encourage rooftop gardens and vertical greenery, and create awareness campaigns around noise hygiene. Simple rules like silent zones near clinics and schools can go a long way.

We also need to promote emotional health. Urban schools can introduce mindfulness activities. Public libraries, community halls, and shared playgrounds should be revived as safe, inclusive spaces. Local NGOs and health workers must work together to normalize conversations around mental health and create accessible referral systems for counseling and psychiatric care.

Diet is another frontier. We must promote weekly farmers' markets in cities, and introduce healthy food carts that offer local, affordable alternatives to junk food. ASHA workers and mohalla committees should be trained in basic nutrition counseling. We need to start urban farming drives in schools and housing societies.

All of this requires vision,

Kashmir's Silent Recession Is a Wake-Up Call

or decades now, the economy of Kashmir has been falling apart. Discord has been the backdrop, but the decline is deeper, more structural. It's visible in fading industries,

scattered families, jobless youth, and the growing emptiness in markets once filled with chatter.

Economic downfall here isn't just about falling numbers. It's a slow erosion of hope

Kashmir's gross domestic product has suffered repeated blows. A report pegged the economic losses at 15 lakh crore by 2015. Then came 2019. The abrogation of Article 370 was followed by a prolonged shutdown. The Kashmir Chamber of Commerce & Industry estimated that over 18,000 crore was lost in just four months.

Tourism tanked, trade froze, investors pulled out, and the internet disappeared.

The cost wasn't just financial. Students lost months of online learning. Young entrepreneurs running digital businesses folded. Families couldn't reach doctors over telemedicine. For a UPSC aspirant in downtown Srinagar, the blackout meant missing lectures, updates, and a critical study window.

Unemployment continues to crush the youth even today. According to the Centre for Monitoring Indian Economy (CMIE), Jammu and Kashmir's unemployment rate has often ranked among the highest in the country. Many of the unemployed are highly educated: engineers, postgraduates, even PhDs. With few opportunities, thousands migrate each vear. Some never return. This steady brain drain is

weakening the backbone of Kashmir's future.

The private sector, which drives most modern economies, is almost non-existent here. Fear of violence, lack of investor confidence, and policy confusion have kept companies away. Local businesses struggle without access to capital or markets. Startups rarely survive.

The private sector hasn't failed in Kashmir. It hasn't been given a

Tourism, once a dependable source of seasonal employment, is barely hanging on. Terror attacks, such as the recent one in Pahalgam, have spooked tourists and widened the trust gap. For shikara operators on Dal Lake or houseboat owners in Nigeen, bookings are no longer predictable. Entire towns dependent on tourism see only occasional spikes, never stability. Handicrafts tell another sad sto-

ry. Pashmina shawls, walnut woodwork, papier-mâché art are heritage. Yet, many artisans are abandoning their craft. Demand has dropped, middlemen exploit profits, and young generations are choosing labour work over looms.

Education should be the great equalizer, but in Kashmir, it's stuck in another era. Classrooms teach outdated content. Exams reward rote learning, not skills. Meanwhile, the rest of India races ahead with coding bootcamps, digital marketing institutes, and startup accelerators. Here, a student can graduate with top marks and still be unprepared for a basic job interview.

The 2019 promise was economic revival. After Article 370 was revoked, the central government spoke of big investments and development. Some road and tunnel projects have come up, but private sector energy remains missing. The bureaucracy moves slowly. Local entrepreneurs feel cut out. The big promises remain mostly on paper.

So what can turn the tide?

First, Kashmir needs to stop relying only on government jobs. A serious investment in skill-based education is essential: coding, design, content, agriculture tech, crafts innovation. It should start in schools and scale in colleges.

Second, the private sector must be nurtured. Offer tax incentives, build startup incubators, and ensure security for businesses. If peace talks remain stalled, at least economic planning shouldn't be.

Third, traditional sectors like handicrafts and tourism should be given global marketing support and fair pricing policies. They are cultural assets waiting for modern platforms.

Finally, the government must earn back trust. Real consultation with local business leaders, educators, artisans, and youth is the only way forward. People want to build. They just need to believe they're part of the future.

Restoring Kashmir's economy isn't only about numbers. It's about dignity.

The Man Who Made Kashmir Laugh

He turned pain into punchlines, sorrow into satire. Now, with Bashir Kotur gone, Kashmir mourns a voice that made it feel whole.

ays before he died, Bashir Kotur looked straight into the camera and flashed his signature angry expressions.

False rumours of his death were swirling online. People were already posting tributes. But Bashir, ever the showman, responded the only way he knew how: with a line sharp enough to pierce grief and absurd enough to go viral. "Don't bury me before my time," he said, wrapped in a pheran, his smile worn but intact.

That was his final performance. On Monday morning, in his modest home in Hanji Gund, Budgam, Bashir Ahmad Bhat, better known across Kashmir as Bashir Kotur, passed away. He was 65.

His death marks the end of an era, not just for Kashmiri comedy, but for a way of telling truth through laughter, a way of resisting despair with disguise.

For nearly two decades, Kotur's face flickered across local cable TV screens. His brand of streetwise comedy became a household ritual, one of the few sources of collective joy in a region fractured by violence and uncertainty.

He was never formally trained in performance, yet he could command a room like few others. His jokes were unscripted, his timing flawless, his satire piercing.

"He made us laugh when nothing else did," said Faheem Dar, a Srinagar-based videographer who grew up watching Kotur's shows. "He wasn't just funny, he made pain easier to live with."

Kotur's sketches, often alongside fellow comedians like Gulzar Fighter and Seth Rafi, were lo-fi productions. Shot with handheld cameras, staged in liv-

ing rooms, draped with floral bedsheets as backdrops, they rarely ran for more than 10 minutes. But they ran deep.

Kotur played everything from corrupt bureaucrats to clueless husbands, each character shaped by the quirks of everyday Kash-

"He turned our relatives into comic roles," Dar said. "You'd watch and say, 'That's my uncle!" And in doing so, Kotur did something re-

markable: he made laughter part of the language of survival.

Born in Hanji Pora Wathora, a hamlet in Budgam district, Bashir was a school dropout. By age 12, he had already discovered a gift for

His heroes weren't film stars or singers. They were Bandh-e-Pather performers: folk satirists who wandered from village to village performing political and social skits that mixed mockery with music.

He came from a long line of these performers. "Seven generations," he'd proudly say. At 17, he joined the National Bandh The-

atre, led by Ghulam Ali Majboor, and trained in folk acting, verse, and physical comedy. He spent hours learning a traditional water-

balancing dance, once breaking a dozen glasses during practice. His response was a shrug and a smile. "I broke a few things," he later joked. "But mostly, I broke people into laughter."
In the early 2000s, as Kashmir reeled from a decade of conflict and curfews, a new me-

dium emerged: local cable TV. It was raw and largely unregulated.

And it gave Bashir Kotur his stage.

His characters, flawed and strangely lovable, became amusing. Schoolboys mimicked his catchphrases. Grandmothers waited for his shows. Shopkeepers played his lines on loop in their stalls.

There was hardly any makeup team or scriptwriters. It was just Bashir, and the life he had watched unfold around him. Comedy, he said, came straight from the

"You just need to listen," he told a friend once. "The jokes are already there, at the ration depot, in the bus, at the bank.

Despite his fame, Kotur never found financial security.

BASHIR KOTUR BELIEVED THAT HUMOUR DIDN'T **MOCK PEOPLE,** it embraced them. "You laugh with people," he used to say, "not at them."

There were no rerun fees, state support, and artist pensions. As cable TV shrank and internet platforms took over, the stage disappeared. He opened a small grocery shop in his village to make ends meet. Even there, he kept performing, cracking jokes with customers, mimicking them as they bought rice or soap.

"I turned the counter into a comedy club," he'd say, only half-joking.

But his health began to falter.

In March 2022, a road accident shattered his arm. The injury didn't heal. He was in and out of hospitals. Then came a chronic illness. His voice grew weaker. His spark dulled.

In one of his final video appeals, watched thousands of times online, he had lost his wit to worry: "I want to live. I want to make you laugh again."

Donations poured in, fans rallied, and artists wrote tributes. But no government agency stepped forward and no cultural institution offered help.

Bashir had spent a lifetime making Kashmir laugh. When he needed the valley's insti-

tutions, they went silent. "He was left to die a legend, but in pover-

ty," said poet and activist Akeel Ahmad. "Like so many Kashmiri artists."

At his funeral in Hanji Gund, dozens gathered: neighbours, young fans, old col-

laborators. Some cried, others passed around phones, showing each other their favourite

"Watch this," one man said, replaying Kotur's famous sketch as a music teacher who couldn't hold a tune.

"He was our Charlie Chaplin," someone whispered. "But from Budgam." His art was local, but his timing universal.

His laughter didn't ignore the pain. It leaned into it, then turned it around.

Bashir believed that humour didn't mock people, it embraced them. "You laugh with people," he used to say, "not at them." And now, the satirist has left the stage. But

somewhere, in a dimly lit home where memories run deep, Bashir Kotur is being remembered for his presence: "He was Kashmir's laughter in the age of lockdowns."

ack in 1975, when most homes didn't even have colour TVs, and mobile phones were a distant dream, Sholay exploded onto the big screen like a cinematic thunderstorm. Half a century later, the fire hasn't gone out.

The timeless flick is a full-blown blockbuster lesson in filmmaking. Sholay had it all - action, drama, friendship, revenge, love, dacoits, unforgettable dialogues - and still does.

Even today, it grips new fans the way it did generations ago. That's the kind of magic only Sholay

The film moves at breakneck speed, contributing to its turbulent and gripping narrative. Every scene is meticulously placed, creating a seamless cinematic experience that keeps viewers at the edge of their seats.

There's nothing superfluous, everything fits perfectly. Modern cinema still struggles to match Sholay's impact. It has set a benchmark that remains diffi-

As the film celebrates its golden jubilee, it transcends being merely a commercial hit. It has become a cultural touchstone.

While a week may be a long time in politics, Sholay's appeal remains unchanged even after fifty years. Ramesh Sippy crafted what could be called a cinematic multiverse long before the term was popu-

larized. Here's why it continues to resonate. The legendary friendship between Jai and Veeru is iconic. Thakur represents vengeance cloaked in restrained wrath. Gabbar Singh is pure evil, unapologetically so, offering no sympathy and expecting none in return.



If Hollywood had spaghetti Westerns, Sholay gave us the quintessential curry Western. From Jai gunning down bandits on horseback to Veeru hurling flaming coals from a leaking barrel of oil, the action still feels exhilarating.

Sholay cracked the code of film marketing long before it became a formal discipline. In many ways, it is an institution in branding.

Revisiting it isn't nostalgia. It's proof of what Indian cinema can achieve when every department delivers at its peak. At home and abroad, Sholay resonates with ev-

It is a living emblem of Indian cinema's soft power. Comparisons have been made with The Magnificent Seven in Hollywood or Kaala Sona in India, but

none hold up. Sholay exported emotion, and when emotion is done right, it outlives every trend.

Ali Emran and the Rise of a **New Kashmiri Cinema**

n a modest Srinagar neighborhood not far from the bustle of Lal Chowk, a Kashmiri filmmaker is building a cinematic universe.

Ali Emran, 42, doesn't chase fame. He seeks something else: meaning. And in a region like Kashmir, where art often wrestles with history, iden-

tity, and silence, meaning matters.

Emran's films feel like they remember. They remember the weight of tradition, the softness of spiritual longing, and the wounds that remain just beneath the skin of everyday life. His stories are shaped by Kashmir, but they speak far beyond it, to anyone who has ever searched for selfhood in a world that often denies it.

In 2006, when Emran released his first short film, The Ninth Act, the idea of a Kashmiri making independent films felt distant.

The film was experimental, unsettling, and full of questions. That was the point.

Since then, his work has moved through genres and languages, from mystical fiction to documentary, from Kashmiri to Urdu, but his preoccupations have remained constant: the soul, the self, and the society around it. Last year, he made history.

On October 4, 2024, Emran's feature film Qouluf: The Ensorcelled became the first Kashmiri-language film to screen in a local cinema hall in more than sixty years.

The screening, held at Inox Srinagar, drew diverse audiences: young cinephiles, old-school artists, students of literature, and even those who had never seen a Kashmiri film on the big screen.

"People cried," Emran recalled. "They heard their mother tongue in a dark theatre and it felt like coming home."

Qouluf went on to screen at the Kolkata International Film Festival and the India Habitat Centre Film Festival in New Delhi. It drew praise for its layered storytelling and cinematic lyricism.

Shot across the highlands of Gurez and the narrow lanes of old Srinagar, the film blends the mystical with the philosophical aspect of Kashmir.

Before Qouluf, Emran had already turned heads with Ibtida (The Beginning), a bold Urdu-language adaptation of Ayn Rand's The Fountainhead.

In the film, he transplants Rand's ideas of creative integrity and defiance into a Kashmiri setting, asking what it means to remain true to art in a place so often shaped by semblance and strife.

The film sparked discussion in academic circles and theatre workshops

His 2025 documentary Baand: The Musical Journey of an Artist is perhaps his most tender film to date.

It traces the journey of a performer of Baand-e-Pather, Kashmir's traditional folk theatre, which once thrived in rural gatherings but now teeters on the edge of disappearance.

With music, oral stories, and sweeping visuals, Emran draws attention to a heritage at risk, and the artists who carry it in their bones.

These stories matter in a region where language and identity have long been entangled with politics and power. Kashmir has more than 7 million people, most of whom speak Kashmiri at home, yet the language remains missing from schools and public life.

Emran's work insists on reclaiming that space through cinema.

His smaller works are no less ambitious. In Tasavuf, he explores Kashmir's deep Sufi tradition. In Know Me, he reflects on the gap between the self and how the world sees it. In Baand-e-Jashn, he revisits moments of joy from a disappearing cultural archive.

Beyond film, Emran has left a mark on Kashmir's theatre scene. His stage production Dream Sellers was choreographed as a movement-based critique of consumerism and lost dreams. His adaptations of Agha Shahid Ali's The Country Without a Post Office and Saadat Hasan Manto's Toba Tek Singh brought literary grief and absurdity to Kashmiri stages with renewed urgency.

Now, Emran is reaching into the past to tell stories about faith and myth. He's working on two upcoming documentaries: Jesus & Kashmir, which examines local legends and forgotten manuscripts linking Jesus's lost years to Kashmir, and End Time Priest-King, a study of pre-Islamic Kashmiri spiritual traditions and their influence on modern identity.

Each project draws from years of personal research, travel, and interviews.

He often jokes that he's partfilmmaker, part-monk. Those who know him say he listens more than he speaks, often scribbling thoughts into a black notebook he's carried for

His films are not fast. They unfold, allow silence to speak, and do what few South Asian films attempt: they give the audience time to feel, wonder, and remember.

The Indian independent film scene is still catching up to what directors like Emran have been doing for years, making meaningful cinema without budgets, stars, or studio backing.

Yet the tide is slowly shifting. Streaming platforms have opened new windows. Film festivals are more curious about regional voices. There's now a conversation around cinema that embraces complexity over gloss.

In this evolving landscape, Emran's voice stands out not only because it's rare, but because it's rooted. His work reminds audiences that

Kashmir is not just a backdrop for conflict, but a world of philosophy, aesthetics, and inner life.

He is often asked why he doesn't move to Mumbai or Delhi. "Because my stories are here," he replies.

For Emran, filmmaking is a form of devotion. His camera is less about spectacle and more about search for beauty, meaning, and a place in a world that often feels fragmented.

In doing so, Ali Emran has become more than a filmmaker. He is, in his own words, "a witness to wonder." And from Srinagar, that wonder

Walking 7,000 Steps Daily May Cut Dementia Risk By 38%: Study

locking in 7,000 steps a day could lower overall death risk by 47 per cent, dementia by 38 per cent, and depression by 22 per cent, a new study published in The Lancet Public Health has claimed.

The analysis of data from 88 studies published between 2014 and 2025, involving 1.6 lakh adults, is the first to comprehensively assess how steps taken daily can help keep numerous health conditions at bay -- unlike previous research that mainly focused on heart health or overall death rates, researchers said.

The study team included researchers from the University of Sydney, among other institutes in Australia, the UK, Spain, and Norway.

Walking 7,000 steps daily was also associated with a six per cent lower chance of developing cancer, and was seen to reduce the chance of developing heart disease by 25 per cent, diabetes by 14 per cent, and of suffering a fall by 28 per cent, compared to taking 2,000 steps daily.

The authors highlighted that targeting 7,000 steps per day may be more realistic, compared to the current unofficial 10,000 steps per day -- especially for the less active -- and can still provide significant improvements in health.



They, however, cautioned that evidence for conditions, such as cancer and dementia, was supported by a small number of studies, which meant a lower level of certainty for

Many studies also did not account for factors, including age and frailty, which can introduce a bias in the study's findings, the team said.

They authors wrote, "Compared with 2,000 steps per day, 7,000 steps per day was associated with a 47 per cent lower risk of all-cause mortality, a 25 per cent lower risk

of cardiovascular disease incidence, a 47 per cent lower risk of cardiovascular disease mortality, a non-significant six per cent lower risk of cancer incidence, a 37 per cent lower risk of cancer mortality, a 14 per cent lower risk of type 2 diabetes, a 38 per cent lower risk of dementia, a 22 per cent lower risk of depressive symptoms, and a 28 per cent low-er risk of falls." They added, "The evidence certainty was moderate for all outcomes except for cardiovascular disease mortality (low), cancer incidence (low), physical function (low), and falls (very low).

Study Estimates Over 9 Of World's Lands At High Risk Of Animal-To-Human Infections

ver nine per cent of the world's land area is at high" or "very high" risk of a zoonotic outbreak -- triggered when an infection spreads from an animal to a human or vice versa, such as the Covid pandemic, according to a study.

Findings published in the journal Science Advances also estimate 3 per cent of the global population to be living in extremely risky areas, and about a fifth in medium-risk areas.

including Researchers, those from the European Commission's Joint Research Centre (JRC) Scientific Development Programmes Unit in Italy, analysed location-specific information from the 'Global Infectious Diseases and Epidemiology Network' dataset and the World Health Organization's (WHO) list of diseases prioritised according to their potential for causing an epidemic or a pandemic.

Covid, Ebola, coronavirusrelated MERS and SARS, and Nipah are among the most prioritised infections in the WHO's list.

The team's analysis suggests that conditions driven by climate change -- higher temperatures and rainfall, and water shortage -- elevate the risk of zoonosis, or 'spillover events'.

The study "presents a global risk map and an epidemic risk index that combines countries' specific risk with their capacities for preparing and responding to zoonotic threats (excluding SARS-CoV-2)."

"Our results indicate that 9.3 per cent of the global land surface is at high (6.3 per cent) or very high (three per cent) risk," the authors wrote.

They also estimated about 7 per cent of Asia's and 5 per cent of Africa's land area to be at high and very high risk of outbreak, following Latin America (27 per cent) and Oceania (18.6 per cent).

Overall, the authors found

that climate-related changes to the environment substantially drove a region's vulnerability to the risk of a spillover event.

They wrote, "This underscores the need for continued monitoring and the integration of climate adaptation and mitigation efforts into public health planning.'

"Translating these risk estimates into an epidemic risk index allows for the identification of high-risk areas and supports policymakers in improving response capacities, allocating resources effectively, and fostering international collaboration to address global health threats," the team

India Sees ₹65,000 Cr Digital Transactions Worth ₹12,000 Lakh Cr In 6 Years

NEW DELHI- Indian digital payment landscape witnessed over 65,000 crore transactions amounting to more than Rs 12,000 lakh crore in the past six financial years, Parliament was informed on Monday.

The government has been closely working with different stakeholders, including the Reserve Bank of India (RBI), National Payments Corporation of India (NPCI), fintechs, banks and state governments, to increase the adoption rates of digital payments in the country including in tier-2 and tier-3 cities, Minister of State for Finance Pankaj Chaudhary said in a written reply in the Lok Sabha.

RBI has set up a Payments Infrastructure Development Fund (PIDF) in 2021 to encourage deployment of digital payments acceptance infrastructure in tier-3 to 6 cities, North-Eastern States and Jammu & Kashmir, he said

As on May 31, 2025, around 4.77 crore digital touch points have been deployed through PIDF, he said.

Replying to another question, Chaudhary said, the New Digital Credit Assessment Model for MSMEs was announced in the

Union Budget 2024-25.

"The model envisioned that the public sector banks (PSBs) will build their in-house capability to assess MSMEs for credit, instead of relying on external assessment. PSBs would develop a new credit assessment



model, based on the scoring of digital footprints of MSMEs in the economy." he said.

Subsequently, the Union finance minister had launched the New Credit Assessment Model for MSMEs on March 6, 2025.

The model leverages the digitally fetched and verifiable data and devises automated journeys for MSME loan appraisal using objective decisioning for all loan applications and model-based limit assessment for both Existing to Bank (ETB) as well as New to Bank (NTB) MSME borrowers, he said.

The digital footprints used by the model may include Pan authentication using NSDL, mobile and email verification using OTP, Application Programming Interface (API), fetching of GST data through service providers, bank statement analysis using account aggregator, ITR upload and verification, API-enabled commercial and consumer bureau fetch and due diligence using Credit Information Companies (CICs), fraud checks, through APIs, among others, he said.

SRINAGAR- Jammu and Kashmir Bank's focus on agriculture and retail lending has helped it register a record profit of Rs 485 crore in April-June, the bank's MD & CEO Amitava Chatterjee said on Monday.

J&K Bank on Friday said its profit after tax at Rs 484.84 crore in the April-June period of FY26 was the highest-ever in a first quarter so far. The latest Q1 profit was 16.7 per cent higher against Rs 415.49 crore recorded in the corresponding quarter a year ago.

Chatterjee further said the bank would have posted its highest-ever profit for a quarter, had it not set aside Rs 87 crore towards investment in the RRB, which was necessitated due to the amalgamation of Ellaquai Dehati Bank in the Union Territory into Jammu and Kashmir Grameen Bank.

"There has been a total transformation in the way the bank has put up a product. We were almost totally dependent on Kissan Credit Cards. Now we have introduced an all-purpose term loan for agriculture that creates an investment credit. The agri sector has already seen a growth of Rs 1,500 crore this quarter," Chatterjee told PTI in an interview.

The MD said the bank has set a target of Rs 5,000 crore loan in the agriculture sector this fiscal and he hopes to cross that mark with much

Indian Economy Has Look And Feel Of 'Steady As She Goes' For FY26: FinMin

NEW DELHI- Indian economy has the look and feel of "steady as she goes" for the current fiscal, the finance ministry said on Monday even as it flagged slowing credit growth. In its monthly economic

In its monthly economic review, the ministry said the first quarter of fiscal 2025-26 (FY26) presents a picture of resilient domestic supply and demand fundamentals.

With inflation remaining within the target range and monsoon progress on track, the domestic economy enters the second quarter of FY26 on a relatively firm footing.

a relatively firm footing.
While geopolitical tensions have not elevated further, the global slowdown, particularly in the US (which shrank by 0.5 per cent in Q1 2025), could dampen further demand for Indian exports.

"Continued uncertainty on

"Continued uncertainty on the US tariff front may weigh on India's trade performance in the coming quarters. Slow credit growth and private investment appetite may restrict acceleration in economic momentum," it said.

Further, given the deflationary trend in the wholesale price index, one has to observe economic momentum in nominal quantities. Measured in constant prices, economic activity may appear healthier than it is, the review report said.



"All that said, the economy has the look and feel of 'steady as she goes' as far as FY26 is concerned," it said.

The report noted despite monetary easing and a strong bank balance sheet, credit growth has slowed, reflecting cautious borrower sentiment and possibly risk-averse lender behaviour.

"A growing preference for bond markets, particularly commercial papers among corporates due to lower borrowing costs, may also explain the shift," it said.

Piggybacking on initiatives like the Employment Linked Incentive (ELI) scheme, the ministry said it is time for corporates to set the ball in motion.

The Reserve Bank has cumulatively reduced the short-term lending rate (repo) by 100 basis points since February.

With an outlay of Rs 99,446 crore, the ELI scheme aims to incentivise the creation of more than 3.5 crore jobs in the country over a period of 2 years, with special focus on the manufacturing sector.

TCS Layoffs: MeitY Monitoring, IT Union Flags Concern To Labour Minister

NEW DELHI- The IT Ministry is keeping a close watch on situation arising out of Tata Consultancy Services' (TCS) decision to lay off over 12,000 employees, and is in touch with the Tata Group company, sources said on Monday.

The move comes as India's largest IT services company is preparing to lay off two per cent of its global workforce this year, in what it describes as a broader strategy to become a "future-ready organisation", with focus on investments in technology, AI deployment, market expansion, and workforce realignment.

The bulk of the impact will be felt on middle and senior grades at TCS.

The IT Ministry is keeping a close watch on the entire situation, and is in touch with the tech company, sources said. The ministry is concerned and will go into the underlying causes that has prompted the move.

The blue-chip stock dipped 1.76 per cent closing at Rs 3,079.05 apiece on the Bombay Stock Exchange (BSE) on Monday, as news of layoffs sent fresh tremors in the tech circles.

Meanwhile, the Nascent Information Technology Employees Senate (NITES) has approached Union Minister for Labour and Employment Mansukh Mandaviya, and urged that the government issue a notice to TCS seeking an explanation. The IT employees' union has termed TCS' latest move as unethical, inhumane, outright illegal.

"The law clearly states that no employee who has served for over a year can be retrenched unless the company provides one month's notice or wages in lieu, pays statutory retrenchment compensation, and notifies the government. TCS has not complied with any of these legal requirements," NITES alleged, terming the move a blatant and wilful violation of the law.

The impact of such action is devastating, NITES said in its letter, adding that thousands of working professionals with families, EMIs, and financial commitments would suddenly lose their livelihood.

The psychological, emotional, and financial trauma of this move is unimaginable, Harpreet Singh Saluja, President of NITES, wrote in the letter.

Gold Declines Rs 500 To Rs 98,020/10 G; Silver Plunges Rs 1,000

NEW DELHI- Gold prices slid for the fourth consecutive session and ended Rs 500 lower at Rs 98,020 per 10 grams in the national capital on Monday due to unabated selling by stockists following a trade deal between the US and the EU, which dampened the safe-

According to the All India Sarafa Association, the precious metal of 99.9 per cent purity ended at Rs 98,520 per 10 grams, down by Rs 600 on Saturday.

In the national capital, gold of 99.5 per cent purity extended its losing run for the fourth straight day, by declining Rs 500 to Rs 97,750 per 10 grams (inclusive of all taxes) on Monday. It had finished at Rs 98,250 per 10 grams in the previous market session.

In addition, silver prices depreciated Rs 1,000 to Rs 1,13,000 per kilogram (inclusive of all taxes) on Monday. The white metal had closed at Rs 1,14,000 per kg

Meanwhile, spot gold and silver traded flat at USD 3,337.95 and USD 38.17 per ounce, respectively, in the global markets.

"Gold traded in a positive but flat range near USD 3,335 per ounce, as strength in the dollar index limited gains last week," Jateen Trivedi, VP Research Analyst, Commodity and Currency, LKP Securities, said.

FinMin Sees Room For More Rate Cuts As Inflation Remains below RBI's Target

How Kashmiris Are

In his first years in the metropolitan city, he traversed unfamiliar train lines and spells of loneliness. "You feel invisible," he says. "Mumbai doesn't stop for anyone."

Today, he makes sure no one from his community feels that way again. He wants everyone to experience the warmth, respect, and embrace of cosmopolitan Mumbai Ikram screens every new member, keeps the conversations focused, and fields a constant stream of requests. His phone lights up at all hours. Sometimes a medical SOS at 3 a.m., and sometimes a job lead mid-afternoon.

"You have to move with Mumbai's rhythm," he says. "I just make sure no one gets lost before they learn the steps.'

A Mumbai Mentor

One of the Circle's key members is Dr. Maroof Bashir, Principal of St. Wilfred's College of Law in Navi Mumbai. He's someone many Kashmiri students turn to when they first land in the city, unsure where to begin with college forms, fees, or scholarships.

He knows the system well and helps young people find their way. But he also introduces them to a side of Mumbai, away from the film sets and high-rises. "There's a thoughtful, literary Mumbai," he says. "You

just need someone to point you to it."

Through his college and personal network, Dr. Maroof helps students feel at home. Whether it's getting them into law school, guiding them on scholarships, or just checking in, he's become someone they can count on.

In a fast and unfamiliar city, it's this steady support that truly makes a difference for Kashmiris arriving in Mumbai as students, strugglers, artists, or patients.

A Banker's Blueprint

Adil Shah, Vice President at Axis Bank, once ran a branch in Srinagar. After relocating to Mumbai, he began to notice the everyday struggles of young, educated, and overwhelmed Kashmiris.

He watched them wrestle with housing agents, freeze at interviews, get lost in hospital corridors.

"It wasn't a lack of talent," he says. "It was a lack of

Adil began building those systems. He linked renters to fair landlords, verified job offers, and created a thread of practical help that others could follow. He calls it civic

duty.
"This is infrastructure," he says. "Built with care, not

Some members of this Circle are focused on building safety nets and support systems for Kashmiri women. Having once been young and vulnerable themselves, they understand what it's like to be a working woman in a big city. It's this understanding that drives women like Anjum Syed.

The Resume Builder

A banker, Anjum moved to Mumbai from Delhi in 2002. In the national capital and across North India, she would often see other Kashmiris at cafés, campus events, or just going about daily life. But Mumbai felt different.

"You don't see or hear much about Kashmir here," she says. "You feel alone."

Then one day, Ikram reached out to her on LinkedIn. She joined the Circle reluctantly. But soon, her inbox filled with résumés, especially from young Kashmiris seeking internships and jobs in the dream city of India. She began editing them, line by line, and coaching

young Kashmiris through the hiring process. "Everyone thinks talent is enough," she says. "Then they meet the walls. I help them knock, professionally."

Anjum says Mumbai tests newcomers early, especially those from small towns like Kashmir. "The first six months decide everything," she says. "It's

never easy. But if you have a support system, like the one we are building, the city stays with you." This spirit of compassion is helping create safe spaces

for Kashmiris far from home, and people like Jasleen Kaur are leading the way.

Comfort on a Plate

Kaur is a Kashmiri Sikh, who runs Folk, a fine-dining restaurant in Kala Ghoda. During the pandemic, she began cooking the food of her childhood: rogan josh, haakh, nadru vakhni. The menu drew others who missed the

Some came for a taste of home, others came in need. Iasleen became one of the Circle's most active re sponders. She sends food to patients near hospitals whenever requested and feasible.

"Sometimes," she says, "a warm plate does more than a doctor's note."

The Medical Guides

Doctors are central to the group's reach. Dr. Ajaz Ashai is among the most active. He often answers calls late at night, sometimes from families newly arrived at train stations or hospital gates. The questions come quickly: Which hospital? What does this report mean? Who will

"It's not just about treatment," he says. "It's about making someone feel like they're not alone in a strange place.'

He and others explain diagnoses, arrange second opinions, and guide families through a medical system that can feel unkind to outsiders. What they offer is more

Names With Weight

The Circle is growing in both size and stature. Among its members are Mehtab Jagil, an IRS officer with Mumbai Income Tax; Dr. Hamid Shah of Tata Hospital, who handles complex medical referrals; Jaan Nissar Lone, a wellknown singer and Mir Sarwar, a film actor with roots in the valley.

They lend their names, but also their time. Their presence adds weight and reassurance, especially when the person asking for help is young or newly arrived.

Plans in Motion

The group is now laying groundwork for the future. Members are drafting proposals for short-stay hostels across Mumbai: safe dormitories where Kashmiris can stay for a few weeks until they stabilize.

They're putting together resource lists, reaching out to NGOs, and looking into scholarships for students from the valley.

For many Kashmiri families, the idea of sending their children to big cities like Mumbai still comes with worry. The Circle is trying to ease that fear with structure, support, and a sense of home.

A Different Migration Story

For many Kashmiris, the move to a city like Mumbai is still heavy. There's the culture shock, the identity struggles, the stress of finding a place to stay, and the pressure to figure things out fast.

Families back home get anxious. And the ones who've just arrived often feel lost.

Mumbai may be fast and full of strangers, but for Kashmiris stepping into it now, the place doesn't feel so unfamiliar anymore.

There's someone to call now. With the JK Mumbai Circle around, the city doesn't

feel so far from home after all.

within or outside the Parliament during this period, then we will talk (on the subject)," Abdullah said.

Addressing a press conference earlier in the day, J&K Congress president Tariq Hameed Karra said they are intensifying the statehood restoration campaign from August 1 by reaching out to traders, transporters and unorganized sectors followed by a chain hunger strike in district headquarters from August 9 to 21.

Karra said the party's campaign for restoration of statehood is on the right track and both rallies in Srinagar and Jammu on July 19 and 20 followed by the Delhi march two days later proved successful.

tack in the next few hours, he said. "PM Modi made it very clear that if that happens, it would be met with an appropriate response from our side. That massive attack took place, and it was foiled by our armed forces.

"On May 10, we received phone calls sharing the impression of other countries that Pakistan was ready to cease the fighting. Our position was that if Pakistan was ready, we needed to get this as a request from the Pakistani side through the DGMO channel. That is exactly how that request came," Jaishankar said.

"I want to make two things very clear. One, at no stage in any conversation with the US was there any linkage with trade and what was going on. Secondly, there was no call between the prime minister and President Trump from April 22 -- when President Trump called up to convev his sympathy -- till June 17, when he called u who was in Canada to explain why he could not meet,"

Talking about the post-Pahalgam actions of the government, Jaishankar said that the Cabinet Committee on Security had decided that the Indus Waters Treaty would be held in abeyance until Pakistan abjures its support for

terrorism, along with a host of other steps. "It was very clear that after these steps, India's response to the Pahalgam attack will not stop there. Our responsibility from a foreign policy approach was to shape the global understanding of the Pahalgam attack,"

Jaishankar said that Indian diplomacy then tried to bring out Pakistan's long-standing support to terrorism and how the Pahalgam attack was targeted at Jammu and Kashmir's economy and sow communal discord.

"Messages were two -- zero tolerance for terrorism and the right to defend our people against terrorists. All diplomatic briefings were aimed at these two objectives." he said.

Jaishankar's remarks came after Congress' Deputy Leader in the House Gaurav Gogoi slammed the government over US President Donald Trump's claim made "26 times", that he used trade to bring about a ceasefire between India and Pakistan.

Defence Minister Rajnath Singh on Monday said in the Lok Sabha that Operation Sindoor was "paused" as the armed forces had achieved the desired politico-military objectives and asserted that there was "no pressure" to

If Pakistan indulges in fresh misadventure, it will resume again, the minister said in his opening remarks on the special debate on Pahalgam terror strikes and Operation Sindoor in the lower house. He said the armed forces are ever vigilant to defend

India's borders and the military operation was an effective and well-coordinated strike against nine terror sites. Seven terror camps were fully destroyed and India has proof of the damage incurred inside PoK and Pakistan, Singh told the House.

The entire operation was over in 22 minutes and the Pahalgam killings were avenged.

The attacks, he asserted, were non-escalatory in

"Before executing Operation Sindoor, our forces studied every aspect and chose the option that would cause maximum damage to terrorists while ensuring no harm to innocent civilians." Singh said.

He underlined that to say or believe that Operation Sindoor was stopped under any pressure is baseless and completely incorrect. It was the director general of Pakistan's director gen-

eral of military operation who requested his Indian counterpart to end the strikes. Singh's statement comes against the backdrop of US President Donald TRump's 'ceasefire' claims.

The minister said the objective was not to cross borders or take over territory but to target terrorist camps, their supporters and to destroy them. He asserted that no innocent civilian was targeted in the military strikes.

The Congress has been repeatedly attacking the government over Trump's remarks. Since May 10, when Trump announced on social media that India and Pakistan had agreed to a full and immediate ceasefire after a long night of talks mediated by Washington, he has repeated his claim on several occasions that he helped settle the tensions between India and Pakistan.

However, India has been consistently maintaining that the understanding on cessation of hostilities with Pakistan was reached following direct talks between the Directors General of Military Operations (DGMOs) of the two militaries.

Oppn Seeks Answers

The Opposition on Monday targeted the government in Lok Sabha on "security lapses" that led to the Pahalgam attack, saying Home Minister Amit Shah must take responsibility for it, and demanded answers on how many Indian jets were downed during Operation Sindoor and why PoK was not taken back.

Participating in a special discussion on Operation Sindoor, the Congress MPs questioned the government on the sudden halting of Operation Sindoor and asked "before whom did Prime Minister Narendra Modi

surrender". Congress deputy leader in Lok Sabha Gaurav Gogoi asked when will India take back its Pakistan-occupied Kashmir (PoK) and also slammed the government over US President Donald Trump claiming "26 times" that he used trade to bring about a "ceasefire" between India and

"If not today, then when will we take Pakistan-

occupied Kashmir back?" Gogoi said. The Congress leader said Prime Minister Modi has been saying since the Uri and Pulwama attacks that "humne ghar mein ghus ke mara", "we destroyed terror infrastructure" and is making the same remarks even now after the "most horrendous" terror attack.

He said the Opposition wants to know from PM Modi that if Pakistan was ready to kneel before India, "why did

you stop and before whom did you surrender?" Noting that US President Donald Trump has claimed 26 times that he used the threat of trade to bring about a "ceasefire" between India and Pakistan, he said the American leader has also claimed five to six jets have been downed.

"That is why we want to know from the defence minister, the country has the courage to listen to the truth, he must answer as to how many fighter jets were downed," Gogoi asked.

"This information, this truth, is not just for Indian citizens; it is important for soldiers, they are also being lied to," he added Gogoi said there are just "35 Rafale fighter jets in the

country" and if some have been downed "it is a big loss". He also asked why Defence Minister Rajnath Singh did not name China during his address in the Lok Sabha and said he must disclose how much support that country

was providing to Pakistan during Operation Sindoor. Singh had initiated the discussion in the Lok Sabha on "India's strong, successful and decisive Operation

Sindoor in response to the terror attack in Pahalgam". The government asserted in the Lower House it can go to any extent to uproot terrorism and warned that Operation Sindoor launched terror sites in Pakistan was on pause as the armed forces had achieved its desired obiectives, but could resume in case of any misadventure by Islamabad. It also rejected Trump's claims on "ceasefire"

Referring to Singh's speech, Gogoi said he gave a lot of information, but did not say, as the defence minister, how the terrorists came to Pahalgam. "The country wants to know ... 100 days have passed,

but this government has not brought the terrorists to justice," he said. Taking on the home minister, he said he made claims that the backbone of terrorism has been broken, but the

Uri and Pahalgam incidents still happened. "Who will take responsibility, the (Jammu and Kashmir) Lieutenant Governor? It is the home minister who must take responsibility. You cannot hide behind the LG. This government is ... so weak that it blamed even tour operators for the Pahalgam attack," the Congress

Congress MP Deepender Singh Hooda demanded that India should not play cricket with Pakistan at a time when Operation Sindoor is going on.

Hooda also batted for modernisation of Indian defence forces and an increase in the defence budget. He questioned the "silence" of Prime Minister Modi on claims made by US President Trump of brokering peace

between India and Pakistan.

The government has to decide its relationship with the US, he said, adding that India should ask Trump to stop speaking on India-Pakistan issues. The Rohtak MP added that the government should

disclose the "terms of the ceasefire" with Pakistan. Taking on the government for halting Operation Sindoor at a time when India's security forces had an edge, TMC MP Kalyan Banerjee questioned the announcement of "ceasefire" and likened it to a player "declaring the innings" on the brink of scoring a century.

"... Have you ever heard that a player batting at 90 and heading towards a century, declare the innings. Only Modiji can do this, no one else... It was a matter of completing 100 runs, ended up being at 90," he said.

He also asked why PM Modi did not "counter" Trump "even once" on his claims made in a social media post on the role of the US in reaching the ceasefire. In a dig at the prime minister, the TMC MP said that in

front of the US President, Modi's stature "gets reduced", and his "chest shrinks from 56 to 36 inches" NCP (SP) member Supriya Sule questioned the government's handling of Operation Sindoor, saying it cannot be called a success until the terrorists responsible for

Pahalgam are caught. Urging External Affairs Minister S Jaishankar to reflect on the global calls for de-escalation, she referred to BJP MP Tejasvi Surya's own question about the objective of the war and highlighted the anguish of victims' families, with one repeatedly asking her, "When will my father get

Sule said Kashmir, once seen as paradise, had become a nightmare for many and mere compensation without

jobs or accountability was not enough Samajwadi Party MP Ramashankar Rajbhar said the country wanted "Operation Tandoor" after the Pahalgam terror attack to roast the terrorist responsible for it, and not Operation Sindoor.

He accused the government of failing to act decisively and questioned the "delay" in the operation, saying that a mission that should have been initiated in three days was carried out after 17 days. "The country was so angry (over the Pahalgam at-

tack) that by the third day, people wanted not Operation Sindoor, but Operation Tandoor, that is to throw the terrorists into that tandoor. But instead, the operation happened 17 days later." "Were those who carried out the Pahalgam attack among the 100 terrorists (killed during the operation)? That's the real question," he asked while lauding the

country for displaying unity and foiling the enemy's plan

of inciting riots. On Trump's claims of bringing a ceasefire, he said, "The real Vishwaguru was sitting in the White House," he said.

Shiv Sena (UBT) MP Arvind Sawant said India should refrain from playing cricket with Pakistan in view of the ongoing tension with the neighbouring country.

Sawant also wondered why India stopped the war with Pakistan without imposing any conditions when the neighbouring country "was on its knees begging for a ceasefire".

"If India was in the vantage position, then what stopped the country from reclaiming Pakistan-occupied Kashmir," he said, adding this was an opportune time to teach Pakistan a lesson like India Gandhi had done during the 1971 war.

The late comedian was laid to rest in the local graveyard near his residence, where hundreds turned up to pay their final respects. Mourners included fellow artists, admirers, and members of the local community who remembered him for his humble nature and unmatched contribution to the performing arts.

In an era of changing entertainment mediums, Bashir Kotur remained a steadfast symbol of Kashmir's traditional storytelling and humour-his legacy, many said, will continue to inspire future generations of performers.

Ben Stokes Set To Play Oval Test, Says 'Pain Is Just An Emotion'

MANCHESTER: England captain Ben Stokes has hinted at his participation in the fifth and final Test against India at Oval despite carrying an injury, saying "pain is just an emotion" but acknowledged the need to rejig their tired bowl-

The fourth Test ended in a stalemate after centuries from skipper Shubman Gill, Ravindra Jadeja and Washington Sundar saw India dominate the final day's play at Old Trafford where drama unfolded in the last hour when Stokes and Co. wanted to call off the match, only to be refused by the visitors who were well within their rights to continue batting.
Stokes, who grimaced through-

out while bowling 11 overs on Sunday, said he had been suffering from pain in his right bicep

"I don't want to eat my words but the likelihood I won't play is very unlikely. I'll always try to

through a brick wall for the team," Stokes said when asked about his chances of playing at the Oval in three days' time.

"It's my bicep tendon. It obviously had a lot of workload through it but it didn't get any worse and hopefully it settles down and will be as good as gold for last game. But yeah, (I spent) a lot of time out in the middle doing my job as an all-rounder this week and (it) just got a little bit flared up...

"Bowling, being out on the field it is tough work. I'm feeling pretty sore. I've physically been better. But I'll keep trying, keep going and as I say to all the bowlers: pain is just an emotion."

Stokes has been bowling full throttle in the ongoing series and is currently the leading wickettaker with 17 scalps. In Manchester, he has also got his first fivewicket haul in eight years before topping it up with a big hundred in England's massive first innings

Having toiled through 143 overs in India's second innings at Old Trafford, Stokes indicated that England would need "fresh legs" for the fifth Test starting Thursday.

"If you look at how long we've been out in the field and the overs that we bowled as a bowling unit, everyone is going to be pretty sore and pretty tired going into the last game of the series," Stokes said.

'There will be an assessment of everyone, and hopefully we can use these next two or three days' rest period wisely and then have to make a decision.

These recovery days are going to be pretty important and we might have to make a few decisions to get some fresh legs in. But that won't be decided until we get closer to the last game.'

Stokes has won his second consecutive Player of the Match award on Sunday and 12th overall, which places him second among English players with only teammate Joe Root ahead of him with

Can Sports Ministry Stop Indo-Pak Asia Cup Clashes? Not Really

NEW DELHI: The India-Pakistan cricketing rivalry is set for a brief resumption at next month's Asia Cup but the mere announcement of it has triggered an avalanche of criticism on social media and a question. Can the sports ministry have a say in the matter?

Emotions are still running high after 26 people were gunned down by Pakistan-sponsored terrorists in Jammu and Kashmir's popular tourist hub of Pahalgam in April. The gruesome killings even led to a brief military showdown between the old foes. Months later, the cricket teams of the two nations will clash in the

"As of now, the BCCI does not come under the purview of the sports ministry as the National Sports Governance Bill is still to be passed. So, the ministry doesn't have a say, but we will wait and see how the BCCI responds to public sentiment," a

sports ministry source told PTI. Lieutenant General (Retd) KJS Dhillon, who served as the Director General of Defence Intelligence Agency, is among the prominent voices who have called for a boycott of any cricketing ties with Pakistan. However, former BCCI President and captain Sourav Ganguly, while condemning terrorism, has stated that 'sport should go on".

The sports ministry has maintained that any bilateral sporting engagement with Pakistan is "out of question" at this point.

But in multilateral contests, it would go by the Olympic Charter, which prohibits any discrimination based on political issues, which is why the government has stated that it would not stop Pakistan from coming to India for international events.

Adherence to the Charter is crucial to India's ambitious bid to host the 2036 Olympics

Cricket too is part of the Olympic movement now and is set for a Games debut in 2028 in the T20 format. However, the eight-nation

Asia Cup is not an ICC event and will be conducted by the Asian Cricket Council (ACC), which is currently led by Pakistan Cricket Board chief Mohsin Naqvi.

The tournament features a scheduled India-Pakistan clash on September 14 with the potential of two more clashes later in the tournament. Crores are riding on these games as broadcasters expect high viewership and in turn igh advertising rates.

Sony Network has secured the eight-year broadcast rights from the ACC for USD 170 million.

It is reliably learnt, that unless there is mandatory India-Pakistan engagement in the continental showpiece, the channel

would end up incurring heavy losses which also ends up affecting ACC's revenue projections.

The losses, while not hurting the cash-rich BCCI significantly, would have a cascading effect on the revenue of the remaining 24 ACC members, most of whom are developing cricket nations.

What the bill says

The National Sports Governance Bill has a provision for the sports ministry to step in and "impose reasonable restrictions" on the international participation of Indian teams and individual athletes when necessitated by "extraordinary circumstances" and in the "national interest."
