# No World Leader Asked Us **To Stop Op Sindoor: PM**

'Proved That We Won't
Bow To Nuclear Blackmail'

\* Calls Indus Water Treaty
'Big Blunder' Of Nehru

New Delhi: Prime Minister Narendra Modi on Tuesday affirmed in the Lok Sabha that no leader of any country asked India to stop Operation Sindoor but lamented that while the nation got support from the entire world, the Congress and its allies could not stand behind the valour of the nation's soldiers.

Responding to the two-day debate on the Pahalgam attack and Operation Sindoor in the Lower House, he said no country in the world stopped India from taking action in its defence against terrorism.

The comments by the prime minister come amid repeated questions by the Opposition about why US President Donald Trump announced the "ceasefire" between India and Pakistan.

Modi told the House that on May 9th night, "US Vice President (JD Vance) tried to reach out to me 3-4 times,



but I was busy with meetings with the armed forces".

"When I returned the call, the US Vice President warned me of a big attack from Pakistan. I told him that if Pakistan attacks India, our attack would be much bigger as we will respond to bullets with cannons," he said.

Modi asserted that no leader of any country asked India to stop the operation.

The prime minister said Pakistani airbases hit by India "are still in ICU" and the masterminds of the April 22 terror attack continue to have sleepless nights.

"No country in the world has stopped India from any action in its defence against terrorism. Only three countries spoke in favour of Pakistan at the UN.

"India got support from the entire world, but it is unfortunate that the Congress did not support the valour of our soldiers. Congress leaders targeted me for political gains, but their frivolous statements

ended up discouraging our brave soldiers," he said.

The prime minister noted that India called out Pakistan's nuclear bluff and showed the world that "we will not bow down to nuclear blackmail".

"Our operations range from Sindoor to Sindhu (Indus Waters Treaty)... Pakistan knows they have to pay a huge price for any misadventure. Terror attacks were launched earlier and the masterminds of attacks knew nothing would happen, but now they know India will come for them."

PM Modi said drones and missiles made in India exposed the capabilities of Pakistani arms and ammunition during the military operation.

"The world saw the strength of self-reliant India during Operation Sindoor. We destroyed terror sites deep inside Pakistan within 22 minutes to avenge the April 22 Pahalgam attack," he said.

Speaking during a special discussion on Operation Sindoor in the Lok Sabha, Shah drew



sharp contrasts between the previous UPA regime's approach and that of the current government.

### **Pahalgam Attack Perpetrators Eliminated: Shah**

New Delhi: Three of the terrorists who carried out the Pahalgam massacre have been eliminated by security forces in a joint operation by the Army, CRPF and Jammu and Kashmir Police near Srinagar, Union Home Minister Amit Shah announced in the Lok Sabha on Tuesday.

The terrorists were killed Monday in an operation dubbed Mahadev but officials had held back in identifying them conclusively as the Pahalgam attackers.

Participating in a special discussion on Operation Sindoor, Shah also attacked the opposition party for giving a "clean chit" to Pakistan for the April 22 Pahalgam attack. Had the Congress opposed Partition, the problem of terrorism in Jammu and Kashmir would never have occurred, he said.

### **Amarnath Yatra Set To Cross 4 Lakh Mark**

The ongoing Srinagar: Amarnath Yatra is poised to cross the four-lakh mark, with a total of 3,93,401 pilgrims having performed darshan at the holy cave as of Tuesday, official data reveals.

According to figures, 7,203 pilgrims offered prayers at the cave shrine on Tuesday, amid tight security and a spiritually charged atmosphere.

Tuesday's batch included 5,025 men, 1,352 women, 109 children, 47 sadhus, 1 sadhvi, 1 transgender pilgrim, and 668 security personnel.

Despite intermittent weather challenges in the upper reaches, officials said the yatra has progressed smoothly with consistent daily turnout. "If the trend continues, the cumulative number is expected to cross four lakh by tomorrow," an official said.

Meanwhile, the 27th batch of 1,490 pilgrims left the Bhagwati Nagar base camp in Jammu early Monday morning and has reached the twin base camps in Kashmir.

Escorted by CRPF and J&K Police, the batch included 1,262 men, 186 women, and 42 sadhus and sadhvis-37 sadhus and 5 sadhvis. | More on P6

Says Army Not Just Protecting Borders, But Culture Too



### **NIA Probes Killing** of Pahalgam **Mastermind**

Srinagar: A team of National Investigation Agency (NIA) officials on Tuesday began a probe into the killing of Sulieman alias Asif, the alleged mastermind of the April 22 Pahalgam terror attack, and his two associates in a gunfight with security forces in the Harwan area on the outskirts

The trio was neutralised on Monday in a swift operation codenamed 'Operation Mahadev' launched by the Army's elite para commandos near Mulnar, close to the Dachigam National Park. The operation was triggered by a technical intercept indicating the use of a satellite phone connected to the perpetrators of the Pahalgam massacre.

Officials said the NIA team arrived at the Police Control Room (PCR) in Srinagar early Tuesday to begin the formal identification of the slain terrorists. Witnesses brought in batches to ensure "cent per cent confirmation" that one of the bodies belonged to Sulieman Shah.

## Woman, Her Paramour Get Life **Term For Killing Husband**

Srinagar: A court in Kulgam on Tuesday sentenced a woman and her paramour to imprisonment for life for killing her husband in December 2013.

Principal Sessions Judge Kulgam, Aijaz Ahmed Khan, while announcing the quantum of punishment observed that justice demands that courts should impose punishment befitting the crime, reflecting public abhorrence of the crime.

# 50% Spike In J&K Narcotics Cases, Convictions Still Low: Data

Srinagar: Despite a sharp rise in narcotics-related cases, Jammu and Kashmir continues to struggle with a low conviction rate, official data presented in Parliament reveals.

According to figures shared by Minister of State for Home Affairs Nityanand Rai, J&K recorded 1,837 cases under the Narcotic Drugs and Psychotropic Substances (NDPS) Act in 2022 – a 50% increase from 1,222 cases in 2020. However, the conviction rate remains stagnant at 41.3% for the second consecutive year, despite improving from a dismal 15.7% in 2020.

In contrast, neighbouring Ladakh registered just eight NDPS cases in 2022 but reported a 100% conviction rate, highlighting sharper



judicial resolution in a smaller caseload.

The data, released in response to a question by MP K C Venugopal during Question Hour in the Lok Sabha, drew attention to the wide disparities in narcotics case outcomes across Indian states. While states like Kerala Mizoram (95.8%), Maharashtra (71.1%) boast high conviction rates,

I&K continues to lag behind the national average.

The Home Ministry's reply also outlined various legal and financial initiatives taken to combat drug abuse. These include the extension of the Assistance to States and UTs for Narcotics Control Scheme through 2025-26 with a to-

### 'Heavy Rains, Flash Flood Risk In J&K' **MeT Issues 3-day Weather Alert**

Srinagar: The Meteorological Centre Srinagar on Tuesday issued a comprehensive weather advisory for Jammu and Kashmir, forecasting a spell of intense rainfall and gusty winds across several parts of the region, particularly in the Jammu division, from July 29 to 31. The forecast

has raised alarms potential flash floods, landslides, and waterlogging in vulnerable areas.

According to the latest bulletin from the MeT Department, the next three days are likely to remain largely cloudy throughout the Union Territory, with light to moderate rainfall expected at many places. However, isolated regions may witness intense downpours accompanied by gusty winds,

particularly during late-night and early-morning hours.

The districts of Jammu, Reasi, Udhampur, Kathua, Rajouri, and Samba have been marked for heavy to very heavy rainfall, heightening the risk of urban flooding, traffic disruptions, and possible damage to infrastructure in low-lying and floodsensitive zones.

The advisory specifically warns against waterlogging and the likelihood of flash floods in nallahs and streams, alongside mudslides

## **SSCL Highlights Inclusive Development of Jhelum Riverfront**

Srinagar: Srinagar Smart City Limited (SSCL) has strongly rebutted a news report published in a local daily on July 28, 2025, concerning the Jhelum Riverfront Development project. Terming the article "unbalanced," "factually inaccurate," and "lacking verifiable information," SSCL issued a detailed statement highlighting the progress, vision, and public benefit of the initiative under the Government of India's Smart Cities Mission.

The statement clarifies that the Jhelum Riverfront project was envisioned to reclaim and revitalise previously neglected riverbanks, making them accessible, inclusive, and ecologically sensitive public spaces. The project has been executed in phases along both the Left and Right Banks of the Jhelum River, with a strong focus on urban inclusivity, environmental sustainability, and cultural revival.

On the Left Bank—from Zero Bridge to Amira Kadal, spanning 2.5 km—SSCL informed that the entire stretch has been completed and was formally dedicated to the public by the Hon'ble Lieutenant Governor on May 20, 2023. "Since its inauguration, this stretch has become a vibrant and inclusive public space actively used by both residents and visitors throughout the day," the statement noted. The upgraded Left Bank includes a continuous pedestrian promenade, accessible landscaped

spaces, dedicated on-street parking, a stormwater drainage corridor, underground and rationalised electric and telecom utilities, and development of modern public toilets. Additional features include high-quality street illumination, wayfinding signage, universal access through kerb ramps, upgraded heritage ghats with barrier-free entry, and integration of existing trees with interactive seating arrangements.

SSCL emphasised that the intervention has notably enhanced safety and accessibility, particularly for senior citizens and persons with disabilities. Before the project, the Left Bank was fenced off, lacked pedestrian infrastructure, and remained largely unused. "The article fails to acknowledge the remarkable transformation and significant rise in public activity on this stretch—a change not seen before," SSCL said.

The Right Bank of the river, from Heritage Zero Bridge to Amira Kadal, is being developed in segments. The first completed segment, approximately 800 metres from Heritage Zero Bridge to the General Post Office (GPO), was inaugurated on November 1, 2023, by the Hon'ble Lieutenant Governor. This portion has seen major upgrades, including improved access points and the creation of new pedestrian routes, such as from TRC to the Heritage Emporium. What was once a debris-filled, unused space has now been turned into a usable public corridor. A surface parking facility was also

constructed under the redundant space of Abdullah Bridge, and modern public toilets were installed to support visitor needs. "This stretch has quickly become a hotspot for public use and cultural gatherings, especially during evenings," SSCL said.

The remaining part of the Right Bank-from GPO to Amira Kadal-is in its final stages of development. Completed components so far include underground electric ducts, a wide and continuous pedestrian walkway, riveredge walkways, upgraded access routes from GPO Lane, Polo View Road, and SBI Lane, development of kiosks, and entry plazas. Ongoing work, being executed on a fast-track basis, includes landscaping, commissioning of the underground electric network, installation of illumination systems, and fixing of seating arrangements.

SSCL reiterated that the Jhelum Riverfront Development has been executed with a strong commitment to ecological preservation, civic functionality, and cultural heritage. "It has transformed once inaccessible and neglected riverbanks into safe, inclusive, and vibrant spaces that enhance urban life and foster civic pride," the statement added.

### School Girl Assaulted, Slaughtered In Langate Village

Police suspect criminal assault, hunting three perpetrators

rinagar- In a ghastly incident, a school girl was criminally assaulted by three unknown assailants in the outskirts of Langate on Friday, and then mercilessly slaughtered in a bid to avoid identification (of the criminals). The enormity of the crime sent waves of shock through the area and thousands of people took to the streets in violent demonstrations

The victim had, as usual, left her home in Batpora this morning for the 4 km trek to the Uqaab Public School in Langate where she studied in class 8. It being Friday, school was over at 1:30 p.m., and she and

two of her friends headed home through what the villagers call the Wilder route From what could later be nieced together from her friends

account, they were suddenly waylaid by three persons who tried to grab the victim.

The two friends fled from the spot terrified and weeping, and out of fear did not say anything at home about their school-mate.

But when pressed by the family of the missing girl, out

poured the story that created alarm in the entire neighbourhood. Search parties made up of the victim's family and their neighbours immediately set out for the track the girls had

taken on their way home, and came across one of her shoes. With fears of the worst mounting, the villagers found the girl's uniform, and shortly after came upon a body hastily hidden beneath clay and bushels of hay.

A villager, Ghulam Muhammad, said that the searchers were shocked to find that the throat of the victim had been slit, and her uniform, school bag, shoes and other belongings had been dumped some distance away from the "grave."

The Handwara police were informed about the gruesome incident, and top officers of the force tried to take custody of the body. But by then the news had reached the village, and a large numbered men and women came out in grief and headed towards the scene of the crime. The huge procession demanded the immediate arrest of the killers.

The Handwara police said that an autopsy would be carried out to find out the motive behind the killing. The police fears that the victim might have been criminally assaulted before being murdered because the body bore marks of violence, and was without any clothes when discovered.

The police said that a liquor bottle and a tumbler were found near the body.

Villagers from Batpora and adjoining areas held up traffic on the roads by pelting stones on passing vehiclea but dispersed late in the evening, when the additional deputy commissioner Handwara, Basheer Ahmad Wani visited the area and assured people of thorough probe into the crime.

Coming from the head of the Union Territory's elected government, it suggests something concrete may be brewing in New Delhi.

Omar's words were measured, but firm: "Let this Parliament session pass. We are hopeful that we will get something. If not, we will talk after that." Such guarded optimism from a sitting chief minister cannot be brushed aside. On its face, it does signal a possible shift in the Centre's approach, or at least some behindthe-scenes assurance that the demand for statehood is not being ignored. Or does it?

Ever since the abrogation of Article 370 on August 5, 2019, and its bifurcation into two union territories, the restoration of statehood has been one of the most pressing demands from J&K political parties While the central government has said that downgrading into union territory status was done for administrative efficiency and better integration, public sentiment in the region has consistently sought the return of statehood.

Recently, the Congress party launched a campaign under the banner "Hamari Riyasat, Hamara Haq." J&K Congress chief Tariq Hameed Karra has laid out an ambitious programme - public outreach, a "Black Day" on August 5, and a district-wide chain hunger strike from August 9 to 21.

Incidentally, the Congress is an alliance partner of the ruling National Conference. They also fought the election together. While the NC emerged dominant, the Congress chose to remain out of government, sticking to its statehood-first principle. This division of roles, governance and protest, might well be a deliberate strategy to push the issue from both within and outside the system. However, the NC has earlier blamed the Congress for not involving it in the statehood protest.

Overall, the NC has chosen to stay away from a confrontationist approach towards centre on the issue, keeping the door open for dialogue and avoiding pre-empting a process that may be quietly underway.

In J&K, restoring statehood is more than a political demand. It is about trust, identity, and restoring a sense of ownership to the people of Jammu and Kashmir. With both the government and the opposition rallying around this cause, the Centre would do well to listen and act. But for now, all we can do is to keep our fingers crossed.

# Why Bandipora Needs **National Highway Status**

While expressways transform the mainland, a strategic border district in Kashmir still waits for a road wide enough to carry hope.

hen winter hits the Himalavan north. Bandipora disappears from the map.

Tucked between the vast Wullar Lake and steep mountains, this district in north Kashmir is home to nearly 400,000 people, more than the population of Maldives or Iceland.

And yet, just two narrow roads link us to the rest of the world. One through Sumbal, the other through Sopore. Most days, they're more broken than usable.

When it rains or snows, or when no one takes care of them, the roads stop working, and so does

Ambulances don't make it, students miss exams, goods stop moving, and teachers cancel transfers. In a matter of hours, Bandi-


pora turns into an island, cut off and left out.

What happens here can impact the whole country. Beyond Bandipora lies Gurez,

a stunning valley perched near the Line of Control. In peacetime or tension, in calm or storm, all access to Gurez passes through our roads. Soldiers, rescue teams, and families rely on these routes to survive and serve

In January this year, the risks turned deadly. On the 4th, four Army personnel lost their lives in a road accident on the Bandipora-Gurez route. The road was narthe warning signs had been there

Poor access means fewer facilities, limited safety, and long periods of isolation. That hurts everyone, especially children, patients, and students.

This highway demand is not new. It has been raised in public meetings, debated in the Assembly, and covered by the press. But it never moved beyond files.

But now, every delay comes with a cost, sometimes in lives.

This isn't a request for charity. It's a call for fairness, and foresight.

## Kashmir's PhDs Are Victims of a Failed Education Policy

ach year in Kashmir, a strange cycle repeats itself. Hundreds of highly qualified college lecturers, many with PhDs and national-level credentials like NET, SET, and JRF, line up to reapply for the very jobs they've held for years. They fill out forms, attach degrees they've earned through sacrifice, update their CVs, and wait, again.

These are not rookies or parttime tutors. They are the backbone of government colleges across Jammu and Kashmir. They've held the system together in remote districts, volatile towns, and disrupted semesters.

And yet, the state pays them 28,000 a month. That's less than the salary of a freshly appointed peon.

The injustice is not new. It's just growing old, and harder to excuse. Across the Union Territory, the

Higher Education Department has refused to bring these lecturers under the University Grants Commission (UGC) pay structure, despite their qualifications and years of full-time service. Meanwhile, institutions such as the University of Kashmir, IUST. and SKUAST-K have already implemented the UGC-recommended pay scales. They follow national academic standards. The colleges under the Higher Education Department do not.

This disparity has left lecturers

"How is it justifiable that someone with a PhD and UGC qualifications earns less than a non-teaching staffer?" asked Dr. Sheikh Afaq of SP College, Srinagar. "What is the value of education if the state treats its educators like this?

A question worth repeating. In J&K's higher education landscape, these lecturers have stepped up again and again. When permanent posts remained vacant year after year, they filled the gaps. When colleges in rural belts needed staff, they moved without protest. When the pandemic forced campuses online, they carried the weight of continuity on their shoulders, with no allowances, security, and institutional gratitude.

The state, in return, gives them neither a contract nor a career path, just an honorarium. The word sounds ceremonial, as if they're being thanked for a favour. In reality, it's a monthly reminder of a broken system.

They are appointed on academic arrangement, a vague term that means nothing in terms of service recognition. There is no provident fund, pension, leave benefits, and medical coverage. And at the end of the academic year, they are asked to leave, only to apply again.

This cycle has played out for over a decade now. And every year, new memorandums are written. Protests are staged, delegations meet bureaucrats, and promises are made.

Even Chief Minister Omar Abdul-

lah publicly assured regularization and pay parity for these lecturers. But those assurances dissolved into silence once the cameras turned off.

The present administration has inherited this backlog of broken promises. And it has added its own indifference to the mix.

Lecturers say they are no longer just underpaid, they are invisible. Their files sit untouched, appeals unread, and their future remains undecided.

A 2022 RTI filed by an education advocacy group in Srinagar revealed that nearly 63% of sanctioned teaching posts in government colleges remained vacant. Yet instead of filling them with permanent faculty or upgrading existing ones, the department has leaned entirely on these temporary appointees while refusing to pay them fairly.

This is exploitation in slow motion. It is eating into the morale of Kashmir's most educated generation. Some of these lecturers have taught for eight or ten consecutive years without a single raise. Others have crossed 40 with no sign of job security.

It is not just a professional crisis

It's a mental and social one. "We're constantly living on the

edge," said a lecturer from Baramulla. "One year you're teaching, the next vear vou're out. You can't plan your life, your child's education, or even apply for a home loan.'

The tragedy is that the state needs them desperately. With the government's renewed focus on skill development, digital education, and research, the higher education system cannot function without competent, committed faculty. But it seems unwilling to build that system on respect.

This is a betrayal of every student in J&K's colleges. When your teachers feel disposable, how do you expect them to inspire? At the core of this crisis is a ques-

tion of dignity. These lecturers are not asking for favours. They are asking for fairness. A lecturer with a PhD and teaching experience deserves to be treated at par with national standards. Anything less is institutional discrimination.

The government must act. The UGC pay scales must be implemented. These teachers must be regularized through a transparent framework. And the annual charade of reappointment must end.

It's hard to speak of "Viksit Bharat" and digital universities when your educators are still begging for dignity. The future of Kashmir's education depends on those who teach in its classrooms with conviction.

It's time they are seen, heard, and paid what they're worth.

# Kashmir's Tech Trap

From signal strength to social strain, Kashmir's digital story is more complicated than it seems.

n a remote corner of south Kashmir's Shopian district, 16-year-old Insha logs into a YouTube channel to revise her physics lessons. The Wi-Fi signal is unstable. The electricity, unreliable. But she keeps going, like thousands of students across the valley, who now rely on digital devices to pursue their education, connect with the outside world, and imagine futures their parents could not have dreamed of.

This is the face of Kashmir's digital transformation. It's a story of hope, but also one riddled with fault lines.

With smartphones in most pockets, and social media shaping everything from community calls to career ambitions, Kashmir is now a digital society, without having had time to pre-

Over the past decade, a region often isolated by geography and politics has plugged into a hyperconnected world. Yet with this connection comes a double bind: a newfound agency, and an escalating vulnerability.

Smartphones began to penetrate Kashmir's market in the late 2000s. By 2024, according to TRAI estimates, mobile phone density in Jammu and Kashmir stood at 122.63 per 100 people, one of the highest in the country.

Telecom towers now dot the mountain skyline. Villages once

out of reach now get online grocery deliveries. Even amid political turmoil, Kashmiris stream global news, edit videos for Instagram, and run e-commerce ventures from home.

The COVID-19 pandemic accelerated the digital shift. When schools shut down, virtual classrooms filled the gap. A government schoolteacher in Anantnag says, "Some kids attended classes by borrowing their neighbour's smartphone.'

Despite patchy bandwidth, students adapted. Online classes, digital worksheets, and education apps became the norm. Health services, too, began

experimenting.
Hospitals like SKIMS and SMHS introduced limited teleconsultation services. Several private clinics now use mobile apps to schedule follow-ups and send prescriptions. For people in far-flung areas like Tangdhar or Uri, digital health offers relief from long travel and waiting

Then there's the new digital

Hundreds of Kashmiri youth, particularly in Srinagar, are working as freelance graphic designers, copywriters, software developers, and content creators for clients in Mumbai, Dubai, and Toronto. Platforms like Fiverr, Upwork, and Instagram have redefined job markets for a region long hampered by unemployment and political instability.

According to the Ministry of Skill Development and Entrepreneurship, over 4,200 youth from J&K registered for online skill certifications in 2023, a 160% rise from three years

Yet the glitter of progress hides deep cracks.

Mental health professionals across the valley report a spike in digital dependency, especially among adolescents.

In a survey conducted by a Srinagar-based mental health welfare body, over 52% of teenagers admitted to spending more than five hours daily on their phones. Social media, gaming, and endless scrolling are taking a toll on attention spans, sleep cycles, and self-esteem.

'Children are losing interest in outdoor play," says a pediatrician in Baramulla. "They're irritable, distracted, and constantly

online, even during meals."

Parents often lack the vocabulary or tools to manage this shift. Digital fatigue is setting in early, and its symptoms, like anxiety, irritability, burnout, are hard to ignore.

The digital world is also amplifying misinformation. WhatsApp forwards during tense situations, like protests or vio-lence, can quickly spiral into

A 2023 study found that nearly 40% of viral content during sensitive events was either misleading or unverifiable. The emotional consequences are immediate.

"People believe what they see in the moment," says a university researcher. "No one pauses to verify. The damage is done in seconds.

Meanwhile, data privacy remains a largely unspoken

concern. Few users in Kashmir are aware of where their personal information goes. Apps demand access to contacts, location, and messages without clear disclosures. Tech literacy, especially among older users, is low. The trade-off between convenience and surveillance is rarely questioned.

Then there's online abuse. Young women, especially, face routine harassment on social media. Some deactivate accounts, others post anonymously.

One 19-year-old in Pulwama recounts receiving threatening messages after posting a video on sustainable fashion. "I was told to stay off the internet," she savs. "But it's also where I learn, connect, and dream.

Even as mobile networks extend their reach, a deep digital divide persists. In rural Kashmir,

5G access is uneven. Many families can afford only one smartphone, usually controlled by the head of the household. Girls often have restricted access or none at all.

In a survey by a local NGO, only 38% of girls in some south Kashmir schools reported having consistent access to online learning tools. In higher education, the gap widens further.

Many students preparing for national entrance exams must

travel to Srinagar or Jammu for digital coaching centers, or settle for poor-quality content over slow networks.

Digital exclusion is becoming the new illiteracy. Without fast, affordable internet and basic training in how to use it, large segments of Kashmiri society risk being left behind. This disparity widens economic and social gaps, reinforcing cycles of marginalization.

Few speak of it, but digital technology comes with a foot-

In junkyards across the city, dead and discarded cellphones and tangled chargers lie in growing heaps. Kashmir generates over 600 tonnes of e-waste annually, according to the recent report. There is no formal recycling system. Toxic materials, like lead, cadmium, lithium,

leach into soil and water. Data centers, while invisible, draw enormous power. The demand for faster, 24/7 internet means higher energy use in a region that often struggles with

basic electricity supply. Kashmir is racing toward a future it didn't entirely choose, but now must shape.

Digital education must go beyond tools and screens. Schools need to teach children how to verify information, manage screen time, and recognize online threats. Media literacy must become foundational, not optional.

Tech companies operating in Kashmir must be held to higher standards. From data protection to harassment reporting, users here deserve the same rights and tools available elsewhere. Governments should invest in local cyber cells, regional content moderation, and languagesensitive AI tools.

At home, the culture around screens needs to shift. Families must treat digital hygiene like physical hygiene, through habits, modeling, and limits.

Phone-free zones, offline hobbies, and digital detox periods are small but powerful steps.

And for those still left out, targeted interventions are needed: community Wi-Fi hubs, subsidized devices, and offline-toonline mentorship programs.

Technology is not neutral. It reflects the systems, values, and inequities of those who create and control it. In Kashmir, where fragility and aspiration go hand-in-hand, the digital world can either deepen fractures or offer a ladder.

The task ahead is to ensure that as the valley plugs into the world, it doesn't lose its way.

## **The Road That Remembers**

Two tunnels, two decades, and too many delays, but change is finally coming to Kashmir's most fragile road.

■he Ramban–Banihal stretch was never just a road. For people like me, it was a gamble with time, a daily test of nerves, a crack in the spine of Kashmir that swallowed chances, appointments, and sometimes lives.

I've seen this highway through fogged windshields and freezing nights, through blocked paths and broken schedules.

And standing there today, watching it transform into a four-lane lifeline, I felt something I wasn't prepared for: hope.

This road has held too much. I remember the ambulances that couldn't move. The families who walked for miles because buses gave up. The tourists stranded without food. The repeated calls we made, asking if traffic had moved beyond Panthyal.

The answer always seemed the same: "Sab kuch Banihal se aage ruk gaya hai."

For so long, we've known this stretch as the place where time stood still, where nature decided whether a child reached school or a patient reached a hospital, and where weddings were postponed and funerals were delayed.

This was beyond potholes or poor maintenance. It was about a whole region being forced to live with uncertainty.

And yet, now, something is changing. I stood and watched cranes bend steel into bridges. I saw tunnels breaking through mountains that once stood in the way.


The new T5 tunnel, bypassing Panthyal, means something deeper than convenience.

It means fewer lives will be lost to falling rocks. It means mothers can breathe easier when their children travel. It means the road can finally serve the people it was meant to.

As an engineer, I looked at the slope protections, the retaining walls, the new viaducts, and I knew the work hasn't been easy.

The terrain is unforgiving, and the weather, unpredictable.

Yet, there are workers in torn gloves and muddy boots, pushing through rain and dust. Some are from local villages, others have come from states far away. Together, they are carving safety out of stone.



I watched one worker haul concrete through knee-deep muck. Another climbed a scaffold without looking down. These are the people building our tomorrow. Their names may not appear anywhere, but this road will always carry their effort.

It's because of these unsung heroes that this construction project has become a recovery.

I think of a fruit trader in Qazigund who once told me, "Hamari zindagi road ke hisaab se chalti hai." His voice still echoes in my head. One highway closure meant a truckload of apples going bad. His profit depended on the weather forecast, not the market. This new highway, for him, is about dignity.

Students have suffered too. I've known boys who missed their exams, and girls who lost their admission letters. Entire futures paused because the road between Ramban and Banihal had given up again.

For them, this new stretch is access, fairness, and the chance to compete like everyone else.

Traffic jams here have always tested our limits. I remember sitting in a car that didn't move for nine hours. There were children crying in the back seat, a tourist couple next to us had no water left, and an elderly man fainted. The anxiety was about safety, and feeling helpless and forgotten.

But I also remember what happened during those long hours. Locals came out with rice and tea. Someone brought blankets. Dhabas opened their doors for strangers. Volunteers handed out medicines and cups of kehwa.

No one told them to do it. Yet every time the road gave up, their compassion kept it alive.

I once walked with a kettle of hot tea through a maze of stranded trucks. A driver took the cup with shaking hands. A mother thanked me with tears in her eyes. That moment has stayed with me. The road might have been blocked, but something deeper kept flowing.

Of course, this project has come at a cost. Mountains have been blasted. Streams have been diverted. Some homes have felt the tremble of every explosion. Progress often leaves marks. My hope is that this time, it listens. That it includes green recovery, proper drainage, and the voices of those who live in its shadow.

Even as I write, I think of the men still on site, finishing their shift under flickering lights. Some will sleep in tin sheds again tonight. Far from their own families, they are building a path for ours.

Years from now, the drive from Jammu to Srinagar may take less time. Children might laugh as they count tunnels. The road may become just another stretch on the map. But for those of us who lived through what came before, it will always mean more.

This road once made us wait, cry, and pray. Now it carries something new - possibility. It tells us that things can get better. That regions long pushed to the side can be brought to In every metre of this new highway

lies a memory, a burden, and a small,

Through food, funerals, and forgotten dialects, a new book documents the living culture of Kashmir's Dard tribes.

In the high valleys of Gurez and Ladakh, the Dard tribes are holding on to their stories, rituals, and fading They speak in a language older

It is this silence that Suheel Rasool Mir breaks in Cultural Encyclopedia of the Dard Tribe: Journey Through

Gurez and Ladakh. Page by page, village by village, he unearths a civilization long buried under snow, state apathy, and academic neglect. His work doesn't simply catalogue a community. It revives

a vanishing world. The Dards, who once inhabited a vast belt stretching across Dardistan, from Gilgit to Gurez, have lived through a slow erasure.

Their stories aren't taught, their songs aren't archived, and their wisdom doesn't trend. And yet, they hold within them the

original pulse of the mountains: resilient, adaptive, deeply rooted. Mir's book begins not with drama.

but with devotion. He steps into their


kitchens, listens to their prayers, learns their games, eats their food, and sits through their grief. What emerges is a tender, textured documentation of the Dard world, from millet fields to marriage

It's not some academic study or longing for the past. It's a cry for attention, and proof of what's slipping

Mir captures the sharp details, like the way butter is churned during snowstorms, the pattern of tattoos on women's wrists, the logic behind clan alliances, and the grief when a traditional flute falls silent for good. Each chapter reads like a dispatch

that Pakistan had some inkling of Indian action and had started issuing nuclear threats, but could do nothing when terror targets were hit.

The Congress and its allies have unfortunately become spokespersons of Pakistani propaganda. India is becoming self-reliant, but Congress is now dependent on Pakistan for issues. The entire country is amazed to see Congress give a clean chit to Pakistan and sing the same tune as theirs.

"The era of 'Aman ki Asha' and terrorism running in parallel is over. We've shut down this one-way traffic," Modi thundered.'

He dubbed the Treaty a "big blunder" of Nehru. "Successive governments did not correct Nehru's mistake of the Indus Water Treaty, but we made it clear that blood and water cannot flow together," Modi said.

PM Modi attacked the Opposition, saying while the nation got support from the entire world, the Congress and its allies could not stand behind the valour of the nation's soldiers.

He also asserted that no leader of any country asked India to end the military action after the Pahalgam terror strike.

"Before asking why PoK has not been taken back yet, Congress must respond -- who let it go. India is still suffering the pain of mistakes committed by previous Congress governments, starting from Jawaharlal Nehru.

"Then Congress governments lost opportunities to get back Pakistan-occupied Kashmir when India had Pakistan's land and soldiers in custody," he told the House.

said. "We banned all its constituents, and today, all of them are behind bars. We will not talk to Hurriyat. We will talk to the youth of the valley.

The Hurriyat, formed in 1993, has long been viewed as a pro-Pakistan amalgam of separatist groups in Kashmir.

Backing the Centre's tough stance with data, Shah highlighted a steep decline in terrorism since the BJP came to power. "Between 2004 and 2014, there were 7,217 terror incidents in Kashmir. Between 2014 and 2025, that number fell by 70% to 2,150,"

Civilian deaths, according to Shah, dropped by 80% – from 1,770 in the UPA era to 357 in the BJP's tenure. Security personnel deaths fell by nearly half — from 1,060 to 542 — while the number of terrorists killed rose by 123%.

"Between 2005 and 2011, there were 27 terror attacks. What did the Congress do? They just sent dossiers to Pakistan," Shah said, taking aim at the opposition. "Now, there are no local terrorists left. They're being sent from Pakistan."

He said the abrogation of Article 370 dismantled the "terror ecosystem" in Jammu and Kashmir, reiterating the government's zero-tolerance policy on terrorism.

Giving details of 'Operation Mahadev', Shah said the slain terrorists have been identified as Suleman alias Faizal, Afghani and Jibran.

"While Suleman was an A-category commander of Lashkar-e-Taiba, Afghani was also an A-category LeT terrorist. Jibran too was a notorious and wanted terrorist. All these three involved in the killing of our citizens at Baisaran valley in Pahalgam have now been eliminated." he said.

Shah said the identity of the terrorists was confirmed by those detained for sheltering and providing them with food ahead of the Pahalgam attack.
'Forensic ballistics, witnesses helped

identify Pahalgam attackers'

The arms -- one M-9 and two AK-47 rifles -- recovered from the terrorists were flown to Chandigarh Monday night in a special flight for examination at the Central Forensic Science Laboratory

The empty cartridges found at Pahalgam and those after test firing by the guns recovered from the terrorists were matched by the forensic lab, Shah said. The ballistic report is with him, he added.
"Six forensic experts have confirmed to

me on a video call this morning that these are the same bullets used in the Pahalgam attack," he said.

"We were not satisfied yet (if these were the terrorists who carried out the Pahalgam attack)...," Shah said, adding that a special plane took off from Srinagar around Monday midnight and landed in Chandigarh with the three rifles seized

from the terrorists. The Central Forensic Science Laboratory (FSL) in Chandigarh had already analysed the bullet shells recovered from the Pahalgam attack site and the experts at the facility fired "all night" from the three rifles flown in from Srinagar to generate more bullet shells, he said.

The two sets of bullets matched and it was established that it was these guns and terrorists who killed the innocents in Pahalgam, he said.

Waving the ballistic report in the House, Shah said six scientists "cross-checked" it and they confirmed its findings in a video call to him at 4:46 am on Tuesday.

The scientists told me that these were "100 per cent those bullets which were fired in Pahalgam", he said.

On the investigation underway in this case, Shah said the government handed over the probe to the National Investigation Agency (NIA) after Lashkar-e-Taiba (LeT)/ The Resistance Front (TRF) claimed responsibility for the attack.

The TRF is the LeT's frontal organisation. He said the NIA undertook a "long and tiring" investigation spanning 3,000 hours and questioned 1,055 people, including the family members of those killed in the attack, tourists, ponywallahs, photographers, various shopkeepers present in the area and their employees.

A sketch was made on the basis of these discussions and questioning. On May 22, Bashir and Parvez, who provided shelter and food to these terrorists, were identified. They were arrested by the NIA.

The two told the NIA that they kept the terrorists in their 'dhok' (hut), about 2 km from Baisaran valley, when they came to them around 8 pm on April 21. Two of them wore black overalls while the third was in

They also told the NIA that the terrorists carried three sophisticated rifles. They ate food, had tea and also took some eatables, salt, chilli and spices when they left.

Shah said the mother of the two arrested men also "identified" the bodies of the three terrorists, apart from some others who helped them.

Shah said security forces had recovered Pakistani voter IDs of two of the killed terrorists as well as chocolates made in Pakistan and the weapons.

"Prime Minister Narendra Modi, through Operation Sindoor, ensured that the masterminds of the Pahalgam attack were eliminated. And yesterday, in Operation Mahadev, those terrorists who were involved were eliminated," he said.

Describing the Pahalgam attack as barbaric, Shah said innocent civilians were brutally killed in front of their families after being asked about their religion.

Expressing condolences for those killed in Pahalgam and during Pakistani shelling on civilians, he said civilians were martyred and some gurdwaras and temples damaged due to Pakistani firing.

Terrorists are now being sent from Pakistan to Jammu and Kashmir as there are no local terrorists in Kashmir, Shah said.

He said after the elimination of the three terrorists, he thought this news would spark a wave of joy across treasury and opposition benches. "But opposition faces are gloomy," he said.

Describing Pakistan as the root of all terrorism, he said Pakistan was a mistake committed by the Congress "Had they rejected Partition, there would have been no

Pakistan," he added. Referring to Chidambaram's statement, Shah said it was extremely unfortunate that a former home minister is saying what evidence was there.

"What are they trying to prove? Whom are they trying to protect? They say that the terrorists were not Pakistani, and in this way, a former home minister from Congress is trying to give Pakistan a clean chit. By saving this. Chidambaram wants to suggest that if the terrorists were not Pakistani, then why did we attack Pakistan," he said, adding this was a clear conspiracy to pro-

tect Pakistan. Shah said under Operation Sindoor, Indian forces attacked targets 100 km inside Pakistan and India could exposed state sponsored terrorism in Pakistan.

He said India's armed forces crippled Pakistan's defence systems in such a manner that the neighbouring country had no choice but to request India to halt attacks.

"In 1948. Indian armed forces were in a decisive position to take back Pakistan occupied Kashmir but then PM Jawaharlal Nehru declared unilateral ceasefire," he said.

In 1971, Shah said, 93,000 Pakistani soldiers surrendered and India had 15,000 sq km Pakistan territory under control, but still PoK was not taken back.

During 1962 war with China, then PM Nehru bade goodbye to Assam in a speech on Akashvani. he said.

Shah said between 2005 and 2011, there were 27 terrorists attacks but what did the Congress government do, they just sent dossiers to Pakistan.

"Terrorists now sent from Pakistan to J-K as no local terrorists in Kashmir... Scrapping of Article 370 has destroyed terror ecosys tem in Jammu and Kashmir," he said.

"From 2004 to 2014, there were 7,217 terrorist incidents in Kashmir. From 2014 to 2025, these reduced by 70 per cent to 2.150. From 2004 to 2014, 1,770 civilians died. This reduced by 80 per cent to 357 from 2014 to 2025. From 2004 to 2014, the number of deaths of security forces was 1,060. This decreased to 542 in our time. And there was a 123 per cent increase in the deaths of terrorists," he said.

Attacking Congress, Shah said underworld don Dawood Ibrahim fled in 1986 when Rajiv Gandhi's government was in power, terrorists Syed Salahuddin, Tiger Memon, Anis Ibrahim Kaskar fled in 1993

when Congress government was in power and when Riyaz Bhatkal fled in 2007 and Iqbal Bhatkal fled in 2010, then again it was a Congress government.

"The answer they demanded from me has already been given by our security forces. Now let Rahul Gandhi answer why these people fled," he said.

Shah said the Prevention of Terrorism Act (POTA) was scrapped by the Manmohan Singh government in its first cabinet meeting after coming to power in 2004.

The country deserves to know who benefitted from Congress repealing POTA? Those opposed to POTA will never appreciate Narendra Modi's anti-terror policies,"

Donald Trump is lying," Gandhi said during the special discussion on "India's strong, successful and decisive Operation Sindoor.

He also claimed that had the government heeded his earlier warning about the China-Pakistan fusion, India wouldn't have lost five aircraft during the operation. "You laughed at me when I said this fusion is India's biggest foreign policy failure. Now you're facing the consequences," Gandhi

Responding later, Prime Minister Modi asserted that no foreign leader had asked India to halt Operation Sindoor, but expressed dismay that while the world stood with India, the Congress and its allies failed to support the armed forces.

Addressing reporters Gandhi reiterated, "Narendra Modi didn't categorically state that Trump is lying. Trump has said 29 times that he brokered a ceasefire, but the Prime Minister remains

Gandhi also slammed Modi for not once mentioning China during his speech. "Everyone knows China aided Pakistan during the Pahalgam attack. Yet the PM didn't say the word 'China' even once," he noted.

In his address, Gandhi accused the government of revealing critical operational details to Pakistan shortly after Operation Sindoor began. "I watched Rajnath Singh ji's speech. He said the operation began at 1:05 AM and lasted 22 minutes. Then at 1:35 AM, we informed Pakistan that we had hit non-military targets and didn't want escalation. That's surrender-within 30 minutes," he said.

He questioned why India conveyed to Pakistan that military infrastructure would not be targeted and why the Air Force's hands were tied. Citing remarks by Defence Attaché Group Captain Shiv Kumar, Gandhi alleged political leadership imposed constraints on striking Pakistan's military and air defenses.

"This was done to protect the Prime Minister's image-he has the blood of Pahalgam victims on his hands," Gandhi charged.

Tagging his speech on X, Gandhi wrote: "Prime Minister, the nation and the army stand far above your image, your politics, your PR and your propaganda. Have the humility to understand this.'

He also stated that if Modi lacked decision-making ability, he had no right to compromise the pride of the army and the

Gandhi argued that the government does not understand deterrence or political He invoked Indira Gandhi's leadership during the 1971 war as an example of decisive action, claiming that today's leadership failed in comparison.

He reiterated that the China-Pakistan military fusion had materialized and was evident during Operation Sindoor. "The Pakistani Air Force was operating in tandem with the Chinese Air Force. The Chinese were feeding battlefield data to Pakistan," Gandhi said, citing remarks by Deputy Army Chief Lt Gen Rahul R Singh.

"Our armed forces should be unleashed with freedom. Don't tie their hands behind their backs. Defeat the enemy once and for all. And don't let President Trump tell the world 29 times that he stopped the war. Have the guts to say—'To hell with you, you didn't stop anything, we fought on our own terms'," Gandhi declared.

He said the current situation is dangerous and India cannot afford a Prime Minister who lacks the courage to fully utilise the armed forces or call out global misinformation.

Gandhi insisted India needs a leader who empowers the Army, Air Force, and Navy to "finish the job," like Indira Gandhi did. "If Trump is lying, Modi must say it openly. If you have half the courage of Indira Gandhi, say: Trump, you're a liar," he said.

He also cited CDS General Anil Chauhan's statement that India rectified its tactics after initial losses during the operation. "The IAF made no mistake. The real mistake was political—'don't attack military targets'. CDS Chauhan should say it clearly—our hands were tied," Gandhi remarked.

Referring to External Affairs Minister S Jaishankar, he said the minister failed to clarify that no country directly condemned Pakistan for the Pahalgam massacre. "When UPA was in power, Pakistan was named and shamed for terrorism," he said.

Gandhi concluded by criticising Modi for not reacting when US President Trump hosted Pakistan Army Chief Asim Munir-"the architect of the Pahalgam attack"—for lunch.

Opposition Blames Lapses, Criticizes **Govt Silence** 

Opposition members in the Lok Sabha on Tuesday said that the Pahalgam terror attack was the result of a "complete intelligence and security failure" and alleged that the government was evading questions and hiding the truth.

Seeking to corner the government during the debate on the Pahalgam attack and Operation Sindoor, they claimed its foreign policy has "failed", as no major grouping — including the G20 and BRICS — passed a resolution condemning Pakistan after the incident.

Congress leader KV Venugopal said US President Donald Trump announced India-Pakistan ceasefire before the Indian government, which "is a clear intervention of third party".

This has never happened in the history of India, the Alappuzha (Kerala) MP said.

Criticising Home Minister Amit Shah's speech, Venugopal said the minister talked about all the peripheral issues but not about the "security failure"

The government claimed it was safe to visit Kashmir, but was it not their duty to ensure the security of tourists, he asked, adding that there was no security cover when terrorists killed 26 innocent people in Pahalgam.

Shah's speech "was incorrect", Vengopal said on the Home Minister's statement on the improvement in security situation in Iammu and Kashmir, adding "a state is burning and the home minister is saying that everything is safe".

"Pahalgam was not an isolated incident. Why did you not put sufficient security measures," he said, adding the conspirators of the attack are "dividing the country from outside and you are doing this from inside". Participating in the discussion, DMK's A

Raja said the government should not blame Jawaharlal Nehru and Indira Gandhi for everything. Raja said that none of the big groupings such as the G7, G20 and BRICS passed a

resolution condemning Pakistan for this He blamed "complete intelligence failure

and incompetence of administration" for the loss of lives. "The Pahalgam attack is a classic case of incompetence of the administration," he

Sharing similar views, ET Mohammed Basheer (IUML) said that several questions remain unanswered, like how the terrorists

managed to reach the tourist spot. "What steps have been taken to stop such incidents... Pahalgam was a security failure," he said, adding, "There was a lapse on your part".

Independent MP from Baramulla (Jammu and Kashmir) Sheikh Abdul Rashid said that the Pahalgam attack was a blot on humanity.

Rashid said the government's claim that everything is normal in the valley is confined to social media only.

'We are tired of carrying dead bodies," he He wanted to know how many mem-

bers from Kashmir were there in the seven multi-party delegation which were sent by the Centre to different countries to convey India's message of zero tolerance against terrorism in May.

Harsimrat Kaur Badal (SAD) said that responsibility must be fixed as there was a security failure that led to this attack.

SRINAGAR: Two Scholars from Shere-Kashmir University of Agricultural Sciences and Technology of Kashmir have brought laurels for the university by securing a postdoctoral fellowship at USA and INSPIRE Faculty Fellowship.

Junaid Nazir and Afnan Saleem, both PhD Scholars of SKUAST-K's Division of Animal Biotechnology, Faculty of Veterinary Sciences and Animal Husbandry, under the guidance of Prof Mudasir Andrabi, have won highest level of recognition for their accomplishments at a very young age.

Afnan Saleem, has been awarded the INSPIRE Faculty Fellowship by the

Department of Science and Technology (DST), Government of India. This fellowship is a recognition that places her among a group of young scientists in the country. Dr. Saleem is the first veterinarian and the first SKUAST-K scholar to receive the fellowship. Her doctoral work explored programmed cell death in bovine mammary gland infections. With 23 publications and two patents, her fellowship project will now focus on developing bioengineered biomaterials for infection control and tissue regeneration.

Junaid Nazir has secured an NIH-funded postdoctoral position at Oregon State University, USA. Nazir's doctoral research is centered on developing a Lactobacillus-based recombinant oral vaccine against Salmonella in poultry. This research holds relevance for the poultry industry and public health. He has contributed to 16 research papers and holds two patents. He is scheduled to begin his postdoctoral work in August 2025, where he will continue vaccine development research, focusing on Neisseria gonorrhoeae.

# **'J&K Faces Variation** Of 700 MWs Power **During Day Time'**

**SRINAGAR:** In the backdrop of low voltage issues during the day time, Jammu and Kashmir is facing a variation of nearly 700 Megawatts (MWs) of power' in comparison to other hours.

The official documents reveal that in view of low voltage during the day hours from 9Am to 2Pm, Jammu and Kashmir State Power Development Corporation Limited has a Available Transfer Capability (ATC) and Total Transfer Capability (TTC) of 2700/2800 MWs of power.

However, during the other hours except for 9Am to 2Pm, there is an ATC and TTC capacity of 3400/3500 MWs of pow-

improving the grid and other major infrastructures that can help in increasing the voltage during the day hours.

According to the official document available with KNO, "J&K SLDC is also sharing (transfer capability limit) ATC/TTC base-case on a regular basis as per CERC approved procedure."

"However, due to low voltages during the daytime, the ATC and TTC figures for day time were recently reviewed and revised figures were communicated to J&K SLDC. Due to low voltages in the Kashmir valley area, the transfer capability limits (ATC/ TTC) are 2700/2800MW during

09-14hrs and 3400/3500MW for other than 09-14hrs duration," it reads.

The documents said that "As of now the schedule of the state control area is not being restricted to ATC, and sometimes it is crossing the assessed ATC and TTC limits."

"However, in future as is the case with Punjab which is separate bid area, schedule of J&K state may be restricted upto their ATC and TTC limits upon formation of separate bid area." it reads.

We need to stay united and work together and every issue can be resolved."

## J&K Police Refund Rs 1.53 Cr **To Victims In Job Scam**

JAMMU: Director General of Police, J&K, Nalin Prabhat on Tuesday presided over a special function at Police Station Nagrota, where Rs 1.53 crore were distributed among 22 victims of a Rs 2.39 crore job scam.

According to the details available to KNO, the amount was recovered by Jammu Police as part of a landmark case executed under the newly enacted Bharatiya Nagarik Suraksha Sanhita (BNSS).

Accompanied by senior officials including IGP Jammu Zone B.S. Tuti, DIG JSK Range Shiv Kumar Sharma, and SSP Jammu Joginder Singh, the DGP lauded the police force for their exemplary investigation and commitment to justice.

The event was attended by officers from the Army, CRPF, civil administration, zonal SPs, SDPOs, and SHOs from Jammu's Rural Zone. SSP Jammu Joginder Singh and SP Rural Jammu Brijesh Sharma briefed the audience about the swift and efficient investigation led by SHO Nagrota, Inspector Parvez Sajad, under the supervision of SDPO Nagrota Vinod Kundal.

This case, according to the officials, marked the first instance in the Union Territory where property was attached and proceeds of crime returned to victims under the BNSS. It involved Harpreet Singh, a resident of Pallanwala, who posed as a Lieutenant Colo-

nel and duped individuals by promising jobs in MES, MoD, and DRDO. "The scam came to light after Arun Sharma of Nagrota filed a complaint on November 6, 2024, resulting in FIR No. 293/2024 at PS Nagrota. Harpreet Singh was arrested the next day. Investigations revealed that proceeds from the fraud were funneled into a real estate transaction involving a duplex property in Channi Bheja. The property, worth Rs 2.22 crore, was being transferred to the accused's mother, Paramjeet Kour. An amount of Rs 1.93 crore was traced back to Harpreet through cash and digital transactions," the officials added.

"On a plea by the police, the Chief Judicial Magistrate, Jammu, issued an attachment order under Section 107(5) of BNSS, executed by Tehsildar Bahu. A show cause notice was served to the accused to explain the source of funds. During proceedings, Kamaljeet Kour (the seller) judicially admitted to receiving ₹1.53 crore, and voluntarily committed to refund the amount," the officials said.

"In the first phase, Rs 75 lakh was distributed among 17 victims, and today, Rs 78 lakh was distributed among 22 victims through cheques. A total of Rs 1.53 crore has been refunded so far, with disputed amounts pending trial. A dedicated account was opened for disbursal on court directions, ensuring transparency and timely restitution."

# Bumrah Is 'Fit To Bowl As Per His Workload'

LONDON: India batting coach Sitanshu Kotak did not rule out Jasprit Bumrah's participation in the series deciding fifth Test against England, saying "he is fit as per his load."

Injury-prone pace spearhead Bumrah was earmarked for three Tests on the tour as part of his workload management but with the series on the line, he could play a fourth one.

After a dramatic draw at Manchester, head coach Gautam Gambhir also did not rule out the possibility of Bumrah featuring in the crunch game. Kotak reiterated that on Tuesday.

'Bumrah is fit now according to his load. He has bowled one inning in the last match. So that obviously head coach, our physio and captain they will have a dis-



cussion and decide. There has been no discussion," Kotak said two days before the game.

At Old Trafford, Gambhir had also confirmed that all his pacers were fit, meaning that Arsh-deep Singh and Akash Deep have recovered from injuries.

Asked about the workload of Mohammed Siraj, who is the only Indian pacer to play all games, Kotak gave a detailed

"So, I don't know what you guys think about the actual workload. So, if I tell you quickly, before the Test series, if a bowler puts in a certain amount of overs per week, that if he's preparing for T20 and putting in 20 overs, 25 overs, 6 overs every day, or putting in 6 overs for five days, that is good enough workload

"They have a GPS. It shows the

record of how many overs the bowler has put in throughout the week. And they're in constant touch with the bowling coach. So, the build-up of the last 4-5 weeks, you need to determine if that there's no spike in it.

"So, what's the spike? If a bowler is putting in 30 overs per week, and suddenly, in the first innings, he's put in 35 overs, then that's the spike in his load. So, the number of overs that Siraj is putting in every week, it's not necessary that it's due to practice.

That load is due to the match as well. So, then, another thing depends on whether Siraj him-self, or the physios, or his body feels that, no, I'm tired. Then, they will think about the load. Otherwise, his bowling load is very high, is very good. So, there's no chance of a spike in it," added Kotak.

Accused Farooque Aslam Khan, a resident of Mira Road, was arrested a few days ago and is now out on bail, an official said.

On June 13, Khan allegedly stole jerseys of IPL 2025 from the official merchandise store of the Board of Control for Cricket in India at the stadium in south Mumbai, and sold many of them online. The theft came to light during an audit of the inventory. BCCI officials approached Marine Drive Police Station with a complaint about the theft on July 17. (PTI)
