# **220 Drug Hotspots** Mapped In J&K 1,032 NDPS Cases, Rs 39 Cr Drug Assets Seized In 2025 So Far

Srinagar: Jammu Kashmir's intensified crackdown on narcotics has led to the registration of 1,032 NDPS cases and the arrest of 1,416 individuals so far in 2025, senior officials revealed during the 14th UTlevel Narco Coordination Centre (NCORD) meeting chaired by Chief Secretary

Atal Dulloo on Thursday. The high-level meeting, convened to review the UT's anti-narcotics strategy, was attended by top civil and police officials, including the

Director General of Police, Additional Chief Secretary, Principal Secretary (Home), ADGP CID, and other seofficers. Commissioners and SSPs from across the UT joined the session virtually.

A key highlight of the meeting was the identification of 220 drug hotspots across Jammu and Kashmir, including 20 newly flagged areas. Officials reported that 33 hotspots have been dismantled, leading to 413 arrests from these high-risk zones. These hotspots have emerged as | More on P10



# **Food Safety Dept Destroys 1200 Kg Spoiled Meat In City Raid**

SRINAGAR: In a significant crackdown on food adulteration, a joint enforcement team from the Food Safety Department Srinagar and the Drug and Food Control Organization (DFCO) seized and destroyed over 1200 kilograms of spoiled meat during a raid at a storage facility in Zakura, Srinagar.

The operation, based on specific intelligence inputs, was led by Hilal Ahmad Mir, Assistant Commissioner Food Safety ICLC, and Yameen Ul Nabi, Assistant Commissioner Food Safety Srinagar, along with a team of Food Safety Officers. The team discovered a large quantity of stale and foul-smelling meat that was allegedly ready to be distributed in the market for human consumption.

'The meat was found in a highly decomposed condition, completely unfit for consumption. It was immediately destroyed on the spot under strict supervision to eliminate any potential health risk to the public," said Assistant Commissioner Yameen Ul Nabi.

The department confirmed that legal proceedings will be initiated against the concerned Food Business Operators (FBOs) under the provisions of the Food Safety and Standards Act. "This is a serious violation of food

safety norms. We are committed to ensuring that such acts of gross negligence do not go unpunished," stated Hilal Ahmad Mir. "Public health cannot be compromised, and we will not hesitate to take the strictest action against violators."

The Food Safety Department reiterated the critical importance of maintaining proper temperature control, especially when handling perishable and high-risk food items like meat. "Temperature abuse is a key factor in spoilage, and we have issued strict directives to all FBOs to adhere to recommended storage practices," the department emphasized in its official statement.

Officials also said that the raid and subsequent action were conducted under the strict directions of Dr. Syed Abid Rasheed, Secretary Health and Medical Education, and Smt. Smita Sethi, Commissioner of Food and Drug Administration FDA), Jammu and Kashmir.

"There are clear instructions from our top leadership to maintain zero tolerance against food adulteration and unhygienic practices. Surveillance and enforcement across markets have been intensified," the statement added.

The department urged consumers and FBOs to remain vigilant and to report any suspicious activities or unhygienic food practices. Reports can be made anonymously by calling the Food Safety Helpline at 104.

This latest enforcement effort underscores the government's resolve to crack down on food safety violations and safeguard the health of the people of Jammu and Kashmir.

### **Chanapora Residents Await Upgradation Of PHC To SDH**

SRINAGAR: Over 13 years have passed since the foundation stone was laid for a hospital at Housing Colony Chanapora, but the residents continue to wait for its upgradation from a Primary Health Centre (PHC) to a Sub-District Hospital (SDH).

Despite an expenditure of over Rs 20 crore and the completion of the building in 2014, the facility still functions as a PHC, offering limited services between 10 am to 4 pm.

Locals said that they have repeatedly approached authorities at various levels, demanding roundthe-clock healthcare services and upgradation to SDH status. "The hospital has sufficient infrastructure. modern equipment and modular operation theatres, but it still fails to meet the healthcare needs of Chanapora and adjoining areas," said Mushtag Ahmad, a local resident

He added that a fully functional SDH operating 24x7 is the need of

Fayaz Ahmad, another local resident, told KNO that despite raising the issue with every concerned authority, no concrete action has been "In medical emergencies, patients are forced to rush to SMHS or SKIMS, which are far away. An upgraded hospital here would greatly ease the burden on tertiary care hospitals and serve the surrounding population better," he said.

He also pointed out staff shortage at the facility, and claimed that expensive medical equipment worth crores lies defunct due to the absence of trained operators.



"Though it is not yet an SDH, the hospital has been strengthened with additional machinery and manpower under NHM. Primary healthcare services such as free screening for non-communicable diseases (NCDs) like diabetes, hypertension and cancers (oral, breast, cervical) are being provided. Free essential medicines and diagnostic services are also available, along with health awareness and wellness programmes aimed at promoting a healthier life-

### **Trump Stirs** South Asia Waters

Washington: In a dramatic realignment of tone and strategy, the United States has sanctioned six Indian companies for trading with Iran, imposed steep new tariffs on Indian imports, and simultaneously announced a new oil development deal with Pakistan. The convergence of actions suggests a growing shift in Washington's South Asia

Sanctions Over Iran Trade

Just hours after Trump slapped new tariff on India, the U.S. Department of State sanctioned six Indian companies under Executive Order 13846 for allegedly engaging in petrochemical trade with Iran--activity the U.S. claims funds terrorism and fuels instability in the Middle East.

The sanctions freeze any U.S.-linked assets and prohibit American entities from en-



posture--with India now facing mounting pressure over its ties with Iran and Russia, and Pakistan emerging as a new energy partner.

### **Tariff Offensive**

The sequence began with U.S. President Donald Trump unleashing a blistering attack on India's trade practices and global alliances. Citing what he called India's "most strenuous and obnoxious" trade barriers, Trump announced a 25% tariff on all Indian goods, to take effect August 1, along with an additional penalty for India's continued purchases of Russian oil and military hardware.

"All things not good! India will therefore be paying a tariff of 25 per cent, plus a penalty for the above," Trump posted on Truth Social.

He also denounced India's involvement in the BRICS alliance--comprising of 10 countries including Russia, China and Iran--branding it "anti-US.

Mumbai, Jul 31: Nearly 17 years after a blast in Malegaon town of north Maharashtra claimed six lives, a special court in Mumbai on Thursday acquitted all the seven accused, including former BJP MP Pragya Singh Thakur and Lt Col Prasad Purohit, noting there was "no reliable and cogent evidence" against them.

Terrorism has no religion, the court said, adding it cannot convict on mere perception.

Thakur and Purohit hailed the court's order. Thakur said the acquittal was not just a win for her, but for "bhagwa" (saffron), as their acquittal rekindled the 'saffron terror' narrative buzz. "Bhagwa ki vijay hui hai," Thakur said.

Welcoming the court verdict, the BJP said the Congress manufactured the theory of "Hindu terror" when in power to stop the rise of Narendra Modi, the then Gujarat chief minister, to appease its Muslim voters.

Reacting to the court verdict, Maharashtra Chief Minister Devendra Fadnavis said "terrorism was never saffron and will never be".

AIMIM leader Imtiaz Jaleel demanded that the state government challenge the acquittal. There is no word yet from any gov-

### **CBSE Amends Affiliation** Norms, Built-Up Area Key Now

New Delhi: The Central Board of Secondary Education (CBSE) has amended its affiliation bye-laws to mandate that the maximum number of sections in a school will be permitted based on the total builtup carpet area of the school building, according to officials.

The board has also decided that schools shall be allowed an equal number of sections at the secondary level and at the senior secondary level.

"The board has been receiving feedback from the schools and stakeholders that there are areas where there is an acute shortage of land availability, due to which, at times, the schools face functional difficulties in increasing additional sections beyond the permissible limit, even when there is a demand for new admissions.

The schools also find it difficult to meet the section student ratio of 1:40 with pressure for new admissions, but are unable to add additional sections due to the limit of permissible sections as per land criteria," said CBSE Secretary Himanshu Gupta.

Gupta said that the board has now decided that the maximum number of sections in a school will be permitted based on the total built-up carpet area of the school building.

"The built-up carpet area of the school building has to be certified by the local body or a licensed architect, or as the case may be. The land area shall be utilised only for the purpose of deciding the category of the schools--Branch School, Middle Level School, Secondary Level and Senior Secondary Level as per affiliation bye-laws," he said.

"The school shall be allowed an equal number of sections at secondary level and at senior secondary level. The total number of sections permitted at secondary level -- class 9 and 10 and at senior secondary level--class 11 and 12, shall be restricted at each level to one-fourth of the total number of sections running in the school from Balvatika to class 10 and 12."

### 8 Air Accidents Killed 274 This Year: Govt

NEW DELHI: The government on Thursday said there have been eight air accidents that killed 274 people in the country so far this year.

Apart from the Air India plane crash on June 12 that killed 260 people, there were three trainee aircraft accidents and four helicopter accidents Minister of State for Civil

Aviation Murlidhar Mohol told the Lok Sabha that the cause of these accidents is under probe by the Aircraft Accident Investigation Bureau (AAIB). "There have been a total of 08

accidents (involving 1 scheduled aircraft, 3 trainee aircraft and 4 helicopters) reported in the year 2025 (till date)," he said in a written reply. On April 22, one person was

killed in a helicopter accident in Gujarat, while on May 8, six people died in a chopper crash in Uttarakhand.

In another helicopter accident in Uttarakhand, seven people were killed on June 15.

As many as 84 people were injured in the eight accidents, including 81 persons in the Air India plane crash.

There have been a total of 08 accidents (involving 1 scheduled aircraft, 3 trainee aircraft and 4 helicopters) reported in the year 2025 (till date),"

In a separate written reply, Mohol said a total of 18 accidents involving Indian civil registered scheduled aircraft have been reported from 2015 till date.

"Payment of compensation to the passenger or next of kin in case of death or bodily injury to the passenger, caused by air accident /incident is governed by the provisions of Carriage by Air Act, 1972.

"India has ratified the Montreal Convention, 1999 by making amendments to the Carriage by Air Act, 1972 in 2009.

As per the said act, the liability of payment of compensation in case of death, delay, damage or loss to persons, baggage or cargo for international carriage, is of the carriers," Mohol said.

### EC Finalises Electoral College | First Major Issue Whether Rohingyas Refugees Or Illegal Entrants: SC For Vice Presidential Poll

New Delhi- The Election Commission on Thursday said it has finalised the Electoral College for the vice presidential election, necessitated due to the resignation of Jagdeep Dhankhar from the post.

The vice president of India is elected by an Electoral College comprising the elected members and nominated members of the Rajya Sabha and the elected members of the Lok Sabha

In a statement, the poll authority said it has finalized the Electoral College list for the Vice Presidential Election, 2025.

The Electoral College list will be available for purchase at a counter set up in the Election Commission office from the date of notification, which is likely to be announced soon, the poll body said.

New Delhi-The Supreme Court on Thursday said the first major issue to be dealt with in cases concerning Rohingyas is whether they are refugees or illegal entrants.

A bench of Justices Surya Kant, Dipankar Datta and N Kotiswar Singh said once that is decided, the other issues might be consequential.

The court observed this while hearing a batch of pleas concerning Rohingyas in the country. "The first major issue is simple, are

they refugees or illegal entrants," Justice Kant observed.

The bench took note of the broad issues

that arise for its consideration in the pleas relating to Rohingyas

"Whether the Rohingyas are entitled to be declared as refugees? If so, what protections, privileges or rights they are entitled to?" the bench said.

It said the second issue is if the Rohingyas are not refugees and are illegal entrants, whether the action of the Centre and states in deporting them was justified.

"Even if the Rohingvas have been held to be illegal entrants, can they be detained indefinitely or they are entitled to be released on bail, subject to such conditions as the court may deem fit to be imposed?" it asked. The court said the other issue raised

in the petitions is whether the Rohingvas. who have not been detained and are living

in refugee camps, have been provided basic amenities like drinking water, sanitation and education.

"If the Rohingyas are illegal entrants, whether the Government of India and the states are obligated to deport them in accordance with law," it noted The bench segregated the pleas in

three groups — one relating to Rohingyas, another not pertaining to the issue of Rohingvas and one plea that it said pertains to a different matter altogether. It said the three groups of matters would

be determined separately and it would fix those for hearing on consecutive Wednesdays.

The bench indicated that on the point of those who were found to be illegal entrants and on the question of the State's

responsibility to deport them, it could only lay down the principles. During the hearing, the bench asked

why these petitions were tagged for hearing. The counsel appearing for the petitioners said there were overlapping issues in the pleas and one of the core issues per-

One of the lawyers said the Rohingyas cannot be detained indefinitely.

On May 16, the apex court had rapped some petitioners who had claimed that 43 Rohingya refugees, including women and children, were dropped in the Andaman sea for deportation to Myanmar and said "when the country is passing through a difficult time, you come out with fanciful ideas".

"Raids were conducted in Gorakhpur and Kanpur, eventually leading to the apprehension of the accused from Yashoda Nagar in Kanpur. During interrogation, Soni confessed to the theft and disclosed that he had hidden the stolen cash in an almirah at his residence," said the DCP.

A total of Rs 5.5 lakh in cash, an iPhone worth Rs 1.5 lakh, and a Motorola foldable mobile phone were recovered from his possession, police said.

Soni had already spent about Rs 1 lakh on clothes, accessories and a lavish lifestyle, police said.

"Soni was employed at the Karol Bagh shop where he committed the theft. He had allegedly planned the act in advance and procured duplicate keys to gain access to the shop outside business hours," said the officer.

Further investigation into the matter is underway, he added.

### **Teacher's Tip-Off Saves 13-Year-Old Bride in Telangana**

13-year-old girl from Ranga Reddy district in the southern Indian state of Telangana has been rescued from an illegal child marriage after her schoolteacher reported the incident to local authorities, according to an

The girl, a Class 8 student, was reportedly married off on May 28 to a 40-year-old married man, identified as Srinivas Goud, from Kandiwada village.

The marriage came to light when the girl confided in her teacher, who promptly informed district tahsildar Rajeshwar and police inspector Prasad.

Mother and others booked 'The girl lives with her mother and brother. Her mother had informed their landlord that she intended to marry off her daughter. A mediator then arranged the match with the 40-year-old man, and the marriage took place in May," said the police inspector.

The man, the girl's mother, the mediator, a priest who conducted the ceremony, and the man's wife have all been booked under the Prohibition of Child Marriage Act.

The minor has been placed in a Sakhi Centre for care and counselling. District Child Protection Officer Prawin Kumar said that the girl and the man had reportedly been cohabiting for nearly two months.

"If the girl was subjected to sexual activity, a case under the POCSO Act will be filed," Kumar said. Engaging in sexual relations with a minor constitutes a criminal offence under the Protection of Children from Sexual Offences (POCSO) Act.

### 17% Students Engage With **Family Work Post Matriculation'**

SRINAGAR: In Jammu and Kashmir at least 17 percent of students engage in family work after completing 10th standard, reveals a report of Ministry of Education (MoE).

Stating the status of 'students outside the educational system' the report said that, "Students exit the education system after Grade 10 because of different reasons like taking up a job, doing an apprenticeship, repeating the grade, and participating in family work."

It also said that the schools reported the exit of students through percentages (0-25 percent, 26-50 percent, 51-75 percent, 76-100 percent.

The MoE has taken a 50 benchmark to identify gaps in the system.

"Aspects that schools reported as 51-75 percent or 76-100 percent are considered as areas needing targeted interventions to reduce the percentage of students exiting the education system," it reads.

According to KNO, the report states that 13 percent students were taking up a job immediately after completing Grade X and 7 percent students were repeating the grade.

It also states that 17 percent of students were getting engaged in family work after completing Grade.

The report further reveals that 51 percent schools were offering career guidance for students in higher grades.

"Some students were reported to leave the formal education system after completing Grade X, either for employment or to support family work," it reads.

It also states that a small percentage were reported to repeat the grade. Career guidance services were available in a little over half the schools, which can play a significant role in helping students make informed decisions about their future.

"Expanding access to structured career counselling and support can help reduce dropout risks and promote continued education," reads the report.

# **Warwan Valley: Hidden Paradise Craving Development, Connectivity**

Locals Demand Tunnels, Internet, Basic Infrastructure To Unlock Its Tourism Potential

**SRINAGAR:** Located deep within the Marwah sub-division of Kishtwar district, Warwan Valley is a breathtaking region of unmatched natural beauty and immense untapped tourism potential.

Surrounded by snow-capped peaks, dense forests, glacial streams, and lush meadows, the valley could easily become a premier tourist destination. Yet, despite its scenic splendour, Warwan remains one of the most neglected areas in the Union Territory.

Situated at an altitude of over 7,000 feet, the Marwah-Warwan belt comprises approximately 15 villages, home to nearly 60,000 residents. For more than four to six months each year, the entire region is cut off from the rest of the world due to heavy snowfall and the absence of all-weather road connectivity.

"From December to April, we are completely disconnected. We have to stock essentials in advance to survive the winter," Mohammad Altaf, a resident of Afti village in Warwan, said. "Even during summer, the road to Anantnag is extremely dangerous and riddled with potholes. To reach our district headquarters in Kishtwar, we first have to travel via Anantnag through Margan Top and then circle back. It's both ironic and frustrating."

Residents allege that continuous administrative neglect has pushed the region into a state of helplessness. They said basic facilities such as internet connectivity, healthcare, education, and mobile network services are either absent or extremely

Travelling to Kishtwar is a daunting task for locals. Shaista



Begum, a college student from the area who travels to Anantnag in winters to pursue her studies, lamented, "There is no reliable mobile network. You have to walk to a specific spot to make a call. As for the internet, it doesn't exist here.'

Despite these hardships, tourists and trekkers who visit Warwan describe it as "Kashmir's hidden gem". Surrounded by majestic Himalayan ranges and traversed by the Marusudar River, a tributary of the Chenab, the valley boasts picturesque meadows and trails ideal for adventure tourism.

"This place is even more beautiful than Pahalgam or Gulmarg," said Rayees Ahmed, a nature photographer who visited last year. "But no one comes here because there are no hotels, no internet, and the roads are too risky. It has everything to become a tourist hotspot, yet it has been left behind."

Waqar Fayaz, a social activist from Shopian who recently visited Warwan, described it as "a true paradise, more beautiful than Pahalgam and Gulmarg". He said the area has a vast space available for tourism infrastructure that remains unutilised.

People from across Kashmir have been visiting Warwan for camping and exploration, but the region lacks basic amenities like bathrooms and other infrastructure, Fayaz added.

The local population has been demanding the construction of two tunnels: one connecting Marwah to Kishtwar and the other linking Warwan to Dardpora, Anantnag. These tunnels would drastically reduce travel time, ensure all-weather connectivity, and better integrate Warwan with the rest of Jammu and Kashmir, locals said.

"In every election, we are promised tunnels and development, but nothing happens," said Abdul Jabbar, a retired teacher from Basmani village. "If this were another place, projects would have started long ago. We are made to feel like secondclass citizens."

The absence of basic services, especially quality education and employment opportunities, has led to a steady migration of youth to towns like Anantnag, Doda, and Kishtwar. "I left my village three years ago because there are no proper educational facilities or job opportunities," said Shabir Dar, now living in Anantnag.

The residents have sought the attention of Lieutenant Governor Manoj Sinha and Chief Minister Omar Abdullah to address these issues—(KNO)

### **Petrol Pumps Observer News Service** SRINAGAR: Jammu & Kashmir, along with Ladakh, will see the addition of 677 new petrol pumps as part of a large-scale expansion by Public Sector Oil Marketing Companies (PSU OMCs), according to a written reply tabled in the Lok Sabha on

J&K, Ladakh To Get 677 New

Thursday. Minister of State for Petro-leum and Natural Gas, Suresh Gopi, as reported by KNO said the selection and setup of new retail outlets are being carried out based on field feasibility, demand potential, and transparent dealer selection processes.

As per the government data, 643 new petrol pump locations have been identified and advertised in Jammu and Kashmir, while 34 are planned for the Union Territory of Ladakh. These outlets are part of the 49,964 dealership slots advertised nationwide in June and July 2023. So far, Letters of Intent (LoIs) have been issued for over 23,000 of these locations, with more than 5,200 petrol pumps already operational as of July 1, 2025.

The ministry clarified that the process is being handled solely by PSU OMCs through online systems involving draws of lots or bidding to ensure transparency. The selection is



based on eligibility criteria outlined under dealership selection guidelines.

The government said the total PSU OMC network in the country currently stands at 88,526 outlets, including 25,705 in rural and remote areas. However, 3,095 outlets across India remain temporarily non-operational due to various reasons, including financial constraints, legal disputes, and low sales. At present, there are no plans to repurpose these sites.

The expansion aims to enhance fuel accessibility, especially in rural and underserved regions such as parts of Jammu, Kashmir Valley, Kargil, and Leh.

### Govt Teacher, 3 Others Booked For Fake Torture Claims In Rajouri

RAJOURI/JAMMU: Police on Thursday booked four individuals, including a government teacher, for allegedly fabricating a false narrative of police torture and spreading misinformation through social media in Jammu and Kashmir's Rajouri district, officials said.

The case pertains to a photograph that recently went viral, showing a man - identified as Mohammad Arif of Gundi in Khawas - with what appeared to be blood on his chin and around his mouth. It was claimed that he had been brutally beaten at the Khawas police post in Rajouri, resulting in serious injuries and the breaking of three teeth, they said.

Taking the matter seriously, the police launched investigation.

Budhal Superintendent of Police (Operations) Wajahat Hussain was appointed as the inquiry officer to thoroughly examine the allegations, they

According to police officials, the probe revealed that the entire story was fabricated. "Not only was the torture claim found to be false but it was also discovered that a colouring agent had been applied to Arif's face to mimic blood stains and injuries, in an apparent attempt to mislead the public."

Following the inquiry, an FIR was registered against four people at Budhal police station under relevant legal sections.

The four individuals, including Arif, booked in the case have been identified as Sarfaraz Ahmed, Shakil Ahmed and Mohammad Ashraf (a government teacher), all residents of Gundi in Khawas tehsil. The police said further legal action and investigation are underway to ensure accountability in the case.

# Zojila Tunnel Completion Pushed To 2028: Govt

**SRINAGAR:** The Zojila Tunnel project in Jammu and Kashmir, which aims to provide allweather connectivity between Srinagar and Leh, is now expected to be completed by February 2028, Union Minister for Road Transport and Highways Nitin Gadkari informed the Lok Sabha on Thursday.

Responding to a question by Ganderbal MP Mian Altaf Ahmad, Gadkari said the initial deadline for the project was September 29, 2026. However, delays caused by the COVID-19 pandemic, a terrorist attack at



the nearby Sonamarg Tunnel Project and extreme weather conditions have pushed the completion date further.

The tunnel, which is being executed by the National Highways Infrastructure Development Corporation Limit-

ed (NHIDCL), has achieved 64% physical progress as of now.

The total estimated cost of the project is Rs 6,809 crore, out of which Rs 3,934.42 crore has been spent so far, the minister stated. A total of 1,141 workers are currently employed in the project Of these, 77% are from the Union Territory of Jammu and Kashmir, and 28% of the workforce is specifically from Ganderbal district, where the project is located.

The Zojila Tunnel, once completed, will significantly improve connectivity to Ladakh and is considered a strategic infrastructure initiative by the central government.

### 'Zero Power Deficit During Peak Summers For 3rd Consecutive Year'

SRINAGAR: In a major achievement, the Union Ministry of Power Thursday said that J&K has maintained 100 percent electricity availability during the peak summer monthsfrom April to June for the third consecutive year.

This marks a dramatic improvement from the acute power deficits recorded in previous years, particularly 2020. According to a written reply

to Unstarred Question in the Rajya Sabha by Minister of State for Power, Shripad Naik said that J&K has successfully met its entire electricity peak demand in the months of April to June for the past three years, reversing the worrying trend seen earlier in 2020 and 2021

As per KNO, during the summer months of April to June 2020, Jammu and Kashmir faced a significant electricity shortage. The peak demand stood at 2,940 MW, but only 2,352 MW could be supplied, resulting in a deficit of 588 MW, which translated to a 20 percent shortfall in meeting the region's power needs.

In the following year, 2021, the situation improved moderately. The peak electricity demand increased slightly to 3,018 MW, of which 2,668 MW was met. This left a deficit of 350 MW, equivalent to a shortfall of 11.6%.



By 2022, Jammu and Kashmir achieved a remarkable turnaround. For the first time in the five-year period, the entire peak demand of 2,723 MW during the April to June period was fully met, resulting in zero power deficit.

This positive trend continued into 2023, when the region recorded a peak demand of 2,890 MW, all of which was successfully supplied without any shortage.

In 2024, the upward momentum was maintained. Jammu

and Kashmir's peak summer demand rose slightly to 2,924 MW, yet the entire requirement was met, reaffirming the region's improved electricity management and supply capabilities. As per the latest figures for

2025 (up to June), the Union Ter-

ritory has sustained this perfor-

mance, meeting its entire peak

demand of 2,906 MW with no

reported deficit, marking three consecutive years of 100% power availability during the summer peak period. The sharp decline in the demand-supply gap is being seen as a reflection of infrastructure upgrades, better resource planning, and central support through power allocation from Central Generating Stations.

Officials attribute this achievement to continued support from the Union Government, which has implemented key reforms in grid management, enhanced hydroelectric generation schedules, and facilitated participation in the Real-Time Market (RTM) for electricity. These measures have collectively played a crucial role in maintaining uninterrupted power supply during peak summer demand.

In contrast, states such as Kerala and Jharkhand have continued to experience electricity shortfalls during the same period. Jammu and Kashmir's consistent zero-deficit record stands out as a noteworthy example of effective power sector planning, especially considering its difficult terrain and historically complex grid infrastructure.

The uninterrupted power availability is also seen as a catalyst for growth in key sectors like industry and tourism, both of which rely heavily on stable and reliable electricity to function efficiently.

### **Burdened By EMIs**

re young Kashmiri government employees falling into debt trap, in pursuit of what they believe to be a wise, early investment into buying a house for themselves? A report in this newspaper cites examples of the young employees locked into decades-long housing loans.

At first glance, housing loans seem like a win-win: Tax exemptions, bank incentives, and the cultural prestige of homeownership combine to create a powerful lure. Initially, it appears like you have to pay a modest EMI for a lifetime asset, but beneath this optimism lies a more sobering reality. For example, a housing loan of Rs 40–50 lakhs translates into EMIs of Rs 35,000–40,000 per month. This is nearly half the take-home pay of a mid-level government employee. And during the first several years, those payments go mostly toward interest, not the principal. As time passes, and the interest accumulates, the EMI keep nibbling away at the salary and savings.

One of the major factors behind this debt trap are the cultural expectations. In the Valley, , owning a home has become a status symbol. It is like a rite of passage, a marker of responsibility and success. This social pressure often overrides rational planning. Houses are built for future generations rather than present needs, grand in structure, which make little financial sense.

Financial literacy is the missing link here. Young employees are rarely taught about opportunity cost, how a portion of their loan amount could have been used to start a small business, invest in higher education, or build diversified savings. There are some good examples too quoted in our story. Many people who delayed their home loan and instead built a business, find themselves better placed. That's the kind of planning we need more of.

It's time we shift the conversation around loans from tax saving to long-term value. A home should make us secure, not financially vulnerable. So, one thing that people in the Valley need is financial literacy, more so the government employees. And this shouldn't just be about constructing a house on loan but managing finances as a whole. The people need to know that investing in businesses at a younger age is more productive than investing in a house. Or for that matter, investing in mutual funds and the allied financial products is a better long-term financial strategy than depositing money in banks.

inancial mistakes come at a high cost in Kashmir, where jobs are scarce and incomes modest. Yet many rush into car loans, drawn by status or impulse, without weighing the long-term hit.

Banks thrive on interest gaps, offering 5% on savings and charging 10% or more on loans. It's profit for them, pressure for you.

A car loses over 70% of its value in ten years, yet many sign up for loans lasting five to seven years. By the time the car ages, the debt often lingers.

These decisions can backfire in a region already facing economic strain. A flashy car may feel like progress, but it's often a costly distraction. Before borrowing, ask: Do I need this? Can I manage without it?

Too often, people ignore what they already have - savings, assets, stability - and opt for loans that bring short-term joy and long-term stress. And when trouble hits, there's little safety net.

Financial discipline is about respect for your work, money, and future. With basic online tools, anyone can calculate risks. Yet the real change comes from within, from resisting trends and choosing what truly matters.

Wise financial choices are no longer optional in the valley. They're essential. Choose needs over wants. Protect what you've built. A car might turn heads, but debt can break backs.

# When Doctors Become Vloggers

The secret filming of patients during labour at LD Hospital is a shameful breach of medical and moral trust.

abour rooms are meant to be safe spaces. It's where women go through some of the hardest hours of their lives. They trust doctors and nurses to care not just for their bodies, but their dignity too.

At LD Hospital in Srinagar, that trust was broken.

Videos of women in their most vulnerable moments were posted on social media by some medicos, as if they were part of a reality show.

Beyond thoughtless behaviour, this is a deep, deliberate violation. It shows how far some have drifted from the values that medicine is supposed to uphold.

Kashmir is a region already strained when it comes to healthcare access. Many women in rural districts rely on overstretched public hospitals.

LD Hospital, one of the largest maternity centers in the valley, sees thousands of births each year. For most patients, especially those from modest backgrounds, this is the only place they can afford.

But what should have been a safe medical experience has now become a source of shame.

These women didn't sign up to become content for strangers' phone screens. They came for care, help, and dignity.

Filming someone without permission is wrong. Doing so in a hospital, during childbirth, crosses into cruelty. Nothing about it was clinical. It was a breach, private pain turned into public content.

There's a word in Islamic teachings that defines a woman's body: awrah. It means something private, and sacred.

Our religious ethics teach us to guard dignity (karamah), preserve privacy (satr), and remain accountable (hisab). That's especially true in medicine.

The Prophet Muhammad (PBUH) advised that even in medi-

cal care, exposure should be limited and, where possible, handled by

someone of the same gender.
Filming women during childbirth without consent breaks every one of those principles. It's a betrayal of trust, faith, and law.

And yet, in some hospital corri-

dors, we're seeing a shift.

Young medics, instead of focusing on empathy and ethics, are seeking viral fame. Smartphones have become tools of distraction. The white coat, once worn with reverence, is being worn for visibility.

That change is dangerous. Patients, especially women in labour, are at the mercy of the people around them. They rely on caregivers to offer more than just medical support. They need respect, compassion, and a sense that they are safe.

When hospitals fail to guarantee that, they fail their core mission.

Consent isn't complicated. You

Consent isn't complicated. You don't record someone in pain without asking. You don't trade their privacy for popularity.

Hospitals in Kashmir need to take urgent steps. Clear rules must be set about phone usage in labour rooms. Recording without written consent must be banned and punished. Oversight should be strict, especially in maternity wards where emotional and physical vulnerability is at its highest.

We also need to rethink staffing. When possible, labour wards should be staffed by female professionals. It's not just a religious concern. It's about comfort.

A woman in labour shouldn't have to endure the additional stress of male eyes, especially in a society where modesty matters deeply.

This is about culture, ethics, and humanity.

Women in Kashmir face enough challenges: limited resources, stigma around reproductive health, long distances to reach hospitals. They shouldn't have to fear humiliation in the place they go to give birth.

What happened at LD Hospital wasn't a slip. It was a choice, to film, share, and shame.

The medical community in Kashmir, and across India, must decide what type of care it wants to stand for. The one that heals, or humiliates?

The line between the two is clear. And women deserve to know which side their doctors are on.

### 1,200 Kilos of Rotten Meat: What Are Kashmiris Really Eating?

he seizure of 1,200 kilos of rotting meat in Srinagar is a warning to every Kashmiri who eats, cooks, or serves food. This foul and frozen filth nearly reached local markets and dinner plates before enforcement officers stepped in and destroyed it on Thursday afternoon.

Clearly, Kashmir is seeing a food safety breakdown. From street vendors to popular restaurants, hygiene has slipped into the background. The rush to meet growing demand, especially from tourists, has outpaced the system meant to regulate it. Walk through any bazaar and it's clear: the basics are being ignored.

Meat hangs in the open under dusty tarpaulins. Raw chicken lies uncovered, feet from open drains. Sweet trays are left exposed to flies. Food is sold near garbage dumps.

Vendors touch raw and cooked items without washing hands. None of this is rare. It's the daily scene.

And the consequences are aleady here. Hospitals are treating more cases

of foodborne illness. Doctors report rising stomach infections, fevers, and drug-resistant bacteria.

The poor suffer the most. Fami-

The poor suffer the most. Families without access to private care are stuck waiting in overcrowded government hospitals, often without a clear diagnosis.

Bad food has become a public

Bad food has become a public burden. What's worse is how casually this risk is being allowed to grow. Food inspection isn't consistent. Licenses aren't verified. Storage standards are overlooked.

In many districts, health officials act only during festivals or when there's public outrage. That's too lit-

tle, too late. The spr

The spread of eateries and dhabas, especially in tourist hubs like Pahalgam, Gulmarg, or Srinagar's old city, has brought economic gains. But what's served on those plates is often unchecked.

Without regular enforcement, food becomes a gamble. And no one should have to gamble with what they eat.

Spoiled meat, reused oil, unclean kitchens are symptoms of a system with weak controls and little fear of being caught. Most violations go unnoticed. Even when raids happen, fines are light and closures are temporary. There's no deterrent.

This is where the government must step in with clarity and consistency. Food safety inspections should be routine, visible, and followed up. Cold chains must be verified, es-

pecially for meat, dairy, and fish. Hygiene logs should be made public. Food licenses must be displayed clearly in every outlet.

Let's be clear: enforcement isn't harassment. It's protection for the mother buying meat for her children, the tourist enjoying wazwan, and the schoolchild buying snacks on the way home.

Every unsafe meal puts someone at risk. Every ignored violation makes that risk bigger.

We need more than promises. Kashmir needs a food safety system that works every day, in every district.

# Cast in Copper

In a world of fakes and fading markets, Kashmiri coppersmiths are holding fire, memory, and craft with unshaken hands.

n Srinagar's Zaina Kadal, one shop still smells of charcoal, chalk, and cardamom. A family has worked this fire for three generations. Outside, the world has turned fast and weightless. Inside, Mushtaq Ahmed listens to copper: heavy, slow, and stubbornly alive.

He is 63, born above the same copper shop he now runs. The room is gone. The river behind it still flows. His father's anvil still waits by the window.

"This is naqashi," he says, tapping a chisel against a polished surface. The sound is hollow, then firm. "We do it by hand, always have."

His hands bear fine scars, a record of all he's etched, carved, and shaped into permanence. The patterns are not random. They have roots in Persian design, Kashmiri nature, and memory: Flowers, vines, prayers.

Sometimes he adds a name, sometimes a date. The copper, he believes, remembers everything.

Long before machines hummed, Kashmir's copperware was functional art, a presence in every home. Families gathered around a trami to eat Wazwan, fingers brushing over the carved edge. The samovar sat like an elder in the center of every winter morning, hissing out noon chai, green and salted.

Copper bowls cradled food, water, and ceremony. Even death had copper. The tashtnari used to wash the deceased before burial. They were the vessels of daily life, and

held our routines, grief, and joy. And they were heavy, both in mass and meaning. For generations, the coppersmith community were the custodians of this craft. Their knowledge moved from wrist to wrist,

across workshops.

A boy learned by sitting beside his father, watching the angle of his tools, the silence before each stroke. A real piece took days to make, sometimes longer.

Mushtaq still works like that. He refuses shortcuts. "If it's too clean, shiny, and fast," he says, "then it's fake."

He can feel the machine's lie in the metal. A handmade bowl has flaws: a line too thick, a swirl that veers. These are the human fingerprints, the proof of presence.



And yet, the fakes are everywhere now. Markets from Lal Chowk to Mumbai brim with factory-stamped copperware. They look close enough, with copied designs and traced patterns, but they lack depth.

Most come from Moradabad, mass-produced, hollow in body and soul. Some even carry forged "Kashmir Handicraft" labels. Tourists buy them. Even locals, pressed for cash or unaware of the difference, take them home.

"They sell faster because they're cheaper," Mushtaq says. "But what are they really buying?" This flood of imitation has done more than confuse buyers. It has broken the chain.

When the market values speed over skill, fewer artisans remain. Fewer boys enter the trade. Apprenticeships shrink, workshops close, and with them, something ancient slips away. "We are becoming fewer," Mushtaq says.

Some families still hold on. In the countryside, copper vessels remain part of the dowry, wrapped in wool, packed like gold. In downtown Srinagar, old women polish their tramis on festive occasions, fingers moving as they did for their mothers.

There is still water drunk from copper cups. There are weddings where the samovar is placed in the center like a blessing. And there is health, too, passed down

from oral wisdom. Copper is said to purify water, ease diges-

tion, balance the body's energies. In homes across the valley, elders insist that copper cools the stomach and steadies the nerves. Science has confirmed some of it: copper kills bacteria and conducts healing. Yet even this knowledge is thinning.

The challenge isn't only about protecting a product. It's about keeping a conversation alive, between generations, and between hands and memory.

For that, copper needs more than nostalgia. It needs investment, intention, and

Some steps have begun. Srinagar hosts an-

nual exhibitions where authentic copperware is placed beside carpets and Pashmina. NGOs have launched labeling campaigns to help buyers distinguish the genuine from the spurious.

Some schools have arranged field visits to copper workshops, letting students witness the slow pulse of handcraft. A few artisans have taken to Instagram, filming their chisels at work, reaching eyes in places they've never been.

But these are still scattered efforts. What's needed is a framework, a way to protect, promote, and pass on.

Artisan cooperatives could give collective strength. Certification systems could restore trust. Artist-in-residence programs and copper museum trails could turn artisans into teachers. Tourism can help too through real encounters. Let people walk into the workshop, touch the metal, smell the coal.

There is also hope beyond borders. The world is hungry for handmade, sustainable, heritage-rich objects. If properly branded and supported, Kashmiri copperware could find its

place on global tables, as art, utility, and story. We've seen this happen before.

Banarasi silk revived through storytelling. Pashmina saved through GI tags and ethical trade models. Kashmiri copper can follow the same arc, if its story is told with care.

The educator Aubaid Akhoon writes: "A legacy is a gift from our ancestors. It carries the pulse of tradition and values, which become our guide through modern life."

He calls for awareness, education, and inclusion to inspire new thinkers to reimagine

# A Therapist's Trauma

At a de-addiction centre in Kashmir, I see schoolboys with needle scars and mothers with trembling hands. The drug crisis is eating away our future.

The boy in front of me looked about sixteen. His school shoes were scuffed, his uniform shirt hung loose from his shoulders. He didn't say a word as he sat down across from me.

His mother stood behind him, holding a plastic bag with some clothes. Her hands didn't stop shaking. The boy had been using heroin for over a year. That morning, he had collapsed on their kitchen floor.

I work at a drug de-addiction facility in Kashmir. I've met hundreds of boys like him. They arrive with hollow cheeks and infected veins. Their parents often carry guilt on their faces, as if their love failed.

What used to be a rare tragedy in Kashmir has turned into a daily reality. We are watching an entire generation slide into addiction and disappear. And many are watching in silence.

I've seen heroin take over lives faster than any storm. At first, it was whispers: "he's fallen into bad company," "she doesn't come home anymore."

Now, addiction walks the streets in broad daylight. Children skip school to find a fix. Hospitals report growing infections linked to shared needles. Shopkeepers know who the local addicts are. Some families hide it. Others run out of money, options, and strength.

According to data from 2023, around one million people in Jammu and Kashmir, about 8 to 10 percent of the population, are affected by substance abuse. More than half of them use opioids, mostly heroin. A report by the Institute of Mental Health

and Neurosciences (IMHANS) says that 33,000 syringes are used every day in the valley. That number haunts me. At our centre, led by the Psychiatry and De-addiction Department under Dr. Tajamul Hussain, we try to help whoever walks through our doors.

My colleagues, Syed Sameer and Farooq Ahmad, both psychiatric social counsellors, work patiently with families who have nearly lost hope. Kifayat, a nurse, manages the de-addiction counter with remarkable steadiness. Together,

we've seen hundreds arrive in pain, and a few walk away on the path to healing. But recovery isn't easy. Many relapse, some

vanish, and a few die. What's worse is the atmosphere of mistrust

that now surrounds our hospitals. I've seen patients denied lifesaving injections simply because the staff thought they "looked like addicts." Insulin syringes are refused to people with diabetes. Emergency medicines are withheld. In some cases, these delays nearly cost lives. We are in a strange place where the pain of the genuine is overshadowed by fear of the addicted. Suspicion has replaced compassion. That

is the most painful part of this crisis. Law enforcement is trying to keep up. In the last four years, over 9,400 people have been arrested in I&K under the Narcotic Drugs and Psychotropic Substances (NDPS) Act.

In 2023 alone, 3,190 cases were registered, double the figure from just a few years ago. But arrests alone won't solve this. Addiction isn't just a crime. It's a wound that needs care.

The first step is expanding de-addiction services. Right now, most centres are overburdened and poorly equipped. Many families can't afford the long travel or the long wait. We need facilities in every district, staffed with trained professionals.

We also need community support: programmes in schools, outreach in villages, and counselling that goes beyond the clinic.

We must stop treating addicts as criminals or moral failures. Addiction can affect anyone: your neighbour's son, your friend's brother, your own child. The stigma stops people from seeking help. And when families hide the problem, the damage only grows.

I once met a man who sold his orchard to send his son to rehab. The boy didn't survive. The father still visits our centre sometimes, handing out tea to other patients. "At least some can be saved," he told me. That sentence has stayed with me.

This isn't about statistics. It's about lives. It's about the mother who hasn't slept in weeks, waiting for her son to come home. The father who spends his pension on medicine that may not work. The young girl who stopped going to school because her brother's addiction became the neighbourhood's shame.

Kashmir has endured conflict, curfews, and lockdowns. This crisis is different. It's internal. It spreads silently, from house to house, from child to child. If we don't act now, we won't just lose individuals. We'll lose what binds us together.

Every time I walk into the de-addiction centre, I hope that the next patient will make it. That this time, the story will end in healing. But hope is no substitute for action. We need policies, funding, and most of all, empathy.

From where I sit, the paradise they speak of is bleeding, and our young are slipping away with the syringe still in their hands.

In a small Srinagar shop, a search for silk becomes a journey through memory, language, and life's little ironies.

called the shopkeeper on a Sunday. I wanted to buy a couple of Kashmiri silk scarves and had some time to spare. I wasn't sure if his shop would be open, but I decided to check.

Years ago, I had ordered a veil for my lehenga from him. Despite a lockdown at the time, he had gone out of his way to deliver it on time. I remember his kindness.

Now, after all these years, I found his number on Google and called. He said the shop was closed for the day but asked me to come by at 11 the next morning.

By 11:30 am the next day, I was at the shopping complex. He did not show up until around 12:15. Just as I was about to give up, he arrived.

I have noticed something strange about how the universe works: Answers seem to arrive just as you're ready to walk away. When I once shared this observation with a wise friend, he joked, "Then giving up must be the real solution."

"You're very late, sir," I said when he finally arrived. He is a thin figure, probably in his early sixties, with a cheerful, comical air.

"No, no. Today is the only time I've come this late," he defended himself.

"Well, the other shopkeepers told me you always open after noon," I replied. "Basically, I'm very loved by my family," he said with a grin. "I try to leave early, but they hold me back. These other shopkeepers are burdens to their

families." He said it casually.
"I see. Can you now show me some nice scarves?" I asked. "Wait, are you the one who called

yesterday? And again this morning?" He asked, surprised. "Yes," I said. "I thought you were an old woman,"

he said bluntly, like a child. "Why do you speak like that?" It reminded me of when I was 12 and used to speak regularly on the phone with my uncle's fiancée. When we fi-

nally met, she nearly fainted. She had imagined I was a grown-up. About seven years ago, I'd felt embarrassed when I couldn't respond gracefully in Kashmiri to a doctor, the way



I could in Urdu. Since then, I made it a point to speak in Kashmiri with professionals and strangers alike. But apparently, this shopkeeper thought I now needed an update.

"If I speak in English, people call me an angrez!" I told him.

"Where did you get my number from?" he asked.

"Why should I tell you?" I spoke with a touch of dry-humour. "I just thought maybe you're an old

customer." "I've been here before," I nodded. He then tried to convince me to buy scarves that were about half the price

of the real silk. "These are good too," he said. But I wanted the Kashmiri ones. I asked him about the material and how to care for it. He explained, "I have a government license for this silk. I can't sell faulty

goods. If I do, they'll grill me. And anyway, Aisha ji should want to come back to this shop after using the product." "How do you know my name?" I

asked, genuinely surprised. "Truecaller. It shows your name with

the number," he replied matter-of-factly. "Meh wento... Please tell me..." was going to ask about the price when a Kashmiri couplet popped into my mind. I recited it playfully:

"Meh wanti kyah gonah korum haqq panun mongum agar?" Tell me, what sin did I commit by asking for my right?

"I was at a mushaira yesterday," he

said, mock offended. "You should've told me, I'd have taken you along! "Well, these lines aren't mine," I con-

fessed. "No, no. Tell me something you've written yourself."

"She writes in English," my friend who was with me chimed in. "I don't want to hear anything in Eng-

lish," he said, disappointed.
"Okay," I said, "Here are a few lines I wrote once in Urdu: Bahut der hogayi

Mein ghadi pe ghadi ginti reh gayi Pehr pe pehr, seher se shaam hogayi Lagta hai meri himmat tamaam hogayi (It is getting very late. I have been counting each moment. The dawn has set into dusk. And I am losing every

ounce of strength.)" "But I never wrote beyond that," I added.

As he folded the scarves, he grew serious. "Stay away from such things," he

"Why?" I asked, though I already knew what he meant.

"You'll lose touch with reality if you go too deep."

I smiled and agreed. I often remind myself: Neither Buddha nor Sheikh-ul-Aalam (RA) stayed in the woods forever. They returned from their retreats, and changed the world.

As I was leaving, he said again, "For God's sake, be youthful! Speak like young people do.

Maybe I should learn a thing or two from my younger sibling, who I saw having muesli for breakfast with two scoops of vanilla ice cream and a couple of cucumber slices. I was left dumbfounded by the combination.

The silk scarf, he told me, will last a hundred years. So I'm saving it for my children, along with other heirlooms, so one day, they'll own antiques from their great-grandmother. Maybe they'll sell them in hard times.

That's what a philosophical mind does. It dreams long and far, sometimes too far from the reality.

### India Fastest Growing Major Economy In World: Goyal

NEW DELHI- With US President Donald Trump terming India and Russia as "dead economies", Commerce and Industry Minister Piyush Goyal on Thursday asserted in Parliament that India is the world's fastest-growing major economy and will soon become the third largest.

In a suo motu statement on Trump tariffs in both houses of Parliament, he said international institutions and economists see India as the bright spot in the global economy.

India is contributing to almost 16 per cent of global growth, he said, adding that it is also widely expected that "we will become the third largest" economy in a few years.

"In just over a decade, India has rapidly transformed from being one of the Fragile 5 to the fastest-growing major economy in the world. We have risen from the 11th largest economy to one of the top 5 economies, driven by our reforms, the hard work of our farmers, MSMEs and entrepreneurs," Goyal said.

The remarks are important as Trump has once again mounted a sharp attack on India and Russia for their close ties, saying he doesn't care what New India does with Moscow.

"I don't care what India does



with Russia. They can take their dead economies down together, for all I care," Trump said, adding that "we have done very little business with India, their tariffs are too high, among the highest in the world".

Goyal further said that in the last decade, the government has taken transformative measures to promote India as the manufacturing hub of the world.

India's young, skilled and talented workforce is driving innovation and competitiveness of the Indian industry, he said.

"Our exports have steadily increased during the last 11 years. In an increasingly protectionist world, India has done mutually beneficial trade agreements with the UAE, UK, Australia and EFTA (European Free Trade Area) countries," Goyal said.

"We are also committed to similar trade agreements with other countries." he added.

### Sensex, Nifty Decline On Concerns Over US Tariff Imposition

MUMBAI- Equity benchmark indices Sensex and Nifty ended lower on Thursday after US President Donald Trump announced the imposition of a 25 per cent tariff on all goods coming from India starting August 1 and an unspecified penalty for buying Russian crude oil and military equipment.

Despite the weak start, the indices staged a sharp recovery, but selling pressure reemerged towards the fag of the session. However, buying in some heavyweight stocks restricted the downward trend, traders said.

Halting its two-day rally, the 30-share BSE index declined 296.28 points, or 0.36 per cent, to settle at 81,185.58 after recovering some lost ground during the afternoon trade. During the morning session, the gauge tanked 786.71 points, or 0.96 per cent, to 80,695.15. As many as 2,418 stocks declined, while 1,598 advanced and 137 remained unchanged on the BSE.

The 50-share NSE Nifty dropped 86.70 points or 0.35 per cent to 24,768.35.

"Following a turbulent start driven by fresh tariff threats, the Indian market started on a pessimistic note. However, the domestic market attempted a strong recovery, but by the end of the day, it closed with marginal losses on a monthly expiry day.

"Investors gravitated toward domestically oriented, non-discretionary players, especially FMCG, which offered attractive valuations, demand outlook and relative insulation from tariff risks. In contrast, oil & gas stocks were the worst hit due to US warnings over Indian energy imports," Vinod Nair, Head of Research, Geojit Investments Limited, said.

The announcement is being seen as a pressure tactic to get New Delhi to agree to demands made by the US, which has, in recent days, got favourable trade deals with major partners like Japan, the UK and the Euro-

The penalty was announced as India has made large purchases of oil and military equipment from Russia. India is the first country to face a penalty for Russian imports.

From the Sensex firms, Tata Steel, Sun Pharma, Reliance Industries, Adani Ports, NTPC and Asian Paints were among the biggest laggards.

However, FMCG major Hindustan Unilever Ltd (HUL) jumped 3.48 per cent after the firm reported a 5.97 per cent rise in its consolidated net profit to Rs 2,768 crore for the June quarter of FY26, helped by gains from a re-estimation of taxes paid in the previous year.

# Trump: India, Russia Can Take Their Dead Economies Down Together

WASHINGTON/NEW DELHI-India and Russia can take their "dead economies down together", US President Donald Trump has said in a fresh attack on the two countries for their close trade ties even as New Delhi continued to analyse the possible impact of his decision to impose 25 per cent tariffs on Indian goods.

In its reaction, India said it will take all necessary steps to safeguard and promote national interest and that the implications of the tariffs are being examined.

The US president's diatribe came hours after he announced 25 per cent tariffs against India from August 1, along with an unspecified "penalty" to punish New Delhi for continuing to procure crude oil from Russia notwithstanding the Western sanctions.

"I don't care what India does with Russia. They can take their dead economies down together, for all I care," he said.

"We have done very little business with India, their Tariffs are too high, among the highest in the World," he added.

Russia remained India's top oil supplier in the last few months.

"The government attaches the utmost importance to protecting and promoting the welfare of our farmers, workers, entrepreneurs, exporters, MSMEs and all sections of industry. We will

### Ladakh's Quest For Identity Of Its Pashmina Wool Gets Helping Hand From Cooperative Society

**LEH-** For the people of Ladakh, Pashmina wool is more than just a product—it's a symbol of identity and a major engine for economic prosperity.

Though Ladakh is the sole re-

gion in India that produces this prized wool, its people are still striving for full recognition of that fact, and helping the cause is a cooperative society that looks after the production and marketing of the super-fine wool.

The All Changthang Pashmina Growers Cooperative Marketing Society has been working since 1995 to ensure that the Pashmina wool fetches the maximum price for its producers, the nomadic herders of Ladakh.

Since 2004, the cooperative has been procuring the raw wool from these herders and processing it into the finest Pashmina wool at its plant here, an official said.

"Our main purpose of this cooperative is to fetch the maximum and remunerative prices for this Changthang product, Pashmina. And to achieve that, we have been consistently working. Managing to sustain and survive is a testimony of the success," the cooperative society's general secretary Thinless Nurboo told PTI here.

There are two pockets where Pashmina wool is produced, and Changthang is the major one, he said.

"History of Pashmina has



been very interesting...when we were with Jammu and Kashmir, we were in a larger state. And I believe we were seeking UT to find identity not just for ourselves, but also for our economy and products. So, I think Pashmina is definitely a product which has been finding its own identity," Nurboo said, stressing the importance of this unique product for the people here.

The Geographical Indication (GI) certification of Pashmina wool has been a boost, though some technical processes are still to be completed, he added.

Nurboo said the sourcing of

Nurboo said the sourcing of raw wool is done from 600-650 families across Ladakh.

From owners of international brands to local self-help groups (SHGs) and weavers, they procure the refined wool from the cooperative society.

"Å lot of international brands keep coming and asking for quotations. One of the major clients for the last 2-3 years has been the Italian entity Brunello Cucinelli. They are not only buying the Pashmina but also supporting this whole nomadic lifestyle," the cooperative official said.

# India's Gold Demand In 2025 To Fall To 5-Year Low On Record Prices: WGC

India's gold consumption in 2025 is set to fall to a five-year low, as record-high prices are denting jewellery purchases, overshadowing a slight boost in investment demand, the World Gold Council said on Thursday.

Gold demand in the world's second-biggest consumer of the precious metal could stand between 600 metric tons in 2025, the lowest since 2020, and down from last year's 802.8 tons, Sachin Jain, CEO of WGC's Indian operations, told Reuters.

Demand could reach 700 tons if prices stabilise, but a 10%–15% price rise driven by geopolitical factors may pull it down to the lower end of the range, he said.

Local gold prices, which

### New Rules For Mussoorie Tourists: No Entry Without Online Check-In

ussoorie - The tourists visiting Mussoorie will now have to register their details on a portal developed by the Uttarakhand Tourism Department at the time of check-in, an official on Thursday said.

District Tourism Officer Brijendra Pandey said that the new rule came into force on Wednesday.

Hotels, guest houses, homestays and other such facilities have to first register themselves on the portal and do the registration of their guests as they check-in, he added. Pandey said this is being done to deal with overcrowding and managing traffic at the popular tourist spot.

The new rule had to be introduced as the arrival of

tourists in the town have almost doubled between 2022 and 2024, he added. "The move will provide

real-time data on tourist

footfall in the town," Pandey said.

Hoteliers and owners of similar facilities have been asked to comply with the

similar facilities have been asked to comply with the new rule, he added. Earlier in May, the Na-

tional Green Tribunal (NGT) had asked the state government to initiate tourist registration in the hill station and submit data regularly.

To manage overwhelming crowds and traffic jams in the popular hill station, the Dehradun administration planned to implement a mandatory pre-registration system for tourists visiting Mussoorie during the peak season.

Mussoorie has witnessed

a sharp rise in tourist numbers, with over 21 lakh visitors recorded in 2024, up from 11 lakh in 2022. This surge has led to severe congestion, especially on the stretch from Gandhi Chowk to Mall Road.

Accommodation providers will first need to register their establishment on the portal with the following details:

1. Name and contact number of the owner 2. Type of facility (hotel, homestay, etc.)

3. Name of the property
4. Number of rooms and total guest capacity
Once this is completed.

Once this is completed, guest registration can be carried out by the facility during check-in.

In addition to hotel-

based registration, tourists will have to pre-register before entering Mussoorie.

### AI To Impact 1.8 Crore Jobs By 2030: Report

anufacturing, retail and education sectors are staring at a "seismic" shift due to agentic artificial intelligence, and over 1.8 crore jobs are set to be impacted in these sectors by 2030 due to new-age technologies, a report said on Wednesday.

Manufacturing jobs will bear the highest impact with 80 lakh workers to be affected, closely followed with retail with 76 lakh jobs to be impacted and education jobs impact is pegged at 25 lakh over the next five years, as per the report by ServiceNow.

The report specified that high-automation roles such as change managers and payroll clerks are being redefined by AI agents that take over routine coordination, while "high-augmentation" roles such as implementation consultants and system admins are increasingly partnering with AI, and not competing with it.

There is widespread concern on the impact of AI on jobs, and after country's largest IT services company TCS announced to cull 12,000 jobs accounting for 2 per cent of the overall workforce due to aspects including artificial intelligence. Sumeet Mathur, managing director for ServiceNow India Technology and Business Centre, said agentic AI would create over 30 lakh new technology jobs by 2030. "India has a generational opportunity to lead globally by developing AI-ready talent and redesigning workflows," he said.

### Marriage To Pak Woman Risked Security: CRPF To HC

Srinagar: The Central Reserve Police Force (CRPF) has defended its decision to dismiss Constable Munir Ahmed before the Jammu and Kashmir High Court, citing serious misconduct involving a secret marriage to a Pakistani woman, forged documents, and concealment of sensitive information that could pose a threat to national security.

In its official response to the court, the CRPF alleged that Munir Ahmed married Menal Khan, a Pakistani national who entered India on a tourist visa in February 2025, without informing his superiors. The force claims that Ahmed not only concealed the marriage but also forged her signature on the nikahnama (marriage document) — a move they argue constitutes a serious legal and disciplinary violation.

Adding to the concern, the CRPF stated that Menal's visa had expired, and instead of alerting authorities, Ahmed helped her apply for a Long-Term Visa (LTV) without notifying the force. The issue came under heightened scrutiny in the aftermath of the Pahalgam terror attack, when the government ordered the deportation of all Pakistani nationals residing in India. It was during this period that Munir Ahmed allegedly went on leave for six days without revealing her legal status.

The CRPF also contended that the nikahnama cited a date when Menal Khan was



reportedly still in Pakistan, suggesting that her signature on the document was forged. The force emphasized that Ahmed, by virtue of his position, had access to sensitive locations and operational information, and his actions posed a potential security breach, especially in the context of Pakistan being regarded as a hostile nation.

In his defense, Munir Ahmed has challenged the dismissal, highlighting his clean service record, prior communication with CRPF officers regarding his marriage plans, and letters from BJP Members of Parliament supporting visa regularization for his wife. He argues that his actions were not in violation of any explicit conduct rules and that the dismissal was unjustified.

However, the CRPF maintains that the issue goes beyond service conduct and enters the realm of national security, which they say requires zero tolerance.

# India To Receive Abovenormal Rain In Aug, Sept

Srinagar: India is likely to receive above-normal rainfall during the second half of the monsoon season (August and September), the India Meteorological Department (IMD) said on Thursday.

Most parts of the country, except the Northeast and adjoining areas of eastern India, are expected to record normal rainfall in August, said IMD Director General Mrutyunjay Mohapatra during an online press conference.

Rainfall in September is likely to be above normal, he said. India received above-normal rainfall during the first half of the monsoon season (June and July), with some states, particularly Himachal Pradesh, experiencing flash floods.

"Overall, above-normal rainfall (106 percent of the Long Period Average of 422.8 mm) is most likely over the country during the second half of the southwest monsoon season," Mohapatra said.

"Geographically, normal to above-normal rainfall is most likely across most regions, except for many parts of the northeast and adjoining eastern India, isolated regions of central India and southwestern areas of the peninsular region, where below-normal rainfall is expected."

Mohapatra said subdued rainfall is expected over the next two weeks; however, the conditions do not meet the criteria for a "break monsoon phase",



which refers to a temporary lull in rainfall during the monsoon when the trough shifts toward the foothills of the Himalayas.

The country received 474.3 mm of rainfall against a normal of 445.8 mm from June 1 to July 31, a surplus of six per cent.

The country recorded 624 very heavy rainfall events and 76 extremely heavy rainfall events, the lowest figures in the last five years, the IMD chief told PTI.

"In Northeast India, this is the fifth consecutive year of below-normal rainfall. Over the last 30 years, a declining trend in rainfall activity has been observed in the northeastern states," he added. According to Mohapatra, good rainfall in July was due to favorable Madden-Julian Oscillation (MJO) conditions in the latter half of the month and the formation of six low-pres-

sure systems spanning 28 days. Of these, four systems intensified into depressions. Among them, three formed over land and moved from Gangetic West Bengal/Northern Bay of Bengal to Rajasthan, triggering frequent heavy to very heavy rainfall and even extremely heavy rainfall

on some days, the IMD said. ENSO-neutral conditions are currently prevailing and are expected to continue until October. Post-monsoon, weak La Niña conditions may develop, the IMD said.

In May, the IMD forecasted that India would receive 106 percent of the long-period average rainfall of 87 cm during the June–September monsoon season. Rainfall ranging between 96 and 104 percent of this 50-year average is considered "normal".

The monsoon plays a critical role in India's agriculture sector, which supports the livelihood of around 42 percent of the population and contributes 18.2 percent to the national GDP. It is also crucial for replenishing reservoirs used for drinking water and power generation

### 14.97 Sanctioned, Only 2 Lakh Installed

J&K Lags in Smart Meter Rollout: Centre

Srinagar: Under the Government of India's Revamped Distribution Sector Scheme (RDSS), a total of 14.97 lakh smart meters have been sanctioned for Jammu and Kashmir, but only 2 lakh have been installed so far, the Centre informed the Lok Sabha on Thursday. The figures were shared by Minister of State for Power, Shripad Naik, in a written reply to a question raised by MP Pushpendra Saroj.

According to the reply, while 272 crore has been sanctioned for J&K's smart metering component under RDSS, no funds have been released or utilised so far. This comes even as other states have already begun receiving allocations since FY 2023–24, the minister noted.

The RDSS, launched in 2021, is a flagship initiative of the Union Government aimed at strengthening power distribution infrastructure, reducing Aggregate Technical and Commercial (AT&C) losses, and accelerating the rollout of prepaid smart meters across the country.

In addition to arrests, enforcement agencies reported the seizure of 1,388 kilograms of narcotic substances and more than 62,000 psychotropic tablets in the ongoing year. Authorities have also frozen or confiscated assets worth Rs 39 crore, including 35 buildings and 13 vehicles directly linked to the drug trade. Relevant entries have been made in revenue records to formalize these actions.

The Chief Secretary directed the Police Department to submit monthly status reports on NDPS cases, detailing progress in investigation, prosecution, and the age and stage of each pending case. He also ordered an audit of longpending cases to identify reasons for delay and initiate timely corrective measures.

To ensure accountability, Dulloo further instructed that all bail and acquittal cases under the NDPS Act should be jointly reviewed by the Law and Police Departments to spot any lapses in investigation or prosecution.

On the de-addiction front, the Chief Secretary asked the Health Department to strengthen in-patient treatment services in Government Medical Colleges and District Hospitals, reducing reliance on private facilities. He also called for capacity building at IMHANS to improve outreach and treatment access.

Inspector General, Crime, Sujit Kumar, shared that 181 cases had been registered under the PIT-NDPS Act, resulting in the detention of 58 high-profile drug traffickers through detailed backward and forward link investigations.

To improve prosecution outcomes, over 2,150 Investigating Officers have been trained across 247 dedicated sessions in modern techniques for handling NDPS cases.

The meeting also discussed awareness campaigns and inter-departmental IEC activities to tackle substance abuse. Officials said that technology-driven solutions like Aadhaar-linked prescription monitoring and dedicated drug tracking portals were being developed with support from BISAG-N to curb misuse of prescription drugs.

Reaffirming the administration's zero-tolerance policy against drug trafficking, Chief Secretary Atal Dulloo called for a coordinated, data-driven and multi-pronged approach to eliminate the drug menace from the Union Territory.

The surprise announcement came amid a US trade team visiting India from August 25 for the sixth round of negotiations for the proposed bilateral trade agreement.

The two countries are negotiating a bilateral trade agreement (BTA) from March with an aim to more than double the bilateral trade in goods and services to USD 500 billion by 2030 from the current USD 191 billion. So far five rounds of talks have been completed.

For the sixth round of talks, the US team is visiting India from August 25.

They are aiming to conclude the first phase of the agreement by fall (October-November) this year. The two sides are also looking at an interim trade deal before the BTA.

India and the US entered into negotiations for a fair, balanced and beneficial bilateral trade agreement in March 2025, with the first phase of the agreement to be completed by fall of 2025, he said.

The minister also said that in just over a decade, India has rapidly transformed from being one of the Fragile 5 to the fastest growing major economy in the world.

"We have risen from the 11th largest economy to one of the top 5 economies, driven by our reforms, hard work of our farmers, MSMEs and entrepreneurs. It is also widely expected that we will become the 3rd largest economy in a few years," Goyal said.

Today, he said, international institutions and economists see India as the bright spot in the global economy.

India is contributing to almost 16 per cent of global growth, he said.

Trump once again mounted a sharp attack on India and Russia for their close ties and said he doesn't care what New India does with Moscow.

"I don't care what India does with Russia. They can take their dead economies down together, for all I care," he said.

"We have done very little business with India, their tariffs are too high, among the highest in the world," he added.

Goyal said that in the last decade, the government has taken measures to promote India as the manufacturing hub of the world, driven by the Make in India initiative.

"India's young, skilled and talented workforce is driving innovation and competitiveness of Indian industry. Our exports have steadily increased during the last 11 years," he said, adding in an increasingly protectionist world, India has done mutually beneficial trade agreements with UAE, UK, Australia and EFTA countries.

"We are also committed to similar trade agreements with other countries. We are consistently working for the welfare of the farmers and Indian agriculture, to promote prosperity and ensure food security," the minister noted.

### Impact Of Trump

The announcement came as a surprise, as the two countries are negotiating a trade agreement. Here is a list of Q & As (questions and

answers) to explain the impact of the US move: What is a tariff?

These are customs or import duties imposed on the import of goods. The importer has to pay this duty to the government. Normally, companies pass on these taxes to end users.

How much tariff is announced on India? The US has announced a 25-per cent tariff plus penalty for buying Russia's crude oil and military equipment. However, the US has not specified the quantum of the penalty and how it will be imposed. An executive order from the White House on the 25 per cent tariff plus penalty will give clarity on the duty structure.

A 10 per cent duty (announced on April 2) applies to all goods.

Besides, there is a 50 per cent tariff on steel and aluminium, and 25 per cent on auto and auto parts. These duties are imposed over and above the existing tariffs on Indian goods. For example, textiles attract a 69 per cent tariff at present, so after adding the 25 per cent, Indian textile goods entering the US from August 1 will attract a 31-34 per cent duty. A penalty could be added further on this.

Why is the US imposing these tariffs?

The US has alleged that it faces a significant trade deficit with India, blaming New Delhi for imposing high tariffs on American goods, which it says restricts US exports to the Indian market.

What is bilateral trade between India and the US?

During 2021-25, the US was India's largest trading partner in goods. The US accounts for about 18 per cent of India's total exports, 6.22 per cent in imports, and 10.73 per cent in bilateral trade. In 2024-25, the bilateral trade touched USD 186 billion (USD 86.5 billion exports and USD 45.3 billion imports).

With America, India had a trade surplus (the difference between imports and exports) of USD 41 billion in 2024-25. It was USD 35.32 billion in 2023-24 and USD 27.7 billion in

In services, India exported an estimated USD 28.7 billion and imported USD 25.5 billion, adding a USD 3.2 billion surplus.

Altogether, India ran a total trade surplus of about USD 44.4 billion with the US.

However, according to think tank GTRI, the US runs a USD 35-40 billion overall surplus when revenues from education, digital services, financial activities, royalties, and arms trade are factored in.

What are the major products traded between the two?

In 2024, India's main exports to the US included drug formulations and biologicals (USD 8.1 billion), telecom instruments (USD 6.5 billion), precious and semi-precious stones (USD 5.3 billion), petroleum products (USD 4.1 billion), vehicle and auto components (USD 2.8 billion), gold and other precious metal jewellery (USD 3.2 billion), ready-made garments of cotton, including accessories (USD 2.8 billion), and products of iron and steel (USD 2.7 billion).

Imports included crude oil (USD 4.5 billion), petroleum products (USD 3.6 billion), coal, coke (USD 3.4 billion), cut and polished diamonds (USD 2.6 billion), electric machinery (USD 1.4 billion), aircraft, spacecraft and parts (USD 1.3 billion), and gold (USD 1.3 billion).

What will be the impact of the tariffs on this crade?

Import duty makes goods expensive in the importing country. Besides, a few other factors also play a role in this. For example, duty on India's competitor nations such as Bangladesh (35 pc), Vietnam (20 pc) and Thailand (36 pc); and quality and standards of items.

According to exporters, Indian labour-intensive goods such as garments, leather and

non-leather footwear, gems and jewellery, carpets and handicrafts may get impacted due to this duty.

What will be the US tariffs on key Indian goods from August 1?

Telecom - 25 pc; gems and jewellery - 30-

Telecom - 25 pc; gems and jewellery - 30-38.5 pc (5-13.5 pc at present); food and agri goods - 29-30 pc (14-15 pc currently); apparel 12 pc plus 25 pc. Penalty component may also be there from August 1.

Is there a substance in Trump's allegations that India has very high tariffs?

The US also imposes high duties on items like dairy products (188 per cent), fruits and vegetables (132 per cent), coffee, tea, cocoa and spices (53 per cent), cereals and food preparations (193 per cent), oilseeds, fats and oils (164 per cent), beverages and tobacco (150 per cent), minerals and metals (187 per cent), and chemicals (56 per cent).

India's average tariff rate of 17 per cent is

India's average tariff rate of 17 per cent is higher than the US's 3.3 per cent, but similar to other major economies like South Korea (13.4 per cent) and China (7.5 per cent).

Last year, more than 5.1 lakh pilgrims paid obeisance at the cave shrine. With heightened security concerns this year, a multi-tier security arrangement was put in place, and the presence of security personnel was increased for the Yatra. Besides that, the government declared all routes to the Amarnath cave shrine a "no-flying zone," banning all kinds of aviation platforms, including drones and balloons, for the duration of the Yatra.

The Amarnath Yatra, which began on July 3, will conclude on August 9, coinciding with Raksha Bandhan.

In the morning session, India lost their openers Yashasvi Jaiswal (2 off 9) and K L Rahul (14 off 40) on a green top but did well to reach lunch 72 for two.

On the greenest pitch of the series, the ball expectedly did seam around but it was not swinging profusely

Playing his first game of the series, Atkinson struck in his second over by having Jaiswal trapped in front. The on-field umpire did not give it out but England reviewed successfully with the incoming ball going on to hit the stumps.

"You saw what happened to England when India batted on a pitch which had a bit of rough and on a pitch which had a bit of turn -- there wasn't a quality spinner so England could not get 20 wickets.

"In the past, great sides had great spinners, whether it's Shane Warne, Murali, England's Swann, Panesar, India's Kumble, Harbhajan, Ashwin. So, I think Kuldeep is someone India will have to continue to look into playing in the future." (PTI)

# 1st Test: Zimbabwe 31-2 After NZ Take Big Lead

evon Conway and Daryl Mitchell missed out on centuries but New Zealand was still in command after Day 2 of the first cricket test against Zimbabwe on Thursday.

No. 9 batter Nathan Smith braved several body blows against Muzarabani's short deliveries before he finally retired hurt for 22 due to an abdominal tear. It is highly unlikely that Smith will bowl in Zimbabwe's second innings as he walked off in pain after being struck on the body by Muzarabani. (AP)

### F1 Champion Verstappen Staying With Red Bull For 2026

ormula 1 champion Max Verstappen says he is staying with the Red Bull team for next year, ending months of speculation over his future.

"For me, it's always been quite clear, and also for next year," the four-time champion said Thursday ahead of the Hungarian Grand Prix.

"I'm discussing with the team already the plans — the things that we want to change for next year, so that means that I'm also staying with the team for next year."

Verstappen has a contract with Red Bull through 2028. At recent races he had deflected direct questions about whether he'd stay with the team next year, and there had been indications that a performance-related clause could allow him to exit the contract earlier. The exact details of any clause are not public.

Mercedes driver George Russell had said he believed his team was holding talks with Verstappen. (AP)


