India Refuses Trump's Bait, Brushes Off 'Pakistan Oil' Taunt

Srinagar: A day after US President Donald Trump claimed that Pakistan possesses "massive oil reserves" and floated the idea of Islamabad eventually exporting oil to India, New Delhi responded with restraint, firmly sticking to its longheld position on strategic au-

tonomy in energy decisions.
At a press briefing on
Friday, Ministry of External
Affairs (MEA) spokesperson Randhir Jaiswal declined to comment on Trump's remarks, saying tersely, "I have no comments to offer in this matter." However, in a subtle yet pointed response, Jaiswal stressed that India's energy policy is dictated solely by market realities and national interest, not external pressures or political rhetoric



"In securing our energy needs, we are guided by what is on offer in the markets and by the prevailing global circumstances," he said.

Without naming Trump directly, Jaiswal reiterated India's relationship with Russia is "steady and time-tested," emphasizing that its partnerships are evaluated on merit and not influenced by "third-country perspectives.

Trump's remarks came in a social media post where he announced a new deal with Pakistan to help develop its "massive oil reserves." In the same post,



D&FCO Cracks-Down On Street Food Vendors

SRINAGAR: Food Safety Wing of the Drugs and Food Control Organization (D&FCO) imposed a fine of Rs. 56,000 on the street food vendors violating hygienic and sanitary norms under the Food Safety and Standards Act (FSSA) during an intensive drive.

As part of this enforcement campaign, various locations across district Srinagar, including Panthachowk, Karan Nagar, Batamaloo, and Hazratbal, were inspected. During the inspections, 44 street food vendors were found non-compliant with the prescribed standards and a total fine of Rs. 56,000 was imposed on them.

The inspection teams examined the raw materials, ingredients, and finished food products offered by these vendors. Food items deemed unfit for human consumption were destroyed on the spot. Vendors were directed to strictly follow Good Hygienic Practices (GHP) and were instructed not to use newspapers or non-food grade utensils for the preparation or sale of food.

The department has reiterated that strict action will be taken against defaulters in accordance with the provisions of the Food Safety and Standards Act.

Consumers are encouraged to report any food safety concerns or complaints by calling the toll-free helpline 104.

Dogs Create Fear On Rambagh-Mehjoor Nagar Bund

SRINAGAR: An atmosphere of fear and anxiety grips the Rambagh-Mehjoor Nagar bund every evening, as large groups of aggressive street ful stretch, chasing pedestrians and vehicles, particularly two-wheelers, with alarming regularity.

What was once a popular walking route for residents, students, and evening joggers has now turned into a dreaded pathway after dusk. Locals say the fear of dog attacks has forced many to avoid the area altogether in the evenings.

There are dogs everywhere you look on the bund. The moment they hear a scooter or see someone walking alone, they charge. It's frightening, said Adil Ahmad, a resident of Padshahi Bagh. "The situation gets worse after evening prayers. You feel like you



are walking through a gauntlet."

Motorcyclists and cyclists, in particular, are frequently chased, often losing control or getting injured in attempts to avoid bites. "They bark and run right into your path. I have seen a rider fall trying to dodge a sudden pack attack," said Waseem Dar, a daily commuter.

Women and the elderly feel especially vulnerable. Some residents revealed they now avoid venturing out for evening prayers or groceries. "Even going to the local masjid becomes nerve-wracking task," said Bilal Ahmed, a resident of Mehjoor Nagar.

Locals believe the unchecked inrease in stray dog population is the result of poor municipal management. "The authorities have completely failed. The sterilization programme is a joke. Every month, the number of dogs seems to grow," said another resident angrily.

While dog bites and chases are being reported informally on a daily basis, no major action has yet been taken. Residents have appealed to the Srinagar Municipal Corporation and the district administration to intervene and make the area safe again immediately.

Similar reports have been reported from Jawahar Nagar, Natipora, Batamaloo, Bemina, and other parts of the city. [KNT]




He said the scooty was being driven by Bilal Ahmad Bhat, son of Mohammad Ramzan Bhat, a resident of Dara, Harwan.

During the two-and-a-Half year tenure of the coalition government, Kumar has been shifted \$ax times from her posts.

2003. In February the next year, she was transferred to industries and commerce, and four months later, in July 2003, to the higher and technical educa-

After serving on that post for one year, she was transferred again in July 2004, and made the principal secretary of the forest department. The government shifted her again in April 2005, this time to the health and medical education department.

Yesterday's revamp, which made her the principal secretary of the revenue department, was the sixth time she was transferred in 2-and-a-half years.

Fed up with the repeated transfers and postings, Sonali Kumar, has gone on leave in protest, sources told the KNS. She has asked the government to grant her leave till October.

Probe Finds Cause Of Stampede at New Delhi **Railway Station**

New Delhi: A big headload falling from one of the passengers triggered the New Delhi railway station stampede that killed 18 people, Railway Minister Ashwini Vaishnaw told Rajya Sabha on Friday.

The minister, in a written reply, shared the findings of the high-level committee constituted to examine the circumstances leading to the stampede on February 15.

He said there was a gradual increase of passengers, many of whom were also carrying big headloads.

Samajwadi Party MP Ramji Lal Suman asked the railway minister about the status of the report of the committee constituted to investigate the stampede and the corrective steps taken by the government.

Vaishnaw said the highlevel inquiry committee has submitted its report for con-

"As per findings of the report, an unfortunate incident on 15.02.25 happened on foot overbridge-3 stairs connecting platform 14/15 at New Delhi railway station. On the day of the incident, sufficient crowd management protocols were in place to handle the overall volume of passengers at the station," he said.

"There was a gradual increase of passenger density on the FOB after 8.15 pm. Many of the passengers were carrying big headloads, affecting smooth movement on the FOB. There was a big headload falling from one of the passengers and the pressure was passed on to the stairs of PF 14/15 stairs. resulting in the tripping of passengers on the stairs. This led to an incident at 8.48 pm on FOR-3 which was limited to the stairs of FOB. Consequently, passengers fell on each other," he said.

The minister informed the House that in the incident, 18 people lost their lives and 15 were injured.

According to Vaishnaw, an ex-gratia amount of Rs 10 lakh to the next of kin of each deceased, an amount of Rs 2.5 lakh each to the grievously injured and Rs 1 lakh each to others injured has been paid.

"Accordingly, a total amount of Rs 2.01 crore has been paid to 33 victims and their family members,' Vaishnaw said

He said the government has taken action to handle the heavy rush of passengers at stations, including the creation of permanent holding areas and access control measures — allowing passengers with confirmed tickets - at 73 identified stations, widening foot overbridges, installing CCTV cameras, developing war rooms at big stations, among others.

ED Issues Look Out Circular Against Anil Ambani

Mumbai: The Enforcement Directorate (ED) has issued a Look Out Circular (LoC) against industrialist Anil Ambani, chairman of the Anil Dhirubhai Ambani Group (ADAG), amid an ongoing probe into an alleged 17,000 crore bank loan fraud. The LoC, issued on Friday, is aimed at preventing Ambani from leaving the country without prior clearance, according to senior officials.

The central financial crime agency has also summoned Ambani for questioning on August 5 as part of its investigation into alleged fund diversion and loan misappropriation by various ADAG-linked companies.

Massive Loan Fraud, Forged Documents, and Fake Bank

The ED alleges that multiple group companies under ADAG umbrella—operating through the Reliance Anil Ambani Group of Associates (RAAGA)-availed large loans from a consortium of Indian banks and financial institutions, which were later misused or siphoned off. The agency suspects systematic deception involving

The ED has sought records from the National Internet Exchange of India (NIXI) to trace the domain registration and digi-

35 Raids Across India, 50 Companies **Under Scanner**

On July 24, the ED launched a nationwide crackdown, conducting searches at 35 premises connected to Reliance Group companies, individuals, and executives. The raids spanned across 50 firms and 25 people, based on a money laundering case that stemmed from a CBI FIR. These actions fall under the purview of the Prevention of Money Laundering Act (PMLA).

According to sources, multiple ADAG executives have already been questioned, and forensic analysis of their transactions is ongoing

Apart from the PMLA probe Anil Ambani is also facing a separate investigation under the Foreign Exchange Management Act (FEMA) for alleged violations of foreign exchange laws.

Officials said early findings indicate a "well-planned scheme to siphon public funds" by misleading lenders and investors. The ED suspects the creation of shell entities and circular transactions designed to obscure mon-

Vice Presidential Election On Sep 9: EC

New Delhi- The election for the post of Vice President will be held on September 9, the poll authority announced on Friday.

The notification for the vice presidential election will be issued on August 7 and the last date for filing nomination papers will be August 21.

The polling, if required, shall take place in room number F-101, Vasudha, on the first floor of Parliament building on September 9 between 10 am and 5 pm. The results will be announced on the same day.

The post of the vice president fell vacant after the resignation of incumbent Jagdeep Dhankhar on July 21.

The Election Commission has appointed the Rajya Sabha Secretary General as the Returning Officer and two officials of Rajya Sabha Secretariat as Assistant Returning Officers for the vice presidential election.

The Electoral College for the vice presidential election comprises members of the Lok Sabha and the Rajya Sabha. The nominated members of the Rajya Sabha too are eligible to vote in the vice presidential election.

The electoral college for the vice presidential election comprises 233 elected members of the Rajya Sabha, 12 nominated members of the Rajya Sabha and 543 members of the Lok Sabha.

There are five vacancies in the Rajya Sabha and one in the Lok Sabha, pegging the effective strength of the electoral college at 782.

The ruling NDA has a comfortable edge in the ensuing poll.

The 543-member Lok Sabha has one vacant seat - Basirhat in West Bengal — while there are five vacancies in the 245-member Rajya Sabha.

Of the five vacancies in the Rajya Sabha, four are from Jammu and Kashmir, and one from Punjab. The seat from Punjab was vacated after AAP leader Sanjeev Arora quit following his election to the state assembly in a bypoll last month.

The effective strength of both the Houses together is 782 and the winning candidate will require 391 votes, considering that all eligible voters exercise their franchise.

In the Lok Sabha, the BJPled NDA enjoys the support of 293 of the 542 members. The ruling alliance has the support of 129 members in the Rajya Sabha (effective strength 240), assuming that the nominated members vote in support of the NDA nominee.

The ruling alliance has the support of total 422 members.

A person cannot be elected as the vice president unless he is a citizen of India, has completed 35 years of age and is qualified for election as a member of the Rajva Sabha.

A person is also not eligible if he holds any office of profit under the government of India or a state government or any subordinate local authority.

Article 66 (1) of the Constitution provides that the vice presidential election shall be held in accordance with the system of proportional representation by means of the single transferable vote and the voting at such election shall be by secret ballot.

In this system, the elector has to mark preferences against the names of the candidates.

Israel Sharpens UAE Travel Warning For Citizens, Cites 'Terrorist' Threat

Jerusalem: Israel's National Security Council (NSC) has sharpened its travel warnings for Israelis visiting and staying in the United Arab Emirates, citing a heightened risk of "terrorist organisations" carrying out attacks in the

In a statement published n Thursday, the a growing threat from "terorganisations (The rorist Iranians, Hamas, Hezbollah and Global Jihad)" attacking Israeli targets, motivated by Israel's military operations in the Middle East

"They are driven by heightened motivation to exact revenge following Operation Rising Lion, in addition to the anti-Israel and pro-Palestinian incitement which has intensified since the start of Operation Iron Swords, and even more so in response to Hamas' starvation campaign," it said, using the names for its military assaults on Iran and Gaza.

Israel is facing mounting international pressure over

Gaza's ongoing starvation crisis, caused by the Israeli military's months-long blockade on aid entering the Palestinian enclave.

In 2020, the UAE became the most prominent Arab state in 30 years to establish formal ties with Israel under a United States-brokered agreement dubbed the Abraham Accords. The country's Israeli and Jewish community has grown larger and more visible in the years since the accords were signed.

But the NSC statement said 'past experience" has taught Israel that "terrorist organisations often focus their efforts in neighbouring countries".

"In light of this, the NSC is reiterating the possibility that they will try to carry out attacks against Israeli and Jewish targets in the UAE, especially on Jewish holidays and Shabbat," it added.

White House: Trump Ended Conflicts Like India-Pak, Deserves Nobel

New York/Washington- Donald Trump should be awarded the Nobel Peace Prize, White House Press Secretary Karoline Leavitt has said, claiming that the US President ended several conflicts around the world including the one between India and Pakistan.

Since May 10, when Trump announced on social media that India and Pakistan had agreed to a "full and immediate" ceasefire after a "long night" of talks mediated by Washington, he has repeated his claim on several occasions that he helped settle the tensions between the two countries.

At a White House press briefing on Thursday, Leavitt said that Trump has "now ended conflicts between Thailand and Cambodia, Israel and Iran, Rwanda and the Democratic Republic of the Congo, India and Pakistan, Serbia and Kosovo and Egypt and Ethiopia.

She said that the president has brokered, on average, about one peace deal or ceasefire per month during his six months in office.

"It's well past time that President Trump was awarded the Nobel Peace Prize," she said.

Trump has repeated his claim nearly thirty times that he "helped settle" the tensions between India and Pakistan and that he told the nuclear-armed South Asian neighbours that America will do a "lot of trade" with them if they stopped the conflict. Prime Minister Narendra

Modi said in Parliament this week that no leader of any country asked India to stop Operation Sindoor. External Affairs Minister S Jaishankar on Wednesday

categorically said there was

no third-party intervention in bringing about a ceasefire with Pakistan during Operation Sindoor, asserting that the halting of the military action was also not linked to trade as claimed by Trump. Intervening in the special discussion on Operation Sindoor in the Rajya Sabha, Jais-

hankar said Prime Minister Modi and Trump did not have any phone calls between April 22, when the Pahalgam terror attack took place, and June 16.

Man Kills First Wife After Secret Second Marriage, Fakes Robbery

New Delhi: In a chilling incident in Uttar Pradesh's Bareilly district, a man allegedly killed his wife at the behest of his lover and tried to pass it off as a highway robbery, police said.

Om Saran (38), the accused, has been arrested and sent to judicial custody, they said.

After inconsistencies in Sarna's initial statement raised red flags, his call records were checked which revealed that he was in touch with a woman named Mannat, prompting police to dig deeper, SSP (Bareilly) Anurag Arya said.

The probe eventually led to the unravelling of the murder conspiracy, Arya

Saran, a resident of Badaun district, has been booked under Sections 103 (murder), 230 (fabricating false evidence), 238 (causing disappearance of evidence of offence), and 240 (giving false information) of the Bharatiya Nyaya Sanhita (BNS), ASP (South) Anshika Verma said in a late-night press briefing on Thursday.

The accused initially told the police that on the night of July 31, he was returning home with his wife Amarvati on a motorcycle when they were attacked near Kanthari village by 3-4 unidentified men, who looted their cash and jewellery and fatally assaulted his wife.

Saran claimed that the attackers stole Amarvati's mangalsutra, gold earrings, and about Rs 10,000 in cash before flee-

Police registered an FIR based on Sar-

na's written complaint. As the investigation progressed, police began to suspect Saran's version of events. Upon rigorous questioning, he admitted that he secretly married Mannat, who pressured him to eliminate his wife if he wanted to continue their relationship, the ASP said.

On July 30, Saran took Amarvati on a trip to Purnagiri as part of the plan. On their way back, he stopped at his in-laws' house in Motipur, where he borrowed a motorcycle and a sharp-edged weapon ('banka') from his brother-in-law, Bhagwandas, Verma said. He stopped the bike near a deserted spot

in Kanthari village around 12:15 am, and brutally attacked Amarvati with the 'banka', killing her on the spot.

To make it look like a robbery, he removed her earrings, mangalsutra and Rs 10,000 from his pocket, and concealed them in nearby bushes. He then called his brother-in-law and a

ambulance, pretending to be rushing his wife for treatment, Verma said. Police later recovered the murder weapon, and the hidden jewellery and cash based on the accused's disclosure. A mobile phone was also seized during the

search, the officer said.

Beloved Children's Author Allan Ahlberg Dies At 87

London: British writer Allan Ahlberg, author of more than 150 children's books, including classics like "Eat Peach Pear Plum" and "The Jolly Postman." has died, his publisher said on Friday. He was 87.

Penguin Random House said Ahlberg died on Tuesday. It did not give a cause of death.

Ahlberg's books introduced generations of young children to reading through simple rhymes. sharp observation and gentle humour. Many were co-created with his illustrator wife Janet Ahlberg, who died in 1994.

"Peepo!" (1981) gave a baby's-eye-view of the world and was interactive in a delightfully analogue way, with peep-holes in the pages to spy the next scenes

"The Jolly Postman" (1986) was even more inventive, incorporating postcards and letters in envelopes for children to engage with while they followed a letter-carrier delivering mail to fairy tale characters. Penguin Random House said it "pushed at the boundaries of what it is possible for a book to be.



Ahlberg also wrote books of jokes, including "The Ha Ha Bonk Book," and poetry for primary school-age children, including "Please Mrs Butler" and "Heard it in the Playground."

Born in 1938 and raised by adoptive parents in a working-class home in OIdbury, central England, Ahlberg worked as a "postman, plumber's mate and grave digger," according to his publisher, before becoming a teacher. He met Janet at teacher training college and the couple's first book, "Here are the Brick Street Boys," was published in 1975.

64% of J&K Students Still Miss Out **On Tech-Based Learning**

SRINAGAR: In Jammu and Kashmir, at least 64 percent school students have no access to use and avail the technology for better learning at home. According to the report of the

Ministry of Education (MoE), only 36 percent of school students have a laptop, desktop and tablet for learning at home. The report further states that

only 60 percent of students were using a smartphone for learning at home. It also said that or

cent of students were having internet access at home and 66 percent of schools were having internet connectivity available for the students.

The report further said that only 62 percent of schools were having computers and tablets for students.

"Many students reported having smartphones and internet access at home, making it possible for them to engage with online learning content," it reads.



The report however said that fewer students mentioned havfor educational use. Internet connectivity and digital devices like computers or tablets are available in several schools.

"Strengthening access to personal learning devices at home and enhancing the integration of digital tools in classrooms can further support better

learning outcomes," it reads. It also states that most students shared that their schools are equipped with basic facilities such as functional toilets.

clean drinking water, and proper ventilation through working fans and lights in classrooms.

"Access to sports facilities is also reported by many students. However, the availability of functional laboratories for Grade IX students is relatively lower in comparison," reads the report. The MoE report further states that ensuring consistent access to all essential infrastructure is important to create a more enabling environment

Pertinently KNO already eported that at least 17 percent of students in Jammu and Kashmir engage in family work after completing 10th standard, reveals a report of Ministry of Education (MoE).

Fruit Growers Secure Early Bookings Amid Cold Storage Crunch

SRINAGAR: As the apple harvesting season nears in Kashmir, cold storage facilities are once again proving to be a lifeline for fruit growers who are securing early bookings to preserve their produce.

With a current cold storage capacity of around 4 lakh metric tonnes (MT) in the valley, growers and officials alike are calling for the expansion of storage infrastructure to meet growing demand.

Growers from various fruitrich areas told KNO that the existing units have helped them fetch better returns in the market, as storing apples for late-season sale significantly boosts

They said there are about two months till the traditional apple season starts, but bookings have begun already as growers have benefited from cold storage units.

"Last year, I stored around 500 boxes of apples in a cold store and sold them in April. The rates were much higher than what I would have received during peak season," said Ghulam Rasool Wani, a grower from Shopian. "But many others couldn't get space due to limited capacity."

According to official data,

there are around 85 cold storage units currently operating across Kashmir, mostly located in Pulwama, Shopian, Anantnag, and Srinagar districts. The combined capacity, however, is falling short of the valley's annual production, which crosses 20 lakh MT of apples.

"Every year, we receive far more booking requests than we can accommodate," said Fayaz Ahmad, manager of a leading cold storage unit in Lassipora.

"This year, bookings started as early as July, with many units already partially booked."

Government officials admit the infrastructure needs expansion to support Kashmir's horticulture economy. "Cold storage is vital for post-harvest management. We are encouraging private players and cooperatives to set up more units through subsidies and soft loans," said a senior official from the Horticulture Planning

and Marketing Department. Under the Mission for Integrated Development of Horticulture (MIDH) and other schemes, the government is offering financial assistance of up to a 50% subsidy for setting up cold storage infrastructure, especially Controlled Atmosphere (CA) units.

We are working to enhance cold storage capacity by an-other three lakh metric tonnes in the next few years to support growers and reduce post-harvest losses," the official added.

Growers have appreciated the government's support, but insist more needs to be done. "Without adequate storage, we're forced to sell apples at throwaway prices," said Bashir Ahmad Dar, an orchardist from Anantnag. "We urge the government to expedite the clearance process for new units and extend support to small growers forming cooperatives.

With apple production likely to be normal this year despite weather challenges, the demand for cold storage is only expected to rise.

Stakeholders believe that timely investment in this sector can significantly improve incomes and reduce distress sales, thereby strengthening the backbone of Kashmir's rural

Ladakh's Legal Infra Expands Slowly: GoI

SRINAGAR: The Ministry of Law and Justice has acknowledged critical gaps in the judicial infrastructure of Ladakh, confirming that more than 30% of sanctioned judicial posts remain vacant and only half of the Union Territory's sub-divisions currently have functioning court infrastructure.

Responding to a question raised by MP Mohammad Haneefa in the Lok Sabha. Union Minister of Law and Justice Arjun Ram Meghwal informed that of the 10 subdivisions in Ladakh, courts are operational in only five including Zanskar, Sankoo, Khaltsi, Nubra and Drass.

According to government data, 17 judicial officer posts have been sanctioned for the region, but only 10 are currently filled.

11 court halls and four residential units are available. while four additional court halls and two residences are under construction.

Over the last five years, the Centre has released Rs 8.33 crore to Ladakh under the Centrally Sponsored Scheme (CSS) for the development of judicial infrastructure. For the year 2025–26, Rs 2 crore has been earmarked under the CSS specifically for UTs without legislatures.

To address access issues in remote areas, the Ladakh administration has set up Special Mobile Magistrate Courts in Leh and Kargil. Lok Adalats are also held regularly under the framework of the Legal Services

In the last three years, National Lok Adalats in Ladakh settled 5,375 cases, while State Lok Adalats handled 240 cases, mostly during 2022-23.

In September 2023, a Legal Aid Clinic was opened in Tangtse village of Leh district, as part of efforts to expand grassroots legal support. Overall, 1,540 people including 477 women and 24 children have benefited from various legal aid services across Ladakh in the last three years, according to the Ladakh Legal Services Authority (LLSA).

The government said steps are being taken, in consultation with the High Court, to fill judicial vacancies following Supreme Court guidelines in the Malik Mazhar Sultan case.

ashmir is a highly consumerist community. We buy more than we build, eat more than we grow, and rely on others for even the basics. That dependence showed its full weight this summer when meat disappeared from local markets, triggering panic and silence around kitchen fires.

It started, as such things often do, far from home. In Punjab, a new private contractor took over cattle fairs. Fees changed, tensions flared, and trucks carrying livestock were halted. Kashmiri mutton dealers, stranded and helpless, traveled to Delhi and Punjab to plead for clarity. Back home, meat counters stayed empty.

Eventually, the Punjab government appointed nodal officers to manage disputes. The strike was lifted. For now, meat is back. But the core problem remains untouched: Kashmir does not produce what it consumes.

The numbers are stark. Kashmir consumes over 500 lakh kilograms of mutton every year. Nearly all of it comes from outside. In 2024, local production covered less than 10% of that need.

For a region with lush meadows, alpine pastures, and a tradition of animal rearing, this dependency should be unacceptable. It puts Kashmir's food security at the mercy of border disputes, middlemen, and shifting policies in other states.

Worse, it exposes a failure of imagination. The valley has thousands of unemployed youth, many of them educated, trained, and stuck. They need work. Kashmir needs livestock. The match should be obvious.

The livestock sector, globally and nationally, is a proven engine of employment. It generates steady income, supports allied trades, and builds local economies. It could do even more in the valley: reduce imports, stabilise prices, and offer young people a reason to stay.

The government says it wants startups and innovation. Yet here is a sector crying for a solid intervention, and investment in cold storage units, e-marketplaces, vet clinics, and fodder banks.

Instead of waiting for another disruption to expose these gaps, the administration must act. It must build an ecosystem where livestock farming is seen as smart, modern, and scalable. A 25-year-old graduate should see a future in food production, not just in coding or coaching.

The July meat crisis was about more than supply routes. It was a glimpse of what happens when a region has no control over what it eats. That control won't come through meetings or memorandums. It will come through self-reliance.

Inside Kashmir's Rotten Meat Crackdown

For years, bad meat passed through official gates. Now, a single seizure has put the entire supply chain on trial.

was there when they opened the cold stor-

It was a typical July day, the one that wears you down with heat, smell, and exhaustion.

But nothing could've prepared us for what we found behind that shutter.

Piled high in crates was meat - 1,200 kilograms of it: chopped, packed, and decomposing. There was no refrigeration and ventilation. And. the spoiled stock was about to be dispatched to different eateries across the city.

The officers who carried out the raid, from the Food Safety wing of the Drug and Food Control Organisation, said they had never made a seizure this big.

For me, it confirmed what I've long feared: we are eating meat that should have been destroyed, not served.

This latest seizure isn't an isolated incident. It's a sign of a much deeper rot in how food is handled, regulated and consumed in Kashmir.

We are a society that holds meat close. From family dinners to wedding feasts to street-side tujj, meat is at the centre of our plates. Yet, we don't know what we're eating anymore.

We rarely ask questions or look closely. Instead, we trust too easily, and that trust is being taken advantage of every single day.

Over the past few years, I've tracked the unchecked influx of frozen meat, fish and poultry into Kashmir. Much of it arrives in trucks from outside the region, crossing into the valley via Lakhanpur or Qazigund. It's rarely inspected. The meat, often poorly packed and improp-

erly stored, floods markets at rates no local butcher could ever match. This is how a food stall offers a full meat

plate for 100. And this is how food vendors set up shop in every village with deep freezers, not I posted images of the Zakura seizure on

my social media handles. The response was overwhelming.

A man from Maharashtra, who had visited Srinagar recently, said he suffered food poisoning after eating fish at a well-known eatery A local user posted a photo of his meal and

asked, "How else do you think they can sell all this meat so cheap?' Another, from Bengaluru, said simply: "This is why I haven't eaten non-veg outside

in five years.' There is anger, but also helplessness. The seized meat was most likely destined for

According to FSSAI regulations, all frozen meat and fish must come from licensed vendors and be tested regularly. But in practice, there are huge gaps.

Many districts lack proper food testing labs. Staff shortages mean inspections are rare. And frozen meat doesn't fall under the same taxation as other goods, making it easier to transport and harder to track.

The result is a perfect storm: cheap, unregulated, and unsafe meat sold freely, and often relished by unsuspecting consumers.

We are already seeing the rise of a dangerous food economy.

From small fast-food joints in villages to barbecue vendors in city centre, frozen meat is the backbone of an industry that feeds thousands every day.

When I spoke with the inspection team after the Zakura raid, they said legal proceedings were being initiated against the food business

I urged them to name and shame, as it is a public safety crisis. The people involved in knowingly distributing rotten meat must be

booked under the Public Safety Act.

These criminals are raking in profits by poisoning the public, repeatedly, and without remorse.

The solution starts with action.

The Health Department must fill staff vacancies and strengthen the Drug and Food Control Organisation. The officers on the ground need resources, equipment, and authority. And there must be permanent food checkpoints at the state's entry points, especially for frozen meat,

But this is also about awareness.

As consumers, we have a role. We need to ask questions, read labels. We shouldn't choose the cheapest meat without understanding what's behind the price. Our silence has enabled this system to flourish.

I believe the Zakura raid will be remembered as a turning point, if we act. If we don't, there will be another 1,200 kilos, another truck, another illness, and another family wondering what went wrong.

or generations, the water flowed without asking in my hometown Mattan. You could lean over a rock, cup your hands, and drink what felt like liquid snow.

But this summer, people woke up to walk farther, carry more, and return with less.

Water is disappearing.

This year, the heat came early, and it came hard. Srinagar hit 37.4°C, hotter than Delhi on some days.

A place where summers used to mean soft sun and cool shadows now feels like it's burning from the inside out. June was the second hottest in over a century. Qazigund recorded its hottest June in more than fifty years.

The hostile heat prompted old men to compare this summer to their childhoods and shook their heads. No one remembers it being this relentless.

Kashmiris are used to the idea of being spared. Surrounded by mountains and meadows, we've long believed we were safe from the worst. Floods might visit, winters may stretch, but something in the landscape always softened the blow. Not anymore.

In my village, taps dried up in April. The traditional nags were empty by May. Even the kunds in the forest, where animals drank and fields were watered, looked like they'd been erased. We had little snowfall during Chillai Kalan, the fiercest stretch of winter. That snow usually melts in summer, feeding our rivers and aquifers. This year, there was barely anything left to melt.

In villages across Khoveripora block, families started queuing near remaining water points. Children, instead of playing before school, waited with cans. For women, water collection replaced rest. Fields began to crack under the sun.

And the farmers, our valley's backbone, watched

their work turn to dust.

An apple grower I know in Ashmuqam told me this was the third year in a row he's seen his yield

drop. He has started removing trees from the highest part of his orchard. "They dry too fast now," he said. 'It's not worth the spray.'

The weather no longer follows a rhythm. Rains fall out of season, or they don't fall at all. When they come, they come with a fury. Hailstorms show up without warning. The pests follow, crops suffer, and

These are not one-off events. They're connected. Climate scientists like Dr. Rajesh Verma from the National Institute of Climate Studies have spoken about how Himalayan regions feel climate change sooner than the plains. The slopes, forests, and rivers here are delicate. Small changes trigger chain reactions. And we're seeing those chains break in real time.

The World Meteorological Organization has warned that between 2023 and 2027, global temperatures could rise up to 1.8°C above pre-industrial levels. That sounds small on paper. But in the mountains, it means earlier glacial melt, fewer snow days,

and more unpredictable rain.

When the ground stays dry for too long, even a normal shower floods it. There's no sponge left to ab-

In 2014, we watched Srinagar drown. In 2021, flash floods tore through Kishtwar. These climatic events were signs of what's coming.

Forests, too, are slipping away. Trees that once cooled our air, held our slopes, and filtered our water are being cut down for roads, buildings, and quick profit. With them goes our best defense.

And yet, we keep building.

Tourism has helped thousands of Kashmiris earn a living. But it has also brought pressure. Roads are widened, concrete replaces soil, lakes are choked with plastic, and meadows are turned into parking lots.

We are selling the image of paradise while losing the substance. If tourists stop coming because it's too hot or too dry, what will we sell then?

We can't afford to shrug this off anymore.

We need to bring back traditional water systems: stone tanks, underground storage, terraced irrigation. We must invest in new wells, plant trees where they can grow, and keep forest land intact.

Kashmir was never built to take big hits. It is beautiful because it is delicate. Its economy, identity, and rhythm lean on nature. And that nature is shifting fast.

This summer was a big message.

If we don't act now, the future might slip away slowly, until one day we look around and find that what we loved most about this place is no longer here.

Roots Over Resumes

After years of job rejections and personal loss, Shugufta Bashir turned to farming, and became a symbol of self-reliance in an unemployment-ridden region.

n a hot summer morning in Banpora village of Pulwama, Shugufta Bashir bends down to check her tomato plants. Her hands are covered in soil, her eyes focused.

A few years ago, she was filling out job forms and chasing interviews. Now, she runs her own farm, and makes a living from the same land her family once left idle.

"I didn't plan this," she said, standing near a sapling she planted last year. "I just knew I had to do something with my life before I lost it to waiting."

At 25, Shagufta is part of a generation of Kashmiri youth raised on degrees and deferred dreams. She holds a postgraduate degree in history and a B.Ed., credentials that

once carried hope of a steady teaching post.
That hope faded after years of unanswered applications and failed interviews.

The job crisis in Jammu and Kashmir is severe. According to the Centre for Monitoring Indian Economy, the region's unemployment rate in 2024 remained among the highest in India, often topping 15 percent. The figures are starker for women.

touching leaves, checking roots, noting which plants have tilted. Her phone remains on silent. Rejection letters don't come anymore, neither do promises. "I kept thinking, maybe next month, maybe the next list," Shagufta said. "Then another rejection would come."

Around the same time her job hunt was faltering, her engagement ended. Two blows, one personal, the other existential.

She remembers the week clearly: her phone silent, her inbox full of forms and regrets. Something in her snapped. Then something else clicked.

"My house looks out onto the fields. That land was always there, just part of the background," she said. "One day, I thought, what if it's the foreground?"

Her father had spent decades growing paddy on the family's ancestral land. The yields were low, the market uncertain. Farming was seen more as survival than ambition.

But Shagufta began to study crop science. She watched YouTube tutorials on horticulture, attended district agriculture workshops, and started sketching layouts for mixed farming. Apples, she learned, could thrive in this soil, so could seasonal vegetables.

Convincing her father took time. "He didn't say no," she said. "He just said,

'Don't expect miracles.'"

She didn't get miracles. She got weeds,

blisters, broken fences, and slow harvests. Her first vegetables barely filled a few baskets. The apple trees would take years to bear fruit. She kept going. She learned how to budget input costs, manage drip irrigation, and source manure from local cooperatives.

Most of the work she did herself. Some evenings, her mother helped water the saplings.
"When I first earned 300 rupees selling

"When I first earned 300 rupees selling vegetables at the mandi, it wasn't about money," Shagufta said. "It was the first time I felt useful."

In Banpora, where most girls are ex-



pected to marry early or wait indefinitely for government jobs, Shagufta's decision to farm drew curiosity and commentary. At first, some villagers laughed. "She's

growing potatoes with a degree," one said.

A few months later, they came to ask what she used to keep pests away.

Today, her story is changing conversations. Girls from nearby villages now visit her fields to learn basic sowing techniques. She walks them through the stages: soil testing, composting, market mapping. Some want to grow mushrooms in their backyards. Others have started working with their mothers on unused patches of land

"There's a shift happening, very slowly," Shagufta said. "When one girl works outside the script, others start asking questions." Her father, once unsure, now watches her plants like a partner. "She's made our name known," he said. "Even old men who doubted her now call her brave."

Shagufta is modest about her success. Her farm is still small, her profits fluctuate. She saves carefully, reinvests most of what she earns, and hopes to set up a processing unit to dry and package organic produce.

She continues to apply for jobs, but with less urgency.

"I used to believe a job would make me complete," she said. "Now I believe in work, whatever shape it takes."

She is also helping to train a few younger girls in the area to handle market logistics, basic bookkeeping, and crop cycles. Her informal workshops are simple: field tours, question hours, note-sharing. A few of the girls now earn money selling fresh herbs or onions to local vendors.

Government support has been minimal. Shagufta received some seedlings from the horticulture department, but no grants or schemes tailored to women farmers in transition.

Still, she persists. She believes if the story is strong enough, systems eventually follow.

"Sometimes people ask me if I regret studying so much," she said. "My answer is no. That education didn't go waste. It brought me here."

On most evenings, she walks through the orchard barefoot, touching leaves, checking roots, noting which plants have tilted. Her phone remains on silent. Rejection letters don't come anymore, neither do promises.

"This is the life I built with both hands," she said, standing in a field of cabbage under a clear Pulwama sky. "No one opened a door for me. I didn't even find one to knock on. So I dug."

And somewhere between rejection and ripening, she found something larger than employment. She found her own use.

A School of Slates

Against all odds, one Kashmiri primary school has become a model of what real education can look like.

t was almost ten in the morning when I reached the school. The sun had warmed the village of Gundi-Khaleel in Narabal zone, Budgam. The school stood at the riverbank of Sukhnag, with its gate open to the sound of water flowing and birds calling across the trees.

As an academic monitor, I've visited many schools, but this one felt different from the moment I stepped into the lawn.

It was a small space, edged with grass, and in the middle, four children were sitting in a circle. They were between four and six years old, completely focused on something.

As we got closer, they noticed us and stood up in perfect rhythm: "Good morning, sir, you are welcome!"

I asked them to introduce themselves.

A little girl responded first. "I am Ujma shirrrr," she said with all the boldness she could gather.

I gently corrected her, thinking she meant Uzma. But she insisted, a little offended, "I am Ujma."

She held her ground like someone used to being heard. I smiled and backed off. The others introduced themselves: Ayaan Ahmad, Abaan Younis, and Aiman Showkat.

On the ground beside them were four traditional slates: takhti, as we call them. Soil-ink bottles and stick pens sat beside each one.

On the slates, I saw beautiful hand-writing: clean, careful strokes. Other students nearby were also working on slates, their focus unshaken. The neatness surprised me.

The Head of the Institution (HOI) soon joined us. I asked about the use of slates. His answer has stayed with me ever since.

"In today's digital world, children are often busy with smartphones before they even learn how to hold a pencil," he said. "Slates help them build fine motor skills, develop creativity, and improve handwriting. It's a sensory experience. Using a stick pen on a slate strengthens hand muscles and focus. Plus, slates are reusable."

He wasn't quoting theory, he was showing its effect in real time.

As we walked toward the building, I noticed how well-maintained it was. Four rooms, freshly painted. In the corridor, I stopped to look at a 'biography board', a kind of wall chart where students could record facts about famous people or even characters from stories they read.

Then my colleague pointed toward something at the far end. We followed him to what the school called its cultural corner. The HOI explained that everything in this corner had been collected from the village.

There were wooden shoes once worn to walk over snow, a stone grinder, a kangri, a strip of Kashmiri carpet, the kind families once wove for a living.

The corper wasn't decorative. It was a

The corner wasn't decorative. It was a bridge between memory and learning. "This helps children link their culture with their classroom," the HOI said.

Everywhere I looked, the walls were alive, with paintings of fruits, vegetables, birds, and animals. Their names were written beside them in bold, clear script.

I called over Uzma and asked her to read a few. She read each word without hesitation. Then little Aiman, just four, tugged my sleeve. "Sir, main bhi padhti hoon," she said, asking if she could read too.

We entered the pre-primary classroom next. It felt like entering a different world. The teachers had turned the large hall into a joyful place of learning. The walls were covered in colour. There were math toys, Rubik's cubes, musical instruments, disconsiderable pages and being tripes.

dice, sketch pens and bright rings. The HOI explained, "We bring in these tools to bring in joy, art, and confidence."
Later, around 12:30, we sat down in the office. That's when we heard the children shouting from the washroom. We rushed out. There, I saw something that both surprised and moved me.

A female teacher stood near the wash

A female teacher stood near the wash area, sleeves rolled up, soap in hand. She was bathing the children, carefully, lovingly. After washing them, she sat down and began feeding them with her own hands.

Back in the office, I asked about the staff. Three teachers for fifty-three students were doing everything themselves: teaching, cleaning, feeding, bathing.

There was a dignity in that work. A belief that children deserve care and attention, no matter how small the school or how limited the staff.

That day reminded me of Rumi's words about the waterwheel, the idea that we must keep moving, giving, turning, without becoming dry inside.

Education too must flow like that. The teacher, like the wheel, must take in knowledge and pour it back out in service, to keep the garden alive.

I left the school with those images

etched in my mind: Uzma correcting me with pride, Aiman pulling my shirt for her turn, the teacher bathing her students, and a staff that never said they were doing too much. There are schools with bigger bud-

When Words Disappear The language of our grandparents may

The language of our grandparents may not reach our grandchildren.

At home, I often feel like an orphan of my own

I grew up hearing Kashmiri in its rawest, most beautiful form, from lullabies that my grandmother hummed on cold winter nights to the haunting stories my grandfather told of witches named Rantas and brave men like Sumpa Halwan.

Those words once held magic. They shaped my childhood, wrapped me in warmth, and connected me to something bigger than myself.

But somewhere along the way, I stopped speaking. And now I wonder: Did I stop, or was I made to forget? Today, when I speak to children, especially

the youngest, those of Gen Alpha, I hear a strange mix.
English, Urdu, and Kashmiri all tumble out at once, with Urdu leading the way. There's no

at once, with Urdu leading the way. There's no single rhythm. The mother tongue, it seems, has become the least spoken in the house. It's fading, not in silence, but in substitution.

Language should be part of Kashmir's quintessential beauty. It should be a living thing. Instead, it's dying.

Even though Kashmiri is the mother tongue of more than seven million people, UNESCO now classifies it as a language in danger.

Look around: in our schools, workplaces, streets, and even homes, communication happens in Urdu or English. It is as if Kashmiri has been boxed away, brought out only for drama performances or cultural functions.

It wasn't always this way.
The Britannica Encyclopedia says Kashmiri began as a Dardic language, though over time, it became more Indo-Aryan. The big shift came during the 19th and 20th centuries, especially when Urdu became the court language.

Slowly, Kashmiri got pushed out. In schools, children were scolded for speaking it. I remember it clearly. We were trained to answer in Urdu, praised when we wrote in English, and slowly made to believe that speaking Kashmiri was somehow shameful

Kashmiri was somehow shameful.

As a child, I started to hide my mother tongue. I didn't want to sound backward in a classroom. That shame didn't come from in-

side me, it was planted.

And now I see that same distance growing in the next generation.

Today's children fall asleep to YouTube reels, not wanwun wedding songs or shruks of Sheikh-ul-Alam. Parents, too exhausted or too busy, let screens take over. Even the cartoons they play are in Hindi or English. It starts early, when imitation begins, language

shapes the mind.

Most schools in the valley don't teach Kashmiri. And if they do, it's never at the center. We celebrate English fluency but ignore the richness of the tongue that holds centuries of our soul.

A language carries lullables, wedding songs, curses, jokes, poetry, and prayer. It carries history, and holds us.

I think often of how Hebrew was revived in Israel, how Eliezer Ben-Yehuda insisted on using it daily, wrote a dictionary, raised his son speaking only Hebrew.

Today, that language stands strong. Or how Dogri, in Jammu, gained new ground with official recognition, school curriculums, and even UPSC aspirants choosing it as a subject.

Can we imagine that for Kashmiri?

Can we imagine YouTube channels with cartoons in Kashur, textbooks that make it fun, school competitions that encourage essays and speeches in our own tongue? Can we have radio shows, podcasts, dramas, all in the language our grandparents knew by heart?

Some steps have begun. The Jammu and Kashmir Academy of Art, Culture and Languages is publishing Kashmiri literature and organizing events. That matters. But it's not enough to rely on institutions alone. The real revival starts at home.

Children should hear their parents speak Kashmiri proudly. We should celebrate those who use it, not treat them like they've been left behind. We need Kashmiri in official speeches, poetry slams, theatre, and songs. We need it to live.

When a language dies, it's not only words that vanish. A whole way of seeing the world disappears. A metaphor your grandmother once used no longer makes sense, a joke no longer lands, and a lullaby goes unsung.

Sometimes, I try to write in Kashmiri. I fail, and it hurts. I can express myself clearly in English and Urdu, but my mother's tongue feels like a ghost in my throat.

I remember her saying to me: "Ho lajya, mouj wandith."

There is no English translation that captures the feeling of that sentence. It doesn't just mean "I love you." It means something deeper, something shaped by snow, sorrow, and survival.

Only the language of home holds the weight of this belonging.

Realistic Deepfakes On The Rise; Combating Them May Require More Al

he phone rings. It's the secretary of state calling. Or is it?

For Washington insiders, seeing and hearing is no longer believing, thanks to a spate of recent incidents involving deepfakes impersonating top officials in President Donald Trump's administration.

Digital fakes are coming for corporate America, too, as criminal gangs and hackers associated with adversaries including North Korea use synthetic video and audio to impersonate CEOs and low-level job candidates to gain access to critical systems or business secrets.

Thanks to advances in artificial intelligence, creating realistic deepfakes is easier than ever, causing security problems for governments, businesses and private individuals and making trust the most valuable currency of the digital age.

Responding to the challenge will require laws, better digital literacy and technical solutions that fight AI with more AI.

"As humans, we are remarkably susceptible to deception," said Vijay Balasubramaniyan, CEO and founder of the tech firm Pindrop Security. But he believes solutions to the challenge of deepfakes may be within reach: "We are going to fight back."

AI deepfakes become a national security threat

This summer, someone used AI to create a deepfake of Secretary of State Marco Rubio in an attempt to reach out to foreign ministers, a US senator and a governor over text, voice mail and the Signal messaging app.

In May someone impersonated Trump's chief of staff, Susie Wiles.

Another phony Rubio had popped up in a deepfake earlier this year, saying he wanted to cut off Ukraine's access to Elon Musk's Starlink internet service. Ukraine's government later rebutted the false claim.

Synthetic media can also aim to alter behaviour. Last year, Democratic voters in New Hampshire received a robocall urging them not to vote in the state's upcoming primary. The voice on the call sounded suspiciously like then-President Joe Biden but was actually created using AI.

Their ability to deceive makes AI deepfakes a potent weapon for foreign actors. Both Russia and China have used disinformation and propaganda directed at Americans as a way of undermining trust in democratic alliances and institutions.

Steven Kramer, the political consultant who admitted sending the fake Biden robocalls, said he wanted to send a message of the dangers deepfakes pose to the American political system. Kramer was acquitted last month of charges of voter suppression and impersonating a candidate.

"We've entered an era where anyone with a laptop and access to an open-source model can convincingly impersonate a real person," said Brian Long, Adaptive's CEO. "It's no longer about hacking systems — it's about hacking trust."

Experts deploy AI to fight back against AI

Researchers, public policy experts and technology companies are now investigating the best ways of addressing the economic, political and social challenges posed by deepfakes.

New regulations could require tech companies to do more to identify, label and potentially remove deepfakes on their platforms. Lawmakers could also impose greater penalties on those who use digital technology to deceive others—if they can be caught.

Greater investments in digital literacy could also boost people's immunity to online deception by teaching them ways to spot fake media and avoid falling prey to scammers.

The best tool for catching AI may be another AI programme, one trained to sniff out the tiny flaws in deepfakes that would go

unnoticed by a person.

Systems like Pindrop's analyse millions of datapoints in any person's speech to quickly identify irregularities. The system can be used during job interviews or other video conferences to detect if the person is using voice cloning software, for instance.

Similar programmes may one day be commonplace, running in the background as people chat with colleagues and loved ones online. Someday, deepfakes may go the way of email spam, a technological challenge that once threatened to upend the usefulness of email, said Balasubramaniyan, Pindrop's CEO.

WASHINGTON- For weeks, President Donald Trump was promising the world economy would change on Friday with his new tariffs in place. It was an ironclad deadline, administration officials assured the public. But when Trump signed

Others saw a policy carelessly constructed by the US president, one that could impose harms gradually over time that would erode America's power and pros-

perity.
"The only things we'll know for sure on Friday morning are that growthsapping US import taxes will be historically high and complex, and that, because these deals are so vague and unfinished, policy uncertainty will remain very elevated," said Scott Lincicome, a vice president of economics at the Cato Institute. "The rest is very much TBD."

The new tariffs build off ones announced in the

Trump initially imposed the Friday deadline after his previous "Liberation Day" tariffs in April resulted in a stock market panic. His unusually high tariff rates unveiled then led to recession fears, prompting Trump to impose a 90-day negotiating period. When he was unable to create enough trade deals with other countries, he extended the timeline and sent out letters to world leaders that simply listed rates, prompting a slew of hasty

Govt Funds Carding Machine To Revive Namdha Craft

Refurbished machine will reduce manual labour, meet local demand big time

SRINAGAR- In a significant step toward revival and promotion of the traditional craft of Kashmiri Namdha, the Government has approved funds for refurbishing and installation of a high-capacity Carding Machine at its UNDP wing.

This initiative falls under the larger objective of strengthening the infrastructure and sustainability of traditional handicrafts and handloom sectors in the Valley.

Namdha, a Centuries-old craft involving felting and embroidery of woollen fabric, has been witnessing a steady decline due to various constraints. notably the lack of wool processing facilities, high input costs, and time-consuming manual methods. The refurbishment of the Carding Machine under the Capital Expenditure (CAPEX) budgeting is expected to ad-

dress these bottlenecks directly. In a press statement issued here today, Mirza Shahid Ali, Deputy Director, UNDP, stated

that the availability of modernized carding facilities shall reduce manual labour and processing time significantly, making the craft economically viable for artisans and increase production capacity, enabling them to meet the growing domestic and international demand. This step is also expected to attract younger artisans to the trade by improving working conditions and productivity.

"This move aligns with the Government's broader vision to revive languishing crafts, with Namdha recognized as a flagship craft. We will ensure timely refurbishment, installation and operationalization of the machine while providing necessary training to the artisans to maximize utility," he added.

This development is expected to breathe new life into the Namdha sector, preserve its rich legacy and improve the livelihoods of hundreds of artisans dependent on this culturally significant art form, which has a huge demand, both locally as

NEW DELHI- The imposition of a 25 per cent US tariff will impact about half of India's over USD 86 billion worth of exports to America, government sources said on Friday.

The sectors which could bear the brunt of 25 per cent duty include textiles/ clothing (10.3 billion), gems and ewellery (12 hillion) shrimn (USD 2.24 billion), leather and footwear (USD 1.18 billion), animal products (USD 2 billion), chemicals (2.34 billion), and electrical and mechanical machinery (about USD 9 billion)

They said that about half of the goods exported from India to the US are in the exemption category (such as pharma and electronic goods), so, the impact will be only on the remaining half.

"More than half of India's exports to the US will not be impacted by the duty. Due to the Section 232 exemption of the US, only exports worth about USD 48 billion would be impacted with these tariffs," they said, adding the remaining exports will have a little

GDP of about USD 4 trillion and a consumer base of 140 crore.

In 2024-25, the bilateral trade between India and the US stood at USD 131.8 billion (USD 86.5 billion exports and USD 45.3 billion imports).

According to think tank GTRI, the 25 per cent tariffs will not be applicable on the exempted categories, including finished pharmaceutical drugs, active pharmaceutical ingredients (APIs), and other key drug inputs; energy products such as crude oil, refined fuels, natural gas, coal, and electricity; critical minerals; and a wide range of electronics and semiconductors, like computers, tablets, smartphones, solid-state drives, flat panel displays,

and integrated circuits. According to an exporter, apparel sector that exports USD 5.33 billion worth of goods to the US will be the

most impacted. Sudhir Sekhri, Chairman, AEPC, said: "We request immediate government intervention to offset this huge setback. Exporters have their back against the wall and will have to sell below cost to keep their factories running and avoid mass layoffs.

Kanpur-based Growmore International Ltd MD Yadvendra Singh Sachan said that exporters should use this opportunity to explore new markets. "We need to diversify our exports," Sachan said.

Federation of Indian Export Organizations (FIEO) Director General Aiav said that the US order provides relaxation for goods in transit and those loaded on ship for final sailing to the US by August 7.

US President Donald unveiled sweep-Trump ing new tariffs on dozens of countries, including 25 per cent duties for goods from India, marking a new era of American protectionism that triggered fresh tensions and concerns over a much wider disruption in the global trade landscape.

The US president signed an executive order that raised tariffs for over five dozen countries, with Washington's negotiations for trade deals going down to the wire ahead of the August 1 deadline.

India's Mfg Sector Growth Hits 16-Month High In **July On Expansion In Output, Sales**

MUMBAI- India's manufacturing sector growth strengthened in July to a 16-month high of 59.1, supported by faster increases in new orders and output amid favourable demand conditions, a monthly survey said on Friday.

The seasonally adjusted HSBC India Manufacturing Purchasing Managers' Index rose from 58.4 in June to 59.1 in July, signalling the strongest improvement in the health of the sector since March 2024

In the Purchasing Managers' Index (PMI) parlance, a print above 50 means expansion, while a score below

50 denotes contraction.
"India recorded a 59.1 manufacturing PMI in July, up from 58.4 during the prior month. This marked a 16-month high for the Indian manufacturing sector, which benefited from strong growth in new orders and output," Pranjul Bhandari, Chief India Economist

at HSBC, said. As per the survey, overall sales rose at the fastest pace in close to five years. Subsequently, production growth strengthened to a 15-month high in July and outpaced the series trend.

Over 3.25 Lakh Child Abuse Cases Disposed Of By Fast-track Courts: Centre

New Delhi: A total of more than 3.25 lakh cases have been disposed of by 746 fast-track special courts -- including 405 exclusive POCSO courts -- operational across 30 states and Union territories, the Women and Child Development Ministry said on Friday.

The fast-track special courts (FTSCs) have been formed to expedite trials in cases of rape and child sexual abuse, the ministry informed Lok Sabha in a written response on Friday.

ten response on Friday.

These courts have disposed of more than 3.25 lakh cases as of April 30, 2025, the ministry said.

Uttar Pradesh leads with nearly 90,000 disposals, followed by Madhya Pradesh with over 31,000 and Kerala with over 25,000 cases, according to data shared by Minister of State for Women and Child Development, Savitri Thakur.

In response to another question, Thakur said 2 lakh Anganwadi centres have been approved to be upgraded as 'Saksham Anganwadis' for improved nutrition delivery and imparting early childhood care and education.

"To ensure that the police stations are more women friendly and approachable, as they would be the first and single point of contact for any woman walking into a police station, 14,658 women help desks (WHDs) have been set up, of which 13,743 are headed by woman police officers," she said in response to another question.

To provide help and support to needy women and women in distress, an Emergency Response Support System (ERSS-112) has been established in all the 36 states and UTs for various emergencies, with computer aided dispatch of field/ police resources, Thakur said.

"Since its launch, more than 43 crore calls have been handled so far. In addition to ERSS, a fully-functional dedicated women helpline (WHL-181) is operational in 35 states/UTs except West Bengal.

The WHL has also been integrated with ERSS. So far, the women helplines have handled over 2.10 crore calls and assisted over 84.43 lakh women," the minister said in another written response.

In 2024-25, the bilateral trade between India and the US stood at USD 131.8 billion (USD 86.5 billion exports and USD 45.3 billion imports).

According to think tank GTRI, the 25 per cent tariffs will not be applicable on the exempted categories, including finished pharmaceutical drugs, active pharmaceutical ingredients (APIs), and other key drug inputs; energy products such as crude oil, refined fuels, natural gas, coal, and electricity; critical minerals; and a wide range of electronics and semiconductors, like computers, tablets, smartphones, solidstate drives, flat panel displays, and integrated circuits.

According to an exporter, apparel sector that exports USD 5.33 billion worth of goods to the US will be the most impacted.

Sudhir Sekhri, Chairman, AEPC, said: "We request immediate government intervention to offset this huge setback. Exporters have their back against the wall and will have to sell below cost to keep their factories running and avoid mass layoffs."

Kanpur-based Growmore International Ltd MD Yadvendra Singh Sachan said that exporters should use this opportunity to explore new markets.

"We need to diversify our exports," Sachan

Federation of Indian Export Organizations (FIEO) Director General Ajay Sahai said that the US order provides relaxation for goods in transit and those loaded on ship for final sailing to the US by August 7.

US President Donald Trump unveiled sweeping new tariffs on dozens of countries, including 25 per cent duties for goods from India, marking a new era of American protectionism that triggered fresh tensions and concerns over a much wider disruption in the global trade landscape.

The US president signed an executive order that raised tariffs for over five dozen countries, with Washington's negotiations for trade deals going down to the wire ahead of the August 1 deadline.

In the Executive Order titled 'Further Modifying The Reciprocal Tariff Rates', Trump announced tariff rates for nearly 70 nations.

With America, India had a trade surplus (the difference between imports and exports) of USD 41 billion in 2024-25. It was USD 35.32 billion in 2023-24 and USD 27.7 billion in 2022-23.

In 2024, India's main exports to the US included drug formulations and biologicals (USD 8.1 billion), telecom instruments (USD 6.5 billion), precious and semi-precious stones (USD 5.3 billion), petroleum products (USD 4.1 billion), vehicle and auto components (USD 2.8 billion), gold and other precious metal jewellery (USD 3.2 billion), ready-made garments of cotton, including accessories (USD 2.8 billion), and products of iron and steel (USD 2.7 billion).

Imports included crude oil (USD 4.5 billion), petroleum products (USD 3.6 billion), coal, coke (USD 3.4 billion), cut and polished diamonds (USD 2.6 billion), electric machinery (USD 1.4 billion), aircraft, spacecraft and parts (USD 1.3 billion), and gold (USD 1.3 billion).

India's merchandise exports to the US rose 22.8 per cent to USD 25.51 billion in the April-June quarter this financial year, while imports rose 11.68 per cent to USD 12.86 billion.

The Centre also clarified that appointing judicial officers in District and Subordinate Courts is the responsibility of the State governments and respective High Courts, under Articles 233 and 234 of the Constitution.

The government added that the Supreme Court's 2007 order in the Malik Mazhar Sultan case prescribes timelines that States and High Courts are required to follow for the timely recruitment of judicial officers.

Back in April, Trump had announced a 26% "discounted reciprocal tariff" for India—1% higher than the rate now being imposed.

Wendy Cutler, Senior Vice President of the Asia Society Policy Institute (ASPI) and former Deputy US Trade Representative, stated that India, once seen as a "promising candidate for an early agreement," was now assigned a 25% tariff.

"This casts doubt on the fate of a bilateral trade agreement. The President's frustration with India on trade and broader issues was evident in his Truth Social post," Cutler remarked.

Ajay Sahai, Director General of the Federation of Indian Export Organisations (FIEO), said the order includes some relief for exporters. Goods in transit and those loaded on ships bound for the US by August 7 are exempt. Additionally, products cleared for US consumption by October 5 will not be subject to the new tariffs.

Cutler also noted the logistical challenges US customs will face due to the varying tariffs now imposed worldwide. The seven-day buffer before implementation may help, but importers and businesses should expect initial discussions.

"US companies will also struggle to navigate this complex new tariff regime, especially amid ongoing uncertainties around additional sectoral tariffs and the risk of more penalties for countries not seen as cooperating fully," she said

Trump explained in the executive order that some trade partners have made or are nearing meaningful trade and security commitments with the US. Others, he claimed, have not addressed trade imbalances or aligned on key economic and security matters, warranting continued tariffs.

The order states that new tariffs will apply to goods entered for consumption—or withdrawn from warehouses—starting 12:01 a.m. EDT, seven days after the order's issue date. Tariffs range from 10% to 40%: Japan (15%), Laos and Myanmar (40%), Pakistan (19%), Sri Lanka

(20%), and the United Kingdom (10%).

Citing a "massive trade deficit" with India, Trump said, "While India is our friend, their tariffs are too high—among the highest in the world—and they enforce some of the most strenuous and obnoxious non-monetary trade barriors globally."

He also criticized India's military and energy ties with Russia, stating: "They buy most of their military equipment from Russia and are among the largest buyers of Russian energy—alongside China—at a time when the world wants Russia to stop the killing in Ukraine. All of this is not good!"

He continued, "India will therefore be subject to a 25% tariff, plus a penalty, starting August 1."

Trump further attacked the India-Russia relationship, saying, "I don't care what India does with Russia. They can take their dead economies down together, for all I care."

He added: "We have done very little business

with India. Their tariffs are too high—among the highest in the world. Likewise, Russia and the US do almost no business together. Let's keep it that way." Referring to former Russian President Dmitry

Medvedev, Trump said, "Tell Medvedev, the failed former President of Russia, who thinks he's still President, to watch his words. He's entering very dangerous territory!"

India responded by saying it would take all

necessary steps to safeguard national interests and is examining the implications of the tariffs. Trump also referenced India's membership in BRICS (Brazil, Russia, India, China, and South

Africa), calling it an anti-US bloc.

At a White House event Wednesday, Trump was asked about the penalty related to India's Russian purchases. He replied, "We're negotiating. But yes, BRICS is a factor. It's essentially anti-US, and India is a member—if you can believe it. It's an attack on the dollar, and we're not going to let that happen."

He stated that the tariffs on India stem from both its trade deficit and BRICS affiliation.

"....the Court finds sufficient reasons not only to dismiss the instant writ petition due to misconduct and concealment of material facts but also to levy exemplary costs as a way to express its disapproval and to discourage the improper use of constitutional remedies," the court said and imposed Rs 50000 as costs on the petitioner "in a view to curb such abuse of the judicial process, to deter litigants from engaging in unscrupulous and dishonest pleadings, and to prevent recurrence of such malpractice."

"The said amount shall be deposited before the Registry of this Court within two weeks from today and thereafter shall be released in favour of Respondent No. 8 (Mir) to compensate for the hardship and inconvenience caused to him," the court added.

Earlier the Bench observed the petitioner deliberately suppressed the filing and dismissal of a prior civil suit on the same cause of action, and approached the High Court with a calculated attempt to re-agitate already rejected claims by misleading this constitutional forum.

"The concealment was neither innocent nor incidental; it was a conscious attempt to secure relief by misusing the process of law."

J&K Bans Synthetic

(Food Products Standards and Food Additives) Regulations, 2011, use of Synthetic food colours is prohibited in prepared food items such as Wazwan, Biryani, Pickles, and other meat-based preparations (ready-to-eat)," read the official communication.

The presence of such prohibited synthetic

colours poses a serious risk to public health. In terms of Section 59 of the Food Safety and Standards Act, 2006, such violations are punishable and may attract Imprisonment for a term which may extend to three months, and also with Fine which may extend up to

3,00,000(three lakhs).

"All Food Business Operators (FBOs) engaged in the manufacture, preparation, processing, sale or service of ready-to-eat food items, especially meat-based products such as Kebabs, Wazwan, Biryani, Chicken Tikka, Pickles, etc, are advised to strictly avoid the use of synthetic food colours in any prepared food items," warned the statement.

Meanwhile D&FCO has sought cooperation of all stakeholders to ensure that only safe, wholesome food reaches the consumer.

NIT Campus Stalled

a petition filed earlier this year by environmental activist Dr. Raja Muzaffar Bhat.

The bench, led by Justice Prakash Srivastava, concluded that the case was premature. But it left a door open.

If authorities move ahead with the project in the future, Dr. Bhat, or anyone else, can return to the tribunal.

The relief was immediate and visible across the cluster of villages bordering the Karewa. "This is our land, our orchards," said Ghulam Nabi, a 62-year-old farmer from Ranbirpora. "The apples and almonds here don't just feed Pulwama, they go across the valley. We were scared this land would be lost in the name of development."

Dr. Bhat, who had filed the petition earlier this year, said the threat was real. "Had I not gone to the NGT, the damage would have been done by now. This order saved our Karewa land

and thousands of trees across 4,500 kanals."
In his plea, Dr. Bhat had alleged that authorities were planning to cut down hundreds of mature trees in the horticultural belt of Newa to build the new NIT campus. The region, known for its layered soil formed by glacial deposits, supports some of the richest orchards in the valley.

Alarmed by the prospect of losing this fragile ecosystem, the NGT had issued a notice in April and sought responses from NIT Srinagar and the district administration.

At that time, the tribunal had also asked for

details of any planned construction and an estimate of trees likely to be axed.

The response from NIT Srinagar was

categorical.
In its affidavit, the institution said it had not been allotted any land in Newa. It clarified that the institute continues to function from its current campus in Hazratbal, Srinagar, spread over about 67 acres. "There has been no transfer, no possession, no cutting of trees," the statement

The Deputy Commissioner of Pulwama also submitted a similar affidavit, confirming that no steps had been taken to acquire land or start any construction.

The affidavits further added that any future project would follow due process and obtain all necessary environmental clearances.

Still, residents and activists remain cautious. The Karewas, or plateaus formed by ancient lake beds, are ecologically significant but often poorly protected. In recent years, large tracts have been lost to road expansion, brick kilns, and construction projects.

Experts warn that such changes can damage the region's already fragile groundwater and soil systems.

"This case shows how quickly things can change on the ground in Kashmir," said Abdul Qayoom, an environmental scientist based in Srinagar. "One day, a plan is just on paper. The next, trees are gone, and there's no going back."

For now, the people of Newa say they'll stay vigilant. Many believe the issue hasn't ended, only paused.

"Today it's the NIT, tomorrow it could be a shopping complex or a housing project," said Razia Bano, a teacher in the village. "The only way to protect this land is to speak up before the first tree falls."

The NGT order may have dismissed the petition on technical grounds, but it has also served as a warning. If development does come to Pulwama's Karewas, it will face a community that's ready to defend its roots.

India Lead By 52 On Day 2 Of Fifth & Final England Test

LONDON: Mohammed Siraj produced a lion-hearted spell and Prasidh Krishna cleaned up the tail to script India's spirited comeback after a brutal assault from England openers on day two of the fifth and final Test here on Friday.

After a forgettable opening session where Siraj and Co. were taken to the cleaners by Ben Duckett (43 off 38) and Zak Crawley (64 off 57), the Indian pacers redeemed themselves by bowling out England for 247 in the final session, giving the hosts only a slender 23-run lead. Both Siraj and Prasidh ended with four-wicket hauls.

India lost the reliable K L Rahul (7 off 28) in their second innings to a rare loose shot from the opener. At close, India were 75 for two in 18 overs, leading England by 52 runs.

Yashasvi Jaiswal (51 batting off 49) batted with aggressive intent despite being dropped twice while Sai Sudharsan (11)



was trapped in front by Gus Atkinson shortly before stumps.

Jaiswal had got going with three fours in Atkinson's opening over including a sublime straight drive before being given a chance on 20 ad 40. He brought up his third fifty of the series with a ramp off Jamie Overton

that went all the way.

Close to stumps, a third catch was dropped when Zak Crawley grassed a regulation chance offered by Sudharsan at third slip. Before that, England were bowled out in the final session following Harry Brook's belligerent 53 off 64 balls. The highlight of his

effort was a falling sweep off Siraj that went all the way for six.

In the afternoon session, Siraj struck thrice in a fiery eight over spell. At tea, England were 215 for seven, effectively eight down with Chris Woakes not available to bat due to a shoulder injury.

The wickets to fall were Eng-

land's batting mainstay Joe Root (29 off 45), Zak Crawley (64 off 57), stand-in captain Ollie Pope (22 off) and Jacob Bethell (6 off 14).

A heated exchange of words between Root and Prasidh was also among the talking points of the session.

After being blown away by the England opener in the opening session, Indian pacers found their lengths post the break. Prasidh sent back Crawley who mistimed a pull to be pouched at midwicket.

Siraj got rid of Pope and Root with a nip backer before firing an inswinging yorker into Bethell's pads. The pitch continues to provide plenty of assistance to the seamers.

ploma holder, Jamil will succeed Spaniard Manolo Marquez, who parted ways with the AIFF last month following India's recent struggles.

His first assignment in his new role will be the Central Asian Football Association (CAFA) Nations Cup, to be held in Tajikistan and Uzbekistan from August 29.



No Show At The Oval Triggers Debate About Bumrah's Test Future

LONDON: India's premier fast bowler Jasprit Bumrah not taking part in the series decider against England at The Oval has sparked a debate over his Test future.

Considering his injury-ravaged body, it is highly unlikely that Bumrah would ever be fully available for a five-match series in the foreseeable future. The next such assignment isn't until 2027, at home against Australia.

He made himself available for three Tests out of five in England and stuck to his side of the bargain but the followers of the game including greats like Anil Kumble were left wanting more with the series on the line in the final Test. Him being released from squad on Fri-

day also had the tongues wagging. India's assistant coach Ryan ten



Doeschate called the subject of Bumrah's availability a complex one but considering the risks associated with his fragile back following two surgeries, the team management decided to honour the pace spearhead's decision that he

took before the start of the series. In the near future, India play only two-match Test series against the West Indies and South Africa while the important white ball commitments include the Asia Cup in September and the T20 World

Cup at home early next year.

There is an Asia Cup around the corner, the T20 World Cup is also there. He would want to play those events. Considering his body, he can't play every game. He needs to be managed with extra care. Playing him at The Oval would have been a huge risk.

'Going forward, there needs to be a clear plan on how to manage Bumrah's Test career," said a BCCI source.

31-year-old Bumrah bowled 119.4 overs across three Tests and took 14 wickets including two five-wicket hauls at Leeds and Lord's. India's only win of the series thus far came at Edgbaston where Bumrah was rested.

Without a doubt, he figures among the world's best but considering the risks involved, should he be allowed to pick and choose

games? Is that fair on the other Indian fast bowlers?

For context, workhorse Mohammed Siraj has featured in all five games of an intensely-fought series. In the media interaction post day one at The Oval, majority of the questions revolved around Bumrah.

The 31-year-old became a household name with his exploits in the shortest format but it did not take him long to gain respect of the opposition after making his

Test debut in 2018. Post the England series, the Indian team selectors will sit down and review the tour. On top of their agenda would be Bumrah's red-ball future. Should he continue to be used sparingly in an important series or sacrifice one format for the other? The picture should be clearer soon.

The all-rounder had to leave the field after landing awkwardly on his left shoulder while saving a ball hit by Karun Nair at long-off late during

the opening day of the match on Thursday. Woakes looked in visible pain as he walked off the field with his left arm wrapped in his

Earlier on Thursday, Woakes teammate Gus Atkinson said Woakes' injury didn't look good. "I don't know too much about it, but it doesn't look great," Atkinson said after India reached 204 for 6 at stumps on the rain-affected day.

Woakes bowled 14 overs on the opening day, picking up the crucial wicket of KL Rahul and conceded 46 runs.

Woakes' injury has added to the woes of England, who are missing several key players, including captain Ben Stokes.

Atkinson picked up two wickets from his 19 overs on the opening day, and seemed confident to take up the responsibility in Woakes' absence.

UAE To Host Cricket Tri-Series Ahead Of T20 World Cup

The United Arab Emirates will host a Twenty20 tri-series including Afghanistan and Pakistan later this month as part of the teams' buildup for next year's T20 World Cup.

Sharjah will host all seven games of the triseries, starting Aug. 29. Teams play against each other twice before the top two qualify for the

Pakistan and Afghanistan have already secured direct qualification for the T20 World Cup to be jointly hosted by India and Sri Lanka. UAE could also qualify but it has to play ICC's Asia-East Asia and Pacific qualifiers in Oman in

Afghanistan, which finished seventh in the last T20 World Cup, hasn't played a T20 since a bilateral series against Zimbabwe late last year. Pakistan is currently playing a T20 series against West Indies in the United States.

The tri-series will be followed by the Asia Cup, also scheduled to be held in the UAE, from Sept. 9 when Afghanistan takes on Hong Kong in the opening game.

Galatasaray Break Record To Sign Osimhen From Napoli

alatasaray have signed striker Victor Osimhen from Serie A side Napoli for 75 million euros (85.74 million dollars), the Super Lig champions announced on Thursday, making the Nigerian the most expensive incoming transfer

Osimhen's transfer shattered the previous record set by Fenerbahce when they signed Youssef En-Nesyri from Sevilla on a five-year contract for 20 million euros in July last year.

As part of the agreement, 10% of any future profit from Osimhen's next transfer will be paid to SSC Napoli, Galatasaray said.



"A four-year contract has been signed with the player, starting from the 2025-2026 season" Galatasaray said.

According to the agreement, the 26-year-old will receive net guaranteed salary of 15.0 million euros for each season.

Osimhen will also get a net loyalty bonus of 1.0 million euros per season and 5.0 million euros as image rights payments — compensating for the use of his name, image, and likeness in the club's branding and promotional activities. Napoli also confirmed the terms of the deal. (AP)
