2 Terrorists **Killed In Kulgam Encounter**

Srinagar: Two terrorists were killed in an encounter with security forces in Jammu and Kashmir's Kulgam district on Saturday, officials said.

The overnight encounter began after security forces launched a cordon and search operation in a forest area at Akhal in the south Kashmir district, following specific intelligence inputs about the presence of terrorists there.

After an initial exchange of fire between the two sides on Friday evening, the operation was halted for the night, the officials said.

The cordon was strengthened, and additional reinforcements were rushed to the area.

Firing resumed on Saturday morning, during which two terrorists were killed, the officials said.

The identity and group affiliation of the slain terrorists are being ascertained, they added, noting that the operation is still underway.
Sources said that both slain

terrorists are reportedly locals who had joined terrorist ranks two years | More on P6

Centre Blocks 1,500+ Online **Gaming Sites**

In a written reply to the Rajya Sabha, Minister of State for Electronics and Information Technology Jitin Prasada said 1,524 such websites were blocked between 2022 and June 2025 under Section 69A of the Information Technology Act. Amarnath Yatra Suspended A Week Early

Srinagar: Authorities have suspended this year's annual Amarnath Yatra, just a week before its scheduled conclusion, due to the need for maintenance on the tracks that were damaged by recent heavy rainfall, officials said on Saturday.

The yatra, which began on July 3, was scheduled to conclude on August 9 on the occasion of Raksha Bandhan. However, authorities decided to shorten it by a week, citing "critical repair and maintenance works" to be undertaken in the wake of the heavy rainfall.

"Due to recent heavy rainfall and the need for track maintenance along both the Baltal and Pahalgam axes of the Shri Amarnathji Yatra route, the yatra movement has been closed on both the tracks," Commissioner Divisional Kashmir, Vijay Kumar Bidhuri, said here.

"It has been observed that due to the continued deployment of men and machinery on the tracks from tomorrow. we would not be able to resume the yatra. The yatra will therefore remain suspended from 3rd August onwards from both the routes," he explained further.

More than 6,000 pilgrims paid obeisance to Lord Shiva at the holy cave shrine on the final day of this year's annual Amarnath Yatra, taking the total number of yatris to 4.14 lakh, officials said.

Last year saw more than 5.10 lakh pilgrims pay their respects at the shrine.

Over 45 Manhole Covers Stolen In City; SSCL **Raises Alarm**

Srinagar: In a worrying trend, more than 45 manhole covers have been stolen from Srinagar in recent months, triggering serious safety concerns, officials said.

They said the latest incident captured on CCTV, shows a man in a passenger auto stealing a few covers in the early hours of July 31 along the busy residency road stretch, from SBI Bank to Abi Guzar Srinagar.

Officials from Srinagar Smart City Limited (SSCL), told the news agency—Kashmir News Observer (KNO) that these thefts have been taking place since December 2024, when 24 covers were stolen from Linz Restaurant to Polo View.

He said more recently over five manhole covers have also gone missing between Press Enclave and Clock Tower. "This is not just theft and it directly pedestrians endangers and motorists. These covers are essential for safety, especially in high-footfall areas like Lal Chowk," said a senior official from Smart City Srinagar SSCL.

He said SSCL engineers had to personally restore multiple manholes in the past two days to prevent any mishaps. "A day before the recent incident, our three Junior Engineers manually fixed two open manholes and they were again out repairing more after the July 31 theft," the official said.

Meanwhile, following the latest incident, SSCL has written to the Senior Superintendent of Police (SSP) Srinagar and SHO Kothibagh, requesting immediate registration of an FIR and review of CCTV footage to trace and arrest the culprits.

Moreover, the letter also called for strict legal action and permanent measures to secure these manholes. "The stolen covers must be restored and efforts must be made to prevent future thefts," it stated.

Additionally, with the frequency of such incidents increasing and including a similar case recently reported from Bemina, the Smart City officials have stressed the urgency of safeguarding vital urban infrastructure and ensuring citizen safety—(KNO)

Man Battling For Life After Stray Dog Chase

Srinagar: A man was left critically injured in Bemina on Saturday after his motorcycle skidded off the road while he was being chased by a pack of stray dogs, once again highlighting the growing threat posed by the stray dog pop-

ulation in the city. The victim, identified as Naseer Ahmed Khan, a resident of MIG Colony Bemina, was on his way through the area when a group of stray dogs began pursuing him. In an attempt to flee, Khan reportedly lost control of his twowheeler, which skidded off the road, throwing him onto the pavement.

Eyewitnesses said the scene unfolded in a matter of seconds. "He was speeding up to escape the dogs

when his bike slipped. We saw him fall hard and rushed to help," said one local resident who witnessed the accident.

Khan was immediately shifted to JVC Hospital Bemina, where doctors confirmed he had suffered a severe head injury. His condition remains critical.

The incident has reignited public anger over the unchecked rise of stray dogs in Srinagar. Locals say this is not the first such case and have reiterated their demand for swift and effective action from the municipal authorities.

"Every day, people—especially children and elderly—live in fear. How many more lives will it take for the administration to wake up?" said another resident, expressing the community's frustration.



Despite Announcements, Major Flyover Projects Still In Limbo

4 Lakh Vehicles Ply On City Roads Each Day, Traffic Snarls Leave People Exasperated

Srinagar: Despite recent government announcements of a massive infrastructure push — including new flyovers and construction projects worth nearly Rs 10,000 crore - most of the promised developments in Srinagar remain limited to papers, fuelling public frustration amid worsening traffic congestion.

One of the centerpiece projects is the proposed flyover from Jehangir Chowk to Pantha Chowk, projected as a game changer for the city's notorious traffic jams. Jehangir Chowk–Pantha Chowk flyover is part of our broader initiative to decongest Srinagar and modernize urban mobility," a senior official from the Jammu and Kashmir Public Works Department said.

He said that the department has secured significant funding and is committed to seeing these projects through.

However, Srinagar residents say they have been hearing similar promises for years. "It's not the first time we have heard about

new flyovers or intersection expansions. We welcome the announcements, but unless work actually starts, these remain empty promises," said Farooq Ahmad, a local shopkeeper near Qamarwari.

According to official sources, the government's plans also include major flyovers from Dalgate to Jehangir Chowk and at other bottlenecks. "Detailed Project Reports (DPRs) and other necessary documentation have already been prepared for several of these proj-

ects," said a senior PWD engineer. "But, due to a variety of administrative and logistical challenges, physical work has not yet commenced on many sites," he added.

The persistent delays are particularly troubling for commuters and business owners in traffic prone localities including Jehangir Chowk, Batmaloo, Qamarwari, Rambagh, Baghat, Natipora, and Umarabad. "Every day, we get stuck in traffic for up to an hour just to travel a few kilometers. It's affecting our livelihoods," said Mushtaq Lone, a businessman from Natipora.

Official statistics highlight the scale of the problem: approximately four lakh vehicles ply on Srinagar roads each day. With traffic volumes continuing to rise and no significant new infrastructure yet in place, congestion is now a daily ordeal for the city's residents. "We understand the public's concerns and are working to expedite project clearances. The government remains committed to improving urban infrastructure across Jammu and Kashmir," said a senior PWD Official—(KNO)

Leave Constitution, Talk Humanitarian: PM

RINAGAR - The prime minister, Atal Bihari Vajpayee, to-day asked all the militant groups in Jammu and Kashmir to come forward for talks with the Centre. While rejecting the possibility of Pakistan's involvement in the peace pro-cess initiated with the Hizbul Mujahideen, he, however, made a significant departure from the oft-imposed rider of holding talks

within the, frame work of Indian constitution.

"Our doors are open. I appeal to all militant groups and organisations, which believe in peace, to join the centre's efforts for peaceful resolution of the Kashmir issue," Vajpayee told media persons here after leading a delegation of major political parties

Asked whether Pakistan would be invited to form part of the peace process, Vajpayee said, there is no question of Pakistan's involvement." Holding Islamabad responsible for the killings, he said the absence of unequivocal condemnation by Pakistan makes it all the more a suspect Pakistan must come clean as its silence on the massacres would further affect the bilateral dialogue process.

Asked whether the talks would be strictly within the frame-

work of the constitution, Vajpayee said, "Leave the constitution. Talks should be held on humanitarian considerations that violence is stopped and no more blood is shed."

To a question whether lapses insecurity led to the killings, he said the government would order an internal inquiry to find out the reasons behind the orgy of violence. Vajpayee was ac-companied by union ministers George Fernandes and Mamata Banerjee, Congress President Sonia Gandhi and her party colleague Ghulam Nabi Azad, Mulayam Singh Yadav (Samajwadi Party), Somnath Chatterjee (CPI-M), K Yerran Naidu (TDP) and Kanshi Ram (BSP).Vajpayee, who was accompanied by Jammu and Kashmir governor G.C. Saxena and chief minister Farooq Abdullah, termed as ridiculous allegation by Pakistan about the involvement of Indian security forces in the killing and rejected the possibility of instituting a judicial inquiry on the issue. The involvement of Pakistan-based Lashker-e-Taiba have been proved beyond doubt other than Hizb-ul-Mujahideen being unhappy over the peace process initiated by the centre

Maintaining that Islamabad must unequivocally condemn the massacres, Vajpayee made it clear that violence and peace talks cannot go together. Nothing can be achieved through killings. He said if General Musharraf continued to maintain silence, then the future of resumption of bilateral parleys would become even more difficult, To a question on the issue of autonomy, Jammu and Kashmir chief minister, who was present the Vajpayee's press conference, said we are talking with the centre

Ramp Up Raids

eople across Kashmir are angry, and they have every right to be. The discovery of 1,200 kilograms of rotten meat at a cold storage unit in Zakura has shaken households across the valley. What made it worse was the revelation that most of the meat came from outside and had already entered the local market.

It's not just a scandal. It's a violation. Playing with public health in this way is criminal, and those responsible deserve more than a slap on the wrist. This calls for exemplary punishment. When food safety is compromised, everything else starts to rot along with it.

The outrage isn't just about spoiled meat. It's about what this says about the systems meant to protect us. Families now wonder what they've unknowingly served their children, guests, and themselves. People have lost trust, and rebuilding that trust won't happen through statements and photo ops.

This can't end with the Zakura raid. That raid should be a beginning. The Food Safety Department must step up in ways people can see and feel. Kashmir needs more than one warehouse raid. It needs a wave of strong, transparent inspections. It needs accountability at every level: from those who move the shipments, to those who store them, to those who sell them.

Most past raids have stopped at the small fish: roadside vendors, local butchers. But it's the big suppliers who run the network. They're the ones importing meat from other states, storing it in poor conditions, and distributing it across the valley with little to no checks. That's where the focus must go now.

We already have laws to handle this. The Food Safety and Standards Act lays it out clearly. What's missing is enforcement with urgency and intention. Random checks, surprise raids, and public reporting of violations could go a long way in restoring some faith.

People shouldn't have to live in fear of what's on their plate. Meat is more than a meal in Kashmir. It's part of how we celebrate, share, and live.

The only way forward is to act decisively. Criminal carelessness with food must end. Public trust must be earned back. And that begins by cleaning up the system.

Endocrine Emergency

Farmers, families, and frontline workers are showing signs of exposure to toxic chemicals.

n the villages of Pulwama and Shopian, apples are a badge of pride and progress. Families have tended these orchards for generations. They know how to prune branches, read the sky for hail, and time the harvest to perfection.

But lately, a darker knowledge has taken root.

Mothers speak in hushed tones about daughters who can't conceive. Young men queue at clinics for unexplained spinal pain.

In one village of 1,400 homes, 15 cancer cases have emerged in just a few years.

I began noticing these patterns during training sessions and outreach camps held in South Kashmir. Women from orchardist households would stay behind after the formal sessions ended.

'Why are we seeing so many girls who can't get pregnant?" one woman in Shopian asked. "Our mothers never talked about this. It's something new.

They are right. It is new, and it's spreading.

In Srinagar's diagnostic labs, young radiologists are alarmed. They perform 20 to 25 scans a day, often over grueling 12-hour shifts. Over half of their patients now

come from South Kashmir, and a worrying share show early signs of spinal degeneration, liver stress, and even brain tumors. Lab technologists, too, are

seeing a surge in hormonal disorders: thyroid dysfunction, PCOD, early menopause.

These complaints form a pattern, and all arrows point back to the orchards.

What changed?

Ten years ago, an average orchardist used just three or four sprays a year, mostly harmless horticultural oil and occasional antifungals.

Today, farmers apply up to 20 chemical treatments per season, and the sprays are no longer benign.

Systemic pesticides, synthetic fungicides, and a newer, more dangerous entrant, Plant Growth Regulators (PGRs), have transformed apple farming.

These are not your grandfather's sprays. PGRs are powerful synthetic chemicals designed to force larger fruit, earlier blooming, and nigher yields.

They also come with a well-documented risk: they disrupt human endocrine systems.

According to Dr. Ghulam Hassan Mir, one of Kashmir's most respected plant pathologists, many of these PGRs are not meant for widespread use in residential areas.



"The chemicals being sprayed now are strong, systemic, and often unregulated." he told me. "Some of them interfere directly with hormones. And we're using them in orchards that are just steps from homes.

The science is clear. Exposure to certain PGRs and systemic pesticides is associated with reduced fertility, hormonal imbalances,

and an elevated risk of cancers. In farming communities where these chemicals are used heavily, the consequences are showing up in medical records, if anyone bothers to look

The problem is, almost no one is looking.

There is no health registry that tracks environmental exposure in South Kashmir. There is no centralized data on the rising incidence of endocrine disorders, cancers, or fertility problems in orchard districts. Public health departments are slow to respond, and agriculture departments often avoid confronting the pesticide lobby.

And so, the burden falls on women undergoing invasive fertility treatments, on men too young to need spinal scans, and on children growing up surrounded by toxins they cannot see.

This is a systemic failure. We cannot separate agriculture from health. What we grow, how

we grow it, and what chemicals we allow into our soil and water will always show up, first in test tubes, then in hospital beds.

Right now, South Kashmir's apple economy is thriving on paper. But in its villages, the cost is becoming unbearable. So what can we do?

First, we need regulation, with teeth. The government must urgently audit and limit the sale and use of PGRs and systemic pesticides, especially in high-density farming zones near homes and schools

Second, we need information. A region-wide health surveillance program should be launched immediately to track disease clusters and correlate them with occupational exposure, soil residue, and groundwater toxicity. Third, we need education.

Farmers are not villains. They're victims of a system that rewards short-term yield over long-term sustainability. Most orchardists I meet are

unaware of what exactly they're spraying, or the cumulative health risks it brings.

Outreach campaigns must be launched for local health workers, Panchayat leaders, and district officials.

Fourth, we must invest in

safer alternatives. Integrated pest management, organic farming incentives, and crop diversification may not offer quick profits, but they are the only path forward if we want our people to thrive alongside our apples.

Finally, we must talk. Health workers, environmental scientists, farmers, and policymakers must begin meeting regularly to share data, concerns, and solutions. No one sector can fix this alone.

What's happening in South Kashmir is a warning, for any region that believes economic success can be separated from ecological balance If we continue to prioritize fruit

size over family health, market yield over medical ethics, we risk destroying the very communities that sustain this valley's economy. The orchard is Kashmir's

pride. But if the price of that pride is rising illness, shrinking fertility, and early death, we must stop and ask: What are we really cultivating?

t began with a cup of tea in a college

I had dropped by to meet a senior academic I've known for years. We were discussing plans to organize a lecture series, something simple that could bring departments together and invite students into deeper conversations.

As we talked through the logistics, I casually suggested reaching out to another colleague on campus, someone equally senior and respected.

Without looking up, he said, "We're not on talking terms. It was a plain, practiced statement, as if

this type of professional cold war were no big deal. Then he sipped his tea. I've started to notice the long silences between colleagues, the polite nods that

cover real tension, and the way meetings end with nothing real being said. I've seen professors refuse to share a panel, department heads skip each other's events, and committees dissolve because

two people couldn't sit at the same table. This ego war is ruining our institu-It shows up in how people introduce

themselves, emphasize their titles, and hold grudges longer than memories.

The work suffers, but somehow, the pride remains intact. Ego on its own is difficult enough. In an

educational space, it becomes dangerous. These places are meant to teach humility, curiosity, and service. And yet, time and again, I've seen that hierarchy and status, what should matter the least, often matter

of Kashmir through education. But if our institutions are teaching rivalry and flattery instead of ethics and excellence, then what kind of future are we building?

Across religious and philosophical traditions, pride is seen as a danger. In Islam, the Prophet Muhammad (peace be upon him) warned against even a grain of pride in the heart. In the Bhagavad Gita, detachment from ego is seen as a path to wisdom. In Buddhism, ego is the root of suffering.

Whether we believe in scripture or science, the message is the same: when people stop listening to each other, everything begins to fall apart.

Modern research backs this up.

Studies by the Harvard Business Review and the American Psychological Association reveal how unresolved conflict and office politics slowly drain institutions. It's silences, standoffs, and the refusal to collaborate that erode teamwork.

The human brain depends on communication between its parts, so do institutions. When two senior administrators won't

speak, departments avoid each other, and good work goes unrecognized because of old grudges, it's like trying to think with only half a brain.

You move, but nothing connects. Eventually, the system collapses under its own disconnection.

We don't need more pitches about transformation. We need cultural repair. And it starts with basic steps: creating space for professionals to talk, disagree, and reconcile.

Promotions should be based on merit, not networks. Every department should model collaboration. Ethical codes should be reviewed as seriously as financial audits. And leaders must be trained, to lead and listen.

A proverb from Africa says: when elephants fight, it is the grass that suffers. In our case, the grass is made of students, ideas, hopes.

Educational institutions don't run on furniture and funding. They run on relationships, trust, and shared goals. When those break, nothing else can hold the place together.

If we want to change education in Kashmir, we need to change the way we treat each other inside our own institutions

Talk to the colleague you've avoided. Praise the person you usually ignore. Share credit, learn to forgive, and choose professionalism over pride.

That's how the healing begins. And that's how students learn what leadership really looks like.

ar and Peace rests on a shelf in a Srinagar study. The cover is plain, the title in flowing Nastalik script, almost too shy to call attention to itself.

But what lies inside is something rare. It is Tolstoy, speaking Kashmiri.

This is no ordinary translation. It's a bridge across continents, centuries, and al-

And behind it was a man who believed his mother tongue was worthy of the world's grandest stories.

Muzaffar Aazim translated Tolstoy alone, in his thirties, with the faith that Kashmiri deserved its place on the global literary

Born in 1934 in Tangmarg, Aazim grew up surrounded by snow, silence, and story. Oral traditions were part of the air.

As a boy, he listened more than he spoke. And later, when he wrote, his words carried that attention.

He studied at Sri Pratap College, taught briefly at Amar Singh College, and went on to become Director of Sericulture in the Jammu and Kashmir government.





Aazim was asking a simple question: How will Kashmiris write their language online?

The job took him across the valley, but no title ever pulled him away from poetry.

His first collection, Zolana (The Fetters), came out in 1963. At the time, Kashmiri literature was still carving out its modern voice. Aazim gave it form: disciplined, lyrical, rooted in metaphor but never lost in

He redefined the rules of the ghazal, gently stretching the form until it fit Kashmir's own shape.



Literary icon Rehman Rahi once called him "a dexterous craftsman," whose poems would "outlast the moment".

That same love of structure, of doing things properly and beautifully, guided Aazim into an unlikely second act: technology.

Long before smartphones came to the valley, Aazim was asking a simple question: How will Kashmiris write their language

He taught himself font design and created Narqalam and Gulmarg Nastalik, the first digital Kashmiri fonts that felt real, not stiff or clunky like the ones people used before.

Aazim worked on Unicode submissions, and exchanged long emails with experts in Silicon Valley, offering insights from a language spoken in mountain villages.

He argued, gently but firmly, for the dignity of Nastalik, and its right to exist in the future. One of his colleagues called his work "a gift that brought Kashmiri back into the digital world." That might sound technical,


Without those fonts, Kashmiri writers might still be typing in borrowed scripts, either in Hindi or Urdu, watching their own alphabet disappear.

Aazim wouldn't allow it.

After War and Peace, he went on to translate iconic Wuthering Heights, besides an Assamese novel called Awami Raj.

Each literary project was an attempt to widen the Kashmiri bookshelf, and show that stories from other worlds could live

He also wrote songs, hundreds of them, for All India Radio Srinagar. Some were



hymns to Kashmir University, others were love letters to his wife. Many became part of the valley's everyday music, played on old radios in kitchens and classrooms.

A producer who worked with him once said, "His lyrics didn't chase trends. They chased emotion."

In his later years, Aazim moved to Virginia. But he never left the language behind. There, in his silent apartment, he began experimenting with calligraphy, mixing Kashmiri letters and digital art, layering them with symbols and ideas from Sufi thought and science fiction.

It was unexpected, but not out of character. He had always wanted to see where the language could go next.

On Doordarshan's Subhai Subhai, he once spoke like a man who believed that culture must be maintained like a garden: watered,

pruned, and protected.

Aazim died on July 8, 2022, at the age of 88. Poets, professors, and programmers paid their tributes, calling his contributions as a living legacy.

Today, Kashmiri is typed across phones and laptops in fonts he shaped. Diaspora writers use Unicode entries he helped draft. Students still sing the songs he once scribbled on paper scraps. His translations still sit in libraries, waiting for curious readers to open it.

For his literary services, Aazim was bestowed with the Soviet Land Nehru Award, two Best Book honours from the J&K Academy of Art, Culture & Languages.

In 2013, his Dastar Bandi was held, a rare literary honour in Kashmir, like being crowned with a turban of respect.

But his real award is what continues. He once said, "A language lives only when it is spoken, written, sung, and now, typed." Muzaffar Aazim gave his language a future it didn't yet know it needed.

And three years after his death, Kashmir still speaks in the letters he carved into

That Day in Gagangeer

We were newly married, full of stories and songs. That day in Gagangeer became our own small forever.

was the first March after our wedding. Zarah and I ■ had been married for six months. The world felt a little different already, as if colours had grown warmer and time had slowed down, just enough for us to notice the shape of our days.

One morning, we decided to drive up towards Sonmarg. It wasn't planned. We just wanted to go somewhere, anywhere.

I didn't know then that the road beyond Gagangeer usually stays closed till late April. These days, the Z-Morh tunnel keeps it open all year, but back then we were driving on hope and sunshine.

I took out my white Maruti 800 car. I had never done this before. In fact, I had never been on a real outing that wasn't about school, exams, family errands, or some distant relative's ceremony. But that day, with Zarah next to me, the air felt easier to breathe.

We drove through willowlined roads, passing shops and fields and stories we'd never heard before. Somewhere near Kullan, we stopped at a roadside shop. I picked up a chilled bottle of Maaza, a big bag of American Lay's, and chewing gum that reminded me of childhood. There were also some fresh, oily local snacks wrapped in a crumpled newspaper. That was lunch, in a way. We laughed as we stepped back into the car, arms full like two kids sneaking treats past their parents.

She fed me chips. I wiped her fingers with my handkerchief. There was music playing, some old Kishore Kumar song that melted into a newer one she loved. Everything felt mismatched, and somehow, just right.

By the time we reached Gagangeer, the snow was everywhere. Locals told us the road

to Sonmarg was shut. It didn't even feel like bad news. Gagangeer looked like a page from a storybook, and that was more than enough.

Horsemen were offering rides for a few hundred metres into the snow, but Zarah didn't feel comfortable, so I dropped the idea. Her smile meant more to me than any view.

We saw a small café run by the tourism department. Its lawn had disappeared under layers of snow, but it still looked inviting. Inside, we ordered sweet tea and sat by the window. Outside, the snow shimmered under the sun, and inside, we sat in a silence that said everything.

For lunch, we had the food Zarah had packed: fried chicken and soft rotis. I suggested we eat outside, and she said yes, without hesitation.

The café had red plastic chairs out in the snow. One chair's leg sank in, then another, and the table tilted too. We tried to fix it but kept laughing as we failed. Zarah's laughter bounced around like windchimes in the air.

I remember thinking: this is what freedom feels like. Just sitting next to someone who laughs with you when the chair falls over.

We finally managed to balance things enough to eat. The chicken was spicy and perfect. The rotis were warm. We added some leftover chips and passed the Maaza bottle between us like we were teenagers again. It felt like the moment that could make you believe in a better kind of world.

After lunch, we took a short walk through the snow. The ground sparkled, the trees looked like sculptures, and though we hadn't reached Sonmarg, I felt like I'd arrived somewhere more important.

I had never experienced anything like it, where silence felt full, not empty.

We started back in the late afternoon. I was nervous about driving downhill, but she trusted me. I saw it in the way she looked out the window and hummed along with the songs. That trust gave me something I didn't know I had: Confidence.

The playlist kept switching, her favourite Bollywood hits followed by my old ghazals. The music didn't match, but we did.

That day may look like nothing special from the outside, but something happened in those hours that staved with me.

I learned what it means to be understood without having to explain. I realised what it feels like when someone holds your hand without asking where you're going.

Later in life, moments weren't easy to speak of. But that day in Gagangeer, frozen in time, still lights something inside me.

It was a day of snow, tea, laughter, and love. I often return to those happy hours when I need to remember what it means to feel whole.

The Brotherhood of Twelve

Inside a forgotten corner of campus, twelve mechanical engineering students built a lifelong bond through grease, grit and grinding gears.

The were literally a dirty In a college buzzing with bigger batches and celebrated courses, the twelve of us were tucked away in a corner. We were mechanical engineering students, half-forgotten by the larger campus, yet fully pres-

ent in each other's lives. We weren't famous, but there was something solid about our group that clicked like a welloiled machine.

Each of us brought something different to the table. Asif Ali, for instance, had a mind like a laser, cutting through problems with precision.

There was one Mounis Mallik, chased by merit. It was like marks followed him out of respect. Then there was Akhtar Rasool. That boy didn't study, he wrestled with books. Mechanics of Solids in one hand, Engineering Drawing in the other, his eyes refused to blink until the

diagrams made sense. Sameer Kaul matched him in energy, as if they were cast from the same mould. Their hunger to understand things pushed the rest of us to raise our game. That's how it worked: we lifted each other without even trying.

We bunked classes a lot. I won't lie about that. But when exams knocked, you'd find all twelve of us holed up in a single room: our notebooks overlapping, questions flying, someone solving problems, someone else brewing tea.

We argued over equations, forgot who owned which pen, and shared everything, especially the stress. Some of us formed tight pairs.

Asrar and Bilal, Hilal, Fayaz and Tajamul moved like clockwork, always in sync, and reliable. Jehangir kept to himself mostly, comfortable in his silent rhythm.

I often teamed up with Suhail Shahzad. Depending on our moods, we'd either stay in the hostel or study at home. Wherever we were, we stayed tuned



to the same frequency: engineers-in-progress, growing into

This wasn't a course we picked casually. Mechanical engineering came with sweat and smudged hands. From the SRTC workshops to dusty training at local firms, we showed up in grease-stained overalls, ready to learn.

Group tuitions in Mathematics and Drawing weren't just coaching sessions. They were daily pilgrimages. We walked, studied, and passed together.

On campus, we didn't carry much weight. We were far from the spotlight. But when it mattered, when unity was called for. we showed up. That's how we protected our space and each other.

Our teachers shaped us who we became.

Ishtiyaq Sir, our Head of Department, balanced humour and sincerity like few could. During our first-year exams, he stood outside Boni Shehjar hall as if guarding our futures.

Once, before a surprise inspection, he whispered, "The Principal, Prof. O. N. Wakhlo, is coming to check your work." I still remember Wakhlo Sir stopping at my desk, glancing over my Engineering Drawing sheet. He gave a small smile and said, "You should've taken Civil. You'll

become a complete engineer." That sentence stuck. It did something to me.

Then $\bar{t}here$ was the man named Sheikh Ashraf Majid. We called him The Colonel. He walked like he owned time,

spoke like a general, and carried knowledge like armour.

Before I ever met him, seniors warned me, "Only go to his office if you must. And only if you're prepared."

His room was a living museum of machine parts - connecting rods, pistons, gears - all lined up like soldiers waiting for inspection.

The first time I knocked, I was more nervous than I'd like to admit. "Come, young man!" he boomed, sounding uncannily like Ashok Kumar from an old Hindi film. He didn't hand me a lecture or a chapter. He gave me a pencil and said, "Draw circles. Freehand. Perfect ones."

That was the beginning. From there, we moved to real parts, breaking them down, understanding their heartbeats.

He was a hard man to impress. His discipline radiated into the staffroom, the labs, even the corridors. Some of the juniors pulled tricks: stealing his tea, poking his car tires. None of it shook him. He kept marching. Every time I saw him. I saw a man stitched into his purpose.

And then came the sound: "Kuchi kuchi kuchi kuchi..."

That was our signal. The Colonel had arrived. And we were his soldiers: Tired, hopeful, oil-

bond of twelve. It was fraternity built through bolts and bearings, lessons and laughter.

No Terrorist Spared, Not Even In 'Pataal Lok': PM On Op Sindoor

Sriagar: Prime Minister Narendra Modi on Saturday invoked Lord Shiva's 'Rudra roop' (fierce form) to describe India's resolute action against terrorism, saying Operation Sindoor showcased the country's strength to the world and delivered a clear message that anyone who dares attack India will not be spared, not even in 'Pataal Lok'.

"My heart was filled with sorrow for the 26 people who lost their lives in the Pahalgam terror attack," Modi said while addressing a public meeting in his parliamentary constituency Varanasi.

"My promise to avenge 'Sindoor' of our daughters was fulfilled with blessings of Mahadev," he said, adding, "I dedicate the success of the operation at the feet of Mahadev."

The prime minister also stressed that the "unity of 140 crore countrymen" became the "strength of Operation Sindoor".

"Shiva means welfare but when terrorism raises its ugly head, Mahadev takes his 'Rudra roop'. During Operation Sindoor, the world witnessed this very form of India," the prime minister said.

Taking a dig at the Opposition, Modi alleged that while the country was celebrating the success of Operation Sindoor, "some people in our own country were troubled by it".

"Congress and its allies are unable to digest the fact that India demolished terrorist hideouts inside Pakistan," he said.

"Aren't you proud of Operation Sindoor? Aren't you proud that India destroyed terror bases (in Pakistan)," the prime minister asked the gathering. He added, "You all must

have seen the visuals of how our drones and missiles precisely struck and reduced terrorist headquarters to rubble. "Several air bases in

Pakistan are still in ICU. While Pakistan's anguish is understandable, what's shocking is that Congress and Samajwadi Party leaders are also unable to cope with it," Modi said.

The prime minister also

accused the Congress of repeatedly insulting the valour of the armed forces and even terming 'Operation Sindoor' a "tamasha" (spectacle).

"Can 'Sindoor' ever be a joke? They dared to insult the sacred mark of our sisters and the valour of our soldiers," he said.

Modi also attacked the Samajwadi Party (SP) for questioning the timing of the military strikes.

"One of their leaders asked in Parliament 'why were the attackers of Pahalgam killed now'. Should I call and ask Samajwadi leaders whether to strike now or later? Should we wait and let the terrorists escape," Modi asked.

"These are the same people who during their rule in Uttar Pradesh gave clean chits to terrorists and withdrew cases against those involved in bomb blasts," Modi claimed, adding that such parties are now disturbed because terrorists are being eliminated.

"This is 'Naya Bharat' (New India), which worships Lord Shiva but turns Kaal Bhairav against its enemies when needed," the prime minister said.

Rajnath Flays Oppn For Raising Questions On Op Sindoor In Parliament

Patna: Defence Minister Rajnath Singh on Saturday came down heavily on the Congress-led opposition for "raising questions" about Operation Sindoor "instead of paying tributes to the valour displayed by our armed forces".

Addressing a function organised by a media house here, the former BJP president also alleged that the Congress had been "soft" on insurgency while in power, and tried to "frame innocent people" by spinning the theory of "saffron terror" because of "vote bank" considerations.

"Recently, we had discussions in both Houses of Parliament on Operation Sindoor. Both debates lasted for 16 hours each. The opposition, which had started off on a belligerent note, was left dumbstruck," Singh claimed.

Singh said it is "regrettable" that the opposition was raising questions on Operation Sindoor, "which saw our valiant armed forced destroying so many terror hideouts".

The occasion warranted paying tributes to the country's armed forces, he said.

"This has been the tradition in the past. During the war of 1971, (when Indira Gandhi was the prime minister), our leader Atal Bihari Vajpayee had wholeheartedly supported the government of the day," Singh said.

He also acknowledged that "political and social unity" had been on display in 1999, when Vajpayee was the PM, and Kargil happened, adding, "such unity is essential to root out terror once and for all".

The defence minister also drew a contrast between the leadership of Prime Minister Narendra Modi, characterised by "decisive action against terror", and the "soft" stance of the past Congress governments, weighed down by concerns of "vote bank" and "politics of appeasement".

"People still shudder to recall the pre-2014 era, when terror attacks had become the order of the day. A series of bomb explosions were seen in this very city," said Singh, referring to the serial blasts that had rocked the Gandhi Maidan in 2013, when he was sharing the stage with Modi, then the chief minister of Gujarat and the BJP's prime ministerial candidate, during the latter's maiden rally in Bihar.

"Elsewhere, like we saw in the Malegaon blast case, innocent people were framed in the name of saffron terror. The judge who delivered the judgment made the remark that terror has no religion. This is exactly what we have been saying all along," the senior BJP leader said.

All the accused in the case, including former BJP MP Pragya Thakur, were recently acquitted.

Singh, who had held the Home portfolio in the previous Narendra Modi cabinet, said, "Vote bank politics weakens the nation's fight against terror. In the last 11 years, our resolve against the menace has grown stronger. The morale of our armed forces is skyrocketing. Anything that dampens this enthusiasm is neither in national interest nor in public interest."

Sources said that two more terrorists are believed to be trapped in the area. "A clearer picture regarding their identity and status of the operation will emerge by Sunday," the sources said.

A soldier sustained injuries during the exchange of fire and has been shifted to a medical facility where his condition is said to be stable.

Army's Chinar Corps posted on X: "Intermittent and intense firefight continued through the day. Alert troops responded with calibrated fire and tightened the noose while maintaining contact. Two terrorists have been neutralised so far. Operation Akhal continues."

Officials said that the thick forest cover and rugged terrain have posed challenges, but the area remains under tight security surveillance. Additional reinforcements have been deployed to seal all possible escape routes.

Drone surveillance, night vision equipment, and thermal imaging devices are being used to track movements in the dense foliage.

The operation has been paused for the night due to poor visibility, in line with security protocols, and will resume at dawn.

J&K Director General of Police (DGP) Nalin Prabhat visited the encounter site and reviewed the ongoing counter-terror operation.

Pertinently, 'Operation Akhal' is the third major anti-terror operation in Jammu and Kashmir within the past week. On Wednesday, two terrorists were killed during "Operation Shivshakti" in Poonch district near the Line of Control following an infiltration attempt. Earlier, on July 28, three Pakistani terrorists were eliminated during "Operation Mahadev" in the Lidwas forest near Harwan on the outskirts of Srinagar. Those terrorists were linked to the April 22 Pahalgam terror attack.(inputs from KNO, PTI)

gaming safer and more transparent. Under the amended Information Technology Rules, 2021 — revised in April 2023 — online gaming intermediaries are required to register with Self-Regulatory Bodies (SRBs), which determine whether a game qualifies as a "permissible real money game."

To curb offshore and unregistered platforms, the government now allows blocking of gaming websites not registered under the GST system.

The Directorate General of GST Intelligence has been empowered to take action against such platforms, and intermediaries can be directed to restrict access to them.

The Bharatiya Nyaya Sanhita, 2023, introduces stricter penalties for illegal betting and gambling, including imprisonment ranging from one to seven years.

Meanwhile, the Consumer Protection Act, 2019 authorizes action against misleading advertisements, including those involving celebrities and influencers. In April 2024, the Ministry of Information and Broadcasting once again cautioned media platforms and advertisers against airing such ads.

To encourage safe gaming habits among children, the Ministry of Education has issued advisories to parents and teachers. Citizens can report cases of online fraud through the National Cyber Crime Reporting Portal or by calling the toll-free number 1930.

Notably, the list includes ten doctors from District Hospital Pulwama. The move is being seen as a step towards restoring accountability and improving the quality of patient care at one of South Kashmir's major health institutions.

Officials said that the transfers were part of a broader strategy to revamp the healthcare system in the region, particularly in hospitals that have faced repeated complaints from the public.

The action comes days after J&K's former Health Minister Sakina Itoo stated that a major reshuffle of doctors was on the cards across Jammu and Kashmir to address long-standing issues in the healthcare system.

deported from the US in the last five years (2020-2024) stood at 5,541.

The number of Indian nationals deported from the UK in the last five years (2020-2024) is 311. In 2025 (till date), the number of Indians deported from the UK is 131, he said.

"The actual numbers may vary for two reasons -- those illegal Indian immigrants in possession of valid travel documents are deported directly by the government of the UK. Further, the Emergency Travel Documents (ETDs) issued to illegal Indian immigrants may not be fully utilised as the individuals may appeal against their deportation," the MoS said.

She had also asked about the modes of deportation used for these Indian nationals.

"Between January 20 and July 22, 2025, a total of 1,703 Indian nationals were deported by the US government to India. Of them, there were 1,562 men and 141 women," he said.

Of these 1,703 Indian nationals, 333 were deported in February in US military flights, 231 were deported in March in charter flights

operated by US Immigration and Customs Enforcement's Enforcement and Removal Operations, and 300 in July through Department of Homeland Security (DHS) charter flights, as per the data shared by the government.

Also, 72 deportees arrived in India individually or in small groups via commercial flights from Panama, as and when their flight tickets were arranged. And, 767 deportees arrived in India through commercial flights from the US, and they arrived in India individually or in small groups, as and when their flight tickets were arranged, according to the data.

The MEA was also asked whether the government has taken any diplomatic steps to ensure better coordination and humane treatment of Indian nationals facing deportation from the US and other countries.

The ministry "remains engaged" with the US side to ensure the humane treatment of deportees during deportation operations, the

He said the MEA has "strongly registered" its concerns with the US authorities on the treatment of deportees, particularly with respect to the use of shackles, especially on women and children.

Concerns with regard to religious or cultural sensitivities, including the use of turbans and dietary preferences, have also been formally taken up with the US side, the minister said.

"This ministry has not received any complaint pertaining to treatment of deportees on any flight after February 5, 2025," he added.

applications moved by her regarding acquiring Indian citizenship as well as a long-term visa.

The court recorded the submission of the solicitor general and noted that "once an inprinciple decision is taken by the competent authority, there is hardly any doubt that, post compliance of the requisite procedures and formalities, the authority would process and accord a visitor's visa to the respondent at the earliest".

The court dismissed Rashid's writ petition seeking relief from the deportation, saying that as a natural consequence, the impugned interim order loses its relevance and thus ceases to exist and operate.

On July 22, Mehta requested the court to defer the proceedings to enable him to explore whether the respondent could be helped in any manner or if it was still feasible to address her

In response, Rashid's counsel, Ankur Sharma and Himani Khajuria, submitted that she was agreeable to the course suggested by the solicitor general.

On June 6, a single-judge bench of Justice Rahul Bharti ordered the Central government to "retrieve" Rashid.

While passing the order, Justice Bharti observed, "This court is bearing in mind the background reference that the petitioner was having long-term visa (LTV) status at the relevant point of time, which per se may not have warranted her deportation, but without examining her case in a better perspective and coming up with a proper order with respect to her deportation from the authorities concerned, she

came to be forced out."
Rashid was served with a Leave India Notice
on April 28 under Sections 3(1), 7(1), and

2(c) of the Immigration and Foreigners Act, 1946, issued by the Criminal Investigation Department, directing her to leave the country by or before April 29.

She approached the high court and sought

interim relief to stay the operation of the order.

However, she was issued an exit permit and escorted to the Attari-Wagah border in

Amritsar by the authorities, from where she crossed over to Pakistan.
Rashid, a resident of Jammu's Talab Khatikan area, has four children who continue to reside in Jammu and Kashmir.

Rashid, daughter of Mohammad Rashid from Namuddin Road in Islamabad, entered India on February 10, 1990, via Attari on a 14-day visitor visa to visit Lammu

She continued to stay under an LTV granted by the authorities on an annual basis. During her stay, she revealed that she married an Indian national.

"It wasn't disputed either that her LTV was valid up to January 13, 2025, and she had applied for an extension on January 4, 2025. But no such extension was ever accorded," the order noted.

Her husband expressed happiness over the decision and thanked the court.

"We are relieved... The entire family was under tension. We were suffering due to the deci-

sion (to deport her)," he said. **After 17 Yrs, Two**

immovable property in Jammu and Kashmir, purchased the said property in his own name.

The victim, under the impression of being a co-owner, lived in the house with Mukhtar for some time, only to realize later that she had been deceived. The investigation revealed that the complainant had come to India in the early 1990s and was residing in Goa when she met Mukhtar Ahmad Guroo in 2005. Their relationship evolved into a domestic partnership, likened to that of husband and wife. Taking advantage of this trust, the accused duped her into parting with her life savings.

The Crime Branch as per the news agency Kashmir News Trust concluded its investigation and filed a chargesheet before the competent court on August 24, 2010, establishing the allegations as true. After hearing extensive arguments from both sides, City Judge Abdul Bari pronounced the judgment, holding both accused guilty.

In a comprehensive and sharply worded verdict, the Judge remarked that the actions of the accused were a "calculated betrayal of trust," executed with the singular intent to defraud an unsuspecting foreign woman who believed in their words.

As per the court order, Mukhtar Ahmad Guroo has been convicted under Section 420 of the Ranbir Penal Code and sentenced to two years of simple imprisonment along with a fine of Rs 5,000. His accomplice, Nazir Ahmad Guroo, was convicted under Sections 109 read with 420 RPC for abetment in the crime and awarded the same sentence of two years' simple imprisonment and a fine of Rs 5,000.

The court further directed that in case of default in payment of the fine, the convicts will undergo an additional six months of simple imprisonment. Both sentences will run

CBK Carries Out Searches In Anantnag, Accused Arrested In Cheating Case

SRINAGAR- The Economic Offences Wing (Crime Branch Kashmir) Saturday carried out searches at several locations and arrested an accused involved in swindling crores of rupees.

The searches were carried out in connection with a case under FIR number 16/2025 under Section 318 (4) BNS 2023 and an accused person, namely Shahid Rehman Bhat S/o Ab. Rehman Bhat R/o Shangus, Nowgam District Anantnag (Proprietor of M/s AR Trading Agri Services Pvt. Ltd) involved in swindling crores of rupees has been arrested, a spokesman said in a statement.

The brief facts of the case are that the Economic Offences Wing (Crime Branch Kashmir) received multiple written complaints, wherein it was alleged that Shahid Rehman Bhat S/o Ab. Rehman Bhat R/o Shangus, Nowgam District Anantnag (Propri-

etor of M/s AR Trading Agri Services Pvt. Ltd) has cheated them on the pretext of providing them High Density Apple Plants, reads the statement.

"The complainants further alleged that the accused after receiving huge amount of money neither provided those High Density Apple Plants nor returned the money but has gone into hiding. Perusal of the bank transaction statements submitted by the complainants reveal that the accused has grabbed Crores of rupees from innocent complainants/farmers," the statement said.

"The accused filed a bail application before the Hon'ble Court of Law however, the bail application has been rejected by the Hon'ble Court of Addl. Sessions Judge Anantnag on the basis of strong objections and prima facie prosecutable evidence submitted by Crime Branch Kashmir," the statement added.

FSD Steps Up Vigil After Seizure Of Rotten Meat

SRINAGAR: In the wake of the recent seizure of 1,200 kilograms of rotten meat from a godown in Srinagar, the Department of Food Safety Kashmir on Saturday assured the public that it is maintaining strict surveillance over the quality of food products in the region.

The department has also urged citizens to promptly report any suspected cases of adulteration or sale of substandard food items through its toll-free numbers.

Speaking about the incident, Assistant Commissioner of Food Safety, Hilal Ahmad Mir, provided details about the operation: "This happened in an industrial area in Zakura. Someone had brought in this meat and stored it improperly. The storage facility lacked the required temperature control these products are supposed to be stored at minus 18 degrees Celsius. When we inspected, we found there was no temperature control, and the meat had completely decomposed. Given the circumstances, we immediately seized and properly dis-

posed of the product."

Mir explained that the bulk of meat and meat products in Srinagar are imported and then distributed locally. "The problem arises when highly perishable items like meat are not kept under the right temperature conditions. If such products are consumed, they can pose serious health risks to

consumers," he said.
Issuing a stern warning to dealers, Mir said, "I want to


make it clear to all dealers that if they fail to maintain proper temperature control systems or handle food products correctly, they will face strict legal action. We are committed to upholding the law and will not hesitate to act against violators."

Mir also encouraged the public to be vigilant and proactive. "Our control room number is available and has been widely published in electronic media. If anyone finds lapses in food quality or has a complaint, they should contact us immediately for swift action," he said.

With high summer temperatures increasing the risk of food spoilage, the department has intensified its inspection drives. "We are actively checking other dealers too. In fact, I have just returned from an inspection. The public can be assured that we are closely monitoring all food products, especially those prone to adulteration or improper handling," Mir said.

The Assistant Commissioner said that targeted action based on public complaints is often more effective than routine checks. "When we receive a complaint, our action is focused and result-oriented. Routine inspections can alert violators and give them time to hide issues, but with complaints, we know exactly

where to act," he said.
"People should be confident
that the Food Safety Department is actively working to
ensure the quality of all food
products. Whenever there is
a genuine concern, we take
immediate and decisive action."—(KNO)

CS Reviews Water Transport, Lake Conservation Measures

SRINAGAR: In a significant push towards sustainable urban transport and ecological conservation, Chief Secretary Atal Dulloo on Saturday chaired a meeting to review the progress on launching of Inland Water Transport (IWT) in Srinagar besides assessing ongoing lake conservation efforts.

The meeting was attended by Commissioner Secretary, H&UDD; Secretary, Transport; Commissioner, SMC; Vice Chairman, LCMA; representatives from the Inland Waterways Authority of India (IWAI) and other stakeholders.

The meeting began with an in-depth review of steps taken to operationalize the water transport on the iconic River Jhelum of the valley. The officials from IWAI and concerned departments highlighted that significant progress has been made, with crucial modalities already finalized.

Commissioner Secretary, H&UDD, Mandeep Kaur, informed that an MoU was signed between IWAI and the J&K Government on March 6, 2025, paving the way for systematic development of water transport facilities. She revealed that the IWAI's Srinagar office is now fully functional and working closely with the local authorities to fast-track its implementation.

She further stated that work has been awarded for seven floating concrete jetties on the



Jhelum River, with an expected completion timeline of five months from the award date of July 15, 2025. Fairway maintenance is already underway with one dredger each deployed upstream and downstream of Wular Lake, she added.

Moreover, it was divulged that a study on urban water transportation on River Jhelum is being conducted by Kochi Water Metro Limited. The stretch from Sangam to Shadipora Bridge has also been completed.

The Department of Transport has shared a Standard Request for Proposals (RFP) to engage an operator for hybrid electric cruise/boat services and is expected to be completed by December 2025.

With respect to the Dal and Nigeen Lake Conservation, the Lake Conservation and Management Authority (LCMA) presented a detailed overview of the measures taken for conservation, management and development of Dal and Nigeen Lakes.

VC, LCMA, Shahid Saleem, detailed out that demarca-

tion of the lake boundary has been completed for the first time through a survey conducted by the Survey of India. He said that the drone surveys, repeated in February 2023, have helped in controlling the illegal constructions and encroachments. A Bathymetric/ Hydrographic Survey was also carried out to enable scientific de-weeding and dredging without damaging the lake's ecosystem, he added.

Expanding the conservation lens, the meeting took note of initiatives underway for Khushalsar and Gilsar Lakes. Plans for their revival and beautification were discussed, with an emphasis on enhancing tourism potential while preserving their ecological sanctity.

Chief Secretary Dulloo lauded the coordinated efforts of various departments and called for timely execution of all planned initiatives. He underscored the need for sustainable solutions that combine eco-restoration, heritage preservation and modern urban mobility.

Pandit Seat Reservation Could Have Bridged Gap With Muslims: Mehbooba

JAMMU: People's Democratic Party (PDP) chief Mehbooba Mufti on Saturday said reserving two assembly seats for Kashmiri Pandits would have been the biggest confidence building measure for the displaced community before their return and rehabilitation in the valley.

The PDP president alleged

The PDP president alleged that the annual Amarnath Yatra has been militarized and no one is allowed to move near the pilgrims.

"I believe the biggest CBM (confidence building measure) for (return of) Kashmiri Pandits would have been reserving two assembly seats for them in the valley instead of sending two members of the community through nomination," Mufti told reporters here.

"By reserving two seats, they would have come for votes and as a result this would have provided both Pandits and Muslims an opportunity to come close to each other. That was the best way to integrate Pandits back in Kashmir," she said.

The former chief minister criticised the BJP's policy on Kashmir and said even tourism related places and pilgrimages have been militarized.

"If you look at Kashmir,

there are so many places for tourists. Amarnath Yatra, which we used to wait for and talk to the saints to feel good, has also been militarized. Even flies cannot go there. What are you doing with Jammu and Kashmir? You are destroying this region," she said.

The PDP president said there



is a need to review the agreement over power projects as "the electricity we are generating is of no benefit to us".

"That is benefiting the rest of the country. First and foremost our state should be compensated financially for these projects and free electricity should be ensured to poor residents," she added.

Reiterating her demand for an impartial inquiry into the recent killing of a Gujjar youth, Pervez Ahmad, in police firing in Jammu, the former chief minister said that the government should ensure justice to his family.

"It is not only about Pervez. More than half a dozen tribal youth have died in mysterious circumstances over the past six months. Makhan Din committed suicide in Kathua after accusing police of harassment, three young men disappeared in Kulgam and it was said they drowned in river," said Mufti.

"In Bandipora, an overground worker was called to the police station and later it was claimed that he died in an encounter, while another arrested youth in Noorabad-Tangmarg (Baramulla) was claimed to have drowned while trying to escape. I see it as a pattern rather than isolated incidents," she added.

The PDP president alleged that the lives of Gujjars have been made miserable in Jammu and Kashmir.

"They are not allowed to freely graze their cattle by police and so called (Gav) Rakshakh. They are not Rakshak but demons who are harassing the Gujjars and forcing them out of forests. Justice should be done with Pervez, who left behind a young widow. An impartial probe should take place since police itself said that he was martyred. There should be accountability and appropriate action so that the family is given justice," she said.

As long as the PDP was in coalition with the BJP, Mufti said "We tied their hands and did not allow them to touch Article 370. I ensured a cease-fire (with militants) and revoked the FIRs of 12,000 youth during my government. (BJP leader) Arun Jaitley came in a delegation to talk to the people of Kashmir."

Thousands of people are in jails and are sick but nobody is talking about them, she pointed out. The PDP chief also trained her guns on the ruling National Conference (NC).

"We thought the (National Conference) government would talk about them. But they are only talking about restoration of statehood and a war is going on between the lieutenant governor-led administration and the NC-led government over authority to transfer. No one talks about real issues like roads, electricity, water and unemployment," she said.

CSIR-IIIM Concludes Training Programme On Scientific Beekeeping

PULWAMA: The CSIR Indian Institute of Integrative Medicine, Jammu, concluded a five day training programme on scientific beekeeping under the CSIR Floriculture Mission at its Field Station, Bonera Pulwama. The training was aimed at imparting entrepreneurial skill and capacity building of aspiring apiarists through scientific and practical knowledge in commercial apiculture.

Zabeer Ahmed, rector **CSIR** IIIM while inabout forming the programme emphasized the Institute's efforts to promote the economically profitable and scalable rural bio-entrepreneurship in Jammu and Kashmir. "Beekeeping present a viable opportunity, particularly for marginal farmers and women led self help groups. This initiative will bridge the knowledge gap in traditional sectors by integrating science driven training programmes," he stated. Such efforts align with our broader goal for fostering self relient and economically empowered rural communities. A total of 25 selected participants from various districts across Jammu and Kashmir participated in the training, he added.

Dr Shahid Rasool, Nodal Scientist CSIR Floriculture Mission informed that the Institute strives for the development of the apiculture sector in the region with imparting the specialized skill to apiarists covering comprehensive modules includ-

ing basics of scientific beekeeping, seasonal management of bee colonies, queen rearing and colony division, winter management strategies, extraction and post harvest handling of honey, identification, control of bee pests and diseases, branding and marketing strategies. The training also included live demonstrations, hands-on techniques, and interaction with apiculture experts to

provide participants with a real time understanding of beehive operations and challenges. Traditional beekeeping practices often face limitations in colony health and honey yield. Scientific beekeeping, when properly adopted, ensures better pollination ser-

vices, increased honey quality, and opens up possibilities for producing high quality honey. Our aim is to transform beekeeping into a viable micro-enterprise supported by science." he added.

Participants expressed enthusiasm and appreciation for the training content, highlighting the need for continued guidance and linkage to market based platforms. The programme also introduced the concept of integrating beekeeping with floriculture and orchard based agro-ecosystems, in line with CSIR-IIIM's trio-business model of apple-lavender-honey.

The training concluded with distribution of participation certificates and a roadmap for follow up supports, including mentorship, FPO integration, and access to scientific beekeeping equipment.

One of the most consistent performers of the series, Jadeja then propped up the score with another vital fifty as he made 53 off 77 balls with five fours. This was his fifth half century of the series apart from a hundred scored in previous Test. Towards the end, Sundar smacked four sixes and four fours to make a quickfire 53 off 46 balls, putting on 39 runs for the last wicket with Prasidh Krishna, to take India's lead beyond the 350-run mark.
