Sick And Struggling: How Healthcare Is Breaking Kashmiri Families

As medicines grow costlier and insurance schemes fail to deliver, falling ill in Kashmir increasingly leads to financial ruin.

Srinagar: Earlier this summer, outside SMHS Hospital in Srinagar, a carpenter waited in the shade with his wife. She rested on his shoulder as they stood in line for her prescriptions.

Her heart medicine costs

₹3,500 a month, about half of what he earns.

"We skip meals sometimes," he said. "She misses doses when we can't afford them. I borrow when there's no other way.'

The carpenter's story is not an exception. It's becoming the rule in Kashmir, where healthcare is turning into a punishing

economic burden.

With strained public hospitals, pricey private care, and patchy insurance coverage, falling sick now means falling behind.

Rural areas face the hardest blows. In 2024, government records showed only 1,030 out of 1,677 sanctioned rural medical officer posts filled. Nearly half of specialist posts at community health centers were also vacant.

"There's a huge gap between demand and supply," said Dr. Iqbal Mir, who runs a primary health centre in South Kashmir. "Patients often wait weeks or travel hours for even routine check-ups."

Pvt Schools Warned On Deposit Rules

Srinagar: The Committee for Fixation and Regulation of Fee of Private Schools (FFRC) Monday said that some private schools were violating the fee regulations by charging 'security deposit and admission fee'.

Chairperson of FFRC Justice (Retd) Sunil Hali in a communique said, "Complaints have been received by the committee that some private educational institutions are reportedly charging 'Security Deposits' from parents and guardians at the time of admission of their wards, ostensibly in lieu of admission fee."

"This practice is arbitrary and is viewed as an indirect attempt to circumvent the statutory provisions and fee regulatory mechanism established under law," it reads.

It also said, "In this regard, attention is drawn to the Jammu and Kashmir School Education Act, 2002 particularly Section 20-C, which prohibits the collection of any fee or charges by private schools without prior approval from the Fee Fixation and Regulation Committee (FFRC)."



Experts Urge Caution At Eateries After Rotten Meat Seizure

SRINAGAR: Following the seizure of over 1,200 kilograms of rotten meat from a cold storage unit in Srinagar, health experts and dieticians have raised serious concerns about meat safety in local eateries and urged the public to exercise caution.

Dr. Nadeem Ahmad, a senior health officer, warned that consuming stale or poorly stored meat can cause food poisoning, gastrointestinal infections, and long-term digestive issues.

"Such incidents reflect regulatory lapses. Until accountability is ensured, people should avoid eating meat at

restaurants and dhabas," he said.

Echoing similar concerns, dietician Shazia Maqbool said that the source and storage conditions of meat in commercial outlets are often questionable. "Poor refrigeration, lack of hygiene, and unethical sourcing are widespread. Home-cooked food is a safer choice, especially for children and the elderly" she advised.

and the elderly," she advised.
Earlier this week, Food Safety Department teams destroyed a large cache of decayed meat at Zakura Industrial Estate. The meat, reportedly headed to local markets, was foul-smelling and unfit for consumption.

The incident has triggered public outrage and alarm, with experts

urging surprise inspections, license cancellations of defaulting suppliers, and more transparency in the meat supply chain.

The Kashmir Chamber of Commerce and Industry (KCCI) has also demanded stricter food safety enforcement, stating that public health must not be sacrificed for profit. Civil society groups and consumer

forums have called on people to report dubious meat-selling practices and ask for hygiene disclosures from food outlets.

"It is better to err on the side of caution," Dr. Nadeem stressed. "Until the supply chain is verified as safe, avoid eating meat outside." (KNT)

Air India Cancels Delhi-Milan Flight After Tech Snag

New Delhi: Air India on Tuesday cancelled its flight from Delhi to Milan due to a technical snag detected in the Boeing 787 Dreamliner aircraft prior to departure.

"Flight AI137 scheduled to operate from Delhi to Milan on 5 August has been cancelled due to a maintenance task identified prior to departure which required additional time for rectification. Our ground colleagues in Delhi are making every possible effort to minimise the inconvenience caused to the passengers due to this unforeseen disruption," the airline said in

The airline also said that arrangements are being made to fly the passengers to Milan at the earliest.

Priyanka: Judges Can't Decide Who's a True Indian

New Delhi: Congress leader Priyanka Gandhi Vadra on Tuesday rallied behind Rahul Gandhi, her brother, over the Supreme Court's reprimand, saying it is not up to the judges to decide who is a "true" Indian.

She said her brother has the highest respect for the army and will never say anything against it. As the Leader of Opposition in the Lok Sabha Rahul Gandhi is liable to ask questions of the government, Priyanka said.

The Supreme Court on Monday stayed the proceedings against Gandhi before a Lucknow court over his remarks on the army during his December 2022 Bharat Jodo Yatra.

The top court, however, censured the Congress leader, saying if he is a "true Indian."

he would not say such a thing. Asked about the court's observations, Priyanka told reporters at the Parliament House complex, "With due respect to the honourable judges of the Supreme Court, they do not decide who is a true Indian. It is the job of the oppo-

lishment he had served.

sition leader. It is his duty to ask questions and to challenge the government."

The Wayanad MP added, "My brother would never say anything against the Army. He holds the army in the highest respect. So it is a misinterpretation (of his remarks)." Later, she said, "With due respect to the judiciary, it is outside its purview to decide who is a true Indian

"Justices can't decide on this. Rahul ji has always and officers. In all his speeches and comments, that respect is reflected. It is the responsibility of the Leader of Opposition to ask questions of the government, and he fulfils that," she added.

Congress general secretary organisation K C Venugopal said Rahul Gandhi's remarks are the thoughts of every Indian.

"When we ask questions inside the House or outside, they (the government) do not answer. We are termed antinational for asking questions. But we are the true Indians who demand answers," he told reporters in the Parliament House complex.



UNICEF: Israel Killing 28 Children A Day In Gaza

New York: UNICEF said in a post on X on Tuesday that the children are dying due to the regime's ongoing bombardment of the territory and its inhumane restrictions on the delivery of desperately needed humanitarian assistance.

"Death by bombardments. Death by malnutrition and starvation. Death by lack of aid and vital services," the UN agency wrote.

UNICEF reiterated that children in Gaza are in urgent need of food, clean water, medicine, and protection. 'More than anything, they need a ceasefire - NOW."

Since Israel launched its devastating war on Gaza in October 2023, more than 18,000 children, roughly one every hour, have been killed.

In the last 24 hours alone, at least eight Palestinians, including one child, have starved to death in the besieged strip.

starving Gaza's youngest population through its continued blockade and the closure of all border crossings

Last month, the Gaza Media Office warned that over 100,000 children, including 40,000 infants under the age of one, were facing imminent death due to the total lack of baby formula and nutritional supplements. It described the crisis as a "massacre in slow motion.'

According to the office, Palestinian mothers have resorted to feeding their babies only water for days, in the absence of formula, while hospitals and health centers are overwhelmed with cases of acute and life-threatening malnutrition.

According to the World Health Organization (WHO), out of the 74 malnutritionrelated deaths recorded this year, 63 occurred in July alone – including 24 children under five, one child over

WHO said most of these victims were declared dead on arrival at health facilities or died shortly afterwards with their bodies showing clear signs of severe wasting. It warned that this crisis remains entirely preventable.

The UN special rappor teur on the right to food, Michael Fakhri, who first warned in early 2024 that Israel was orchestrating a campaign of deliberate mass starvation in Gaza, now says the international community cannot feign surprise at the horror unfolding.

"Israel has built the most efficient starvation machine you can imagine," Fakhri told the Guardian. "So while it's always shocking to see people being starved, no one should act surprised. All the information has been out in the open since early 2024."

"Israel is starving Gaza. It's genocide. It's a crime against humanity. It's a war crime," he stated.

President's Rule in Manipur **Extended by 6 Months**

New Delhi: Parliament on Tuesday approved a statutory resolution to extend President's Rule in Manipur for another six months beyond August 13.

The resolution, which was passed by the Lok Sabha last week, was approved by the Rajya Sabha, amid uproar by Opposition members over the issue of electoral rolls revision in Bihar.

He then asked YSRCP member Subhash Chandra Bose Pilli to speak on the resolution. Opposition MPs however started raising slogans against the Special Intensive Revision (SIR) of electoral rolls exercise with TMP MPs raising slogans while standing next to the YSRCP member.

Rai also said Home Minister Amit Shah had undertaken a tour of violence- affected areas in Manipur. "He (Shah) met high level officials, security forces, civil society members... Rai said, claiming that the northeast has witnessed widespread development under the Narendra Modiled government.

He also said since the President's Rule was imposed in Manipur, only one incident of violence has been reported.

The Rajya Sabha later approved the resolution with a voice vote.

"He was detained on Mon-

day. A joint interrogation will be conducted today," Superintendent of Police, Jaisalmer, Abhishek Shivhare said.

"He is suspected to have provided sensitive information related to strategic operations and activities in the region," the police said.

DRDO conducts tests and trials of missiles and weapons in Pokaran firing range in Jaisalmer, and experts and officials involved in the process stay in the guest house.

'No Compromise on Sovereignty' **Hezbollah Stands Firm on Weapons**

BEIRUT: A member of Hezbollah's parliamentary bloc said on 5 August that the resistance group will not sign off on an agreement to "destroy Lebanon's sovereignty,' hours ahead of a highly antic ipated cabinet meeting set to discuss the issue of weapons.

Ali al-Miqdad, member of Hezbollah's Loyalty to the Resistance bloc, told Sputnik on Tuesday there has been a "media and political hype" around the session, aimed at portraying it "as pivotal or historic.'

The first and most important thing is to hold pivotal sessions to discuss crucial issues such as the occupied territories, prisoners, and reconstruction. Is this session necessary for Lebanon, or for the Israeli and American enemy?" Miqdad added, while condemning those in Lebanon who have "identified



with Israeli and American discourse."

"We will not sign a resolution that would destroy Lebanon's sovereignty and protection, or erase a large portion of the Lebanese people from existence," he went on to say.

"The solution to internal crises must be Lebanese, away from external pressures. The priority today is protecting the country from the existential threat. President Joseph Aoun is en-

trusted with the constitution [Aoun] spoke of Israel's withdrawal from the occupied territories and the cessation of attacks, before referring to the issue of weapons as an internal Lebanese matter."

Miqdad also rejected the idea that the events of 7 May 2008 could repeat. At the time, clashes erupted across Beirut following a government call demanding the dismantlement of Hezbollah's telecommunication system.

Malik was born on July 24, 1946, in the Baghpat district of Uttar Pradesh.

His political journey started as a student leader with socialist ideology but his career was later characterised by party hopping as he switched from the Bharatiya Kranti Dal (BKD) to the Congress, then the Janata Dal and finally BJP.

The Jat leader was first elected to the Uttar Pradesh Assembly in 1974 on Charan Singh's BKD party.

Malik was elected twice to the Rajya Sabha — from 1980 to 1986 and then from 1986 to 1989 — before he decided to contest the Lok Sabha elections on the Janata Dal ticket. He won from the Aligarh parliamentary seat. The then VP Singh government appointed him as the Union Minister of State for Parliamentary Affairs and Tourism.

After the fall of the VP Singh government and the subsequent turmoil in the Janata Dal, Malik switched to BJP, where he became a party vice-president and also acted as in-charge of its Kisan Morcha (farmers' cell).

₹13.12 Crore MGNREGS Wages Pending in J&K, Centre **Informs Lok Sabha**

SRINAGAR: The Government of India on Tuesday revealed that wage liabilities amounting to ₹13.12 crore are pending in Jammu and Kashmir under the Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) as of July 30, 2025.

Minister of State for Rural Development, Kamlesh Paswan, shared the information in a written reply in the Lok Sabha. He clarified that the pending dues belong to the ongoing financial year, while wage liabilities for the year 2024-25 have been fully cleared. "Wage payments are made directly into the beneficiaries' bank accounts using the Aadhaarbased Direct Benefit Transfer (DBT) system." he stated.

Paswan also noted that job cards are not deleted merely due to failures in Aadhaar-bank streamline the process of job card deletions and restorations, the ministry issued a Standard Operating Procedure (SOP) in January 2025. This SOP mandates verification by the Gram Sabha, public display of proposed deletions, a redressal mechanism for grievances, and the settlement of any pending dues before cancellation.

The Minister further added that the release of funds under the Pradhan Mantri Gram Sadak Yojana (PMGSY) is an ongoing process, with approvals being granted daily through the Public Finance Management System (PFMS) after necessary procedures.

He reaffirmed the Centre's commitment to timely wage disbursals and said any delays reported by states or stakeholders are actively addressed.

J&K's GeM Procurement Share Drops To 0.4%

SRINAGAR: Jammu and Kashmir's share in total procurement through the Government e-Marketplace (GeM) has seen a consistent decline over the last five financial years, falling to just 0.40% in 2024-25, according to data provided in the Lok Sabha by the Ministry of Commerce and Industry on Monday.

In 2020-21, J&K accounted for 2.29% of the total procurement on GeM. This figure dropped to 1.41% in 2021–22, then further to 1.06% in 2022-23 and 0.57% in 2023–24 before reaching its

current low of 0.40%. Despite the decline in procurement share, seller participation in Jammu and Kashmir remains strong. The number of new sellers and service providers from the Union Territory onboarded on GeM in 2024-25 was 4,455, while 746 new buyers joined the

platform during the same period. În comparison, 6,318 new sellers joined in 2020–21, followed by 6,132 in 2021–22, 5,146 in 2022– 23, and 4,852 in 2023-24, the data. A copy of which lies with Kashmir Observer reads.

The number of new buyer registrations, though lower than seller registrations, showed fluctuating trends, with 3,159 new buyers in 2020-21, 4,369 in 2021-22, 2,178 in 2022-23, and 1,211 in 2023–24, it added.

Responding to the parliamentary question, Minister of State for Commerce and Industry, Jitin Prasada, said the total procurement value through GeM across India since inception has reached Rs 14.77 lakh crore.

The platform's usage by central government entities has significantly increased over time-from 54.5% in 2020–21 to 88.8% in 2024-25-while the share of State and UT procurement has dropped.

Farmers Demand Accountability As ₹400 Cr **National Saffron Mission Fails**

SRINAGAR: Once known for producing the world's finest saffron, Pampore—the saffron town of south Kashmir's Pulwama district has been continuously witnessing a sharp decline in saffron cultivation and yield, with growers raising alarm over the complete failure of the National Saffron Mission (NSM) on the ground.

Farmers and stakeholders alleged that despite a Rs 400 crore investment under the National Saffron Mission, the project has failed to rejuvenate saffron cultivation or provide the much-needed sprinkler irrigation facilities.

Ashiq Hussain, a saffron grower from Pampore, said the entire project has remained confined to paperwork.

"We've been hearing about the mission for over 15 years now, but nothing has changed on the ground. There's a Spice Park in Dusoo and we have GI tagging, but what use is it when reproduction is on decline?" he asked. He said that despite assur-

ances, no functional irrigation system has been implemented, leaving fields dry and productivity stunted. "Currently, it is time for the irrigation process of our saffron fields but despite spending crores farmers still rely on rains," he said.

Growers said the production , in 2024 year was only 30-40% of the expected output, continuing a decade-long down-



ward trend and it is going to go down further if positive steps won't be taken.

According to official data, the area under saffron cultivation has dropped from 5,707 hectares in 1996-97 to just 2,387 hectares by 2019-20—a staggering 65% decline.

Ghulam Rasool, another distressed grower, warned of dire consequences if immediate measures are not taken. "Every year the yield is falling. If this continues, there will be no saffron left in Pampore by 2030," he said. "The government must act now—stop the blame game and focus on reviving this heritage crop.'

Growers said that three main challenges plaguing the saffron industry include lack of irrigation infrastructure, especially sprinkler systems, unavailability of quality saffron corms, rapid conversion of saffron land for other agricultural or commercial uses

Some farmers have already shifted to other crops like mustard, while others are moving towards horticulture due to low returns from saffron.

The growers are now demanding an in-depth probe into the National Saffron Mission, alleging large-scale failure and possible mismanagement of funds.

"This was a Rs 400 crore project. Where has the money gone? Why are there no irrigation systems in place?" questioned one of the farmers. 'Those responsible must be held accountable so that the people get the promised facilities and this dying crop gets a chance at revival."

They appealed to Chief Minister Omar Abdullah and the Agriculture Minister to personally intervene in the matter and ensure revival efforts are seriously pursued.

They said that if immediate and serious steps are not taken—especially regarding irrigation, seed availability, and land protection—the future of Pampore's saffron industry looks bleak-(KNO)

Vital Trenz To Arihal **Road In Shambles**

SRINAGAR: The Trenz to Arihal road in South Kashmir continues to lie in a dilapidated condition, with locals expressing deep resentment over the authorities' failure to carry out macadamisation work for several years.

The road, which serves as a vital link connecting parts of Kulgam and Shopian to Srinagar via Pulwama, has turned into a nightmare for commuters.

The stretch passes through several key villages including Trenz, Sheikhpura, Sanzan, Allowpora, Marhang, Ahgam and Arihal.

Residents say the road is riddled with potholes, causing frequent damage to vehicles and posing serious risks to the lives of passengers, especially during emergencies.

'This road hasn't seen blacktopping in years. It's full of deep potholes and large cracks. We struggle every day, whether it's school children, patients or daily commuters," said Reyaz Ahmad, a local from Marhang.

Locals added that despite raising the issue repeatedly with concerned departments, no concrete steps have been taken to improve the condition

of the road.

"When MLAs and other political leaders could stage protests against the shifting of the Deputy CEO's office from Shopian, why can't they protest over this critical public issue that affects thousands daily?" questioned Mir Asif, a resident of Trenz.

People have demanded immediate intervention by the district administrations of both Pulwama and Shopian and political representatives to ensure that the road is macadamised at the earliest.

"We are not asking for luxury, just a basic right to safe and motorable roads. The silence of the authorities is disappointing," said another local from Arihal.

Locals urged the R&B department and the district administration to prioritize the Trenz-Arihal road in upcoming developmental plans and pro-vide some relief to the suffering population.

Meanwhile, an official from R&B Pulwama told KNO that macadamisation for this stretch hasn't been sanctioned as of now. He, however, said that efforts are on to get it sanctioned and macadamise the road at an

Kashmir's **Fertility Crisis**

f the current trends are anything to go by, rising infertility is one of the serious public health challenges faced by Kashmir. Diagnostic clinics, hospitals, and outreach workers across the Valley are reporting a significant increase in cases of hormonal disorders, early menopause, and reduced fertility. As a report in this paper makes it clear, the trend is no longer anecdotal as it is being observed across age groups.

More young couples are struggling to conceive. Women are reporting irregular menstrual cycles, early menopause, and polycystic ovary syndrome. Similarly, men are undergoing fertility testing. Clinics across the Valley are seeing rising numbers of such cases. The pattern is becoming difficult to ignore.

One key factor that has been found to enable this trend is the sharp increase in the use of chemical sprays in orchards. A decade ago, farmers typically used a few basic treatments. Today, many orchards receive up to 20 chemical applications a season, including plant growth regulators (PGRs) and systemic pesticides. These are not only stronger but also more harmful. Some are known to interfere with human hormones and have been linked to reduced fertility and certain cancers. These chemicals leave a long-term health impact, more so, when they are used near homes, schools and water sources.

There are other factors too: Kashmir is experiencing rising unemployment, particularly among educated youth. This has delayed marriage and family formation. According to doctors and social scientists, late marriages are now a key factor in declining fertility rates. Stress, financial uncertainty, and the growing social pressure to delay marriage until economic conditions improve are all contributing to this demographic shift.

The issue of infertility, in turn, has been found to further complicate the marital landscape, with childless couples facing heightened strains and increased likelihood of divorce. While once considered a taboo topic, divorce has gradually shed its stigma, empowering couples to seek liberation from unhappy unions.

Mental stress is another factor, and in fact, a more common one. Over the past few decades, Kashmir has become one of the saddest places in the country because of the rise in mental health issues, triggered by a combination of joblessness, family pressure, and social isolation. This, in turn, is not just taking a toll on the physical but also reproductive health of young Kashmiris.

Infertility in Kashmir is thus a layered issue. And to get this right not just needs proper health facilities to treat this epidemic but also a broader response to mental health crisis and joblessness, which, in turn, fuels late marriages and consequent infertility.

India's financial regulators are powerful tools. SEBI handles grievances related to shares, mutual funds, and ETFs. IRDAI steps in when insurers deny or delay claims. RBI resolves banking disputes. AMFI keeps fund houses and agents in check.

This system works. In 2024, SEBI resolved over 80% of complaints in a month. RBI's Ombudsman handled over four lakh cases nationwide. Yet in Kashmir, very few people know about

Financial literacy hasn't kept pace with digital growth here. Young Kashmiris are investing through apps. Older citizens are buying insurance. But when things go wrong, they're left without

Legal battles take years. Regulators act in weeks. And their word carries weight.



Kashmir's Bloodline Stamp

It's no longer enough to say, "He was my father." The state wants it written, stamped, and sealed.

few weeks ago, a young woman from North Kashmir visited a local government office. Her father, a government driver, had passed away suddenly. She wanted to apply for a job under the compassionate appointment rule, a system meant to support families after the death of a government employee. But before anything else, she was asked to prove she was really his daughter.

She pulled out her Aadhaar card. Her name matched her father's, so did the ration card. Yet, the official told her these weren't enough. What she needed was a Blood Relation Certificate.

That one paper would decide whether she would get the job, or whether her family would slip deeper into hardship.

In many parts of India, families are still close-knit. In Jammu and Kashmir, those family ties must often be stamped and certified.

The Blood Relation Certificate may sound like a simple form but it plays a big role in the lives of people here. It helps you claim land, get jobs, receive pensions, apply for visas, or even access welfare benefits.

For years, there were no clear rules on how to get this certificate. Some people got it easily, others were asked for endless documents.

In some places, officials below the required rank signed off. In other places, applications were delayed or denied without reason. That changed earlier this year.

On March 27, 2025, the Jammu and Kashmir administration issued Statutory Order No. 75. This order laid out, in clear terms, who can issue a Blood Relation Certificate, what it can be used for, and what documents are needed.

It put the Tehsildar, the local revenue officer, in charge and made sure no one below that rank could sign it.

Now, to apply, you must submit an application, an affidavit, identity proof, sometimes a death certificate, ration card details, and a verification report from the local patwari. You also need two witnesses to confirm your claim. If all goes well, the certificate

should be ready within 15 working days. On paper, this sounds fair. In re-

ality, things are more complicated. In villages, patwaris are often

overburdened. Some offices are understaffed. Field verification can take weeks. And if the case involves a land dispute or a large property, it might take months.

Sometimes, two people claim to be the child of the same deceased parent. Without birth certificates, which many older people becomes even more difficult. Even embassies now ask for

this document. When Kashmiris apply for family visas, especially to Canada, the Gulf, or the UK, the certificate often

replaces a missing birth record. In a place like ours, where not everyone was born in hospitals or registered with the municipality, the Blood Relation Certificate be-

comes the only proof of kinship. So, what can be done to make this process better?

First, there should be a digital family database linked with Aadhaar and land records. This would help reduce fake claims and make verification faster.

Second, for high-value inheri-

don't have, it's hard to verify. Then there's pressure.

In politically sensitive areas, Tehsildars often face requests,

or even demands, to approve or block certain certificates. Some applicants bring forged documents. Others exaggerate or hide facts in affidavits. For the officials on the ground, it's not always easy to spot the truth.

Still, the certificate remains important. It affects many lives.

Think of families where someone died in service: a policeman, a teacher, a government clerk. Their children or spouses apply for support jobs. Without this certificate, the process doesn't move.

Or think of landowners who pass away without leaving a will. The heirs must prove they're related to get their names on the property.

For children of second marriages, adopted children, or widows living away from home, this tance cases, a public notice could be issued so others can raise objections if needed. Third, short video recordings

of applicants and their witnesses might help verify claims and discourage fraud. And finally, Tehsildars must be given proper staff support,

Srinagar Is Losing More Than Manholes

45 manhole covers have disappeared across the city. They were taken from Srinagar's main arteries, from roads that carry schoolchildren, elderly vendors, working

women, and daily commuters. The CCTV footage that recently surfaced is chilling in its normalcy. A man stops his auto-rickshaw, steps out, lifts a heavy manhole cover with practiced ease, loads it into his vehicle, and drives away. His movements are calm, unhurried, as

if what he's doing is just another job. We are used to blaming thefts on poverty, unemployment, or weak policing. But what this pattern shows is

something much worse: a moral drift that turns wrongdoing into routine.

Srinagar calls itself a Smart City now. We have LED-lit footpaths, gleaming bicycle tracks, and cameras on poles. Yet, when a child trips into an uncovered drain, what good are digital dashboards?

If a city has smart infrastructure but people stop caring, what's left?

Engineers with the Srinagar Smart City Limited have been racing against time out of a growing fear: that someone might fall in and lose their life. That fear shouldn't be carried by engineers. It should be shared by citizens. It should be ours.

An open manhole is a risk map

carved into asphalt. Every uncovered hole is a question about where we stand as a society. Are we so absorbed in ourselves that we no longer notice danger unless it touches us? Or have we convinced ourselves that it's someone else's problem?

This is how civic decay begins. It begins with small silences. We don't speak when we see someone prying open public property. We simply step over the danger, hoping it won't

But the danger is spreading. If manhole covers can disappear in broad daylight, what stops someone from stripping electric wires, uprooting traffic signals, or disabling

Once theft becomes normalized, there's no telling what's off-limits.

Technology can make a city efficient, but only citizens can make

The smarter the city becomes, the harder the mirror it holds to its people. These manhole thefts don't just expose roads. They expose us.


And if we keep ignoring them, we risk falling into a deeper hole, one no engineer can fix.

Grace of Grand Mosque

Jamia Masjid Srinagar has survived fire, floods, and centuries of change. What it may not survive is our indifference.

n a recent Friday, I stood near the arched wooden gate of Jamia Masjid and watched a motorcycle slide past a group of elderly men removing their shoes for prayer. It weaved between street vendors shouting over each other, then stopped beside a tea stall where the mosque's old stone wall had turned into a

shelf for paper cups.
This wasn't a surprise. It's become a scene we've grown used to. And that's exactly the problem.

Jamia Masjid is more than 600 years old, a relic of grace and faith from an era when buildings were made to reflect the soul.

Commissioned in 1402 by Sultan Sikandar Shah and expanded by his son, the beloved Budshah Zain-ul-Abidin, it was designed not only as a mosque but as a symbol of harmony, community, and

Its 378 deodar pillars still hold it up, even after three devastating fires and cycles of war, flood, and lockdown.

Yet what it faces today feels more dangerous than those past calamities. It's the slow decay that comes from within, from carelessness, overcrowding, and a failure to draw the line between reverence and routine.

The streets around Jamia used to grow silent before prayers. Now, they choke with honking vehicles, loud bargaining, selfie sticks, and the occasional fight over parking.

The lanes leading to the mosque, historically walked with wuzu and inward focus, now double as shortcuts for commuters and commercial overflow.

On Fridays, the crowd spills far beyond the courtyard, but so does the chaos.

The real damage isn't just the physical strain from structural vibrations or air pollution, though those are serious. It's the erosion of sanctity.

People come and go, barely noticing they've walked into a 15th-century house of prayer. Some smoke outside its gates. Some vendors blast music beside the ab-

And in the middle of all this, a prayer call still rises, even if few pause long enough to hear it.

Growing up, I was taught that Jamia Masjid was a madrasa for the heart, a space where sermons sparked ideas and softened egos. It was a living witness to Kashmir's philosophical and political life, a place where we were reminded, every Friday, what it meant to be part of a collective.

Today, those lessons are drowned out by commerce and crowd. The mosque still stands, but what it stands for is fading.

This erosion didn't happen in a day. It came with people treating the mosque like an Instagram stop or a shortcut between errands. It came with authorities turning away, too busy or too uncertain to protect what clearly needs protecting.

There are practical steps we can take. Designate the entire mosque area as a pedestrian-only zone. Establish parking lots at a respectful distance. Regulate vendors, ban vehicles near the prayer space,

and launch an awareness campaign led by religious leaders and historians who understand what's at stake.

But we also need something deeper: a cultural reawakening to the idea that sacredness is worth preserving.

Jamia Masjid is neither a medieval monument, nor a ruin to admire and move on from. It is a breathing, beating symbol of what Kashmir once valued: re-

flection, scholarship, dignity.
Letting it dissolve into noise and convenience is a rejection of that legacy.

I say this not as an academic or an outsider. I'm from Gund Sonamarg, but I have spent years walking Srinagar's lanes, praying beneath Jamia's wooden canopy, feeling its centuries-old coolness in summer and its worn stone warmth in winter.

I've sat under its chinars, watching children play, listening to old men speak of things that no longer made it to street shrill. I've felt the weight of that place, and I know what it meant to people who had little else to hold on to.

We say we want to protect our heritage. Then we must prove it. We must stop treating this mosque like a through-lane and start treating it like the heart of our spiritual and civic life again. If we fail to do this, the building may remain, but its meaning will not.

And one day, our children will walk through it and feel nothing. hat scares me mos

Deconstructing Dabashi

In turning doctrine into metaphor, Dabashi replaces centuries of Shia thought with psycho-political impressions.

For decades, Hamid Dabashi has cut a striking figure in academic and cultural circles. An Iranian-American professor at Co-

lumbia University, he's known for his wideranging commentaries on cinema, Islam, revolution, and exile.

His prose is lyrical, references layered, and style unapologetically bold.

Shi'ism: A Religion of Protest, published in the wake of dashed hopes following the Iranian revolution, carries his familiar voice: part theorist, part memoirist, and always a provocateur.

But this time, Dabashi's literary confidence comes at a cost.

His core claim, that Shi'ism is not a theological system but a cultural posture rooted in historical grief, raises eyebrows for reasons deeper than scholarly disagreement.

The book may be stirring, but it trades doctrinal accuracy for poetic mood, and collapses centuries of intellectual tradition into a metaphor of endless defiance.

In Dabashi's hands, Shi'ism becomes a ritualized resistance narrative.

From the martyrdom of Imam Hussain at Karbala to the chants of modern protestors, Dabashi reads the entire tradition as a theatre of dissent.

For him, power corrupts theology, while defeat preserves its soul.

This view, while emotionally charged, struggles to align with Shia sources or the tradition's own self-understanding. Faith, in this telling, lives only in mourning. Once it governs, it dies.

The problem isn't that Dabashi notices protest within Shia history, any student of Karbala or the Safavid era can confirm that defiance has deep roots. The issue is that he elevates protest into a theology of its own, sidelining core doctrinal pillars: divine unity, prophecy, and most crucially, the Imamate, divinely guided leadership central to Shia belief.

These concepts form a framework of knowledge, authority, and meaning. They cannot be reduced to metaphors of rebellion without losing their spiritual substance.

Dabashi's approach leans heavily on psychoanalysis. He recasts the Karbala tragedy as a site of inherited trauma, drawing from Freudian motifs rather than Qur'anic exegesis or hadith literature.

The Shia community, he suggests, is locked in an unconscious cycle of guilt and revolt. But grief in Shi'ism is a moral covenant, rather than a psychological wound. Commemorating Hussain's sacrifice is a pledge to justice, a reaffirmation of divine principles. It isn't an act of helpless mourning.

Dabashi misses this.

The omissions pile up. There is barely a rious discussion of ture, or theology. Names like Shaykh al-Tusi, Allama Hilli, or Ayatollah Sistani don't enter

his landscape. Instead, we get Zoroastrian imagery, Iranian cinema, and flashes of revolutionary nostalgia.

Even basic facts falter: claims about the Prophet's miracles, the Prophet's family, and early Islamic history are drawn from contested accounts and presented as fact, often at odds with Shia teachings.

His scope is equally narrow. While claiming to speak for global Shi'ism, the book remains steeped in post-revolutionary Iranian politics.

Shia communities in Iraq, Lebanon, Pakistan, and East Africa receive scant attention, and when they do appear, they serve as supporting actors in an Iran-centered drama.

The diversity of practice, interpretation, and leadership across the Shia world is flattened into a single narrative of disillusion-

Gender is another blind spot. Central female figures, Fatimah al-Zahra and Zaynab bint Ali, are treated briefly, if at all. Yet their roles in theology, history, and devotional life are indispensable.

Shia spirituality, like its politics, is shaped by women's voices, acts of remembrance, and claims to authority. To overlook them is to misread the tradition.

Perhaps the most troubling assertion in the book is its conclusion: that Shi'ism, once it seizes power, collapses. Here, Dabashi offers not theology, but resignation. For him, the tradition's only truth lies in resistance, never in responsibility.

But Shia thinkers have long grappled with questions of ethical rule, legal reasoning, and statehood. Imam Ali's caliphate, though marked by turmoil, was rooted in a vision of just governance. Jurists across centuries have sought to balance divine law with worldly responsibility. Shi'ism has never feared power. It has tried to sanctify

To be clear, Shi'ism: A Religion of Protest isn't without value. It captures a moment in Iranian intellectual history, a sense of despair among those who saw revolution fade into repression. As a political memoir filtered through reli-

gious symbolism, it has power. But as a study of Shi'ism, it falls short. It mistakes poetry for theology, nostalgia for scholarship. Faith, especially one as rich and contested

as Shi'ism, deserves more than metaphor. It requires engagement with scripture, tradition, and the lived realities of its followers.

Shi'ism doesn't vanish in authority. It struggles to make authority just. Its truth isn't silenced by history, it lives through it.

Dabashi wanted to write about protest. In doing so, he forgot to listen to the faith he sought to interpret.

Is Your Health Really Covered?

Non-communicable diseases are silently crippling Indian families. It's time for insurance to focus on prevention, not just treatment.

utside a clinic in Srinagar, a 42-yearold mechanic waits for a blood test he can't afford. His fingers are swollen, his breathing is heavy. For months, he brushed off the signs, until his body gave out.

His insurance covers hospitalization, not the check-ups that might have caught the disease earlier. Now he's being screened for chronic heart failure.

He's one of millions stuck in a healthcare catch: health insurance in India is growing, but most plans only kick in after you get sick. The idea of insurance that helps people stay healthy in the first place still feels unfa-

miliar, when it should be foundational. Across India, families are paying a steep price for this gap in coverage.

More than half of all deaths in the country are now caused by non-communicable diseases, conditions like heart disease, diabetes, cancer, and chronic respiratory disorders.

These non-contagious diseases don't come from polluted water or mosquito bites. They grow silently from our diets, routines, and

And they are growing fast. Non-communicable diseases (NCDs) have dominated India's disease burden for over three decades. The numbers are staggering.

The economic cost of NCDs in India is projected to exceed 511 lakh crore (US\$6.2 trillion) by 2030. Obesity and overweightrelated illnesses alone cost the country 2.8



lakh crore annually, more than 1% of our en-

These numbers translate into skipped meals to pay for medicine, lost workdays, breadwinners gone too soon. They show up in overcrowded emergency rooms, and in the

silence of funeral homes. And many of these tragedies could have been prevented.

Health insurance in India has made progress. Schemes like Ayushman Bharat have improved access for many. Private players have expanded offerings. But most policies are still built around one model: wait until someone falls sick, then pay the bill. That model is outdated.

A modern healthcare system must shift from treating illness to preventing it. And that starts with redefining what insurance should cover.

A preventive healthcare plan is a life-saving tool. It covers regular health check-ups, early diagnostic screenings, vaccinations, diet and fitness consultations, even mental health support. Instead of reacting to disease, such plans reduce its chances of ever occurring.

This is about addressing systemic risk than pampering policyholders with wellness

When people have access to early screening, they're more likely to detect blood pressure spikes before strokes, monitor cholesterol before heart attacks, or catch sugar imbalances before diabetes sets in.

Apart from lives, preventive care saves money, time, and human potential.

Yet, the majority of Indian insurance policies don't include preventive benefits, or of-fer them only as costly add-ons. That has to

Globally, the preventive healthcare market is booming. It's expected to grow to US\$197 billion by 2025, at a compound annual growth rate of 22%.

We're seeing signs of momentum in India. Some forward-looking insurance providers now offer preventive packages with broader benefits, ranging from non-accidental dental services and wellness consultations to diabetes management plans and family floater options.

These innovations matter. A family floater plan, for instance, allows all members to get regular preventive check-ups under one umbrella. Some providers are even introducing child-specific plans that ensure kids are monitored closely from birth to adolescence.

Yet access remains deeply unequal. Lowerincome households often skip check-ups due to out-of-pocket costs. Many aren't aware such plans exist. And policy frameworks have yet to catch up with the urgency of the moment.
We're facing a public health challenge that

requires coordination between government, insurers, employers, and citizens. Preventive care should be a core feature of all health in-

Every delayed diagnosis has a human story. A driver in Bangalore who ignores chest pain until it's too late. A homemaker in Jaipur who lives with chronic fatigue, unaware it's a symptom of diabetes. A student in Anantnag who faints in class and wakes up to a diagnosis that could have been prevented with a routine test.

These are the costs of a reactive system.

India cannot afford to treat healthcare like disaster response. We must shift our thinking. Insurance should help people stay healthy, not simply cover them when they're already unwell.

Preventive care is a moral imperative. It reduces the national disease burden, strengthens workforce productivity, and protects families from financial ruin.

It's a way of telling every Indian: your health matters before you get sick.

As insurers, policymakers, and citizens, we must ask: why are we still waiting for people

to fall ill before offering help?
The tools are here, the data is clear, and the

urgency is real. What we need now is the will to act.

ED Attaches ₹42 Crore Assets Of Indian Held In US Crypto Fraud

NEW DELHI- Assets worth Rs 42.8 crore of an Indian man, arrested in the US for allegedly stealing USD 20 million through a fake website that mimicked crypto exchange Coinbase, have been attached under the anti-money laundering law, the Enforcement Directorate said on Tuesday.

The federal probe identified the accused as Chi-

The ED initiated investigation in the case on the basis of media reports which said Tomar was arrested in the US for stealing more than USD 20 million through "use of fake or spoofed" sites mimicking the cryptocurrency exchange website Coinbase.

Tomar is currently lodged in jail in the US, the agency said in a statement.

Describing the modus operandi of the alleged fraud, the ED said a search engine optimisation technique was deployed and when the Coinbase website would be searched, the fake website would appear at the top.

The fake website appeared "exactly similar" to the trusted website except the contact de-



tails, the agency said.

When the users used to enter the login credentials, the spoofed website would show it as wrong and the users would contact the number given in the fake website connecting them to a designated call centre "managed" by Tomar, the ED said.

Once the fraudsters gained access to the victim's accounts, they would quickly "transfer" the victim's cryptocurrency holdings to crypto wallets under their control.

"The stolen cryptocurrency would then be sold on various crypto platforms and converted into Indian rupee," the ED said.

"Subsequently, the money was transferred in the bank accounts of Chirag Tomar and his family members and was used to buy immovable properties," it said.

Anil Ambani Appears Before ED In 17000 Cr Loan 'Fraud' Case

NEW DELHI- Reliance Group Chairman Anil Ambani on Tuesday appeared before the Enforcement Directorate here for questioning in a money laundering case linked to alleged multiple bank loan fraud cases worth crores of rupees against his group companies.

businessman reached the office of the central probe agency in central Delhi in an EV vehicle around 10:50 am.

The statement of the 66-year-old businessman is being recorded under the Prevention of Money Laundering Act (PMLA), official sources said

The summons come after the agency conducted searches at 35 premises of 50 companies and 25 people, including executives of his business group, in Mumbai on July 24.

The ED has notified a Look Out Circular (LOC), as per standard operating procedure in large bank 'fraud' cases, against Ambani even as some executives of his group have also been summoned to appear for questioning during the week as part of this probe.
In a related case, the ED

had recently arrested Partha Sarathi Biswal, the MD of a Odisha-based company, for allegedly providing a fake bank guarantee of Rs 68 crore for a Anil Ambani

Group company.
Biswal may be confronted with Ambani during the latter's questioning, the sources said.

The action against Ambani pertains to alleged financial irregularities and collective loan "diversion" pegged at more than Rs 17,000 crore by multiple group companies of Anil Ambani, including Reliance Infrastructure (R Infra).

The first allegation pertains to "illegal" loan diversion of around Rs 3,000 crore, given by the Yes Bank

The ED suspects, the sources said, that just before the loan was granted, Yes Bank promoters "received" money in their companies. The agency is investigating this nexus of "bribe" and the loan.

The sources said the ED is also probing allegations of "gross violations" in Yes Bank loan approvals to these companies, including charges such as back-dated credit approval memorandums and investments proposed without any due diligence/credit analysis in violation of the bank's credit policy.

The loans are alleged to have been "diverted" to many group companies and "shell" (bogus) companies by the entities involved.

The agency is also looking at some instances of loans given to entities with weak financials, a lack of proper documentation of loans and due diligence, borrowers having common addresses and common directors in their companies, etc., according to the sources.

The money laundering case stems from at least two CBI FIRs and reports shared by National Housing Bank, SEBI, National Financial Reporting Authority and Bank of Baroda with the ED, they had said.

A Reliance Group spokesperson had denied any wrongdoing and said in a statement that the allegation regarding alleged diversion of Rs 10,000 crore to an undisclosed party was a 10-year-old matter and the company had stated in its financial statements that its exposure was only around Rs 6,500 crore.

Reliance Infrastructure had publicly disclosed this matter on February 9, 2025, nearly six months ago, the statement said.

"Through mediation proceedings conducted by a retired Supreme Court judge and the mediation award filed before the Honourable Bombay High Court, Reliance Infrastructure arrived at a settlement to recover its 100 per cent exposure of Rs 6,500 crore," it said.

CS Reviews Impact Of **Employment Generation Schemes In J&K**

SRINAGAR- Chief Secretary, Atal Dulloo, Tuesday chaired a high-level meeting to review the performance and impact of employment generation schemes across Jammu and Kashmir.

The meeting was attended by the Principal Secretary, Agriculture Production Department; Principal Secretary, Finance; Commissioner Secretary, Social Welfare; Commissioner Secretary, Cooperatives, Secretary, Labour & Employment Department; Director Employment and all Deputy Commissioners who joined virtually.

In-depth deliberations were held to enhance the effectiveness, transparency and reach of self-employment initiatives.

The Chief Secretary underscored the urgent need to consolidate all employment-related schemes onto a single online platform to ensure seamless service delivery and minimize manual intervention. He stressed that only empowered committees should be entrusted with the approval of applica-tions, thereby eliminating scope for unilateral decision-making.

Highlighting the critical role of financial institutions, the Chief Secretary directed the departments to strengthen bank linkages, particularly under schemes implemented by the Women Development Corporation (WDC).

He also emphasized the importance of focusing on interest subvention components by the departments to ease the financial burden on the beneficiaries.

The Chief Secretary observed that it is imperative that transparency remains the cornerstone of all self-employment schemes. He added that outcome-based assessment must be conducted regularly to evaluate real-time impact at the grassroots level.

The meeting included a detailed review of flagship schemes such as Self Help Group (Umeed), Prime Minister's Employ-ment Generation Programme (PMEGP), J&K Rural Employment Generation Programme (JKREGP) and Mission Youth initiatives like Mumkin, Tejaswini and Spurring Entrepreneurship.

The Chief Secretary noted the issue of overlapping mandates among schemes like JKREGP and Mission Youth. He called for greater coordination and data standardization for effective monitoring.

The meeting expressed concern over the high Non-Performing Asset (NPA) ratios in non-bank-supported schemes, particularly those being run by the J&K SC, ST & BC Development Corporation and JKWDC, with some NPAs reported as high as 45%. The need for tighter credit discipline and recovery mechanisms was emphasized.

Stock Markets Slide Ahead Of RBI Policy Decision, Selling Rush In RIL, HDFC Bank

MUMBAI- Equity market benchmark indices Sensex and Nifty ended lower on Tuesday amid selling in oil & gas and banking shares ahead of the Reserve Bank's monetary policy announcement.

The 30-share BSE Sensex fell by 308.47 points or 0.38 per cent to close at 80,710.25. During the day, it declined 464.32 points or 0.57 per cent to hit an intraday low of 80,554.40.

The broader NSE Nifty fell 73.20 points or 0.30 per cent to close at 24,649.55. During the session, it slipped by 132.45 points or 0.53 per cent to 24,590.30.

Among Sensex shares, Adani Ports, Reliance Industries, Infosys, ICICI Bank, Eternal, BEL, HDFC Bank, Power Grid, ITC and Sun Pharmaceutical were the major laggards.

However, Titan, Maruti, Trent, Bharti Airtel, Bajaj Finance, Tech Mahindra, State Bank of India, L&T, HCL Technologies and NTPC were among the gainers.

The BSE smallcap gauge went lower by 0.27 per cent and the midcap index by 0.14 per cent.

Among sectoral indices, Oil & Gas fell by 0.96 per cent, Energy by (0.74 per cent), FMCG by (0.61 per cent), Services and Focussed IT by (0.59 per cent each), IT and Realty by (0.52 per cent each) and Health-

care by (0.48 per cent). Auto, Power, Capital Goods, Commodities, Industrials, Consumer Durables, Metal and Telecommunica-

tion were the only gainers. "Despite positive global cues, domestic markets remained rangebound in negative territory. Oil & gas stocks led the decline amid concerns about future import restrictions on Russian oil. Weakness persisted on Pharma and IT stocks which are among the largest exporters to the US. 'Gold prices rose on Tuesday, supported by demand for safe haven and an increasing consensus that the US Federal Reserve will restart its interest ratecutting cycle in the upcoming meeting next month.

"Dovish remarks from Federal Reserve officials, along with last week's disappointing job market report, led traders to become more optimistic about potential rate cuts at the Fed's upcoming meeting in September, boosting gold traders sentiment," Saumil Gandhi, Senior Analyst, Commodities at HDFC Securities, said.

As per the Sarafa Association, silver prices rallied Rs 2,000 to Rs 1,12,000 per kilogram (inclusive of all taxes) on Tuesday. The white metal had finished at Rs 1,10,000 per kg in the previous market session.

"Spot gold extended its rally to close nearly 0.30 per cent higher on Monday at USD 3,375 per ounce as US factory orders fell in June.

"The US President Donald Trump threatening India with significantly steep tariffs over Russian oil purchases also boosted the metal as the Indian rupee fell to Rs 88/dollar in the NDF market," Praveen Singh, Associate Vice-President. Fundamental currencies and commodities at Mirae Asset Share Khan,

Meanwhile, spot gold fell by USD 20.95 or 0.62 per cent to USD 3,352.61 per ounce in New York.

Rupee Hits All-Time Low; Ends 22 Paise Weaker At 87.88 Against US Dollar

MUMBAI- The rupee revisited its all-time low level and ended with a loss of 22 paise at 87.88 against the US dollar on Tuesday, as risk-off sentiment deepened after US President Donald Trump renewed threats to raise tariffs on Indian goods over New Delhi's continued purchases of Russian oil.

Forex traders said the rupee is likely to slide further as India-US trade deal uncertainty continues to dent domestic market sentiments.

Moreover, weak equity markets dented investors' sentiments further. However, the domestic unit pared some of its losses on supposed intervention by the Reserve Bank of India (RBI).

A soft US dollar and overnight decline in crude oil prices also cushioned the downside to some extent,

At the interbank foreign exchange, the domestic unit opened at 87.95 against the greenback, its lowestever intra-day level that was previously recorded on February 10 this year. During the session, it touched the high of 87.75 against the American currency.

At the end of Tuesday's trading session, the domestic unit was at 87.88, down 22 paise over its previous

Greater Noida man's bank account credited with Rs 11 lakh crore, then what he did...

On August 1, the 20-year-old got a message that a sum of Rs 11.13 lakh crore had been credited to his bank account.

An unemployed Dileep rushed to his bank, only to be told that the windfall was the result of a glitch in the NAVI UPI app — and he still had zero money in his account.

His lore, all the same, was shared widely on social media and stoked a chatter on several 'what ifs'

Dileep had opened a bank account only two months ago in a private bank. He has no parents.

Jobless techie attempts robbery at bank manager's house in Pune; arrested

An indebted and jobless IT professional hailing from Manipur allegedly entered a bank manager's house here posing as a courier delivery agent and tried to rob his son at gunpoint, police said on Tuesday.

The accused, however, ran out of luck as he was overpowered by the bank manager's brother and handed over to the police following the incident last week, they said.

40-year-old man seemed to have committed the crime out of desperation as he was jobless and unable to pay the EMIs for two flats owned by him, the police said.

A licensed gun, 19 live rounds, and a kukri (a sharp weapon) were recovered from his possession. The accused has been arrested under sections related to robbery, causing hurt, as well as provisions of the Arms Act, the police said.

The incident took place on July 31 evening at a housing society in Pimple Gurav area of Pune district.

The accused, identified as Sangboi Kom Serto, was a native of Manipur and lived with his family in the NIBM area of Pune, Senior Police Inspector Jitendra Koli told PTI.

"The accused came to Pune 12 years ago and was working as a business analyst in a private firm. However, he lost his job last year. After that, he became debt-ridden and penniless as he struggled to pay the EMIs for his two flats," Koli said.

The probe suggested the accused frequently visited a nationalised bank in Sangvi area, where he noticed the manager and hatched a plan to rob him of Rs 8 to 10 lakh. He allegedly followed the manager to his residence and conducted a recce of the house, the official said.

"Around 6 pm last Thursday, the accused went to the manager's housing society and rang the bell. When the bank manager's son opened the door, the accused posed as a courier agent and claimed to be delivering bank-related documents," Koli said.

"He asked the boy to get his father's ID for verification. As the boy turned around, the accused forced his way inside. When the boy asked why he entered, he pointed a gun at his chest and demanded cash

and valuables," Koli said. While the accused was threatening the boy, the bank manager's brother, who was in the house, overpowered him from behind, pinned him down, and alerted the police.

The brother of the bank manager suffered injuries in the incident, the official said.

"A police team reached the spot and arrested the accused. We have recovered a licensed gun, 19 live rounds, a kukri, and a suspicious object resembling an explosive, which turned out to be fake," Koli said.

The accused had done some business management courses and previously worked as a business assistant. He lived in Pune with his wife and two children. "As per preliminary infor-

mation, he owns two flats in the NIBM area. After losing his job a year ago as business analyst at an IT firm, he defaulted on loan repayments. Initially, he managed EMIs using his savings, but later ran out of money.

The families of terror victims narrated their traumatic experiences. They exposed the injustice perpetrated by Pakistan-sponsored terrorists and their sympathizers against their families.

Sinha paid his heartfelt tribute to civilian martyrs and saluted the courage and perseverance of families who have suffered from terrorism in Jammu Kashmir.

"Wounds that have persisted for decades are now being healed. Today's landmark event provided a sense of closure to the families who have silently suffered trauma for years.

He said that for more than three decades, the terror state Pakistan is shedding innocent blood through its proxy terrorist outfits. "Time did not erase the pain of loss. Invisible scars on their soul can be felt and the mute eyes are witness to many unfulfilled dreams," LG said, adding that the long wait for justice and for healing to begin is over for the terror victim families.

"They have come out to reveal the role of Pakistani terrorists and terror ecosystem that was operating in J&K."

LG Shares Tragic Accounts

The Lieutenant Governor shared the tragic account of Abdul Majid Mir's family, whose lives were shattered on June 29, 2004. On that day, Abdul Majid, from Sheikhpura, Baramulla, was kidnapped and brutally murdered by terrorists.

"Abdul Majid's family lost their sole breadwinner and received Rs 1 lakh as an exgratia payment under the Security Related Expenditure (SRE) scheme. Despite Abdul Majid Mir's martyrdom, his family struggled to live a life of dignity. Today, by providing a government job to his son, Mudasir Majid, the administration has fulfilled its long-overdue responsibility," Sinha said.

After decades of waiting, justice has also

reached Suhail Majeed of Anantnag. His father, Abdul Majeed Wani, was killed by Pakistanbacked terrorists on August 30, 1994. "It took 31 years, but Suhail has finally received his appointment letter, bringing closure to his family's prolonged pain," the LG added.

According to Sinha, the family of SPO Manzoor Ahmad Rather from Warpora, Baramulla, endured a similar fate.

"On February 24, 2000, SPO Manzoor Ahmad Rather, a resident of Warpora, Baramulla, was killed by Pakistan-backed terrorists. For 25 years, his family received no compensation. Today his son Khurshid Ahmad Rather has received an appointment letter. Traumatic period for the family is finally over."

"For Parvez Ahmad Dar, the path to justice was painful. On July 6, 1996, terrorists killed his father, Ghulam Qadir Dar. On July 30, 2004, his brother, Aijaz Ahmad Dar, was also killed by terrorists. 29 years after his father's death, Parvez's nightmare is over," the LG said.

He observed that the void in the lives of terror victims' families cannot be filled with financial assistance or jobs, but it will be ensured that these families can live with dignity.

"We will do everything possible for the rehabilitation of terror victims. It is my promise to the NoKs of terror victim families that perpetrators of heinous crime will receive exemplary punishment. We will also ensure the harshest possible punishment to terror sympathisers.

"I assure the family members of civilian martyrs that I will not rest until every family that has been a victim of the terrorists' atrocities gets justice. I want to tell the loved ones of martyrs that the dreams of your father or your mother will now be fulfilled," he said.

On the occasion, the Lieutenant Governor also spoke on the transformative journey of new Jammu Kashmir post abrogation of Article

life spiraled after his mother also passed away a decade later.

"My sister had to marry at 15. We were completely alone. I walked from pillar to post, but no one ever helped. Even our relatives turned their backs," he said, adding, "I used to think of ending my life. But today, holding this letter in my hand, I feel seen for the first time. I have nothing but prayers for LG Manoj Sinha.'

Yasmeen Bano from Baramulla was too choked with emotion to speak much.

"When my father was killed, my mother raised me alone. Today, I just couldn't stop my tears while receiving the appointment letter. I'm overwhelmed," she said softly.

'Angel in Disguise' Bisma, from Qazigund (Anantnag), another NoK, was not even born when her father was killed. Her entire childhood was shaped by her mother's sacrifices.

"My mother worked in homes with one hand and held me in the other. No one helped us. But today, this man—LG Sinha, came to us like an angel. I have no words, only gratitude and tears," she said.

'His Sacrifice Mattered'

Junaid Ali Malla, who lost his policeman father to a terrorist attack, said he was three when the tragedy struck. "No one helped us. I had to build everything on my own. But I always told my mother that my father's sacrifice won't go in vain. Today, I feel proud, and this letter proves his sacrifice mattered."

Anju Riyaz, another victim who was just six months old when her father was killed, recalled being thrown out by her paternal family. "We lived in my maternal home. My mother made me what I am. We were never helped, not even once. But today, this letter brought us a moment of peace we never had," she said.

'Journey from Kindergarten to Justice' For 16-year-old Soliha Javed from Bijbehara, August 05, 2025, will be etched in her memory not just as a date, but as the day justice finally knocked at her door after 12 long years of si-

lence, pain and perseverance. "I was in UKG when my father was killed in a terror attack," Soliha said, her voice steady but

eyes welling with emotion. "Now, I am in Class 10 and this is the first time I have felt that someone heard our cries,"

Soliha said her father was killed in a terrorist attack more than a decade ago. Since then, her mother, a single parent, bore the burden of raising her daughter while knocking on every door for justice.

"My mother would hold my hand with one and the documents in the other," she said. The girl spoke of fighting every battle-legal, emotional and financial on her own. "Today, I saw

relief on her face for the first time," she added. "This appointment letter is not just a paper; it is a reward for my mother's struggle and a recognition of my father's sacrifice," she said.

Soliha said she wants to focus on her studies now. "My father's dream was for me to become something in life. With this support, I can think of a future. I feel light, as if a heavy weight has been lifted from our shoulders," she added.

Moreover, Soliha expressed deep gratitude to

the LG Manoj Sinha administration: "We are very happy and thankful to LG Sahab. He didn't just announce something, but he gave us justice but something we have waited for all these years." For 22 years, Samena of Anantnag district

carried a wound time could never heal, as the loss of her family members, who fell victim to a terrorist attack in the early 1990s. She said decades passed in silence, with no

justice, no support and no recognition. But on August 5, 2025, her tears carried a different meaning — tears of justice, gratitude, and hope.
"For the first time in 29 years, someone in power looked at us with compassion. Today, we felt heard. LG Manoj Sinha gave us justice,

not sympathy," Samena said. As she sat among dozens of families of terror victims during an official event in Srinagar, LG Sinha assured that justice will prevail. For Samena, those words felt like a long-awaited answer to years of unanswered prayers.

"Nobody ever came to ask how we survived all these years. But today, LG sahab stood before us and promised that justice would no longer be delayed. When he said appointments will be fulfilled, we cried. We truly cried," she

Over the years, Samena says her family struggled - financially, emotionally and mentally. "We were not just grieving; we were abandoned," she recalled. But this year's event, which marked six years since the abrogation of Article 370, brought something her family had never experienced before: dignity and closure.

"People used to ask us why we still talk about something that happened so long ago. But pain doesn't expire. For the first time, our pain was acknowledged. LG Sinha made us feel like we matter," she said.

She added, "LG Manoj Sinha has given us more than a job, he has restored our dignity, our faith and our place in this land."

On Tuesday, a total of 158 appointment letters were distributed by LG Sinha himself to victims and their family members from north, south and central Kashmir. (KNO)

Jaiswal and Test captain Gill have not featured in the last few T20 assignments owing to a packed calendar but their onemonth rest period post the five-Test series against England is expected to make them available for the continental tournament.

As per sources in the BCCI, the national selectors are keeping options open even as the Test series against the West Indies at home



starts in less than a week's time if India qualify for the final of the continental T20 event which is slated on September 28.

Jaiswal scored 559 runs at a strike-rate of 160 in the last edition of the IPL while Gill had 650 runs in 15 games at a healthy strike- rate of 155-plus.

"There is a five week break and with no cricket around, these three should walk into any T20 squad despite stupendous show by Sanju Samson and Abhishek Sharma. In 21 days in Asia Cup, if one plays till final, there are 6 T20 games and that's not much of a workload. But obviously with 17 member squads allowed for the Asia Cup, selectors will weigh op-

tions carefully," a BCCI source told PTI on conditions of anonymity.

Bengaluru FC Suspends Salaries Of Players & Staff

Bengaluru FC has indefinitely suspended the salaries of its first-team players and staff amid the continued uncertainty over the

Indian Super League (ISL), which remains on hold.
The club, home to legendary striker and former
India captain Sunil Chhetri, said the lack of clarity
on the League's future left it with no choice but to
take this "difficult" decision

The ISL was put on hold by its organisers, Football Sports Development Limited (FSDL), due to the unresolved status of the Master Rights Agreement (MRA) with the All India Football Federation

The current 15-year MRA between FSDL and AIFF, signed in 2010, expires on December 18.

Amid the growing uncertainty, eight ISL clubs have written to the AIFF expressing concern about their future. The AIFF's top brass is scheduled to meet the CEOs of the clubs on Thursday to discuss the situation.

Last month, AIFF President Kalyan Chaubey had assured that the 2025-26 ISL season would be held, but stopped short of confirming a start date. In its statement, Bengaluru FC also urged both the AIFF and FSDL to resolve the impasse at the earliest. (PTI)

7 Indian Boxers Assured Medals At U19 Asian Championships

ndian boxers continued their march towards a significant medal count at the U19 and U22 Asian Boxing Championships with seven women pugilists assuring themselves of a podium finish here on Tuesday.

Competing in the U-19 category, Yakshika (51kg), Nisha (54kg), Muskan (57kg), Vini (60kg), Nisha (65kg), Akansha Phalaswal (70kg) and Aarti Kumari (75kg) reached the semifinals of their respective weight classes.

India is already assured of over a dozen medals in the U22 category and the contingent will be looking to bag as many gold medals as possible in the business end of the competition.

Yakshika began India's march in the last four stage with a hard-fought 3:2 split decision victory in the 51kg bout over Mukhtasar Alieva of Uzbekistan before Nisha showed her attacking prowess to force the referee to stop the bout against Milana Shikhshabekova of Kyrgyzstan in the 54kg contest.

Muskan then came to the party and earned a unanimous decision against Robiya Ravshanova of Uzbekistan in the 57kg quarterfinals and Vini then forced the referee to stop the bout in the very first round with a flurry of punches to knock out Adelia Asylbek Kyzy of Kyrgyzstan. (PTI)

Barcelona Opens Disciplinary Proceeding Against Ter Stegen

B arcelona has opened a disciplinary proceeding against Marc-André ter Stegen saying the goalkeeper refused to sign a medical report about his back injury, according to a person with knowledge of the proceeding.

The club needed Ter Stegen to sign the report so it could be sent to the Spanish league in order to clear some salary-cap space and more easily register other players without breaching financial fair play rules.

But the club and the goalkeeper are at odds about the recovery time for the surgery that took place last week to deal with recurring lower back ailments.

Ter Stegen said ahead of the surgery that the recovery time would be about three months. The club did not give an official timetable for the recovery process, saying only that the operation was "successful" and that "his recovery will determine when he can return."

Depending on the length of the recovery process, Barcelona could clear a percentage of Ter Stegen's salary from its cap, making more room to add other players to the squad.

The club signed Espanyol goalkeeper Joan García in June. Its other goalkeepers are veteran Wojciech Szczesny and Iñaki Peña. (AP)
