Al Boosts Early Career Citations For Scientists From Developing Nations: Study

An analysis of scientists who became topcited research authors early in their careers has revealed patterns -- they tend to be affiliated to institutions in less developed countries, including China and India, and working in areas, such as artificial intelligence and environmental sciences.

Becoming a top-cited author within the first five years of scientific career -- or being an "ultra-precocious" scientist -- could also be related with high rates of self-citation, the analysis published in the journal PLOS One found.

Citing a previously published research -- which is a way of acknowledging and crediting its authors -- in a new paper adds credence. Citations are critical for academic integrity.

Achieving a high citation impact can happen for some scientists whose work and talent is quickly recognised. For others, however, the same can be achieved through fraudulent means, including manipulating data and repeatedly citing own work (self-citation). Researcher John P. A. Ioannidis from the US' Stanford University categorised 'precocious scientists' as researchers achieving exceptional success in citations within the first eight years of their career, and 'ultra-precocious' as those accomplishing similar feats within the first five years.

Ioannidis said, "Precocious authors seem to be a mixture of some of the very best, outstanding scientists and some of the very worst, manipulative ones.'

Analysing data on scientists counted among the top-100,000 cited authors across 174 scientific fields, the researcher found that between 2017 and 2023, scientists with precocious and ultra-precocious citation impact increased in number.

The author found "469 precocious and 66 ultra-precocious citation impact author profiles in 2023".

Looking closely at 59 of the ultra-precocious scientists, Ioannidis found they were 'were heavily enriched in affiliations from less developed countries, as compared with the list of all top-cited authors where highly developed countries, led prominently by the US, had the lion's share.'

"Affiliations in China and India were heavily enriched among authors with ultra-precocious citation impact as compared with the full list of top-cited authors," the author wrote.

Institutes in Turkey, Iraq, Iran, Russia and Pakistan were among the others that the study mentioned.

Further, ultra-precocious scientists were found to heavily cluster across four scientific fields of research -- environmental sciences, energy, artificial intelligence and image processing, and mechanical engineering and transports.

2 Soldiers Killed As Kulgam Op Enters 9 Day

Srinagar:Two Army soldiers were killed and as many injured in an overnight gunfight with terrorists in Jammu and Kashmir's Kulgam district, in one of the longest anti-terror operations in the Valley that entered the ninth day on Saturday, officials said.

The Army's Srinagar-based Chinar Corps, in a post on X, paid tributes to the soldiers killed in the encounter and said that the operation was still underway.

Two terrorists have been

killed in the encounter that began on August 1 after security forces launched a cordon and search operation in a forest at Akhal in the south Kashmir district, following specific intelligence inputs about the presence of terrorists there.

The identity and the group affiliation of the slain terrorists

Nearly 19K From J&K Get Jobs Abroad Since 2020: Govt

Delhi: Nearly 18,952 people from Jammu and Kashmir received Emigration Clearances (ECs) for overseas employment between January 1, 2020 and June 30, 2025, official data tabled in the Lok Sabha has revealed.

The figures show a steep rise in 2022 and 2023 compared to the COVID-hit years of 2020 and 2021. In 2020, 1,095 workers from the Union Territory were granted ECs, dropping slightly to 992 in 2021. The trend reversed in 2022 with 4,868 clearances, peaking at 5,264 in 2023, before easing to 4,322 in 2024 and 2,411 in the first half of 2025.

ECs are required mainly for holders of Emigration Check Required (ECR) passports, typically workers headed to Gulf and other overseas labour markets. For women in this category, the minimum age for overseas employment is 30 years to prevent exploitation.

Officials also underlined the role of the Indian Community Welfare Fund (ICWF), which is used by Indian missions abroad to assist citizens in distress. The aid covers boarding and lodging, emergency medical care, legal help, repatriation of mortal remains, air passage to India, and payment of

Rotten Meat Scandal Spreads In Kashmir

Massive Dumpings Spark Crackdown

Srinagar: The rotten meat scandal in Kashmir has taken a disturbing turn, with decayed meat turning up not only during raids on shops and cold storages but also dumped along roadsides. From heaps of sheep heads to bulk pack-ages of rotting chicken and mutton abandoned in city outskirts, the finds point to a disturbing network of unsafe meat supply operating on a worrying scale.

Dozens of unclaimed meat packages, estimated at weighing around 1,000 kg, were found dumped overnight along the roadside in Soura near SKIMS on the outskirts of Srinagar. In a separate incident, sheep heads were spotted discarded near GD Goenka School in Lal Bazar. Two more consignments were found dumped



on roadsides in Nowgam and

Pampore on Friday. "The rotten meat and chicken packages were without labels or trade markings. Exposing the traders and their supplier links is now a matter of investigation. In coordination with the police, and by collecting technical and material evidence, we will unravel this illegal trade practice that is endangering

Customers Stay Away, Restaurants Feel Heat

Srinagar: Over the last few years, Srinagar's skyline has changed in more ways than one. Alongside new buildings, mushrooming of restaurants — from sleek cafés to family-run kebab joints - has brought the aroma of grilled meat and wazwan delicacies to almost every busy street. 6 Pak Aircraft Shot Down **During Op Sindoor: IAF Chief**

New Delhi: Six Pakistani aircraft, including five fighter jets and another large aircraft, were downed during Operation Sindoor, the Indian Air Force has confirmed, in their first big revelation on the extent of damage caused to the Pakistani side during the mega military offensive.

This is the first official comment on the damage caused to Pakistan during the Indian strikes over three months ago. Many opposition leaders have been attacking the government over the delay in revealing the extent of damage caused to both India and Pakistan during Operation Sindoor, which was in response to the Pahalgam terror attack in which 26 people, mostly tourists, were killed.

The "big bird" that was downed was an AEW&C (airborne early warning and control system), the loss of which dealt a massive blow to Pakistan's air strength during the May 7 operation after the Pahalgam attack. Besides the six aircraft that were hit midair, Air Chief Marshal AP Singh also confirmed the losses that the Pakistan Air Force suffered



on the ground in the aerial strikes at Pakistan airbases.

"We have five confirmed kills and one large aircraft, which could be either an ELINT or an AEW&C aircraft, which was taken on at a distance of kms. This is actually the largest ever recorded surface-toair kill that we can talk about," the Air Chief Marshal said at the 16th Air Chief Marshal LM Katre Lecture in Bengaluru.

Calling the Russian-made S-400 a "game-changer", he said that Pakistan was unable to penetrate the surface-to-air missile system.

"Our air defence systems did a wonderful job. The S-400 system, which we had recently bought, has been a gamechanger. The range of that system has really kept their aircraft away | More on P10

Untreated Water Supplied To Srinagar Homes For Over 2 Weeks

Srinagar: For more than 15 days, residents in Srinagar's uptown areas have been receiving dirty, untreated water, allegedly because the Doodhganga Water Supply Plant in Lalpora ran out of essential purification chemicals.

The affected localities include Hyderpora, Barzulla, Baghat, Humhama, Rawalpora, Gogjibagh, and several adjoining areas. Residents say the water has been arriving at their homes muddy, foul-smelling, and unsafe to drink, forcing many to either buy bottled water or risk consuming it.

Following repeated public complaints, staff at the facility confirmed that a shortage of alum — the key chemical used in sedimentation and filtration had persisted for over two weeks.

Plant workers reportedly sent multiple letters to senior officers, warning of the crisis, but claimed no action was taken in time. Officials in the Procurement Division insisted the chemical | More on P10

Can People Be Happy Only With **Development? Wangchuk**

New Delhi: Ladakh has witnessed rapid infrastructure development since it became a Union Territory, but people can't be happy only with development if their voices are not heard, climate activist Sonam Wangchuk said, pressing the demand for statehood and sixth schedule.

In an interview with PTI, the Ramon Magsaysay Awardee said locals point out that "development" is there on the other side of the border in China as well, but people in Tibet are not happy.

This comes as a three-day hunger strike demanding statehood and sixth schedule status for Ladakh began in Kargil on Saturday.

Asked about the changes in Ladakh, one of the world's highest inhabited regions, since it became a Union Territory, Wangchuk said people agree that the pace of the development of the roads has increased, and the budget has also increased multiple times.



"I will state the facts as they are... People in Ladakh say they can see a difference in terms of development (in Ladakh), roads have been built..."

However, he also said, "Development is there in China as well... But are the people of Tibet happy? No, because that development is neither in their hands nor is it

being done for them," he said. "Is that being repeated in Ladakh? In that case, it would be a cage made of gold. There

is no platform where people

can come together and decide

what kind of development they want. This would be someone else's development, (and) this is the problem of people of Ladakh," he said.

Ladakh shares its eastern border with the Tibet Autonomous Region to the east, and the Leh region shares strong cultural and religious ties with Tibet.

Dissatisfaction had been brewing amid the two regions in Ladakh as the talks being held by the Home Ministry with representatives of Leh Apex Body (LAB) and Kargil Democratic Alliance (KDA) appeared to be stuck.

This dialogue did not start again; it got suspended... it was supposed to happen on the 15th (July), then on the 25th, then on the 28th... So, people wanted to start the movement again to express their pain," he said.

The hunger strike in Kargil, which started on Saturday, will conclude on August 11 with a public meeting.

Gaza Starvation Toll Rises

Israeli Forces Kill 21 More Aid Seekers

Jerusalem: Israeli attacks have killed at least 39 people, including 21 seeking humanitarian aid and 11 who starved to death, over 24 hours in Gaza, Palestinian health authorities say.

Gaza's Ministry of Health said on Saturday that the total number of malnutrition deaths has reached 212, including 98 children, since Israel launched its war on Gaza in October 2023.

Most of the deaths have occurred in recent weeks as Israel continues to impose severe restrictions on aid supplies entering Gaza after partially lifting a total blockade in late May.

Mohammed Abu Salmiya, the director of al-Shifa Hospital in northern Gaza, told Al Jazeera that famine continues to pose a serious risk "especially among children and the elderly".

"Malnutrition among children leads to decreased immunity and may lead to death," he said.

On Friday, the World Food Programme (WFP) called on Israel to allow the delivery of at least 100 aid trucks per day to Gaza, noting that only 60 of its

aid truck drivers have been vetted and approved by the Israeli military to date.

Saturday, the UN agency for Palestinian refugees, UNRWA, noted that it has not been allowed to bring any humanitarian aid into Gaza, including food and medicine, for more than five months, depriving hungry and ailing Palestinians of what they need to survive.

UNRWA has been calling on Israel to lift its siege on Gaza,

saying the ongoing airdrops of humanitarian aid from several countries "are very expensive and ineffective" at reaching those urgently in need.

The warnings come as Israeli forces continued to escalate their attacks across the territory. Six people were killed by Israeli soldiers while waiting for aid near the Netzarim Corridor in central Gaza, medical sources told Al Jazeera.

Two other Palestinians were also killed and transported to the Nasser Medical Complex from a GHF aid distribution site in the southern part of the territory.

One woman was killed and another person was wounded in an Israeli air strike targeting an apartment in Khan Younis in the south.

According to the Gaza Health Ministry's latest count, at least 39 people have been killed in 24 hours.

Israel's war on Gaza has killed at least 61,369 Palestinians in Gaza and wounded 152,850. An estimated 1,139 people were killed in Israel during Hamas-led attacks on October 7, 2023, and more than 200 were taken captive.

Nagasaki Marks 80th Anniversary Of US Atomic Bomb Attack On Japan

On August 15, 1945, Japan surrendered, marking the end of World War II.

Experts: Dharali Disaster Not Isolated, Need Study

Dehradun : Four days after raging waters buried half of Dharali village in Uttarkashi, experts have stressed the need to study the existing settlements located on the river banks or in the flood plains.

They say that the Dharali disaster should not be seen as an isolated case.

Dr. Sushil Kumar, former senior scientist at the Dehradun-based Wadia Institute of Himalayan Geology, said, 'Now the time has come to study all those areas where large settlements have come up on the headlands of rivers and streams.'

Headlands are the plains situated on the banks of the river which are covered by floods from time to time. These plains are usually made up of soil, silt, sand and gravel deposited by the river.

Due to the high amount of nutrients, this land is fertile, which makes it very useful for agriculture and because of this, villages and settlements are also established in these areas, but they are often at risk of floods

Many scientists including Dr. Kumar say that the debrisladen water stream that hit Dharali was on its original path and destroyed all the hotels, homestays, restaurants and houses that came in its way.

In view of the boom in tourism in the last few years, dozens of hotels, restaurants and homestays have mushroomed in Dharali and most of the buildings destroyed in the disaster were built in violation of environmental rules on the banks of the Khirgad seasonal river, they said.

This disaster, which struck on August 5, turned a beautiful stop on the way to Gangotri Dham into a high pile of rubble in the blink of

Locals say the government also turns a blind eye to violation of norms in environmentally sensitive areas, including a ban on new construction along the Bhagirathi riverbank.

In 2023, a large building of a training academy collapsed like a pack of cards amid heavy floods in the Song River in Maldevta area of Dehradun.

Experts say that the building was constructed on the river bank in gross violation of environmental norms.

Environmentalist Anoop Nautiyal said that the most glaring example of violation of environmental norms in construction is present in Dehradun where the Uttarakhand Assembly building has been built right on the banks of the Rispana river.

In the last few years, dozens of colonies including Bhagat Singh Colony have been built by encroaching on the banks of the Rispana and Bindal rivers in Dehradun.

The locals have alleged that in most cases, government officials are in collusion with land mafia and buildings are constructed on the vacant land.

Many petitions have been filed in the Uttarakhand High Court regarding the damage to the environment due to illegal construction in Dehradun, Rishikesh and other areas.

The High Court has also directed the state government to remove encroachment from the land along the banks of Rispana and Bindal rivers. PTI

Sub-Divisional Police Officer (SDPO) Pratibha Sharma said police personnel brought the situation under control.

"The matter is related to the education department and referred to the district education officer (DEO)," Sharma said.

Kashmir's Dirty Water Danger

very day, nearly seven lakh people in uptown Srinagar turn on their taps hoping for clean water. But for fifteen days, what comes out has been muddy and unsafe.

The Doodhganga river meant to provide fresh drinking water, has been delivering something far from safe.

People began noticing the water's poor quality as turbid, foul-smelling liquid flowed into their homes. When Kashmir Observer investigated, a troubling truth was uncovered: essential chemicals like alum, which are necessary to clean the water, have been stuck in transit for days.

Officials first denied there was a problem. But when pressed, they admitted the truth. This is not just a failure in management. It's a failure to provide one of the most basic needs: access to safe water.

This new health crisis has surfaced when Kashmir is wrestling with the rotten meat scandal. And it has further hit the public trust.

While Kashmiris can choose to avoid rotten meat, water is different. It cannot be refused. It is vital to life.

The government needs to recognize this as an emergency. Quick action and clear accountability are necessary. This means not just fixing water treatment but also over seeing food safety and public health departments.

People are falling ill with stomach problems and other mysterious diseases. Many believe contaminated water and unsafe food are to blame.

Slow reforms and empty promises won't do. Kashmir's food and water systems need a complete overhaul with strong, transparent monitoring.

Anyone who breaks safety laws, no matter who they are, must be held responsible. Without strict laws and enforcement, these problems will continue to harm lives and

This crisis reveals a hard truth: neglecting public health services is a serious human rights violation. The people of Kashmir deserve clean water, safe food, and respect. The time to act is now.

Stop Faking Journalism

A casual compliment in Kashmir turned into an endorsement of "journalism without degrees." Media schools, are you watching?

he line between journalism and performance in Kashmir is blurring in ways that would make any media professor shake their head.

The latest example came again from social media, where one content creator rushed to laud another, a Facebooker celebrated online as a sort of public savior, and anointed him a journalist.

His reasoning reeks of ignorance: The man had "stood out" in covering the recent rotten meat scandal, his voice booming in viral videos.

What this bromance conveniently skipped over was the fact that the first reports, investigations, and follow-ups came from trained reporters working in regulated newsrooms.

These journalists have degrees, editors, and a professional code. They did not need to shout into a phone camera to prove they were doing their jobs. They verified facts, consulted experts, and published their work. Then they moved to the followup, and the next story.

Social media in Kashmir, as in much of the world, has made it easy for anyone with a mic and a smartphone to call themselves a journalist.

The performance is often compelling with urgent voice and raw visuals, but the work is rarely subject to the checks and balances that define the profession.

The result is a distortion of public perception: the loudest voice is mistaken for the most credible.

Journalists here already work under strain. The press, long considered the fourth pillar of democracy, has faced mounting challenges in recent years for what this creator wearing many hats simply called "giving information".

Against this backdrop, equating a viral personality with a trained reporter is not just an innocent compliment. It chips away at a profession that depends on credibility to survive.

Many influencers know exactly what will travel online. They lean into outrage and emotion because it is rewarded with reach. Some have promoted questionable

investment schemes, and even endorsed brands with no vetting.

When people get hurt, there is no editor to hold accountable and no institution to demand redress. The work vanishes into the feed.

Endorsing these personalities as journalists sets a dangerous precedent.

If a degree, editorial process, and ethical code count for nothing, what exactly defines the field? Is journalism just optics and

emotional drama now? Does shouting louder make the work more valuable?

If that logic holds, then me-

If that logic holds, then media schools may as well shutter, and the years spent training in newsrooms could be written off as wasted effort.

Journalists don't need lessons from influencers. Just like doctors don't learn surgery from You-Tube, this profession doesn't take guidance from outsiders. During the recent SMHS Hospital crisis, a burst of social media outrage quickly shifted focus from the actual incident to blaming doctors. In the heat of the moment, facts were flattened, and professionals became villains.

That is the risk when optics overpower verification.

Content creators are free to do what they do: tell stories, entertain followers, document daily life, or even sell pipe dreams. Many produce engaging, humancentered work.

The problem is when that work is packaged as journalism, and when the people making it claim authority over a field that is not theirs.

Journalism is not a creation of social media. It is a societal need that predates reels and will outlast them

sob stories for Likes and Shares. It is about holding institutions accountable, preserving public trust, and protecting the democratic space.

Those responsibilities cannot be replaced by viral fame. They require training, oversight, and a willingness to work without appliance.

ness to work without applause.

If influencers want to keep their followers entertained, they should. They can film mountains, meadows, and streets. They can speak passionately about causes that matter to them.

But what they should not do is recast themselves as journalists or redefine the profession for an audience that may not know better.

Journalism in Kashmir deserves more respect than that.

hen I was transferred to a distant Kashmir countryside, I expected only hardship in the form of unreliable electricity, long roads, and few amenities. What I didn't expect was to meet a part of my culture I'd never known.

It was here I learned of Pir-e-Khear, a festival marking the first bloom of rice grain.

During those ten days, daughters are called home to their parents' kitchens, fish prepared with meticulous care, and prayers stretched into the night. The air remains thick with the smell of hearth fires and the sound of old Kashmiri songs.

The festival is philosophy in action: the divine acknowledged in the renewal of nature, the love of daughters reaffirmed, tradition kept alive through taste and sound.

Fish recipes are handed down for generations. Songs are sung in Kashmiri, each word carrying centuries of thought. These are living archives.

And yet, people told me, it is not celebrated like it once was.

In some places, it has stopped entirely. The loss was not from natural change, but from deliberate neglect.

When a ritual dies, people lose more than a celebration. They lose a connection to themselves.

Many young Kashmiris now treat their own language as a burden. English is the language of intellect and opportunity, while Kashmiri is for kitchen and village. Cultural symbols and sounds are snubbed in the name of "civility."

Behind this fall are absurd narratives that long ago declared Kashmiri culture "irrational" and "uncivilized." Over decades, those judgments have been absorbed into local thinking.

Ng g wa Thiong'o once wrote that the deepest control is of the mind. You see it in the ridicule of folk traditions, casual dismissal of Kashmiri as a serious language,

and shame in wearing a pheran.

Pir-e-Khear was never just about rice. It was poetry in the fields: Pandits and Muslims cooking side by side, children running through the paddies, and songs rising like

prayer from the earth.

It was unity without proclamation, a culture lived, not displayed. Now, the division works so subtly it leaves no fingerprints, just forgetfulness.

I remember the warmth of the chilai kalan, the kanger on my lap, elders telling stories of Rantas, Pasikdar, and Brambram-

chok. Beyond bedtime diversions, they were mythology, oral history, and emotion woven together.

My mother's Kashmiri muhavharat were as sharp as they were musical, each one a perfect fit for its moment. I didn't always understand every word, but I felt their weight. Her stories fed me like food. When a tale ended on a sad note, I'd object, hungry for resolution.

Those moments were emotional nourishment, and they bound me to her in ways no textbook could.

This erosion runs deeper than language or dress. It reaches into the crafts that once defined our economy and identity, like spinning wheel.

My great-aunts spun thread into livelihood, their hands moving with the rhythm of the wheel. Today, the wheels are still, and the skill is vanishing with the elders.

The irony is bitter. In Europe and America, there is a growing market for sustainable, handmade, organic goods, exactly what Kashmir once produced naturally.

Instead of nurturing these skills into thriving industries, we let them fade.

The loss of culture is tied to the loss of land. We have stripped forests, cut through mountains, and reshaped valleys. The results are plain: hotter summers, less snow, late winters, and shrinking glaciers.

We have been unfaithful to the earth in the same way we have been unfaithful to our heritage.

And yet, no cultural society, or intellectual circle, rallies to defend these vanishing skills. The stories still live in us, but they are passed down without the same urgency. In two or three generations, they will

not even survive as museum pieces.

We were once a people rich in story.

Now, we are a people forgetting the sound

of our own voice.

Kashmir's Rising Crisis of Cognitive Fatigue

Two stories of burnout reveal a growing challenge, and hope in Kashmir through simple, science-backed interventions.

For three weeks before his entrance exams, Adil Khan, 19, sat in his little room in Srinagar, flipping physics notes long into the night.

He had already spent 12-hour days in a coaching center. Then came the haze: He forgot formulas, his head throbbed, and a 90-minute test felt like a slog.

"My brain just shut down. I couldn't think," Adil said. The pressure was immense, but his coping strategy only made things worse: late-night study, coffee-fueled mornings, and no breaks.

In Anantnag district, 34-year-old Naila Gani cares for her elderly father who has Parkinson's. She handles his medicine, meals, and physical therapy from dawn till dusk. There is no respite.

"I feel awake but empty by evening," Naila said. "I forget small things, like where I placed my keys or what I was cooking."

She is not alone. Caregivers across the valley report similar feelings of mental emptiness after long days with little rest or recognition.

What people often call feeling mentally tired is actually cognitive fatigue, a condition

when your brain gets foggy and it's harder to think clearly or make decisions after working hard for a long time. Tasks that once took minutes now drag into hours. Memory falters, emotions become sharper, and mistakes seen through

Repeated exam stress, caregiving demands, remote work calls, and social media bingeing are draining people's mental reserves in Kashmir.

A well-known psychiatrist at GMC Srinagar said this isn't simple tiredness. When people push their minds too long without proper rest, it starts breaking down. "Focus fades, emotional control weakens, and eventually, the mind stops cooperating."

Health data from Kashmir shows the problem is growing. A 2023 survey found that forty percent of university students reported serious trouble with concentration and memory. More than thirty percent said they felt mentally drained on most days. Insomnia is also widespread.

At a prominent city hospital, nearly half of the admitted patients reported sleeping difficulties. Sleeping pill use is rising, pointing to a region under mounting mental strain.

Research in India and beyond offers clues to why this is happening.

Poor sleep, a familiar struggle across the country, is a major factor. More than a third of Indian college students report poor sleep quality

Sleep loss disrupts memory, attention, and decision-making. During exams, student fatigue can spike from thirty-nine to fifty percent, especially when screen use and caffeine consumption increase.

In Nagpur, professors now describe this screen-related burnout as "digital obesity," a silent epidemic spreading among students.

Constant multitasking, like juggling studies, mobile apps, and household chores, is steadily draining people's brain energy. Psychology studies confirm that decision fatigue lowers judgment and weakens self-control.

A Srinagar-based therapist often tells his patients that when sleep breaks, the mind breaks. "Many people in Kashmir need simple, regular routines, not more hours of work."

The therapist said high stress and poor sleep are driving many people toward sleeping pills, but their misuse only worsens memory problems and mental confusion.

The way out does not require big solutions. Experts recommend small, steady changes. Sleep remains the foundation. Staying off screens at least an hour before bedtime, aiming for seven to nine hours of uninterrupted rest, can help reset mental sharpness.

In Srinagar, some students are now using the Pomodoro method, breaking study time into twenty-five-minute work blocks followed by short breaks, to keep their minds fresh

Regular movement, even short walks along the Jhelum or near Dal Lake, can improve mental clarity. A balanced diet rich in leafy greens, nuts, fish, and water is key to sustaining brain power.

Many overlook hydration, but even mild dehydration can slow down thinking. Limiting screen time, switching off notifications, and cutting back on multitasking can all help

protect the brain's energy.

Caregivers like Naila need support: shared responsibilities, time off, and space to re-

With guidance from mental health therapist and support from his family, Adil slowly rebuilt his daily routine. He went to bed earlier, added regular screen-free breaks, and began taking mindful walks in the Mughal gardens. His focus and memory gradually returned. He completed his exams feeling steadier, though some days remain hard.

Naila has since joined a local women's support group in Anantnag. They meet weekly, sometimes just to talk. She has started sleeping better and now notices when she needs to pause before her energy slips away. Her fatigue hasn't disappeared, but she is learning to step back in time.

In Kashmir's fast-moving ecosystem, many people are pushing their minds to the edge without knowing it. The way back is simple: rest, routine, and community.

The harder part is noticing the silent signs, and choosing to stop before the mind does.

When Love Costs Too Much in Kashmir

Young couples in Kashmir face heartbreak not from fading feelings but from the impossible demands of dowry, jobs, and social status.

I've seen love that feels strong and real, full of hope and warmth in Kashmir. But even with all that strength, it often faces challenges it can't overcome, making it hard for that love to last.

The heartbreak probably made Pablo Neruda to write, "Love is so short, forgetting is so long." Those words speak of parting and memory's sting.

Here, in our towns and villages, forgetting is not the worst part. The cruelest sorrow is watching love end before it ever truly begins.

The saddest farewells I know come

from reasons no one dares to name aloud: unemployment, empty pockets, and the weight of customs we call tradition.

I have witnessed young couples, bound not by fleeting attraction but by years of

I have witnessed young couples, bound not by fleeting attraction but by years of shared dreams, slip into strangers. They don't stop caring. Their hearts remain connected. What breaks them apart is the brutal reality of a world that demands a steady paycheck, gold ornaments, and social standing before love can take root.

Once, a man's kindness, honesty, and goodwill were enough to ask for a woman's hand. Today, that's only the opening on a long checklist.

A suitor must show a government job or something just as permanent, own a car, and ideally have his own house.

I've seen the man, who stood by her when everyone else walked away, replaced by someone with a better salary and a family that can afford gold that gleams brighter.

It isn't betrayal in the classic sense. It's surrender to economic reality, and that makes it all the more heartbreaking.

I've seen this pain up close through a good friend of mine. The woman he loved walked away, even though their feelings were still there. But his job stayed stuck, just like his heart.

I sat beside him as he fought back tears, pretending to be strong. In those moments, words felt hollow. I could only place a hand on his shoulder, knowing nothing would fill that emptiness

This is the type of heartbreak that breaks something deep and silent. It can push young men into despair, addiction, and



worse

Fathers carry a different kind of fear. Their daughters' marriage is often measured in copper utensils, bed sets, and the washing machine's brand. Many fathers sell land or borrow money, sacrificing their lifetime savings to avoid shame. The neighbours will forget the feast within a week, but the stigma lasts much longer.

Young men struggle in their own way.

They work and save, yet inflation and soaring gold prices push the dream of gifting jewelry out of reach.

Without stable income, they watch the women they love leave, not by choice, but because families demand "security."

This obsession with financial guarantees turns love into a contest, one some cannot win.

We've made marriage a public show instead of a private blessing. Respect is mea-

sured in grams of gold, size of the feast, and the make of the car.

We drain savings, sell fields that once fed families, all to maintain a social image in communities that gossip regardless. We forget the lessons our faith teaches: that the simplest marriages are the strongest, and faith binds souls more tightly than pos-

sessions ever could.

The harshest heartbreak is love held back by society's price tag. Delayed mar-

When the "right time" comes, the best years have slipped away. The laughter and warmth once dreamed of become distant memories, replaced by silence and longing, for love denied, and for children who never came.

We see the toll on young people's mental health. The bonds that once held communities together weaken, replaced by competition and judgment. The call to make marriage easy, to build families on faith and love, fades beneath the weight of expectations.

Until we break free, love will bow to gold prices, job titles, and dowry demands. The longest kind of forgetting might not be moving on from love, but learning to live in a world where it is not allowed to thrive.

If we do not change, history will remember us as the generation that traded love for furniture and copper. One day, when the feasts fade and the gold turns dull, we will see the truth: we gave up something priceless for things that never mattered.

Habitual Offender Booked Under PSA In Anantnag

Srinagar: In a significant step towards curbing fraudulent activities and protecting the interests of the public, police in Anantnag have detained a habitual offender involved in the sale of counterfeit gold under the PSA.

The accused identified as Showkat Ahmad Zargar son of Noor Mohammad Zargar resident of New Colony, Bijbehara A/P Shamsipora, have been booked under the provisions of the PSA for his repeated involvement in selling counterfeit gold and has been shifted to Kot Bhalwal Jail, Jammu, for lodgement, a police spokesman said in a statement issued to Kashmir Observer.

It is pertinent to mention here that, Police Station Bijbehara had been receiving multiple complaints against the accused over the past years regarding fraudulent sale of fake gold items, and accordingly several FIRs (FIR No. 06/2023, FIR No. 223/2024 and FIR Nos. 149 & 150 of 2025) were registered against him.

During the investigation, the counterfeit gold items produced by complainants were seized and sent to the Hallmarking Centre, Srinagar, for purity verification. Reports confirmed that all seized items were fake

ECI Deregisters 3 Little-Known Parties Of J&K

Srinagar: In a significant development, the Election Commission of India (ECI) has deregistered three obscure political parties from Jammu & Kashmir.

According to an official order, a copy of which is in possession of Kashmir Observer, the poll body today removed the All Jammu & Kashmir Republican Party, Indian Peoples Conference Party, and Socialist Democratic Party from its registry.

These parties were served show-cause in the month of June, asking them to explain why they shall not be de-reg-

Residents Fall III in Daferpora Over Contaminated Water

Srinagar: Panic gripped Daferpora village in South Kashmir's Pulwama district after several residents fell ill, allegedly due to contaminated drinking water supplied by the Public Health Engineering (PHE) department.

Locals said Daferpora, a small hamlet with around 40 households, has seen nearly 30 households affected in recent days. Most patients are suffering from diarrhoea and vomiting.

Speaking to KNO, residents allege the water supply scheme in the area, constructed in 2002, has been neglected for over two decades. "The main water storage tank has never been cleaned since it was installed. We have been drinking from the same unclean source all these years. This negligence is now directly affecting our health," said Ghulam Nabi, a local resident.

Another villager, Abdul Rashid, said repeated pleas to clean the tank and improve supply have fallen on deaf ears. "The government prom-

ised us a new water scheme under the Jal Jeevan Mission. Land was identified and pipes were brought here, but the work never started. It is sheer negligence and indifference towards our suffering," he said.

They have demanded an investigation for this reason at an earliest. A senior health official confirmed

that a medical team had visited the village to treat patients and conduct awareness sessions. "So far, 16 people have fallen ill, out of which 12 have recovered. Three fresh cases were reported today. The situation is under control and we have advised residents to drink only boiled water until further notice," the official said.

Water samples have been collected from the supply line and results are expected by tomorrow. "Preliminary indications point to contamination as the likely cause,' the official added.

Villagers have urged the local MLA, Deputy Commissioner Pulwama and PHE authorities to act immediately. "We cannot afford another such crisis. Clean drinking water is our basic right," they said.

India Endorses US-Russia Summit In Alaska

After US President Donald Trump announced that he will meet Russian President Vladimir Putin next Friday, 15th August, in Alaska for talks aimed around ending the war in Ukraine, the Ministry of External Affairs in a statement said that India welcomes the understanding between the US and Russia for a meeting.

"India welcomes the understanding reached between the United States and the Russian Federation for a meeting in Alaska on 15th August 2025", the statement said, adding "This meeting holds the promise of bringing to an end the ongoing conflict in Ukraine and opening up the prospects for peace. As Prime Minister Narendra Modi has said on several occasions, "This is not an era of war".

This will be Putin's first trip to the United States since 2015, when he met former President Barack Ohama.

In a post on Truth Social, Trump wrote, "The highly anticipated meeting between myself, as President of the United States of America, and President Vladimir Putin of Russia will take place next Friday, August 15, 2025, in the Great State of Alaska. Further details to follow. Thank you for your attention to this matter!"

The Kremlin informed that the two leaders would

"focus on discussing options for achieving a long-term peaceful resolution to the Ukrainian crisis", describing the process as "challenging" but one that Moscow would engage in "actively and energetically."

While speaking at the White House, Trump had said during the signing of the Armenia-Azerbaijan peace accord that striking a deal could involve exchanging land. "We're going to get some back, and we're going to get some switched. There'll be some swapping of territories to the betterment of both, but we'll be talking about that either later or tomorrow," he told reporters.

However, Ukrainian President Volodymyr Zelensky said on Saturday that they "will not give their land to occupiers".

"The answer to Ukraine's territorial question is already in the constitution of Ukraine," Zelensky said in a message on Telegram. "No one will and no one can deviate from it. Ukrainians will not give their land to the occupier."

Trump's special envoy, Steve Witkoff had a meeting with Putin in Moscow for three hours. The US said that the meeting was "highly productive".

On Wednesday, Trump imposed a 25 per cent tariff on India over its imports of Russian oil.

Over 27 Quintals Of Expired Fish, Chicken Seized In Jammu



3 Cases Registered

Srinagar: Over 2700 kgs of expired fish and chicken were seized and subsequently destroyed in a joint inspection by Legal Metrology Department (LMD) and Food Safety Department here on Saturday, officials said, prompting the registration of three separate cases against the erring shopkeepers.

The recovery of 27 quintals of expired frozen food comes days after a rotten-meat

scandal has shaken consumers in Kashmir where authorities have destroyed more than 3500 kgs of adulterated varieties of meat over the past week.

"On the instructions of the government, we conducted joint inspection of fish and chicken market in the city in view of the festival season to check whether the products, including those imported from outside J-K, are stored as per the norms and carry packaging date, expiry and MRP," Deputy Controller LMD, enforcement, Manoj Prabhakar

He said a total of 27 quintals of rotten and spoiled frozen fish and chicken were seized during the inspection and accordingly, three cases under legal metrology act were registered against the dealers for violation of various guidelines.

A challan under section 56 along with improvement notice under section 32 was also recommended against the shopkeepers for storing the frozen food in the most unhygienic condition and in violation of the provisions of the food safety and standard act, he said.

He said all the seized material was destroyed with proper SOP along with a team of Jammu Municipal Corporation at dumping station Kotbhalwal in the outskirts of the city.

New Delhi: The Election Commission on Saturday said it has delisted 334 registered unrecognised political parties which have failed to fulfil the essential condition of contesting even a single election for six years since 2019.

The offices of these parties could also not be physically

located anywhere.

These 334 registered unrecognised political parties are from different states and Union Territories across the country, the poll panel said.

Out of the total 2,854 registered unrecognised political parties, 2,520 remain after the cleanup exercise. At present, there are six national parties and 67 state parties.

Food Safety Department sealed a restaurant at Beehama area of Central Kashmir's Ganderbal and destroyed nearly two quintals of rotten meat items late Friday.

"Staff members attempted to dump bags of Rista and Kabab into a neighbouring courtyard to evade seizure, but the move was thwarted. All contaminated meat was confiscated and disposed off on the spot," an official said.

In south Kashmir's Kokernag, an eatery was penalised after spoiled meat was found during a joint inspection drive on Saturday. The contaminated food items were destroyed on the spot, and a fine of Rs 18,000 was imposed for serving unhygienic and unfit food to customers.

Is Rotten Meat

Dr Mohammad Salim Khan, Head of the Department of Community Medicine at GMC Srinagar, said that improper handling of meat and poultry can have devastating consequence

"Unsanitary practices during slaughtering, dressing, packaging, transportation, storage, and distribution can contaminate meat with harmful bacteria, leading to foodborne illnesses such as food poisoning, diarrhoea, dysentery, and typhoid fever," he said.

He added, "Meat, especially poultry, spoils quickly when exposed to environmental conditions without proper handling and storage. Unfortunately, in many cases, meat is transported in unhygienic thermocol boxes or kept in the open, rather than in refrigerated vehicles and deep freezers."

Dr Khan stressed that the safe disposal of spoiled meat is equally important. "Improperly discarded meat can contaminate water bodies and the environment. It must be destroyed scientifically, either through incineration or deep burial with disinfectants," he said.

Adding to the alarm, Dr Owvass H. Dar, a consultant radiologist at GMC Anantnag, said the link between unsafe food and chronic diseases, including cancer, cannot be ignored.

"The incidence of cancer in Kashmir has reached alarming levels—there is hardly a village, locality, or mohalla left untouched. In the Radiology Department, we diagnose at least one or two new cancer patients every day on ultrasound or CT scans," he said.

While lifestyle changes and environmental factors play a role, the consumption of rotten meat treated with carcinogenic chemicals to disguise spoilage is a preventable risk, Dr Owais said. "This is not just about food hygiene—it could be silently contributing to the cancer epidemic in our valley," he said.Dr Dar called for urgent, large-scale research into the causes of the cancer surge in Kashmir, backed by strong logistics and government support.

"Each of us can protect our families by avoiding unsafe, pre-processed foods and choosing fresh, hygienic options. Food safety is not simply about avoiding a bad meal—it's about saving lives and preventing a public health disaster," he added.

Authorities have stepped up inspections, seizing thousands of kilograms of unsafe meat and other food items. However, experts say enforcement must be coupled with public awareness campaigns to ensure that the valley's residents understand the dangers of consuming adulterated and unhygienic food.

Customers Stay

(ICLC) and Yameen Ul Nabi, along with Food Safety Officers, the team raided the premises, confiscated the meat, and destroyed it under strict supervision. Legal proceedings have been initiated under the Food Safety and Standards Act.

For the city's restaurant owners, the damage has been swift and unforgiving. "We used to be full during lunch hours, now half the chairs stay empty," said a downtown restaurant owner, speaking on condition of anonymity. "Even though our kitchen is spotless and our meat is fresh, customers are nervous. The fear is bigger than the facts."

The chain reaction has also hit suppliers who cater to eateries. One street vendor selling "ristas and kebabs" described his loss bluntly: "I used to prepare around 70 kilograms of meat every day. Now I can't sell even 30 kilograms. Negative social media reviews and viral videos have destroyed people's appetite."

In the days since the raid, social media timelines have been flooded with clips of meat inspections, rumours about unhygienic kitchens, and heated debates on food safety. For many families, the decision is simple — eat at home until trust is restored. "I don't want to take any

risks for family" said a woman from Hawal. The psychological effect on restaurant staff is also showing. Waiters, once busy ferrying trays of mutton rogan josh and kebabs, now linger by the counter, glancing at the door for customers who may never come. Some chefs admit they are cooking smaller batches to avoid wastage, while others are slashing menu items altogether.

Officials have again warned all Food Business Operators — especially those dealing with high-risk, perishable goods — to maintain strict cold-chain storage and hygiene measures. "This is about saving lives, not hurting livelihoods," an enforcement officer said. "Clean kitchens and safe meat are the only way forward."

For Srinagar's once-thriving restaurant sector, the battle ahead is not just about passing inspections. It's about winning back a public whose trust — like the city's dinner tables — now sits half empty.

He scored 14 goals in his first season with the club and followed that with 13 last term.

Sesko has six goals in 28 Champions League games for Leipzig and his previous club Salzburg. He's tallied 16 goals in 41 games for Slovenia.

"Benjamin possesses a rare combination of electrifying pace and the ability to physically dominate defenders, making him one of the most exceptional young talents in world football," said Jason Wilcox, United's director of

"We have followed Benjamin's career closely," he added. "All of our data analysis and research concluded that he has the required qualities and personality to thrive at Manchester United." The move for Sesko comes

after United's reported interest in Liam Delap, Viktor Gyokeres and Ollie Watkins.

Sesko is unproven in England, but Cunha and Mbeumo are tried and tested in the Premier League.

Mbeumo scored 20 league goals for Brentford last season, with only Mohamed Salah, Alexander Isak and Erling Haaland netting more. Cunha scored 17 in all competitions and helped Wolves avoid relegation last term.

New Zealand Crushes Zimbabwe In Record Win

BULAWAYO: New Zealand recorded its biggest-ever test win when it crushed Zimbabwe by an innings and 359 runs in the second test to wrap up a lopsided series 2-0 on Saturday.

New Zealand pace attack. Debutant fast bowler Zakary Foulkes followed his four-wicket haul in the first innings with 5-37 in the second outing and narrowly missed out a 10-wicket haul in his memorable debut test.

But still Foulkes' match haul of 9-75 was New Zealand's best bowling figures by a test debutant, surpassing Will O'Rourke's match figures of 9-93 against South Africa at Hamilton last year.

Fast bowlers Matt Henry (2-16) and the two other pace bowling debutants Jacob Duffy (2-28) and Matthew Fisher (1-22) were also among the wickets as Zimbabwe was dismissed in 28.1 overs for its lowest total in the series.

Obviously we lost the toss, but we bowled very well in the first innings," New Zealand captain Mitchell Santner. "We talked

about keeping the standards up." No. 3 batter Nick Welch remained unbeaten on 47 off 71 balls and was one of only two Zimbabwe batters to reach double figures along with captain Craig Ervine, who made 17. New Zealand had earlier de-

clared its first innings at the overnight monumental 601-3 with Rachin Ravindra (165 not out) and Henry Nicholls (150 not out) combining in a blazing 256run fourth-wicket stand. Devon Conway (153) also made his first test century after more than two years in New Zealand's highestever total against Zimbabwe.

Hasan Nawaz Leads Pakistan To Win Over WI

TAROUBA: Hasan Nawaz hit an unbeaten 63, including a six and a clinching boundary in the secondto-last over, to help Pakistan beat West Indies by five wickets in the first one-day international.

Pakistan reached 284-5 with seven balls to spare after the home side scored 280 after being sent in to bat by Pakistan, which won the preceding Twenty20 series 2-1 played in Florida. Captain Mohammad Rizwan

added 53 runs for Pakistan. "At the start, the spinners were great, but once the dew came in it got easier," playerof-the match Nawaz told the host broadcaster.

Earlier, Evin Lewis, captain Shai Hope and Roston Chase scored half-centuries for West Indies. Shaheen Shah Afridi led the Pakistan bowlers with four wickets for 51 runs while Naseem Shah added 3-55.

"It was tough to play in conditions like this, and the toss had a big part," Hope said. "Maybe we could've got more runs. Credit to our bowlers for fighting at the end. We needed to score more in the middle overs. But all in all, we're still one step behind."

"as per established procedure." The AIFF said it received a ioint letter from nine referees on August 5, requesting extension of their professional match official contracts due on August 31.

"The AIFF urges all parties to remain calm, as several competitions are currently ongoing, where many of our referees are officiating in matches, like in Durand Cup, and the

Futsal Club Championship," added the AIFF.

"Other activities such as the U20 women's National Team's matches in the AFC U20 Women's Asian Cup 2026 Qualifiers in Myanmar, and the U23 men's and U17 women's National Team camps in Bengaluru are currently underway as well."


The anxiety among referees could be traced to the ongoing deadlock over the ISL's 2025-26 season.
