Rotten Meat Scandal Revives Kashmir's Appetite For Traditional Food

Srinagar: The word "fresh" is suddenly heavy with meaning in Kashmir's summer markets. Customers lean closer to sniff cuts of mutton. Butchers are peppered with questions they never used to hear: When was this slaughtered? Where did it come from?

now-infamous "rotten meat scandal," in which sacks of decomposed mutton were seized from a cold storage in Srinagar.

What might have been dismissed as a routine food safety raid has, instead, hit a nerve, reviving a public debate about how the valley abandoned its centuries-old fresh food traditions and whether it can win



DECOMPOSED MUTTON HAS PUSHED KASHMIRIS to demand tougher food laws and a return to the fresh, local eating that once kept the valley healthy and proud.

"This isn't just about one storage unit or a few corrupt sellers," said Nazir Ahmad, a wazwan chef from Srinagar. "It's about how we lost the discipline our elders lived by: buy fresh, eat fresh, waste

For most of the 20th century, freshness in Kashmir was non-negotiable.

Families knew their butcher

and their chicken seller by name. Meat was bought in the morning and cooked before sunset. Fresh vegetables came from the fields of neighbours. Freezers, if they existed at all, were for rare ice cream or leftover wazwan curry.

Those habits have eroded. Over the past decade, frozen mutton and industrially farmed broiler chicken have

replaced much of the local supply, their journeys stretching hundreds or even thousands of kilometers.

Along the way, experts say, nutrients are lost and harmful extras, like antibiotics, preservatives, even water injections to inflate weight, slip in. Doctors say they are seeing

Over 11,600 Kg Unsafe Meat Seized In Week-Long Raids

Srinagar: In one of the biggest food safety crackdowns in recent years, authorities in Jammu and Kashmir have seized over 11,668 kilograms of unsafe meat across the Union Territory, in just over a week, while Srinagar Police have identified a key suspect and his another aide for their alleged involvement in this racket, officials said on Monday.

Food and Drug Administration (FDA) Commissioner Kashmir, Smiti Sethi said a total of over 11,668 kilograms of unsafe meat has been seized across J&K so far, with intensified raids underway to purge markets of manipulation and health hazards.

She said until the market improves, the drives will continue. "We are following proper procedure and once the process is complete, details will be made public," Sethi said.

Moreover, the large-scale seizures come amid a government crackdown following multiple raids in recent weeks-ranging from the destruction of 1,200 kg of rotten meat in Srinagar's



Zakura to the disposal of thousands of kababs and Gushtaba found laced with prohibited colouring agents in other districts.

Additionally, health experts at the meeting, including SKIMS and GMC Srinagar heads, warned of chronic illnesses linked to food adulteration and urged the public to avoid buying meat from unverified vendors. Also, the authorities have appealed to citizens to report violations via the helpline "Dial 104" rather than resorting to vigilante actions.

CM Omar Orders Food Check Posts, Labs At J&K Entry Points

Says Those Playing With Public Health Must Face the Law

Srinagar: Chief Minister Omar Abdullah on Monday directed officials to take exemplary punitive action, including initiating criminal proceedings, against those found storing or selling unsafe food.

Omar chaired a high-level meeting here to review the ongoing food safety enforcement campaign in the wake of recent seizures of unsafe meat and meat products, particularly in the Kashmir valley.

The chief minister emphasised that offenders posing risks to public health must be prosecuted under the relevant provisions of the Food Safety and Standards Act. He also called for criminal proceedings against the most serious violators.

"The grave problem appears to have remained unchecked and unnoticed for too long. The unscrupulous elements have played with the health and



lives of people. This has to stop and those deliberately involved in playing with public health must face the law," Omar said.

"I appreciate officials for launching the drive and exposing the dangerous rot in our food chain. There can be no compromise on public health and the drive will continue. There will be an audit of the departments concerned

and the mechanism to stop import, sale and use of the unhygienic meat and other food

items," he added. To tighten quality control, the chief minister ordered the establishment of entrypoint check posts and testing laboratories at Lakhanpur and Qazigund to screen mutton, chicken, and other perishable items entering Jammu and Kashmir.

He also directed that Food Testing Laboratories be set up at every district headquarters, instead of limiting such facilities to Jammu and Srinagar, thereby significantly enhancing the government's enforcement capacity.

Air India to Suspend **Delhi-Washington Flights**

Srinagar: Air India will suspend flights between the national capital and Washington D.C. from September 1, mainly due to nonavailability of multiple Boeing 787 Dreamliner planes as the legacy aircraft fleet is undergoing retrofit. The Tata Group-owned airline, which currently operates five weekly flights from Delhi to Washington using the Dreamliner, on Monday (August 11, 2025) said the decision has been taken on account of a combination of operational factors to ensure reliability of its overall route network.

The suspension is primarily driven by the planned shortfall in Air India's fleet, as the airline commenced retrofitting 26 of its Boeing 787-8 aircraft last month. This extensive retrofit programme, aimed at significantly enhancing customer experience, | More on P10

One-Fifth Of Indians Aged 45 And Above Had Diabetes In 2019: Study

bout a fifth of those aged 45 and above were living with diabetes in 2019, with two in every five possibly unaware of their condition, according to data from a study among India's ageing adults. Findings published in The Lancet Global Health also suggest that as the country's population rapidly ages, diabetes cases among the middle-aged and older adults will increase, even if increase in prevalence of the condition in age-specific groups can be arrested, authors said.

Researchers, including those from the International Institute for Population Sciences, Mumbai, and US, also found that 46 per cent of those aware of their diabetes regained a control over blood sugar levels, while around 60 per cent were able to control their blood pressure the same year. Six per cent were taking a lipid-low-

ering medication to reduce the risk of cardiovascular disease, the team said. The 'Longitudinal Aging Study in India' (LASI), which surveyed about 60,000 adults aged 45 and above during 2017-2019 (Wave 1), found prevalence of the metabolic condition was similar among men and women (nearly 20 per cent) and that in urban areas was twice, compared to prevalence in rural

Further, states that were economically more developed tended to have a greater prevalence of diabetes, with



about a third or more having diabetes in the states where prevalence was highest, the researchers said.

"Our study provides updated, nationally representative, and staterepresentative estimates of diabetes prevalence, awareness, treatment, and control using glycaeted haemoglobin (HbA1c) concentrations among middle-aged and older adults in India," they wrote.

The team "found that approximately one in five people aged 45 years and older had diabetes (50.4 million individuals), that variation across states was wide, and that urban diabetes prevalence was twice as high as rural prevalence.'

The authors added that compared to results from previous national surveys, such as the Indian Council of Medical Research-India Diabetes (IC-MR-INDIAB) study that spanned 20082020, findings from the LASI suggest a slightly higher achievement of glycaemic and blood pressure targets, but a lower achievement of lipid-lowering medication targets, among the population.

The authors' findings support the notion that "India continues to be at a stage in the nutrition transition characterised by greatest diabetes prevalence among higher socioeconomic groups.

Further, the results showing a greater prevalence of diabetes among the older age groups are important as the country's population ages rapidly, the team said.

The results suggest that "in the coming years, the total number of middle-aged and older adults with diabetes will increase even if the rise in age-specific diabetes prevalence can be halted.

City's Smallest Mosque Stands Tall At Regal Market

sRINAGAR: Amid the crowded streets and the constant bustle of Lal Chowk, a small yet significant religious landmark quietly stands in Regal Lane — the Srinagar's smallest mosque.

Built in 1968 and rebuilt

Built in 1968 and rebuilt in 2014, this three-storey structure can accommodate only 24 people at a time. The mosque's ground floor serves as a washroom and ablution area, while the upper two floors are dedicated to prayers. Despite its modest size, the mosque holds a special place in the hearts of Regal Lane's traders, who have been looking after it for decades.

"This mosque may be small in size, but in terms of blessings and community spirit, it's huge," a shopkeeper at Regal Market said.

er at Regal Market said.

"We ensure it's clean, the prayer mats are in good condition, and it's always ready for worshippers. It is our shared responsibility."

The 2014 reconstruction was a collaborative effort by local traders, who contributed funds, materials, and labor. "We did not rely on outsiders. Everyone here pitched in what they could. Some gave money, others offered materials, and many helped physically in the work," recalled another trader from the lane.

Given its small capacity, the mosque fills up quickly during prayers and in the holy month of Ramadan, with worshippers often praying in shifts.

"For traders, this mosque is a blessing. We work long hours, and being able to step away from our shops for a few minutes to pray gives us peace of mind," the shop keeper said.

Over the years, the mosque has also caught the attention of visitors exploring Lal Chowk. Many are surprised to find a functioning mosque of such compact size, tucked between busy shops. (KINS)

The meeting was attended by Advisor to the Chief Minister Nasir Aslam Wani, Chief Secretary Atal Dulloo, Commissioner Secretary Housing & Urban Development Department (H&UDD) Mandeep Kaur, Divisional Commissioners of Kashmir and Jammu, Deputy Commissioners of Srinagar and Jammu, Commissioners of Srinagar Aunicipal Corporation and Jammu Municipal Corporation, Vice Chairpersons of Srinagar and Jammu Development Authorities, and other

senior officials concerned.

The meeting held detailed deliberations on the Srinagar Master Plan-2035, Jammu Master Plan-2032, and the Unified Building Bye-Laws-2021. Commissioner Secretary H&UDD gave a comprehensive presentation on the master plans, highlighting their strategic vision, projected urban growth patterns, infrastructure requirements and policy interventions.

The Unified Building Bye-Laws were also discussed, particularly those related to permissible land use for residential, industrial, public and semi-public spaces, as well as other technical provisions aimed at streamlining urban development.

Chief Minister Omar Abdullah emphasised that master plans must be realistic, implementable and re-

flect ground realities, rather than existing solely as vision documents.

2 J&K Police Officers Dead In Srinagar Accident

Narparistan-Fateh Kadal Road In Shambles

SRINAGAR- The Narparistan road near Tiny Tots School in Fateh Kadal, Srinagar, has fallen into severe disrepair, sparking outrage among locals who say its condition is causing daily hardships and posing serious safety hazards. Residents describe the stretch as a vital link now marred by deep potholes, uneven surfaces, and scattered debris-problems they attribute to years of official neglect. They say that for the last three years not a single layer of macadam has been laid, making driving or even walking on the road hazardous.

According to locals, the poor drainage has compounded the problem, leaving the road nearly impassable during rains. Waterlogging, runoff, and incomplete drainage work have worsened the damage, while in dry weather thick clouds of dust engulf the area, making it difficult for pedestrians and two-wheeler riders to breathe. Public transport operators and private vehicle owners report frequent damage to vehicles, with travel times nearly doubling due to the road's poor state.


Locals say they have lodged multiple complaints with the Srinagar Municipal Corporation's Roads Division, and their local MLA, but no action has been taken. They allege that despite repeated appeals, authorities have ignored their plight. Residents maintain that the road's bad condition has persisted for over three years right outside their homes, causing immense suffering. They say they approached the City Roads Department many times, submitted written requests,



and even contacted the grievance cell, but no concrete measures have been taken so far.

The residents also accused local NC MLA Shamima Firdous of ignoring repeated calls for help. Kashmir Observer tried to contact her on her official phone, but a respondent said she was

in a meeting. Hours later, when another call was made, the same reply was given. Frustrated and feeling abandoned, the residents are now demanding immediate repairs to prevent further deterioration and ensure safe passage for commuters and pedestrians alike.

SC's Big Order: Remove **Stray Dogs from Delhi-NCR**

Srinagar: The Supreme Court has ordered that all stray dogs in Delhi-NCR be moved to shelters, warning of strict action against individuals or organisations obstructing the process. The decision follows a surge in dog bite cases—35,198 in the first half of 2025—and 49 rabies deaths in the region.

Following the Supreme Court's big order, the Delhi government said it will ensure its timely implementation.

A bench of Justices J B Pardiwala and R Mahadevan called the situation "grim" and directed civic bodies in Delhi, Noida, Ghaziabad, Gurugram, and surrounding areas to start the relocation immediately, prioritising vulnerable localities. Authorities have been told to identify an initial target of 5,000 dogs and complete the transfer within six weeks.

"NCT Delhi, MCD, NMDC shall at earliest start picking up stray dogs from all localities from more particularly vulnerable localities and cities. How to do it is for the authorities to look into and if they have to create a force, do it earlier. However, this should be the first and foremost exercise to make all localities free of stray dogs," the

bench said. Calling it a "serious situation", the court affirmed, "There should not be any compromise in undertaking any exercise"

"If any individual or organisation comes in the way of picking stray dogs or rounding them up, we will proceed to take action against any such resistance," the court added, while adjudicating a case it had taken on its own last month.

The court rejected proposals for stray dog adoption, citing risks of re-abandonment. and ordered that none of the captured dogs be released. Shelters must have trained staff for handling, sterilisation, and vaccination, along with CCTV monitoring to prevent escapes. A helpline for reporting dog bites must also be set up.

The bench stressed that rabies vaccine availability be publicly documented, with regular updates on stocks and treatments. Solicitor General Tushar Mehta told the court that earlier relocation efforts were stalled by activist-led stay orders, but warned, "We cannot sacrifice our children just because of a few dog lovers.'

The court took up the case suo motu after media reports highlighted the stray dog menace, with the aim of making Delhi-NCR's streets "absolutely free" of stray dogs.

China To Build Xinjiang-Tibet Rail Link 'Near' LAC With India: Report

Beijing- China is set to build the most ambitious rail link connecting Xinjiang province with Tibet, part of which will "run near" the Line of Actual Control (LAC) with India, ac-

Work is expected to get underway this year on one of the world's most ambitious rail projects with the launch of a state-owned company to oversee the construction and operations of a line that will link Hotan in Xinjiang and Lhasa in Tibet, the Hong Kong-based South China

Morning Post reported. The Xinjiang-Tibet Railway Company (XTRC) had been formally registered with 95 billion yuan (USD 13.2 billion) in capital and wholly owned by China State Railway Group to build the project, the report said, quoting the state-run Shanghai Securities News

"This ambitious project aims to establish a 5,000 km plateau rail framework centred on Lhasa by 2035," Hubeibased Huayuan Securities said in a research note on Friday.

The project's registered capital represents initial funding, not total project costs. For uan-Tibet Railway required an estimated 320 billion yuan (USD 45 billion) to build, according to the report published on Saturday.

"Parts of the route will also run near the China-India Line of Actual Control (LAC), the de facto border between the two countries, giving it defensive importance in a frontier area with less infrastructure than the rest of China,"

the report said. China's mega infrastructure project in the route, the Xinjiang-Tibet highway, also known as G219 highway, was built through the disputed Aksai Chin area, which was a major flashpoint in the 1962 war.

Israeli Strike Kills Journalists In Gaza

Jerusalem- Israel's military targeted an Al Jazeera correspondent with an airstrike Sunday, killing him, another network journalist and at least six other people, all of whom were sheltering outside the Gaza City Hospital complex.

Officials at Shifa Hospital said those killed included Al Jazeera correspondents Anas al-Sharif and Mohamed Qureiqa. The strike also killed four other journalists and two other people, hospital administrative director Rami Mohanna told The Associated Press. The strike also damaged the entrance to the hospital complex's emergency building.

Both Israel and hospital officials in Gaza City confirmed the deaths, which press advocates described as retribution against those documenting the war in Gaza. Israel's military later Sunday described al-Sharif as the leader of a Hamas cell — an allegation that Al Jazeera and al-Sharif had previously dismissed as baseless.

The incident marked the first time during the war that Israel's military has swiftly claimed responsibility after a journalist was killed in a strike.

It came less than a year af-

ter Israeli army officials first accused al-Sharif and other Al Jazeera iournalists of being members of the militant groups Hamas and Islamic Jihad. In a July 24 video, Israel's army spokesperson Avichay Adraee attacked Al Jazeera and accused al-Sharif of being part of Hamas' military wing.

Al Jazeera called the strike "targeted assassination" and accused Israeli officials of incitement, connecting al-Sharif's death to the allegations that both the network and correspondent had denied.

"Anas and his colleagues were among the last remaining voices from within Gaza, providing the world with unfiltered. on-the-ground coverage of the devastating realities endured by its people," the Qatari network

said in a statement. Al-Sharif reported a nearby bombardment minutes before his death. In a social media post that Al Jazeera said was written to be posted in case of his death, he bemoaned the devastation and destruction that war had wrought and bid farewell to his wife, son and daughter.

"I never hesitated for a single day to convey the truth as it is, without distortion or falsification," the 28-year-old wrote.

The journalists are the latest to be killed in what observers have called the deadliest conflict for journalists in modern times The Committee to Protect Journalists said on Sunday that at least 186 have been killed in Gaza.

Al-Sharif began reporting for Al Jazeera a few days after war broke out. He was known for reporting on Israel's bombardment in northern Gaza, and later for the starvation gripping much of the territory's population.

In a July broadcast he cried on air as woman behind him collapsed from hunger.

"I am taking about slow death of those people," he said at the time.

Al Jazeera is blocked in Israel and soldiers raided its offices in the occupied West Bank last year, ordering them closed.

Al-Sharif's death comes weeks after the New York-based Committee to Protect Journal ists said Israel had targeted him with a smear campaign.

"Israel's pattern of labelling journalists as militants without providing credible evidence raises serious questions about its intent and respect for press freedom," Sara Qudah, the group's regional director, said in a statement. (AP)

Pezeshkian Warns Against US Hegemonic Schemes In Caucasus

Tehran: Iranian President Masoud Pezeshkian savs re gional countries must remain vigilant and cautious in the face of possible schemes by the United States to pursue its hegemonic goals in Caucasus.

In a phone conversation with Armenian Prime Minister Nikol Pashinyan on Monday, Pezeshkian warned that the US may use a project on the construction of a transportation corridor in the Caucasus region to achieve its objectives under the guise of economic investment or promotion of peace.

He said the project must preserve Armenia's sovereignty and prevent any foreign military and security intervention.

"It must be ensured that this corridor will truly be a path of peace and development and not a tool for materializing the hegemonic goals of foreign powers.'

'The Islamic Republic of Iran, as a harbor of peace, stability, and security in the region, welcomes any agreement that leads to the promotion of peace, notably among regional countries, Pezeshkian said.

Azerbaijan and Armenia signed a US-brokered peace agreement on August 8 during a meeting with US President Donald Trump after decades of tensions over the long-disputed region of Karabakh.

The region has always been internationally recognized as part of Azerbaijan. Azerbaijani troops retook

the region a 24-hour offensive in September 2023 Iran is acutely aware of

longstanding UK and US am-

bitions to extend their influ-

ence from the Caucasus into Central Asia—a strategy that seeks to dominate the three smaller regional states while isolating Iran and Russia. Iranian Foreign Minister

Abbas Araghchi said on August 10 that Tehran welcomes any peace agreement between Armenia and Azerbaijan.

"We call for the maintenance of the full sovereignty of all countries in the region over their territories and defend the territorial integrity of all regional countries. We also defend international borders and do not accept any change to them.

Iran-Armenia ties strategic, constructive: Pezeshkian

Elsewhere in his remarks. Pezeshkian said "strategic" ties between Iran and Armenia have always been constructive and based on good neighborliness and respect for the territorial integrity of each country.

He said Tehran and Yerevan firmly oppose any attempt to disrupt deep-rooted mutual relations.

The Iranian president said Tehran has always prioritized common interests in regional relations, particularly with its

Iran is also confident that neighboring countries also pursue a similar approach as one of their fundamental priorities, he said.

India Added to UK's 'Deport Now, Appeal Later' List For **Foreign Criminals** Press Trust Of India

New Delhi: India is among the countries being added to an expanded UK government list of countries where foreign criminals will be deported once they are sentenced before their appeals are heard as part of measures to crack down on rising migration to the country.

In an announcement on Sunday, the UK Home Office confirmed that the scope of its "Deport Now Appeal Later" scheme will be nearly trebled from eight countries to 23, with foreign nationals from these countries to be deported to their home countries before they can appeal against that decision. Foreigners who have had their human rights claim refused will have a chance to take part in their UK appeal hearing remotely from overseas using video technology.

"For far too long, foreign criminals have been exploiting our immigration system, remaining in the UK for months or even years while their appeals drag on. That has to end," said Home Secretary Yvette Cooper.

"Those who commit crimes in our country cannot be allowed to manipulate the system, which is why we are restoring control and sending a clear message that our laws must be respected and will be enforced," she said.

The list of countries covered under the remote hearing scheme, revived in 2023 by then Conservative home secretary Suella Braverman, included Finland, Nigeria, Estonia, Albania, Belize, Mauritius. Tanzania and Kosovo.

Now, India will be added along with Angola, Australia, Botswana, Brunei, Bulgaria, Canada, Guyana, Indonesia, Kenya, Latvia, Lebanon, Malaysia. Uganda and Zambia.

Three-Quarters Of UN Members Support Palestinian Statehood

PARIS: Three-quarters of UN members have already or soon plan to recognize Palestinian statehood, with Australia on Monday becoming the latest to promise it will at the UN General Assembly in September.

The Israel-Hamas war, raging in Gaza since the Palestinian militant group's attack on October 7, 2023, has revived a global push for Palestinians to be given a state of their own.

The action breaks with a long-held view that Palestinians could only gain statehood as part

According to an AFP tally, at least 145 of the 193 UN members now recognize or plan to recognize a Palestinian state, including France, Canada and Britain.

Here is a quick recap of the Palestinians' quest for statehood: On November 15, 1988, during the first Palestinian intifada, or uprising against

Israeli rule, Palestinian leader Yasser Arafat unilaterally proclaimed an independent Palestinian state with Jerusalem as its capital.

He made the announcement in Algiers at a meeting of the ex-

iled Palestinian National Council, which adopted the two-state solution as a goal, with independent Israeli and Palestinian states existing side-by-side.

Minutes later, Algeria became the first country to officially recognize an independent Palestinian state.

Within a week, dozens of other countries, including much of the Arab world, India, Turkiye, most of Africa and several central and eastern European countries followed suit.

The next wave of recognitions came in late 2010 and early 2011, at a time of crisis for the Middle East peace process.

Raut said rumours are circulating in Delhi that Dhankhar has been confined to his residence and is reportedly not safe.

"There has been no communication with him or his staff, which is a matter of grave concern," he said.

"What exactly has happened to our

(former) vice president? Where is he? How is his health? Is he safe? The nation deserves to know the truth about these questions," he said.

Last week, Shiv Sena-UBT chief Uddhav Thackeray asked about Dhankhar's whereabouts. "Where is the former vice-president now? This is the issue that should be discussed," he said at a press conference here on Thursday.

Raut, a Rajya Sabha member, said some of his colleagues from the Upper House are considering filing a writ petition of Habeas Corpus in the Supreme Court as they are genuinely worried about Dhankhar.

"Before knocking on the doors of the Supreme Court, I thought it to be prudent to seek this information from you. I hope you will understand my sentiments and provide genuine information regarding Shri Dhankhar's current whereabouts and his safety and health," Raut said.

Robbers Loot Gold Worth Rs 10 Crore, Rs 5 Lakh In Cash From MP Bank

Jabalpur: Five people looted 10 kilograms of gold valued at Rs 10 crore and Rs 5 lakh in cash from a bank in Khitola area of Madhya Pradesh's Jabalpur district on Monday, a police official said.

The heist took just 18 minutes, the official said, adding the accused came on two motorcycles and entered the facility wearing helmets.

"As per the calculations of ESAF Small Finance Bank, the robbers looted 10 kilograms of gold (worth around Rs 10 crore) and Rs 5 lakh in cash. Further calculations are under way," Jabalpur Range Deputy Inspector General of Police Atul Singh told PTI.

"The bank branch did not have a security guard. There were six staffers at the time of the incident. The robbers entered it at 8.50 am and came out around 9.08 am. They fled on motorcycles. We have scanned CCTV cameras. They did not have weapons in their hands. One of the robbers had a firearm tucked under his belt," Singh said.

The DIG also pointed out that the staffers notified the police 45 minutes after the incident following discussions with senior officials at the lender.

"Had they informed us in time, the robbers would have been caught. Efforts are on to nab the accused," Singh added. According to sources, the bank started its

day at 8 am instead of its usual opening time of 10.30 am due to the ongoing festive season.



Statehood Petition Listed For Hearing On Aug 14

Residents Demand Reopening Of Tourist Destinations In Budgam

SRINAGAR: The inhabitants of prominent tourist destinations in Budgam including Doodhpathri, Yousmarg and Tosamaidan here have appealed to the Jammu and Kashmir administration to reopen the prominent sites, citing severe economic distress following their closure in the wake of the Pahalgam terror attack.

The administration as had ordered the shutdown of several tourist spots across the Valley for security reasons after the Pahalgam attack.

However, locals say the prolonged closure of these three meadows, which draw thousands of visitors each summer, has crippled the local economy.

Many service providers, including pony handlers, guesthouse owners, taxi operators and shopkeepers, depend entirely on the tourist season for their income.

"We have taken loans to run our seasonal businesses. With no tourists, we have no earnings and the banks are pressuring us to pay our EMIs,"

said Abdul Rashid from Raiyar

Khansahib.

"Our families survive on what we earn in these few summer months. If the place stays closed, we will be left with no way to feed our children," said Ghulam Nabi, who runs a tea stall near the main meadow.

Former MLA and Peoples Democratic Front (PDF) Chairman Hakeem Mohammad Yaseen has supported the demand, urging the government to consider a phased reopening with adequate security measures in place.

"Tourism is the economic backbone of these areas. Keeping these destinations closed for too long is pushing our youth into financial desperation. The government must act and reopen them with proper safety arrangements." Yaseen said.

Although officials have reopened 16 closed destinations in phases, no timeline has been announced for Doodhpathri, Yousmarg, or Tosamaidan.

According to KNO, locals said that missing the summer season will deepen the financial crisis for hundreds of families who rely on tourism for survival.

Health Minister Warns Against Food Adulteration, Vows Action

SRINAGAR: Minister for Health and Medical Education, Sakina Itoo, on Monday vowed strict action against food adulteration and the mixing of harmful chemicals in consumables, warning that the government will not spare anyone found endangering public health.

Speaking to reporters on the sidelines of a function at Amar Singh College, Srinagar, Itoo described the menace as a "serious health concern" that has reached alarming proportions. She said health experts are increasingly linking the rise in cancer, liver ailments, tumours, and sudden heart attacks—particularly among young people—to the widespread consumption of adulterated food.

"Some people are playing with our health by giving us food items that are adulterated and laced with harmful chemicals. This is not only unethical but life-threatening," she said.

Health officials revealed that Jammu & Kashmir currently has around 51,000 ac-

tive registered cancer cases, in addition to a growing number of patients suffering from chronic liver diseases, tumours, and cardiac complications. Itoo expressed concern over the growing incidence of sudden heart attacks among otherwise healthy young individuals. "We often hear of such deaths and used to wonder why they were happening. It now seems adulteration and chemical contamination in food could be one of the major reasons," she noted.

To address the crisis, Chief Minister Omar Abdullah on Monday chaired a high-level meeting attended by three concerned ministers and top officials. The meeting approved a multi-pronged action

plan to eliminate adulteration from the market.

A key feature of the plan is the establishment of modern testing laboratories at every district headquarters to enable on-the-spot safety checks of edible items. "The government will act firmly. There will be strict checks, punishments, and continuous monitoring. No one will be allowed to indulge in this dangerous practice in the future," Itoo as-

She also stressed the importance of maintaining public trust in the medical fraternity. "Both patients and doctors are our own people. We must strengthen the bond between them. However, wherever there is negligence on the part of doctors, the government will not leave any stone unturned in taking action," she

Reassuring the public, the minister said the govern-ment is determined to curb the menace once and for all. "Whosoever is involved will face the music. This is about safeguarding public health, and we will not compromise," she affirmed.

Health experts have long cautioned that consuming contaminated and chemi-cally treated food is directly contributing to a surge in lifethreatening diseases in the region.

Fan Facility In Classrooms Out Of Bounds For 30% JK Students

SRINAGAR: As Jammu and Kashmir faces the music of scorching heat, at least 30 percent of school students bear the brunt of unavailability of fans and lights in the classroom.

The Ministry of Education (MoE) in a report said, "70 percent of students reported that their schools have working fans and lights in the classroom."

The report further said that 75 percent of students reported that their schools have separate functional toilets for boys and girls.

It also states that 69 percent students reported that their schools provide adequate sports facilities to all students "70 percent Students re-

ported that their schools have working fans and lights in the classroom," reads the report. The MoE in a report also said that 73 percent Students re-

ported that their schools have clean drinking water available. "60 percent Students reported that their schools have functional laboratories for grade IX

students," it reads. MoE further said that the school facilities play an important role in the teaching-learning process.

The figures illustrate the availability of essential school facilities like sports facilities, drinking water, functional fans and lights, science lab, and

separate functional toilets. Instances where availability is below 50 percent need targeted interventions," it reads.

The report also said that "Most students shared that their schools are equipped with basic facilities such as functional toilets, clean drinking water, and proper ventilation through working fans and lights in classrooms.'

"Access to sports facilities is also reported by many students. However, the availability of functional laboratories for Grade IX students is relatively lower in comparison," MoE said.

The report further said that ensuring consistent access to all essential infrastructure is important to create a more enabling environment for learning. Pertinently, KNO in previous

week reported that a segment of students in Jammu and Kashmir, are pessimistic about their ability to achieve their future goal while a huge number of students in schools are reeling under stress, anxiety, isolation or loneliness.

MoE had said, "A segment of students reported feeling stressed, unhappy, or isolated, and some also expressed reluctance to attend school.'

"Some students mentioned difficulty in talking to someone when feeling upset, while a few shared concerns about the pressure of excessive activities," it reads—(KNO)

CS Reviews Implementation Of SASCI, SNA SPARSH Programmes

SRINAGAR: Chief Secretary, Atal Dulloo Monday chaired a high-level meeting to review the progress on Special Assis-States for Capital Investment (SASCI), SNA SPARSH and various revenue augmentation initiatives in the Union Territory of Jammu & Kashmir.

The meeting was attended by concerned Administrative Secretaries and senior officers of the Finance Department.

During the meeting, the Chief Secretary underscored the potential of the SASCI scheme, an interest-free loan facility being extended to all the States and Union Territories over and above their normal borrowing limits, setting an ambitious target of securing around Rs 2,000 crore for I&K under the scheme.

It was informed that 27 departments have already submitted their project proposals,

which have been duly uploaded by the Finance Department.

The meeting also deliberated on key sectoral reforms in Transport, Mining, Urban Planning and modernization of land records, aimed at boosting the infrastructure and governance efficiency

Taking stock of the Aadhaarbased payments being made to the beneficiaries of various government schemes, the Chief Secretary emphasized the need to achieve full saturation across all beneficiaryoriented programmes. He directed the departments to seek guidance from the central ministries, particularly in cases where benefits are provided in kind rather than cash.

Principal Secretary, Finance Department, Santosh D Vaidya, informed the meeting that Aadhaar penetration in J&K has seen a remarkable rise from just over 50% to 97%, with most of the schemes already achieving 100% coverage. The Chief Secretary also

reviewed the UT's revenue performance, including collections from power and water utility provisioning, GST motor spirit stamp duty and other tax and non-tax sources. Stressing the importance of plugging revenue leakages, he called for strict checks on input tax credit theft, improved e-way bill compliance and enhanced enforcement mechanisms.

He directed the Power Development Department (PDD) to accelerate the installation of smart meters and improve billing efficiency to maximize revenue realization.

The Chief Secretary reiterated the administration's commitment towards leveraging the financial assistance schemes effectively while ensuring robust revenue generation mechanisms to support the UT's development priorities.

'Worm Infections Cause Tiredness, **Malnutrition In Children'** cause blood loss, and trigger in-

SRINAGAR: Medical experts in Jammu & Kashmir have warned that children suffering from worm infections often feel persistently tired due to malnutrition and anaemia, which can impair their physical and cognitive development. However, they stressed that such infections are easy to control if diagnosed early and treated promptly.

Doctors said parents must closely monitor their children's growth, behaviour, and overall health, as untreated worm infections can stunt healthy development, cause poor nutrition, and reduce a child's ability to concentrate and learn.

They, however, said treatment is simple, safe, effective, and free of charge, adding that a single dose of deworming medicine can drastically reduce the number of worms in each child.

Dr Shabir Ahmad Dar, a child

specialist, said worm infections

can lead to many health prob-

lems, including anaemia, abdominal distention (swelling), severe abdominal pain, diarrhoea, loss of appetite, malnourishment, tissue damage, and impaired mental and physical growth.

"Deworming boosts nutrient absorption, enhances immunity, improves concentration, reduces anaemia risk, and prevents digestive issues," he explained. Dr Shahzada Akhter, another

physician, said the World Health Organization (WHO) recommends deworming every six months in regions where such infections are prevalent.

"Deworming improves immunity, reduces chronic illnesses caused by worms, enhances school performance, and even increases work potential later in life," she said. "The main reason behind the rising prevalence of anaemia in children is helminthic infection."

Helminthic infections, she noted, are caused by parasitic worms that compete for nutrients, impair iron absorption, flammation. The doctor dismissed the misconception that deworming

should not be done in winter, saying it is effective in all seasons when given at regular intervals. According to the latest National Family Health Survey (NFHS-5), about three-fourths (73%) of children aged 6–59 months in India are anaemic, which is up from 43% in NFHS-4. This includes 25% with mild anaemia, 44% with moderate anaemia, and 4% with severe

In Jammu & Kashmir, the figures are even higher, with 74% of children in this age group being anaemic, even among those whose mothers have 12 or more years of schooling.

Doctors urged parents to combine regular deworming with good hygiene practices and balanced nutrition to protect children from worm infections and ensure healthy growth. -(KNO)

Rotten Meat Crisis

ver the past two weeks, Kashmir has been a constant witness to raids and seizures of the tonnes of rotten meat and stale chicken in the so-called cold storages, and even shops. Heaps of discarded sheep heads were found dumped along roadsides. While on its face, it may look like a hygiene lapse, it is much more than that: it's a betrayal of public trust, and it's unfolding on a scale that points to an organised network feeding unsafe meat into the Valley's kitchens.

From the outskirts of Srinagar to small towns in south and north Kashmir, Food Safety Department teams have found and destroyed thousands of kilograms of decayed meat. Raids have revealed supplies imported from outside the state, stripped of labels, and destined for kebab joints, wazwan caterers, and everyday restaurants. The findings are grotesque: traders trying to dump contaminated meat into courtyards to evade seizure, consignments rotting in thermocol boxes, and even road-side piles of animal remains.

The economic fallout has been swift. Srinagar's once-bustling restaurants now see empty chairs where lunch crowds once gathered. Owners insist their meat is fresh, but fear has taken root. Street vendors who sold 70 kilos of kebabs a day now sell less than half. Social media has only amplified the panic, with videos of raids and rumours spreading faster than official reassurances. Trust, in the food business, is the most perishable commodity of all, and it has all but vanished and will take time before it is restored.

The issue, however, is less about its economic cost for the restaurants and the meat business, it is about health. Health experts warn that spoiled meat is not just a ticket to food poisoning; it is a silent carrier of long-term harm. The food safety department has found that the traders treat meat with chemicals to mask decay, which can be carcinogenic. People are now suspecting that the alarming rise in the cancer rates could be linked to this unwitting consumption of unsafe food.

While this may look like an isolated scandal, it isn't one. The scam has, for once, unmasked a systemic rot. It is true that the food safety department has exposed the deep network of the import of the unsafe meat, but this doesn't absolve it of the negligence in recent years. Civil society is also responsibile, in part, for not paying attention. Weak enforcement, low penalties, and public apathy together havecreated an environment where unscrupulous suppliers throve. And it is time to end this complacency and address the menace at its source, before it poisons both our plates and our public health.

The spoiled meat scandal is a crime against Kashmiri culture, faith, and memory. And sadly, it came from our own.



The next time I return to Kashmir, my questions will not be reserved for unfamiliar places. They will be for my own. I will ask to see the kitchen. I will ask for proof. I will hesitate before taking the first bite.

Those who played with our faith, our health, and our heritage may never understand the depth of the harm they have done. They didn't just serve rotten meat. They served us a

ast year, I was home in Kashmir after months away. My younger son had been asking for goshtabas since the day we booked our tickets. We went to a restaurant with a reputation so solid, I didn't even think twice.

The copper bowl of yakhni arrived, steaming and fragrant. We ate like people who had been counting down the days for that moment.

By nightfall, my little one was doubled over in pain. For a week, he battled severe food poisoning. I told myself it couldn't be the restaurant. I blamed weather, airport sandwiches, and anything but Kashmiri food.

The idea that our own could harm us felt too unthinkable.

Now, after hearing the rotten meat scandal unfold in full detail, I find myself connecting the dots.

Perhaps the meat was stale, or it came from a dead animal. Maybe the chef knew and served it anyway. The thought fills me with disgust.

The pain runs deeper than a bad meal. Wazwan is not just a menu for us Kashmiris. It is a communal act, a cultural performance. It is how we celebrate weddings, welcome guests, and even mourn the dead. It is the rhythm of our festivals and the language of our love.

To serve it with rotten meat is to corrupt that language. It's like slipping poison into a prayer.

I left Kashmir in my teens. carrying my mother's caution like an invisible thread: Be careful what you eat.

Outside the valley, meat always came with a shadow of doubt. Was it halal? Was it clean? That doubt kept me away from meat for my first six months in a New Delhi hostel.

Then one afternoon, our war-

den took me to Motibagh Market and introduced me to Qureshi, a small-time butcher with a spotless shop. He looked me in the eye and said, "The day I don't supply to your hostel, you will get a call. Till then, eat without fear. All my meat is halal.'

That day, after half a year of saying no, I finally tasted chicken again. It wasn't Wazwan, but it felt like trust.

That trust became my compass. Through marriage, two grown children, countless cities and airports, one question has followed me everywhere: Is this

My four-year-old once mimicked me, pointing at restaurant walls and asking about certificates before touching his food. Even after checking, there were times the smell, the stains on a counter, or a hesitant answer told us to leave.

We became conditional vegetarians. Friends knew it and some even joined our chorus of caution.

Trust in food is not just about hygiene. For us, it is bound to faith. When you say a meal is halal, you are not just talking about a method of slaughter, you are making a promise that the food is clean, pure, and permissible.

Breaking that promise is not a minor offence. It is a wound to the soul.

That is why this scandal has felt like more than a public health crisis. It is a moral injury. And this time, the betrayal did not come from outsiders.

It came from our own kitchens and markets.

For greed, some chose to poison their neighbours. For a few extra rupees, they served filth, trampled on trust, and desecrated something sacred.

This is a crime against community, against faith, against the

very idea of Kashmiri hospitality. Some will say not everyone is guilty, that only a few bad actors brought shame to the rest. That may be true. But when the rot touches

the trust, the whole table feels spoiled. Even the honest butcher and the careful chef will now face our suspicion.

The next time I return to Kashmir, my questions will not be reserved for unfamiliar places. They will be for my own. I will ask to see the kitchen. I will ask for proof. I will hesitate before taking the first bite.

And if my questions are met with irritation or evasion, I will stand up and walk away. I would rather go hungry than eat from a plate I cannot trust.

It will take years to repair what has been broken. Trust, once lost, is slow to return. It will take more than government raids and temporary outrage. It will take transparency, honest sourcing, and a commitment from every butcher, chef, and supplier to protect what Wazwan means to us.

For now, I mourn what has been lost, the innocence of sitting at a Kashmiri table and eating without suspicion. And I grieve that the betrayal came from within.

Those who played with our faith, our health, and our heritage may never understand the depth of the harm they have done. They didn't just serve rotten meat. They served us a piece of our culture, spoiled

And that is something I cannot forgive.

This Scandal Should Force Kashmir to Clean Up Its Plate

t took 1,200 kilograms of rotting meat to shake Kashmir's conscience.

spoiled stockpile, seized last week in Srinagar, was a warning that the food on our plates is only as safe as the weakest link in a chain driven by profit over people.

Since the raid, reports of more suspicious consignments have emerged, and the real question is not what was caught, but what may already have been served, swallowed, and digested.

Meat is at the heart of Kashmiri life. Wazwan feast is a symbol of hospitality and honour. Yet the very food we treat as sacred is being trafficked through markets with alarm-

Somewhere in that supply chain, a wholesaler knew the meat had gone bad. A transporter looked the other way, vendors chose to sell it anyway, and this wasn't a slip-up. It was a calculated gamble that

the public wouldn't notice.

The risk is not theoretical. Spoiled meat can harbour Salmonella, E. coli, Botulism, and Listeria, bacteria that survive cooking and can cause fatal illness, especially in children, pregnant women, and the elderly.

A plate of minced kebabs made from such meat can deliver toxins straight into the bloodstream.

The bigger failure lies in enforcement. Where were the checkpoints when the trucks entered the valley? Why were routine inspections absent in wholesale markets? Food safety cannot be a reaction to viral videos and public outrage. It must be constant, visible, and uncompromising.

The scandal also exposes a cultural blind spot. We rarely ask questions when we eat out. We don't demand to see hygiene certificates. We trust that someone, somewhere, is keeping us safe.

That trust, unchecked, is exactly what bad actors exploit.

Destroying the seized meat is only step one. Kashmir needs prosecutions, permanent bans on offenders, cold storage infrastructure, licensed vendors, and regular market sweeps.

Public health campaigns must

teach consumers to demand transparency because informed buyers are the first line of defence.

Our markets today resemble crime scenes where the murder weapon is food. And the casualty could be anyone.

The real question is whether we let this outrage fade or turn it into a movement for safe, ethical, and accountable food in every Kashmiri

The next time, it may not be 1,200 kilograms in a dumpster. It may be on the plate in front of you.

Breaking down silos and incubation rivalry, she creates networks where Kashmir's young entrepreneurs support and learn from each other.

n a bright morning at the University of Kashmir, a nervous first-year student walked into the NewGen Innovation and Entrepreneurship Development Centre clutching an idea: a solar-powered irrigation device.

Within minutes, Dr. Irfana Rashid, the centre's new coordinator, was already mapping out his path forward: mentoring, prototype funding, and connecting him with alumni who could help.

"For years, I taught entrepreneurship in classrooms," she says. "Now, I finally get to bring those lessons to life."

Her background is impressive: UGC-NET/ JRF/SRF awardee, an MBA from the University of Kashmir, a Ph.D. from Aligarh Mus-lim University, and training at IIM Ahmed-

With over 30 research publications and ₹50 lakh in funding, she's guided more than a thousand students and faculty across the

Dr. Irfana's vision for NewGen IEDC is clear: to blend Kashmir's rich heritage with new opportunities. She points to saffron, apples, walnut wood, and trout farms as sectors where innovation can thrive globally while preserving the valley's identity.

She's focusing on agritech, arts and crafts, medicinal plants, tourism, and sustainability. And she's pushing a bold idea called "coopetition", getting rival incubators to share resources and work together to build a stronger startup ecosystem.

The biggest challenge is to change mindsets in a place where comfort and caution have long held sway. "We offer support, but we also expect accountability. Nothing truly valuable comes free."

Her long-term dream is a self-sustaining culture of innovation, where student-led entrepreneurship cells and pre-incubation courses nurture ideas from the ground up.

Back in her office, she's sketching out partners and timelines for that irrigation device. "Where there's a will, there's a way," she says. "Show us your will, and we'll help you find the way."

In this interview with Kashmir Observer, Dr. Irfana shares how she's working to make moments like this everyday reality for Kashmir's young innovators.

You've just taken charge at NewGen IEDC, University of Kashmir. What excites you

It's a deep personal calling. After teaching

entrepreneurship for over a decade, I wanted to bring it to life. This role gives me that chance: to help young people here turn their ideas into ventures that truly matter.

Kashmir brims with untapped potential, but opportunities often seem out of reach. Being part of a mission that helps students bridge that gap truly excites me.

If a student walks in nervous but hopeful, what's their first experience like under your leadership?

I want them to feel welcomed, safe, and heard. For me, every idea counts, even the wild or incomplete ones. We offer mentoring, workshops, small funds to build prototypes, and access to experts.

Soon, we'll launch one-on-one onboarding sessions to help every newcomer map out their idea and connect with the right people from day one. The goal is to leave them confident, knowing they're not alone and that NewGen is a place their dreams can grow.

Kashmir has a unique culture and economy. How do you balance that with preparing students for the global stage?

We root innovation deeply in Kashmir's rich heritage: lakes, orchards, crafts, medicinal plants, and even renewable energy. At the same time, we reach out to the global Kashmiri diaspora to bring mentorship and connections from around the world.

It's about blending local identity with global opportunity, so our students become not only tech-savvy but also proud custodians of Kashmir's legacy.

Alright, but what's your vision for NewGen IEDC over the next five years?

I see it as the birthplace of Kashmir's startup revolution. We want to transform students from job seekers into entrepreneurs who lead sustainable, high-growth ventures.

Our ambition is to be a national model for academic-driven startups and a hub where the valley's unique culture fuels global in-

This vision is close to the heart of our Vice-Chancellor, Prof. Nilofer Khan, who often says that Kashmir University must become the home of innovation and entrepreneurship in the region

few months ago, on a night that started like any other, my family was asleep except for my father. He was restless, pacing the house with

a strange ache on the right side of his I was deep in sleep when a nightmare jolted me awake. I screamed, "My family,

where are you?" My father was the first to answer. His calm voice pulled me out of fear and made me worry about his health. I told him about the nightmare, and he shared that he hadn't slept all night.

We rushed to the hospital.

The waiting area was packed, with many patients ahead of us. When the nurse called out a name that sounded like my father's, I asked her politely if she could repeat it.

have seen many battles in courtrooms, but none as heartbreaking as those ■that begin far from legal disputes, especially in classrooms, hostels, and homes across Kashmir.

The relentless pressure on our students to score high marks feels like a shadow that darkens their every step. Too often, this pressure turns into tragedy.

Last week, the Supreme Court issued a ruling that brought this silent crisis into the open.

Triggered by the suicide of a student in Visakhapatnam, the Court went beyond ordering a probe. It issued clear, binding directions to protect students' mental health nationwide.

For Kashmir, where students face the extra weight of living in a strife zone, this judgment offers a vital lifeline.

It requires every school, coaching centre, and hostel to have mental health policies and trained counsellors. It demands an end to harmful practices

like segregating students by marks, public shaming, and setting impossible academic targets. Hostels and classrooms must display

helpline numbers. Teachers and wardens will be trained to spot early signs of distress. Safety protocols, like tamper-proof fans and rooftop restrictions, are mandatory in residential institutions.

The Court singled out coaching hubs notorious for student suicides, including those in Kashmir, ordering "heightened mental health protections.

This is a direct call to reform the very



spaces where many young people feel most vulnerable.

Crucially, the judgment introduces institutional accountability.
If schools or hostels ignore harassment

or distress that leads to self-harm, they face legal consequences.

This is a shift from silence and neglect to responsibility. The apex court also spoke to parents: ease off the constant academic pressure,

and see your child as more than a mark-

Protecting young minds is a shared duty between families, schools, and government.

Kashmir authorities now have just two months to draft rules for private coaching centres, with district officials charged to

monitor compliance and respond to complaints. The central government must file progress reports every 90 days.

This moment offers Kashmir a chance to change how we educate and care for our children. If we delay, we risk more lives lost to pressure and despair.

If we act, students will find help when they need it. Our homeland will resonate with hope, not sorrow.

As a lawyer, I know the power of the law. Yet laws alone won't protect our children. It's on all of us to listen, and act.

The Supreme Court has spoken. Kashmir must answer.

Inflammation Control In Diabetics May Cure Depression, Methods Vary: Study

n analysis has revealed that addressing inflammation in diabetes can help determine success in treating depression in a group of patients. However, there are differences in outcomes between type 1 and type 2 diabetes, researchers said.

While type 2 diabetes is a metabolic condition marked by an inability to manage blood sugar, type 1 diabetes is an autoimmune disorder in which the body's immune system mistakenly attacks and damages insulin-producing cells in the pancreas.

"People with type 2 diabetes and high inflammation levels possibly respond particularly well to a change in depressive cognitions through cognitive behavioural therapy. People with type 1 diabetes and high inflammation levels, on the other hand, could benefit more from anti-inflammatory drug therapies," said author Norbert Hermanns from the Research Institute of the Diabetes Academy Mergentheim (FIDAM), Germany.

Findings published in the journal Diabetologia could help develop cus-



tomised treatment plans for diabetics, who might be doubly vulnerable to depression compared to the general population, the team said.

Diabetes is often accompanied by anxiety and negative feelings of sickness, which constitute depressive symptoms and can impair progress in treatment.

The researchers said that while early diagnosis and effective treatment of depression in diabetics is important, not all respond equally whether with medication or cognitive

behavioural therapy (a form of psychotherapy).

The team looked at 521 people with type 1 or type 2 diabetes and analysed how their depressive symptoms responded to behavioural therapy over a year.

Measuring 76 inflammatory markers in the blood, the research team examined whether there was a link between inflammation levels and the severity of depression.

Among people with type 2 diabetes and higher levels of inflammation,

cognitive behavioural therapy was found to improve depressive symptoms, including joylessness.

However, among patients with type 1 diabetes and high inflammation, behavioural therapy was found to produce smaller improvements, especially in fatigue, sleep disorders, or loss of appetite.

It is possible that distinct immune processes autoimmune processes in type 1 diabetes and metabolic inflammation in type 2 diabetes could be responsible for the differences in outcomes, the researchers said, adding that future research could help better understand this.

"In people with type 2 diabetes, higher levels of 26 biomarkers were associated with greater reductions in depressive symptoms, whereas in people with type 1 diabetes, higher levels of 13 biomarkers were linked with lower reductions in depressive symptoms," the authors wrote.

"There were also diabetes typespecific differences in the associations with symptom clusters of depression. This suggests that different inflammation-related pathways may be relevant for the response to depression treatment in people with type 1 diabetes or type 2 diabetes." they wrote.

IIT-Roorkee Researchers Discover Promising Drug Candidate To Fight Deadly Antibiotic Resistance

Researchers at the Indian Institute of Technology (IIT), Roorkee have developed a new drug candidate that can restore the effectiveness of a potent antibiotic against deadly drug-resistant bacteria, according to officials.

The researchers' team has designed a novel molecule that works alongside the antibiotic -- Meropenem -- to treat infections caused by KPC-2-producing Klebsiella pneumoniae, a superbug listed among the World Health Organization's (WHO) top-priority threats, the officials said.

The research has been published in the prestigious "Journal of Medicinal Chemistry" and is expected to contribute significantly to future drugdevelopment efforts targeting superbugs.

"This breakthrough offers a promising solution to one of the world's mosturgent health challenges, antimicrobial resistance. Our compound neutralises the resistance mechanism and shows strong therapeutic results in preclinical models," said Ranjana Pathania, Principal Investigator, Department of Biosciences and Bioengineering, IIT-Roorkee.

The newly-discovered molecule belongs to a class of -lactamase inhibitor drugs that prevent bacterial enzymes from breaking

down life-saving antibiotics. Compound 3b is highly specific, safe to human cells and works synergistically with Meropenem to kill resistant bacteria. Lab and animal tests significantly reduced bacterial infection in the lungs.

"This innovation reflects IIT-Roorkee's commitment to developing impactful scientific solutions for global challenges. In the face of rising antibiotic resistance, such research provides critical hope for effective and accessible treatments," said K K Pant, Director, IIT-Roorkee.

Pant said as antibiotic resistance threatens global healthcare systems, innovations like this bring renewed hope for effective treatments and reinforce India's contribution to frontline biomedical research.

Climate Heat Extremes Cut Tropical Bird Populations by 40% Since 1950: Study

Heat extremes driven by climate change may have reduced the world's tropical bird population by 25-38 per cent on average since 1950, a study has estimated.

Findings published in the journal Nature Ecology and Evolution suggest that climate change is endangering tropical bird populations even in the absence of direct human pressures, such as changes in land use, researchers said.

The world's tropical regions -- having a high biodiversity -- are home to nearly half of all bird species. However, many species are said to be living at temperatures close to their tolerance thresholds.

The team, led by researchers at Spain's Barcelona Supercomputing Centre and Potsdam Institute for Climate Impact Research in Germany, said that impact of heatwaves on birds, including tropical populations,

remains under-studied.

They analysed data gathered from monitoring over 3,000 bird populations across the world during 1950-2020, resulting in over 90,000 observations.

Compared to a scenario where there is no humancaused climate change, "the historical intensification of heat extremes has caused a 25-38 per cent reduction in the level of abundance of tropical birds, which has accumulated from 1950 to 2020." the authors said.

1950 to 2020," the authors said. An exposure to extreme heat -- defined as days registering temperatures among the highest one per cent for a region -- was strongly related with a reduced growth in yearly bird numbers, espe-

cially in tropical regions.

The researchers said that the analysed impacts of heatwaves were consistent across modelling approaches and migratory behaviours of the bird species.

They added that the total impact of human-caused intensification of heat extremes over the decades was more

than that from direct human pressures in the studied tropical populations.

The study highlights the growing threat of climate change, with heat extremes playing a critical role in endangering bird numbers in tropical regions.

Along with strategies to mitigate greenhouse gas emissions, the authors also called for conservation measures addressing both habitat protection and the growing threat of climate extremes.

CM Omar Abdullah Reviews Dairy Infrastructure Scheme

Underscores J&K's Immense Dairy Potential



SRINAGAR- Chief Minister Omar Abdullah Monday chaired a highlevel review meeting on the Jammu & Kashmir Dairy Processing Infrastructure Development Scheme (JKDPIDS), a ₹1,433 crore initiative aimed at transforming the J&K's dairy sector into a robust, organized and globally competitive industry. During the review, the Chief Minister highlighted the vast potential of dairy in Jammu & Kashmir.

He stressed the urgent need to expand organized milk processing from the current 4% to at least 20% within the next seven years, ensuring better prices, regular payments, and market access for over 5 lakh dairy farmers.

Principal Secretary, Agriculture Production Department (APD), Shailendra Kumar, gave a detailed presentation on the scheme, implemented by the National Dairy Development Board

NEW DELHI- From McDonald's and Coca-Cola to Amazon and Apple, US-based multinationals are facing calls for a boycott in India as business executives and Prime Minister Narendra Modi's supporters stoke anti-American sentiment to protest against US tariffs.

India, the world's most populous nation, is a key market for American brands that have rapidly expanded to target a growing base of affluent consumers, many of whom remain infatuated with international labels seen as symbols of moving up in life.

India, for example, is the biggest market by users for Meta's WhatsApp and Domino's has more restaurants than any other brand in the country. New Income Tax Bill: Here's **What It Means For Taxpayers**

NEW DELHI- The Income Tax Bill (No.2) 2025 - a major legislative move to replace the 63-year-old law governing income taxation for individuals and corporations — was passed in the Lok Sabha on Monday in just three minutes, without any

The Bill, which streamlines TDS, exemptions and other compliance-heavy provisions and also allows individuals to claim refunds without penalty on delayed filings, was passed as the opposition parties continued to disrupt proceedings over allegations of irregularities in the special intensive revision (SIR) of electoral rolls in Bihar.

Finance Minister Nirmala Sitharaman, who had on August 8 withdrawn the Income Tax Bill, 2025 — which she had introduced in February - on Monday introduced an updated version incorporating recommendations made by a Parlia-mentary panel that scrutinised the legislation. Amid slogan shouting by the opposition, the bill was put to vote and passed by voice vote.

The Bill will now go to the Rajya Sabha for approval and thereafter to the President for assent. It will become law once the Presidential assent is provided.

The new bill reduces the size



and complexity of the current Income Tax Act, drastically cutting the number of effective sections and chapters and nearly halving the word count.

"Almost all of the recommendations of the Select Committee have been accepted by the government. In addition, suggestions have been received from stakeholders about changes that would convey the proposed legal meaning more accurately," said the statement of Objects and Reasons of the Income Tax (No.2) Bill.

It does away with the confusing concepts of assessment year and previous year, replacing them with easier to understand 'tax year'.

According to the revised Bill, individuals will be allowed to claim TDS refund even if their return of income is filed beyond the statutory timeline provided for filing of the original income-tax return. Thus, the Finance Ministry has incorporated the provision of the existing Income Tax Act, 1961.

Banks Free To Decide On Minimum Balance For Savings Accounts: RBI Guv

GOZARIA (GUJ)- Reserve Bank of India Governor Sanjay Malhotra on Monday said banks are free to decide the minimum balance for savings accounts and that it does not fall under the regulatory domain of the RBI.

He was speaking to reporters on the sidelines of a function on 'Financial Inclusion Saturation Drive' organized at Gozaria village panchayat in Gujarat's Mehsana district.

Asked about a private bank increasing the minimum balance required for savings accounts, Malhotra said, "The RBI has left it to individual banks to decide on what minimum balance they want to set. Some banks have kept it at Rs 10,000, some have kept Rs 2,000 and some have exempted (customers). It is not in the regulatory domain (of RBI)."

In a recent decision, private lender ICICI Bank increased the minimum balance requirement for those opening new savings accounts from Au-

The minimum average monthly

balance (MAB) has been increased by five times to Rs 50,000 from Rs 10,000 on savings bank account, as per the lender's website.

Similarly, MAB for semi-urban locations and rural locations have been increased five times to Rs 25,000 and Rs 10,000, respectively.

Meanwhile, the State Bank of India has decided not to penalise savings account holders if they do not keep minimum balance.

Traditionally, public sector banks have lower balance requirements compared to private lenders with the requirement waived for Jan Dhan accounts. Several public sector banks have done away with the requirement, and customers who fail to maintain the minimum prescribed balance do not need to pay a penalty.

Speaking at the event, Malhotra said digital literacy was very important to succeed in the new age.

Gold Retreats From All-Time High. Ends Rs 900 Lower At Rs 1,02,520/10g

Gold of 99.5 per cent purity, which also reached the peak of Rs 1,03,000 per 10 grams in the preceding session, declined 900 to Rs 1,02,100 per 10 grams (inclusive of all taxes) on Monday.

In the five sessions until Friday, the yellow metal prices increased by Rs 5,800 per 10 grams.

"Gold resumes trading on a weaker note as the upbeat market mood diminishes demand for traditional safe-haven assets.

"Additionally, a de-escalation in geopolitical tensions, as President Donald Trump agreed to meet Russian President Vladimir Putin in Alaska. later this week to discuss peace efforts surrounding the Russia-Ukraine conflict," Saumil Gandhi, Senior Analyst - Commodities at HDFC Securities, said.

Also, the clarification from the White House regarding a 39 per cent tariff on gold bars exerted downward pressure on gold prices, Gandhi said.

According to the All India Sarafa Association, silver prices depreciated by Rs 1,000 to Rs 1,14,000 per kg (inclusive of all taxes) on Monday. The white metal had ended at Rs 1,15,000 per kg on Friday.

NIA's Death Penalty Plea: Delhi HC Seeks Malik's Response

New Delhi:The Delhi High Court on Monday sought separatist leader Yasin Malik's response on a plea filed by the National Investigation Agency seeking death penalty for him in a terror funding case.

A bench of Justices Vivek Chaudhary and Shalinder Kaur granted four weeks to Malik to file his response to the NIA's petition.

The court posted the hearing for November 10.

Malik, who previously sought to argue in-person against NIA's plea seeking the

enhancement, was supposed to appear virtually from jail but wasn't produced.

The Jammu and Kashmir Liberation Front chief (JKLF) is lodged in Tihar jail where he is serving a life term in the

The high court noted that neither Malik was produced virtually in the proceedings from jail nor he filed his reply to NIA's plea in pursuance to the court's August 9, 2024 order.

On August 9, Malik was directed to be produced virtually and not physically due to security threats.

On Monday, the bench

directed the jail authorities to produce him virtually on November 10.

Malik last year turned down the court's suggestion to appoint a lawyer on his behalf and said he wished to argue the case in-person.

On May 29, 2023, the high court issued notice to Malik on the NIA's plea seeking death penalty.

Subsequently, jail authorities filed an application seeking permission for his virtual appearance on grounds that he was a "very high-risk prisoner" and it was imperative to not physically produce him in court to maintain public order

The request was allowed by

the high court. On May 24, 2022, a trial court sentenced Malik to life imprisonment after holding him guilty for offences under the stringent Unlawful Activities (Prevention) Act (UAPA) and IPC.

and safety.

Malik had pleaded guilty to the charges, including those under the UAPA, and was convicted and sentenced to life imprisonment.

Appealing against the sentence, the NIA emphasised that a terrorist cannot be sentenced life term only because he has pleaded guilty and chosen not to go through trial.

While seeking enhancement of the sentence to death penalty, the NIA said if such dreaded terrorists are not given capital punishment on account of pleading guilty, there would be complete erosion of the sentencing policy and terrorists would have a way out to avoid capital punishment.

The trial court, which rejected the NIA's plea for death penalty, had said the crimes committed by Malik struck at the "heart of the idea of India" and were intended to forcefully secede Jammu and Kashmir from the Union of India.

Police Search Bookshops In Rajouri For 25 Banned Books

Jammu: The Jammu and Kashmir Police on Monday carried out searches at bookshops across Rajouri district to seize the 25 books banned by the Lieutenant Governor's administration in the Union Territory.

"Police carried out extensive searches at multiple locations across the district to trace and seize books that have been recently prohibited by the competent authority," a police officer said. The action was taken to prevent the circulation of the prohibited literature, he said.

The general public, especially bookshop owners, is advised not to buy or sell any of the 25 banned books, he said.

"Anyone found involved in the sale or purchase of these books will be dealt with strictly under the relevant sections of the BNS," he added. The Jammu and Kashmir administration had last week banned the publication of 25 books for "promoting false narratives and glorifying terrorism."

According to an order issued by the Home Department, the books, including those written by famous authors like Moulana Moudadi, Arundhati Roy, A G Noorani, Victoria Schofield, and David Devadas, propagate secessionism in J-K and need to be declared as forfeited in terms of Section 98 of Bharatiya Nagarik Suraksha Sanhita 2023.

is processed, stored too long, or contaminated, it affects the gut microbiome, immunity, and overall health," said Dr. Firdous Mir, a gastroenterologist in Srinagar. "We're seeing more gastric infections, more acidity, more allergies, and diet is a major driver.

A 2023 Directorate of Health Services survey found that 41 percent of urban Kashmiri households consume frozen meat regularly, and more than half have no idea how long it was stored before reaching their kitchens.

The rotten meat scandal has sharpened calls for reform.

Consumer rights advocates want clear dateof-slaughter labels, maximum storage timelines, and random market inspections.

"Without enforceable laws, the dishonest seller will always undercut the honest one,' said Fayaz Sofi, a Srinagar-based advocate.

Organic farmers see the moment as a chance to reset.

"We can feed ourselves without depending on imports," said Parveen Akhtar, who runs a small poultry farm in Budgam. "Modern hygiene can work with our old wisdom: buy fresh, eat in season, trust your source."

Researchers warn the stakes extend beyond public health.

Industrial farming drains groundwater, erodes soil, and pollutes streams in the fragile Himalayan ecosystem. Local sourcing, they say, can ease these pressures while reviving rural livelihoods.

Yet price is a sticking point.

Imported frozen meat can be 20 to 30 percent cheaper. Reformers argue for targeted subsidies for small farmers and public awareness campaigns to make people think about the hidden costs of cheap, low-quality food.

In markets across the valley, the fallout is visible. Foot traffic in some butcher lanes has dropped. Some shoppers now travel long distances to buy from trusted sellers, while others are turning to vegetables and traditional haakh-batte meals.

In downtown Srinagar, 68-year-old Abdul Rahim remembers when a chicken's yolk colour told you what it had been fed.

"Fresh food kept us strong in body and

mind," he said. "Beyond taste, it was dignity." No one knows if the valley will get that dignity back. But the call for fresh food is now louder than the cleavers, carrying a Kashmiri truth: freshness is wellness.

Meanwhile, in a joint operation, the Srinagar Police and the Food Safety Department conducted raids at multiple locations across the city, targeting vendors suspected of selling unhygienic and expired meat products.

An official said, "During the operation, substantial quantities of rotten meat were seized and destroyed on the spot under relevant sections of the Food Safety and Standards Act."

In one such action, Srinagar Police in collaboration with officials of the Food Safety and Standards Association of India (FSSAI) raided cold storage unit in Parimpora where rotten meat was stored, which was seized, subsequently leading to the seizure of the cold storage under relevant section of the Food Safety and Standards Act, they said, adding that the action is part of an intensified drive to safeguard public health and ensure strict adherence to food safety standards.

"Similarly, acting on credible input received at Police Station Zakura, authorities identified Abdul Hameed Kuchay, a resident of Soura and operator of Sunshine Foods located at SICOP Zakoora, as a key suspect. He is alleged to be involved in a criminal conspiracy with Arif Ahmad Shah, of Baghat Barzulla, to supply decomposed meat unfit for consumption in large quantities to restaurants and hotels across Srinagar," Police said.

Police stated that this deliberate act of distributing rotten meat poses a serious threat to public health and constitutes a grave offence under applicable laws.

Consequently, FIR No. 48/2025 has been registered at Police Station Zakura under sections 271, 275, and 61(1) of the Bharatiya Nyaya Sanhita (BNS), and further investigation is underway.

Srinagar Police affirms that inspections and legal action will continue in collaboration with concerned departments in the coming days to ensure strict compliance and accountability across the food supply chain, in the interests of public health and safety

Security forces stormed the deep cave on Monday and searched it thoroughly but there was no trace of the terrorists who are believed to have managed to escape deep inside the forest, the officials said, adding a massive search operation is on to track down and neutralise

About the natural cave, the officials said it was very long and believed to be used by terrorists in the past as their hideout.

The terrorists had established well-fortified positions at different places inside the cave, where wood and other daily-use items were found stored, they said.

The hiding terrorists had opened fire on the search parties at 6.30 AM on Sunday and fled in the face of retaliation by security forces, the officials said, adding that intermittent exchange of fire was reported two more times during the

cordon and search operation was strengthened with the joining of more reinforcements from the army, including para commandos, police and CRPF, and deployment of drones to ensure that the terrorists are not able to escape, the officials said.

They said the firing from the terrorists was last reported near the cave on a cliff Sunday evening, with security forces suspecting that they had managed to take shelter inside

Extensive deployment of police and paramilitary forces has been made along the International Border (IB) and the Line of Control (LoC), with senior officers reviewing arrangements in vulnerable border belts to ensure smooth coordination between agencies, the official added.

To bolster security further, drones and highresolution CCTV cameras have been deployed to monitor key event venues and surrounding areas. Checkpoints have been set up in Srinagar and other district headquarters, particularly at major entry points, with random vehicle checks and frisking to prevent the movement of subversive elements.

Inspector General of Police, Kashmir Vidhi Kumar Birdi today said that multi-tier security arrangements were in place to ensure peaceful Independence Day celebrations.

He said the Jammu and Kashmir Police, along with paramilitary forces, have been deployed in strength to ensure foolproof security for the August 15 celebrations.

Speaking to reporters in Srinagar, Birdi said rehearsal dill preparations are currently underway for the I Day function.

Three days ago IGP, Kashmir had chaired a security review meeting at Police Control Room Kashmir to review the overall security scenario and arrangements regarding the celebration of Independence Day.

The Bill will now go to the Rajya Sabha for approval and thereafter to the President for assent. It will become law once the Presidential assent is provided.

The new bill reduces the size and complexity of the current Income Tax Act, drastically cutting the number of effective sections and chapters and nearly halving the word count.

"Almost all of the recommendations of the Select Committee have been accepted by the Government. In addition, suggestions have been received from stakeholders about changes that would convey the proposed legal meaning more accurately," said the statement of Objects and Reasons of the Income Tax (No.2) Bill.

It does away with the confusing concepts of assessment year and previous year, replacing them with easier to understand 'tax year'.

According to the revised Bill, individuals will be allowed to claim TDS refund even if their return of income is filed beyond the statutory timeline provided for filing of the original income-tax return.

Thus, the Finance Ministry has incorporated the provision of the existing Income Tax Act,

The Income Tax (No.2) Bill provides for 'nil' TCS on Liberalised Remittance Scheme (LRS) remittances for education purposes financed by any financial institutions. Nangia Andersen LLP Partner Sandeep

The present act provides authorised officers to conduct search and seize assets and books of accounts of individuals who may be suspected to have any undisclosed income or documents in order to evade paying tax. This allowed the authority to break the lock on any door, box, or locker if they couldn't find their keys or had cause to believe that any books of accounts or undeclared valuables were being stored there.

In the bill introduced in February, Clause 247 allows tax officers to bypass passwords and access digital platforms like emails and social media during searches if taxpayers refuse cooperation.

It stipulates that an authorised officer, in consequence of information in his possession, has reason to believe, can "break open the lock of any door, box, locker, safe, almirah, or other receptacle for exercising the powers conferred by clause to enter and search any building, place, etc., where the keys thereof or the access to such building, place, etc., is not available, or gain access by overriding the access code to any said computer system, or virtual digital space.

where the access code thereof is not available" This provision had sparked concerns around

The updated bill states that tax authorities can "break open the lock of any door, box, locker, safe, almirah, or other receptacle or override the access code to any computer system ... where the keys thereof are, or the access to such building, place, etc., or the access code to such computer system ... is not available".

While the 'digital space' is missing from the clause, it is included in the definition of computer systems

Tax experts believe that starting April 1, 2026, when the new income tax law comes into force, income tax officials could get the authority to access individuals' digital accounts, such as emails, social media, bank accounts, trading platforms, and online investments, if they suspect tax evasion.

The sections were enacted to ensure that diverse voices, including those from underrepresented communities, could contribute to the legislative process, the MHA said.

Women are not adequately represented in the legislative assembly, it said.

Hence, the LG was empowered to nominate members to address the need for representation of certain communities or groups that may not have adequate electoral representation.

As per the Union government, the Lieutenant Governor has the powers to exercise the duty in his discretion, as a statutory functionary without aid and advice and not as an extension of the government.

The impugned sections serve a critical legislative function by ensuring representation for historically displaced communities and unrepresented persons within the governance structure of the Union territory, it added.

The legislative intent behind these provisions is well-founded in law and equity, ensuring that the voices of these displaced communities are neither ignored nor marginalised in the democratic process, the MHA

As per the affidavit, the Lieutenant Governor of J&K holds executive authority, like the governance model of New Delhi and Puducherry.

Lok Sabha Passes Sports Bill

Minister Calls it Biggest Reform Since Independence

NEW DELHI: The long-awaited National Sports Governance Bill was passed in the Lok Sabha here on Monday with Sports Minister Mansukh Mandaviya describing it as the "single biggest reform in Indian sports since independence" amid opposition protests over revision of electoral rolls in Bihar.

The National Anti-Doping (Amendment) Bill was also passed when the Lok Sabha reassembled at 2 pm after an early adjournment due to opposition

"It is the single biggest reform

in sports since independence. This Bill will ensure accountability, ensure justice, best governance in sports federations," Mandaviya said amid sloganeering by opposition members.

"It will have massive significance in India's sports ecosystem. It is unfortunate that such an important bill and reform does not have the opposition's participation," he added.

The opposition leaders were not present in the house when the Bills were introduced for consideration and passage as most of them were detained while marching towards the Election Commission headquarters against the Special Intensive Revision of electoral rolls in Bihar and alleged voter data fudging.

But after two MPs participated in the consideration debate, speaking in the Bill's support, the opposition members returned to the House and started raising slogans.

Amid the din, the Bills were passed by a voice vote following which the House was adjourned

Earlier, Chairman of the parliamentary committee on sports. Digvijaya Singh, requested Lok Sabha Speaker Om Birla to refer the National Sports Governance Bill to the panel. He felt that the Bill should be examined and discussed before it is taken up by Parliament.

Mandaviya said the two Bills were key reforms aimed at building a "transparent, accountable and world-class sports ecosystem" in India as the country aims to bid for the 2036 Olympics.

"Efforts have been made since 1975 and in 1985, we had the first draft. But sports was also politicised for personal gains. Some ministers made efforts to bring this bill but could not move forward.

"In 2011, we had a National Sports Code. Another effort was made to turn it into a bill. It reached the cabinet, there was a discussion as well but the bill was deferred after that. It did not reach the Parliament," the minister stated while presenting a timeline of the Bill's journey.

"The National Sports Gover-nance Bill is a force of change... Despite being such a large country, our performance at the Olympic Games and on the international stage has not been satisfactory and this Bill aims to build India's sports capacity," he

Fans & Family Honour 'Palestinian Pele' Killed In Gaza

GAZA CITY: The "Pele" of Palestinian soccer hoped to keep scoring goals until he was 50. An Israeli tank shell dashed that dream a decade early, his family said, killing Suleiman al-Obeid as he queued in southern Gaza this week to collect food.

Obeid's widow Doaa al-Obeid now clutches the blue-and-white number 10 shorts he wore for his Gaza club, Al-Shati, one of the only mementos she has of her late husband, as she and her five children mourn the revered 41-year-

"This is the most precious thing left behind by him," she said. The family have few other be-

longings of Obeid, whose home was destroyed in a bombardment earlier this year. They now live in a tent among the ruins of a neighbourhood of Gaza City.

Obeid, likened by fans to Brazilian great Pele for his skills and goalscoring, hit headlines this week after Liverpool forward Mohamed Salah criticized a tribute to Obeid by Europe's governing body UEFA that did not mention the cause of death.

"Can you tell us how he died, where, and why?" wrote Salah.

The Palestinian Football Association said Obeid was killed in an attack by the Israeli military in southern Gaza while waiting to collect aid at a distribution point.

His family said it was a tank



shell that killed him.

Responding to Salah's post on X, an Israeli military spokesperson Nadav Shoshani said: "Hev Mohamed, After an initial review, we found no records of any incidents involving Suleiman al-Obeid. In order to take a closer look, we need more details."

Obeid, who had played for the Palestinian national team, was still playing for his club in Gaza when the war between Israel and Hamas began in October 2023.

Hamas attacked Israeli towns and villages killing more than 1,200 people. Israel in response has laid waste to the Gaza Strip, a coastal enclave housing more than 2 million people, and killed some 61,000 Palestinians.

Most have been killed by airstrikes, artillery and gunfire, but a growing number are starving to 'THIS PLAYER WAS A GAZELLE' Obeid kept playing throughout

the hardship, his widow Doaa said.

"He used to go training every day and never stopped, not a single day. Even during the crisis of war, in the midst of rockets, shelling and mass killing, he would go play. He used to gather his friends and loved ones and go play with them," she said.

Crystal Palace Loses Appeal Against Demotion By UEFA

₹rystal Palace lost its appeal at sport's highest court on Monday against demotion to the third-tier Conference League because of breaching UEFA rules on club ownership with American investor John Textor.

The Court of Arbitration for Sport said its judges dismissed the English cup winner's request to stay in the more lucrative second-tier Europa League in a case that also involved Premier League rival Nottingham Forest and French club

Forest and Lyon are confirmed taking entries directly into the Europa League in September and Palace must start in the Conference League qualifying playoffs round next week.

UEFA demoted Palace because Textor had a 43% ownership stake last season while also owning Lyon. Palace missed a March deadline set by UEFA to solve the potential issue. CAS said its judges decided Textor "was a board

member with decisive influence over both clubs at the time of UEFA's assessment date." (AP)


subsequent attempts to play there also failed. Staging a match abroad has been part of the league's goal of promoting soccer and its brand in
