

Trump-Putin Meeting: Did Alaska Belong To Russia?

Moscow: Alaska, the US state that will host the meeting between Vladimir Putin and Donald Trump on Friday, is a source of imperial nostalgia and often less-than-serious territorial claims in Russia.

The territory that Russia sold to the United States in 1867 is now a symbol of the entwined history of the countries, whose relations have been severely damaged since Russia launched its offensive in Ukraine in 2022.

To some experts, the summit in Alaska evoked memories of the thaw between the Soviet Union and the United States during the Cold War.

"It's a classically orchestrated summit, like in the era of detente," Russian political scientist Fyodor Lukyanov

"Its symbolic significance is the absence of intermediaries: the powers, so to speak, decide for themselves," he added, saying that China is "not close" to Alaska and that Europe is "as far away as possible"

Fur trading hub

But beyond being a unique meeting place, Alaska also fuels Russian memories of the Tsarist empire, the historic predecessor of the Soviet

"For Russia, Alaska symbolises the peak of an expan-Alexander Baunov. senior fellow at the Carnegie Russia Eurasia Centre, said on the centre's website. It was "when the Russian

continental empire had, for the only time, succeeded in crossing an ocean like the European empires", Baunov said. A Russian colony since

the 18th century, Alaska was eventually sold to the United States for \$7.2 million in 1867 by Tsar Alexander II.

The remote territory was economically very difficult for the Russians to exploit and at the time its sale was welcomed by the Imperial Court as the country was struggling economically

But the transaction later came to be seen as a regrettable bargain after what formerly was a fur trading hub turned out to house crucial natural resources: gold and oil.

In recent years, the price at which Alaska was sold, considered by some to be ridiculated as a sidered as a sider lously low, and the legal validity of the transaction have become regularly recurring debates in Russia.

In July 2022, in the midst of patriotic fervour in Russia and as tensions soared between Moscow and Washington following the offensive against Ukraine, the Alaska issue resurfaced.

The speaker of the Duma, the lower house of the Russian Parliament, Vyacheslav Volodin, spoke of "lands to be returned", describing Alaska as a "disputed territory".

Russia's authorities are apparently not interested in reclaiming it.



Millions Converge in Karbala to Mark Arbaeen

Najaf: Millions of Muslims from across the world have converged in the holy Iraqi city of Karbala to mark Arba'een, the 40th day after the martyrdom anniversary of Imam Hussein (AS), the third Imam and the grandson of Prophet Mohammad (PBUH).

They moved toward Karbala on foot from different directions and descended upon the shrine of Imam Hussein (AS) to commemorate

Along the routes, thousands of Moukebs, or volunteer service stations, offer free food, water, medical care, and rest to pilgrims.

The Arbaeen march is one of the largest annual religious congregations in the world, where the participants pay tribute to martyred imam, who is the all-time icon of fighting injustice, oppression, and despotism.

Gaza's Young Musicians Sing And Play In The Ruins Of War

GAZA CITY: A boy's lilting song filled the tent in Gaza City, above an instrumental melody and backing singers' quiet harmonies, soft music that floated into streets these days more attuned to the deadly beat of bombs and bullets.

The young students were taking part in a lesson given on August 4 by teachers from the Edward Said National Conservatory of Music, who have continued classes from displacement camps and shattered buildings even after Israel's bombardments forced them to abandon the school's main building in the city.

"When I play I feel like I'm flying away," said Rifan Al-Qassas, 15, who started learning the oud, an Arab lute, when she was nine. She hopes to one day play abroad.

"Music gives me hope and eases my fear," she said.

Al-Qassas hopes to one day play abroad, she said during a weekend class at the heavily shelled Gaza College, a school in Gaza City. Israel's military again pounded parts of the city on August 12, with more than 120 people killed over the past few days, Gazan health authorities say.

The conservatory founded in the West Bank and had been a cultural lifeline for Gaza ever since it opened a branch there 13 years ago, teaching classical music along with popular genres, until Israel launched its war on the Mediterranean enclave in response to the October 7. 2023 Hamas attacks.

Before the fighting, Israel sometimes granted the best students exit permits to travel outside Gaza to play in the Palestine Youth Orchestra. the conservatory's touring ensemble. Others performed inside Gaza, giving concerts in both Arabic and Western traditions.

After 22 months of bombardment, some of the students are now dead, said Suhail Khoury, the conservatory's president, including 14-year-old violinist Lubna Alvaan, killed along with her family early in the war.

Man Beaten To Death By 10 Men For Chatting With Girl, Four Held

Mumbai :A 20-year-old man was allegedly beaten to death by 10 persons in Jalgaon district of Maharashtra after they spotted him chatting with a girl in Jalgaon district of Maharashtra, leading to the arrest of four individuals, police said on Wednesday.

Police suspect an old enmity led to the murder of Suleiman Khan, who was preparing for the police recruitment exam.

The four accused were produced before a local court, which remanded them in police custody even as a search for the mastermind of the crime is underway.

Khan, a resident of Betawad Khurd village, had gone to Jamner to fill the form for a police recruitment exam on Monday. He was chatting with a girl in a cafe when 10 individuals confronted him and started beating him, a police official said.

The attackers forced Khan to accompany them to his village, where he was assaulted with sticks and iron rods at the bus stand, he

When Khan's family members tried to break up the fight, they were also beaten up. Khan was rushed to a hospital, where doctors declared him dead, the official said.

The incident created tension in Jamner, leading to the deployment of a posse of police

personnel in sensitive areas. Khan's relatives and locals gathered at Jamner police station on Monday night, demanding the immediate arrest of the culprits and stringent action.

A case was registered under various sections of the Bharatiya Nyay Sanhita (BNS) for kidnapping, rioting, and murder.

"Prima facie, an old enmity between two groups is the cause behind the incident. We are investigating the case from various angles," the official said.

'Incidents Like Pahalgam **Cannot Be Ignored'**

SC Seeks Centre's Reply On Plea For J&K Statehood

NEW DELHI: The Supreme Court on Thursday sought a response from the Centre on a plea seeking the restoration of statehood to Jammu and Kashmir, saying ground realities, including the recent Pahalgam incident cannot be ignored.

"You also have to take into consideration the ground realities... you cannot ignore what has happened in Pahalgam," CJI B R Gavai said when counsel including senior advocate Gopal Sankaranarayanan sought an early hearing.

The bench also comprised Justice K Vinod Chandran.

Solicitor General Tushar Mehta, appearing for the Centre, sought dismissal of the plea and said in the past too, the court had imposed costs on such pleas.

"Elections are held, my lords are aware of the peculiar position emerging from this part of the country and there are several considerations which go into decision-making," Mehta said.

The bench posted the plea, filed by academician Zahoor Ahmad Bhat and socio-political activist Ahmad Malik, for hearing after eight weeks.

Sankarnarayanan, appearing for Bhat, said it had been 21 months since that judgment was passed by the Constitution bench on issues including the abrogation of Article 370 of the Constitution. "There has been no movement partly because, my lords fairly trusted the Union when they made this statement before the court that they will implement the statehood," Sankarnarayanan said.

Referring to the judgment, he said the bench did not address the issue in view of the assurance given by the solicitor general that the statehood to Jammu and kashmir will be restored.

Sankaranarayanan said the bench had merely directed that restoration of statehood at the earliest and did not set any timeline.

On December 11, 2023, the Supreme Court unanimously upheld the revocation of Article 370,

which accorded a special status to the erstwhile state of Jammu and Kashmir, even as it ordered that assembly elections be held in the union territory by September 2024 and its statehood be restored "at the earliest".

Last year, a plea was filed in the top court seeking directions to the Centre for the restoration of statehood to Jammu and Kashmir within two months.

"Delay in the restoration of statehood would cause serious reduction of democratically elected government in Jammu and Kashmir, causing a grave violation of the idea of federalism which forms part of the basic structure of the Constitution of India," Bhat's plea said.

The assembly elections and the Lok Sabha polls were conducted peacefully in Jammu and Kashmir without any incident of violence, disturbance or any security concerns being reported, it said.

Therefore, there is no impediment of security concerns, violence or any other disturbances which would hinder or prevent the grant/restoration of the status of statehood to Jammu and Kashmir as had been assured by the Union of India in the present proceedings," the plea added.

The non-restoration of the status of statehood of Jammu and Kashmir, the plea said, would result in a lesser form of elected democratic government to the state, particularly given legislative assembly results were declared on October 8, 2024.

Despite the apex court's directions for the restoration of statehood to Jammu and Kashmir "at the earliest and as soon as possible", the Centre took no steps to provide any timeline for the implementation of such directions, it claimed.

"Jammu and Kashmir is being operated as a Union Territory for a period of almost five years now, which has caused many impediments and grave losses to the development of Jammu and Kashmir and has affected the democratic rights of its citizens," the plea added.

HC Grants Petitioner Time To File Rejoinder

SRINAGAR: The High Court of extension of the government. kh on Thursday granted the petitioner time to file a rejoinder to the Ministry of Home Affairs' (MHA) affidavit on the nomination of five members to the J&K Assembly, before the next hear-

ing on September 26. In its affidavit, the MHA said the powers vested in the Lieutenant Governor (LG) to nominate five members to the legislative assembly were essential for ensuring inclusivity and adequate representation of all communities. It maintained that the LG's powers were discretionary, could be exercised without the aid and advice of the council of ministers, and that the LG's office was not an

sponse to a plea by Congress leader Ravinder Sharma challenging the constitutional validity of sections 15, 15-A and 15-B of the Jammu & Kashmir Reorganisation Act, which allow the LG to nominate five members to the assembly beyond its sanctioned strength.

As the division bench of Justice Sanjeev Kumar and Justice Rajesh Sekhri took up the matter, the petitioner sought time to file a rejoinder to the objections filed by the respondents. The court accepted the request and fixed the next hearing for September 26.

79th Independence Day: 3-tier Security In Place In J&K

SRINAGAR: Jammu and Kashmir is set to celebrate the 79th Independence Day under a three-tier security cover on Friday.

Officials said that the main official event in Kashmir will be held at Bakshi Stadium in Srinagar, while M A Stadium will host the central function in Jammu.

Celebrations are scheduled at all district and block headquarters, government offices, and educational institutions, they said, adding that public representatives, Deputy Commissioners, and members of Panchayati Raj Institutions will hoist the national flag at various administrative levels, including sub-districts, tehsils, and panchayats.

To ensure the smooth conduct of the events, authorities have implemented heightened security across the Union Territory.

A senior police officer said that both manpower and technology will be deployed to prevent any untoward incidents.

High-rise buildings around the main venues in Srinagar and Jammu have been secured by sharpshooters from the Police. CRPF and other forces, he said. The officials said that these

locations remain under constant observation, with drone surveillance being carried out to monitor the ground situation.

In Srinagar, detailed checks



and identity verifications are being conducted on roads and highways, the officials added.

Security forces are carrying out random frisking of commuters and vehicles. Similar arrangements have been made in Jammu, where multiple security layers are in place at key points.

Officials in Jammu said coordination between various security agencies is ongoing to maintain order. People have been urged to cooperate with security personnel for the safety of all.

Security has also been stepped up in border areas, particularly in North Kashmir sectors like Gurez, Uri, Karnah, and Tangdhar, as well as in the Sunderbani sector of Jammu. Along the International Bor-

der in Jammu, BSF personnel are conducting regular patrols and using digital surveillance tools to maintain constant vigilance.

The officials said surveillance and patrolling along the Line of Control (LoC) have been intensified. Forces remain on alert to respond to any infiltration attempts or ceasefire violations.

The Army has employed smart fencing and robotic surveillance systems in difficult terrains to ensure continuous monitoring.

Quadcopters and drones with night vision and high-resolution capabilities are being used to gather real-time intelligence. Troops have access to bullet-

proof and all-terrain vehicles for quick movement in mountainous regions.

Security personnel are also undergoing training exercises simulating potential threats to improve operational preparedness.

The officials have appealed to the public to participate in the Independence Day events and assured them that all necessary arrangements are in place for their safety. (KNO)

HC Chides Govt For Not Holding Regular DPCs

Uphold CAT Order On Removing Director Family Welfare

SRINAGAR: The failure of government to convene DPC on regular basis and make promotions in time has created a situation where not even a single candidate in the service is eligible to hold the post of Director Family Welfare, MCH & Immunization, J&K, the High Court of J&K and Ladakh has said.

The Court made the observations while upholding the Central Administrative Tribunal's order, underlining Dr Mushtaq Ahmad Rather could not have been assigned the additional charge of the post of Director, Family Welfare, MCH & Immunization, J&K.

The Tribunal had quashed the Government Order dated 23 December 2024 and had directed the Government to assign the charge of the post of Director, Family Welfare, MCH & Immunization J&K to the senior most and eligible member of the J&K Health & Family Welfare (Gazetted) Service.

"The petitioner(Dr Mushtaq Ahmad Rather), who belongs to a different service and does not fall in the feeding cadre to the post of Director in question, is absolutely not eligible to hold the post even in officiating capacity," a bench of Justice Sanjeev Kumar and Justice Sanjay Parihar said while dismissing Rather's plea against the CAT.

"We understand the difficulty respondent No.2 (Health and Medical Education Department) may be facing in posting an eligible person under the Rules as Director, Family Welfare, MCH & Immunization but that does not give absolute discretion to respondent No.2 to pick up any person from any service and impose it on the Health and Family Welfare (Gazetted) Service."

If for some reasons beyond the control of Health and Medical Education Department, the court said, the working of the office of Director, Family Welfare, MCH and Immunization is required to be carried out by giving temporary charge to an ineligible person, "it would be in the fitness of the things to pick up such person from within the service."

"We can visualize that this dif-

ficulty has arisen because of failure of respondent No.2 to convene the meetings of DPC/PSC for making regular promotions in different gazette cadres of the service periodically," the Bench said, adding, "This failure of respondent No.2 to convene DPC on regular basis and make promotions in time has created a situation where not even a single candidate in the service is eligible to hold the post of Director."

In such a situation, the court said, the Government may be justified in giving temporary charge of the post even to an ineligible person.

"We, however, fail to understand that when the Government has picked up an ineligible person to manage the post of Director, Family Welfare, MCH & Immunization, why it could not do so by picking up such person from within the service," the court said, adding, "May be on officiating posts, there are candidates including respondent No.1 (Dr. Poonam Sethi), who is holding the post of ADMO Labour/ Deputy Director (Schemes) since 2023. These officers like respondent No.1, who have now reached to the level of Deputy Director, have long experience of decades at their back to run the administration in different capacities in the department of Health and Family Welfare."

The petitioner (Dr Rather), the court said, is already holding the position in the Department of Medical Education and, therefore, "importing" him to the department of Health and Family Welfare smacks of an act of favouritism, the court said.

"We are well aware that ordinarily a person who himself is not eligible to hold the post cannot throw challenge to the appointment of another candidate," the court said, adding, "However, in a case where one ineligible person is ignored at the cost of another ineligible person without reasonable basis or rationale, ineligible person, who has been ignored, can raise his voice and approach the Court to find out the reasons for his/her exclusion and rue the inclusion of another ineligible candidate that, too, who does not even belong to

Flash Floods Hit Multiple Areas In Kashmir

MeT Forecasts More Rains, Landslides

SRINAGAR: Flash floods occurred in several locations across Kashmir on Thursday, while intermittent light rains continued in other parts, including Srinagar, the summer capital of Jammu & Kashmir. The ongoing rainfall has contributed to a dip in temperatures across the valley.

According to reports, flash floods affected areas such as Kawcherwan and Kangan, Gund, Sumbal, Frislan, and Batkoot in Pahalgam, Qazi Nallah in Karnah, Ichoo Nallah in Kokernag, and others.

Independent weather foreaster Faizan Arif Keng confirmed these incidents, saying a massive flash flood occurred in the Saspol area of Leh along the Srinagar-Leh National Highway.

The water level in Sheshnag Nallah and Betaab Valley exceeded the danger mark today, reaching 5.23 feet, which is above the critical level of 5.09 feet, raising concerns of potential flooding nearby.

Authorities have advised residents to stay away from rivers and streams as a precaution. Keng said that "nothing alarming" is currently happening, as the surge appears localised and is being moni-



tored continuously. He urged caution but assured there is no immediate threat.

Meteorological officials said that with vigilance and timely alerts, the situation remains under control. Water levels are under close watch, and rescue teams are on standby in case of emergencies, they said.

Rainfall persisted intermittently throughout the day in Srinagar and other parts of Kashmir. The IMD's detailed report states that Pahalgam received 33.6 mm of rain, Gulmarg recorded the highest with 47.2 mm by 5:30 PM. Srinagar saw 1.5 mm; Qazigund 0.4 mm; Kupwara 1.8 mm; and Kokernag 0.4 mm.

The weather forecast predicts light to moderate rain thunderstorms across many areas of Jammu division until tomorrow, with isolated

heavy rainfall expected in Reasi, Udhampur, Jammu, Samba, Kathua, Doda, Kishtwar, Poonch, Rajouri, and Ramban. Some parts of Kashmir may experience brief, intense

showers and gusty winds. The IMD further foreca generally hot and humid weather with brief showers on August 16, followed by continued light to moderate rain and thunderstorms in many places on August 17 and 18, with heavier rainfall in parts of Jammu division.

An official advisory warns of the possibility of heavy to very heavy rainfall, thunderstorms, landslides, mudslides, and shooting stones in vulnerable areas until tomorrow. Residents have been advised to stay away from water bodies, river embankments, and loose structures to avoid accidents.

Shia Association Defies Kashmir Grand Mufti Summons

SRINAGAR: A fresh row has erupted in Kashmir after the J&K Shia Association, led by Molvi Imran Reza Ansari, outrightly rejected a summons issued by the Office of Kashmir's Grand Mufti, declaring that the body has no rightful authority over Shia religious

The Association reaffirmed that it would not appear in any proceedings initiated by the Mufti's office, framing its refusal as a principled stance aimed at safeguarding core beliefs rather than an act of evasion.

The controversy began after remarks by Imran Reza Ansari drew strong public reaction and widespread social media debate. In response, the Muttahida Majlis-e-Ulama (MMU) — the umbrella body of major Sunni and Shia religious organisations in J&K – convened a meeting on July 15 to address the issue.

Chaired by Mirwaiz Umar Farooq, the MMU unanimously reaffirmed that the sanctity of the Sahaba the revered companions of Prophet Muhammad (Pbuh) - and the Ahl al-Bayt — the Prophet's noble family is a foundational belief shared by all Muslims.



"Differences in theology must never become an excuse for disrespect," the Majlis said, warning that unity built on centuries of coexistence in Kashmir is a moral and religious obligation. The MMU welcomed the public stance of senior Shia clerics distancing themselves from Ansari's comments, emphasising that such views were personal and contrary to the guidance of top Shia Maraji, who forbid any disparagement of Sunni sacred figures.

To ensure accountability, the MMU resolved to constitute a panel under Grand Mufti Nasir-ul-Islam to summon Ansari for clarification on August 13 and to also question others accused of derogatory remarks towards the Ahl al-Bayt.

However, cracks appeared soon after the MMU resolution. Three senior Shia leaders - Agha Syed Hassan Al-Moosvi, Agha Syed Muhammad Hadi Al-Moosvi, and Maulana Masroor Abbas Ansari — issued a joint statement rejecting a subsequent press conference by the Grand Mufti. They accused him of making a "unilateral" and "fabricated" statement that deviated from the council's joint resolution.

Reaffirming their commitment to the agreed position of mutual respect between sects, they cited edicts from Shia authorities prohibiting derogatory speech against Sunni sacred figures, particularly the Rightly Guided Caliphs. They also criticised what

they saw as the Mufti's endorsement of a historically controversial figure and stressed the need to protect Kashmir's centuries-old inter-sect

SHIA ASSOCIATION REFUSES SUMMONS

Against this backdrop, on Thursday the J&K Shia Association issued a defiant statement refusing to appear before the Grand Mufti's panel. The Association declared that the Mufti's office had "no rightful authority over Shia religious matters" and that its stance was rooted in the protection of its core beliefs, not in evasion.

The Association accused the Mufti's office of "selective engagement."

"What is even more troubling is the selective vocality of the Office of the Grand Mufti – prompt in addressing certain matters, yet conspicuously silent when Hazrat Abu Talib (a) was maligned from the pulpit. This inconsistency raises questions not merely of principle but of motive," it alleged.

The statement also expressed disappointment at the stance of senior Shia clerics Aga Syed Hassan Al-Moosvi and Aga Syed Hadi, who, it claimed, despite having the same beliefs, have on multiple occasions aligned themselves with the Office of the Grand Mufti.

bouring country as an area warranting scrutiny. "Given these patterns, one is compelled to inquire whether such actions are driven by external influences, particularly in light of the evident ideological inclinations and political leanings towards a neighbouring country. The possibility of such external orchestration cannot be dismissed without due scrutiny,"

Underscoring its position, the Association added: "Our responsibility is to safeguard the beliefs that define us. No political convenience or external pressure can compel us to dilute our faith. We will continue to stand firm against any attempt to undermine our religious identity."

MMU Panel Slams Imran Ansari for Dodging Clarification Meeting

SRINAGAR — A panel of the Muttahida Majlis-e-Ulama (MMU) Jammu & Kashmir has sharply criticised Molvi Imran Raza Ansari for failing to attend a meeting convened to seek clarification over his alleged offensive remarks about revered Islamic figures.

The panel, chaired by Grand Mufti Nasir-ul-Islam, said Imran Ansari's absence showed a lack of willingness to engage in dialogue and reinforced perceptions that his statements were deliberate and provocative.

The meeting, held on Wednesday, brought together prominent scholars including Mufti Nazir Ahmad Oasmi, Aga Sved Mohammad Hadi Al-Moosavi, Mufti Mohammad Yaqoob Baba Al-Madani, and Aga Mujtaba Al-Moosavi. It followed the MMU's July 16 decision to investigate remarks attributed to Imran Ansari and certain other preachers from the Ahl-e-Sunnat wal Jamaat, as well as derogatory social media posts targeting the Sahaba (RA) and the Ahl al-Bayt (AS).

Panel members expressed "deep disappointment" over Imran Ansari's refusal to attend despite a formal request, terming it "unbecoming of a public figure" and "especially inappropriate" for someone claiming religious responsibilities. They condemned his conduct and reaffirmed the MMU's uncompromising stance against any disrespect towards the Sahaba or Ahl al-Bayt, stressing that mutual respect and unity among Muslims in Jammu & Kashmir is a religious and moral obligation.

Silencing The Gaza Witnesses

he recent killing of five Al Jazeera journalists, including the widely known correspondent Anas al-Sharif, in an Israeli strike near Gaza City's Al-Shifa Hospital is more than another grim statistic in a war that has already claimed thousands of lives. It is a direct assault on the principle that journalists as civilians and chroniclers of truth must never be targeted. Israel insists al-Sharif was a Hamas operative posing as a journalist, but has yet to produce evidence that would withstand independent scrutiny. It has become the familiar pattern with Israel: accuse Hamas of sheltering among residential neighbourhoods to justify killing civilians. And to accuse journalists of being Hamas sympathisers to justify their killing. This is something that has also been highlighted by the Committee to Protect Journalists.

According to UNESCO, at least 62 journalists and media workers killed in the line of duty in Palestine, excluding deaths in circumstances unrelated to their work, while OHCHR reports that at least 242 Palestinian journalists have been killed in the same time frame.

Is the world doing anything about this? Yes, by issuing condemnation statements, calling for investigation and issuing calls for restraint. But actually doing little to avert daily massacres of innocent people including those of journalists and taking steps to bring to an end this horrible war. The result is that the war is grinding on, exacting daily toll on Palestinians who are living under famine-like conditions.

What is required is not just another temporary ceasefire, soon to be broken by the next provocation or retaliation, but a sustained, enforceable political effort to address the root causes of this endless conflict. We need a serious global effort to not only stop the war whichwill complete two years in next two months, but work actively towards a lasting resolution to lingering israel-palestine conflict. It also means holding Israel accountable for indiscriminate attacks, for violations of humanitarian law, and for systematic genocide of Palestinians and attempts tp ethnically cleanse them from their land.

That said, the deaths of al-Sharif and his colleagues should force the global community to confront an uncomfortable reality: Journalists are dying not as collateral damage but in targeted strikes on clearly marked press sites. If this is allowed to pass without consequence, it will signal to every combatant in every future conflict that truth-telling is fair game. To merely mourn their deaths is to guarantee more will follow. The world therefore must act to not only to stop the current bloodshed, but to resolve the larger conflict that makes such tragedies inevitable.

Crossing Srinagar: The Daily Gamble of City Streets

very morning on my way to the office, I see the same worrying sight. Patients and their attendants, sometimes with small children, dart across the Bypass near the Children's Hospital and JVC Bemina. With no zebra crossing or pedestrian signal, every step feels risky. Cars and bikes speed by, leaving almost no margin for error.

The government deserves credit for moving hospitals from crowded city centers to the outskirts. The idea makes sense. It eases congestion and gives hospitals more space.

On the roads, however, the reality is harsh. Unsafe streets, traffic bottlenecks, and missing basic safety measures make the journey to these hospitals dangerous. A modern building matters little if people risk their lives just to reach it.

Simple interventions could save lives: marked pedestrian crossings, working traffic signals, and strict speed limits. Public health facilities need safe access as much as they need good infrastructure.

Urban traffic planning cannot be reactive. Signposts, footpaths, traffic lights, and pedestrian subways should be standard, not optional. Policies must be guided by evidence, foresight, and accountability.

These measures are mandatory as Srinagar's streets are becoming increasingly hazardous. Weak enforcement, reckless driving, and absent pedestrian infrastructure turn the city into a hazard zone. Zebra crossings fade into the asphalt, parking is scarce, and enforcement sometimes encourages bribery instead of compliance. Fines alone won't change behaviour. Education,

infrastructure, and enforcement must work together.

Commercial drivers, especially tippers and Tata Mobile operators, need mandatory training. Underage driving is common, and risky two-wheeler stunts spike in winter. Restricting teenage riders during peak accident months could prevent injuries. Overloaded vehicles worsen congestion, damage roads, and endanger lives. Temporary suspension of licenses, rather than fines.

may be more effective.

City roads are filling up faster than they can be expanded. Widening roads, building flyovers, enforcing one-way streets, and integrating modern public transport can ease pressure.

Schools, colleges, and government offices concentrated in central Srinagar should gradually shift to suburban areas. During peak hours, traffic personnel near schools and colleges can make movement safer for students and parents.

Srinagar needs a holistic traffic plan. Urban planning, civic education, smart infrastructure, and strict enforcement must work together.

Moving from chaos to order is possible, but it requires effort from the government, civil society, and every road user.

Every pedestrian crossing, traffic light, and road sign matters. The city's streets should not be a daily gamble. They should be a promise of safety and shared responsibility.

ike many Kashmiris, I love food with curiosity, nostalgia, and unapologetic **⊿**indulgence.

Walking through Srinagar's old city, I still catch the smoky aroma of sizzling kebabs, the earthy scent of Goshtab simmering in copper pots, and the warm fragrance of freshly baked naan.

These streets are alive with food, each restaurant and stall a thread in the fabric of our culture and history.

For years, many young people turned to the food trade, drawn by the promise of steady work and an apparently easy path.

Then came delivery apps: a few taps, and a plate of biryani, a tray of kebabs, or fried fish would appear at your door.

We ate with ease, trusting that someone somewhere had ensured the food was safe. Last week, that trust broke.

Social media was flooded with reports of frozen, spoiled, and substandard meat seized from Srinagar restaurants. Food safety authorities finally acted: raiding kitchens, questioning owners, and penalising eateries that ignored basic hygiene.

Seeing the faces behind these businesses, people we'd trusted, caught in the act of putting public health at risk was shocking. It's easy to point fingers, but I can't help

thinking about the years before this week. We relished the same restaurants, the same kebabs and Rista, the same frozen

chicken and fish. How often did we pause

to ask if it was safe? Hospitals now report rising cases of food poisoning, stomach infections, and gut problems. The truth is, bacterial toxins grow slowly in improperly stored meat and fish.

For years, many of us have been eating food that might have harmed us. Better late than never, I tell myself. This is a wake-up call for anyone who enjoys

Dining should still be a pleasure, but it comes with responsibility. Watch the kitchen, the counters, the cooks. Ask about ingredients, storage times, and refrigeration. Consumers in Kashmir, and everywhere,

deserve this knowledge. Processed foods carry the highest risk. Non-vegetarian dishes are often stored for days, sometimes weeks. If temperatures slip or storage is prolonged, a delicacy can quickly become dangerous.

Bacteria grow silently and relentlessly, causing everything from mild food poisoning to serious infections.

Our love for taste, convenience, and tradition has too often blinded us to this danger. I've started eating differently now. I savor food with attention, tasting with both **EATING DIFFERENTLY NOW. I SAVOR FOOD** WITH ATTENTION,

tasting with both tongue and mind. Health has become a choice, not an expectation. Homecooked meals are safer, yes, but even when eating out, vigilance makes a big difference.

Why Millions Still Walk for Hussain

Forty days after Ashura, the road to Karbala becomes a living testament to Hussain's stand.

Some moments in history do not fade. They live on in memory, faith, and conscience.

The stand of Imam Hussain (A.S) on the plains of Karbala is one such moment. It was a battle fought with moral convic-

tion, spiritual clarity, and an unshakable refusal to accept oppression. Forty days after Ashura, the day of that

great tragedy, comes Arbaeen. It is a time when millions across the world pause to remember, mourn, and renew their pledge to the values Hussain lived and died for. Arbaeen is a mirror we hold to ourselves.

Voice Tone, Clarity May Help Detect Early Laryngeal Cancer: Study

Researchers have found that voice features in recordings -- such as tone, pitch and clarity -- could help detect early warning signs of cancer of the larynx (voice box).

Findings published in the journal Frontiers in Digital Health could help in developing artificial intelligence (AI) models for detecting abnormalities, or 'lesions', in vocal folds from the sound of a voice -- lesions may be benign, but could also represent early stages of laryngeal cancer, the researchers said.

Current diagnostic procedures, such as endoscopies and biopsies, are invasive, they added.

"Here we show that with this dataset (of voice recordings) we could use vocal biomarkers to distinguish voices from patients with vocal fold lesions from those without such lesions," said author Dr Phillip Jenkins, a postdoctoral fellow in clinical informatics at Oregon Health and Science University, US.

The team analysed tone, pitch, volume, and clarity of over 12,500 voice recordings of 306 participants, taken from the publicly available 'Bridge2AI-Voice' dataset.

"Among the overall sample, significant differences were identified in HNR (harmonic-to-noise ratio) and fundamental frequency between benign lesions and both healthy controls and laryngeal cancer," the authors



wrote. A 'harmonic-to-noise' ratio, or 'clarity', measures the amount of noise in a voice signal.

While marked differences in voice features were found between men

having benign lesions in vocal folds, and those with laryngeal cancer, the researchers could not find distinct acoustic features among women's

It is possible that a larger dataset would reveal such differences, they

Changes in the harmonic-to-noise ratio can be helpful in monitoring how lesions in vocal folds evolve over time and detecting laryngeal cancer at an early stage, at least in men, the researchers said.

"Our results suggest that ethically sourced, large, multi-institutional datasets like Bridge2AI-Voice could soon help make our voice a practical biomarker for cancer risk in clinical care," said Dr Jenkins.

The team is looking to train the AI model on larger datasets of voice recordings and test it among men and women.

NIT Rourkela **Decodes Sugar** Molecules, **Protein Complex** To Boost Bone Regeneration Tech

esearchers at the National Institute of Technology (NIT), Rourkela have uncovered how natural sugar-like molecules in the human body can alter the behaviour of Bone Morphogenetic Protein-2 (BMP-2), a protein responsible for bone formation and repair, according to officials.

Published in the prestigious journal Biochemistry, the findings of this research can be used for advanced treatments in bone and cartilage regeneration, improved implants and more effective proteinbased medicines.

According to Harekrushna Sahoo, Associate Professor, NIT, Rourkela, proteins carry out various functions in the human body -- from building tissues and supporting chemical reactions to acting as signals between cells.

However, for the best productivity, they need to be folded or unfolded into precise three-dimensional shapes. Understanding why and how proteins unfold is a major goal in biology, with implications for medicine, biotechnology and drug delivery.

"In this context, BMP-2 plays a crucial role in forming bones and cartilage, healing injuries and guiding stem cells to become bone-forming cells. However, in the human body, this protein interacts with different Glycosaminoglycans (GAGs), special sugar-like molecules found in connective tissues and joint fluids," Sahoo said.

The team observed that BMP-2 unfolded faster in the presence of Sulfated Hyaluronic Acid (SHA), a type of GAG, compared to regular Hyaluronic Acid or without additives. The researchers found that SHA binds directly to BMP-2 protein, gently altering its structure and making it unfold in a more controlled manner.

"BMP-2 is a critical protein in humans that plays a fundamental role in osteogenesis and bone regeneration. Our study reveals how specific GAG-BMP-2 interactions influence unfolding dynamics and structural stability. These insights allow scaffold designs to actively preserve BMP-2's functional conformation, prolong bioactivity, lower dosage needs and reduce side effects.

"Furthermore, the work offers a mechanistic basis for tailoring GAG functional group modifications to modulate protein structure and activity, guiding next-generation pharmaceutical formulation," he said.

Feeding Kids Can Be A Daily Battle. But You Wouldn't Know It Looking At Instagram

any families find feeding children a constant challenge. A favourite food is suddenly refused, someone is grumpy after a long day, siblings fight at the table.

But if parents and caregivers are turning to social media for advice, it may do more harm than good. Because here, feeding kids looks downright easy.

Our new research found Instagram is flooded with highly polished content that can perpetuate unrealistic standards of mealtimes. This could be adding to the frustration and guilt many caregivers already face.

We know parents face many pressures when it comes to feeding their kids, but little is known about how social media may be contributing to these pressures.

To find out how family meals are portrayed on social media, we looked at a popular platform, Instagram. With about 2 billion users, Instagram proffers a seemingly endless carousel of images and videos related to food, cooking and eating.

For our study, we downloaded the top posts from the hashtags #familymeals #familybreakfast, #familylunch and #familydinner every week for 14 weeks from February to May 2024, to analyse what was being posted.

Lots of 'meals on a plate'

Unsurprisingly, most posts depicted food and drink, typically meals on a plate, the cooking process, or step-by-step recipe instructions.

Many posts included "healthy foods" from the five core food groups. Interestingly, #familybreakfast contained the most "unhealthy foods", such as pancakes, waffles and big fry-ups.

But few posts promoted realistic, everyday family meals. Most images depicted highly polished and staged kitchens, plated foods and mealtimes.

To meet the ethics approval for our research, we are not able to publicly share the posts in our study. But below are images similar to those we found

Where's the mess?

It was rare to see posts with a toddler hanging off mum's leg while she cooked, or a kid getting cranky because they are hungry. We didn't see many kitchen benchtops with scattered ingredients, or plated food with sauce around the edges.

In reality, family meals are often made in a rush, squeezed between daycare pickups, sports training, work and school, Caregivers often describe mealtimes as messy, chaotic and noisy.

Image captions often contained reci-

pes described as "quick", "easy" or "family-friendly".

However, there were few posts with families actually eating these meals together - which makes us question how "easy"

these meals might actually be. "easy" recipe posts also assume life always goes to plan, kids help set the table and want to eat what has been prepared (sometimes a simple meal of baked beans on toast can still result in chaos).

Few posts depicted people - they were more about the "perfect" food. Where they did, it was usually a woman or mother.

or fathers, and children were rarely depicted. The majority of family mealtime content was also posted by women and mothers. This messaging may further reinforce outdated gender roles and division of foodrelated labour.

What do parents need to keep in mind?

Instagram may offer caregivers quick, easy and family-friendly meal ideas. But it's important to remember not everything you see on social media is real.

Algorithms favour popular content, and as a visual platform, Instagram posts are often picture-perfect and aesthetically pleasing. Messy kitchens and chaotic mealtimes do not make for visually appealing content.

So try not to compare your meals to the curated content and perfect dishes you see on social media. It is unlikely this is how a

family cooks or eats every day. Food content may also be professionally filmed or photographed.

What works for one family may not work for yours. If you see a new recipe or idea, give it a try. But don't be discouraged if it doesn't work out. It can take up to ten exposures to a new food for a child to even agree to taste it, and some children are more adventurous eaters than others.

Also remember, healthy meals don't need to be complicated. Look out for simple recipes with plenty of vegetables.

Mealtimes also do not need to look perfect to be healthy and enjoyable.

Post about real life

To promote more realistic, relatable social media content, we need to start posting it. Sharing images or videos of everyday dishes and family meals may support other parents to feel more comfortable and less guilty about their own mealtimes.

We know many men and dads are involved in family mealtimes. Sharing these moments may also help other men feel more comfortable getting into the kitchen.

Promoting gender diversity and real-life mealtimes on social media can help shift family mealtime norms, including easing some of the burden of feeding families that often falls on women and mothers

WPI Inflation Declines To 2-Year Low Of (-) 0.58% In July

NEW DELHI- Wholesale price inflation declined to a 2-year low of (-) 0.58 per cent in July, as deflation in food and fuel kept WPI in the negative zone for the second consecutive month, government data released on Thursday showed.

Experts, however, projected WPI inflation to move back into positive territory in August, as base effects fade and seasonal price increases continue.

WPI-based inflation was 2.10 per cent in July last year, and (-) 0.13 per cent in June.

"Negative rate of inflation in July 2025 is primarily due to a decrease in prices of food articles, mineral oils, crude petroleum & natural gas, manufacture of basic metals, etc," the industry ministry said in a statement.

According to WPI data, deflation in food articles widened to 6.29 per cent in July, as against a deflation of 3.75 per cent in June, with vegetables witnessing a sharp drop.

Deflation in vegetables was 28.96 per cent in July, compared to 22.65 per cent in June. Fuel and power saw a negative inflation or deflation of 2.43 per cent in July, as against 2.65 per cent in June.

In the case of manufactured products, inflation was higher at 2.05 per cent in July, as against 1.97 per cent in the month before.

Barclays in a research note said that July wholesale price inflation was driven by lower food and energy prices.

"The continued negative print in headline in year-onyear terms despite the monthon-month rise in wholesale prices is explained by base effects," Barclays said.

The Reserve Bank of India (RBI), which takes into account retail inflation to decide on monetary policy, had kept benchmark policy rates unchanged at 5.5 per cent earlier this month. The retail inflation in July dropped to an 8-year low of 1.55 per cent.

ICRA Senior Economist Rahul Agrawal said the deflation in wholesale inflation was largely driven by the food segment, which witnessed a larger yearon-year contraction, led by vegetables, pulses, and eggs, meat & fish

Tariffs On India Could Rise If Trump-Putin Talks Fail: US

NEW YORK- US Treasury Secretary Scott Bessent has warned that the secondary tariffs on India could go up if "things don't go well" during talks between President Donald Trump and Russian President Vladimir Putin in Alaska on Friday.

Last week, Trump imposed tariffs totalling 50 per cent on India, including 25 per cent for Delhi's purchases of Russian oil, that will come into effect from August 27.

"I think everyone has been frustrated with President Putin. We expected that he would come to the table in a more fulsome way. It looks like he may be ready to negotiate. And we put secondary tariffs on the Indians for buying Russian oil. I could see, if things don't go well, then sanctions or secondary tariffs could go up," Bessent said in an interview with Bloomberg on Wednesday.

When asked about China, the main buyer of Russian crude, Bessent said he is "not going to get ahead of the President, but the President is the best at creating leverage for himself, and he will make it clear to President on

the table".

On whether sanctions can go up or loosened, Bessent said, "Sanctions can go up, they can be loosened. They can have a definitive life. They can go on indefinitely. You know, there's this Russian shadow fleet of ships around the world that I think

Putin that all options are on

we could crack down on."

He said that even as
Trump is meeting with Putin, the Europeans "need to
join us" and need to be willing to "put on these secondary sanctions".

Bessent recalled that at the G7 meeting in Canada this year, he asked the leaders at the table whether they were willing to put a 200 per cent secondary tariff on China. "And you know what, everybody wanted to see what kind of shoes they were wearing."

He added that Trump is committed to ending the bloodshed in the Ukraine war. "It's put up or shut up time. The President is creating his own leverage. We need the Europeans to come in and help create more leverage," Bessent said.

Responding to the tariffs, the Ministry of External Affairs has said that the targeting of India is unjustified and unreasonable. "Like any major economy, India will take all necessary measures to safeguard its national interests and economic security," it said.

Annual FASTag Pass Of ₹3,000 For Private Vehicles Goes Live From Today

NEW DELHI- The annual highway toll pass of Rs 3,000 for private cars, jeeps, and vans will be rolled out from Friday.

Ahead of the roll out, the government has opened the pre-booking window for FAST-ag-based annual passes that allow users to cross up to 200 highway toll booths on a single recharge of Rs 3,000 within a

A dedicated link for activation of the annual pass is available on the Rajmarg Yatra app.

The link would also be available on the official websites of National Highways Authority of India (NHAI) and the Ministry of Road Transport and Highways (MoRTH).

The annual pass will be applicable only for non-commercial private vehicles such as cars, jeeps, and vans. It will allow seamless travel across National Highways without the need for repeated recharging of FASTag cards for toll payments.

In closed tolling highways such as Delhi-Mumbai Expressway - where toll collection occurs exclusively at exit points - a single trip includes both entry and exit points. On the other hand, on open tolling routes like Delhi-Chandigarh, each toll plaza crossing would constitute a separate trip.

The pass can be recharged again once the 200-trip limit in a year is reached.

According to the MoRTH, those who already have a FASTag on their vehicles will not need to purchase a new FASTag.

The annual pass will be valid only at National Highway (NH) and National Expressway (NE) fee plazas.

At fee plazas on Expressways, State Highways (SH) managed by state governments or local bodies, the FASTag will operate as a regular one, and applicable user fee charges may apply.

FASTag - the electronic toll

collection system - uses Radio Frequency Identification (RFID) technology to automatically deduct toll charges from a prepaid account linked to the vehicle. Over 10.1 crore FASTags were issued till December 1, 2024, according to the road transport ministry's 2024 yearend review.



Exports Rise 7.29% To USD 37.24 Bn In July

Trade Deficit Widens To 8-Month High Of USD 27.35 Bn

NEW DELHI- Snapping the two-month declining streak, India's exports rebounded by 7.29 per cent to USD 37.24 billion in July, while trade deficit widened to an eight-month high of USD 27.35 billion during the month.

Official data released on Thursday also showed that imports increased by 8.6 per cent year-on-year to USD 64.59 billion in July 2025 due to increased inbound shipments of crude oil and gold.

Trade deficit widened to USD 27.35 billion in July, the highest since November last year when the trade gap was USD 31.77 billion.

During April-July 2025-26, exports increased by 3.07 per cent to USD 149.2 billion, while imports rose 5.36 per cent to USD 244.01 billion.

The trade deficit during the first four months of 2025-26 was USD 94.81 billion.

Briefing media on the data, Commerce Secretary Sunil Barthwal said that despite global economic uncertainties, India's goods and services exports are doing well.

Exports have grown substantially, much higher than the global exports growth, he said.

He also said that the export promotion mission will also be announced "very soon".

The main sectors that pushed

the growth in July included engineering (13.75 per cent to USD 10.42 billion), electronics (34 per cent to USD 3.76 billion), gems and jewellery (29 per cent to USD 2.4 billion), pharma (14 per cent to USD 2.7 billion) and chemicals (7.19 per cent to USD 2.46 billion).

Petroleum exports, however, dipped by 25 per cent to USD 4.34 billion due to fall in global oil prices. At the import front, crude oil imports rose by 7.46 per cent to USD 15.57 billion. Similarly, gold imports increased by 13.83 per cent year-on-year to USD 3.93 billion.

The data showed that the estimated value of services export for July was USD 31.03 billion as compared to USD 30.60 billion in the same month last year. The imports were estimated at USD 15.40 billion in July.

No Pause On Russian Oil Imports, India Continues Imports Based On Economic Rationale

NEW DELHI- India has not halted oil purchases from Russia in response to the US President's tariff threat and continues to buy based solely on economic considerations, said AS Sahney, Chairman of Indian Oil Corporation (IOC), the country's largest oil firm.

Purchase volumes may fluctuate monthly based on the discounts offered on Russian crude grades like Urals. While discounts had previously reached as high as USD 40 per barrel, they have narrowed to just USD 1.5 late last month, resulting in reduced offtake. Discounts have since widened to about USD 2.70.

However, India's intent to continue buying Russian oil remains unchanged.

India became the largest customer of Russian oil from 2022, after western countries shunned Russian oil and imposed sanctions on Moscow for its invasion of Ukraine.

Sahney said refiners like IOC buy crude oil from Russia purely on economic consideration and have not been asked to cut or boost purchase in response to US tariffs, he said.

"There is no pause," he said. Russian oil has continued to flow to Indian refiners in July as well as this month.

"We continue to buy, purely based on economic considerations, that is to say if the pricing and characteristics of the crude make sense in our scheme of processing, we



buy," he told reporters here.
"No special effort is being

"No special effort is being made to either increase or decrease (the import volumes). We are buying crude as per economic considerations," he said.

Imports from Russia made up for 22-23 per cent of all the crude oil that IOC refineries processed in the April-June period.

US President Donald Trump last week announced an additional 25 per cent tariff on US imports from India -- raising the overall duty to 50 per cent -- as a penalty for the country's continued imports of Russian oil. Since the steep tariffs are likely to hit the USD 40 billion of non-exempt exports that India does to the US, there has been chatter around stopping or curtailing oil imports from Russia.

"There are no sanctions on Russian crude," he said. "India has not done anything that violates any sanctions".

Separately, Bharat Petroleum Corporation Ltd (BPCL) Director (Finance) Vetsa Ramakrishna Gupta on an investor call said the discounts have narrowed to USD 1.5 per barrel, and led to lower imports last month.

In the first quarter, Russian oil made up 34 per cent of BP-CL's crude intake and the company hopes to return to a 30-35 per cent ratio as long as there are no sanctions, he said.

Before February 2022, Rus-

sian crude oil accounted for less than 1 per cent of India's total oil imports. However, after Moscow's invasion of Ukraine, western nations shunned Russian energy, leading to Russian crude being available at discounted rates compared to global benchmarks.

Seizing the economic opportunity, India ramped up its purchases, significantly increasing its reliance on Russian oil to meet domestic energy needs. Russian crude oil now meets 30 per cent of the requirement.

Sahney said at no time was import of crude oil from Russia sanctioned and so India continued to purchase keeping in mind economic considerations.

Stock Markets End Flat After Volatile Session

MUMBAI- Benchmark stock indices Sensex and Nifty ended flat in a highly volatile trade on Thursday as investors turned cautious ahead of the US-Russia talks on August 15.

Extending gains to the second day, the 30-share BSE Sensex climbed 57.75 points or 0.07 per cent to settle at 80,597.66. During the day, it rallied 211.27 points or 0.26 per cent to 80,751.18.

The 50-share NSE Nifty rose by 11.95 points or 0.05 per cent to 24,631.30.

Among Sensex firms, Eternal, Infosys, Asian Paints, HDFC Bank, Bajaj Finserv and Titan were the major gainers. However, Tata Steel, Tech Mahindra, Adani Ports and

Bharat Electronics were among the laggards.

The Trump-Putin meeting could have significant implications for energy markets, potentially leading to an easing of sanctions against Moscow.

"After a volatile weekly expiry-day session, Indian equities ended flat as investors traded cautiously ahead of the US-Russia summit. IT and pharma stocks advanced on the back of a softer US inflation data and dovish outlook. Banking and consumer durables also gained on hopes of a consumption-led recovery," Vinod Nair, Head of Research, Geojit Investments Ltd, said.

The BSE smallcap gauge declined 0.59 per cent and midcap index dipped 0.18 per cent.

Gold Climbs ₹400 To ₹1,01,420, Silver Rallies ₹1.500

NEW DELHI- Gold prices climbed Rs 400 to Rs 1,01,420 per 10 grams in the national capital on Thursday on fresh buying by stockists in line with firm global trends, according to the All India Sarafa Association.

The yellow metal of 99.9 per cent purity had settled at Rs 1,01,020 per 10 grams in the previous session.
Gold of 99.5 per cent purity increased by Rs 400 to Rs

1,01,000 per 10 grams (inclusive of all taxes) on Thursday. It had closed at Rs 1,00,600 per 10 grams on Wednesday. In the national capital, silver prices rose by Rs 1,500 to Rs 1,13,500 per kg (inclusive of all taxes) on Thursday.

"Gold and silver prices rose after traders increased their bets on the US Federal Reserve for resuming interest rate cuts in the September meeting. While indications of a slowing labour market provided room for additional easing, the most recent US Consumer Price Index report allayed worries over tariff-driven inflation," Renisha Chainani, Head of Research at Augmont said.

On the global front, spot gold went up marginally to trade at USD 3,356.96 per ounce in New York.
"Gold extends gains to trade ahead of US Producer Price Index and jobless claims data.

"However, optimism over trade, as Washington and Beijing extended their tariff truce by 90 days, and upcoming talks between US, European, Ukrainian, and Russian leaders, could temper further upside," Kaynat Chainwala, AVP of Commodity Research at Kotak Securities, said.

Passenger Vehicle Dispatches Dip Marginally In July On Muted Demand

NEW DELHI- Passenger vehicle dispatches from companies to dealers in the domestic market declined marginally year-on-year in July, hit by muted demand, industry body SIAM said on Thursday.

Passenger vehicle wholesales stood at 3,41,510 units in July 2024.

"All vehicle segments posted stable performance in July 2025, though overall sentiments in the passenger vehicles segment have remained subdued," Society of Indian Automobile Manufacturers (SIAM) Director General Raiesh Menon said in a statement.

Two-wheeler dispatches rose 9 per cent year-on-year to 15,67,267 units last month from 14,41,694 units in the year-ago period. Scooter sales stood at 6,43,169 units last month, an increase of 16 per cent as compared with 5,53,642 units in July 2024, SIAM said.

Motorcycle dispatches to dealers rose 5 per cent yearon-year to 8,90,107 units in July. Mopeds saw a dip of 9 per cent year-on-year to 33,991

units last month, as against the same period last year.

Three-wheeler dispatches to dealers saw an increase of 17.5 per cent year-on-year to 69,403 units in July as

compared with 59,073 units in the year-ago period.

"With the advent of the festive season beginning with
Onam festivities in the latter part of August, the Indian auto
industry remains cautiously optimistic for the demand momentum to pick up in the coming months," Menon noted.

Unbelievable How Gill Led India In England: Yuvraj Singh

NEW DELHI: Former India batter Yuvraj Singh feels Shubman Gill's performance on the recent England tour was nothing short of unbelievable, especially considering the question marks over his batting in overseas conditions heading into the five Test series.

During the Anderson-Ten-dulkar Test series recently, Gill scored four centuries and finished as the leading run-scorer with 754 runs. The feat made him the first Asian batter to score 700-plus runs in a Test series in a SENA country, and helped the visitors draw the five-Test series 2-2.

Gill, 25, led a young side on the tough tour after three Test stalwarts -- Virat Kohli, Ro-hit Sharma and Ravichandran Ashiwn -- quit the longest format in quick succession, leaving a vacuum in the side.

'There were a lot of question marks over his overseas record. The guy (Gill) became



the captain and scored four Test hundreds. It's just unbelievable that when you're given responsibility, how you take it," Yuvraj told ICC Digital on the sidelines of the '50 Days To Go' Women's Cricket World Cup event.

"So, very proud of them (In-

dian team). I certainly feel it's a win for us, although it's a drawn series, because it's a young team. And it's not easy to go and play well in England and prove

Despite being hit by injuries to wicketkeeper-batter Rishabh

Pant, Akash Deep and Arshdeep Singh, and their pace spearhead Jasprit Bumrah playing only three games to manage his workload, India's determination was on show as they pulled off a thrilling six-run win in the fifth Test at Oval to level the series.

Despite his bowling prowess, Maxwell has bowled only five powerplay overs in total in the shortest format between the 2022 T20 World Cup and the ongoing home series against South Africa.

But the 36-year-old feels he could come in handy in powerplay overs during the T20 World Cup as the new ball grips the subcontinent's wickets better.

"I think in the subcontinent you might be able to get a little bit more out of it (wicket) as a spinner early on," Maxwell was quoted as saying by cricket.com.au.

"Especially that new ball, the hard seam, being able to grip on those dry surfaces. So it might be something we think about heading forward," he

Any Misadventure Will Have Painful Consequences: India To Pak

New Delhi: India on Thursday warned Pakistan not to continue with its "hateful" rhetoric against New Delhi saying any misadventure will have "painful consequences".

"It is well known modus-operandi of the Pakistani leadership to whip up anti-India rhetoric time and again to hide their own failures.'

"Pakistan would be well-advised to temper its rhetoric as any misadventure will have painful consequences as was demonstrated recently," he said.

ILLEGAL BETTING APP

ED Freezes Rs 110 Cr Worth Bank Funds; Seizes 1,200 Credit Cards

New Delhi: Funds worth Rs 110 crore kept in mule bank accounts have been frozen and 1,200 mule credit cards were seized following recent searches against the Indian operations of a Cyprus-based "illegal" online betting platform named Parimatch, the Enforcement Directorate said on Thursday.

Parimatch app, as per the federal probe agency, gained visibility in the country through "aggressive" marketing, including sponsorship of sports tournaments and partnerships with well-known celebrities. It is alleged to have cheated investors luring them with high returns and generating "They also set up Indian entities

to run surrogate advertisements under the names 'Parimatch Sports' and 'Parimatch News'. Payments to these agencies were made via foreign inward remittances," the Enforcement Directorate (ED) said in a statement.

The agency had conducted searches at 17 locations in Mumbai, Noida, Jaipur, Surat, Madurai, Kanpur and Hyderabad on August 12 as part of a case registered under the Prevention of Money Laundering Act (PMLA) against the operations of Parimatch.

The ED case stems from an FIR filed by the cyber police station of Mumbai Police against parimatch. com for "duping" users through online betting.

The agency said funds worth about Rs 110 crore kept in various bank accounts belonging to persons/entities used as mule accounts (bank accounts used for money laundering and similar criminal activities) and/or for

"layering" purposes were frozen. More than 1,200 mule credit cards, found in a single premises during the searches, have also been seized, it said.

Describing the alleged modus operandi deployed by the betting platform, the ED said it routed users' fund through mule accounts using different strategies across the country.

ited by users into mule accounts were withdrawn in cash in a specific locality in Tamil Nadu. This cash was handed over to hawala operators, who used it to recharge virtual wallets of a UK-based company.

These wallets were used to buy cryptocurrency in the name of mule crypto accounts, which were actually operated by Parimatch agents, it alleged.

In western India, the ED said, Parimatch engaged services of domestic money transfer (DMT) agents. Funds collected in mule accounts controlled by these DMT agents were sent to Parimatch agents through payments made by mule credit cards.

The directive has been communicated to all Chief Medical Officers and Drawing and Disbursing Officers (DDOs) across the Jammu division. They have also been advised to keep all ambulances in ready mode to meet any eventuality arising from inclement weather conditions.

The order further emphasizes maintaining strict readiness of the health workforce and ensuring uninterrupted medical services in the affected areas.

Disaster struck Chositi, the last motorable village on the way to Machail Mata temple, between 12 noon and 1 pm. A large number of people had gathered there for the annual Machail yatra that began on July 25 and is scheduled to end on September 5. The 8.5 kilometre trek to the temple at 9,500-feet height

begins from Chositi. Chositi is about 90 kilometres from Kishtwar town. A 'langar' (community kitchen) packed with devotees bore the brunt of the cloudburst, which led to flash floods and washed away several structures, including shops and a security outpost.

Videos showed torrents of muddy water, silt and rubble tearing through the steep slopes, destroying everything in the way. Houses folded over like pack of cards, rocks came tumbling down, blocking roads and rescue paths, the mudslide turning the verdant landscape to a grim brown-grey.

The fragile Himalayan slopes faced disaster just nine days after flash floods wreaked havoc in Dharali village of Uttarakhand's Uttarkashi district. Though only one person is confirmed dead, 68 people are still reported missing in the calamity that struck on August 5.

Immediately after news came in of the disaster, Kishtwar Deputy Commissioner Pankaj Kumar Sharma and senior officials mobilised rescue teams and headed towards the spot to personally supervise the operations.

A large-scale rescue operation was launched by NDRF, SDRF, police, Army and local volunteers, the authorities have mobilised more rescuers, including two fresh teams of NDRF from Jammu to speed up the rescue efforts, officials

"Deeply distressed to learn about the devastating cloudburst in the Chositi area of Padder, which may lead to significant loss of life. I have iust spoken with LG @manojsinha_ Ji and @ DrJitendraSingh Ji to assess the situation. NDRF teams and helicopters are being mobilized to the site at the earliest. Efforts are underway to evaluate the damage and coordinate rescue and medical operations. I am en route to the location to personally oversee the response and ensure that all necessary measures are taken,"

Sunil Sharma wrote on X. M Y Tarigami, CPI (M) leader and MLA Kulgam has expressed deep sorrow over the

Calling it a "deeply sad moment for all," Tarigami said the tragedy, which left several dead and many injured, demands an immediate and coordinated response. "The government should announce compensation for the deceased without delay, ensure proper treatment for the injured, and expedite rescue op-

erations," he said. Peoples Conference (PC) Chairman and MLA Handwara, Sajad Gani Lone in a post on X, has extended condolences to the bereaved families.

"Bad news coming in from Kishtawar sector. There has been a cloudburst and reportedly there are some fatalities. My condolences to the bereaved families. May they rest in peace,"

Apni Party President, Syed Altaf Bukhari expressed shock and said this is a tragedy beyond

"Shocked and deeply grieved by the news of at least 10 lives lost in a massive cloudburst in Chishoti village, Padder area of Kishtwar district. This is a tragedy beyond words. In this hour of unimaginable pain and sorrow, Apni Party stands in solidarity with all those who have lost their loved ones. May the Almighty grant them the strength to endure this immense loss, and may the departed souls rest in eternal peace," Altaf Bukhari wrote.

Rescue Teams

carried the injured on their backs for hours through mud-choked terrain to reach hospitals. Many survivors had no memory of the disaster, still dazed as they were treated.

"The catastrophe is widespread. You can see devastation, deaths, and injuries everywhere. It is the worst situation," said BJP leader and J&K Assembly Leader of Opposition Sunil Sharma.

Families wept openly as they searched for missing loved ones. Sharma and Kishtwar MLA Shugan Parihar joined locals and security forces in lining up bodies on the roadside, covering them with white shrouds. Parihar was seen consoling grieving women and girls, while injured children were carried unconscious to hospitals, drips administered on the

"It is unbearable. I cannot hold back my tears," Parihar said. "We are pleading for more ambulances. The situation is very bad here in the village battered by the cloudburst.'

Hospitals were overwhelmed. Patients lav on floors as beds filled up, with medical staff rushing from across Paddar and Kishtwar to Atholi Hospital. Injuries ranged from broken ribs and legs to suspected mud lodged deep in throats and lungs.

Several victims are in a dangerous condition with broken ribs and legs, their injuries reflecting the sheer force of the cloudburst and subsequent landslides. "Most have severe injuries some to the chest, some on the head, others on the legs," medical staff said. Health officials also suspected sand and mud lodged deep inside patients' throats, lungs, and wounds.

The disaster struck between 12 noon and 1 pm, when the pilgrimage camp was bustling. Flash floods, mudslides, and debris flows buried homes, shops, and vehicles. A security camp was swept away, and several vehicles at the bus stand — starting point for the 8.5-km trek to Machail Mata – were destroyed.

A temple in the centre of the flooded zone miraculously survived. But a langar (community kitchen) set up for devotees was obliterated. 'Hell Broke Out'

"We had just left the shop near the langar and walked a kilometre when hell broke out. The flood decimated everything. Within minutes, the langar disappeared," recalled a pilgrim from Jammu.

The floodwaters hurled massive trees into

the village, scattering them over a 500-metre stretch. Health officials appealed for clothing for the injured, and locals — even nurses brought garments from home. DIG Doda-Kishtwar range Shridhar Patil confirmed rescue and relief operations were ongo-

ing, urging people to remain calm and contact designated helplines for missing persons. Chositi lies about 90 km from Kishtwar town, the last motorable point before the trek to Machail Mata shrine. The pilgrimage began

on July 25 and was due to end on September 5. This disaster comes just nine days after flash floods ravaged Uttarakhand's Uttarkashi district, where 68 people are still missing. (With inputs from PTI)


