# Kashmir's Top Women's College Breaks The Silence On Harassment

For thefirst time, Kashmir's campuses are openly debating how to make classrooms and workplaces safe for women.

Srinagar: It is rare to hear open talk about sexual harassment in Kashmir. That changed in Srinagar on Tuesday, when Government College Women filled its hall with voices ready to confront the issue. The two-day workshop, ti-

tled Strengthening the Internal

Committees for Zero Tolerance Campus, was an attempt to reimagine how institutions in Kashmir respond to one of the most underreported and stigmatized issues in society.

Organized by the college's Internal Committee with WISCOMP (Women in Security, Conflict Management and Peace), New Delhi, the

gathering brought together Internal Committee members and "gender champions" from colleges across the valley.

On stage, Prof. Mohammad Mobin, Vice Chancellor of Cluster University Srinagar, wasted little time. "Internal Committees must inspire trust," he told the audience. spoke

complaint systems, online reporting, and case tracking that could bring transparency to a process often weighed down by suspicion.

"If students do not believe in the process," he said, "we lose more than cases. We lose credibility.'

The challenges in Kashmir are sharper than the statistics

suggest.

# **LS Clears Online Gaming Bill**

Srinagar:The Lok Sabha on Wednesday passed the online gaming bill to ban real money online games, citing instances of gambling addiction, money laundering and financial frauds. The legislation will now go to the Rajya Sabha for approval to become a law.

The move affects India's \$3.8 billion gaming industry, which has drawn global investors and fostered fantasy sports apps like Dream11, Games24X7 and Mobile Premier League.

The Promotion and Regulation of Online Gaming Bill, 2025, was tabled in the Lok Sabha on Wednesday evening. It essentially bans online gaming apps that require users to pay money to win cash.

"The government believes that the harms of addiction, financial loss and even extreme consequences such as suicides associated with online money gaming can be prevented by prevention of such activities," according to a media statement released by the government.

"Additionally, online money gaming platforms are often misused for financial fraud, money laundering, terror financing and messaging activity that compromise national security," it added.

Piloted by Minister of Electronics and Information Technology Ashwini Vaishnaw, the Promotion and Regulation of Online Gaming Bill, 2025 was passed without a debate as Opposition members raised slogans demanding a discussion on the special | More on P6

# **Shah Tables Bills To Oust** Jailed PM, CMs; Oppn Erupts

JPC To Examine Bills, Submit Report Before Next Session

New Delhi: Home Minister Amit Shah on Wednesday introduced in Lok Sabha three Bills for the removal of prime minister, chief ministers, and ministers under arrest for 30 consecutive days on charges of corruption or serious offenses, drawing fierce protests from opposition MPs who tore up copies of the draft law and marched close to his seat shouting slogans.

In a charged atmosphere, several opposition MPs spoke against the introduction of the Bills, claiming they violated constitutional principles, targeted federalism, turned the jurisprudence 'innocent until proven guilty' on its head, were open to misuse for political reasons and threatened to turn the



country into a police state. Shah, however, batted for an enhanced standing for moral values in public life, saying, "We cannot be so shameless that we continue to occupy constitutional positions while facing serious charges".

# **Heavy Rains** In J&K From Aug 23: MeT

Srinagar: The Meteorological Centre Srinagar on Wednesday issued a detailed weather forecast for Jammu and Kashmir, cautioning residents about the likelihood of heavy rains and possible flash floods in coming days.

According to the forecast, weather from August 20 to 22 will remain generally hot and humid across the Union Territory, with brief spells of rain or thundershowers at a few places. Isolated heavy showers are expected in Jammu, Reasi, Udhampur, Rajouri, Kathua and Samba on the night of August 22.

The most significant weather activity is predicted between August 23 and 26, when light to moderate rain and thundershowers are expected at many places. accompanied by heavy rainfall at select locations in both Jammu and Kashmir divisions. Areas likely to be impacted include Jammu, Reasi, Udhampur, Samba, Kathua, Rajouri, Anantnag and Kulgam, while moderate to intense showers are expected in Poonch, Ramban, Doda and Kishtwar.

# HC Seeks Govt's Response To PIL On Rotten Meat In J&K

Srinagar: The High Court of I&K and Ladakh on Wednesday sought response of the government within four days to a Public Interest Litigation seeking slew of directions on preventing the sale, storage, distribution, and transportation of rotten, unhygienic, and unsafe meat and products within the Jammu & Kashmir.

A division bench Chief Justice Arun Palli and Justice Rajnesh Oswal also impleaded Food Safety and Standards Authority of India (FSSAI) to the PIL filed by a practicing lawyer Mir Umar through advocate Shafaqat Nazir.

Besides FSSAI, the response has been sought by August

25 of Union Territory of J&K through the Chief Secretary Commissioner Secretaries of Consumer Affairs & Public Distribution Department, Health and Medical Education Department as well Commissioner Srinagar and Jammu Municipal Corporations.

Among others, the PIL seeks urgent judicial intervention to address a "serious and ongoing public health crisis" in the J&K particularly Kashmir Valley.



# Search Ops Enter Day 7, Death Toll Rises To 65

Srinagar: Search and rescue operations continued for the seventh straight day on Wednesday in cloudburst-hit Chisoti village of Kishtwar, where the death toll has climbed to 65.

Principal Secretary, Home, Chandraker Bharti, chaired a meeting of various agencies after assessing the ground situation on Wednesday. The senior official is the first

of the 10 IAS and IPS officers who have been directed by the Lieutenant Governor to visit the disaster-hit area over eight days to supervise relief and rescue operations.

The death toll in the natural calamity that struck the last motorable village en route to the Machail Mata temple on

August 14 during the yatra has reached 65, including three CISF personnel and one Special Police Officer (SPO) of J&K Police. Over 100 people were injured and 39 are still missing.

"The search on day seven started with early morning showers but later the sun came out and the rescuers fanned out on the assigned locations to look for the missing persons believed to be buried under the rubble or washed away in the stream," an official of the SDRF said.

The search operation was extended on Tuesday to cover the entire 22-km stretch of the stream from Chisoti to Gulabgarh, following the recovery of two bodies downstream over the past two days, the official said.

# **Study Finds COVID-19 May Have Aged Blood Vessels By 5 Years, Especially Among Women**

COVID-19 infection could age one's blood vessels by about five years, especially among women, according to a new study.


The effect was found to be stronger among women who experienced persistent symptoms after recovering from COVID-19 -- collectively termed 'long Covid' -- such as shortness of breath and fatigue.

"Since the pandemic, we have learned that many people who have had (COV-ID-19) are left with symptoms that can last for months or even years. However, we are still learning what's happening in the body to create these symptoms," lead researcher Rosa Maria Bruno from Université Paris Cité, France, said.

The study, published in the European Heart Journal, looked at around 2,400 people -- about half were women -from across 16 countries, including Australia, Brazil and those in Europe.

While blood vessels are known to become stiffer with age, a COVID-19 infection can accelerate the process and can heighten the risk of developing cardiovascular disease, including stroke and heart attack, the research-

The participants' vascular (blood vessel) age was measured using a device that looks at how quickly a wave of blood pressure travels between the ca-



rotid artery (in the neck) and femoral arteries (in the legs) -- called 'carotidfemoral pulse wave velocity'.

A higher value indicates more stiffness and ageing of blood vessels. Measurements were taken six months after a COVID-19 infection and again after 12

An increase in pulse wave velocity of around 0.5 metres per second is clinically relevant and roughly amounts to ageing by five years, with a three per cent increased risk of cardiovascular disease, in a 60-year-old woman, the researchers said.

The study found that, on average, pulse wave velocity among women who had a mild infection was increased by 0.55 metres per second, by 0.60 metres per second in those hospitalised and by over one metre per second for women treated in intensive care.

"(Pulse wave velocity) differences were significant in women, but not in men. Among COVID-19 positive women, persistent symptoms were associated with higher (pulse wave velocity)," the authors wrote.

"A stable or improved (pulse wave velocity) after 12 months was found in COVID-positive groups, whereas a progression was observed in the COVIDnegative group," they wrote.

Explaining how COVID-19 impacts blood vessels, Bruno said that the disease-causing virus "acts on specific

receptors in the body, called the angiotensin-converting enzyme 2 receptors, that are present on the lining of the blood vessels."

"The virus uses these receptors to enter and infect cells. This may result in vascular dysfunction and accelerated vascular ageing. Our body's inflammation and immune responses, which defend against infections, may also be involved," the lead researcher said.

Further, compared to men, women are known to produce a more rapid and robust immune response which can protect from infection but can also inflict damage on blood vessels after initial infection, Bruno said.

In a related editorial, published in the European Heart Journal, researchers from Harvard Medical School in the US wrote, "Although the acute threat of the COVID-19 (coronavirus disease 2019) pandemic has waned, a new challenge emerged in its aftermath: post-acute COVID-19 syndrome."

The study highlights that "COVID-19's vascular legacy is real, measurable, and with a plausible likelihood of sexspecific findings," they wrote.

'COVID-19 has aged our arteries, especially for female adults. The question is whether we can find modifiable targets to prevent this in future surges of infection, and mitigate adverse outcomes in those afflicted with COVID-19-induced vascular ageing," the au-

# **Advisor To CM Holds Meetings With Various Delegations**

SRINAGAR: Advisor to the Chief Minister Omar Abdullah , Nasir Aslam Wani, held a series of meetings on Wednesday in Srinagar, engaging with the Kashmir Chamber of Commerce & Industry (KCCI) as well as several other delegations to discuss a range of public, trade, and employee-related issues.

At the Civil Secretariat, Advisor Wani chaired a high-level meeting with the KCCI delegation led by its President, Javed Tenga. The meeting was attended by Additional Chief Secretary to the Chief Minister, Dheeraj Gupta, Commissioner Secretary Industries & Commerce, S. Vikramjit Singh, Director Handicrafts & Handloom Kashmir, Mussrat Islam, and other officials.

The KCCI President raised concerns regarding the handicrafts and handloom sector, particularly in the wake of notices issued by the Department of Handicrafts & Handloom to Kashmiri handicraft showrooms over the sale of machine-made products alongside handcrafted items. He also stressed the need to expedite the testing and certification of GI-tagged products at the PTQCC laboratory at Bagh-e-Ali Mardan Khan.

Officials briefed the Advisor about the background of these notices, citing formal complaints from tourists who had been sold machine-made imitations as genuine Kashmiri handicrafts. In one serious case, a showroom was blacklisted for selling counterfeit

products with fake GI labels in order to deceive buyers.

Reiterating the Government's commitment to protecting artisans and weavers, Advisor Wani directed the department to prepare a comprehensive proposal to safeguard the interests of both artisans and business stakeholders. He advised the KCCI delegation to hold formal consultations with the Department and submit a proposal for consideration regarding the sale of machine-made products, provided such items are clearly labeled and

# **'Illiterate' Appointed Instead Of Namesake**

hadura (Budgam) - Even as numerous scandals of fake appointments have surfaced in various government departments over the recent years, incidence of the wrong doing is far from being stamped out. Some diehards still manage to get a job in one or the other department by manipulating records and documents, and by tapping the 'right' person and the 'tight' timer.

An illiterate villager has got a government job allegedly by impersonation, and got away with it, assurance of the finance minister to get the wrong undone notwithstanding. In the process, the genuine claimant for the appointment continues to be jobless. Reports said Nazir Ahmad Dar r/o Abdul Kabir Dar R/o Badipore, has passed his 12th (TDC) clam examination. But, it is his namesake in the neighbourhood who, though illiterate, has allegedly got a government job. The only difference between the two is in the names of their grandfathers. While the former's grandfather is named Abdullah Dar, the latter's name is Ahmad Dar.

According to reports, the uneducated Nazir Ahmad Dar was appointed in the horticulture department in 1996. He is posted in the district office at Budgam. Sources in the department said Dar managed to procure the certificates of his educated namesake which he produced in support of his claim. The department did not entertain the 'genuine' claim of the educated Dar.

Though the serious case of alleged swap was brought to the notice of the state vigilance organisations, no action has been taken so far. The educated Dar approached the finance minister, Abdur Raheem Rather, who also happens to be his neighbour. He had assured him to get the right person appointed against the post. However, justice 'still eludes hint despite lapse of about four years

In another case, Mushtaq Ahmad Zargar s/o Ghulam Ahmad Zargar r/o Badipore has managed to secure a job allegedly by producing a fake certificate of academic qualification. According to reliable sources, he is barely read upto 4th standard. However, he managed to get a certificate of having passed his 9th class (under metric) examination from the government higher secondary school, Nagam, in 1996 allegedly, through his brother, Abdul Rasheed Zargar, who is a teacher at Badipore.

On the basis of the alleged fake certificate, Zargar was

On the basis of the alleged fake certificate, Zargar was appointed as a peon in the animal husbandry department. He has been working at the veterinary dispensary here for about three years past. Sources said the department did not take any action to unravel the facts and bring the accused to justice even after the matter was brought to its notice.



# **Apple Farmers Need Protection**

lthough, the ongoing trade tensions between India and the United States have not hit Kashmir's apple industry, a sector that sustains hundreds of thousands of families, it hasn't helped it either. The import of the cheaper foreign apples including those from the US continues unabated impacting the market share of Kashmiri apple. While President Trump's tariffs on Indian goods were initially aimed at steel, aluminum, and other industrial exports, the ripple effects are now being felt in the orchards of Kulgam, Sopore, and Shopian. It is expected that the if India was forced to lower tariffs on the US fruit, cheap American apples, pouring into Indian markets, will threaten to undercut local produce at a time when costs for farmers are climbing sharply.

Kashmir produces nearly four-fifths of India's apples. It is more than a regional specialty, it is a backbone of our economy. Orchardists, laborers, transporters, commission agents, and market vendors all depend on this fruit trade. A dip of even a few rupees per kilo affects all of them: wages fall, debt grows and smallholders edge closer to ruin.

Today, that danger is no longer theoretical. Wholesale prices in the Valley are already down, while input costs. electricity, irrigation, fertilizers, pesticides continue to rise. Farmers who borrowed to maintain their orchards through the Kisan Credit Card scheme are staring at mounting repay ments. When agriculture is pushed into such a squeeze, the effects for farmers are grim.

This is why New Delhi cannot afford to sit on its hands. Other countries have not hesitated to shield their growers when global trade turned hostile. India must consider a strong, proportional response, whether by imposing steep import duties on American apples or by offering immediate relief to domestic producers through subsidies, credit restructuring, or targeted price support. The point is not to encourage an endless tariff war, but to ensure that small farmers do not pay the price for geopolitical maneuvering.

Also, promises of free or subsidized power for orchard irrigation remain unfulfilled in many pockets of Kashmir. Infrastructure to store, sort, and market apples is still inadequate. And while high-density plantation schemes are encouraged, there is little planning to protect farmers from volatile prices. Unless these gaps are addressed, temporary trade shocks will keep returning as existential threats.

At stake is more than an industry. Kashmir's apple belt is a rare zone of economic self-reliance, one of the few rural sectors that has consistently supported families without constant government aid. If the central government fails to act decisively this strength will erode, and rebuilding it later will be far more costly than protecting it now.

The government must send a clear signal: when global mar kets turn unfair, India will stand by its farmers, as prime minister Narendra Modi himself has said. If that means calling for tariffs, relief packages, or both, so be it.

The result is troubling: suspicions between Shias and Sunnis, and between Barelvi, Deobandi, and Salafi traditions, have begun to overshadow the bonds of brotherhood.

These rifts may appear minor, but in a region already fragile from decades of conflict, they threaten to corrode the very foundations of society.

The irony is that sectarianism has no basis in Islam. The Qur'an and the Prophet Muhammad rejected it unequivocally. "Surely this religion of yours is one, and I am your Lord, so fear Me alone," says the Qur'an (Al-Mu'minun 52-53). In another verse, it warns, "Do not be like those who split into sects after clear proofs had come to them" (Ale-Imran, 3:105).

These commands are meant to protect the Muslim community from the exact divisions we now see in Kashmir.

The Prophet himself offered both warnings and metaphors. He compared believers to a single body: if one limb suffers, the whole body responds with pain. He cautioned that those who separate from the main body of Muslims risk dying in a state of ignorance.

The message is stark: unity is a duty, and division is a be trayal of faith.

Sectarianism is not just a theological problem. It has practical, even devastating, consequences.

A community that spends its energy debating minor points of doctrine wastes resources that could build schools, generate livelihoods, or address poverty. Internal quarrels strip Muslims of moral authority, leaving them less able to speak with one voice on issues of justice and dignity. They open the door for outsiders to exploit divisions for their own agendas.

Sectarianism provides one more lever of manipulation in Kashmir, where politics has long thrived on divide-and-rule.

Religious leaders must carry a share of responsibility. Sermons too often dwell on differences, reinforcing divides rather than closing them. Pulpits can either unite or fragment. The choice lies with those who hold them.

Imagine if mosques became centers of dialogue and cooperation, emphasizing common principles rather than doctrinal quarrels. That shift alone could restore much of the harmony that once defined Kashmiri society.

The youth of Jammu and Kashmir also hold the key. With smartphones in hand, they are the most powerful narrators of the valley today. Yet too often their social media posts amplify sectarian language, spreading suspicion at the click of a button. This is not harmless banter.

A tweet or video clip that mocks another tradition can harden divisions for years. If Kashmiri youth recognized that disagreements do not require disrespect, common values, youth who refuse to spread hate, communities that reject political manipulation, and scholars who frame difference as diversity rather than division.

It also requires memory, recalling that Kashmir earned its reputation for harmony because its Muslims once found peace within themselves.

The Qur'an calls believers to hold firmly to the "rope of Allah" and avoid divisions. That call is as urgent in today's Kashmir as it

and that reverence across sects is a form of strength, they could model the unity their elders failed to preserve.

The timing matters. Kashmiri Muslims face immense political and social challenges, from curbs on democratic representation to economic marginalization. To fracture now is to walk into a trap set by those who benefit from a divided community.

History tells the story clearly: whenever Muslims stood united, they achieved progress. And whenever they splintered, decline followed.

Sectarianism has no roots in Kashmir's cultural past. The valley's legacy is one of shared shrines, collective prayers, and festivals where differences dissolved into common rituals.

To let sectarian divisions define the present is to betray both faith and history. It is to trade the rope of unity that the Qur'an commands believers to hold firmly for the brittle threads of factional pride.

Unity requires deliberate choices: preachers who stress was in the Prophet's time. Unity is both a religious obligation and a survival strategy.

If Muslims in the valley rise above sectarianism, they can preserve not only their faith but also the cultural heritage that made Kashmir a symbol of coexistence. If they do not, they risk watching that heritage slip away

Kashmir has already endured decades of political turmoil. It cannot afford to add sectarian strife to its wounds.

The choice before Muslims of the valley is simple, though not easy: to rebuild the bonds of brotherhood and live the true spirit of Islam, or to let division hollow out the paradise they inherited.

The path to unity is clear. What remains is the courage to take it.

# The Wound in Ganderbal is More Than a Crime Scene

he tragedy in Ganderbal left the valley stunned. A young girl died at the hands of her own sister, a person meant to be a companion, protector, and second mother. The crime did not happen in a stranger's shadow but inside a home. the place that should shield us.

The horror goes beyond headlines. It reflects a deeper sickness, a slow corrosion of bonds, empathy, and responsibility in our families.

Homes in Kashmir were once spaces of nurture, where patience, love, and respect were taught before lessons in letters or numbers. Today, too often, they resemble battlegrounds. Small disagreements escalate into rage. Sibling rivalry replaces companionship. Neglect, impatience, and self-centeredness feed the soil in which anger grows. Affection is replaced by entitlement, empathy by resentment, respect by rivalry. In such soil, even the sacred bond of sisterhood can break

The crisis is generational. Children and teenagers here are technically skilled, fluent in gadgets and apps, yet illiterate in empathy. Girls are trained to excel professionally, boys to pursue ambition, but both often evade the responsibilities that make homes thrive. Desire outweighs duty. Freedom replaces accountability. Rebellion masquerades as strength.

The consequences are evident: fractured marriages, fatherless children, and siblings estranged before they even part ways

Anger is not only a personal failing. In a culture where patience is mocked and humility scorned, it becomes a social illness. Everyday life in Kashmir shows its subtler forms: disrespect between parents and

children, cold wars among siblings, spouses treating each other as competitors. Normalized anger leaves violence inevitable.

Children surrounded by parents yet starved of love become "orphans with living parents." Emotional absence leaves wounds that no school or guardian can heal. Ganderbal is not unique. Across India, siblings kill siblings over petty disputes, children lash out at parents, and marriages dissolve into battles of ego. These incidents are mirrors, showing what happens when homes lose sanctity and values are replaced by vanity.

Ganderbal must be remembered as a moral turning point. Homes should teach compassion before alphabets. Parenthood must be reclaimed as sacred. Emotional education, including anger control, empathy, conflict resolution, must be prioritized alongside science and technology. Society must rethink freedom: true freedom lies in fulfilling responsibilities with dignity.

The wound in Ganderbal is more than a crime scene. It reflects the cracks in our homes, the neglect of sacred bonds, and the dangers of raising children hollow inside. Justice in the courtroom punishes acts of violence. Justice in society rebuilds love, responsibility, and faith in family.

The question is not whether punishment will follow. The question is whether we will learn. If we do not, the wound in Ganderbal will fester, spreading silently until every home carries a scar of its own.

# Guardian of Wahibugh

In a village shaped by Kashmir's quintessential struggles, 27-year-old Suheel Gulzar Sofi uses education, faith, and service to unite his people.

n a cold spring night in Srinagar, the corridors of LD Hospital were hushed except for the shuffle of feet and the sound of machines.

It was nearly 3 a.m. when an elderly woman's blood pressure surged dangerously above 200. Panic rippled through the ward as attendants called for help.

Before the doctors could respond, a young man from Pulwama lifted her into his car and drove her to another facility, staying by her side until the crisis passed.

The man was not a doctor or a nurse. He was Suheel Gulzar Sofi, a 27-year-old civil engineer from the village of Wahibugh. For him, that night was no exception.

"This is what a human being should do when someone's life is in danger," he said later.

In Wahibugh, where nearly every household carries a story of struggle, Suheel has become the person people

depend on.

rely on when daily life falters.

Nestled among orchards

and streams that feed the Jhelum, this small Pulwama village depends on agriculture, with few opportunities beyond the fields.

Unemployment among Kashmiri youth remains among the highest in India, government surveys put it above 18 percent, and many young men leave the valley in search of work.

Suheel could have followed the same path. With degrees in civil engineering and computer applications, he had every reason to pursue a career outside his village.

Yet, those who know him say he made a different choice: to use his education to serve the people around him.

His professors remember him as a student who grasped difficult concepts with ease. His neighbours remember him as the young man who fixes water pipes, tutors children, and helps carry the sick to hospitals.

"Suneel has the rare ability to understand complex things and still remain grounded," one of his teachers recalls.



has been education.

Each week, he gathers children from underprivileged households and teaches them for free.

Such support can change the course of a child's life in a region where private tuitions are often expensive and where public schools suffer from shortages of teachers.

"Our children are getting a chance to study, and it's all thanks to Suheel," says Ishfaq, a farmer who earns just enough from his apple orchard to feed his family.

Another villager, Moham-

Another villager, Mohammad Shafi, a wood seller, says his son has learned more than academics: "He [Suheel] has taught him kindness and responsibility. That is a gift we can never repay."

Across Kashmir, parents worry about education. Despite one of the highest literacy rates among Indian states, dropout levels in rural districts remain high, especially among poor families.

Many children leave school early to help in fields or shops. Suheel's free classes, neighbours say, keep dozens of children in Wahibugh connected to learning, and to hope.

On Fridays, when Wahibugh gathers for prayers, Suheel can be found at the mosque before the crowd arrives. He sweeps the floor, arranges prayer mats, and checks the loudspeakers.

For him, faith is service. "Mosque is not just a place of worship," he says, "it is also a

responsibility for us."

Akram, a villager who watches him each week, points out how this example has changed others. "When people see him work with his hands, they remember what faith is supposed to mean."

Suheel's sense of responsibility stretches into the streams that run past Wahibugh.

Kashmir's rivers and springs, once pristine, are increasingly polluted by waste and neglect. For a community that depends on orchards and fields, clean water is survival.

Suheel gathers groups of children to clean riverbanks, explaining why each scrap of plastic removed matters.

"Water is life," he tells them. "If our rivers stay clean, our village will thrive." fills it," says Ayoub, the shopkeeper. "He is showing us that one person can make a difference." His efforts won't fix Kash-

The Doctor Who Heals With His Voice

In the winter of 2011, when my mother's blood sugar kept rising despite months of treatment, we were desperate. She had been diagnosed with Type 2 Diabetes, and like many Kashmiri families, we had made rounds of government hospitals and private clinics.

Each doctor adjusted her medicines, ordered more tests, and told us to wait. Nothing seemed to work. She grew weaker, her diet grew stricter, and the uncertainty pressed heavily on all of us.

One day, a cousin suggested we visit a physician named Dr. Irfan Ali, an internist practicing in Srinagar. "He listens," my cousin said.

That simple description felt a big relief. In a place where consultations are hurried, and where patients often leave with more confusion than clarity, the promise of a doctor who listened was enough for us to try.

That morning, we stepped into his modest chamber. My mother sat across from him, weary and anxious. What followed was not a typical consultation. Dr. Ali asked about her fears before he asked about her food. He heard her complaints in full, without interruption. He wrote her prescription neatly, every letter clear.

By the time we left, something in her had lifted. It was not only the medicine that mattered, but the attention.

In the months that followed, her sugar levels stabilized. They have remained under control ever since.

From that day on, he became our physician of choice.

Over the years. I have often thought

Over the years, I have often thought about what sets him apart. Part of it is skill. His training in internal medicine is evident in the care with which he diagnoses. Yet skill alone does not explain the trust he has earned.

What distinguishes him is a way of treating patients that feels increasingly rare: with respect, patience, and a sense that illness is not just physical but emotional.

In 2017, when I went to see him for my own health concern, I noticed it

I was tense when I entered, but the consultation calmed me even before the medicine could. He listened carefully, nodded thoughtfully, and spoke with kindness.

This may sound small, but in Kashmir it is not. Studies show that Jammu and Kashmir has one of the lowest doctor-patient ratios in India. The World Health Organization recommends one

doctor for every thousand people. The ratio is almost double that in the valley, one doctor for nearly two thousand patients.

In large hospitals like SMHS or SKIMS, patients often wait for hours only to be rushed through five-minute consultations. In such a system, listening becomes a casualty.

Yet listening is what Dr. Ali restores. His patients leave with answers, referrals when necessary, and prescriptions they can actually read.

He does not hold on to cases unnecessarily. He refers promptly to surgeons or specialists when the situation demands it. This honesty has made him widely trusted.

I have often wondered why his style matters so deeply to us. Part of it lies in Kashmiri culture itself.

Here, word of mouth is the most reliable referral system. Families discuss doctors over dinner, shopkeepers exchange stories about treatments, and one person's good experience can ripple through an entire neighbourhood.

In this informal network, Dr. Ali's name circulates with warmth. His patients become his ambassadors, through stories of care.

For my family, he has become more than a physician. His office is where we go when we are unwell, yes, but also where we go when we need assurance.

The visit itself is part of the healing ritual. My mother says that she feels better the moment she sits in front of him, even before medicine touches her tongue.

This is what healthcare in Kashmir

often misses. We have capable doctors, many of them highly trained. We have hospitals, though overburdened. Yet what patients crave most is dignity and time.

Looking back on that first visit in

2011, I see more clearly what we were searching for. It was not only a solution to my mother's illness. It was reassurance that someone would guide us honestly through the uncertainty of disease.

In Dr. Irfan Ali, we found that. He has reminded me of what medicine can still be: an act of kindness.

was scrolling through X, formerly Twitter, when a tweet kept appearing over and over. Normally, I scroll past vulgar posts without a second thought. They flood timelines, designed to provoke, amuse, and shock.

But this one stopped me. The words "Recorded secretly" jumped out, and I felt a pang of unease.

The tweet narrated a story about a girl whose friend was secretly recorded by her boyfriend's friend. It described a night when four people went out: the boyfriend, the girl tweeting, the friend who got recorded, and the friend behind the

couple alone. The boyfriend's friend filmed them without consent.

At first, the girl tweeting claims she resisted the situation, seeing her friend being coerced. Yet soon, the story shifted: money exchanged hands, and she helped the boy, allegedly enjoying the unfolding events and making her friend pay for their outing.

Reading it, I felt a deeper chill than the mere vulgarity of the story.

Laws exist to protect women



from harassment, but what about harassment by peers, betrayal among friends? Trust is sacred. We often confide

more in friends than in family. And here, friendship became a weapon. Even if this story is fake, the mere act of framing such betrayal as en-

tertainment exposes a moral decay.
This is not an isolated post. Every day, X and similar platforms overflow with stories designed to shock, provoke, and attract clicks.

The introduction of monetization made things worse: reach equals payout, and vulgarity equals reach. The platform thrives on the most extreme content.

Kashmir, despite its cultural roots, is not untouched. Online, our youth are drawn into a race of who can be the boldest, the most sensational, and the most visible.

The consequences extend beyond clicks. Repeated exposure to pornographic or sexually explicit content alters thought patterns. Suicides follow shame when unmarried girls become pregnant, often after relationships shaped by this imported "modern culture." Young men describe depression, citing loneliness or lack of a girl-

friend as the cause.

Western notions of casual relationships, often glamorized online, have seeped into Kashmir, masking moral consequences with the veneer of freedom.

Islam offers a clear guide. Surah Al-Isra, 17:32, warns: "Do not ap-

proach adultery. It is truly a shameful deed and an evil way."

The Quran forbids even actions leading to adultery, emphasizing moral responsibility before temptation fully manifests.

Scholars explain that Zinah can

Scholars explain that Zinah can happen in many ways, through the eyes, hands, lips, and more. It shows that morality is about the way we think and act. Scholars follow careful rules to interpret religious guidance, but most of us take shortcuts and bend it to our convenience.

Social media exploits these gaps in understanding. It magnifies betrayal, scandal, and temptation. It thrives on exploiting human weakness for visibility and profit.

As I scroll, I feel the tension between ancient guidance and modern temptations. We are witnessing the signs our Prophet Muhammad (SAW) warned about: moral confusion, peer pressure, and fitnah surrounding youth.

The solution is not only regulation but conscious choice, education, and adherence to values rooted in the Quran.

Kashmir values trust and respect, yet social media pushes the opposite. It prizes attention over ethics and voyeurism over care.

We can keep scrolling, or we can pause and reclaim our values.

even consider approaching a committee. Many students say they do not know who sits on those committees or what the complaint process looks like.

Dr. Meenakshi Gopinath, Director of WISCOMP, urged the audience to think beyond rules. "We need a new vocabulary to talk about gender," she said in her keynote address. "Leadership must be empathetic, inclusive, and aware of power structures that silence women."

She pointed to women leaders who have balanced strength with humility, insisting that higher education should cultivate not only knowledge but also a culture of dignity and respect.

The college principal, Prof. Yasmeen Farooq, reminded participants that building a zero-tolerance campus is a collective task. "Committees alone cannot do it," she said. "It requires every teacher and student to stand together."

The sessions unfolded in layers: legal frameworks of the POSH Act, interactive group activities, and role plays that mapped the spectrum of harassment.

In one exercise, When Women Write, participants were divided into groups and given brief case studies to reflect on and discuss. For faculty serving on Internal Committees,

the workshop offered both clarity and solidarity.

"Often, you feel isolated handling cases," said a professor from north Kashmir. "Here, you realize the struggles are shared, and solutions can be shared too."

The urgency was clear. Women's literacy in Jammu and Kashmir has improved dramatically, yet their participation in the workforce remains among the lowest in India.

Experts say unsafe or unsupportive campuses are part of the reason. For students in the hall, hearing senior educators speak openly about harassment was itself a turning point.

"When professors talk about it, it makes us believe things can change," said one student as the day ended.

For her and many others, the workshop was a rare acknowledgment that dignity and safety must stand at the center of education in Kashmir.

## Opposition MPs Protest, Tear Bills

As soon as the Bills were introduced soon after 2 pm, opposition members trooped into the well, raising slogans and some even tore copies in front of Shah for the sight to be captured by cameras broadcasting the home minister's remarks.

A few BJP members, including Union ministers Kiren Rijiju and Ravneet Singh Bittu, stepped out of their seats to prevent opposition members from coming near Shah and waved them to go back to their side of the aisle.

When Congress MP K C Venugopal questioned Shah about his claim of public morality by referring to his arrest in a criminal case when he was the home minister of Gujarat in 2010, the senior BJP leader hit back.

He said he wanted to set the record straight as he had resigned on moral grounds before his arrest on "false" allegations and did not join a constitutional position till he was discharged by the courts

charged by the courts.

"What are they (opposition) teaching us about morality? I had resigned. And I want moral values to rise. We cannot be so shameless that we continue to occupy constitutional positions while facing charges. I

resigned before arrest," Shah said.
Opposition MPs, including AIMIM's
Asaduddin Owaisi and Congress' Manish
Tewari and Venugopal, and RSP's N K
Premachandran, spoke against the introduction, terming the proposed law against the

Constitution and federalism.

The home minister also said that the Bills will be sent to the Joint Committee of Parliament, where members of both Houses, including those from the opposition, would

get an opportunity to give their suggestions. The three Bills are the Government of Union Territories (Amendment) Bill 2025; the Constitution (One Hundred And Thirtieth Amendment) Bill 2025; and the Jammu and Kashmir Reorganisation (Amendment) Bill 2025.

The constitutional amendment bill will require the support of at least two-thirds of the members in both houses. The ruling alliance currently lacks such a majority on its

The Bills have proposed that if prime minister, union ministers or chief ministers, are arrested and detained in custody for 30 consecutive days for offences that attract a jail term of at least five years, they will lose their ichs on the 31st day.

term of at least five years, they will lose their jobs on the 31st day. Demanding that Shah withdraw the Bills. Tewari said they were "squarely destructive" of the basic structure of the Constitution and turned the fundamental principle of the rule of law that a person is innocent till proven guilty on its head.

The Bills give due procedure a go-by and make an investigating officer the "boss of prime minister of India", he asserted.

The Congress MP said the proposed law distorts parliamentary democracy by undermining the will of the people through mere custody bereft of judicial determination. It also opens the door for political misuse by the state's instruments whose arbitrary conduct has been "frowned upon" by the Supreme Court, he added.

Owaisi said it allows executive agencies a free run by becoming the judge, jury and executioner based on flimsy allegations and suspicion, putting chief ministers and ministers at their mercy.

He accused the government of being hellbent on creating a police state, likening it to Nazi Germany's secret police service, the Gestapo.

Venugopal claimed the Bills were aimed at sabotaging India's federal structure.

The home minister, meanwhile, rejected Premachandran's contention that the Bills were brought in haste, saying they will be sent to the joint committee, where members of both Houses would get an opportunity to give their suggestions.

Due to the noisy protests, Speaker Om Birla adjourned the House briefly. The Bills were introduced and then sent to the joint committee after the House reconvened at 3

BJP leaders have linked the need for the Bills to the decision of then-Delhi Chief Minister Arvind Kejriwal to continue to hold the post for months after his arrest in a corruption case and the incidence of several ministers in different states, including V Senthil Balaji in Tamil Nadu, following a similar practice.

## **Centre Should Relook**

Dar said the party hopes these bills will be "relooked".

"These bills are going to the JPC. We hope the concerns raised by the Opposition on the bills are addressed there as well," the NC state spokesperson said.

J&K Pradesh Congress Committee (JKPCC) chief Tariq Karra alleged that the bills reflected the "authoritarian character" of the ruling dispensation at the Centre.

"Rather than further strengthening the states and restoring statehood to J&K, they have shown the whole world their authoritarian mindset and authoritarian attitude under which they are trying to tighten the noose around the neck of a CM or a minister of any state," Karra said here.

PCC president was speaking to reporters after paying floral tributes to former Prime Minister Rajiv Gandhi on his birth anniversary at the party office.

Karra said the Centre should respect the wishes and aspirations of the people of J&K.

"They played with the identity of the people of J&K, took away their constitutional guarantees, the protection of land, resources and jobs. Now, rather than respecting the wishes and aspirations of the people of J&K, they are showcasing their anti-J&K mindset once again," he added.

To a question whether the Congress party will support the signature campaign announced by J&K Chief Minister Omar Abdullah for the restoration of statehood, the JKPCC chief said the National Conference runs as per its agenda, while the Congress party has its own agenda that it follows as it is not bound by compulsions of being in government.

"Do not put your words into our mouth. We are in complete alliance with them (NC), but we are not a part of the government. We have said that we have our own agenda, we had our own manifesto, and they have theirs.

"They talk about statehood in their own way, and we do it in our own way. The aim is the same. But since they are in the government, they may have some compulsions that the Congress does not have. So, we have openly launched a struggle for the restoration of the statehood," Karra added. (PTI)

Once the legislation is passed by both Houses of Parliament, offering or facilitating online money gaming will be punishable by imprisonment of up to 3 years and/or a fine of up to Rs 1 crore.

The bill also seeks to prohibit advertisement related to online money games and bars banks and financial institutions from transferring funds for any of such games.

Advertising of money games can attract imprisonment up to two years and/or fine up to Rs 50 lakh. Facilitating financial transactions related to money games can lead to imprisonment up to three years and/or fine up to Rs 1 crore.

Repeat offences attract enhanced penalties, including 3-5 years' imprisonment and fines up to Rs 2 crore.

Offences under key sections are sought to be made cognizable and non-bailable. Online money game is one played by a user by depositing money in expectation of

winning monetary and other enrichment. The bill outlaws all online betting and gambling (satta and jua) activities -- from online fantasy sports to online gambling (like Poker, Rummy and other Card games)

and online lotteries.

Talking to PTI after passage of the bill by the Lower House, Vaishnaw said online money gaming has become a serious social and public health issue, with proven significant negative impact on society.

"Our endeavour is to promote eSports and social gaming, online social gaming, and we

would like India to become a game-making hub. For that, a lot of efforts are already being made," he said.

The minister said so far as digital technologies go, online gaming has emerged as a "major sector" with three main segments.

"Two segments, eSports and online social gaming, are good for society. We are promoting two out of three segments... These two will get legal recognition and they will be promoted. And this bill will create an authority which basically creates programs and schemes which promote eSports and online social gaming," Vaishnaw said.

The third segment, online money gaming, is causing harm to the society, he said, adding that this has emerged as a major social and public health problem.

Endorsements by top cricketers and film stars have incited interest in real money gaming apps such as fantasy sports betting games offered by Dream11, Games24X7, and Mobile Premier League.

There is a realisation that online gaming has become a major problem for the society, a senior official said, adding that the government has decided to keep the welfare of people above revenue loss from its ban.

According to the bill there will be a regulator for eSports, educational platforms, and social games. It seeks to completely ban offering, operating, or facilitating online money games, irrespective of whether based on skill, chance, or both.

The bill seeks to "ensure the responsible use of digital technologies", "maintain public order and protect public health" and "safeguard the integrity of financial systems and the security and sovereignty of the state".

Additionally, online money gaming platforms are often misused for financial fraud, money laundering, terror financing, and messaging activities that compromise national security.

The legislation aligns digital domain with existing laws for corresponding activities in the physical world, wherein betting and gambling are restricted or punishable -- such as in the Bharatiya Nyaya Sanhita, 2023 as well as various state government legislations.

The bill recognised e-sports as a legitimate form of competitive sport in India, for which the Ministry of Sports will frame guidelines and standards for conduct of such events.

For online social games, the Ministry of Electronics and IT (MeitY) and the Ministry of Information and Broadcasting (MIB) will extend support to online games that foster educational and cultural values, skill development and social engagement.

Citing "psychological and financial harm" that can be caused by such games, the bill says that no person "shall offer, aid, abet, induce or otherwise indulge or engage in" the offering of online money games and such

Industry bodies representing real money game players -- India Gaming Federation (AIGF), the E-Gaming Federation (EGF), and the Federation of Indian Fantasy Sports (FIFS) -- in a letter to Home Minister Amit Shah raised concerns over the bill saying the online skill gaming industry is a sunrise sector with an enterprise valuation of over Rs 2 lakh crore and annual revenue exceeding Rs 31,000 crore

It contributes over Rs 20,000 crore in direct and indirect taxes annually and is projected to grow at a 20 per cent compound annual growth rate (CAGR), doubling by 2028, the industry bodies said.

However, another section of the gaming industry, came in support of the bill.

NODWIN Gaming Co-Founder and MD Akshat Rathee said the government's intent to recognise and promote esports is an encouraging step towards building a structured and globally competitive ecosystem.

Animesh Agarwal, Co-Founder and CEO of S8UL, said by drawing a clear line between skill-based competitive gaming and betting, the bill safeguards the integrity of the ecosystem while opening doors for structured growth.

"Such unsafe food items pose a grave threat to the lives and health of thousands of unsuspecting consumers, exposing them to potentially fatal diseases including food poisoning, salmonella, E. coli contamination, and other zoonotic infections," the petitioner

Despite repeated seizures and media reports highlighting the problem, the petitioner says that authorities have "failed" to take effective, sustained action to prevent the menace.

The petitioner contends that this "inaction" constitutes a violation of the fundamental right to life under Article 21 of the Constitution of India and breaches multiple statutory provisions including the Food Safety and Standards Act, 2006 and related regulations, as well as the Jammu & Kashmir Municipal Corporation Act, 2000.

The petitioner says that the State's constitutional duty under Article 47 to improve public health and nutrition is being "undermined by this neglect".

Among others, the petitioner seeks enforcement of food safety laws, accountability of authorities, and directions for the establishment of stringent preventive and monitoring mechanisms to ensure that only safe, hygienic meat and poultry products are permitted for sale in J&K, thereby protecting public health and upholding constitutional guarantees.

The petitioner says that in Jammu & Kashmir, meat and poultry consumption is predominantly by the Muslim majority population, for whom adherence to "Halal dietary principles is not merely a preference but a religious obligation.

"Given this demographic reality, "Halal

certification" of all meat and poultry products is not just desirable, but necessary to safeguard religious rights, public health, and consumer trust," the petitioner says, adding, "The recent discovery of large quantities of rotten meat in Kashmir has underscored the urgent need for strict regulatory mechanism."

Such incidents reveal serious lapses in quality control, hygiene standards, and supply chain monitoring, the petitioner says.

The petitioner has sought directions to the government to ensure all necessary measures to prevent the sale, storage, distribution, and transportation of rotten, unhygienic, and unsafe meat and poultry products in IRAK

He has also sought establishing and implementing, within a time-bound framework, a permanent inspection and monitoring mechanism at all entry points, slaughter-houses, and markets to ensure that all meat, fish and poultry products entering and sold in the J&K are duly certified safe for human consumption by competent veterinary authorities.

The petitioner also seeks direction to the authorities to strictly enforce the provisions of the Food Safety and Standards Act, 2006, the Food Safety and Standards (Licensing and Registration of Food Businesses) Regulations, 2011, the Jammu & Kashmir Municipal Corporation Act, 2000, and all other applicable laws, rules, and regulations relating to the sale and handling of meat and poultry products. Besides, he has sought directions to the authorities to conduct regular, surprise inspections of markets, cold storages, restaurants, and slaughterhouses, and to seize and destroy all unsafe meat products found unfit for human consumption, maintaining public records of such actions for transparency.

He has also sought directions to prosecute and penalise all persons, traders, and entities found guilty of selling, storing, or transporting unsafe meat products, in accordance with the penal provisions of the FSSA, the Bharatiya Nyaya Sanhita, 2023, and other applicable laws.

Principal Secretary, Home, Chandraker Bharti on Wednesday chaired an hour-long meeting with senior civil, police, Army and paramilitary officers in Kishtwar town and discussed the ongoing rescue and relief operation in detail.

Bharti visited the scene following an order issued by Lt Governor Manoj Sinha on Tuesday and undertook a comprehensive assessment of the ground situation.

The official engaged with local residents and held detailed interactions with rescue personnel and civil administration teams, besides evaluating the immediate requirements of the affected families to ensure the timely delivery of relief measures.

The Principal Secretary underscored the need for a swift, coordinated and sustained response from all departments and agencies concerned to maximise rescue outcomes and accelerate relief and rehabilitation efforts.

The flash-floods triggered by the cloudburst left a trail of destruction, flattening a makeshift market, a langar site for the annual Machail Mata yatra, damaging 16 houses and government buildings, three temples, four water mills, a 30-metre-long bridge, besides over a dozen vehicles.

The joint teams of police, army, National Disaster Response Force (NDRF), State Disaster Response Force (SDRF), CISF, Border Roads Organisation (BRO), civil administration, and local volunteers are engaged in the rescue efforts.

Army engineers on Sunday built a Bailey bridge over Chisoti nullah, providing muchneeded connectivity to the village and the Machail Mata shrine. The Army has also inducted a couple of all-terrain vehicles as part of the efforts to intensify the rescue and relief operation.

The rescuers also conducted over half a dozen controlled explosions to blow up giant boulders hampering the search.

The annual Machail Mata yatra, which

began on July 25 and was scheduled to conclude on September 5, remained suspended for the seventh consecutive day on Wednesday. However, authorities will allow a group of devotees carrying 'Charri' from Jammu and is expected to reach the shrine on August 21 or 22.

The 8.5-km trek to the 9,500-foot-high shrine starts from Chisoti, located about 90 km from Kishtwar town.

Omar directed all the departments and district administrations to focus on revenue realisation and social inclusion schemes, and monitor the progress on a monthly basis rather than leaving corrective measures to

the last quarter of the fiscal.

"Departments must not wait till February or March to chase revenue targets. Each department will receive specific communication from the finance department flagging their areas of concern and giving a six-month revenue target breakdown. They should start working on improving revenue realisation today, with a clear monthly plan," Omar said.

He said the deputy commissioners will be receive district-specific instructions from the finance department, particularly regarding the coverage of social welfare schemes such as the PM Jan Dhan Yojana, PM Suraksha Bima Yojana, PM Jeevan Jyoti Bima Yojana, Atal Pension Yojana, Integrated Social Security Scheme, and widow, old-age and disability pensions.

"We will conduct another review of the social welfare schemes after three months, and I expect to see a significant improvement in coverage at the district level," Omar said.

The chief minister called for expediting the finalisation of work plans under the CDF and to upload the works on the BEAMS portal.

He also gave instructions that the MLAs be informed about the works included in the UT and District Capex plans, which were prioritised by the MLAs during the pre-budget meetings, and to intimate them about the works found unviable.

The chief minister cautioned that delays in revenue mobilisation could force the government to take difficult decisions, such as imposing cuts in department expenditures.

"If departments do not want to find themselves in a position where their expenditure is curtailed, they must focus on improving revenue realisation. The responsibility lies with each department to ensure timely progress," the chief minister said.

SRINAGAR: Chief Secretary, Atal Dulloo on Wednesday held detailed deliberations with a delegation from the International Crops Research Institute for Semi-Arid Tropics (ICRISAT), Hyderabad, to advance the agenda of Climate Smart Agriculture in the Union Territory of Jammu and Kashmir.

The delegation, led by Dr. Stanford Blade, Deputy Director General, ICRISAT, also included Senior Scientists, Dr. Manzoor Dar and Dr. Demaris Odeny, while Professor Haroon Naik, Director Research, SKUAST-Kashmir, was present during the meeting.

The discussions primarily revolved around the establishment of Himalayan Centre of Excellence for Dryland Agriculture at SKUAST-K, envisioned as a landmark initiative to position J&K as a leader in climate-resilient and sustainable agriculture.

The proposed Centre will serve as a hub for research, innovation and technology dissemination suited to the unique agro-ecological conditions of the Himalayan region. Its focus areas will include

development of climate-resilient crop varieties, strengthening decentralized seed systems, promoting regenerative and dryland farming practices and advancing soil and water conservation besides enhancing farmer-centric value chains across the UT.

A key part of the deliberations

A key part of the deliberations highlighted the critical importance of fodder security for J&K. With a large proportion of farming households dependent on livestock particularly in hilly and rainfed areas.

The Chief Secretary was apprised of the urgent need to strengthen fodder development programs. He was informed that ensuring year-round availability of quality fodder would improve livestock productivity and enhance both nutritional and livelihood security for rural communities.

The Centre of Excellence is expected to integrate the crop-live-stock systems, advanced research, and farmer-focused innovations, thereby contributing to sustainable livelihoods, resilience against climate shocks and long-term prosperity of J&K's farming communities in the times to come.

# Top Indian Athletes Set To Compete In Dal Lake's Water Sports Festival

**SRINAGAR:** Some of the best canoe, kayak and rowing exponents from across the country will vie for supremacy at the iconic Dal Lake when the inaugural Khelo India Water Sports Festival commences here on Thursday.

The three-day event will see more than 400 athletes compete for 24 gold medals in the three water sports disciplines with Uttarakhand, Madhya Pradesh, Odisha and Kerala expected to dominate

The KIWSF is the first consolidated Open-age category championship where all 14 kayaking & canoeing events and 10 rowing events, which are part of the Olympic curriculum, will be held. The first edition of the KIWSF



will also have three demonstration events - water skiing, 'shikhara' boat spring and dragon boat race - to add more glamour

to the event.
A total of 36 states and union

territories are participating in the festival.

Suhani Meena, a rower from Madhya Pradesh who will be competing here, said the KI-WSF was a great opportunity to showcase her talent.

The qualification standards for all medal events have been kept very high. In kayaking and canoeing, the last nationals held at Tehri (Uttarakhand) in November will be the benchmark.

The top 15 in singles and doubles and the top-eight in fours will participate in KIWSF. In rowing, only the top-eight from the nationals held in Bhopal in March this year will be eligible.

The country's leading rower, Army man Arjun Lal Jat, representing Delhi here, will be one of the star attractions. Jat, 28, has taken part in the 2020 Tokyo Olympics and won silver in the light-weight double sculls at the Asian Games in Hangzhou in 2023.

The KIWSF will see almost

equal representation from men and women. Of the 409 athletes competing for medals, 202 will are female. Madhya Pradesh (44), Haryana (37), Odisha (34) and Kerala (33) will have some of the largest contingents at KIWSF 2025, while Gujarat, Puducherry and West Bengal will have the smallest teams.

Nitish Chaudhary, a two-time national silver medallist from Rajasthan, said, "For a water sports athlete like me, the climate and the facilities here are amazing."

Three gold medals - in kayaking and canoeing - will be decided on day one. All 10 rowing finals are slotted on August 23.

The opening ceremony, expected to be attended by the union minister of state Raksha Khadse, will be held on Thursday.

# Online Gaming Bill: Cricket Industry's Revenue Could Be Hit

NEW DELHI: The 'Promotion and Regulation of Online Gaming Bill 2025', which was introduced in the Lok Sabha on Wednesday, could spell the end of "real money gaming platforms", that have stakes in the sponsorship market of Indian sports, most significantly cricket.

The contents of the bill, which aims to regulate one of the fastest growing industries, is music to the ears for the Esports fraternity in the country.

But the multi-billion dollar fantasy gaming industry comprising companies that have spent big money in sponsorship of cricket might see a marked dip in their revenues.

And as a chain reaction, it could also affect the sports sponsorship market, including individual players' sponsorship and franchise-based domestic leagues of disciplines like kabaddi and football.

The Online gaming regula-

tion bill looks to create a regulatory body that will look after four diverse segments -- Esports, educational gaming, social and casual gaming and real money gaming. Of these, there will be restrictions on online money games, states the document which is in possession of PTI.

As per "PROHIBITIONS" clause: "No person shall offer, aid, abet, induce or otherwise indulge or engage in the offering of online money game and online money gaming service.

"No bank, financial institution, or any other person facilitating financial transactions or authorisation of funds shall engage in, permit, aid, abet, induce or otherwise facilitate any transaction or authorisation of funds towards payment for any online money gaming service."

The "OFFENCES AND PENALTIES" clause clearly terms real money gaming as a criminal offence which could lead to jail and humongous fine for the service provider.

# Spinner Kuldeep Yadav Slips To Third In ODI Rankings

DUBAI: India wrist spinner Kuldeep Yadav has slipped to third place in the latest ICC ODI rankings for bowlers released on Wednesday with South African tweaker Kehsav Maharaj reclaiming the top position.

Maharaj regained the top position after helping his team beat Australia by 98 runs in the first ODI of their three-match series in Cairns.

The 35-year-old left-arm spinner, who was named Player of the Match after grabbing five for 33, overtook Kuldeep and Sri Lanka's Maheesh Theekshana to the top spot, which he had earlier held briefly in November

and December 2023.

Apart from Kuldeep, Ravindra Jadeja is the only Indian bowler who is in the top 10 in the updated list.
The Indian team has not

played an ODI match since their title triumph in the Champions Trophy.

In the men's batting rankings, Shubman Gill continues to top the list with 784 points, with Shreyas lyer being the other Indian in the top 10 at sixth position.

In the men's T20I rankings, India's Abhishek Sharma and Tilak Varma remained on the top two places with skipper Suryakumar Yadav in the sixth spot and Yashasvi Jaiswal in 10th position.

# **SA's Subrayen Reported For Suspect Bowling Action**

outh Africa off-spinner Prenelan Subrayen was reported for a suspect bowling action during the first one-day international against Australia, the ICC said on Wednesday.

"The match officials' report specified concerns about the legality of Subrayen's action," the ICC said in a statement.

Subrayen picked up 1-46 in his debut ODI against Australia on Tuesday as South Africa romped to a 98-run win to lead the three-match series 1-0.

The 31-year old Subrayen has 14 days to undergo an independent assessment of his bowling action at an ICC-accredited testing laboratory. He is allowed to bowl until the results of his tests are known.

The rule allows a bowler 15 degrees of elbow extension when he delivers the cricket ball. This is not the first time that the off-spinner has come under scrutiny. (AP)
