# **2 Govt Employees Sacked Over Terror Links**

Srinagar: Jammu and Kashmir Lieutenant Governor Manoj Sinha on Friday terminated the services of two government employees in the Union Territory over their alleged involvement in terror activities, officials said.

The sacked employees were identified as Siyad Ahmad Khan, an assistant stockman in the Sheep Husbandry Department residing in the Keran area, and Khurshid Ahmad Rather, a school teacher from the Karnah area -both in north Kashmir's Kupwara

Article 311 (2)(c) of the Constitution was invoked to terminate their services after investigations by security and intelligence agencies established their involvement, they said. Both of them are currently lodged in the Kupwara district jail.

According to officials, Rather is accused of working as an overground worker (OGW) for the Lashkar-e-Taiba.

A probe revealed that Rather, who was appointed under the Rehbar-e-Taleem scheme in 2003 and confirmed in 2008, allegedly procured and | More on P6

# ₹1 Million Loan Fraud: Poor **Teacher Left Paying EMIs**

Srinagar: A humble village teacher from Mujpathri in central Kashmir's Budgam district has been battling a nightmare for the past two years after falling victim to a shocking cyber fraud.

In early August 2023, Jalaludin had already noticed suspicious withdrawals from his salary account and rushed to the local J&K Bank branch, asking officials to freeze his account. But as banking hours had ended, staff reportedly kept his application pending and directed him to approach



# **IIT-B Researchers Assess Feasibility Of DSWC Systems For Cooling Data Centres**

mid rapid expansion of data centres driven by growing demand for digital services, researchers at the Indian Institute of Technology (IIT) Bombay on Friday said they have come up with a new methodology to assess the feasibility of Deep Seawater Cooling (DSWC) systems.

Researchers from IIT Bombay, under the guidance of Prof Gurubalan Annadurai, have unveiled a comprehensive methodology to assess the feasibility of DSWC systems, presenting an alternative to conventional, energy-intensive cooling methods.

"As the planet warms and our digital footprint expands, finding energy-efficient and sustainable cooling solutions is a critical necessity. In DSWC systems, cold water from deep ocean layers is transported through long pipelines to land-based facilities," said Dr Kashish Kumar, a postdoctoral fellow at IIT Bombay and the lead author of the study.

The new study presents a framework that enables the precise calculation of the resources required and the payback period on investments, while implementing a DSWC system based on the prescribed methodology.

According to the International Energy Agency, data centres accounted for approximately 1-1.13 per cent of global electricity consumption in 2022, a figure projected to rise significantly in the coming years, the report stated. Cooling these server-packed facilities is a sig-



nificant part of this energy burden, often consuming up to 40 per cent of a data centre's total

This demand is expected to more than double by 2030, primarily driven by the expansion of Artificial Intelligence.

While the depths of the ocean offer easy solution to our cooling needs, transporting large amounts of water over long distances, while maintaining its temperature and rate of flow, can be cost-intensive to both install and oper-

"As the cold water travels through warmer upper ocean layers, it can absorb heat and become less effective for cooling. Each segment (of pipeline) is also exposed to harsh marine conditions, including salinity, high pressure, and biological activity (biofouling)," said Dr Kumar while explaining the challenges of using DSWC. In tropical oceanic regions, particularly around the equator and extending into low latitudes such as the Andaman and Nicobar Islands, sea-

sonal variations in seawater temperature, especially at depths beyond 100 metres, are minimal, she explained.

"This consistent deep-sea temperature ensures that the DSWC system delivers reliable cooling performance throughout the year, without requiring seasonal modifications or recalibrations," Dr Kumar added.

Researchers found that when applied to a data centre with a 100 MW cooling load in a tropical region like the Andaman and Nicobar Islands, a DSWC system could achieve an impressive annual energy saving of 79 per cent.

The approach promises substantial environmental benefits, including over 79 per cent annual reduction in carbon dioxide emissions, the study revealed.

However, the researchers acknowledge certain limitations, as their study relies on some simplifying assumptions, such as fixed supply air temperature and heat exchanger performance based on standard guidelines, which might vary in real-world scenarios.

The system also performs economically and operationally better in coastal regions with easy access to deep ocean cold water.

Nevertheless, the framework developed allows for investors to carefully assess the economic and technical feasibility of switching from conventional to DSWC systems.

By harnessing the naturally cold temperatures of the deep ocean, DSWC systems can alleviate strain on electrical grids, lower operational costs for businesses, and contribute substantially to reducing greenhouse gas emissions, Dr Kumar said.

Developing nations may benefit immensely, particularly island nations and coastal regions. However, international cooperation, technology transfer, and targeted policy support (green finance or infrastructure subsidies) are essential for scalability," Dr Kumar added.

# **Researchers Observe Mathematicians Describe Unpredictability Prior To 'Eureka' Moment**

inutes before a mathematician had a breakthrough 'eureka' moment, re-**L** searchers saw subtle changes in their behaviour that notably became less predictable -- findings offer a new window into understanding human creativity, they said. Derived from the ancient Greek language, the word is famously known to have first uttered by the mathematician and inventor Archimedes, when he discovered the principle of bouyancy while taking a bath and ran naked down the streets shouting 'Eu-

However, how these sudden 'eureka' moments -- that drive progress in science and mathematics -- happen remains shrouded in mystery, the researchers from the US' universities of California Merced and Indiana said in the study published in the journal Proceedings of the National Academy of Sciences.

The team videographed six PhD-level mathematicians as they worked out "notoriously tough problems" from the William Lowell Putnam Mathematical Competition -- considered a premiere one at the university level -- on a blackboard.

Analysing more than 4,600 momentto-moment interactions with blackboard "inscriptions" that included



writing, pointing, erasing and shifting attention, the researchers observed that the mathematicians' behaviour became measurably less predictable in the minutes before suddenly exclaiming 'aha!' or 'I see it!'. Familiar patterns of moving between

ideas gave way to novel, unprecedented connections, the team said. "Using naturalistic video recordings of mathematicians working on proofs 'in the wild' (i.e., in their own offices and seminar rooms), we show that insights that appear to come out of nowhere are actually prefigured by changes in how mathematicians are writing and gesturing," the authors wrote.

They used analytical methods from statistical physics and theoretical ecology to understand the onset of 'eureka' moments.

Using information theory -- a math-

ematical analysis of concepts, parameters and rules that influence how a message is conveyed -- the researchers quantified the unpredictability prior to the 'eureka' moment and found that it reliably ramped up before insights were verbalised.

"This is one of those discoveries that was possible only because we made connections between very different scientific disciplines," senior author Tyler Marghetis, Assistant Professor of Cognitive and Information Sciences, University of California Merced, said.

"We took ideas from ecology and physics, added tools from information theory, and combined them with a century of work on the psychology of creativity," Marghetis said.

The authors added that even though the study focussed on expert mathematicians, the methodology can be applied in any field where thinking unfolds in observable steps, such as a chemist sketching molecular bonds, or an artist exploring new forms

The study's approach could help scientists better understand the microdynamics of creativity and, perhaps, even predict breakthroughs before they happen, the authors said.

"Our method for inferring when mathematicians are on the cusp of a breakthrough is quite general, so it may apply to other systems that generate a time series of discrete, symbolic events." they wrote.


tive disclosure by public authorities and regular transparency audits to assess the effectiveness of the RTI framework.

# **Kashmir's New Stage Is Streaming**

he valley has always been a place of stories. They live in its songs, papier-mâché patterns, poetry recited in community gatherings, and youth waiting for a stage What Kashmir has lacked is a platform large enough to carry these voices beyond its mountains. That pos-

sibility is finally arriving with the rise of streaming services.

Later this month, Prime Video will release Songs of Para dise, a musical drama inspired by the life of legendary singer Raj Begum. The film, directed by Kashmiri filmmaker Danish Renzu, brings back the voice of a woman who once sang her way into the conscience of the valley. More than nostalgia, its global release signals a new beginning for Kashmiri creativity

For decades, the region has been absent from the map of Indian cinema. Kashmir has provided the backdrop for countless Bollywood romances, yet the valley itself has not pro duced a mainstream feature film or web series that tells its own story. Local artists have worked in fragments while waiting for opportunities that never arrived.

Streaming platforms can change this. India already has nearly 50 million paid OTT subscribers, and the audience is hungry for authentic, place-rooted stories. Series like Mirzapur or Delhi Crime have shown how regional narratives, when well told, can capture international attention. There is little reason why Kashmir's cultural icons cannot travel the

The potential is vast. Folk musicians struggling to preserve wanvun traditions, artisans painting walnut wood with age-old patterns, and young filmmakers scripting on laptops in cramped Srinagar rooms carry stories that could find global resonance.

With the right investment and platforms willing to take risks, Kashmiri talent can move from margins to mainstream

The stakes are more than cultural. Kashmir's economy remains fragile. Youth unemployment is among the highest in the country. A thriving creative sector, powered by digital distribution, can create livelihoods while also reshaping how the world sees Kashmir.

The valley has waited long enough for its creative voices to be heard. The release of Songs of Paradise shows what becomes possible when a Kashmiri story is carried by a global platform

Streaming services now have the chance, and the responsibility, to open the door wider. Behind it stand thousands of young artists, ready for the world.

# **Waste Piles Up While Wars Take the Blame**

Officials in Jammu and Kashmir are blaming Operation Sindoor for failing to clear toxic garbage. The river, and the people who drink from it, are paying the price.

When floods devastated the vallev in 2014, officials in towns untouched by water suddenly claimed their records had been "washed away.

Requests under the Right to Information Act were stonewalled with this excuse. The damage became less about nature and more about officialdom shielding itself.

The same story is unfolding again in Poonch. This time the scapegoat is Operation Sindoor, a security offensive launched in May after the Pahalgam attack.

The operation lasted barely three or four days. Yet when the National Green Tribunal (NGT) pressed the local administration to remove mountains of garbage choking the Pulast Nadi, the Assistant Commissioner Development, who also heads the Municipal Council, claimed the waste could not be cleared because of the Op Sindoor.

The tribunal's order was unambiguous. On April 9, it directed that all "legacy waste" dumped along the Poonch river must be removed by August 31.

That gave the municipality almost five months. Even after Operation Sindoor ended, officials had weeks to begin work. They did nothing.

By the time the case was listed again on August 19, less than 10 percent of the waste had

Faced with an angry bench led by Justice Prakash Srivastava, the officer changed tack. He promised that all waste would be cleared by November 30. The NGT forced him to submit an undertaking within ten days.

What happened days before that hearing

On August 16, municipal workers drove JCB machines straight into the dump site and pushed tons of waste into the river itself. The act was recorded by local residents who shared geotagged videos and photographs.

The attempt was cynical: make the dumping ground look cleaner in photographs while the garbage simply disappeared into the current.

I alerted Deputy Commissioner Ashok Sharma, who had only recently taken charge, and sent him the evidence. He stopped the work

immediately. Yet reports suggest it silently re-

More than administrative laziness, this is environmental crime that violates the Municipal Solid Waste Rules of 2016 and the Water (Prevention & Control of Pollution) Act of 1974.

The Poonch river supplies drinking water to thousands downstream. Every bag of waste pushed into its waters seeps into kitchens and stomachs.

The NGT has already imposed a penalty of Rs 1.62 crore on the Municipal Council for continuous violations. Earlier, it even fined the Deputy Commissioner personally for failing to act.

Officials had secured 12 kanals of land near Kassalian village for scientific waste disposal. The land lies unused. Instead, the garbage keeps flowing into the river under Sher-e-Kash-

Ordinary residents have shown more urgency than officials. Hindu, Sikh, and Muslim groups have jointly petitioned the administration to act. The Sanatan Dharma Sabha Poonch wrote to the DC this month, calling the dumping "unscientific and dangerous." Activists like Lokesh Sharma have taken the issue to the press.

This unity is rare and powerful. It shows that communities understand what is at stake:

clean water, safe air, and dignity. I first visited the Poonch dump site in 2016 and wrote about the danger it posed. After years

of broken promises, I went to the NGT in 2023. Since then, the tribunal has repeatedly grilled the administration. Little has changed

Each deadline leads to another, each order meets another excuse. This time, the excuse was Operation Sindoor.

By invoking a counter-terror operation to justify civic failure, officials not only trivialized their responsibility but also insulted the seriousness of the operation itself. Security cannot be used as camouflage for mismanagement.

Jammu and Kashmir's rivers are lifelines. They irrigate fields, power turbines, and fill taps. To poison them with untreated garbage is to endanger every family downstream. It is negligence dressed as governance.

The Chief Secretary of Jammu and Kashmir must hold the Poonch administration accountable. Statements made to the country's highest environmental court cannot be shrugged off as casual falsehoods. The officials who misled the NGT and endangered public health should face disciplinary action.

The river flowing through Poonch carries centuries of history and sustains a district. Today it also carries the stench of decay and delay.

Unless we act, the region's waters will become repositories of excuses rather than sources of life.

ne United States, as gleaned from mainstream' media and the hullabaloo raised thereof, appears to be in crisis mode, almost on the verge of decline, taken over by the forces of irrationality.

But this is a caricature, even from afar. The proverbial marrow of the problem appears to lie in a mélange of ideological and extreme form of liberalism, the concept and idea of man(woman) that emerges from this-classical and modern, and variants of nationalism elaborated upon by Herder, Rousseau and so on.

To throw this broad assertion into sharp relief, consider extreme ideological liberalism and the concept(s) of man(woman).

This form of liberalism fawningly and grovelingly elaborated upon by a person of Francis Fukuyama fame, in his, 'End of History' thesis postulated that liberal democracy was the last bastion of mankind. This ideology reckoned that all peer competitors had all died and there was no serious competitor to it.

And that a new man(woman) had emerged from liberal democracy's 'triumph'. Because of these, virtually, practically and philosophically history had ended.

The 'new' man(woman) was a modern one, not encumbered by the 'detritus' of tra-

dition, custom or any other 'baggage'.

Undercutting the western classical concept and idea of man(woman), which held the human being to be defined by purpose whose goal was the cultivation of virtue, this concept reduced humans to a bundle of 'utils' driven merely by utilitarian urges (pleasure maximization and pain minimization), emotional 'baggage', social influences and socialization into these (so called 'nurture versus 'nature') and other assorted 'prejudices'.

The ideology of extreme liberalism preened and postulated that it would liberate mankind from these

Inhering in the pretenses of liberal democracy was universalism best reflected in Fukuyama's assertions (paraphrased here) that 'even though it was in America that Liberal democracy had reached its apogee, the rest of the mankind would follow with

both the push and pull factors. This universalism could, after being given a jolt or a push, resonate in and among all peoples of the world. It would appear that in reified form liberal democracy's push was globalism, another ideology where economics and its vision of man(woman) came to

rule the proverbial roost. Allied to a narrow vision and idea of nationalism where Rousseau's 'general will' was wed with it, the globalist experiment

began in the United States, leaving its mark on all spheres of life.

Thus began the dissipation of the 'organic' concept of the nation and nationalism adumbrated by Johanne Herder, and the privileging of 'homo economics', bound together in a spaghetti bowl of 'multiculturalism'.

In this schema, the liberal canards were apparently held together by multi-culturalism with open immigration policies.

The larger idea seemed that in the sphere of immediacy, cultures that migrated to the US would retain their power. But in the 'long duree' scheme these too would dissolve in the liberal mush.

All this is not to demean liberalism which has some really redeeming features like tolerance and toleration but to put extreme liberalism into perspective.

When the 'general will' was elevated to the position of the sovereign, nationalism in the US lost its 'sting'. But humans being human need an anchor to give sense and meaning and even stability to their lives. To give people that, in the US, extreme liberals concocted and conjured the idea of 'civic nationalism'.

While in the 'roaring nineties', the end of the cold war (which had given people in the US some degree of stable expectations) and the heyday of globalization, the occlusion of Herder's idea of organic nationalism, the elevation of 'the general will into a sovereign status' and fetishizing 'civic nationalism', the undercurrents of resistance to these remained obscure.

But gradually, these came to the fore when the 'vox' (people) of the US saw their world-familiar, stable and known- dissipate. (It may be that the 2008 financial crisis was the proverbial crisis that opened the pandoras box.)

In any nation other than America, the resistance would have taken the form of revolution. But in the US, it took the form and shape of 'populism' emblematized by Donald Trump.

Parsed and pared to essence then, this populist yearning was a cri de la cœur by Americans to revert to a past or an age where Americanness was not dissolved in globalism (no matter the window dressing and gloss imparted to it), where the nation gave meaning to people's lives and an economic paradigm gave society stability and structure.

In combination, reversion to an organic concept of nation, where economics is not unmoored, leading to the financialization of the economy, where identity is not collapsed in the vortex of civic nationalism and the 'general will,' are the explanatory variables of Trumpism, a movement that is not going anywhere after Donald Trump's presidential term is over.

From a power political perspective and a political party one, it was the democrats who embraced extreme liberalism lock stock and barrel, embracing, for example, identity politics over say bread and butter issues for 'ordinary' Americans and foreign policies where other countries had voice and even veto on these.

The Dems probably believed that the pain was short term and the attendant price to be paid not a great one. But the tides of history and the future have their own 'logic'.

It was ordinary' Americans that resisted and showed their power with gusto in 2016 and 2024.

The question is, will America, at this 'inflection point,' be turbulent and chaotic?

The country will, in all likelihood, revert to a 'golden mean' that is best for its people and their interests. That is, people's interests and the nation's interest will become aligned and congruent.

What about the country's foreign policy? The same could be said for it. If these realignments take root, what is the rest of the world to do? Adjust and realign their people's and state's welfare.

The world is in the midst of a transition brought about by a multitude of forces that include Donald Trump's use of American power.

The attendant 'disruption' need not be deleterious. It can indeed be a force for general good, only when and if countries across the world re-adjust and think of their peo-

# The Hidden War Within Kashmiri Families

Behind the phrase "domestic disputes" is a human rights crisis Kashmir has yet to confront.

n a routine morning in Anantnag, hospital staff wheeled in a young woman with burns covering most of her body. Her inlaws told doctors it was a kitchen accident.

The explanation was familiar, almost rehearsed.

By evening she was gone, another name added to Kashmir's grim ledger of women whose lives end violently inside their own homes.

Across the valley, cases like hers appear with alarming regularity. They are explained away as "domestic disputes," as if the phrase itself could soften the blows, erase the burn marks, or silence the cries of women who die too young.

The term hides a much harsher truth: women in Kashmir are being beaten, set on fire, pushed to suicide, or slowly worn down by relentless cruelty.

Physical violence is only the most visible form. Many women endure constant humiliation, forced isolation, and the sting of being cut off from parents who are told not to interfere.

Some are denied the right to work or have their earnings confis-

Institutions meant to protect women provide little comfort. Laws such as the Protection of Women from Domestic Violence Act and the Dowry Prohibition Act exist on paper, but their enforcement is feeble.

Police often treat cases as family matters, urging reconciliation rather than registering criminal complaints. Court cases drag on for

years, sapping families of money and resolve.

Safe shelters are scarce, mental health services are difficult to access, and many women do not know what legal rights they have. With every institutional failure, perpetrators are emboldened and

victims further silenced. The scale of the problem is re-

flected in numbers. According to the National Crime Records Bureau, Jammu and Kash-

mir registered over 3,000 cases of crimes against women in 2022, a figure experts say barely scratches the surface because so many cases

go unreported. Dowry-related deaths, assaults, and cases of cruelty by husbands or relatives remain among the highest

Each statistic hides a name, a face, and a family that will never recover.

Breaking this cycle requires more than laws. Police and courts must recognize domestic violence as a serious crime, not a quarrel to be patched up.

Communities must confront entrenched norms that tie family honour to a woman's silence. Religious leaders, with their reach and influence, can play a role in challenging the dowry system and the stigma of

Women need safe places to turn to: helplines that work, counseling centers, and shelters where they are not treated as a burden.

They also need financial independence. Skill programs and employment opportunities can give them the means to walk away from abusive homes.

Kashmir's uncertain reality still looms large, shaping daily life and deepening social stress. Yet it cannot be an excuse for ignoring the

violence taking place inside homes. Each woman who dies in the name of dowry, each suicide driven by despair, and each life wasted in silence is a reminder that the valley is fighting a war within its own households.

Beyond private disputes, they are preventable crimes, demanding urgent attention before more names slip silently into the shadows of memory.

Her laughter and care were the pulse of the house. Now, the courtyard and orchard remember her, and so do we.

t is strange to measure absence. My grandmother, Moajie, left us in the early hours of August 15, at 4:19 am, a Friday, as if the valley itself held its breath. Outside, life carried on with its usual cadence, but inside, our nanihaal, the maternal home of Ganderbal, paused. How do you bid farewel to someone whose existence was your first language of love?

A maternal home in Kashmir is incomplete without grandparents. Their presence fills walls with warmth, courtyards with laughter, and even ordinary afternoons with the pulse of belonging.

Moajie was the heartbeat of our home. Her love was ordinary and extraordinary at once. Ordinary in the way a grandmother cares: with food, protection, and endless worry. Extraordinary in how it endured through sickness, and time's unrelenting erosion.

She held us together. In moments of joy, her courtyard became the center of laughter. In moments of fear or hardship, her voice was the thread that turned anxiety into patience.

Childhood in that courtvard was a tapestry of small miracles. Mud walls became palaces. Cherry and grape orchards swelled with sun and wind. Moajie's hands seemed to summon sustenance and stories from an old sandook as if by

Each grandchild carried a piece of her, stitched into the fabric of daily life. We never imagined a day when that thread could fray.

Twenty days before she passed. I went to see her. She was frail. her body no longer her own, her breaths measured by machines.

Two cousins lifted her gently, as one lifts a child. Night pressed against the room. And yet, her eyes found me. "Emis Dichva chai?" Have you served him tea?

Even then, her concern was for others, not herself. When asked who I was, she named me with clarity, as if love itself had summoned memory from a place where it might otherwise have

That night, she asked for kishmish dach, the long green grapes of our valley, the ones that become raisins. I searched for them, hoping to grant her a taste of memory,

only to find none.

The longing itself was an act of grace, a reminder that even love cannot satisfy every desire.

In her final days, Moajie was admitted briefly to SKIMS Soura. When she returned home, frail and fading, she was accompanied by my mother, cousins, and a driver.

And yet, her love lingered in gestures, habits, and the smallest details of everyday life.

validity of the managing committee of 215 such schools has expired and have been reported adversely upon by the intelligence agencies.

Pertinently, in June 2022, the School Education Department had ordered cessation of schools functioning under the Falah-e-Aam Trust (FAT).

SED had said that in pursuant to the directions passed by the High Court, all the students presently studying in these banned institutions shall admit themselves to nearby government schools for the current academic session 2021-22.

The government that time had said that approximately 11000 students were reportedly studying in these schools and institutions run by the FAT, consequent to the ban, the students were allowed to take admission in nearby government schools.

It had also said that no new admission shall be taken in these banned FAT institutions and no further registration of these institutions shall be done,

According to the previous communique, the case of FAT was examined in the department and it was found that the government of Jammu and Kashmir has already declared and banned the FAT association organization to be an unlawful association on 11 May 1990 and October 2019.

In Anantnag district, a total of 37 private schools are listed. These include institutions such as Hazrat Amir Kabir Memorial School Brakpora (HAKMS), Islamia Model School Akingam, Paradise English Medium School Chee (PEMS), Hanfia Islamia Institute Tachloo, Sheikh-ul-Aalam Memorial Institute Nagam, and Gazi Memorial Institute Soaf Shali. The list further features MS Najmiya Islamia, MS English Medium Halmulla, MS Sheikh-ul-Alam Public School, Public English Medium School Veeri, Green Land Public School Chandpora Anantnag, MS New Ira English Medium (NEEMS), Iqra Public High School Katriteng Gundi Nowroz, Shining Public High School Arwani, Public Model School HP Bagh, HS Rehmati Aalam GB Khalil, and Public English School Hakura

The minister said she had suggested in her order that these schools be looked after by the principals of the nearby government schools for three months since their management committee had expired.

She said around 221 schools were given negative verification by the CID, while the management committee of these schools had also expired a long ago. "These schools were facing issues in registration and the future of over 51,000 students was at stake. So, I had mentioned in my order that these school be looked after by the principals of the nearest government schools," she said.

Earlier, the Jammu and Kashmir School Education department ordered the taking over of 215 Jamaat and FAT affiliated schools, asking deputy commissioners to control the management of these schools. The Centre had last year banned Jamaat-i-Islami, a politico-religious outfit in Jammu and Kashmir, for a period of five years over its alleged terror links.

The minister said she had ordered that until these schools get new registration and managing bodies, principles of the nearest government schools will look after these schools for three months. "I had even approved the list of principals who were supposed to look after these schools," she claimed.

She said she has not directed or ordered Deputy Commissioners (DC's) to take over these schools. "The secretary has wrongly mentioned in the order that these schools be taken over by the deputy commissioners. The order that has been issued is not exactly what I had written," she said.

Meanwhile, People's Conference chairman and MLA Handwara Sajad Gani Lone trained his guns on the Omar Abdullah led government, saying the schools have forcibly taken over by the government and that the elected government is a party to all acts undertaken.

"The elected government has passed the order. Shame and shamelessness have assumed new meanings in this government. They are setting new standards in servility. And just to recall the sermons the edicts that this party passed against their opponents. Be under no illusions. This elected government is a party to all acts undertaken. Be it mailings or termination of employees, they are equal partners. They have been equal partners in the past. And they will be equal partners in the future. This is the A team. This was always the A team," he said in a post on X. (KNO)

In line with the roster issued under the directions of Lieutenant Governor Manoj Sinha, Principal Secretary Anil Kumar Singh conducted an on-ground review of the ongoing rescue and relief operations in Chisoti.

Accompanied by Inspector General of Police (Traffic) Suleman Choudhary, Singh carried out a detailed assessment of the situation, interacted with the affected residents, and reviewed the response of rescue teams and the district administration.

He also reviewed the status of road from Atholi to Pallali and Pallali to Machail, and issued necessary directions to authorities. Singh further assessed the pressing needs of displaced families and directed to facilitate prompt relief distribution.

Search teams have focused operations at three key locations: the major impact spot near a langar (community kitchen), the area where several houses were washed away, and Bhuat Nallah in the Gulabgarh-Paddar belt.

Of the total 136 persons initially reported missing, 67 were rescued alive or injured, while 37 bodies have been recovered so far, officials said.

Kishtwar Deputy Commissioner Pankaj Sharma, who is supervising the large-scale rescue and relief operation, said efforts to trace the remaining 32 missing people are continuing.

Sharma, who had reached the spot within hours of the cloudburst, said the search operation in the last nine days included teams from NDRF, SDRF, Army, CRPF, CISF, Police, GREF, civil administration locals and NCOs

Apart from manpower, 30 machines including JCBs, dumpers, rock cutters and excavators, along with 135 vehicles and sniffer dogs, have been deployed, he said. Heavy vehicles, including monster trucks, have been pressed into service to assist in evacuation and relief opera-

Flashfloods triggered by the cloudburst left behind massive destruction — flattening a makeshift market and a langar site for the annual Machail Mata yatra, damaging 16 houses, several government buildings, three temples, four water mills, a 30-metre bridge, and over a dozen vehicles

Army engineers on Sunday constructed a Bailey bridge over Chisoti Nallah, restoring vital connectivity to the village and the Machail Mata shrine. The Army has also inducted all-terrain vehicles to intensify relief efforts.

Rescuers carried out over half a dozen controlled explosions to clear giant boulders blocking search operations.

The annual Machail Mata yatra, which began on July 25 and was scheduled to conclude on September 5, remains suspended for the seventh consecutive day as of Wednesday.

On the same day, Union Minister Jitendra Singh reviewed the rescue and relief operations in Chisoti and said the priority was to trace the people still missing and believed to be buried under the debris.

Leader of Opposition and senior BJP leader Sunil Sharma has been camping in the cloudburst-hit village since August 14, when the incident took place and assisting the relief operations in the area, which falls under his assembly segment Paddar-Nagseni in Kishtwar district.

Deputy Commissioner Kishtwar Pankaj Sharma, who is supervising the large-scale rescue and relief operation for the ninth day on Friday, said efforts are continuing to trace the remaining 32 missing persons.

the long-term permanent rehabilitation may require over Rs 100 to 150 crore.

The Union minister called on civil society to help the administration in curbing illegal encroachments in flood-prone areas.

Singh also assured both financial and material assistance to the affected families. "The initial loss has been estimated at about Rs 25 crore, and the Centre is ready to provide any assistance required by the Union territory administration to deal with the disaster," he told reporters in Kathua.

He further said that the estimate for longterm rehabilitation could go well beyond Rs 100–150 crore. Singh added that houses damaged in the calamity would be rebuilt, and land would be provided to those whose homes were washed away in the flash floods.

Seven members of four families, including five children, were killed and 15 were injured in two separate incidents of cloudburst and landslide in Jodh Ghati village of Rajbagh and Bagra village of Janglote on August 18.

On the occasion, he distributed relief mate-

"Relief camps have been set up in Gati and other places, which are being taken care of by the administration. The Chief Minister has personally reviewed the situation, and a review meeting has also been held where a rough estimate was formulated," he added.

Singh, who visited Ghatti, Janglote, Bhed Blode and Dhol Khad areas, met the affected families and enquired about their well-being. He assured them of all possible help in this difficult time.

Singh, while visiting these areas, directed officials to immediately provide water tankers, solar lights, and medical ambulances to inaccessible areas. He also instructed officials to take measures to prevent the outbreak of any epidemic. He also distributed ration kits from his personal resources.

and withdrawn it overnight, leaving him to shoulder the burden. The teacher, who earns a modest salary, has since been forced to pay monthly EMIs for a loan he never sought.

According to Jalaluddin, hackers withdrew money from his account and even got a loan sanctioned in his name without consent. Despite receiving multiple SMS alerts, the bank did not take immediate action to freeze the account.

"If my account had been frozen immediately after noticing the first unauthorized transaction, this loss could have been prevented. The bank's negligence allowed the hackers to sanction loans and withdraw money from my account," Jalaluddin said:

A bench of Justice P. S. Narasimha and Justice Atul S. Chandurkar said the J&K Expert Appraisal Committee committed "a serious error" by relying on a faulty District Survey

The report had not been prepared under the mining guidelines issued by the Ministry of Environment, Forests and Climate Change in 2016 and 2020. Most critically, it lacked replenishment data, information that measures whether mined rivers can naturally restore themselves.

The judges also faulted the J&K State Environmental Impact Assessment Authority for approving the project despite these lapses. "It is unfortunate that regulatory integrity was compromised," the court said, warning that such shortcuts were exactly how "regulatory failure occurs."

"Had the petitioners been diligent, they could have raised their grievance immediately or at least within a fortnight of the notification of examination dates. The belated representations, thus, lack bona fides and deserve no consideration," she said, adding it would neither be reasonable nor practical to disturb the entire examination process involving more than 31,000 candidates for just four applicants.

Agreeing with the arguments of the senior AAG, the CAT said the contention of the applicants that the dates of examination conducted by the JKSSB are in clash with the dates of the UPSC Main Examination is not a sufficient ground for rescheduling the exam.

It also said that the applicants' concerns do not outweigh the need to maintain the integrity of the recruitment process and the rights of other candidates, who have made arrangements based on the existing examination schedule.

The bench referred to a judgement of the Supreme Court and said both the examinations (one conducted by J&K SSB and the other by UPSC) are of a different nature and different levels.

He was tasked by Pakistan-based handlers to procure and distribute arms, ammunition and narcotics among active terrorists in the Valley. He reportedly received several consignments through the LoC in Karnah. The weapons were supplied to terrorists, while proceeds from narcotics sales were used to fund operations, they said.

His role surfaced after intelligence inputs on January 25, 2024, indicated that two Pakistani terrorists, with the help of four associates, including Rather, were smuggling arms in Kupwara.

Khan, appointed in 2004, was caught with an AK-47 and is accused of sheltering and infiltrating terrorists and smuggling arms.

Investigators revealed that he was in touch with a Pakistan-based handler, who used him for smuggling arms and narcotics across the LoC for further distribution to active LeT

Officials described their actions as "betrayal of national trust", underscoring the administration's zero-tolerance policy against terror support networks within government ranks.

They said the Lieutenant Governor was satisfied after considering the facts and circumstances of the cases and noted that, on the basis of the information available, the activities of the two are such as to warrant their dismissal from service.

More than 70 government employees have been dismissed in Jammu and Kashmir in recent years over alleged terror links.

# No Female Staff In ECG Rooms **Leaves Women Uncomfortable**

SRINAGAR: The non-availability of female staff in ECG (Electrocardiogram) rooms across many hospitals in Jammu & Kashmir has become a cause of concern for female patients, who say they often feel uncomfortable undergoing the test in the presence of male staff.

Several women patients and attendants said that the absence of female technicians not only causes hesitation but also delays timely diagnosis and treatment in many cases.

Shazia Bano, a patient at a district hospital in south Kashmir, said, "I was asked to undergo an ECG last week, but when I saw a male technician inside, I felt extremely uneasy. I waited for hours, hoping a female staff member would come, but there was none. This hesitation can cost patients their health."

Another patient from north Kashmir shared her experience: "The test requires exposure of the chest area, and for women, it is not easy to go through it in front of male staff. Many of us skip the test altogether. The government must deploy female staff in ECG rooms for female patients.'

Doctors also acknowledged the issue, saying that patient comfort is essential in ensuring timely medical intervention. "ECG is a basic and often urgent



diagnostic tool. If patients delay or avoid it due to discomfort, it can seriously affect treatment outcomes. Authorities should take note and address this gap,' said a senior physician who wished to remain anonymous.

Health experts suggest that a simple policy intervention could resolve the issue by ensuring at least one trained female staff member is available in ECG rooms in every hospital.

They said that I&K's health minister is also a woman, and she can better understand the discomfort in this test.

Patients and their families have now urged the Health and Medical Education Department to take immediate steps. "Just like female staff are made available in gynaecology wards, the same should be done for ECG rooms. It is a matter of dignity and comfort for women," said Rukhsana, an attendant at a Pulwama hospital.

They have urged Health Minister Sakina Itoo to look into the matter and take immediate steps in this regard—(KNO)

# Kashmir's Apple Growers Say Modern Grading **Technology Profitable**

**SRINAGAR:** The introduction of modern apple grading lines across Kashmir is revolutionizing the region's apple packing and marketing processes, resulting in improved quality, increased profits for farmers, and the creation of new employment opportunities.

Horticulture has long been recognised as the backbone of Kashmir's economy, with apples serving as its most vital product. A major portion of the local population depends directly or indirectly on this industry for their livelihood.

For years, apple growers voiced concerns over their inability to secure fair prices despite transporting their produce to various markets across the country. Experts say this challenge is primarily due to the lack of proper grading and quality packaging standards. Some stakeholders, with

government support, have established modern grading lines in different parts of the valley. These facilities sort apples based on size and quality before packaging, ensuring systematic and standardized handling.

The impact of this development is already evident. Not only are farmers benefiting directly, but traders, laborers, and transporters associated with the fruit industry are also reaping the advantages of the



improved system.

Previously, grading facilities were mostly limited to cold storage units. Now, with government assistance, similar technology is being introduced at smaller scales, making quality grading accessible to a broader base of farmers.

"With the introduction of grading lines, apples reach markets in a more refined form and in less time. Fresh, well-packed fruits always attract higher demand, enabling farmers to secure better prices," Mehraj Ahmad, a unit nolder in Pulwama said.

Subzar Ahmad, owner of a cold storage unit, explained the difference compared to traditional methods: "Earlier, farmers had to spend extra time and money on packing, yet the quality remained inconsistent. Now, with grading lines, the process is faster and more efficient, allowing farmers to make profits instead of

# Rajouri's Govt Schools Crippled By Infra Gaps

SRINAGAR: The condition of government schools across Rajouri district has reached an alarming low, as efforts at the government level to improve education quality have largely failed to yield results.

Reports and testimonies from residents highlight a grim reality: most schools in the district not only suffer from an acute shortage of teachers but also lack even the most basic facilities, undermining the very purpose of education.

Across various areas and hamlets, schools are plagued by severe infrastructural deficiencies. Students are forced to study without access to essential amenities such as playgrounds, toilets, electricity, and proper sanitation. These shortcomings present significant obstacles to the learning process, especially for young children. In primary and middle schools, the situation is particularly dire, with infrastructure forcing multiple classes to be

areas, the absence of sufficient teachers has left local communities deeply concerned about their children's futures. In some schools, a single teacher is left to manage both primary and middle classes, resulting in a compromised learning environment and increased difficulties for students. Alarmingly, several schools have roofs and walls that are on the verge of collapse, while some are functioning without a roof

going crisis can be found in the Kotranka subdivision, where Government Primary School Taran has remained closed for over a decade. Despite being built at a cost of lakhs of rupees, the building has reportedly been locked by a local family due to a longstanding dispute. # **Over 12.6 Lakh PMUY LPG Connections Distributed In J&K: Centre**

NEW DELHI, AUG 22: The Ministry of Petroleum and Natural Gas has informed the Lok Sabha that a total of 12,69,306 Liquefied Petroleum Gas (LPG) connections have been distributed under the Pradhan Mantri Ujjwala Yojana (PMUY) in the Union Territory of Jammu and Kashmir.

Of these, 2,87,658 connections were provided to beneficiaries belonging to the Scheduled Caste (SC) and Scheduled Tribe (ST) communities, Minister of State for Petroleum and Natural Gas Suresh Gopi said while responding to a question on the scheme's coverage of BPL, SC, and ST fami-

lies across India, including Bihar. Launched in May 2016, PMUY aims to provide deposit-free LPG connections to women from Below Poverty Line (BPL) households, with the broader objective of promoting access to clean cooking fuel among rural and un-

derprivileged communities. The scheme's initial target of eight crore connections was achieved in September 2019, after which subsequent phases including Ujjwala 2.0, expanded its reach further. As of August 2025, more than 10.33 crore connections have been distributed across the country. The Ministry acknowledged that

some beneficiaries face challenges in refilling cylinders due to affordability concerns. To address this, the Government of India has introduced targeted subsidies. As of July 2025, the effective price of a 14.2 kg domestic LPG cylinder for PMUY consumers stands at Rs 553, after a direct subsidy of Rs 300 per cylinder.
