2 Jailed For 10 Yrs, Rs 4.15 **Lakh Fine Imposed**

Srinagar: Two weeks after holding them guilty in connection with a case involving trafficking of psychotropic substances, a court here on Wednesday sentenced two persons to 10 years of jail and imposed over Rs four lakh as fine on them. The court—Special Judge NDPS Cases Srinagar, Vinod Kumar, on September 29 found the duo-Mudasir Sultan Bhat alias Majid and Feroz Ahmad Khan alias Jaja, both residents of Bemina, guilty under Sections 8/22 read

with Section 29 of the NDPS Act.

Mudasir has been also found guilty under IPC Sections of 468, 471(forgery), and 420 (cheating) for orchestrating and facilitating the transport of psychotropic substances under the guise of legitimate pharmaceutical trade.

Pronouncing the quantum of punishment, the court sentenced the duo to ten years rigorous imprisonment under Section 22 NDPS Act (commercial quantity) and imposed a fine of Rs 1,00,000 (minimum

2 Terrorists Killed In **Kupwara**

Srinagar: Two unidentified terrorists were killed as Army troops foiled an infiltration bid along the Line of Control (LoC) in Kupwara district of Jammu and Kashmir, officials here said on Tuesday.

Women Account For 70% Of Autoimmune Disease Patients: Experts

early 70 per cent of people living with autoimmune diseases are women, and it needs to be recognised as a major health issue in the country, according to experts.

The experts at the 40th Annual Conference of the Indian Rheumatology Association (IRACON 2025) said that doctors in India have observed that autoimmune diseases are far more common among women, especially between the ages of 20 and 50, when hormonal and lifestyle factors are

During a special session dedicated to women's health and autoimmune disorders, leading rheumatologists discussed how hormonal changes, genetic predisposition and distinct biological mechanisms make women more vulnerable to such condi-

The discussion highlighted that the female immune system, though stronger in fighting infections, can sometimes turn against the body itself, leading to autoimmune dis-

A recent study by Stanford University has also shed light on this difference. The researchers found that women's bodies produce a special molecule called Xist RNA, which helps control one of the two X chromosomes that women carry.

However, this molecule can sometimes confuse the immune system, making it attack the body's own healthy cells instead of protecting them.

This could be one of the key reasons why autoimmune diseases are seen more often in women

Experts at IRACON 2025 said this scientific discovery supports what doctors in India have observed for years: autoimmune diseases are far more common among women, especially between the ages of 20 and 50, when hormonal and lifestyle factors are

Autoimmune disorders occur when the



body's defence system, which usually protects against infections, mistakenly attacks its own tissues. Common conditions include rheumatoid arthritis, lupus, thyroiditis, psoriasis, and Sjögren's syndrome. These diseases can affect joints, skin, blood

vessels, and even internal organs such as the heart and lungs.

"In my outpatient clinic at AIIMS, almost seven out of every ten patients with autoimmune diseases are women. We see a clear pattern. Women often come late because they overlook persistent symptoms,' said Dr Uma Kumar, Head of Rheumatology at AIIMS, New Delhi.

Genetic make-up, hormonal changes during reproductive age and after childbirth, combined with stress, obesity, and nutritional deficiencies, can make them more vulnerable to autoimmune diseases, she

"It's time we recognise autoimmune disorders as a major women's health issue in India," Kumar said.

Dr Bimlesh Dhar Pandey, Organising Secretary of IRACON 2025 and Director of Rheumatology at Fortis Hospital, said, "Every week, I meet women who have been living with unexplained joint pain or swelling for years before getting diagnosed.

'Many are in their 30s or 40s, juggling family and work. By the time they reach us, the disease has already damaged their joints or organs. We must increase awareness and ensure early screening, especially among

In India, doctors say the issue is made worse because women often ignore early warning signs like tiredness, joint stiffness or swelling, dismissing them as minor problems or results of stress or ageing.

Many delay visiting doctors due to family responsibilities, lack of awareness, or social reasons, which allows the disease to progress silently until it becomes more severe. Adding to this, Dr Neeraj Jain, Vice Chairman of Rheumatology at Sir Ganga Ram Hospital, said, "We have also seen the same trend, a clear majority of autoimmune patients are women. The Stanford study gives a biological explanation, but social and environmental factors in India play a major role in increasing the incidence of autoimmune diseases. Pollution, infections, and poor lifestyle habits can all trigger or worsen autoimmune responses.'

"In my practice, about 70% of autoimmune patients are women, and many have gone through years of wrong treatment before reaching a specialist. We must identify the early signs, especially in women, so they can be referred to rheumatologists sooner. Early diagnosis can prevent long-term disability," Dr Pulin Gupta, Professor and Rheumatologist at Dr Ram Manohar Lohia Hospital, noted.

Emphasising the need for focused policies, Conference Chairman Dr Rohini Handa, Senior Consultant at Indraprastha Apollo Hospitals, said, "Autoimmune diseases are as common as diabetes or heart disease, yet they get far less attention. When 70% of those affected are women, we can't treat it as a gender-neutral issue. There is a strong need for awareness campaigns, womenspecific research, and better access to rheumatology services across India."

Experts agreed that, in addition to biological factors, lifestyle and environment play a key role in triggering autoimmune disorders in Indian women. Increasing pollution levels, sedentary routines, unhealthy diets, rising stress, and lack of adequate sleep are all contributing factors.

Some studies have shown that exposure to air pollutants and industrial chemicals can disturb hormonal and immune pathways, further increasing risk.

Doctors at IRACON 2025 also highlighted that timely diagnosis and treatment can make a huge difference. While autoimmune diseases cannot be completely cured, they can be effectively managed through medication, exercise, balanced nutrition, and stress control.

India currently faces a shortage of trained rheumatologists, with fewer than 1,000 specialists for a population of over a billion. Experts suggested that primary care physicians should be trained to recognise early symptoms and refer patients appropriately. Public health programs should also include autoimmune diseases under women's health initiatives, similar to how reproductive and cancer screenings are promoted.

Srinagar: Wearing a safety vest and uniform while splattering colours across a mock battlezone, paintball is fast winning hearts in Kashmir.

Once known mainly for cricket and football, the valley is now witnessing a fresh wave of recreational excitement as paintball—the global combat sport born in the U.S. makes its entry in Srinagar's Rajbagh.

It all began with young entrepreneur Tajamul, who transformed the top floor of a building in Rajbagh into Kashmir's first and only indoor paintball arena. The game offers a taste of action long missing from the region's leisure scene.

"I wanted to bring something new to Kashmir, something that takes people away from their daily scrolling or online gaming and lets them enjoy in a safe, exciting way," Tajamul said while holding paintballs in his hand and briefing players about the game.

He said paintball is not just about shooting colours but about teamwork, bonding, and unforgettable moments. "Players gear up in two teams, helmets and protective safety vests before charging into friendly battles that combine teamwork, adrenaline and thrill "he added

It is worth mentioning that the sport, which originated in the 1980s in the United States, has become a global craze with arenas in cities like Delhi, Bengaluru and Mumbai. For Kashmir, where recreational infrastructure has long remained limited, the entry of paintball marks a refreshing shift.

About the introduction of this sport, Tajamul said he has been trying to bring this game to the valley

since 2017. "We introduced paintball in Kashmir in 2017, and now, after so many years, we have started the arena in Rajbagh," he said.

Similarly, paintball's rise in the valley also signals a changing mindset, where recreation and innovation are slowly replacing uncertainty and reviving the love for new-age games—(KNO)

Matric Exams Postponed; Teachers Threaten To Sabotage Govt Move

Srinagar- The Jammu and Kashmir Board of School Education BOSE, this evening announced its decision to postpone the examinations of 10th class soon after the day long negotiations failed to resolve the crisis raised by the teachers boycott of the examinations duty.

The Board authorities while announcing the decision to postpone the examinations said that the fresh date sheet would be sued next week.

Earlier representatives of the Teachers Forum and Lecturers Association held negotiations with the Government to resolve the crisis. The Government was represented by the Commissioner Secretary Education and the Director Education besides Minister of State of Education, Muhammad Sharief Tariq.

Sources said that teachers remained adamant as they demanded that Government should accept all their demands in black and white before they would call off their strike. The Government today showed willingness to re-solve the crisis by assuring teachers that their genuine demands will be fulfilled at the earliest. But sources said, the teachers remained adamant saying that their past experience has been bitter. The promises made with them in the past had been hollow as Government backtracked from its decision, the teachers representative reportedly told the Government during the meeting.

The representatives of the Government told the teachers that the decision involving financial implications has to be taken by the Cabinet as nobody from the Government has authority to pass such orders. The Minister of Education, Muhammad Sharief Tariq, earlier in the day appealed the teachers to defer their strike upto October 26 so that the teacher's demands would be decided in the cabinet.

The Government later passed an order asking the Chairman of the State Board of School Education to conduct the examination immediately. The Chairman of the BOSE, Prof Ali Muhammad Charu told Observer News Service that the examinations would commence from October 20 as they have to recruit employees from other departments.

The Chairman said that the Board needs 4405 employees to conduct the exams. The staffers to be taken from the department of Revenue, Agriculture, Engineering, said the Chairman. As the conduct of the examinations is a technical job the recruits have to be imparted the necessary training, he said. The new staff will be given training in the district head-quarters on October 17, 18 and 19 and the examination would start from October 20, Chairman hoped.

Meanwhile a statement issued by the Joint Co-ordination Committee of Teachers Forum has advised the state government to shun the rigid attitude and issue orders for the implementation of demands put forth by teachers forum so that precious time of the students is not wasted. The statement said that the government is pursuing a policy of delaying tactics and is trying to nullify some demands of the Forum. But this time teachers community will not compromise on any of its demand, the statement added.

Statement condemned the rigid attitude of government and made it clear that Teachers Forum will boycott the house examinations of 8th and 11th class as well. If the Government goes ahead with the examination pro-cess all the schools in the valley will be locked, adds the statement justified the boycott of teachers and appealed the people and students misunderstand the strike issue.

Statement appealed all trade unions to support the Teachers demands. (Kashmir Observer, October 15, 1998)

Whispers of a Garden

hen Mahjoor sang his call for renewal, Kashmir was not the basket case it is today. If the poet was animated by fervour for the future, he was also inspired by what he saw around himself - nature, largely unsullied and unspoilt. His words of hope and challenge must have sprung as much from his confidence in his compatriots as from the bounteous mother's blessings the Valley boasted of. But now, and for a long time, there has been betrayal on both counts. Anyone visiting Kashmir untutored today would find it hard to believe that it had once moved the poet to sing walo ha baaghwano nau baharuk shaan paida kar. Where is the baagh, and where is the baghbaan? Even saints and rishis born and bred here have found inspiration from nature's bequests and scaled great heights in their spiritual journeys, leaving behind timeless lessons for humanity on how to forge its relationship with the world. In a way, this intellectual debt has been acknowledged time and again in poetry and prose, with some going to the extent of attributing the noblest verses sung here to the portraiture of nature. Ancient sites excavated during the twentieth century are also an indication of the strong affinity people of Kashmir had with their land. This is also reflected in literature, whatever the language in vogue in different periods of the re-

Hafeez Jalandhari compared portraying Kashmir to drawing streams of milk from the rocks of Mount Bistun. The warp and woof of Ghani Kashmir's poetry is nothing but the beauty of Kashmir. Even poets like Thomas Moore and Mirza Ghalib, who have never visited Kashmir but read of it in books or heard of it from others, have produced masterpieces in glowing tributes to this land. Thomas Moore introduced Kashmir to the world thus: Who has not heard of the Vale of Cashmere/With its roses the brightest that earth ever gave?. Mirza Ghalib put it thus: Mir's poetry is beyond description; it is no less than the garden of Kashmir. Pandit Narayan Chakbast said, 'Every speck of my Kashmir is exceedingly hospitable; even the wayside stones offered me water to drink.' European travellers who visited Kashmir have praised this land in most beautiful prose.

Love for nature and its preservation was deeply ingrained in the local psyche. Long before the Vedic period, people here were 'nature worshippers'. They saw gods and goddesses in different manifestations of nature and held them in high esteem. For them, preserving nature was the greatest religious duty. And this is said to have been so for thousands of years.

Assuming that Kashmir today has even average awareness of how highly such elements figure in its lore, both recorded and transmitted by word of mouth, is there even a tinge of a sense of loss at what has been wrought? What would the verdict be today if some outsider arrived for inspiration for his creativity? Would anyone find a resonance, or even a fleeting resemblance, with what had been described so graphically barely a hundred years ago? Given their aspirations in life and how they translate into the physical world, would present-day Kashmiris be remembered as lovers of nature? No one should be surprised if the undeniably talented artists and writers of today sing no odes.

Kashmir's Art of Healing

The world measures recovery in rebuilt walls. Kashmir reminds us it should be measured in healed hearts.

hen the Pahalgam attack took place earlier this year, I was full of life. I had been attending youth conferences, leading discussions, and speaking on education, women's hygiene, and emotional well-being.

That evening, my friend and I were on a live session about tourism in Kashmir, talking about how travellers saw our valley as a "piece of the moon." Midway through the conversation, the news broke. There had been an attack. We went silent. Within minutes, we ended the session.

What I felt first was anger. Then panic. What would this mean for our future, for the sense of peace we were finally learning to build?

I remember thinking: why does every spark of hope in Kashmir have to fight so hard to stay lit?

For generations, people here have been conditioned to survive. We have lived through upheavals, curfews, communication blackouts, and natural disasters. Survival became our default mode. But survival leaves scars that seep into how we think, feel, and raise our children.

Drug addiction, depression, and suicides are no longer rare incidents. They've become symptoms of an emotional epidemic that nobody wants to name.

After the attack, I met a local official and asked him what we were doing about the mental health crisis. He had no answer. Our priorities always lie in security, infrastructure, and relief. Mental health still feels like a distant privilege. But when we neglect it, everything else falls apart.

This year's World Mental Health Day theme, "Access to Services – Mental Health in Catastrophes and Emergencies," feels like it was written for us.

Soon after the April attack, we faced another blow. Continuous rains triggered flood-like conditions across parts of Kashmir, reviving memories of 2014 when homes, schools, and entire neighbourhoods were swallowed by water. I saw the same fear again: children crying, elders staring helplessly at rising waters, families trapped with no supplies. Relief camps were set up quickly, but no one talked about emotional care. Shelter and food took priority. Healing minds was never part of the plan.

When crises hit, conversations rarely go beyond ration, water, and safety. But disasters fracture the sense of safety people hold inside. What happens to the boy who wakes up screaming after seeing his house collapse? Or the mother who can't sleep because silence

reminds her of the flood's roar? Or the young man whose only dream of stability is washed away overnight?

Those wounds don't vanish when the water recedes. They stay in our bones.

Kashmir's mental health infrastructure is painfully limited. For millions of people, we have only a handful of psychiatrists and psychologists, most based in Srinagar. Rural areas barely have access to basic counselling. Even in peaceful times, the waiting lists are long. During crises, help disappears altogether. Families facing trauma are left with silence as their only counsellor. And silence, I've learned, can be brutal.

When trauma is untreated, it multiplies. Parents who have lived through conflict, violence, or floods carry invisible wounds into their parenting. Fear, hyper-alertness, and emotional numbness spill into family life. Children grow up believing the world is dangerous, that it's safer to suppress feelings than express them.

Trauma becomes hereditary. It travels from one generation to the next, shaping how we love, trust, and dream. This is how an entire society begins to live half-alive: physically present, emotionally absent.

To heal, we must change how we respond to crisis. Relief camps should include counsellors as naturally as they include doctors. Schools reopening after disasters should offer group sessions where children can talk about their fears through storytelling, art, or play. Simple acts, like listening, acknowledging, and validating pain, can do more for recovery than we realize. Mental health is part of the crisis response itself.

Healthy coping is learning how to live with the memories without letting them con-

sume us. For that, we need communities that talk about pain instead of hiding it. We need teachers trained in psychological first aid, social workers equipped to spot trauma, and parents who reassure children that fear is normal after chaos. These are human solutions.

The drug crisis in Kashmir is a grim example of what happens when emotional wounds go untreated. The number of substance abuse cases has surged dramatically in recent years. The government's own data shows over 70,000 people currently battling addiction. Many started using drugs as a way to "forget" anxiety, fear, or grief.

In the absence of therapy, they turned to substances for escape. What could have been treated with counseling turned into a public health disaster.

But hope lives in small actions. A few NGOs in the valley now run community counseling programs where trained volunteers offer psychological first aid. Parents' groups have begun sharing resources on coping mechanisms and emotional literacy. These may seem like modest efforts, but they are shifting the culture from silence to conversation.

The world has been no stranger to catastrophe. Floods in Pakistan and Bangladesh, earthquakes in Turkey and Syria, wars in Gaza and Ukraine carry the same psychological toll. A Kashmiri mother watching her house disappear in floodwater shares the same pain as a Gazan child trembling at the sound of sirens. Trauma has no geography. Healing shouldn't either.

That is why mental health first aid must become as common as physical first aid in every relief effort, everywhere.

Governments and policymakers have to think beyond rebuilding roads and homes. They must fund therapy, create mental health units in disaster response teams, train community leaders to offer psychological care, and make counseling free and accessible after emergencies. The mind, too, deserves recovery.

As someone who has lived through both fear and hope, I've realized survival is not enough. A community can rebuild its homes, but remain broken inside. Healing begins when we tend to our minds with the same urgency as we do our wounds.

This World Mental Health Day, as Kashmir stands once again between chaos and calm, I hold on to one belief: we deserve to thrive, not merely survive.

Kashmir's Forgotten Tradition of Labour

n my childhood, life in Kashmir moved to the pulse of shared work. Families and neighbours helped one another in harvesting paddy, building homes, chopping wood, and running errands.

Work was a language of trust, care, and friendship. Villages and mohallas were knit together through these daily acts of cooperation.

A harvest could stretch into a celebration, a house could rise on laughter and collective effort. Everyone contributed, and shared.

Today, that picture has shifted. Most of the work we once did ourselves is now carried out by workers from Bihar, Uttar Pradesh, and other states who earn hundreds or thousands of rupees a day.

A single paddy field, which could have been harvested by neighbours in exchange for small favours or shared labour, now comes alive only when hired hands arrive. Families pay daily wages for jobs that could be done collectively at a fraction of the cost. The money leaves our homes, and our bonds slowly fade.

This shift has consequences beyond finance. Social cohesion, once built through joint effort,

is weakening. Children grow up seeing independence replaced by convenience, and a sense of shared responsibility disappearing.

Even the wealthy, those who once prided themselves on self-reliance, now hire labourers for harvesting their own paddy, stacking firewood, or fixing fences. When the rich outsource, others follow, believing that doing everything themselves is outdated. Poor families spend more while losing a sense of agency. Local workers, who could have earned a living, are left with fewer opportunities.

The erosion of local skill-building contribute, in subtle ways, to inequality. Those who can afford hired labour continue to do so, while those who cannot mimic the same habits, often out of social pressure. The result is a widening gap: the poor grow poorer, the rich appear more modern, and the community fragments.

Reviving the culture of shared work could reshape both economy and society. If four or five neighbours helped each other in rotation, the money would remain in the community. Families could save thousands of rupees per season, and that money could support students, small shopkeepers, and struggling households. Young people could find

work within their own villages, learning skills and pride that no hired labour can provide.

Beyond savings, shared work rebuilds relationships. Mutual effort fosters empathy, trust, and solidarity.

Our elders built Kashmir with their hands, shaping homes, fields, and relationships alike. Their legacy was social in spirit and synergy. They understood that peace and happiness grew from community effort, that respect and dignity were forged through contribution and cooperation.

Real development comes from within. It begins with us, our hands, our work, and our willingness to support one another.

If Kashmiris reclaim this habit of cooperation, we can restore both our economy and our social fabric. We can teach children that labour is honorable, that helping one another is strength, and that progress is measured in bonds, trust, and shared purpose. Real development begins at home.

Each chapter of Heart Lamp struck a personal chord, drawing stark parallels to the struggles women face here in Kashmir. The stories are more than literary works. They act as a mirror to our own societal issues, shedding light on the silent battles women fight every day.

On this International Day of Rural Women, it is the perfect time to immerse ourselves in Mushtaq's poignant storytelling. The book becomes not just a reflection of women's struggles but a powerful call for moral awakening. It urges us to confront the harsh realities of gender inequality and challenges us to rethink our attitudes and actions.

There is no better time than today to engage with this work and reflect on the urgent need for change in how we treat and empower women, particularly in rural and marginalized communities.

The very first chapter, "Stone Slabs for Shaista Mahal," sets a powerful tone. The story narrates the plight of a woman with many children, focusing on the eldest daughter who, despite her brilliance is denied further education and forced to care for her younger siblings.



Detained AAP MLA Moves HC For Permission To Cast Vote In RS Polls

Jammu: Jammu and Kashmir AAP president and MLA Mehraj Malik, who was detained under Public Safety Act (PSA) last month, has moved the High Court of J&K and Ladakh seeking permission to participate in the upcoming assembly session and to cast his vote in Rajya Sabha elections.

The J&K Assembly session is scheduled to start on October 23 and the biennial elections to fill the four Rajya Sabha seats of the Union Territory, lying vacant since 2021, would be held on October 24.

Admitting the application of Malik, Justice Sanjay Dhar directed the government to file its reply. He was hearing the main habeas corpus petition filed by the politician who was detained on September 8 for allegedly disturbing public order and was subsequently lodged in Kathua jail.

Senior advocate Rahul Pant, along with advocates S S Ahmed, Muzaffar Iqbal Khan, Appu Singh Slathia, Tariq Mughal, M Zulkarnain Chowdhary and Joginder Singh Thakur, submitted that they have filed an application seeking permission for the detenu to participate in the upcoming assembly session and to cast his vote for the Rajya Sabha election. Furthermore, they emphatically put forth that the replies in the main petition have not been filed till date.

On September 24, Malik filed a habeas corpus petition, challenging his detention and claim-

ing Rs 5 crore compensation.

Justice Chatterji Koul had issued notices to the principal secretary, Home Department of J-K government, Doda district magistrate, the senior superintendent of police and the superintendent of Kathua district jail to file their response by October

14, the next date of hearing.

"It was humbly and vociferously submitted that the applications are of emergent nature, therefore should be considered expeditiously so that the detenu can participate in the upcoming assembly session of J&K and can cast his vote for the Rajya Sabha election," a spokesperson of the AAP said.

Senior advocate Sunil Sethi and Senior Additional Advocate General Monika Kohli appeared for the government of J&K and sought time to file reply in the application as well as the main petition.

After considering the pleas of both the parties, Justice Sanjay Dhar grated time to the J&K government to file the reply in the application by or before October 18 and to file reply in the main petition by or before November 7 with further direction to keep record available on November 7 for consideration of the matter, the spokesperson said.

RS 'Safe Seat'

to provide the party a 'safe seat' in the upcoming Rajya Sabha polls. Sources said the report detailed grievances over what Congress called NC's violation of coalition dharma and marginalization of Congress leaders over the past year.

"The party leadership in Jammu and Kashmir is anguished over the backtracking of commitment by the National Conference leadership with senior leader Sonia Gandhi over Rajya Sabha polls," sources said, adding that mounting pressure exists on the Pradesh Congress Committee (PCC) leadership to consider pulling out of the government.

Congress J&K chief Tariq Hamid Karra described the NC's refusal to grant a safe seat as a "blatant betrayal" and claimed the move was a tactical step away from the INDIA alliance. Speaking on Sunday at a party meeting, he accused the NC leadership of having "questionable motives" since the formation of the alliance government.

"By backtracking on the promise of providing a single safe seat in the forthcoming Rajya Sabha elections, the National Conference is tactically moving away from the INDIA alliance," Karra said. He emphasised that Congress initially joined hands with the NC for the "higher purpose" of restoring dignity and countering divisive forces in Jammu and Kashmir.

Karra also accused the NC of disregarding alliance principles by not forming a coordination committee to ensure smooth governance and sidelining Congress in decision-making, particularly on matters like statehood restoration. He further criticised Chief Minister Omar Abdullah for statements perceived as favouring the BIP and undermining Congress's role.

The NC had announced three candidates for the Rajya Sabha and offered the fourth to Congress, which declined to contest the "riskier" seat. Omar Abdullah reportedly denied that any commitment was made to Congress regarding a safe seat, despite claims that NC president Farooq Abdullah had assured one to senior Congress leader Sonia Gandhi.

The political fallout has drawn attention from other parties as well. Peoples Conference (PC) chairman Sajad Gani Lone announced he would not vote for NC candidates in the Rajya Sabha polls, accusing Omar Abdullah of aligning with the BJP and betraying Congress. Lone claimed that Congress is the only party genuinely opposing BJP in the region and argued that NC's actions indirectly benefit the ruling party at the Centre.

The current assembly strength makes the Congress's six MLAs crucial. If Congress withdraws support, the NC-led government's effective strength would drop to 48 in the 90-member assembly, slightly above the majority mark of 45, leaving the coalition vulnerable amid the ongoing RS seat dispute.

With the Rajya Sabha elections scheduled for October 24, all eyes are on the Congress high command to decide its strategy and future course of action in Jammu and Kashmir.

Will Sajad Lone's

elections, a move seen as giving a crucial edge to BJP candidate Sat Sharma in the polls.

Lone's decision came amid an earnest appeal by Chief Minister Omar Abdullah, who urged all non-BJP parties to unite and support the National Conference's fourth candidate, Imran Nabi Dar, to prevent a BJP victory.

Lone has rejected Omar's call.

"I would rather die than vote for the National Conference. Stop dictating to us who we should vote for and who we should not. You cannot label us. You are not a prince," the JKPC leader, who was a minister in the BJP-PDP government, told reporters here.

The polls are scheduled for October 24 and the NC is expected to easily secure three of the four Rajya Sabha seats based on the current strength of the legislative assembly.

However, the contest for the final seat is razor-thin. The assembly has a strength of 88 MLAs out of which the NC-led ruling coalition has 55.

BJP candidate Sat Sharma needs only three non-BJP MLAs to either abstain or cross-vote to ensure a victory for the saffron party. The BJP has only announced three candidates for the four seats.

Omar, meanwhile, termed the upcoming polls as a litmus test for political parties in the

"I appeal to political parties not to stay away from the elections and prove that they are against the BJP because there are only two parties contesting the polls — the BJP and the National Conference," he said in Baramulla.

he said.

Responding to Lone's announcement of abstention, Omar said, "Everyone knows who will benefit from such a move... What are his compulsions only he would know? But we will need everyone's support to ensure that the National Conference wins all the seats and the

BJP wins none."

Lone questioned the NC's commitment to fighting the BJP saying "today you are in the dock. You have to prove to the people of J-K that you did not deny a Rajya Sabha seat to the Congress on BJP's orders. Prove to the people of J-K that you are not sitting in the BJP lap."

Dismissing Omar's assertion that abstention amounted to tacit support for the BJP, the JKPC chief added, "Your sense of entitlement is synonymous with lunacy."

The chief minister, meanwhile, countered Lone's allegations, defending the party's decision to field a fourth candidate.

"Had that been the case, we would not have fielded a candidate and compromised... If Sajad is against the BJP, then he should vote for our candidate. By staying away, it is benefitting the BJP," Omar asserted, highlighting that his party had felt the Congress was best suited to win the fourth seat before they opted not to field a candidate.

The elections for the four seats of Rajya Sabha in J&K have been divided into three notifications. Chowdhury Mohammed Ramzan of the NC will have a direct contest with Ali Mohammed Mir of the BIP in one of the seats.

For the second seat, NC's Sajjad Kitchloo will fight against Rakesh Mahajan of the BJP. The third seat will have Imran Nabi Dar of

the NC contesting against BJP's Sat Sharma. There are two independent candidates also in the fray and all the nomination papers will

Speaking about the Pahalgam attack, Omar said it was not only a setback for tourism but also affected the perception of Jammu and Kashmir as a home for people and visitors alike. "Pahalgam was a setback to how we perceive Jammu and Kashmir as a home," he noted.

Despite the setbacks, Omar expressed optimism about the future. "The situation in Jammu and Kashmir, when it is good, is very, very good, and when it is bad, it is terrible. We came very close to the lowest point earlier this year, but the direction now, I would like to believe, is positive," he said.

He added that restoring Jammu and Kashmir to its pre-Pahalgam economic and social position would take time and sustained effort, but he remained hopeful about gradual recovery.

further strengthened the confidence of citizens in our security forces," Shah said.

Highlighting the government's zero-tolerance policy under Prime Minister Narendra Modi, he said the campaign against terrorism has included surgical strikes, air strikes, and now Operation Sindoor. "No matter where terrorists hide, our forces have proven that no place is safe for them. Our soldiers are resolutely determined to go to the depths of the Earth to punish every act of terror," Shah added.

Since 2019, the government has strengthened counter-terror measures, including amendments to the UAPA and NIA Act, strict enforcement of the Prevention of Money Laundering Act, banning terror groups such as the Popular Front of India (PFI), and upgrading the Multi-Agency Centre for intelligence sharing.

Shah also praised the NSG for its bravery and preparedness, noting that the force had conducted reconnaissance of 770 important locations nationwide, including religious sites, inland waterways, and Parliament, with 3D modelling of key structures underway for strategic planning.

The Home Minister laid the foundation stone of a special operation training centre for the NSG in Manesar, to be constructed at a cost of Rs 141 crore over eight acres. The centre will also train personnel from anti-terrorist squads across the country.

Shah announced the setting up of a sixth NSG hub in Ayodhya, Uttar Pradesh, joining existing hubs in Mumbai, Chennai, Kolkata, Hyderabad, and Gandhinagar. He lauded the NSG for protecting the nation in critical operations since 1984 and said every citizen can feel the country is safe in the hands of its Black Cat

The Army commander complimented the armed forces for their role in Operation Sindoor, saying it gave a befitting reply to Pakistan after the Pahalgam terror attack.

"Pakistan again attempted a nefarious strike through a terrorist attack in Pahalgam, but the Indian Army responded strongly. In Operation Sindoor, we received full support from the public, veterans, state and civil administration, and everyone else," he said.

Addressing an ex-servicemen rally to commemorate 60 years of the 1965 India-Pakistan War, he said that terrorists killed innocent people in the Pahalgam attack. "The Indian Army gave a befitting reply to Pakistan. Operation Sindoor was successful as we received full support from the administration, ex-servicemen, and the local people."

The Army commander maintained that the forces are ready to thwart future attacks by the neighbouring nation.

He said that Pakistan does not have the courage to face India directly and will not desist from its designs. "We believe Pakistan's attitude will not change. It will try again to attack us. It lacks the courage to face us directly, so it will attempt another terrorist attack like the one in Pahalgam. It is important that we remain vigilant. The Indian Army is ready to thwart any nefarious move by Pakistan," he said.

Recalling the 1965 Indo-Pak war, he said the reason for Pakistan's defeat was that it underestimated the patriotism of the people of Jammu and Kashmir.

"We won the trust of the people of the nation after defeating Pakistan in the 1965 war, and that trust is intact today. Pakistan's aim was to capture Jammu and Kashmir. About 10,000 Razakars trained by the Pakistani Army infiltrated, but they made a mistake in measuring the patriotism of the people of Jammu and Kashmir," he said.

Taking a dig at Pakistan, he said, "With the help of the public, the Indian Army chased them away."

Marking the Diamond Jubilee of the 1965 Indo-Pak War, the Indian Army's Tiger Division organised a series of events in Jammu to honour the valour and sacrifice of its soldiers

The ceremony began at Balidan Stambh with the hoisting of a 50-foot-high national flag, followed by a wreath-laying by Lt Gen Katiyar in tribute to fallen heroes.

He also interacted with schoolchildren, NCC cadets, Scouts and Guides, urging them to uphold the values of patriotism and discipline.

A mega ex-servicemen rally at Satwari Ground, attended by more than 3,000 veterans, 'Veer Naris' and 'Veer Matas', was graced by Lieutenant Governor Manoj Sinha.

The rally, themed "Shaurya, Samarpan aur Samadhan", paid homage to 1965 war heroes and reaffirmed the Army's commitment to the welfare and honour of its veterans. (PTI)

Father-Son Drug

FIRs filed under the Narcotic Drugs and Psychotropic Substances (NDPS) Act. Mohd Saleem Dar, alias Sahib Matto, son of Abdul Rasheed Dar, was booked under FIR No. 167/2025 for his involvement in illicit drug trafficking. His father, Abdul Rasheed Dar, had earlier been booked under FIR No. 113/2025 for similar offences.

Investigations revealed that the duo had accumulated wealth through the proceeds of narcotics trade, acquiring a double-storey residential house and a single-storey commercial shopping complex in Village Tulkhan.

"Following legal procedures and based on concrete evidence, both properties have been formally seized and attached under Sections 68-E and 68-F of the NDPS Act," the police statement said.

The district police said this action marks a significant milestone in their ongoing campaign against drug trafficking. "We reiterate our zero-tolerance policy towards drug-related crimes and remain committed to eradicating this menace from society," the statement added.

This operation is part of the broader efforts by Anantnag Police to dismantle narcotics networks and hold accountable those who profit from illegal drug trade. (inputs from KNC)

In an interim order, the top court had on September 15 put on hold a few key provisions of the Waqf (Amendment) Act, 2025, including a clause that only those practising Islam for the last five years could create waqf, but refused to stay the entire law outlining the presumption of constitutionality in its favour.

It also held the Centre's order to delete the "waqf by user" provision in the newly-amended waqf law was prima facie not arbitrary and the argument that waqf lands would be grabbed by governments held "no water".

Waqf by user refers to a practice where a property is recognised as a religious or charitable endowment (waqf) based on its long-term, uninterrupted use for such purposes, even if there isn't a formal, written declaration of waqf by the owner.

Earlier on October 9, Pasha, appearing for Owaisi, had said that a miscellaneous application seeking extension of time for registration of want properties be heard

of waqf properties be heard.

He said that six months time was given in the amended law for registration of the waqf properties and "Five months went during the judgement, we now only have one month left."

The Centre had on June 6 launched the Unified Waqf Management, Empowerment, Efficiency and Development Act, 1995 (UMEED) central portal to create a digital inventory after geo-tagging all waqf properties.

According to the mandate of the UMEED portal, details of all registered Waqf properties across India are to be mandatorily uploaded within six months.

Apple Demand Picks Up After Month-Long Slump

Growers Urge Govt to Compensate for Earlier Losses

SRINAGAR: After facing over a month of sluggish demand and falling prices, apple growers in Kashmir are finally witnessing some relief as rates have started

According to traders and farmers, the demand for Kashmiri apples has improved over the past week, pushing prices up by nearly 30 per cent.

Bashir Ahmad Basheer, president of the Kashmir Valley Fruit Growers Cum Dealers Union, said the turnaround has brought a glimmer of hope to the community after weeks of distress.

'The rates have started going up as demand has increased in various markets outside Kashmir. We expect prices to improve further in the coming days, which could help growers recover at least part of the losses they suffered earlier," he said.

Basheer added that the government's "indifference" to-wards the crisis faced by orchardists has deepened their financial woes.

"A majority of the growers have already suffered heavy losses this season due to low demand, poor rates, highway

closure, freight rise and other issues. Unfortunately, the gov-



ernment has so far failed to provide any compensation or relief," he said.

Local farmers echoed similar concerns, expressing cautious optimism about the current rise in rates but warning that recovery may still take time.

Abdul Rashid, an apple grower from Shopian, said that the last month was "one of the worst" in recent years.

"We were forced to sell apples at throwaway prices. The rates were so low that they didn't even cover transport and packaging costs. Now, with the demand improving, we are hopeful the next few weeks will be better," he said.

Another grower, Mohammad Yousuf from Sopore, said many farmers had to delay sales in the hope of better prices. "Those who stored their apples are now in a better position as the market has started responding. If the demand continues to rise, it could bring some relief to us," he

Traders in the other fruit mandis also confirmed an uptick in market activity. They said demand from many Indian states has improved slightly due to festive season needs, leading to higher prices for A- and Bgrade apples.

Experts believe the next few weeks will be crucial for the fruit market, as consistent demand could stabilise rates and help offset the losses growers incurred earlier in the season.

Meanwhile, farmers have reiterated their appeal to the government for compensation and support, saying the horticulture sector-one of the backbones of Kashmir's economy-needs urgent attention to prevent long-term distress—(KNO)

Reservation Row

Will Ruhullah Take to the Streets Again?

SRINAGAR MP and senior National Conference (NC) leader Aga Syed Ruhullah has indicated that he may join students in protests over the unresolved reservation issue in Jammu and Kashmir, raising questions about renewed agitations in the Valley.

In an interview, Ruhullah said the government had promised to resolve the issue within six months after setting up a committee, but no significant progress has been made. "The committee was supposed to submit its report within six months. Later, it was said that the report had been sent to the law department, but it has not been made public yet," he said.

Ruhullah said he has been in contact with students affected by the issue and assured them of his support if they decide to protest again. "At that time, I spoke to the students and told them that if they have to go on the streets again, I am ready for that too. It is an elected government why will they not listen? Why should students have to protest repeatedly?" he aske

He added that previous plans to discuss the matter at Tiger Hall were blocked, but he continues to engage with students. "I do not want students to suffer, but I remain with them. Internally, the issue is neither dead nor on the back foot for me," Ruhullah said.

Speaking on internal party discussions regarding the up-



Budgam elections, Ruhullah said he had made his position clear. "Before we talk about Budgam, you should act on what you had promised regarding reservation," he said, stressing that he had put forward one key condition: the cabinet must take up the reservation issue and the sub-committee report be made public. "If you can show your intention by doing these two or three things, then I will give my answer regarding Budgam," he added.

Addressing speculation about differences with the NC, Ruhullah clarified that his stance is issue-based rather than confrontational. "Reservation is one among several issues tied to the broader political rights of Jammu and Kashmir. Our commitment to people is based on our agenda and rights, including those linked to Article 370. If political effort is not visible, it appears as confrontation," he said.

Ruhullah reiterated that he continues to raise the issue in every available forum and remains consistent in his advocacy. "Wherever and in whichever way I can fight, I am fighting the same issuebased fight," he said. (KNS)

Darbagh Shopian Residents Demand Bridge Over Nallah Tongri

SHOPIAN: The residents of Darbagh Watchi in Zainapora subdivision of South Kashmir's Shopian district have appealed to the administration for the construction of a concrete bridge over Nallah Tongri, a crucial link that was damaged during the 2014 floods and has remained unsafe ever since.

Locals said the old structure, which serves as the main connection between Darbagh and several neighbouring villages, has deteriorated to a dangerous extent. The bridge, they said, is tilted

"We have been living with this danger for years. Every time when it rains heavily, we fear that the bridge might collapse completely," Gulzar Ahmad, a local resident said. "People face huge difficulties during medical emergencies and while transporting daily essentials. A single delay can cost lives." Residents said they have repeatedly approached district authorities and public representatives, but their pleas have failed to

"The government has sanctioned projects worth lakhs elsewhere, yet our demand for a basic bridge remains unheard," said

Nisar Ahmad, another villager. The absence of a proper bridge, they said, has isolated the area and slowed down socio-economic

activities. "A new bridge will not just connect us to nearby villages but also ensure easier access to schools, health centres and markets," said one of the residents, adding that the issue is more than just an infrastructural need - it is about safety, dignity, and equitable development.

Locals said they have raised the demand in every possible forum – from grievance camps to election rallies - but only hollow promises were made. "We are tired of assurances. What we need now is immediate action," they said, urging the Lieutenant Governor Manoj Sinha, local MLA Showkat Hussain Ganaie and the Deputy Commissioner Shopian to intervene personally.

Meanwhile, an official from the district administration confirmed that the bridge project has been sanctioned. "The proposal for the new bridge has been approved, and the work is expected to start soon," the official said—(KNO)
