Srinagar: Union Home Minister Amit Shah on Saturday promised the restoration of statehood for Jammu and Kashmir "at an appropriate time" and assured a "good resolution" of demands raised by the people of Ladakh.

Speaking at a media conclave organized by ABP News and Hindustan, Shah said that since the abrogation of Article 370, Jammu and Kashmir has "taken a U-turn" in terms of security, adding that "no local terrorist has been recruited in the last nine months." He described this as a "qualitative change" in a region where separatism had been festering since the 1990s.

"Earlier, Pakistan placed arms in the hands of our children. Now the situation has changed. The people of Jammu and Kashmir feel they belong to At Appropriate Time'



the entire country, and the entire country belongs to them,' Shah said.

Highlighting the restoration of democratic processes, he noted that panchayat, municipal, and legislative assembly elections have been successfully held, with Rajya Sabha polls expected in due course.



# **Study Documents Genome Sequencing Completed In Just Four Hours**

**Press Trust Of India** 

study has documented an instance where genome sequencing and result interpretation were completed within just four hours, demonstrating the technique's feasibility for routine clinical use. Described in an article published in the New England Journal of Medicine, the time clocked to sequence one human genome surpassed the Guinness World Record of five hours and two minutes, which was achieved by a team from the US' Stanford University on March 16, 2021.

Researchers and experts from Boston Children's Hospital and Broad Clinical Labs in the US and Switzerland-based Roche Sequencing Solutions, sequenced and analysed 15 human samples, including seven cases from the neonatal intensive care unit, over a period of three weeks.

"The mean time to generate variants from genomic DNA was four hours four minutes," the authors wrote.

"In the case of blood samples that arrived at the laboratory by 7:00 am, we obtained an interpreted report between 2 pm and 4:30 pm the same day," they said.

The quickest duration from receiving a sample for genome sequencing to generating a report was

clocked at six hours 47 minutes. The feat represents a significant clinical development that would expedite more precise treatments to critically ill babies in neonatal intensive care, the team said.

Typically, obtaining results from whole genome sequencing can take five to over 40 days, accord-

# **Congress Leaders Hold Hunger Strike in Srinagar**

SRINAGAR: The Jammu and Kashmir Pradesh Congress Committee (JKPCC) on Saturday intensified its campaign for the restoration of full statehood to Jammu and Kashmir by organizing a district-wise chain hunger strike under the banner "Hamari Riyasat Hamara Haq." The protest was held at the party's Srinagar headquarters and was led by JKPCC President Tariq Hameed Karra.

Karra was joined by senior Congress leaders, legislators, district presidents, and several party functionaries who observed the hunger strike as part of the party's ongoing agitation programme across the Union Territory. The participants reiterated the Congress Party's strong demand for the immediate restoration of Jammu and Kashmir's statehood and the revival of its democratic institutions.

Speaking during the protest Karra said that the Congress

Party remains committed to fighting for the dignity, rights, and political empowerment of the people.

"Restoration of full statehood is not just a political demand but a democratic necessity," Karra said, asserting that the delay in restoring statehood has deepened the sense of alienation among the people. He accused the central government of "diluting" Jammu and Kashmir's identity and demanded immediate measures to revive the democratic process.

The hunger strike was part of a larger series of district-level demonstrations being organized by the JKPCC under the Hamari Riyasat Hamara Haq campaign, aimed at mobilizing public opinion for the reinstatement of statehood and the strengthening of civil institutions.

Party leaders at the event expressed solidarity with the people's aspirations and vowed to continue peaceful protests until Jammu and Kashmir's full statehood is restored. [KNT]

On the sidelines of the meeting, a two-day training workshop titled "Beyond Barriers: Reading and Learning with Assistive Tools and Technologies" was inaugurated at the Allama Igbal Library (AIL). The event was organised in collaboration with the University's Special Cell under the aegis of the Department of Students' Welfare (DSW), KU.

The workshop aimed to foster inclusive education by introducing participants to modern assistive technologies and AI-based learning tools that enhance reading, writing, and classroom participation for students with disabilities.

Speaking at the inaugural session, Vice-Chancellor Prof. Nilofer

Khan reaffirmed the University's commitment to equitable access to education.

# **Pak-Afghan Delegations** in Doha for Crisis Talks

Islamabad: Afghan and Pakistani delegations are heading to the Qatari capital, Doha, to defuse the deadliest crisis between them in several years, after more than a week of fighting killed dozens of people and injured hundreds on both sides.

The Taliban government said Saturday that the Afghan delegation included the defence minister and the head of the national intelligence agency. A Pakistani delegation was due to depart Saturday; the national broadcaster PTV had said a day earlier. It did not give further details.

Each country says it is responding to aggression from the other. Pakistan accuses Afghanistan of harbouring militants who carry out attacks in border areas, a charge rejected by the Taliban.

A 48-hour ceasefire intended to pause hostilities expired Friday evening. Hours later, Pakistan struck across the border.

Singh said it instilled a new confidence among Indians and proved BrahMos' effectiveness to the world.

"The entire world now recognises India's capability. Brah-Mos has strengthened our belief that India can turn its dreams into reality," he said.

Under Operation Sindoor, Indian defence forces targeted terror infrastructure and defence installations in Pakistan in May, following an attack in Jammu and Kashmir's Pahalgam on April 22 that claimed 26 lives.

Indigenously developed BrahMos supersonic cruise missiles were used by India to destroy Pakistan's air bases during the operation.

On the manufacturing of BrahMos at the Lucknow unit, Singh said the project symbolises India's growing confidence and capability in defence manufacturing.

"Lucknow is not just my parliamentary constituency, it resides in my soul. Today, it has become a city of technology and industry, apart from culture and tradition

"The successful production of BrahMos missiles here shows that what was once a dream has now become a reality. The project represents patience, hard work and determination," he said.

Assuring direct employment to hundreds of people, Singh said that it is estimated that around 100 missile systems will be provided annually to the Army, Air Force and Navy from here. In the next financial year, the turnover of this unit will reach Rs 3,000 crore, which will generate GST revenue of Rs 500 crore.

Highlighting the capabili-ties of BrahMos, he said that BrahMos is not just a missile, but a symbol of India's growing indigenous strength.

While appreciating Adityanath, he said that "We all know that Uttar Pradesh was once identified with gangsterism and broken law and order. # Fire Breaks Out at Dhaka Airport, Flights Suspended

Dhaka: A massive fire broke out on Saturday at the cargo complex of the international airport in Bangladesh's capital, forcing authorities to suspend all flight operations as thick black smoke engulfed

At least nine flights of different airlines scheduled to land in Dhaka were diverted to Shah Amanat International Airport in southeastern Chattogram and Osmani International Airport in northeastern Sylhet. Eight of them landed in Chattogram and one in Sylhet.

There were no immediate reports of casualties.

Civil Aviation Authority of Bangladesh (CAAB) said the blaze broke out in the afternoon at the Hazrat Shahialal International Airport prompting the deployment of over two dozen firefighting units, with additional teams rushing to the scene.

"We received the information at 2:30 pm and immediately dispatched our units to join the ones deployed at the airport," Fire Service spokesman Talha Bin Zasim said.

Thirty-six firefighting units are engaged in the operation, he said.

CAAB officials said the Air Force's fire units also joined the rescue campaign.

"Landings and takeoffs of all aircraft have been suspended until further notice. All our aircraft are confirmed safe," a CAAB spokesperson said.

According to local media reports, chemicals stored in the cargo zone posed a major challenge for firefighters.

Eyewitnesses said personnel from the army, air force, navy, and Border Guard Bangladesh (BGB) joined the firefighting and rescue efforts. They described the fire as

a major one, with thick smoke covering a large part of the airport and surrounding areas.

This is the third major incident of fire in Bangladesh within a span of five days.

An eight-storey factory building at the Chittagong Export Processing Zone (CEPZ) was completely destroyed in a massive fire on Thursday. There were no casualties.

# **Punjab DIG Arrested by CBI in Bribery Case**

handigarh, Oct 18 (PTI) Punjab Deputy Inspector General of Police (Ropar Range) Harcharan Singh Bhullar, who was arrested by the CBI in a bribery case, has been suspended, according to a state government order.

Bhullar, along with another person, was arrested on Thursday in connection with a corruption case involving bribery of Rs 8 lakh

Bhullar was held from his Mohali office following a complaint lodged by a Fatehgarh Sahib-based scrap dealer, who accused the senior IPS officer of demanding recurring monthly payment for "set-

tling" a 2023 FIR against him. Bhullar was sent to judicial custody by a CBI court here on Friday.

An order of the Punjab Home Affairs department issued on Saturday said, as per Rule 3(2) of the All India Services (Discipline & Appeal) Rules, "a member of the service who is detained in official custody whether on a criminal charge or otherwise for a period longer than forty-eight hours, shall be deemed to have been suspended by the Government concerned under this rule."

"In pursuance of the said Rule, Harcharan Singh Bhullar. IPS is hereby deemed to be suspended with effect from 16.10.2025, as 48 hours have lapsed since his arrest," stated the order.

Bhullar has been booked under relevant Sections of the Bharatiya Nyaya Sanhita, 2023, and the Prevention of Corruption Act, 1988.

During searches at his



residence, the CBI seized Rs 7.50 crore in cash and 2.50 kg of gold iewellery.

It also recovered 26 luxurv watches, including brands such as Rolex and Rado, documents pertaining to more than 50 immovable properties held in the names of family members and suspected benami entities, locker keys and details of multiple bank accounts, four firearms along with 100 live cartridges.

From Bhullar's farmhouse in Samrala, the CBI sleuths found 108 bottles of

liquor, Rs 15.70 lakh cash and 17 live cartridges.

A middleman identified as Kirshanu was also arrested, and the CBI sleuths recovered Rs 21 lakh from him.

According to the FIR lodged by the CBI, complainant Akash Batta alleged that DIG Bhullar had demanded illegal gratification through his middleman for settling the 2023 FIR registered in Sirhind against him and for ensuring that no further coercive or adverse police action was taken against his scrap business.

The complainant further alleged that Bhullar had been demanding recurring monthly payments, referred to as "sewapaani", and had threatened to falsely implicate him in business-related criminal cases in case of non-compliance.

# **Sri Lanka to Seek Interpol Alerts for Athletes Who Fled 2022 CWG**

olombo, Oct 18 (PTI) Sri Lanka will seek Interpol red notices for the arrest of athletes who fled the 2022 Commonwealth Games village in Birmingham and failed to return home, a court was informed.

The Colombo Chief Magistrate's Court on Friday imposed travel bans on 10 athletes believed to be residing illegally in the United Kingdom.

According to the Sports Ministry's Offences Prevention Unit, the absconding athletes caused a financial loss of about 50 million Sri Lankan rupees to the government by not returning to

the country after the games. Police Inspector Supun Vidanage from the unit told the court Friday that the Sri Lankan contingent for the 2022 Games comprised 116 athletes, 28 training officials, 11 medical officers and 23 others representing Boxing, Wrestling, Judo and Vollevball.

Nine athletes, a manager and a sports photographer did not return to the country after the event, he said.

The official said the ministry will soon seek Interpol red notices for them.

Vidanage later told reporters that the court action marked the first step in the investigation, noting that local arrest warrants must be issued before Interpol can be approached to seek international arrest notices. Sri Lanka won one silver

and one bronze medal at the 2022 Birmingham Games, ranking 31st in the overall medal tally.

The Games were held from late July to mid-August 2022, at the time when Sri Lanka's was facing unprecedented economic crisis and had declared bankruptcy after defaulting on its external debt.

A special police investigation unit was established in 2019 under the Prevention of Offences Relating to Sports Act.

"We appeal to the administration to intervene and ensure regular and timely salary disbursement. We are performing our duties sincerely even under tough conditions; the least we expect is timely payment," they added—(KNO)

### Leh Apex Body Backs Judicial Probe, Demands Ladakh Representation

**LEH:** Leh Apex Body (LAB) on Saturday welcomed the centre's decision to conduct a judicial probe into the September 14 violence but demanded inclusion of a representative from Ladakh in the team.

The group criticized the Lt Governor-led administration for foiling the silent march earlier during the day and said "such actions can never prove fruitful or convince us to resume talks with the centre".

# Govt to Introduce Law to Ban Artificial Colouring on Fruits: Minister Javid Dar

Says practice damaging fruit industry, health, market

**SRINAGAR:** Minister for Agriculture Production, Rural Development & Panchayati Raj, Cooperative and Election Departments, Javid Ahmad Dar on Saturday said the government will soon introduce a law to prohibit the use of artificial colouring on fruits, saying the practice is damaging Kashmir's fruit industry, consumer health and market credibility.

Speaking to reporters in Baramulla, Minister Dar said artificial colouring has become a serious concern. "Colouring is affecting our fruit business across markets. Buyers in Delhi, Jammu and Kolkata have complained about it. We will be soon drafting a law to step its use completely." he said

to stop its use completely," he said.

Minister said the government is also finalizing the creation of a dedicated Enforcement Wing to regulate fertilizers and pesticides. "Many fertilizers and pesticides in use are of poor quality. We are strengthening enforcement to identify and act against violators," he said.



He warned that penalties will be imposed on traders and growers who bring coloured fruit to markets ahead of the season. "If a September apple arrives in August and shows colouring, it is malpractice. This must stop," he said.

On pest control, Minister Dar said the illegal import of rootstocks without quarantine checks has worsened the "leaf miner" pest problem. "Some people bring rootstocks through black marketing. We have identified them and strict action will follow," he said.

The Minister said the government will ensure safety standards in trade. "We are a progressive state. We will not ban licenses arbitrarily, but misuse will not be allowed," he said.

## Daily Hassles for Commuters as Uri-Bla Road Widening Drags On

**SRINAGAR:** The widening of the Uri-Baramulla road into two lanes has turned into a daily ordeal for residents and commuters, who have faced persistent traffic jams, dust pollution, and rising environmental concerns for the past year.

Locals blame poor planning and mismanagement for the ongoing issues. Despite the road being a key route in north Kashmir, residents say the project suffers from a lack of manpower and oversight, leading to frequent delays and traffic snarls. "Every day, we're stuck in traffic for hours. There's no proper traffic regulation," Ali Mohammad, a resident of Uri said. He added that irregular work zones and a lack of staff during rush hours slow down vehicles to a crawl.

Dust pollution is another major issue. Constant digging and the absence of dust control measures have made travel difficult, especially for children and the elderly. "There's no water sprinkling at all. The dust is unbearable," said local resident Imtiyaz Ahmad Mir.

Environmental concerns are also mounting, with residents accusing the construction agency of cutting down hundreds of trees near the NS Bridge and Boniyar area without replanting. This, they say, has led to landslides during the rainy season and made the slopes near the bridge hazardous.

Fed up with the situation, residents are urging authorities to conduct heavy construction work at night to ease daytime congestion. "Why can't they do the heavy work at night when traffic is less?" asked Imtiaz, a local bus driver.

Some locals have also alleged the use of substandard materials in the project. However,officials said the overall traffic situation has improved compared to previous months. "Traffic disruptions persist in a few stretches, but the rest of the road is in much better condition," said a senior official, adding that the remaining problem areas are expected to improve within a month or two. He also stated that the issue of dust control has been raised with Beacon officials.—(KNO)

HE latest to join the city's long list of emotional dramas is Shelly Mahajan v. Ms. Bhanushree Bahl & Anr. — where a wife has sued her husband's "special friend" for 4 crores, accusing her of alienation of affection. No one's been found guilty, and no final verdict has been passed — the Delhi High Court merely pressed the doorbell: "Ding-dong, summons."

It's a plotline that would make even Indian TV serials blush — a 2012 marriage, twin children, a business venture, a new colleague in 2021, and by 2023, a digital discovery that turned love into litigation.

This isn't about criminal adultery. That chapter ended in Joseph Shine v. Union of India (2018), when the Supreme Court struck down Section 497 IPC and politely asked the State to stay out of people's bedrooms. But Delhi has now added a footnote to that freedom: adultery may no longer land you behind bars, but it can still make your bank account lighter. Love, it seems, has gone from passion to payment gateway.

So yes, no handcuffs — just consequences. You can follow your heart, but someone else might follow you to court.

#### When Love Meets Law

The Court didn't preach or pass verdict; it simply said the claim deserves to be heard. But that one line was enough to stir quiet curiosity across the country. Over steaming cups of Chai and lateevening gossip, people are debating this new idea of "damages for affection."

The reactions are half amusement, half disbelief — "Four crores for love lost? In Delhi, even heartbreak comes with a valuation!" Somewhere between sips and sarcasm, someone adds, "At this rate, even a harmless Chai invitation could end up in court.

Even the shikaras on Dal Lake seem to glide a little more cautiously now — too many reflections, too much evidence, and far too many stories waiting to float.

#### **Cupid's New Disclaimer**

And somewhere beneath the laughter sits a quiet truth: the law won't jail you for falling in love, but it might make you pay for falling carelessly.

So perhaps that's the modern moral of the story love may be private, but the hurt it causes rarely stays indoors. In Delhi, the court has gently reminded everyone that while love is no longer a crime, it's definitely not tax-free either.

So if the doorbell rings at an odd hour, pause before you smile. It might not be love waiting outside — it might just be litigation in formal shoes.

"Love freely, yes... but maybe keep your banker on speed dial.'

# Sirens, Status, and Silence

Noise pollution, though often underestimated. poses a serious threat to public health, productivity, and mental peace. The misuse of sirens is not merely an act of indiscipline — it reflects a broader failure of governance and civic responsibility.

HE unchecked and unnecessary use of sirens by government convoys, official vehicles, and even ambulances without patients has become a widespread menace one that contributes significantly to noise pollution and public inconvenience.

What was once intended to alert citizens during genuine emergencies has now transformed into a symbol of status and authority, often misused without restraint or accountability.

For example, Ganderbal, already notorious for traffic jams, is now grappling with yet another disturbance—the shrill and unregulated blare of sirens from government vehicles. The problem is particularly severe near the Court Complex Ganderbal, located along a busy main road. Constant siren blasts make it extremely difficult for judges, lawyers, and litigants to concentrate, disrupting daily judicial proceedings.

The sanctity of the court which demands peace, order, and decorum — is under continuous assault. This reckless practice not only disturbs the public but also undermines the credibility and urgency associated with genuine emergencies.

Such misuse clearly breaches the Noise Pollution (Regulation and Control) Rules, 2000, and violates citizens' fundamental right to a peaceful environment under Article 21 of the Constitution of India.

#### Legal Framework and Responsibility

Noise pollution in India is regulated under the Environment (Protection) Act, 1986 and the Noise Pollution (Regulation and Control) Rules, 2000.

Rule 5A specifically empowers authorities to restrict the use of horns, pressure horns, and sirens allowing them only for genuine emergencies such as police, fire, or ambulance services. Even in these

cases, the use of sirens is permitted only during actual emergencies, not for routine movement or convenience

Under Article 21, every citizen has the right to life, which includes the right to a peaceful and pollution-free environment. The Supreme Court, in In Re: Noise Pollution (V), (2005) 5 SCC 733, held that noise beyond permissible lim-

its violates fundamental rights. Therefore, the misuse of si-



rens by non-emergency vehicles falls squarely within the ambit of actionable noise pollution.

The National Green Tribunal (NGT) has repeatedly cautioned against urban noise hazards, noting that continuous exposure to high decibel levels causes psychological distress, hearing impairment, and reduced workplace efficiency. When such disturbance extends to judicial institutions and residential areas, it becomes not only a public nuisance under Section 278 of the Bharatiya Nyaya Sanhita, 2023 (corresponding to the old Section 268 IPC), but also a breach of statutory and constitutional duties by public authorities.

#### Need for Strict Regulation and Enforcement

There is an urgent need for uniform guidelines restricting the use of sirens strictly to genuine emergencies. Installation of sirens in government or official vehicles except those legally authorised for emergency use - should be completely banned.

The Transport Department and Traffic Police must carry out regular inspections and impose penalties under the Motor Vehicles Act, 1988, along with relevant state rules.

Courts, hospitals, educational institutions, and residential areas should be declared "No Siren Zones", similar to existing Silence Zones under noise control laws. In addition, awareness campaigns

must be launched to sensitise government drivers and ambulance operators about the legal and ethical responsibilities attached to siren use.

#### Respect for Silence, Respect for Law

Noise pollution, though often underestimated, poses a serious threat to public health, productivity, and mental peace. The misuse of sirens is not merely an act of indiscipline — it reflects a broader failure of governance and civic responsibility.

It is time the local administration and the Hon'ble High Court take suo motu cognisance of this growing menace and direct strict implementation of noise control regulations.

Respect for the environment begins with respect for silence – and it is the duty of every citizen, especially those in positions of authority, to lead by example.

The cause was neither a political statement nor a social protest, but the grand opening of a national coaching brand — unveiled in full Bollywood splendour, far removed from the quiet grace that once defined Kashmir's social, cultural, and spiritual temperament.

An event meant to celebrate learning saw spectacle take centre stage. The promise of nurturing intellect was dimmed by the dazzle of performance. What should have been an invocation of knowledge a sacred pursuit in every tradition — turned into a carnival of glamour and applause. The words "bright future" echoed often, but the light seemed to come from spotlights rather than the flame of wisdom that true education kindles.

While these advances have created opportunities, they have also subtly shifted collective consciousness. The teacher, once revered as a guide of the spirit, is now marketed as "faculty." The path of learning, once walked with humility and discipline, is now paved with slogans of speed and competition.

Kashmir has a rich legacy of valuing education that goes hand in hand with cultural and ethical grounding. Yet videos from some educational institutes - both national and local — occasionally surface online, showing practices that clash with these values. Loud music, entertainment-based activities, or spectacle in classrooms may be seen as "motivational" by some, but many parents perceive it as distracting and culturally misaligned.

#### The Celebrity Culture in Classrooms

no specific institute is being accused of misconduct. The concern is broader: the increasing commercialisation of education and the dilution of its foundational values in some settings.

#### **Education Beyond Academics**

Education, especially in Kashmir, must serve more than just academic ends. Parents entrust not only the intellectual growth of their children to schools and coaching centres but also expect them to uphold values of discipline, integrity, and respect. When institutions focus primarily on flashy success stories and aggressive marketing, these deeper, more enduring goals risk being sidelined.

Institutes often highlight the success of a select few students, showcasing top ranks and admissions into elite colleges. Little is said about the thousands who don't make the cut. For many students, the pressure to perform in hypercompetitive environments — sometimes lacking mentorship or emosuperficial attention, where discipline, humility, and hard work take a back seat.

This is not to say that modern tools are harmful — they are not. Digital smart boards, video lectures, and motivational activities can greatly enhance learning. But their use must be guided by responsibility, cultural sensitivity, and an understanding of the community they serve.

#### Where Local Systems Failed — and Why Hope Still Remains

Many parents turned to national brands because local coaching institutes failed to provide consistent, high-quality, value-based education. Frequent faculty changes, poor planning, and commercial interests overshadowing academics eroded trust. Rebranding of failed institutes and frequent name changes further weakened credibility.

However, this failure is not of any single individual or institute it reflects a collective gap in building a reliable, sustainable educational

model rooted in Kashmiri ethos.

#### A Ray of Hope: School-Integrated Coaching

Amid these challenges, a promising model is emerging: schoolintegrated coaching. Unlike standalone coaching centres, these setups function within established school environments maintaining discipline, structure, and accountability. Schools are accountable to parents, management boards, and regulatory authorities - unlike private coaching centres, which may operate with more flexibility.

Such institutions are better positioned to deliver holistic education, balancing academic rigour with moral and emotional development. They cannot afford to fail the reputation of the entire school is at stake, not just an annual batch or a marketing campaign.

#### Conclusion: Time to Choose Values Over

Kashmir needs education that builds not just doctors and engineers, but responsible, value-driven individuals. As parents, teachers, and citizens, we must reflect before we choose.

It is not about demonising any institute — national or local — but about demanding better: better standards, better ethics, and better alignment with who we are. # In the Age of AI, Students Must Learn to See, Not Just Write

# Literacy today extends beyond reading and writing

Prom the earliest year of school, children begin learning how to express ideas in different ways. Lines across a page, a wobbly letter, or a simple drawing form the foundation for how we share meaning beyond spoken language.

Over time, those first marks evolve into complex ideas. Children learn to combine words with visuals, express abstract concepts, and recognise how images, symbols and design carry meaning in different situations.

But generative artificial intelligence (AI), software that creates content based on user prompts, is reshaping these fundamental skills. AI is changing how people create, edit and present both text and images. In other words, it changes how we see – and how we decide what's real.

Take photos, for example. They were once seen as a "mirror" of reality. Now, more people recognise their constructed nature.

Similarly, generative AI is disrupting longheld assumptions about the authenticity of images. These can appear photorealistic but can depict things or events that never existed.

Our latest research, published in the Journal of Visual Literacy, identifies key literacies at each stage of the Al image generation process, from selecting an Al image generator to creating and refining content.

As the way people make images changes, knowing how generative AI works will let you better understand and critically assess its outputs.

#### Textual and visual literacy

Literacy today extends beyond reading and writing. The Australian Curriculum defines literacy as the ability to "use language confidently for learning and communicating in and out of school". The European Union broadens this to include navigating visual, audio and digital materials. These are essential skills not only in school but also for active citizenship.

These abilities span making meaning, communicating and creating through words, visuals and other forms. These abilities also require adapting expression to different audiences. You might text a friend informally but email a public official with more care, for example. Computers, too, demand different forms of literacy.

In the 1960s, users interacted with computers through written commands. By the 1970s, graphical elements like icons and menus emerged, making interaction more visual.

Generative AI is often a mix between these two approaches. Some technologies, like ChatGPT, rely on text prompts. Others, like Adobe's Firefly, use both text commands and button controls.

Software often interprets or guesses user intent. This is especially true for minimalistic prompts, such as a single word or even an emoji. When these are used for prompts, the AI system often returns a stereotypical representation based on its training data or the way it's been programmed.

Being more specific in your prompt helps to arrive at a result more aligned with what you envisioned. This highlights that we need "multimodal" literacies: knowledge and skills that cut across writing and visual modes.

### What are some key literacies in AI generation?

One of the first generative AI literacies is knowing which system to use.

Some are free. Others are paid. Some might be free but built on unethical datasets. Some have been trained on particular datasets that make the outputs more representative or less risky from a copyright infringement perspective. Some support a wider range of inputs, including images, documents, spreadsheets and other files. Others might support text-

only inputs.

After selecting an image generator, you need to be able to work with it productively.

If you're trying to make a square image for an Instagram post, you're in luck. This is because many AI systems produce images with a square orientation by default. But what if you need a horizontal or vertical image? You'll have to ask for that or know how to modify that setting.

What if you want text included in your image? AI still struggles with rendering text, similarly to how early AI systems struggled with accurately representing human fingers and ears. In these cases, you might be better off adding text in different software, such as Canva or Adobe InDesign.

Many AI systems also create images that lack specific cultural context. This lets them be easily used in wider contexts. Yet it might decrease the emotional appeal or engagement among audiences who perceive these images as inauthentic.

#### Working with AI is a moving target

Learning AI means keeping pace with constant change. New generative AI products

appear regularly, while existing platforms rapidly evolve.

These examples show where things are headed. Users will be able to create and edit text, images, sound and video in one place rather than having to use separate tools for each.

Building multimodal literacies means developing the skills to adapt, evaluate and cocreate as technology evolves.

If you want to start building those literacies now, begin with a few simple questions.

What do I want my audience to see or understand? Should I use AI for creating this content? What is the AI tool producing, and how can I shape the outcome?

Approaching visual generative AI with curiosity but also critical thinking is the first step toward having the skills to use these technologies intentionally and effectively. Doing so can help us tell visual stories that carry human rather than machine values.

In many societies, disability has long been perceived negatively. People with differing abilities were often seen as objects of pity or charity rather than individuals with equal rights. In traditional or less educated communities, disabilities were associated with misfortune, sin, or fate. As a result, people with disabilities were often excluded from mainstream social, educational, and economic activities. Such perceptions fostered stigma and discrimination, undermining self-esteem and opportunities for persons with disabilities (PWDs).

Over time, growing awareness, education, and advocacy have begun to change these views. Disability is increasingly understood through the social model, which emphasises that societal barriers—not impairments—

create disability. People are recognising that disability is a part of human diversity, not an abnormality. Media representation, inclusive education, and disability rights movements have gradually improved respect, inclusion, and acceptance.

Khushboo and Mehvish, sisters from the remote village of Mathindoo, Larnoo in Anantnag, exemplify this change. Blind from birth, they have shown that disability is not a misfortune, sin, or fate. Both sisters recently passed their HSE-II exams with flying colours, bringing immense pride to their parents, teachers, and community.

Their journey began in May 2016. On my way to work at Govt. Middle School Badray,

I noticed an elderly lady guiding two young girls, wearing goggles and walking with bowed heads, to a nearby school. Astonished, I asked the grandmother about them. With tears in her eyes, she explained that they were blind sisters and she feared leaving them alone. Having recently attended a workshop on Inclusive Education for visually impaired children, I was deeply inspired. I realised this was an opportunity to make a real difference in their lives.

I immediately decided to teach and guide them at their home. The next day, I met their family and held a counselling session. The parents expressed concern for their daughters' safety and shared how the girls were struggling. I reassured them that I would teach the girls daily after 4 pm. Overjoyed, the family expressed heartfelt gratitude.

From that day onward, I began teaching them life skills, Braille, and Braille typing at their home. Over time, they progressed steadily. By the 8th standard, they were able to use a smartphone, which became a pivotal tool for learning as it allowed them to listen to lessons repeatedly. In classes 9th and 10th, I personally taught them Music and Home Science at home. Their participation in curricular and co-curricular activities continued unabated, reaching zonal, district, and even state-level programs.

Passing their 10th board exams with distinction, the sisters demonstrated that true vision is not in the eyes but in determination and the pursuit of knowledge. I continued to support them, and in 2024, both excelled in their 12th board exams, proving that no obstacle is insurmountable when determination and desire to succeed are unwavering. Their achievements stand as a testament to resilience, hard work, and an indomitable spirit

indomitable spirit.

The journey of Khushboo and Mehvish is not just a personal success story—it is a lesson for society. It underscores that disability does not define a person; attitude does. Their courage has changed perceptions and continues to inspire everyone who believes in the power of education,

empathy, and hope.

This journey also highlights the vital role of dedicated educators who go beyond the classroom to make inclusion a lived reality. Teachers who guided them exemplified the essence of education: patience, empathy, and commitment. Their consistent support not only helped the sisters excel academically but also strengthened the community's

#### 5. Bell Peppers Bell peppers - especially red and yellow varieties — have nearly three

times more vitamin C than oranges. Snack on them raw or toss them into stirfries, salads, or soups

# 30 Of 54 Daily-Use Items See More-Than-Expected **Price Reduction**

NEW DELHI- As many as 30 of the 54 daily-use items monitored by the government over the past almost a month has more-than-expected price cuts post reduction in GST rates, while for others the government will work with the industry to ensure further reduction in retail prices.

Government data showed that while prices of all 54 items have come down since September 22, the actual price cut in case of 24 items was less than the initial estimate of the government.

The government had asked its Central GST field offices to monitor price changes of 54 commonly used items like butter, ghee, cheese, powder, soap and others after lower Goods and Services Tax (GST) rates were implemented from September 22.

As per information received from 21 different CGST zones across the country, 30 items including AC machine, TV set, tomato ketchup, cheese, cement, have seen more-than-expected price reduction.

However, 24 items, including notebooks, chocolates, hair oil, tooth paste, pencil, thermometer, and bicycle, have not seen expected decrease in price based on reduction of GST rate, assuming that all other cost and

profit remain constant. Effective September 22, Goods and Services Tax (GST) have become a two-tier tax structure of 5 and 18 per cent, and a special 40 per cent rate for ultra-luxury items. Prior to this, GST was taxed at rates of 5, 12, 18, and 28 per cent, plus a compensation cess on luxury

This has resulted in slashing of prices of as many as 375 items ranging from toothpaste and shampoo to cars and televi-

As per the government data on monitoring of GST rate on sensitive commodities before and after GST rate reduction, in case of food items more than expected decrease in price based on average price reported by various zones was seen in dried fruits, cheese, condensed milk, jam, tomato ketchup, soya milk drink and drinking water bottle (20L). GST on all these items were slashed to 5 per cent effective September 22, from 12 per cent.

In case of butter, however, there is scope for more decrease in prices. Butter, which was taxes at 12-18 per cent depending on the type, was reduced to 5 per cent. The expected decrease, as per government estimates is between 6.25-11.02 per cent, while the actual decrease has been 6.47

# **Tourists Spots Closed After Pahalgam Attack Need To Be Reopened: CM Omar**

**SRINAGAR-** Jammu and Kashmir Chief Minister Omar Abdullah on Saturday said his government's efforts to bring back tourists to the Union territory can work only after the tourist spots closed in the wake of Pahalgam terror attack are reopened.

"First, we have to reopen those places which have been shut. We did not shut these places in 35 years. When the militancy was at its peak, Drang or Doodhpathri were not closed, the upper areas of Gulmarg were not shut, Aru valley was not closed," he told reporters here.

Abdullah said some courage is needed to be shown and open tourist spots and pro-

mote them effectively.

Addressing criticism that his government was focusing too much on tourism, the chief minister said, "We are trying at our own level despite the fact that we are subjected to taunts that why are we doing so much tourism promotion?

"We know that homes of lakhs of people depend on it and we want tourism to be restored to the level that was there before the Pahalgam attack."

The chief minister said his government has sent teams outside the country to promote tourism, pointing out that a big delegation is in Singapore to restore tourism from Southeast Asia. They will also go to Berlin and London next month for tourism promotion, he added.

"If we talk about within the country, Nasir (Aslam Wani) had recently gone to Udaipur for promotions. We are not leaving any stone unturned. I cannot say that the Centre has not supported us, but, the reality is that unfortunately, we are talking in two voices from within J-K.

"On one hand, the elected government talks about tourism promotion, but on the other, the unelected government has kept a large part of Kashmir closed for tourism,"

### **GST Reforms PM Modi's** 'Diwali Gift', Says Govt; Cites **Record Sales Across Sectors**

**NEW DELHI-** The government on Saturday hailed the GST reforms as a "Diwali gift" to consumers, pointing to a surge in festive sales across sectors including automobiles, electronics, and daily essentials.

Finance minister Nirmala Sitharaman, along with commerce and industry minister Piyush Goyal and information and broadcasting minister Ashwini Vaishnaw, said the lower GST rates introduced on September 22 are already boosting household consumption.

The revamped GST structure, which came into effect on September 22, 2025 has led to price reductions in 375 items, ranging from toothpaste and shampoo to cars and televisions.

The GST Council had approved the overhaul on September 3, introducing a simplified two-rate system of 5 and 18 per cent in place of the earlier four-rate structure of 5, 12, 18, and 28 per cent.

The finance minister said 99 per cent of daily-use items are now cheaper under the new regime.

Sitharaman said the government has been monitoring 54 essential items to ensure that the benefits of the tax cuts are passed on to consumers.

"We found that in every one of them, the tax benefit due to the GST reforms has been passed to the end consumer. The Prime Minister's Diwali gift has been delivered," she

She added that in some cas-



es, businesses had passed on higher-than-expected benefits to consumers.

"GST rate reduction has resulted in an increase in purchases. The consumption drive will continue," Sitharaman said, noting that the lower rates have already boosted sales in automobiles, electronics, and FMCG sectors.

The GST reforms, while hailed by the government as a "Diwali gift," have also drawn heavy criticism from some quarters. Consumers on social media pointed out that the prices of several essential items, including cooking oils and grocery staples, have in fact risen since the reforms.

The finance minister informed that the consumer affairs department has received 3,169 complaints regarding non-reduction in prices commensurate with GST cuts, of which 3,075 have been forwarded to nodal officers in the Central Board of Indirect Taxes

and Customs (CBIC). 94 complaints have been resolved so far. To streamline the process, the department will soon enable a new functionality on the grievance reporting portal to forward complaints directly to chief commissioners of respective zones.

### Ladakh LG launches REWA 2.0, **Says Scheme Removes Financial Barriers For UPSC Aspirants**

# **Ghanta Ghar To Tick Craft Bells** On Oct 25 In 2nd Edition Of 'Know **Your Artisan' Series**



# Apple's iPhone Air Sold Out In **China Minutes After Its Launch**

**BEIJING-** Apple's iPhone Air sold out within minutes of its launch in China on Friday, notwithstanding the current tariff war between Washington and Beijing.

The new iPhone instant sale also underscores its popularity among Chinese consumers despite competition from Android devices.

The strong sales followed Apple CEO Tim Cook's visit this week to promote the product in the world's largest smartphone market amid ongoing geopolitical tensions between China and the US.

Cook is the advisory body at China's Tsinghua University's management

During his visit, he also met Chinese Vice-Premier He Lifeng, who heads China's trade delegation, which is currently holding trade talks with the US to resolve tariffs on Chinese exports.

Pre-sales for the iPhone Air, which supports only e-SIM, began at 9 am local time on Friday, more than a month later than most of the world.

Minutes after bookings opened, the model was sold out at all bricks-and-mortar stores in Beijing and Shanghai, as well as in cities like Tianjin, according to Apple's website. Online shipments were delayed by one



to two weeks, according to the Hong Kong-based South China Morning Post.

The robust demand reflects the positive reception of Apple's newest and thinnest model in the Chinese market heightened competidespite tion from local brands such as Huawei Technologies and Xiaomi, which are striving to expand in the higher-end market in a challenging economy, the report said.

The Chinese smartphone market contracted 3 per cent year on year in the third quarter, with Vivo capturing an 18 per cent share to claim the top

Huawei and Apple followed in second and third place with 16 per cent and 15 per cent shares, respectively, trailed by Xiaomi and Oppo.

Cook has emerged as one of the most prominent US business leaders actively engaging with Chinese consumers and government officials.

### **Maruti Hits Record Sales On Dhanteras, Expects To Cross 50k Units; Hyundai Sees 20% Growth**

He also noted that this year, Dhanteras deliveries are spread across multiple days because of it being a Saturday.

While gold prices surged 63 per cent to Rs 1,32,000 per 10 grams of 24-carat (inclusive of taxes) in the national capital -- up from Rs 81,400 last Dhanteras on October 29, 2024 -- silver prices gone up by 40 per cent, yet demand held firm.



In major markets, gold and silver prices saw a modest correction on Dhanteras. In Mumbai, 24-carat gold eased to Rs 1,28,000 per 10 grams on Saturday from Rs 1,30,000 on Friday, while silver fell to Rs 1,70,000 per kg from Rs 1,77,000. In Delhi, gold dropped to Rs 1,32,000 per 10 grams (from Rs 1,34,800) and silver to Rs 1,70,000 per kg (from Rs 1,77,000).

The overnight Rs 2,000 dip in gold further fuelled purchases. Buying momentum picked up post-lunch, with consumers shifting to coins and bullion in 1-50 gram denominations for investment, early weddings, and light-

weight jewellery. According to All India Gem and Jewellery Domestic Council (GJC) Chairman Rajesh Rokde, "Dhanteras 2025 has seen a 10-15 per cent dip in overall volume compared to


last year, but value is up sharp-

ly... we expect festive sales to

cross Rs 50,000 crore. "Despite high prices, sentiment remains upbeat, driven by strategic purchases. Silver coins and puja items surged 40 per cent year-onyear, marking silver's rise as a smart, value-focused investment," he told PTI.

# **Tobacco Sale, Storage Banned Within** 100-Meter Radius Of Schools, Colleges In Ajas

Srinagar: In a move aimed at protecting students' health, Executive Magistrate 1st Class, Ajas, has imposed a complete ban on the sale, storage, and offering of tobacco products within a 100-meter radius of all educational institutions under his jurisdiction. The order has been issued under the Cigarettes and Other Tobacco Products (Prohibition of Advertisement and Regulation of Trade and Commerce, Production, Supply, and Distribution) Act, 2003 (COTPA), and came into immediate effect.

The directive prohibits individuals and shopkeepers from selling or storing tobacco products near schools, colleges, and other educational establishments. All vendors operating within the restricted zones have been instructed to cease sales immediately.

The magistrate has directed the D.O. Ajas to enforce the order strictly and initiate legal proceedings against violators under the relevant provisions of the COTPA Act. Locals and educational institutions have been urged to report any breaches of the order to the nearest police station or the office of the Executive Magistrate.

Authorities have warned that violations will attract strict penal action under the law. Copies of the order have been circulated to the District Magistrate Bandipora, Senior Superintendent of Police Bandipora, SDPO Sumbal, and the D.O. Ajas for necessary action and compliance.

Asked about activist Sonam Wangchuk, currently in jail for allegedly inciting protests in Leh, Shah said, "I can speak of the demands of the people, not about any individual. The matter is before the court, which will decide based on evidence.'

Shah also addressed Maoist insurgency, asserting that the government has undertaken claiming that over 600 Maoist camps have been dismantled in the past 11 years. "Maoism will be completely wiped out by December 31, 2026," he declared.

#### **Will Omar Move**

Omar said he is consulting senior lawyers in Jammu and Kashmir as well as in Delhi to explore the legal option, given his unique position as someone who has served both as the chief minister of a state and of a Union Territory.

"I don't think anybody else understands the disadvantages that we are put to by being a UT than I do. I am the only person in the entire country with the experience of being both the chief minister of a state and the chief minister of a UT. I can put it on paper and share with the honourable Supreme Court when they have to decide about the statehood to J&K," he said.

He added that the decision will depend on legal advice. "This is something that is actively being discussed with a legal team and based on their opinion, there is a possibility that as chief minister, I will make myself a party to this case," he said.

The Supreme Court is currently hearing a batch of petitions seeking restoration of statehood to Jammu and Kashmir and has given the Centre four weeks to respond.

On the political front, Omarr made it clear that his party has no plans to join hands with the BJP to speed up the statehood process. 'Tying up with the BJP or an alliance with the BJP is out of the question," he said.

He added that Jammu and Kashmir is still paying the price for the PDP-BJP alliance formed in 2015. "We have already seen how much that destroyed J&K. We are still suffering the after-effects of that. I have no intention of repeating mistakes that other people have made," the chief minister said.

Omar said if the restoration of statehood depends on the BJP forming a government in the region, the national party should be honest about it. "If that is the case, the BJP should tell us that so long as there is a non-BJP government in J&K, you will not get statehood. Then we will decide what we want to do," he remarked.

He also highlighted the confusion arising from dual governance in the Union Territory setup, revealing that his government's appointed advocate general has not been allowed to function. "We appointed an advocate general within days of coming to power. Technically, we have an AG but he has not been allowed to work," he said, adding that the authority to appoint the AG rests with the elected government.

On the situation in Ladakh, Omar said the Centre had failed to keep promises made to the region's people. "The crisis in Ladakh is extremely unfortunate. Promises were made which have not been kept. Ladakhis were promised the Sixth Schedule but not granted. Do you want to push the people of Jammu and Kashmir to the wall as well?" he asked.

He said both Jammu and Kashmir and Ladakh deserve the promises made to them after the revocation of Article 370. "Two Union Territories were born out of one state, yet J&K has been treated differently. The main promises made to the people should be kept," Omar

Security, law and order all these things should be under the control of the elected government. The day these things are ours, I won't even wait for the assembly session. We will remove the Jammu and Kashmir Public Safety Act (PSA) through an ordinance," Omar said.

Responding to Union Home Minister Amit Shah's statement in Patna that statehood would be restored at an "appropriate time" after discussions, Omar rejected any linkage between statehood and incidents like the Pahalgam attack, noting that those involved were not from &K. Reflecting steady core operations, the Bank's Net Interest Income (NII) for the half-year (H1) is marginally up by 3.4% Year-on-Year at Rs 2899.43 Cr, while for Q2 NII stood at Rs 1433.99 Cr. In line with its market guidance, the Bank has maintained its NIM at 3.64% for the halfyear (H1). The Bank's other income for H1 was at Rs 405.19 Cr while the Cost to Income Ratio for the half-year stood at 60.80%

Commenting on the Bank's Q2H1 numbers, MD & CEO Amitava Chatterjee said, "In spite of widespread disruptions during the first quarter following the Pahalgam incident and the extensive damage caused by floods in the second quarter, the overall growth we have recorded is both encouraging and reassuring."

"Even though profitability for Q2 was moderated due to an additional impairment provision of Rs 92 Cr made during the quarter in compliance with regulatory requirements, the performance is better than what was anticipated under the challenging circumstances.", he added. Notably, the Bank has made a total provisioning of Rs 180 Cr towards Jammu and Kashmir Grameen Bank during the first two quarters of the current financial year. Excluding the impact, the Bank's H1 profitability would be upwards of 15% YoY.

Asset-Quality Despite difficult situation arising out of Pahalgam attack in Q1 and floods, landslides thereafter in Q2, the Bank has gained further stability in asset quality. During the quarter, the Bank's Gross NPA Ratio has declined 18 basispoints QoQ to 3.32% and decreased by 63 bps

YoY from 3.95% recorded in September, 2024. **BARCELONA:** For a second straight day, protests by La Liga players against the league's decision to stage a game in the United States were not broadcast for television audiences.

Neither of the television feeds for Saturday's Sevilla-Mallorca and Barcelona-Girona contests started with a normal wide shot of the field, which would have shown the players remaining still for the first 15 seconds after kickoff in opposition to a regular season game between Barcelona and Villarreal in Miami in December.

The TV broadcast at Sevilla focused closely on the center circle for the first seconds, while at Barcelona the feed was from outside tains of the top flight teams supported it for games in the ninth round from Friday through Monday.

For the first protest on Friday night, the TV feed showed the outside of Oviedo's stadium while its players and Espanyol's held the protest. The feed went back to normal after 25 seconds when the players had started play. The union said the sym-

bolic action was to protest the "lack of transparency, dialogue and coherence of La Liga regarding the possibility of playing a game in the United States.
