## CWC Report: Himalayan Lakes Growing, 50 in J&K at Risk

Srinagar: Glacial lakes and other water bodies in the Himalayan region have grown by 9.24% over the past 14 years, highlighting the visible impact of climate change, according to a report by the Central

The total area of glacial lakes

5.30 lakh hectares in 2011 to 5.79 lakh hectares in 2025. The CWC's Monthly Monitoring Report, which tracks water bodies in the Himalayas, notes that shrinking glaciers and expanding lakes are among the clearest signs of glob-

Over the 14-year period, 1,435 glacial lakes and water bod-



water spread, while 1,008 recorded a decrease. Using highresolution Sentinel satellite data via Google Earth Engine, the CWC monitors 2,843 lakes across the Himalayan belt.

Within India, 428 lakes have expanded and require vigorous monitoring for disaster preparedness. Jammu & Kashmir accounts for 50 of these lakes,

while Ladakh has 133, Himachal Pradesh 13, Uttarakhand 7, Sikkim 44, and Arunachal Pradesh 181. The total water spread in Indian glacial lakes rose from 1,995 hectares in 2011 to 2,445 hectares in 2025, a 22.56% increase.

## Ex-JE Jailed 7 Years for Two-Decade-Old DoB Fraud

Court Also Imposes Rs 352760 Fine On Octogenarian For 21-Month Overstay

Srinagar: A Pulwama court on Thursday sentenced a former Junior Engineer of the Rural Development Department to seven years' imprisonment for manipulating his date of birth by five years in his service book.

Special Judge Anti-Corruption Pulwama, Dr. Noor Mohammad Mir, also imposed a fine of Rs 3,52,760 on the convict, Sonaullah Wani (now octogenarian), after finding him guilty of multiple offences, more than two decades after the trial began.

According to prosecution, the case had been registered in 2000 by erstwhile Vigilance Organization of Kashmir now Anti-Corruption Bureau (ACB), following a complainant.

During the investigation, the VoK had sent Wani's matriculation certificate to J&K Board of School Education for verification and it had confirmed his actual Date of Birth to be 8 June 1940

instead of 8 June 1945. Wani's Service Book was also sent to Jammu and Kashmir Forensic Science Laboratory Srinagar and it confirmed that its first

page had been torn off and fresh one tagged. Besides, all the entries including Date of Birth entry were found to be fictitious, which have been made by Wani under his own hand, the prosecu-

tion said.

The tigation rethat vealed Wani caused wrongful loss to the state exche-

quer to the tune of Rs.2,62,760 by his overstay in the department fraudulently for 21 months beyond his actual date of retirement i.e 30 June 1998. Wani's pay had been stopped in April 2000.

In 2003, the VoK had filed chargesheet against Wani for the offences punishable under sections 5 (2) Prevention of Corruption Act 2006 and erstwhile RPC's 420 (cheating), 467 (forgery of valuable documents) and 471 (using forged documents as genuine).

After hearing both the sides and weighing evidence, the court held Wani guilty for the commission of offences punishable under section 420, 467, 471 RPC and 5 (2) of J&K Prevention of Corruption Act Svt. 2006.

#### **Midnight Fire Reduces 9 Habba Kadal Homes To Ashes**

**Observer News Service** 

Srinagar: A devastating fire tore through Karfali Mohalla in Habba Kadal during the night between Wednesday and Thursday, reducing nine houses and a godown to ashes and leaving thirteen families homeless.

According to locals, the fire erupted around midnight near the community hall in the densely populated locality. Flames quickly spread from one house to another, creating panic among residents.

Fire and Emergency Service teams from Maharaj Gunj, Babdem, and Headquarters stations rushed to the scene to control the inferno, but narrow lanes and congested housing typical of old Srinagar slowed containment efforts. After several hours of firefighting, nine houses were completely destroyed, with several adjoining homes partially damaged.

Residents described the night as one of chaos and fear. "Flames rose so high, lighting up the entire neighbourhood. People ran screaming, clutching whatever belongings they could grab," said Sahil, a local resident. Many

barely escaped with their children, while others lost decades of memories, photographs, clothes, documents, and savings in minutes.

Authorities confirmed that no casualties were reported. However, the material losses were immense, leaving families stranded in the chilly October night. Locals came together, sharing clothes, blankets, and food salvaged from neighbours.

Political and social leaders have expressed concern. PDP President Mehbooba Mufti tweeted: "Dozens of families have been left without a roof over their heads in this harsh winter, losing not just shelter but a lifetime of belongings. It's heartbreaking." She urged the government to provide immediate financial assistance and building materials so families can rebuild.

Police and Fire Department teams have launched an investigation into the cause of the fire and are recording statements of affected families. District administration officials visited the site, assuring relief and rehabilitation measures for those affected

# **After 15 Years, Noor Jehan Bridge Set To Open**

Srinagar: The long-delayed Noor Jehan Bridge at Qamarwari, spanning 127 metres over the Jhelum River, is finally set to open within days-offering long-awaited relief to thousands of commuters caught daily in downtown Srinagar's traffic snarls.

Sanctioned in 2009 at an estimated cost of 9.5 crore, the bridge was conceived to ease congestion near the old Cement Bridge-one of the city's busiest and most chaotic junctions. However, the project missed multiple deadlines over the years due to land disputes, contractor delays, and shifting government priorities.

Shabir Ahmad Kumar, Superintending Engineer, R&B Division Srinagar (North), said that the bridge has been completed and is ready for use. "We have conducted the load test and resolved all pending issues. The bridge is complete and awaiting final approval for public opening," he said.





## The Kashmir We Don't Photograph

very season, our phones fill with different shades of Kashmir. There are images of Dal Lake shining at sunrise, tulip gardens in full bloom, and hillsides covered in flowers. Tourists arrive with cameras, calling it "paradise on earth." Those pictures travel far, but they show only one side of life here.

Away from those frames, another Kashmir exists. The man rowing a shikara at dawn has been working since early morning, hoping to earn enough to feed his family. The woman planting rice spends hours in muddy fields, her back bent and hands sore. The street vendor selling nuts near the lake faces eviction whenever officials clear the roads.

These people are the ones who keep the valley alive, but their stories rarely appear in anyone's photo.

Behind the beauty, life has become harder for many families. Prices keep rising while jobs remain scarce. Government data says unemployment in Jammu and Kashmir is around six percent, but among young people, it is nearly three times higher. Tourism brings money, but most of it goes to those who own hotels and transport. The workers who serve visitors earn the least and struggle the most.

The way Kashmir is shown to the world also adds to the problem. When people see only perfect landscapes, they forget the effort behind them. Local photographers often say their pictures of farmers, artisans, or children in old neighbourhoods get ignored. Media outlets prefer snow peaks and sunsets over stories of people's lives and work.

Kashmir's story is more than its scenery. It belongs to the farmer who waits for rain, the mother who runs her home with little, and the young man who still searches for a job. They carry the real spirit of this land.

To truly see Kashmir, we have to look past the postcard views. The real beauty lives in the people who row the boats, plant the fields, weave the shawls, and build the homes. They are the ones who keep this valley breathing

# Who Is Plundering Doodh Ganga Again?

Despite Supreme Court and NGT orders declaring Short-Term Permits illegal, sand mining continues in Kashmir's rivers, exposing a deep governance failure and an alarming disregard for the law.

If the law of the land says Short-Term Permits are non-est, how can new ones be issued? When court orders are so clear, why is enforcement so weak? These are questions that need answers not in files, but in action on the ground. The Supreme Court gave us a chance to correct the past. Whether we seize it or let the river die under the weight of excavators will decide the kind of future we want, for Doodh Ganga, and for Kashmir itself.

n March 2024, India's Supreme Court delivered what environmentalists hailed as a landmark judgment. A bench led by Justice Abhay S. Oka and Justice Sanjay Karol ruled that the Ministry of Environment, Forest and Climate Change (MoEFCC) had acted arbitrarily in granting blanket exemptions to certain mining and construction activities. The court made it clear: every project that could harm the environment must first obtain a proper environmental clearance.

This ruling, in the Noble M. Paikada vs. Union of India case, went a step further by declaring 'Short-Term Permits" (STPs) and "Disposal Permits" (DPs) illegal, non-est, under law.

These permits had long been used as shortcuts to bypass environmental checks and speed up riverbed mining operations. The judgment, in effect, outlawed a practice that had devastated river systems across India, including Kashmir's Doodh Ganga and Sukhnag streams.

But, months later, the same old story unfolds in broad daylight. Trucks, excavators, and JCBs are back at the banks of Doodh Ganga in Budgam district, ripping sand and gravel from its bed. And they do this under the same permits, STPs and DPs, that no longer have any legal standing.

This isn't the first time authorities have turned a blind eye. Earlier, on March 15, 2024, the National Green Tribunal (NGT) imposed an interim penalty of 15.79 lakh on two contractors for illegal riverbed mining in Chadoora. They had used heavy machinery in violation of their environmental clearance.

The NGT order, passed by Justice Sudhir Aggarwal and Dr. A. Senthil Vel, also banned further mining in Doodh Ganga and directed the Jammu and Kashmir Pollution Control Committee (JK-PCC) to recover the fine.

The tribunal even calculated the contractors' potential earnings from the illegal extraction, over 1.5 crore in three months, and ordered them to pay 10% as environmental compensation.

The message was unmistakable: Kashmir rivers are not for sale. But enforcement has faltered.

Even after clear judicial directions, the final penalty remains unrecovered, and mining has resumed in the same streams under new "Short-Term Permits." The District Mineral Officer

(DMO) of Budgam and the Assistant Director of Fisheries have issued fresh permits, allegedly allowing contractors to excavate riverbed material at Kralwari and Borwah villages, again using heavy machinery

On October 21, 2025, I visited Kralwari myself, along with a few concerned citizens. What we witnessed was shocking. Excavators were operating openly in the river. The machines roared as if mocking the law. The contractor showed no fear, perhaps emboldened by official backing.

When questioned, local irrigation officials appeared helpless. They admitted they couldn't intervene. It's strange how the same departments act swiftly against poor labourers who dig sand manually but stay silent when powerful contractors use machines that gouge the riverbed.

Later that day, the Assistant Director of Fisheries, perhaps realizing his mistake, wrote a letter to the DMO Budgam (communication no. ADF/Bud/2025-26/Misc dated 21.10.2025) asking that the contractor stop using heavy machinery. The DMO did not act.

This is more than a local issue. It reflects how environmental governance collapses when accountability is missing. The Supreme Court's 2024 ruling was explicit. The NGT's July 2025 order in Raja Ram Singh vs. State of UP reiterated the same: Short-Term Permits and Disposal Permits hold no legal value. But they continue to be issued, as if court judgments are optional advisories.

Across Kashmir, such violations have become routine. From Doodh Ganga to Sindh and Rambiara, unregulated mining has altered river flows, eroded embankments, and destroyed aquatic life. A study by the J&K Pollution Control Committee in 2023 recorded that suspended solids in

Doodh Ganga exceeded permissible limits by nearly 300%. Riverbanks that once absorbed floods are now weakened by unchecked excavation.

Each illegal truckload of sand taken out means lost soil fertility, lost livelihoods for local fishers, and lost resilience against climate disasters.

environmental Kashmir's story has always been one of beauty meeting neglect. The region's fragile ecosystems demand strict enforcement. The Supreme Court's orders should serve as a foundation for reform, not a document to be ignored.

Authorities need to move beyond token actions. The JKPCC must recover the pending compensation and hold responsible officers accountable. The District Magistrate Budgam must stop issuing illegal permits and initiate departmental action against violators.

Above all, public participation, something the Supreme Court itself emphasized, must become central to river governance. communities, especially those living near riverbanks, should be empowered to monitor and report violations. Digital monitoring of mining sites through drones and satellite data can further strengthen transparency.

Doodh Ganga is a lifeline for thousands. Its name, "river of milk", once symbolized purity and abundance. Today, it tells a story of greed and governance failure.

#### The Hands That Nurture Kashmiri Children

efore the first bell rings in government schools across Jammu and Kashmir, a woman moves through the classrooms carrying a broom in one hand and a child's hand in the other. She wipes desks, arranges mats, comforts crying children, and helps little ones begin their day feeling safe and

She is the AAYA, a familiar figure in schools whose presence shapes early learning in ways that often go unnoticed. Her role may seem small, but it is central to how children experience school for the first time.

Under the Samagra Shiksha framework, the government has strengthened Early Childhood Care and Education (ECCE), aiming to nurture children aged three

to six through learning, health, and care. Teachers lead lessons, but the AAYA provides the support that allows learning to take root. She is the bridge between home and school, turning anxiety into comfort, and hesitation into curiosity.

Her work extends far beyond keeping classrooms tidy. She guides children safely between play areas, toilets, and classrooms, ensures hygiene, cleans toys and mats, and supports teachers during storytelling, art, and group activities. During meals under programs like PM POSHAN, she makes sure every child eats properly, follows hygiene routines, and feels included. A gentle word or gesture from her can transform a shy child's day.

Her emotional presence matters

just as much. She often soothes the first tears, calms fears, and offers a lap of reassurance. She understands the small needs of children in ways adults focused on instruction may miss. In her care, children learn trust, safety, and belonging, the invisible lessons that shape their earliest social and emotional growth.

Recognition of AAYAs remains limited. Teachers and school heads can change that. Respect, guidance, and inclusion in staff discussions allow AAYAs to feel valued. Training in early childhood development, hygiene, safety, and first aid strengthens their work. Timely honorarium and acknowledgment of their daily efforts reinforce their dignity.

When teachers and AAYAs work in harmony, children witness respect

## It's Time Men in Kashmir Are Heard

Beneath the smiles and "I'm fine" lies a crisis of men's mental health in Kashmir. Their pain deserves attention.

grew up in Srinagar hearing the same words boys everywhere hear: "Be strong. Don't cry. Be a

At first, it felt like guidance, a way to survive in a world full of rules and expectations. Over time, it became a weight.

A silent, invisible weight that follows you into adulthood, shaping how you speak, laugh, and even

Men in Kashmir, including my friends, classmates, and neighbours, carry burdens no one asks about. There's the pressure to provide for the family, to perform at school or work, to protect loved ones from harm.

Fathers work long hours, often juggling multiple jobs, so the household runs smoothly. Sons push themselves to excel in exams, sports, or careers, trying not to disappoint their parents. And brothers act as anchors when the storms of life hit, silently taking on problems that never belong to them alone.

But rarely do we pause to ask how they are coping. I've seen the subtle signs of men

recover, and live fully.

breaking silently in hallways of hospitals, on streets, and in class-



rooms. A long stare into nothingness, withdrawal from friends, late-night scrolling through old messages, laughter that seems a

shade too loud.

These moments are expressions of the pain we teach men to bury.

Global reports show men are far more likely to die by suicide than women. This is reflected in the young Kashmiri men who juggle the expectations at home with dreams they cannot speak aloud. Society rewards endurance and strength while punishing vulnerability. We celebrate men as providers and protectors but rarely as humans who need care, love, and understanding.

I know men cry. I've cried. We cry in showers, in dark rooms, through work, sarcasm, or anger. Our emotions don't disappear. They wear masks. Many of my peers carry these invisible scars, often alone.

I've watched friends joke through exhaustion, laugh off stress, and hide behind stoicism because we are told that showing emotion is weakness. We internalize these lessons, turning our hearts into vaults of unspoken pain.

The pressure can feel amplified in the valley. Political instability, economic uncertainty, and social expectations shape the environment in which men grow.

leaving for higher education, but worry about supporting his family financially. A husband might feel exhausted from trying to be everything at home, while a father might carry generations of expectation on

Each silent struggle contributes to a pattern where men break

alone, their pain invisible to those around them.

Mental health conversations exist, but men are often left out. Campaigns speak of hope, hashtags spread awareness, but the young man who works three jobs or the student hiding tears behind textbooks rarely sees himself reflected.

Husbands smile at dinner tables while carrying the weight of unspoken failures. Sons sit beside their mothers, longing to confess loneliness and fear but remembering the lessons of childhood: men must endure.

Real courage lies in facing these struggles, sharing them, and asking for help. Emotional health is not gendered. Pain does not discriminate between male or female. Permission to express it often does.

If you are a man reading this, your pain is valid. You don't have to carry it alone. Speak to someone: a friend, a family member, or a counselor. Let your words breathe. And if you love a man, including a father, brother, partner, and friend, look beyond the surface. Ask how he is doing, and listen. Your question could be the lifeline he needs.



Winter is returning to Kashmir, and with it, a daughter learns to live with loss, remembering those who remain only in memory.

Tinter is almost here again. The sunsets have started slipping away early, as if they too are tired of the day. The evenings have grown heavier, the kind that press against the windows.

There are blankets now th smell of burning wood, the familiar hum of heaters, and the emptiness that sits beside it all.

The rooms are warm, but there is an ache in the air that warmth cannot touch. I keep noticing those who are missing. Their absence feels louder than the wind outside.

When I look out from my window in Srinagar, people move with their heads bent low. Their shadows stretch long on the road. I keep watching them, searching for something I cannot name. Peace, perhaps.

Life changes without warning. No one told me that last winter would be my mother's last. We spoke about ordinary things: the price of apples, the way the sun hit the Chinar leaves in the courtyard. I didn't know I was living inside the last moments with her. When she left, it felt as if a door had shut and the house had fallen silent forever.

I still hear her voice in the rooms. The same rooms that now echo differently. Her shawl still hangs on the back of a chair. I touch it sometimes, as if fabric can bring back a heartbeat.

The days that followed were strange. I was breathing, but I had forgotten how to live. It was as if I was made of air and stone at once: light and heavy, alive and absent.

Grief is a private language. Mine came like snow, soft at first, then relentless. It filled every corner of my mind. I tried to hold it back, to seem strong for others, but it pushed against my chest until I couldn't breathe. The world outside carried on,

but I stayed behind, in a world that had tilted away from light. There were days when I want-

ed to forget. And there were nights when forgetting felt like betraval.

I learned that grief doesn't follow rules. It comes when it wants. It leaves when it must. The pain doesn't vanish. It changes shape, turns quieter in-



I prayed a lot that winter. I spoke to Allah through tears, silence, and the long nights when the valley slept. Each prayer felt like a thread holding me together. Slowly, the wound began

Winter has returned to Kashmir, and this time, I meet it differently. I no longer fight the cold. I let it in.

# Defence Ministry Approves Procurement Proposals Worth Rs 79,000 Crore

New Delhi: The defence ministry on Thursday cleared proposals to procure weapons and military hardware worth Rs 79,000 crore, including Nag missiles, amphibious warfare ships and electronic intelligence and surveillance systems, to boost the combat capabilities of the three services.

The procurement proposals were cleared at a meeting of the Defence Acquisition Council (DAC) chaired by Defence Minister Rajnath Singh.

It is the second major decision on procurement following Operation Sindoor.

Procurement projects worth Rs 67,000 crore were approved on August 5.

The DAC approved various proposals amounting to a total cost of about Rs 79,000 crore, the defence ministry said.

For the Indian Navy, approval was granted for the procurement of Landing Platform Docks (LPDs), 30mm Naval Surface Guns Advanced Weight Torpedoes (ALWTs), the Electro Optical Infra-Red

Search and Track System and Smart Ammunition for the 76mm Super Rapid Gun Mount.

The procurement of LPDs will help the Navy undertake amphibious operations along with the Army and the Air Force, the ministry said.

LPDs are amphibious warfare ships that are generally capable of carrying helicopters, ground mobility vehicles, tanks and land troops. The Indian Navy was looking

at procuring at least four LPDs. The ministry said the integrated sea capability provided by LPDs will also help the Navy undertake peacekeeping operations, humanitarian assistance

and disaster-relief measures. "The induction of ALWT, which is indigenously developed by Naval Science and Technological Laboratory, DRDO is capable of targeting conventional, nuclear and midget submarines," the ministry said in a statement.

The procurement of 30mm NSGs will enhance the capability of the Indian Navy and the Indian Coast Guard to conduct low-intensity maritime operations and initiate anti-piracy measures.

For the Indian Army, approval was accorded for the procurement of the Nag missile system (Tracked) Mk-II (NAMIS), the ground-based mobile ELINT (electronic intelligence system) and high-mobility vehicles (HMVs).

The procurement of the NAMIS will enhance the Army's capability of neutralising the enemy's combat vehicles, bunkers and other field fortifications, whereas the GBMES will provide round-the-clock electronic intelligence of enemy activities, the ministry said.

The induction of HMVs will significantly improve logistics support to the forces in diverse geographical terrains, it added.

The DAC approved the pro-curement of Collaborative Long Range Target Saturation/ Destruction System (CLRTS/ DS) for the Indian Air Force (IAF). It also cleared some other procurement proposals of the IAF.

The CLRTS/DS has the capability of autonomous take-off, landing, navigating, detecting and delivering payloads in the mission area.

# **UK Boosts Security Funding for Mosques Amid Hate Crimes Spike**

London: Prime Minister Keir Starmer on Thursday announced a 10-millionpounds boost to security funding for the UK's mosques and Muslim faith centres to protect them from hate crime and attacks.

The additional investment into the Protective Security for Mosques Scheme is aimed at providing security measures such as CCTV, alarm systems, secure fencing, and security personnel services.

The scheme was created to protect mosques, Muslim community centres, and Muslim faith schools that have experienced or are vulnerable to hate crime.

"Britain is a proud and tolerant country. Attacks on any community are attacks on our entire nation and our values," said Starmer.

"This funding will provide Muslim communities with the protection they need and deserve, allowing them to live in peace and safety. I want a Britain built for all and my government is committed to delivering safer streets for everyone - and that means protecting places of worship from those who seek to divide us through hate and violence," he said.

The most recent official



statistics revealed that anti-Muslim hate crimes rose by 19 per cent in the year ending March 2025, and 44 per cent of all religious hate crimes targeted Muslims. The funding boost follows Starmer's visit to Peacehaven Mosque in East Sussex, which was targeted in an arson attack earlier this month.

on the "The attack Peacehaven Mosque was an appalling crime that could easily have led to an even more devastating outcome," said UK Home Secretary Shabana Mahmood.

"I am proud of this country because of the rights we all have to follow the faith of our choosing, and to live free from hatred and fear. That right must be defended.

Violence and intimidation directed at any community or faith are attacks on us all. We must stand together against those who seek to

divide us," she said.

The additional 10-millionpound funding is intended to ensure more sites can be protected, building on the 29.4 million pounds already available for this year towards the protection of mosques and Muslim faith schools under the government-backed protection scheme.

Akeela Ahmed, CEO of the British Muslim Trust, welcomed the move because she said too many members of Britain's Muslim communities have become "fearful and apprehensive as their mosques, places dedicated to faith, love and peace, have been vandalised, set on fire and worshippers abused and assaulted".

"We welcome the announcement of this funding, which will play a key role in helping members of Britain's Muslim communities feel the safety and reassurance they need and deserve." she said.

#### **Govt Initiates Process** To Appoint New CJI; **Justice Surya Kant Next In Line**

New DelhI: The government on Thursday initiated the process to appoint the next chief justice of India as incumbent B R Gavai demits office on November 23, sources said.

The letter asking Justice Gavai to name his successor is set to be delivered either this evening or on Friday, people aware of the procedure to appoint Supreme Court and high court judges said.

According to the memorandum of procedure, a set of documents which guide the appointment, transfer and elevation of SC and HC judges states that appointment to the office of the Chief Justice of India should be of the seniormost judge of the Supreme Court considered fit to hold the office.

The Union law minister would, "at the appropriate time", seek the recommendation of the outgoing Chief Justice of India for the appointment of his successor.

Conventionally, the letter is sent a month before the incumbent CJI retires on attaining the age of 65 years.

Justice Surya Kant is the seniormost judge after the CJI and is next in line to become the head of the Indian judiciary.

Once appointed, Justice Surya Kant will become the next CJI on November 24 and hold the office for nearly 15 months till February 9, 2027.

Chief Minister Ömar Abdullah on Thursday exuded confidence that the NC would sweep all four seats but acknowledged that success would depend on "every non-BJP vote being cast in favour of NC's candidates.'

Omar also revealed that PDP president Mehbooba Mufti had been approached for support. "One of our candidates, Shammi Oberoi, met Mehbooba Ji and requested her backing. Our president Dr. Farooq Abdullah also spoke to her. She has assured me she will consult her colleagues and take the right decision," he said.

The political equation, however, saw a minor tilt after Sajad Lone's Jammu and Kashmir People's Conference (JKPC) announced its deci-sion to abstain from voting, a move that could indirectly aid the BJP.

Meanwhile, Congress MLAs skipped a key allies' meeting convened by the NC earlier this week, though Omar played down the absence saying, "They have their own internal processes. This is nothing new and will not affect the

The Congress' decision to vote in favour of NC comes hours after the PDP made a similar pledge. Party chief Mehbooba Mufti on announced its support to the ruling National Conference (NC) for the third Rajya Sabha seat, saying the move was aimed at keeping the "fascist forces" out. The first Rajya Sabha polls since Jammu and Kashmir's downgrading to a Union Territory are scheduled for Friday.

"We have decided to give support to the NC and vote for their candidates," Mehbooba Mufti said at a press conference, emphasizing that the decision was taken to keep the BJP away.

"The PDP, which has three votes, will vote to keep the BJP away and vote for such a party which does not deserve it. We will vote keeping in mind that we have to stop the fascist and communal forces at any cost," she asserted.

Mehbooba acknowledged differences with the NC, saying that when the People's Alliance for Gupkar Declaration (PAGD) was formed, the aim was to provide collective leadership in J&K to counter the BJP. "But they broke it when they realised it does not serve them any benefit,' she said, referring to the alliance that included both NC and PDP.

The decision to support the NC was taken after discussions with PDP leadership and MLAs, she said. NC president Faroog Abdullah had personally called her requesting support, and NC treasurer and Rajya Sabha candidate G.S. Oberoi (Shammi Oberoi) met Mehbooba on Wednesday to seek backing.

However, the PDP's support comes with conditions. Mehbooba said it was given on the understanding that the NC would support bills introduced by PDP MLAs — the Land Regularisation Bill and the Regularisation of Daily Wagers Bill — in the Assembly.

"I told Farooq (Abdullah) to help us in passing our bills. They have the majority, the Speaker, and the assembly are theirs," she said. Mehbooba added that the BJP had opposed the Land Regularisation Bill, with Leader of Opposition Sunil Sharma reportedly describing it as "land jihad."

The PDP will support the NC candidate on the third seat but not the fourth. "Our three votes are very few, but they mean a lot. We want to give our votes for Shammi Oberoi. We do not want to give support to the fourth candidate because if they lose, they will blame the PDP," she said.

Mehbooba also stressed that the ball is in NC's court regarding the PDP bills. "Whether it is the land rights bill or the daily wagers bill, if NC does not act, the decision will be taken in the people's court," she said, adding that if the bills are stalled, it would indicate that BJP's agenda is being implemented with NC's

On Friday, the House is scheduled to vote to elect four Rajya Sabha members from Jammu and Kashmir. The seats have remained vacant since 2021 as Assembly elections were delayed until last year. Three NC candidates are expected to sail through comfortably due to the party's numbers, while the fourth seat will see a tight contest between veteran BJP leader Sat Pal Sharma and young NC spokesperson Imran Nabi Dar. Dar will require support not only from NC members but also from the opposition PDP, Awami Ittehad Party, and AAP.

The session is expected to be stormy, with debates likely to focus on issues such as restoration of statehood, reservation policies, and regularisation of thousands of daily wagers. Opposition members are also expected to scrutinise the promises made in the NC's manifesto ahead of last year's J&K polls.

## Kashmir's Autumn Smog: Leaf Burning in **Kashmir Fuels Pollution, Respiratory Ills**

SRINAGAR: As autumn wanes in Kashmir, a familiar haze blankets the valley-not from fog, but from the widespread burning of fallen leaves and tree branches. This long-standing practice, intended to produce charcoal for Kangris (traditional firepots) during harsh winters, is raising corious harsh is raising serious health and environmental concerns.

Every year, apple-growing districts like Pulwama, Shopian, Baramulla, Kulgam, and Anantnag see smoke rising from orchards and roadside piles of leaves. The dense smoke contains fine particulate matter, carbon monoxide, and Benzo(a) pyrene, a carcinogenic compound linked to lung disease.

Dr Umar Mushtaq of SKUAST Kashmir explained, "This smoke penetrates deep into the lungs, triggering respiratory problems, particularly among children, the elderly, and those with asthma or heart conditions." The smoke also irritates eyes and throats and reduces oxygen-carrying



capacity in the blood.

Despite environmental regulations and Supreme Court guidelines prohibiting open burning, many residents feel they have no choice. Orchardist Waqar Ahmed of Pulwama said, "We need charcoal for our Kangris, and with frequent power cuts, this is the only way to stav warm."

Environmentalists warn that

the combined effect of thousands of small fires forms a toxic smog, worsened by Kashmir's topography which traps pollutants during temperature inversions. Dr Mukhtar Ahmad, an environmentalist, added, "These fires also damage soil health, killing beneficial microorganisms and reducing fertility."

These schools, upgraded over time, have been functioning without formally sanctioned staff, relying instead on internal arrangements, officials said.

During a meeting with senior officers, the minister was briefed on the status of these schools and instructed that the proposal for staff creation be submitted without delay to the Finance Department for concurrence. She emphasized the importance of avoiding unnecessary delays in processing urgent files and directed all officers to ensure timely disposal.

Minister Itoo also called for the drafting of a comprehensive transfer policy for RETs and other interdistrict or inter-divisional transfers, directing the Secretary of the SED to seek inputs from the directors of planning and finance for framing

On the issue of civil works, the minister reviewed the ongoing proj-

ects under Samagra Shiksha and instructed that a mechanism for physical monitoring at the district level be introduced immediately. "The services of 82 engineers engaged under Samagra Shiksha should be utilized for monitoring civil works at the individual level," she said. Chief Education Officers, along with Executive Engineers from the PW(R&B) Department, are to jointly review progress on a monthly basis.

Further, Itoo directed the preparation of Detailed Project Reports (DPRs) for new works approved under the PAB for 2025–26 and instructed that they be handed over to the PW(R&B) Department for tendering and allotment without delay.

The minister also expressed concern over the non-utilization of funds released to CEOs for urgent procurement and other exigencies, warning that action would be taken against officials who unnecessarily parked funds instead of using them as per proper procedures.

Itoo's instructions underline the government's focus on strengthening educational infrastructure in the Union Territory while ensuring accountability and timely execution of developmental projects.

The accused had been evading arrest since 2003, a police spokesman said in a statement.

After sustained efforts, the police team traced and arrested him. The arrested absconders namely Munshi Chohan resident of Aribal Kulgam wanted in FIR No. 29/1999 under sections 381 RPC of Police Station Shopian, Gulzar Ahmad Bhat resident of Niloora Pulwama wanted in FIR No. 25/2002 under sections 379, RPC, 6 Forest Act of Police Station Shopian and Farooq Ahmad Lone resident of Noorpora Tral wanted in FIR No. 410/2010 under sections 379 RPC of Police Station Shopian, the spokesman said, adding that these individuals were involved in various criminal cases and had been deliberately evading the due process of law for over three decades.

"In Awantipora, Police arrested one absconder who was evading his arrest for the last 14 years. Police received non-bailable warrants under section 299 CrPC/ 335 BNSS issued by the Hon'ble Principal Session Court Pulwama against one absconder namely Latief Ahmad Akhoon son of Jalal din resident of Mulfaq Harwan Srinagar. The absconder was involved in case FIR No 100/2011 under section 20/20 NDPS Act registered at Police Station Awantipora. Subsequently, the arrested accused was produced before the Hon'ble Court of Law," police said.

#### **Frequent Fires Devastate Karnah. Locals Demand More Stations**

Tire incidents have become a recurring crisis ◀in Karnah, where even a minor spark during dry weather can escalate into a major disaster. Reports indicate that around 20 to 25 fire incidents occur in the region every year, often leaving poor families homeless and financially devastated.

The latest tragedy struck on Wednesday in Chitterkoot, where Zahoor Ahmad Khawaja's house was completely engulfed in flames within minutes. Despite the joint efforts of the Army and local residents, the blaze could not be controlled. A Fire and Emergency Service vehicle eventually arrived but by then the house had been reduced to ashes.

Officials noted that the delayed response was due to poorly maintained and difficult roads in Karnah, which make access to remote villages challenging. Residents pointed out that the sole Fire and Emergency Service station in Tangdhar, which houses large fire vehicles, struggles to reach distant mountainous areas in time.

Locals are now urging the government to establish at least three additional fire stations in Karnah and Chitterkoot and to deploy smaller, fast-response vehicles to handle emergencies more efficiently. They called on the district administration and senior officials to take urgent action, emphasizing that dozens of poor families lose their homes and lifelong savings to fire incidents each year. It also discussed arrangements for three-day exhibition showcasing local products.

To ensure real-time coordination among departments, the Div Com directed the establishment of a Command & Control Centre.

#### Jammu Court Summons BCCI Prez Mithun Manhas In Complaint Case

**SRINAGAR:** The Judicial Magistrate 1st Class (Sub Judge), Jammu, has issued a summon notice directing BCCI President Mithun Manhas and others to appear in court in connection with a complaint filed by retired Dy SP Sudershan Mehta.

The complaint, as per the court order, has been filed under Sections 356, read with section 45, and 61 of the BNS Act, against Manhas and other officials associated with the Jammu and Kashmir Cricket Association (JKCA) and several media editors, including Rattan Singh Gill (The Northlines), Shafqat Hussain Bukhari (The Kashmir Horizon), Farooq Ahmed Wani (Brighter Kashmir), and a journalist from The Indian News Service.

The court notice, issued on October 18, instructs Manhas to appear in person or through a legal representative on November 24.

As per the court notice, the



list of accused in the complaint includes Mithun Manhas, Anil Gupta (Retd Brig, Member Administration, JKCA), Majid Dar (Assistant Member, JKCA), and several media editors.

The court's order emphasises that no cognizance can be taken without hearing the 'proposed accused'. It also instructs that copies of the complaint and annexures be sent to the accused via registered post.

The case, which was transferred from the Chief Judicial Magistrate, Jammu, is scheduled for the next hearing on November 24. (KNO)

#### **Bangladesh Wins ODI Series After Leaving West Indies In A Spin**

The Bangladesh spinners were responsible for all 10 wickets as their team thrashed West Indies by 179 runs in the third and final ODI to take the series 2-1 on Thursday.

The dominant victory, its second largest overall and biggest ever against the Caribbean side, helped Bangladesh claim its first ODI series triumph since March 2024. In between, it has lost four such encounters.

Leg-spinner Rishad Hossain capped a successful spell with 3-54, taking his wicket-tally to 12, the highest by a Bangladesh spinner in an ODI series. West Indies was bowled out for 117 in 30.1 overs.

Left-arm slow bowler Nasum Ahmed also took 3-11 to rip through the top order while off-spinner Mehidy Hasan Miraz and left-armer Tanvir Islam picked up two wickets each. Mustafizur Rahman, the lone paceman in the side, didn't even have to bowl.

Earlier, Bangladesh openers Saif Hassan and Soumya Sarkar put on 176 as Bangladesh piled up 296-8. (AP)

#### Babar, Naseem Recalled For Pakistan's T20 Series Against SA

ormer captain Babar Azam and pacer Naseem Shah have been recalled to Pakistan's T20 squad for the upcoming home assignment against South Africa and a tri-Series involving Sri Lanka and Zimbabwe next

Pakistan and South Africa will also feature in a three-match ODI series to be held at the Iqbal Stadium in Faisalabad from November 4 to 8.

It will be followed by another three-match ODI series against Sri Lanka at the Rawalpindi Cricket Stadium from November 11 to 15. Naseem and Babar also feature in the Pakistan's ODI squad. (PTI)

## **Lionel Messi Signs New Contract With Inter Miami Till 2028**

ionel Messi has finally agreed to a new contract with Inter Miami, a deal that required several months to complete and ensures that the sport's biggest icon will be with the Major League Soccer club for its planned move into a new stadium next year.

The deal was announced Thursday, one day before Inter Miami's playoff opener against Nashville. Messi's team — the No. 3 seed in the Eastern Conference — will play host to Game 1 of that best-of-three series on Friday night.

The team announced the move in a social media post, one showing Messi signing the contract inside the new stadium that remains under construction.

Inter Miami said it was a three-year deal through 2028. The notion of Messi playing two or three more seasons certainly would serve as a boost to ticket sales at the stadium the team has been building near Miami International Airport. (AP)
