

PM Erased Art 370 & Terror From J&K: Shah

Srinagar: Union Home Minister Amit Shah on Wednesday launched a sharp attack on the Congress, accusing it of "protecting" Article 370 for seven decades and allowing terrorism to thrive in Jammu and Kashmir, while asserting that Prime Minister Narendra Modi "erased both Article 370 and terrorism" from the region.

Addressing election rallies in Darbhanga, Samastipur, and Begusarai, Shah said the abrogation of Article 370 marked a decisive shift in India's response to terrorism. "Earlier, terrorists used to bleed India and go unpunished. Now, under Prime Minister Modi, India enters terrorist hideouts and eliminates them," he said, adding that Modi "has ended the era of appeasement and weakness.'

Shah said the Modi government had mounted strong responses to cross-border terrorism, citing surgical strikes,

Govt Spent ₹6.49 Cr On Upkeep of Properties **Outside J&K**

Srinagar: The Jammu and Kashmir government informed the legislative Assembly that Rs 6.49 crore have been spent on the maintenance and renovation of properties owned by the Union Territory outside I&K during the 2024–25 fiscal year.

The expenditure covered repair, renovation and upkeep of J&K Houses and other assets in Delhi, Mumbai, Chandigarh, Amritsar and Haryana.

The government, while responding to a query by a legislator, informed that these properties include prime assets such as J&K House on Prithviraj Road, I&K House at Chanakyapuri, and Kashmir House on King George Avenue in New Delhi.

Other properties include land at Dwarka, Shalimar Bagh, and a showroom on Baba Kharak Singh Marg housing the Kashmir Government Arts Emporium and J&K Industries

Constituency Development Fund

CM Removes Spending Limits For MLAs

Srinagar: Chief Minister Omar Abdullah on Wednesday announced major amendments to the Constituency Development Fund (CDF) scheme, expanding the scope of works that legislators can recommend and removing several financial ceilings that had earlier restricted developmental activities.

Speaking in the Legislative Assembly, Omar said the government had been reviewing the scheme for the past two months and approved a set of reforms aimed at giving elected representatives greater flexibility to address local needs.

"We want to inform the House about the changes that have been approved by the government," the Chief Minister said.

Key Changes in Power, PHE and Health Sectors

Abdullah Omar nounced that the ceiling under the Power Development Infrastructure category has



been withdrawn, allowing MLAs to recommend works in this sector without any upper limit. Similarly, the 10 lakh cap on solar light installations has been removed.

Under the Public Health Engineering (PHE) sector, MLAs can now recommend the purchase of mobile water tankers and individual household connectivity projects. In education, the purchase of school vans and buses-both three- and four-wheelershas been made permissible.

In the health sector, the revised guidelines will also

allow the purchase of wheelchairs, tricycles, and manual or motorized scooters.

Special Provisions for Calamity Relief

Referring to recent floods in the region, the Chief Minister announced a one-time relaxation allowing MLAs to use up to 50 lakh from their CDF allocation for rehabilitation of calamity-affected families. The relaxation will apply to the current financial year and 2026-27.

Found: J&K Bans **Loose Paneer**

Foreign Fat

KO Web Desk Jammu: In a decisive move to

curb food adulteration and safeguard public health, the Jammu and Kashmir Government imposed an immediate ban on the manufacture, sale, distribution, import and transportation of loose paneer found to contain foreign fat.

The order, issued by Commissioner of Food Safety, Smita Sethi, comes in response to laboratory tests confirming the presence of beta-sitosterol—an indicator of vegetable or foreign fat—in paneer sourced from neighbouring states. The contamination renders the product unsafe under the Food Safety and Standards Act (FSSA).

Authorities reported that multiple consignments of loose paneer were seized in recent | More on P6

Kashmir To Get Direct Rail Soon: Official

Jammu: After starting the twin Vande Bharat trains on Srinagar-Katra route, marking the completion of Udhampur-Srinagar-Baramulla rail link in June, the northern railways is now eyeing to provide direct connectivity between Kashmir and the rest of country, an official said.

Senior Divisional Commercial Manager of Jammu division Uchit Singhal said the work is underway to address the operational and security hassles to achieve another milestone in Jammu and Kashmir.

Talking to PTI after introducing a two-minute stoppage for semi-high speed Vande Bharat trains running between Katra and Srinagar at Reasi station this morning, he said it was a dream project to bring Kashmir on the railway map.

"The Katra-Srinagar Vande Bharat Express, inaugurated by Prime Minister Narendra Modi on June 6, marked a historic



milestone as the first rail service connecting Kashmir with Kanyakumari. The beginning has been made with the launch of rail service between Katra to Srinagar.

"The work is progressing smoothly to address operational and security hassles to provide a direct train service between Kashmir and other parts of the country soon," Singhal said.

Starting Thursday, the Srinagar-Katra Vande Bharat Express, train number 26401 and 26402, will have a two-minute stop at Reasi railway station. The train will depart from

Katra railway station at 8.10 am and arrive at Reasi railway station at 8.28 am. It will then continue its journey towards Srinagar. Similarly, train number 26402 will return to Reasi railway station at 4:34 pm.

J&K Police Registers 1,342 NDPS Cases Till Sept

Properties Worth ₹16.64 Crore Attached in Anti-Drug Drive

Srinagar: The Jammu and Kashmir Police has intensified its crackdown on drug smuggling and peddling, registering 1,342 cases under the Narcotic Psychotropic Substances (NDPS) Act till September this year. Of these, 1.305 cases have been challaned, leading to 142 convictions and 197 acquittals, officials said.

Additional Director General of Police (ADGP) Crime, Sujit K Singh, said 339 trials were completed during this period, including 12 high-conviction cases. "A total of 215 detentions were invoked under the Prevention of Illicit Traffic in NDPS Act (PITNDPS). Besides, 222 drug hotspots were identified - 44 of which have been demolished - while 1,350 individuals are under active surveillance," he added.

Singh said that 67 financial investigations led to the attachment of 81 properties valued at 16.64 crore. "Nearly 99 per cent of retail pharmacies across J&K have implemented computerised billing and CCTV surveillance systems to curb illegal sales," the ADGP informed.

On the operational front, 983 CCTV cameras have been installed across both divisions of the Union Territory, and only 71 Forensic Science Laboratory (FSL) cases were pending as of October 6. "A total of 103 backward and forward linkages were established, leading to the arrest of 113 accused persons," he said, | More on P6

HC Quashes PSA Detention Of Pulwama Youth

Srinagar: The High Court of J&K and Ladakh on Wednesday quashed detention order under Public Safety Act against a youth from Pulwama and ordered his release forthwith in case he was not required in any other case.

A bench of Justice Moksha Khajuria quashed Kazmi detention order against Sajad Ahmad Bhat alias Baaber, a resident of Rajpora, Pulwama, observing that the same has been issued in 2025 against the 27-year-old for his involvement

in a case registered in 2020. 'The same (order) therefore, is based on the stale grounds as the impugned order of detention has been passed five

years later the date of the registration of the FIR," the court said, adding, "This fact goes on to suggest that there is no proximate link to the alleged actions of the detenue (Sajad) that were deemed to be prejudicial to the maintenance of security of the State."

The Apex Court in various pronouncements, the Bench said, has held that the detention order cannot sustain if there is no proximate link between the detainee and his alleged

subversive actions. District Magistrate Pulwama had passed the order on April 30 after having been found involved in case FIR No. 119 of

Most Indian Soils Low In Nitrogen, Organic Carbon: Study

ndia's soils are alarmingly deficient in essential nutrients such as nitrogen and organic carbon, a study said on Tuesday, raising serious concerns for the future of sustainable agriculture.

The study by Delhi-based think tank Centre for Science and Environment (CSE) is based on the government's own Soil Health Card data.

It found that 64 per cent of soil samples were low in nitrogen and 48.5 per cent were low in organic carbon, two key indicators of soil fertility and climate resilience. The findings suggested that India's heavy use of fertilisers has failed to improve soil health.

Data indicates that applying nitrogen-based fertilisers to the soil does not lead to any "corresponding improvement in soil nitrogen levels", the s tudy said, adding that there is "no improvement in soil organic carbon due to use of total (NPK) fertiliser".

The CSE study warned that this deficiency threatens long-term productivity and the ability of soils to store carbon, which is essential for climate change mitigation. "A critical function of a healthy soil is its capacity to store organic carbon,

which makes it essential for

Apoorva Oza, global lead agriculture, food security and climate resilience at the Aga Khan Foundation, said: "India has around 14 crore farmer households. In the past two years, soil card testing has reached only 1.1 crore. When it comes to soil testing, what is being measured, why, and by who are key to understanding the gaps." 

Srinagar: The Jammu and Kashmir Government on Wednesday said that 18 projects under the Atal Mission for Rejuvenation and Urban Transformation (AMRUT) 2.0, including four in Shalteng constituency, have been approved to strengthen the water supply system in Srinagar city.



IAS Officer, Others Face Prosecution For Fraud

rinagar - Kashmiri officialdom was never very particular about how contemptibly low it stoops to plunder public funds, but it must have required an unusual degree of meanness to cheat backward Gujjars and Bakarwaals of their paltry government compensation for losses suffered due to hailstorms and heavy rain . In this 7-year-old case, the then deputy commissioner Pulwama -incidentally, a senior IAS officer - S. D. Lone; another deputy commissioner, Muhammed Akram Hajam; the then assistant commissioner, revenue, and presently director, land records, Srinagar, Muhammed Afzal Bhat and the then tehsildar Pulwama, Habibullah Mir. along with nearly half-a-dozen petty officials of the district DCs office have been challaned by the vigilance) organisation misappropriating Rs 15 lakh which the state had santioned as relief to the nomads for livestock losses during natural calamities in the hilly areas of Shopyan and Pulwama. The entire amount had been placed at the disposal of the then DC, who had been charged with the responsibility of disbursing it to the deserving members of the community after proper verification.

Vigilance investigations revealed that the officers named m the case, in collusion with four private persons (who have asked been charge sheeted had manipulated records to show that Rs 14,80,940 had been distributed among 652 members of the Gujjjar and bakarwaal community.

Sixty-two persons among the supposed beneficiaries selected at random by the VO, denied having recieved any relief, and the finger impressions on acquitance rolls did not tally with the fingerprints. Expert established that thumb impressions supposed to be the marks of 181 different recipients were in fact the thumbprints of only a few people repeated over and over on the rolls. The VO also found that recepients who were shown belonging to the Udhampur and Rajoun districts were only fictitious names and that Rs 3,75,090 were deposited with Reshi Gas Agency lather than going to a sufferer.

Having prima-facie established the officers' involvement in the fraud; the VO has pressed charges against them under relevant laws before the special anti-corruption court in Srinagar.

Hope In The Himalayas

n today's Kashmir, it often feels like everyone wants to leave. Young people line up outside passport offices, scrolling through study visas and job offers abroad. Leaving seems like the only way to move forward.

But scattered across the valley are a few who made a different choice: they stayed. Their stories don't trend online, but they carry a silent strength that may define Kashmir's real future.

At the agricultural university in Srinagar, young scientists are growing new apple and saffron varieties that can survive changing weather. In Baramulla, a teacher teaches physics to students in faraway villages through her phone. In Pulwama, two brothers are building solar dryers that help farmers save their produce. Each of them chose to build rather than leave.

Kashmir's youth unemployment rate is among the highest in India. Many graduates see migration as their only escape. Each year, thousands leave for the Gulf or Western countries, carrying their hopes and talents with them. Those who remain often face slow systems, few opportunities, and little recognition. But staying also means something powerful: the chance to rebuild home from within.

A young woman from Kupwara, runs a small coding club for local girls. A doctor in Anantnag has set up a telemedicine network linking rural clinics with specialists in Srinagar. Their work is not flashy, but it changes lives. These are the people turning small ideas into lasting hope.

For too long, progress in Kashmir has been measured by distance, by how far one could go. That idea needs to change. True progress comes when people choose to stay and work for their own communities.

Staying back in Kashmir takes courage. It means facing delays, uncertainty, and limited support. But it also means planting seeds for a future rooted in belonging.

Kashmir's story has often been told through pain and departure. It's time to tell it through those who stayed, those who teach, heal, build, and grow where they were born. Their patience and persistence deserve investment and faith.

If the state and society support them with resources and trust, they can shape a future where staying home feels like success, not sacrifice.

Real progress, after all, isn't about how far you go. It's about what you choose to build where you are.

The Highway Problem

Year after year, the valley survives a seasonal isolation policy written by geography.

very winter, as snow tightens its grip on the mountains, the Srinagar-Jammu highway disappears beneath ice and rock.

The trucks line up for miles, engines go off, and drivers wait for road clearance. Each closure cuts Kashmir off from the rest of the country.

Fuel runs low, markets slow down, and for a moment, it feels as if the valley has stopped breathing.

The 270-kilometer highway carries Kashmir's economy, food, medicine, and spirit. Apples from Sopore, petrol bound for Srinagar, oxygen cylinders, and letters of hope all move along this road.

When it closes, the valley feels the pause in homes, markets, and waiting hands across the land.

In the months of sunlight, the highway lives in constant motion. Trucks roll in convoys, dhabas thrum with laughter, and the hills echo with engines and honking horns.

From dawn to midnight, it feels like a living river, one that keeps the valley fed and the markets awake.

Then comes December. Snow begins its slow descent, turning the road into a test of endurance. One rockfall near Ramban or an avalanche at Banihal can freeze life for days.

The drivers know this dance well. They line up their trucks, boil tea on small stoves, and wait with the patience of men who understand

that nature decides the pace.
"When the highway sleeps, we
also sleep," a driver from Anantnag says. "We wait for it to
breathe again."

That wait travels down

the mountains into homes and bazaars. Within days, fuel stations limit supply. Vegetable crates in Batamaloo grow fewer. Bakers shorten their batches.

Families stretch rations with calculation. Mothers check medicine stocks, children study under dimmer lamps, and markets learn to hold their breath.

This cycle has repeated for decades. The valley's economy, worth over 2.2 lakh crore, leans heavily on this one fragile road. Each closure costs millions in trade delays and fuel losses. But the tone in Kashmir remains calm.

People adapt, share, and show a collective choreography of courage.

Small lives hinge entirely on traffic along the route. Mechanics in Ramban hammer frozen axles, chai sellers in Qazigund serve steaming cups to stranded drivers, and roadside shopkeepers survive on the uncertain movement. When the highway sleeps, they too wait, patiently.

The struggle is immense for the men who reopen it. The Border Roads Organization works through snowstorms and landslides, often risking their lives to restore the route. They stand knee-deep in frost, clearing debris while

machines groan behind them. Their work rarely get noticed, but their effort keeps two regions alive.

When the road finally reopens, it feels like dawn. Engines roar awake, horns echo through tunnels, and convoys crawl forward like a great procession of persistence. The dhabas fill again with the smell of fresh bread and hot tea. Markets in Srinagar revive, prices settle, and life resumes.

The NH-44 teaches patience in delay, faith in uncertainty, and strength in stillness. It reminds Kashmir that progress here moves at the pace of mountains.

A Culture of Connections Is Killing Kashmir's Campus Merit

ne of the most troubling realities inside our universities today is the rise of student favouritism. In institutions built to celebrate equality and learning, it's painful to see some students enjoy special treatment for their closeness to teachers or administrators. This growing habit of rewarding connections over competence eats away at the very foundation of education: fairness.

The signs are easy to spot in Kashmir campuses. Certain students receive relaxed attendance rules, extra attention, or higher marks. They are chosen to represent their universities at conferences and competitions. Meanwhile, others with equal or greater talent are sidelined, their

efforts ignored.

The message is clear: it's not

always what you do, but who you know. And that is dangerous for any academic community.

This kind of bias breeds frustration. Students begin to feel that hard work has little value if influence speaks louder. It damages morale and makes learning feel transactional rather than transformative. Those favoured by teachers may not even realize how this privilege harms their growth.

Over time, they learn to rely on proximity instead of performance. For those left out, disappointment turns into distrust toward teachers, peers, and sometimes the entire idea of education itself.

Inside classrooms, this behaviour reshapes the dynamics. Instead of curiosity and dialogue, there's a sense of competition for approval.

Teachers, often without realizing it, let personal preference guide decisions. Sometimes it's about personality, social background, or a student's ability to flatter authority. Whatever the reason, the result is the same: it poisons the trust that keeps a classroom healthy.

The impact goes deeper than marks or opportunities. Many students facing bias experience anxiety and self-doubt. When effort doesn't translate into fairness, they stop participating in class, trying, and even believing. This mental toll is often invisible, but it's real. And once such a culture takes root, it spreads fast, making fairness feel like a forgotten word.

Kashmir universities need to reclaim that fairness. Transparent evaluation, objective grading, and open access to academic opportunities must be non-negotiable. Teachers should undergo regular ethics and sensitivity training to ensure that personal bias never clouds professional judgment. Students should have the confidence to speak up without fear.

Every student arrives with a dream, to learn, build, and rise. When those dreams are dimmed by favouritism, education loses its meaning. It's time our universities restore the value of integrity, equality, and effort.

After all, learning grows only in the light of fairness, and when that light fades, everyone loses.

'The Fertility Clock Is Ticking For Kashmir'

As families shrink and youth migrate, Kashmir faces a slow-burning demographic crisis.

ashmir's newest population data has set off alarm bells. The National Family Health Survey (NFHS) reports the region's fertility rate has plummeted to 1.4, one of the lowest in the country and far below the replacement level of 2.1.

The number signals a dramatic social shift for a place once defined by large, close-knit families.

'I didn't believe it at first," says Dr. Sabahat Rasool, one of Kashmir's top fertility specialists. "It's deeply worrying.'

The change is visible in living rooms and wedding halls across the valley. Fewer marriages, delayed parenthood, and shrinking families are becoming the new normal.

"We've turned marriage into a burden," Dr. Sabahat says. "Big weddings, job demands, and unhealthy competition have made it inaccessible for many."

Couples marrying later, struggle to conceive, and enter parenthood when their best reproductive years are already behind them.

Experts say this shift could alter Kashmir's social and economic fabric in the years ahead.

With young people moving out, elderly care rising, and family ties thinning, the region faces a future that feels both modern and uncertain.

"We are slowly becoming a society that's old before it's ready," warns Dr. Sabahat. "The fertility clock is ticking, not just for women, but for Kashmir as a whole.

In a candid chat with Kashmir Observer, Dr. Sabahat Rasool, Senior IVF Consultant and Associate Professor at LD Hospital, breaks down what's driving the fertility fall, how modern lifestyles are reshaping family choices, and what the numbers really mean for Kashmir's future.

When you first saw that NFHS report showing J&K's fertility rate at 1.4, what was your first reaction?

Honestly, my first thought was, this can't be right! And if it is, then yes, it's worrying. We all know fertility rates are dropping around the world, but I didn't think we'd come this close to those numbers. It's a big deal because fertility rate says a lot about where a society is headed.

So, what does this number really tell us about how Kashmiri families are living today?

It says a lot, actually. It shows how marriage has become such a heavy burden, something that was supposed to be simple and blessed has turned into a competition. We've turned weddings into shows of extravagance, and that's made marriage inaccessible

Then there's this obsession with government jobs. People literally treat it like a marriage eligibility test. If you're in the private sector or doing a startup, you're somehow less "marriage material." It's ridiculous.

Some people say smaller families are a choice. Others think it's about stress, money, health, or migration. What do you think is really going on?

I think it's a mix of everything. First, women today are more independent. They're studying, building careers, and want to be financially stable before they think of marriage or children. Then there's this constant stress, the pressure to

And because people are marrying later, often in their 30s, the biological window gets smaller. That brings fertility issues, highrisk pregnancies, and dependence on treatments like IVF when people are already in their 40s.

So women's education and jobs, would you say they've completely reshaped how people plan families now?

Oh, absolutely. Women are used to earning and managing their own lives now. They don't want to marry early and put their dreams on hold. They're also changing gender roles. They expect equal partnerships, husbands who share housework and childcare.

Oh, things are already shifting. Gender roles are changing fast. You'll see more men sharing childcare and housework.

But on the flip side, young people are leaving Kashmir for better jobs, and their parents are left behind, lonely and aging. Grandkids are growing up abroad, detached from

Slowly, the cultural identity we're so proud of starts fading.

Could this really lead to brain drain or cultural loss?

It already is. The local workforce is shrinking because so many young people are moving out. That's why we're depending more on outside labour.

And as our next generations grow up abroad, they lose their language, and sense of "home.

Over time, the idea of being Kashmiri becomes more symbolic

How strong are religion, culture, and family traditions in all this? Are they still guiding people's choices, or are they fading?

They're fading, no doubt about it. Religion never taught us to show off, but look at how weddings are

now: pure Bollywood! Families are under pressure to outdo each other. That's not culture, that's competition.

And somewhere in all this glitter, we're losing respect for parents, forgetting values, and letting the family bond fray.

There's a deep disconnect be-tween what faith teaches and how we actually live.

And are our systems, including health, education and everything, ready for an older population and fewer kids?

Honestly, no. We're not ready at all. The elderly population is growing fast, and with that come new health needs: loneliness, chronic diseases, and dependency.

We don't even have proper oldage homes or care facilities. Access and affordability of care are huge problems. Old age, in itself, becomes like a disease when society doesn't know how to handle it.

Should this be left to families to figure out, or do you think the government and media should

Government and media have to step in. This is a social issue. The government should plan policies for senior citizens, and media should start conversations about it. We can't pretend it's a "family problem." It affects the structure of our society.

If a young Kashmiri couple asked for your advice on family size, what would you tell them?

I'd tell them, marry young if you can. Have kids while you're still young and energetic. Enjoy their childhoods instead of being too tired or too sick to keep up.

In the end, those moments are what truly stay with you.

Finally, if you had to send one message to the public about this fertility decline, what would it be? Fertility shapes the very back-



ussain Zafar's Shareefo Ka Mohalla (The Clan of Decents) is a book that feels both deeply personal and universally resonant.

Rooted in Kashmir's soil and shaped by its layered society, it captures what it means to live, strive, and stay grounded in one's values while moving through a changing world.

Zafar writes with the calm assurance of someone who has seen both the simplicity of village life and the complexities of city living.

US Doing A Trade Deal With India: Trump

Seoul: US President Donald Trump on Wednesday said that the US is "doing a trade deal with India" as the two sides continue to hold talks on the proposed trade pact.

While speaking at the APEC (Asia-Pacific Economic Cooperation) CEO Summit in Gyeongju, South Korea, Trump added that he had great "respect and love" for Prime

Minister Narendra Modi.

"If you look at India and Pakistan ... so, I'm doing a trade deal with India and I have great respect and love, as you know, for Prime Minister Modi, we have a great relationship," Trump said.

However, without elaborating further on the subject of the trade deal, Trump once again shifted to his claims of resolving the conflict between India and Pakistan in early May.

Trump's comment came at a time when the relations between New Delhi and Washington have been reeling under severe strain after Trump imposed 50 per cent tariffs on India, including an additional 25 per cent levies for its pro-

It is understood that Minister of External Affairs Jaishankar

and US Secretary of State Marco Rubio broadly delved into the proposed trade pact between the two sides during their meeting in Kuala Lumpur on Monday on the sidelines of the annual summit of the Association of Southeast Asian Nations (ASEAN).

However, there was no indication that the US side assured India of removing the 25 per cent tariff slapped for its energy ties with Russia.

In the last couple of weeks, US President Donald Trump Minister Prime claimed Narendra Modi told him that India would stop buying Russian crude oil. Following Trump's first claim, India suggested that there was no such

of the J&K High Court and the Chief Secretary will be taken on board while finalizing the location of the university.

He said that the government will not make any discrimination as far as the establishment of the National Law University is concerned. However, he said that "at present, we have a space available in Ompura, Budgam, which is lying vacant.

We have an option to come up with the varsity there as well."

Earlier, Bhat brought the resolution in the House to seek establishment of Jammu and Kashmir National Law University.

MLA Sonawari Hilal Akbar Lone moved an amendment proposing that the varsity be established in his constituency. However, later he withdrew his proposal.MLA Bandipora's resolution was passed through a voice vote in the

Meanwhile, the Revenue Department informed the House that over 21,000 kanals of land have been delineated in the Jammu division under the Jammu and Kashmir Water Resources (Regulation and Management) Act, 2010. However, no such delineation has been carried out yet in the Kashmir division.

Responding to a query by MLA Rajiv Jasrotia, the department said the delineation and demarcation process began after the issuance of SRO-456 on October 25, 2017, aimed at preventing disputes over water sources and watercourses.

The Administrative Council, through its decision dated January 29, 2022, also constituted three-tier committees to oversee the delineation and demarcation of lands recorded as Gair Mumkin Khad, Gair Mumkin Darya, or Gair Mumkin Nallah in revenue records but not

forming part of any water source. So far, 21,697 kanals and 17 marlas of land have been delineated in the Jammu division, with Kathua district alone accounting for

15,057 kanals and one marla, including both state and private land.

'To address issues related to Gair Mumkin Khad and similar land categories, the government has set up a committee headed by the Deputy Chief Minister, which will submit its report within three months," the department said, adding that the Jal Shakti Department will serve as the secretariat for the committee.

It further stated that since delineation requires technical expertise, the Jal Shakti Department, as the nodal agency for water resource management, has been entrusted with carrying out the process as per statutory

Sept Floods Cost J&K ₹209 Cr In Farm Sector

he Jammu and Kashmir government has confirmed that recent flash floods in September 2025 caused widespread damage to standing crops, horticulture and livestock across several parts of the Union Territory, including Marh Constituency, with total losses assessed at Rs 209.214 crore.

In a written reply to a question by MLA Surinder Kumar, the Agriculture Production Department said that in Marh Constituency alone, 836 beneficiaries were affected due to the floods.

"Out of the total 728.79 hectares sown under paddy, around 449.93 hectares were reported as affected," the reply stated.

The department added that a Joint Survey was carried out under the State Disaster Response Fund (SDRF) by officials of the Agriculture Department in coordination with the Revenue Department to assess the damage and process compensation.

"So far, a compensation amount of Rs 169.13 lakh has been disbursed among 1,436 farmers in District Jammu, including Marh Constituency," the reply said.

To expedite insurance settlements, Crop Cutting Experiments (CCEs) are currently being conducted in the affected fields. Once completed, compensation will be credited directly into farmers' bank accounts through the Direct Benefit Transfer (DBT) system under the Pradhan Mantri Fasal Bima Yojana (PMFBY) guidelines. AAY Beneficiaries Getting Extra 10 Kg Free Ration Since April: Govt

he Jammu and Kashmir government has said that it is providing an additional 10 kg of free ration per beneficiary to Antyodaya Anna Yoja-na (AAY) households in the region since April 2025, while the proposal for providing 12 LPG cylinders to these families is still under consideration.

As per official documents, the Department of Food, Civil Supplies and Consumer Affairs (FCS&CA) stated that the additional ration is being distributed in light of Government Order No. 25-JK (FCS&CA) of 2025 dated April 2, 2025, with an aim to augment the monthly food requirements of AAY households having a family size of four or more members.

The department clarified that the distribution ensures the quantity "does not exceed 10 kg per beneficiary" under the Public Distribution System (PDS).

However, the provision of 12 LPG cylinders to AAY families "is a policy matter and is currently under consideration with the Government," the department added.

Regarding allocation of funds, the department informed that no separate funds have been allocated for the procurement of additional ration. The food grains are being distributed free of cost to bonafide rationees as per government directives, while the cost of procurement, loading, unloading and other components is being met from the department's revolving fund account. (KNO)

Robotic Surgery On The Cards At GMC Srinagar

SRINAGAR: The Jammu and Kashmir government has admitted that untreated industrial waste from the Industrial Estate Rangreth, as well as from the Army Establishment (JAKLI), is being discharged directly into the flood channel that passes through Rawalpora to Peerbagh near Hill View Colony in Srinagar.

Responding to a question by MLA Mushtaq Guroo in the Legislative Assembly, the Industries and Commerce Department said that steps have been initiated to ensure proper treatment of industrial waste before disposal. The department informed that

the State Industrial Development Corporation (SIDCO) has constructed a Common Effluent Treatment Plant (CETP) with a capacity of one million litres per day (1.0 MLD), using Moving Bed Biofilm Reactor (MBBR) technology to treat industrial waste. A dedicated sewerage and drainage pipeline has also been laid to carry treated water to the Urban Environmental



Engineering Department (UEED) drain and the city's main drainage

It added that the CETP structure has been completed and a power connection secured from the Power Development Department (PDD). The plant is currently under a trial run, while environmental clearance is being processed with the Pollution Control Board (PCB).

The department further stated that testing of inlet and outlet parameters will be carried out after the trial run concludes, ensuring that effluents are treated within permissible limits before being discharged into the nearest water

SRINAGAR: The Jammu and Kashmir government Wednesday said it is examining the possibility of introducing a robotic surgery facility at Government Medical College (GMC) Srinagar.

Responding to a question raised by MLA Arwind Gupta in the Legislative Assembly, Health and Medical Education Minister Sakeena Itoo said the proposal is currently under review at GMC Srinagar's Super Speciality Hospital, Shireen Bagh.

"The advancement of the health sector involves the introduction of new equipment and technology only after thorough evaluation of their impact, financial viability, and space requirements," the minister said in a written reply.

She informed that GMC Jammu has already initiated formal procedures to procure robotic Jammu and Kashmir Medical Supplies Corporation Limited (JKMSCL), with an estimated



cost of ₹35 crore.

On diagnostic facilities, Itoo said several hospitals in Jammu and Kashmir are in the process of upgrading outdated CT scan machines. "The existing CT scan machine at the Super Speciality Hospital Jammu has outlived its operational life and is being replaced through JKMSCL," she said, adding that similar replacements are underway at SMGS Hospital and Chest Diseases Hospital, Srinagar.

The minister also informed hat the government has taken up the proposal for implementing a 3-Tier Faculty Structure (Phase-II) in GMCs and Super

Speciality Hospitals of Srinagar and Jammu with the Finance Department. The proposal is currently under examination following observations raised by the department.

Itoo added that medical and paramedical staff are being rationally distributed across rural and remote areas as per sanctioned strength to ensure equitable healthcare delivery under the Integrated Primary Health-"The government remains

committed to strengthening healthcare facilities across J&K by improving infrastructure, technology, and staffing," she said.

No Land Delineation Carried Out in Kashmir: Govt The Jammu and Kashmir Government has delineat-

ed over 21,000 kanal of land in the Jammu Division under the provisions of the J&K Water Resources (Regulation and Management) Act, 2010, while no such delineation has been carried out in the Kashmir Division so far, the Revenue Department has said.

In a written reply to a question by MLA Rajiv Jasrotia, the department said that the delineation and demarcation process is being conducted to avoid disputes in water sources and courses following the issuance of SRO-456 dated October 25, 2017.

The government said that the Administrative Council vide Decision No. 17/1/2022 dated January 29, 2022, had ordered the constitution of three-tier committees to oversee delineation or demarcation of lands not forming part of any water source but recorded as Gair Mumkin Khad, Gair Mumkin Darya or Gair Mumkin Nallah in revenue records.

It informed that a total area of 21,697 kanal and 17 marla has been delineated in Jammu Division, while in District Kathua, 15,057 kanal and 01 marla (including both state and private land) have been demarcated.

"To examine issues relating to Gair Mumkin Khad and similar categories, the Government has constituted a committee under the chairmanship of the Deputy Chief Minister, which shall submit its report within three months," it said, adding that the Jal Shakti Department will service the committee.(KNO)

'QUALIFICATION BAR'

113 Applicants Denied Marriage Aid In J&K

t least 113 applicants were denied financial aid under the Marriage Assistance Scheme in Jammu and Kashmir between April and October 2025 due to the qualification bar set in existing guidelines.

Minister In charge Social Welfare department in a written response stated that these beneficiaries were found ineligible for assistance, as they did not meet the prescribed minimum educational qualification, reported news agency KNO. However, the government has now moved to re-

lax the qualification criteria. The minimum qualification of Class 8 pass has been relaxed up to March 31, 2028, making more applicants eligible for the scheme. The change will apply retrospectively from April 1, 2025. (Observer News Service)

Rohit Sharma Becomes World's No. 1 **Ranked ODI Batter For First Time**

DUBAI: Former India skipper Rohit Sharma on Wednesday claimed the top spot in the ICC Men's ODI batter rankings for the first time in his distinguished career.

The 38-year-old Rohit created history as he rose two spots on the back of his superb unbeaten century (121 not out) in the third and final ODI between India and Australia in Sydney where he led his side to an emphatic ninewicket triumph in style.

The experienced right-hander was in a damaging mood alongside fellow India legend Virat Kohli (74 not out) as he smashed 13 fours and three massive sixes on his way to scoring his 33rd

The former skipper wasn't the only India player to make some ground on the updated rankings this week, with spinner Axar Patel rewarded for a strong game in Sydney with gains in both the bowling and all-rounder category.

Axar jumped six places to 31st behind No.1 ranked Rashid Khan on the list for ODI bowlers and improves four spots to eighth overall behind Azmatullah Omarzai on the rankings for ODI all-rounders.

Inside the top 10 for ODI bowlers, there are gains for New Zealand spinner Mitchell Santner (up three rungs to fourth) and Aus-

tralia seamer Josh Hazlewood (up two spots to eighth), while England right-hander Harry Brook improves 23 spots to move to 25th overall on the list for ODI batters.

There was also some movement on the latest Test rankings following South Africa's impressive eight-wicket victory over Pakistan in Rawalpindi, with experienced spinner Keshav Maharaj the biggest beneficiary on the back of his Player of the Match heroics.

Maharaj gained nine places to obtain a new career-high rating in 13th place on the list for Test bowlers after nine wickets in the Test, while teammate Simon Harmer rises 26 spots to move to 45th following his six-wicket haul in the second innings of the same match.

I can see real talent coming up, so watch out," the umpire said.

Mellissa said the increasing participation of women in cricket is a positive sign for the future of the sport. "If what's happening here is anything to go by, the women's IPL is going to be absolutely amazing," she added.
