Light Rain, Snow Likely On Nov 4-5: MeT

Srinagar: The Meteorological Centre Srinagar (MeT) has issued a weather forecast and advisory for Jammu and Kashmir, predicting mainly dry conditions over the next few days, followed by a brief spell of rain and snow in parts of the Union Territory next week.

As per the weather forecast the weather will remain generally dry from November 1 to 3 across both Jammu and Kashmir divisions.

However, on November 4 and 5, the region is likely to witness generally cloudy weather with a possibility of light rain or light snowfall over higher reaches at scattered places during the evening and night of November 4 and continuing till the morning or forenoon of November 5.

The forecast further suggests generally dry weather again from November 6 to 13, with no significant precipitation expected.

În its advisory, the MET department has cautioned that thunderstorms, lightning, and gusty winds may occur at a few places on the evening of November 4. It also warned of a significant drop in day and night temperatures from November 5 onwards in many areas.

Ganderbal- A local court in Ganderbal has sentenced Abdul Majeed Khan, son of Abdul Ahad Khan and a resident of Gounchi Mohalla, Akhal Kangan, to life imprisonment after finding him guilty of murdering his wife in 2020. The conviction stems from case FIR No. 50/2020 registered under Sections 302 and 201 of the Indian Penal Code at Police Station Kangan.

Investigations conducted by Ganderbal Police established Khan's direct involvement in the brutal killing, which had triggered widespread outrage in the area at the time.

After a sustained investigation and comprehensive presentation of evidence before the court, the prosecution successfully secured a life sentence for the accused.

Srinagar: Chief Minister Omar Abdullah on Saturday said that both Jammu and Srinagar have suffered years of neglect and assured that his government would correct the "wrongs of the past" through inclusive and balanced development across the Union Territory.

Omar was speaking after laying the foundation stone for the widening and four-laning of the Boulevard Road from Nehru Park to Kral Sangri here - a landmark project aimed at improving connectivity along the picturesque Dal Lake.

India Targeted Terrorists, Not Civilians: Army Chief

Rewa: Army Chief Gen Upendra Dwivedi on Saturday said India fought with the combined strength of principles and technology during Operation Sindoor and did not target civilians or military installations in Pakistan.

Speaking to reporters in Madhya Pradesh's Rewa district, Gen Dwivedi asserted that India only destroyed terrorist infrastructure in the neighbouring country.

In response to the April 22 Pahalgam terror attack, India launched Operation Sindoor on May 7, targeting terrorist infrastructure in territories controlled by Pakistan. The strikes triggered four days of intense clashes that ended with an understanding on stopping the military actions on May 10.

"Operation Sindoor was successful because we fought with the combined strength of our



made it a point that no innocent civilians in Pakistan suffered. We only targeted terrorists and their bosses," the Army chief said.

All citizens should work for nation building to achieve the target of Viksit Bharat by 2047, he said.

DIPR Orders Crackdown On Fake Journalists Misusing Media Identity

Srinagar: In a significant move aimed at tackling the growing menace of individuals posing as journalists to extort or coerce officials, the Directorate of Information and Public Relations (DIPR) has issued a stringent directive to all District Information Officers (DIOs) across Jammu and Kashmir, calling for heightened vigilance and coordinated action against such activities.

According to the circular issued on Friday, the DIPR noted that it had received "repeated complaints" from field officers, public representatives, and media houses regarding individuals falsely claiming to represent media organisations. These individuals, the directive said, have been "misusing the name of media for blackmail, extortion, coercion of officials, and



circulation of unverified and defamatory material against public institutions and officers.'

"In several instances, such individuals were apprehended and booked for extortion and misuse of media identity," the DIPR observed, underlining the seriousness of the issue.

Mandatory Verification of Media Personnel

To curb this trend, all DIOs have been directed to maintain and regularly update a verified list of accredited, authorised,

and bona fide media persons operating within their respective districts. This list is to be prepared in consultation with the Directorate and recognised media houses.

The directive further instructs officers to ensure that press releases, media invites, and official briefings are shared only with verified journalists and authorised media outlets through official channels such as email or social media.

District officers have also been asked to keep a close watch on individuals or entities "misusing media credentials, indulging in coercion, or attempting to malign officials or institutions for personal or financial gain."

Wherever such cases arise, the DIPR has directed DIOs to coordinate closely with deputy commissioners and police authorities to | More on P6

USG Showing Cysts Not Sole Diagnosis For PCOS: Director SKIMS

Launches Monthly Initiative To Share Research Findings With Public

Sher-i-Kashmir Srinagar: Institute of Medical Sciences (SKIMS) Soura on Saturday launched a monthly initiative to share its latest research findings with the public – a platform aimed at translating scientific outcomes into better patient care and local health awareness.

Speaking during the inaugural session, Director SKIMS Prof. Mohammad Ashraf Ganie - who also led the country's largest and most comprehensive study on Polycystic Ovary Syndrome (PCOS) under the Indian Council of Medical



Research (ICMR) — clarified that the presence of cysts on an ultrasound alone should not be mistaken for a PCOS

the reproductive axis," Prof. Ganie explained. "Ultrasound findings showing cysts should not alarm patients or families.

Many girls and even adult

women may have cysts that carry no clinical significance." He urged both doctors and the public to refrain from repeated ultrasounds in young girls, emphasizing that "mere presence of cysts is not PCOS, and vice versa - absence of cysts does not rule it out."

"PCOS is diagnosed only when a woman has multiple symptoms together - irregular menstrual cycles, signs of metabolic dysfunction such as high insulin levels, or other hormonal abnormalities," he said. "That's why SKIMS has set up a multidisciplinary PCOS clinic with different specialists to study and man-

PGIMER Flags Rise in Rare Chest Infections in North India

A team at the Postgraduate Institute of Medical Education and Research (PGIMER), Chandigarh, has reported a significant rise in infections caused by a lesser-known bacterium that mimics whooping cough in north India, officials said on Thursday.

Pertussis, commonly known as whooping cough, is a highly contagious respiratory illness that has historically been a major cause of childhood mortality, with fatality rates reaching 10 per cent in the early 20th century, a PGIMER statement noted.

The study, titled 'Emergence of Bordetella holmesii-Associated Pertussis-Like Illness, Northern India, 2019–2023', was published in the Emerging Infectious Diseases iournal (of the Centers for Disease Control and Prevention, USA) and analysed 935 suspected pertussis

After a brief decline during the CO-VID-19 pandemic, the number of cases has sharply rebounded. India recently reported approximately 13.6 million cases, while China's incidence rose from 0.13 per 1,00,000 in 2013 to 2.15 per 1,00,000 in 2019, exceeding 58,990 reported cases by early 2024, it said.

The PGIMER team's findings underscore the institute's pivotal role in identifying emerging pathogens and follow the scientific team's earlier identification of stenotrophomonas sepilia, a new bacterium responsible for sepsis, it added.

5th Edition Of Kashmir **World Film Festival Opens**

Srinagar: The 5th edition of the much-awaited Film Festival commenced today at Tagore Hall, Srinagar, marking a vibrant celebration of cinematic art, creativity, and cultural exchange.

The inaugural ceremony witnessed an impressive turnout of film enthusiasts, artists, and students of cinema. Veteran film and television personalities Raza Murad, Shishir Sharma, Jayati Bhatia, and Sunit Tandon graced the occasion as chief guests. They were felicitated with traditional Kashmiri shawls and mementos in recognition of their contributions to the entertainment industry.

Renowned actors and filmmakers Rajit Kapur, Madhur Bhandarkar, and Lalit Parimoo are expected to join the creative work and contributions to regional cinema.

Well Done, **Information Department**

After years of unchecked chaos on social media, Kashmir's information department has finally drawn a line. The era of phone-camera "reporters" may soon face long-overdue scrutiny.

'n Srinagar, it's now common to find someone standing in the middle of a crowd, phone in hand, talking breathlessly into

"Full story coming soon," they say, as people gather around, some curious, others amused. A video is uploaded within minutes. Shares and comments pour in.

By evening, that "breaking" clip is everywhere, sometimes with facts bent, names twisted, and stories reshaped to fit a dramatic frame

This has become the new identity of news in Kashmir's digital bazaar. Almost anyone with a smartphone can be a "reporter." A protest outside a government office, a family dispute, or a scuffle on the street becomes content.

What began as a way to show life on the ground has now become raging and reckless pursuit.

The intention was once noble. In the absence of mainstream access and representation, young Kashmiris turned their cameras toward daily life, giving visibility to people often unseen. But the platforms rewarded something else.

Algorithms favoured outrage over accuracy, emotion over evidence. Soon, the most viral stories were the noisiest.

Over time, social media news in Kashmir began to look less like journalism and more like performance. The lens followed anger. A camera pointed at an official's desk or a roadside argument became a tool of intimidation rather than inquiry. A few voices started using the word "journalism" as a license to coerce or shame, collecting views and sometimes favours.

Behind many of these viral videos was no newsroom, editor, or verification, rather a person with a phone and a need to be seen. Meanwhile, trained reporters who spent days chasing facts

and verifying quotes found their work overshadowed. Their stories, grounded in reality, were often drowned out by the noise of handheld outrage. The audience, caught between distrust of institutions and attraction to immediacy, started to confuse spectacle with truth.

That confusion, for years, went unchecked.

On October 31, 2025, the Department of Information and Public Relations (DIPR) in Kashmir issued a sweeping directive to all District Information Officers, It was a rare official acknowledgment of what many in the media had discussed for years: the misuse of "media identity" by individuals with no credentials, ethics,

The order, signed by Joint Director Information Syed Shahnawaz Bukhari, doesn't mince words. It notes that "certain individuals, without any formal accreditation or authorization. are posing as journalists," misusing media names for "blackmail, extortion, coercion of officials, and circulation of unverified and defamatory material.'

For the first time, the administration has directed district officers to maintain verified lists of authorized journalists, report misuse immediately, and coordinate with police and deputy commissioners on legal action.

For many in Kashmir press circles, this feels like long-overdue justice. It marks a moment when the system finally acknowledges that journalism has been under siege, from within its own collapsing ecosystem.

The unchecked rise of "freelancers" without ethics has harmed genuine reporters and eroded public trust.

The directive also calls on media houses to clean up their own spaces: to verify their stringers, issue proper ID cards, and distance themselves from anyone misusing their name. It reminds editors to uphold the code of ethics laid down by the Press Council of India. The message is simple but firm: credibility must return to the center of journalism.

For audiences, too, this could mean a change.

A new line is being drawn between free expression and impersonation, between a citizen's right to speak and a journalist's duty to verify. The state's renewed vigilance may finally create a distinction that digital chaos had blurred.

Kashmir mediascape has always existed under extraordinary pressure. But amid that struggle, social media once offered hope: a window for young storytellers to speak in their own voices. Somewhere along the way, that hope got hijacked by ambition, ego, and misinformation.

This new directive is not a cure-all. It won't instantly separate genuine reporters from pretenders. Nor will it solve the deeper crisis of trust that plagues journalism everywhere. But it sets a tone, that journalism is not an open mic for manipulation. It's a public trust built on credibility, compassion, and care for facts.

If implemented honestly, this could restore some order to Kashmir's digital storytelling. Real reporters might finally regain space and respect. Citizens might once again learn to question before sharing.

In the long run, the story of Kashmir media may well be remembered in two phases: before this directive, when everyone claimed to be a journalist, and after it, when the meaning of journalism began to recover.

Maybe that's how justice begins here, with accountability, slowly stitched back into the profession that once gave Kashmir

Darbar Move Returns

Omar Abdullah's decision to revive the century-old Darbar Move may rekindle nostalgia, but it raises deeper questions about governance priorities, fiscal logic, and the lived realities of common people in Jammu and Kashmir.

he decision by Jammu and Kashmir Chief Minister Omar Abdullah to revive the Darbar Move, a colonial-era practice of shifting the Civil Secretariat between Srinagar and Jammu, has reopened an old debate about the region's governance priorities.

First introduced in 1872 by Maharaja Ranbir Singh, the move was intended to balance administrative presence between the two capitals and adapt to seasonal extremes: Jammu's heat and Srinagar's cold.

Over the years, it became a political ritual wrapped in symbolism, until it was suspended in 2021 by Lieutenant Governor Manoj Sinha for being economically wasteful and administratively unnecessary.

Four years later, its reinstatement feels like a step backward. The question is not about history or symbolism. It is about whether the government can afford such an expensive exercise when the region is still struggling with unemployment, poor healthcare, and underfunded education.

According to official estimates, the biannual shift costs around 200 crore every year. This includes the transportation of files, furniture, and equipment, the payment of travel allowances and accommodation for thousands of employees, and the logistics of running two capitals.

For a Union Territory that continues to rank among India's most resource-constrained regions, this expenditure raises tough questions.

Can a government that claims to be digitized justify spending this much money on a symbolic migration of files and officials?

The funds could instead be used for repairing flood-hit infrastructure, improving hospitals, building schools, or creating jobs for young people who are increasingly leaving Kashmir in search of livelihood.

When a single administrative tradition consumes the equivalent



of dozens of developmental projects, it reflects a deep mismatch between governance and ground realities.

Supporters of the Darbar Move often argue that it boosts local economies in both regions, as officials and their families spend money on housing, travel, and services. But this argument overlooks who truly benefits.

Many believe that the move primarily enriches a small class of officials and business owners, particularly those with hotels and commercial properties in Jammu.

Each transfer season guarantees a surge in demand for accommodation, creating steady profits for the well-connected few while the larger public foots the bill.

The practice also imposes a serious human cost on employees.

Twice a year, thousands of families are forced to pack up and relocate, disrupting children's schooling and separating families. Many employees leave behind elderly parents and young children as they move between the two capitals.

What was once considered a matter of prestige has become a recurring emotional and financial strain. For many civil servants, the Dar-

bar Move is a dreaded ordeal that drains both morale and savings.

It is telling that the Jammu and Kashmir High Court, in its 2020 judgment, called the practice

an unnecessary and wasteful activity with "no legal justification or constitutional basis.

The court observed that such movements consume "a tremendous amount of time, effort, and energy" that could be better spent addressing the needs of the people. It even questioned the logic of diverting limited public resources toward non-essential traditions at a time when the Union Territory was struggling to provide basic services.

Despite this clear judicial disapproval, the government's decision to bring the Darbar Move back reflects a troubling sense of misplaced priorities

It shows how political symbolism often triumphs over administrative sense.

The same machinery that struggles to meet employment targets or restore proportionate reservation for students has acted with remarkable efficiency to revive a colonial legacy.

This contrast reveals that governance in Jammu and Kashmir is often about what can be done easily, not what must be done urgently.

The revival also exposes the limits of political imagination. Instead of using the opportunity to invest in technology-driven governance or sustainable economic models, the administration has chosen to pour

Such decisions send the wrong message to the citizens of a place still recovering from economic shocks, political fatigue, and environmental challenges.

At its core, the Darbar Move debate is about power, privilege, and public accountability. When 200 crore can be spent on moving offices, it becomes fair to ask why the same urgency is absent in creating jobs for thousands of unemployed youth.

When digitization has already made physical relocation redundant, reviving the practice feels less like a necessity and more like a gesture to maintain political optics.

Kashmiri people deserve more than symbolic governance. They deserve leaders who understand that progress is measured not in ceremonial traditions but in schools built, hospitals upgraded, and young people employed.

Reviving an outdated administrative ritual will not unite the two regions or heal their divisions. It only deepens the gap between those who make decisions and those who live with their consequences.

The return of the Darbar Move might remind some of the days of royal grandeur and administrative rhythm. But in today's context, it represents something different: the triumph of nostalgia over necessity

The people of Jammu and Kashmir have every right to ask why an archaic practice has been given precedence over their everyday struggles.

For a region that has spent decades waiting for stability, accountability, and growth, this decision feels like another reminder that governance here often moves, like the Darbar itself, in circles.

A Green Wave in Budgam?

As Budgam heads into by-elections, the political mood feels restless. Once a stronghold of National Conference, the district now wrestles with disappointment, nostalgia, and the promise of a revived People's Democratic Party.

he streets of Budgam are alive again. From the narrow lanes of Charar to the open fields near Humhama, a familiar chorus rises each evening: "Zoun ho Zoun ho, PDP'an

The chant, once born of a mispronunciation, has become a declaration Even as the autumn chill deepens, people stay out late, drawn by the thrill of rallies that stretch into the night. The phrase itself has a curi-

ous history.

During the 2024 assembly campaign, People's Democratic Party (PDP) leader Iltija Mufti, unused to the Kashmiri accent, mistakenly said "Zoon ho" instead of "Zoun ho. The slip went viral.

Now, a year later, it echoes across Budgam as both a slogan of hope and mockery, reshaped by the people as only Kashmiris can.

The last election left Budgam in an odd state, represented, yet forgotten.

When Omar Abdullah, the National Conference (NC) leader and current Chief Minister, contested from both Budgam and Ganderbal, he promised to retain whichever seat gave him a stronger mandate. Budgam did. But he chose Ganderbal.

To many, it felt like a betrayal. For a district that shares borders with Srinagar yet remains among the least developed in Kashmir, it was another reminder of its political neglect.

Budgam's roads are pitted, its water taps often dry. Government buildings appear frozen in the past, their paint peeling, and their purpose dimmed.

People still talk of the promise that came with 2024, of jobs, better schools, and clean water, but none of it arrived. "They said five years, but one is already gone," a shopkeeper in Beerwah says, shaking his head. That lost year is now at the cen-

ter of this by-election. The campaigns feel different this time: more personal, and desperate.

The star campaigner missing from NC's rallies says everything about the party's troubles Aga Ruhullah Mehdi, a par-

liamentarian from Srinagar and once a trusted NC face, has distanced himself after months of frustration with the government's unfulfilled promises.

Ruhullah's silence cuts deep because his presence once defined the party's credibility in central Kashmir.

In 2024, he had been reluctant to contest the parliamentary seat. It took persuasion from top NC leaders, who assured him they would fight for the restoration of rights taken after August 2019 and review the reservation policy. He eventually ran and won decisively, defeating PDP's Waheed Para by over a lakh votes. His fiery first speech in Parliament made him a symbol of Kashmiri dignity.

But today, the same leaders downplay his voice. When Omar Abdullah addresses rallies, his tone toward Ruhullah borders on dismissive. In political circles, it feels like a slow unraveling, a split between old lovalties and new realities.

Meanwhile, PDP's new face in Budgam, Aga Syed Muntazir, draws crowds that hum with energy. The chants at his rallies sound both defiant and devotional: "Ase chu Aga'as wadie kourmt, Ase chu Aga'e badshah banavun." We have promised

The NC leans on its legacy, the PDP on its revival. Between them stands a restless electorate, eager to end the long wait for tangible change.

When the votes are cast and the results uploaded, the numbers will tell one story. The real story, however, is already unfolding on the streets, where people chant under the fading lights, warming themselves by the hope that their voices, this time, might matter.

Kashmir Can't Afford Late Diagnoses Anymore

AI and precision oncology are transforming breast cancer care, but doctors say early screening remains Kashmir's biggest need.

▼very October, Kashmir, like **◄** much of the world, turns pink. Ribbons decorate hospital walls, social media floods with statements, and everyone talks about awareness. But behind all the colour and campaigns, a painful truth remains: too many women are still being diagnosed

Breast cancer has become the most common cancer among women across India. In Kashmir too, doctors are seeing a steady rise, especially among younger women.

'Symbolism doesn't save lives, early action does," says Dr. Shabnam Bashir, Director of Surgical Oncology, Division of Breast & Colorectal Cancers & Non-Cancer Disorders at Paras Hospital, Srinagar.

Dr. Shabnam has treated countless women who come in when the disease has already advanced. Many delay checkups because of hesitation, stigma, or lack of aware-

"The pink ribbon should remind us to act, not just observe," she says.

To her, awareness is essentially about starting conversations at home, getting regular screenings, and breaking the silence that still surrounds breast health in Kashmir.

She believes the fight against breast cancer is entering a new phase. Artificial Intelligence is helping detect tumours earlier, and precision oncology now allows doctors to design treatments that fit each patient's unique needs.

Survival rates are improving, but Dr. Shabnam says technology alone cannot save lives. "Unless women feel safe to speak up and seek help early, we will keep losing precious

In a detailed conversation with *Kashmir Observer*, the oncologist explains how timely screening, empathy, and open discussion can help change the story of breast cancer in

Every October, everything turns pink: ribbons, T-shirts, campaigns. But does it actually make a difference?

It can, if we let it. The pink is powerful, but only when it leads to action.

Awareness without followthrough is like lighting a candle and walking away before it burns.

Book your mammogram, do a self-exam, talk about breast health with your family. The colour should remind us to act, not just to observe.

The real power of pink is when someone says, "Because I saw that ribbon, I got myself checked." That's when it works

Everyone says, "check for lumps." Is that the only red flag?

Lumps are the most talked about, but they're not the only clue. The body has other ways of waving red

Notice if there's nipple discharge (especially from one side), if the nipple looks different, like it's pulled in, thickened, or has a sore that won't heal.

Even the skin can tell you something: dimpling, thickening, or discoloration. Basically, if something feels off or looks unusual, don't ig-

We usually think of breast cancer as a "women's disease." But men get it too, right?

Yes, and that's one of the biggest awareness gaps.

About 1% of breast cancer cases are in men, and because it's unexpected, it's often caught late. Men have less breast tissue, so the disease spreads faster. Plus, many hesitate to see a doctor because they feel embarrassed.

The New Great Game

A physicist's idea, a century-old humiliation, and a Cold War opening all converge as Trump and Xi meet to redraw the world's political map.

Three themes, two historical events and the other a concept from physics, may best describe (or even define) the meeting between Donald Trump and Xi Jinping.

Physics first. In this schema, singularity is a point of infinite density and spacetime curvature [....] where concepts of space and time break down. A derivative from mathematics, 'singularity is a point where the mathematical function is not "well behaved". Conjoined together and meshed with technology, singularity is a point in time in the future where stupendous and irreversible changes lead to unknown and unpredictable changes to human civilization'.

consider historical events.

In the 19th century Qing China, when country ran a trade surplus with the world, exporting more and importing less, imperial Britain sought to open China to the Opium trade.

Resisted by China, all in vain, leading to the First Opium War, this era, a defining one for the country, led to the unravelling of Qing China. (This including territorial losses over regions like Hongkong.) Thus was born what Chinese scholars called 'the century of humiliation'.

A pivotal time for China, the 'century of humiliation' can, in modern parlance, be held to be the country's 'foundational myth' (that has roots in real history).

The implications of 'the century of humiliation' have been stark. A bedrock principle internalized by China's political and intellectual elite, the lessons drawn are: never again and never negotiate from a position of weakness.

Historical event two. In 1971, at the peak of the Cold War, between the United States and the former USSR, the able but very cynical practitioner of realism, Henry Kissinger, made an opening to Mao Tse Tung's China. The aim was to engineer a split between Soviet Russia and China.

Against the backdrop of the Vietnam war and Richard Nixon's domestic shenanigans, Kissinger was eminently successful. The China opening was a historical event of great im-

Albeit seemingly unrelated, the concepts of singularity, the historical events delineated here, separated by time, all come eloquently and poignantly together in the historic meeting between Trump and Xi today. The question is how.

Consider the concepts of singularity first.

A defining feature of Donald Trump's approach to politics, all forms of the concept- physics, technological, and mathematical- mesh in the 47th president of the United States.

A 'disruptor', to borrow an inaccurate term from the start-up lexicon, Trump appears to roll back time to the 'Golden Years' of the United States, the post 1950's interlude. This naturally and inevitably has both domestic and international implications.

Emblematized by the 'Make America Great Again' (MAGA) slogan, Trump, given the US constitutional term limits on presidential office, does not have much time. To obviate this, Trump is compressing politicsinternational, domestic- economics, politics and cultural aspects of the same in the overall framework informed by sin-

gularity. Tariffs and trade policy are central to this.

The 47th president of the United State's singularity comes into sharp focus in China, a country that has emerged as a power in its own right, but whose politico-cultural focus and orientation is informed by the 'century of humiliation' and

the lessons drawn thereof.

While the parallel with Kissinger's opening to China is not entirely accurate, but in terms of world historical import, it

holds, the real 'battle' is between Trump's singularity and Xi's conception of China.

Such is the import of the meeting that world peace, global security and the larger all-important questions of war and peace in the 21st century are entirely dependent on the outcome of the meeting.

What then can be expected from the meeting?

Nothing can be foretold given the nature of the conceptual underpinnings and issues at stake. But what is obvious is that both the international system and structure - the structural, operating and conceptual frameworks for international relations - are at this world historical stage dependent on personalities and leaders of two important nations. This is not an aberration; it has happened in the past and the past being determinative of the future, both leaders, Trump and Xi must seize the present. What would this entail?

For Trump, it means understanding in clear and lucid terms where Xi comes from, the well springs of the Chinese presidents' fears, hopes and aspirations for his country. (The century of humiliation and the never again lesson is central to these.)

On his part, the Chinese president must understand in same terms the fears, hopes and aspirations that Trump has for his country.

This starting point for nego-tiations between Trump and Xi will have implications for international relations. What could be the best outcome of the negotiations?

Given the stakes and the nature of the issues involved, there can unfortunately be no best outcome. What there can be is an optimal one that corresponds to the micro-economics notion of 'pareto optimality -'a condition where resources are allocated on such an efficient basis that it is impossible to make one person better off without making the other worse off'.

What structure, the question is, would international relations and world order correspond to?

Given the fluidity of international relations, multiple inflections points and so on, no single theory or concepts of power, system polarity and structure appear to capture the Trump-Xi

Again, microeconomics may offer an approximation.

Post an optimal meeting denouement of two leaders. Trump and Xi, whose respective notions of what is best for their people will determine war and peace, it may be duopoly for the great powers, loose form of oli-gopoly for others (among themselves and in relation to the duopoles) and a kind of monopsony for the rest (in terms of a favorable buy in terms of the distribution of power and resources).

Would this be a fair order? Alas no. Optimal and thereby peaceful? Maybe.

For this to happen the peoples of the world must keep their fingers crossed and pray for a trade deal between Trump's America and Xi's China!

DM Orders Mandatory Tenant, Employee Verification In Jammu By Nov 6

Jammu: Authorities in Jammu have made it mandatory for all landlords, property owners, and business establishments to disclose details of their tenants, domestic helpers, and employees to the local police within seven days, officials said on Saturday.

District Magistrate Rakesh Minhas said the order, issued on Friday under Section 163 of the Bharatiya Nagarik Suraksha Sanhita (BNSS), follows a report from the Senior Superintendent of Police, Jammu, highlighting the need for such a verification.

It comes a couple of days before the reopening of move offices, which were closed in Srinagar on October 31 and are scheduled to reopen here on November 3 in accordance with the age-old practice of 'Darbar Move'.

According to the directive, all property owners, contractors, and commercial establishment heads must submit particulars of their tenants and workers through a declaration form, duly signed by both the owner and the tenant/worker, either in person or via registered post to the SHO concerned.

Those who have already rented out premises or engaged workers prior to the issuance of the order must furnish the details by November



who will do so in the future will have to similarly inform the SHO within the stipulated period of seven days.

The order directs every police station in Jammu district to maintain a separate register for tenant and employee verification records.

It clarified that all arrangements of hiring workers, as well as letting or sub-letting the property to paying guests and tenants, shall be covered by this order.

Any violation of the order will attract legal action under Section 223 of the Bharatiya Nyaya Sanhita (BNS), the order said.

Under the Darbar Move system in Jammu and Kashmir, government offices function from Srinagar during the summer months and shift to Jammu in the winter.

The tradition was reinstated by the Omar Abdullah government on October 16, after being abolished by the lieutenant governor's administration in 2021.

Delhi's Air Quality Deteriorates, Slips Into 'Very Poor' Category

Srinagar: Showing no signs of relief, Delhi's air quality worsened on Saturday, slipping into the 'very poor' category, with an overall Air Quality Index (AQI) reading of 303 compared to 218 recorded the day before. A thick haze of smog continued to envelop the city despite anti-pollution measures being implemented across the National Capital Region (NCR).

At 8 am, the Anand Vihar monitoring station recorded an AQI of 298, while several other locations reported 'very poor' air quality levels. According to the Central Pollution Control Board (CPCB), the city's average Air Quality Index stood at 303 at 4 pm, indicating a sharp decline in air quality.

An AQI between 201 and 300

is considered poor, 301–400 very poor, and 401–500 severe, per CPCB norms.Efforts to curb pollution levelsThe worsening air quality follows the post-Diwali spike, typically caused by emissions, stagnant weather, and residual smoke. Stage 2 of the Graded Response Action Plan (GRAP) remains in effect across Delhi-NCR. Wazirpur reported the highest pollution level in the city with an AQI of



383, placing it in the 'very poor' category, according to data on

the CPCB's Sameer app.
Out of 38 monitoring stations in the national capital, 26 recorded air quality in the 'very poor' category (above 300), while the remaining stations fell in the 'poor' category (below 300).According to the CPCB classification, an AQI between zero and 50 is considered 'good', 51-100 'satisfactory', 101-200 'moderate', 201-300 'poor', 301-400 'very poor' and 401-500 'severe'.

The maximum temperature was recorded at 30.5 degrees Celsius, three notches below the seasonal average, while the minimum settled at 19.4 degrees Celsius, 3.3 notches above normal, according to the India Meteorological Department (IMD).The humidity

pm.Additionally, the IMD has forecast shallow fog for Sunday morning, with the maximum and minimum temperatures likely to hover around 31 and 18 degrees Celsius, respectively.

To discourage vehicular pollution, the New Delhi Municipal Council (NDMC) has doubled parking fees at all designated sites. Meanwhile, the Commission for Air Quality Management (CAQM) has banned entry of non-Delhi-registered BS-III and lower commercial goods vehicles from Saturday. Passenger vehicles are currently exempt. Authorities said these measures aim to reduce vehicular emissions, one of the biggest contributors to urban smog.

Cloud seeding suspended after failed trials. Plans to induce artificial rainfall through cloud seeding have been temporarily suspended after trials earlier this week failed to produce rain due to low moisture levels. Officials said further attempts would depend on favourable atmospheric conditions. Residents-particularly children, the elderly, and people with respiratory conditionshave been advised to limit outdoor exposure as pollution levels remain elevated.

During the "Research Dissemina he discussed SKIMS' leadership in the ICMR-PCOS Task Force study, recently published in JAMA Open Network, which assessed 9824 women aged 18-40 years across 18 premier medical institutions in India.

Prof Ganie revealed that nearly one in five women in India is affected by Polycystic Ovary Syndrome (PCOS).

The study found alarming metabolic risks among women with PCOS - 43.2% were at risk of obesity, 91.9% for dyslipidemia, and nearly one in three for non-alcoholic fatty liver disease

Prof. Ganie called the findings a "transformative moment for women's health in India." He said that the study offers the first robust national data on PCOS prevalence and its complications, revealing rates of 7.2% (NIH 1990 criteria), 19.6% (Rotterdam 2003 criteria), and 13.6% (AE-PCOS criteria).

The prevalence of PCOS was highest in Central and North India, and it decreased with increasing age. Urban areas showed slightly higher prevalence rates compared to rural areas.

Highlighting SKIMS' role as both a research and clinical hub, the Director said the new monthly sessions will regularly disseminate key research insights from the institute to the public.

"We do research so that the benefits reach our patients," he said. "It's important for our local population to understand what our studies mean for them — and how research can directly translate into better healthcare."

The circular further calls upon all districtlevel offices and departments to verify credentials before granting access or sharing information with anyone claiming to be a journalist.

Engagement and Accountability of Media

In addition to field monitoring, the DIPR has urged DIOs to sensitise local media houses and editors about the growing problem of impersonation and unethical practices. Editors have been advised to exercise due diligence while engaging correspondents, freelancers, and stringers ensuring that only "qualified, credible, and verified" individuals are authorised to represent their outlets.

The directive also stresses the need for media organisations to take disciplinary and legal action against representatives found involved in coercive or defamatory conduct and to publicly disassociate from anyone misusing their name or credentials.

Further, media houses have been cautioned to refrain from legitimising individuals facing credible allegations of extortion or blackmail under the guise of journalism and to uphold the journalistic code of ethics prescribed by the Press Council of India and DIPR accreditation guidelines.

Vigilance and Ethical Journalism Emphasized The directive underscores the government's growing concern over the misuse of media identity and its potential to damage public trust, disrupt governance, and malign genuine iournalists.

Kashmir's media circles have long raised alarms about the rise of unverified individuals exploiting journalism for personal gain, often damaging the credibility of legitimate media professionals. The DIPR's latest order is expected to introduce a stronger framework of accountability and verification at the district level, ensuring that press freedoms are not misused as a cover for unethical practices.

Kashmir Marathon 2025 To Be Valley's Biggest Event Since Pahalgam Attack: Tourism Director

SRINAGAR: The Director of Tourism, Kashmir, Raja Yaqoob, on Saturday announced that the upcoming Kashmir Marathon 2025 will be the biggest sport-ing event in the Valley since the Pahalgam attack, saying it will send a powerful message of resilience and unity from Jammu

and Kashmir to the world. "Post-Pahalgam inc incident. this is the biggest event taking place," Yaqoob told reporters. "A strong message is being sent through this marathon that no matter what kind of terrorism occurs, it cannot break the spirit of Jammu and Kashmir."

The director said that athletes from 27 Indian states and



11 countries, including Germany, Denmark, the United States, Ethiopia, Kenya, Japan, and Sri Lanka, will take part in

the event. "We are expecting at

least 1,500 runners, with over 1,200 athletes already in Kashmir along with their families,"

Calling the 2025 edition a

"challenging but symbolic" event due to recent travel advisories and a temporary tourism slowdown, Yaqoob said the marathon represents Kashmir's determination to rise again. "Tourism dipped significantly after the Pahalgam incident, but this marathon proves that our spirit is unbreakable," he said.

The Kashmir Marathon was introduced last year under the initiative of the Chief Secretary to promote adventure and sports tourism. According to Yaqoob, the event will now be an annual fixture, with plans to expand further in scale and participation.

Highlighting the economic impact, Yaqoob said the marathon has already generated thousands of room-night book-

ings and boosted local trade. "Families, coaches, and participants have arrived early, supporting hotels, transporters, and artisans. We also plan to introduce 5K and 10K runs in summer to encourage greater local participation," he said.

The marathon will feature 21 km (half marathon) and 42 km (full marathon) categories, attracting professional runners who have previously competed in international events such as the Boston and London Marathons.

Saffron On The Edge: Pampore **Growers Report 90% Decline**

SRINAGAR: Kashmir's famed saffron sector is once again in crisis, with growers in Pampore – known as the "Saffron Bowl of Kashmir" warning that this year's yield has fallen by nearly 90 percent, pushing thousands of families into distress.

Farmers say production this season is barely 10–15 percent of normal levels, with many fields yielding little to nothing. They fear that if immediate measures aren't taken, the centuries-old crop that defines Kashmir's cultural and economic identity may soon disappear.

"This year the corms haven't sprouted properly at all," said Abdul Majeed Wani, President of the Saffron Growers Association J&K. "Production is hardly 15 percent. It isn't even half of last year's crop, which itself was only about 30 percent of the normal harvest. Every year it is decreasing, and the government doesn't seem serious about

safeguarding this sector." According to growers, repeated long dry spells, lack of irrigation, and the poor quality of corms available

in recent years have devastated saffron fields. They have appealed to Chief Minister Omar Abdullah and the Agriculture Minister to intervene urgently and take emergency steps. Their demands include

immediate irrigation facilities, regular monitoring of saffron meadows, strict actraction, and the availability of high-quality corms for replantation.

The area under saffron cultivation has drastically declined – from 5,707 hectares in 1996–97 to just 2,387 hectares in 2019–20, a reduction of nearly 65 percent. Government data shows production dropped from 17.33 metric tonnes in 2021 to 14.87 MT in 2022, with a negligible rise to 14.94 MT in 2023. However, growers claim these figures do not reflect the grim ground reality.

"Last year's real output was barely 20 percent of an average harvest — and this year is even worse," said a Pampore grower.

While the National Mission on Saffron (NMS) has managed to revive some fields through sprinkler irrigation and farmer awareness programmes, experts warn that its impact has been limited. "Siphoning off of corms and poor land management continue to negate the gains achieved under the mission," said an agricultural scientist from SKUAST-K.

Pampore's saffron prized worldwide for its deep crimson hue, aromatic thread, and medicinal value has been more than just a crop; it is a symbol of Kashmir's identity and heritage.

"Revival of saffron isn't just about saving a crop; it's about preserving a tradition, a culture, and an identity," said a group of distressed growers. "If immediate and effective measures aren't taken, by 2030 there may be no saffron left in Pampore." (inputs from KNO)

Record Tampering

Ex-RDD Engineer Gets 7-Year Jail Term

The Special Judge Anti-Corruption Pulwama, Dr. Noor Mohammad Mir, convicted a former Iunior Engineer of the Rural Development Department in a 25-year-old corruption case for tampering with official service records.

The case, registered under FIR No. 24/2000 by the then Vigilance Organisation Kashmir (now Anti-Corruption Bureau), pertained to the manipulation of the accused's service book and date of birth to unlawfully extend his service tenure.

After a detailed trial spanning over two decades, the court found the accused guilty and sentenced him to seven years of imprisonment. The court also imposed a fine of ₹3,52,760 to compensate the loss suffered by the government.

The conviction was recorded under Sections 420, 467, and 471 of the Ranbir Penal Code, and Sections 5 and 2 of the Prevention of Corruption Act. Officials said the verdict underscores the judiciary's and the Anti-Corruption Bureau's firm stance against corruption and misuse of official authority. (KNT)

30 Films From 14 Nations To Light Up TIFFS In Jammu

Crackdown on Drug Traffickers

2 Held, Properties Worth ₹80 **Lakh Attached**

Tammu and Kashmir Police arrested two alleged drug peddlers and attached properties of two other individuals accused of being narcotics traders in separate incidents in the Kathua and Poonch districts on Saturday, an official said.

The police arrested Rasheed and Koushail, both residents of Kathua from the Rajbagh area of the district and recovered 10.5 kg of bhukki (poppy straw) from them, a police spokesman said, adding that a case under the Narcotic Drugs and Psychotropic Substances (NDPS) Act has been registered against them for further investigation.

In another case, properties including two residential houses and three cars belonging to Nazakat Hussain and Mukhtar Ahmed, both residents of Poonch, were attached by a team of Udhampur police in a case registered against them under the narcotics prevention law and BNS, a police spokesman said. (PTI)

CAT Orders Retrospective Regularisation Of Contingent Worker from 2008

SRINAGAR:The Central Administrative Tribunal (CAT) Srinagar Bench has directed the Jammu and Kashmir Education Department to retrospectively regularize a long-serving contingent worker as a Class-IV employee with effect from October 16, 2008, under SRO 308 of 2008, while also ordering the counting of 50 percent of his contingent service towards qualifying pension benefits.

The order was pronounced by Mr. D.S. Mahra (Member-Judicial) in O.A. No. 1775/2021 filed by Mohammad Amin Baba, a resident of Barzulla Panzigam, Bandipora. The applicant was represented by Advocate B.A. Tak.

According to the tribunal's findings, the applicant had been engaged on a contingent basis as early as July 5, 1992, and continued to serve continuously and satisfactorily for nearly three decades. Despite fulfilling all criteria under SRO 308, his regularization was delayed until September 4, 2020, depriving him of lawful monetary and service benefits.

The tribunal noted that the delay in extending regularization was entirely administrative and not attributable to the applicant. It observed that once SRO 308 was notified on October 16, 2008, the respondents were legally bound to consider all eligible contingentpaid employees for regularization from that date.

Referring to a previous judgment in Zerifa Begum's case, the tribunal, as per the news agency Kashmir News Trust reiterated that a contingent-paid or workcharged employee subsequently brought on regular establishment is entitled to count 50 percent of such service towards qualifying service for pension and that regularization should take effect from the date of eligibility under the applicable SRO.

Allowing the application, the tri-

bunal directed the respondents to treat the applicant as deemed regularized from October 16, 2008, fix his pay and seniority accordingly, count 50 percent of his contingent paid service from 1992 to 2008 towards qualifying service for pension, and release all consequential pensionary benefits.

The Education Department has been given eight weeks from the receipt of the order to complete the entire process. The tribunal made no order as to costs. [KNT]
