Srinagar: The Sher-i-Kashmir Institute of Medical Sciences (SKIMS), in collaboration with the Sher-e-Kashmir University of Agricultural Sciences and Technology (SKUAST-K), convened the Food Safety and Health Conclave 2025 on Tuesday, bringing together top experts, policymakers, and public health officials to deliberate on strengthening food safety mechanisms in Jammu and Kashmir.

Minister for Agriculture, Development & Panchayati Raj, Javid Ahmad Dar, who was the chief guest at the valedictory session, announced that 7,500 hectares have been earmarked for natural farming to reduce pesticide use and promote sustainable agriculture. He said the government was already implementing flagship horticulture programmes and



had strengthened food safety checks following recent public

"Adulteration and unsafe practices must be tackled through both regulation and moral responsibility," Dar said, calling for awareness campaigns at the grassroots level. Prof. M. Ashraf Ganie,

Director of SKIMS, said the

conclave followed the recent rotten meat scandal and was part of the institute's effort to lead a scientific intervention on food safety. He announced that SKIMS would submit a white paper on food safety to the government, highlighting

AIIMS Kalyani, warned that low-dose pesticide exposure posed long-term risks to children and called for coordinated efforts between scientists, religious leaders, and policymakers to strengthen public

He stressed the role of religious scholars and scientific institutions like SKIMS and SKUAST-K in ensuring safe food practices.

'Worked 7 Years Beyond Limit'

At 93, Ex-MD Convicted For Forging DOB

Srinagar: A local court in Jammu and Kashmir has convicted a 93-year-old former Managing Director of the J&K Cooperative Central Land Development Bank Limited for forging his date of birth to unlawfully extend his tenure in service.

According to officials, the Economic Offences Wing (EOW) of the Crime Branch Kashmir secured the conviction of Mohammad Shafi Banday, who was found guilty of fraudulently manipulating his date of birth to gain illegal

service benefits. The case stemmed from a complaint alleging that Banday had deliberately recorded his

date of birth as September 1, 1939, instead of 1934, by producing a fake certificate. A verification conducted by the Crime Branch later established that his actual date of birth was June 26, 1932, officials said.

During the investigation, it was revealed that Banday had overstayed in service for more than seven years, causing wrongful gain to himself and a corresponding loss to the state exchequer.

A formal case was registered by the Crime Branch (now EOW), and after a detailed probe, a chargesheet was filed before the competent court.

'Cannons For Bullets': Shah Vows **Retaliation to Terror Attacks**

Srinagar: Union Home Minister Amit Shah on Thursday warned Pakistan-sponsored terrorists to refrain from attacking India, asserting that any repeat of such acts would invite a fierce response. Speaking at back-toback election rallies in Bihar, Shah said, "If they repeat the mistake, goli ka jawab goley se diya jayega (they will face cannons for bullets).'

Addressing a large gathering in Darbhanga, the Home Minister said explosives manufactured in Bihar's proposed Defence Corridor would be used against these terrorists.



"Prime Minister Narendra Modi is setting up a Defence Corridor in Bihar. The cannons that will answer Pakistan's bullets will be made here," Shah declared, drawing loud applause.

'Inability To Pay Attention When Sleep-Deprived **Could Be Brain Wanting To Clear Waste'**

Attention lapses due to sleep-deprivation could be because the brain is trying to catch up with waste cleansing which typically happens while sleeping – during the day, a new study has suggested.

The cerebrospinal fluid, which flows into and around the brain and spinal cord cushions the central nervous system from shocks, helps remove waste from the brain that was built during the day through 'flushing'. It is considered important for maintaining brain health and

"If you don't sleep, the cerebrospinal fluid waves start to intrude into wakefulness where normally you wouldn't see them. However, they come with an attentional tradeoff, where attention fails during the moments that you have this wave of fluid flow," said Laura Lewis, associate professor of electrical engineering and computer science at the Massachusetts Institute of Technology and senior author of the study published in the journal Nature

Sleep is critical for normal daily functioning, with deprivation known to cause an impaired cognitive function, such as in remembering and paying attention, among other deficits. Problems in the brain's waste clearance has been suggested in previous studies to lead to dementia.

The study tested 26 participants for their ability to pay attention — once following a night of sleep deprivation in the lab, and once when they were well-rested in a visual and an auditory task.

or the visual task, the participants were asked to press a button when a cross on a screen in front of them would change to a square. For the auditory one, they were asked to do the same when they heard a beep.

Recordings of brain activity using an electroencephalogram and functional magnetic resonance imaging (fMRI) scanner revealed that sleep-deprived participants performed worse, compared to the well-rested ones.

Time taken to respond to changes in



visuals and audio was more and in some cases, the participants did not register the change – an attention lapse, the researchers said.

Among the physiological changes seen during an attention lapse, the researchers noted that the cerebrospinal fluid flowed out of the brain during the lapses and flowed back in after each lapse. The result suggests that "at the moment that attention fails, this fluid is actually

being expelled outward away from the

brain. And when attention recovers, it's drawn back in," said Lewis.

The researchers proposed that when the brain is sleep-deprived, it begins to compensate for the loss in cleansing that normally occurs during sleep, possibly at the cost of attention.

"One way to think about those events is because your brain is so in need of sleep, it tries its best to enter into a sleep-like state to restore some cognitive functions," lead author Zinong Yang, a postdoctoral associate at MIT, said. A reduced breathing and heart rate and narrowing of pupils were among the other physiological changes related with an attention lapse, pointing to how effects of sleep-deprivation are body-wide, the researchers said.

They "demonstrate that attentional failures during wakefulness after sleep deprivation are tightly orchestrated in a series of brain-body changes, including neuronal shifts, pupil constriction and cerebrospinal fluid (CSF) flow pulsations, pointing to a coupled system of fluid dynamics and neuromodulatory state."

Kashmir's **Vanishing Villages**

ilence is fast spreading across Kashmir countryside, where laughter once filled the air. The young have moved to Srinagar, Delhi, or the Gulf, leaving behind homes that feel empty. Migration that once promised hope now feels like loss.

Every year, thousands of young people leave rural Kashmir to find work and stability. Official data shows that this shift from villages to cities has grown sharply in the past decade. Farming, once the pride of the valley, is losing its strength. Unpredictable weather, falling profits, and weak market support have made agriculture a struggle. Many no longer see a future in the fields their families once cherished.

The signs are hard to miss. New houses stay locked through winter. Apple boxes lie untouched beside broken carts. Lanes that once rang with children's voices now fall silent. Village life is slowing down. Festivals, weddings, and local markets grow smaller each year.

This change runs deeper than economics. It is reshaping community itself. Villages were once places of shared work and friendship, where neighbours built together and celebrated together. When the young leave, they take away energy, stories, and the sense of belonging that kept these places alive. The old remain, tending their fields alone, watching their villages fade into memory.

Women carry much of the burden. They manage homes, farms, and children while men work far from home. Money comes back through remittances, but families grow apart. Many live between two worlds, uncertain where they truly belong.

Government programs promise rural development, but most fail to touch the core issues: weak irrigation, few small industries, and poor access to credit. Without real reform, migration will continue to drain the countryside of its youth and its vitality.

Kashmir's strength has always come from its villages. Reviving that spirit needs a clear vision and a new pride in rural life.

The land still waits, ready to give back. What it needs are young people willing to dream on it again.

As Kashmir races into modernity, the loss of trust between its people is leaving scars deeper than any economic crisis.

here was a time in Kashmir when a handshake sealed a deal. A promise carried more weight than a signed paper. That simple trust was the real wealth of the valley. It built families, friendships, and entire communities. Today, that fabric feels strained. Money has begun to speak louder than integrity, and deceit has found a disturbing respectability.

The shift is visible in daily life. Bounced cheques and broken commitments are no longer exceptions. Many treat dishonesty as shrewdness. The old wisdom that a lie travels fast but falls hard has been replaced by a belief that shortcuts are clever. Behind the smiles, there is unease. Suspicion now shadows even the smallest exchanges, and stress has silently entered homes that once knew contentment.

This erosion of trust has a cost that goes beyond money. A society built on mistrust cannot prosper in spirit. Kashmir's economy might recover from losses, but its culture will not survive without moral repair. Restoring honesty is not about law. It is about conscience.

Elders must lead by example, reminding the young that wealth without integrity brings no peace. Schools must teach ethics alongside equations. Every small act of sincerity—repaying a debt, keeping a promise—helps mend the tear.

Kashmir has endured many storms. Its resilience lies in the decency of its people. To rebuild that, we must believe again in the strength of a word, in the beauty of trust. The valley's true paradise was never only in its mountains. It was in the honour

Is Gold Shaping a **New World Order?**

From Riyadh to New Delhi, the rush for gold reflects a deeper quest for autonomy in an era of digital currencies and geopolitical finance.

he post-1945 financial order was built on the belief that global systems were apolitical: the money, markets, and networks functioned on neutrality. That belief no longer holds true.

Payment systems can now be weaponised, reserves can be blocked, and algorithms can enforce sanctions faster than diplomats can

In the shifting terrain of global finance, sovereignty is being silently redefined by gold reserves. Gold has re-emerged as the most elemental form of security which is solid, neutral, and beyond manipulation.

The recent surge in gold prices crossing \$3,500 an ounce in 2025 and projected to touch \$4,100 by 2026 is not merely a market phenomenon. It is a political signal.

For decades, the U.S. dollar anchored the world economy, offering both convenience and control. But when financial systems were restricted and sanctioned after geopolitical conflicts, the illusion of neutrality vanished.

Holding dollars came to mean holding conditional power where wealth could be rendered inaccessible overnight.

It is this loss of certainty that has made the solidity of gold newly attractive. The world is, thus in effect, rewriting the grammar of sovereignty, and gold is becoming its new syntax.

Central banks have taken note. Between 2023 and 2024, they purchased more than a thousand tonnes of gold: the fastest accumulation in modern history. This is not a speculative rush but a structural correction, a hedge against the weaponisation of finance.

IMF data reveals that the dollar's share of global reserves fell from 65 per cent in 2016 to below 58 per cent in 2024. In the same period, gold's share rose sharply, particularly among emerging economies.

A 2022 IMF report titled "The Stealth Erosion of Dollar Dominance" observed that the dollar's share in reserves declined from 71 per cent in 1999 to 59 per cent in 2021

"If dollar dominance ends," the IMF concluded, "it will not be replaced by a single currency, but by a collection of alternatives."

The trust that once converged on the dollar is now dispersing across multiple assets. Central banks are quietly diversifying their holdings, adding euros, yen, and smaller but stable currencies.

Meanwhile, gold's share in foreign exchange reserves is rising. Emerging markets now keep about 9 percent of reserves in gold, more than double the 4 percent a decade ago. For developed markets, the figure stands

near 20 percent. And gold, sitting outside this competition, gains value precisely because it belongs to no one.

This slow rearrangement is visible even within the old foundations of the global system. The petrodollar order, which once tied oil and power to the dollar's supremacy, is being silently rewritten.

Saudi Arabia, which has long been the guarantor of that system, increased its gold holdings by 9 percent in 2024, reaching 15.4 tonnes, the highest level since 2014.

The move is not symbolic. It coincides with Rivadh's \$6.9 billion currency swap agreement with China, designed to facilitate trade in local currencies, and the rollout of its digital rival under the mBridge project, which is a cross-border payment experiment using central bank digital currencies.

These shifts may look technical, but they point to something profound: a steady effort to diversify exposure and regain monetary

For complex economies like India, gold offers a vital "middle path", the external resilience needed to stay integrated with the global system while cushioning against its inherent volatility. The dollar's authority now rests on consent rather than certainty, signaling a profound shift in global trust. Gold's strategic resurgence stands as the ultimate expression of an emerging multipolar

India's direction appears similar but carries its own context. The Reserve Bank of India's latest data shows gold reserves crossing marking the highest share in India's reserves

world order.

Gold now makes up 14.7 percent of the total reserve basket. The increase is not dramatic but deliberate. It signals a desire for buffers in the world of volatile trust

India isn't part of the loud de-dollarization talk. The approach is pragmatic: expanding the UPI network across borders, testing the digital rupee step by step, and pushing trade in local currencies where it fits.

Each initiative, in its own way, adds flexibility to financial sovereignty. India remains within the system but tries not to be trapped

Within BRICS and the Shanghai Cooperation Organisation, India engages with alternative payment networks but stops short of endorsement.

Gold fits naturally in this middle path. Its growing share in Indian reserves offer an understanding of stability and caution in a shift-

India's larger story lies outside its official vaults. Roughly, 40 percent of the country's total gold reserve base originates from domestic holdings, including households, temples, and private safes. It is one of the largest unofficial reserves in the world.

But much of it stays idle. India can stand out in this new order by utilizing the reserves that already exist to prevent the import of gold. The idea sounds simple: turn sleeping wealth into living reserves with the help of smarter Gold Monetization Scheme where families could deposit their jewellery, in return for digital gold bounds or paper gold.

Turning physical gold into ETFs (Exchange-Traded-Funds) or digital forms builds strength without more imports. Incentives can make it real, like tax breaks, safe returns, and easy conversion through banks or known

The potential is significant. Even a 10 percent conversion of private gold holdings could reduce India's import bill sharply, strengthen the rupee, and expand RBI's capacity to stabilise external accounts.

Instead of re-importing physical gold, consumers could convert digital units back into ornaments when required. That loop keeps cultural habits intact but redirects liquidity to national reserves. It allows India to preserve sovereignty without confronting the dollar order directly and helps it to balance participation with protection.

First, gold enforces multipolarity by acting as the universally accepted, non-sovereign reserve asset, allowing central banks to divert trust from a single currency to a collection of stable alternatives like Yuan Second, its elemental security lies in re-

storing monetary sovereignty for nations wary of the weaponization of finance. It serves as a fundamental means to de-risk national systems and preserve economic agency.

For complex economies like India, gold offers a vital "middle path", the external resilience needed to stay integrated with the global system while cushioning against its inherent volatility.

The dollar's authority now rests on consent rather than certainty, signaling a profound shift in global trust.

Gold's strategic resurgence stands as the ultimate expression of an emerging multipolar world order.

verywhere I look, people seem to be chasing comfort and success, but losing peace along the way. We have built taller homes, faster cars, and smarter phones, but inside we feel more restless than ever. Families break down over money, neighbours fight over pride, and nations clash over borders.

Living in Kashmir, I have seen how conflict seeps into everything, from conversations at home to lessons in school. The younger generation grows up surrounded by tension and uncertainty. That is why education cannot remain limited to exams and jobs. It must teach how to coexist, value life, and build peace in a world losing it.

The Apple Architect of Kashmir

How one man's faith, labour, and leadership helped turn a modest village in Sopore into the heart of Kashmir's apple revolution.

n Warpora, a village in Zaingeer Sopore, the story of Haji Mohammad Sultan War still moves from lip to lip like an old folksong.

Those who knew him describe

Those who knew him describe him as a man who carried a century of Kashmir's history in his heart and left behind orchards that continue to bloom with his spirit.

Sultan was born around 1925, in a modest mud house where the family's few possessions were measured in faith rather than fortune. Along with his elder brother, Haji Ghulam Rasool War, he began life with nothing except a patch of land and a will that would one day transform the landscape of North Kashmir.

The brothers were orphans before they were adults, burdened with responsibility before they could dream of ease. But instead of yielding to hardship, they leaned into it. They chose to work hard, and with purpose.

As young men, the two would travel across the mountains to Gilgit-Baltistan, on horseback and foot, looking for work in places where no roads existed. Those journeys stitched strength and spirit into their character.

When they returned to Zaingeer, they returned with vision. It was the mid-twentieth century, a time when much of rural Kashmir still lived from one harvest to the next. The brothers saw promise in the soil. They began to plant apple saplings, an idea that seemed strange in a region accustomed to subsistence farming.

tence farming.

The first trees took years to



bear fruit. Seasons passed. People watched, sometimes with doubt, and sometimes with hope. Then the miracle began.

The orchards bloomed, and with

them, Zaingeer changed.

From the 1950s through the 1970s, the valley's green fields turned into a mosaic of apple trees. A generation that once struggled to make ends meet began to find prosperity through the same soil that had once yielded so little.

Today, Sopore's name is synonymous with apples, the "apple town" of Kashmir, and its roots trace back to those two brothers who planted a new way of life.

What made Sultan's story remarkable was his humanity.

When the area had only one car, it belonged to him, but it never stayed parked at his home. It served as a community vehicle, rush-

ing the sick to hospitals, carrying neighbours through emergencies, or ferrying strangers across villages.

To own a car in that era was to possess a kind of power, but Sultan used it to serve. He believed that blessings grew by sharing them.

Those who visited his home recall the same generosity. The door stayed open to everyone: labourers, travellers, families in distress. There was no pride in his hospitality, only a deep sense of duty. He and his brother built their lives on work, faith, and compassion.

Politics tempted many of their generation, but they kept their distance. They admired Sheikh Mohammad Abdullah's National Conference, but never chased public office. They seemed content with their silent revolutions of soil and seed.

On 4 November 2025, Sultan passed away in his village at the age of around one hundred. His departure was as calm as his life, without ceremony and commotion, surrounded by the same land he had tended since boyhood.

His brother Ghulam Rasool had

left a few years earlier, completing a parallel journey of faith and purpose.

Today, when apple trucks roll out of Sopore toward markets across India, few remember the men who first planted the dream. But, in every box of fruit leaving the valley,

their legacy travels.

The race for grades has replaced the joy of learning. Schools now reward memorization instead of understanding, and many children feel trapped under expectations they can't escape.

This pressure is visible everywhere. From Kupwara to Kulgam, young students spend long hours in crowded coaching centers. Parents invest their savings hoping that high marks will secure better futures for their children. The idea seems right, but it comes with a cost.

A 2022 survey by the National Council of Educational Research and Training found that 81 percent of Indian students feel stress and anxiety before ex-

This pressure is worse in Kashmir because of sudden disruptions, poor infrastructure, and limited access to digital tools.

According to the National Statistical Organization, one in five students across India takes private coaching to handle exam stress. In Kashmir towns, coaching centers have replaced playgrounds.

The outcome is worrying. The National Crime Records Bureau reported that more than 13,000 students across India died by suicide in 2022. These numbers reflect a system where exams have become a source of fear instead of learning.

Exams were meant to test knowledge. Instead, they now divide students into winners and losers. They reward those who can memorize quickly and repeat what they learn on paper. Creativity, empathy, and problem-solving rarely count.

As a result, many graduates in Kashmir leave college with degrees that do not match the



skills needed in today's job market.

The National Education Policy (NEP) 2020 tried to change this pattern. It suggested that assessment should help children learn and grow. The policy encourages teachers to use regular, small assessments that show how students think and apply ideas. It also introduced an initiative called PARAKH, which promotes projects, portfolios, and performance-based tasks as better ways to test learning.

If applied properly, these ideas could change how students in Kashmir experience **PP**

education. They could reduce the fear of exams and make learning more engaging. But

progress has been slow.
The old system still dominates classrooms. Many teach-

ers and parents continue to value grades over understanding. Students are still taught to memorize answers instead of

explore questions. Exam scores have also become symbols of family pride. Relatives discuss results in gatherings as if they reflect the family's honour. Children grow up believing that their worth depends on marks written in red ink. This comparison culture starts early and erodes confidence.

Psychologists call this a fixed mindset, the belief that intelligence cannot grow. It makes students afraid to fail or experiment.

What they need instead is a growth mindset, the belief that effort and feedback lead to improvement.

When students see a low score as a step toward progress, they become stronger. Teachers and parents can help by appreciating effort, curiosity, and persistence, rather than perfection.

Education should prepare children for life, not lifelong stress. Exams can be useful when designed well, but they lose meaning when they only test memory.

Changing the way we assess students is essential in Kashmir, where young people already live with many challenges.

The NEP 2020 offers a good starting point, but it will work only if everyone participates. Teachers need support and training to design better assessments. Parents must see education as more than report cards. Policymakers have to ensure that schools get the resources to make learning creative and flevible.

Children in Kashmir deserve classrooms where they can ask questions, explore ideas, and make mistakes without fear. Real education begins when students learn for understanding.

When that happens, exams will no longer be a burden. They will become moments of growth.

India, Israel Sign Major Defence Pact

New Delhi, Nov 4: India and Israel on Tuesday inked a defence pact that will facilitate sharing of advanced technologies and promote co-development and co-production of key weapon systems and military hardware, in a major move to further bolster their already robust strategic ties.

Memorandum Understanding (MoU) was signed in Tel Aviv following a meeting of the India-Israel Joint Working Group (JWG) on defence cooperation.

The MoU on defence cooperation was signed to provide a "unified vision and policy direction to deepen the already strong defence cooperation between the two countries", the defence ministry said.

The pact also provides for cooperation in the areas of artificial intelligence, cyber security, defence research and innovation and industrial collaboration.

India is a leading buyer of Israel's military hardware, and the latter has been supplying various weapon systems, missiles and unmanned aerial

vehicles over the last few years. However, the transactions have largely remained behind the curtains.

India-Israel defence partnership is long-standing, based on deep mutual trust and shared security interests," the ministry said.

The signing of the MoU came when Israeli Foreign Minister Gideon Sa'ar is on a three-day visit to India.

In a statement, the defence ministry said a wide range of areas for cooperation have been identified in the MoU that will benefit both countries.

"Important fields include strategic dialogues of mutual interest, training, defence industrial cooperation, and capabilities including science and technology, research and development and technological innovation. artificial intelligence and cyber security cooperation," the min-

The MoU will enable the sharing of advanced technology and will promote co-development and co-production," it said.

The JWG reviewed the oncooperation defence

initiatives and agreed that both the nations have benefited from each other's strengths, the ministry said.

The two sides discussed the potential areas for future collaboration in the field of technology as well as enhancing operational capabilities," it said.

They also deliberated on various issues, including shared challenges of terrorism, and underscored their collective resolve to fight against the threat," it said.

The signing of the pact came amid reports that Israeli Prime Minister Benjamin Netanyahu is likely to visit India in the next couple of months.

External Affairs Minister S Jaishankar and his Israeli counterpart Sa'ar held extensive talks in New Delhi on Tuesday that focused on working for a global approach of "zero tolerance" to combat terrorism.

The two sides also decided to enhance cooperation in areas of trade, infrastructure and connectivity.

The ties between the two countries have expanded manifold in the last few years in di**Online Gaming Law Pleas**

SC Seeks Centre's Detailed Reply

The Supreme Court on Tuesday asked the Centre to file a comprehensive reply on petitions challenging an online gaming law which prohibits "online money games", and bars banking services and advertising related to them.

A bench of Justices J B Pardiwala and K V Viswanathan was informed that the Centre has filed its reply on the interim prayer made in the pleas.

"We want the Additional Solicitor General appearing for the Union to file a comprehensive reply to the main petition itself," the bench said.

It said copy of the reply be served in advance to the advocates appearing for the petitioners and if they want to file any rejoinder, they may do so at the earliest.

The bench posted the matter for hearing on November 26.

Promotion Regulation of Online Gaming Act, 2025 is the first central legislation banning real-money online gaming, including fantasy sports and e-sports played for stakes and has faced challenges before the Delhi, Karnataka and Madhya Pradesh high courts. Senior advocate C A Sundaram, appearing in the matter, told the bench that the business was completely shut for over a month.

During the hearing, one of the advocates told the bench that a fresh writ petition was filed in the matter but it was not listed for hearing.

"I (petitioner) am a chess player and its a source of livelihood. I was also about to launch an app," the lawyer said.

"India is a strange country. You are a player. You want to play. It's your only source of income and therefore, you want to ioin the proceedings," Justice Pardiwala observed.

The counsel said the petitioner participates in online tournaments organised by the companies and he pays a participation fee also. The bench said his plea be also tagged with the pending petitions.

The top court was hearing a batch of transferred petitions

challenging the online gaming law. The bench said a separate petition, which has sought directions to the government to prohibit online gambling and betting platforms that allegedly operate under the guise of social and e-sports games, would also be heard on November 26.

The top court on Monday had sought response of the Centre on the plea filed by the Centre for Accountability and Systemic Change (CASC) and Shourya Tiwari.

The petitioners argue that the Act imposes a blanket ban even on judicially recognised skill-based games, violating Article 19(1)(g) of the Constitution, which guarantees the right to practice any profession or carry on lawful trade.

The Karnataka High Court had recently issued notice in another related petition.

On September 8, the top court had allowed a plea by the Centre to transfer the petitions challenging the Promotion and Regulation of Online Gaming Act, 2025 from three high courts to the apex court to avoid conflicting verdicts.

has left the press fraternity in shock, and his funeral drew droves of journalists, officials, and friends who remembered him as "fair, fearless, and humble.'

"He was a professional par excellence – sharp in his insight, fearless in his analysis, and unwavering in his integrity," said former journalist Suhail Bukhari, who worked alongside Tariq for years. "In a profession as strained as journalism in Kashmir, his laughter brought rare light. His humour could lift even the heaviest newsroom days.'

Tariq Bhat's journey into journalism began in the 1990s, when Srinagar was caught in the throes of turmoil. After finishing his postgraduate degree in Mass Communication and Journalism at the University of Kashmir, where a classmate, Mussarat Zia, remembered his "striking resemblance to Abdullah Abdullah, the Afghan foreign minister", Tariq worked briefly with The Indian Express before joining The Week in 2001.

His first assignments took him deep into the countryside, where he wrote about the forgotten corners of the valley. "He loved journalism deeply, not as a career but as a calling," said one of his former colleagues. "He carried the despair of what journalism in Kashmir was becoming, silently, on his shoulders and in his

At The Week, his stories were known for precision and compassion. He wrote without embellishment, often letting his subjects speak for themselves. His award-winning report on Dardpora, a north Kashmir village of widows, earned the International Press Institute's India Award in 2014, shared with the magazine's chief photographer Arvind Jain. It remains one of the most haunting portraits of loss and survival from Kashmir's decades of discord.

"I leaned heavily on his razor-sharp insights, his unerring depth, and his quiet generosity," said Yusuf Jameel, a veteran journalist and friend. "His voice will echo in every story we tell from the Valley.'

Colleagues recall his modesty. Though he was The Week's senior-most journalist in Kashmir, Tariq preferred to describe himself as a "small-time reporter" or "lesser mortal." He never sought attention, said PDP leader Naeem Akhtar, who often interacted with him in his capacity as the party's spokesperson. "He had an invincible curiosity to get to the bottom of an issue," Akhtar said. "He gave soul to society and became a torchbearer for the budding iournalists of our land.'

For many younger reporters, he was exactly that - a mentor who never stopped guiding. "I first met Tariq Sahib in 2007, as a fresher stepping into journalism," one scribe said. "He often took us along on assignments, experiences that shaped our early careers. Whenever he spotted a good story, he'd call and say, 'Write this for a national or international audience.' That was his way of teaching us to think beyond borders."

In his newsroom, he was known for his patience. Colleagues at The Week recall how he treated even the youngest trainee with kindness. "He was courteous to everyone," one editor said. "He was the kind of senior who made space for others."

His last article, published on November 3, examined the annual migration of Jammu and Kashmir's government offices to Jammu, the traditional Darbar Move, and quoted Chief Minister Omar Abdullah as saying that the move fulfilled one promise from his election manifesto.

Hours before his death, Tariq Bhat had exchanged messages with friends, ending one conversation with the Kashmiri blessing, "Lassiv", be blessed.

When the news of his death broke, messages of grief flooded social media. CM Omar Abdullah and former chief minister Mehbooba Mufti expressed their sorrow, describing him as a journalist of rare integrity. Journalists across the country echoed that sentiment.

"He represented the best of what Kashmiri journalism once stood for — sincerity, warmth, and an unshakable belief in truth," said one of his peers. "Some people are simply irreplaceable. Tariq bhai was one of them.'

Bhat's passing has left a void that many say will be hard to fill. In an age when journalism

in Kashmir often feels trapped between fright and fatigue, his career stood as proof that dignity and depth could still coexist in reporting.

At his funeral in Srinagar, the November air carried a hush as mourners offered prayers. Among them were reporters he had once mentored, editors who had once critiqued him, and friends who still couldn't believe he was gone.

A few spoke about that old lamppost in Chotta Bazar, how it had once cast its light on a young boy's open notebook, and how that light, in some way, never really went out.

analysis. "Clinically, there's a noticeable rise in flu-like illnesses, but the situation is not alarming," he said.

Compared to last year, the flu season started a little earlier that is around October but the severity of illness remains similar. "There has been a surge in outpatient cases, but no major increase in hospital admissions or severe cases, indicating that the disease is not more dangerous this year. The number of cases mainly reflects how widely the virus is spreading, not how severe it is," he said.

Who is most affected?

- · The most vulnerable groups include:
- · Children under five years, · Elderly people,
- · Those with chronic illnesses like asthma, diabetes, heart disease, or cancer · Healthcare workers, who are at high exposure risk.

"But that doesn't mean healthy people are immune," Dr. Naik pointed out. "Anyone can get infected."

What exactly is a flu shot?

A flu shot is an inactivated influenza vaccine meaning that it contains killed virus components that train your immune system to recognize and fight the flu.

"After vaccination, the immune system produces neutralizing antibodies. That's why, even if you catch the flu later, the illness is usually milder," Dr. Naik explained.

He added that for children under five, the vaccine helps prevent complications like pneumonia, dehydration, febrile convulsions, and hospitalization.

Trivalent vs. Tetravalent: What's the difference?

Here's where confusion often begins.

The Trivalent vaccine protects against three virus strains - two influenza A strains (H1N1 and H3N2) and one influenza B lineage.

The Quadrivalent (Tetravalent) vaccine covers four strains – the same two A strains plus two B lineages (B/Victoria and B/Yamagata), of-

fering broader protection. Although the World Health Organization (WHO) currently recommends trivalent vaccines based on global circulation patterns, the quadrivalent vaccine is generally preferable if cost is not a barrier. Also, according to Indian Consensus Practice Guidelines (2019), quadrivalent vaccines are recommended over triva-

lent ones (Grade 2A) for the Indian population. "In Kashmir, both are available, and quadrivalent vaccines are often priced similarly, making them a good choice," he said.

Which one should Kashmiris choose this

"If there's no major cost difference, both work," Dr. Naik explained. However, given the broader coverage, quadrivalent vaccines are preferable. "What matters most is that highrisk people get vaccinated without delay irrespective of the vaccine type."

When should you get vaccinated?

Flu activity in Kashmir usually increases between November and March, coinciding with cold weather and indoor crowding

"October is ideal for vaccination so immunity builds before peak season," Dr. Naik said. "But it's never too late. The vaccination can be done anytime between September and March."

Are flu shots safe for children?

Yes, flu vaccines are safe for babies over six months. "In India, the Indian Academy of Paediatrics (IAP) Advisory Committee on Vaccines and Immunization Practices (ACVIP) recommend two doses in the first year, one month apart, followed by a single shot every year," Dr. Naik said.

Naik elaborates flu vaccines are generally very safe. "They are administered worldwide on a large scale every year. Some individuals, however, may experience mild, short-lasting side effects such as low-grade fever or soreness at the injection site. However, people especially children with asthma or with a known egg allergy should receive the vaccine in a hospital setting under medical supervision, because most flu vaccines are prepared using egg-based production methods.

How long does protection last?

Immunity begins about two weeks after vaccination and is strongest in the first few months. Because both the virus and our immunity change over time, annual vaccination is essential. "That's why last year's vaccine doesn't fully protect you this year," Dr. Naik explains.

Can you still get the flu after being vaccinated?

Yes, it's possible. But it doesn't mean the vaccine failed. "Some people may catch flu before their immune system fully responds, or they might be infected by a strain not covered by the vaccine," Dr. Naik says. "Still, vaccines drastically reduce the risk of severe disease and hospitalization."

The bottom line

Doctors across Kashmir agree, getting any flu shot be it trivalent or tetravalent is far better than skipping it.

"Vaccination is the best defense we have," says Dr. Naik. "It may not prevent every case, but it prevents serious illness, especially among children and the elderly."

As flu cases rise with the onset of winter, experts say now is the best time to roll up your sleeve and protect yourself and your family from the season's most common infection.

Traditional Orchards Give Way to High-Density Apple Plantations

SRINAGAR: With demand for traditional apple varieties remaining comparatively low in the market, more growers in Kashmir are switching over to high-density apple cultivation, especially in low-lying areas where paddy land is now being converted into orchards at a rapid pace.

Growers from several areas of Kashmir said that until a few years ago, many areas had no history of apple orchards. But after a few farmers experimented with high-density apple varieties and recorded remarkable success both in terms of production and returns — more and more people started shifting from paddy to horticulture, they said

They added that apples are being grown in every corner of Kashmir as paddy lands are being converted into the horticulture sector. "Earlier, we never thought that this land could produce apples at all," the growers said, adding that "after seeing the results on some private plots, almost evervone has now started planting high-density varieties."

According to KNO, High-

troduced in Kashmir after 2015. These trees start yielding fruit as early as the first or second year and reach full production by the fourth or fifth year. The traditional apple trees, on the other hand, usually take nearly 10 years to bear fruit and are harvested late in the season, mostly in November – a period vulnerable to untimely snowfall.

orchardists High-density say the early harvest (August-September) and availability of protective measures against hailstorms have made the new cultivation system more economically secure.

Mohammad Amin Dar, a farmer from a low-lying area of Shopian who has planted highdensity apples on 8 kanals of land, said the trend is driven by practical benefits.

"People have noticed the advantages of high-density apples. We have now prepared another 12 kanals and will convert that too into a high-density orchard," Dar said. "These trees need less labour and inputs, yet the fruit is of superior quality — uniform colour, uniform size, and bet-



ter grade. That is why they fetch double the rates compared to traditional apples.'

Varieties like Jeromine, King Roat, Gala Scarlet, Red Velox, Scarlet Spur-II, Super Chief, Redlum Gala and Auvi Fuji, RD 11, Syncho Gala, Terex Gal, Z 1, and SS2 are among the most popular high-density cultivars currently grown in J&K.

Another grower, Farooq Ahmad, said that in the Lassipora area of Pulwama alone, thousands of high-density plants are being planted this year. "Hundreds of kanals of paddy land are being converted into these or-

chards now because the economics are simply better," he said.

Officials in the horticulture department said the shift involves modern planting systems, advanced pruning techniques, drip irrigation, fertigation and technology-based monitoring.

"This entire approach is transformative," said an official. "It is attracting attention from the apple experts across India. Farmers are embracing it because they clearly see the higher productivity potential and financial returns.'

According to official figures, over 1000 hectares of land have already been brought under

high-density apple farming in J&K so far, with plans to expand the coverage to 5,500 hectares in the next few years. The horticulture department is currently offering a 50 per cent subsidy for orchardists who establish or convert to high-density systems.

It was in September 2015 that the then Chief Minister Mufti Mohammad Sayeed inaugurated the first-ever high-density apple orchard in Bamdoora, Anantnag marking the official beginning of the transition in Kashmir's horticulture sector.

Kashmir produces on average over 20 lakh metric tonnes of apples every year — a figure that in some years touches 25 lakh MT. According to the J&K Economic Survey-2017, nearly half of Kashmir's population is directly or indirectly dependent on the apple industry. More than 3.5 lakh hectares are under apple cultivation in the region currently.

contributes Horticulture around 9.5 per cent to J&K's GDP, while about 8.5 crore man-days of employment are generated annually through this sector, making it one of the most vital pillars of Kashmir's economy.

several book chapters, Dr Arif is globally recognised for his pioneering work on scleroderma — an autoim-mune disease that hardens the skin and internal organs. He serves as Editor-in-Chief of Morphea and Related Disorders (2024), a comprehensive reference published by Bentham Science. His research on "Esopha-

geal involvement in systemic sclerosis and morphea" was reviewed by the New over 155 publications and England Journal of Medi-

cine (NEJM)-a rare honour in global medical research. Dr Arif's diagnostic innovation, the "Tasleem's Water Jet Sign", and his novel surgical techniques in vitiligo and hyperhidrosis have also earned international recog-

DPRs Invited for 7 Ropeway Projects in J&K

JAMMU: The National Highways Logistics Manage-ment Limited (NHLML) has invited detailed project reports (DPRs) for seven ropeway projects in Jammu and Kashmir under the Public-Private Partnership (PPP) mode, officials said.

According to PTI, the information was shared by officials during a meeting chaired by Chief Secretary Atal Dulloo to review the progress of ropeway projects under the Parvatmala scheme, the Inter-Modal Station (IMS) at Katra and the Multi-Modal Logistics Park (MMLP) in Jammu.

These projects are seen as crucial for improving connectivity, tourism and logistics infrastructure in the Union Territory, they said.

NHM Employees in Hajin Block Stage Protest

mployees working under the National Health Mission (NHM) in Block Hajin of north Kashmir's Bandipora district staged a protest at the Community Health Centre (CHC) Hajin on Monday, demanding the release of their pending salaries for the last four months.

The protesting employees expressed anguish over the delay, saying it had pushed them and their families into financial crisis. Several employees displayed white papers at their workplaces as a symbolic gesture to highlight their plight and draw the government's attention.

Dr Shahnaz, one of the protesting employees, said despite repeated appeals, their demands had gone unheard. "We are facing serious problems due to nonpayment of salaries. In Bandipora, other blocks have received their dues, but Hajin block is still awaiting release. I'm a single mother, and paying my child's school fees has become impossible," she said. She added that around 93 NHM employees in the block were affected and struggling to meet daily expenses. "We have informed higher authorities, including the BMO Hajin, but nothing has been done yet," she said.

Dr Muzaffar, another protesting doctor, said the employees continued to serve diligently under challenging conditions, ensuring uninterrupted health services, implementing government programmes, and responding to emergencies. "Despite our dedication, we have been left unpaid for months, which has caused immense hardship," he said, appealing to the Lieutenant Governor and the Mission Director NHM J&K to intervene for immediate salary release and ensure timely disbursement in future. [KNT]

ACB Books Officials, Beneficiary in Illegal Petrol Pump

rinagar: The Jammu and Kashmir Anti-Corruption Bureau (ACB) has registered a formal case in connection with the illegal construction of a petrol pump on Kahcharaie land in central Kashmir's Budgam district. The case, registered under FIR No. 21/2025 at Police Station ACB Srinagar, follows a detailed verification based on a complaint lodged by the inhabitants of Arigam village.

According to the ACB, the verification established that one Ali Mohammad Khan, son of Sonaullah Khan, a resident of Arigam Budgam, constructed a petrol pump on Kahcharaie land at Arigam in June 2020 by obtaining a license through manipulated and misleading information.

The inquiry revealed that during 2018, the then Patwari, Naib Tehsildar, and Tehsildar of Arigam and Khansahab had issued No Objection Certificates (NOCs) for proprietary land under Survey Nos. 531 and 533 Min. However, they deliberately omitted to mention that access to these plots was only through State/Kahcharaie land (Survey No. 535), which lay between the site and the main road.

It was also found that the concerned Patwari concealed the existence of Survey No. 532 (Shamilat land) while preparing Khaka Dasti, thereby misrepresenting the actual position on the ground. Despite a clarification sought by the Additional Deputy Commissioner Budgam in March 2018, the field officials falsely certified the site as suitable for transportation and storage of fuel.

Based on these misleading reports, the then Deputy Commissioner Budgam issued a petrol pump license (No. DCB/2020/10 dated May 22, 2020) in favour of the beneficiary on non-contiguous survey numbers. The then Sub-Divisional Magistrate Khansahab also forwarded the reports to higher authorities without conducting any independent verification or record scrutiny. [KNT]

3 MW Hydropower Project in Daksum to Illuminate 3,500 Households

SRINAGAR: Construction work on a 3-megawatt hydropower project is underway in the Dessu Daksum area of Kokernag in south Kashmir's Anantnag district. Once completed, the project is expected to generate power for around 3,000 to 3,500 households.

According to KNO, the construction company has already completed the laying of approximately 800 metres of the pipeline required for the project, and the remaining 400 metres are expected to be completed within the next two to three weeks. After construction, the proj-

ect will operate round the clock in three shifts, providing employment to 30 to 35 workers per

Ghulam Hassan Dekka, a local, said, "We have been working here for some time. This power project will benefit the local population a lot because this is a poor and far-flung area.'

Dekka said there is no harm from this project. "Many labourers are working here. Such projects are the need of the hour," he added.

Another local said they had to face a lot of difficulties during winter and power curtailment, and now they are expecting 24hour electricity. "Electricity is important in this modern era. The water bodies should be used for these projects, and after generating electricity, the same water can be used again," he said. Junaid Mohammad Makroo,

Managing Director, Kashmir Valley Energy Private Limited, said "This is a 3 megawatt power project which we have taken from the Jammu & Kashmir Energy Development Agency (JAKEDA), and with overload capacity, it will function up to 3.6 megawatt. We have already laid around 800 metres of pipeline, and the remaining 400 metres will be completed within the next 2 to 3 weeks."

He said that at present, around 150 local workers are engaged in this project. "Once construction is completed and the plant reaches the commissioning and operational phase, around 30 to 35 people will work in each shift, and the plant will operate

for future opportunities as well," he said. "Labour here is mostly local; only specialised skilled labour has been hired from outside where necessary."

Makroo added, "This project becomes a national asset. Such projects usually operate under the Public-Private Partnership (PPP) model, 'Build-Operate-Transfer' (BOT), where a private entity builds and operates the project for a fixed term, after which it is handed over to the government."

Budgam Bye-Election: NC Candidate Faces Public Anger

As per KNO, a woman all of sudden walked on the stage and addressed the gathering by raising concerns over rising hardships faced by poor families.

She said several political parties had visited their area repeatedly but can't trust anyone until they fulfill their promises. "She demanded that chairs of leaders should remain upside down until the demands of the poor are fulfilled," locals said.

During her short address, the woman loudly chanted slogans against the installation of electricity smart meters. She further highlighted the struggle of educated unemployed youth.

Her unexpected intervention drew loud applause from parts of the crowd especially women, briefly shifting attention from the scheduled speeches.

JK Records Nearly 2,900 **Dengue Cases This Year**

SRINAGAR: Jammu and Kashmir has witnessed a rise in dengue infections this year, with close to 2,900 confirmed cases reported so far, officials said on Tuesday.

Health experts have once again appealed to the public to follow precautionary measures to curb the spread of the mosquito-borne disease.

As per official figures, available with KNO, 2,867 dengue cases have been registered across the Union Territory to date. Jammu continues to remain the worst hit with 1,209 cases, followed by Kathua with 772, Udhampur 399, and Samba 160.

Other districts reporting cases include Reasi (59), Rajouri (62), Poonch (26), Doda 58), Ramban (41) and Kishtwar 12). Twenty-eight cases have been detected in the Kashmir division while 41 cases were reported from outside J&K.

Officials said 24,141 tests have been carried out this year. "Only 48 patients needed hospitalization and nine of them are still undergoing treat-ment," an official said adding that one resident of J&K lost his life at DMC Ludhiana due to dengue-related complications.

The official stressed that there is no dedicated vaccine or specific antiviral therapy available for dengue at present. "The only way to control dengue is to prevent the breeding of mosquitoes. People must keep their surroundings clean and ensure there is no stagnant water."

Health experts said dengue continues to pose a serious public health threat.

"Aedes aegypti mosquitoes

breed even in small collections of clean water — like pots, tubs, tyres, lids, buckets or bottles. Every household needs to check such spots regularly," doctors said. They advised people to use mosquito repellents, wear full-sleeved clothing and keep water storage containers covered.

Doctors further said that dengue mosquitoes tend to bite early morning and during late afternoon hours, therefore people are advised to use mosquito nets or window screens even during daytime rest.

Common symptoms include high fever, severe headache, pain behind eyes, intense body and joint aches, vomiting, nau-

"Severe dengue can show red-flag symptoms like continuous vomiting, stomach pain, gum or nose bleeding, blood in stools or vomit, sudden fatigue or restlessness. Such cases need urgent hospitalization," they warned.

Dengue cases have fluctuated in the region over the past few years - J&K recorded around 7,000 cases in 2024, 6,403 in 2023 and the highest ever 8,269 cases in 2022, which also resulted in 18 deaths. In comparison, dengue was almost non-existent in the region a decade agowith only two cases reported in 2009 and none in 2010.

Drug Peddler's Property Attached in Udhampur

Police here on Tuesday attached property worth Rs 50 lakh belonging to a drug peddler under the provisions of the Narcotic Drugs and Psychotropic Substances (NDPS) Act in Jammu and Kashmir's Udhampur district, officials said.

During the investigation into narcotics cases, it was found that the accused, Amit Singh, had acquired a residential house with land at village Preyan Sounthan and a KTM Duke motorcycle from the proceeds of the narcotics trade, they said.

Based on the material evidence and investigation, police found that the said properties were acquired through illicit earnings from drug trafficking, they said. Accordingly, the movable and immovable assets were attached under the NDPS Act for further legal proceedings, they added. The total value of the attached properties, including the house, land, and vehicle, is estimated at Rs 50 lakh.

In Udhampur, the police said they have so far attached properties worth Rs 10.50 crore in NDPSrelated cases during the current year, reaffirming its resolve to make the district drug-free.(PTI)

Police Arrest 4 Drug Peddlers

rinagar: Continuing its unwavering crackdown on drug trafficking and substance abuse, Police on Tuesday said to have arrested four drug peddlers in Pulwama and Shopian and recovered contraband substances from their possession.

In Pulwama, during naka checking at Gudoora Crossing, a police party intercepted two individuals carrying nylon bags. During the search, about 7Kgs of Poppy Straw were recovered from their possession, a police spokesman said in a statement issued to Kashmir Observer.

They have been identified as Mohd Ashraf Naik, son of Gh. Ahmad Naik, resident of Ghat Gulzarpora and Abdul Qayoom Mir son of Wali Mohd Mir resident of Gudoora Pulwama. In another operation at Singo Narbal, police apprehended one individual carrying charas-like substance (weighing 77.5 grams. He has been identified as Ishfaq Ahmad Hafiz son of Mohd Ashraf Hafiz resident of Pricho Pulwama, the statement reads.

Similarly in Shopian, a police party of Police Station Zainapora at a checkpoint established at Heff Kuri intercepted a suspicious person, identified as Tariq Ahmad Sheikh resident of Heff Zainapora. Upon the search, 3.600Kgs of charas-like substance was recovered from his possession. He has been arrested and shifted to a police station where he remains in custody, police said. (Observer News Service)

Asia Cup Fallout: Rauf Gets 2-Match Ban; Surya Fined, Bumrah Gets Demerit Point

DUBAI: India's T20 captain Suryakumar Yadav and Pakistan pacer Haris Rauf were on Tuesday fined for "bringing the game into disrepute" during the Asia Cup in September with the latter also copping a two-ODI suspension for accumulating four demerit points during the tournament.

Rauf was handed financial penalties of 30 per cent of his match fee for two incidents in two separate games against India, leading to a two-match ban in the ODI series against South Africa that began on Tuesday. The next game is on November 6 and he will sit out of that as well.

Rauf accumulated four demerit points for the two incidents which were converted into two suspension points as per ICC rules.

Suryakumar was penalised 30 per cent of his match fee for his comments supporting the Indian armed forces and showing solidarity with victims of the Pahalgam terror attack after the September 14 game between the two sides.

Indian pace spearhead Jasprit Bumrah was also handed one demerit point for making a "plane down" gesture after yorking Rauf in the final.

In the September 14 game, Rauf was found guilty of offensive gestures depicting a plane crash, mocking the Indian military action under Operation Sindoor and alluding to the Pakistani claims that six Indian fighter jets were downed by it during



the showdown.

He repeated the same gesture on September 28 while fielding near the boundary line trying to instigate a group of Indian fans.

Pakistan batter Sahibzada Farhan was also handed a demerit point but Indian pacer Arshdeep Singh was let off without a fine or

demerit point. In case of Farhan. he had indulged in mock gun fire celebrations after completing his fifty against India

In the press release, the ICC stated that on September 14, 2025, "Suryakumar Yadav (India) was found guilty of a breach of Article 2.21 of the ICC Code of

duct that brings the game into disrepute. He was fined 30 per cent of his match fee and received two demerit points."

"S. Farhan (Pakistan) was found guilty of the same offence and was issued an official warn-

ing, receiving one demerit point."
"Haris Rauf (Pakistan) was also found guilty of the same offence and fined 30 per cent of his match fee, resulting in two demerit points.'

Meanwhile in case of Arshdeep, it was about a social media clip in which he was seen mocking Pakistani fans but the ICC Match Referee didn't find it offensive. The reference was India vs Pakistan Super 4 game on September 21.


Prof. Bilal Ahmad Malik was declared Man of the Match for his sensible and composed innings that proved crucial in setting up the victory. (KNS)
