SC Orders Relocation Of Stray Dogs From Streets

New Delhi: The Supreme Court on Friday took note of the "alarming rise" in dog bite incidents in institutional areas like educational centres, hospitals, bus stands and railway stations, and directed the authorities to move such canines to designated shelters.

The apex court also ordered the authorities, including the National Highways Authority of India (NHAI), to ensure the removal of stray animals and cattle from highways and expressways.

A three-judge special bench comprising Justices Vikram Nath, Sandeep Mehta and N V Anjaria passed a slew of directions in the stray dogs case.

Study Finds Moderate Step Count Daily May Delay Cognitive Decline By 7 Years

alking up to 5,000 steps everyday may help delay cognitive decline by three years on average while 7,500 steps daily may delay it by seven years, a study in around 300 individuals has found.

Sedentary individuals were seen to have a significantly faster buildup of tau proteins in the brain -- contributes to neuron death and is considered a hallmark of Alzheimer's disease -- and more rapid declines in cognition and daily functioning.

"Lifestyle factors appear to impact the

earliest stages of Alzheimer's disease, sugeventually hampering everyday functioning. The analysis, published in the journal Nature Medicine, looked at data from 296

participants aged 50-90 years old in the 'Harvard Aging Brain Study', all cognitively unimpaired at the study's start.

scans were used to measure amyloid-beta in plaques and tau in tangles -- both refer to accumulation of proteins in brain and are symptoms of Alzheimer's -- and assessed the participants' physical activity using waistband pedometers. The participants

Women's Free Ride **Scheme Leaves E-Bus**

SRINAGAR: More than eight e-buses in Srinagar have been grounded due to lack of funds needed for repairs and purchase of spare parts.

The government has also not cleared the liabilities owed to the Jammu and Kashmir Road Transport Corporation (JKRTC) for providing free travel to women passengers.

Top officials in the transport department told KNO that the corporation has written several times to the government seeking compensation for losses incurred after the administration directed RTC not to charge women passengers. Officials said no payments have been released so far. They added that the e-bus

project will struggle to survive if adequate funding is not provided immediately.

He said earlier reports about e-buses losing lakhs of rupees every day reflected only part of the problem, and that the actual losses are even higher.

Due to insufficient funding, the corporation has been un-

able to carry out timely repairs. Several buses now have deflated tyres or remain grounded for want of spare parts.

"Out of 20 e-buses operating in Srinagar, more than eight have been grounded. The number may rise if the situation continues," the official said.

The NC-led administration launched the Zero Ticket travel initiative on April 1 this year, allowing free travel for women in Smart City e-buses and JKRTC buses across Jammu and Kashmir. The measure was projected as an important step for women's safety.

However, concerns were raised at the time that women passengers constitute a significant share of the overall ridership, and the initiative could affect the revenue of private transporters who rely heavily on female passengers.

Officials had also warned that the decision could put additional strain on the already cash-starved state exchequer.

Police Launch Drive to Inspect SIM Card Vendors

SRINAGAR: In its continued and sustained efforts to strengthen Public safety and communication security, District Police Srinagar has initiated a comprehensive inspection drive of SIM card vendors across the district.

The drive aims to prevent the misuse of SIM cards for any criminal, fraudulent, or terror-related activities and to ensure strict compliance with Know Your Customer (KYC) guidelines and telecom regulations, a police spokesman said in a statement issued to Kashmir Observer.

Police teams from all five zones - covering Police Stations Kh-

anyar, Lal Bazar, Saddar, Nishat, RM Bagh, Soura, Parimpora, Safakadal, Karan Nagar, Batamaloo, Maisuma, Kralkhud, Kothibagh. Zakoora, Ahmad Nagar, Shaheedganj, Sangam, Soura and Police Posts Noorbagh and Bagiyas, Khimber – conducted thorough inspections of SIM vendors operating within their respective jurisdictions.

More than 50 SIM vendors were checked, focusing on verification of identity proofs, record maintenance, and ensuring that SIMs are issued only to genuine subscribers with valid documentation.

Any vendor found violating regulatory norms will face legal consequences, including penalties, cancellation of license, or prosecution under relevant laws, police said.

The public has been requested to extend cooperation during these inspections and to ensure that SIM cards registered in their names are not misused. Citizens are also urged to report any suspicious activity or irregular issuance of SIMs to the nearest police station or the District Police Helpline.

Meanwhile, the spokesman said that Srinagar Police remains committed to ensuring the integrity of communication networks and maintaining public trust by preventing their exploitation for unlawful or anti-national activities.

Donald Trump Says He Could Travel to India Next Year

NEW YORK/WASHINGTON-US President Donald Trump has said he could travel to India next year and noted that talks with New Delhi are "go-



"It's great, going good. He (Prime Minister Narendra Modi) stopped... Largely he stopped buying oil from Russia," Trump said at the Oval Office in response to a question on how talks with Modi and trade discussions with India are progressing.

"He's a friend of mine, and we speak... He wants me to go there. We'll figure that out. I'll go. I had a great trip there with Prime Minister Modi, he's a great man. And I'll be going," Trump said.

When asked if he is planning to go to India next year, Trump said, "It could be,

India will host leaders from Australia, Japan, and the United States for the Quad summit in New Delhi after the 2024 summit was held in Wilmington, Delaware.

However, the dates for the summit in India are yet to be announced.

In his remarks before the press, Trump reiterated his claim that he stopped the war between India and Pakistan in May using trade.

"Of the eight wars I ended, I would say five or six were ended because of tariffs. I'll give you an example. If you take a look at India and Pakistan, they started to fight, they are two nuclear nations... They were shooting each other. Eight planes were shot down. It was seven. Now it is eight, because the one that was sort of shot down is now abandoned. Eight planes were shot down.

"And I said, 'Listen, if you guys are going to fight, I'm gonna put tariffs on you'. And they both went, you know, they were not happy about that. And within 24 hours, I settled the war. If I didn't have tariffs, I wouldn't have been able to settle that war,' Trump said. The president also termed tariffs a "great national defence".

Delhi Airport's Air Traffic **Control Faces Tech Issues**

Over 800 Flights Face Delays

New Delhi- Delhi airport, the country's busiest airport, plunged into chaos on Friday as more than 800 domestic as well as international flights were delayed due to technical problems with the air traffic control system, sources said.

All airline operations at the airport have been impacted and authorities are working to

The sources said airlines have cancelled at least around 20 flights.

IndiGo, Air India, Air India Express, SpiceJet, and Akasa Air said there are delays in their flights at the Delhi said technical teams are working to restore the system at the

The sources said the air traffic control system had faced issues intermittently in the last two days and the technical issue started to impact the system significantly from around 5.45 am.

"All airline operations at Delhi Airport are currently delayed. Concerned authorities are working on resolving the issue at the earliest," Delhi airport operator DIAL said in a post on X at 1:42 pm.

DIAL (Delhi International Airport Ltd) also said flight operations have been disrupted due to an ongoing technical



airport due to the issues with the air traffic control system.

The national capital's Indira Gandhi International Airport (IGIA), the country's busiest airport, handles more than 1,500 flight movements daily.

Airports Authority of India (AAI), in a post on X at 10:08 am, said flight operations at the Delhi airport are facing delays due to a technical issue in the Automatic Message Switching System (AMSS), which supports air traffic control data.

The state-owned AAI, which provides air traffic control and navigation services,

Information available on flight tracking website Flightradar24.com showed that over 800 flights have been delayed at the airport and the delay for departing flights is around 50 minutes at the Delhi airport. The count of flights include arrivals as well as departures.

YouTube Secretly Deletes 700 Videos Documenting Israeli War Crimes

San Bruno: YouTube has secretly deleted more than 700 videos documenting Israeli violations in Gaza and the West Bank after removing the accounts of three major Palestinian human rights organizations, a move widely condemned as an assault on free expression and accountability.

The accounts belonged to three prominent Palestinian human rights Al-Haq, groups: AlMezan Center for Human Rights and the Palestinian Centre for Human Rights. The deleted content

included a documentary featuring mothers surviving Israel's genocide in Gaza, a video investigation that uncovered Israel's role in the killing of a Palestinian American journalist Shireen Abu Akleh, and footage revealing the destruction of Palestinian homes in the occupied West

alleged Israeli crimes. The move came in response to a US government campaign to stifle accountability for Israeli war crimes against Palestinians in Gaza and the West Bank.

Bank—all critical evidence of

Musk Thanks Tesla for Record \$1 Trillion Pay Package

esla shareholders have approved a massive pay package for CEO Elon Musk that could make him the world's first trillionaire if the company meets ambitious growth targets, CNN reported.

At Tesla's annual shareholder meeting on Thursday, more than 75 per cent of shareholders voted in favour of Musk's stock-based compensation plan, excluding the 15 per cent stake he already owns. The room erupted in cheers and chants as the results were announced.

"I super appreciate it," Musk told shareholders after the vote, thanking them and Tesla's board for their support, as per CNN.

Unlike most CEOs, Musk does not take a salary. His compensation comes entirely through stock options, and this new package could grant him up to 423.7 million Tesla shares over the next decade, a poten-

tial payout worth around USD1 trillion if the company hits a market value of USD 8.5 trillion. That target would require Tesla's stock price to rise by 466 per cent from its current level, a feat that would make it more valuable than Nvidia, currently the world's largest company at USD 5 trillion.

If Musk secures all 12 tranches of the stock award, the earnings would equal USD 275 million per day, the largest executive pay deal ever recorded. Tesla's board had warned shareholders that rejecting the pay plan could prompt Musk to walk away from the company. In a regulatory filing, the board said Musk had raised concerns about continuing as CEO without greater assurances of control that the pay package could grant him.

Despite the approval, Tesla is facing a challenging year. The company's sales and profits have dropped sharply in 2025 amid slower EV demand and reduced US government incentives for electric vehicles, CNN reported.

British National Escapes Delhi Airport Before Deportation

New Delhi: In a major security breach at the Indira Gandhi International Airport, a British national who arrived from Bangkok allegedly fled the immigration area and escaped into the city, prompting a massive search operation, police said on Friday.

70-Year-Old Man **Wakes Up Before His Funeral**

'ndore: A home that plunged into mourning in Madhya Pradesh's Indore erupted in ■joy after a 70-year-old man, presumed dead by his family, started breathing again even as preparations were underway for his funeral, a relative said on Friday.

Talking to PTI, Sanjay Vaid said that his father, Makhanlal Vaid, was admitted to a private hospital in the city on November 1 after he suffered a brain haemorrhage.

"My father underwent surgery at the hospital. The operation was successful, but after some time, his condition deteriorated and he was put on life support," he said.

Saffron Growers Warn of Deepening Crisis as Harvest Falls Short

SRINAGAR: Kashmir's famous saffron industry is staring at yet growers reporting that the crop bloomed for barely a few days this year. They said the overall harvest has remained below 10 percent of the normal output.

Farmers said that, unlike earlier years when saffron flowers continued to appear for weeks together, the bloom this time lasted just a few days, leaving fields almost barren soon after.

"This is the worst season we have ever seen," said Abdul Rashid, a grower from Lethpora. "Normally, we used to pick flowers for 15 to 25 days. This year, we were done in hardly three

days."
"We have lost hope now. For 10 years, we have been begging



authorities for timely action, but nobody took us seriously," Rashid lamented.

Farmers claim that despite repeatedly raising alarms about drying corms, unavailability of irrigation and continuous weather stress, nothing concrete was done on the ground.

"Had the government ensured irrigation infrastructure on time, the sector would not have collapsed like this," said another farmer, Javaid Ahmad, from Pampore. "When the corm stays dry during spring, autumn and

in 2010 to address issues of irrigation, quality corms and scientific cultivation.

"We want to know where this money has gone and what the outcome of this Mission actually is," said a grower, Mohammad Iqbal. "There is nothing visible on the ground. This Mission has completely failed."

Even though the Mission was later extended by two more years, farmers say the promised benefits never materialised and saffron land continues to be converted for other use.

Although the agriculture department data initially showed a steady rise in saffron yield between 2010 and 2014, farmers said the sector never recovered after the 2014 floods. Multiple years of severe dry spells dealt additional blows.

According to KNO, in 2024, production was already at just around 30 percent of the normal crop, and this year, the production is just below 10 per cent, according to growers.

Official data also shows that land under saffron cultivation has shrunk from 5,707 hectares in 1996-97 to 2,387 hectares in 2019-20- a 65% reduction, and production fell from 17.33 MT in 2021 to 14.87 MT in 2022, and marginally improved to 14.94 MT in 2023, but last year's real output was only around 30% of expected production.

Farmers said irrigation availability, providing quality corms and stopping land conversion are urgently needed steps if the sector is to survive. They warned that if immediate measures are not taken, there will be no saffron left here in a few years.

Court Convicts Police Sub-Inspector for Forging Date of Birth

he Court of City Judge Srinagar has convicted a Sub-Inspector of the Jammu and Kashmir Police and sentenced him to three years of simple imprisonment along with a fine of Rs 5,000 for forging his date of birth to secure unlawful service benefits, including extension and promotions.

According to official sources, the Crime Branch Kashmir had registered a case in 2023 against Sub-Inspector Jagdesh Singh, son of Kartar Singh, resident of Atina Budgam, for tampering with his date of birth in official records. During the investigation, the officer's matriculation certificate, session 1974 bearing Roll No. 6759, was sent to the Jammu and Kashmir Board of School Education (BOSE) for verification. BOSE authorities confirmed the certificate to be fake and fabricated and authenticated his actual date of birth as November 10, 1957. However, the accused had fraudulently altered it to November 10, 1959 in his service documents, including the Character Roll and matriculation record, to unlawfully obtain a two-year service extension and related benefits. During the trial, the Crime Branch produced around sixteen witnesses in support of the prosecution. After an eleven-year-long trial, City Judge Srinagar Abdul Bari said, in a detailed 68-page judgment, found the accused guilty under Sections 420, 511, and 468 of the Ranbir Penal Code (RPC). The court held that the officer had intentionally deceived the authorities for personal gain by manipulating his official records and, accordingly, sentenced him to three years of simple imprisonment and imposed a fine of Rs 5,000 under Section 420 read with 511 RPC. Major Land Compensation Scam

Crime Branch Chargesheets 10 In Anantnag

SRINAGAR: In its continued drive against corruption and financial fraud, the Economic Offences Wing (EOW) of Crime Branch Kashmir has filed a comprehensive charge sheet in a major land compensation scam that defrauded the government exchequer in South Kashmir's Anantnag district.

According to official sources, the charge sheet was filed in case FIR No. 12/2015 under Sections 420, 467, 468, 471, and 120-B of the Ranbir Penal Code (RPC), read with Section 5(2) of the Prevention of Corruption Act. The document was formally presented before the Hon'ble Court of Special Judge, Anti-Corruption, Anantnag.

The Fraudulent Scheme

Investigations revealed that the case stemmed from the fraudulent disbursement of compensation money meant for land acquisition during the construction of the Verinag-Kokernag road via Batagund. Officials found that compensation was released to fictitious beneficiaries whose land had never been acquired by the government.

According to the EOW, several officials from the Revenue Department, including the then Tehsildar Dooru, Naib Tehsildar Dooru, Cirdawar Dooru and Pathwari Dooru, allegedly colluded with private individuals to orchestrate the fraud. The accused are said to have manipulated official revenue records and fabricated land ownership documents to create false claims for compensation.

"These fictitious entries were deliberately made to facilitate the release of government funds to undeserving and non-existent persons," an EOW spokesperson said, adding that the conspiracy resulted in significant losses to the state treasury while eroding public trust in administrative integrity.

Charges and Evidence

Following an extensive investigation that included the collection of documentary evidence, witness

statements, and forensic scrutiny of land and revenue documents, the EOW concluded that the accused officials and private individuals acted in concert to commit fraud. The evidence reportedly establishes a clear pattern of corruption, forgery, and criminal conspiracy.

The charge sheet has now been submitted to the court for judicial determination, marking a crucial step toward accountability in one of the region's notable economic offences.

EOW's Stand on Accountability

Earlier, in another major breakthrough, the CBK filed a chargesheet against eight individuals, including a local BJP leader and four revenue officials, in connection with a multi-crore land scam in Srinagar.

The chargesheet, submitted before the Court of the Special Judge Anti-Corruption, pertains to the alleged illegal encroachment and manipulation of records for over 52 kanals of land in Ahel Danihama. The investigation, conducted under FIR No. 23/2019, exposed extensive irregularities in land record management, including fraudulent mutation entries and illegal occupation of state land. Those booked included Nadeem Ahmad Mayer, alias Nadeem Qasba, of Iqbal Colony, Shalteng and several former and serving revenue officers who face multiple FIRs in fraudulent land deals

Reaffirming its zero-tolerance policy towards corruption, the Crime Branch Kashmir emphasised that it remains committed to upholding transparency and ensuring that public officials and private actors engaged in economic offences are brought to justice.

"The Economic Offences Wing will continue to pursue such cases vigorously to safeguard public funds and reinforce trust in governance." the statement read.

This development underscores the growing scrutiny of land compensation and revenue recordkeeping in Jammu and Kashmir, areas that have often been susceptible to manipulation and financial irregularities in the past.

Pulwama's 400-Year-Old Mosque to **Undergo Restoration**

SRINAGAR: In a significant development, the centuries-old Mughal-era mosque at Shadimarg in south Kashmir's Pulwama district is all set to undergo restoration work, with the government sanctioning more than 22 lakh rupees for its renovation.

Officials said that the government has cleared funds, and the renovation process will begin in the coming days.

The locals have been consistently demanding preservation of the heritage monument. The mosque, believed to be over

400 years old, dates back to the Mughal period and is considered one of the oldest surviving architectural structures in the region.

Locals said the monument holds immense cultural, historic, and architectural value, and preserving it is not only necessary

for heritage but also for identity "This mosque is a living reminder of our glorious past. Its craftsmanship, thick walls and traditional structural style clearly depict the Mughal influence," said Zakir Ahmad, a resident of Shadimarg. "We had been requesting authorities for years to safeguard this structure, and we are happy that finally something concrete is happening."

Another local, Nadeem Ahmad, said the site has the potential to become a heritage tourism spot if restored properly. "The surroundings are beautiful and the mosque itself is a masterpiece. Once restored, it can attract tourists — both domestic and foreign — who are interested in history, culture and architecture," he said.

According to KNO, residents said that over the decades, the mosque had suffered deterioration due to weather, ageing and lack of maintenance. Cracks had developed in the structure, and parts of the building had started weakening.

They welcomed the sanction of funds and approval of renovation. "This was a long-pending demand of the area. We are thankful that the government has taken note of the issue. The renovation funds approved will help in preventing further damage," said another resident.

Officials said the project will focus on retaining the original architectural essence of the mosque, ensuring that the heritage character is not disturbed.

Locals hope that completion of this renovation will not only save this historic structure but also boost heritage tourism in Pulwama, thus contributing to the socio-economic landscape of the region.

J&K HC to Hear Detained AAP MLA's Plea on Nov 20

The High Court of Jammu and Kashmir and Ladakh has listed a plea filed by detained Aam Aadmi Party (AAP) MLA Mehraj Malik for final consideration on November 20, a party spokesperson said after the hearing of the case on Friday. Malik, who is the AAP's Jammu and Kashmir

unit president, was detained under the stringent Public Safety Act (PSA) on September 8 for allegedly disturbing public order and was subsequently lodged in the Kathua jail. On September 24, Malik filed a habeas corpus petition, challenging his detention and claiming Rs 5 crore as compensation.

"Malik's habeas corpus petition was listed before Justice Rajneesh Oswal of the High Court of Jammu and Kashmir and Ladakh at Jammu on Friday. When the matter was taken up for hearing, his legal team vociferously submitted that a reply has not been filed by the government till date and due to the lackadaisical approach, an incumbent MLA is still behind bars and the people of his constituency are suffering," AAP spokesperson Appu Singh Slathia said.

Slathia, who is part of Malik's legal team that also includes senior advocate Rahul Pant, advocates S S Ahmed, M Tariq Mughal and M Zulkarnain Chowdhary, said Senior Additional Advocate General Monika Kohli and senior counsel Sunil Sethi, appearing for the government, submitted that they filed their replies on Thursday but due to a defect in the affidavit, the same is not on record.

In the open court, the respondent's counsel served the copies of the reply to the counsel of the petitioner, Slathia said. She said the court has directed the registry to place on record the replies filed by the government and asked the government counsel to make the record available on the next date of hearing.

Kashmir's Organic Alarm

n November 7, a Kashmiri startup owner spoke at an EDI program and shared a warning that lingered long after the session ended. He described how a shipment of Mushkaboodrich rice bound for the Middle East was rejected because it contained dangerously high levels of pesticides.

The news unsettled farmers, entrepreneurs, and fellow startup owners. Beyond a trade issue, it revealed a deeper crisis taking hold across the valley.

For years, chemical fertilizers and pesticides have been part of daily farming in Kashmir. They promised bigger harvests and wider markets. Now, those same chemicals are turning against the farmers.

Some western buyers have flagged concerns about Kashmir crops. They warn that high chemical levels could harm the reputation of the valley's famous fields and threaten future exports.

The risk goes beyond trade. Hospitals in South Kashmir report a rise in patients with serious illnesses. Doctors at SKIMS and SMHS hospitals in Srinagar point to exposure to agricultural chemicals as a possible factor. What once felt like a distant threat has

Rejected shipments, sick patients, and farmers' complaints all point in the same direction: the valley cannot ignore the cost of chemical-heavy farming.

Kashmir's soil and crops carry a legacy. From saffron and apples to walnuts and Mushkaboodrich rice, agriculture here has cultural and historical significance. The irony is striking. The methods used to increase yields now threaten health, soil, and the very future of these crops.

If nothing changes, Kashmir risks losing its markets and the fertile foundation that sustained its farm-

The EDI meet was a reminder that Kashmir's next revolution must be organic. Farmers need training and incentives to adopt sustainable practices. Policymakers must support shifts that protect health, soil, and exports. Entrepreneurs and startups can promote organic certification, eco-friendly technology, and new markets for chemical-free produce.

Crypto Craze

As cryptocurrencies capture the imagination of Kashmir's young investors, the lessons of risk, regulation, and restraint are being learned the hard way.

n a small internet café in Srinagar, two friends discuss "the next big coin." One of them shows an app on his phone, with graph rising in steep green lines.

"It's going to explode soon," he says with conviction.

This is a familiar scene in Kashmir these days. The youth, fluent in digital language and eager for opportunity, have found in cryptocurrency an alluring promise of fast wealth.

But, as with most speculative booms, the excitement often outpaces understanding.

The crypto fever sweeping Kashmir reflects a broader pattern of high-risk investing emerging across smaller Indian towns, where aspiration meets limited financial literacy.

The result is an ecosystem of misplaced trust, overconfidence, and, increasingly, loss.

In theory, cryptocurrency offers the thrill of autonomy: no intermediaries, no banks, and endless upside. But in practice, it remains an unpredictable, often manipulated market.

Data from CoinMarketCap shows that over 20,000 digital coins exist globally, but more than 95 percent of trading volume is concentrated in fewer than 50 established cryptocurrencies.

The attraction has shifted from these global giants like Bitcoin and Ethereum to lesser-known "low-volume" tokens circulating through social media and messaging apps in Kashmir. They promise extraordinary returns, often backed by slick marketing and fabricated

The risk is simple: in such low-volume markets, even a few large trades can distort prices. A handful of insiders can engineer temporary spikes to lure new buyers, then exit, leaving others stranded with coins that no longer move.

For investors in the valley, where every rupee of savings is hard-earned, this can mean total loss. Once these coins collapse, there is no regulator, no recovery mechanism, and often, no trace of the people behind them.

The social and economic landscape of Kashmir makes it particularly vulnerable to speculative trends. The region's unemployment rate remains among the highest in India, especially among youth. In such a setting, the idea of doubling one's savings through a mobile app becomes irresistible.

Crypto influencers exploit this desperation skillfully. Telegram channels and WhatsApp groups push "investment alerts," often mixing religious or local language appeals with financial jargon. Some promote referral-based systems that resemble pyramid structures. Early investors are paid from the deposits of newcomers until the sys-

Several Kashmiris who invested in these schemes over the past two years report losing entire savings when the promoters disappeared overnight.

remains ambiguous. The Reserve Bank of India has repeatedly warned that digital currencies are neither legal tender nor backed by any authority. Yet trading continues, facilitated by offshore exchanges and mobile applications that operate beyond domestic jurisdiction.

Tax policy, however, is clear. Any gain from crypto transactions is taxed at a flat rate of 30 percent, with no deductions for losses. For small investors in Kashmir, this makes the arithmetic especially harsh: a modest gain after high transaction costs and taxes often yields negligible real profit.

Moreover, India's new money-laundering guidelines require exchanges to maintain records of user identities and transactions, creating additional compliance uncertainty.

Such legal ambiguity heightens risk. A sudden regulatory shift, say, a ban on certain exchanges or a tax tightening, can wipe out local holdings overnight. For investors who barely understand these frameworks, the exposure is total

Globally, cryptocurrency markets have endured cycles of euphoria and collapse. The 2022 crash erased over two trillion dollars in market value worldwide, forcing regulators to confront the social cost of unchecked speculation. For investors in mature economies, the loss was painful but educational. In regions like Kashmir, where financial safety nets are weaker, such losses can push entire families into debt.

Experts advise following a disciplined "portfo-

lio approach": allocating no more than 5 to 10 percent of total savings to high-risk assets like crypto. In developed markets, this portion is considered "risk capital", money one can afford to lose.

The concept remains largely unknown in the valley. Many small investors pour their entire savings into one or two tokens, often encouraged by friends or social media groups rather than professional advisors.

Financial literacy programs remain scarce in the valley, and awareness around digital investing is even thinner. Educational initiatives, whether from local universities, NGOs, or banks, could bridge this gap by teaching basic investment principles: diversification, due diligence, and the understanding of taxation and regulation.

For those already investing, the advice is simple but powerful: diversify your portfolio, verify every platform, and avoid coins with low trading volume or vague backstories. Transparency should always outweigh hype.

an autumn morning in Srinagar, a government eBus hums past Lal Chowk. Its bright frame gleams in the sunlight. Women board, smiling at the promise of free travel. The gesture feels progressive. It signals mobility, inclusion, and care. It is meant to empower.

A Kashmiri Architect's Journey From Darkness to Design

After years of struggle, a Kashmiri woman turned her pain into purpose and became a voice for mental health awareness.

n the soft morning light of Larnoo, a small village near Kokernag, Hina Khan believed life was exactly as she had planned it.

The architect's home rang with her son's laughter, her sketchbooks filled with clean lines and balance. At work, her designs earned praise. Her husband spoke proudly of her strength.

In those days, she felt steady, certain, surrounded by the small, familiar joys that make a life feel complete.

Then, one rain-soaked morning, a phone call changed everything.

Her younger brother had died in a road accident near Anantnag. The sky that day, she says, "looked tired, like it already knew."

Grief came in waves she didn't know how to swim through. For weeks she stayed composed for her

parents, family, and everyone who looked to her for strength. Then, when the condolences stopped and the house turned still, she began to break from within.

"I stopped recognizing myself," she recalls. "I couldn't feel joy or sadness. I felt erased."

The days slipped by without shape. She avoided people. Work felt impossible. Small things, like bathing, cooking, and even combing her hair, became unbearable.

When friends told her to pray or rest, she wanted to scream but couldn't find her voice. At night she lay awake, her thoughts circling the same dark corners.

"Depression tells you that you're a burden," she says. "And the worst part is, you start to believe it."

It was her mother who saw through the

One evening she arrived from the nearby village, sat beside Hina for a long while, and said softly, "My child, this is illness. Let's go see a doctor.

That moment, Hina says, was her first step toward the light.

"It wasn't what she said," she recounts, "it was how she said it. She didn't blame me. She

loved me through it. A week later, Hina and her husband visited a psychiatrist in Srinagar. The doctor listened, nodded, and told her, "You are unwell, not weak. And you can heal."

Those words shifted something inside her. "For the first time, I felt hope," she says.

Treatment began slowly. The medicines

dulled the sharp edges of despair, and therapy gave her a way to speak her pain aloud.

"My therapist told me, 'You can't heal from what you refuse to face.' That sentence stayed with me," she says.

Healing, though, wasn't a straight line. Some days she felt like herself again. On others, she fell back into darkness.

On those mornings, her husband would bring her tea and say, "Just one sip, Hina." Her son would crawl into her bed, touch her face, and whisper, "Mama, smile."

Those small gestures became her anchors. Soon she started walking again, first around the courtyard, then through the meadows near Larnoo.

"I noticed the smell of pine, the shimmer

of sunlight on wet grass," she says. "It felt like breathing after being underwater.'

She returned to her sketchbook. The lines she drew began to open up: more windows, bridges, and air. "Every drawing became a way to talk to myself again," she says. "It was as if my art was pulling me back to life."

Months later, when her strength returned, she went back to work in Srinagar. Her designs grew lighter, her voice steadier. But she carried within her a sense of duty: to speak about what she had endured.

"People think depression only happens to others," she says. "I wanted them to know it can happen to anyone.'

She joined a small mental health awareness group in Anantnag. The first time she spoke publicly, her hands trembled. She told the audience about the sleepless nights, the emptiness, and the fear.

When she finished, a woman came up to her with tears in her eyes and said, "I thought

I was the only one." That single sentence, Hina says, made all the pain worth it.

Today, she receives messages from people seeking help. Among them are young women, students, and even elders.

She listens, shares her story, and gently urges them to seek treatment. "I tell them, if you can talk about fever or pain, you can talk about sadness too," she says.

Her husband tells her she has changed. "You used to build homes," he once said. "Now you build hope."

Hina smiles when she recalls it. "Maybe pain makes us see life differently," she says. "It breaks us, but it also deepens us."

In her new projects, she designs with light in mind: open courtyards, broad windows, and places where air moves freely. "I want people to feel warmth in their walls," she says. "Light heals."

Every morning, she walks to the edge of her village. The hills rise like slow-breathing giants, and the mist curls through the pine trees. Children pass by, laughing on their way

Fit at Forty

Many Kashmiris in their forties are embracing movement as a way to stay strong and focused. Science shows that starting to exercise now can add strength, clarity, and years to life.

urning forty once meant slowing down. That age often came with the weight of responsibility: long work hours, family duties, and less time for oneself. But today, that story is changing.

Morning walkers fill Srinagar parks. Groups of cyclists ride through the Boulevard road at dawn. Meditation mats roll out in homes. A new generation of Kashmiris is proving that midlife can be a time to move, rather

Science supports this shift. After our thirties, the body begins to lose muscle mass at a rate of about 3–8% per decade. Bone density declines, metabolism slows, and joint flexibility drops.

The result is predictable: stiffness, fatigue, and lifestyle diseases that often surface in the forties. But these changes are not irreversible. Regular physical activity can reverse much of the decline and restore vitality.

A large study in the British Journal of Sports Medicine found that adults who began exercising in their forties enjoyed nearly the same reduction in mortality risk as lifelong exercisers. Another by the U.S. National Institutes of Health showed that even late starters could add several healthy years to their lives.

The message is simple: it's never too late to begin.

That message has started to resonate in the valley. Local gyms and fitness studios now see more participants in their forties than ever before. Parks are alive with joggers, while brisk walking has become a social activity for many.

For some, the motivation comes from health scares, like a high blood pressure report, and a warning from the doctor. For oth-

ers, it's a desire to stay active for their children and careers.

Cardiologist Dr. R. Mehra calls exercise "the safest medicine you can take every day." Regular activity improves heart function, reduces stress, balances hormones, and keeps blood sugar and cholesterol under control.

The Centers for Disease Control and Prevention (CDC) reports that adults who meet the minimum weekly activity guidelines, about 150 minutes of moderate exercise, have a 33% lower risk of early death compared to inactive individuals.

Experts suggest four essentials for midlife fitness: cardio, strength, flexibility, and

Brisk walking, swimming, or cycling strengthen the heart and lungs. Strength training with resistance bands or light weights helps preserve muscle and bone density. Yoga, stretching, and balance exercises improve mobility and reduce the risk of falls. Recovery, through proper sleep, rest, and nutrition, gives the body

time to rebuild. In India, lifestyle diseases have become a national concern. The ICMR reports that one in three Indians above forty has hypertension, and one in ten has

These numbers are rising in Kashmir too. But there's hope in the growing awareness. People are realizing that health can't depend only on medicines or medical check-ups. It begins with movement, even a short walk or climb up the stairs counts.

Getting started, however, requires patience. Begin with lowimpact exercises like walking or yoga and increase intensity gradually. Warm-up and cooldown sessions help prevent injury. Those with chronic conditions should always seek medical advice before starting a program. Many aches that people associate with aging actually come from inactivity.

Exercise also uplifts the mind. It increases blood flow to the brain, boosts mood, and improves memory.

A 2023 Harvard study showed that people who exercised regularly after forty performed better on memory and focus tests and had a lower risk of dementia.

At forty, fitness isn't about turning back the clock. It's about getting ready for the years ahead with strength and ease. Every walk, stretch, or push-up becomes a small promise to yourself, for better health, more confidence, and a little more joy in everyday life.

There was a time when the word adab carried weight in our homes. It meant grace, restraint, and warmth woven together.

Deaths Due To Kidney Problems Highest Following Tropical Cyclones: Study

n analysis of deaths in the wake of tropical cyclones in nine countries has found that the highest increase of 92 per cent was seen in deaths due to kidney diseases, followed by 21 per cent in deaths due to physical injuries.

A tropical cyclone is an extreme weather event originating in oceans in the tropics, bringing violent winds, torrential rains and in some cases, destructive coastal flooding.

Deaths due to diabetes were seen to increase by 15 per cent, and those due to neuropsychiatric disorders and infectious diseases by 12 per cent and 11 per cent, respectively, according to findings published in The British Medical Journal.

Researchers led by those at Monash University looked at 14.8 million deaths linked to 217 tropical cyclones during 2000-2019 across 1,356 communities in nine countries including Australia, Brazil, the Philippines and Thailand.

"Mortality risks from various causes consistently increased after tropical cyclones, with peaks occurring within the first two weeks after the cyclone," the authors wrote.

"During the first two weeks after a tropical cyclone, the highest increases were seen in mortality from renal diseases and injuries, with (an increase of 92 per cent and 21 per cent), respectively, for each additional

tropical cyclone day," they said.

Communities with higher levels of deprivation and seeing fewer tropical cyclones historically were found to be at a sub-

stantially higher risk of death due to renal, infectious and digestive diseases.

The researchers attributed the spike in deaths to disrupted healthcare services, a limited access to medicines and an increased physical and psychological stress among residents.

Deaths due to tropical cyclones could be more strongly linked with rainfall than wind speed, possibly due to flooding and water contamination, suggesting that rainfall in early warning systems should be given a greater emphasis, they said.

However, evidence regarding how tropical cyclones impact public health is lacking, especially in regions that have historically seen fewer tropical cyclones and may have a low resilience to the extreme weather events, the team said.

The study provides "com-

pelling and quantitative evidence for the notably elevated mortality risks from various causes following tropical cyclones at a multi-country level." More evidence on how tropical cyclones can worsen public health problems needs to be urgently integrated into disaster response measures under a continued warming of the planet, the authors said.

They added that the highest risk to health does not stem from immediate trauma but from disrupted healthcare systems, contaminated environment and prolonged stress.

Insights from studies need to be translated into framing policies to protect the most vulnerable and build a resilience against direct and indirect impacts on health due to devastating extreme weather events, the team said.

Auto Retail Sales Peak at 52 Lakh **Units in Festive Season: FADA**

NEW DELHI- Automobile retail sales across the domestic market witnessed a 21 per cent year-on-year increase in the 42-day festive season led by record registrations of passenger vehicles and two-wheelers aided by GST rejig enabled drop in prices across segments, dealer' body FADA said on Friday.

Overall retail sales rose to 52,38,401 units in the festive period this year as compared with 43,25,632 units in the same period last year, registering an increase of 21 per

The 42-day festive period of 2025 stands as a defining milestone for India's auto retail, delivering the highest-ever sales and growth across categories," Federation of Automobile Dealers Associations (FADA) President C S Vigneshwar said in a statement.

Passenger vehicle registrations rose to 7,66,918 units during the period as against 6,21,539 units in the same period last year, log-

ging an increase of 23 per cent. The GST 2.0 vision of empowering affordability and boosting middle-class con-sumption found real reflection on dealership floors. Compact and sub-4-metre cars saw strong resurgence as reduced tax rates expanded the buying base. Dealers also noted that retail momentum exceeded supply in several models," Vigneshwar stated.

Two-wheeler retails rose to 22 per cent to 40,52,503 units as compared with 33,27,198 units in 2024.

The segment was powered by improved rural sentiment, better liquidity, and the affordability impact of GST rationalisation, Vigneshwar stated.

Dealers described it as the best festive season in recent memory, with strong traction in commuter bikes and scooters, alongside rising EV interest, he added.

Similarly, three-wheeler and commercial vehicle registrations rose 9 per cent and 15 per cent, respectively during the 42-day period.

"This season's success has reaffirmed that the GST 2.0 reform is not just a tax simplification, but a catalyst for consumer-led growth and national prosperity. It has lowered ownership costs, energised Bharat's economy, and rekindled aspiration in every segment of society," Vigneshwar stated.

For the month of October, automobile retail sales rose 41 per cent year-on-year to 40,23,923 units, driven by all-time high monthly sales of both passen-

ger vehicles and two-wheelers. Passenger vehicle registrations rose to 5,57,373 units last month, up 11 per cent against 5,00,578 units sold in October

HAL Seals Mega Deal With GE Aerospace For Procurement Of 113 Jet Engines

NEW DELHI- The Hindustan Aeronautics Ltd (HAL) on Friday sealed a major deal with American defence major GE Aerospace to procure 113 jet engines for its Tejas light combat aircraft programme.

The firming up of the deal came notwithstanding a downturn in India-US relations after the Trump administration slapped a 50 per cent tariff on Indian goods.

Under the deal, the delivery of the F404-GE-IN20 engines will begin from 2027 and the supplies will have to be completed by 2032, officials said. The size of the deal is learnt

The HAL is also using GE F404-"IN20 engines to power another lot of LCA MK1A jets. In February 2021, the de-

fence ministry sealed a Rs 48,000 crore deal with HAL for the procurement of 83 Tejas Mk-1A jets for the IAF.

The delivery of the jets are facing delays primarily due to GE Aerospace missing several deadlines for supply of its aero engines to power the jets.

The IAF is looking at inducting the warplanes as the number of its fighter squadrons have gone down to 31 from officially sanctioned strength

Cost Of Home-Cooked Thalis Fell By Up To 17% In October. Here's Why

NEW DELHI- The cost of homecooked vegetarian and nonvegetarian thalis fell as much as 17 per cent and 12 per cent (year-on-year) in October, respectively, primarily because of a steep decline in the prices of vegetables and pulses, a Crisil

report said on Friday. Potato prices slid 31 per cent on a high base, wherein production in Rabi season 2024-2025 rose by 3-4 per cent onyear, while tomato prices fell 40 per cent on-year on the back of higher supplies from western and southern markets, according to Crisil's monthly indicator of food plate cost.

According to Pushan Sharma, Director, Crisil Intelligence, onion prices fell owing to an increase in supply of stock from the rabi season 2024-25, ahead of the kharif crop arrivals in the market from November.

"Pulses saw price corrections as well, supported by an increase in imports of Bengal gram, yellow pea and black gram. In the medium term, onion prices could see a moderate rise, as excess rainfall in August and September in key producer states such as Karnataka and Maharashtra has delayed kharif transplantation and raised yield



concerns," Sharma mentioned. Potato prices are expected to remain firm in November because of low supplies of the early rabi crop, but may ease after cold storages release their stocks by mid-December

Tomato prices are likely to stay soft amid continued kharif arrivals, according to the report.

Prices of pulses may inch up in the near term, reflecting the impact of excess rainfall on kharif yields and the recent imposition of a 30 per cent import duty on yellow pea. Should the government extend the import duties to other pulses, prices could witness a steeper rise, said Sharma.

The cost of a non-vegetarian thali fell relatively less because broiler prices fell a moderate 6 per cent on-year. Broilers account for about half of the thali cost. Lower prices of vegetables and pulses, however, helped bring down the overall cost.

India, New Zealand End Fourth FTA Talks; Target Early Agreement

ROTORUA- India and New Zealand on Friday concluded the fourth round of negotiations for the proposed free trade agreement and have agreed to work towards its early conclusion.

Commerce and Industry Minister Piyush Goyal was here to review the progress of these negotiations with his New Zealand counterpart Todd McClay.

The fourth round of India-New Zealand FTA negotiations was focused on goods market access, services, economic and vestment opportunities, Goyal said in a social media post.

"We look forward to working towards the early conclusion of a balanced, comprehensive and mutually beneficial agreement, in line with the growing strategic and economic convergence between India and New Zealand," he said.

During this three-day visit, Goyal also held meetings with business leaders to discuss ways to boost trade and investments.

The minister, on November 6, stated that talks are progressing fast and expressed hope that the free trade agreement will be finalised soon.

The FTA negotiations were formally launched on March



16, 2025.

Meanwhile, the Indian minister held meetings with several New Zealand business leaders, including Carmen Vicelich, CEO of Valocity; Ranjay Sikka, CEO of Slumberzone; and Nathan Guy, Chairman of the Meat Industry Association. The interactions reflect

the growing interest in expanding cooperation with India across diverse sectors, such as agriculture, tourism, technology, education, sports, gaming, and drone technology.

Given India's significant advancements in the space sector, including its recent lunar missions, space collaboration was identified as a promising area for future engagement, the commerce ministry said.

India's bilateral merchandise trade with New Zealand stood at USD 1.3 billion in 2024-25, registering a growth of nearly 49 per cent over the previous year.

New Zealand's average import tariff is just 2.3 per cent. In a free trade agreement,

two countries either significantly reduce or eliminate customs duties on the maximum number of goods traded between them. They also ease norms to promote trade in goods and services.

India and New Zealand began negotiating the Comprehensive Economic Cooperation Agreement (CECA) in April 2010 to boost trade in goods, services, and investment.

After nine rounds of discussions, however, the talks stalled in 2015.

India's key goods exports to New Zealand include clothing, fabrics, and home texsupplies; refined petrol; agricultural equipment and machinery such as tractors and irrigation tools, auto, iron and steel, paper products, electronics, shrimps, diamonds, and basmati rice.

The main imports are agricultural goods, minerals, apples, kiwifruit, meat products, such as lamb, mutton, milk albumin, lactose syrup, coking coal, logs and sawn timber,

wool, and scrap metals. Meanwhile, the Commerce and Industry Minister will visit Australia tomorrow.

The visit is important as negotiations are underway between the countries for the second tranche of the India-Australia free trade agreement.

India's Forex Reserves Drop USD 5.62 Bn To USD 689.73 Bn

MUMBAI- India's forex reserves dropped USD 5.623 billion to USD 689.733 billion for the week ended October 31, the

Reserve Bank of India said on Friday. The overall reserves had declined by USD 6.925 billion to USD 695.355 billion.

For the week ended October 31, foreign currency assets, a major component of the reserves, decreased by USD 1.957 billion to USD 564.591 billion, the data released on Friday showed.

Expressed in dollar terms, the foreign currency assets include the effect of appreciation or depreciation of non-US units, like the euro, pound and yen held in the foreign exchange reserves.

The value of the gold reserves declined by USD 3.81 billion to USD 101.726 billion during the week, the RBI said. The Special Drawing Rights (SDRs) were down by USD 19

million to USD 18.644 billion, the apex bank noted. India's reserve position with the IMF increased by USD 164 million to USD 4.772 billion in the reporting week, according to the data.

The precious metal of 99.5 per cent purity slipped Rs 100 to Rs 1,24,000 per 10 grams (inclusive of all taxes) from Thursday's closing of Rs 1,24,100.

In the local bullion market, gold of 99.9 per cent purity had settled at Rs 1,24,700 per 10 grams in the previous

However, silver prices remained flat at Rs 1,53,300 per kilogram, inclusive of all taxes, on Friday.
Globally, spot gold rose USD 19.84, or 0.5 per cent, to USD

3,996.93 per ounce while spot silver was trading 0.96 per cent higher at USD 48.48 an ounce. "Gold prices gained on Friday as investors sought safehaven assets amid growing concerns over a possible AIdriven bubble in equity markets and uncertainty surround-

ing the prolonged US government shutdown," according to commodity market experts. Meanwhile, the dollar index, which gauges the greenback's strength against a basket of six currencies, fell 0.08

per cent to 99.65, lending support to gold prices.
"The US government shutdown has entered its 38th day, weighing on economic output and delaying the release of

key macroeconomic data. "Given the combination of market uncertainty, dollar weakness and the extended shutdown, there may be further scope for gold appreciation," an expert said.

Go Beyond Traditional Crops, Agri Min Tells Farmers Press Trust Of India

BEED- Union Agriculture Minister Shivraj Singh Chouhan on Friday urged cultivators to diversify beyond traditional crops and announced direct transfer of seed subsidy to farmers' accounts is under consideration of the government.

He asserted the Centre and the Maharashtra government will "leave no stone unturned" in helping farmers who suffered crop losses due to recent heavy rains in parts of the state. The minister also announced measures to reduce the price gap between rural markets and major urban centres by enabling government agencies to directly channel farm produce to big markets.

Chouhan was addressing a large 'Shetkari Samvad Melava' (farmer interaction meet) at Sirsala in Parli Vaijnath tehsil of Beed district in central Maharashtra organised by the Global Vikas Trust founded by social activist Mayank Gandhi. Farmers from across the Marathwada region and adjoining regions attended the meet.

"Under Prime Minister Narendra Modi's leadership, the government is committed to ensuring a prosperous and self-reliant farming community," Chouhan insisted.

"When farmers prosper, the nation prospers. No household will be allowed to remain in poverty," the agriculture minister maintained.

Urging cultivators to diversify beyond traditional crops, he said, "Along with soybean and cotton, farmers should shift towards fruits, flowers and organic farming. Every rupee of compensation for crop loss will be disbursed. Direct transfer of seed subsidy to farmers' accounts is also under consideration."

Kashmiri Doctor Held In UP

Sriagar: A Kashmiri doctor working at a private hospital in Uttar Pradesh's Saharanpur has been arrested and handed over to the Jammu and Kashmir Police for allegedly putting up posters supporting the banned terror outfit Jaish-e-Mohammed (JeM) in Srinagar, officials said on Friday.

According to police, the accused, identified as Adil Ahmed, a resident of Anantnag district in Jammu and Kashmir, was working at a private hospital on Ambala Road in Saharanpur. He was taken into custody by a Srinagar police team with the assistance of the local police and the Special Operations Group (SOG).

"Adil Ahmed was arrested on Thursday in connection with a case registered in Srinagar after posters promoting Jaish-e-Mohammed were found in several parts of the city," said Additional Superintendent of Police (City) Vyom Bindal.

Police sources said the case was registered in Srinagar last week after posters bearing JeM slogans and insignia were spotted on public walls.

During the investigation, CCTV footage helped identify a man allegedly seen putting up the posters, later confirmed to be Adil Ahmed.

The Jammu and Kashmir Police tracked the suspect's movements and traced him to Saharanpur, where he had been employed for some time at a private medical facility. Following coordinated inputs, a joint operation was launched to apprehend him.

After his arrest, the accused was produced before a court in Saharanpur, which

granted transit remand to the Srinagar police. He was subsequently taken back to Jammu and Kashmir for further investigation.

Officials said local intelligence units in Saharanpur have been put on alert to verify the backgrounds of other residents from Jammu and Kashmir currently working in private hospitals and nursing homes in the district.

Police said further investigation is underway to determine whether the accused acted alone or in coordination with other operatives.

SC Orders Relocation

following directions in the interest of public safety, health and management of stray dogs," the bench said.

It directed states and Union territories, through their respective local or municipal authorities, to identify such institutions within two weeks.

The bench asked the administrative heads of such institutions to ensure that the premises are secured by adequate fencing, boundary walls, gates and such other structural or measures as may be necessary to prevent the ingress of stray dogs.

It said this exercise should be completed as soon as possible, and preferably within eight weeks.

The bench said the management of such institutions shall designate a nodal officer responsible for the upkeep and cleanliness of the premises and for ensuring that stray dogs do not enter or inhabit the campus.

"The details of the said officer shall be displayed permanently at the entrance and notified to the jurisdictional municipal body or authority," it said.

The bench said local municipal authorities and panchayat shall carry out regular inspections at least once in every three months of all such premises to ensure that no stray dog habitats exist within or in the immediate vicinity of these institutions.

"It shall be the responsibility of the jurisdictional municipal body or authority to forthwith remove every stray dog found within the premises of an educational institution and other institutions... to a designated shelter after due sterilisation and vaccination in accordance with the Animal Birth Control Rules," it said.

The bench said the stray dogs shall not be released back to the same place from where they were picked up.

"We have consciously directed the non-release of such stray dogs to the same location from which they were picked up, as permitting the same would frustrate the very impact of the directions issued to liberate such institutional areas from the presence of stray dogs," it said.

The bench referred to an order passed by the Rajasthan High Court in August, issuing directions for tackling the menace of stray animals on city roads and highways.

The top court directed the authorities of all states, Union Territories and the NHAI to ensure the removal of all cattle and other stray animals from state highways, national highways and national expressways falling within their respective jurisdictions.

It said the authorities shall undertake a joint coordinated drive to identify stretches of highways and expressways where stray cattle or animals are frequently found, and take immediate steps for their removal and relocation to designated shelters.

The bench said cattle and other stray animals so picked up shall be kept in appropriate centres or cattle pounds and provided with necessary food, water and veterinary care in accordance with the provisions of the Prevention of Cruelty to Animals Act and the Animal Birth Control Rules, 2023.

It directed the authorities to constitute dedicated highway patrol teams and assign existing road safety units for continuous surveillance and immediate response to reports of stray cattle or other animals obstructing the roadways.

"All national highways, state highways and national expressways shall have prominently displayed helpline numbers at regular intervals, enabling commuters to promptly report the presence of stray animals or accidents caused thereby," the bench said.

It said these helplines shall be linked to the control rooms of the local police, NHAI, and district administration for real-time redressal and monitoring.

It fixed the matter for further hearing on January 13.

On November 3, the apex court said it will pass interim directions to tackle the issue of "grave menace" of dog bites in institutional

areas, where employees feed and encourage stray dogs.

The apex court is hearing a suo motu case, initiated on July 28 over a media report on stray dog bites leading to rabies, particularly among children, in the national capital.

It has expanded the scope of the stray dogs case beyond the confines of Delhi-National Capital Region, and directed that all states and Union territories be made parties in the matter.

It said every state and UT shall file comprehensive additional affidavits before the next date of hearing, specifically indicating the remedial measures undertaken to ensure full compliance with this court's directions and to rectify the lapses highlighted in the report.

It noted that pursuant to the court's directions of August 22 and October 27, the states and Union territories, except Dadra and Nagar Haveli and Daman & Diu, have submitted their compliance affidavits in the matter.

Aadhaar-based initiatives and assess measures to strengthen the authentication ecosystem across the Union Territory.

During the meeting, Dulloo underlined the need to focus on targeted enrolment drives to achieve universal Aadhaar coverage, particularly among children aged 0–5 years, where enrolment currently stands at 59.07 percent. He directed the Health and Social Welfare Departments to intensify efforts for complete coverage in this category.

The Chief Secretary also instructed the School Education Department to expedite

demographic updates and the Mandatory Biometric Update (MBU) process for school-going children, while asking Deputy Commissioners and the IT Department to submit weekly progress reports on Aadhaar enrolment and Direct Benefit Transfer (DBT) scheme notifications.

Emphasizing the importance of technological upgrades, Dulloo called for a shift from manual, non-verifiable certificates to QR-codeenabled online certificates to enhance transparency and trust. He also urged departments to adopt Face Authentication Technology for more inclusive biometric verification across all age groups.

UIDAI Regional Officer, Chandigarh, Commodore (IN) Dhiraj Sareen, informed that while Aadhaar saturation in J&K is among the highest in the country, around 4.7 lakh mandatory biometric updates remain pending. To address this, the Chief Secretary directed district administrations to organize special enrolment camps in schools and Anganwadi Centres.

The meeting also reviewed progress on the Birth Registration-Based Aadhaar Enrolment (BRBAE) initiative aimed at enrolling every newborn for Aadhaar at the hospital itself.

Currently, J&K operates over 1,000 Aadhaar enrolment centres, supported by two Aadhaar Seva Kendras (ASKs) in Jammu and Srinagar, with ten more in the pipeline. The administration is also transitioning from the ECMP to the Universal Client (UC) platform and upgrading ePDS devices for more reliable beneficiary authentication.

The UIDAI proposed deploying Face Authentication Technology at high-footfall religious destinations such as Shri Amarnath Ji and Shri Mata Vaishno Devi shrines to enhance security and streamline pilgrim management.

Dulloo also stressed on data cleansing and inter-departmental integration to improve transparency in welfare delivery, directing departments including ePDS, Revenue, and regional banks to proactively share Aadhaarseeded data with UIDAI.

The UIDAI Regional Officer appreciated the proactive measures undertaken by the J&K administration and assured continued support for upcoming Aadhaar-linked reforms.

substandard drugs in J&K, and as such, had sought directions to the authorities to submit a detailed report with respect to the operation of unregistered companies and manufacturing units and selling misbranded and unregistered medicines in J&K.

He had also sought directions to the authorities to immediately ban the sale and distribution of drugs manufactured and distributed by unregistered companies in Jammu and Kashmir and initiate legal proceedings against the erring companies and individuals after seizing the spurious, fake and misbranded drugs and medicines.

The petitioner had also sought directions to the authorities to devise a strategy to prevent supply and availability of spurious, fake drugs and medicines in the Union Territory. He had also sought directions for creating awareness about the labelling

The authorities filed the response to the PIL, stating that the Drugs and Cosmetics Act, 1940 and the rules framed thereunder, lay down a comprehensive mechanism with all checks and balances to regulate the sale and purchase of medicines.

The manufacturer of drugs is under statutory obligation to test each lot of the raw material used for manufacturing drug and each batch of the final product, they said.

Besides, they said, the Drug Control Department lifts samples of drugs randomly as well as on the basis of complaints from the vendors. J&K has two testing labs, one each at Jammu and Srinagar, they said.

ous drug rackets and the prompt prosecution

of perpetrators of crime under Drugs and Cosmetics Act, they said. They had also stated that the petitioner has

not gone through the "label claims" of medicinal preparations, which are governed by Rules 96 and 97 of the Drugs Rules, 1945.

Among others, every drug manufactured in India shall bear on its label the number of the licence under which the drug is manufactured, the figure representing the manufacturing licence number being preceded by the words 'Manufacturing Licence Number' or 'Mfg. Lie. No.' or 'M.L. The authorities said that there is proper complaint redressal mechanism and all the complaints received are attended to the entire satisfaction of end-users. "The Union Territory of Jammu and Kashmir has to broadly rely on manufactures "in-house testing and the regulatory mechanism available within the respective States from where manufactured drugs enter the Union Territory of Jammu and Kashmir. The Department has carried out extensive market checks and found that the drugs in circulation are manufactured by companies having established credentials."

The authorities submitted that a detailed mechanism is put in place for training of personnel, lifting of samples and their testing to determine the quality of drugs and medicines.

"I had told my colleagues that I would not contest from two seats, but this is not an appropriate time to present the reality. A day will come when everything will be shared with you," he said.

Omar also expressed confidence of winning both Budgam and Nagrota seats in Jammu, where bypolls are also taking place.

"We feel that the situation is in our favour in both the seats. Now, the final few days (of the campaign) remain, and we have to work harder to reach out to those voters whom we have not yet appealed to, and encourage them to vote for the National Conference," he said.(PTI)



SC Issues Notice To Mohammad Shami On Wife's Plea For Higher Maintenance maintenance.

NEW DELHI: The Supreme Court issued a notice to cricketer Mohammad Shami on Friday on a plea filed by his estranged wife, seeking enhancement of the interim maintenance granted to her

and their minor daughter. A bench comprising Justices Manoj Misra and Ujjal Bhuyan sought Shami's response on his wife's plea challenging two orders passed on July 1 and August 25 by the Calcutta High Court.

The high court has enhanced the interim maintenance payable by Shami to Rs 1.5 lakh per month for his

spouse and Rs 2.5 lakh per month for their daughter, while allowing the cricketer to clear the arrears in eight monthly instalments.

In her plea before the apex court, Shami's wife has contended that the amounts awarded are "grossly inadequate", considering the cricketer's financial standing and

'lavish lifestyle". She has sought a monthly maintenance of Rs 7 lakh for herself and Rs 3 lakh for their daughter.

The petition points out that Shami's annual income, as disclosed in his Income Tax Return for 2021-22, stood at nearly Rs 48 crore, while

she has been forced to live in "downtrodden conditions", struggling to meet even basic expenses.

It also highlights Shami's ownership of luxury vehicles, including a Range Rover, a Jaguar, a Mercedes and a Toyota Fortuner. The couple got married in April 2014.

In 2018, Shami's wife got an FIR lodged at the Jadavpur police station in Kolkata, alleging domestic violence, which subsequently led to a chargesheet against the cricketer.

She later moved a court under the Protection of Women from Domestic Violence Act, seeking interim

A trial court had initially granted Rs 80,000 per month for the child but denied maintenance to Shami's spouse.

On appeal, the Sessions Court awarded her Rs 50,000 and the child Rs 80,000 in 2023.

The Calcutta High Court, through its July 1 order, further increased the amounts to Rs 1.5 lakh and Rs 2.5 lakh, respectively.

The August 25 order allowed Shami to pay the arrears in instalments.

Non-disclosure of Conviction by Candidate Renders Election Void: SC

New Delhi: The non-disclosure of conviction in a nomination form will lead to the disqualification of an elected candidate, the Supreme Court has said.

A bench of Justices P S Narasimha and A S Chandurkar passed the order on an appeal filed by a former councillor, Poonam, who was unseated from the post as she did not disclose her conviction in a case in the nomination form for



the election.

Poonam was unseated from the municipal councillor's post in Nagar Parishad, Bhikangaon, Madhya Pradesh. She was convicted in a cheque bounce case and sentenced to imprisonment for one year with a direction

to pay compensation.

er's plea to save her from disqualification, the bench said, "Once it is found that there has been non-disclosure of a previous conviction by a candidate, it creates an impediment in the free exercise of electoral right by a voter."

"A voter is thus deprived of making an informed and advised choice. It would be a case of suppression/nondisclosure by such a candidate, which renders the election void," it said.

Delhi Airport: Air Traffic Control System Glitch Delays Over 800 Flights

New Delhi: Delhi airport, the country's busiest airport, plunged into chaos on Friday, as more than 800 domestic and international flights were delayed due to the air traffic control system's technical issue, which was later addressed by the AAI.

The Airports Authority of India (AAI) also said that due to some backlogs, there may be some delays in the normal functioning of automated operations, but the situation will be normal soon.

All airline operations at the Indira Gandhi International Airport (IGIA) were impacted due to a technical issue in the Automatic Message Switching System (AMSS), which supports air traffic control data.

Sources said more than



800 flights were delayed, and at least 20 flights were cancelled.

The national capital's Indira Gandhi International Airport handles more than

1.500 flight movements daily. The AAI, in a post on X at 8:56 pm, said it has addressed the "technical issue in the Automatic Message Switching System (AMSS), which caused delays in processing flight plan messages". The issue was detected in the IP-based AMSS system on November 6.

"The OEM (Original Equipment Manufacturer) was engaged, and additional staff were deployed to manually process Flight Plans for the Air Traffic Control system to ensure uninterrupted and safe air traffic operations immediately.

and AAI personnel is still on site. The AMSS systems are up and functional now. Due to some backlogs, there may be some delays in the normal functioning of automated operations, but the situation will be normal soon," the AAI said in another post on X.

ECIL (Electronics Corporation of India Ltd) officials from Hyderabad came to the national capital to help in addressing the technical issue.

An enquiry will be conducted to find out the reasons that resulted in the technical issue, sources said.

The AAI, which provides air traffic control, navigation and other services, deployed additional manpower to manually process flight plans.

Delhi HC Tells Google To Remove Rajat Sharma Deepfakes

New Delhi: The Delhi High Court on Friday directed Google LLC to take down two YouTube channels hosting and circulating deepfake and fabricated videos using the personality rights of journalist Rajat Sharma.

The high court ordered Google to take them down within 36 hours and to disclose BSI details, access and contact details and monetisation data of the channels to Sharma within one week.

"Keeping in the averments made in the application categorically asserting the videos uploaded on these channels are fake, doctored and AI generated impersonating plaintiff no. 1 (Sharma) and spreading misinformation, the court is satisfied that the plaintiff has made out a case for issuance of directions as prayed for," Justice Manmeet

The counsel called the two channels "rogue" for hosting deepfake, fabricated videos and impersonating Sharma, as well as other prominent Indian journalists.

The court granted liberty to Sharma to approach Google regarding any other false or fake videos unloaded against him on any other channel and ordered Google to take them down within 48 hours.

Earlier, another bench of the high court passed an interim order protecting Sharma's personality rights, while ordering the removal of any content bearing doctored traits of the TV journalist.


