Srinagar: The Government on Wednesday termed the blast near the Red Fort as a "terrorist incident", as investigations revealed that Dr Umar Nabi, who was driving the explosives-laden car, had planned an attack to coincide with the Babri Masjid demolition anniversary on December 6.

Officials said the blast, which occurred on Monday evening and claimed 12

lives while injuring several others, was "a heinous act perpetrated by anti-national forces.'

A meeting of the Union Cabinet, chaired by Prime Minister Narendra Modi upon his return from Bhutan, directed investigating agencies to deal with the case with "utmost urgency and professionalism."

Visits Blast Survivors, Assures Justice

Srinagar: Prime Minister Modi Narendra Wednesday visited the Lok Nayak Jai Prakash Narayan (LNJP) Hospital in the national capital to meet the survivors of the Red Fort blast, assuring that those behind the attack will be brought to justice.

"Went to LNJP Hospital and met those injured during the blast in Delhi. Praying for everyone's quick recovery. Those behind the conspiracy will be brought to justice,' the Prime Minister said in a post on X after his visit.

Officials said that Modi, who returned from his state visit to Bhutan earlier in the



day, drove straight to the hospital to inquire about the condition of those injured in the powerful explosion that ripped through a slow-moving car near the Red Fort traffic signal on Monday evening, killing 12 people and injuring several others.

Valley Shivers As Srinagar Hits –1.6°C

Srinagar: The winter chill has tightened its grip over the Kashmir Valley, with Srinagar the summer capital of Jammu and Kashmir-recording the coldest night of the season at minus 1.6 degrees Celsius, officials from the Meteorological (MeT) Department said on Tuesday.

According to the MeT data Pahalgam remained the coldest place in the Valley, with the mercury dipping to minus 3.8 degrees Celsius. Qazigund, the gateway to Kashmir, recorded a low of minus 1.5 degrees, while Kupwara in north Kashmir settled at minus 2.0 degrees Celsius.

Gulmarg recorded a minimum temperature of minus 1.0 degrees Celsius, and Kokernag registered a low of 0.8 degrees Celsius.

Unlike the night temperatures, the day temperatures stayed above normal across most parts of the Valley, except in Gulmarg, where the maximum temperature was recorded at 8.4 degrees Celsius slightly below the normal of 9.2 degrees.

HIV Cases Rise in J&K; 117 in 3 Months

Srinagar: The HIV cases in Jammu and Kashmir are showing a steady increase, with 117 positive patients registered for care from April to June 2025.

As per the details, from April to June 2025, 117 HIV-positive individuals, including 80 males, 34 females, and three minors, were registered for HIV care. This information was dis-

closed through a Right to Information (RTI) file obtained by RTI activist MM Shuja.

According to the data, 361 new cases were registered in 2019-20, with 17 deaths in the

same year. In 2020-21, 206 cases

were registered and 12 people died; in 2021-22, 272 cases were registered with 19 deaths; in 2022-23, 374 cases with 21 deaths; in 2023-24, 338 cases with 14 deaths; and in 2024-25, 403 cases with 16 deaths.

Meanwhile, health experts in Jammu and Kashmir have urged people to adopt preventive measures and spread awareness to protect themselves and others from Human Immunodeficiency Virus (HIV) which continues to be a serious public health concern.

Mian Qayoom's Property Attached Under UAPA

Srinagar: Jammu and Kashmir's Director General of Police (DGP) Nalin Prabhat on Wednesday ordered the attachment of immovable property belonging to former High Court Bar Association (HCBA) president, Advocate Mian Abdul Oavoom in connection with a 2009 case related to an anti-India seminar.

According to officials, the double-storey house located at Bulbul Bagh, Barzulla in Srinagar, measuring 2 kanals and 1 marla, has been attached under provisions of the Unlawful Activities (Prevention) Act (UAPA).

The J&K Police, in a post on X, said: "DGP Nalin Prabhat orders the attachment of the property of Pakistani agent and terrorist, Mian Qayoom."

The order, issued by the Police Headquarters, is linked to FIR No. 157/2009 registered at Police Station Shaheed Gunj under

Sections 120, 121, 153-A RPC and Sections 13, 38, 39 of UAPA.

As per the case details, the police had received information that a seminar organised at Hotel Jehangir, Srinagar, on December 31, 2009, marking the death anniversary of Mohammad Ali Jinnah, featured anti-India speeches and secessionist slogans.

The seminar was attended by several separatist figures, including Aasia Andrabi, Shabir Ahmad Najar, and Mian Qayoom.

During subsequent searches, police recovered banned literature, Hizbul Mujahideen documents, a letterhead with seal, and a letter from Syed Salahuddin to former US President Bill Clinton from Qayoom's residence.

Authorities said the property qualifies as "proceeds of terrorism" under Section 2(g) of the UAPA, and its attachment was approved under Section 25 of the Act. | More on P6

SC Orders HCs To Display Verdict On Websites

New Delhi: To enhance transparency and accountability, the Supreme Court on Wednesday directed all the high courts in the country to create a dashboard on their websites giving details of judgements reserved after January 31, verdicts pronounced, and the date of uploading on their platforms.

A bench of Justices Kant Surya and Joymalya Bagchi, which has taken a critical view of several high courts, including the Jharkhand High Court, not delivering verdicts in both criminal and civil cases for years together after hearing the final arguments and reserving their decisions, said this data should be in public domain.

"Let everyone know how many judgements were reserved, in how many cases orders were passed and on which date the decision was uploaded on the high court website,"

Justice Kant said.

Concurring with Justice Kant, Justice Bagchi said, "Creating a dashboard or a separate window on the high court's website will show the accountability of the judiciary towards the people".

The top court was hearing a batch of pleas of which one, filed initially by several death row and life convicts

through Fauzia Shakil, complained the top court that

Jharkhand High Court did not deliver judgements for couple of years on their ap-

peals against conviction and sentence, after hearing the final arguments and reserving the decisions.

However, immediately after the apex court's nudge, the Jharkhand High Court delivered the verdicts in their matter and most of them were acquitted of their charges.

Study of 4 Million Reports Reveals Half of Indians May Have High Blood Sugar

An analysis of four million lab test reports by an online healthcare company in India suggests that every other person could be having high levels of blood sugar.

About half of the men and women who tested were found to have had a high blood sugar or 'hyperglycaemia'. Further, over 90 per cent of those having a high blood sugar also showed an abnormality in parameters of liver, lipid, heart or thyroid, the 'Diabetes: The Silent Killer Sweeping Across India' report by PharmEasy said.

Findings of the analysis published ahead of World Diabetes Day on November 14 also show a 22 per cent improvement in blood sugar levels among those who retested within six months, highlighting how regular

monitoring can be crucial to managing diabetes effectively, the authors said. Diabetes tests conducted by PharmEasy during the period January 2022 to September 2025 were analysed.

The authors wrote, "One in two people tested show high blood sugar levels; 51.9 per cent of men and 45.43 per cent of women who tested had high blood sugar." Looking at how high blood sugar varied across age groups, a sharp increase in reports of high blood glucose was seen among those aged 30 and above.

Nearly 60 per cent of the total lab tests - 64 per cent of men, 54 per cent of women - also revealed insulin resistance, where the body's cells do not respond to insulin and which is an early sign of one's metabolic risk.

One can watch out for insulin resistance through indicators such as dark

velvety patches on the back of the neck, armpits or elbows, skin tags on eyelids or elsewhere on the body, or an increase in waist circumference, the authors said.

They also found that one in four people with high blood sugar also have a thyroid problem, most commonly an underactive thyroid or 'hypothyroidism'. More than one in three people with hyperglycaemia showed signs of liver problems – this can happen due to a build-up of fat in the organ, with high blood sugar and insulin resistance as contributing factors, the authors said. Around 90 per cent of the lab reports revealed abnormal cholesterol and fat levels - often a mix of high 'bad' cholesterol (LDL) and triglycerides, and low 'good' cholesterol (HDL) - which can significantly raise the risk of heart disease and high blood pressure.

Residents Allege LCMA 'Stalling' Construction Permissions

Srinagar: Scores of residents have accused the Lake Conservation and Management Authority (LCMA) of delaying construction permissions without valid reasons, saying that files are piling up even after they have completed all formalities.

They said months have passed since they submitted the required documents.

Residents said every time they approach the office, they are told that "the file is under process."

One of the residents from the Nishat area said the delay has left many people "frustrated and helpless."

The locals further said that the delay stems from internal issues, particularly linked to "one executive officer", who is allegedly not clearing permissions on time.

"It is not a system-wide problem," a local said on condition of anonymity. "It is mainly one officer whose non-clearance of files is holding up approvals for everyone else.'

Meanwhile, sources in the LCMA department said that a review meeting is ex-

pected next week to decide on the pending permissions. "If this continues, the higher authorities are likely to intervene," he said.

Meanwhile, the residents urged the Lieutenant Governor administration and Chief Minister Omar Abdullah to take note, saying that such bureaucratic delays have stalled genuine residential projects and "opened doors for corruption and selective clearances.

According to a review of official records by KNO, the LCMA's Building Operations Controlling Authority (BOCA) has met only twice in 2025 so far as on April 12 (137th) and August 2 (138th), while compared to more frequent meetings in previous years. The minutes of the 138th meeting show that only a limited number of residential and commercial permission cases were discussed, with several files deferred due to "incomplete documentation" or "technical clarifications."

Despite the backlog, the minutes reflect no major push to clear pending applications from early 2024 and late 2023.

Admin Issues Fire Safety Advisory for Winter Season

SRINAGAR: In view of the increasing number of fire incidents in Srinagar particularly with winters about to set-in, the District Administration Srinagar has issued Fire Safety Advisory (Dos & Don'ts) for the general public to prevent fire hazards in residential areas as well as commercial places.

The District administration has highlighted that dry weather conditions and widespread use of heating appliances significantly raise the risk of fire accidents during winters. Through the advisory, District Administration Srinagar has urged citizens to follow safety precautions to prevent fire hazards in residential as well as commercial areas.

According to the ad-

visory, people have been asked to ensure that all electrical heating gadgets, bukharis, and LPG stoves are switched off before going to bed or leaving their homes. The use of kangris should be handled with utmost care and kept in safe places during nights to avoid its toppling.

The advisory further stresses maintaining good ventilation while using LPG heaters, keeping escape routes and water access points clear, and avoiding careless disposal of live cigarette butts.

Locals have also been advised to avoid storing combustible materials such as dry grass or rejection wood near residential areas, refrain from using faulty or substandard electrical appliances, and to ensure proper wiring and installation of circuit breakers.

'50 Percent Indians Are Corrupt'

EW DELHI: Almost 60 per cent of Indians using government services end up paying bribes, according to a recent survey commissioned by India's Central Vigilance Commission (CVC). But only 20 per cent actually filed complaints against such corrupt practices.

The study was carried out by the Centre for Media Studies (CMS), which interviewed 2,576 visitors to government offices in five cities across the country from October 31 to November 4.

More than 60 percent of respondents said the problem of corruption was not being tackled seriously and that the judiciary was largely ineffective. Most of the respondents agreed the offices for securing driving licenses and civil supplies were the most corrupt in all five cities - New Delhi, Lucknow, Madras, Hyderabad and Pune.

One-third of respondents admitted to using "influence or favour" to get the service they needed. The survey noted that members of the business community and the self-employed topped the list of bribe givers. According to the survey, the government departments in Lucknow and Hyderabad were the most corrupt. About 42 per cent of people said the departments operated "Middle men" who acted as a paid conduit between the public and officials. The public departments covered by the survey included electricity and telephone boards, civil supplies, driving license and local and urban development offices.

Kashmir's **Living Past**

ashmir history lives in its stones and waters. The Mughal gardens of Srinagar, the old structures scattered across towns, and the shrines along its rivers all tell stories that stretch back centuries. Tourists come with cameras and curiosity, often unaware that every step leaves a mark. Protecting these treasures has become a daily struggle.

Local caretakers know this struggle well. The Shankaracharya Temple, calm and timeless, overlooks Srinagar, but its steps and walls show the wear of time, weather, and visitors. Small towns with historic mosques face the same challenge. Tourism brings income, but it also chips away at the very heritage that draws people in.

Srinagar roughly sees over 1.5 million tourists each year. Visitors bring money, but they also bring pressure: crowded streets, litter, and delicate carvings at risk. Many of these buildings are centuries old, and keeping them intact requires skills that fewer artisans now practice. Repairs are slow, expensive, and often beyond the means of local communities.

There are ways to protect Kashmir's past. Community projects maintain key sites, digital archives preserve carvings and frescoes, and training programs revive traditional skills among local artisans. But these efforts need attention, support, and a careful balance between earning a living and honouring culture.

Kashmir heritage isn't just for visitors. It carries the dreams of poets, the visions of rulers, and the memories of generations.

Protecting it requires cooperation between authorities, communities, and travellers.

As cold storage capacity reaches its peak in the valley, growers and investors face a new question: what comes next for the Kashmir's apple economy?

n the autumn air of south Kashmir, the scent of apples fills the roads leading to Las-🗕 sipora.

Over the last decade, the area has transformed into the heart of Kashmir's apple revolution. Rows of steel chambers and cooling units now stand where open fields once stretched.

Controlled Atmosphere (CA) storage has changed how apples are preserved, stored, and sold, giving growers the power to decide when to market their produce.

According to the State Industrial Development Corporation, Lassipora alone has 83 CA stores with a combined capacity of around 3,45,000 metric tonnes. Shopian adds about 50,000

MT through 10 units. Anantnag, Srinagar, Budgam, and Baramulla contribute another 75,000 MT. More than 20 new projects are

being built, which will raise the valley's total CA capacity close to 6 lakh MT.

These numbers tell a story of steady progress.

Kashmiri growers for years were forced to sell their harvest at throwaway prices as trucks lined up on highways during peak season. CA storage changed It allowed apples to be stored

for months and sold later when helped growers move closer to international post-harvest standards and opened a new chapter in the valley's horticultural economy. This success, however, raises

a serious question. Has the CA storage sector already reached

Kashmir produces around 21 lakh metric tonnes of apples each year. Only a third of this produce qualifies as A-grade, suitable for long-term storage. That amounts to roughly seven lakh MT.

Out of this, about two lakh MT are sold directly in the open market during harvest season, leaving five lakh MT that actually require CA storage.

With existing capacity already close to that figure, the balance between supply and demand seems to have been reached.

When the first units opened in Lassipora, growers rushed to book space. Now, several chambers remain partly empty even at the height of the season.

Investors who once saw guaranteed profits are struggling with high costs and slower returns. Building more facilities without matching demand risks creating a surplus that could hurt the entire sector.

At the same time, Kashmir orchards are changing fast. Growers are shifting from traditional trees to high-density (HD) plantations that yield more fruit, mature earlier, and have better colour and uniform size

The new varieties have reshaped the valley's landscape and boosted income in the short term. But, they come with a practical limitation.

HD apples are not suited for long storage. Experts say these apples lose firmness and taste after a month in CA units. This shift could further reduce the

The next stage of Kashmir's apple economy must focus on improving quality rather than expanding capacity. What matters now is how to increase the share of premium-grade apples through scientific orchard management.

The region also needs modern packhouses, refrigerated trucks, and efficient cold-chain logistics to move fruit safely across long distances.

There is enormous potential in value addition. Apple juice, concentrates, cider, and dried slices can absorb any surplus and create more stable income sources.

These industries can employ thousands and reduce reliance on raw apple sales, which remain vulnerable to weather and price fluctuations.

Exports also remain an untapped frontier. Most of Kashmiri apples are sold in Delhi and northern Indian cities. Reaching international markets could change the game, bringing higher prices and long-term growth.

To achieve that, Kashmir must invest in better packaging, certification, and compliance with global food standards.

The CA storage boom was a turning point for Kashmir's apple industry. It helped growers escape the trap of seasonal distress sales and offered investors a chance to build modern infrastructure. But the rapid expansion has now created new challenges

When growth outpaces planning, the risk of overcapacity becomes real. Empty chambers and idle investments can quickly turn success into strain.

The way forward lies in collaboration. Growers, entrepreneurs, policymakers, and researchers need to review the entire post-harvest system to-Investments should where they add real value: in quality, innovation, and market diversification.

The time has come to move beyond expansion and think about transformation.

Kashmir Is Raising a Generation of Overthinkers

always say that human resources are the greatest resources. Investing in people is the best investment a society can make. In Kashmir, that means caring for our youth, their minds, emotions, and sense of hope.

We live in a country that wiped out polio, but many still hesitate to visit a therapist or speak about depression at home. We have reached the Moon, but mental health remains stuck on the ground.

Awareness has grown, but often feels hollow. Everyone says "mental health matters," but few act on it. Youth has always driven change, and that energy is what we need today, to heal, listen, and rebuild emotionally.

When I joined Amar Singh

College, one subject, Early Childhood Care and Education, changed my view. It showed me that everything starts in childhood. Our mental health as adults often begins with what we experience as children.

This is especially true in Kashmir. Our generation grew up with fear and uncertainty. Our parents lived through crackdowns and curfews, and their worries shaped the way we think and feel. They were focused on surviving, not healing. Many of us carried that anxiety before we even knew its name. Real healing begins when we start to understand it.

Anxiety comes in many forms: social, performance, attachment, or obsessive. It can't be cured by silence. Medication can help, but the real work is

emotional. Anxiety is a signal, not an enemy. It tells us something is off. How we respond to it decides whether it becomes strength or suffering.

Social media has made things worse. Our attention is scattered, emotions hijacked by constant comparison. Algorithms reward outrage over reflection. We scroll more and feel less. What we need are real conversations, fewer screens, and more empathy. Feeling deeply is not weakness. It's strength.

Healing can start in small ways. Schools can begin the day with short emotional check-ins. Talking about feelings builds strength. Parents also need to learn what anxiety is and how it affects the body. Many of our common health problems, including hair loss, IBS, and insomnia are signs of stress.

Therapy should be accessible to everyone, especially students. Kashmir has fewer than one psychiatrist per 100,000 people. Like the Golden Health Card, the government could introduce Therapy Cards for those who can't afford help.

Real progress begins when we see mental health as essential. Without healthy minds, no system can hold.

Every idea and institution relies on the people who keep it going. When they break down, everything else does too.

The Woman Leading Kashmir's Green Awakening

A Kashmiri ecologist brings science and community together to protect the valley's vanishing biodiversity.

n a foggy morning in Srinagar, a small group of women huddle near the edge of a wetland, notebooks in hand, listening to birdsong and watching ripples on the

They're part of a nature education program started by Dr. Mehreen Khalil, a Kashmiri conservationist who believes that saving the environment begins with empowering people, especially women.

After earning her PhD in Ecological Sciences from the Indian Institute of Science, Bangalore, Dr. Mehreen returned home to work where conservation is often seen as someone else's

She founded the Wildlife Research and Conservation Foundation (WRCF) in 2018 to change that.

Through the foundation, she brings together local communities, students, and policymakers to bridge the gap between science and everyday life.

Her journey began deep in the Himalayas, where she spent years studying langurs.

But what started as curiosity about a rare primate soon became a lifelong mission to reconnect people with the natural world. "I realized that conservation doesn't start in labs or offices,' she says. "It starts in the hearts and hands of people who live closest to nature.'

Today, WRCF runs training programs that teach women ecological literacy and leadership, turning kitchen waste into compost, classrooms into nature labs, and curiosity into community change.

Dr. Mehreen also collaborates with scientists across India, consults for various conservation projects, and advocates for women in STEM fields.

In this interview, she talks about Kashmir's vanishing wetlands, melting glaciers, and how empowering women could transform the region's environmental future.

You started your journey as a primatologist, studying Himalayan langurs. Let's begin there. What was so special about them?

Oh, the Himalayan langurs are incredible. They live in some of the harshest, steepest terrains of the Himalayas and still manage to thrive.

I was fascinated by how little we knew about them. Locals often called them Wan-mohniv, meaning yeti, or

sometimes apes and gorillas. That showed me the huge gap in awareness about wildlife right at our

So you were looking at animals, but it sounds like you ended up discovering people.

Exactly. Studying langurs up close opened my eyes to the fragile balance between wildlife, people, and the environment.

You realize very quickly that saving a species is essentially about the forests, rivers, and communities tied

That realization slowly shifted my work from studying primates to working with people who share their space.

Was there a single moment when you thought, "Ah, conservation is really about people"?

Actually, there were a few. The first was when I hired a local

Gujjar man as my field assistant. He knew the forest inside out. He could read the terrain, predict animal movement, and even tell which areas were

I learned more from him than from

And that changed your approach? Completely.

Then there was a moment I'll never forget: a tribal woman caring for two baby langurs separated from their troop. She looked after them like her own children.

Watching her, I realized that empathy for wildlife already existed in these communities.

Conservation was something to build with them.

You work across science and activism. That's not an easy mix. How do you balance both?

For me, they go hand in hand. Science gives you facts, activism gives

those facts meaning.

My research on langurs revealed how fast their habitats were shrinking. But instead of just publishing data, I sat with local villagers to talk about how they used the forest and how we could protect it.

The insights they shared made my research better, and the science gave their concerns more weight.

So, it's less about balancing and more about connecting?

Exactly. Science tells you what is happening. Activism tells you what to

Let's talk about the big picture. How



do you see Kashmir's environment changing, with all the cloudbursts, drying wetlands, and melting glaciers? What worries you the

most? The speed of it.

Jammu and Kashmir has lost nearly 57% of its wetlands in just ten years, from about 391,500 hectares in 2011 to 164,110 hectares in 2021.

And glaciers are melting too. Between 1980 and 2018, glacier area dropped by about 29%, and the Kolahoi Glacier alone has lost 20-25% of its mass.

That's huge.

It is. And it's not just about numbers. When wetlands disappear, the region's water security, farming, and livelihoods collapse. Every ecosystem here is tied to the other.

That's what makes Kashmir's ecology so vulnerable, and so globally im-

You've said Kashmir's conservation story is a global one. How so?

Because everything here is connected. The birds that spend winters in Kashmir travel across continents. Our glaciers feed rivers that support millions of people. Our forests help shape the region's climate.

When we protect nature in Kashmir, the impact reaches far beyond these

So Kashmir becomes a testing

ground for global solutions? Exactly. What works here can inspire other mountain and wetland

Your foundation is launching a training program on nature education for women. Why women?

regions facing similar crises.

Because women are already caretakers of nature here. They collect water, farm, manage

households, and make choices that directly affect natural resources.

But they rarely get a seat at the table when decisions are made about conservation.

And this program changes that?

That's the idea. By training young women in ecological literacy and leadership, we're helping them turn everyday experience into environmental expertise.

When women learn, they don't keep it to themselves. They share it with families, children, and communities. The ripple effect is incredible.

Let's say a woman joins your program. How does it actually change her daily life?

It can be as simple as turning waste into opportunity.

Traditionally, cow dung or organic waste is thrown away to keep homes clean. Through training, women learn to make compost or organic manure, which improves soil and earns in-

When they understand wetlands or sustainable farming, they can lead community meetings or school

That's how small actions become leadership.

Sounds powerful. But what are the biggest hurdles women face in joining such work?

Mobility, mainly. Families are often uncomfortable with young women traveling to forests or remote sites, places seen as male spaces.

There's also a lack of role models. Would you believe there isn't a single female wildlife or forest guard working in the field in Kashmir?

Not one. That's why we're building safe learning spaces and connecting women with mentors.

Once they have support and confidence, they can step into leadership naturally.

A lot of organizations stop at awareness campaigns: posters, events, hashtags. What's different about your model?

We move beyond awareness to action. Our focus is on field-based learning. Participants lead nature walks, conduct surveys, and design their own outreach projects.

By the end, they don't just "know" about conservation, they can do it.

What do they actually learn?

They explore Kashmir's ecosystems, including wetlands, forests, and mountains, while learning about the species that depend on them.

They practice nature journaling, environmental storytelling, and community engagement.

They also gain leadership and communication skills.

And we connect them with women conservationists who mentor them long after the program ends.

Do you see this work influencing schools or even policy someday?

Absolutely. When trained young women go back to their schools and colleges, they introduce new ideas and lesson plans.

Over time, that shapes how environmental topics are taught.

And when local officials see women leading conservation efforts, it challenges stereotypes and encourages more inclusive policies, like including women in wetland management or environmental committees.

Your foundation connects to global sustainability goals too, doesn't it?

Yes. Everything we do ties into the UN Sustainable Development Goals, especially SDG 4 on Quality Education, SDG 5 on Gender Equality, SDG 13 on Climate Action, and SDG 15 on Life on Land.

We also connect our participants to international youth movements. Some have contributed wetland data to global databases, others have spoken at youth climate events.

It shows them that what they're doing in Kashmir is part of a much larger

Do you imagine a day when Kashmiri women become global voices for the planet, like Greta Thunberg or Vandana Shiva?

I do. Kashmiri women already carry powerful stories of resilience. They've lived through shrinking resources and climate uncertainty. They don't need

inspiration, they just need platforms. I'd love to see a young woman from Kashmir stand on a global stage and say, "Here's what sustainability looks like where I come from."

You began with langurs and now run a conservation foundation. What keeps you going?

The people. Every time I see a young woman confidently lead a nature walk or teach her community about wetlands, it reminds me why this matters. At the end, conservation is about

unlocking human potential. Let's end with a dream. Picture

I see flourishing wetlands, living rivers, and forests alive with birds. I see schools where nature educa-

An ode to the Srinagar we grew up in, where life was slower, hearts were warmer and every day felt enough.

ometimes I slip back in time without even trying. A familiar sound of iar sound, a faint smell, or the sight of an old school bus is enough to bring back the Srinagar I once knew, the city that moved at its own calm pace and taught us how to find happiness in simple things.

My schooling began at Caset Experimental School, Rainawari, founded by C. L. Vishen Sahib, and later at Greenland High School in Hawal. That school was a world full of warmth, friendships, and teachers who shaped us with patience. The Srinagar of the eighties and nineties was slower and softer.

neighbours greeted each other warmly, and evenings were for tea, laughter, and family talk. Classrooms had wooden benches and cracked blackboards, water came from a shared tap, and schoolbags were light. We didn't need gadgets or air-conditioned rooms. What

Mornings smelled of kangri smoke,

mattered was learning respect, honesty, and kindness. Our teachers made every subject feel alive: Siraj Sir, Farooq Sir, Narinder Sir, and Rita Ma'am among them. Discipline came through care. Parents trusted teachers completely,

and that trust built character. Our school was a reflection of Srinagar itself: Muslims, Pandits, and Sikhs studying and celebrating together. Eid, Nauroz, Shivratri, and Baisakhi belonged to everyone.

What united us was our shared culture, language, and the calm way we treated one another.

Every morning, our principal, the late Mohammad Ashraf Jan Sahib, arrived in his white Fiat. His dignity commanded respect. Even the noisiest student straightened up when he

Around him worked people who formed the school's heart, including



Maqbool Seab, Halima Ji, Kanta Ji, and others. They were always kind and smiling.

Our 52-seater school bus, driven by the cheerful Maqbool Seab, waited under a wide Chinar tree in Botshah Colony. I remember how proud I felt each morning as it took me to school. Later, a small canteen opened. A cup of tea and a hot samosa cost two

placed a crisp two-rupee note in my hand, my daily allowance. It felt like more than money. It was trust, love, and a lesson in being content. That note could buy tea and samosa, an ice cream for fifty paisa, or a masala roti for one rupee. Each

rupees. Every morning, my father

choice carried small joy.
Lunch breaks were for sharing food and laughter. When the final bell rang, we left in neat lines, waving to our teachers. That sense of order and unity feels precious now.

Then came the uneasy years. I was in Class 7 when unrest began. The bus stopped running. We walked long distances or crammed into crowded TATA buses. Strikes and curfews became normal, but our school kept going whenever it could. Teachers came even on tense days, teaching us courage through their

Evenings still had their familiar charm: the smell of tchuchwer, chil-

dren playing cricket in narrow lanes, radios humming old songs, and families talking across rooftops. That was Srinagar's living pulse: simple, steady, and spirited.

Today, when I see classrooms where students argue with teachers or parents question every rule, I feel an unspoken ache. We have modern schools, but we've lost something softer: the respect and gratitude that once shaped us.

The Srinagar I remember isn't gone completely. It lives in our memories, in our stories, in how we treat each other. We can bring it back by remembering what mattered most: simplicity, kindness, and faith in one another.

I no longer wear my green sweater or carry a tiffin box. But inside, I'm

still that boy with two rupees in his pocket and a hot samosa in hand, thankful for everything he had. Whenever I close my eyes and return to those mornings under the Chinar tree, I find peace, the kind the world seems to have misplaced.

When Welfare Turns Fair

By removing the education requirement from the Marriage Assistance Scheme, Jammu and Kashmir has taken a vital step toward equality, inclusion, and trust in governance.

The recent decision by the Government of Jammu and Kashmir to remove the eighth-grade education requirement from the Marriage Assistance Scheme has opened a door long closed for many

This rule kept out the very women who needed help most for years.

Those who grew up in poverty, took care of families too soon, or lived in villages where schools were too far or too few were automatically disqualified.

By linking support to education, the state had unintentionally turned a welfare measure into a test of privilege.

The new policy sends a clear message: empowerment is not defined by a classroom. It's defined by fairness. Thousands of Kashmiri

women who could not meet the earlier criteria will now qualify for assistance that can ease a major financial burden. This change speaks directly to the idea that welfare must meet people

where they are, not where

we think they should be. The move also highlights the values behind global development goals, especially those focused on gender equality and reducing inequality.

Sustainable Development Goal 5 calls for empowering all women and girls, while Goal 10 aims to narrow the gaps between different social groups. The reform translates

those global ideals into local

action. It shifts policy from



selective charity to a more human-centered approach that values dignity over documentation.

In many rural and under-privileged parts of Kashmir, access to education remains limited. Families still depend on girls for household work, caregiving, or agricultural labour.

Dropping out of school is rarely a choice. It's a necessity shaped by circumstance.

Linking welfare benefits to education, therefore, punished women for conditions beyond their control. Removing that condition

is both practical and moral. It recognizes that women's contribution to society goes far beyond formal schooling. Many without certificates manage homes, raise children, and sustain communities with strength. Their work keeps families together and society func-

Supporting them equally restores balance and fair-

ness to social policy. This change also eliminates a strange divide that existed within poor families. Imagine two women with

the same income and needs,

Such distinctions breed resentment and weaken trust in governance.

The reform ends that imbalance and replaces it with equity. Welfare, after all, should be about need, not qualification.

Still, a reform is only as good as its implementation. For it to truly work, the government must ensure simple, transparent procedures and strong awareness

campaigns. Many women in remote areas remain unaware of their rights or unsure about how to apply for benefits. If they can't handle the paperwork or reach officials, the change

will exist only on paper. Linking this scheme with livelihood or skill programs could multiply its impact, helping women move from dependency to economic independence.

they didn't "fit" the criteria because of missing documents. These moments taught me that empowerment begins when systems listen. Policies must grow from the ground up, shaped by real

experiences. That is why this reform

feels so important. It reflects the government's willingness to learn from the field and correct what wasn't fair. It restores faith among women who had begun to feel invisible in the system.

Jammu Police Calls For Public Alert On Suspicious Movements, Installs CCTV Cameras

Jammu: Police on Wednesday reached out to various localities and sensitive areas in Jammu city, urging people—particularly traders—to remain alert about any suspicious movement and to install CCTV cameras as part of the security setup in the capital city.

The move comes in the wake of a high-intensity explosion that ripped through a slow-moving car at a traffic signal near the Red Fort metro station in Delhi on Monday evening, killing at least 12 people and gutting several vehicles.

"We have asked the people, particularly shopkeepers and business establishments, to remain alert about any suspicious movement in their areas. The drive aims to sensitise them," Deputy Superintendent of Police Vikram Bhau told reporters after security meetings.

He said meetings were held with shopkeepers,

transporters, business owners and street vendors at the bus stand to ensure vigilance in the area and seek their support in informing police about any suspicious movement or unattended objects.

Seeking public cooperation in enhancing surveillance, he said, "We urge citizens and traders to install CCTV cameras — preferably high-resolution ones — as part of the broader security setup. This will greatly help the police."

Police have intensified roundthe-clock patrolling and are monitoring footage from dozens of cameras across the city as part of strengthened security measures. "We want people to act as our eyes and ears to help prevent any untoward incident," the officer added.

He said that CCTV cameras have been installed in the bus stand area, which had remained in high vigilance. "The quick reaction teams are put in place. Jammu police is always in your service. Please share any suspected movement", he said.

The officer, however, said that there is no need to panic but remain vigilant, as police and security forces are able to deal with any situation.

Police officers, led by Deputy Inspector General Shiv Kumar Sharma, also conducted outreach activities across Jammu, Samba, and Kathua districts to enhance alertness among security forces as well as the public following the Delhi blast.

Security has been further tightened across the Jammu region, with heightened vigilance along the Jammu-Srinagar national highway, railway tracks and other sensitive installations.

Security has also been beefed up at the cave shrine of Mata Vaishno Devi and its base camp at Katra in Reasi district, officials said.

A high alert has been sounded across the region.

Trump Urges Israel to Pardon Netanyahu, Sparks Concern

Jerusalem: US President Donald Trump on Wednesday sent a letter to Israel's president asking him to pardon Prime Minister Benjamin Netanyahu in a long-running corruption trial that has bitterly divided the country.

It was the latest attempt by Trump to intervene in the case on behalf of Netanyahu, raising questions about undue American influence over internal Israeli affairs. Trump also called for a pardon for Netanyahu during a speech to Israel's parliament last month, when he made a brief visit to promote his ceasefire plan for the war in Gaza.

In Wednesday's letter to President Isaac Herzog, Trump called the corruption case "political, unjustified prosecution".

"As the Great State of Israel and the amazing Jewish

People move past the terribly difficult times of the last three years, I hereby call on you to fully pardon Benjamin Netanyahu, who has been a formidable and decisive War Time Prime Minister, and is now leading Israel into a time of peace," Trump wrote.

Netanyahu rejects the allegations, and in Trump-like language has condemned the case as a witch hunt orchestrated by the media, police and judiciary. Netanyahu has taken the stand multiple times over the past year, but the case has been repeatedly delayed as he has dealt with wars and unrest stemming from Hamas-led militant attacks of October 2023.

Israel's presidency is a largely ceremonial office, but the president does have the authority to grant pardons.

Herzog acknowledged receiving the letter, but said that anyone seeking a presidential pardon must submit a formal request.

Herzog has declined to say how he would respond to a request by Netanyahu, saying publicly only that he believes the trial has been a distraction and source of division for the country and that he would prefer to see Netanyahu and the prosecution reach a settlement.

When Trump called for a pardon in his speech last month, he received a raucous standing ovation from Netanyahu's allies in parliament.

But it has also raised questions about American influence over Israeli policies, especially relating to security in the Gaza Strip. Those concerns came to a head during a series of visits from senior American leaders, from Vice President JD Vance to Secretary of State Marco Rubio.

Jaishankar Meets US Secretary of State Rubio in Canada

Raids were carried out simultaneously across all 10 districts of the Kashmir Valley — Srinagar, Ganderbal, Budgam, Baramulla, Bandipora, Kupwara, Anantnag, Kulgam, Pulwama and Shopian — targeting the residences and premises of Jel members and their associates.

Officials said the crackdown was part of sustained efforts to dismantle the terror ecosystem and its ideological, financial, and logistical support networks.

In Srinagar, police conducted searches at over 150 locations, targeting overground workers (OGWs) and individuals associated with proscribed groups, in connection with ongoing investigations under the Unlawful Activities (Prevention) Act (UAPA).

In south Kashmir's Kulgam, one of the largest operations in recent months was launched, with over 200 locations raided in the past four days. More than 400 cordon-and-search operations were carried out in the district at the premises of OGWs and other banned networks. Around 500 individuals were questioned, with several bound down or detained under preventive laws.

In north Kashmir's Baramulla, particularly in Sopore, Zaingeer, and Rafiabad areas, police carried out simultaneous raids at over 30 locations, recovering a significant quantity of incriminating documents and digital gadgets with links to banned groups. Several suspects were detained for questioning.

Similar operations were carried out in Ganderbal, Pulwama, Awantipora, and other districts, where police recovered incriminating material, digital devices, and printed content with direct links to the banned outfit. A number of individuals affiliated with Jel were interrogated and bound down under law.

Officials said these operations form part of J&K Police's preventive and intelligence-driven strategy aimed at disrupting any efforts to reorganize banned organisations or spread radical ideology at the grassroots level.

"The searches were conducted based on credible inputs about revival attempts by Jellinked individuals through covert channels and front groups. The objective is to pre-empt threats, gather evidence, and maintain peace and public order," a police spokesperson said. Heightened Security After Delhi Blast

Following the Delhi car blast near the Red Fort, in which nine people were killed and 20 injured, the J&K Police have heightened security measures across all districts and appealed to the public to remain vigilant.

All field units have been directed to increase surveillance and checking in sensitive areas, while senior officers have held multiple meetings with locals, shopkeepers, and traders, urging them to report any suspicious movement or unattended objects immediately.

"We have reached out to business owners and transporters to strengthen community surveillance. Cooperation from citizens is essential to maintain security," a senior officer said

Authorities have advised traders and residents to install CCTV cameras and assist in strengthening the city's security grid. Security checks have been intensified at bus stands, railway stations, and markets, while Quick Reaction Teams (QRTs) and additional personnel have been deployed at key locations.

The security outreach has also been extended to Samba, Kathua, and Reasi, with extra deployment at the Mata Vaishno Devi shrine in Katra and its base camp.

Patrolling has been stepped up along the Jammu-Srinagar National Highway and railway tracks, while across Kashmir, security forces continue wide-ranging preventive operations to ensure peace and stability.

In Bandipora, police advised citizens to exercise restraint and responsibility while using social media and to avoid engaging with content that promotes communal or divisive narratives.

The advisory stated that strict legal action would be taken against individuals spreading hate or misinformation and warned against falling prey to accounts operated from across the border aimed at disturbing peace and pub-

lic order.
Similarly, Ganderbal Police issued a strong advisory cautioning against posting or sharing

inflammatory or anti-national content, particularly related to the recent Red Fort blast. Police said some users had mocked the tragic incident online, terming such behaviour as "inhumane and provocative".

The advisory urged users to report objectionable posts or accounts directly to law enforcement agencies instead of amplifying them and emphasised that any content threatening public harmony would invite legal consequences.

In Sopore, police appealed to citizens and WhatsApp group administrators to use social media responsibly and warned that any antinational, communal, or sectarian post, comment, or forward would attract the strictest legal action.

The advisory urged people not to amplify hate or misinformation and to use social media as a tool for connection rather than division.

"It has come to notice that some social media users are posting or reacting insensitively to the recent tragic incident at the Red Fort. Such actions are deeply objectionable and antinational, aimed at spreading hatred and disturbing public harmony," Kupwara Police said, adding that it urges everyone to avoid posting, sharing, or endorsing any content that is antinational, communal, or disrespectful in nature.

"The public is advised to report such content or accounts to the concerned platform or law enforcement authorities instead of engaging with or spreading them," the police said, adding that it is closely monitoring online activity.

Police warned that strict legal action will be taken against anyone found involved in creating or promoting such content.

Meanwhile, in Shopian, police registered an FIR after taking cognisance of a viral video circulated through a Facebook page titled "Voice of Humanity". The video reportedly contained a speech promoting separatist sentiments and activities aimed at disturbing public peace.

Officials said a case under FIR No. 109/2025 has been filed at Police Station Zainapora, and investigations are underway to identify those involved in creating and circulating the content (KNO)

HIV Cases Rise

Dr Showkat Ahmad, a senior physician at GMC Srinagar, said, "HIV is preventable if people remain aware and follow basic precautions. Unprotected sexual contact, use of unsterilized syringes, and transfusion of unscreened blood are major routes of transmission. People must be cautious and responsible."

He added that the availability of Antiretroviral Therapy (ART) has improved the quality of life for those living with HIV, but preventing the infection remains crucial. "Early diagnosis through regular testing can help control the spread and enable timely treatment," he said.

Doctors highlighted the importance of using disposable syringes, ensuring blood safety before transfusion, and promoting safe sexual practices. They said there should be no stigma attached to people living with HIV, as social discrimination often prevents individuals from seeking timely medical help.

Dr Mariya Jan, a health educator, said, "Awareness at the grassroots level, particularly among youth, is vital. Schools, colleges, and community organisations should participate in educational campaigns so that people understand how the virus spreads and how to stay

Health authorities have urged people to avail of free HIV testing and counselling facilities available at government hospitals and Integrated Counselling and Testing Centres (ICTCs) across the Union Territory.

Regular testing, safe behaviour, and compassion towards affected individuals are key to ending the HIV epidemic, the doctors said.

The 'White Collar Module' With JeM Links Investigators said Dr Umar Nabi and Dr Muzammil Ganai, both from south Kashmir, had met overground workers of Jaish-e-Mohammed (JeM) during their 2021 trip to Turkiye.

Data recovered from Muzammil's phone showed that he had recced the Red Fort area multiple times, particularly in the first week of January, indicating plans for a possible Republic Day attack.

Investigators believe Umar was building a vehicle-based improvised explosive device (VBIED) and had taken instructions from online sources about assembly and detonation.

Panic Before Blast

Officials suspect Umar panicked on November 10 after Faridabad Police announced the busting of a terror module linked to JeM and the recovery of 2,900 kg of explosive material. Fearing imminent arrest, Umar drove the

Delhi and parked near the Red Fort, where a premature explosion occurred.

The blast destroyed the car and killed Umar instantly. The VBIED was incomplete as shrapnel had not yet been installed, officials said.

Red SUV Seized in Faridabad Investigators have also seized a red Ford EcoSport SUV linked to the module from Haryana's Khandawali area.

The vehicle, registered in the name of Dr Umar Un Nabi, was purchased on October 29, just weeks before the blast. CCTV footage showed three people inside the car on the day it was taken for pollution testing.

The Delhi Police had issued a city-wide alert to trace the car, suspected to have been used in planning the attack.

Preacher's Home
A preacher, Maulvi Ishtiyaq, from Haryana's
Mewat district, who allegedly helped the module store explosives at his rented home near Al

Investigations have revealed that Umar and Muzammil were part of a radicalised "doctor module", which also included Dr Shaheen Sayeed from Al Falah University.

Their passports show travel to Turkiye in 2021, where they reportedly established con

2021, where they reportedly established contact with JeM handlers operating through Telegram groups, including one run by Umar bin Khattab in Pakistan.

The module had allegedly been instructed to disperse across India and choose target locations after their Turkiye visit.

Possible Mumbai-Style Attack Foiled Investigators believe the group intended to execute a "Mumbai 2008-style coordinated attack" in Delhi.

They had initially planned to strike during Diwali, but postponed it to December. Recovered data suggests plans to target crowded public areas and government landmarks.

A senior police officer confirmed that mobile dump data and CCTV analysis place Umar and Muzammil near Red Fort multiple times as part of their reconnaissance ahead of Republic Day. University Distances Itself Following the arrests, Al Falah University in

'World Pneumonia Day'

Pneumonia Hits People with Weak Immunity Harder, Experts Caution

SRINAGAR: Immunocompromised individuals, including those with weakened immune systems due to underlying health conditions, medical treatments, or age, are more vulnerable to pneumonia, doctors said on Wednesday.

"Pneumonia is one of the most common and serious respiratory infections that inflames the air sacs in one or both lungs. It can be caused by bacteria, viruses, or fungi," Dr Naveed Nazir Shah, a noted pulmonologist and Head of the Department at Chest Diseases (CD) Hospital Srinagar told KNO.

He said pneumonia continues to be the leading infectious cause of death in children under five years of age globally and also poses a serious threat to older adults and immunocompromised individuals.

"The good news is that pneu-

monia is largely preventable," Dr Shah added. "Vaccination plays a crucial role — particularly PCV (Pneumococcal Conjugate Vaccine), Hib, influenza, and COV-ID-19 vaccines. Maintaining good nutrition, exclusive breastfeeding in infants, practising hand hygiene, and reducing indoor air pollution are equally vital."

Another pulmonologist, Dr Javid Ahmad, said that immunocompromised individuals are at higher risk due to weakened immune systems and greater susceptibility to opportunistic infections. "People with conditions like HIV, cancer, or those using immunosuppressant drugs must be extra cautious," he said. "They are strongly advised to receive all recommended vaccines against pneumonia-causing

against pneumonia-causing pathogens."

Dr Javid further said that antibiotics are prescribed only for bacterial infections or in certain high-risk viral cases. "Most viral

symptomatic treatment or antivirals, not antibiotics," he clarified.

According to doctors, early medical intervention can make a crucial difference. "Persistent cough, high fever, chest pain, and shortness of breath should never be ignored," they advised. "Timely evaluation by healthcare professionals can prevent complications and save lives."

Pneumonia can stem from bacterial, viral, or fungal causes, and identifying the correct cause is essential for appropriate treatment, according to doctors. They said risk factors include extreme age (infants or elderly), chronic diseases (like COPD, diabetes, heart disease), smoking, excessive alcohol use, and recent respiratory infections such as flu or COVID-19.

Doctors recommended several preventive measures, including vaccination against pneumoniacausing pathogens, good hygiene such as regular hand washing, healthy nutrition and exclusive breastfeeding for infants, avoiding exposure to cold air in early morning and evening hours, wearing adequate clothing, especially covering the mouth and nose, and managing chronic conditions while maintaining a healthy lifestyle.

They also cautioned that CO-VID-19 and flu can mimic pneumonia symptoms, and tests are necessary to differentiate between viral and bacterial infections

According to experts, modern medical tools have improved pneumonia management. They said rapid diagnostic tests like biomarkers, molecular diagnostics, and point-of-care testing have helped identify the cause of pneumonia more accurately. This ensures targeted therapy and reduces unnecessary antibiotic use, they said.

JKPSC 10+2 Lecturer Aspirants Allege 'Paper Leak'

A spirants of lecturer 10+2 post (English) who recently appeared in Jammu and Kashmir Public Service Commission (JKPSC) objective type test Wednesday alleged that the paper was 'partially leaked' days before the examination was held.

One of the aspirants said that many questions that they attempted in the exam were already shared in a mock test held by some local academy on November-06.

The aspirants further alleged that they came to know through news reports that the questions of the paper were shared 3 days before the JKPSC exam. They further alleged that the question paper was extremely lengthy and were not able to attempt at least 70 or 80 percent of it. "The paper was 40 pages long and was difficult to attempt in just two hours of time."

Another aspirant said, "As the question paper carries negative marking, we had to attempt limited questions and the majority of time during the exams got wasted in understanding the lengthy paper."

JKPSC Chairman Arun Kumar Choudhary told KNO that "If the aspirants have any issues, they can come to the office of JKPSC and submit their complaints."

About the leaking of the question paper Choudhary said, "If the aspirants have evidence and proof, they can come to us or they can lodge a complaint with police." He also said, "Many a things are being shared on social media but there shall be proper evidence for us to take action against any complaint." (Observer News Service)

JMC Seizes 500 Kg of Substandard Meat

JAMMU: The Jammu Municipal Corporation (JMC) has launched a major drive against vendors selling substandard and unhygienic meat in the city, following similar action in the Kashmir Valley.

Nearly 500 kilograms of substandard frozen meat were seized and destroyed, and fines amounting to Rs 50,000 were imposed on the offenders.

The campaign was carried out by JMC's veterinary wing under the supervision of Municipal Commissioner Dr. Devesh Yadav and led by Municipal Veterinary Officer Dr. Jaswant Singh. Surprise inspections were conducted across various localities of Jammu city.

During the operation, around 500 kg of unfit meat was seized from several vendors found violating food safety and hygiene

norms. The seized meat was destroyed on the spot as per safety protocols to ensure it did not reach the market.

Several shop owners were served notices for lacking valid licenses, failing to maintain hygiene, and selling unstamped meat. Apart from the collective fine of Rs 50,000, a separate penalty of ₹7,000 was imposed on shops found selling unhygienic or unverified meat in violation of the Municipal Corporation Act, 2000.

Dr. Jaswant Singh told KNO over phone that the corporation's focus remains on ensuring the sale of safe and clean meat to consumers. "Strict action will continue against those engaged in illegal slaughtering and against vendors operating without a No Objection Certificate from the corporation or registration from the Food Safety Department," he said.

Six Grenades Recovered During Joint Operation in Jabri Forest

KUPWARA: A joint search operation by the Indian Army, Jammu and Kashmir Police, and the Border Security Force (BSF) led to the recovery of six hand grenades from a forested area in north Kashmir's Kupwara district on Wednesday.

Officials said the operation was launched following specific intelligence inputs about the presence of a militant hideout in the Jabri Forest area of Tangdhar sector. During the search, security personnel discovered a cache containing six grenades concealed in the dense forest.

According to KNT, the grenades were destroyed on the spot by bomb disposal experts as a precautionary measure to prevent any untoward incident.

Security officials said the continued recovery of war-like stores in Kupwara highlights the persistent attempts to disrupt peace in the region. They added that recent successful operations have been the result of close coordination and heightened vigilance among the Army, Police, and BSF.

The area remains under tight surveillance, and further searches are being conducted to rule out the presence of additional caches or hideouts. (Observer News Service)
