Over 40% Of India's IT, Gig Workforce Uses AI Tools; Employability Soars To 56%: Report

ver 40 per cent of India's IT and gig workforce uses AI tools for automation, analytics, and creative production, according to an India Skills Re-

The employability in India has improved to 56.35 per cent, up from 54.81 per cent in 2025, showing consistent progress in job readiness and skill adaptability, it said.

The 13th edition of the India Skills Report 2026 was released by Educational Testing Service (ETS), in association with Confederation of Indian Industry (CII), All India Council for Technical Education (AICTE) and Association of Indian Universities (AIU).

The report is based on data from over 1 lakh candidates and 1,000 employers across seven sectors.

The document noted that India's demographic advantage, a workforce with an average age of 28.4, presents both urgency and opportunity, and women have surpassed men in job readiness for the first time.

"To sustain its rise as the world's skills capital, the na-



tion must scale AI-ready learning ecosystems that empower every learner, from schoolchildren to senior professionals," the report said.

It lauded such moves as NEP 2020, SOAR (Skilling for AI Readiness), and Skill India Digital as foundational for the country's growth, yet claimed that "true transformation" will need deeper alignment across academia, industry, and government.

"Employability in India has improved to 56.35 pc, up from 54.81 pc in 2025, showing consistent progress in job readiness and skill adaptability. Tier-2 and Tier-3 cities such as Lucknow, Kochi and Chandigarh are emerging as strong employability hubs, narrowing the urban-rural skill gap," it

The report found female employability at 54 per cent surpassed male employability at 51.5 per cent, driven by hybrid work and digital skilling initia-

It said India now accounts for 16 per cent of the world's AI talent, which is projected to reach 1.25 million professionals by 2027.

More than 90 per cent of employees across sectors use Generative AI tools, while 70 per cent of IT and half of those

working in banking, financial services, and insurance (BFSI) organisations have adopted AIbased recruitment systems, it

In 2025, over 40 per cent of India's IT and gig workforce uses AI tools for automation, analytics, and creative production, it

With 71 per cent of Gen Z freelancers receiving AI training, India is "pioneering a new hybrid model of human-AI collaboration, balancing technical precision with creative problem-solving," the report added. Hiring intent for FY 2026-27 stands at 40 per cent, up from 29 per cent in the previous year, driven by sustained demand in technology, BFSI, manufacturing, renewable energy, and healthcare, it said.

The BFSI and fintech sectors alone are expected to generate 2.5 lakh new jobs by 2030, with an annual growth rate of 8.7 per cent.

"By 2030, global labor shortages are projected to reach 85 million, while India is forecast to supply a surplus of 45 million skilled professionals, positioning it as the world's primary talent hub," the report said.

Says Society Must Stand Up **Against Terror Sympathisers**

Srinagar: Lieutenant Governor Manoj Sinha on Thursday said that while security forces remain determined to dismantle the terror ecosystem in Jammu and Kashmir, society too must come forward and shoulder its responsibility in combating terrorism.

Addressing a special convocation ceremony at the University of Jammu, the Lieutenant Governor said terrorism is a "multifaceted challenge" that cannot be fought by security forces alone.

"Society must actively counter terrorism because it is a multifaceted challenge and society plays a critical role in recognizing and reporting suspicious terror activities and counter the radicalization efforts," he said.

Sinha cautioned that if people do not stand up strongly against terrorists and their sympathisers, the threat will grow into an "existential" challenge for society.

"If the people don't stand up



strongly against terrorists, then it will become an existential threat for society and destroy its stability, peace and progress," he said.

Calling upon "enlightened citizens" to play a proactive role, the LG urged people to expose those who provide shelter to terrorists or promote ex-

New Delhi: Union Home Minister Amit Shah on Thursday said that those responsible for the deadly blast near Delhi's Red Fort will face the "strictest possible punishment," asserting that the action taken will serve as a message to the world that no one should ever dare to attempt such an attack in India again.

Shah made the remarks via video link while virtually inaugurating the Shri Motibhai R Chaudhary Sagar Sainik School and Sagar Organic Plant at Boriyavi village in Mehsana district of Gujarat. His scheduled visit to the state was cancelled following Monday's car explosion in the national capital, which claimed 13 lives.

"All those who committed this cowardly act and those behind it will be brought before the law and given the strictest possible punishment. The Government of India and



Ministry of Home Affairs are fully committed to ensuring this," Shah said, according to an official release.

He expressed condolences to the families of those killed in the high-intensity blast, describing it as a terrorist attack intended to disturb peace and stability.

Quoting Prime Minister Narendra Modi's stance, Shah said, "Prime Minister Narendra Modi's resolve to ensure strict punishment for all those responsible for this terrorist act will definitely be fulfilled."

Srinagar: As political parties brace for a crucial day, counting of votes for the Budgam and Nagrota Assembly constituencies will take place on Thursday, with both seats drawing intense attention for very different political reasons.

The Election Commission of India has put in place elaborate arrangements for the smooth counting process held for the bypolls conducted on November 11. Officials said the counting will begin at 8 a.m. with postal ballots, followed by the opening of Electronic Voting Machines (EVMs) at 8:30 a.m.

Returning Officer for Budgam, Afroza Bano said that 15 rounds of counting will be held for the seat. However, the Returning Officer for the Nagrota constituency, Rajesh Kumar, declined to share the details, citing other engagements.

Kashmiri Mother's Viral Story Of Lost Child Prompts Hospital Probe

SKIMS Responds: Infant Death Inquiry Began Before Online Uproar

Srinagar: It was just after midnight on Friday, October 17, when Sumaira Sumi realised her baby was seriously ill.

Ahmed, her infant son, had a fever over 101 degrees, persistent vomiting, and flu-like

"He couldn't settle all night. I kept worrying he was get-ting worse with every hour," Sumaira recalls in a post that has gone viral, nearly a month after her child's death.

By morning, Sumaira began calling local paediatricians, only to find that most would not be available until late afternoon.

One doctor, Tanveer Bashir at Noora Hospital, said he would see patients from 11 a.m. to 4 p.m. Assured by the hospital staff, the mother left home with Ahmed, hoping for care.

They arrived around noon. The doctor was absent. Staff said he was attending the emergency room, promising he would arrive in 10 to 15 minutes. Hours passed. And when Sumaira asked if the doctor had stepped out for prayers, staff insisted he was in the ER. "They kept saying he was coming, but we waited more than two hours," she said.

By 2:30 p.m., Dr Bashir finally showed up. At 2:45, Sumaira went inside. The mother said the doctor didn't examine her son, didn't take his temperature, and didn't check his vitals. The only measurement taken was the baby's weight by the receptionist. "I told him Ahmed might be dehydrated. He didn't



even check," Sumaira said. remained restless. Sumaira and The night grew worse. Ahmed her husband took him to the

paediatric emergency room at SKIMS. There, only one doctor, Dr Tahir, was present. A nurse arrived late, after Ahmed had been denied timely care. Attempts to draw blood for

basic tests failed repeatedly. The veins, the staff said, were "too cold."

After eight painful pricks, they inserted a DNS line and began fluids.

Half an hour later, test results had not been processed. Dr Tahir was asleep. When asked about the tests, he asked

Sumaira's husband to deliver them to the lab.

Throughout the Ahmed's condition worsened. His lips turned blue. Oxygen levels dropped to 64. Nurses and the doctor dismissed concerns, attributing the readings to faulty machines or cold extremities. Finally, only after raising her

voice did the doctor attend to Ahmed. He was rushed to NICU. By 10:15 a.m., Ahmed had died.

'It is intimated that, as per the Bye-laws of the Association of Indian Universities(AIU), all universities shall be treated as members as long as they remain in good standing, said AIU Secretary General, Pankaj Mittal.

"However, it has come to notice that Al Falah University, Faridabad, Haryana, does not appear to be in good standing. Accordingly, the membership of AIU was accorded to Al Falah University, Faridabad, Haryana, stands suspended with immediate effect," she added.



SC Bans Mining Within I KM of National Parks, Sanctuaries

New Delhi ~ The Supreme Court on Thursday banned mining activities within an area of one km from national parks and wildlife sanctuaries, noting that such activities wil be hazardous to the wildlife.

A bench comprising Chief Justice of India BR Gavai and Justice K Vinod Chandran was considering pleas on issues related to the notification of areas under Saranda Wildlife Sanctuary (SWL) and the Sasangdaburu Conservation Reserve (SCR) as a conservation reserve in Jharkhand.

"It has been the consistent view of this court that mining activities within one km of the protected area will be hazardous to the wildlife. Though in the case of the Goa Foundation, the said directions were issued with respect to the State of Goa, we find that such directions need to be issued on a pan-India basis.

"We direct that mining within national parks and wildlife sanctuaries and within an area of one km from the boundary of such national parks or wildlife sanctuaries shall not be permissible," the bench said.

ed the Jharkhand government to notify the region as a wildlife sanctuary.

It clarified that the rights of the tribals and forest dwellers in the region should be protected as per the Forest Rights Act and asked the state government to widely publicise it.

Earlier, the bench had asked the Jharkhand government to take a decision to declare the ecologically rich Saranda region as a reserve forest.

The matter pertained to a long-pending proposal to notify the Saranda and Sasangdaburu forest areas in West Singhbhum district as a wildlife sanctuary and conservation reserve, respectively.

EC Puts Elaborate Security, Monitoring Mechanism in Place Across 243 Constituencies

Patna: The Election Commission of India will begin counting of votes for the high-stakes Bihar Assembly elections from 8 a.m. on Friday, marking the final stage of a fiercely contested political battle. Barely 24 hours before

results, top leaders across parties huddled in strategy meetings on Thursday, finetuning last-minute plans. The verdict will decide whether Nitish Kumar, the JD(U) stalwart and Bihar's longestserving Chief Minister, secures a record fifth consecutive term—or whether voters swing towards change.

Exit polls have largely projected a clean sweep for the NDA, of which the JD(U) is a key constituent, triggering jubilation in ruling circles and unease in the opposition INDIA bloc. BJP leaders have reportedly ordered large quantities of sweets in anticipation of a "day of victory," PTI reported.

Senior JD(U) leader Shravan Kumar, who held the rural development portfolio, predicted an NDA win "with a difference." Meanwhile, RJD leader Tejashwi Yadav, the INDIA bloc's chief ministerial candidate, dismissed exit poll findings, recalling past media "goof-ups" such as exaggerated Operation Sindoor reports and false news of veteran actor Dharmendra's death.

EC's Tight Security, 4,300 Counting Tables Ready

According to the Election Commission, elaborate arrangements have been made for counting across all 243 constituencies. The process will be overseen by 243 returning officers (ROs), their observers, and candidates or their representatives.

A total of 4,372 counting tables have been set up, each staffed by a supervisor, assistant, and micro-observer. More than 18,000 counting agents appointed by candidates will also will begin first at 8 a.m., followed by EVM counting at 8:30 a.m. Postal ballots will be tallied before the penultimate round of EVM counting The Election Commission emphasized that seals and serial numbers of EVM control units will be verified before counting, with VVPAT slips cross-checked in case of discrepancies. After EVM counting, five

SC Orders HCs To Display Verdict On Websites

New Delhi- To enhance transparency and accountability, the Supreme Court on Wednesday directed all the high courts in the country to create a dashboard on their websites giving details of judgements reserved after January 31, verdicts pronounced, and the date of uploading on their platforms.

A bench of Justices Surva Kant and Joymalya Bagchi, which has taken a critical view of several high courts, including the High Court, not delivering verdicts in both criminal and civil cases for years together after hearing the final arguments and reserving their decisions, said this data should be in public domain.

"Let everyone know how many judgements were reserved, in how many cases orders were passed and on which date the decision was uploaded on the high court website," Justice Kant said.

Concurring with Justice Kant, Justice Bagchi said, "Creating a dashboard or a separate window on the high court's website will show the accountability of the judiciary towards the people".

The top court was hearing a batch of pleas of which one, filed initially by several death row and life convicts through advocate Fauzia Shakil, complained to the top court that the Jharkhand High Court did not deliver judgements for couple of years on their appeals against conviction and sentence, after hearing the final arguments and reserving the decisions.

However. immediately after the apex court's nudge. the Jharkhand High Court delivered the verdicts in their matter and most of them were acquitted of their charges.

Similarly, other convicts lodged in different jails of Jharkhand also approached the top court seeking similar directions. The bench then expanded

the scope of the litigation and sought details of such cases from all the high courts, where judgements were not pronounced for months even after reserving the decisions. On Wednesday, Shakil,

appointed amicus curiae in the matter, pointed out that seven high courts have not submitted their details, while the rest have submitted their reports and the data is being compiled.

'Exercise Trishul Sets New Benchmark, Strengthens Forces'

Porbandar: Tri-services' Exercise Trishul has set new benchmarks in jointness and interoperability and "we go back much stronger out of it" top Indian military commanders said on Thursday.

The nearly two-week-long exercise that culminated with a joint amphibious exercise --Amphex 2025 -- was the largest tri-services exercise conducted after Operation Sindoor.

Lt Gen Dhiraj Seth, General Officer Commandingin-Chief, Southern Command; Vice-Admiral Krishna Swaminathan, Flag Officer Commanding-in-Chief, Western Naval Command; and Air Marshal Nagesh Kapoor, Air Officer Commanding-in-Chief, South Western Air Command, witnessed the exercise.

The top commanders also interacted with the media be-

fore the exercise commenced on Madhavpur Beach off the Saurashtra Coast in Gujarat's Porbandar.

Asked if Exercise Trishul was a fallout of Operation Sindoor conducted by the armed forces in May, and whether there was any strategic messaging in it, Air Marshal Kapoor said "no" to both the queries.

This has been a continuous process, a regular exercise. To give or not to give a strategic message was not our aim. Our aim was to refine our protocols and procedures. and field new technology. So, it was not a fall-out of Operation Sindoor, and there was no strategic messaging (in it)," he said.

Air Marshal Kapoor also shared that the exercise brought to the table "our warfare capabilities", saying the IAF has flown "approximately 1,450 sorties during this exercise".

"We analyse the results to ensure our tactics become more refined in the next exercise. Various new equipment have been fielded during the exercise... I can confidently say that our troops are ready to come out stronger, and I have no doubt about that," the officer said.

From Thar desert to Kutch, the Army, Navy and the Air Force took part in a series of sub-exercises for the last two weeks, under the overarching framework of Exercise Trishul.

Lt Gen Seth said the exercise has set a new benchmark in jointness, integration and interoperability. "During Exercise Trishul.

the kind of jointness, integration and interoperability we have established is a new symbol. It has been very effective, and we have set a new benchmark," the army commander said.



"Earlier, school timings were 8 AM, but now both schools and offices start at 10 AM. As everyone leaves and returns together, the traffic load converges on key routes,' he said, adding that the situation worsens in the evening when people finish work between 3 and 4 PM.

According to KNO, he said additional personnel are being deployed at critical junctions and appealed for citizen cooperation. "We understand the public's inconvenience, but people must avoid roadside parking and prefer shared or public transport. Only collective effort can ease the gridlock," he said.



Kashmir's Diabetes Distress

orld Diabetes Day carries a deeper meaning for Kashmir. It points to a growing health crisis that has slowly spread through homes and hospitals across the valley.

Studies show that around 19 percent of adults in Jammu and Kashmir live with diabetes, almost double the national average. In cities, the figure rises to 26 percent, placing the region among the highest in North India.

Hospitals report a steady rise in new cases, and younger people are increasingly affected. Doctors at SKIMS and GMC Srinagar say that nearly one in five patients visiting their outpatient departments now suffers from diabetes or prediabetes. Many discover it late, when complications like kidney failure or heart disease have already begun.

Researchers point to the same causes: poor diet, lack of physical activity, obesity, and high stress.

Traditional Kashmiri meals once centered on grains, vegetables, and home-cooked food. Today, processed snacks, sweetened tea, and fried street food dominate daily life.

Long winters and sedentary routines make things worse. Studies from the Indian Council of Medical Research and local universities show that central obesity and hypertension are major risk factors among Kashmiris. Smoking and genetic predisposition add to the burden.

Diabetes is now one of the leading causes of blindness, kidney disease, and amputations in the region. It silently drains families of income and energy, often pushing them into debt from medical expenses.

Every village needs regular sugar testing and counseling at health centres. Schools and offices should encourage movement and healthy food. Awareness must focus on prevention than cure.

Community leaders, religious groups, and media can help people change habits before it's too late.

On November 14, World Diabetes Day reminds Kashmir to act now. Simple habits like walking daily, eating healthy, and testing sugar levels can help the valley stop this silent crisis before it deepens.

Why Kashmir's Schools Must Change

A documentary about social media fame reveals how schools can nurture confidence and self-expression alongside academics.

ast week, I found myself in a packed hall at the University of Kashmir, attending a film festival organized by the Media Education Research Centre. Various documentaries and short films were being screened, each followed by lively discussions between students and scholars.

I wandered among the audience, notebook in hand, ready to capture impressions. One documentary, in particular, stayed with me long after the lights came back on. Its title was almost casual: Hello Guyzz.

The film follows the life of a married woman from a middle-class family. She started making TikTok videos and went viral.

Her journey was far from easy. Family opposition, even physical abuse from her husband and relatives, could not shake her resolve. She continued creating content, learning along the way, refining her voice, and growing ever more confident.

I do not advocate that every woman in Kashmir follow her path or make similar content. Our society has deep cultural and religious traditions that guide public behaviour.

Still, her story illuminates a universal truth: confidence and courage are skills in themselves, and they can flourish outside conventional education.

Many viewers might dismiss her success as trivial. After all, TikTok videos are short, informal, and often unpolished.

But speaking confidently into a camera and sharing ideas with an audience is far from easy. It requires overcoming hesitation, fear, and self-doubt, barriers that many students in our schools face every day.

The woman in the documentary may not have had a formal higher education, but the environment she grew up in nurtured her with kindness, encouragement, and patience.

These qualities gave her the fearlessness

that propelled her to viral success.

Scrolling through social media, most of us encounter content that feels superficial or cringe-worthy. Few stop to consider the courage it takes to put oneself out there for public scrutiny.

That courage, the ability to face an audience without fear, is precisely what our schools often fail to cultivate.

Kashmiri students frequently grapple with stage fright, hesitation, and low self-

confidence. These are consequences of systemic shortcomings.

From early schooling onward, teacherstudent relationships hinge on academic performance rather than holistic development. Good grades become the currency of approval, while personal expression, creativity, and risk-taking remain undervalued.

This pattern is visible across both government and private schools, though the disparities are sharper in the former.

Government schools, particularly at the primary and middle levels, often struggle with inadequate resources, overcrowded

publicly remains handicapped in both personal and professional arenas.

The documentary reminded me that education must extend beyond textbooks. It must develop courage and self-assurance. Schools should foster positive, supportive teacher-student relationships. Students who perform well academically tend to receive encouragement, boosting their confidence. Those who lag fall behind emotionally, reinforcing fear of failure.

We need a system that values every student's voice, not just their grades.

classrooms, and outdated teaching methods. Students in such schools carry a weak foundation into higher education, hampering both knowledge and confidence.

Parents who can afford it send their children to private schools, hoping for an edge in academics and self-expression. Even teachers often do the same for their own children.

I have asked myself where the responsibility lies.

Are government teachers underperforming because their job security reduces pressure? Do parents in government schools fail to engage enough in their children's learning?

The truth is more complex. Becoming a teacher in a government school requires rigorous study and a competitive selection process. Knowledge is rarely the problem. The challenge lies in nurturing students who can express themselves without fear and hesitation.

In a digitally connected society, knowledge alone is insufficient. Confidence and communication are equally crucial for success.

Digital tools and online learning platforms have reshaped education, offering students a chance to learn at their own pace. Private school students often benefit from exposure to these tools, which can enhance their self-expression and creativity.

But fear and nervousness persist even among the academically gifted. A student who excels in exams but struggles to speak self-expression in a world where traditional employment remains uncertain. Campus radio, digital storytelling, and media-related co-curricular activities can give students the tools to communicate, collaborate, and showcase their skills.

Exposure to such platforms at the school level can cultivate fearlessness, preparing students to face both digital and real-world challenges.

Zobran Mandani's election as New York

Zohran Mamdani's election as New York City's youngest councilman demonstrates the power of social media. He leveraged online platforms to amplify his voice and reach audiences that traditional methods might have ignored. Schools do not need to train students to

follow the same path. They only need to provide safe spaces for public expression, where creativity and confidence can flourish.

The Invisible Weavers of Kashmir

Kashmir's pashmina glows in global markets, while the women behind it remain in the shadows of their own homes.

Then I began my postgraduate research on women in pashmina work in Baramulla, I imagined I was studying a traditional art form.

I did not expect to walk into a world where women's hands sustain an industry that forgets their

Every household I visited had the same sound in the background: the soft, steady whirr of a spinning wheel. It was almost musical.

But behind that sound lay a silence about ownership, pay, and

Pashmina is a symbol of heritage. patience, and pride in Kashmir. A single shawl can travel from a small village in Baramulla to a boutique in Delhi or Paris, fetching thousands of

But the woman who spins the wool into fine yarn may earn less than what a city café charges for a cup of coffee.

Î met Sara, a 23-year-old spinner, one cold morning in her modest home. Her fingers moved fast and sure over the spindle, twisting the fine fibres of raw wool into perfect

"I start before sunrise," she told me, her eyes fixed on her work. "Once I finish my house chores, I sit

here till late evening."
She worked beside her brother, but when it came to money, the control shifted. "He decides how to spend it. I only get a small amount for myself."

That pattern was everywhere I looked. Women produced the yarn, the most delicate and time-consuming part of the process, while men handled the selling and transactions. They travelled to markets, negotiated prices, and brought back the earnings.

At home, women worked long hours, often under poor light, and rarely saw the real value of what they created.



In one village, I met a group of women who spent up to four months weaving a single shawl. When their total earnings were divided across that time, they made roughly 300 to 400 rupees a day, less than an unskilled labourer.

The finished product would sell for fifteen to twenty thousand rupees. "It's like our hands make gold," one woman said with a faint smile, "but we only touch dust."

Beyond wages, this imbalance is about control, over money, mobility, and decisions.

In most families, women are expected to work from home. They are discouraged from visiting markets or

Their exclusion extends to policy and planning. In the villages where I conducted

my fieldwork, over 90 percent of households were involved in pashmina weaving, but few women's names appeared in cooperative or union records.

Since their work takes place within the home, it is often dismissed as "family labour." They do not exist as workers. And that invis-

cannot save, invest, or make choices that improve their lives. Some I met spoke of being

them with little power to challenge such treatment or walk away from it. During interviews, I often found

myself struggling with anger. These women were not unskilled or passive. They were experts at what they did: patient, precise, and deeply proud of their craft.

What they lacked was access. The tools, the raw material, and the buyers were controlled by men. Even the language of the industry reflects this hierarchy: "master weaver," "dealer," "exporter" - all male titles.

The pashmina that adorns global runways owes its existence to invisible hands. Every strand that passes through a loom carries the touch of a woman who is rarely paid what she deserves. The global market celebrates the product but forgets the person behind it.

Real change must begin with ownership. Women-led cooperatives could transform this landscape by letting artisans sell directly and

When women control their sales,

they earn more and command respect at home. In a few parts of Kashmir, small self-help groups have started doing this, but they remain underfunded and unsupported.

Skill recognition is another missing link. Government certification could help women gain fair rates and enter export chains.

If a spinner's name appeared on the product she created, her value would increase, so would her pride. Legal protection matters too. Home-based artisans must be brought under labour laws to ensure minimum wages and social

Money alone cannot solve everything. The deeper challenge lies in changing attitudes that see women as helpers rather than earners.

Awareness campaigns in weaving communities could help families understand that women's income is not a threat but an asset.

Access to microfinance is equally vital. Many women told me they would like to buy their own spinning wheels or raw material but

lacked funds.

Small, interest-free loans could give them independence and stability.

When I look back on my research, I remember those long winter afternoons spent inside rooms where women sat spinning by the hearth. Their fingers were fast, their talk gentle, and their laughter rare. They spoke of dreams, of sending children to school, buying a machine, and having their own name on the product they make.

The beauty of a pashmina shawl lies in its softness and fine weave, but its story is one of endurance.

Behind every shawl sold abroad is a woman in Kashmir who works through cold mornings and late nights, her labour woven into something she can never claim as her own.

True value for these women will come only when the hands that create Kashmir's most treasured fabric are also allowed to own it.

Pashmina's future depends on whether the women behind the wool are finally seen, valued, and free to shape their own lives.

Buyer Not A Consumer If Purchase Made For Profit: SC

NEW DELHI- In a significant verdict, the Supreme Court on Thursday held that if any purchase of goods or services is for profit generation, then the purchaser cannot be held to be a consumer and consequently cannot pursue cases under the Consumer Protection Act.

A bench of Justices JB Pardiwala and Manoj Misra, delivering the judgement in an appeal filed by M/s Poly Medicure Ltd, affirmed the findings of the State and National Consumer Disputes Redressal Commissions that the complaint filed by the company was not maintainable under the Act.

It held that a company purchasing software to automate its business processes cannot be regarded as a "consumer" under the Consumer Protection Act, 1986, as such a transaction is for a "commercial purpose".

Authoring the verdict, Justice Manoj Misra referred to various judgements and said, "the transaction of purchase of goods/ services (i.e., software) had a nexus with generation of profits and, therefore, qua that transaction the ap-



pellant cannot be considered a consumer as defined in Section 2(1)(d) of the 1986 Act."

If the transaction has a nexus with generation of profits, it would be treated as one for a commercial purpose, it said while dismissing the appeal of the firm.

The appeal arose from a complaint filed by Poly Medicure Ltd, a manufacturer and exporter of medical devices, before the Delhi State Consumer Disputes Redressal Commission in 2019.

The company had alleged deficiency in service by M/s Brillio Technologies Pvt Ltd, from which it had purchased a software product licence for streamlining its export-im-

port documentation system. Poly Medicure claimed that despite making full payment,

the software did not function properly and sought a refund of the licence and development costs, along with 18 per cent interest.

However, the SCDRC, in its order of August 19, 2019, dispraced the appropriate to the

order of August 19, 2019, dismissed the complaint on the ground that the company did not qualify as a "consumer" under the Consumer Protection Act, since the purchase was for a commercial purpose.

The National Consumer Disputes Redressal Commission subsequently upheld the SCDRC's view in June 2020, prompting the appellant to approach the top court.

Gold Surges Rs 3,000 To Rs 1.30 Lakh/10g Press Trust Of India

NEW DELHI- Gold prices surged Rs 3,000 to Rs 1,30,900 per 10 grams in the national capital on Thursday tracking firm global cues and weak dollar, according to the All India Sarafa Association.

Traders said the end of US government's shutdown also supported the appeal of the safe-haven asset.

The precious metal of 99.5 per cent purity extended its gains for the third straight day, jumping Rs 3,000 to Rs 1,30,300 per 10 grams (inclusive of all taxes) from Wednesday's closing of Rs 1,27,300 per 10 grams.

In the local bullion market, gold of 99.9 per cent purity had closed at Rs 1,27,900 per 10 grams in the previous market session.

Silver prices skyrocketed Rs 7,700 to Rs 1,69,000 per kilogram (inclusive of all taxes) on Thursday. The white metal had settled at Rs 1,61,300 per kg, up Rs 5,540 on Wednesday.

Meanwhile, the dollar index, which gauges the greenback's strength against a basket of six currencies, was trading 0.20 per cent lower at 99.30, after the Trump administration passed the bill to end a 43-day record government shutdown, lending support to the bullion prices.

In the international markets, spot gold rose USD 41.19, or 0.98 per cent, to USD 4,236.84 an ounce.

"Bullion extended its gains on Thursday, supported by a soft US dollar and growing expectations for more rate cuts following weaker macroeconomic



data from the world's larges economy.

"Additionally, the Federal Reserve is likely to inject more money into the system to address a partial liquidity drain caused by the shutdown, which also impacted positively precious metals," Saumil Gandhi, Senior Analyst -- Commodities at HDFC Securities, said.

Spot silver was trading 1.13 per cent higher at USD 53.86 per ounce in overseas trade.

"Silver has rebounded strongly this week, gaining more than 10 per cent so far. This surge is driven by several bullish factors, including expectations for rate cuts, supply concerns, robust industrial and investment demand, and strong technical momentum," Gandhi added.

The US Department of the Interior added silver to its "critical minerals" list, and highlighted its importance to the economy and national security.

"The market is now awaiting a flurry of official data after the US government ends the longest shutdown in its history. The official data eliminates the market's dependence on private data, offering clarity about the US economy's health and dispelling uncertainty about future rate decisions," he said.

SC Raps Banks for Filing Cheque Bounce Cases in Distant Courts

NEW DELHI- Expressing displeasure over the "misuse of law" and "harassment" meted out to small-time borrowers by financial institutions and banks by lodging cheque bounce cases at distant locations in the country, the Supreme Court on Thursday said it would examine the issue and settle the law.

A bench of Justices Surya Kant and Joymalya Bagchi expressed shock over a case in which one Golla Naraesh Kumar Yadav sought the transfer of a case lodged by Kotak Mahindra Bank before the chief judicial magistrate at Chandigarh to a court of metropolitan magistrate in Adoni of Kurnool district in Andhra Pradesh.

Appearing for Yadav, the bench was informed by advocate P Mohith Rao that the bank has lodged the case at Chandigarh despite all transactions having taken place in Andhra Pradesh, which is creating difficulties for the petitioner.

He said that the borrower of the credit facilities from the bank regularly paid the loan instalment but the case was lodged due to a small default.

The bench asked the counsel appearing for the bank as to why the complaint was lodged against Yadav in Chandigarh when the entire transaction had taken place in Andhra Pradesh.

The counsel for the bank said that they have an office in Chandigarh which deals with the loan for which the petitioner is a guarantor.

"Just because you have an office in Chandigarh, you will lodge a complaint there. This



is unfair and harassment of small-time borrowers.

"What makes you think that you will not get justice in Andhra Pradesh? Chandigarh courts are not sitting idle," Justice Kant told the counsel for the bank.

Rao told the bench that this is a problem which is happening day in and day out, and the apex court is flooded with cases where litigants, who are sometimes small borrowers, have to seek transfer of the cases lodged against them.

"They file cases in Delhi, Calcutta or any other city while transactions normally have taken place in some other distant part of the country," he submitted.

Justice Kant told the bank's counsel, "You are like an octopus. You have offices everywhere, so does it mean you will file cases here and there? We are opening courts everywhere but you still file cases at distant places, just to harass the borrowers. Where is the access to justice?"

The counsel for the bank said the complaint was filed under the provisions of the Negotiable Instrument Act and the 2015 amendment to the law provided for it.

Justice Bagchi said the question is not of territorial jurisdiction but in transfer cases, the court normally looks at the convenience of the parties.

Justice Kant intervened and told the bank, "Just because you can file a complaint anywhere in the country where you have a collection centre, does not mean you will harass these small-time traders or borrowers."

The bench said, "It means

if transactions took place in Srinagar, you will file a complaint in Kanyakumari or Coimbatore. This was not the intent of the legislation. It is a misuse of the law. We will examine this issue and pass orders and set the law."

The top court allowed the petition of Yadav and transferred the case to the court in Andhra Pradesh.

It asked Rao to find out how many complaints the bank has filed in Chandigarh, which court is examining them and the status of those cases.

The case pertained to a Cotton trading company situated in Andhra Pradesh which obtained credit facilities like overdraft in 2021 from the bank through its branch situated at Adoni in Kurnool district.

'GST Rate Cuts Pull Down Oct Inflation By 85 Bps'

NEW DELHI- The GST rate cuts brought down retail inflation by 85 basis points to a record low of 0.25 per cent in October and the declining trend is likely to continue in the coming months, according to experts.

The Consumer Price Index- (CPI-) based retail inflation was lowest in the current series (base year 2012), which captures data since January 2014.

CPI inflation increased in case of personal care and effects, owing to higher gold prices, at 57.8 per cent, an SBI research report said, adding that if if the precious metal is excluded, headline CPI turns the print negative at -0.57 per cent year-on-year. "We believe, given the current trend, CPI, excluding gold, would remain negative even in the next two months," the 'SBI Ecowrap' said.

GST rationalisation, which came into effect from September 22, has also led to reduction in CPI inflation.

"We earlier estimated that CPI will moderate by 65-75 bps owing to GST. However, the decline in CPI inflation due to GST has been higher at around 85 bps," the report said.

It further said the CPI inflation trajectory calls for a strong case for decisive actions. The higher growth numbers for second quarter and the October inflation print will pose a serious dilemma for the RBI for a rate action in December.

"Under these circumstances, we believe December rate cut is a close call and not a given. It will entirely depend on how the RBI is able to communicate to the market a rate cut when growth numbers are in excess of 7 per cent," the SBI report said.

'Indian Businesses Keen To Expand Trade Investment In Saudi'

DUBAI- A large number of Indian business leaders see Saudi Arabia as a reliable investment destinations and are keen to increase trade with the country amid global uncertainties, a new report has said.

This aligns with the Kingdom's Vision 2030 plan, which aims to build a resilient, stable economy with attractive growth opportunities, according to the HSBC New Networks of Capital: Saudi Arabia report.

Citing a survey, the report said that Indian businesses are increasingly viewing Saudi as a reliable partner and 85 per cent of Indian businesses – the highest among surveyed markets – see Saudi Arabia as a more attractive destination for trade and investment amidst global uncertainties. As many as 78 per cent of Indian businesses are planning to increase investments in Saudi Arabia in the next six

months – representing the highest level of commitment among any market outside the Middle East, claims the report. Looking ahead over the next five years, this figure is expected to rise to 88 per cent.

The report is based on a survey of 4,000 business deci-

sion makers with international operations, each generating annual revenues of USD 50 million to USD 500 million.

The survey uncovered insights into the evolving trade

and investment links between Saudi Arabia and eight major global markets, including the UK, Hong Kong, Mainland China, USA, India, Germany, UAE, and Egypt. Responses were also drawn in-market, from Saudi Arabia.

US Tariffs: 'India Doing Right Thing By Trying To Sign FTA With US'

NEW DELHI- Former Planning Commission deputy chairman Montek Singh Ahluwalia on Thursday lauded the government's handling of the tariff issue with the United States, and said signing the Free Trade Agreement (FTA) with the US would be the "right thing" to do.

Delivering a lecture on former prime minister late Manmohan Singh's life and legacy at the Prime Ministers Museum and Library (PMML) here, Ahluwalia also favoured the lateral entry of young people from the private sector into governance, citing the example of Nandan Nilekani while introducing Aadhaar. Ahluwalia said the idea of "Viksit Bharat" cannot be achieved unless human resources are tackled in a reasonable manner.

"Some people criticise the government saying the US is acting tough on tariffs and we should also act tough on the same. I don't think it is actually correct.

"In fact, what we are doing, which is trying to sign an FTA, is a very good thing. Some people do feel that it is the right thing to do," he said. It is important to design a policy in such way that differences are erased amicably, he added.

Noting that there will always be differences on the way one designs the policy, "but the best way to do is encourage people to erase those differences and discuss it".

Citing the case of Nandan Nilekani, who was brought in from the private sector to introduce Aadhaar in the country, Ahluwalia said in future when we have complex things such as AI and cyber security, this cannot be done in a normal way.

Special Security Drive At Jammu Station As Railways Intensifies Vigil

Jammu:The Northern Railway on Thursday conducted a special drive at the Jammu railway station as part of enhanced security measures, officials said.

The move comes in the wake of a high-intensity blast in a slow-moving car near the Red Fort in Delhi on Monday evening, killing 13 people.

"Special security drives are conducted periodically at various railway stations in the

Jammu division of Northern Railway to ensure passenger safety," Senior Divisional Commercial Manager, Jammu Division, Uchit Singhal said.

The special security drive was carried out by the Railway Protection Force Government Railway Police (GRP), dog squad, and officials from the commercial department, he added. The Jammu station and the surrounding railway premises were thoroughly checked, Singhal said.

"Passenger luggage, platforms, and arriving and departing trains were checked using metal detectors and dog squads. The waiting room, reservation counters, booking office, and parcel office were specially inspected," he added.

Passengers were informed about security precautions during the drive. "The primary objective of this special security operation is to ensure normal rail traffic at the station without causing inconvenience to passengers," Singhal said.

DNA Confirms Umar Was Driving the Blast Car Police sources on Thursday confirmed that DNA samples collected from the blast site match those of Pulwama-based doctor Umar Nabi, establishing beyond doubt that he was driving the explosives-laden Hyundai i20 that blew up outside the Red Fort on Monday evening. The DNA samples of his mother, taken on Tuesday, were analysed alongside the remains recovered from the site.

"The DNA results confirm that it was indeed Umar who was driving the fateful vehicle," a senior police source said. Umar was among the key suspects linked to a module with alleged ties to Jaish-e-Mohammed and Ansar Ghazwat-ul-Hind. Umar's Final 24 Hours: Zigzag Routes & Night

Investigators reconstructed Umar's route using footage from more than 50 CCTV cameras across Delhi and Haryana. The trail shows him leaving Faridabad on Sunday morning, travelling along the Delhi-Mumbai Expressway, halting at a dhaba in Haryana's Nuh district, and spending the night inside his car.

The next morning, he re-entered Delhi via the Badarpur border and drove a looping, zigzag path across Southeast, East, New Delhi, Central and Northwest Delhi-movements police believe were calculated to avoid surveillance.

He was captured stopping at an eatery in Ashok Vihar, appearing calm, before heading toward central Delhi. Later, he visited a mosque near Asaf Ali Road, where he stayed for nearly three hours.

Police said his phone activity during this period is also being closely examined. Investigators suspect he might have received instructions before proceeding toward the site.

"At 3:19 pm, Umar's car entered the parking area adjacent to the Red Fort complex, where it remained stationary for around three hours. CCTV footage shows the car parked quietly among other vehicles near the Sunehri Masiid parking," an of ficer privy to the investigation said.

Around 6:22 pm, the car was seen leaving the parking area and heading towards the Red Fort Metro Station side. Barely 30 minutes later, at 6:52 pm, the vehicle exploded in a powerful blast that shattered windows, scattered body parts across the road, and triggered panic among visitors and commuters in the area.

Encrypted Apps, 26 Lakh Pool & 4-City Terror

Investigators probing the Red Fort blast have uncovered an extensive network of encrypted communication, pooled funds, coded notes and chemical purchases that point to a meticulously coordinated plan by what officials describe as a "white-coat terror module" involving young medical professionals.

According to police sources, the three core suspects – Dr Umar Nabi, who drove the explosivesladen Hyundai i20 that detonated on Monday, Dr Muzammil Ahmad Ganaie and Dr Shaheen Shahid – allegedly used the Switzerland-based encrypted messaging app Threema to communicate and coordinate their activities. Umar had also created a small Signal group, consisting of two to four members, to handle operational instructions.

Investigators said the group had pooled more than 26 lakh in cash, which was handed over to Umar for "safekeeping and operational use." Using part of the pooled amount, the suspects allegedly bought 26 quintals of NPK fertiliser, worth around 3 lakh, from suppliers in Gurugram, Nuh and nearby towns. NPK fertiliser, when mixed with other chemicals such as potassium chlorate and sulphur, can be used to make Improvised Explosive Devices (IEDs).

Police sources said at least eight suspects were preparing to carry out blasts in four cities, with the plan to move in pairs to each target location. The Red Fort blast was allegedly the first in the

The scale of the conspiracy became clearer after investigators recovered notebooks and diaries from Dr Muzammil's Room No. 13 and Dr Umar's Room No. 4 at the Al Falah University campus. The diaries contained coded entries, names, numerical sequences and the repeated use of the word "operation", dated between November 8 and 12. Police said the codes suggest layered planning and a high level of coordination.

The entries also included references to 25–30 individuals, largely from Jammu and Kashmir the home state of the two doctors — as well as Faridabad and surrounding areas. Officials say the material gives insight into the structure and reach of what they are now calling a "white-coat terror module", a nod to the suspects' medical

Investigators believe the group rented multiple

accommodations outside the university to store chemicals, fertiliser bags and explosive components. During raids earlier this week, two additional vehicles — a red Ford EcoSport and a Maruti Brezza — were seized for forensic examination. One senior officer said a large bag believed to contain explosives had been placed on the back seat of Umar's car as he drove toward Delhi ahead

Police said Umar, considered academically gifted by peers, allegedly became radicalised over the last two years, joining several encrypted and closed-group messaging platforms.

Probe Enters Multi-State, Multi-Agency Phase Officials say the case has now entered a complex phase involving Delhi Police, NIA, J&K Police, UP ATS, Haryana Police and central agencies. With DNA confirmation, extensive CCTV mapping, cross-border elements, foreign travel links and multiple detentions across states, investigators believe they are uncovering a sophisticated "white-collar" network that used professional credentials, encrypted communication and overseas travel as cover. More arrests and internation-

In Kanpur, the Uttar Pradesh Anti-Terrorist Squad detained Dr Mohammad Arif Mir (32), a first-year DM cardiology student at GSVM Medical College. Arif was picked up from an undisclosed location on Thursday, after which ATS personnel searched his rented accommodation in Ashok Nagar, seizing his phone and laptop before taking him to Delhi. Officials said Arif had been in telephonic contact with individuals linked to the network on the day of the blast. He allegedly attempted to delete data from his phone when ATS teams arrived

Arif is believed to have come under the ATS radar during the interrogation of former GSVM professor Dr Shaheen Sayeed, who has already been arrested in the case. Investigators say Arif recently travelled to Jammu and Kashmir and may have used a shared email ID-an old technique employed by terror groups to avoid electronic surveillance.

Kanpur Police Commissioner Raghubir Lal told PTI that he has received information about the detention and has sent a team to verify the reports. "We are checking the facts. I will comment only

after confirmation," Lal said. Dr Awadhesh Kumar Sharma, media in-charge of GSVM Medical College, said, "Arif first got admission at Sanjay Gandhi Postgraduate Institute Sciences, Lucknow, but later chose Kanpur during the second round of counselling."

College director Dr Rakesh Verma said Arif secured an All-India Rank of 1608 in the NEET Super Speciality examination. "He was a bright and disciplined student," Verma added.

Arif's roommate, Dr Abhishek, who briefly went missing after the ATS action, later surfaced to deny any link with the case. "I was at a friend's house when he was taken. I have no connection with any suspicious activity," he told reporters.

According to the sources, Arif's flat near Fatima Hospital in Ashok Nagar was arranged with the help of another doctor, Mohammad Yasir of Aligarh.

"He would leave for the hospital on a bike taxi every morning and return late in the evening. He rarely interacted with anyone," a neighbour said. The medical fraternity in Kanpur has expressed

shock over the developments. Meanwhile, both the National Investigation Agency (NIA) and ATS have begun verifying the backgrounds of Kashmiri-origin students studying in Kanpur and are continuing operations to trace any additional links to Dr Shaheen's network.

According to ATS sources, around 48 such students are currently enrolled at a leading technical institute and details about their activities are being collected.

More names may surface as the probe progresses, they said.

Meanwhile, the government on Thursday ordered a forensic audit of all records of the Al Falah University, which is under the scanner following the Delhi blast, besides asking the ED and other financial investigative agencies to check the money trail of the Haryana-based institution, sources

The Association of Indian Universities (AIU) suspended the university's membership, saying it 'does not appear to be in good standing".

The National Assessment and Accreditation Council had earlier issued a show-cause notice to Al Falah University for displaying false certification on its website.

Mohammed Tariq Ishtiaq, Assistant Director at the MSME office in Srinagar, highlighted Kashmir's textile sector as an example. He explained that registering a weaving design or trademark allows products to command higher prices, enter national markets, and reduce imitation risks.

Prof. Parvez A. Mir, CEO of the CIED-IUST Foundation, encouraged participants to connect research-driven innovation with entrepreneurship to drive regional growth.

Entrepreneurs shared their experiences and sought expert guidance on safeguarding their

said, "Registering a design or process turns creativity into a business asset. It protects ideas, opens opportunities, and lets your business contribute to society." From the government side, Saheel Alaqband

Ubaid Mehraj, managing director of L-Crystal,

outlined schemes like the Credit Guarantee Fund Trust for Micro and Small Enterprises (CGTMSE) and SRI Funds, showing how financial support can reinforce intellectual property protection. Attorney Zainab Syed led a technical session on registering designs, trademarks, and patents,

and discussed how MSMEs can leverage the Intellectual Property Facilitation Centre. The workshop included a lively Q&A where

participants asked about costs, timelines, and commercializing ideas in Kashmir context. Kashmir's entrepreneurship scene has grown

Since 2020, over 1.72 lakh women-led MSMEs egistered through Udvam and Assist portals raising women's share of enterprises from 11.39% in 2020-21 to 26.62% in 2023-24.

The sector now employs more than 17 lakh skilled youth, with around 1.6 lakh new micro and small enterprises launched over three years. Credit access has expanded, with nearly 3.99 lakh loans sanctioned under the Pradhan Mantri

Mudra Yojana and 1.51 lakh guarantees approved under CGTMSE. Traditional crafts are gaining recognition too. Fifteen crafts now hold Geographical Indication (GI) tags, including Sozni embroidery, Pashmina and Kani shawls, and walnut wood carving. The

Handicrafts & Handloom Department has issued 55,113 GI labels to protect regional handicrafts. But challenges remain. More than 700 MSME units closed between July 2020 and November 2024, showing the risks of running businesses

without proper legal protection and strategy. The workshop highlighted success stories. A Srinagar-based embroidery startup that registered its design secured a contract with a national

retailer, boosting margins by about 30%. Eight more crafts, including Kashmir Namda and Crewel embroidery, recently obtained GI certification, bringing the total to 15.

These registrations create new pathways for branding and exports.

In the tech sector, registering copyrights or patents gives startups credibility and opens doors to national and international investors.

For Kashmiri entrepreneurs, the message was clear: A good idea is only the beginning. Legal protection, strategic planning, and ecosystem support are essential to turn creativity into sustainable growth.

Reflecting on the session, Afiya Khan concluded, "I came for IP registration guidance. I leave with a path to make my idea survive and grow beyond the valley."

rative around the NC-Ruhullah conflict, observ-

ers added that the outcome itself may not bring Ruhullah direct political gains-since an NC win or PDP win has limited personal impact for him. What a PDP Win Would Mean For the PDP, reduced to the margins of Kashmir's electoral landscape, a victory in Budgam would be

Sources said late on Thursday that the inquiry committee has submitted its report to Director SKIMS Dr Ashraf Ganaie.

Talking to Kashmir Observer, Dr Ganaie said the institute will act upon the report forthwith. He also clarified that the SKIMS administration had initiated the inquiry soon after the incident was reported and not in response to any viral post.

India Wary Of South Africa's Spin Threat In Opening Test At Eden Gardens

KOLKATA: India's awe-inspiring batting depth will face a stern test against South Africa's quality spin attack when the reasonably well-matched sides clash in an eagerly-anticipated two-match Test series beginning here on Friday.

India would be haunted by the ghosts of last year's home debacle against New Zealand when their home record was shattered by Kiwi spinners Ajaz Patel, Mitchell Santner and Glenn Phillips, who shared 36 wickets across three Tests, fashioning an unprecedented 0-3 whitewash.

Given South Africa's heavy reliance on tweakers right now, that collapse against sustained spin pressure will linger in the collective memory of the home side.

The reigning World Test champions are known for fiery pacers historically but are currently armed with one of the most potent spin groups in world cricket.

The Proteas arrive on the back of a morale-boosting 1-1 draw in Pakistan, achieved without inspirational captain Temba Bavuma.



South Africa's spin trio of Keshav Maharaj, Simon Harmer and Senuran Muthusamy accounted for 35 of the 39 wickets to fall across the series outperforming Pakistan's own slow-bowling contingent of Noman Ali, Sajid Khan, Asif Afridi and Salman Agha, who managed 27 wickets collectively

Simon Harmer, now 36 and

holder of 1,000 first-class wickets, is no stranger to Indian conditions. He arrives in Kolkata after an eight-wicket match haul in Rawalpindi last month that spun South Africa to a series-levelling

win over Pakistan.
His control, drift, and subtle changes of pace make him an ideal foil for the left-arm spin of Maharaj, who is arguably one of

the most accurate and attacking spinners in the modern game.

The Eden Gardens pitch has therefore become the most-watched element of this contest. While India batting coach Sitanshu Kotak and captain Shubman Gill have made multiple pitch inspections, Cricket Association of Bengal president Sourav Ganguly has assured that it "won't be

a rank-turner

Over the last 15 years, pacers have taken 61 per cent (97 of 159 wickets) in Tests here as seam and swing play a major role, especially in the early and closing stages.

For India, the focus will be on application and patience against spin

With Rishabh Pant fit again and an in-form Dhruv Jurel set to play as a specialist batter, the middle order looks more stable. Washington Sundar, who topped India's spin charts in that New Zealand series with 16 wickets, provides drift and bounce and lends depth with the bat.

Given it's only a two-match series, the margin for error is slim.

Falling behind early could prove fatal especially with unfamiliar conditions set to play their part in the final Test in Guwahati, which will make its debut as a Test yenue.

For India, batting big and putting the opposition under the scoreboard pressure will be the key to exorcising the ghosts of last year's collapse.

'Pakistan Military Chief Salvaged Cricket Tri-Nation Series'

Pakistan military chief directly intervened to salvage the tour of visiting Sri Lankan cricket team following the suicide attack in Islamabad, the interior ministry said on Thursday.

Mohsin Naqvi told the Senate that Field Marshal Asim Munir facilitated the talks with Sri Lanka top officials, when the Lankan cricketers showed weariness to play after the attack.

Sri Lanka's cricket board said late last night that its team's ongoing tour of Pakistan will proceed, following the high-level exchanges that saved the situation for Pakistan.

"Our field marshal himself spoke to their defence minister, secretary and convinced them and assured them fully of [providing] security," Naqvi, also the Pakistan Cricket Board (PCB) chief, said while speaking on the Senate floor.

Naqvi recalled that the Sri Lankan team yesterday "decided to return after the bomb blast occurred".

Naqvi said that high-level security was being

Naqvi said that high-level security was being provided to the visitors.

The PCB chairman noted that the Zimbabwe team has arrived in Pakistan, and the rest of the matches will be held in Rawalpindi.

The series will now begin on November 18,

instead of November 17 and Rawalpindi will be the sole venue as against Lahore's Gadaffi stadium that was chosen as the original venue to host all T20 games.

The crisis followed after a suicide blast in Islamabad on Tuesday, which killed 12 people. (PTI)

Turkey Imposes Temporary Bans On 102 Players Over Betting Scandal

Turkish soccer temporarily banned 102 professional players including 25 from the top-tier league on Thursday over a widening betting scandal that has implicated hundreds of referees.

The Turkish Football Federation imposed bans on 25 players from the Super Lig and 77 from the second-tier first division for terms ranging from 45 days to one year. It followed days after more than 1,000 players

were provisionally suspended in the scandal.
Galatasaray and Turkey defender Eren Elmali
was suspended for 45 days, three days after he was
pulled out of the national-team squad for World
Cup qualifying games.

Club teammate and former Turkey Under-21 center back Metehan Baltaci was suspended for nine months. Konyaspor winger Alassane Ndao, who is a former Senegal international, got a 12-month ban.

The bans apply to matches but the players can continue training, Haberturk television reported. A total of 1,024 players have been referred to the federation's Professional Football Disciplinary Board in the ongoing investigation.

More than 150 Turkish referees are alleged to have bet on games, including seven who are approved to handle top-level games and 15 top-level assistants. (AP)
