Seized Explosives Trigger Massive Blast in Nowgam PS

Srinagar: An accidental explosion at the Nowgam police station in the outskirts of the city here late on Friday night injured at least eight personnel extracting samples from a massive cache of explosives recently seized in connection with the 'white-collar' terror module case, officials said. They said the blast occurred while personnel were handling the explosive material that had been brought from Haryana's Faridabad.The material, part of the 360 kilograms of explosives recovered from the rented residence of arrested doctor Muzammil Ganaie, was being sampled as part of the ongoing investigation, the officials said. Ambulance and police sirens broke the silence of the night as the injured were rushed to a hospital.Small successive explosions prevented immediate rescue operations by the bomb disposal squad. It was not immediately clear if the entire 360 kg of explosives was stored at the police station, where the primary case for the terror module was registered. The entire conspiracy was unravelled after the posters threatening police and security forces appeared on walls in Bunpora, Nowgam, in | More on P6

Speaking at the valedictory function of the first phase of the 150th-year celebrations of the national song Vande Mataram at MA Stadium, Jammu, the LG said the Union Territory has taken a decisive turn toward peace and progress since 2019, but "this transformation is causing

discomfort to some people." "There are still some elements hiding within society



who are trying to radicalise our youth. Several such cases have come to our attention in recent months," Sinha said. "We must

root out these elements and isolate the terror ecosystem. Collective action of society will prove to be the last nail in the coffin of terrorism."

"I am of the firm belief that when terrorists and their sympathizers stop getting oxygen, that will be the last nail in their coffin- and that day is not far."

"My fervent appeal to all is to come forward and put in an effort to make J&K completely terror-free," he added.

The event, organised by the Department of Culture, witnessed a massive gathering, with more than 20,000 students and citizens joining in the mass singing of Vande Mataram. Sinha congratulated the people of Jammu and Kashmir for securing the highest national participation in the week-long celebrations.

Red Fort Blast: House Of Accused Demolished; NMC Deregisters 4 Doctors

Srinagar: Security forces have demolished the house of Dr Umar Nabi, the man identified as the driver of the explosiveladen car used in the Red Fort blast that killed 13 people in New Delhi earlier this week. The demolition was carried out in south Kashmir's Pulwama district during the intervening night of Thursday and Friday, officials said.

The blast, which took place near the Red Fort on Monday night, led to massive casualties and prompted a multi-agency probe. Învestigators said Umar was driving the Hyundai i20 packed with explosives. His identity was confirmed after DNA samples from



the blast site matched with those of his mother.

Once known as an academiaccomplished young

doctor, Umar is suspected to have undergone rapid radicalisation over the last two years. Officials said | More on P6

Study Finds Brain's Learning Processes Linked With Female Reproductive Cycle

Brain processes involved in helping one learn may naturally fluctuate in line with the female reproductive cycle and be linked with molecule changes due to dopamine production, according to a new study in mice, findings from which could potentially explain how the neurochemical helps in learning in humans.

"There is a growing realisation in the medical community that changes in the oestrogen levels are related to cognitive function and, specifically, psychiatric disorders," said Christine Constantinople, a professor in New York University's center for neural science and senior author of the study published in the journal Nature Neuroscience.

"Despite the broad influence of hormones throughout the brain, little is known about how these hormones influence cognitive behaviours and related neurological activity," Constantinople said.

Researchers performed experiments with mice, which involved providing the animals with audio cues carrying information about water availability. Learning abilities of the mice were seen to be enhanced when oestrogen levels were increased, which the authors said could be because the female sex hormone boosts dopamine activity in the brain's 'reward centre', making reward signals stronger.

However, when oestrogen activity was



suppressed, the hormone was curbed in its ability to regulate dopamine and therefore, learning was seen to be diminished in the animals.

The result pointed to a potential link between hormone levels and symptoms of neuropsychiatric disorders, the researchers said.

"All neuropsychiatric disorders show fluctuations in symptom severity over hormonal states, suggesting that a better understanding of how hormones influence neural circuits might reveal what causes these diseases," Constantinople said.

The team added that cognitive activ-

ity was seen to be unaffected by oestrogen activity, and that effects were specific to learning abilities.

The authors wrote, "(Natural oestrogen production) predicts dopamine reuptake and RPE (reward prediction errors) signalling, and causally dictates the impact of previous rewards on behaviour.'

'Our results provide a potential biological explanation that bridges dopamine's function with learning in ways that better inform our understanding of both health and disease," lead author Carla Golden, a postdoctoral fellow at New York University said.

Locals said the park, which was meant to offer much-needed open space in the congested locality, has now turned into a "dumping ground" due to lack of

Another resident said the park's current state has robbed the area of its aesthetic charm. "The uneven terrain, mud patches, and dumped materials make it look shabby and uninviting. It doesn't even resemble a park anymore," he said.

maintenance by the concerned authorities. They described the once-lively park as an "ugly patch of land" now littered with waste, scrap, and debris.

A local resident said that the park has no benches, no proper pathways, and no lighting.

"It is disheartening to see such neglect at a place so close to a shrine that draws thousands of devotees.

Residents have appealed to the Srinagar Municipal Corporation (SMC) to take immediate steps to revive the park. They urged authorities to level the land, plant fresh grass, install benches, repair fencing, and ensure regular cleaning to bring back its lost charm.

Road Accident Critically Injures 7-Year-Old at Lawaypora

Srinagar: A 7-year-old girl from Zalpora in Budgam was critically injured after being hit by an unknown motorcycle at Lawaypora on Friday. The girl, identified as Zara, daughter of Mudasir Hussain Dar, was immediately shifted to JVC Hospital in Bemina, where doctors confirmed that she has suffered severe internal injuries. Her condition remains critical and she is undergoing intensive medical care.

Family members said the child was attempting to cross the road when a speeding motorcycle approached from the opposite direction and struck her without slowing down. According to them, the impact threw the girl several feet away, leaving her unconscious on the road.

Eyewitnesses told the family that the motorcyclist did not stop after the collision and fled towards the Srinagar outskirts. Locals assembled at the spot and assisted in shifting the injured child to the hospital. The family has appealed for strict action against the rider involved in the incident.

ammu and Kashmir Legislative Assembly is getting younger, as two fresh faces were voted to the house on November 14.

One retained her father's Nagrota seat, carrying forward a legacy while bringing her own perspective. Another defeated a well-known local figure by a clear margin of 4,400 votes. A third young candidate made strong gains in Budgam, earning recognition for persistent engagement with voters.

These victories reflect a growing demand for leaders who understand life on the ground.

Jobs, education, and basic services remain pressing concerns, but voters are also looking for accessibility and action. Leaders who listen, connect with daily realities, and respond to people's needs are gaining trust over names or party labels alone.

Retaining a family seat shows that tradition still matters, but energy and fresh ideas are now equally important. Winning against an established party sends a clear signal: Kashmir's electorate is open to change when it brings relevance and responsiveness.

Young leaders are clearly shaping the conversation. Their campaigns show that the valley is ready for voices attuned to immediate challenges, bridging the gap between citizens and institutions.

People are paying more attention to sincerity, engagement, and results rather than ritual and rhetoric.

For traditionalists, this is a moment to rethink strategies. Loyalty alone cannot guarantee support. The future of Kashmir politics may belong to those who combine roots with energy, heritage with engagement, and experience with responsiveness.

The new faces in the assembly do more than just add numbers. They bring renewed trust, and show that young leaders are ready to face the regional challenges.

Budgam Turns the Tide

A long-loyal constituency turned away from the National Conference, driven by anger, family politics and a sense of being left unheard.

grew up hearing that Budgam never strayed far from the National Conference

The seat carried the memory of old leaders, family ties and a sense of loyalty that moved from one generation to the next.

People often spoke of the place as if it had a natural pull toward the party. Ten out of eleven elections since 1962 had gone its way. The only exception came in 1972 when a Congress candidate won for a single term.

That history shaped the way many looked at this year's byelection. The expectation felt fixed. A surprise seemed unlikely.

The result forced a pause. The PDP candidate, Aga Syed Muntazir Mehdi, defeated NC's Aga Syed Mehmood by more than five thousand votes.

The margin shocked even those who believed Budgam was restless.

A fall from 36,000 votes polled by Omar Abdullah in the last assembly election to this loss within a year pointed to deeper cracks. The turnout told its own story as well. Half the electorate voted this time, far lower than the previous assembly poll.

Omar Abdullah had created the first shift. He contested both Budgam and Ganderbal last year and won both. His victory in Budgam was larger, but he chose to keep Ganderbal.

People in Budgam felt they had been left behind. Many told me they believed Omar Abdullah had promised to stay in the constituency that gave him more votes. He announced his decision through the Pro-tem Speaker in the assembly, and the news travelled fast.

These conversations grew louder after months passed with no MLA on the ground. The government did not hold a by-election for a full year. Budgam stayed without a voice in the house through a period that saw many local concerns

Ganderbal held its own meaning for Omar Abdullah. His grandfather Sheikh Mohammad Abdullah won here after years of detention. His father, Dr Farooq Abdullah, carried the seat through 1983, 1987 and 1996, Omar himself reclaimed it in 2008.

The emotional and symbolic weight of Ganderbal has always been clear. The choice made sense in that narrow political frame. But the sense of abandonment in Bud gam carried a different force.

For many residents, the question was direct: if more people trusted him in Budgam, why did he walk away?

That question shaped the months that followed. Roads, schools, land issues, and regular administrative matters needed attention. People expected at least visible engagement from the chief minister's office. Many hoped for frequent visits, public meetings, or instructions to district officers.

These visits did not materialize. The absence formed its own narrative.

There were other complications as well.

The new MP from Srinagar, Aga Ruhullah, represented large parts of Budgam district. Two assembly segments, Budgam and Beerwah, had been taken out of the Srinagar parliamentary seat by the delimitation commission. These two areas now fall under Baramulla, represented by Engineer Rashid, who remains in jail.

Ruhullah could not use any of his MP funds here. People read this as another sign of neglect. Conversations on village streets carried a long list of complaints and very few responses

The story inside the Shia leadership of Budgam formed another layer.

Aga Muntazir entered the by election with a strong personal base. His father, Aga Syed Hassan, heads Anjuman Sharie Shiyaan and holds deep respect in Shia communities. He stayed away from electoral politics through the years because of his association with the Hurriyat. His son stepped into the arena last year and lost to Omar Abdullah.

He won the Srinagar Lok Sabha seat last year on an NC ticket, though he has been at odds with his party leadership for months. He has spoken against the party's silence on Article 370 and other policy matters. The sharp words made him popular among young voters who often look for a direct voice.

During the byelection campaign, Ruhullah stayed away from NC rallies. His supporters campaigned for PDP's Muntazir in open view. They did this even though Ruhullah and Muntazir come from branches of the same family that have shared years of friction.

Their fathers, both sons of Aga Syed Mustaffa Al Mosavi, stood on different sides of political questions for decades.

This time the Mustafavee faction stayed together. The old disputes within the clan did not spill into the poll. Several residents I spoke with described it as a straight contest between two traditions of leadership.

The logic they gave was simple: iron cuts iron. If Budgam wanted to send a message to the ruling party, they needed a candidate who could actually win, and the only person who could do that against NC's strongest Shia figure was another Aga.

There was another young contender in the contest.

Jibran Dar contested as an independent and polled seven thousand votes. He had worked for a full year on the ground, meeting villagers, visiting homes, and handling small civic issues. Some expected him to split the vote in a way that might help NC. This expectation did not take shape.

The electorate had a clear plan. They aimed their vote at the person with the highest chance of defeating the ruling party candidate.

The final result reflects a deep er change in Budgam.

The district has seen a shift in sentiment since the removal of Article 370. Youth unemployment, land use laws, electricity shortages and long delays in basic services have shaped daily life. Trust in large parties has thinned. Local groups, religious organisations and clan dynamics have gained influence again.

The anger at losing representation for a year carried real weight. The sense that decisions were taken far away from the people added to it.

The defeat of NC in Budgam is not a single-cause story. It comes from many layered grievances: the abandoned seat, an unrepresented district, an unavailable MP, a popular young leader kept at a distance, and a rising sense that the government is speaking from a faraway place.

In the end, they looked at the candidates, their histories and the power of family networks. Their choice reflected an old Kashmiri instinct: when communities feel ignored, they pick someone who can make their anger heard.

How NC Lost it's Traditional Seat

When prepaid meters, broken promises and shifting loyalties collided, Budgam delivered a verdict few expected.

woke up at 8:30 in the morning and reached for my phone before my eyes had even adjusted to the light. My thumb opened X out of habit. The early trends were leaning toward the National Conference, I told myself these numbers never stay still in the first hour.

The cold slowed my fingers, so I placed the phone next to my pillow and slipped back under the blanket. The room felt colder than usual and I stayed in bed longer than I planned.

When I checked again, the screen pulled me awake faster than any cup of coffee. The lead had shifted.

The seat that the National Conference had held since 1977 was slipping toward the People's Democratic Party.

Only a year ago Omar Abdullah had won it by more than nine thousand votes. A seat with such history rarely changes hands in such a short time. The red flags that once dominated Budgam were giving way to green, and the wave had force behind it.

The crowds during the PDP campaign had hinted at this change. Rallies were packed with young men who didn't hide their anger at Omar Abdullah or at the party that had promised relief in daily life. Their most common demand was simple. They wanted an end to prepaid and smart meters. Their bills had climbed, and their patience had dipped.

Many told me they had voted for the National Conference in 2024 because they believed the party would stop the meters. When Omar Abdullah kept repeating the need for smart meters, even after his ear-

lier statements, the reaction was sharp. I spoke to voters on polling day and heard the same line again and again. They were tired of rising bills, tired of the way the state handled basic services and tired

of watching the government distance itself from people who asked for help.

Many remembered Omar's rallies where he said the smart meters would land in the gutters. They believed those words. They carried those words to the

The party tried to rely on the same BJP-factor that had helped them last time. The problem was that this time people had videos. Clips of NC leaders walking with senior BJP figures kept circulating on phones in Budgam.

One NC legislator even tried to warn voters about the BJP during his own campaign speech. He happened to be the same ties. PDP needed to show that the government had failed to meet expectations. NC needed to show that it was delivering something real.

The result spoke for itself. PDP used the land rights bill that NC had rejected to build a sharp message. They framed NC as a party standing close to the BJP on issues that touched land, homes, and The message stuck, people listened,

person seen in a viral clip beside a BJP leader. When his speech hit social media. the comments filled up with a single line: 'Wrong number.'

The trouble for the National Conference had started much earlier.

The rift around Aga Ruhullah created visible cracks inside the party. The approach after forming the government added more. The episode where Omar Abdullah dismissed a daily wage worker in Ganderbal stayed alive in conversations. The "aunty" remark from another

Omar Abdullah's **Budgam Gamble Backfires**

A single decision by Omar Abdullah reshaped half a century of political certainty in central Kashmir.

udgam has always seemed predictable in politics. For nearly fifty years, it stood as a loyal friend of the National Conference. Generations grew up calling it a "safe seat," a fortress immune to change. That image shattered in November 2025.

The bypoll turned Budgam into a dramatic stage for the Aga against Aga contest.

Aga Muntazir of the Peoples Democratic Party, Aga Mehmood of the National Conference, and Aga Mohsin of the BJP all stood in the same constituency, representing three different political moods.

On the surface, it could be dismissed as coincidence. Below the surface, it was a loud message: Budgam had split. And this division was not accidental.

It traces back to a political choice Omar Abdullah made last year. He contested Budgam and Ganderbal and then chose to vacate Budgam, despite winning there with more votes. The way the decision was made, the timing, and the silence that followed left voters feeling abandoned.

Budgam's voters are emotional and expect reciprocity. When Omar picked Budgam as one of his seats, they felt chosen. When he left, they felt discarded. In politics, emotion is currency. A single misstep eroded the fifty-year bond between the NC and the constituency. The three-way Aga contest was only the

visible layer of a deeper fracture.

The Agas have long shaped Budgam's politics. They carry social weight, religious authority, and community trust. This election was unprecedented: three Agas on three different platforms. Parties saw a vacuum and rushed to fill it. The NC, which relied on history and loyalty, faced a challenge to its narrative. The PDP, seeking a comeback, promised voters a representative who would stay rather than abandon them. The BJP, testing new ground in central Kashmir, offered a bold, symbolic presence.

Aga Mehmood of NC carried the weight of legacy. He tried to repair the emotional damage left by Omar's choice, but repairing trust is harder than maintaining it. Aga Muntazir of PDP turned the moment

into opportunity, appealing to voters who felt humiliated by last year's decision. Aga Mohsin of BJP represented ex-

perimentation, testing whether ideological boundaries had softened in a constituency once seen as impenetrable. Tea shops, markets, and mohallas buzzed with the same question: "Why did Omar Abdul-

lah leave Budgam after we gave him such a mandate?" No answer has satisfied the voters. In the absence of clarity, speculation became truth, and sentiment hardened. NC's grip weakened. The bypoll was less about which Aga would win and more about what it

revealed about Budgam's identity. Before results, three outcomes were imagined. An NC win would be clear but weak. A PDP win would mark a revival. A strong BJP showing would signal a larger political shift

than vote counts could show. One thing was certain: Budgam was no longer a safe seat. It had become a battleground of wounded pride, confused loyalty, and political experimentation.

The lesson is simple: voters in Jammu and Kashmir remember when they feel overlooked. Omar's choice may not have been meant to hurt, but perception matters as much as intent.

When people feel used and discarded, the consequences arrive eventually. Budgam has delivered that emotional bill.

The Soft War Inside the Kashmiri Home

The emotional map of the Kashmiri home shifts after marriage, and the sister must face the fault lines alone.

ashmiri families work like small constellations. Several generations often live under one roof, sharing food, laughter, and the small disagreements that come and go like weather.

The home becomes a space where emotions move around freely, where loyalty and love are constantly weighed and rearranged.

At the center of this everyday universe stand three figures: the son, his wife, and his sister.

The sister, the Zaam, is the groom's closest companion. Her role grows out of years of care. Her presence shapes rituals, family gatherings, and all the small, unspoken understandings that hold a home together.

She supports her brother, steadies her parents, plans celebrations, and eases tension before it turns into trouble. She becomes the glue that keeps the family balanced.

Marriage changes this balance. The son steps into his new life as a husband. A bride arrives, confident and hopeful, and slowly becomes the new center of the home.

The son shifts his focus toward her. He grows attentive, thoughtful, and eager to match her needs. He opens doors, buys small gifts, and shapes his days around her comfort.

His mother looks at him differently, and his sister's words no longer carry the same weight. Only the bride rises in importance.

The Zaam starts to fade into the background. She speaks, and people hear something else. She smiles, and someone reads it the wrong way. She moves around the house carefully, knowing her presence can be twisted into a problem.

Religion does not justify this imbalance. Islam asks for fairness, tenderness, and balance in every family bond. A son must care for his parents, honour his siblings, and love his wife. There is no permission to ration compassion or divide

The gap comes from tradition, habit, and a warped idea of masculinity. It is shaped by hierarchy. And the Zaam carries the burden

of these distortions. Her life becomes an ongoing negotiation. If she speaks with confidence, she is accused of upsetting the peace. If she speaks softly, she disappears from the conversation.

She keeps the home steady. She smooths tensions. She protects her brother's name. She works in ways no one counts, and receives the blame for what she never caused.

She moves with care, adjusting her words, steps, and presence to boundaries she never agreed to but must face every day.

The tragedy is that families celebrate loyalty and unity. They talk proudly about devotion. But they forget the women who have held these values up all their lives.

The Zaam lives inside a paradox. She is needed but unseen, praised but exhausted, cherished but suspected.

Her story reveals how affection shrinks when shaped by hierarchy,

and how marriage rearranges love in ways that leave some women standing at the margins.

Education before marriage can shift the ground. Every Kashmiri man can learn that a mother is not a helper, a sister is not a threat, and love is not a limited resource.

He can learn that a home runs on shared labour and shared regard, and that dignity and affection must extend to every woman under the same roof.

The Zaam deserves care, respect, and a sense of justice. She is not a rival. She is a daughter of the house, a sister who gives without measure, and steadies the family.

Acknowledging her changes everything. It brings balance back into the home. It turns loyalty into truth. It makes devotion real instead of ceremonial.

Kashmiri families overflow with affection. They honour tradition, cherish kinship, and carry rituals with grace. They pour tea with tenderness and keep ties alive across generations.

But they risk losing their own warmth when they fail to see the women who hold these

Real devotion to family, faith, and life begins with how we treat the ones within arm's reach, not with public performances of love.

The Zaam carries the past and the present, along with expectations she never agreed to shoulder.

Her life mirrors the culture around her: love rearranged by custom, devotion handed out unevenly, and tenderness shaped by hierarchy.

To honour her is to honour the home itself. To truly see her is to understand the Kashmiri family in all its beauty and its contradictions.

The Backbench Shift Begins in Kashmir

The backbenchers were never aimless. They were the first to see the cracks in our education system.

Shahzaib Al-Qudsi

grew up thinking classrooms had all the answers I would ever need. At home, my parents talked about education with the same faith people often give to prayer. The smell of chalk felt like progress, and the morning bell always sounded like a door opening to something bigger.

I held on to these beliefs for a long time, until the system began to feel different.

Slowly, I started noticing how the pressure of marks filled every room I sat in. The walls seemed to echo it.

The change didn't happen all at once. It showed itself slowly. I would sit behind my desk and watch my classmates stare at the blackboard with eyes that had lost their spark. Their faces looked tired, even when they didn't say a word.

Teachers assumed we were distracted. The truth is, we were trying to breathe through a kind of pressure we didn't yet have the words for.

For many students in Kashmir, marks decide whether we feel proud or ashamed. I have watched friends break down because they missed a cutoff by a few points. I have seen families fall into stress after a single mid-term result. In every coaching centre I went to, the fear in the room felt heavier than the books we carried.

The race for marks swallowed our natural desire to learn. We memorised

ing as if it were a survival test.

The NEET 2024 scandal made all of this even clearer to me. When the news of the leaks spread, it felt like a mask had finally dropped. People whispered about bribes and backdoor deals. Many of us felt angry, but under that anger was a kind of understand-

I knew students who cheated because they thought they had no other choice. Their actions came from panic. The system had pushed them into believing that failure was the end of everything.
Through all of this, I found myself

drifting toward the back row. Teachers often joked about backbenchers. Some even scolded us for choosing those seats. In their minds, the front rows were meant to shine and the back rows were meant to fade. But in those last seats, I discovered

a different world. The backbenchers were not careless. They were alert in a way most people didn't notice. They were thinking, observing, and trying to survive the system in their own way.

Some wrote poems in their notebooks. Some sketched whole landscapes when the lecture stopped making sense. Others stared out of the window and wondered how the world outside had anything to do with the chapters we memorised. Many of them understood the cracks in the system long before I did.



our silence had its own thoughts. People saw us as indifferent students, but that wasn't true. We were trying to protect the small spark inside us, the spark the system kept pressing down.

Over time, I began reading about how pressure shapes the mind. Psychologists call it learned helplessness, when people start believing they have no control over their lives. Many Kashmiri students live inside that feeling. One low score can convince you that you are a failure.

I felt it in myself every exam season. My hands trembled before I even opened the answer sheet. My sense of worth seemed tied to those numbers printed in blue ink.

Families across the valley still spend large amounts on coaching centres. They want safety for their children, and I understand that. We all do. But I have also sat with friends who whispered about burnout or cried because

they no longer recognised their own The pressure sits between genera-

tions. It shapes how we speak, study, and imagine our futures.

The backbenchers taught me something important. They never let go of their dreams. They questioned lessons that felt empty. They showed me that learning can survive outside the tight circle of marks. Many of them later became artists, thinkers, engineers, and storytellers.

Their strength came from the small freedom they carried inside themselves and refused to lose.

When I think about the future of education in Kashmir, my mind goes back to my own classroom. I can still see the chalk dust on the blackboard, hear the teacher's voice fading around the edges, and watch the sunlight falling gently across the last row. I picture the backbenchers leaning toward each other, sharing ideas in silent voices.

Their refusal to let numbers define them felt like a small uprising. It reminded me that learning is alive. It needs room to move and breathe. Students need spaces where questions are welcome. They need teachers who listen. And they need a system that values imagination as much as accu-

I believe change will begin in small moments. A student will look up from a textbook and allow himself to think for a while. Another will ask a question that breaks the silence. Someone else will finally gather the courage to say she feels trapped.

These small acts will create a slow shift, the same way all real change be-

PDP Breaches NC's

Bharativa Janata Party (BJP) cruised to a com-

manding victory in Nagrota.

Opposition PDP candidate Aga Syed Muntazir defeated ruling NC nominee Aga Syed Mehmood by 4,478 votes, securing 21,576 votes against Mehmood's 17,098, according to

the Election Commission of India (ECI). The BJP's Aga Syed Mohsin fared poorly in the Shia-dominated segment, finishing sixth

with 2,619 votes. Budgam recorded a voter turnout of 50.01% of its 1.26 lakh electorate — slightly lower than the 52.27% turnout in last year's Assembly

The bypoll was necessitated after Chief Minister Omar Abdullah vacated the Budgam seat last year and chose to retain his family bastion of Ganderbal.

Muntazir, a law graduate from Amity University, New Delhi, had contested the 2023-24 assembly polls as well, losing to CM Omar by over 18,000 votes. This time, the political calculus worked in his favour.

Muntazir's election marks a historic shift in central Kashmir politics. It is the first time since 1977 that the NC has lost the Budgam seat while being in the fray. The party had won every election in the segment except in 1972, when it boycotted the polls.

The NC's rout is widely attributed to the absence of senior Shia leader and Srinagar MP Aga Ruhullah Mehdi, who stayed away from campaigning due to his differences with the party leadership over issues including reservation policy and the dilution of NC's stand on Article 370.

Despite Chief Minister Abdullah camping in the constituency for three days with ministers, MLAs and senior leaders, the ruling party could not halt the PDP's surge.

PDP chief Mehbooba Mufti led an energetic campaign assisted by party MLAs Waheed Para, Mohammad Fayaz and Mohammad Rafiq Naik.

Muntazir – son of prominent cleric and former separatist Aga Syed Hassan – joined mainstream politics in August 2024 after completing his post-graduation in law from Amity University. He had earlier contested the 2024 Assembly polls, losing to Abdullah by over 18.000 votes.

His win on Friday raises the PDP's strength in the 90-member Jammu and Kashmir Assembly

BIP Sweeps Nagrota With Massive Margin In Nagrota, the BJP comfortably retained

the seat as 30-year-old Devyani Rana secured 42,350 votes, defeating JKNPP president Harsh Dev Singh (17,703 votes) by a staggering 24,647-vote margin.

NC's Shamim Begum finished third with 10.872 votes

The bypoll witnessed an enthusiastic turnout of over 75%.

The election was held following the death of Devyani's father and sitting MLA Devender Singh Rana, a prominent BJP figure in Jammu. Contesting her first election, Devyani capitalised on her father's legacy and the party's organisational strength in the region.

Celebrating her victory, she said she was "blessed with the same love the people gave Rana Sahab in 2024," and dedicated the win to her father. Devyani, an economics graduate from the University of California who manages her family's media and automobile businesses, said she intends to bring a "fresh, professional approach" to politics.

Nagrota has alternated between the BJP and NC over the last five Assembly elections since 1996. This time, the Congress neither fielded a candidate nor formally supported the NC campaign despite being its alliance partner at the

would undertake a thorough internal review of its defeats in Budgam and Nagrota.

Speaking to reporters on the sidelines of an official function, Omar said Ruhullah's decision to stay away from campaigning had lasting consequences.

"There is an English proverb — you cut your nose to spite your face. Whatever message he wanted to send to me is one thing, but politically he has taken a suicidal step," Omar said. "The person who won the seat from there will never allow him to rise again."

The chief minister said that while he personally could recover from political losses, Ruhullah's prospects in Budgam had become deeply uncertain.

Budgam, long considered an NC stronghold, was lost to PDP's Aga Syed Muntazir Mehdi in a rare setback for the party. Omar, who had earlier won both Budgam and Ganderbal in the 2024 elections and later vacated Budgam, said the people had chosen differently despite the

"We contested the election to win, but the people of Budgam wanted something else. We wanted to ensure progress and a close working relationship with the government for the next four years. But the people of Budgam wanted something else," he said.

He noted that a "large section" of voters in the constituency cast their ballots based on personal preference rather than issues.

Omar said NC president Farooq Abdullah would convene a working committee meeting to analyse the party's performance in Budgam and Nagrota, identify shortcomings and initiate corrective measures both within the party and the administration.

Commenting on the Bihar election results, Omar said expectations from the Congress had been "inflated" due to its recent "vote theft yatra," which made seat-sharing discussions more difficult. suppressed the material facts and thus, petition filed by them be dismissed with exem-

The Government Advocate produced copy of suit already filed by the petitioners before Trial Court involving the same subject matter.

"Thus, due to petitioners' failure to come to the Court with clean hands, this Court is not inclined to venture into the merits of the case," a bench of Justice Wasim Sadiq Nargal, holding the petition as "misconceived, false, frivolous and liable to be dismissed."

Referring to Apex Court's judgment, the Bench said that when a party suppresses mate-

rial facts, it renders the proceedings a nullity. It is the duty of every litigant to disclose all material facts as withholding material facts from the Court not only undermines the process of justice but is also violation of the principle of "coming to the Court with Clean Hands," the court noted.

"Since the petitioners have approached this Court by concealment of the facts, therefore, it is a fit case where costs are required to be imposed upon the petitioners," the court said, burdened them with costs of Rs. 20,000 to be deposited in the Advocate's Welfare Fund within two weeks.

"The costs have been imposed upon the petitioners with a sole object to deter such unscrupulous persons to approach this Court with unclean hands, who try to mislead this Court,"

Deregistration from the IMR and NMR bars the four doctors from practising medicine anywhere in India. They cannot prescribe medication, offer clinical care, or serve in any government or private healthcare institution until the registration is reinstated.

The notice was issued from NMC headquarters in Dwarka and signed by Rajiv Sharma, Secretary In-Charge, Ethics Board.

Mehbooba stressed that while strict action is necessary, it must follow due legal process. "Amit Shah had said the law will take its own course. We also want strict action but it must be according to the law. Creating fear and carrying out crackdowns on innocent families is unjust and should not happen," she said.

She added that many families across the Valley were in panic due to the ongoing raids, urging authorities to ensure that investigations do not violate constitutional rights.

10% of J&K People Suffering **From Diabetes, Say Doctors**

octors on Friday said that around 10 per cent of people in Jammu and Kashmir are suffering from diabetes, and approximately 15 per cent are in the pre-diabetes stage, with the number increasing each day.

Doctors said that almost one in ten persons in J&K has diabetes-like conditions, while more than 15 in 100 people are in the pre-diabetes stage.

Dr Saleem Iqbal said the world is shrinking into a global village and that we have more facilities available at our fingertips. "Eventually, the simplicity of life has been lost in this progress," he remarked. He added, "The progress is important, but we must understand that it shouldn't be in such a way that the deleterious effects outweigh the benefits of that progress."

Regarding dietary habits, Dr Iqbal said, "Once we start consuming ultra-processed foods, high-calorie foods, and sugary drinks, it leads to an increase in diabetes, especially in developing countries like India." All patients must understand that exercise and a balanced diet are essential, the doctor said. "We need to teach youngsters the importance of complete health, and that will only be possible once we ourselves take up the challenge of remaining fit and healthy," he added.

According to KNO, the Kashmir & Ladakh Report (July 2023 - January 2024) of the ICMR INDIAB study, conducted under the leadership of Prof M. Ashraf Ganie, reports on the prevalence of diabetes, prediabetes, obesity, hypertension, and dyslipidemia in a representative sample of adults from both urban and rural areas of the union territory.

The study aims to identify region-wise and state-wise differences in these NCDs using robust sampling and diagnostic methods, thereby helping to assess the current status of the epidemic and its likely future trajectory.

According to the report, 7.8 per cent of the population has diabetes, of whom 5.4 per cent are aware of their condition, while 2.4 per cent are unaware. The study also indicates that 10.5 per cent of people are in the prediabetes stage, 30 per cent are hypertensive, and 57.6 per cent are obese. (Observer News Service)

CS Launches Single Window System for Recruitment Rules

Commending the ARI & Trainings Department and BISAG-N for developing the platform in a timebound manner, he urged them to initiate work on a similar digital system for conducting Departmental Promotion Committees (DPCs), with integrated hosting of employee seniority lists to ensure timely promotions and prevent administrative delays.

Speaking at the launch, Commissioner Secretary, ARI & Trainings Department, ShabnamKamili, highlighted that the newly launched Single Window System will significantly streamline the entire Recruitment Rules lifecycle by making each stage digitally traceable.

She said the platform brings clarity, accountability, and standardization into recruitment-related decision-making and is expected to substantially reduce delays, minimize litigation, and ensure timely career progression for employees across all cadres. IAMMU: Leader of Opposition in Jammu and Kashmir Legislative Assembly, Sunil Sharma on Friday said that the election results in Nagrota and Budgam clearly reflect the public's verdict against "nepotism, corruption and family-driven politics" in Jammu and Kashmir.

No Discussion At All: SA Not Complaining About 'Bauna' Remark At Temba Bavuma

KOLKATA: South Africa batting coach Ashwell Prince on Friday played down the stump-mic chatter involving Indian pacer Jasprit Bumrah and wicketkeeper Rishabh Pant, saying the visitors will have "no discussion" around the incident during the opening day's play in the first Test at the Eden Gardens.

The exchange happened on the last ball of the 13th over in South Africa's innings when at 62/2, a leg-before appeal from Bumrah against Proteas captain Temba Bavuma was turned down.

During the conversation about whether to take the DRS, the stump mic picked up Bumrah saying, "bauna bhi hai," a remark many interpreted as a taunt at Bavuma's height.



Prince, however, distanced the team from any such controversy during the interaction after the opening day's proceedings.

"No, there will be no discussion. It's the first time, obviously, it's come to my attention. I don't think there'll be any issues with

what's happened out in the middle," Prince said.

Bavuma, returning to lead the Test side after recovering from a calf strain, had a brief and forgettable outing as he was dismissed for 3 off 11 balls by Kuldeep Yadav via a leg-slip trap.

The injury had earlier forced him to miss the start of South Africa's World Test Championship title defence against Pakistan.

The incident unfolded when Bumrah angled a good-length delivery back into Bavuma, struck him on the thigh pad and the pacer, who returned with five wickets, went with a huge appeal only for the umpire to reject it.

Pant felt it was going over and the replays later confirmed the ball would have missed the

stumps.

monly used for those suffering from dwarfism, but its usage for someone who is simply short in height can be viewed as offensive.

South Africa, however, are not lodging any complaint.

Meanwhile, Bumrah turned a rare four-spinner gamble into his personal stage, producing a mesmerising exhibition of seam, swing and control as India skittled out South Africa for 159 on the opening day of the first Test on Friday.
