Doctor, Wife Detained In **CIK Raids**

Counter Intelligence Kashmir (CIK) on Tuesday detained a doctor and his wife for their alleged involvement in unlawful

In a statement, a CIK spokes-person said, "The Counter Intelligence Kashmir today conducted coordinated search operations at four locations across Srinagar, Kulgam and Anantnag

However, the officials said the searches are not linked to the "white collar" terror module or the Delhi blast case.

"During the operation, two accused: Shahzada Akhtar, wife of Dr Umer Farooq Bhat of Bugam Kulgam and presently residing at Shireen Bagh Srinagar, with her husband Dr Umer Farooq Bhat, who is presently working in Super Speciality of SMHS Hospital.. Srinagar were detained," he said, adding, "The CIK teams seized multiple digital devices and incriminating material having direct relevance to the investigation.

The recoveries include five mobile phones, five SIM cards, one tablet | More on P6

Cloudflare Outage Disrupts Major Platforms

Srinagar: A widespread internet outage struck several global digital platforms on Tuesday, leaving millions of users unable to access services like X, OpenAl's ChatGPT, Perplexity Al, Google Cloud, and Canva.

Kashmir Observer was also affected, as its services briefly went down during the disruption.

Popular gaming titles League of Legends and Valorant were also impacted.

The disruption has been traced back to a critical network failure at Cloudflare, a web infrastructure company that powers a significant portion of the internet.

"Cloudflare is experiencing an internal service degradation. Some services may be intermittently impacted. We are focused on restoring service. We will update as we are able to remediate. More updates to follow shortly," Cloudflare's system status | More on P6

Moscow: India on Tuesday said that the world must display "zero tolerance" towards terrorism in all its forms and manifestations, that there can be no justification, no looking away and "no whitewashing"

"As India has demonstrated, we have the right to defend our people against terrorism, and will exercise it," External Affairs Minister Jaishankar said in his address at the Shanghai Cooperation Organisation (SCO) Council of Heads of Government meeting

No Major Snowfall Till Dec 15: Weatherman

Srinagar: Meteorologist Sonam Lotus on Tuesday said that Jammu and Kashmir is unlikely to witness any major snowfall until December 15, as the region continues to remain under a prolonged dry spell.

Lotus said the weather across J&K will stay dry and stable through the end of November. However, he cautioned that temperatures are set to dip further in the coming days, intensifying the ongoing cold wave, especially in the Valley.

"It will remain dry and clear," Lotus said. "But the cold will intensify in the mornings and evenings. The minimum temperature may go down further possibly touching minus

ened its grip across Kashmir. Calm nights and clear skies have pushed temperatures down sharply, making early mornings particularly harsh. Residents have begun stocking up on heating gadgets and winter supplies, while frost formation has increased in several higher reaches over the past few days.

Lotus added that while light snowfall is possible after mid-December, there is no forecast of any significant or widespread snowfall in December. He noted that long-range predictions remain uncertain, but current weather data shows no strong Western Disturbance approaching the region in the coming weeks.

Lotus, known for his mostly accurate local weather forecasts, has earlier warned about extended dry spells in Jammu and Kashmir.

Man Gets 6-Yr Jail In 2021 **Shopian Encounter Case**

Srinagar: A special NIA and UAPA court for Kulgam and Shopian has sentenced Towseef Ahmed Thokar of Khawajapora Reban, Zainapora, to six years' imprisonment after finding him guilty in the 2021 Imam Sahab encounter case. The case was initially registered under FIR No. 25 of 2021 at Police Station Imam Sahab.

The court held Towseef offences under

Sections 16, 18 and 20 of the Unlawful Activities Prevention Act (UAPA), Section 307 of the IPC, and Sections 7 and 27 of the Arms Act. Sentencing was scheduled for November 17, after which the punishment was formally announced.

The case relates to an encounter on May 5, 2021, in Imam Sahab, where three militants - Danish Ahmed Mir, Zahid Bashir and Umar Hassan Bhat – were killed. Towseef was detained from I More on P6

Govt Warns Channels Against Sensitive, Inciteful Content

Srinagar: The Ministry of Information and Broadcasting on Tuesday issued an advisory to all private television channels, cautioning them against telecasting visuals or content that could aid, abet, or promote unlawful activities.

The advisory comes after certain TV channels aired material related to the recent blast near Delhi's Red Fort, including videos showing methods of making explosive devices. The explosion, which occurred last week, left several people dead.

"It has come to the notice



of this Ministry that some news channels have been broadcasting content related to alleged persons involved in the Red Fort blasts, justifying their acts of violence, as well as information videos of how to make explosive material," the advisory said.

'High BP Cases In Children, Teens **Doubled In Last 20 Years'**

Prevalence of hypertension or high blood pressure among children and teenagers has nearly doubled in the last two decades, from 3.2 per cent in 2000 to over six per cent in 2020, according to a global analysis published in The Lancet Child and Adolescent Health journal.

Left unaddressed, hypertension can lead to cardiovascular and kidney dis-

Estimates also suggest that nearly a fifth of the world's children and adolescents with obesity have hypertension -- about eight times the prevalence among those having a healthy weight (2.4 per cent), researchers including those from the UK's University of Edinburgh said.

The findings suggest obesity is a substantial driver of the increase in childhood hypertension. Obesity tends to cause other issues, such as insulin resistance and changes in blood vessels, which can make it harder to maintain a healthy blood pressure.

Further, eight per cent of children and teenagers around the world may be having pre-hypertension, which is a warning sign of hypertension, the study found.

"The nearly twofold increase in childhood high blood pressure over 20 vears should raise alarm bells for healthcare providers and caregivers,"



said study author Igor Rudan, director of the centre for global health research at The Usher Institute, University of Edinburgh (UK).

"But the good news is that we can take steps now, such as improving screening and prevention efforts, to help control high blood pressure in children and reduce the risks of additional health complications in the future," Rudan said.

The meta-analysis looked at data from 96 previously published studies, involving more than 443,000 children and across 21 countries.

"Between 2000 and 2020, the prevalence of childhood hypertension nearly doubled, increasing from 3.40 per cent to 6.53 per cent in boys and from

3.02 per cent to 5.82 per cent in girls," the authors wrote.

The study also found that more than nine per cent of children and adolescents the world over may have masked hypertension -- which is high blood pressure that only shows up in outof-office tests and therefore could be undetected during regular checkups. How blood pressure is measured can affect prevalence estimates, the researchers said.

For example, when confirmed by a healthcare provider at a minimum of three in-office visits, the global prevalence of hypertension was estimated at 4.3 per cent of children and adolescents. However, when the researchers also included out-of-office assessments

such as home blood pressure monitoring, the prevalence of sustained hypertension climbed to about 6.7 per cent. "Childhood high blood pressure is more common than previously thought, and relying solely on traditional in-office blood pressure readings likely underestimates the true prevalence or leads to misdiagnosis of hypertension in children and adolescents," said study author Peige Song of the Zhejiang University School of Medicine in China.

"Early detection and (an) improved access to prevention and treatment options are more critical than ever to identify children experiencing or at-risk for hypertension. Addressing childhood hypertension now is vital to prevent future health complications as children transition to adulthood," Song said.

Pre-hypertension is especially prevalent during teenage, with prevalence reaching around 11.8 per cent, compared to about seven per cent in younger children, the researchers found.

Blood pressure also tends to increase sharply during early adolescence, peaking around age 14, especially among boys, they said.

The pattern emphasises the importance of regular blood pressure screening during critical years, the team added.

Court Convicts Man in Rs 7.20 Lakh Cheque **Bounce Case**

Srinagar: A Srinagar court has convicted a man in a cheque bounce case and sentenced him to six months of simple imprisonment besides imposing a fine of Rs 7.20 lakh along with six percent annual interest. The order was passed by the Court of the 4th Additional Munsiff and Judicial Magistrate First Class Srinagar in a complaint filed under Section 138 of the Negotiable Instruments Act.

The case was initiated by complainant Ishfaq Rashid, who stated that he had provided financial assistance of Rs 7.20 lakh to accused Showkat Ahmad Zargar of Dangerpora Tulmulla for business purposes. The accused allegedly failed to return the amount despite repeated reminders and later issued a cheque to settle the liability.

According to the court record, the cheque bearing No. 387870 was presented on June 12, 2023, at J&K Bank N S Road Srinagar but was returned unpaid for insufficient funds. A demand notice was issued to the accused on July 3, 2023, which he received but did not respond to or comply with.

During the proceedings, the accused admitted to issuing the cheque, writing the amount on it and owing Rs 7.20 lakh to the complainant. The court held that these admissions attracted statutory presumptions under Sections 118 and 139 of the NI Act and that the accused had failed to rebut them through credible evidence.

18-Year-Old Regains Life **After SKIMS Spine Surgery**

Srinagar: In a remarkable medical feat, doctors at the Sher-i-Kashmir Institute of Medical Sciences (SKIMS) have successfully performed a marathon 11-hour surgery to remove a rare holocord intramedullary spinal cord tumour in an 18-year-old girl, one of the most complex spinal surgeries ever performed in the region.

The entire procedure was carried out free of cost, a statement issued to Kashmir Observer.

The surgery involved 17-level laminoplasty followed by the delicate removal of a tumour from within the spinal cord (intramedullary), a technically demanding procedure rarely attempted even in leading neurosurgical centres.

The operation was led by Dr. Abrar Ahad Wani, Professor & Head of Unit, Department of Neurosurgery, along with his dedicated surgical team.

A New Silence in Kashmir

ashmir has always leaned on community for strength. People gathered over warm meals, traded stories in living rooms, supported each other in difficult times and created space for comfort. This season feels different.

Weddings stay crowded, funerals draw lines of people and markets stay active. But the mood inside these gatherings tells a different truth.

Conversations fade, people arrive late and leave early, and faces look tired even in celebration.

A social freeze is visibly settling over the valley. It shows up in homes, courtyards and public spaces. Years of stress feed it. Families deal with rising medical bills, winter expenses and coaching fees. Young people carry pressure from studies, long commutes and uncertain work.

These strains show up in everyday life. People talk

in short bursts, stay distant and lose energy quickly. Friends who once met every weekend now meet only when schedules align. Neighbours who shared long tea breaks now settle for a polite nod. Phone calls that carried long conversations shrink into short messages. Even family gatherings feel heavier, as if everyone is present but half-absent in thought.

Counsellors say many people they meet speak of "social exhaustion" as their biggest concern. They feel drained by screens, constant updates and a sense of uncertainty. Family events feel heavier than before, and many look for a reason to step out early.

This new fatigue shapes how Kashmir connects. Money pressure adds to it. Weddings feel harder for families who juggle costs. Guests sense this strain and find it difficult to celebrate.

The same pattern appears at funerals. People show up out of duty, speak little and leave with a heavy heart.

This freeze in social life carries long-term risks. A community loses strength when people reach out less. Children grow up in homes where adults speak little. Elders feel alone even inside full rooms. Young people drift away from festivals and family traditions.

Kashmir needs a gentle renewal. It can begin with longer conversations, shared meals, small circles of support, and spaces where eople feel free to speak.

These moments rebuild trust and remind people that community lifts instead of weighing them down.

A simple update in your Demat account can save your family from long queues, legal knots, and years of uncertainty.

growing number of young people in Kashmir are investing in ETFs, REITs, shares and mutual funds. It signals a shift in how families here think about savings. A Demat account sits at the centre of this shift. Still, many investors overlook one of its most basic safeguards: the nominee.

Families often run from one office to another when a loved one passes away. Property papers, bank accounts and insurance claims take months to settle. Investments held in a Demat account follow the same path unless a nominee is already named. A nominee makes the transfer smooth and protects the family from conflict. It also gives clear direction to institutions that need proof before they release assets.

Many accounts in Kashmir remain incomplete. Some lack updated bank details, which blocks dividend transfers. When dividends remain unclaimed for eight years, they move to the Investor Education and Protection Fund, and the recovery process can stretch for months. A simple check of your 16-digit bank account number can prevent this loss.

Mutual fund investors face similar gaps. People who use RTAs often forget to update nominations for each folio. Every folio needs a clear nominee, or the family will need to produce multiple documents during transfer. It turns a difficult moment into a heavier burden.

A Demat account grows stronger with small acts of attention. Review your nominee every few years. Update your bank information. Ask your advisor to scan your folios.

These steps may look routine, but they carry real weight.

The Case of Empty Desks

Attendance is Kashmir's first education challenge, and it demands more empathy than enforcement.

ow attendance in schools often looks like a simple case of missing students. A teacher marks the register, counts the empty seats, and moves on with the lesson.

The National Education Policy 2020 does not fix a specific attendance bar for students to sit in exams. It leaves the number open, and does something more important.

It asks schools and families to understand why a child stays home in the first place.

This shift matters for Kashmir, where thin attendance has shaped the lives of students for decades.

Notably, attendance across India falls short of what a healthy learning system needs. Studies show a worrying pattern.

In many rural districts, between 4.73 and 17.84 percent of students in primary and upper primary classes stay absent almost every day.

Another nationwide review found that attendance has been stuck around 72 percent for years even though enrolment touches 98 percent.

Delhi offers its own sharp picture. In the 2022-23 school year, more than 3.48 lakh students in government schools were tagged "chronically absent." A year later, the count rose to more than 6.6 lakh.

Kashmir has its own story inside these numbers.

Attendance thins for reasons tied to life at home, distance from school, and the way classrooms function.

The result is the same everywhere: lost learning, weaker confidence, and habits that travel into adulthood.

Poverty often keeps children out of school. In many parts of the valley, kids take on adult responsibilities earlier than expected. Families running orchards, farms, shops, or small businesses rely heavily on their voungest members.

A child might help sort fruit, tend to livestock, or cover for a parent working long hours. A daughter may stay home to care for younger siblings, while a son might take seasonal work to support the family.

Each day missed may seem small at the time, but over months, those absences pile up into a gap that becomes hard to recover.

Some students do not come from difficult homes. Their struggle begins in their company.

Teenage life brings confusion, stress, and a search for belonging. A group that treats school as an inconvenience can shape a student's choices. Wandering markets, skipping classes, or scrolling through phones in parks look harmless. These habits form a loop that keeps children at the edge of school life instead of at its center.

Parents and teachers often see



ality well. A room with broken windows, a toilet without water, or a teacher who teaches with fear instead of trust weakens the bond between a child and the school.

A lurking cane, a harsh tone. or a lesson delivered without care tells the child they do not belong here. Learning, in such spaces, be-

comes a burden. Girls face an added layer of concern.

In several far-flung areas, schools run without a single female teacher. Parents hesitate to send their daughters across long distances when they feel the environment is unsafe or insensitive.

This hesitation grows in hilly hamlets where most students are girls and support systems are thin. A simple step, posting a trained

female teacher, can change the trajectory of dozens of lives. Kashmir cannot ignore this

when it aspires to build an educated generation of daughters.

Child psychology plays a crucial role in all of this.

A teacher who understands a child's fears, hopes, and limits can change attendance more effectively than any rule. The American psychologist B.F. Skinner once said, "Give me a child, and I will shape him into anything.

This line carries weight in classrooms where teachers engage with children as individuals instead of rows of roll numbers.

A trained teacher plans lessons that feel reachable. He makes space for questions, and sees the child before the syllabus. Attendance follows naturally.

In some communities of Jammu and Kashmir, attendance dips every summer for cultural reasons

Gujjar and Bakerwal families move to high meadows, taking their herds along. Children join the migration because the animals need care. They miss weeks of schooling during the most active academic months. This is a longrooted tradition.

Any solution must respect their way of life while offering flexible learning support.

Addressing low attendance requires steady work. Parents must hear clearly why every missed day matters. Monthly parentteacher meetings, already part of the school system, offer a space for these conversations.

Teachers can go further by speaking to families about a child's progress with honesty and warmth. A child shows up for a teacher who sees them, remembers their struggles, and checks on them when they fall behind.

Communication inside school also matters. A friendly teacher-student relationship encourages children to talk about what holds them back: fear of a subject, bullying, family pressure, or simple confusion.

Schools can set up complaint corners where students drop notes when they cannot speak openly. A committee of teachers, students, and parents can review these concerns and close the loop in a fair way.

When children feel heard, attendance rises on its own.

Kashmir classrooms can turn this around. The valley has a long tradition of valuing learning. Families invest in tutors, celebrate exam results, and take pride in educated children.

Low attendance disrupts this culture from within.

Fixing it means giving every child a school that feels safe, meaningful, and human.

And that type of school keeps its seats full.

Low attendance

lean public washrooms are hard to find in the valley, and that may be why many people choose to wait a little longer. Students sit through classes in discomfort. Workers in orchards and shops delay restroom breaks. Travellers hold it in during traffic jams and long queues. The habit looks harmless, though the body responds differently.

The bladder only stores urine for a short time. When people ignore the urge again and again, the system strains. Doctors across Kashmir see rising cases of urinary tract infections, bladder issues, and kidney complications. Young women, office goers, students, and elderly men with prostate problems form the largest group of patients. Many say the trouble began because they delayed urinating during work hours

A full bladder is a warm space. Urine that sits too long gives bacteria more time to grow. This is why urinary infections are common among

women, though men face similar risks. A single infection can disturb daily life through fever and burning sensations. Repeated infections force people to skip work or college and make frequent hospital visits.

These patterns play out in clinics across Srinagar, Anantnag, Baramulla, Sopore, and Kupwara.

The bladder is a strong muscle that works well when treated with care. Stretching it beyond capacity weakens it over time. People who hold urine often eventually struggle to empty the bladder fully. They experience frequent urges, leakage, or discomfort even after using the bathroom. It affects confidence, sleep, and routine activities.

The kidneys, which work silently to remove waste from the blood. depend on a healthy bladder. When the bladder stays too full, pressure can push urine back toward the kidneys. This can harm kidney tissue. Kashmir already sees a high burden of kidney stones and other renal diseases. Holding urine is one of the

small but important factors behind this rise. Pain is another clear sign. People

working long shifts in fields, offices, or shops often report lower abdominal cramps or back pain. Many do not link this pain to a full bladder. The strain builds slowly and appears as aches that come and go. These become part of daily life until a doctor points out the root cause

Older men in Kashmir deal with an added challenge. Prostate enlargement is common after a certain age. Delaying urination puts more pressure on the bladder and reduces the flow. Many elderly men speak of discomfort during winter months or during long prayers when they try to wait longer.

A simple habit can prevent these problems. Empty the bladder every three to four hours or whenever the urge appears. Drink enough water through the day. Reduce caffeine and fizzy drinks. Strengthen pelvic muscles through basic exercises. These steps may look small, though

they protect long-term health and improve comfort. Many men ask whether sitting

or standing is better for urination. Young and healthy men can choose either position. Men with weak flow or prostate issues benefit from sitting because it helps the bladder empty completely. Women empty the bladder best in a sitting or squatting position

Bladder health rarely finds space in our public conversations. People talk about blood pressure, sugar, diet, and fitness. Urinary health stays unnoticed, even though it affects daily comfort and long-term well-being.

A full bladder is a message from the body. Responding on time is a simple act of care that protects health, improves focus, and strengthens quality of life.

anuary light filtered weakly through the frost as we packed our Alto 800 for the journey to

My wife suggested we drive ourselves, promising comfort I was not entirely sure we would find.

Four passengers, two children, and my mother made the car feel smaller than it was.

Arshad, six, bounced with excitement, asking about monkeys. Sarah followed, quieter, her wide eyes fixed on the road ahead.

Their laughter turned the cramped cabin into a warm space, a shield against the chill outside.

The Srinagar-Jammu highway is both beauty and test. Mountains lean over gorges, hairpin turns demand attention, and winter fog can steal visibility without warning.

I had never driven this stretch. The thought pressed on me, small and insistent. Sarah sensed it and asked if we would reach safely.

I held her hand and said, "Inshallah, beta, we will," feeling both the weight and the fragility of that promise.

By seven, the car was loaded. The rooftop carrier sagged under blankets, clothes, and our small comforts, tied tightly with ropes I had checked twice. Inside, a flask of steaming noon chai offered warmth. I had inspected brakes, tires, and oil. Everything seemed ready, but the load above me whis-

OSHNARI, Anantnag — High on a hill in South Kashmir's Shangus region, the government middle school here buzzes with a life that once seemed impos-

In 2009, only five girls attended classes here. Dropouts were common. Families, struggling with poverty and illiteracy, often saw school as an optional burden.

Riyaz Ahmad Sheikh arrived that year.

A young teacher with resolve, he began walking through homes, talking to parents, and listening.

He asked why children, especially girls, were missing

Slowly, he built trust. And slowly, families began to see that education could matter. Today, the school has 67 girls enrolled.

Riyaz's efforts have shifted the village's attitude toward learning.

The young educator's approach extends beyond textbooks. He treats a school as a shared project, one that de-

He forged links with the Chief Education Office, Rural Development, Tourism, Public Health Engineering, and

the Deputy Commissioner's office to bring resources.

Former Deputy Commissioner K.K. Sidha installed projectors, a public address system, and digital teaching aids. The current DC, Dr. Syed Fakhrudin Hamid, added smart TVs, new pavements, and upgraded classrooms.

Riyaz's work balances grassroots outreach with institutional support, a rare combination in government schools.

In 2023, he received the National Teacher Award from President Droupadi Murmu and spoke in New Delhi with Prime Minister Narendra Modi and Education Minister Dharmendra Pradhan about the school's transformation.

Walking through the campus, it is clear why the school feels different.

Walls and floors are alive with lessons. Numbers, letters, science diagrams, and cultural motifs are painted across every surface, a concept known as Building as a Learning Aid.

Children learn as they move through the school, absorbing lessons without

The open library invites students to browse and read. ence books, and storytelling

A corner dedicated to science lets students explore experiments and ideas on their own. In the mathematics corner, children handle three-dimensional models and charts, turning abstract numbers into playful puzzles.

Two other spaces reflect Riyaz's holistic approach.

The Heritage Corner showcases local crafts and traditions, giving students a sense of identity. The Hygiene Corner teaches self-care, stocked with soap, toothpaste, and lotions.

A small Honesty Box reinforces integrity: students deposit items that do not belong to them, practicing honesty daily.

The young Kashmiri teacher's work offers a model for rural education in India. The school has become a place where children learn skills, values, and self-respect. But challenges remain.

Rising enrollment demands additional classrooms, more teachers, and modern learning tools. The educator's vision risks being constrained by resources.

Iran Suspends Visa-free Entry For Indians; Here's Why

New Delhi: Iran has suspended visa-free entry for Indian nationals starting November 22, 2025, after a spike in human trafficking, fake job rackets and kidnapping incidents involving Indians who were lured to the country under the guise of employment or onward travel to third nations. The move marks a major rollback of a facility Iran had introduced in February 2024 to boost tourism.

The decision comes amid mounting concerns from both Tehran and New Delhi over organised criminal networks misusing the visa waiver to traffic Indians-many of whom ended up abducted for ransom.

Embassy in New Delhi and India's Ministry of External Affairs (MEA), dozens of Indian nationals were duped by unauthorised agents who promised lucrative jobs or assured them that Iran would merely be a "transit point" en route to Europe, Australia or Central Asia. Instead, many victims were

dicates and held in illegal

running into millions of rupees. spokesperson Randhir Jaiswal recently confirmed that several Indians were "lured on false promises" and then "kidnapped upon arrival in Iran", prompting urgent diplomatic interventions.

"The one-way tourist visa cancellation regulations for Indian nationals have been suspended as of 22nd November 2025. From this date, Indian nationals with ordinary passports will be required to obtain a visa to enter or transit through Iran."

The suspension covers both entry and transit, meaning travellers can no longer even fly via Tehran without a valid visa.

India issues a strong advisory Following the announcement, the Indian government issued a detailed travel advisory, warning citizens against:

agents offering visa-free travel to Iran, job offers without verified contracts, and promises of onward transit to third countries through Iranian airports.

The MEA said its attention had been drawn to multiple recent kidnappings, adding that some families were forced to pay large ransoms to secure the release of their relatives.

The advisory stressed that Iran's visa-free access was only meant for tourism, restricted to 15 days once every six months, and never permitted employment.

Airlines told to tighten checks Airlines operating flights to Iran have now been instructed to strictly verify visa compliance before boarding. Passengers who fail to show valid visas risk being denied boarding, detention upon arrival, or immediate deportation at their own expense.

Recent cases spark bilateral concern

A series of high-profile trafficking cases, particularly involving youth from Punjab, Haryana, and Uttar Pradesh, set In one instance, three Indian youths attempting an illegal route toward Australia were kidnapped soon after reaching Iran. They were rescued only after urgent diplomatic intervention.

Officials say the trafficking networks operate through a chain of illegal agents in India, middlemen in the Gulf, and criminal syndicates inside Iran. Tourism hopes derailed

Iran introduced the visa waiver in 2024 to encourage Indian tourists to visit historic destinations such as Isfahan, Shiraz, Qom and Mashhad, and

to attract budget travellers using the country as a transit hub for Central Asia. But the facility's misuse for illegal migration and trafficking

forced authorities to shut it down.

What travellers need to know

Effective November 22, 2025: Visa-free entry for Indians stands suspended.

A valid visa is mandatory for both entry and transit.

Employment-related el must undergo stringent

verification. Travellers must avoid unauthorised or unregistered recruit-

ment agents. The MEA concluded with a firm warning:

"All Indian nationals intending to visit Iran are strongly advised to remain vigilant and avoid agents offering visa-free travel or onward transit to third countries via Iran."

With the suspension in place, authorities on both sides hope to curb trafficking networks and prevent further exploitation of Indian citizens abroad.

"Interestingly, Dr. Umer Farooq, who is a government employee, was found indulging in online unlawful activities, misusing his official position and social legitimacy to engage in behavior detrimental to public order and national security. Subsequently, during the course of the investigation, it has also emerged that the detained individuals were misusing their positions and social standing to mask unlawful activities," the spokesman said, adding, "The female suspect, Shahzada Akhtar, in particular, is alleged to have been involved in radicalizing local women through curated online and offline engagements, pushing divisive narratives, and influencing vulnerable groups under the pretext of community interaction.

Her affiliation with banned terrorist organization 'Dukhtaran-e-Milat', is currently under investigation. This dimension of the case highlights a concerning trend of the exploitation of social roles and professional facades to advance disruptive agendas."

"All recovered devices are undergoing detailed forensic analysis, which is expected to unravel a broader digital network linked to organized propaganda efforts. Early leads indicate the possibility of a wider ecosystem of collaborators and sympathizers, whose activities were aimed at amplifying extremist content and manipulating public perception," he added.

The spokesman said; "Searches were conducted on the warrants issued by the Hon'ble Designated Court under the NIA Act, Srinagar, in connection with FIR No. 05/2025 under Sections 196, 152, 351(2) of the Bharatiya Nyaya Sanhita (BNS) and Section 13 of the Unlawful Activities (Prevention) Act, Police Station CIK."

These searches are part of an ongoing crackdown against social media abusers operating in connivance with handlers across the border. who have been deliberately engaged in furthering terrorist, secessionist, and separatist agendas. By leveraging their professional status and societal standing, the involved individuals were allegedly using social media platforms to spread disinformation, radicalize youth, incite violence and disturb public order, posing a serious threat to the peace and sovereignty of the Union of India," he said, adding, "This operation sends a clear and unambiguous message: No individual, irrespective of position or profession, will be allowed to weaponize social or digital influence to aid terrorism or disturb public order."

"The CIK remains resolute in its mission to dismantle the terror ecosystem, including its operators, facilitators, sympathizers, promoters, and propagators. The crackdown continues, and more actions are expected as the investigation unfolds," the spokesman said.

A resident of Qazigund in Anantnag, Jasir was arrested in Srinagar on Monday for allegedly providing technical support for carrying out terror attacks by modifying drones and attempting to make rockets ahead of the bomb blast, the agency said in a statement.

In a statement on Monday, the NIA termed Wani an active co-conspirator behind the attack, who worked closely with the terrorist, Umar un Nabi, to plan the "terror carnage."

On Monday, the court remanded Amir Rashid Ali, a key accused in the case, to NIA custody for 10 days.

The agency had told the court that Amir allegedly arranged a safe house and provided logistical support to Nabi.

Notably, the investigations and the DNA test had revealed that a doctor from South Kashmir's Pulwama district Dr Umar Mohammad carried out a suicide attack near Red Fort on November 10 by blowing off the i20. In the blast more than ten people were killed.

A few days before the blast, J&K, Haryana and UP Police had recovered a major cache of explosives, nearly 2,900 kg during a raid in Faridabad. Initially two Kashmiri-origin doctors were detained from Al Falah University in connection with that operation. "Dr Umar was associated with those arrested and may have gone ahead with the attack fearing imminent arrest." an official had said.

On November 14, the National Medical Commission (NMC) removed four doctors from the Indian Medical Register (IMR) and National Medical Register (NMR) with immediate effect following their involvement in a case registered under the Unlawful Activities (Prevention) Act (UAPA).

The doctors removed includes Dr. Muzaffar Ahmad (Reg. No. 14680/2017), Dr. Adeel Ahmad Rather (Reg. No. 15892/2019), Dr. Muzamil Shakeel (Reg. No. 15130/2018), and Dr. Shaheen Saeed (Reg. No. 45961/2022).

The Jammu & Kashmir Medical Council had already cancelled the registrations of Dr. Ahmad, Dr. Rather, and Dr. Shakeel based on evidence shared by investigating agencies.

Dr. Saeed, registered with the Uttar Pradesh Medical Council, was removed through a separate NMC order. The removal followed FIR No. 162/2025, lodged at Nowgam Police Station in Srinagar on October 19, under multiple sections of the UAPA, including provisions relating to unlawful activities, terrorist acts, raising funds, recruitment, and harbouring.

The NMC said the conduct of the doctors was "prima facie inconsistent with the standards of ethical propriety, integrity and public trust" required under the Indian Medical Council (Professional Conduct, Etiquette and Ethics)

The order states that the four individuals "shall cease to practice medicine or hold any medical appointment till further orders". All State Medical Councils have been instructed to enforce the directive.

site showed, identifying the problem as a "global network issue" causing widespread API and dashboard failures.

Outage tracking website Downdetector saw a massive spike in reports, logging over 10,000 complaints for various service disruptions before the site itself struggled to load – ironically, also becoming a victim of the Cloudflare

As screens went blank, users flocked to the few surviving platforms, such as Reddit and Threads, to vent their frustration and crack jokes about the "internet meltdown"

"My entire staff portal and sites are using Cloudflare, so everything is down," a netizen said, while another took a dig at how the outage happened just after maintenance.

'Cloudflare being down, and almost all of my most visited websites and mobile banking also being down with them, means that it's probably not smart for these companies to put all of their cybersecurity eggs in one basket," another user quipped.

Cloudflare CTO Dane Knecht took to social media to address the widespread outage that disrupted services across the internet.

Cloudflare, which describes itself as "one of the world's largest networks", acknowledged the disruption and issued an apology.

Knecht said, "I won't mince words: earlier today we failed our customers and the broader Internet when a problem in @Cloudflare network impacted large amounts of traffic that rely on us. "They did not wait for a phone call... saw the blast through their window, took out their ambulances, and reached the spot before anyone else, and took the injured from there. Many of the injured are in their hospital, four are in ICU I hope all of them get well and go home," he

Asked about providing compensation to the families of the victims, the chief minister sad the government has already announced exgratia from the CM's relief fund.

"For the structural damage, I have talked to the MLAs, a case is being prepared and whatever we can give according to the procedure, we will, and the rest, because the blast took place in the police station, it is hoped that these house owners should get relief from the funds available with the Home Department and with the LG," he said.

Asked if the government will provide a job to the family of the tailor, Mohammad Shafi Parray, who lost his life in the blast, Omar said his kin should get the job.

"There used to be SRO (Statutory Rules and Orders) for such cases, now its name has been changed, but the scheme is the same. A government job is provided as compensation to the families of those killed in such incidents. I will tell the government officers to process the case for the tailor's family and as soon as it comes to us, we will approve it," the CM added.

Nine people -- five personnel from the police department and four civilians -- were killed, and 32 others sustained injuries in an accidental blast in Nowgam police station.

During his visit to the hospital, the Chief Minister reviewed the medical condition of the injured and interacted with the doctors and attendants

Calling for the best possible treatment, he said, "Every injured individual must receive the utmost care. Their wellbeing is our immediate

Unvented Gas Heaters Can Be Deadly, Doctors Warn

SRINAGAR: Health professionals in Kashmir have issued a strong advisory against the use of unvented gas heaters in closed and poorly ventilated rooms, cautioning that such devices can lead to severe health complications and even death due to carbon monoxide (CO) poisoning.

Speaking to KNO, Dr Zahoor Wani, a senior doctor at the Directorate of Health Services Kashmir (DHSK), said that unvented heaters burn fuel inside the room without a chimney or outlet for harmful gases. This results in the gradual accumulation of toxic substances-particularly carbon monoxide.

"Unvented gas heaters release combustion byproducts directly into the room. When

carbon monoxide builds up beyond a certain level, individuals are at high risk of CO poisoning, especially while sleeping," he explained. He stressed that the safest solution is to avoid these heaters altogether and opt for vented models that channel emissions outside the home.

Dr Wani warned that if residents continue using unvented heaters, they must avoid operating them in bedrooms, bathrooms, or any confined area. "Such heaters should only be used in spaces with sufficient airflow. Using them at night in closed rooms is extremely dangerous," he said.

The doctor described carbon monoxide as particularly dangerous because it gives no warning signs. "You cannot smell it, see it, or taste it. It renders a person helpless without them realising it," he said. "Most vic-



tims lose consciousness quietly during sleep, making it especially deadly.'

derly individuals, pregnant women, and people with chronic illnesses are more susceptible to poisoning even at lower concentrations.

Another medical expert, Dr Shahid Khan, highlighted the physical indicators and early symptoms of suffocation and CO exposure. "People may experience headaches, dizziness, nausea, and confusion in the initial stages. If exposure continues, it can lead to fainting and eventually death," he said.

Dr Khan added that in cases of severe suffocation, medical examinations may reveal petechial haemorrhages—tiny red or purple spots in the eyes, face, and lungs-indicating oxygen deprivation."As the victim struggles to breathe, foamy mucus can accumulate in the airways," he noted.

Other symptoms he listed include difficulty breathing, slow heart rate, hoarseness, sore throat, disorientation, nosebleeds, and visual disturbances.

After Recent Surge, Dengue **Cases Show Steady Decline**

SRINAGAR: After weeks of rising dengue infections across Jammu and Kashmir, health authorities have reported the first signs of decline. However, with 3,248 confirmed cases recorded so far, officials have cautioned that the situation still demands strict preventive efforts from the public.

According to official data accessed, the Jammu division remains at the forefront of the outbreak, reporting 1.384 cases, followed by Kathua with 862, Samba with 459, and Udhampur with 172. Smaller but notable numbers have emerged from Reasi (70), Rajouri (69), Poonch (28), Doda (74), Ramban (43) and Kishtwar (15).

In Kashmir, 31 cases have been confirmed, while 41 infections were detected in individuals from outside

Health officials told KNO that 26,980 dengue tests have been conducted across Jammu and Kashmir to date. "Only 49 patients required hospital admission, and 46 have been discharged, which is a positive sign," an official said, adding that one J&K resident died at DMC Ludhiana due to complications linked to the infection.

Experts reiterated that dengue remains a preventable but potentially serious disease, stressing that no specialised vaccine or antiviral medication is currently available in India.

"The only effective way to break transmission chain is to ensure mosquitoes do not breed. Stagnant water anywhere, even in small amounts, becomes

a breeding ground," an official said. Medical professionals explained that the Aedes aegypti mosquito thrives in everyday household objects. "Even a little clean water collected in pots, tyres, buckets, lids, bottles or tubs is enough for mosquitoes to mul-

tiply," they said. They advised people to use mosquito repellents regularly, wear long-sleeved clothing, keep water tanks and containers tightly sealed, and install window screens or mosquito nets even during daytime hours when dengue mosquitoes are most active.

"These mosquitoes bite mostly early in the morning and late in the afternoon, so precautions during these hours are particularly important,"

Doctors said people should seek immediate medical attention if they notice danger signs, such as persistent vomiting, abdominal pain, bleeding from the nose or gums, blood in vomit or stools, extreme fatigue, or unexplained restlessness, all of which may indicate severe dengue.

Notably, dengue was almost unheard of in the region a decade ago, with just two infections reported in 2009 and zero cases in 2010.

With the disease still circulating, officials have once again urged the public to maintain strict preventive measures. "People should regularly inspect their homes, shops, and surroundings. Eliminating stagnant water is the most powerful tool we have they said

The authorities said that collective efforts from neighbourhoods, community groups, institutions, and local bodies will be crucial in bringing down the case numbers further—(KNO)

NGT Presses J&K Officials on **Delayed Poonch Waste Removal**

SRINAGAR: A stretch near the Sher-e-Kashmir Bridge in Poonch holds nearly 90,000 metric tons of legacy waste. The mound has grown over the years and stands only a short distance from the river.

On Tuesday, the National Green Tribunal reviewed the case and asked officials for firmer answers on how soon the site will be cleared and whether the planned bio-mining facility sits inside the floodplain

J&K Power Demand May **Surge 50% in a Decade**

SRINAGAR: While the power sector continues to function with 'decades old infrastructure', Jammu and Kashmir is likely to witness growth in power demand by nearly 50 percent in a decade. According to the official

documents available, authorities have projected that Jammu and Kashmir will likely have an extra power demand by 49.42 percent by the year 2034-35.

The official further clarified that the peak demand will be more than the average growth saying that the region may likely witness an increase in power demand by 6 percent each year from 2025-26 to 2034-2035.

Stating the year wise growth rate in power demand, authorities have said that in the year Jammu and Kashmir will likely have a five percent extra demand in the year 2025-26 followed by four percent in the year 2026-27, four percent in 2027-28, three percent in 2028-29.

It also said that in the year 2029-30, the region may experience growth

five percent followed by four percent in 2030-31, four percent in 2031-32, three percent in 2032-33, five percent in 2033-34 and four percent in the year 2034-35 respectively.

"Peak and Energy Demand for the UT of J&K and Ladakh has been taken as per the projections provided by the UT department. The Demand estimation by J&K was higher than projected by 20th Electric Power Survey of India (EPS). Therefore, the studies have been carried out using projections given by the J&K UT department," it reads.

According to KNO, the documents further reveal that the future demand profile for the year 2034-35 has been projected using the demand profile of J&K for the year 2022-23 as the base profile. "The actual solar generation profiles and CUFs have been taken

as provided by J&K." It also said that according to the data provided by J&K, an additional 392 MW of Coal (Shakti Scheme), 620 MW of solar and 1206 MW of hydro is planned till 2030.

Dardpora Lolab **Residents Forced to Drink Contaminated Water**

SRINAGAR: Despite the government's repeated assurances of providing safe drinking water across Jammu and Kashmir, the remote hamlet of Dardpora Lolab in north Kashmir continues to grapple with acute water scarcity and contaminated supplies, placing its vulnerable population—including the elderly and children—at serious health risk.

Local residents told KNO that, despite the establishment of a vital water supply project under the Jal Jeevan Mission (JJM), their village remains deprived of clean water. "We have approached the concerned offices on multiple occasions, but our grievances continue to fall on deaf ears," the inhabitants lamented.

According to the villagers, the little water that does reach them is so dirty and muddy that "even animals would refuse to drink it." They also revealed that the main water tank in the area is left uncovered, allowing monkeys and other animals to drink from it, further contaminating the water that is later supplied to homes. This, residents say, has led to a rise in waterborne illnesses in the community.

The residents of Dardpora Lolab and nearby hamlets have urgently appealed to authorities for intervention. They claim that while water

from the JJM project has been supplied to distant areas, their own locality was neglected. Instead, water is channeled to them via a pipe running through an open drain, past a small, uncovered bank, leaving it exposed to contamination by rats, monkeys, and other animals.

"We have provided video evidence of these appalling conditions, but no action has been taken so far," the locals said, adding that the area has been without potable water for the last two months. While some farmers from outside the area manage to bring water for irrigation, residents themselves remain deprived of clean drinking water.

Repeated complaints to the Project Implementation Unit (PIU) and even written submissions over the past four months have yielded no results, with officials citing the need for higher approval before taking any action. "Officials keep making excuses and refuse to take responsibility," the residents alleged.

Now, the villagers are urging senior government officials to visit the area, verify their claims firsthand, and end their ordeal. "If our complaints are unfounded, we will accept responsibilitybut if they are true, our misery must come to an end," the residents said, renewing their call for the immediate provision of clean water to Dardpora Lolab.

Educated Youth Getting Radicalised Alarming: Bukhari

pni Party President Altaf Bukhari on Tuesday voiced serious concern over the growing trend of educated youth being drawn towards radicalisation and terror-related activities, calling it an "alarming development" that warrants urgent and honest introspection.

"Authorities must investigate why even welleducated youth are being influenced to join terrorist activities," Bukhari said while addressing a press conference in Srinagar, as per KNO.

He said this trend poses a serious challenge and requires a comprehensive evaluation by all stakeholders.

Bukhari reiterated his party's firm opposition to all forms of violence, saying that those found guilty must face the law, but also cautioned that innocent individuals should not be harassed in the name of counterterrorism measures."

Expressing sorrow over the 'accidental blast at Nowgam Police Station' near Srinagar, the Apni Party chief urged the government to provide proper compensation to the families of the deceased and to those whose homes and properties were damaged in the explosion.

"We convey our heartfelt sympathies to the families who lost their loved ones in the Nowgam incident. The victims whose properties were affected must be adequately compensated," he said.

Reading a detailed resolution passed in the party's day-long working committee meeting held at the party office in Srinagar, the Apni Party president said the party expressed deep concern over the recent Delhi car blast and the alleged involvement of well-educated individuals in the incident. KU's e-Gov Portal Back Online After 270 Days

rinagar: Days after highlighting the prolonged shutdown of the University of Kashmir's e-Governance portal, dubbed by students as "Digital Hell", the portal has finally been restored, bringing an end to nearly "nine months (around 270 days)" of frustration and offline workarounds.

Students confirmed to KNO that the portal (https://egov.uok.edu.in/eConduct/) was now accessible publicly, marking the first time since early February that services such as registration, admit card downloads and fee payments could be done online. "It is finally working! We had lost hope after months of inconvenience.," said a relieved B.Tech student.

Last week, it was reported that the University's e-Gov portal, intended to streamline access to vital academic services had remained locked behind the University's internal Intranet, forcing thousands of students to physically visit college IT cells for routine tasks.

The report, which triggered a wave of student reactions across social media, appears to have prompted quick action from the University's IT division. Jammu Police to Launch Portal

Oolice in Jammu will soon launch a dedicated web portal to streamline tenant verification and reduce the need for people to visit police stations, a senior official said on Tuesday. Senior Superintendent of Police (SSP) Jammu,

Joginder Singh, said the current manual system requires every tenant and landlord to physically visit the police station, which often causes inconvenience. "We are working to remove this physical contact. A user-friendly tenant verification portal is being developed and will be launched soon,"

He said that once active, neither the tenant nor the landlord will need to come to the police station. "Verification forms can be submitted online, and the police will carry out the verification.'

The SSP also said that verification of employees by shopkeepers and employers is mandatory under the orders of the Deputy Commissioner. "Every shopkeeper or employer must ensure

verification of their workers. This is compulsory." he said. He clarified that the verification drive is a routine, year-round process, not something triggered by any recent incident. 'Verification continues throughout the year,

under which we routinely check and verify individuals," he said. (PTI)

Bike-lifting Racket Busted in

olice has busted a major two-wheeler theft racket and recovered 40 stolen motorcycles and scooters worth over Rs 35 lakh from various parts of the city, officials said.

Another Weekend, Another Pole For Kashmiri F1 Racer Atiqa Mir

ABU DHABI: Formula 1 Academy-backed Indian racer Atiqa Mir showed scorching speed for her second pole position in as many weeks before picking up a Heat win in Round 2 of the RMC UAE Karting Championship here.

After a pole and podium finish in the Formula 1-backed COTFA series last week, Atiqa switched seamlessly into a different equipment to set blistering pace at the Al Forsan Circuit. She is the first Indian to be supported by Formula 1.

In the Official Practice sessions, Atiqa topped three out of the four sessions and clocked the fastest time of the day in a highly competitive field of international drivers. She was the only female.

Atiga, who turned 11 last week, carried that form into qualifying, clinching pole position in the dying minutes of the



session with a sizzling time of 60.686 seconds.

Representing Akcel GP, she led from the front in the Heat race for a deserving victory. She lost the lead briefly on Lap 1 before regaining it soon after and pull-ing away from the field of 18

In the pre-final race, Atiqa suffered a big crash while fighting for the lead on the last lap, injuring her elbow.

Her determination and fighting spirit came to the fore when she drove the final lap with the injury and a broken kart. After making up five places on the opening lap, Atiqa's kart developed a technical problem, forcing an early retirement.

"What could have been a dominant weekend ended back in the pits. But that is racing, we are racing so close to each other at such high speeds that crashes are bound to happen.

"I got a hard hit on my elbow and it is bruised quite badly. I wanted to fight and get back to the front in the final but it wasn't meant to be as my panel broke and due to that I couldn't drive," said Atiqa.

Her father and former Formula Asia Vice Champion Asif Mir said luck was not on her daughter's side this weekend but at the same time, called the collision part of racing.

"A dominant show by her, a slight touch with another kart changed her entire weekend. She deserved a better result but that is how it goes sometimes in sport. She is driving at a high level week in and week out in different karting championships.

"She has to switch engines, tyres almost every weekend and she is able to adjust well," said Asif.
