

Over 80% Of Indians With Disabilities Lack Health Insurance: NGO White Paper

ore than 80 per cent of Indians with disabilities remain uninsured, and over half of those who apply are often rejected without explanation despite legal safeguards meant to ensure equal access to health coverage, a new white paper released on Thursday has found.

The report, titled "Inclusive Health Coverage for All: Disability, Discrimination and Health Insurance in India", was launched by the National Centre for Promotion of Employment for Disabled People (NCPEDP) at a roundta-ble attended by policymakers, insurers, and disability rights advocates.

Drawing on a nationwide survey of over 5,000 persons with disabilities across 34 states and union territories, the study warns that "deep systemic inequities" continue to block nearly 16 crore disabled Indians from both public and private insurance schemes. According to the findings, 80 per cent of respondents had no health insurance, while 53 per cent of those who applied said their applications were rejected.

Many reported being turned away solely because of their disability or pre-existing conditions, with particularly high denial rates among persons with autism, psychosocial and intellectual disabilities, and blood disorders such as thalassemia.

The report noted that these practices persist despite constitutional protections, the Rights of Persons with Disabilities Act, 2016, and repeated directives from the Insurance Regulatory and Development Authority of India (IRDAI). Researchers also flagged unafford-

able premiums, inaccessible digital platforms, and a widespread lack of awareness about available schemes as major barriers to coverage. Speaking at the launch, Manmeet



Nanda, Additional Secretary, Ministry of Social Justice and Empowerment, said the government was working to strengthen assistive technology and improve coordination across minis-

"IRDAI's role, along with the Ministry of Health and Family Welfare and the Department of Empowerment of Persons with Disabilities, needs to be very strongly converged and coordinated because this is not a single ministry's game," she said, adding that insurers could be mandated to meet annual disability coverage targets monitored through digital dashboards.

She also offered to integrate the Unique Disability ID database with insurance processes to track rejections and streamline access.

Calling the findings a "moral and constitutional challenge", NCPEDP Executive Director Arman Ali said the continued exclusion of persons with disabilities from affordable insurance "is more than a systemic failure; it is a violation of rights".

"Even as the government expands Ayushman Bharat (PM-JAY) to cover all senior citizens aged 70 and above, persons with disabilities remain conspicuously excluded despite facing equal, if not greater, health vulnerabilities." Ali said.

There is no principled or policy justification for this gap... India cannot be burdened with the generational 'cost of exclusion' of people with disabilities," he added.

The white paper recommended immediate inclusion of all persons with disabilities under Ayushman Bharat without age or income criteria, aligning with the government's 2024 expansion for senior citizens.

Other key proposals include enhanced insurance coverage for mental health. rehabilitation and assistive technologies, the creation of a dedicated Disability Inclusion Committee within IRDAI, standardised and non-discriminatory premiums across private insurers, and mandatory accessibility in all insurance processes.

It also urged expanded awareness programmes for insurers and healthcare staff to ensure disability-sensitive service delivery.

Kashmir Needs Platforms

any young Kashmiri entrepreneurs are creating smart, original products that can easily stand on global shelves. They make herbal blends, craft tools, design software, and develop services rooted in local skills.

But most of their work stays hidden, limited to small workshops or social media pages.

The main issue is the absence of platforms. A founder may spend years perfecting a product and still have no clear path to reach customers outside the valley. Without strong marketing support, distribution networks, or collaborations, many promising ideas never grow beyond a familiar circle of buyers.

At the same time, global brands are taking over local markets. Kashmiri bazaars are now full of products promoted across India. Shopkeepers prefer them because these brands are well-known and sell quickly.

Even online, searches for items traditionally made in Kashmir often show national and international companies first, instead of the people who create these products here.

This creates an uneven playing field. A local entrepreneur may offer something of equal or better quality than a big brand, but without visibility, his work goes unnoticed.

The idea of "vocal for local," once meant to support homegrown businesses, is slowly losing ground.

This gap weakens the dream of a strong startup ecosystem in Jammu and Kashmir. If we want innovation to thrive, we need platforms that feature local makers, policies that make it easier for young founders to grow, and partnerships that help them reach wider markets.

The national push to support local products applies here too. Kashmir has hundreds of young builders ready to innovate and compete. They simply ask for guidance, fair chances, and a place to showcase their work to the world.

Kashmir does not have to reject global products. But it must raise its own talent with equal energy.

If the region wants a vibrant startup culture, it should begin by trusting its own creators and giving them the support they need to shine.

Kashmir Eyes Better Returns

A shift from property pride to smarter financial choices can reshape household wealth in the valley.

or many Kashmiri families, real estate remains the first choice for investment. Elders still urge everyone to buy land whenever possible. The idea feels safe and rooted in tradition. But the financial landscape today pushes investors to look again and consider new options.

Property still offers emotional value. Families recall homes in Delhi that rose in price and created stability. But the numbers today are less convincing.

Rental yields in major cities stay close to 2 to 3 per cent a year. Maintenance bills take away more value. Returns once touched high double digits in a few pockets. Growth slowed after the 2014 floods as many localities struggled to deliver steady gains. Selling a property can take months and legal processes add delays.

Market-linked products present a stronger case. The Nifty 50 has averaged about 12 per cent CAGR across thirty years. Leading flexi-cap mutual funds have delivered close to 15 per cent over two decades with simpler taxation and easy liquidity.

These products work without high commissions, legal hurdles, or long waiting periods. Only 7 per cent of Indians invest in such instruments. Kashmir's share stays below 1 per cent due to mistrust and poor awareness.

The preference for real estate is more psychological than financial. Property feels stable and markets feel risky, though long-term data suggests the opposite. A mutual fund can be sold in minutes. A flat may take a year to find a buyer. Investors need to study costs, track real returns after inflation, and choose products with low charges.

Kashmir once relied on land, gold, and fixed deposits. Today the region can access national and global markets with ease. Wealth grows when learning grows. A balanced, flexible approach offers younger generations a clearer path to financial strength.

Supreme Court directives spark structured intervention in Kashmir to balance public safety with animal welfare.

ashmir mornings start with a sense of worry. Children head to school with extra care. Shopkeepers keep an eye on the lanes outside their stores. Even a short visit to a hospital can

Behind this caution is a growing stray dog population across Jammu & Kashmir that has changed the way people move through public spaces.

Thousands of bite cases in recent years have stretched hospitals, worried families, and pushed people to ask for firm action.

This month, the Government of Jammu & Kashmir issued an extensive order to address the problem systematically, creating committees at both the Union Territory and district levels.

The move follows directions from the Supreme Court, which has flagged the threat stray dogs pose to children in particular and urged states to adopt scientifically proven and humane measures to control populations.

For the first time in years, there is a sense that administration, judiciary, and communities are approaching the issue with aligned seriousness.

At the heart of the new strategy is a Union Territory-level committee, chaired by senior bureaucrats from diverse sectors: Health, Education, Housing, Public Works, Transport, Sports, Rural Development, and Law.

Representatives from national bodies like the Animal Welfare Board and the NHAI are also included, reflecting a multi-departmental, whole-of-government approach.

Housing & Urban Development acts as the nodal authority, responsible for tracking progress, ensuring compliance with the 2023 Animal Birth Control (Dog) Rules, and reporting to the Supreme Court.

Sterilisation and vaccination form only one part of the plan. Officials also have to secure public institutions, including schools, hospitals, playgrounds, transport points and other busy areas, against stray dog intrusions.

In Srinagar, several spots near hospitals, markets, and tourist areas have turned into dog hotspots, largely because of scattered food waste. The administration wants to reduce these risks by identifying such zones, cutting access to food waste, and keeping a closer

watch across public and private institutions. At the district level, committees headed by Deputy Commissioners will coordinate with Municipal Commissioners, police officers, and departmental heads. Their responsibili-

ties include inspecting public spaces, arrang-

ing fencing or gates where needed, and ensuring stray dogs are sterilised, vaccinated, and moved to shelters. Feeding will be regulated through designated spots to discourage random street feeding while ensuring animals receive con-

trolled care. Public awareness is another important part of the plan. Schools and hospitals will run sessions on safe behaviour around animals, how to respond to bites, and why quick report

stretched during peak tourist seasons, will now work alongside hospitals that are required to keep steady stocks of anti-rabies vaccines and immunoglobulin.

Waste management, often overlooked in discussions about stray animals, is central to the new system. Improper disposal at markets, schools, or transport hubs can sustain dog populations regardless of sterilisation drives.

The government order mandates strict waste protocols and regular monitoring to complement other interventions.

Coordinated highway patrols will also ensure that stray dogs and livestock do not disrupt traffic or create accidents, illustrating the administration's intention to protect both human and animal life.

Monthly progress reports from district committees, including covering sterilisation, vaccination, sheltering, inspections, and awareness campaigns, will feed into UT-level assessments, forming a structured compliance record for the Supreme Court.

The scale and ambition of this initiative mark a departure from piecemeal measures

effort offers relief to parents anxious about their children, commuters wary of daily routes, and healthcare workers burdened with bite cases.

It also signals a larger shift: that urban safety can be strengthened without sidelining animal welfare, and that collaborative governance can tackle challenges that affect everyday life in deeply tangible ways.

The next few months will reveal whether these committees can translate policy into action, and whether Srinagar and Jammu can reclaim public spaces from the threat that has lurked too long in plain sight.

An Open Letter to Omar Abdullah on the Future of J&K Students

Honourable Chief Minister,

write with a simple concern that many of us in Jammu and Kashmir talk about in private. Our Leducation system is slipping into a cycle of ceremonies while students struggle with real learning and teachers feel increasingly sidelined.

Your warning about the mushrooming of colleges struck a chord. The rush to approve 50 degree colleges in 2019 happened without planning or accountability. Many of those institutions still run with low enrollment, weak facilities, and almost no permanent staff. Students and teachers carry the burden of decisions made in haste.

The transfer system tells a similar story. The ATD Portal, introduced in 2023 as a step toward transparency, has been pushed aside for manual transfers. Teachers feel tossed around from one posting to another without fairness or clarity. This goes against the spirit of a digital India.

Meanwhile, the world is changing fast. AI can now write, analyze, and organise information in seconds. This means teachers have to guide students to think clearly, ask better questions, and solve real problems. Creativity and critical thinking count more than memorising facts. Teachers can take on this role only when they get the support they need.

Many colleges do not even have basic staff like sweepers or chowkidars. Others rely heavily on Local Fund Employees whose wages swallow money meant for student services. Smaller colleges suffer while larger ones carry an imbalance. The system feels stretched in all directions.

Teachers need steady training in new technology, help in pursuing higher studies, and a clear path for promotions. A teacher who never gets a chance to learn cannot prepare students for the future. Career stagnation is pushing many bright educators into frustration.

Another challenge sits right in front of us. The administration has become obsessed with events. Seminars, parades, and cultural shows happen one after another. These activities have value although they have overtaken the real work of teaching. A stage gets ready faster than a laboratory. This says everything about our priorities.

This drift feeds our unemployment crisis. Thousands of students graduate with outdated degrees that the modern job market does not value. They walk into the world with paper boats in a rising storm. Reforming old courses and building skill-based learning is an urgent need, not an optional exercise.

Honourable Chief Minister, you have the authority to shift this course. The staged receptions during official visits hide the daily struggles inside classrooms. The truth lives in the eyes of a teacher waiting for a fair posting and a student unsure of what lies beyond graduation.

Jammu and Kashmir can rebuild its education system with focus and courage. The future is moving fast. Our classrooms must move with it.

Ancient Wisdom for Modern Kashmir

Amid anxiety and social pressures, two forgotten Islamic practices offer Kashmiri youth practical and spiritual guidance for life beyond home.

ife in Kashmir has grown heavier over the years. Economic uncertainty, political tension, and social expectations touch every part of daily life. For young people, even stepping out of the valley for studies or work at times feels risky.

After the recent Delhi suicide attack, I saw friends hesitate and reconsider journeys that once seemed simple. Profiling, stereotyping, and suspicion have become routine. Fear now shapes decisions that used to depend on ambition or

From my perspective as someone who studies society, this feels like what Émile Durkheim called excessive regulation.


When expectations, scrutiny, and moral pressures pile up, people shrink under the weight. I see young Kashmiris caught between performing perfectly for others and avoiding misjudgment.

Families, once sources of warmth, drift into routine. Friendships weaken, community bonds strain, and anxiety grows silently in homes and streets.

Some young people I know shrink their own worlds, choosing what to do, where to go, and even what to dream based on fear.

I have often thought about how Islam addresses such moments.

I think of my own life and of the young Kashmiris I meet, and I realize how often a conversation with someone trusted could prevent rash decisions.

Leaving the valley for studies, work, or migration should never come from fear. It should come from careful consultation and reflection. Istikharah completes this pro-

When human advice reaches its limit, turning to God provides calm. I have practiced it myself when fear blurred judgment. It reminds me that clarity is always near if I pause long enough to ask for it.

In a world crowded with digital misinformation, political manipulation, and communal mistrust, Istikharah has become my anchor. It teaches that some decisions require surrender and trust.

This guidance feels significant for Kashmiris because pressures on young people are growing.

Families face economic challenges. Communities are fragmented.

WHEN I LOOK AT **YOUNG KASHMIRIS** TODAY, I SEE FEAR, **BUT I ALSO SEE POTENTIAL.** I see ambition that needs direction and a generation that can thrive if it learns to pause, seek advice, and trust. Istisharah and Istikharah can give that direction.

Young people see lifestyles that impress but leave them hollow.

Decisions often happen in reaction to fear of judgment, failure, isolation, or profiling.

I have spoken to friends who avoid opportunities because anxiety holds them back. I have seen depression rise silently among those carrying the weight of social expectations.

When pressure builds, faith often steps aside, and fear rushes in to fill the space.

I have come to see Istisharah and Istikharah as tools for survival. They remind young Kashmiris to pause, seek counsel, pray, and weigh decisions carefully.

They restore agency in moments when the world feels threatening and confusing. They teach that clarity comes through patience, courage through reflection, and trust can grow even in the valley's uncertainty.

I remember friends who rushed decisions out of fear. I remember families who discouraged travel because they could see the risks I could not.

In moments like these, I learned that consulting others and turning to God are acts of courage. They protect the mind, heart, and body from choices made in haste.

I now tell young people around me: pause before you decide. Seek advice, pray sincerely, and consider consequences. Step beyond the valley with thought instead of fear.

Guidance is always close, but we have to reach for it. Clarity comes when we pause and ponder. Calm grows when we let go of fear. Strength comes from patience, careful thought, and trust.

For Kashmiris, these practices can ease anxiety, restore confidence, and guide decisions toward safer and more fulfilling paths.

They protect mental health, reduce the silent suffering of those carrying societal pressure, and restore purpose to a generation facing uncertainty.

When I look at young Kashmiris today, I see fear, but I also see potential. I see ambition that needs direction and a generation that can thrive if it learns to pause, seek advice, and trust.

few days ago in Srinagar, I watched a short video on Facebook while talking with colleagues. It showed a teacher explaining how we wake our children in the morning. He said many of us begin their day with pressure. His message felt true the moment I heard it.

When we connect waking up with something pleasant, children step into the day with ease instead of stress.

Childhood carries learning, surprise, fear, courage and a constant search for new experiences. Science backs this.

Between one and twelve years, the brain grows at its fastest pace. UNICEF says more than 80 percent of brain development happens before age five.

Every word, tone and action shapes a child's emotional world. Even small stress in early years affects attention and confidence.

Kashmiri teachers see this in classrooms every day.

Mornings matter the most. A child wakes with an active subconscious mind that receives every signal clearly. A calm voice helps release happy hormones like dopamine and serotonin. A tense voice triggers adrenaline. Both shape the child's mood for the entire day.

Many of us use the same warnings at dawn: "Wake up or you will miss the bus," "Get up or your exam will go

These lines sound normal in our homes, though they carry fear. Children still wake up, eat and go to school. Their day often feels heavy. I see this in my students in Anantnag.

I decided to try something new with my own two children. I started waking them gently: "Wake up, I made your

favourite tea," or "Your friends will be happy to see you today," or "Look outside, the sunrise is beautiful.'

Many students walk long distances to reach school. A warm greeting changes their day. Children who feel valued engage better, learn faster and make stronger friendships.

A widow in Srinagar devotes her life to her family, only to face betrayal inside the home she built with her own hands.

aabirah walked into her Srinagar home at eighteen, carrying more hope than Her husband greeted her with

warmth, and his parents opened belonged there.

She entered her new life with steady resolve. Days filled with cooking, visits to relatives, small favours for neighbours, and a kindness that shaped every corner of the house. Motherhood soon added its

own glow. First a son, then two

She handled the long days of work, prayer, and parenthood without complaint and later joined a private school as

Her small salary brought dignity and helped her family rise a

little above worry.
Evenings filled with tuitions and children from nearby homes, their notebooks spread out across her kitchen table.

Life moved in a straight, dependable line until the morning everything collapsed.

Her husband suffered a sudden cardiac arrest and passed away when she was forty-two. The house felt smaller after that day. Nights stretched out with a heaviness she had never known. Many Kashmiri widows carry their pain in silence, and she be-

She guit her job and focused entirely on her children and her ageing in-laws. There were illnesses to handle, medicines to measure, and long nights beside She used her husband's sav-

ings carefully and kept the house in shape through slow years filled with responsibility. When her children grew older, she arranged their marriages with whatever she could gather: savings, her pension, even the gold she had collected since her

She worked through winter chills and summer heat, keeping every corner of the home clean.

She gave without pause and never spoke about her losses. Her son Imran stayed with her after marriage. She welcomed his wife, Naila, with affection.

She taught her family routines,



guided her through the household, and helped her settle into the home. When Naila wished to work as

a teacher, Saabirah encouraged her. She promised to take care of the home and the children, and she fulfilled that promise without hesitation. Her grandchildren became

the center of her days. She cooked for them, washed their clothes, soothed their fevers, and waited at the gate every afternoon. Her pension often went to-

ward family expenses, and she offered it gladly. The house moved smoothly because she handled everything behind the Then the tone inside the

home shifted. The warmth she had built over decades started to thin. Conversations turned sharp. Small disagreements grew into larger ones. Naila dismissed her opinions and spoke with irritation.

tensions between These women inside Kashmiri households often stay hidden behind polite greetings and shared family meals.

Saabirah felt the change but kept her peace.

The day Naila told her to leave the house left her stunned. The house she had shaped since girlhood now felt unfamiliar. Her refusal brought more strain. Naila began pressing through

legal channels, filing complaints and taking steps that pushed Saabirah outside the home she had nurtured for decades. False cases appeared, painting

her as an intruder instead of a mother who had spent her life holding this family together. Imran stood with his mother.

He tried to explain the value a mother brings to a home, the status she holds in Kashmiri culture, the blessing that comes from her presence. His words changed nothing.

Arguments grew tense, and the situation turned harsh. Naila dragged both mother and son into disputes that drained them emotionally and financially.

The home that once carried prayer and laughter now carried fear of the next step.

Through this turmoil, Saabirah relied on her faith. She prayed through long evenings and asked Allah to protect her son and grandchildren. She prayed for Naila as well. Forgiving came easier to her than anger. It had always been that way.

Now she moves through her late sixties with slow steps. She wakes before dawn, spreads her prayer mat, and recites verses with a steady voice. Her eyesight weakens, her hands shake, but her faith stays firm.

Relatives visit during long afternoons. They sit in her courtyard, sip kehwa, and share memories of her younger days. They speak of her years of service, the sacrifices she never mentioned, the calm she carried even when life broke around her. She listens with a small smile and holds their hands with gratitude.

She asks for fairness from Allah alone. She carries no bitterness, only a hope that truth finds its way through tangled narratives. Her story reflects a larger

truth inside Kashmiri homes. Women face deep struggles, and sometimes those wounds come from another woman. Conversations about women's

rights often overlook mothersin-law whose entire lives revolve around their families. These women need dignity as much as anyone else.

A home stays whole when every woman inside it receives respect, and Saabirah knows this better than anyone. She waits for peace to return

and continues with the same calm she brought into this house when she was a young bride.

Iammu: Security forces conducted search operations along the Indo-Pak border and hinterland areas in Kathua, Samba and Jammu districts on Thursday as part of a security drill to enhance vigilance, officials said.

Stereotyping Unfortunate: Sajad Lone To PM

Srinagar: People's Conference president Sajad Lone on Thursday appealed to Prime Minister Narendra Modi to ensure the safety of Kashmiris outside the union territory.

"Please ensure that any citizen of India, including Kashmiris, is not harassed in their own country," Lone said and expressed concern over reports of harassment they face across the country.

"Reports of harassment of Kashmiris across India are coming in. Stereotyping of a Kashmiri, unfortunately, is a favourite hobby across the country," he said in a statement.

The MLA from Handwara said the incidents of harassment were not new, but the intensity has increased over the past 10 years.

"It is not a new trend. It is just that it has become more chronic in the last decade," he said.

Pointing to the anxiety faced by Kashmiri families, Lone said lakhs of Kashmiris are in other parts of the country for busi-

ness, education, or other work. "The families of these people are most concerned that no adverse events should take place, which will put the safety of their

loved ones in danger," he added. Lone admitted that extremism existed but emphasised it should not define an entire community.

"Yes, there are radical lunatics in every society. But they are an aberration," he said.

Meanwhile, PDP MLA from Kupwara Mir Mohammad Fayaz spoke with Himachal Pradesh Governor Shiv Pratap Shukla regarding the incident involving

harassment of Kashmiri vendors.

"The Hon'ble Governor has assured that necessary action will be taken," the PDP posted on its X handle. (PTI)

facilities, multimodal connectivity and last mile access have ensured that remote areas are linked to development. He added that e-commerce and the expanding retail sector are also strengthening the warehousing and logistics ecosystem in Jammu and Kashmir.

He called for meeting the developmental needs of the region through smart logistics infrastructure and improved operations.

"A strong storage, logistics and warehouse ecosystem is essential to move towards selfreliance and to connect producers directly with consumers," Sinha said.

He added that such improvements would support traders, industrialists, farmers, artisans and MSMEs.

The Lieutenant Governor said Jammu and Kashmir is working on several initiatives to make the Union Territory more competitive and investment ready. He announced that the J&K Logistics Policy 2025 will be unveiled soon.

Sinha said the policy will introduce a comprehensive framework focused on multimodal connectivity, development of dry ports and warehousing zones, and greater private sector participation. It will also grant industry status to the logistics sector to ensure it receives ben-

efits under the industrial policy. He said that under the PM GatiShakti National Master Plan, 49 major logistics and connectivity projects worth about 3,000 crore rupees have already been mapped, helping improve coordination and accelerate execution. According to him, the integrated planning approach is helping the region identify logistics gaps, strengthen last mile connectivity to industrial estates, improve freight movement and reduce costs and transit times.

The Lieutenant Governor said a Multi Modal Logistics Park will be developed in Vijaypur, Jammu, through a public private partner-ship model using the Build Develop Finance Operate Transfer approach. The facility will include an inland container depot, warehousing, cold storage, a truck terminal and a container freight station to support trade and improve logistics efficiency.

has risen to six. The NIA had earlier arrested Amir Rashid Ali and Jasir Bilal Wani. Investigators said Dr Umar un Nabi, who drove the explosives laden car that detonated outside the Red Fort, bought the vehicle in Ali's name. Wani was arrested after it emerged that Umar had tried to convince him to become a suicide bomber. He refused but allegedly agreed to work as an overground supporter for the banned Jaish e Mohammed.

Officials said interrogation has shown that the module, led by a group of doctors, had been scouting for a suicide bomber since last year. They said Umar was the key planner and was described during questioning as a hardcore radical who insisted that their plot required a suicide attack. Wani told investigators he met the doctor group in October last year at a mosque in Kulgam and backed out in April due to financial hardship and his belief that suicide was forbidden in Islam.

The investigation led police and central agencies to Al Falah University in Faridabad where 2,900 kilograms of explosives was recovered. The probe began after Jaish e Mohammed posters appeared on walls outside Srinagar on the night of October 18 and 19. Three persons were arrested after CCTV footage showed them pasting the posters. During interrogation, they named Maulvi Irfan as the person who provided them. His questioning eventually led police to the university and the doctors associated with the module. Ganaie was arrested in Faridabad, Saeed from the same town and Adeel Rather from Saharanpur in Uttar Pradesh.

Following the arrests and recoveries, authorities across Jammu and Kashmir have intensified security and compliance checks at medical institutions, commercial units and public

Locker Inspections Across Hospitals

In Srinagar, police along with health department officers inspected lockers used by doctors and staff across district hospitals, private hospitals, medical colleges, primary health centres and health facilities. The inspections

were aimed at preventing misuse of lockers for unauthorised storage of restricted or hazardous material. All racks and lockers were checked and staff were reminded to keep proper records and use the space only for official purposes. Officials said similar checks will continue as part of routine vigilance.

In south Kashmir, a major inspection drive was carried out at Government Medical College Anantnag where an AK forty seven rifle was recovered earlier this month from the locker of Dr Adeel Rather. His arrest had led to the busting of the doctor led terror module and the recovery of nearly three thousand kilograms of explosives. Police and hospital authorities checked all lockers, identified unclaimed ones and instructed the college administration to update records.

Security Drives Extended Across Valley

Security checks have also been extended to Bandipora where police and civil administration teams inspected medical and administrative facilities. In Shopian, teams intensified inspections of shops dealing with chemicals, fertilisers, explosives, hardware and vehicle workshops. Shop owners were directed to maintain detailed records of buyers, quantities purchased and intended use. They were also advised to install functional CCTV cameras to aid monitoring.

In Kulgam, authorities carried out verification drives across LPG agencies and commercial gas cylinder outlets. Inspecting officers checked stock registers, distribution logs and transport records to ensure compliance with safety rules. Dealers were told to verify the identity of consumers before sales and maintain proper documentation. Violations will invite strict legal action, officials said.

Highway Monitoring Intensified

Security personnel have been deployed at strategic points including on the Srinagar Jammu highway near Pulwama and at the Qazigund gateway to monitor vehicle movement and maintain public order.

carried out by experts from the Forensic Science Laboratory when the accidental detonation occurred.

Refuting the unverified posts being shared online, police said several social media claims were based on speculation and intended to mislead people. The statement urged the public not to circulate unverified information and to rely only on official updates.

Police said the Government of Jammu and Kashmir has already constituted a high-level committee on 16 November to investigate the incident. The committee is headed by the Principal Secretary, Home Department, and includes the Inspector General of Police Kashmir Zone, the District Magistrate Srinagar and a senior scientist from the Central Forensic Science Laboratory of the Government of India.

The committee will examine the circumstances leading to the incident, police said.

'Intellectual Terrorists

Police said it had become a trend now for doctors and engineers to engage in anti-national activities.

Additional Solicitor General SV Raju, appearing for the Delhi police, told a bench of Justices Aravind Kumar and N V Anjaria that the delay in trial was attributable to the accused, and they cannot take advantage of it.

Raju showed in the top court videos of Imam giving "inflammatory speeches" against the Citizenship Amendment Act.

The videos showed Imam giving speeches at Chakhand, Jamia, Aligarh, and Asansol in 2019 and 2020 before the riots in February 2020 in

Pointing out that Imam is an engineering graduate, the advocate said, "Nowadays there is a trend that doctors and engineers are not doing their professions but engaging in antinational activities."

Raju added, "It's not a simple protest. These are violent protests. They are talking about

At this juncture, Justice Kumar asked if the speeches were part of the chargesheet, to which Raju replied in the affirmative.

The ASG said CAA protests were timed with US President Donald Trump's visit to India to

get international media coverage. "The ultimate intention is regime change. CAA protests were a red herring; the real purpose was regime change, create economic deprivation and create chaos across the country. The riots were deliberately made to coincide with the visit of US President Donald Trump. These so-called intellectuals are more dangerous than the ground-level terrorists," Raju said.

Khalid, Imam, Gulfisha Fatima, Meeran Haider, and Rehman were booked under the UAPA, the stringent anti-terror law, and provisions of the erstwhile IPC for allegedly being the "masterminds" of the 2020 riots, which left 53 people dead and over 700 injured.

The violence erupted during widespread protests against the Citizenship (Amendment) Act (CAA) and the National Register of Citizens

Strongly opposing the bail pleas of activists, Delhi on Tuesday had argued that it was not something spontaneous but an "orchestrated, pre-planned, and well-designed" attack on the sovereignty of the nation.

HC Affirms Remand

to set aside an order by the Appellate Tribunal includes the power to remand, which is a necessary attribute or concomitant of the power to annul or set aside the order under appeal, unless such power is expressly, or by necessary implication or intendment, taken away by the statute which creates the appellate tribunal," said a bench of Justice Sanjeev Kumar and Justice Sanjay Parihar while dismissing a batch of related plea.

The bench responded in affirmative to common question of law that whether the appellate Tribunal defined under Section 2 (b) of the Act of 2002 and exercising powers under Section 26 thereof is empowered to remand the matter back to the Adjudicating Authority after setting aside the order of confirmation passed by the latter confirming the provisional attachment made by the authorized officer under Section 5 of the Act of 2002?'

The power of remand is an important postulate of any authority exercising appellate jurisdiction and vested with the power to confirm, modify or set aside the order appealed against, the court underlined.

"Such power is a necessary concomitant to the powers of the Appellate Authority to pass the orders like the order of confirmation. modification or setting aside," the court said, adding, "Absent such power, the power to set aside or annul the order appealed against, that too, on the technical grounds, like non compliance with the principle of natural justice, would render the power itself illusory and ineffective.

This power is inherent in, and forms an integral part of, the power of the statutory appellate authority to annul or set aside an order under appeal, the court added.

Respiratory Ailments Surge in Kashmir as Mercury Plunges

SRINAGAR: As Kashmir's temperatures drop, hospitals across the valley begin to witness a sharp spike in admissions of Chronic Obstructive Pulmonary Disease (COPD) and asthma patients.

Doctors said the majority of emergency and casualty cases during winters are linked to COPD—an irreversible and progressive lung condition—largely triggered by smoking and worsening air pollution. They called for prevention, early diagnosis and enhanced respiratory care facilities in the region.

Dr Ghulam Hassan Khan, a chest disease expert, told KNO that COPD cases in J&K are increasing at an alarming rate.

"Most of the patients landing in casualty during the winter months are COPD and asthma patients. Smoking remains the leading cause. Quitting smoking is the single most effective step to prevent this lifelong disease," he said.

The doctor said a considerable number of people who have never smoked also develop COPD due to exposure to poor air quality, which, he points out, is deteriorating in Kashmir.

"Environmental pollution is rising due to combustion emissions, industrial activities, wood and kerosene burning in homes, biomass fuels, and even charcoal used in kangris. At times, Kashmir's air quality has been reported to be worse than major metro cities," he added.

According to Dr Khan, reducing smoking rates and improving overall air quality would significantly reduce respiratory disease cases. He urged the administration to take concrete measures for cleaner air.

"Apart from smoking and pol-

lution, genetic factors, socioeconomic conditions, repeated lung infections, exposure to toxic fumes, and vascular complications among IV drug users also contribute to COPD," he said.

Dr Khan advised lifestyle modifications such as quitting smoking, avoiding allergens and respiratory irritants, staying hydrated, maintaining good nutrition, regular exercise, and avoiding extreme temperatures can slow the progression of COPD.

COPD, once developed, is ir-

COPD, once developed, is irreversible, he explained. Winter months bring frequent infections that push patients into hospitals, he added.

"Flu vaccination, pneumococcal and Haemophilus influenzae vaccines every five years are crucial. These vaccines can prevent infections that worsen COPD during winter," Dr Khan said.

Dr Javid Ahmad, another chest specialist, said that COPD

incidence in Kashmir is higher than in other parts of the country. "COPD is a lifelong disease. Winter and pollution aggravate symptoms, leading to increased hospital footfall. Most COPD patients are long-term smokers," he said.

Dr Ahmad said that early awareness is crucial so that people quit smoking before irreversible lung damage occurs. "Most patients are diagnosed after the age of 45, by which time they've often smoked for two decades. The earlier they quit, the better their lungs can cope," he added.

Doctors advised patients to follow preventive measures to avoid winter complications, which include avoiding overcrowded, poorly ventilated rooms, ensuring adequate ventilation at home, increasing water intake, maintaining a balanced diet and staying away from smoke, dust and pollutants.

Saffron Crisis Deepens as Production Plummets

SRINAGAR: Kashmir's famous saffron sector is facing one of its toughest years in recent memory, with production dropping drastically to nearly 5–10 percent of the usual yield. As a result, saffron prices in the market have surged by around 20 percent, and traders fear the rates may climb even further in the coming weeks.

Growers and traders, who spoke to KNO attributed the crisis to prolonged dry spells, erratic weather patterns, and shrinking traditional saffron fields—factors that have collectively dealt a heavy blow to this centuries-old industry.

Muhammad Ashraf, a saffron grower from Pampore, often called the 'Saffron Bowl of Kashmir', said this year's output has left farmers devastated. "We have never seen production fall to this extent. Most of us harvested barely a few grams. If this continues, many growers will have no option but to abandon saffron farming," he said.

Another grower, Haleema from Lethpora, said the low yield has pushed many families into financial distress. "Saffron is our main livelihood. With only 5–10 percent produce this year, we are unsure how to manage daily expenses. We request the government to intervene immediately before this crop disappears

from Kashmir," she said.

Traders dealing with saffron say that the supply shortage has already led to a noticeable spike in prices. "Prices have jumped by nearly 20 percent in just a few weeks. If the market continues to receive low stocks, we may see another surge soon," said Bashir Ahmad, a trader in south Kashmir's Anantnag district.

He added that buyers, especially from outside Kashmir, are already expressing concern about limited availability.

Another trader, Imran Rather, said the demand is stable, but the supply is extremely low. "This imbalance is pushing the rates up. We are worried that saffron from other countries might capture the market if local production keeps declining," he said.

Saffron growers have appealed for urgent government assistance, including measures to ensure proper irrigation, protect land from conversion, and strengthen the Mission Saffron project.

support, better irrigation systems, and strict action against land encroachment. Without government help, the saffron industry of Kashmir is at serious risk," said Abdul Majid, a grower.

Stakeholders also urged authorities to compensate growers who suffered heavy losses this season.

SIA Raids KT Office in Jammu

Police says cartridges of AK rifles recovered; Paper denies charges

JAMMU: The State Investigation Agency on Thursday raided the head office of Kashmir Times in Jammu and recovered arms, ammunition and incriminating documents during the search operation conducted over allegations that the publication was promoting anti-national activities, an SIA spokesperson said.

The agency also searched the house of Prabodh Jamwal, the owner of the media house situated at Gandhi Nagar in Jammu, in pursuance of the same investigation.

The searches, conducted in the presence of an Executive Magistrate, were carried out in continuation of the investigation into the case registered against the media house Kashmir Times (kashmirtimes.com) for its alleged involvement in criminal conspiracy with secessionist and other anti-national entities operating within and outside Jammu & Kashmir, a statement issued by the agency said.

The FIR was registered against the organisation, indicating that this particular media platform has been allegedly disseminating terrorist and secessionist ideology, spreading inflammatory, fabricated, and false narratives, attempting to radicalise the youth of Jammu & Kashmir, inciting disaffection and separatist sentiments, disturbing peace and public order, and challenging the sovereignty and territorial integrity of India through print and digital content, it said.

In the raid and search conducted at the office premises of Kashmir Times, located at Residency Road, Jammu, the following incriminating arms and ammunition were recovered: one revolver, 14 empty cases of AK-series weapons, three live AK rounds, four fired bullets, four grenade safety levers, and three suspected pistol rounds, the statement said.



"All recovered items were seized on the spot following due legal procedures. These recoveries indicate possible unlawful possession and suspected linkages with extremist or anti-national elements, warranting further detailed investigation," it added.

The seized arms, ammunition, digital devices, and documents will undergo forensic and technical examination to determine their origin, purpose, and any potential connections to proscribed organisations or individuals.

The investigation remains active, and further action shall be taken based on emerging evidence.

KT Management Slams Raid The Kashmir Times man

The Kashmir Times management issued a sharp rebuttal, calling the allegations "baseless" and the raid an attempt to intimidate an independent media institution.

Editors Prabodh Jamwal and Anuradha Bhasin said in a joint statement, "The reported raids, the accusations of being inimical to the state, and the coordinated crackdown are yet anoth-

er attempt to silence us."

They stressed that criticism of the government must not be equated with being anti-national.

"A robust, questioning press is essential to a healthy democracy. Our work of holding power to account strengthens the nation. It does not weaken it," they stated.

The editors highlighted that Kashmir Times, founded by veteran journalist Ved Bhasin in 1954, has a legacy of independent journalism and reporting uncomfortable truths. They accused authorities of targeting the organisation for "speaking truth to power" and called the allegations "a tactic to intimidate and delegitimise" the outlet.

"We will not be silenced," the statement said, urging withdrawal of charges and calling for solidarity from media colleagues and civil society.

They noted that although the newspaper's print edition was suspended in 2021–22 following what they termed "relentless targeting", the organisation continues digital operations with all content publicly accessible. (With inputs from PTI)

J&K BOSE Suspends Affiliation of Four Schools

he Jammu and Kashmir Board of School Education (J&KBOSE) has suspended the affiliation of four private schools after confirming that they had prescribed textbooks not approved by the Board, in violation of its statutory guidelines and the terms of affiliation.

In a statement issued, J&K BOSE said the institutions had displayed "open defiance" of mandatory norms by adopting non-prescribed learning material. Show-cause notices are being served to all four schools, seeking an explanation as to why their affiliation should not be cancelled altogether.

The schools facing suspension are Radiant Public School, Anantnag; Solace International School, Pulwama; Holy Mission School, Narbal, Budgam; and Pioneer Educational Institute, Hanjiwara, Pattan, Baramulla. All Board-related facilities to these institutions have been halted with immediate effect.

The Board has also imposed monetary penalties on eight other private schools for similar violations. These include Candid Higher Secondary School, Nowgam; Fayaz Educational Institute, Chanapora—Nowgam; Al-Huda Public School, Pattan, Baramulla; Shamas Memorial School, Khansahib, Budgam; Hanfia High School, Frisal, Kulgam; Future Vision School, Bandipora; and Linton Hall School, Rajbagh, Srinagar. The penalised schools have been directed to deposit the fine within one week. Failure to comply will trigger formal proceedings for disaffiliation, the Board warned. (Observer News Service)

SKIMS Issues Public Health Advisory

KIMS on Thursday issued a comprehensive public health advisory on three common winter-related health conditions, urging people to take necessary precautions as part of the World COPD Day observance organised by the Department of Pulmonary Medicine, Division of Internal Medicine.

A statement issued to Kashmir Observer reads that the event featured a series of expert lectures during a day-long CME-cum-Workshop themed "Shortness of Breath – Think COPD."

Director SKIMS Prof. M. Ashraf Ganie, Patron & Chief Guest, appreciated the Department of Pulmonary Medicine for its remarkable progress. He expressed satisfaction over the establishment of the newly carved-out Pulmonary ICU and the standardized Paediatric Pulmonary Lab, stressing that SKIMS must now strive to achieve global recognition through its specialised skills and resources. Highlighting COPD as the second leading cause of death with a particularly high prevalence in Jammu & Kashmir, he called for a comprehensive screening strategy to enable early diagnosis of non-communicable diseases such as COPD. Citing recently published research in JAMA, he noted the high prevalence of lung cancer in J&K, where smoking remains a major risk factor common to both diseases.

"Early diagnosis and prevention are central to reducing the burden of non-communicable diseases," he emphasized. (Observer News Service)

Kashmir May Face 20% Peak-Time Power Hike

SRINAGAR: Close on the heels of a massive controversy in Kashmir over the installation of smart meters, the Power Development Department (PDD) has proposed an extra 20 percent charge on electricity consumption during morning and evening hours in the Valley.

The Kashmir Power Devel-

opment Corporation Limited (KPDCL) has sought approval from Joint Electricity Regulatory Commission (JERC) to impose a 20 percent surcharge on all categories of consumers except for the agriculture sector during peak hours, when demand is at its highest due to the bone-chilling cold in the Valley. According to a petition filed before the JERC for J&K and Ladakh, KPDCL has proposed the surcharge for different consumer categories, including domestic households. The JERC, a quasi-judicial body, is empowered to approve or reject tariff proposals.

Confirming the development, Managing Director KP-DCL, Mahmood Ahmad Shah told KNO that "KPDCL has proposed a 20 percent surcharge on tariff for the peak hours of the day. As of now, no decision has been taken by the regulatory commission."

The proposal is part of the

Time of Day (ToD) tariff system, under which electricity costs vary depending on the time of consumption.

However, the proposal has been vehemently opposed by the Kashmir Chamber of Commerce and Industry (KCCI) during the hearing on KPDCL petition on Thursday. The KCCI, represented by Secretary General Faiz Ahmad Bakshi argued that it was misleading for KPDCL to claim it had not raised tariffs while simultaneously proposing a surcharge during peak hours.

"Since electricity consumption during these hours is a necessity and not a discretionary choice, treating it as an additional charge is fundamentally unfair," the KCCI said.

Citing figures, the KCCI said

"As per Central Electric-

"As per Central Electricity Authority figures for 2022, the System Average Interruption Duration Index(SAIDI) for Kashmir stands at a shocking 889, while the System Average Interruption Frequency Index(SAIFI) stands at 723.95. These numbers are several times higher than the national averages of 116.12 and 171.64. Even Jammu, despite its own problems, performs significantly better with a SAIDI of 489 and SAIFI of 442," the business body said.(KNO)

GOA: The 19th edition of the

WAVES Film Bazaar—South Asia's foremost film market-opened on Wednesday at the Marriott Resort, Panjim, with an exuberant inaugural ceremony that brought together leading filmmakers, policymakers, producers, festival programmers and global delegates. Held alongside the International Film Festival of India (IFFI), the rebranded WAVES Film Bazaar will run from November 20 to 24.

In his opening address, Ministry of Information and Broadcasting Secretary Sanjay Jaju described WAVES Film Bazaar as a "natural beginning" to IF-FI's celebrations and lauded its evolution into a "complete ecosystem of screenings, masterclasses, and technology showcases." He said the Bazaar's new identity aligns with the

Prime Minister's vision of "converting art into commerce," adding that WAVES is now a unique platform "connecting creators and countries, making India a meeting point for global collaboration."

Jaju highlighted the extensive slate of curated projects, grants, and structured evaluation systems, while also emphasising India's first-ever AI Film Festival and Hackathon hosted at the venue.

Guest of Honour Jaewon Kim, Member of the National Assembly of the Republic of Korea, praised the organisers for their consistency and commitment since the market's inception. Calling for deeper cultural and creative ties between India and Korea, she captivated the gathering with a moving rendition of Vande Mataram, which drew warm applause and a standing ovation.

England Desperate To End Ashes Drought In Australia As Series Begins

PERTH: The build-up to the Ashes series starting Friday began at the end of July 2023 following one of the more acrimonious test cricket series between England and Australia.

Ben Stokes and his England lineup won that test at The Oval in South London but it wasn't enough to reclaim the Ashes from the Aussies, who won the first two tests and drew the fourth in a fivematch series to retain the old urn.

Cue to Perth Stadium, Day 1 of a possible 25 spanning seven weeks and five cities. There are some big questions in play.

Can an aging, understrength Australia continue an unbeaten run in home Ashes tests that dates to the 2010-11 series?



Can Stokes inspire an end to that long drought for England? Can Joe Root, the world's No. 1-ranked test batter, finally post an Ashes century in Australia?

losses, two draws and no wins in England's last 15 tests Down Under. He's thinking more about the 2010-11 squad that beat the Australians 3-1.

In a bid to break the drought, England is likely to start a pair of express pace bowlers in condifra Archer is primed to do well in Australia and 35-year-old Mark Wood recovered from a minor hamstring strain to be including in the 12-man match squad for the first test.

THE AUSSIES

Australia captain Pat Cummins and fellow paceman Josh Hazlewood will be missing the first test because of injuries, leaving Australia's attack without half of its frontline bowlers.

The remaining half — left-arm fast bowler Mitchell Starc and offspinner Nathan Lyon - are confident that the team can win on what is expected to be a fast, bouncy pitch in Perth. Brendan Doggett is set to make his test debut alongside fellow fast bowler Scott Boland, making it the first time the men's test XI will contain two players with Australian Indigenous heritage.

Cameron Green's fitness to

bowl means he'll fill the allrounder spot and Australia can give opening batter Jake Weatherald a test debut at the age of 31. The flow-on means Marnus Labuschagne will return at No. 3, with stand-in skipper Steve Smith at No. 4 and allrounder Beau Webster has been cut from

the lineup. **SMITH'S ROLE**

The 36-year-old Smith will lead Australia for the third time this year and the seventh time since his era as full-time captain ended with the Sandpapergate scandal in 2018.

Kabaddi Coaching Camp Probables East Bengal Knocks PM's Door,



Seeks Help For Football Revival

NEW DELHI: Concerned about Indian football's "decline for many years", East Bengal, one of the country's oldest clubs, on Thursday sought Prime Minister Narendra Modi's urgent intervention to address the "unprecedented crisis", highlighted by the uncertainty over the fate of Indian Super League (ISL) and a sharp decline in investment in the sport.

In the letter, the 106-year-old club pointed out that the national team has slipped to 142nd in the latest FIFA rankings despite its illustrious past, which includes Asian Games gold medals in 1951 and 1962 and a bronze in 1970.

The Supreme Court is

currently seized of the matter relating to the selection of a new commercial rights holder of the ISL after the tender floated by the All India Football Federation (AIFF) found no takers. The matter is likely to come up before the SC on Friday.

Interestingly, the Kolkata club is also a part of the 12 ISL teams which have filed a joint application for intervention before the SC, praying for a solution in the vexed issue arising out of the uncertainty in conducting the ISL season.

The club expressed concern that the ISL -- the country's top-tier league -- had still not begun this season, causing "deep distress" among players, clubs, officials and supporters.

Gill To Undergo Fitness **Test Friday But Unlikely** To Play 2nd Test

GUWAHATI: India captain Shubman Gill, who has not trained due to a neck spasm sustained during the first Test against South Africa, will undergo a fitness test on Friday in a last-ditch attempt to be available for

the second game, batting coach Sitanshu Kotak has indicated

Gill developed the spasm on the second day of the opening Test in Kolkata that India lost by 30 runs and hasn't returned to the nets ever since.

While his chances remain slim, the BCCI sports science team is waiting as long as possible before taking a final call. The second and final Test begins

"See, he is definitely recovering really well, because I also met him yesterday," Kotak said ahead of a practice session that Gill skipped.

'Now, the decision will be taken tomorrow evening, because the physios and doctors have to decide whether, even if he is fully recovered, there's a chance of the spasm recurring during the match. That is very important."

"If there is a doubt, then I am sure he will rest for one more game because it won't help the team otherwise. A player like Shubman, and he's the captain so any team would miss him," Kotak added.

Indian Football Team Drops 6 Places To 142nd In FIFA Rankings

he embarrassing 0-1 defeat to Bangladesh in the 2027 Asian Cup qualifiers saw the Indian men's football team drop six places down to 142nd in the latest FIFA rankings, reflecting the national side's free fall in the last two years.

The Khalid Jamil-coached team lost to Bangladesh for the first time since 2003 in Dhaka on Tuesday, leaving the country's football fans deeply anguished at the continuous downward slide in its fortunes.

The team has already been knocked out of Asian Cup contention after losing to Singapore in Goa last month. This was the worst ranking of the team since October 2016 when it was placed at 148th.

The Indian team is now ranked 27th among the 46 Asian countries included in the FIFA rankings, with Japan on top at 18th, followed by Iran (20th), South Korea (22nd), Australia (26th) and Uzbekistan (50th). India's best ever ranking was 94 in February 1996. (PTI)

Rising Asia Cup: India A Take On Bangladesh A In Semis

rndia A will need a heftier contribution from their top-order batters to support the in-form Vaibhav Suryavanshi when they take on a tricky Bangladesh A in their Rising Stars Asia Cup semifinal here on Friday. Suryavanshi, the second highest run-maker with 201 runs in this T20 event, has done most of the heavy-lifting with the bat while making a blistering hundred and 45. But other batters in the line-up such as skipper Jitesh Sharma, Naman Dhir, Priyansh Arya and Nehal Wadhera have not exactly set the tournament ablaze so far. A far more rounded outing from batters is mandatory against Bangladesh as the latter is not a team to be taken lightly. They have bowled out a capable Afghanistan A side for a paltry 78 and then stretched a strong Sri Lanka A all the way till the last over of a league match. (PTI)
