# **India Rolls Out Four New Labour Codes**

New Delhi:In a landmark overhaul of labour laws, the government on Friday notified all four Labour Codes, ushering in major reforms, including universal social security coverage for gig workers, mandatory appointment letters for all employees, and statutory minimum wages and timely payment across

The four Labour Codes -- the Code of Wages (2019, Industrial Relations Code (2020), Code on Social Security (2020) and Occupational Safety, Health and Working Conditions Code (2020) -- effective Friday, replace 29 fragmented laws with a unified, modern framework.

The reforms include expanded rights and safety for women, including night-shift work, free annual health checkups for workers aged over 40

Launches Housing Project For Shelling-Hit Families In Rajouri



Srinagar: Lieutenant Governor Manoj Sinha on Friday laid the foundation stone for construction of new houses for families affected by recent natural calamities and unprovoked Pakistani shelling during Operation Sindoor in Poonch and Rajouri.

A total of 133 houses in Poonch and 388 houses in Rajouri that were completely damaged will be built free of cost with the support of the High range Rural Development Society (HRDS India).

Reaffirming Government of India's commitment to full rehabilitation, the Lieutenant Governor said the initiative reflects the resolve to improve the lives of border residents.

"Earlier, ex gratia relief and employment to Next of Kins



by HRDS India; solar panels in second phase of the deceased were provid-

ed and compensation paid to the families affected by flash floods and Pakistani shelling in both the districts. Under SRE and central schemes, relief of more than Rs 10 crore was already provided to other house owners in Poonch. It is being ensured that not a single family is deprived of their rights and fundamental needs," the Lieutenant

Governor said.

He noted that 13 NoKs in Poonch were provided government jobs and 14 families received ex gratia. In Poonch, 160 kachcha and 425 pucca house owners were given compensation to rebuild their homes. In Rajouri, one NoK of a civilian killed during Operation Sindoor was provided a government job, while 465

#### After Hospitals, Searches Widen To Fertiliser Shops & Car Dealers

Srinagar: Authorities in Kashmir on Friday expanded a largescale inspection drive, extending checks from hospitals to chemical and fertiliser shops and car dealerships across multiple districts as part of heightened security measures, officials said.

Police teams in Ganderbal carried out surprise inspections at several hospitals in coordination with hospital administrations. The checks focused on verifying locker use, ensuring security protocols, and preventing any misuse of hospital premises. Staff were briefed to report suspicious activity and ensure lockers and workspaces are used strictly for official purposes.

In Kupwara, police inspected lockers at Government Medical College Handwara, reminding

employees to maintain proper records and adhere to safety guidelines. The inspections follow recent security concerns after the Delhi blast and the recovery of arms and ammunition from what officials described as a white collar terror module. Earlier this month, an AK rifle was found in a doctor's locker at GMC Anantnag, prompting intensified checks across districts.

In Srinagar, the sweep widened further on Friday, with coordinated inspections across chemical and fertiliser shops, car dealerships and hospital facilities. Last week, police uncovered a white collar terror module involving doctors from Kashmir, Faridabad and Uttar Pradesh who allegedly stored explosives. The network was linked to the blast near Delhi's Red Fort and triggered | More on P6

#### 20% Peak Hour Power Hike **Draws Sharp Opposition**

Srinagar: The Jammu and Kashmir Government's proposal to impose a twenty percent surcharge on electricity consumed during peak hours has drawn strong criticism from several political parties, who say the move will deeper the hardships of people already struggling through economic distress and harsh winter conditions.

The proposal, sent by the Kashmir Power Distribution Corporation Limited, recommends a surcharge on morning and evening consumption. Political leaders across the region have opposed the idea, calling it unfair and insensitive at a time when incomes are falling and essential expenses

In a post on X, NC MLA Tanvir Sadiq said power is a necessity and not a luxury. He said the administration should not burden people in the middle of winter when electricity becomes essential for basic

PDP MLA Waheed ur Rehman Para also voiced his concern. He said the government must do a real ground assessment before increasing tariffs. "People in posh areas may not feel it, but for ordinary Kashmiris winter is a battle for survival. Electricity in Kashmir is not a luxury, it is life support. ## No Major Weather **Activity Till Dec 9: MeT**

Pir Ki Gali Sees Light Snow; Valley Remains In Sub Zero Grip

Srinagar:The Meteorological Department on Friday said there is no forecast of any major wet spell in Jammu and Kashmir for the next several days, even as the higher reaches of Shopian received a brief spell of snowfall.

Independent weather forecaster Faizan Arif Keng said that light snowfall was recorded in the upper

reaches of Shopian earlier in the day. "Pir Ki Gali received light snowfall today. The spell lasted for only one to two hours," he said.

Director MeT, Dr Mukhtar Ahmad, said radar and satellite observations indicate dry weather across Jammu and Kashmir until at least December 2. He said generally cloudy conditions may prevail, with a brief spell of very light snowfall likely over isolated higher reaches during the night of December 2 and the morning of December 3.

Overall, nothing significant is expected till December 09," Dr Ahmad said.

# **Drug Traffickers Inflict A Deadly** Blow On Youth: HC

Dismisses Bail Plea Of Accused Under Incarceration For 4 Years

Srinagar: The High Court of J&K and Ladakh on Friday dismissed bail plea of a drug trafficker, observing that such of-fenders deal a "deadly blow" to the youth and pose a grave threat to society.

Dismissing a plea by 27-yearold Shahnawaz Ahmad Dar, a bench of Justice Wasim Sadiq Nargal noted that drug trafficking not only devastates individual lives but also undermines public health, weakens family structures, fuels secondary crimes, and endangers entire communities.



"Drug traffickers inflict a deadly blow on the youth and are a hazard to society. Their activities not only destroy individual lives but also undermine public health, erode family structures, fuel secondary crimes, and threaten communities," the court said, underling that granting bail in such cases without strict

compliance with the statutory conditions creates a real and tangible risk of the accused returning to the same network

and re-offending.
"The social cost of permitting such offenders to re-enter the community, even temporarily, is immeasurable," the court said, underlining that the legislative intent behind the NDPS Act is precisely to shield the public from the grave dangers posed by drug traffickers and to prevent the recurrence of offences that carry devastating consequences for present

# **Study: A Decade of Evidence Shows Why Public Trust in Media Is Crumbling**

The Conversation

That trust in media is declining throughout the world is almost an unquestioned truth today. But researchers have found it hard to clearly demonstrate how we went from an era of high trust in 20thcentury media to one of low trust in the digital age.

The ways people engage with media and where they go for trusted information are changing. From 2011 to 2024, my colleagues and I at the Glasgow University Media Group have charted these trends through a series of focus group studies.

Our findings, summarised in my book The Construction of Public Opinion in a Digital Age, suggest that many people feel journalism today represents the interests of the powerful and does not speak for them.

For audiences of 20th-century broadcasting and press, trust largely rested on what we might call a leap of faith. With only a small number of news outlets – and where organisations like the BBC were given exclusive access to politicians and experts – there were few alternatives for audiences to turn to for information.

Most people didn't have access to other sources or direct experience of what was reported in the news - though when they did, they trusted news reports less.

Traditional media outlets now rely on digital platforms to deliver their content, where it competes with an expanded range of alternative information sources.

Mainstream news continues to be led by the perspectives of government, business and economic experts. But digital platforms also allow the voices of social media influencers, independent journalists, activists and everyday users to be heard. This gives audiences easy access to perspectives which directly and regularly challenge the narratives presented in news.

In this environment, journalists working for mainstream news outlets are

expected to prove they best represent the interests of their audiences - it is no longer taken as gospel by readers, listeners and viewers.

Focus group participants told me and my colleagues over many hours of discussions that they see mainstream journalism as being bound up with a political system that is failing. For example, journalists may positively report percentage points of economic growth and demand sensible spending plans, but many people simply don't believe things will get better.

In our most recent study, which analysed media content and audience reception in relation to the cost of living crisis (and will be published as a book in 2026), we found that journalists, in line with politicians, reported the crisis as a short-term shock, temporarily raising food and energy prices.

But our participants understood the crisis as one of long-term decline in their communities and standard of living. In other words, there is a disconnect between the priorities and beliefs of journalists and their audiences.

This disconnect was evident across all demographic groups studied - yet not all are affected to the same degree. Our findings point to a correlation between those most disaffected with the political system particularly those really struggling - and the likelihood of investing trust in alterWhere do you get your news?

native "news" sources.

With more choices than ever for where to get information, people now move between different platforms and devices depending on their needs and circumstances. During the pandemic, millions tuned in to the BBC for the latest health guidance. At other times, people follow algorithm-driven social media feeds for entertainment and news.

Our research indicates, however, that most people have a dominant mode of engagement they rely on to deliver trusted information. These fell largely into three categories in terms of preferences:

1. Mainstream sources

Older and highly-educated participants tended to rely on mainstream news. They invested trust in official forms of evidence and authoritative voices such as politicians and experts.

2. Non-mainstream sources

Lower-income participants were more likely to engage with sources which were seen as free of the mainstream "agenda". Trust was often invested in partisan podcasters, independent outlets and bloggers – as well as social media posts more generally – who shared their scepticism of public institutions and establishment figures.

3. Mix of sources

Younger participants were more likely to filter news through aggregation apps like Google News, friend endorsements, or simply be led by platform algorithms. They decided who to trust by comparing multiple sources, often giving more credibility to social media influencers who were more relatable and seen to better represent their interests. It is important to note that these these are generalised categories - it is not the case that all those on low incomes go to social media for their news, nor that young people don't access mainstream outlets.

New information sources are emerging in the context of algorithm-driven platforms which push provocative content to users, as well as political groups which amplify and distort people's frustrations.

The danger is that as greater numbers move away from traditional news towards information sources without any formal verification processes or proper scrutiny of political parties, uncertainty about who or what to trust may only deepen.

Interestingly, there was one source across our studies which held a unique position of being widely trusted across a broad range of groups. That was the website MoneySavingExpert and its founder, Martin Lewis. As a financial journalist who then set up his consumer website, Lewis brings his expertise to often personalised, everyday financial concerns.

At a time when mainstream journalists are seen to parrot political rhetoric, Lewis positions himself on the side of the public - most notably during the cost of living crisis, making an emotional appeal to politicians to "help people" live on TV.

If journalists want to re-engage with communities lost to online alternatives, the remedy may lie in lessons that can be learned from figures such as Lewis, and his innovative model of trust which seems to work so well for the digital generation.

Srinagar: In a renewed push to strengthen public safety and tighten vigilance across the city, Srinagar Police on Friday conducted extensive inspections at chemical and fertilizer shops as well as at medical institutions, covering a wide network of police station jurisdictions and healthcare facilities.

As part of the citywide security drill, inspection teams fanned out across areas falling under Police Stations Nowhatta, Lal Bazar, Shaheed Ganj, Chanapora, Rajbagh, Ram Munshi Bagh, Harwan, Nishat, MR Ganj, Safakadal, Zadibal, Hazratbal, Nigeen, Saddar and several others. The checks focused on ensuring that chemicals, fertilizers, and other sensitive materials are neither misused nor stored in violation of existing norms.

officials fied stock and sales records, scrutinised identity checks for bulk purchasers, and inspected storage conditions for materials with potential security implications. Dealers were also asked to ensure valid licensing and strict ad-

herence to regulatory guidelines. Shop owners were briefed on enhanced security requirements and encouraged to immediately report suspicious transactions.

Simultaneously, nagar Police, in coordination with medical officers from the Health Department, carried out inspections of lockers and storage racks used by doctors and staff in district hospitals, private health centres, medical colleges, PHCs and other healthcare institutions. The drive aims to prevent any unauthorized or illegal storage within hospital premises and to reinforce internal security protocols.

All lockers were thoroughly examined, and staff were reminded to maintain transparency in record-keeping and to restrict locker usage strictly to official, permis-

Authorities said both inspection drives will continue as part of routine vigilance measures to safeguard public spaces and critical institutions. Srinagar Police reiterated its commitment to ensuring the safety of citizens and maintaining the security of the nation.

# **Hogaad, Hokh Suen Face Fading Demand in Modern Kashmiri Kitchens**

Srinagar: As winter wraps Kashmir in its chill, Srinagar's markets are witnessing a quiet shift. Once a must-have in every Kashmiri kitchen, Hogaad (dried fish), Hokh Suen (dried vegetables) and other traditional delicacies are seeing dwindling demand.

Vendors who once struggled to meet crowds now find their stalls nearly empty.

"Earlier, people stock up weeks before the first snowfall. Now, many youngsters don't even know how to cook these traditional items,' says Abdul Majeed, a vendor at Srinagar's Mahraj Bazaar, while speaking to KNO. He adds that the decline reflects broader changes in Kashmiri eating habits.

"The younger generation prefers fresh vegetables or ready-to-cook items. The culture of preserved winter foods is slowly fading," said another vendor nearby.

Traditionally, these foods were prepared to last through harsh winters when fresh produce was scarce. Families would soak, sun-dry and preserve vegetables to create meals that were both nutritious and long-lasting. Today, with supermarkets and year-round availability of fresh produce, that necessity has all but disappeared.

Vendors hope the trend reverses but admit the change is generational. "It's not just food; it's a way of life disappearing slowly," says Majeed, glancing at his unsold piles of Hogaad and Hokh Suen.

With Srinagar settling into winter, these age-old delicacies, once a symbol of resilience and tradition, may soon become rare glimpses of Kashmiri heritage rather than staples on every plate.

## **Police Held 2 Associates** of Accused Woman

Srinagar: Srinagar Police said it has arrested a woman accused in multiple cheating and stolen-gold cases along with her two associates, cracking a racket that had been operating across several districts of the Kashmir Valley.

Police Station Lal Bazar con-

ducted the operation following sustained intelligence inputs that led to the tracking of the prime accused, identified as Asmat Jan alias Taboo, who was wanted in several cheating and fraud cases in Lal Bazar, Safakadal, Chadoora, Sopore and Khrew in Awantipora. According to officials, she had been evading law enforcement for an extended period by frequently shifting locations in West Bengal,

working under the supervision of the SDPO and the Zonal SP, traced the accused to Hotel White House in Jalandhar, Punjab, where she was taken into custody. Police said the arrest followed weeks of coordinated efforts.

The Gold Association of Kashmir Valley had earlier raised concern over her repeated involvement in cheating gold shopkeepers. In this regard, FIR No. 42/2025 has been registered at PS Lal Bazar under Sections 303(2) and 318(4) of the Bharatiya Nyaya Sanhita.

During further investigation, police said credible evidence surfaced pointing to the involvement of two associates who were facilitating the disposal of stolen gold. Both have been arrested.

They have been identified as Shameem Ahmad Sheikh, son of Sonaullah Sheikh of Iqbal Colony, Indra Nagar, a goldsmith at Bohri Kadal accused of knowingly purchasing stolen gold at undervalued rates and helping in its concealment and circulation, and Basir Ahmad Dar, son of Abdul Aziz Dar of Nawakadal, who police said was involved in transporting and clandestinely disposing of stolen gold.

All three accused are in custody, and police said further arrests and recoveries are expected as the investigation progresses.

n Old Srinagar, a small square was meant to be a fresh start for the neighbourhood. New tiles brightened the ground. Benches invited families to sit and relax. Public spaces bring people together. They help strangers feel like neighbours. When these spaces stay dirty and damaged, the distance grows. The city begins to feel unfriendly instead of welcoming.

Taking care of a public space only needs manners. Walk on the paths instead of flowerbeds. Use dustbins. Respect the effort that went into making the place better. Remind others when they forget. These everyday actions create pride. And pride builds community.

The locked square in Old Srinagar sends a stark message: money can create beauty, but people must protect it.

So, the next time a public space opens, let it stay open. Paradise is not just a view. It is home. And home should be treated with love.

# A Copenhagen-style **Future for Lal Chowk**

Srinagar can join global city centres that grew stronger by choosing clean mobility over more traffic and fumes.

everywhere are rethinking how people move through their busiest streets.

From Istanbul's Sultanahmet to the walkable promenades of Copenhagen, the idea stays the same: a city works best when its heart breathes, instead of choking on traffic.

As Srinagar plans its own mobility shift, especially around Lal Chowk and nearby markets, the global push for clean energy, shared transport, and peoplefriendly spaces feels more important than ever.

Srinagar's historic centre sees tens of thousands of people every day. Students rush to classes, of fice workers squeeze through tight schedules, families visit hospitals, shopkeepers lift their shutters. and tourists arrive to feel the pulse of the city

On a typical weekday, around 35,000 to 40,000 vehicles enter the wider Lal Chowk area through MA Road, Residency Road, Dalgate, Jehangir Chowk and nearby routes.

What stands out is how people choose to travel.

More than 60% of these vehicles are private cars and twowheelers. But they carry less than 20% of the total commuters.

Most people are moving in the least space-efficient way, taking up the most road space while transporting the fewest passengers.

This is where small, clean-energy vehicles like e-rickshaws can shift the balance.

An e-rickshaw uses only about 3 to 5 kWh of electricity for a full charge. That is roughly equal to just half a litre of petrol. One charge usually covers 70 to 90 kilometres, which means it can make many short trips in a day without releasing any tailpipe pollution.

On the other hand, a regular petrol car emits 120 to 150 grams of CO for every kilometre it travels.

So, if an e-rickshaw takes over even 40 kilometres of short trips that would otherwise be done by a private car, the city prevents around 5 to 6 kilograms of carbon emissions in a single day from just

On Srinagar's busiest roads, a private car takes up about 8 to 10 square meters of space and usually carries just one person. An erickshaw takes less than half that space, but it keeps moving 8 to 12 passengers every hour through short, quick trips.

Over a full day, one e-rickshaw can serve 120 to 160 passengers. A private car used only for commuting might move just two or three people in total.

This difference in efficiency is hard to ignore in a city where every square foot of road is precious. The economic benefits are

When a commercial centre is easy to walk around, convenient to reach, and free from big vehicles, more people visit the shops. In Chandni Chowk in Delhi

and Church Street in Bengaluru, studies found retail visits rose by 18-25% after the areas became safer and less crowded. Internationally, Copenhagen

found that when it created calm mobility corridors, it brought four times more daily pedestrians over the decades, boosting local businesses in the process

A similar model could work

In the Lal Chowk area, where businesses depend heavily on walk-in customers, students, and daily repeat shoppers, shifting toward cleaner, smaller vehicles encourages more walking, easier street crossings, and longer stays.

All of it adds up to a busier, more successful marketplace.

Energy use tells an even stronger story. One litre of petrol holds around 8.9 kWh of energy, but a normal petrol car turns only 20 to 25% of that into actual movement. The rest is lost as heat.

An e-rickshaw, on the other hand, uses electricity far more efficiently. More than 80% of the energy goes straight into moving passengers.

So when hundreds of short trips in the city centre shift from fuel to electric power, the energy savings add up fast

In busy areas like Lal Chowk, where thousands of quick rides happen every day, this efficiency helps the city become quieter, cleaner, and less dependent on fuel. But the impact is not just envi-

ronmental or economic. It is social. Around Lal Chowk, MA Road, and Residency Road, more than 60,000 students live their daily routines alongside office workers, shoppers, and people visiting clinics.

For many of them, e-rickshaws offer what they need most: an affordable, reliable, and accessible ride.

They act as the city's most flexible last-mile option, quickly connecting people from bus stops and shared taxi stands to the inner commercial lanes where bigger vehicles struggle to move.

Cities that improved their mobility systems, including Singapore, Seoul, Madrid, and even parts of Delhi, did it by strengthening these last-mile electric services.

If Srinagar wants Lal Chowk to feel cleaner, calmer, and more in line with global city centres, the answer may not be to push out small electric vehicles. Instead, we need to control how many private cars enter the core.

Many cities do this by building parking hubs at the edge of busy districts.

In Singapore, for example, large parking facilities sit outside the main shopping zones. Srinagar could follow a similar approach around Batamaloo to hold most of the cars coming into the centre.

From there, e-rickshaws, using very little energy and producing zero emissions, can take people into the pedestrian-friendly heart of the city.

In the long run, this is not a fight between one type of vehicle and another. It is about deciding what kind of city Srinagar wants to become: a city with cleaner air, safer streets, more shoppers, and stronger local business

arren Buffett never bought land in Kashmir. But many smart investors here unknowingly follow his approach.

They study plots for years. They ignore brokers who push pressing deals. They stay calm through political tension and changing tourist seasons. They focus on what a property can earn and treat land like a business.

This slow and steady mindset has silently built wealth in one of India's most uncertain real estate markets.

But not everyone listens to patience. In 2018, Nazir Dar borrowed against his father's orchard to buy three new flats near the airport. Brokers promised the highway expansion would double their prices within months. Nazir hoped to sell quickly, clear the loan, and keep the profit.

Then everything got delayed. Worried about his growing interest payments, he sold two flats at a loss. The third is still unsold, worth less than what he paid.

Something similar happened in Anant-

Gulzar Ahmad, a retired teacher, trusted a broker named Mir who visited him often with glossy brochures and big claims. Gulzar sold a family plot for what he thought was a good price and bought two smaller parcels Mir said were under-

Both new plots had legal disputes. The money disappeared into court cases. Gulzar now rents the home his grandfather

once owned. In Sopore, shopkeeper Gaffar Khan and his cousin Ali from Kupwara gathered money from relatives to flip properties. They bought agricultural land near proposed highways and commercial shops

We liked the idea, so in 2018 we advertised for "Aayas," promised 5,000 rupees a month and forgot to write what the job actually is.

The omission turned a global best practice into a maid post and wasted the cheapest chance we have to lift early learning across the valley.

The government order that created the position runs to four lines. It says "engage Aaya on need basis."

It never spells out the peed, payer

It never spells out the need, never lists tasks, and never sets working hours.

Head teachers filled the blank the way institutions always do: they handed the new hire a bucket.

Overnight the classroom assis-

Overnight the classroom assistant became the school maid, and the concept that helps Finland top world charts was reduced to scrubbing toilets and peeling onions for the midday meal.

Aayas are not make-believe characters. They are real women already on the payroll: 6,400 across the val-

ley, one for every 25 Balvatika, kindergarten, pupils.

Most never finished high school, but they spend seven hours a day with four- and five-year-olds whose brains are forming faster than at any later stage.

Research from the National Council of Educational Research and Training shows rural first-grade classes with a trusted ancillary worker record 17 percent lower absenteeism

We have the ratio right. We simply refuse to treat the worker as educator.

The salary tells the story. Five thousand rupees is less than the price of a single school blazer sold in Srinagar's boutiques. It arrives quarterly, often three months late.

Three quarters of Aayas hold a second job after the last bell. 40 percent report chronic back pain from mopping floors. Burnout is routine, turnover is rising, and still the department wonders why the teaching-learning process stays stuck.

We could blame headmasters for overloading the position, but they were never given guidance.

One principal sends the Aaya to maintain voter rolls during village elections. Another makes her midday-meal incharge. Neither violates

the original order, because the order is silent. And silence is expensive.

Finland spends 4 percent of its education budget on auxiliary staff training. We spend zero and then complain that our reading scores trail the global median.

Signs of repair are visible, but they are tentative.

This summer the State Council of Educational Research and Training teamed up with a local nonprofit to run three-day workshops in all ten districts. Two thousand Aayas have

already practised breathing games and learned to flag early signs of dyslexia.

Attendance is voluntary, enthusiasm is high, and the first cohort of schools reports a 9 percent jump in daily attendance from kindergarten sections.

The program costs less than the price of two smart classrooms that usually stay locked for want of a key.

What comes next is neither mysterious nor costly.

Double the honorarium to 10,000 rupees and pay on time through the same direct-benefit portal already used for pensions. Issue a one-page

role chart signed by the director of school education: Aayas will assist in classroom management, maintain play corners, accompany sick children to the nearest health center and will not cook lunch.

Finally, guarantee twelve hours of refresher training every year, the same way we refresh math teachers on new textbooks.

The package would add 1.2 percent of the existing central education outlay for the region, and could place a trained second adult in every Balvatika room by next spring.

Kashmir public schools enroll 1.2 million children. One in four is a Balvatika pupil, the age group whose test scores predict later retention, employment and even civic participation.

Give each of those rooms a confident, trained Aaya and we add the equivalent of a full academic year to a child's life before grade three.

Keep the mop and we lose the moment, probably for another generation.

# What Happened to Our Meals?

Fast food now rules young appetites in Kashmir. Reviving local food traditions offers a path to lasting well-being.

Subzar Ahmad Reshi

grew up seeing food as a form of love. My grandmother cooked with ingredients that always had a story behind them.

Fresh produce came from nearby farms, grains were ground at home, and fruits and vegetables were dried for winter. Noon chai paired with homemade bread. A simple bowl of millet or maize kept people going through long days.

No one counted calories or talked about nutrition. Health came from the food on our plates.

Today, I feel worried when I look around. Home-cooked food has lost its place in many Kashmiri lives. Lines outside fast food stalls grow longer every month. Even toddlers know the flavour of packaged chips better than the taste of a simple recipe cooked at home.

The change did not arrive overnight. It slipped into our everyday life until we started accepting it as normal.

I teach students who survive on fried snacks, sugary drinks, and restaurant meals from early morning until late evening. Many leave home without breakfast. They rush from school to tutoring centers and grab whatever is sold outside. Their parents try to cook for them, though their efforts often lose to catchy ads and shiny wrappers designed to make junk irresistible.

Health reports from hospitals tell a harsh story.

Obesity, hypertension, and diabetes show up earlier in life now. Doctors speak about teenagers with high cholesterol. Many young adults take daily medicines for issues that once appeared only in old age.

International studies by the FAO and USDA keep reminding us that natural foods protect the heart, brain, bones, immunity, and mood.

More than ninety percent of lifestyle diseases in families stem from how we eat.

There is another side to this picture. Some households struggle to afford proper nutrition. Work keeps parents away from kitchens for long hours. Fresh vegetables and whole grains often cost more than processed options.

ten cost more than processed options. Food choices shrink when the goal is only to stay full enough to get



through the day.

I meet children who have access to calories but not nourishment. Two different food crises exist in the same society: overeating without health and under-eating without strength.

Good food costs money, though poor food drains far more through hospitals and pharmacies later in life. I hear people say they will manage

I hear people say they will manage with whatever is available and focus on work first. How long can a person truly work when the body feels tired

and inflamed from chemicals and excess oil?

There is also the land that feeds us. Farmers today rely on pesticides and synthetic fertilizers to grow more and earn faster. These substances end up in rivers, lakes, and soil.

A vegetable may look perfect from outside while carrying chemicals that silently damage health.

Kashmiri fields once produced clean food. That memory deserves a return as we face a future shaped by

climate stress and rising disease.

Organic farming is possible here. Traditional crops like millets and pulses suit our soil and climate. Apple orchards and walnut trees can thrive without harmful chemicals if farmers receive proper support.

When the earth heals, we heal along with it. Real food begins far before it reaches the kitchen.

The cultural memory of food in Kashmir holds strength. We once believed that feeding someone was equal to blessing them. A cup of kehwa prepared at home tasted like welcome. A plate of haakh served love.

These dishes still exist, though fewer young people know how to prepare them. Food traditions fade when families stop passing them down.

I want children to learn where food comes from and how it supports memory, stamina, and immunity. A simple lesson about whole grains or vegetables can shape habits for years. Public spaces can encourage healthier options too.

Educational institutions with access to clean, homemade food would improve life more than any billboard promoting exam success.

Everyone has a role. Doctors can talk about prevention. Parents can bring their children back to the dining table. Restaurants can celebrate local ingredients instead of only copying global menus. Policymakers can promote chemical-free farming and regulate harmful additives. Social groups can organize food literacy drives that

# IAF Tejas Jet Crashes at Dubai Air Show, Pilot Killed

Srinagar: A Tejas fighter jet of the Indian Air Force crashed during an aerial display at the Dubai Air Show on Friday, killing the lone pilot, Wing Commander Namansh Syal. The accident, which occurred around 2.10 pm local time, is the second involving the indigenous Light Combat Aircraft in less than two years.

Video footage showed the aircraft losing height during a low-altitude manoeuvre before nosediving and exploding into a ball of fire inside the airfield grounds. Thick black smoke rose over Al Maktoum International Airport as stunned spectators watched the crash unfold.

Wing Commander Syal, in his mid-30s and a native of Himachal Pradesh, died on the spot. The IAF said it "deeply regrets the loss of life" and has ordered a court of inquiry to



determine the cause.

Aeronautics Limited, manufacturer of the LCA Tejas, said it was "deeply saddened" by the loss of the "courageous IAF pilot." Defence Minister Rajnath Singh and Chief of Defence Staff General Anil Chauhan also expressed grief and extended condolences to the pilot's family. The Congress party too mourned the

death, with Rahul Gandhi saying the nation stands with the bereaved family.

The crash took place during an eight-minute demonstration flight on the final day of the biennial air show, which features flying and static displays from global aerospace giants. The air show resumed its demonstrations about ninety minutes after the accident

Eyewitnesses told local media the jet appeared to turn sharply before going down, and some believed the pilot was attempting to avoid residential areas

The previous Tejas crash occurred in March 2024 during a return flight from the Bharat Shakti military exercise in Jaisalmer. The pilot had ejected safely in that incident.

enous multi-role light combat aircraft, designed for air-toair combat, ground attack and maritime missions. The jet, declared airworthy in 2011, has gone through decades of development. Two IAF squadrons, 45 and 18 Squadrons, currently operate the Tejas.

The aircraft has faced scrutiny over past technical issues but remains central to India's longterm fighter fleet plans. In 2021, the government signed a Rs 48,000 crore deal with HAL for 83 upgraded Tejas Mk-1A jets. In 2023, the defence ministry cleared an additional proposal for 97 more aircraft.

As emergency teams worked at the crash site in Dubai, the local administration said it responded rapidly to the incident. Police and firefighters sprayed foam across the area, while Indian diplomatic officials reached the spot.

According to Labour Minister Mansukh Mandaviya, the labour Codes will formalise employment, strengthen worker protections, and make the labour ecosystem simpler, safer and globally aligned.

Additional systemic reforms include a national floor wage, gender-neutral work policies, the Inspector-cum-Facilitator model for supportive compliance, faster dispute resolution through two-member tribunals, and a National Occupational Safety, Health (OSH) Board to harmonise safety standards.

The government will now initiate consultations to frame detailed rules and schemes.

During the transition, provisions of existing labour laws will remain applicable wherever required.

The social-security coverage had expanded from 19 per cent in 2015 to over 64 per cent in 2025. The enforcement of the Labour Codes marks the next transformative step -- broadening worker protections, easing business operations and promoting a pro-worker labour

According to a labour ministry statement, the Codes lay the foundation for Aatmanirbhar

India's labour laws were framed in the pre-Independence and early post-Independence era (1930s-1950s), at a time when the economy and world of work were fundamentally

Labour Minister Mandaviya said on X, "Modi Government's Guarantee: Dignity for Every Worker! From today, the new labour codes have been made effective in the country."

The minister said the codes will guarantee minimum wages for all workers, appointment letters for the youth, equal pay and respect for women, social security for 40 crore workers, gratuity for fixed-term employees after one year of employment, free annual health check-ups for workers above 40 years of age, double wages for overtime, 100 per cent health security for workers in hazardous sectors and social justice for workers as per international

"These reforms are not just ordinary changes, but a major step taken by Prime Minister Shri Narendra Modi for the welfare of the workforce. These new labour reforms are an important step towards a self-reliant India and will give new momentum to the goal of a developed India by 2047," he said on X.

Under the Code on Social Security, 2020, all workers, including gig & platform workers, will be covered by social security. All workers will get PF, ESIC, insurance, and other social security benefits.

Under the Code on Wages, 2019, all workers will receive a statutory minimum wage payment. Minimum wages and timely payment will ensure financial security.

The ESIC coverage and benefits are extended Pan-India -- voluntary for establishments with fewer than 10 employees, and mandatory for establishments with even one employee engaged in hazardous processes.

Now, Fixed-Term Employees (FTE) will receive all benefits equal to those of permanent workers, including leave, medical, and social

The Codes have defined 'Gig work', 'Platform

work', and 'Aggregators' for the first time. Aadhaar-linked Universal Account Number will make welfare benefits easy to access, fully portable, and available across states, regardless

Plantation workers will be brought under the OSHWC Code and the Social Security Code.

Digital and audiovisual workers, including journalists in electronic media, dubbing artists, and stunt performers, will now be entitled to full benefits.

#### **What New Labour**

The four Codes — Code of Wages (2019), Industrial Relations Code (2020), Code on Social Security (2020) and the Occupational Safety, Health and Working Conditions Code (2020) - replace 29 separate laws with a unified legal framework. The government said the updated structure creates a future-ready labour ecosystem that protects workers while easing compliance for industry.

The reforms significantly expand rights for workers across sectors, particularly gig workers, platform workers, migrants, contract labour and MSME employees.

Key before-and-after shifts include: Appointment letters: Mandatory for all

workers, ensuring transparent and documented employment.

· Universal social security: PF, ESIC, insurance and other benefits extended to all workers, including gig and platform workers.

further observed that while the factor of prolonged incarceration is undoubtedly a relevant consideration in the adjudication of a bail application, such consideration cannot, in itself, furnish an adequate or independent ground for the grant of bail in cases governed by the rigors of Section 37 of the NDPS Act.

"The statutory restrictions imposed under Section 37 are mandatory in nature, and the Court is bound to record its satisfaction regarding the twin requirements—first, that there exist reasonable grounds for believing that the accused is not guilty of the alleged offence, and second, that he is not likely to commit any offence while on bail," the court said while rejecting Dar's contention that he has been in

custody since 2021. "This Court is equally mindful of the petitioner's plea that petitioner has been in custody for more than four years, having already undergone more than one-third of the minimum sentence prescribed, therefore, in light of such prolonged incarceration the continuance of the detention of accused would impinge Article 21," the court said, adding, "However, the record reveals that as many as ten prosecution witnesses out of thirteen have already been examined, and the trial is now at an advanced stage. The right under Article 21 operates subject to the 'procedure established by law', and Section 37 of the NDPS Act constitutes such

valid and stringent statutory procedure." Where the Legislature, in its wisdom, has mandated the recording of specific satisfaction before granting bail in cases involving commercial quantity, the Court cannot dilute or bypass these conditions on general notions of delay or liberty, the Bench said.

"Consequently, the continued custody of the petitioner (Dar), in the absence of satisfaction of the twin conditions, cannot be characterized violative of Article 21 of Constitution of India. the court said and rejected Dar's plea for grant

Police teams also inspected lockers used by doctors and staff in district hospitals, private hospitals, medical colleges and PHCs across Srinagar to ensure there was no unauthorised storage of hazardous or prohibited items.

In Anantnag, teams checked vehicle dealerships for documentation, stock verification and compliance with the Motor Vehicles Act. Dealers were directed to maintain accurate records and share sale and purchase details with authorities.

Officials said similar operations were underway in other parts of the valley as part of efforts to strengthen public safety and prevent anti national activities. Police said the inspection drives will continue in the coming days and urged citizens, shopkeepers, dealers and medical staff to cooperate.

# **Enhanced ILS to Keep Sgr Airport Flights Running Without Cancellations**

SRINAGAR: Director, Srinagar International Airport, Javid Anjum, on Friday said the flight cancellations due to weather are 'unlikely this winter' as the airport has been equipped with an upgraded Instrument Landing System (ILS) Category-II.

Speaking to KNO, the Director said the upgraded system ensures safer and more reliable landings even under low-visibility conditions.

Anjuman said that Srinagar usually records around 1,000 metres of visibility during winters, which allows for comfortable landings. "Earlier, the threshold was 1,200 meters, but now the system is much improved. This year, we expect no flight cancellations," he said, adding that the upgraded ILS now allows landings with visibility

as low as 400 metres. The Director said the ILS up-



grade was already functional last year and that no cancellations occurred due to weather conditions, marking a major improvement in airport reliability

during foggy and snowy months. Highlighting enhanced passenger facilities, he said, "We have improved the heating system, added more seating and also introduced free Wi-Fi for passengers. The airport has also seen the addition of 22 new retail shops and nine food & beverage outlets, with three more expected to open soon."

On flight operations, Anjum

said the number of daily flights has dropped mainly due to lower passenger turnout, not operational constraints. "We had around 54 flights per day before the Pahalgam episode, but now we are operating about 30. Passenger traffic has declined from around

19,500 daily to 8,000-10,000, though we expect a rise with the onset of winter tourism," he said.

Regarding international oper-ations, the Director said the airport has "ample infrastructure" to handle international flights and that a formal request has already been made to the ministry. "We are ready, and it now depends on the airlines to come forward," he added.

# 'Fight Where It Matters': Ruhullah Rebukes CM, NC Leaders

SRINAGAR: Member of Parliament Aga Syed Ruhullah Mehdi on Friday issued a sharp rebuttal to criticism from some National Conference (NC) leaders, urging them to "direct their political energy where it is actually needed" rather than targeting him.

Speaking to reporters after visiting Hari Parigam in Awantipora to condole the family of Crime Branch photographer Javid Ahmad-killed in the recent Nowgam blast—Ruhullah said senior NC figures should have displayed the same courage against the central government that they are now showing towards him.

He said that the Chief Minister must "set ego aside" and prioritise the mandate given by the people. "Omar Abdullah should avoid personal attacks and fight for what he received votes for," he said.



The MP spent time with the bereaved family, assuring them that he would raise the issue at all relevant forums and push for justice for every affected household.

Ruhullah renewed his call for a thorough and independent investigation into the Nowgam blast, questioning the manner in which the ammunition material was transported and stored. "Why was such sensitive material handled in an unprofessional way? Why was it kept inside a police station? And how were civilians, including the tailor and the Naib Tehsildar, present there? Every angle must be examined so that the truth comes out," he said.

He urged the administration to extend compensation to all victims, including civilians and officials who were injured or killed. "Whoever has suffered in this blast deserves compensation. The government must ensure justice reaches every affected family," he added.

He emphasised that the fight against terrorism has been a collective struggle. 'People from every community-Muslims and non-Muslims-have sacrificed. Javid Ahmad's death is also part of that fight."

Reiterating his long-held position, Ruhullah said the restoration of democratic rights and empowerment of states remains crucial. "People in J&K felt empowered when they had special status. After its revocation, they feel disempowered. States must be strengthened through democratic rights," he said.

#### **Mehbooba Mufti, Family Should Be Probed for Terror Links: BJP**

he BJP's Jammu and Kashmir unit on Friday called for a probe into the "possible terror links" of Peoples Democratic Party president Mehbooba Mufti and her family.

BJP spokesperson Altaf Thakur criticised Mehbooba and her daughter Iltija Mufti for repeatedly defending the Kashmir Times daily, which was raided by the Jammu and Kashmir Police's State Investigation Agency a day ago.

According to PTI, Thakur questioned the motive behind the Mufti family's stance and their constant objections to anti-terror actions of agencies.

The pattern is too obvious to ignore: whenever law enforcement agencies have taken action against the newspaper over controversial activities in the past, the Mufti family became its most vocal defender," Thakur said, adding that it is strange and raises serious doubts.

"Why do Mehbooba and Iltija immediately jump in to support Kashmir Times? What is their interest? Is there some old association or influence that keeps bringing them into the picture every time?" the BJP spokesperson asked.

Calling for a probe, Thakur said agencies must thoroughly examine all angles, including any questionable affiliations if they exist, rather than allowing political noise to derail actions aimed at dismantling support systems that once glorified separatism and terrorism. (Observer News Service)

#### **Surprise Ticket Drive at Jammu Station Catches 60 Without Tickets**

orthern Railway's Jammu Division conducted a surprise ticket-checking operation at Jammu Railway Station early Friday, during which 60 ticketless travellers were detected and fined a total of 26,325,

The four-hour "fortress check" was carried out from 4 am to 8 am with a team of 15 ticket-checking personnel led by Senior Divisional Commercial Manager Uchit Singhal, alongside Railway Protection Force (RPF) and Government Railway Police (GRP) staff. Security personnel were stationed at all entry and exit points to verify ticket validity and check for any unauthorized or suspicious items, the railway division said in a statement.

Officials noted that Jammu station handles a heavy rush of passengers during early morning hours, making it a key location for such checks.

Singhal said similar surprise drives will continue across the division to discourage ticketless travel and enhance security at stations. According to the railway division, over 40.06 lakh in penalties has been collected so far this financial year from around 6,600 passengers without valid tickets. (Observer News Service)

# Zainapora DM Bans Loudspeakers for Moving Vendors

SRINAGAR: Sub-Divisional Magistrate (SDM) Zainapora, Bilal Ahmad has issued a stringent public order banning the use of mikes and megaphones on moving vehicles across the sub-division.

The move comes in response to a rising number of complaints about noise pollution caused by vendors using loudspeakers while selling fruits and other consum-

Officials informed KNO that the administration had been flooded with complaints from residents during public outreach programmes, including the recent Block Diwas held on November 19,

where locals highlighted the "unbearable disturbance" caused by frequent loud announcements by mobile vendors.

Invoking Section 152 of the Bharatiya Nagarik Suraksha Sanhita (BNSS), 2023, the SDM directed that no vendor shall henceforth use loudspeakers or megaphones while moving through streets, lanes, or market areas within Sub-Division Zainapora.

The order states that the practice has been causing "noise and other pollutions... rendering public spaces congested and susceptible to accidents", and is "injurious to the health and physical comfort of the community".

The notice further warns that

any violation will attract strict penal action under the law.

The decision has drawn strong support from residents, many of whom say the problem has been growing unchecked for years. Speaking to KNO, Mohammad

Yousuf, a resident of Zainapora,

said the constant loudspeaker announcements had become "a daily nuisance". "Since early morning till late

evening, these vendor vehicles keep roaming with loudspeakers on full volume. It disturbs people, especially students, patients, and elderly persons. This order was much needed," he said. Another local, Shakeela Bano,

said the elderly and sick were

the worst affected. "My mother is bedridden, and every time these vendors pass by with loudspeakers, she gets startled. Such noise has no justification. We are thankful the administration finally listened."

Parents also expressed relief, saying the move will help students prepare for exams without any disturbance. Rameez Ahmad, a college

student, said that during exam season, the noise becomes unbearable. "I hope this order is implemented strictly, and other areas also follow the same." he said. Several residents from neigh-

bouring villages have called for similar orders across Kashmir.

"The issue is not limited to Zainapora. Almost every town and village faces this problem," said Imran Mir, a shopkeeper from Shopian. "Authorities across Kashmir should impose a uniform ban on these unnecessary loudspeakers. Public comfort must be pri-

Officials said the move aims not just to curb noise pollution but also to reduce road congestion and accident risks caused by randomly parked vendor vehicles.

An official told KNO that enforcement teams have already been instructed to monitor the movement of such vehicles and take action wherever violations are noticed.

# **UTLBC's Special Drives Bring Forgotten Savings Back to Citizens**

SRINAGAR: In a bid to simplify the process of reclaiming long-pending financial assets, the Jammu & Kashmir Union Territory Level Bankers' Committee (UTLBC) organised Special Facilitation Camps in Reasi, Rajouri and Anantnag under the nationwide initiative "Aapki Poonji, Aapka Adhikar – Your Money, Your Right." The programme is part of a threemonth campaign launched by the Union Ministry of Finance's Department of Financial Services (DFS) in coordination with RBI and other financial regulators.

The camps assisted citizens in tracing unclaimed bank deposits, dormant insurance proceeds, inactive mutual fund units, unclaimed dividends, shares and other assets held with various institutions.

At the district-level camp



in Reasi, ADC Rakesh Kumar, accompanied by RBI Deputy Manager Vibha General Gupta and senior officials from banks and insurance companies, underscored the role of coordinated financial outreach. Gupta highlighted RBI's "3A Strategy — Awareness, Accessibility and Action," urging banks to proactively identify dormant accounts. She said Reasi has 36,642 unclaimed accounts worth Rs 9.95 crore, and encouraged banks to return funds to rightful claimants

in a time-bound manner.

Participants were trained

in using the RBI's UDGAM Portal, and 20 beneficiaries received cheques totalling Rs 35 lakh.

In Rajouri, the camp hosted at J&K Bank's Zonal Office brought together officials from RBI, NABARD, commercial banks and insurance firms. Zonal Head Rajeev Kumar Digra stressed the importance of last-mile financial literacy. The district has 81,955 unclaimed accounts amounting to Rs 17.45 crore, officials said. During the camp, 17 beneficiaries were handed over cheques worth Rs 8.10 lakh.

## **LG Ladakh Calls on Union Health** Minister JP Nadda

**NEW DELHI:** Lieutenant Governor of Ladakh, Kavinder Gupta on Friday met J.P Nadda, Union Minister of Health & Family Welfare and Minister of Chemicals & Fertilizers, in New Delhi and discussed key issues related to healthcare development, medical education, and public welfare in the Union Territory of Ladakh.

Kavinder Gupta expressed gratitude for the continuous support extended by the Union Government and apprised the Union Health Minister of the progress on major projects, including the establishment of Ladakh's first Medical College and the proposed Nursing College in Leh. He informed that substantial steps-such as release of central funds, land allotment, and submission of proposals for construction and creation of posts-have already been completed. He requested the Ministry to expedite the remaining administrative approvals so that the Medical College and Nursing College can be operationalised at the earliest.

The Lt Governor also highlighted the need to fast-track the upgradation of District Hospital Kargil from 100 to 200 beds, noting that construction of additional infrastructure is under progress but the creation of essential posts requires early approval from the Ministry.



Kavinder Gupta further requested the establishment of a CGHS wellness centre in Leh, pointing out that thousands of central government employees and pensioners posted in Ladakh currently lack access to this facility. He also urged the Ministry to bring the entire ST population of Ladakh under full PMJAY coverage and revise the premium to reflect higher healthcare delivery costs in the region.

The Lt Governor proposed setting up a specialised AYUSH Hospital and requested consideration for establishing an AIIMS campus in Leh to significantly improve tertiary care and medical research in the trans-Himalayan region. He reaffirmed Ladakh's commitment to building a strong and inclusive healthcare ecosystem with continued support from the Government of India.
