Youth Must Resist Radicalisation: LG


Urges Athletes To Drive Social Change Through Sports

J&K Tightens Checks On Vehicle Trade With New Guidelines

Srinagar: In a move aimed at curbing misuse and fraudulent transfer of vehicles, the Jammu and Kashmir government has issued fresh operational guidelines making authorisation mandatory for all dealers han-dling registered vehicles in the Union territory.

Officials said the Transport Commissioner's office has circulated new operational guidelines for the registration and authorisation of dealers of registered vehicles, following a notification issued by the Union Ministry of Road Transport and Highways.

The new framework makes authorisation compulsory for



any entity dealing in resale, stock or handling of registered vehicles, with complete digital traceability ensured through the VAHAN platform. Key provisions include online

applications with mandatory verification of premises, fiveyear validity of authorisation, real-time reporting of transactions, secure custody of vehicles, and | More on P6

'The question that arises for determination is whether, in these circumstances, it was obligatory for the Investigating Agency to send samples from each of the 38 recovered bottles for chemical analysis. The answer is an emphatic 'no', as all the bottles contained a similar solu-

tion from the same batch. Therefore, one sealed bottle from the recovered lot would. prima facie, constitute a representative sample of the entire seizure," observed a bench of Justice Sanjay Dhar while dismissing the bail plea of Rouf Ahmad Ganie

Kataria, who arrived in Kashmir on a multiday visit, said Srinagar's transformation into one of India's top tourist destinations was a matter of national pride. "There was a time when coming here wasn't easy. But today, tourists from all over India

are walking freely in Lal Chowk and enjoying the beauty of Kashmir. That is the biggest sign of peace and progress," he said.

The Governor also praised the Valley's cold weather and natural charm, saying both have helped boost winter tourism. "Kashmir's chill carries warmth and it brings people together. The more tourists visit, the stronger our emotional and cultural unity becomes," he added.

Four Accused Charge Sheeted for Fake Property Deal

Srinagar: The Economic Offences Wing of Crime Branch Kashmir filed a charge sheet before the Court of Chief Judicial Magistrate Srinagar against four accused persons involved in an alleged property fraud amounting to Rs 1.66 crore.

The accused have been identified as Abdul Wahid Khan son of Abdul Qayoom Khan of Khan Mohalla Baghat e Barzulla Srinagar, Mohammad Yousuf Malik son of Late Mohammad Ramzan Malik of Nai Sarak Habba Kadal Srinagar at present Natipora Srinagar, Mohammad Ashraf Mir son of Ghulam Nabi Mir of Hakhripora Pulwama, and Mohammad Maqbool Shah son of Late Shamas ud din Shah of Peerbagh Srinagar. The case followed a complaint filed by individuals who were seeking to purchase a house along with sufficient land in Srinagar.

According to the investigation, the complainants were approached by the accused posing as property dealers. They allegedly showcased a double storey house along with one kanal and five

marlas of land at Chinar Colony Baghat i Barzulla, claimed to be owned by Mst Koshaliya widow of Jawahar Lal Rafiz. Crime Branch Kashmir stated that the accused prepared forged documents and executed a false agreement to sell migrant property, persuading the complainants to pay an initial sum of Rs 1.16 crore.

According to KNT, the investigation further revealed that the accused later inflated the sale price and extracted an additional Rs 50 lakh. Despite receiving a total of Rs 1.66 crore, the accused neither handed over possession of the property nor refunded the money Crime Branch Kashmir said the four accused were found to have entered into a criminal conspiracy and executed fraudulent documents to misappropriate the complainants' hard earned money.

A charge sheet in FIR No 14 of 2018 under Sections 420, 468, 471 read with 120 B of the RPC has been submitted for judicial determination. During proceedings, the Court remanded two accused. Mohammad Yousuf Malik and Mohammad Maqbool Shah, to judicial lock up.

Feed Community Animals Under New ABC Rules: SMC

Srinagar: The Srinagar Municipal Corporation (SMC) on Tuesday issued a public advisory, urging residents and community representatives to ensure the humane feeding and care of street and community animals across the city, in line with the revised Animal Birth Control (ABC) Rules, 2023 notified by the Ministry of Fisheries, Animal Husbandry & Dairying.

According to the notice, issued by the Municipal Veterinary Officer, the duty of arranging feeding spots and schedules now rests with Resident Welfare Associations, Mohalla Committees, Apartment Associations and recognized animal welfare activists.

The notice states the civic body said such spots must be designated through mutual understanding and kept away from areas frequented by children or senior citizens, such as playgrounds, staircases and main entry or exit points.

The notice further reads that feeders must ensure no littering occurs at feeding locations and all activity should remain in conformity with guidelines framed by local committees.

Moreover, the designated feeders have been permitted to assist SMC teams in vaccination drives, animal catching and release operations under the Animal Birth Control programme.

The first challenge is the break in routine. Schools close, outdoor life slows down, and evenings stretch longer. This change affects everyone, but it hits harder for people who already feel

Doctors at IMHANS see more patients in winter with panic attacks, disturbed sleep, and low mood. Less sunlight plays a big role. It lowers energy, affects sleep, and makes the mind feel

heavy. That is why we must plan ahead. Light is the easiest and most helpful tool. Even a few minutes in the sun can lift the mood. Families can step outside whenever sunlight appears. Elders can sit near a window in the morning. Offices can give short daylight breaks. Light gives the mind a gentle push and helps the body stay balanced.

Cold weather keeps people mostly indoors and still, and stillness makes the mind feel dull. Small exercises can change that. Ten minutes of stretching, slow indoor walks, or simple work outs help a lot. Moving together also helps people stay connected

A small knock on the door or a five-minute phone call can

stop loneliness from turning into distress. Kashmir cannot avoid winter. The cold season may slow life,

With a few steady habits, the valley can move through these months with comfort, clarity, and strength.

Scams Shape Sales

Fake deeds, multiple sales and emotional pitches continue to pull buyers into avoidable scams.

uying land in Kashmir often feels like entering a deal where the other side has already planned the trap. Families save for decades and still fall into scams run by brokers, document forgers and small mafia net-

works. The cases of Ali, Muzamil, Ahmad and Nazir show a pattern that repeats across districts. Ali trusted a broker who promised quick access to farmland. He paid in cash and waited for a meeting with the owner. The broker disappeared and the land vanished with him. Muzamil relied

on clean-looking papers and handed over his savings. The documents belonged to a completely different plot. His "purchase' turned into an empty site and a long search for justice. Ahmad bought land through a man who claimed to hold power of attorney. Later, the actual owner returned from overseas and learned his signatures were forged. Ahmad entered a legal battle that drained more than the original cost of the plot. Nazir paid for a

so-called distress sale and received only paper slips. The same land had been sold to several buyers through duplicate agreements. These scams survive because brokers operate without regulation, land offices struggle with outdated records, and corruption creates space for forged deeds. Many buyers trust emotional stories, rush into payments or depend on middlemen who work

for hidden interests. Safe buying in Kashmir needs slow steps. Every payment must be traceable and made only to the seller. Documents should be checked at the sub-registrar's office and cross-verified on government portals. Buyers must inspect the land in person and consult experienced, independent legal help.

Strong due diligence costs far less than losing a lifetime of savings. In a risky market, caution remains the only real protection.

The J&K Upshift

A generation raised on the promise of government jobs is carving out a different economic path through skill, patience, and imagination.

ork in Jammu and Kashmir is going through a real shift.

For years, most young people prepared only for government jobs. Now many of them are choosing a different road. They are starting small ventures from their homes, rented rooms, shared offices, and even

from the back corners of family shops These ideas are changing daily life and showing how wide opportunity can stretch in the valley and in the hills of Jammu.

This new wave did not grow in easy conditions. It took shape in the middle of tough realities. The region's young founders often begin with modest resources and limited networks. They start with hope more than certainty. Even then, they persist.

Their journey has turned into one of the most interesting economic shifts in recent years.

Connectivity improved and government programs widened the pool of options available to young people. Online platforms allowed products from Kashmir to travel across borders. Digital literacy grew across schools and towns. The sense of possibility expanded.

Progress, however, moves alongside daily hurdles that make entrepreneurship in J&K a tougher climb than in many other parts of the country.

The business environment carries a level of unpredictability that can unsettle anyone trying to build something from the ground up.

Heavy snowfall, blocked roads, sudden communication breaks, and sensitive political conditions can slow work without warning.

A café owner in Srinagar, for instance, may spend days waiting for supplies stuck on the Jammu-Srinagar highway. A small logistics firm may struggle to keep delivery schedules steady.

These disruptions affect customer trust, long-term planning, and investor confidence. Entrepreneurs often source raw materials

from outside the region, raising input prices. Sending finished goods back to large markets adds another layer of expense. A young craft seller from Budgam shared

that shipping a single parcel to Bengaluru sometimes costs almost as much as the product itself. This imbalance cuts into earnings and

slows expansion.

Infrastructure gaps also hold back many promising ventures. Internet coverage has certainly grown, but several rural belts still face sudden drops in speed or breakdowns. This affects digital payments, online sales, and social media marketing. Warehousing facilities, cold storage units, and modern packaging services remain limited.

These gaps create real barriers for agribusinesses and handicraft exporters trying to reach competitive markets.

The administrative maze adds further strain. A first-time founder can spend weeks trying to understand licensing rules, tax requirements, and compliance procedures

lar supplies and limited brand visibility.

Tourism entrepreneurs search for stable partnerships in a sector that fluctuates with every major event.

Women are also shaping the startup landscape with remarkable will. Many run ventures from their kitchens or living rooms due to mobility limits or family expectations. Their access to funds, digital tools, and networks remains unequal.

Even so, women-led businesses across Kashmir are expanding with community support, online marketplaces, and word-of-mouth trust.

For all these challenges, young entrepreneurs continue to reshape the region's economic identity. Their work reflects ambition and also a

e a man. Men don't cry. Are you even a man? Start earning, you are a man. Mard ko dard nahi hota.

Kashmiri boys hear these words everytime, and everywhere. They grow up learning to hide their feelings, and hold their pain inside. Over time, the chest grows heavy.

Men carry these silences while society applauds women for speaking up. Feminism promised equality, but often it forgot that men face pressures too.

The movement began with a hashtag, #MeToo. Women shared experiences of harassment and violence. It gave them a voice that was long silenced.

With time, some cases turned out to be false, sometimes personal disputes disguised as justice.

But the accused men faced ruined reputations, with no apologies or chance to explain. A man's life could change overnight.

Despite these pulls and pressures, Kashmiri men silently play their roles as providers, caregivers, and partners. They love, protect, and try to make life easier for those around them. But society often

Sawalkote Gives Ramban a Reason to Believe Again

he hills of Ramban rise and fall like long waves, carrying the Chenab River in their folds. Pogal, Paristan, and Neel sit deep inside these folds.

Life here has moved at its own pace, far from the attention that other parts of Jammu and Kash-

Roads remained incomplete. Bridges held on through storms. Electricity flickered more than it flowed. Many projects, from rail lines to highway upgrades, passed these valleys without touching them. Families learned to expect very little from the world outside.

A fresh sense of hope arrived recently when the Ministry of Environment, Forest and Climate Change cleared the 1856 MW Sawalkote Hydroelectric Project in village Tanger. The site stands miles away, but the impact reached these remote communities at once.

It felt like an acknowledgment that Ramban's

most distant villages matter. I travelled through Maligam, a village that links Pogal and Paristan. Terraced fields stepped down to the Chenab. In the shade of a walnut tree, Bashir Ahmed rested after a long morning on his land. His hands told the story of years of work.

"Projects came to other areas," he said. "Our villages stayed cut off. Pogal, Paristan, Neel... we waited and waited. Sawalkote feels like a new sun

He looked toward the hills and spoke of his son. "He dreams of work near home. Young people leave because they have no other choice. This time, I hope he will stay.' This feeling repeats across these villages.

Sawalkote carries the promise of energy for the region, a dam and a powerhouse carved into the mountains. For local residents, the true meaning lies else-

where. It signals that development can reach villages long left outside the map of progress. The emotional impact is clear: the people feel seen. In Neel Valley, children ran along the water as

if sensing some shift. They imagine brighter class-

rooms and homes that stay lit at night. Mothers in Paristan picture evenings when they can help their children study without worrying about a lantern running out.

Farmers in Pogal talk about irrigation pumps,

reliable power, and tools that could ease the

weight of daily labour.

For decades, the four-lane expansion of NH44 passed them by, leaving dangerous stretches untouched. Promised rail lines stayed on paper. Every plan that skipped their villages deepened the sense of being forgotten.

Sawalkote changes that conversation.

Better roads, more stable power, and work opportunities may follow. Even the thought of these changes brings a spark that has long been missing.

There is caution as well. Residents understand what construction in hilly terrain can trigger: landslides, loss of forest cover, the chance of displacement. They hope for responsible planning, fair compensation, and a place at the table when decisions are taken. Their optimism rises from

In Maligam, Ghulam Mohammad summed up the mood. "We want our children to build lives here. Sawalkote gives us that hope.

Kashmir's Forgotten Rider, Found Inside a Photograph

An old picture from Handwara brings back the story of a tireless cyclist, a long week on the road, and the people who watched him ride through the dark.

have spent much of my life holding a camera, collecting small moments without thinking they would one day feel like

windows to another time.

Many prints aged before I could protect them. A few disappeared during transfers from one posting

The pictures that survived carry scratches and stains, though digital tools have given them new light.

One picture came back to life re-

Silverfish had eaten its corners and the surface had turned dull. After restoration, the image opened like a fresh page

The year was 1985.

I was living in my official residence in Handwara. The photograph shows a simple scene: four people sharing tea in a modest drawing room.

If you glance at it, the moment feels ordinary. When I look closely, I see the end of a long, extraordinary

The guest at the center of the picture was a cyclist who had taken on a challenge that still feels unbeliev-

His name has slipped from my memory, though his effort refuses to leave it.

He arrived from outside the region and set out to pedal for six nights and seven days. He wanted to test how far the human body can go on a simple bicycle.

I had heard of long-distance riders, from India's K2K challengers to global endurance legends, though watching someone attempt such a feat in a small Kashmiri town created its own sense of wonder.

He rode through the valley's



shifting weather. Days stretched into nights and nights into long hours of slow light. He ate little and drank carefully. His rest came in short spells inside a small tent that

my team had set up.
I remember checking on him dur-

ing the early hours when the streets fell silent. His cycle light created a thin path on the road. My support team stood near the route with paramedics, watching his steady

Every time I arrived, he was still

pedaling, his focus fixed on the next

My job was simple. I had to ensure his safety. This was an age without constant surveillance. Human vigilance was the only way to track the ride.

I assigned a dedicated group to monitor him and instructed them to stay alert through the long nights.

I visited at odd hours to make sure everything remained in order. We grew used to the sight of his silhouette moving through the darkness, hour after hour.

When he completed the challenge, we organized a small cer-

A medal, a certificate and a garland were presented. He looked exhausted and proud.
Later that day, I invited him home

for tea. That moment is what the restored photograph captures.

I sit in a plaid shirt. A colleague stands nearby. A young boy watches the scene. The cyclist holds his medal with calm face. But his body was still carrying the strain of the long ride.

It always felt larger than its words. It pulled us toward a hill that seemed to hold something steady at

The shrine of Baba Hanneef U Din Reshi [R.A.] sits on Daresh Hill with a natural ease. People call him Baab Sob as if he were part of the family. The mystic followed the path of Hazrat Zain Ud Din Wali [R.A.] of

Ashmuqam, who followed Sheikh Noor Ud Din Noorani [R.A.]. That line of devotion travelled across the valley and settled on this

rise in Rathsun Magam. I often picture Baab Sob choosing the spot for its calm and letting

prayer shape the place.
Reaching the hill feels simple.
Roads curve up from Budgam, Beerwah, Radbugh, and Magam. The Budgam-Beerwah road glides along its slope, revealing the shrine as if introducing it. Srinagar is about an hour away. Magam and Beerwah sit close enough for a short detour after tea.

At the top, the world opens in clear lines. Srinagar lies to one side, Baramulla and Bandipora in the distance, Gulmarg's hills resting like folded cloth. Tosamaidan and Doodhpathri stretch out in long swells, and the Pir Panjal stands straight across the horizon. Villages below look tucked into the land, their rooftops catching the

Seasons redraw the hill with confident strokes. Spring wakes the slopes with green and small flowers that seem to arrive without effort. Summer brings steady breeze under the pines where families settle with baskets and stories. Autumn deepens the sky and fills the ground with amber leaves. Winter lays a clean sheet of snow across everything, making the shrine seem even more certain.

Many of my earliest memories sit here. School picnics, steel flasks of tea, grass stains on trousers, and the sense that the hill would outlast our tiny worries.

Even now, the place holds the same pull. Families still climb up with food packed in newspaper, and children still race toward the trees as if the hill were made for them.

There is another tradition woven into the place.

Newly married couples visit Baab Soubun before they settle into their new routines. They stand on the slope and take in the long view, and the air seems to steady them. The land spreads out in soft rises and sharp climbs, a reminder that life holds

Something in that sight brings a kind of courage.

Daresh has grown greener because of a plantation drive led by social activist Riffat Abdullah. Himalayan blue pine, deodar, and silver fir now rise along the slopes. These trees have changed the air and given the hill a deeper sense of care. Baab Soubun's resting place breathes easier.

People come here for many reasons. Some want to pray, some want fresh air, and others just need a break. The hill welcomes everyone in its own embracing way.

When I reach the top and feel the wind on my face, with the whole valley opening in front of me, something inside settles. I walk away feeling

lighter.
"Walsa Baab Soebun Gasow."
The old call still works on me. Each visit feels like a small step toward clarity, a reminder that sometimes you rise in spirit by simply walking up a hill you have known all your life.

Ethiopia Volcano Ash Disrupts India Flights, No Weather Impact



Srinagar: Ash clouds from a major volcanic eruption in Ethiopia drifted into parts of India on Tuesday, disrupting flight operations across several regions, though authorities confirmed there was no impact on local weather or air quality. According to the India Meteorological Department (IMD), the ash plumes—currently moving eastward-are expected to clear Indian skies by 7:30 pm on Tuesday. The clouds, detected in the upper troposphere, affected aviation routes over Gujarat, Delhi-NCR, Rajasthan, Punjab, and Haryana.

IMD and the civil aviation ministry said they are maintaining continuous monitoring as precautionary measures were activated across airports and airlines.

Flight operations saw significant disruption, with seven international flights cancelled and 12 delayed at Delhi's Indira Gandhi International Airport alone. Air India cancelled 13 flights since Monday after seven of its aircraft that flew through affected air corridors were taken for precautionary checks. These aircraft was cleared for service on Tuesday.

The disruption followed the eruption of the Hayli Gubbi shield volcano in Ethiopia's Afar region



on Sunday, which sent ash plumes rising nearly 14 km (45,000 ft) into the atmosphere. Strong winds carried the ash across the Red Sea, Yemen, Oman, and the Arabian Sea, eventually reaching western and northern India.

IMD said its Met Watch offices in Mumbai, Delhi, and Kolkata issued ICAO-level SIGMET warnings, advising airports and airlines to avoid affected airspace and altitude levels. Continuous satellite monitoring, dispersion models, and advisories from Volcanic Ash Advisory Centres (VAAC) informed route adjustments and fuel planning.

The Ministry of Civil Aviation assured that there was "no cause for concern" and that coordination between ATC, IMD, airlines, and global aviation agencies was underway. The Airports Authority of India (AAI) also issued a NOTAM alerting pilots and operators.

The Directorate General of Civil Aviation (DGCA) instructed airlines to strictly avoid ash-affected zones, adjust flight paths, and immediately report any suspected ash encounters, including engine anomalies or cabin odour. It further directed airports to inspect runways and taxiways for contamination should ashfall reach ground level. IMD Director General Mrutyunjay Mohapatra reiterated that the ash was confined to higher altitudes.

"The volcanic ash is being seen only in the upper troposphere... It has no impact on weather or air quality," he said.

As the ash cloud continues drifting toward China, authorities expect a gradual normalisation of flight operations through the evening

SC: Nation Won't Tolerate Custodial Violence, Deaths

New Delhi: The Supreme Court on Tuesday said custodial violence and death is a "blot "on the system, and the country will not tolerate this.

While hearing a suo motu case concerning lack of functional CCTVs in police stations, a bench of Justices Vikram Nath and Sandeep Mehta referred to its order passed in the matter and said 11 deaths were reported in police custody in eight months in Rajasthan.

"Now this country will not tolerate this. This is a blot on the system. You can't have deaths in custody," the bench said.

Solicitor General Tushar Mehta said nobody can even justify or attempt to justify custodial deaths.

The bench also questioned the Centre as to why it has not filed compliance affidavit in the matter.

"The Union is taking this court very lightly. Why?" Justice Nath asked.

Mehta said he was not appearing in the suo motu matter but nobody can take the court lightly.

He said the Centre would file the compliance affidavit within three weeks

In September, the apex court

had taken suo motu cognisance of a media report which stated that 11 lives were lost in police custody in Rajasthan in the first eight months of 2025, of which seven incidents occurred in the

Udaipur division. In a separate matter, the apex court had in 2018 ordered installation of CCTV cameras in police stations to check human rights abuses.

During the hearing on Tuesday, the bench also heard the submissions of senior advocate Siddhartha Dave, who is assisting the apex court as an amicus curiae in a separate matter in which the top court had passed an order in December 2020.

In that order, the top court had directed the Centre to install CCTV cameras and recording equipment at the offices of investigating agencies, including the CBI, the Enforcement Directorate and the National Investigation Agency.

Dave told the bench on Tuesday that he has filed a report in the case in which order was passed in December 2020.

'On the last date, we had made certain specific queries from all the states and Union Territories (UTs). Have they responded?" the bench asked.

The bench was informed that in the suo motu case, only 11 states have filed their compliance affidavits.

Dave said in the earlier case also, many of the states have not filed their compliance affidavits.

The bench observed that Madhya Pradesh has given a positive response and each police station and outpost in the state is connected to centralised work station at district control

"That is something remarkable," the bench said.

Dave said CCTVs were installed in three central probe agencies but the other three are yet to comply with the apex court's direction.

"It's a judgement of the court. we are bound. But having CCTV inside the police stations also is something which can be counter productive to investigation. Now there is a judgement, we can't argue," Mehta said.

The bench observed that in America, they have live streaming of the footage.

"America has even private jails where you can get almost resort level facilities," the solicitor general said.

He said there was a suggestion from one of the benches that "why don't you persuade the industrialists, who are suppose to spent some money of CSR (corporate social responsibility), to create private jails".

The bench said it is already seized of a matter concerning

open air prison. 'You don't need any other system. That is one of the best resolutions to so many problems of overcrowding and regular complaint of violence in jails," the bench said, adding it would also help in reducing the financial burden.

Dave flagged that there was no budgetary allocation done for installation of CCTVs for three central agencies.

"We find that only 11 states have filed their compliance affidavits in the suo motu writ petition. The remaining states and Union territories have not filed their compliance affidavits which includes the Union of India also," the bench noted in its order.

It granted three weeks time to the states and UTs, which have not yet filed their compliance affidavits, to do so and posted the matter for hearing on December 16.

The bench said if by the said date, the compliance affidavits are not filed by the remaining states and UTs, their principal secretary in the department of home will remain present before the court along with their respective explanations for not complying with the orders.

to Sharma's demand that admission of the first batch be cancelled and reserved only for those who "have faith in the deity", Omar said the principle must be applied openly. "If you do not want Muslims admitted, then declare it a minority institute. The Muslim and one Sikh student who have secured admission on merit can be accommodated elsewhere," he said.

He cautioned that the BJP should not accuse the Muslim community of sectarian behaviour while simultaneously pushing children away from institutions where they seek education. "When children choose to study at Mata Vaishno Devi College without caring about its name or funding, and you deny them admission because of their religion, what message are you sending?" he asked.

Referring to recent arrests linked to a "white collar" radicalisation network at Al-Falah University, Omar questioned the hypocrisy. "You ask why Kashmiri doctors went to institutes where they became radicalised. But when they want to study at an institute like Mata Vaishno Devi, you want to shut the door. If tomorrow they go somewhere else and get radicalised, will Sunil Sharma take responsibility?" he said.

Omar urged the BJP not to "push Muslim children to the wall," adding that students denied admission locally may simply go abroad for studies. "If you want Muslim students not to study there, change the status and our children will get admission elsewhere – even in Bangladesh or Turkey," he said.

The SMVDIME has been allotted 50 MBBS seats this year. Admission of 42 students belonging to one community in the first batch triggered controversy, with right wing groups demanding the institute be declared a minority institution. Officials maintain that admissions were strictly merit based as the institute does not have minority status.

Later reacting to Omar's remarks, Sharma said the BJP was not opposed to merit but

in north Kashmir recorded minus 1.2 degrees. The high altitude Zojila Pass, which connects the valley with Ladakh, experienced extreme conditions as temperatures dropped to minus

16 degrees. The region has been reeling under a prolonged dry spell since October. The MET Office has forecast dry weather for the coming week, offering no immediate relief from the deepening cold.

unanimous 2019 verdict and the establishment of the Shri Ram Janmabhoomi Teerth Kshetra Trust. Modi laid the foundation stone in 2020, the idol was consecrated in January 2022, and the Ram Darbar opened to devotees in June 2025.

The official said some other deposits which have been discovered by GSI in J&K include lithium, copper, titanium and iron and coal besides gold, but how much of those minerals are economically viable is yet to to be assessed.

Asking the J&K government to ensure handholding of the successful bidders for the seven limestone blocks, he said the ministry will extend support to the UT.

Anil Kumar Singh, Additional Chief Secretary, J&K Mining Department, said the pioneering initiative of e-auction of seven limestone blocks is expected to bring in approximately Rs 500 crore revenue for the Union Territory. The transparent electronic bidding process

will boost investor confidence, open new opportunities for entrepreneurship, ensure setting up of cement and other mineral-based industries and generate substantial employment opportunities for the local population," he said.

He said they are also in the process of processing 24 new landform blocks which will be brought to e-auction by March next year with an estimated revenue of around Rs 1.500 crore for the UT, further accelerating economic growth and development.

Singh said J&K has embarked on a new horizon in mining by introduction of Integrated Mining Surveillance System (IMSS) which employs satellite imaging monitors to keep a watch on illegal mining activities.

The department is also conducting a trial run of various advanced technology within a fortnight to make mining operations fully transparent and accountable, he said, adding the system would become fully operational by early January 2026.

He said citizens would soon be able to register complaints directly through mobile applications, further strengthening public

participation.

For future roadmap and mineral explorations beyond the edge zone, the department is driving exploration of other critical minerals, including lithium and sapphire, which are under dedicated study and set to be pre-auctioned in the coming financial year.

Active consideration is being given to scientific exploration and extraction of graphite, granite, copper, metal and shallow gas in identified zones, he said.

He said detailed geological mapping, relay and feasibility assessments are going on to ensure responsible and sustainable mineral development in J&K.

He thanked the Ministry of Mines for recommending I&K mining department for financial assistance of Rs 100 crore for development of command and control centres, rapid response infrastructure to curb illegal mining and for ensuring scientific and sustainable mining.

"Since the provisions contained in Section 37 of the NDPS Act are mandatory in nature, the petitioners cannot be granted bail," the court

CM Omar Reviews Key Revenue Department Projects

SRINAGAR: Jammu and Kashmir Chief Minister Omar Abdullah on Tuesday reviewed the progress of infrastructure projects taken up by the revenue department.

As many as 18 major building projects -- including tehsil and niabat offices, residential quarters, mini secretariats, and revenue complexes -- are currently being executed across Jammu and Kashmir.

These projects -- located in Ramban, Kathua, Poonch, Doda, Udhampur, Reasi, Bandipora, Anantnag, Pulwama and Srinagar -- form a critical part of the administration's efforts to strengthen building infrastructure and grassroots governance,



a government spokesperson said. He said the review highlighted certain bottlenecks, including delays in fund disbursement, pending approvals and legal issues in a few locations.

Quota Issue: Ruhullah Threatens Fresh Protest

SRINAGAR: Member of Parliament Aga Ruhullah Mehdi has urged the party-led govern-ment in Jammu and Kashmir to resolve the reservation issue before the Winter session of Parliament concludes, warning that he will join quota protests if the delay continues.

The Winter session is scheduled from December 1 to 19, with 15 working days. Mehdi has backed general category aspirants who seek a review of the existing reservation policy, accusing the Union territory administration of turning a blind eye to the frustration of educated youth.

In a sharp post on X, the Budgam MP asked the government what it would take to acknowledge the "agony and hopelessness" young aspirants are facing. Referring to the recent controversy at Shri Mata Vaishno Devi University, where merit-based admissions sparked debate, he said, "Doesn't today's case open their eyes? Don't they feel the urgency

to give our youth some relief?" Mehdi had earlier joined student protests outside Chief Minister Omar Abdullah's residence in December last year, demanding



rationalisation of the quota system. The Omar government later set up a Cabinet sub-committee to study grievances and submit a report within six months.

On October 16, Omar announced that the Cabinet had accepted the sub-committee's report and sent it to the lieutenant governor for approval. Mehdi, however, said the timeline has stretched far beyond what was promised. "Last year, they said six months. Those six months have turned into a year," he said, adding that assurances given before the recent Budgam bypoll have also not materialised.

He said even a future resolution would not compensate job aspirants for the time and vacancies already lost. "Now even if they solve this sometime in future, what will compensate for the

years gone by?" he asked. Mehdi warned that if the government does not act by December 20, he will again sit with the protesters. "And this time it will not be for a day," he said.

The MP also criticised the BJP for questioning the high number of Muslim admissions in the first MBBS batch at SMVDU's medical institute. Right-wing groups have demanded minority institution status for the new institute after 42 out of 50 seats went to students from one community.

Mehdi asked how the BJP could object to Muslim enrolment at a state-backed institution while supporting the appointment of non-Muslims to Waqf boards. "What principle is at work here?" he asked, calling it a selective use of religion. Chief Minister Abdullah also reacted strongly, pointing out that the law establishing SMVDU does not permit religionbased admissions. Officials said the institute has no minority status and therefore could only admit students on merit.

The SMVDU medical institute received approval for 50 MBBS seats this year. While officials maintain the admissions were merit-driven, the controversy has added to the rising tensions around reservation, merit, and representation in the UT.

Raise issues in Parliament, Not on **Streets: Dy CM Advises MP Ruhullah**

SRINAGAR: Advising Member Parliament Aga Ruhullah Mehdi to raise issues in the Parliament and not on streets, Deputy Chief Minister Surinder Kumar Choudhary on Tuesday said the senior leader should focus on working for people rather than looking for opportunities to remain in the limelight.

CS Stresses Accountability, Speed in Power Sector Reforms

JAMMU: Chief Secretary, Atal Dulloo Tuesday undertook an in-depth review of the reforms being implemented by the Power Development Department (PDD) across Jammu and Kashmir with a focus on enhancing operational efficiency, strengthening infrastructure and substantially reducing power losses under the Revamped Distribution Sector Scheme (RDSS).

The review meeting was attended by Additional Chief Secretary, PDD; Managing Director, JPDCL/KP-DCL; Chief Engineers of the Corporations; representatives of NTPC and PESL. besides other senior officers.

Emphasising the need for strict adherence to timelines, the Chief Secretary directed that all ongoing reform works aimed at loss reduction must be completed within the sunset period prescribed under RDSS by the Government of India.

He stressed on fixing daily and weekly targets for all components of loss reduction works, including LT cable replacement, augmentation and replacement of



the distribution system, HT line cabling, replacement of HT conductors, feeder segregation and installation of electric poles.

He further underlined the importance of improving feeder-wise billing and revenue collection efficiency and called for stringent action against officials found negligent or lax in discharging their responsibilities. The Chief Secretary instructed the Divisional Commissioners of Jammu and Kashmir to conduct monthly reviews and identify field-level staff failing to perform responsibly.

To prevent delays during the harsh winter season, especially in snow-bound and remote areas, the Chief Secretary underscored the need for advance dumping of essential material in difficult terrains to ensure uninterrupted execution of works despite road closures.

Three members of the grieving families, led by Chamail

Singh, who lost his son and brother in the incident, sat on an indefinite hunger strike inside the premises of Shiv Temple in Malhar area of Kathua district. The protest commenced after a 'havan' (special prayer)

for the deceased, with locals of Madoon, Deota, Machhedi, Lohai and Kund villages joining the grieving families to press for an impartial probe into the incident. The delay amounts to denial of justice," Singh said, vow-

ing to continue the struggle until the truth comes out and the guilty are punished. He said it was unfortunate that despite the "brutality of

the crime," the government had failed to conduct a fair probe. "My son, my brother, and my brother-in-law were murdered in a planned way, and their bodies were thrown into Ishu Nullah on March 4. They were found after several days," he said, blaming terrorists for the murder.

He said the families have been waiting for the final police report for nine months, yet no conclusive findings have been shared. he Narcotics Control Bureau (NCB), Srinagar Zone, has successfully dismantled a narcotics supply module active in the Baramulla-Pulwama belt with the seizure of 2.730 kilograms of charas and the arrest of three accused persons, including the main supplier.

"Acting on specific intelligence, on 20.11.2025, a team of NCB Srinagar intercepted Bashir Ahmad Malla, R/o Dhobiwan, PS Kunzer, District Baramulla, and recovered 2,730 kg of charas from his possession." an official statement issued to Kashmir Observer reads. During sustained interrogation and prompt follow-up

action with the help of Baramulla Police, i.e., Kunzer Police Station, the NCB team arrested his close associate, Mansoor Ahmad Wani, R/o Dhobiwan, PS Kunzer, District Baramulla, who was actively involved in the supply chain, it reads. NCB Srinagar appreciated the strong cooperation and

timely support extended by Baramulla Police, whose proactive assistance played a vital role in the successful execution of the operation and further strengthened inter-agency coordination in the region. "Based on the disclosures of both the accused and sub-

sequent operational intelligence, the main supplier, Abdul Rashid Dar, was apprehended from Pulwama, thereby unearthing the complete trafficking chain. All accused have a previous criminal history in connection with NDPS cases," the statement added.

With the arrest of the mastermind, associate and supplier, the entire module involved in the procurement, transportation and distribution of the seized contraband has been dismantled, it reads, adding that further investigation is ongoing to identify backward and forward linkages, financial trails and any inter-state connections.. South Africa Close In as India Face Whitewash

GUWAHATI: India stared down the barrel as a ruthless South Africa slowly tortured the home side by posting an improbable victory target of 549 that has all but ensured the visitors' first series triumph here in 25 years at the end of the fourth day of the second Test.

After South Africa declared their second innings at 260 for 5, India were reeling at 27 for 2 at stumps on Tuesday, having lost openers Yashasvi Jaiswal (13) to Marco Jansen and KL Rahul (6) to Simon Harmer respectively.

Sai Sudharsan (2 batting) and night-watchman Kuldeep Yadav (4 batting) were at the crease but it will take a herculean effort from the remaining batters to save the game on the final day and avoid the ignominy of a 0-2 whitewash.

The only saving grace for them could be the fact that light fades quickly in this part of the world after 3:45 pm and not more than 80 odd overs have been possible on any of the past four days.



Head coach Gautam Gambhir will certainly prefer a 0-1 series defeat over a 0-2 result which would be the second series debacle at home against a SENA nation in the past 12 months.

On the fourth day, the reigning World Test Champions had two targets. First was to set a target that would be virtually out of reach

Secondly, the more time Proteas spent batting on the fourth

day, stronger became the chances of the red soil track crumbling on the fifth day.

Tristan Stubbs (94 off 180 balls), who missed out on a half-century in the first innings by a solitary run, this time fell short of a Test ton by only six runs.

Once Stubbs became Ravindra Jadeja's (4/62 in 28.3 overs) fourth victim, skipper Temba Bavuma declared the second innings having knocked the stuffing out of

the Indian team by making them bowl for 78.3 overs.

Stubbs enjoyed a 101-run stand for the fourth wicket with Tony de Zorzi (49) and another 82 for the fifth wicket with Wiaan Mulder (35 not out). This was after a 50-plus opening stand between Ryan Rickleton (28) and Aiden Markram (35).

Bavuma, an experienced captain, looked tactically superior compared to India's stand-in skipper Pant, who looked bereft of ideas in his debut in the leadership role, albeit in a one-off game.

Bavuma could have jolly well called his men in after they their lead swelled to 450. But he perhaps wanted to ensure that the SG Test remained relatively new when his men come out to bowl in the morning.

They would try to exploit any help available from the surface before it all flattens out.

The pitch still looks solid even though the degree of turn from less than three on the first day, has now gradually increased to 4.6 on the fourth day.

1.6 on the fourth day. That was evident when Jadeja, who hardly gets any purchase in helpful batting conditions, tossed one up to Aiden Markram and lured him into playing a forward defensive stroke.

The ball pitched on the middle stump, turned sharply away from Markram's outside edge while clipping the off-stump. A few overs later, it was Bavuma, who fell for a leg-side trap set by Washington Sundar as he got one bouncing and turning into his rib cage.

The tickle was taken down at leg-slip by Nitish Reddy.

However, after that dismissal, both Washington (1/67 in 22 overs) and Jadeja stopped getting any appreciable turn and once the ball went soft, Stubbs and De Zorzi farmed the strike with ease.

Pant's tactical calls and field placements also left a lot to be desired as he would constantly switch between "in-out" field (half close in and a few in deep) to five fielders in the deep to save boundaries.

There was a point after which it felt that the Indian team was just playing the waiting game looking for Bavuma to declare the innings at some stage.

Olympic heartbreak sapped motivation: Lakshya

ewly crowned Australian Open champion Lakshya Sen says the heartbreak of finishing fourth at Paris Olympics drained his motivation and planted a seed of doubt but renewed focus on physical conditioning and mental clarity helped him rekindle his love for badminton.

The 24-year-old from Almora endured a difficult spell after returning from Paris, where he narrowly missed a medal last year.

"Post the Olympics, it was a little bit hard for me to find motivation again to train really hard. I took a break for some time. I was not doing so well," Lakshya told a select media after arriving home from Sydney. "I think there was a lot of first round exits as well. A lot of the things I was dealing with mentally, I was still competing in a few tournaments, but I was not really 100% there."

His downward spiral deepened when a back issue persisted through the Singapore-Indonesia leg.

"There were a few niggles here and there. It was not a major injury but I was getting some back spasms because of high match intensity or the loads in the back," he said.

Lakshya spent time in hospitals and later visited the Athlete Performance Centre in Salzburg, Austria to strengthen the affected areas. The physical strain was accompanied by mental fatigue.

"There were a lot of things throughout the year, there were a lot of doubts that were there in my mind. And a lot of people had a lot of different opinions about training, about tournaments, about playing," he said. (PTI)

SA Coach Shukri Conrad Creates Stir

'We Wanted India to Grovel'

GUWAHATI: South Africa head coach Shukri Conrad wanted his men to make India "grovel" on the fourth day by setting them the mammoth 549-run target that the embattled hosts are currently chasing to save the second Test and an imminent series whitewash.

Conrad's expression could well stir tensions in what has been a fairly amicable series, but he did mention that he was "stealing a phrase" from the infamous interview by late England skipper Tony Greig before the 1976 home series against Clive Lloyd's West Indies which his team lost 0-3.

"We wanted India to spend as much time on their feet out in the field. We wanted them to really grovel, to steal a phrase, bat them completely out the game and then say to them well come and survive on the last day and an hour this evening," Conrad literally rubbed it in at the post-play press conference when asked why South Africa batted for nearly 80 overs when



they had already acquired a size-

To "grovel" means to "lie or crawl abjectly on the ground with one's face downwards", something that Greig, who was of white South African heritage, had said in reference to the Caribbean players, their painful history of slavery and the apartheid in the Rainbow Nation.

Whether Cricket South Africa has a quiet word with their coloured coach making an objectionable reference at an opposition national team, that has its own history of facing racism, is not yet known.

Conrad was asked to explain why they delayed the declaration and whether it could affect the final outcome of the match with India getting away with a draw.

"There were a few factors. We obviously were looking at how best we are going to use the new ball, so that in the morning we still get a newish, hard ball," Conrad said.

He then gave an interesting insight into his tactical nous.

"We felt that when the shadows come across the pitch in the evening, there's something in it for the quick bowlers. So we didn't want to declare too early and not be able to use that (with hard ball).

"And then obviously we wanted India to spend as much time on their feet out in the field."

India bat till number 8 and Conrad knows that the hosts would try their best not to get skittled out.

"So far so good but we also know they are just not going to roll over. We have to be at our very best tomorrow but those are the factors that we considered here."

2026 T20 World Cup: India, Pakistan in Same Group

MUMBAI: Traditional rivals India and Pakistan have been clubbed in Group A for the 2026 Men's T20 World Cup and will play each other in Colombo's R Premadasa Stadium on February 15, as per the schedule unveiled here on Tuesday.

Pakistan will play all their games in Sri Lanka as per the agreement reached between the BCCI and PCB for the tournament.

Reigning champions India will open their campaign against the USA in Mumbai on February 7 before facing Namibia in Delhi on February 12. They will then head to the Sri Lankan capital for the high-voltage clash against Pakistan before concluding their league engagements against the Netherlands in Ahmedabad on February 18.

The showpiece will be held across eight venues (five in India and three in Sri Lanka) from February 7 to March 8.

The tournament will feature



55 matches in Delhi, Kolkata, Ahmedabad, Chennai, Mumbai, Colombo and Kandy.

ICC chairman Jay Sharma made the announcement while unveiling the tournament's schedule.

Group B features Australia, Sri Lanka, Ireland, Zimbabwe an Oman while Group C

will have England, West Indies, Bangladesh, Nepal and Italy.

Group D comprises New Zealand, South Africa, Afghanistan, Canada and UAE.

India Lose to Belgium 2-3 in Azlan Shah Cup Hockey
