### **J&K Bank Clears ₹1,250 Crore Capital Raise for Expansion**

Srinagar: Jammu & Kashmir Bank has approved a capital raise of up to ₹1,250 crore as the lender seeks to reinforce its balance sheet and accelerate its growth strategy amid improving financial metrics and a strengthening regional economy.

In a statement following its board meeting on 26 November, the Srinagar-based bank said the fundraising plan includes ₹750 crore in equity capital through a Qualified Institutional



Placement (QIP) and ₹500 crore via privately placed, unsecured, non-convertible Tier-II bonds compliant with Basel-III norms. The move remains subject to

regulatory clearances. equity component through QIP signals the bank's intention to tap institutional investors as it prepares for a new expansion phase. ## **One In Four Indian Adults Obese, Claims New Report**

Nearly one in four Indian adults is now obese, a study inaugurated by the Tony Blair Institute for Global Change in Delhi on Tuesday claimed, adding that India is at a turning point as obesity-driven diseases rise sharply across both urban and rural ar-

The report says national data already shows how serious the problem has become. Quoting the National Family Health Survey 2019-21, the study says that in Delhi, 41 per cent of women are obese compared to 12 per cent in Meghalaya. Further, 22.8 per cent of children aged 6 to 16 in Delhi are obese compared to 13.6 per cent in Maharashtra.

The paper titled 'Building on success to secure India's future health' said that 24 per cent of women and 23 per cent of men in India have either overweight or obesity, almost five times higher than 30 years ago. Rates are much higher in cities and vary widely across states.

The report adds that this pattern is part of a wider global trend. Worldwide healthcare spending has doubled in the last two decades but people are spending fewer of their added years in good health. Health systems built mainly to treat illness are now under pressure from rising demand and shrinking resources. Global obesity rates have doubled since 1990 and now affect almost one billion people. If trends continue, more than half of all adults worldwide could be overweight or obese by 2050, it added.

The report warns that obesity is At the roundtable held in the naalready increasing India's disease burden and placing pressure on the economy.

Obesity costs India about USD 2.4 billion every year in healthcare spending and reduces the country's economic output by roughly USD 28.9 billion, close to one per cent of GDP, it said.

Initiatives such as Eat Right India and the Fit India Movement are helping improve diets and physical activity. A "sin tax" on sugary drinks introduced this year and work on national obesity guidelines show further action on prevention, it said.

Vivek Agarwal, Country Director at the Tony Blair Institute for Global Change, said India is well placed to lead in prevention.

Srinagar: Police in Srinagar have busted a narcotics module operating in the Nowhatta and Rainawari areas with the seizure of over five kilograms of charas-like substance and the arrest of three accused persons in connection with FIR No. 57/2025.

According to police officials, a naka checking point was established at Malkha Chowk by Police Station Nowhatta at about 5:30 pm on November 16. During checking, a person approaching from Tujgari Mohalla towards Malkha Chowk attempted to flee after noticing the police party while carrying a white bag. He was chased and apprehended on the spot.

The accused disclosed his identity as Hyder Javaid, son of Javaid Ahmad Wani, a local of Kathidarwaza, Rainawari. Upon checking the bag, officials recovered 3.40 kilograms of charas-like powder and 12 Tramadol injections. Subsequently, a case under relevant sections of law was registered and investigation was initiated.

On November 20, during further investigation and on the disclosure of the first accused, police acted on backward and forward linkages and arrested another accused identified as Altaf Sheikh, son of Hameed Sheikh, a local of Sheikh Mohalla, Nowhatta. From his possession, 722 grams of charas powder was recovered and seized as per due legal process.

### Kashmir's **Lancet Love Test**

ast month, a 26-year-old schoolteacher in Budgam brought sweets to her fiancé's house. The family asked for one more gift: a fresh blood-sugar report.

She returned with an HbA1c of 6.4, just below the diabetic line. The wedding is off. The mother explained, "We cannot bring a sick girl into the house."

The girl now checks her glucose each morning and wonders if love comes with a lancet.

Endocrinology out-patient departments in Kashmir have doubled in five years. Government data show 2.4 lakh registered diabetics in 2025, up from 1.1 lakh in 2020.

Doctors blame the shift from home-cooked mutton and turnip to city-bought snacks and cola, plus winters spent around the firepots instead of the cricket ground.

Whatever the cause, the number is public, and it is deciding who is marriage-ready.

Matrimonial notices in a local newspaper used to list height, job, and whether the girl covers her head. Now twenty percent end with "non-diabetic only."

A pathology lab owner in city has even started a "bridal package": full blood count, thyroid profile, and glucose tolerance test, all for two thousand rupees. Business is brisk.

The test itself is harmless. A drop of blood, a three-minute wait, a figure between four and six is normal. The meaning attached to the figure is not.

Families treat the printout as a character certificate. A number above six is read as proof that the girl will cost money in metformin, insulin, or maybe kidney failure. Boys are given more room. An overweight groom can still negotiate, especially if he works in the Gulf.

The health department has no policy on pre-marital screening. Private labs are happy to fill the gap. They hand out colourcoded charts that list glucose values but leave out the line that says diabetes can be managed, even reversed. The chart sticks to the fridge like a verdict.

A number produced by a machine is being used to decide who is worthy of family life. The machine does not ask what the girl teaches, how she behaves, and whether she can calm a crying child. It only knows glucose.

If the same number can block a wedding, it can also block a job, a visa, and a place in college.

The line from blood to bias is short, and Kashmir is walking it in full view.

### **Loan Apps Harvest Apple Valley**

A Rs 15,000 salary, one wedding, and a house full of broken hopes

he boy who sells apples near Lal Chowk earns exactly Rs 15,000 a month. Last autumn he married. He served over 100 tramis of wazwan at the cost of Rs 3.8 lakh he borrowed from a micro-finance app that charges 22% interest.

Today half his pay vanishes before dawn on the EMI due date. The math is cruel: Rs 7,500 gone, Rs 7,500 left to feed five mouths. Inside his single-storey house in Natipora, the mood shifts daily. His mother skips diabetes tablets because the chemist asks for Rs 480. His old father keeps wondering about debt.

Doctors at the Government Psychiatric Hospital in Srinagar say financial stress is the fastest-growing reason for male outpatient visits, up 42 % in five years. Hypertension clinics report the same curve. Debt is not only counted in rupees. It is measured in sleepless hours and skipped meals.

The solution is not another loan-rescue scheme. It is a lesson plan. Kashmir's school boards still treat commerce as an optional subject taken by "weak" students. Parents who can recite the verses of Mehjoor cannot read a bank statement.

If a tenth-grade pupil were taught that Rs 3.8 lakh at 22% becomes Rs 5.6 lakh in two years, the wedding guest list would shrink faster than the snow on Afarwat.

Community centres run by masjid committees and self-help groups can host Saturday classes: how to budget, compare interest, and say no to a cousin's demand for a bigger marquee.

Kashmiris survived decades of discord by sharing firewood and rice. We can survive the age of easy apps by sharing knowledge.

# **Zoom Nikah in Kashmir**

Dating apps are deleting the three-day wazwan courtship that once buffered nerves and blood sugar. The marriage is done before the stew is stirred, and mental-health workers are picking up the pieces.

ast month, I stood in the bride's room at a Srinagar marriage hall while a young woman pressed refresh on her phone.

The screen showed a man in Muscat repeating Quranic verses after a cleric. The entire ceremony lasted eight minutes. The groom's family had sent a plate of honey sweets by courier. The bride's family had not cooked a single meatball.

This is the new Kashmiri wedding, marketed as halal speed-dating.

Matrimonial apps boast thousands of Kashmiri profiles. Their dashboards filter by height, salary, skin tone and visa status.

If both sides swipe right, the app books a cleric and opens a In 2025, at least three hun-

dred and twenty marriages have been contracted online, double last year's count.

The companies call this progress. They do not pay for the counselling sessions that follow.

For centuries, a Kashmiri wedding began with a three-day wazwan feast. Relatives tasted rice from the same copper plate, judged the family's generosity, and watched how the boy's parents treated the girl's family.

The food was rich but the scrutiny was richer.

Young people absorbed the gravity of marriage while surrounded by aunts who had survived bad ones.

The feast worked like a social vaccine: it provoked mild anxiety and produced long-term immunity against hasty decisions.

The app replaces that feast with a forty-five-minute video call. The couple discuss job location, future children, maybe fa-

vourite colour. Then the screen

goes dark.

Two weeks later, they are pronounced husband and wife. Psychologists say the average

waiting time for a post-wedding anxiety appointment has dropped from eight months to four. One Srinagar-based mental

health specialist sees newlywed women who cannot sleep because they shared their first meal with a stranger. She sees men who tremble while describing the first night they spent with someone whose laugh they had never heard in person.

There are clear consequences of these speed marriages.

When you remove extended family oversight, you also remove the safety net. A swipe cannot replicate the aunt who notices the groom's hands shake when he speaks, or the cousin who reminds the bride that divorce is not a curse word

The app model adds a fresh pressure: performance metrics.

One mother told me she approved a match because the boy's profile showed "response time: three minutes." She assumed quick replies meant good character.

The cleric who officiated the Zoom nikah told me he now spends half the call explaining that Islam permits the bride to say no even after yes has been typed into a chat box.

Health data show Kashmir already carries one of the highest female anxiety rates in India. The National Mental Health Survey put lifetime prevalence at twenty-two percent. Adding marital stress to that load is like pouring boiling water on a heal-

The companies could build in safeguards for free. A mandatory four-session video counselling package before the nikah screen

unlocks. A fee of two thousand rupees paid into a joint mentalhealth fund. A pop-up that lists emergency hotlines the moment the word divorce is typed.

These tweaks cost less than the price of one sponsored Instagram post.

Some clerics demand a forty-eight-hour cooling-off period between video consent and online nikah. The apps refuse, fearing users will migrate to rival platforms.

The government refuses to intervene, calling matrimony a private contract. The families refuse to slow down, dazzled by Gulf salaries and Roman-script romance.

Meanwhile, the wazwan cooks sit idle. One chef told me his booking diary lost forty entries since January. He now drives a taxi and listens to passengers describe weddings that ended before the rice was boiled.

The bride I watched on the phone closed the laptop and walked into a banquet hall where two hundred guests were waiting.

She had never met her husband in person. She had never tasted his family's cooking. She had never heard his laugh bounce off the walls of a crowded kitchen.

She carried a small bouquet and a big question: who is the man I just married?

Kashmir taught the world that patience can be a form of resistance. Patience in choosing a life partner should not be the next casualty of speed.

### Polyester Pherans Are Giving Kashmir a Winter Rash

ast week, a 19-year-old girl from Srinagar sat in an outpatient room with her back covered in red spots. She thought bed bugs had attacked. The culprit was the new pheran she bought from a street vendor for 450 rupees. The wrap looked bright, but the fabric

Dermatologists report growing cases of skin infections. Most patients are young women who wear the cheap printed pherans that flood the market when the cold season begins. The garments feel warm for the first hour because plastic traps heat. After that, the skin begins to sweat, pores block, bacteria grow, and the itch starts.

For six hundred years, the pheran was made from local wool. It breathed, absorbed moisture, and carried the faint smell of sheep and smoke. Woollen yards still sell for 800 rupees a metre, out of reach for many families.

A printed polyester wrap looks like a bargain. It is not. Patients spend more on creams and bus fare to hospital than they saved on the fake dress.

The law already requires every textile seller to display fibre content in both English and Hindi. Few vendors bother. I asked three shopkeepers in Lal Chowk what their pherans contained. One said: "silk touch." Another said, "warm cloth." The third waved me away. None knew that polyester is plastic.

We cannot ban imports, but we can demand that the label carry the warning in Kashmiri: 'This cloth does not absorb sweat. It may cause skin infection."

The same rule that forces cigarette packs to show a cancer photo can force a clothing tag to tell

Some will argue that a warm look is better than no new coat at all. I argue that a government which spends crores on promoting local wool should not look away while plastic replaces it on

If the heritage dress becomes linked to rash and ridicule, the next generation will drop it altogether.

The solution is simple: Give the buyer knowledge. Let every imported pheran carry a clear tag in the language people read at home.

# Postdoc Turned Professor Brings Smart Tech Home

From apple orchards to avalanche zones, the valley-born engineer explains why data is the new crop and privacy is the fence around it.

Picture this: a farmer in south Kashmir wakes up to a phone alert that the soil under his apple trees is one sip away from drying out, while a traffic cop in Srinagar watches live data that tells him exactly when to let cars roll out of Lal Chowk.

These scenes are not lifted from a Silicon Valley pitch deck. They are snapshots from a future that Dr. Syed Rameem Zahra believes can bloom in her own backyard.

Born and raised in Srinagar, Zahra earned her doctorate at NIT Srinagar, polished her skills at IIT Delhi and now teaches future engineers at Netaji Subhas University of Technology.

She has spent the last decade coaxing tiny sensors to speak clearly and safely on crowded networks, work that matters as much to an apple orchard in Shopian as to a metro line in Delhi.

In a long conversation with Kashmir Observer, she argues that the valley's tough terrain, patchy roads and fragile ecology are not roadblocks but reasons to embrace the internet of things.

Cheap, battery sized chips can track snowfall on the Sinthan Pass, warn drivers of black ice, guide ambulances through traffic snarls and tell a farmer when to water, spray or pick.

The same data streams, she warns, can leak personal habits or open doors to hackers if households keep default passwords and ignore software updates.

#### Let's begin on a lighter note. Could you share a bit about your journey into the world of data science and IoT, and what drew you to these exciting fields?

My journey into IoT began in 2016 when I read about Kevin Ashton and his idea of the "Internet of Things." He believed IoT could change the world, even more than the Internet. This idea seemed crazy then, but now we see its impact in various aspects of life, from baby monitors to military tech. This inspired me to pursue research in IoT to make a difference.

### Since Kashmir is known for its rich cultural heritage, how do you envision blending technological innovation like IoT with the preservation of this legacy?

The Kashmir Valley indeed boasts a rich cultural heritage. Preserving this legacy while integrating technological innovations like IoT presents a unique opportunity. In the digital era, where internet access is growing in Kashmir, language barriers hinder participation and knowledge sharing.

To blend technology with cultural preservation, we can initiate efforts to document key aspects of Kashmiri culture, such as stories and oral traditions, through audio and video recordings. These digital resources can serve as building blocks for language and cultural preservation tools.

Furthermore, we can create pronunciation libraries for Kashmiri words, enhancing accessibility through text-to-speech and speech-to-text technologies. Utilizing open-source software like Kathabhidhana, LinguaLibre, and Pronuncify, we can facilitate the recording and preservation of pronunciations.

### 4 More Trains **To Resume Operations In** Jammu From Dec 1

Jammu: Four trains will resume operations in the seventh phase from December onwards in Jammu division, a senior official said on Thursday, indicating gradual normalisation of train services after the heavy rainfall in August.

The trains being restored from December 1 include train no. 14662 (Jammu Tawi-Barmer), train no. 22462 (Shri Mata Vaishno Devi Katra-New Delhi) and train no. 74907 (Pathankot-Shaheed Captain Tushar Mahajan). Train no. 74906 (Shaheed Captain Tushar Mahajan-Pathankot) will be re-operated from December 2.

"These trains are being reinstated after ensuring the safety and continuity of the railway tracks. They are being operated in the seventh phase, following the resumption of six earlier phases," said Uchit Singhal, Divisional Senior Commercial Manager, Jammu division.

He said train operations in the division are gradually being normalised. "To avoid any inconvenience, passengers are advised to check the train schedules on the Northern Railway website or through relevant helpline numbers."

Over 50 trains were suspended or terminated before their destinations on August 26, following damage to many tracks and bridges owing to heavy rainfall.

Divisional officials are periodically reviewing various sections, ensuring safety, and reinstating trains from time to time.

# Mull Stringent Law To Deal With Derogatory Remarks Against Disabled: SC To Centre

New Delhi: Highlighting the need for a stringent law to protect the dignity of the disabled, the Supreme Court on Thursday asked the Centre to consider framing a statute to make derogatory remarks ridiculing persons with disabilities and rare genetic disorders a penal offence on the lines of the SC-ST Act.

Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989 criminalises casteist slur, acts of discrimination, humiliation, and violence against the members of SCs and STs and makes offences non-bailable.

"Why can't you bring a stringent law on the lines of the SC-ST Act which criminalises casteist remarks - there is punishment if you demean them," a bench comprising Chief Justice Surya Kant and Justice Joymalya Bagchi said.

Solicitor General Tushar Mehta, appearing for the Centre, appreciated the observation and said humour cannot be at the cost of someone's dignity.

The bench also said that there was a need for a "neutral, independent and autonomous" body to regulate obscene, offensive or illegal content in online platforms.

On the issue of framing guidelines or putting in place a mechanism to deal with derogatory remarks and ridicule against persons with disabilities (PwD), the bench was informed by the Ministry of Broadcasting that certain guidelines are in the process



The bench asked the ministry to bring the guidelines in public domain for discussion and listed the matter after four weeks.

The top court was hearing a petition filed by M/s SMA Cure Foundation, which works for individuals affected by rare Spinal Muscular Atrophy disease. The plea flagged jokes made by "India's Got Latent" host Samay Raina and other social media influencers, Vipun Goyal, Balraj Paramjeet Singh Ghai, Sonali Thakkar, and Nishant Jagdish Tanwar.

Asking them to be careful about their conduct in future, the bench also directed comedians Raina and others to hold two programmes or shows per month about the success stories of PwDs to generate funds for the treatment of disabled persons, especially those suffering from SMA.

The bench said it is part of social

penalty and they are spared of other punitive measures.

They have been asked to do so as a reparation for their insensitive jokes about the disabled.

CJI Kant said the influencers can invite specially-abled persons on their platforms to promote the cause of generating funds to provide timely treatment to those suffering from rare diseases such as SMA.

The bench refused to consider the plea for recall of the direction on the ground that they are not hosting

"This is a social burden we are putting on you," it said.

In the hearing, senior advocate Aparajita Singh, appearing for Cure Foundation, said many children, suffering from SMA have, achieved great accomplishments in their lives.

Singh said the foundation refused to accept the offer of Raina to pay Rs 2.5 lakh to them as the question was

"They have mocked this court," the solicitor general said.

Taking note of the foundation, the bench said, "It has been rightly suggested that there should be a dedicated fund/corpus that may be created by the concerned ministry, or if it is already created, the same can be given wide publicity, inviting corporate entities and individuals to generously donate in that fund which is exclusively meant for the treatment of the specially abled persons, like those suffering from SMA.

"The respondents 6 to 10 (comedians) have also volunteered to organise at least two events in a month to generate funds for the corpus. They also seek permission of this court to invite the persons whose success stories whose details are brought on record by Singh," the bench noted.

The bench asked the comedians to 'persuade and invite" the specially abled persons on their platforms to promote the cause of generating funds to provide timely and quality

treatment to the specially abled like those suffering from SMA.

"We are quite sure that respondent 6 to 10 are repentant and show their sincerity and commitment to the cause, the specially-abled persons who have made landmark achievements in life will also accept to come on the platforms for the purpose of wider publicity in the cause. We hope and expect that such few memorable events will take place before we hear matter on the next date," it said.

Attorney General R Venkataramani and the solicitor general apprised the bench that Centre has proposed some fresh guidelines and the consultation

The solicitor general said that the issue was not just confined to "obscenity" but "perversity" in user generated content, which are published by individuals in their own YouTube channels or other platforms.

"Freedom of speech is an invaluable right but it cannot lead to perversity,"

Referring to self-regulatory mechanisms, the bench said, "self styled bodies will not help. Some neutral autonomous bodies which are free from the influence of those who exploit all of this and the state also are needed as a regulatory measure.'

If the self-regulation mechanism were so effective then why were instances of violations repeating, the CII asked. Earlier, the bench said commercial

and prohibited speeches are not covered under the fundamental right.

Police said such operations will continue wherever credible inputs indicate the presence of individuals or material connected to terror or radical activity.

other locations linked to members and associates of the outfit. Officials said the action individuals connected to Jamaat e Islami were involved in activities deemed anti national.

Electronic devices, documents, and literature were seized from several houses. Officials said all recovered material has been taken for detailed examination.

Ruhullah said his political stance is driven by principles and not positions of power, a day after Deputy Chief Minister Surinder Choudhary advised him to raise his voice in Parliament and stop seeking the limelight.

He said that people who lack discipline, principle, honesty, and loyalty in their politics are not even worthy of a response. "The Deputy CM left the PDP, and yet he advises me about principles and party. My fight is for principles, not for the chair. I have not changed the party and principles for the chair," he said.

He added, "Two years ago, the Deputy CM was not in the National Conference, and sometimes aligned with the BIP, sometimes with the PDP. Wherever he gets the chair and opportunity, he goes there. Such people have no principles, no values, and no direction in their lives. My politics and my efforts are based on principles and values. That is why, if I have expressed disagreement with the party, it is based on principles, and not for the chair.

The cold wave extended across South and North Kashmir. Pahalgam recorded minus 5.0, Pampore minus 5.5, Budgam minus 4.6, Bandipora minus 4.5 and Awantipora minus 4.0 degrees. Anantnag and Pulwama dipped to minus 5.7 and minus 5.8 degrees. Shopian remained the coldest in the Valley at minus 6.5 degrees. Gulmarg recorded minus 1.0 degrees, while Zojila reported the lowest overall reading at minus 16.0 degrees.

participates in the conduct of a polygamous marriage may face up to two years in jail and a fine of up to Rs one lakh. Any person who knowingly solemnises a marriage in violation of the proposed law may

who dishonestly conceals facts or intentionally

be punished with up to two years of imprisonment or a fine of up to Rs 1.50 lakh. The bill further proposes that a person who enters into a polygamous marriage and has been convicted by a court under this new legislation shall not be entitled to any public em-

ployment or appointment which is funded or aided by the state government. Moreover, the person cannot be a beneficiary of any scheme funded or aided by the state government, and also cannot contest in any election for Panchayati Raj Institutions, Urban

The proposed legislation seeks to provide compensation to the victim women, as they have to suffer immense pain and hardships due to polygamous marriage.

Islam upholds monogamy, not polygamy:

Earlier, taking part in the discussion in the Assam Assembly, the Chief Minister asserted that "In Islam, monogamy is the rule and polygamy is the exception.'

Citing interpretations of the Quran, Sarma said that the widespread belief that Islam inherently promotes polygamy is "factually Speaking during the discussion on the Assam

Prohibition of Polygamy Bill, Sarma referred to historical accounts from the time of Prophet Muhammad. He said that during the Prophet's spiritual period, some men reportedly entered into as many as 50 marriages. The Prophet then regulated the practice and limited it to four wives under strict conditions.

According to the Chief Minister, this historical shift demonstrates that the Prophet's intent was to curb excesses, not encourage multiple marriages.

"His line of thinking was not in favour of polygamy. In his time, he reduced it from 50 to four. That itself shows the direction," Sarma

He further claimed that under Islamic law,

explicit consent of the first. "If someone marries without that consent, the marriage is not legally valid in Islam," he told the House. Sarma added that several Muslim-majority nations have restricted or banned polygamy because the strict conditions laid down by the

The move comes after a multilayered inquiry that began in 2022, starting with a committee set up to probe allegations in the selection of Firemen and Firemen Drivers. The committee submitted its report in February 2024, after which the matter was referred to the Anti Corruption Bureau for a detailed investigation.

Following verification, the ACB registered an FIR against LMES IT LLP and examined the role of M. K. Wali in the tendering and selection process. The investigation found that LMES was ineligible under several mandatory conditions of the e NIT. Despite being the L 2 bidder, quoting Rs 179 per candidate, the firm was awarded the contract over the L 1 bidder, UMC Technology, which had offered a significantly lower rate of Rs 107.50. The L 1 bidder was neither called for negotiations nor formally accepted or rejected.

The ACB also found that LMES lacked the required experience of conducting similar recruitment exercises for two police or paramilitary forces. The firm failed to meet the criteria of a reputed vendor and did not provide three years of its own financial records. Instead, it submitted documents from another

The report further highlighted a conflict of interest, noting that Wali, who owns 99 percent of LMES, had previously been associated with a firm whose earlier recruitment process for the same department had been scrapped. Despite this, LMES was still awarded the contract, giving him undue leverage, the ACB said.

Based on these findings, the Home Department recommended blacklisting under Rule 151 of the General Financial Rules. After reviewing all reports, the competent authority approved the proposal.

The government has ordered that LMES IT LLP and Wali be barred from all future recruitment related bids in Jammu and Kashmir.

### **Delhi Court Allows Er Rashid** to Attend Parliament

SRINAGAR: A Delhi court on Thursday permitted Baramulla Member Parliament (MP), Abdul Rashid Sheikh, also known as Engineer Rashid, to attend the sixth session of the 18th Lok Sabha while remaining in custody.

According to details obtained by KNO, the court said that the permission is subject to conditions imposed previously.

Additional Sessions Judge Prashant Sharma clarified that the cost of travel for Rashid would depend on the outcome of an ongoing appeal in the Delhi High Court.

Rashid has been lodged in Tihar jail since 2019 in connection with a terror funding case registered in 2017. He is represented by a team of advocates, including Vikhyat Oberoi, Nishita Gupta, Shivam Prakash, and Ravi Sharma.



sion bench of the Delhi High Court delivered a split verdict regarding Rashid's plea to waive the cost of his security and travel arrangements while attending Parliament. The bench comprised Justices Vivek Chaudhary and Anup Bhambhani. Justice Chaudhary concluded that Rashid does not have any entitlement to attend parliamentary proceedings while in lawful custody.

Justice Bhambhani, in contrast, ruled that Rashid is only required to cover the expenses of transportation from jail to Parliament and back, including the costs of the jail van and

The police had estimated

the total per-day cost for Rashid's attendance at approximately Rs 1.45 lakh, including charges for accompanying officers.

Justice Bhambhani stated that the state's demand for Rashid to pay for police personnel accompanying him is not justified.

Rashid was formally charged by a special NIA court in Delhi in March 2022 after the case was lodged in 2017.

Earlier in March 2025, the Delhi High Court allowed him to attend the Lok Sabha during the Budget session, subject to the condition that expenses related to his travel and other arrangements would be borne by him while he remained in state custody.

The court's decision ensures that Rashid can participate in parliamentary proceedings without being released from custody, while clarifying the financial obligations associated

### **Tral Schools Grapple With** Poor Infrastructure

**SRINAGAR:** As the school education department is conducting enrollment drives in Kashmir to attract more and more students towards government schools, several institutions in Tral sub-division of south Kashmir's Pulwama district are grappling with staff shortage and poor infrastructure.

As per the details obtained by KNO, many government schools in Tral continue to reel under severe infrastructure deficiencies and acute staff shortages, leaving hundreds of students, mostly from economically weaker families, struggling for basic educational facilities.

Aggrieved parents and locals have urged the Education Minister to personally intervene and address what they describe as "years of neglect".

They said that despite multiple requests to authorities, several schools in Tral are functioning under extremely difficult conditions, with children studying in tin sheds, overcrowded classrooms, and buildings lacking even basic amenities.

At Middle School Trale-Bala, more than 70 students are forced to attend classes in tin sheds, exposed to extreme heat in summer and freezing temperatures in winter. "It becomes unbearable for our children during harsh summers and even worse in the cold months," said Abdul Rashid, a concerned parent. "If the government can provide other facilities across the district, why can't they give our kids proper classrooms?'

Teachers also expressed helplessness, saying that teaching in such conditions directly affects learning outcomes.

The situation is similar at Government Middle School Lanzgund Branpathri, where around 70 students

from nine different classes are taught by only five teachers in just four rooms. "How can nine classes run in four rooms? Students end up disturbing each other because different subjects are taught in the same space," said Shabir Ahmad, a local. "Our children de-

serve better than this." At Government Middle School Gurtoo, 140 students are cramped into only three functional rooms. Parents said the shortage of both classrooms and staff has severely impacted the quality of education. "Our kids are bright, but how can they learn properly when they are squeezed into overcrowded rooms?" said Rafiqa Begum, a mother of two. "The government should at least provide additional classrooms and appoint teachers where

needed. Schools in Satoora and Zarihad also face similar issues. GMS Satoora has around 150 students but

is functioning with just six rooms. Locals said the infrastructure has not been upgraded for years. "It's the same story every year. Promises are made, but nothing changes," said Manzoor Ahmad, a resident of Satoora. "We urge the department to take our children's future seriously."

The most alarming condition has been reported from Gojer Basti Showjan Panzoo, where the school, functioning from nursery to class 8th in four rooms, has no toilet facility whatsoever. "This is the only government school in the area without a toilet," said Ghulam Nabi, a local elder. "Girls especially suffer the most. How can a school run without something as basic

as a washroom?" Parents warn that the absence of a toilet not only affects hygiene but also discourages students, especially girls, from attending regularly.

Parents across these villages have appealed for immediate intervention by the Education Minister to ensure proper infrastructure, adequate staffing, and basic amenities. "We are not demanding anything extraordinary—just fundamentals of a dignified education system," said Mohammad Yousuf, a parent. "We are poor people. The government schools are our only hope."

Locals said that unless urgent action is taken, the educational future of hundreds of children in Tral will continue to hang in the balance. They questioned the government's enrollment drives: "On what basis can they lure students when there is poor infrastructure and staff shortages?'

# Ahmedabad Lines Up Mega Events After Winning 2030 CWG

NEW DELHI- India's sporting ambitions received a major boost as officials on Wednesday revealed that Ahmedabad—freshly awarded the 2030 Commonwealth Games—has also been proposed as host for a series of major global competitions, including the 2028 World U20 Athletics Championships and the 2031 World Senior Athletics Championships. The announcements come as Gujarat positions the city as the centrepiece of India's bid to host the 2036 Olympics.

The Commonwealth Sport General Assembly's approval in Glasgow confirmed Ahmedabad as the host for the centenary edition of the CWG, marking the event's return to India 20 years



after the Delhi 2010 Games.
Ashwani Kumar, Principal Secretary for Sports in the Gujarat government, said the state is building world-class sports infrastructure with the long-term vision of making Ahmedabad In-

ready have the 2029 World Police and Fire Games lined up. These events will drive the local economy and showcase our capability."

India previously expressed interest in hosting the 2028 U20 Worlds during World Athletics President Sebastian Coe's visit last year. World Athletics is expected to announce hosts for the junior championships next month, while the 2029 and 2031 senior worlds will be awarded in 2026.

Ahmedabad has recently hosted the Commonwealth Weightlifting Championships and the Asian Aquatics Championships at the new Veer Savarkar Multisports Complex, with the Asian Weightlifting Championships scheduled for next year.

Gujarat Chief Minister Bhupendra Patel celebrated the CWG an-

nouncement as a "historic moment", crediting Prime Minister Narendra Modi and Union Home Minister Amit Shah for shaping the state's modern sports infrastructure.

"Ahmedabad is now a premier sporting destination—home to the Narendra Modi Stadium and world-class training hubs," Patel said, adding that the 2030 Games would be "grand, unforgettable and historic."

Deputy CM Harsh Sanghavi called the selection a landmark for Indian sports, reinforcing the country's growing profile as a global sporting host.

The 2030 CWG is expected to significantly strengthen India's pitch for the 2036 Olympics, with officials viewing the successful hosting of a multi-sport event as crucial proof of capability.

# Fans Boo Gambhir After 408-run Hammering

**GUWAHATI:**For the first time since taking charge of the Indian cricket team as head coach in 2024, Gautam Gambhir was booed by a visibly agitated section of supporters at the Barsapara Cricket Stadium here on Wednesday, moments after the hosts suffered a staggering 408-run loss to South Africa in the second Test.

Angry fans from one of the stands began shouting "Gambhir hai hai, go back," the chants ringing loud inside the stadium that had just witnessed one of Indian cricket team's darkest home afternoons.

The coach briefly looked towards the gallery, only to turn his face away and refusing to react.

The scenes quickly caught the attention of the players. At one point, several members of the playing XI found themselves staring in the direction of the commotion,

**NEW DELHI:** India's Test vice-captain Rishabh Pant has apologised for the team's shambolic performance in the 0-2 series loss to South Africa, asserting that the team will "regroup, refocus and reset" to come back stronger.

India were handed a 0-2 drubbing in the

series that ended with the second Test in Guwahati on Tuesday. Pant led the home side in this match as regular skipper Shubman Gill was nursing a neck injury.

## Real Madrid Beats Olympiakos in Champions League

Peal Madrid star Kylian Mbappé scored four goals in a Champions League match for the first time in his career Wednesday, including the second-fastest hat trick in the competition's history.

Mbappé netted three times in just under seven minutes in Real Madrid's 4-3 win at Olympiakos.

"I'm very happy to have scored the goals, it's always a pleasure for me," Mbappé said. "My teammates always set me up with good balls. I'm lucky to play for this team that has so much quality."

Mbappé scored the hat trick in the 22nd, 24th and 29th minutes — after Chiquinho had put Olympiakos ahead in the eighth. The France international added his fourth goal in the 60th after Mehdi Taremi had scored for the hosts in the 52nd. Ayoub El Kaabi scored Olympiakos' third goal in the 81st.

Mohamed Salah's hat trick for Liverpool at Rangers in 2022 had broken the record for the quickest ever scored in the Champions League, according to UEFA. The Egypt forward needed six minutes, 12 seconds to score his goals after entering the match seven minutes before his opening strike.

It was Mbappé's fifth hat trick in the Champions League
— and second this season. He had scored three times against
Kairat in the second round of the league phase. Two of his hat
tricks came with Paris Saint-Germain.

Lionel Messi and Cristiano Ronaldo have eight hat tricks each in the Champions League, while Robert Lewandowski has six

Mbappé now leads the Champions League in scoring this season with nine goals, three more than Galatasaray's Victor Osimhen. It's already Mbappé's best Champions League tally in a season. He has 22 goals in 18 matches with Madrid this campaign. (AP)

## **Barcelona Sluggish in Champions League**

Flick optimistic team can rebound

ansi Flick says his Barcelona team must play with "greater aggression" now that it finds itself in a Champions League mini-slump.

Barcelona's 3-0 loss to Chelsea on Tuesday left the team in 15th place ahead of Wednesday's games, and it followed a 3-3 draw at Club Brugge. In both matches, defensive mistakes were costly. At Stamford Bridge, Barcelona was outplayed and its attack failed to score for the first time in 53 games. It was a reality check for the Catalan club, which has been doing well in Spain. "We definitely need to be more dynamic and play with greater aggression," Flick said.

It was Barcelona's second defeat in the Champions League. It lost at home to Paris Saint-Germain in early October. With three games left in the league phase, Barcelona hosts Eintracht Frankfurt next month. "We have to accept the defeat and stay positive about what comes next," Flick said after Tuesday's loss. "I saw positive things and I believe we can still take the nine points left to play for."

Flick said things might have been different in London had Ferran Torres converted on his close-range opportunity in the fifth minute, when he missed from near the penalty spot with only the goalkeeper to beat. He said defender Ronald Araujo's red card in the 44th also played a big role.

"We started very well and had a very big opportunity to score the first goal" he said. "Then the red card changed the match, and it's not easy to recover against a team like Chelsea when you're a man down." (AP)
