#### **NIA Raids 8 Locations In Kashmir**

The National Srinagar: Investigation Agency on Monday raided eight locations across Pulwama, Shopian and Kulgam districts in connection with a white collar terror module linked to the car blast near Delhi's Red Fort, officials said.

Searches were carried out at the residence of Moulvi Irfan Ahmad Wagay in Shopian, who has emerged as the key figure behind the radicalisation and recruitment of the module busted early last month. Wagay, arrested by police in October, was taken into NIA custody last month after the agency took over the probe into the blast that killed fifteen people and left several others injured.

Raids were also conducted at Koil, Chandgam, Malangpora and Samboora areas of Pulwama, with officials saying these locations were connected to individuals associated with the Delhi | More on P6

# J&K Placed In New **Highest-Risk Seismic Zone VI**

Srinagar: In a landmark shift with direct implications for Jammu & Kashmir, the Union Territory has been placed in India's newly created highestrisk seismic Zone VI, according to a radical overhaul of the country's earthquake hazard map released by the Bureau of Indian Standards (BIS). The reclassification, issued under the revised Earthquake Design Code, marks the strongest official acknowledgement yet of the extreme tectonic stresses underlying the Himalayan region.

With the updated map, the entire Himalayan stretch from I&K to Arunachal Pradesh has now been grouped under Zone VI—an unprecedented move that unifies the mountain arc under a single, severerisk category. Scientists say the change corrects earlier inconsistencies that split the Himalayas across Zones IV and V despite all segments being threaded by the same active megathrust fault.

The new hazard zonation

Map of India

also reveals that 61% of India's landmass falls under moderate to high seismic zones, with nearly 75% of the population living in areas vulnerable to strong ground shaking. For I&K—situated atop one of the most geologically active sections of the Himalayan collision zone-the upgrade signifies heightened urgency for seismic-resilient construction, retrofitting of critical facilities and stricter enforcement of building norms.

Experts say the revised map moves India decisively toward probabilistic seismic hazard assessment (PSHA), a global standard that uses fault-specific data, maximum expected magnitudes, soil response, and ground-motion modelling.
"The updated map final-

ly brings uniformity to the Himalayan belt," said Vineet Gahalaut, director of the Wadia Institute | More on P6

Eight infiltrators were killed and five others were pushed back, a senior BSF officer said.



#### **SC Orders CBI Probe Into Digital Arrest Scams**

New Delhi: The Supreme Court on Monday asked the CBI to carry out a unified pan-India probe into digital arrest scam cases and asked the RBI as to why it was not using Artificial Intelligence (AI) to find out and freeze bank accounts used by cyber criminals.

Digital arrest is a growing form of cybercrime in which fraudsters pose as law enforcement, court officials or personnel from government agencies to intimidate victims through audio and video calls. They hold the victims hostage and put pressure

on them to pay money.

#### **Civil Court Has Primacy Over Revenue Authorities: HC**

Srinagar: The High Court of I&K and Ladakh on Monday quashed a series of orders issued by a revenue authority, holding that such actions could not stand once a civil court was already seized of the matter.

Emphasizing the settled legal position that the jurisdiction of the civil court was "superior to, and overrides, that of the revenue authorities" in disputes involving title, possession, or civil rights over immovable property, a bench of Justice Wasim Sadiq Nargal observed that revenue authorities are obligated to refrain from passing any orders that may conflict with



or prejudice ongoing civil proceedings

The bench passed the verdict while hearing a petition, challenging the orders dated March 3, 2016, May 23, 2016, and February 27, 2018, issued by a concerned revenue officer in Baramulla.

#### Rubaiyya Sayeed Kidnapping Case

#### CBI Arrests 'Absconder' After 35 Years

Srinagar: The Central Bureau of Investigation on Monday arrested an absconder carrying a reward of ten lakh rupees in the 1989 kidnapping of Rubaiyya Sayeed, the daughter of the then Union Home Minister Mufti Mohammed Sayeed. Officials identified him as Shafat Ahmed Shangloo, alleged to be a close confidant of JKLF chief Yasin Malik.

The agency said Shangloo had been wanted for decades for allegedly taking part in a conspiracy hatched by members of the banned Jammu Kashmir Liberation Front. He was arrested by a CBI team along with Jammu and Kashmir Police from his residence in Nishat, Srinagar, after following the due legal process.

statement, Shangloo had conspired with Malik and others in the crime under various sections of the Ranbir Penal Code and the TADA Act in 1989. He carried a reward of ten lakh rupees and will be produced before the TADA court in Jammu. Officials said Shangloo was

an office bearer of the banned outfit and handled its finances.

His arrest comes amid ongoing court proceedings where Yasin Malik has been attending hearings through video conferencing due to restrictions on his movement. Malik is currently lodged in Tihar Jail after being convicted in a terror financing case.

During the hearings, Rubaiyya Sayeed had identified Malik and four other accused as part of the group involved in her abduction. She was kidnapped near Lal Ded Hospital in Srinagar on December 8, 1989, and released five days later after the central government, led by V P Singh and supported by the BJP, freed five militants in exchange.

Now settled in Tamil Nadu, she is listed as a prosecution witness. The CBI took over the case in 1990. To expedite the trial, the agency appointed senior counsel Monika | More on P6

## **US Study Finds Physical Activity In Mid-Life Could Lower Dementia Risk By 45%**

egular physical activity during mid-life years and later could lower one's risk of developing dementia by up to 45 per cent, compared to those who are less active during the period, found an analysis of over 4,300 adults in a US town. The findings, published in The Journal

of the American Medical Association (JAMA), could help develop strategies that are timed to the most relevant stages of adult life, researchers said. Dementia is an ageing-related condition in which one's memory, thought processes and speech are steadily impacted over time, and can eventually interfere with daily activities. Alzheimer's disease is the most com-

Researchers from Boston University School of Medicine looked at data from the 'Framingham Heart Study', which began in 1948 and recruited men and women from the town of Framingham in the US state of Massachusetts. The participants were followed up for a period of up to 37

'Individuals with the highest levels of physical activity at mid-life and latelife had 41 per cent and 45 per cent lower risk of all-cause dementia, respectively, compared with those with the lowest levels of physical activity," authors wrote.

Among the participants -- 1,526 young adults, 1,943 in mid-life and 855 in late years -- 567 cases of de-

mentia were noted at the end of the follow-up period.

Moderate levels of physical activity was associated with 35-38 per cent lower risk of dementia, compared to the least physically active ones. The researchers also looked at how carrying the 'APOE e4' gene variant

considered among the strongest factors for developing Alzheimer's disease -- impacted the link between physical activity and dementia risk. For those not carrying the gene variant, highest levels of physical activity during mid-life were linked to a nearly 50-60 per cent lower risk of dementia, while highest levels during late-life resulted in a 46 per cent lower risk, compared to lowest levels of activity.

# Nishat WTP Set for Capacity Boost

SRINAGAR: Minister for Jal Shakti, Forest, Ecology & Environment and Tribal Affairs, Javed Ahmed Rana on Monday visited the Nishat Water Treatment Plant to review its functioning and evaluate the treatment processes.

The Minister was accompanied by legislators Showkat Ganai, Ali Mohammad Dar and Ghulam Mohiuddin.

The Minister accompanied by concerned officers conducted a comprehensive inspection of the plant's filtration, treatment and distribution mechanisms. They closely observed the operational efficiency of different units, ongoing maintenance works and the protocols in place to safeguard water quality standards.

During the review, the delegation assessed the technical functioning of the machinery, performance of treatment beds and upkeep of essential infrastructure.

The Minister emphasised evaluation the current maintenance practices and identifying areas requiring immediate attention to ensure seamless service delivery

As part of the visit, the Minister also reviewed the ongoing works under Smart City Limited and AMRUT 2.0, which are aimed at upgrading Srinagar's water supply infrastructure. He inspected the 3 MGD Rapid Sand Filtration Plant being developed under Smart City Limited, which will enhance the existing Water Treatment Plant capacity from 19 MGD to 22 MGD.

This augmentation will significantly strengthen the water supply to tail-end areas including Khanyar, Rainawari, Lal Chowk and their adjoining localities, benefitting an additional 87,000 residents.

Rana further reviewed the 7 MGD Activated Carbon Chamber being constructed under AMRUT 2.0 to improve the quality of treated water supplied from WTP Nishat.

The project addresses the long-standing colour and odour issues arising from raw water, a concern repeatedly raised by MLAs of the Estimates Committee. Once operational, the upgraded system will ensure improved water quality for nearly 6 lakh residents of Srinagar.

# Srinagar's Critical Medical Zone to Get New Alternate Route

Srinagar: Deputy Commissioner (DC) Srinagar Akshay Labroo on Monday said the administration has rolled out a coordinated and technology-supported plan to tackle the traffic congestion in a systematic way across the district.

Speaking during a field inspection of the Sonarkol Road project near the Super Speciality Hospital and Government Dental College, DC Labroo, as per KNO that a series of mobility-focused projects, ranging from new link roads to improved traffic enforcement are being executed to ease daily movement through the city's most congested zones.

He said the Sonarkol link road that is currently under construction will connect Nawa Bazar with Safa Kadal and provide an alternate route for ambulances and commuters.

He said the district administration, Srinagar Smart City, R&B, Traffic Police and other departments are working in close coordination under a multidisciplinary committee chaired by the Chief Secretary and Divisional Commissioner.

He said that the recent infrastructural upgrades such as the Sanat Nagar flyover and Noor Jahan Bridge have already provided partial relief. "The ongoing scientific mobility plan will be implemented in phases to ensure lasting impact."

The DC further added that "The administration is focused on creating a long-term system that offers infrastructure expansion, smart traffic solutions and disciplined driving behaviour so that Srinagar moves not just faster, but smarter."

# Public Role Vital in Fighting Traffic Snarls: SSP

rinagar: Senior Superintendent of Police (Traffic City), Ajaz Ahmad Bhat Monday said traffic gridlocks cannot be completely eradicated due to structural limitations but citizen discipline can prevent the congestion.

The SSP said that the Traffic Department is intensifying enforcement and regulation measures in Srinagar while the long-term decongestion depends on coordinated infrastructural interventions by the administration.

Speaking to media persons in Srinagar, the SSP said that the department's role is limited to regulation and enforcement. "The infrastructure upgrades such as road widening, alternate routes and parking facilities fall under the purview of the administration."

"We can regulate and act against violators, but creating infrastructure is the administration's responsibility. The district administration regularly takes our suggestions and if the suggestions are implemented effectively, these steps can significantly ease the congestion," he said, as per KNO.

The SSP said the city's key stretches, including areas around SMHS and Super Specialty Hospitals, face severe congestion due to the flow of vehicles of patients and other vehicular movement, street vendors and narrow road space.

The statement reads, the project is a part of the broader mobility improvement and traffic regulation plan along the Nawab Bazar-Kaksa-

raie—Darish Kadal Corridor aimed at streamlining vehicular movement by distributing traffic through the Suner Kul route.

During the visit, the DC and SMC Commissioner along with senior Officers and engineers, carried out an onsite assessment of the works initiated to develop this alternate road for improving mobility and decongesting the critical Medical Area around Super Specialty Hospital, SMHS and Dental College.

It said that the project will al-

It said that the project will allow alternate vehicular movement through a specialised route. An on-site assessment of establishing a dedicated parking facility around the high-priority hospital zone encompassing SMHS Hospital, Dental Hospital and the Super Specialty Hospital to prevent roadside congestion and facilitate smooth access for patients, attendants and emergency vehicles was also deliberated upon.

"The Nawab Bazar–Kak Saraie-Darish Kadal corridor via the Suner Kul bund link, is aimed at ensuring smooth mobility and decongested vehicular movement," it reads.

The DC directed the concerned executing agencies to ensure that the pace of work on the approved decongestion project is maintained at a fast rate so as to ensure timely completion of the project, emphasizing the need to prioritize interventions that guarantee swift patient movement and timely ambulance access, while minimizing inconvenience to local residents, traders, and commuters.

He noted that the proposed corridor would help redistribute traffic load, reduce bottlenecks in densely populated market stretches and streamline the approach roads leading to the major hospitals of Srinagar City.

The DC further highlighted that all measures are being implemented in close coordination with SMC, Traffic Police, local stakeholders, and health authorities to ensure smooth execution with minimal disruption.

alk to anyone in Kashmir today and the conversation drifts toward cement. Someone's cousin has poured a new roof. An aunt is adding a second floor. A neighbour's marble gate went up last week.

Building a home feels like a milestone. It tells you that your children will have a safe place and that the difficult years have not dimmed your dreams.

But step inside many of these fresh-painted homes and you sense worry in the air.

The walls stand firm, but the family is still trying to pay the mason. Bank loans are out of reach for many. Land papers are unclear, incomes change from day to day and property cases move slowly.

When the bank turns them away, people walk to lenders in back alleys who offer cash at 24 or even 36 percent interest with no questions asked.

So a staircase goes up and then stays unfinished. A gate is installed, while the rooms behind it remain bare. Prices of bricks, timber and sand jump each spring. Winter stops work for months.

Every pause adds more debt. And social pressure only adds to the weight.

Parents feel judged if they delay repairs. Newly married couples want their own entrance. Relatives keep track of every upgrade.

A lovely front yard can end up hiding skipped meals, children moved out of private schools and postponed clinic visits.

Government schemes exist in small pockets. Grants and subsidised loans are there on paper, but the forms expect steady salaries and clean titles.

Many families fall outside those neat requirements. Cooperative banks, community purchase plans and a simple one-hour money basics session at the

village office could make a real difference. Small steps like these can keep a home from

weighing people down. A house, at the end of the day, should feel like shelter, a space that brings calm instead of stress.

Many young people saw their parents struggle and stepped away. Handicraft exports fell, incomes dropped, and trade networks broke.

Meanwhile, Marwari traders kept growing. When one business slowed, they moved into another. They treated business as a lifelong habit: tracking costs, reinvesting profits, training the next generation, and never letting location limit them.

Kashmiri youth can do the same, without copying anyone. They need to focus on a skill, stay honest, adapt to digital tools, and let family life teach real business. Social media, online shops, and logistics can turn local crafts into global brands.

The key is mindset. If today's generation combines skill, honesty, patience, and smart reinvestment, Kashmir can once again produce trade houses the world respects, this time using technology and global markets, while keeping its proud legacy alive.

# **When Honey Hurts**

Chemicals hidden in honey, butter, and sweets are silently harming children and adults across Kashmir, creating a health crisis that could span generations.

If Kashmir fails to act, the consequences will be massive: rising childhood disorders, metabolic disease, sudden heart attacks, failing kidneys, and families trapped in lifelong medical struggle. These products are engineered threats. And those producing and selling them are silent executioners.

serious health crisis is sweeping through Kashmir, disguised in everyday treats. It hides in jars labelled "pure honey," tubs of "village butter," colourful sweets, and bakery goods.

What looks like a harmless cottage industry is actually a deep and dangerous network of food adulteration.

It takes advantage of families who don't suspect a thing, the trust of elderly patients, and the vulnerability of children.

The threat is a direct attack on people's health. And if Kashmir doesn't act quickly with science, and firm laws, it could be staring at a generational health disaster far bigger than anything it is ready for.

In the Barthana-Parimpora stretch of Srinagar, the crisis is already showing its real size.

Homes that should be sheltering families have turned into hidden processing units, run by people who have moved in from different districts and rented these rooms for the job.

What looks like normal residential life from the outside turns into something unsettling once the doors shut.

Industrial suga boiled and coloured to pass as honey. Cheap hydrogenated fats are melted to look like butter. Fake combs are crafted to fool buyers.

And the most worrying part is the sweets and bakery items made from chemical dyes, rancid oils, synthetic emulsifiers, and stabilizers that can be harmful even in small amounts. These fake products move

through informal networks into rural Kashmir, where trust in visitors and the absence of testing make families easy targets. Children in villages are often

the first to suffer, drawn to the bright sweets and baked snacks that hide a slow poisoning beneath their colours.

To grasp how serious this really is, we need to set aside emotion and look at what science tells us about a body under attack.

Natural honey is a biologically rich food made by bees, packed with enzymes, antioxidants, and minerals that help the body absorb it safely. But the "honey" sold in many

of these markets is nothing more than engineered sugar. It is high-fructose corn syr-

up, rice syrup, or inverted sugar made to look real. When these syrups enter the body, they trigger a sudden and dangerous spike in glucose levels. For someone with diabetes or

pre-diabetes, even a single spoon of this fake honey can send blood sugar from a safe level to a lifethreatening one in hours. Readings can leap from 120 or

150 mg/dL straight into the 300s, 400s, or even 500 mg/dL.

Such spikes can trigger insulin shock, strain organs, damage pancreatic cells, and set the stage for long-term kidney and vascu-

In a place already struggling with diabetes and high blood pressure, this is deadly serious. The adulterated butter, sweets, and baked goods from these hidden units make the danger even worse.

These products are loaded with hydrogenated fats, trans fats, synthetic colours, and industrial chemicals that act like slow poisons. They push up LDL cholesterol, inflame arteries, thicken the blood, and raise the risk of hidden blockages that only show up when a heart attack hits.

For children, these chemicals are especially harmful. They damage the liver, slow growth, and disturb metabolism, setting the stage for diseases that may appear years later.

The risk is already greater in Kashmir, where hospitals are full of patients with unstable blood sugar, strained hearts, and failing organs.

In this vulnerable situation, fake and adulterated food only makes things worse.

A diabetic eating fake honey is simply being pushed toward a medical emergency. A child eating brightly coloured sweets is ingesting chemicals linked to longterm toxicity and cancer.

Those making and selling these products cannot be treated as petty criminals. They are knowingly putting lives at risk.

Their actions can cause organ failure, coma, heart attacks, and chronic disease

Whether they see the results or not, the chain of harm is clear and scientifically undeniable.

Kashmir cannot treat this as a routine enforcement issue.

Homes turned into processing units must be raided, samples tested, and manufacturers and financiers prosecuted under the strictest laws.

Supply routes into villages must be mapped and stopped. Enforcement must hit the operation's core, rather than just street-level sellers.

Without strong action, the slow poisoning of Kashmir will continue.

Families need to know that real honey, butter, and sweets cannot be sold at throwaway prices.

Artificial colours can harm children's livers and behaviour. Fake honey can spike blood sugar in minutes. And cheap fats can silently clog arteries.

The belief that "natural-looking" equals safe must end. Socialmedia influencers promoting these products as medicinal or "diabetic-friendly" are spreading danger and must be regulated

If Kashmir fails to act, the consequences will be massive: rising childhood disorders, metabolic disease, sudden heart attacks, fail ing kidneys, and families trapped in lifelong medical struggle.

These products are engineered threats. And those producing and selling them are silent executioners.

The choice is clear: act decisively now, or watch a generation suffer from diseases that were preventable and inflicted knowingly.

The poison is already in kitchens. The question is whether society has the will to remove it and hold its creators accountable.


# Global Learning Can Help Kashmir Break Old Patterns

Foreign study helps young minds step out of the narrow race for titles and into a broader world of ideas.



#### IN MANY UNDERDEVELOPED **AREAS, THE LACK OF QUALITY SCHOOLS, TRAINED**

**TEACHERS,** or criticalthinking curricula leaves people unprepared to face ethical complexity or uphold civic responsibility. Corruption becomes normal, and trust in institutions collapses. People rely on informal networks, family ties, or shortcuts because the formal system lacks moral credibility. In such environments, even honest behaviour is hard to sustain, as survival often outweighs ethical ideals.

oo often, people in Kashmir follow the crowd, moving along familiar paths without questioning them.

Superficial concerns, ego, envy, and an obsession with status shape much of everyday life.

Gossip spreads easily, personal gain often comes before the common good, and narrow, tribal thinking blocks fresh ideas.

When careers instit ambitions are driven more by competition and self-interest than by purpose or ethics, it's hard for any society to truly move forward.

The problem goes even deeper. Social pressures and hidden cultural shifts shape the way we think,

often without us realizing it. Over time, this erodes our sense of right and wrong, creating patterns that weaken communities in-

stead of helping them grow. Even many white-collar professionals are guided more by comparison than by true purpose.

If a cousin or neighbour becomes a doctor, others feel pressure to follow the same path, simply to keep up or prove themselves.

In the process, even careers meant to serve others can lose their meaning. They shift from contribution into competition and from service into status.

A similar pattern shows up in the growing interest among young Kashmiris in civil services, which is an admirable ambition on the surface. But when asked about their goals, many focus more on the appeal of authority, privileges, and social recognition than on improving education, making policies effec-

tive, or serving the community. This reveals a mindset that puts

personal gain above civic duty. When status, comparison, and ego drive choices, every part of society reflects it. Politics, bureaucracy, healthcare, and education all start to mirror the same motivations.

Over time, individual ambitions shape institutions, and those institutions, in turn, reinforce the same ambitions. A self-perpetuating cycle forms, where personal gain overshadows collective purpose, and this mindset becomes woven into the social fabric.

The same mindset shows up when we look at how society values different professions.

Take a waiter, for example. Many see his work as "lesser," but he earns his living honestly, without exploiting anyone, bending rules, or pretending to be someone he is not. In many ways, he shows more integrity than people in prestigious jobs who fail to live up to the ethics those roles demand.

The problem grows when whitecollar professionals, armed with degrees but lacking humility, assume they are inherently superior.

This reveals a deeper misunderstanding of what education truly

Beyond collecting degrees or qualifications, education is essentially about shaping wise character. A truly educated person sees dignity in all honest work, whether someone is serving a meal or performing a complex surgery.

This difference is clearer in societies where respect, not hierarchy, shapes social life.

In many European countries, strong ethical standards are the result of centuries of cultural traditions, accountable institutions, and shared moral expectations.

Morality is part of everyday life in West. Politicians and civil servants go about their routines with ease and simplicity. It's normal to see a minister standing in line at a supermarket, carrying their own groceries, cycling to work, or taking the metro without security.

These actions aren't celebrated because they're expected. Public office doesn't put anyone above ordinary life.

In these societies, power is stripped of spectacle. Leaders who demand special treatment or show entitlement are seen as unfit.

Authority is not a personal advantage, and public trust depends on humility and restraint.

European politicians aren't from another world. Their behavior reflects the values of the society that shaped them.

In contrast, in much of South Asia, politicians and bureaucrats often seem out of touch. They rise from systems where ethical standards are weak, and this shapes the kind of governance people actually experience.

This same moral framework helps explain why resignations over seemingly small ethical breaches are treated as normal rather than shocking events.

In Germany, Health Minister Ulla Schmidt faced a national controversy simply for using her official limousine during a private vacation in Spain, a breach of public trust that damaged her credibility.

State Secretary Thomas Mirow resigned after accepting discounted airline tickets linked to corporate interests.

In Ireland, ministers such as Beverly Flynn, Ivor Callely, and Michael Lowry stepped down over improper phone expenses, undeclared payments, or small preferential deals, issues that in other countries might have been dismissed as trivial.

In the United Kingdom, more than twenty MPs and Lords lost their positions for claiming public money for household cleaning, gardening, furniture, or even maintain ing a decorative moat.

The amounts were often modest, but the expectation of integrity was so high that even minor breaches ended careers.

Taken together, these examples reveal a deeper truth about Europe: ethical conduct is a social obligation enforced by the public conscience.

In these societies, the moral compass of the community values humility, transparency, and selfrestraint.

Dignity is measured by one's commitment to fairness, honesty, and civic responsibility. Ethical behaviour is an internal guide shaped by values passed down through generations.

European social ethics grow from a culture where hierarchy is intentionally softened so equality can thrive.

A teacher, a nurse, a bus driver, or a minister are all seen through the lens of what they contribute. Respect comes from recognizing human worth, rather than job titles. Even professions like medicine, civil service, or engineering are valued for service than status.

The absence of a superiority complex keeps society from falling into competition-driven vanity.

This mindset also makes arrogance easy to spot as a moral failure. Ego is seen as a barrier to reason, and domination is seen as a threat to the collective good. A leader who acts overly power-

ful only exposes insecurity. A civil servant who rules like a king instantly loses legitimacy. Ethical consciousness in these societies is both personal and insti-

Schools teach civic responsibility, families nurture emotional discipline, and governance systems reward humility while punishing

The result is a society where ethical behaviour is routine. People are not perfect, but they live in systems that encourage good

choices and discourage showing off,

dominating others, or using status for personal gain.

The difference between societies that thrive and those that stagnate lies in the social conditions that shape how people understand dignity, authority, and responsibility.

This is what sets apart societies that grow through moral maturity from those weighed down by ego, comparison, and status obsession. When ethics are internalized, in-

#### Par panel asks govt to enhance domestic output of P&K fertilisers, cut imports

New Delhi, Dec 1: A parliamentary panel has asked the government to boost domestic production of phosphatic and potassic (P&K) fertilizers and reduce import dependence.

A Standing Committee on Chemicals and Fertilizers on Monday presented a report on self-sufficiency in the production of fertilizers with a view to curbing the import of fertilisers and reviewing constraints.

"The Committee note that the country is heavily dependent on imported raw materials for production of P&K fertilizers," it said.

The country imports nearly 95 per cent of its phosphate requirements and is 100 per cent dependent on imports of

The Committee observed that any increase in global prices of these raw materials, exchange rate fluctuations and global supply chain disruptions impact the domestic cost of fertilizer production.

The report pointed out that the domestic production capacity of P&K fertilizers (which include DAP & NPK) in the country is 160 lakh tonnes per annum against the total requirement of 240 lakh tonnes per annum.

The Committee said the consumption of P&K fertilizers would increase to 305 lakh tonnes during 2035-36.

The report said that work for the commissioning of some new units and capacity enhancement initiatives is planned or is in progress in the P&K sector.

The Committee, therefore, sked the Department of asked Fertilizers to take steps for the timely completion of the projects already started and capacity expansion of the other existing plants.

This will enhance domestic production of P&K fertilizers and reduce dependence on

In a separate report on the Department of Pharmaceutical, the Committee stressed the need to reduce the price of

The panel asked the NPPA (National Pharmaceutical Pricing Authority) as well as the department to look into the matter to bring down the prices

"The Committee have also recommended that the NPPA should strictly monitor and ensure that the stents are not made available to the patients over and above the prices fixed by it and cases of overcharging, if any, may be dealt with strictly," the report said.

# 'No Delete Option' India Tells Smartphone Firms To Preload State Security App

Srinagar: India's telecoms ministry has privately asked smartphone makers to preload all new devices with a state-owned cyber security app that cannot be deleted, a government order, accessed by Reuters, showed, a move likely to antagonise Apple and privacy advocates.

In tackling a recent surge of cyber crime and hacking, India is joining authorities worldwide, most recently in Russia, to frame rules blocking the use of stolen phones for fraud or promoting state-backed gov-

ernment service apps.
Apple, which has previously locked horns with the telecom regulator over development of a government anti-spam mobile app, is among the companies, such as Samsung, opens new tab, Vivo, Oppo and Xiaomi, opens new tab bound

by the new order. The November 28 order, seen by Reuters, gives major smartphone companies 90 days to ensure that the government's Sanchar Saathi app is pre-installed on new mobile phones, with a provision that users cannot disable it.

For devices already in the supply chain, manufacturers should push the app to phones via software updates, the ministry said in its order, which was not made public and was sent privately to select companies.

The government said the app was essential to combat "serious endangerment" of telecom cyber security from duplicate or spoofed IMEI numbers, which enable scams and network misuse.

Apple's iOS powered an estimated 4.5 per cent of 735 million smartphones in India by mid-2025, with the rest using Android, Counterpoint Research says.

While Apple pre-installs its own proprietary apps on phones, its internal policies prohibit installation of any government or third-party app before sale of a smartphone, a source with direct knowledge of the matter said.

"Apple has historically refused such requests from governments," said Tarun Pathak, a research director at Counterpoint.

Apple, Google, Samsung and Xiaomi did not respond to requests for comment. India's telecoms ministry also did not

À 14- to 17-digit number unique to each handset, the IMEI, or International Mobile Equipment Identity, is most commonly used to cut off network access for phones reported to have been stolen.

The government app allows users to report suspicious calls, verify IMEIs and block stolen devices through a central registry.

With more than 5 million downloads since its launch, the app has helped block more than 3.7 million stolen or lost mobile phones, while more than 30 million fraudulent connections have also been terminated.

The government says it helps prevent cyber threats and assists tracking and blocking of lost or stolen phones, helping police to trace devices, while keeping counterfeits out of the black market. (Reuters)

## Hindu rights outfit demands reservation, shifting of Muslims from medical college in Jammu

Jammu, Dec 1: The Yuva Rajput Sabha on Monday protested and demanded that Muslim students be shifted from the Shri Mata Vaishno Devi Institute of Medical Excellence (SMVDIME) and Hindus get reservation.

The protest followed the selection of 42 Muslims, mostly from Kashmir, one Sikh and seven Hindu candidates through the National Eligibility cum Entrance Test (NEET) against the sanctioned 50 MBBS seats for the 2025–26 academic session.

The medical college, built on 34 acres of land owned by the Shri Mata Vaishno Devi Shrine Board, was granted permission by the National Medical Commission on September 8 to commence admissions for the

Activists, led by Yuva Rajput Sabha leader Mandeep Singh, staged a demonstration at the Tawi bridge, alleging that the admission was part of a "conspiracy" against Jammu and the minority Hindu community there through, what they termed, flawed legislative bylaws.

Protesters raised slogans against the government, the Lieutenant Governor's administration, accusing them of denying Hindus reservation on the pattern of Baba Ghulam Shah Badshah University, Islamic University, and Mahant Bijender Singh institutions, which they claimed community-based provide reservations.

"This protest is a matter of faith as Mata Vaishno Devi University and its colleges are important institutions for the community in Jammu and Kashmir. The Act and bylaws have been deliberately framed in a manner that harms the Hindu community," Mandeep Singh told reporters.

He warned that the outfit would intensify its protest if the government failed to address its demands within 15 days.

The Yuva Rajput Sabha expressed full support to the Shri Mata Vaishnodevi Sangharsh Samiti (SMVSS), a conglomeration of several organisations spearheading the movement.

The group urged the LG administration, the J-K government and the Centre to honour assurances regarding admissions and sought declaration of Mata Vaishno Devi University as a minority institution.

They also appealed to Prime Minister Narendra Modi and Union Home Minister Amit Shah to amend the Act and bylaws of the university in the interest of what they termed the welfare of Sanatan Dharma and Hindu students.

Environmental and seismic-risk analyst Rajesh Solomon Paul called the reclassification a "historic shift". In addition to LoC duties, BSF units continue to secure vital installations and assist police and other agencies in safeguarding civilians.

The IG highlighted Operation Sindoor as the force's most notable achievement this year. He said BSF units, along with the Army, executed precise fire assaults on Pakistan posts and terrorist launch pads along the LoC, causing heavy casualties to Pakistani troops, damaging forward posts and destroying some launch pads.

He said the country's leadership appreciated the BSF's strong and professional response during the operation.

Yadav also said the BSF has deployed Mahila Troops in forward areas along the LoC and at round the clock checkpoints on roads approaching the frontier. These units help intercept female couriers and sympathisers of terror groups and smuggling networks. He said Mahila Troops have earned the trust of women in border villages and are playing a key role in countering anti-national activities in coordination with local women.

Chowdhury said she had picked up the stray earlier in the day and was taking it to a veterinarian. She also claimed that the government does not like animals and questioned the objections raised by the ruling party MPs, saying there was no law against rescuing a stray dog.

In the Lok Sabha, a relentless Opposition repeatedly trooped into the Well and raised slogans demanding debate on SIR, prompting Speaker Om Birla to caution them against lowering the dignity of the House.

The House saw two adjournments before being adjourned for the day around 2.20 pm as disruptions continued.

The Lower House also passed the Manipur GST Bill to replace an ordinance promulgated to implement the GST 2.0 reforms in the northeastern state. The Bill was introduced on Monday itself and cleared after a brief debate.

It was the first day of Radhakrishnan as the presiding officer after being elected as the vice president in September following the sudden resignation of Jagdeep Dhankhar.

Addressing the House, Radhakrishnan urged members to uphold the Constitution and follow parliamentary norms while adhering to the 'Lakshman Rekha' as envisaged under the rules of the Upper House.

He also called upon members to respect institutions and understand their responsibilities towards the nation.

Welcoming the new Chair, Prime Minister Narendra Modi said the rise of Radhakrishnan from an ordinary background to the office of Vice President reflects the true strength of democracy, and hoped his experience and guidance will aid in the smooth running of the Rajya Sabha.

At the start of the Winter session of Parliament, Modi congratulated him and wished that the House, under this guidance, would have meaningful discussions and take crucial decisions.

"I congratulate you, and I am confident that every member of this House will honour its traditions and uphold your dignity as well," the prime minister said.

The Leader of Opposition in Rajya Sabha, Mallikarjun Kharge, while welcoming Chairperson Radhakrishnan made a mention of the "unexpected and sudden exit" of his predecessor Dhankhar that triggered sharp reactions from the treasury benches.

In his brief speech, Kharge urged the Rajya Sabha Chair to maintain a balance between both sides and allow the opposition members also to raise their issues in the House.

Chowdhary Rajya Sabha member Mohammed Ramzan on Monday raised concerns over what he described as the limited powers of Jammu and Kashmir's elected government, asserting that real authority continues to rest with Lieutenant Governor Manoj

Delivering his maiden speech in the Rajya Sabha, Ramzan said the people had given the National Conference a two thirds majority, paving the way for a popular government led by Chief Minister Omar Abdullah. But despite this mandate, he said, the elected administration had little executive control over governance in the Union Territory.

Speaking amid interruptions from some members, Ramzan said, "I would like to say here with great sorrow that all the power is in the hands of the LG. Orders flow from there.' He added that the elected government held almost no authority over day to day affairs.

Ramzan was formally addressing the House on behalf of his party to felicitate Vice President C P Radhakrishnan on assuming charge as Rajya Sabha Chairman. Acknowledging that he did not know the Chairperson personally, he praised his background as a social worker and said such positions come only after long years of public service and sacrifice.

However, he quickly shifted to the issue of governance in Jammu and Kashmir, arguing that although free and fair elections were held in 2024, the elected dispensation remained powerless. At this point, the Rajya Sabha Chairman intervened, asking Ramzan to stick to the designated welcome address and assuring him that he would get another opportunity to raise his concerns.

Despite the intervention, Ramzan continued, stressing the strategic importance and turbulent history of Jammu and Kashmir. "You know what has happened in Jammu and Kashmir in the last decades. We have to strengthen it." he said, adding that the overwhelming mandate given to the elected government meant little if it lacked authority.

Ramzan's remarks drew appreciation from Chief Minister Omar Abdullah, who watched the proceedings from the visitors gallery along with his advisor Nasir Wani. "First day, first show. Well done... Ch Mohd Ramzan for using the first available opportunity to remind the union government of its promise about restoration of statehood to Jammu and Kashmir," Omar said on X.

It asked Solicitor General Tushar Mehta to ensure that the views of various Union ministries, including Ministry of Home Affairs, Department of Telecom, Ministry of Finance and Ministry of Electronics and Information Technology, are put before it to deal with cy-

bercrimes cases. The top court said all states and UTs and their police agencies along with the CBI are free to freeze bank accounts used in defraud-

ing citizens. At the outset, the bench directed the CBI to probe bank officials who are hand-in-glove and who help in operating mule accounts with the fraudsters in duping citizens, and register cases against them under the Prevention of Corruption Act.

A mule account is a bank account also known by some other names used by cybercriminals to receive and transfer illicit funds, making it harder to trace the source of the money for the probe agencies.

The bench said amicus curiae advocate N S Nappinai has, after preliminary analysis, flagged broadly three types of cybercrimes -digital arrests, investment scams and part-time job scams -- which are most prevalent in the

While explaining the nature of these three cyber crimes, the bench said that there can be no second opinion that every such crime needs to be investigated but digital arrest cases require immediate attention. The other two categories -- of investment and part-time job scams -- can be taken in the second and third phases, it added.

The top court directed the CBI to induct any officer from states and technical experts and associate them as members of the probe team on digital arrest cases.

On November 3, the top court said it needs to deal with digital arrest cases with an iron hand, while expressing shock over the scale of such cybercrime cases in the country, with over Rs 3,000 crore allegedly extorted from victims, including senior citizens.

It went through two sealed cover reports submitted by the Ministry of Home Affairs and the CBI.

On October 27, the top court said it is inclined to entrust the CBI with the probe into digital arrest cases after taking into consideration the magnitude and pan-India spread of It sought details of FIRs registered in differ-

ent states and UTs. The top court said it would monitor the progress of the CBI investigation and issue whatever directions were necessary to deal with these crimes. On October 17, taking note of the rising inci-

dents of online fraud in the country, especially

digital arrests to dupe citizens by fabricating judicial orders, the top court sought responses from the Centre and the CBI, saying such offences strike at the "very foundation" of public trust in the system.

The apex court flagged the rising number of digital arrest cases across the country and said forging apex court, high court orders and signatures of judges to digitally arrest innocent people, including senior citizens, strikes at the bottom of trust and faith of people in judicial

It said forgery of documents and criminal misuse of the name, seal and judicial orders of this court or high court is a matter of grave concern, and such criminal acts cannot be treated as an ordinary or solitary offence of cheating or cyber crime.

Ganie owns land in the adjoining patch and already has access through two approach roads, the petitioner said and supported the same by revenue extracts.

However, after the petitioner fenced his land and raised construction, Ganie approached the Tehsildar concerned, alleging encroachment on an "alleged common pathway."

The Tehsildar was informed that a civil suit on the issue was already pending. Consequently, the Tehsildar had initially directed that proceedings before him would remain on hold until the civil court's decision. Subsequently, Tehsildar Pattan directed Khan to remove the alleged obstruction from the pathway within five days.

The High Court noted that in that civil suit, the trial court had vacated an interim status quo order that was earlier granted in favour of Ganie, finding no prima facie right in his

Setting aside the revenue orders, the High Court reiterated that once a civil dispute is seized by a competent court, parallel proceedings by subordinate authorities cannot be permitted to create prejudice or influence the outcome of the judicial process.

"The Tehsildar, despite being fully aware of the pendency of the civil suit, proceeded to decide the matter unilaterally," the court said, adding, "Such conduct is squarely barred by the doctrine of res sub judice, also by the settled principle that subordinate authorities cannot pass orders which may prejudice or interfere with the adjudication pending before the civil

# Injecting Drug Use, Stigma Fueling HIV Spread, Say Doctors

SRINAGAR: Once considered a low-prevalence region, Jammu and Kashmir is witnessing a slow but steady rise in HIV cases, with health professionals calling for urgent awareness, wider testing, and a decisive push to end stigma.

As per details obtained by KNO, 2,071 new HIV cases and 66 AIDS-related deaths have been recorded in the Union Territory since 2019.

Although the overall adult prevalence in J&K remains among the lowest in the country, hovering between 0.03% and 0.06% in recent years, the numbers reflect that infections continue to occur, especially among high-risk groups such as people who inject drugs.

Doctors said the new figures underline a pattern they have been observing quietly for years. "J&K is not a high-burden state, but the upward trend is undeniable. Each new infection is preventable, and each delay in testing has consequences," said a senior physician, requesting anonymity.

Another infectious-disease expert at a government medi-

cal college in Srinagar said that late diagnosis remains common. Many patients, he said, walk in only when their immunity is severely compromised. The reason is stigma and misinformation, he said. "If people felt safe coming forward, we would catch infections early and prevent most AIDS-related deaths."

HIV (Human Immunodeficiency Virus) weakens the body's immune system. Without treatment, it can progress to AIDS, a stage where the immune system becomes unable to fight common infections.

It mainly occurs due to unprotected sexual contact, sharing needles or syringes, mother-tochild transmission during pregnancy, childbirth, or breastfeeding, and rarely, contaminated blood transfusion where proper screening is absent.

According to doctors, modern antiretroviral therapy (ART) allows people with HIV to live long, healthy lives, and those who take ART regularly and achieve viral suppression cannot transmit the virus sexually.

Health workers said the most vulnerable group in J&K is people who inject drugs (PWID). 'Sharing needles is one of the most efficient ways for HIV to spread. Even one shared syringe **J&K IS NOT A HIGH-BURDEN** STATE, BUT THE **UPWARD TREND**

can transmit the virus," said a senior community-medicine specialist.

Experts outline five pillars of HIV prevention, all of which need strengthening in J&K: early testing and linkage to ART, safe sexual practices, harm reduction for PWID (such as needlesyringe programmes and opioid substitution therapy, which are proven to reduce transmission but remain limited in reach), testing pregnant women and providing timely ART to protect newborns, and community outreach and awareness.

"People still fear being judged more than they fear the disease itself," said a psychiatrist involved in HIV counselling. "Stigma pushes the virus underground. It stops people from get-ting tested, hides cases within families, and delays treatment." He added, "Many people

wrongly believe HIV spreads through casual contact - sharing food, shaking hands, or sitting together. These myths isolate patients and damage public health."

Health experts said that HIV is now a treatable medical condition, not a moral issue, and must be approached with empathy. "If we want to reverse the trend, we must normalise HIV testing," said one ART consultant. "Make it as routine as checking blood pressure, and we will catch cases before complications begin."

Despite the rise in numbers, doctors said that J&K can prevent a larger outbreak if it acts "We have the medical tools - ART, testing, and prevention programmes. What we lack is openness," said a senior physician. "The message must be simple: HIV is not something to hide from. It is something to treat."

Addressing the officers, the Div Com stressed the importance of completing all ongoing works within the stipulated timelines. He further directed them to submit revised expenditure details for extended works and ensure timely submission of bills for clearance of liabilities.

#### **Two-Storey Building Sealed** in Sonawari Drive

The Sub-District Administration Sonawari in North Kashmir district on Monday sealed a two-storey shopping complex at Shadipora in Bandipora district, citing alleged encroachment on state-owned Shamlaat land, officials said.

According to KNT, the revenue officials said the structure was found to have been raised illegally on government land and the sealing action was taken to prevent further unauthorised construction. The move comes days after a similar complex in Bandipora town was sealed as part of a wider anti-encroachment drive launched by the

The owner of the complex, contested the action and claimed that a portion of the land belongs to him legally. Speaking to reporters, the owner said he approached both the district administration and the divisional administration after receiving a notice. He claimed that out of the total land, 3.5 marlas are his proprietary property and

urged authorities to demarcate his portion. He said he has no objection if any section of the building is found to be on state land but insisted that his legally owned land should be clearly identified and excluded from sealing. Khan also questioned why no objection was raised by officials when the building was being constructed. He alleged that the sudden sealing pointed to administrative failure during earlier stages of construction and called for a transparent inquiry.

When contacted, officials did not provide an on-record response. The Sub-Divisional Magistrate Sumbal directed queries to the Tehsildar Sumbal, while the Tehsildar advised contacting the Deputy Commissioner Bandipora. Deputy Commissioner Indu Kanwal Chib, however, declined to comment over the phone. (Observer News Service)

## **FDA Boosts Food Safety Surveillance in 2025**

**JAMMU:** Concerned by ing the availability of safe and hygienic food across Jammu and Kashmir, the Food and Drug Administration (FDA) has conducted 13,944 routine inspections in 2025, leading to case registrations, prosecutions, and imposition of penalties against violators. During the inspections,

the FDA collected 10,620 surveillance against the annual target of 7,080 samples, FDA Commissioner Smetha Sethi said.

The department had achieved more than 150 per cent of the target as compared to last year, reflecting its strong commitment to consumer safety. She said food safety officers also carried out 1,423 risk-based inspections Union Territory in addition to routine checks.

"To ensure infrastructure and hygiene compliance, 943 Improvement Notices were issued to Food Business Operators (FBOs) under Section 32 of the FSS Act, surpassing the target of 625 notices," Sethi

The Food Safety and Standards (FSS) Act, 2006, establishes the Food Safety Standards Authority of India (FSSAI) for laying down science-based standards for articles of food and to regulate their manufacture, storage, distribution, sale and import, to ensure the availability of safe and wholesome food for human consumption.

Under the civil adjudication process (Section 30), a total of 718 prosecutions were launched, of which 671 cases have already been decided, resulting in

84.33 lakh, she added. Besides, 21 criminal cases involving unsafe food were filed, with convictions secured in 10 cases, including fines and imprisonment.

Giving details of special enforcement drives conducted in November, Sethi said a focused drive on ghee resulted in the seizure of 80.78 kg of stock. "Of the 41 samples tested, 12 failed quality standards, following which prohibition orders were issued against the manufacturers".

According to PTI, the information has been shared with the FSSAI and the concerned states, including Httar Pradesh Harvana and Gujarat, for action at the source, she said.

Sethi further said that during the Poly Pack Milk drive, 95 samples were tested, of which only two failed, indicating a high level of compliance, while the test results for the 32 samples of the packaged drinking water are awaited.

On infrastructure expansion, the commissioner said proposals have been submitted for setting up two additional state-ofthe-art food testing laboratories and procuring 10 more "Food Safety on Wheels" mobile vans to improve outreach and surveillance, especially in remote and rural areas

the current status of traffic improvement initiatives, the Divisional Commissioners outlined the steps taken in both cities, such as introducing diversions where required, setting up new roundabouts, installing traffic signals at strategic points, augmenting parking facili-ties, identifying no-parking stretches, earmarking dedicated bus stops, enforcing one-way traffic on congested routes and adjusting school and college timings. They further informed that dedicated corridors for eastern and western minibuses have been planned, honking zones are being regulated, additional charging points for Smart City electric buses are also going to be established here.

# India seal AFC U17 Asian Cup Berth

Rally to Stun Favourites Iran 2-1

**AHMEDABAD:** An indomitable Indian football team staged a remarkable comeback to stun overwhelming favourites Iran 2-1 in their last Group D qualifying game and seal a place in the 2026 AFC U17 Asian Cup here on Sunday.

The Blue Colts had achieved what looked, for long stretches of the match, almost impossible thanks to goals from Dallalmuon Gangte (45+1' penalty) and Gunleiba Wangkheirakpam (52') at the EKA Arena.

This was after Amirreza Valipoor put the visitors ahead with his 19th-minute strike.

The next U17 Asian Cup is to be held in Saudi Arabia, and it will be India's 10th appearance in the tournament.

Iran, with seven points, entered the match as favourites, unbeaten and needing only a draw to progress. India, on four points, needed nothing less than a win.

And when Valipoor struck first, calmly finishing after a defensive misjudgement, the task appeared to loom even larger. But this young Indian side refused to accept their fate.



First, they equalised through Gangte when the forward converted a penalty before Wangkheirakpam netted the winner.

The victory meant that India climbed to seven points, level with Iran but ahead on head-to-head and enough to secure qualification against a powerhouse of Asian youth football.

The early narrative belonged to Iran.

They pressed sharply, moved the ball fluidly, and forced India goalkeeper Rajrup Sarkar into two crucial saves, first tipping away a long-range effort from captain Mahan Beheshti in the 10th minute, then punching out a fierce volley from the same player moments later after Jafar Asadi carved through on the left.

Iran looked ruthless, composed, and in command.

Yet India hung in, never allowing panic to creep in despite Iran's territorial superiority. They tested the waters with speculative shots from distance and tried to break Iran's structure by shifting the ball quickly into the wide channels. Nothing seemed to pierce Iran's disciplined defensive line.

Then came the moment that changed everything.
