Ineligible Candidates Can't Claim Regular Posts Via Contractual Stints: HC

Srinagar: The High Court of I&K and Ladakh has held that an ineligible candidate cannot claim relaxation of eligibility criteria solely on the basis of having served on a contractual basis for some time.

A Division Bench of Justice Sanjeev Kumar and Justice Sanjay Parihar also emphasized that contractual engagement does not create any vested right to claim waiver of essential qualifications or to bypass the regular selection process mandated under Article 14

of the Constitution of India. The Court made the observations upholding its single bench's verdict, dismissing a plea filed by a candidate against who had challenged her disqualification from a recruitment process conducted by Sher-e-Kashmir University Sciences Agricultural Technology (SKUAST), Kashmir pursuant to adver-

tisement in 2015. The Division Bench noted that the candidate had applied for the post on the basis of a certificate claiming FMPHW diploma to be equivalent to a Nursing Diploma.

"The pleathatthe FMPHW certificate should be considered equivalent to "Diploma in Nursing" cannot be accepted for the simple reason that the qualifi-

cation prescribed for the post of Female Nurse is Diploma in Nursing only and not any othqualification equivalent thereto," the court said. In absence of any

such stipulation in the qualification, the court said, the reliance placed by candidate on the "so called equivalent qualification is totally uncalled for and not permissible under law".

Kashmir Industrial Estate Stalled Over Flood Risk

Environmental tribunal questions whether a new industrial estate in Shopian sits on land meant to carry floodwaters.

Srinagar: India's top environmental court has put the brakes on a multimillion-dollar industrial project in Kashmir after an activist warned that building factories on the edge of the Rambiara River could spell disaster for villages downstream.

On Wednesday, a three-judge bench of the National Green Tribunal issued formal notice to the Jammu and Kashmir government, asking officials to explain why they approved a 500-kanal (about 63-acre) industrial estate



in Trenz village, Shopian district, on land the petitioner says lies squarely in the river's natural

floodplain.

The petition was filed by Raja

Muzaffar Bhat, a well-known

Kashmiri RTI activist. He argues that the site chosen by the Jammu and Kashmir State Development Industrial Corporation is barely 30 meters from the riverbank and sits in the exact path where high floodwaters spill during the rainy

"If this estate comes up, it will act like a dam on one side of the river," Bhat's lawyer, Saurabh Sharma, told the bench headed by Justice Prakash Shrivastava.

The water will have nowhere to go except across the opposite bank, drowning homes, farms,

and the famous apple orchards that feed dozens of villages in Shopian and Pulwama." Sharma pointed to the dis-

trict's own draft disaster management plan, which openly states that one-third of Shopian is vulnerable to floods and flash floods, especially along the Rambiara and nearby streams.

The document lists past flooding events and marks the season from April to August as "likely" for major inundation.

Study Reveals How The Brain Evolves Through Five Distinct Stages

The human brain goes through five major eras of structural changes over a lifetime -- marked by turning points at ages nine, 32, 66 and 83 -- as it rewires to support varied ways of thinking as one grows, matures and ultimately declines, a study has suggested.

Age nine is when communications between brain networks developed since birth transition to the adolescent phase, which then lasts up to age 32, researchers led by those from the UK's University of Cambridge explain. Early thirties is when the brain's neural wiring shifts into "adult mode" -- the longest era lasting over three decades and marked by a stabilising of the brain's architecture. Age 32 is also the "strongest topological turning point" of the entire lifetime, they said. Age 66 was found to signal the start of an "early ageing", and age 83 that of a "late ageing" stage of brain structure.

The findings published in the journal Nature Communications "help us understand why some brains develop differently at key points in life, whether it be learning difficulties in childhood, or dementia in our later years," lead researcher Alexa Mousley, a graduate student at the University of Cambridge's cognition and brain sciences unit, said. 'These eras provide important context for what our brains might be best at, or more vulnerable to, at different stages of our lives," Mousley said. The lead researcher added that the study is the first to identify major phases of how brain wiring changes

across a human's lifespan. "We know the brain's wiring is crucial to our development, but we lack a big picture of how it changes across our lives and why," said Mousley.

The study analysed the brain structure of 3,802 people, aged zero to ninety, using datasets of magnetic resonance imaging (MRI) diffusion scans, in which connections are mapped by tracking how water moves through brain tissue. 'We identified four major topological turning points across the lifespan -around nine, 32, 66, and 83 years old. These ages defined five major epochs of topological development, each with distinctive age-related changes in topology," the authors wrote.

The childhood era of the brain is defined by "network consolidation" as synapses -- junction between two brain cells or neurons -- overproduced in a baby's brain are whittled down, with the more active ones surviving, the researchers said. At age nine, the brain is experiencing a step-change in cognitive capacity and an increased risk of mental health disorders, they said.

Communication across the brain's networks is increasingly refined during the adolescence era -- post age nine up to early thirties. White matter continues to grow in volume and efficiency of connections increases, and is related with an enhanced cognitive performance, the team said.

Untraceable Bear

Public Cautioned Amid Ongoing Evening Sightings

Srinagar: A bear, first sighted inside the Kashmir University campus, has triggered alerts across several localities on the outskirts of Srinagar after being repeatedly spotted in areas including Soura, Habak, NIT and Nigeen over the past few days, prompting the Wildlife Protection Department to advise people to remain vigilant.

An official from the Wildlife Department told the news agency Kashmir News Trust that the animal has been primarily seen during the evening hours and is believed to be moving through different parts of the city's outskirts under the cover of darkness. During the daytime, however, the bear has remained untraceable.

"The bear has been observed mostly in the evening hours. During the day, it hides somewhere. Our teams are alert and deployed in suspected locations," he said.

The official said that despite sustained search operations for several days, field teams have not come face to face with the animal so far. "We have not physically sighted the bear during our operations. So far, its movement has only been confirmed through CCTV footage installed in various localities," the official said.

According to KNT, authorities are yet to determine whether the sightings involve a single bear or more than one animal. "At this stage, it is not clear whether it is one bear or multiple bears. Investigation and tracking are ongoing," the official added.

In view of the situation, the Wildlife Department has urged the public to remain alert, especially during evening and night hours, and avoid venturing into isolated or poorly lit areas. People have also been advised to inform the department immediately if the animal is sighted in any locality.



Nowpora Fire Guts 5 Houses, Leaves 4 Orphaned Sisters Homeless

Srinagar: A destructive fire swept through Nowpora, Srinagar, on Wednesday afternoon, leaving five homes damaged and families grappling with sudden loss.

Officials said the fire began in the attic of one house and quickly spread to neighboring homes, sending thick smoke across the area. The fire call was received at "By the time we arrived, three

inter has turned bitter, and the capital of Kashmir feels different. Streets have fewer people, hotels are emptier, and many families are seeing their incomes shrink.

Those who once depended on tourism or small businesses are finding it harder to make ends meet, unsure when the next source of income will come.

Carpet weavers, pashmina makers, wood carvers, and papier-mâché artists have fewer orders, and work that once gave them pride and purpose is now hard to find.

Young people are feeling the pressure too. Many educated youth cannot find jobs, and government positions that once offered stability are hard to come by. Small shops, restaurants, and home-based businesses are shrinking, leaving families to adjust however they can.

Some take loans to get by, some leave the city to find work elsewhere, and others stay, hoping opportunities will return.

nside Government Middle School in Budgam district, Grade VI children wait for their first class. They whisper, fidget, and look toward the door.

Ten minutes go by, then twenty. Their science teacher still does not come.

A boy shrugs and says what everyone already knows: "Sir will come after the meeting." He is right.

The man is twenty kilometres away, signing a petition at the Deputy Commissioner's office because a teachers' forum booked the 9am slot. After that he must reach the District Institute of Education and Training office for a second roll call held by the Rehbar-e-Taleem group.

By the time he returns, the last period is over and the kids have walked home. Children here learn early

that "meeting" is just another word for empty classroom.

Kashmir runs 18,724 govern-

kasnmir runs 18,724 government schools for 13.6 lakh students. One in every four has fewer than twenty pupils. UDISE+2025 lists 119 schools that have zero children, but every one still draws full staff salaries.

The excuse is always the same: "We are on official duty." In plain words, duty means another meeting.

Headmasters have stopped pretending. A school in South Kashmir pinned a note to its gate last week: "No classes today, teachers attending federation work."

The federation came up in May with a push for quicker promotions. It has no office of its own, so it uses school buildings for its rallies.

Teachers say they have already lost scores of working days to its programmes since summer. Parents have run out of pa-

Parents have run out of patience.

Rubina Jan of Budgam sold her gold bangle and moved her daughter to a private school that charges Rs 1200 a month. "At least the teacher is there every morning," she says. She is not alone.

ASER 2024 tested simple reading in 1,600 valley villages. Only 24% of Grade V children in government schools could read a Grade II story. In private schools the rate was 79%.

The difference is seat time: private teachers stay inside class-rooms while government staff sign registers.

Dropout numbers follow the same curve. Primary pupils leaving mid-year have climbed from 3.89% in 2023 to 6.2% this year.

Forums were born to fix small problems. One asked for timely salary, another for transfer transparency. Each carried a catchy slogan: "Students First," "Quality for Every Child."

The slogans are still printed on banners that now hide empty corridors. The Government school school mentioned earlier has four separate banners hanging above its gate. None of them belongs to the school.

The department keeps a list of recognised bodies. The list runs to 63 names and covers three pages. No one can explain why a zone with six schools needs twelve associations.

The only clear rule is that every new body demands representation on every committee, which means more trips to the district headquarters.

A Zonal Education Officer showed his diary for October: 37 meetings in 22 working days. The topics ranged from "eco-club logo design" to "winter uniform colour shade."

Each meeting required at least two teachers from every school. "I sign attendance sheets faster than lesson

plans," he admits.

The damage moves downstream. Children left with substitute staff lose interest and stay away. When attendance falls below fifty percent for three months, the state merges the school.

Since 2022, 4,400 tiny institutions have been shut, most of them in remote areas where a walk to the next village means crossing a mountain stream.

The closures save money on paper, but they push girls out faster because parents will not risk the longer journey.

The solution is simple. Treat teaching hours as sacred. Make biometric attendance record public online. Any teacher who misses more than fifteen days without a valid reason loses a day's pay. Finland did the same and kept teachers in class for 190 days a year without spending an extra rupee.

Second, move every grievance online. Salaries, transfers, pension papers can be tracked through a single dashboard. No teacher should travel for a signature that a mouse can give.

Third, cap the number of associations. One forum per zone, elected for two years, with a written constitution that puts classroom time above protest time. Any rally during school hours should trigger automatic suspension of the office bearers.

Kashmiri students have already lost too much to lockdowns, street shutdowns and network bans. They cannot afford to lose the one place that still promises a way out: the classroom.

The next time a bell rings and a teacher is missing, the question is simple. Who sent him away, and who will bring him back?

Kashmir Needs a New Political Culture

ublic life in Jammu and Kashmir moves in a cycle that leaves people drained of hope.

Every election brings a wave of trust. Villagers open their doors, shake hands with candidates, listen to long speeches on employment and development, and keep faith that this time will be different.

Once the results come, the distance returns.

Phone calls are ignored, letters remain unanswered, and the every-day voter disappears from the frame until the next polling day. Many Kashmiris feel that their value ends with the ink mark on their finger.

This growing gap between elected leaders and citizens has weakened the democratic spirit of our region.

I still remember my days in Punjab, where an MLA from a ruling party studied his Ph.D. with us. He lived like any student, moved without escorts, waited in lines, and spoke to

everyone with ease. There was no show of rank in his behaviour. That memory often returns when

I see how power is displayed in Kashmir.

A person who wins a seat suddenly expects deference. The idea of a representative slowly shifts into the idea of a ruler. For a poor person who needs help, meeting an MLA often means spending an entire day outside a gate for a brief moment of attention. Even that moment depends on which party he supported.

This practice has turned public service into a form of punishment for those who stand outside the circle of influence.

Political favouritism has pushed the youth into despair. Students with postgraduate degrees line up for exams, interviews, and endless verification rounds, while those with political backing walk into jobs meant to be filled through merit.

This unfairness does more than

delay careers. It delays marriages, divides families, and forces many young people into long spells of joblessness that shape their confidence and choices. A region with some of the highest unemployment numbers among educated youth cannot afford a system that rewards loyalty over talent.

The signs of misgovernance are visible in everyday life. Leaders who once lived simply now occupy spacious homes. Their children travel abroad and study in private universities while many parents in Kashmir struggle to afford school books.

Funds meant for local works rarely reach the classrooms, roads, and health centres that need them.

The flow of money slows as it rises through layers of influence, reducing public welfare to a distant idea instead of a lived reality.

Politics, at its core, is supposed to be an act of service. A leader should be accessible, humble, and ready to

absorb the concerns of those who elected him.

Kashmir needs representatives who travel the same roads as the people, listen without judgement, and understand that their seat is an amanat.

A democracy grows strong only when leaders stay close to those who trust them with their future.

The people of Kashmir deserve a political culture that heals. Progress will come when service replaces status and empathy guides decisionmaking.

Until then, the cycle of disappointment will continue and the common citizen will carry its weight.

A Winter of Wild Alarms in Kashmir

A roaming animal becomes a symbol of a valley where forests and people struggle to find space.

■he bear arrived in Srinagar like a restless traveller who refused to read the season. It should have curled into a den somewhere in the upper forests by now, locked inside the long winter sleep that makes the cold easier to

Instead it roamed the city with a strange energy, slipping through campuses, brushing past boundary walls, leaving half-seen shadows on security cameras, and finishing its nights with a swim in the chilled waters of Nigeen.

People spoke of it with nervous jokes in daytime markets, then lav awake after sundown, listening for the scrape of claws on tin roofs.

Wildlife officers spent night after night tracing it through lanes that usually host students, shopkeepers and caretakers, instead of a hulking animal shaking droplets from

They said the bear seemed confused, not aggressive, as if pushed downhill by forces larger than in-

Word of the bear moved through the city like whispered gossip. Parents kept their children close, and hostel gates clanged shut long before dusk. In Hazratbal and Naseem Bagh, guards who used to watch for stray dogs now tracked a larger, stranger presence, a figure that might vault over walls without

The story of this bear does not stand alone. It folds into a broader tale that has been unfolding across the valley for years: a slow and steady drift of wild animals toward human life.

Official data up to March 2024 records 264 deaths and more than 3,100 injuries from wildlife encounters over nearly two decades. Assembly figures for 2023-24 and 2024-25 each list 16 deaths.

Every district has lived through its share of shock: a maize field raided in Budgam, a leopard spotted under a streetlight in Kulgam, boar tracks found in Sopore and

These incidents trace back to the forests, where the pace of change has quickened.

Jammu & Kashmir has seen a surge in wildfires, with estimates for the 2024-25 fiscal year cross-

ing a thousand. Hillsides that once held thick undergrowth lie scorched, turning safe shelters into exposed slopes.

When fires run through a forest, herbivores rush for escape, and predators follow the trail of movement. The chain ends in orchards, lanes and backyards that cannot absorb this sudden arrival.

There is another layer to the problem.

Forests have been clipped at the edges over the years through new roads, expanding suburbs and sanctioned clearances. Movement corridors that once guided animals seasonally have been broken into small, confused patches.

In these fractured spaces, a leopard can wander into a nursery school, drawn by the scent of dogs or livestock. A bear can stumble into an abandoned storage shed, searching for food where none exists.

These animals are responding to a landscape where every familiar signpost has shifted.

Prey loss adds pressure. Deer numbers have thinned in many pockets. Predators respond in the only way they can: they widen their search.

Villages with open garbage pits, free-ranging dogs and unprotected livestock turn into easy targets. Wild boar, thriving across North, Central and South Kashmir, have become bold raiders of maize and apple fields. Farmers speak of nights spent guarding their land with torches and makeshift alarms, unsure of what they will find at

A single animal can ruin a season of crops, topple fences, injure livestock and disrupt livelihoods built on narrow margins.

Compensation, when it comes, takes time and paperwork. Families wait through long stretches of worry. Wildlife rescue teams work hard, though their resources seldom match the scale of the challenge. Officers often carry tranquilizers, nets and torches into terrain that needs stronger tools and larger

teams.

Forests need corridors restored and protected, not pieced together during emergencies. Springs need revival. Fire lines and early-warning systems must be strengthened. Waste near forest edges demands strict control so that animals do not treat dumps like open invitations.

Communities can shape solutions too. Small shelters for livestock, solar lights for orchard perimeters, neighbourhood alert groups and steady awareness programs can

Compensation must be faster and transparent. Farmers who feel heard are less likely to act in fear, which protects both people and

At the heart of this issue lies an appeal for understanding.

Governments have taken action through rescues, advisories and relocations. These steps help in the moment, though the rise in encounters shows that the crisis sits deeper.

teach English at HSS Salia, a school set among the or-L chards about twenty minutes from Anantnag town. Most of our students walk in from villages you won't find on many maps, including Hapatnar, Vail Nagbal, Halwan and Pethgoo.

On some winter mornings, it takes them close to two hours. The mud freezes stiff, the wind feels sharp, and they still keep walking.

Six years ago, the school was only holding on. The pass rate hovered around sixty-five. Many benches emptied out after Class 8, especially for the girls. Teachers finished their classes, locked the rooms and went home.

Then Zahida Ma'am arrived.

She was soft-spoken, always in a cream shawl, and she looked like someone who should have been resting instead of running a school. She had health issues she rarely mentioned, though it was clear some days were tougher than others.

Even then, she reached by eight, greeted Ghulam Hassan the sweeper first, and then the rest of us.


At her first staff meeting, she placed a blank sheet of paper on

Assembly speeches were my favourite. She never shouted. She'd talk about a boy from Halwan who got ninety-eight in math, or the cook who bought

his son a bicycle with overtime money, and suddenly every kid in the ground felt ten feet tall.

She treated everyone the same. Senior lecturer, Class-IV employee, and child who walked four hours received same respect.

Ghulam Hassan still keeps a note she once gave him: "Thank you for keeping our school beautiful. Your daughter's fees are taken care of this year."

IndiGo Cancels 100 Flights, Airport Chaos Boils Over

Mumbai– IndiGo cancelled more than 100 flights at various airports, and scores of services were delayed on Wednesday as the country's largest airline grappled with significant operational disruptions mainly due to crew shortages and announced calibrated schedule adjustments for the next 48 hours to normalise the operations.

As part of the calibrated adjustments, there will be cancellations and rescheduling of flights, sources said on Wednesday, a day when airports witnessed chaos as hundreds of passengers faced hardships due to services getting cancelled and getting delayed for long.

The airline, which operates around 2,300 domestic and international flights daily, on Wednesday said a "multitude of unforeseen operational challenges" have significantly disrupted its operations across the network for the past two days and apologised to the passengers for the inconvenience.

The challenges include "minor technology glitches, schedule changes linked to the winter season, adverse weather conditions, increased congestion in the aviation system and the implementation of updated crew rostering rules (Flight Duty Time Limitations), which had a negative compounding impact on our operations in

a way that was not feasible to be anticipated," an airline spokesperson said in a statement.

The sources said over 100 IndiGo flights were cancelled at various airports, including at Delhi, Bangalore, Mumbai and Hyderabad. At least 42 flights were cancelled at the Bangalore airport, 38 flights at the Delhi airport, 33 at the Mumbai airport and 19 at the Hyderabad airport, they added.

"IndiGo has been facing an acute crew shortage since the implementation of the second phase of the FDTL (Flight Duty Time Limitations) norms, leading to cancellations and huge delays in its operations acoust the airports," a source told PTI

J&K Has Rs 196.29 Crore Pending Liabilities Under MGNREGS: Centre

New Delhi: Jammu & Kashmir has pending liabilities of Rs 196.29 crore under the Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS), according to data presented in the Lok Sabha on Wednesday.

Responding to a question on funds owed to States under the scheme, Rural Development Minister Shivraj Singh Chouhan said the Union Territory has dues of Rs 5.48 crore under the wage head, Rs 188.50 crore under material costs and Rs 2.31 crore under administrative expenditure as on November 26, 2025.

The Minister said wage payments are issued daily by the Centre through the Public Finance Management System (PFMS) after receiving fund transfer orders from States and UTs.

He added that all admissible wage liabilities up to FY 2024-25 have been cleared across the country, except in the case of West Bengal.

On the release of funds for the

On the release of funds for the current financial year, Chouhan informed that rupees 68,393.67 crore has been disbursed nationwide under MGNREGS as of November 26, 2025, including rupees 57,853.62 crore for wages and rupees 10,540.05 crore for material and administrative expenditure.

He noted that funds for material and admin components are released in tranches based on factors such as labour budgets, work demand, pending liabilities, utilisation rate and submission of relevant documents by States and UTs.

Data tabled in Parliament also shows that Jammu & Kashmir received Rs 1,151.20 crore under MGNREGS in 2024-25, compared to Rs 921.60 crore in 2023-24, Rs 1,051 crore in 2022-23 and Rs 950.14 crore in 2021-22.

The minister also stated that funding to West Bengal remains suspended since March 2022 due to non-compliance with directives issued by the Centre. (KNO)

The committee had advised that other vertical reservation categories, including ST I, ST II, Scheduled Castes, Other Backward Classes and Actual Line of Control or International Border residents, should remain untouched.

The revised proposal will now be forwarded to Lieutenant Governor Manoj Sinha for approval. Under the rules governing the Union Territory, the LG will have to seek the Centre's view if the changes impact minorities or reserved communities.

At present, ST I, ST II, RBA and EWS each hold ten percent reservation. Scheduled Castes and OBCs each have eight percent, while ALC or IB residents have four percent. Once approved, the Open Merit category is expected to rise to fifty percent of vertical reservation.

Political reactions
Opposition parties have not issued formal
statements so far. The BJP said it will respond
only once the proposal is made public.

"It would be premature to comment at this juncture," party spokesperson Sunil Sethi said. National Conference MP Aga Ruhullah Mehdi, who has been demanding rationalisation of reservation, could not be reached for comment.

People's Conference chairman Sajad Gani Lone, however, alleged that the government is creating divisions within Kashmir.

"In the reservations issue, the elected government is passing on the buck and trying to create a wedge in the Kashmiri ranks," Lone wrote on X. He added that the Assembly can restore district and divisional recruitment through legislation if it chooses to act.

The Cabinet decision comes after months of debate over reservation expansion in the Union Territory following the Centre's recent additions to reserved categories.

naming anyone, Omar said those who were accusing them of doing nothing on the

reservation are now threatening agitation. "It is easy to do politics on the issue. Those who were taunting us, saying that we had done nothing on reservation, are now saying if you do this, we will launch an agitation," he said.

The issue of reservations has gained prominence in Jammu and Kashmir after the central government expanded quotas and added more communities to reserved categories over the past five years. The push to raise the reservation quota to 70 percent, including a separate ten percent quota for Paharis and other tribes and an eight percent quota for OBCs, has triggered objections from various groups.

Omar confirmed that the reservation policy was one of twenty two agenda items discussed during the meeting. Other items included construction of a new Kashmir House in Dwarka, appointments of chief engineers in the roads and buildings department and steps to revive cooperative societies.

Last December, the government set up a Cabinet sub committee to examine grievances related to the existing reservation system. The panel submitted its report in October followed by a detailed review by the law department.

Omar said the process required time because the issue invites political sensitivities. He said the Cabinet held multiple rounds of consultations before finalising the proposal.

He asserted that the decision was taken in the interest of the people of Jammu and Kashmir rather than to satisfy any individual leader. He added that critics who earlier accused the government of inaction are now threatening protests.

National Conference MP Aga Syed Ruhullah Mehdi had recently urged the government to settle the issue before the end of the Winter session of Parliament and warned that he would support quota protests if no solution was provided.

For damage to immovable property caused by blasts or sabotage, compensation will be 50 percent of the assessed loss or Rs 1 lakh, whichever is less. Where actual loss is up to Rs 10 lakh, relief has been capped at Rs 7 lakh for immovable assets and Rs 3 lakh for movable property. Loss due to shelling or firing will also be compensated at 50 percent of the loss or Rs 1 lakh.

Officials said the consolidated order replaces fragmented earlier instructions and standardises payouts under SRE across the Union Territory.

JAMMU: Jammu and Kashmir Chief Minister Omar Abdullah on Wednesday said his government is committed to ensuring full transparency and a simplified process in compassionate appointments.

He also reiterated his government's commitment to clearing the backlog of compassionate appointments under SRO-43 and the Rehabilitation Assistance Scheme (RAS).

Abdullah was speaking at a function organised at the Convention Centre here where he handed over appointment orders to candidates under SRO-43 (Statutory Rules Order-43) and RAS-2022, besides issuing regularisation orders to Contingent Paid Workers (CPWs) of the School Education Department.

The chief minister, who is also the minister in charge of the General Administration Department. assured the beneficiaries that the government is determined to clear the backlog of cases under SRO-43 and RAS-2022.



"As far as the orders of SRO-43 are concerned, I assure you that we will try our best to dispose of the pending cases. We will grant relaxation in cases as per the norms and make this process as

transparent as possible," he said. Expressing deep empathy with families who approach the government during their most difficult hours, Abdullah stressed that compassionate ap-

The camps aim to provide citizens with one-stop access to guidance, verification and on-the-spot support for claiming unclaimed bank deposits and other inactive financial holdings. Officials from banks, insurance companies, SEBL PERDA, LIC. IEP-FA, district administrations and the RBI will participate across all four districts.

The Lead District Office Ganderbal will organise its Mega Facilitation Camp at Govt Boys Higher Secondary School Ganderbal at 11:00 AM. Representatives from banks, insurance bodies, SEBI, PFRDA and IEPFA will assist participants with guidance and on-thespot claim processing. The MLA, District Development Commissioner, RBI officials and senior bankers are also expected to join.

World Disability Day

Parents Plead for Special Schools in J&K

SRINAGAR: As Jammu and Kashmir marks World Disability Day, parents of specially-abled children have once again highlighted a longstanding concern—the acute shortage of special schools across the Union Territory, a gap they say is depriving their children of quality education and essential developmental support.

Speaking to KNO, several parents expressed frustration, saying that despite repeated appeals, dedicated educational facilities for children with special needs remain virtually non-existent in most areas. They lamented that children are losing precious years due to missing infrastructure.

Parents said the absence of accessible, disabilityfriendly education centres forces many children to remain confined to their

Nelofar Akhter, a mother from south Kashmir said countless families like hers struggle daily. "There are so many specially-abled children who simply cannot attend school because there are no special schools

nearby," she said. Akhter added that her own son would also have remained out of school had it not been for Zeba Apa School in Bijbehara, an institution started by Javed Ahmad Tak, a Padma Shri awardee who himself is

physically challenged. "If this school hadn't existed, my child would have been at home like many others. There are no government-run special schools that offer such support," she added. Other parents said that Abhenandana Home in Srinagar is the only prominent facility available, but it cannot meet the needs of children across the entire Union Territory.

Parents said that children admitted to Abhenandana Home often require a family member to stay with themsomething not feasible for most families from far-off districts. "Not everyone can shift to Srinagar to look after their child. We need schools closer to home," a parent from Pulwama said.

To ease the burden on families, parents suggested that special schools should be established at the tehsil level, ensuring accessibility and reducing travel difficulties and dedicated colleges for differently-abled students should be set up at the district level to open pathways for vocational and higher education.

Creating such infrastructure is essential for helping children with disabilities become self-reliant and confident contributors to society, they said.

Meanwhile, Abhenandana Home Higher Secondary School, Solina Rambagh, run by the Department of Social Welfare, Kashmir, marked World Disability Day with a vibrant and inspiring event.

The programme featured a historic moment as deaf and mute students performed the national anthem in Indian Sign Language for the first time in Kashmir, drawing emotional applause from the audience. Students also presented cultural performances, including a Ladakhi song and a drama, all in sign language.

Kashmir's Specially-Abled Decry Stigma Observer News Service

SRINAGAR: Several specially-abled persons on Wednesday said that despite the promises and schemes announced over the years, their lived experiences tell a completely different story.
"It is painful that on a

day meant for acknowledging us, we are compelled to raise our voices for basic rights," they said. "If we had been truly empowered, we would have been celebrating this day instead of complaining for

They lamented that the guarantees under the Persons with Disabilities Act, 2016, remain largely unimplemented in Kashmir. "Prime Minister Narendra Modi launched the Accessible India Campaign with much fanfare, but on the ground, barely anything changed. A few token works were done here and there, and most funds lapsed without meaningful

results," one of them said. According to KNO, many accused the government of failing even in ensuring that newly constructed buildings have mandatory accessibility features like

ramps, lifts, tactile paths, disabled-friendly washrooms. such facilities, we are being pushed further to the margins," they added.

Another major concern raised was the lack of special educators, accessible classrooms, and teaching materials in schools. "How can children with disabilities pursue education when the system itself is not inclusive? The four per cent job reservation for disabled persons also exists only on paper," one speaker pointed out.

"Society still hides us," said Sania Jan, a specially-abled woman from Srinagar. She said the challenges begin right at home. "Many parents hesitate to put effort or money into the education of children with disabilities. Due to the lack of awareness, some children face emotional and even physical neglect," she said.

Sania said that social stigma remains deeply rooted: "Families hide their disabled children and avoid taking them to gatherings. People worry about what others will say. This discrimination isolates us even further."

Traffic Plan Rolled Out for Construction-Hit Jmu-Sgr Highway

Mughal and several officials from NHAI and the traffic police visited the affected site to assess the challenges on the ground.

Accrding to PTI, the officer said he had directed the traffic police to exercise utmost care and responsibility to ensure that two-way traffic is not hampered by the construction and installation of signage, particularly of 'no overtaking' at vulnerable points along the 270-km road. Mughal also inspected other congestion points on the highway, the only all-weather road linking Kashmir with the rest of the country. (Observer News Service)

Sikh Body Demands One-Time Quota

he All Parties Sikh Coordination Committee (APSCC) on Wednesday demanded a one-time reservation for the Sikh community in Jammu and Kashmir.

The committee chairman, Jagmohan Singh Raina, said the reservation in jobs and education should be given to the people who really deserve it, and it should not be a continuous process.

"Facts and provisions should be sorted out meticulously so that merit holders do not suffer and the maximum share should be for the majority community," Raina said in a statement here.

"It has been observed that a person gets the benefits of reservation on multiple fronts. The process needs to be changed, and it should be the prerogative of the candidate to avail the reservation benefits at the education level or at the job level.

"Once a youth avails the benefits of reservation, the process should be stopped forthwith. It is not just to extend the benefits of the reservation to the same youth time and again," he said.

According to PTI, Raina said that under the National Minority Act, Sikh is a minority community. Yet no quota for it is an injustice, he said, and accused the ruling National Conference of practising a "double policy." (Observer News Service)

SA Chase 359 Despite Kohli, Gaikwad Tons to Level Series

RAIPUR- Virat Kohli's 53rd ODI ton and Ruturaj Gaikwad's maiden century were eclipsed by a collective effort from South Africa in a steep run chase, giving the visitors a series levelling four wicket-win in the second ODI against India here on Wednesday.

Chasing 359, South Africa rode on a brilliant century from Aiden Markram (110), a brutal 34-ball 54 (1x4s, 5x6s) from Dewald Brevis and Matthew Breetzke's 68 to get over the line in another resilient effort with the bat.

The series-deciding third and final ODI will be played in Visakhapatnam on Saturday

India's job was far from done even after putting a daunting total on board as heavy dew in the second half not only made spinners' job tougher, but poor returns from Prasidh Krishna (2/79) did not help their cause.

Prasidh, who had broken a second-wicket century partnership earlier by dismissing Temba Bavuma (46), got it right finally to pin Breetzke leg-before late in the game, and soon after, Arshdeep Singh (2/54) removed the dangerous Marco Jansen (2), but Corbin Bosch (29 not out off 15) and Keshav Maharaj (10 not out off 14) took the Proteas over the line with four balls to spare.

Markram was in his elements utilising a flat deck under lights to notch up his maiden century against India and providing South Africa a heavy contribution from the top to push on

He took the initiative in the opening partnership and even though he lost Quinton de Kock (8) early with Arshdeep drawing first blood, Markram found a stable partner in Bavuma to put on 101 for the second wicket.

Markram had to remain the aggressor as Bavuma farmed the strike from the other end. Markram pierced gaps at will with brute force as well as some artistry.

He also hit through the line and over the bowlers' head to clear the ropes while using the feet well against Indian spinners, with heavy dew making their job even more difficult as the innings progressed.

But the opener also had luck favouring him when a powerful hit off Kuldeep Yadav towards long on saw the ball going through Yashasvi Jaiswal's hands for a six.

Had the catch been taken, Markram's charge would've ended on 53.

Markram eventually fell off a short offcutter from Harshit Rana (1/70) but his dismissal had Brevis and Breetzke teaming up,



who waltzed to 92 off the next 64 balls to put South Africa in complete control.

While Brevis fell after his quick fifty which featured some massive sixes, Breetzke made a composed 68 for a second consecutive half-century.

Incidentally, it was only the second occasion where India lost an ODI despite scoring in excess of 350, with the first instance being against Australia in March 2019 when they lost by a similar margin of four wickets despite making 358/9 at Mohali.

Earlier, Kohli's successive hundred, maiden century from Gaikwad (105) and KL Rahul's quickfire 66 not out propelled India to a formidable 358 for five.

Kohli (102 off 93 balls, 7x4s, 2x6s) and Gaikwad (105 off 83 balls, 12x4s, 2x6s) reset the record for highest third-wicket stand for India in ODIs against South Africa as their 195-run association built the platform for the hosts to launch themselves into a big score.

And Rahul's (66 not out off 43 balls, 6x4s, 2x6s) second fifty in a row ensured that, even as India continued to tinker with their batting line-up with the stand-in skipper coming in at No 5 ahead of Washington Sun-

dar, who endured another failure.

Unlike at Ranchi where he did not look accustomed to batting in the middle order, Gaikwad emerged a perfect foil for Kohli as the two began racking up runs with ease.

With Ajinkya Rahane in tow, Kohli had put on 189 at Durban in February 2018 but perhaps on some counts, this partnership with Gaikwad was the one he may have enjoyed a little more as the Maharashtra batter matched his style of play.

The rotation of strike was deft, the singles were seamlessly converted into doubles and at times it was difficult for one to distinguish who had pierced the gap for those runs — not necessarily boundaries — as Gaikwad even appeared to be matching Kohli in terms of stroke-play.

terms of stroke-play.

If he was roughed up at the start, Gaik-wad grew in confidence to post a fine half-century. Once past the milestone, he picked up pace.

Off the blocks with a perfect pull shot which sent the ball sailing over the ropes, it was yet another day in the office for Khli who did not put a foot wrong on way to a record extending 53rd ODI ton.

SA Cricket Trending Upwards: Shamsi

DUBAI: South African left-arm wrist-spinner Tabraiz Shamsi felt that their recent wave of success in international cricket, which included an away Test series win over India recently, is a sign of the Proteas landing their maiden ICC World Cup sooner than later.

South Africa reached the 2023 ODI World Cup semifinals, finished runners-up in the 2024 T20 World Cup and then clinched the World Test Championship title in June this year before whitewashing India 2-0 in the recently concluded away Test series.

Touching base with PTI on the sidelines of the fourth season of the ILT20, Shamsi, who is set to make his debut in the tournament for the Adani Sportslineowned Gulf Giants, said the progress has been gradual yet encouraging.

"You can see, probably since 2021-22, we started performing better and better in knockout



games. We got to the semifinals of the 2023 World Cup, then the final of the T20 World Cup in 2024, and then won the World Test Championship against Australia. As South African cricket, we've been trending upwards, and I'm really hoping that we lift our first World Cup very

soon," said Shamsi.
South Africa outplayed India on their own conditions with off-spinner Simon Harmer emerging as the top wickettaker with 17 scalps and was adjudged player-of-the-series.
Left-arm spin duo of Keshav

Maharaj and Senuran Muthuswamy have also done well in the recent past when SA held Pakistan 1-1 in another away

series.
Shamsi was delighted to see the rise of spin in the pace bowling heartland.

"Oh, unbelievable. It's been so many years of pain, especially for our Test team visiting India and being beaten quite comprehensively in the past. To see that the South African team has gone there and done so well, and especially seeing our spinners doing so well, that gives me a lot of joy because in past series the Indian spinners have given our batters a tough time.

"So for our spin bowlers to give the Indian batters a tough time... That was really nice to see. Of course, they have to be (the best in the world right now). Indian batters are very good at playing spin, in my personal experience, and for our boys to trouble them so much in their home conditions, of course they have to be the best trio."

New Zealand Leads West Indies by 96 Runs

CHRISTCHURCH: Shai Hope batted in sunglasses because of an eye infection but saw the ball well enough to compile his first test half century against New Zealand on Wednesday before the West Indies ended the second day of the first test trailing by 96 runs.

The West Indies were bowled out for 167 in their first innings, 64 runs behind New Zealand who reached 32 without loss in seven overs before stumps.

While it might have been incongruous to see Hope sporting large reflective glasses under his helmet in gloomy conditions, his innings of 56 stabilized the West Indies' first innings after the loss of two early wickets.

At the other end Tagenarine Chanderpaul labored diligently over a half century from 165 balls. A 90-run partnership between the pair helped the West



Indies towards parity with New Zealand whose first innings ended at 231.

The West Indies were 157-6 before a late rain shower forced players from the field. When they returned, the tail had to face the New Zealand pacers in fading light and the last four wickets fell for 10 runs. Jacob Duffy captured all four to finish with 5-34, his first five-wicket bag in tests.

New Zealand then had to bat again under darkening skies and reached 32 without loss with Tom Latham 14 not out and Devon Conway 15.

The accomplishments of Hope and Chanderpaul were magnified by the fact it was a day on which the ball constantly beat the bat, where runs had to be grafted for and bowlers explored all aspects of a batter's technique.
