

New Delhi: The Lok Sabha and Rajya Sabha were adjourned sine die on Friday, drawing curtains on the 19-day-long Winter Session of Parliament.

The Lok Sabha ended on an abrupt note amid Opposition protests on the passage of the VB-G Ram G Bill.

Rajya Sabha too was adjourned sine die after papers, statements and reports were laid on the table of the House.

Chairman C P Radhakrishnan read out a synopsis of the legislative and other business transacted during the 15-day sitting.

This was followed by the playing of the National Song, after which the Chair adjourned Rajya Sabha proceedings sine die.



# Court Extends NIA Custody Of Accused By 7 Days

Srinagar: A Delhi court on Friday extended by seven days the National Investigation Agency (NIA) custody of Dr Bilal Naseer Malla, an accused in the

Red Fort blast case. The court also remanded Soyab, a Faridabad resident accused of harbouring Red Fort bomber Umar-un-Nabi, to judicial custody for five days.

The NIA produced both the accused before the Patiala House Court under tight security after the expiry of their earlier four-day NIA custody granted on December 15.

Media persons were barred from covering the proceedings The accused were produced before Principal and Sessions Judge Anju Bajaj Chandna, who

allowed the probe agency to continue custodial interrogation of Dr Malla for seven more days. Soyab was sent to judicial custody till December 24. Earlier, an NIA

spokesperson Soyab, a resident of Dhauj in Haryana's Faridabad district, was arrested for allegedly providing logistical support to Umar-un-Nabi ahead of the terror bomb blast in Delhi.

### 'Red Gold' At Risk As Porcupines Destroy Saffron Corms

Srinagar: Already battered by the effects of climate change, saffron growers in Pampore and adjoining areas of south Kashmir's Pulwama district are facing a fresh crisis as porcupines destroy saffron corms on a large scale, raising serious concerns over further decline in production of Kashmir's prized crop.

Farmers warned that unless urgent preventive measures are put in place, saffron cultivation, which has steadily shrunk over



the years, could suffer irrevers-

Growers from Pampore, Konibal, Dusoo, Lethpora and surrounding villages told the news agency Kashmir News Observer that porcupines have been digging out saffron corms

almost every night, leaving fields damaged and future yields uncertain. The problem has intensified at a time when the availability of quality corms is already limited.

"Climate change has already disrupted our crop cycle. Irregular rainfall, warmer winters and prolonged dry spells have badly affected saffron," said Abdul Rashid Shah, a grower from Konibal. "Now porcupines are destroying whatever is left. Once a corm is damaged, there is no flowering. That means zero | More on P6

## 'Normalising Blood Glucose In Prediabetes **May Cut Cardiovascular Risk By Half'**

Bringing blood glucose to normal range through lifestyle changes could halve the risk of heart attack, heart failure and premature death among prediabetics, according to a study.

Findings published in 'The Lancet Diabetes and Endocrinology' journal show that remission of prediabetes -- achieving normal blood glucose levels -- may establish a new, measurable target for clinical guidelines, according to researchers.

A fasting blood glucose value of under 97 milligrams per decilitre proved to be a simple marker for a persistently lower risk of heart disease, regardless of age, weight, or ethnic background, the researchers said.

This threshold could be applied in primary care practices worldwide, making prevention more tangible, they added.

"Our results suggest that remission of prediabetes not only delays or prevents the onset of type 2 diabetes, as already known, but also protects people from serious cardiovascular diseases in the long term, over the span of decades," author Dr Andreas Birkenfeld, a board member of the German Center for Diabetes Research and medical director of the department of medicine at University Hospital Tübingen, said.

The team, including researchers from the US and China, analysed long-term data from more than 2,400 people with prediabetes. The participants' risk of cardiovascular death reduced by roughly 50 per cent, with a significant lowering of overall mortality.

The US study followed its participants for 20 years, while the China

one tracked participants for 30. Cardiovascular prevention has so far rested on three pillars -- blood pressure control, lowering LDL cholesterol, and smoking cessation. With the new findings, a fourth pillar could be added -- a sustained normalisation of blood glucose in prediabetes, the team

"Reaching prediabetes remission is linked to a decades-long benefit, halving the risk of cardiovascular death or hospitalisation for heart failure in diverse populations. Targeting remission might represent a new approach to cardiovascular prevention," the authors wrote. Birkenfeld said, "We see a clear therapeutic window: If glucose levels are normalised already at the prediabetes stage, the longterm risk of heart attack, heart failure and premature death can be markedly reduced." "Our data support explicitly anchoring remission as a primary treatment goal in guidelines for the prevention of diabetes and cardiovascular disease," the author said.

### **Winter Without Work**

inter has always been part of life in Kashmir. People expected it. They planned for it. Families saved money in summer, stored firewood, and slowed their work. Winter was tough, but it was familiar. It had a rhythm.

That rhythm is breaking.

Today, winter lasts longer, costs more, and leaves fewer ways to earn. For many families, the cold months are no longer just uncomfortable. They are risky. They push households closer to debt and distress.

From November to March, work fades. Construction slows, tourism thins, and street vendors disappear from the roads. Daily-wage workers sit at home, waiting for a phone call. Many earn nothing for weeks. Some earn nothing at all through the winter.

Heating is one of the biggest worries. Firewood is expensive and harder to find. Coal costs more than it once did. Electric heaters are common, but electricity bills are heavy. Power cuts last for hours, often at night, when the cold feels sharpest. Families gather in one room to stay warm. Children do homework under blankets. Elders cough through long, cold nights.

Money runs out fast.

A houseboat worker may earn well in summer but has no income in winter. A mason or carpenter cannot work when the ground is frozen. Shopkeepers open late and close early because customers are few. Debts grow silently. People borrow from relatives, shopkeepers, or local lenders, hoping summer will make things better.

But even summer feels uncertain now.

Snowfall is unpredictable. Sometimes it comes late. Sometimes it barely comes at all. This affects farming, water supply, and tourism. A weak winter no longer promises a good year ahead. The old rhythm of seasons no longer holds.

There are government schemes, subsidies, and promises. But help often arrives late, or not at all. Winter planning remains short-term. Each year, the cold returns, and each year, families struggle in the same ways.

This problem cannot be solved with sympathy alone. It needs planning. Kashmir needs reliable electricity in winter. It needs affordable ways to heat homes. It needs winter jobs, especially for daily-wage workers. It needs better systems to store fuel, food, and basic supplies before the cold sets in

Winter affects health, education, and peace of mind. When families spend months worrying about warmth and money, life grows smaller.

Kashmiris know how to endure winter. But endurance should not be confused with strength without support.

Winter will always be cold. It does not have to be this costly.

# **The West Wind Comes**

A mother's weather wisdom and the science behind the storms that shape winter life in Kashmir.

n winter afternoons in our home in south Kashmir, my mother would pause at the doorway and look up.

She did not need a phone alert or a forecast on television. She watched the poplars bend, felt the air turn colder on her face, and said the same line she had said for years: when the wind comes from the west, rain or snow will follow.

Soon enough, clouds would thicken over the mountains, and by evening the first drops or flakes would arrive.

I carried that sentence with me for decades as I walked this land, watched rivers swell and thin, and saw fields change colour with the seasons. Only much later did I learn the scientific name for what my mother described so plainly.

Meteorologists call them Western Disturbances, traveling storms born far away that decide how our winters unfold. The science added detail and distance, but it never replaced the truth of her words. It gave them another layer.

Western Disturbances begin over the Mediterranean and nearby seas, thousands of kilometers from Kashmir. They form as low-pressure systems and are carried east by high-altitude winds known as the westerly jet stream.

Along the way, they gather moisture, sometimes pulling more from the Arabian Sea. When these systems meet the Himalayas, the air rises, cools, and releases rain in the valleys and snow on the high slopes.


This process explains why Srinagar may see cold rain while Gulmarg turns white under the same sky. Elevation decides the outcome, and gravity does the rest.

For Jammu and Kashmir, these storms matter more than most people outside the region realize.

From October to March, when the summer monsoon is absent, Western Disturbances provide much of the rain and snow that sustain life here. Snow settles on the mountains like a savings account, released slowly as meltwater in spring. Rivers such as the Jhelum depend on this cycle, feeding farms, homes, and power stations.

A weak winter leaves streams low and fields anxious. A generous one brings relief that lasts months.

Long before satellites traced these



When the west wind rises now, I still hear my mother's voice. I also think of the long journey that air has taken, crossing seas and deserts before meeting these mountains. The snow that falls on a distant ridge, the rain that darkens a lane in the valley, and the rivers that swell weeks later are part of the same story. It is a story of movement and memory, of science and observation, written across the sky above Jammu and Kashmir.

paths across continents, people here learned to read smaller signs. Farmers noticed the smell of damp soil before a snowfall. Shepherds felt the wind shift against their backs while grazing animals high above the valley. Planting and harvesting followed these cues.

My mother's weather lessons came from standing in courtyards, listening to elders, and watching what happened year after year.

This was knowledge shaped by attention rather than instruments.

Modern science does not cancel this understanding. It sharpens it. Researchers like Sonam Lotus and Mukhtar Ahmad have mapped the routes of Western Disturbances and measured their strength with data drawn from decades of observation.

Their work explains why these storms sometimes arrive earlier or later, and why one winter buries mountain roads under snow while another passes with little trace. It also shows how warming seas and changing wind patterns are altering these systems.

Winters now bring greater uncertainty, with spells of heavy snow followed by dry stretches, or rain falling at times once reserved for frost.

These changes carry real consequences. Agriculture across the region depends on steady winter moisture for crops like wheat and mustard. Tourism relies on predictable snowfall in places such as Gulmarg and Sonamarg, where winter visitors support thousands of

families. Transport routes, including the Jammu-Srinagar highway, close more often during intense storms, cutting off supplies and travel.

Heavy snow raises the risk of avalanches in high terrain, while rain on unstable slopes leads to landslides that damage homes and roads.

The same system that sustains life can also disrupt it.

Climate change adds pressure to this balance. Studies show Western Disturbances growing more variable in timing and intensity as global temperatures rise. Warmer air holds more moisture, increasing the chance of sudden downpours or heavy snowfall in short periods. These shifts deepen existing vulnerabilities in the valley.

They also make the old signs harder to read. The wind still comes from the west, but its message has become less predictable.

Even so, the connection between lived experience and science remains strong.

My mother never spoke of jet streams or atmospheric pressure, but her observation captured the essence of a system that spans continents.

Science explains the mechanics, memory explains the meaning. One tells us how storms travel. The other reminds us what they do to people waiting beneath the clouds.

Kashmir has always lived close to

weather. Homes, crops, and daily routines bend around it. Listening carefully has been a form of survival. Today, that listening must widen.

Satellite images and climate models

Satellite images and climate models belong alongside the knowledge carried in kitchens and fields. Together they offer a fuller picture of what lies ahead.

When the west wind rises now, I

still hear my mother's voice. I also think of the long journey that air has taken, crossing seas and deserts before meeting these mountains. The snow that falls on a distant

ridge, the rain that darkens a lane in the valley, and the rivers that swell weeks later are part of the same story.

It is a story of movement and memory,

of science and observation, written across the sky above Jammu and Kashmir.

# Anxiety in Every Rupee

A look inside how the lack of basic money education shapes everyday anxiety and small awakenings in Kashmir.

ijaz Mir pushes his shikara into Dal Lake before the sun rises over the hills. On good days, tourists fill his boat and the tips are generous. On slow days, he counts every note twice. By evening, his thoughts turn to school fees, groceries and the long winter ahead.

He knows how to work hard. What he never learned is how to plan his money beyond the next few weeks.

When visitors ask about life on the lake, Aijaz talks about the water and the view. He does not talk about the stress of uncertain income or the fear of an emergency wiping out whatever little he has saved.

No one ever taught him how savings could grow or how planning could bring some peace.

In another part of Srinagar, Sana Aziz sits in her rented room after work, scrolling through her phone. She has a good degree and a steady job.

Every month, her salary arrives on time and disappears just as quickly. Rent, transport, family needs and medical expenses take their share.

expenses take their share.

She tells herself she will start saving next month. That month keeps moving forward

month keeps moving forward.

Aijaz and Sana live different lives, but they share the same problem.

They were taught how to study, earn and adjust. But they were never taught how money works. This story is quite common in Kashmir. People work long hours and make careful choices, but many live with

constant money worries. Schools focus on marks and degrees. Homes focus on getting through the month.

Conversations about budgeting, saving or investing rarely happen. Money remains something to man-

age by instinct.

Financial literacy sounds like a big term, but it is simple at heart. It means knowing where your money goes, how to

save some of it, and plan for the future.

It means understanding debt before it grows heavy. It also means learning how time can help money grow, even in

The lack of this knowledge shows up in everyday pain.
A sudden illness pushes families into loans they spend years repaying. Young people earn decent salaries and still live one emergency away from trouble. Older adults worry

about how they will cope once work is no longer possible.

One evening, a small hall in Srinagar fills with young men and women attending a free workshop on money. The first exercise sounds harmless. Write down what you spend

in a month. Pens hover. A few people smile awkwardly. Many realize they have never really counted it all before.

As the session continues, the room changes. People lean forward. Hands go up. Questions come quickly. Simple ideas begin to settle in. Save before you spend. Start early, even if the amount feels small. Allow time to carry some of the weight.

What once felt overwhelming starts to feel manageable.
The idea of compounding catches many by surprise.
Small, steady savings over years can become real support later in life. Waiting too long makes everything harder.

In a place where jobs can pause without notice and incomes can disappear overnight, this lesson carries real weight.

Families also shape how people deal with money. In

many homes, adults hide financial stress from children. The intention is protection. The result is silence.

When families talk openly about income, expenses and

priorities, children grow up better prepared for real life.
Some teachers have started filling this gap on their own.
They explain bank accounts, insurance and basic budgeting in simple ways.

These are small steps, but they leave lasting impressions. Financial literacy offers clarity. It helps people feel less anxious and more in control. It turns money from a constant worry into something that can be planned, even if resources are limited.

Aijaz recently opened a small savings account. The amount is modest, but it feels like a beginning. Sana has started tracking her spending and setting aside money the day her salary arrives. For the first time, she feels she is

moving forward, not standing still.

Learning how to manage money helps people turn hard work into security and hope into a plan.

# Kashmir's Problem With Math

A ground-level look at how weak foundations, staffing gaps and exam pressure are reshaping students' relationship with numbers.

n a winter morning in south Kashmir, a Class 7 class-room fills with the sound of chalk scraping against a blackboard. The teacher writes a long division problem, turns around and asks the students to copy it down. A boy in the second row raises his hand and asks why the numbers are arranged that way. The teacher pauses, then says, "This is how it comes in the exam." The lesson moves on.

After class, the boy tells me he likes science and wants to be an engineer. Mathematics, he says, makes him nervous. He studies it every day and still feels lost. His parents tell him to focus on passing marks and not worry too much. "Maths is not for everyone," they say.

Scenes like this play out across Kashmir, in government schools and private ones alike. They offer a window into a deeper problem that has been building for years: mathematics is steadily losing ground here.

In many government primary schools, mathematics is taught by teachers who did not study the subject themselves. Some are trained in language or social science and are asked to handle math simpwly because no one else is available. At first glance, this may seem manageable. Young children are learning basic numbers and operations. Over time, the gaps begin to show.

Mathematics is not a subject that can be carried forward by habit alone. Each idea rests on the one before it. When teachers lack confidence in the material, lessons turn mechanical. Students learn steps without meaning. Questions that fall outside the textbook are avoided. Curiosity is treated as a distraction.

Private schools often promise better outcomes, but the picture there is mixed. Many hire teachers without professional training, including those without a B.Ed., especially for mathematics. The pressure is on results.

Parents ask about board scores, rather than understanding. Coaching notes replace classroom discussion. Students memorize formulas without knowing where they come from. Fear enters early and stays.

The syllabus set by the Jammu and Kashmir Board of School Education does not clearly spell out how skills should build over time. Basic operations such as addition, subtraction, multiplication, division and order of operations are meant to be mastered through practice and application. In reality, they are rushed.

Activity-based learning is rare. Mathematics is taught as a hurdle to clear, rather than a tool to use.

Classes 6 to 8 mark a turning point. This is where arithmetic gives way to algebra, geometry and abstraction. It is also where many students fall behind for good. These grades demand teachers who understand how concepts connect and how to explain them in more than one way.

In many schools, the same nonspecialist teachers continue. Mistakes harden into habits. Confusion becomes permanent.

By Classes 9 and 10, the consequences are clear. Large numbers of students develop a deep dislike for mathematics. Even at this stage, many schools do not have specialized math teachers. Experience stands in for expertise. Students prepare for exams through shortcuts and guesswork. When they fail, they blame themselves.

Teachers' attitudes matter as much as their training. Students often describe math teachers as impatient or dismissive. Some are, but many are simply overwhelmed.

When the classroom becomes a place of embarrassment instead of inquiry, students shut down. The focus on exams reinforces this. Marks matter more than meaning.

re than meaning.
Families play a role too. Many par-

ents urge their children to choose science streams while treating mathematics as an obstacle to be endured until Class 10. "Just pass," they say, believing the subject has little use later.

As a result, very few students in Kashmir opt for mathematics at the higher secondary level. Colleges struggle to fill math programs. The pipeline thins.

Recent policy decisions risk deepening the problem. The introduction of two levels of mathematics at the secondary stage was meant to reduce stress. In practice, it sends a different message: that the subject can be diluted rather than taught better.

Lowering expectations does not build confidence. It narrows horizons.

There are ways forward. Kashmir needs specialized mathematics teachers at every level, starting from the middle grades. Targeted schemes to recruit and train them would make a measurable difference. Teacher training must focus on content mastery and classroom practice, rather than paperwork. The curriculum needs revision to emphasize understanding, logical thinking and real-life application.

Public attitudes must change as well. Mathematics is not just another subject. It underpins science, economics, technology and everyday decision-making. Students who gain confidence in math often find other subjects easier. They learn how to think, test ideas and solve problems.

Back in that Class 7 classroom, the boy who asked "why" still sits near the front. He works hard. What he needs is not reassurance that math is optional, but a teacher who can meet his question with an answer, or at least guide him toward one.

When that happens, fear gives way to interest.


This is useful, but it also takes something away.

# The Limits of "Thinking Rich"

Books on success motivate, but they often overlook historical, economic, and political barriers to prosperity.

uring the two-day book fair held at Maulana Azad Library on December 15 and 16, I across Wallace D. Wattles' wellknown work, The Science of Getting

Written more than a century ago, the book continues to attract new readers by offering a promise of prosperity through disciplined thinking and purposeful action.

A careful reading of the text, however, invites not only motivation but also deep sociological reflection.

At the core of Wattles' argument is a straightforward and compelling idea: wealth isn't just the result of labour or opportunity but of thinking in a certain way.

According to him, mental clarity, faith, and focused action are sufficient to attract material success.

For students, job seekers, and others facing professional uncertainty, such ideas naturally resonate.

The book provides hope, a sense of control, and psychological comfort in an otherwise unpredictable social and economic environment.

It is exactly here, however, that sociology encourages us to pause and

The difficulty begins with the book's depiction of wealth as an almost universal opportunity, available to anyone willing to correct their mindset. This assumption ignores a basic social truth: societies are not level playing fields.


Access to quality education, stable employment, economic resources, social networks, and respect is unevenly distributed across class, caste, gender, region, and generations.

Suggesting that prosperity mainly comes from correct thinking risks ignoring deep-rooted structural inequalities and makes them seem like individual faults.

From a sociological perspective, this gap is not just intellectual. It is political.

The focus on individual responsibility for success and failure closely aligns with neoliberal ideas, where risks are increasingly shifted from institutions to individuals.

In this view, unemployment is seen as a lack of effort, poverty as a failure of imagination rather than the product of historical and institutional barriers, and inequality as a natural

result rather than a social issue. As C. Wright Mills warned, this creates a dangerous confusion between personal troubles and public issues.

failure.

Pierre Bourdieu's concept of symbolic violence helps us understand this dynamic more clearly.

When individuals internalise the belief that their economic position reflects their mental discipline rather than their social location, inequality becomes normalised. Structural disadvantage is turned into self-blame, and critique gives way to acceptance. People are encouraged to change their thoughts instead of questioning the systems that limit their opportunities.

This does not mean the book has no value. Positive thinking can definitely boost confidence, discipline, and resilience. Mental clarity is essential, especially in competitive and stressful settings. However, psychological motivation cannot replace sociological explanations. Belief alone does not fix unequal schooling systems, create secure jobs, or eliminate inherited disadvantages.

In the Indian context, particularly in regions such as Jammu and Kashmir, where historical, political, and economic forces significantly shape life chances, such books must be read with caution. Inspiration without structural awareness can unintentionally silence questions about justice, redistribution, and collective responsibility.

Reading The Science of Getting Rich at Maulana Azad Library, a place that symbolises access to knowledge, debate, and intellectual diversity, served as a reminder of why critical reading is essential. Books do not merely motivate indi-

viduals. They also shape how society explains success and failure. When these explanations go un-

examined, they can make inequality seem like destiny or personal failure. Wealth, ultimately, is not simply 'attracted". It is produced, distributed, and legitimised through social

institutions and power relations. Recognising this does not deny individual effort, rather it situates it honestly within the context of society.

Te are born into society long before we understand our-

From the moment we learn to speak, we also learn to notice on ions, expectations, judgments, and comparisons.

Our identity grows in interaction. Society acts as a mirror, showing us who we are.

Up to a point, this shaping is necessary. Society gives us language, discipline, values, and a sense of belonging. It teaches us modesty, responsibility, and how to live with others.

When social influence guides us and supports our growth and happiness, following it feels natural and comforting.

The danger begins as society stops guiding and starts commanding. Approval takes priority over being true to ourselves. Fear replaces choice. People stop asking what is right for them and focus only on what will shield them from judgment.

This burden is heaviest on the poor. Poverty is more than a lack of money. In a society where worth is measured by lifestyle, it becomes public exposure. Decision feels like a performance,

while failure becomes a story for oth-A poor father watches others cau-

tiously, worried that his children will seem less, that modesty will be mistaken for failure, or that honesty will invite punishment. Society has made dignity expensive,

and he tries to keep up for survival.

I remember a father who came to me for help. He spoke hesitantly. His words were heavy with years of restraint. His younger daughter was in the 11th grade and needed a tablet to continue her education online. He had already taken a loan for the marriage of his elder daughter. The money had gone into rituals, expectations, jewelry, and feasts. We call those things honour.

# US Lifts Syria Sanctions, Paving Way for Normalisation

Damascus: Syria's government and its allies on Friday welcomed the final lifting of the most draconian sanctions imposed on the country in recent

The US Congress imposed the so-called Caesar Act sanctions in 2019, targeting Syria's government and financial system to punish President Bashar al-Assad's administration as it fought to end a nearly 14-year civil war that began in 2011 with Western backing for opposition

During the conflict, Damascus relied heavily on its ally Iran, which for decades had worked to build an "axis of resistance" to shore up its regional defences. The axis was central to Tehran's strategy to deter Israel and the United States and relied on Syria as a crucial land corridor linking Iran to the Levant.

connected That corridor Tehran to the powerful Lebanese ally Hezbollah, an integral part of the axis, providing what analysts described as its logistical backbone.

Underscoring Syria's importance, Iran spent billions of dollars to retain hold on Damascus. Tehran intervened militarily in Syria's civil war in 2013, deploying hundreds of Islamic Revolutionary Guards Corps (IRGC) officers to recruit and train tens of thousands of local and foreign fighters, playing a decisive role in shoring up the

Syrian army. However, the fall of Assad's government in a lightning rebel offensive in December 2024 dealt irreparable damage to the axis of resistance, analysts say, paving the way for Israel to confront Iran more directly, including during the July war this year.



advocates-including some who had previously lobbied for the sanctions-began pushing for their removal, arguing that the penalties were preventing international investors from launching reconstruction projects and blocking Syria's ability to rebuild its devastated economy and infrastructure.

US President Donald Trump,

who had earlier lifted the sanctions temporarily by executive order, signed off on their final repeal late Thursday after Congress passed the measure as part of the annual defence

Some lawmakers had sought to make the repeal conditional on steps by Syria's new Sunni Islamist-dominated government to protect religious minorities and meet other benchmarks. Ultimately, the sanctions were repealed without conditions, though the legislation requires periodic reports to Congress on Syria's progress on issues including minority rights and counterterrorism.

ministry foreign thanked Washington for the move, saying it would "contribute to alleviating the burdens on the Syrian people and open the way for a new phase of recovery and stability."

The ministry called on Syrian businesspeople and foreign investors to "explore investment opportunities and participate in reconstruction", the cost of which the World Bank has estimated at \$216 billion.

Governor Central Bank Abdulkader Husrieh said the repeal of the Caesar Act would facilitate Syria's reintegration into the international financial system by allowing the country to seek a sovereign credit rating.

'Syria will likely start with a low rating, which is normal for countries emerging from conflict," he said. "The real value lies in the benchmark set by the rating and the road map it provides for improvement."

Regional allies of the new Syrian government, led by interim President Ahmad al-Sharaa, also welcomed the decision. Turkey, Saudi Arabia and Qatar all issued statements supporting the move.

"We hope that this step will contribute to strengthening stability, security and prosperity in Syria by further promoting international cooperation towards the country's reconstruction and development," Turkish Foreign Ministry spokesman Oncu Keceli said.

Saudi Arabia's foreign ministry praised "the significant and positive role played by US President Donald Trump" in lifting the sanctions. Trump has previously said he moved to remove the penalties at the urging of Saudi Crown Prince Mohammed bin Salman and Turkish President Recep Tayyip Erdogan.

Also on Friday, the United Kingdom—which had earlier removed its own broad sanctions on Syria's government and financial institutions—imposed new targeted sanctions on organisations and individuals it said were "involved in violence against civilians" in Syria.

Those measures include four individuals affiliated with the former government in military or financial roles, as well as two individuals and three armed groups linked to the new Syrian government's military, accused of involvement in attacks on civilians during sectarian violence on Syria's coast earlier this year. morning hours, particularly near water bodies, affecting visibility.

Pampore and Shopian both recorded minimum temperatures of minus 3.5 degrees Celsius, while Baramulla dipped to minus 3.6 degrees Celsius. Kupwara recorded minus 2.8 degrees Celsius, down from minus 1.0 degrees Celsius a day earlier.

Gulmarg recorded a minimum of 1.0 degree Celsius, slightly lower than the previous day, while Pahalgam settled at minus 2.6 degrees Celsius. Kokernag and Kulgam recorded 0.5 degrees Celsius and 0.9 degrees Celsius respectively.

In the Jammu region, Jammu city recorded a minimum temperature of 9.9 degrees Celsius, while Jammu airport registered 11.1 degrees Celsius. Banihal recorded 3.5 degrees Celsius and Bhaderwah 2.3 degrees Celsius.

In Ladakh, Leh recorded a minimum temperature of minus 4.6 degrees Celsius, compared to minus 3.4 degrees Celsius a day earlier.

The Kashmir Valley is bracing for the onset of Chillai-Kalan, the harshest 40-day winter period, beginning on December 21 and ending on January 30. The period is traditionally associated with the coldest temperatures and the highest chances of snowfall.

So far, the Valley has not witnessed any major wet spell this winter, officials said.

The prolonged dry weather has led to a rise in seasonal ailments such as cough and com-

Meteorological officials said the next 24 hours are likely to remain largely dry, with only isolated chances of precipitation at a few places. However, from Saturday evening, cloudy weather is expected to set in across the region, followed by rain in the plains and snowfall over higher reaches.

According to the MeT, fairly widespread rainfall in the plains and snowfall in higher reaches is likely on Sunday, particularly in north Kashmir. Upper reaches of north Kashmir are o receive snowfall, while plains of Kupwara may receive 2 to 3 inches of snow. Srinagar is likely to receive 1 to 2 inches of snowfall during the period.

Parts of central Kashmir may also witness similar conditions, with snowfall in isolated areas. Another weak western disturbance is likely to affect the region around December 22.

Weather conditions are expected to remain mostly dry but cloudy from December 22 to December 24, after which dry weather is likely to prevail till December 28, officials said.

People, especially those travelling to higher reaches, have been advised to remain cautious during the period of expected snowfall.

its for much of the day.
Airport officials said multiple morning and afternoon flights could not operate due to persistent fog over the runway. Airlines including Air India, IndiGo, and SpiceJet cancelled their inbound and outbound services as visibility dropped sharply.

Among the affected flights were Air India's services AI-3423 and AI-1799 to Delhi. IndiGo cancelled flights 6E-6164 on the Amritsar sector and 6E-2044 bound for Delhi. SpiceJet's flights SG-661 and SG-180 to Delhi, along with IndiGo flight 6E-6961 to Kolkata, were also cancelled due to adverse weather conditions.

Airport authorities said passenger safety remains the top priority and flight operations will resume once weather conditions improve. Several passengers reported long queues at

airline counters as they sought rebooking and clarification regarding their travel plans.

Officials have advised travellers to remain in contact with their respective airlines for updated information, warning that further delays or cancellations cannot be ruled out if fog persists through the evening.

Under Mission Mausam, the India Meteorological Department (IMD) is using next-generation forecasting models such as the Bharat Forecast System (BharatFS), which operates at a high spatial resolution of six kilometres and provides short to medium range rainfall forecasts up to ten days, informed the

These forecasts are now generated at the panchayat and cluster-of-panchayat levels, proving beneficial to weather-sensitive regions like Jammu and Kashmir.

The government has also introduced a new system known as the Mithuna Forecast System-- a new generation global coupled model integrating atmosphere, land, ocean and sea-ice components. This is being used to improve district-level forecasts for extreme weather events, including heavy rainfall, snowfall, heatwaves and fog— a phenomenon frequently occurring in J&K.

The Ministry further stated that artificial intelligence and machine learning-based tools are now being integrated into the forecasting chain to enhance nowcasting and impactbased warnings. These systems help generate more reliable alerts for disasters such as flash floods, cloudbursts and avalanches, which are common in hilly and mountainous areas like Jammu and Kashmir.

To issue timely weather advisories, satellitebased monitoring, through INSAT platforms and real-time data from radar networks, is being used. These are then disseminated through IMD websites, mobile applications such as Meghdoot, Mausam and Damini, and other digital platforms.

The Government said that the expansion of weather forecasting infrastructure will continue to happen under Mission Mausam. It includes setting up additional radars to address the coverage gaps and further strengthen disaster preparedness and climate resilience in vulnerable regions, including Jammu and Kashmir.(KNO)

### J&K Steps Up

Centre, adoption of official government e mail IDs by employees, expansion of Government Drive usage, and capacity building measures to promote cyber hygiene across departments.

Emphasising the need for robust protection of IT assets, the Chief Secretary directed all Drawing and Disbursing Officers to complete inventorisation of IT assets on the e SAM portal within one month. He further instructed the NIC to prepare a comprehensive action plan within a month for strengthening the capacity of the State Data Centre and implementing additional cyber security measures across J&K.

Earlier, IGP Crime Sujit Singh briefed the meeting on an in depth assessment of cyber forensic capabilities at the Cyber Investigation and Cyber Examination unit. He said a structured three phase approach is being followed to strengthen cyber forensic infrastructure in the UT, with focus on emerging threats such as deep fakes, encrypted communications and data breaches.

Technology Secretary Information Department Dr Piyush Singla informed that security audits of departmental websites have been completed and 35 redundant websites decommissioned after consultation with the concerned departments. He said EDR and UEM solutions have been deployed across the Civil Secretariat complexes in Jammu and Srinagar, covering nearly 5,100 devices, while another 15,000 devices in HoD offices are scheduled to be secured by January 2026.

The meeting was informed that 28 departments have initiated census of IT assets, while 14 departments have been asked to expedite the process. The adoption of official government e mail IDs has reached 1.81 lakh users, with 35,000 users added since May 2025.

Other initiatives discussed included deployment of 19 honey pots, training support from CERT In, limited white listing of USB devices, and increased use of Government Drive across departments.

CEO JaKeGA Mahima Madan informed that select applications have been migrated to the MeghRaj Cloud, the Mini SOC at Jammu has been operationalised and will be upgraded into a full fledged SOC, and government websites are being migrated from IPv4 to IPv6 by the end of the year.

The Chief Secretary underscored that strong cyber security mechanisms are essential for efficiency, transparency and reliability in governance and directed departments to coordinate closely with the IT Department and complete all pending tasks within stipulated timelines.

### **Court Extends NIA**

on December 9 and has been described by the agency as a key accused in the conspiracy. According to the NIA, he had knowingly harboured Umar-un-Nabi by providing logistical assistance and is also accused of destroying evidence linked to the terrorist attack.

So far, the NIA has arrested nine accused in the case. Those held include doctors Dr Muzammil Ganaie, Dr Adeel Rather, and Dr Shaheen Sayeed, along with religious preacher Maulvi Irfan. Amir Rashid Ali and Jasir Bilal Wani, alias Danish, have also been arrested.

On December 18, the agency arrested the ninth accused, Yasir Ahmad Dar, a resident of Jammu and Kashmir and allegedly a close associate of Umar-un-Nabi. The NIA has claimed that Dar was an active participant in the conspiracy and had taken an oath to carry out selfsacrificial operations.

Umar-un-Nabi was driving an explosive-laden i20 car that detonated outside the Red Fort on November 10.

saw the passage of crucial bills, including one to repeal the 20-year-old MNREGA and another on opening up the civil nuclear sector for private participation.

The total sitting hours during the Winter Session was 92 hours and 25 minutes.

When speaker Om Birla was reading out his valedictory statement, some members were heard raising "Mahatma Gandhi ki jai" slogans. Prime Minister Narendra Modi was present when the proceedings were adjourned.

During the 15 sittings of the Winter Session, the House took up two politically-charged debates -- one on the 150 years of Vande Matram and the other on election reforms.

The prime minister had initiated a discussion to commemorate the completion of 150 years of the national song. The House discussed the subject for 11 hours and 32 minutes, during which 65 members participated.

A debate on air pollution, which was to be initiated by Congress leader Priyanka Gandhi, could not take place.

The opposition had been insisting on a debate on the Special Intensive Revision (SIR) of the voter list in 12 states and Union Territories. but the government made it clear that the poll panel and its functioning cannot be discussed in the House, and agreed to hold a debate on election reforms instead.

The issue was discussed for approximately 13 hours, with the participation of 63 MPs. The opposition, however, focused its attack against the government on SIR, the new law on the appointment of the chief election commissioner and election commissioners, and the "vote chori" issue.

Eight bills were passed during the session. The Viksit Bharat Guarantee for Rozgar and Ajeevika Mission (Gramin) or VB-G RAM G Bill, assuring 125 days of guaranteed jobs for rural India, was passed amid opposition protests on Thursday, including tearing of papers.

Sustainable Harnessing Advancement of Nuclear Energy for Transforming India (SHANTI) Bill, which seeks to open the tightly-controlled civil nuclear sector for private participation, was also passed during the session.

The Lok Sabha also passed a bill to raise foreign direct investment (FDI) in the insurance sector to 100 per cent from the current 74 per cent. It is expected to increase insurance penetration, lower premiums, and boost job

The Sabka Bima Sabki Raksha (Amendment of Insurance Laws) Bill, 2025, was cleared by the Rajya Sabha with a voice vote, a day after was passed by the Lok Sabha. The Lower House also passed a Bill to repeal 65 amendment Acts and six principal laws, which had lost relevance.

The Manipur Goods and Services Tax (Second Amendment) Bill, 2025; the Central Excise (Amendment) Bill, 2025 and the Health Security se National Security Cess Bill, 2025 were also among the bills passed in the Lok Sabha during the session. The House also passed the Supplementary Demands for Grants - First Batch, 2025-26.

A bill to set up a higher education regulator -- the Viksit Bharat Shiksha Adhisthan Bill, 2025 -- was referred to a joint committee of the two Houses. It seeks to establish an overarching higher

education commission along with three councils for regulation, accreditation and ensuring academic standards for universities and higher education institutions in India.

Another bill on the market securities code was introduced and referred to a department-related standing committee for further examination. During the session, 300 starred questions

were admitted, and 72 were answered orally. A total of 3,449 unstarred questions were admitted during the Session. In total, 408 matters of urgent public importance were raised by the members during

the Zero Hour, and 372 matters were taken up

under Rule 377. On December 11, as many as 150 members raised their matters during Zero Hour in the House.

PRS Legislative, a think tank, said the Lok Sabha functioned for 103 per cent of its scheduled time and the Rajya Sabha for 104 per cent. Each House spent over 40 per cent of its time

Growers said saffron production in Kashmir has already been hit by a combination of factors, including a shrinking cultivation area, erratic weather linked to climate change, lack of timely irrigation, and the non-availability of high-quality corms.

'Porcupines are adding to our misery," Ishrat said. "If this issue is not addressed immediately, there will be no viable saffron corms left in these fields in the coming years.'

Farmers recalled that a repellent spray introduced by SKUAST-Kashmir a few years ago provided temporary relief, but its effect was shortlived and failed to offer a long-term solution. "We are not experts. The government must

can guide us on sustainable ways to prevent porcupine damage," said a grower from Lethpora. "So far, no permanent measure has been put in place.' Locals said they have repeatedly brought

the issue to the notice of agriculture and wildlife departments, but no concrete steps have followed.

### Over 17,000 Street **Vendors Benefit under PM SVANidhi in J&K**

SRINAGAR: Nearly 17,000 street vendors in Jammu and Kashmir have benefited from the Prime Minister Street Vendor's AtmaNirbhar Nidhi (PM SVANidhi) scheme and over ₹48 crore loan disbursed so far, as per the official data tabled in Parliament shows.

In a written reply by the Ministry of Housing and Urban Affairs in response to a Lok Sabha question, a total of 17,315 street vendors in Jammu and Kashmir are registered as beneficiaries under this scheme.

The data further reveals that loans amounting to ₹50.83 crore have been approved in favour of these vendors. So far, ₹48.18 crore has already been disbursed, which depicts a high disbursal rate in the Union Territory.

The Ministry said, "Urban Local Bodies (ULBs) play a key role in identify ing eligible street vendors through surveys conducted under the Street Vendors (Protection of Livelihood and Regulation of Street

After the verification is completed, eligible vendors are provided with Certificates of Vending, identity cards or Letters of Recommendation (LoR). Then their loan applications are sent to banks and other lending institutions for approval and disbursement. Urban Local Bodies (ULBs) also facilitate vendors through handholding, mobilising applicants and coordinating with banks to ensure loans are released promptly.

The forum appealed to the GMC Handwara administration to install CCTV cameras in every OPD to ensure accountability and prevent alleged malpractice.

Responding to the controversy, Medical Superintendent of GMC Handwara, Dr. Aijaz Ahmad, admitted that the hospital's CT scan machine had developed a technical fault.

He, however, clarified that the attendants pushed the patient 'in haste' despite being stopped by hospital security personnel.

"The CT scan machine had a technical snag, but the attendants rushed without coordinating with hospital staff. Nobody requested for an ambulance," Dr. Aijaz said.

He added that an engineering team had been called to address the malfunction, but the machine again developed a snag. "Hopefully, the CT scanner will be restored to order by tomorrow," he said.

### **SCM Projects Nearing Completion in J&K**

SRINAGAR: Jammu and Kashmir has made a substantial headway under the Smart Cities Mission (SCM), as data presented in the Parliament records the majority of approved projects in Jammu and Srinagar nearing completion.

In a written reply to Lok Sabha, the Ministry of Housing and Urban Affairs, said that Jammu and Kashmir has received ₹941 crore as Central Financial Assistance under SCM, of which ₹864.6 crore has already been utilised. A total of 288 projects amounting to ₹6,603.5 crore were taken up in the Union Territory. Of these, 279 projects, amounting to ₹6,364.7 crore, have been completed, while nine projects totalling to an amount of ₹238.8 crore are under execution, indicating an overall completion rate of more than 96 per cent.

Under Smart City, Srinagar has witnessed significant progress as 156 out of 161 projects have been completed so far. The completed projects in Srinagar account for ₹3,523.6 crore, while five projects with a cost of ₹110.8 crore are under execution. While in Jammu city, 127 projects with a total cost of ₹2.969.1 crore were approved under the mission. Of these, 123 projects worth ₹2,841.1 crore have been completed, while four projects are still undergoing, which cost ₹128 crore.

While highlighting the objective of Smart Cities, the Union Government clarified that the Smart Cities Mission is not the development of entire cities, but focused area-based development through retrofitting, redevelopment, greenfield projects and pan-city initiatives. These also include interventions in smart mobility, water supply, sanitation, governance, energy and environment sectors, it added.

As per KNO, the Ministry further informed that the projects are implemented through Special Purpose Vehicles (SPVs) and are audited as per provisions of the Companies Act, 2013, with audits conducted by State Audit authorities.

Aimed to improve urban infrastructure and quality of life through technology-driven and sustainable solutions, the Smart Cities Mission was launched in June 2015 and during the different rounds of the national challenge process, Jammu and Srinagar were selected.

### **Kashmiri Doctor Clinches Fourth International Honour**



ashmiri gastroenterologist and hepatologist Dr. Hameed Raina has added another feather to his cap by winning the Second Best Video Award at the 3rd International Hepatopancreaticobiliary (HPB) Conference, held recently in Dubai. This marks his fourth international award in recent years, underscoring his growing global stature in advanced endoscopy and endoscopic ultrasound (EUS).

Dr. Raina, a native of Hussipora, Chadoora in central Kashmir, was recognised for presenting a highly advanced and innovative technique titled "EUS-Guided Cystogastrostomy and Direct Endoscopic Necrosectomy in Post-Pancreatitis Walled-Off Necrosis." The procedure is considered cuttingedge in the management of severe complications arising from acute pancreatitis and reflects a major leap in minimally invasive gastrointestinal care.

An alumnus of Government Medical College, Srinagar, Dr. Raina completed his MD in Internal Medicine from the Sher-i-Kashmir Institute of Medical Sciences (SKIMS) before earning a DM in Gastroenterology and Hepatology from Tata Memorial Hospital, Mumbai, one of India's most prestigious medical institutions. He also holds multiple international fellowships, including FMPB, FEUS and FATE, and is a Member of the Royal College of Physicians, United Kingdom (MRCP-UK).

Significantly, Dr. Raina is regarded as the first Kashmiri gastroenterologist to achieve international recognition in the highly specialised field of interventional EUS, a domain that bridges advanced endoscopy and complex surgical outcomes. ammu and Kashmir Police in Shopian have taken action against a stunt biking incident reported from the Zawoora area. In this connection, a case FIR No. 270/2025 has been registered under Sections 281 and 125 of the Bharatiya Nyaya Sanhita (BNS) and Section 184 of the Motor Vehicles Act. The motorcycle involved in the incident has been seized and further investigation is underway.

The accused rider has been identified as Furqan Ahmad Dar son of Mohd Ashraf Dar resident of Zawoora, Shopian. He was found indulging in dangerous stunts on a public road, thereby endangering his own life and posing a serious risk to other road users.

J&K Police have reiterated that stunt biking and rash driving on public roads are strictly prohibited and will attract stringent legal action. Public roads are meant for safe commuting and such irresponsible behaviour can lead to tragic consequences. The police have appealed to the youth to adhere to traffic rules and adopt responsible driving practices. Parents and guardians have also been urged to guide and counsel their children regarding road safety and traffic discipline. (Observer News Service)

# **CBK Files Charge Sheet in Job Fraud Case**

**SRINAGAR:** The Special Crime Wing of Crime Branch Kashmir has filed a charge sheet against a Ganderbal resident for allegedly duping several people of rupees 5.50 lakh on the pretext of providing government jobs, reaffirming its zero-tolerance policy towards job frauds and cheating cases.

According to a statement issued to Kashmir Observer, the Special Crime Wing of Crime Branch Kashmir has filed

a charge sheet in case FIR No. 05/2020 under Section 420 RPC before the Hon'ble Court of Sub Judge 13th Finance, Srinagar, against Muzaffar Ahmad Shah S/o Shamsudin Shah, resident of Saloora, Ganderbal, at present residing at Co-operative Colony, Peerbagh.

The statement says, the case originated from a complaint alleging that the accused fraudulently obtained an amount of 5.50 lakh from complainants on the false promise of providing government jobs to them and their relatives. Acting

promptly on the complaint, the Special Crime Wing Kashmir initiated a detailed probe into the matter. It says, during the course of investiga-

tion, substantial evidence came to light establishing the involvement of the accused in the alleged offence. The investigation revealed that the accused had deliberately misled the complainants. exploiting their aspirations for government employment, and dishonestly induced them to part with their hardearned money.

DUBAI: Vice-captain Vihaan Malhotra's exhilarating stroke-play was well complemented by Aaron George's composure as India U-19 set up an U-19 Asia Cup summit date with arch-rivals Pakistan after crushing Sri Lanka colts by eight wickets in a rain-curtailed semi-final here on Friday.

After rain reduced the match to 20 overs per side, the Indian bowling unit, which has been spot on throughout the tournament, restricted Sri Lanka to 138 for 8 in 20 overs.

In reply, left-handed Malhotra (61 not out off 45 balls), who was snapped up by RCB at the recently concluded IPL mini auction, flicked and pulled with ease to hit a couple of sixes apart from muscling a few boundaries.

In the other semi-final, Pakistan beat Bangladesh by eight wickets, and the bitter neighbours will meet in the continental final after a gap of 11 years.

The last time India U-19 beat Pakistan in the Asia Cup final in 2014, the team comprised of Shreyas Iyer, Sarfaraz Khan, Sanju Samson and Kuldeep Yadav, to name a few.

India U-19 had an inauspicious start to its chase, with teenage IPL sensations Ayush Mhatre (7) and Vaibhav Suryavanshi (9) being done in by pacer Rasith Nimsara. Mhatre, who has endured a horrible tournament, was hurried into a mistimed pull by a short ball from Nimsara.

Nimsara varied his pace for Suryavanshi, who tried to close the face of the bat but got a leading edge that ballooned.

However, Malhotra started with a flicked six off Nimsara, and there was no looking back. In the case of George, an imperious drive off off-spinner Kavija Gamage showed his class.

Sri Lanka U19 were still giving a fight till the 13th over bowled by Dunith Sigera, where Malhotra first played a short firm pull for a boundary, followed by a drive through extra cover and then another front-foot pull that landed on the grass banks.

Opting to field, India's colts' bowling unit did well to reduce Sri Lanka to 28 for 3 within the first six overs before skipper Vimath Dinsara (32) and Chamika Heenatigala (42) added 45 in the next six overs to stabilise the innings.

However, it was Sethmika Seneviratne's cameo -- a 22-ball-30 -- that took Sri Lanka past the 135-run mark. For India, spinner Kanishk Chauhan and Henil Patel took two wickets apiece.

## Head Century Crushes England's Hopes As Australia Eye Ashes Win

Travis Head proved England's nemesis once again as he scored his second century of the Ashes to carry Australia toward a seemingly inevitable series triumph on day three at Adelaide Oval on Friday.

Head's unbeaten 142 in front of an adoring home crowd of 53,696 helped Australia to 271 for four at stumps and a 356-run lead after the hosts bowled England out for 286 in the morning.

Australia lead the fivematch series 2-0 after comfortable victories in Perth and Brisbane, and need only a draw in Adelaide to retain the urn as holders.

Head's fellow South Australian Alex Carey also cashed in, adding an unbeaten 52, as the local heroes combined in an unbroken 122-run partnership to bang another nail into Eng-



land's coffin.

Head's century was unwelcome deja vu for the tourists following his sensational 123 off 83 balls in the fourth innings in Perth.

The second ton nearly eluded him, though when he slashed Jofra Archer low to the gully when on 99, only for Harry Brook to spill a second, costly catch of the test.

The following over, Head smashed Will Jacks over his

head for four to bring up the hundred in 146 balls.

The boundary sparked one of the warmest ovations of his sporting career, the 31-year-old getting down on his knees to kiss the pitch where he made his career for state side South Australia.

With England captain Ben Stokes looking tired and opting not to bowl, the tourists had no answer to Head despite plugging away for some reward against the other batters. "From what I understand he's pretty fit to bowl," England bowling coach Jeetan Patel told reporters of Stokes. "I know he's pretty knackered."

Opener Jake Weatherald (1), number three Marnus Labuschagne (13) and Cameron Green (seven) fell cheaply but stand-in number four Usman Khawaja joined Head in an important 86-run stand after Australia were 53 for two.

### Runs Aplenty: Kiwis Declare at 575, West Indies 110-0 on Day-2

evon Conway scored his second Test double century more than four years after his first, powering New Zealand to a declaration at 575 for 8 on Friday, the second day of the third Test against the West Indies.

Undeterred by New Zealand's imposing total and the need to bat in gloomy late-afternoon conditions, West Indies openers John Campbell and Brandon King surged to 110 without loss in 23 overs by stumps.

New Zealand lead the three-match series 1-0 after the first Test was drawn and the Black Caps won the second by nine wickets.

King reached his halfcentury from 63 balls and was 55 not out at the close, while Campbell was 45 not out after the pair



put on a century opening stand from just 116 balls.

After reaching 200, Conway went on to register his highest Test score of 227 in an innings lasting nearly eight-and-a-half hours. He had made exactly 200 in the first innings of his debut Test against England at Lord's in June 2021.

Conway's marathon knock of 227 came from 367 balls and included 31 fours. It featured a commanding 323-run opening partnership with Tom Latham, putting New Zealand firmly in

control. Latham made 145 on the opening day.

Rachin Ravindra then built a half-century across the second and third sessions on Friday, finishing 72 not out when the declaration was made shortly before 5 p.m., with about 90 minutes, or 23 overs, remaining in the day. Ravindra struck six fours and two sixes, accelerating as the declaration approached, and shared an unbroken 39-run stand with Ajaz Patel, who ended on 30 not out.

# India defeat South Africa by 30 runs, clinch T20I series 3-1



ard-hitting India batters Tilak Varma and Hardik Pandya hammered fine half-centuries while spinner Varun Chakravarthy snared four wickets as India defeated South Africa by 30 runs to clinch the five-match T20I series 3-1 here on Saturday.

With Varma (73 off 42 balls) and Pandya (63 off 25 balls) in full flow, India scored a competitive 231 for 5 and then restricted the visitors to 201 for 8.

The Proteas were in the match till opener Quinton de Kock (65 off 35 balls) and Dewald Brevis (31 off 17) were at the crease, but the visitors lost wickets quickly once the two departed in successive overs.

Chakravarthy (4/53) removed the dangerous Aiden Markram and Donovan Ferreira off consecutive deliveries in the 13th over to take the fight out of the South Africans by reducing them to 135 for 5 from 118 for 1 in 10 overs.

Earlier, skipper Suryakumar Yadav's poor run with the bat continued as he scored just five runs but India still put up a big total with Varma and Pandya sharing a 115-run stand for the fourth wicket.

### **ED Attaches Assets of Yuvraj Singh, Uthappa in Betting Case**

ssets of former Indian cricketers Yuvraj Singh and Robin Uthappa, apart from those of ex-TMC MP Mimi Chakraborty and actor Sonu Sood, have been attached by the ED in an "illegal" betting app linked money laundering case estimated to be worth more than Rs 1,000 crore, official sources said Friday.

The properties of actor Neha Sharma, mother of model Urvashi Rautela and Bengali actor Ankush Hazra, have also been attached after the federal probe agency issued a provisional order under the Prevention of Money Laundering Act (PMLA), according to the sources.

These include assets worth about Rs 1 crore of Sood, Rs 59 lakh of Chakraborty, Rs 2.5 crore of Yuvraj Singh, Rs 1.26 crore of Sharma, Rs 8.26 lakh of Uthappa, Rs 47 lakh of Hazra and Rs 2.02 crore of Rautela's mother, the sources said.

All these celebrities were questioned by the ED in the past, and these assets have been categorised as the "proceeds of crime" (illicit money under the PMLA) of the alleged illegal betting app named 1xbet registered in Curacao.

The agency had some time ago attached assets worth Rs 11.14

crore of former cricketers Shikhar Dhawan and Suresh Raina as
